On the hardening of the ionizing radiation in H II regions across galactic discs through softness param eters

ABSTRACT

We carry out a study of the hardness of the radiation of ionizing clusters in H $\scriptstyle\rm II$ regions. Firstly, we explore the applicability of the softness parameter , originally de ned in the optical for pairs of consecutive ionization stages of the same species. W ith the advent of the infrared space observatories, this de nition has been extended to the m id-infrared. We show that the softness parameters, as determined both in the optical and the m id-infrared wavelengths, are sensitive to the elective temperature using a sample of data in both spectral regimes. This is con med by comparing the data with a grid of photoionization models, although no complete agreement has been found even for di erent stellar model atm ospheres. Finally, we show that both softness parameters are consistent in the discs of spiral galaxies. We ind a range of trends, from galaxies showing pronounced gradients to those showing very at ones. A lthough the detectability and slope of these gradients can be altered by the size and lum inosity of the studied H II regions, it looks that their existence is related to the maximum of the galaxies and, hence, to the properties of the entire disc.

1 IN TRODUCTION

The radiation eld em itted by massive stars ionizes the interstellar medium producing the HII regions. These regions are found preferentially in gas-rich galaxy discs and starforming dwarf galaxies and remain a powerful tool to investigate m any relevant properties of the interstellar medium (ISM; metallicity, density, tem perature) and of the massive stellar populations of galaxies (star formation rate, spectral energy distributions, IM F, am ong others).

Since the pioneering works of Searle (1971) the observation of giant HII regions in the discs of nearby spirals has revealed the existence of gradients of the excitation of the ionized gas, as measured by the ratio of [D iii]/H lines. These excitation gradients were originally associated to the existence of chem ical abundance gradients across the galaxies (Sm ith, 1975), now adays a general property of spiral discs (e.g.P ilyugin et al., 2004). In addition to the abundance gradient, it was originally found that a gradient in the hardness of the ionizing spectral energy distribution (SED) was necessary in order to produce a detailed m odeling of the spectra of (inner) H II regions in som e spiral galaxies (Shields & Searle, 1978). Indeed, the spectral sequence of (near zero-age/m ain sequence) giant H II regions has been shown to be driven by three main functional param eters: metallicity, e ective ionizing tem perature and ionization parameter (e.g. M cC all et al., 1985), allowing for a certain evolution of the ionizing stars and their nebulae (e.g. Stasinska and Schaerer, 1997).

In order to put these earlier suggestions on a mer observational basis, the degeneracy between the spectral param eters excitation and metallicity must be broken, since the spectral observables of e ective tem perature, ionization param eter and metallicity are usually self-correlated. In this vein, V khez & Pagel (1988) de ned a methodology to evaluate the e ective tem perature of the ionizing stars in H II regions independently (to rst order) of the value of the ionization parameter; they used 0 sterbrock's equation for the abundance equilibrium of two consecutive ionization stages of two di erent species to produce a SED \radiation softness" parameter; thus removing the dependence on the ionization parameter:

where n (Xⁱ) is the number density of the itim es ionized atom s of the element X, u is the ionization parameter, c is the speed of the light, hⁱ is the mean value of the photoionization cross-section of Xⁱ, (Xⁱ) is the total recombination coe cient, Q (Xⁱ) is the number of ionizing photons of the ion Xⁱ and Q (H) the number of ionizing photons of hydrogen. Since the quotient of ionizing photons is sensitive to the shape of the ionizing SED and, hence, to the hardening of the radiation, this quantity can be used to derive the e ective tem perature. The dependence on the ionization param eter can be rem oved (to rst order) by taking the ratio of two di erent quotients. This method can be used for any pair of chosen consecutive ionization stages. Therefore, using the available em ission lines in the optical range of the H II region spectrum, an optical \radiation softness" parameter was de ned as:

which does not show a strong dependence on the electron tem perature and it is proportional to the corresponding ratio based on the em ission lines,

where all the wavelengths are in A. This parameter results inversely related to the elective temperature, given the difference in the ionization potentials involved (O⁺ IP 35.1 eV; S⁺ IP 23.3 eV). Then, combining with one of the ionic quotients we can solve also for u.

M ore recently, M art n-H emandez et al. (2002) and M orisset et al. (2004), am ong others, have explored the use of sim ilar softness param eters de ned using the intensities of em ission lines available in the m id-infrared (m IR), in particular, based on Ar, N e and S ne structure em ission lines. N evertheless, until recently it has not been possible to carry out an empirical test of these m IR \softness" param eters; presently this test is possible given the am ount of data now available from space-based observations with Spitzer Space Telescope, in addition to previous data from the Infrared Space O bservatory.

Spiral galaxies can o er the best laboratory to check, in a consistent way, the validity of these m \mathbb{R} softness param eters, since the H II regions in these discs have been observed under sim ilar conditions and analyzed consistently. At present, there is a useful source of data available ofm \mathbb{R} em ission lines of \mathbb{N} eii], \mathbb{N} eiii], \mathbb{S} iii] and \mathbb{S} iv] in H II regions of spiral discs (see Table 1). W ith this inform ation, a \softness" param eter in the m \mathbb{R} can be de ned as follow s:

To keep the negative correlation with the e ective tem – perature {as in the de nition of the optical param eter{ we used the line of N e^+ (IP 41.0 eV) in the num erator over the line of S²⁺ (IP 34.8 eV). The study of the behaviour of this quotient using photoionization m odels (M orisset et al., 2004; Sim on-D az & Stasinska, 2008) indicates a very slight dependence on the stellar atm osphere used in the m odels; and recent studies using a larger em pirical database (cf. G roves et al., 2008) point to a clear o set of the AGN swhen view ed within the same fram ew ork.

A lthough recent evidences point towards possible variations in the ionizing SED s of H II regions across spiral discs, yet it remains unknown whether this behaviour appears an \universal" feature of spiral galaxies. In particular, we do not know to which extent realgradients of the ionizing SED s do exist in spiral galaxies; whether these (possible) gradients of the ionizing SED s could be param eterized in term s of the physical/chem ical properties of spiral galaxies remains to be Table 1. studied. W ith this aim s, in this work we study empirically the applicability of both, optical and m IR softness param – eters and make an exam of our results in the light of the predictions of a set of photoionization models. Then, using recent high quality data of H II regions for a sam ple of spiral galaxies, we make a consistent study of the behaviour of the (gradients of) hardening of the ionizing radiation across their discs, as traced by the emission lines of their bright H II regions. Finally, we discuss the results obtained and present our conclusions.

2 EM PIRICAL "SOFTNESS" PARAMETERS AND PHOTOIONIZATION MODELS

W e have made a selection from the recent literature of all high quality emission line uxes necessary to calculate both, the optical and m IR softness parameters. In the case of the optical, we took the reddening-corrected spectroscopic data used in Perez-M ontero et al. (2006), with the addition of the H II galaxies studied in H agele et al. (2008), a sam ple of m etal-rich H II regions in spiral discs (B resolin et al., 2006) and the C ircum nuclear Star Form ing R egions (C N SFR s) studied in D az et al. (2007).

In the case of the m IR, we have compiled spectroscopic data from di erent sources corresponding to ISO and Spitzer observations. Table 1 lists the compiled objects along with their references and the source of observations.

W e make use of the photoionization code CLOUDY 08.00 (Ferland et al., 1998), taking as ionizing source the SED of m etal line-blanketed, NLTE, plane-parallel, hydrostatic modelatm ospheres of 0 stars calculated with the code TLUSTY (Hubeny & Lanz, 1995). W eassum ed sphericalgeom etry, a constant density of 100 particles per cm 3 and a standard fraction of dust grains in the interstellar medium . W e assum ed as well that the gas m etallicity is the sam e for the ionizing source, covering the values Z /30, Z /10, Z /5, $\rm Z$ /2 and $\rm Z$, taking as the solar metallicity the oxygen abundance m easured by A splund et al. (2005; 12+ log (0 /H) = 8.66). The rest of ionic abundances have been set to their solar proportions. A certain am ount of depletion was taken into account for the elements C, O, Mg, Si and Fe, considered for the form ation of dust grains in the code. Regarding other functional parameters we considered di erent values

of the ionization parameter (log U = -3.5, -3.0, -2.5 and -2.0) and of the stellar elective temperature (T = 35000 K, 40000 K, 45000 K and 50000 K). This gives a total of 80 photoionization m odels intended to cover the range of conditions of di erent ionized gas nebulae.

3 RESULTS AND DISCUSSION

In Figure 1 we show the relations between the ratios of em ission lines used to de ne both the optical and the m IR softness parameters. Both ' are obtained directly by the lines of slope 1 with the same di erence between the y and the x axis. The models are represented by crosses and the best linear t to each set with the same e ective tem perature are represented as solid lines of di erent colours.

In the left panel, we show the plot of the optical softness parameter. The models t reasonably well the data, with the probable exception of H II galaxies, which present abnorm ally high e ective tem peratures as com pared with the scale of the m odels; these values can be even higher than the stellar atm ospheres with e ective tem perature of 50 kK. This feature has been previously related to a (claim ed) additional source of heating in these objects (e.g. Stasinska & Schaerer, 1999). At same time, we can observe that higher e ective tem peratures correspond to lower values of the ' param eter. On the other hand, as was already found by M orisset (2004), low erm etallicities lead to low ervalues of 0 , but this e ect is sensibly lower in the considered range of metallicity than those caused by di erences in stellar e ective tem perature. A nyway it precludes to provide a precise calibration of the e ective tem perature as a function of this param eter.

In the right panel, we show the equivalent plot for the em ission line ratios of the m id IR softness parameter. In this case, there is not a general agreem ent between the com piled data and the predictions of the m odels for all the stellar tem peratures; in such a way that a large fraction of the objects (m ostly GEHRs) appears to be located in a region of the diagram corresponding to e ective tem peratures lower than 35 kK Thism ism atch, already found by M orisset et al. (2004), does not look to be caused by the use of speci c sets of stellar m odel atm ospheres. For instance, the sam e grid of m odels but using the W M Basic stellar atm ospheres (Pauldrach et al., 2002) produced o sets of 0.3 dex towards even lower values of '. Besides, m odels predict a sim ilar dependence on m etallicity as in the case of the optical param eter.

As in the case of the optical parameter, models also show a dependence of the m \mathbb{R} parameter on elective tem – perature, in the sense that higher values of the m \mathbb{R} parameter eter are associated to lower model elective temperatures. Nevertheless, the position of H II galaxies in this diagram, overlapping a fraction of the data, and the con uence of the dierent slopes of the ts to the models towards the higher excitation corner of the plot, indicate that this parameter appears less elecient/reliable for those objects with higher ionization degree (i.e. lower [Siii]/[Siv] ratios).

The study of these softness param eters along the radial direction of the discs of spiral galaxies provides a consistent scenario to study the variation of the hardening of the ionizing radiation, mainly because these HII regions have been observed consistently across each galaxy. In Figure 2, we show the deprojected gradient of the optical softness param eter for sets of H II regions in a sam ple of spiral discs for which the four required em ission lines have been m easured. In Table 2, we list the bibliographic sources from which we have extracted the data for each galaxy as well as the slopes of the corresponding best linear ts, along with their errors. All of the galaxies show negative or at radial gradients of (opt). The values of the slopes ranging from 0.00 0.01 (NGC 1365) to -0.11 0.05 dex/kpc (NGC 598). This result indicates that, besides no radial positive gradient has been found, the existence of strong gradients of the hardening of the ionizing radiation in HII regions of spirals is not an universal property. Rather, it seems that a range of slope values can be de ned.

In Figure 3, we show the gradients that were derived using the m IR softness parameter. A lthough a rst im pression gives us a large number of observations in this spectral regime, the poorer quality of a major part of the data { mainly due to low signal-to-noise ratio of the [Siv] em ission

line in H II regions{, precludes this study in a high num ber of galaxies. The slopes of the linear ts and their errors are also listed in Table 2. As in the case of the optical parameter, we observe two m ain trends, with a pronounced gradient of the hardening of the radiation in some of the objects but a at one in some others, as in the case of the M ilky W ay

G alaxy. This behaviour we noted for our G alaxy was derived also by M orisset (2004) using ISO data. A qualitative agreem ent is seen between both param eters in those galaxies for which they can be m easured simultaneously. For instance, both param eters lead to pronounced gradients in M 101 and within the common radii of NGC 2403 (the inner 5 kpc have both optical and m IR param eters). On the contrary, both param eters point to a som ewhat at gradients in M 83. This agreem ent appears to reinforce the corresponding presence or absence of gradient in these galaxies. In the case of M 33 the agreem ent between both slopes seem s poorer, but still m arginally consistent. Unfortunately, given the lim itations expressed above for the m IR and the low er num ber of galaxies analized, along this discussion we w ill use the slopes derived from this param eter only in a qualitative way.

In order to try to understand the possible origin of the gradients derived for the ionizing SED of H II regions in spiral galaxies, we have studied the correlation between the strength of these gradients and the properties of the disc H II regions. In principle, one can expect that this relation could be driven by the existence of gradients of the m etallicity across the discs. Though m etallicity gradients have been derived for all these galaxies giving a range of slopes, we failed to nd a clear correlation between the slope of the m etallicity gradient (taken from Pilyugin et al 2004) and the corresponding slopes of the gradients of the ' parameter T his result does not exclude the possible correlation, within a given galaxy, between the softness parameter of H II regions and their individual abundances (e.g. V ilchez and P agel 1988; B resolin et al 2009); it is how ever clear that, at

the galaxy scale, the strength of the 'gradient seems not to be driven by the m etallicity gradient.

W e have explored possible driving mechanism s of this behaviour at the galaxy scale. A swe show in Figure 4 a signicative trend appears to be present between the slopes of the gradients of the hardening the ionizing radiation {obtained with the optical softness parameter{, and the rotation velocity of the corresponding discs (taken from Pilyugin et al., 2004). This means that the gradient is more pronounced in the slow rotation, less massive galaxies. This fact may be pointing to a link between the evolutionary status of the galaxy discs and the properties across them of the ionizing radiation produced by the massive stellar clusters. A hint in this direction can be seen in the right panel of Figure 4 where the slope of the 'gradient is shown versus the m orphological type of galaxies. A gain a trend is present in the gure, favouring stronger gradients for later type galaxies. In this respect, it is necessary to bear in m ind that the slopes of the gradients of the hardening of the ionizing radiation could be driven by the star form ation properties of the sam ples of H II regions (e.g. e ciency of star form ation) selected in the discs. Overall, this fact would imply that faint/low surface brightness and bright HII regions represent two fam ilies of objects that could relect dierent stellar tem perature behaviours across spiral discs. Thus, contrary to typical (bright) giant H II regions (m ore frequent in later types), low surface brightness H II regions probably rem ain less a ected by the star form ation conditions in the whole discs (see Helm boldt et al., 2009) . In turns, this latter kind of H II regions seem s m ore typical in earlier types. This m ay be the paradigm atic case of the M ilky W ay, whose at gradient is traced mainly by small H II regions.

In sum mary, the existence of radial gradients of the hardening of the radiation looks to be real and independently supported in some galaxies by the results coming from the optical and them IR, but its relation with the mechanism s governing star form ation across the discs using H II regions of di erent lum inosities must be further investigated.
