Vacuum uctuations and topological Casim ir e ect in Friedmann-Robertson-Walker cosmologies with compact dimensions

A bstract

We investigate the Wightm an function, the vacuum expectation values of the eld squared and the energy-momentum tensor for a massless scalar eld with general curvature coupling param eter in spatially at Friedmann-Robertson-Walker universes with an arbitrary num ber of toroidally compacti ed dimensions. The topological parts in the expectation values are explicitly extracted and in this way the renorm alization is reduced to that for the model with trivial topology. In the limit when the comoving lengths of the compact dimensions are very short compared to the Hubble length, the topological parts coincide with those for a conform all coupling and they are related to the corresponding quantities in the at spacetime by standard conform al transformation. This limit corresponds to the adiabatic approximation. In the opposite limit of large comoving lengths of the compact dimensions, in dependence of the curvature coupling param eter, two regimes are realized with monotonic or oscillatory behavior of the vacuum expectation values. In the monotonic regime and for nonconform ally and nonm inim ally coupled elds the vacuum stresses are isotropic and the equation of state for the topological parts in the energy density and pressures is of barotropic type. For conform aland m inim alcouplings the leading term s in the corresponding asymptotic expansions vanish and the vacuum stresses, in general, are anisotropic though the equation of state remains of barotropic type. In the oscillatory regime, the amplitude of the oscillations for the topological part in the expectation value of the eld squared can be either decreasing or increasing with time, whereas for the energy-momentum tensor the oscillations are dam ping. The lim its of validity of the adiabatic approxim ation are discussed.

1 Introduction

Friedm ann-R obertson-W alker (FRW) spacetimes are among the most popular backgrounds in gravitational physics. There are several reasons for this. First of all current observations give a strong motivation for the adoption of the cosm ological principle stating that at large scales the

Universe is hom ogeneous and isotropic and, hence, its large-scale structure is well described by the FRW metric. A nother motivation for the interest to FRW geometries is related to the high symmetry of these backgrounds. Due this symmetry numerous physical problems are exactly solvable and a better understanding of physical elects in FRW models could serve as a handle to deal with more complicated geometries. In particular, the investigation of quantum elects at the early stages of the cosm ological expansion has been a subject of study in many research papers (see, for example, [1, 2] and references therein). The originalmotivations in this research were mainly to avoid the initial singularity and to solve the initial conditions problem for the dynamics of the Universe. The further increase of the interest to this topic was related to the appearance of in ationary cosm ological scenarios [3]. During an in ationary epoch, quantum uctuations introduce inhom ogeneities and may a lect the transition toward the true vacuum. These uctuations provide a mechanism which explains the origin of the primordial density perturbation needed to explain the formation of the large-scale structure in the universe.

In many problem s we need to consider the physical model on the background of manifolds with compact spatial dimensions. In particular, the idea of compact extra dimensions has been extensively used in supergravity and superstring theories. From an in ationary point of view, universes with compact dimensions, under certain conditions, should be considered a rule rather than an exception [4]. The models of a compact universe with non-trivial topology may play in portant roles by providing proper initial conditions for in ation. The quantum creation of the universe having toroidal spatial topology is discussed in [5] and in references [6] within the fram ework of various supergravity theories. In the case of non-trivial topology, the boundary conditions in posed on quantum elds give rise to the modi cation of the spectrum for vacuum uctuations and, as a result, to the C asim ir-type contributions in the vacuum expectation values of physical observables (for the topological C asim in e ect and its role in cosm ology see [7, 8] and references therein). In the Kaluza-Klein-type models, the topological Casim ir e ect has been used as a stabilization mechanism for moduli elds which parametrize the size and the shape of the extra dimensions. Recently, the relevance of the Casim ir energy as a model for dark energy needed for the explanation of the present accelerated expansion of the universe has been pointed out (see [9] and references therein).

In most work on the topological C asim ir e ect in cosm ological backgrounds, the results for the corresponding static counterparts were used replacing the static length scales by com oving lengths in the cosm ological bulk. This procedure is valid in conform ally invariant situations or under the assumption of a quasi-adiabatic approximation. For non-conform all elds the calculations should be done directly within the fram ework of quantum eld theory on time-dependent backgrounds. In a series of recent papers we have considered the topological C asim ir e ect for a massive scalar eld with general curvature coupling [10] and for massive ferm ionic eld [11] in background of the de Sitter spacetime with toroidally compacti ed spatial dimensions. D ue to the high symmetry of the de Sitter spacetime in both cases the corresponding problem s are exactly soluble.

In the present paper we will consider another exactly soluble problem for the topological C asim ir e ect on background of a more general class of spacetimes. Namely, we investigate the vacuum expectation values of the eld squared and the energy-momentum tensor for a massless scalar eld with arbitrary curvature coupling parameter induced by the compactness of spatial dimensions in spatially at FRW universes where the scale factor is a power of the com oving time. The vacuum polarization and the particle creation in the FRW cosm ological models with trivial topology have been considered in a large number of papers (see [1, 2, 7] and references therein for early research and [12]-[23] and references therein for later developments). In particular, the vacuum expectation values of the eld squared and the energy-momentum tensor in models with power law scale factors have been discussed in [14, 15], [24]-[32] (see also [2]). The expectation

value of the eld squared is the crucial quantity in discussions of the topological mass generation as a result of one-loop quantum corrections and dynamical symmetry breaking. It also is of interest in considerations of phase transitions in the early universe, in particular, related to in ationary scenarios. In addition to describing the physical structure of the quantum eld at a given point, the expectation value of the energy-momentum tensor acts as the source of gravity in the Einstein equations. It therefore plays an important role in modelling a self-consistent dynamics involving the gravitational eld.

The present paper is organized as follows. In the next section we evaluate the positive-frequency W ightman function in spatially at FRW model with topology R^p (S¹)^q. By using the AbelP lana summation formula, we decompose this function into two parts: the rst one is the corresponding function in the geometry of the uncompactied FRW spacetime and the second one is induced by the compactness of the spatial dimensions. In section 3 we use the W ightman function for the evaluation of the vacuum expectation value of the eld squared. The asymptotic behavior of the topological part is investigated in the early and late stages of the cosm ological evolution. In section 4 we consider the vacuum expectation value of the energy-momentum tensor. The part in this expectation value corresponding to the uncompactied FRW model is well investigated in the literature and we are mainly concerned with the topological part. The special case of the model with a single compact dimension and the corresponding numerical results are discussed in section 5. The main results of the paper are summarized in Section 6.

2 Wightman function

We consider a scalar eld with curvature coupling parameter evolving on background of the (D + 1)-dimensional spatially at FRW spacetime with power law scale factor. Such a eld is described by the equation

where r₁ denotes the covariant derivative and R is the curvature scalar of the background spacetime. For the most important special cases of minimally and conformally coupled elds one has the values of the curvature coupling parameter = 0 and = $_{\rm D}$ (D 1)=4D respectively. The spatially at FRW line element expressed in comoving time coordinate is

From the (D + 1)-dimensional Einstein equations we not the energy density and the pressure p for the source of the metric corresponding to (2):

where G is the (D + 1)-dimensional gravitational constant. The corresponding equation of state has the form $p = [2=(cD) \ 1]$. In the special case

the equation of state is of the radiation type and the R icci scalar vanishes. The case c = 2=D corresponds to the dust-m atter driven m odels. Note that the line element (2) with c > 1 describes

the power law [33] and extended [34] in ationary models. Such a power law expansion may be realized if a scalar eld with an exponential potential V () = e dominates the energy density of the universe. The corresponding cosm ological models admit power law in ationary solutions of the form (2) (see, for instance, [35]) with c = 4 ²=(D 1). Solutions having power law scale factor with c = 2 (n 1) (2n 1)=(D 2n) arise in higher-order gravity theories with the Lagrangian Rⁿ [36].

For the further discussion, in addition to the synchronous time coordinate t it is convenient to introduce the conformal time in accordance with dt = a(t)d or

Here we assume that $c \in 1$. In the case c = 1 one has $t = t_0 e_{-}$, with a constant t_0 , and this case should be considered separately. In terms of the conform altime the line element takes the form :

which is manifestly conformal to the M inkowski spacetime. Note that one has 0.6 < 1 for 0 < c < 1 and 1 < 6.0 for c > 1.

W e will assume that the spatial coordinates z^1 , l = p + 1;:::;D, are compactified to S^1 : 0 6 z^1 6 L_1 , and for the other coordinates we have 1 6 z^1 6 +1, l = 1;:::;p. Hence, we consider the spatial topology R^p (S^1)^q with p + q = D. For p = 0, as a special case we obtain the toroidally compactified FRW spacetime. A long the compact dimensions we will consider the boundary conditions

where $z_p = (z^1; ...; z^p)$, $z_q = (z^{p+1}; ...; z^p)$, and e_1 , l = p + 1; ...; D, is the unit vector along the direction z^1 . In (8) we have introduced phases with constants 0.6 $_1$ 6 1. The special cases $_1 = 0$ and $_1 = 1=2$ correspond to periodic and antiperiodic boundary conditions. The corresponding elds are also called as untwisted and twisted ones.

Am ong the most important characteristics of the vacuum state are the vacuum expectation values (VEVs) for the eld squared and the energy-momentum tensor. These VEVs are obtained from the W ightman function and its derivatives in the coincidence limit of the arguments. For the topology under consideration we will denote this function by $G_{p/q}^+(x;x^0)$. The W ightman function is also important in the consideration of the response of particle detectors (see, for instance, [1]). Let f'(x);'(x)g be a complete set of solutions to the classical eld equation satisfying the periodicity conditions (8) and is a set of quantum numbers specifying the solution. The W ightman function may be evaluated by using the mode-sum form ula

where jDi is the amplitude for the vacuum state under consideration.

In accordance with the sym m etry of the problem the mode solutions of the eld equation are separable: ' (x) = () $e^{ik_p \ g+ik_q} \notin$, where $k_p = (k_1; k_2; \ldots; k_p)$ and $k_q = (k_{p+1}; k_{p+2}; \ldots; k_p)$. For the components of the wave vector along the uncompacti ed directions we have 1 < $k_1 < 1$, $l = 1; 2; \ldots; p$. The components along the compact dimensions are quantized by the periodicity conditions (8) and for the corresponding eigenvalues we have

From the eld equation (1) we obtain an ordinary di erential equation for the function ():

For a massless scalar eld, m = 0, the general solution of this equation is expressed in terms of a combination of H ankel functions:

Note that is either real and nonnegative or pure in aginary. For a conform ally coupled eld we have = 1=2 and for a m inim ally coupled eld = jbj. Dierent choices of the coe cients in (13) correspond to dierent vacuum states. We will consider the Bunch-Davies vacuum [26] for which $c_1 = 0$. With this choice, in the limit c! 0 we recover the standard vacuum in the M inkowski spacetime associated with the modes k $^{1=2} \exp(ik_p pr + ik_q qr)$.

The corresponding eigenfunctions satisfying the periodicity conditions take the form

In the case p = 0, q = D (topology $(S^1)^D$) and $_1 = 0$, l = 1; :::; D, there is also a norm alizable zero mode with $k_D = 0$ which is independent of the spatial coordinates (for the discussion of zero modes in topologically nontrivial spaces see [37]). The corresponding eigenfunction has the form $'_0() = {}^b(c_{10} + c_{20})$. From the norm alization condition we have the relation $c_{10}c_{20} = q_0c_{20} = isign() = (2 V_D)$ for real and the relation $j_{20}f$ $j_{10}f$ = sign() = (2 $j_D V_D$) for in aginary . These form use give a relation between the coefficients c_{10} and c_{20} and one of them remains undetermined. This arbitrariness arises because of freedom to choose the quantum state [37]. In the discussion below we will consider the contribution to the VEVs from the nonzero modes. If the zero mode is present, its contribution should be added separately.

Substituting the eigenfunctions (16) with the normalization ∞e cient (18) into the modesum formula for the W ightman function, one nds

In form ula (20), for the further convenience, we have written the H ankel function in term s of the m odi ed Bessel function. For a scalar eld with periodic boundary conditions along compact dimensions ($_1 = 0$) and for Re > p=2 the integral in (20) has an infrared divergence at $k_p = 0$ com ing from the modes $n_q = 0$. In this case the Bunch-D avies vacuum is well de ned only if Re < p=2. For the case p = 0 and $_1 = 0$, in (20) $n_q = n_D \in 0$ and the contribution of the additional zero m ode should be added.

W e apply to the sum over n_{p+1} in (20) the AbelP lana type sum mation form ula

This form ula is obtained by combining the summation form ulae given in [38]. After the application of this form ula, the term in the expression of the W ightman function with the rst integral on the right of (22) corresponds to the W ightman function in the FRW modelwith p+1 uncompactified and q 1 toroidally compactified dimensions, $G_{p+1,q-1}^+(x;x^0)$. As a result one nds the recurrence form ula

In the special case D = 3 and = 0 the form ula (29) coincides with the result given in [26] (with the m isoprint in the coe cient corrected, see also [1]). Shifting the time coordinate t! t+ ct₀, with a constant t₀ and taking the limit c ! 1 for xed t and t₀, from (2) we obtain the corresponding line element in de Sitter spacetime with the scale factor $a(t) = e^{t=t_0}$. In this limit the expression (30) tends to t_0^{1-D} and from (29) we recover the expression for the W ightman function in (D + 1)-dimensional de Sitter spacetime.

3 VEV of the eld squared

The VEV of the eld squared in FRW model with topology \mathbb{R}^p (S¹)^q is obtained from the two-point function $G_{p,q}^+(x;x^0)$ taking the coincidence limit of the arguments. In this limit the W ightman function diverges and a renormalization procedure is necessary. The crucial is that under the toroidal compactication the local geometry is not changed and the divergences are contained in the part corresponding to the uncompactied FRW spacetime. As we have already extracted this part, the renormalization is reduced to that in the uncompactied FRW model which is well investigated in the literature (see for example [1, 2] and references given therein). For the VEV of the eld squared we have the recurrence formula

The expression for h' ${}^{2}i_{p,q}^{(t,M)}$ is directly obtained from (36) and is valid for arbitrary values of the curvature coupling parameter

. Note that we have = 1=2 in the general case of the curvature coupling parameter for the power law expansion with c = 2 = (D + 1) which corresponds to radiation driven models. In this case the topological part of the VEV is given by formula (36) with b = 1=2 and $A = {D - 1}(D + 1)^2 = (D - 1)^2$.

Now we turn to the investigation of the topological part $_{p+1}h'^{2}i_{p,q}$ in the VEV of the eld squared in the asymptotic regions of the ratio $L_{p+1}=$. For small values of this ratio, $L_{p+1}=$ 1, we introduce the new integration variable $y = L_{p+1}x$. By taking into account

that for large values x one has [I (x) + I (x)]K (x) = x, we derive that to the leading order $p_{+1}h'^{2}i_{p,q}$ coincides with the corresponding result for a conform ally coupled massless eld:

Note that, by taking into account (35), the condition $L_{p+1}=-1$ can also be written in the form $L_{p+1}^{(c)}=r_{H}$. Hence, the asymptotic form ula (37) corresponds to small proper lengths of compact dimensions compared with the Hubble length. The expression on the right hand side of (37) is obtained from the corresponding expression in M inkowski spacetime with the topology $R^{p} = (S^{1})^{q}$ and with the lengths of the compact dimensions L_{p+1} ;:::; L_{D} , replacing L_{1} by the com oving lengths $L_{1}^{(c)}$. Hence, (37) corresponds to the adiabatic approximation. In this regime the topological part m onotonically decreases with increasing scale factor.

In the opposite lim it of large values for the ratio $L_{p+1}=$, the behavior of the topological part is qualitatively di erent for real and in aginary values of the parameter . For positive values

, by using the asymptotic formulae for the modi ed Bessel functions for small values of the arguments, to the leading order we nd

Note that for 0 < c < 1=D and < 0 one has b > and the topological part in the expectation value of \prime^{2} increases with increasing com oving time t. For a minimally coupled scalar eld and for c < 0; 1=D) [(1;1) one has = b, and in the limit under consideration the VEV tends to nite nonzero value. In the case = 0 the corresponding asymptotic form ula is obtained from (38) replacing ()! 4 ln ($L_{p+1} =$) and after substituting = 0. The limit under consideration corresponds to large com oving length of the com pact dimension com pared to the Hubble length: $L_{p+1}^{(c)} r_{H}$.

Hence, the behaviour of the topological part in the VEV for the eld squared is oscillatory in the early (late) stages of the cosm ological expansion for 0 < c < 1 (c > 1). The amplitude of these oscillations behaves like $t^{1 \ cD}$ and the distance between the nearest zeros linearly increases with increasing t. Note that for 0 < c < 1=D the oscillation amplitude increases with time.

From the asymptotic analysis given above it follows that in the special case of a minimally coupled eld the topological part $_{p+1}h'^{2}i_{p,q}$ tends to nite nonzero value at early stages of the cosm ological expansion when 0 < c < 1=D. At late (early) stages and for c < 1 (c > 1) the topological part behaves like $t^{(1 D)c}$. At early times and for 1=D < c < 1 one has $_{p+1}h'^{2}i_{p,q} / t^{2(1 D)}$.

4 VEV of the energy-m om entum tensor

Having the W ightm an function and the VEV of the eld squared, the expectation value of the energy-m om entum tensor is evaluated with the help of the form ula

In Eq. (42) we have used the expression of the metric energy-momentum tensor for a scalar eld which diers from the standard one (see, for example, [1]) by the term vanishing on the solutions of the eld equation [41]. The topological part in the VEV of the energy-momentum tensor is obtained substituting (23) and (31) into formula (42). In this calculation we need the covariant d'A lembertian acted on the topological part of the eld squared:

Recall that the ratios in the arguments of these functions may also be written in the form (35).

The expressions for the VEV of the energy-m om entum tensor are further simplied for a conformally coupled scalar eld. In this case, after some calculations we nd (no sum mation over i):

This result is also obtained from the corresponding formulae in the toroidally compactied M inkowski spacetime by using the standard relation for the VEVs in conformally related problems. Formula (54) for a conformally coupled eld holds for any conformally at bulk with general scale factor (). As we see, for a conformally coupled eld the stresses along the uncompactied dimensions are equal to the vacuum energy density.

In the special case of power law expansion with c = 2 = (D + 2) and for general we again have = 1=2. A fiber the integration over y, in this case we nd

For small values of this ratio the arguments of the modied Bessel functions in the expressions for the VEV of the energy-momentum tensor are large. In the leading order we have $F^{(0)}(z) = \frac{2^{b-1}}{z^{b-1}}$ and to this order the rst term in the square brackets in the expression (49) for the vacuum stresses does no contribute. The integral over y is explicitly evaluated and we nd

The limit under consideration corresponds to late times of the cosm ological expansion (t ! 1) for c > 1 and to early times (t ! 0) for 0 < c < 1, or alternatively, to large comoving length of the compact dimension in units of the Hubble length: $L_{p+1}^{(c)} = r_H$ 1. Note that the coe cient in (58) does not depend on p and, hence, similar relation takes place between the total topological parts in the VEVs of the eld squared and the energy-m om entum tensor (given by formulae (34) and (53)). At early stages, t! 0, we have $hT_{i}^{ii}i_{pq}^{(t)}$ / t 2c for 0 < c < 1=D and $hT_{i}^{ii}i_{pq}^{(t)}$ / t $^{2D\ c}$ for $1=D\ < c < 1$. In the models with c > 1 and at late stages of the cosm ological expansion the topological part decays like t 2c . At early stages and for c > 1 one has $hT_{i}^{ii}i_{pq}^{(t)}$ / t $^{(D\ +1)c}$.

5 Special case and num erical exam ples

As an application of the general form use given above let us consider the special case of topology $R^{D-1} = S^1$. For this case the expression for the topological part in the VEV of the eld squared takes the form

Form ula (66) describes the asymptotic behavior of the VEV in the general case of in early stages of the cosm ological expansion (t ! 0) for c > 1 and at late stages (t ! 1) for 0 < c < 1. In the opposite limit of late times (t ! 1) for c > 1 and early times (t ! 0) for 0 < c < 1, for positive values of , the asymptotic behavior is given by the expression

Note that in this expression L_D is the comoving length of the compact dimension. For in aginary values of we have the asymptotic described by the relation (63). In particular, in the models of power law in ation (c>1) we have h' ${}^{2}i_{D}^{(t)}_{1,1} / t^{(1 D)c}$ at early times. At late times the topological part behaves monotonically as $t^{2(b)}$ (1 c) in the case of positive and oscillatory like $t^{1 CD} \cos[2j](c 1) \ln t + const]$ for in aginary values of . In the latter case the distance between the nearest zeros linearly increases with increasing t.

Note that the ratio $h'^{2}i_{D}^{(t)}_{1;1}=h'^{2}i_{D}^{(t,c)}_{1;1}$, with $h'^{2}i_{D}^{(t,c)}_{1;1}$ being the VEV for a conformally coupled eld given by (66), is a function of L_{D} = alone and depends on the parameters and c through . In gure 1, we have plotted this ratio as a function of L = , with $L = L_{D}$ being the length of the compact dimension, for untwisted D = 3 scalar eld ($_{D}$ = 0) and for various values of the parameter (numbers near the curves). In this special case one has

 $h'^2 i_{D_{1,1}}^{(t,c)} = 1 = [12 (L_D)^2]$. Note that the ratio L = is related to the com oving length of the com pact dimension, measured in units of the Hubble length, by Eq. (35). Figure 1 clearly shows that the adiabatic approximation for the topological part is valid only for small values of the ratio L $^{(c)}=r_H$.

In the special case under consideration, for the topological part in the VEV of the energy-m om entum tensor we have the following representation (no sum mation over i)

where $F^{(0)}(y)$ is defined by (48), $f_D^{(0)}(x) = 0$, and $F^{(i)}(y) = F(y)$ for i = 1; ...; D. The functions $f_D^{(i)}(x)$ for i = 1; ...; D are given by expressions (50). For a conformally coupled eld we have (no sum mation over i = 0; 1; ...; D 1)

Form ula (69) describes the asymptotic behavior of the VEV for the general case of the curvature coupling parameter in the lim it $L_D = 1$. In the opposite lim it the corresponding asymptotic form ulae directly follow from the expressions (58) and (63) for real and in aginary respectively. The form ulae are simplied in the case c = 2 = (D + 1) for general curvature coupling parameter (no sum mation over i):

where $g_i = 1$ for i = 0; 1; ...; D 1, $g_j = D$ and f_i is de ned after formula (56).

In order to see the relative contributions of separate terms in the VEV of the energymomentum tensor, in gure 2 we have plotted the ratio $hT_{i}^{ij} i_{D}^{(t)}_{1;1} = hT_{0}^{0} i_{FRW}$ in the radiation driven model (c = 2=(D + 1)) for D = 3 m inim ally coupled untwisted (left panel) and twisted (right panel) scalar elds versus =L with L = L_D being the length of the compact dimension. Here, $hT_{0}^{0} i_{FRW} = 1 = [480 \ ^{2} (2t)^{4}]$ is the vacuum energy density for a massless m inim ally coupled scalar eld in the corresponding FRW model with trivial topology. Note that for the special case under consideration one has = (2=)t^{1=2}. In the same model and for a conform ally coupled scalar elds we have (no sum mation over i = 1;2)

where C = 1=90 and C = 7=720 for untwisted and twisted elds respectively.

Now let us estimate the relative contributions of dimensions of dimensions in the total energy density for the D = 3 radiation dominated model. Introducing the Planck mass M $_{\rm P}^2 = 1$ =G and the Planck time t_P, for the energy density being the source of the background metric one has $M_{\rm P}^4 = (t=t_{\rm P})^2$. The average vacuum energy density in FRW model with trivial topology is estimated as $hT_0^0 i_{\rm FRW}$ $M_{\rm P}^4 = (t=t_{\rm P})^4$. For the topological part in the vacuum energy density in the case of the conformally coupled eld we have $hT_0^0 i_{\rm conf}^{(t)}$ $M_{\rm P}^4 = (L^{(c)} = l_{\rm P})^4$, where $L^{(c)} = a(t)L$ is the comoving length of the compact dimension and $l_{\rm P}$ is the Planck length. For a minimally coupled eld one has $hT_0^0 i_{\rm min}^{(t)}$ $hT_0^0 i_{\rm conf}^{(t)}$ [L + const $(f^{\rm C}) = t)^2$]. From these relations, for the ratios of the separate parts in the vacuum energy density to the source term we nd

where r_H is the Hubble length. From these relations we conclude that the term $hT_0^0 i_{FRW}$ is comparable to the source term only near the Planck time. The topological part dom inates the part $hT_0^0 i_{FRW}$ when $L^{(c)} < r_H$ and becomes of the order of the source term for $L^{(c)2} \downarrow r_H$. In the latter case the backreaction of quantum topological elects should be taken into account.

6 Conclusion

In the present paper we have investigated one-loop quantum e ects for a scalar eld with general curvature coupling, induced by toroidal com pactication of spatial dimensions in spatially at FRW cosm ological models with power law scale factor. We treat gravity as a given classical background eld and do not consider the backreaction of the quantum e ects on the metric. General boundary conditions with arbitrary phases are considered along compact dimensions. As special cases they include periodicity and antiperiodicity conditions corresponding to untwisted and twisted elds. The boundary conditions in posed on possible eld con gurations change the spectrum of vacuum uctuations and lead to the Casim ir-type contributions in the VEVs of physical observables. A m ong the m ost im portant characteristics of the vacuum state are the expectation values of the eld squared and the energy-m om entum tensor. Though the corresponding operators are local, due to the global nature of the vacuum these VEVs carry an in portant information on the global structure of the background spacetime. As the rst step we evaluate the positive-frequency W ightm an function. By using the Abel-P lana sum mation form ula, we have derived recurrence relation connecting the W ightm an functions for the topolo- $(S^1)^q$ and R^{p+1} $(S^{1})^{q-1}$. The repeating application of this relation allows to present qies R ^p the W ightm an function as the sum of the function for topologically trivial FRW m odel and the topological part. The latter is nite in the coincidence lim it and in this way the renorm alization of the VEVs for the eld squared and the energy-m om entum tensor is reduced to that for the FRW universe with trivial topology. The latter problem is well investigated in the literature and we concentrate on the topological parts.

The topological parts are given by form ulae (33) and (34) for the eld squared and by form ulae (47), (49), (53) for the energy density and the stresses. In the case of a conform ally coupled scalar eld the problem is conform ally related to the corresponding problem in at spacetime with topology R^{p} (S¹)^q and the general form ulae are simplied to (36) and (54) for the eld squared and the energy-momentum tensor respectively. These form ulae describe the asymptotic behavior of the VEVs in the general case of the curvature coupling in the limit L_{1} = 1. In this limit the com oving lengths of the com pact dimensions measured in units of the Hubble length are smalland it corresponds to early stages of the cosm ological expansion for 0 < c < 1 and to late stages of the cosm ological expansion when c > 1. The topological parts in the VEVs behave like $h'^{2}i_{p,q}^{(t)} / t^{c(1 D)}$ and $hT_{1}^{k}i_{p,q}^{(t)} / t^{c(1+D)}$ and the stresses along the uncom pact i ed dimensions are equal to the vacuum energy density.

In the opposite $\lim it L_1 =$ 1, corresponding to large com oving lengths of com pact dimensions compared to the Hubble length, the behaviour of the VEVs is qualitatively di erent for real and in aginary values of the parameter de ned by Eq. (15). For real values, the asymptotics are given by formulae (38) and (58) and the topological parts in the VEVs behave as $h'^{2}i_{p,q}^{(t)} / t^{2(c-1)} = cD + 1$ and $h\Gamma_{1}^{k}i_{p,q}^{(t)} / t^{2(c-1)} = cD - 1$. In this lim it the vacuum stresses are isotropic and the equation of state for the topological parts in the vacuum energy density and pressures is of the barotropic type. For a minimally coupled scalar eld in the case c = (0; 1=D) [(1; 1) and for a conformally coupled eld, the leading terms in the asymptotic expansions for the VEV of the energy-momentum tensor vanish. The corresponding asymptotics are given by $hT_1^{k}i_{p,q}^{(t)} / t^{c(1+D)}$ for conform ally coupled eld and by $hT_1^{k}i_{p,q}^{(t)} / t^{2c}$ for a minimally coupled eld in the model with c2 (0;1=D) [(1;1) (see form ulae (61) and (62)). In these special cases the vacuum stresses are anisotropic though the equation of state remains of the barotropic type with the coe cients depending on the lengths of compact dimensions. In 1 and for in aginary values of the parameter the asymptotic behaviour of the $\lim it L_1 =$ the topological parts is described by the form ulae (40) and (63) and this behaviour is oscillatory with the oscillating factor in the form $\cos[2j]$ (c 1) ln (t=5) +]. For the eld squared the

am plitude of the oscillations behaves as t^{1-cD} . For the energy-m om entum tensor the am plitude of the oscillations decreases like t c^{D-1} and the oscillations are dam ping for all values of the parameter c.

The general results for the VEVs of the eld squared and the energy-m om entum tensor are specied in section 5 for the case of a model with a single compact dimension. By numerical examples for this case we have illustrated that the adiabatic approximation for nonconformally coupled elds is valid only in the limit when the comoving length of the compact dimension is very short compared to the Hubble length. We have also estimated the relative contributions of various sources in the total energy density. In particular, in the radiation driven model, for the comoving lengths L ^(c). $\downarrow_{\rm P} r_{\rm H}$ the topological part of the energy density becomes of the order of the source term and the backreaction of quantum elects should be taken into account.

In this paper we have considered the case of a massless eld when the equation (11) for the mode functions is exactly integrable in the class of special functions. By using this equation, we can estimate the role of e ects due to the nonzero mass of the eld. The ratio of the rst and second terms in gure braces of (11) is of the order $m^{2}t^{2}$. Hence, for m t 1 the e ects related to the nonzero mass may be disregarded and the results described in the present paper are applicable for massive elds as well.
