Star Cluster D issolution in A rp 284

A bstract. We present results from a study of proto-globular cluster candidates in the interacting galaxy system A rp 284 (NGC 7714/5). Studies of the Antennae and M 51 have suggested that the majority of these star clusters dissolve within 20 M yr due to mass loss. We obtain cluster colors using archival HST data, and estimate ages and extinctions for over 150 clusters using evolutionary synthesis models. We not that clusters in NGC 7714 are generally less than 20 M yr old, while the data in the bridge is too limited to allow good estimates for individual clusters. We also examine H ii region com plexes with lower-resolution GALEX and ground-based H images. Several of these regions appear to be much older than the detected clusters within them, which may indicate the presence of an older, unresolved population of low mass or dispersed clusters.

1 Introduction

The study of extragalactic star clusters has bene ted trem endously from the high resolution of the H ubble Space Telescope. In interacting systems, where star clusters are particularly abundant, it is possible to study the dem ographics of cluster populations. Such studies have revealed an overabundance of young clusters in the Antennae (Fall, Chandar, & W hitm ore 2005) and M 51 (Bastian et al. 2005), suggesting that clusters tend to dissolve due to m ass loss after 20 M yr (Bastian & Goodw in 2006; Goodw in & Bastian 2006), an elect known as infant m ortality.

In this study, we exam ine A pp 284 (NGC 7714/5), an interacting system at a distance of 38:6 2:7 M pc ($1^{00} = 190$ pc; NED). The system features several tidal environments that host ongoing star formation, including the starburst nucleus of NGC 7714, three tidal tails, and a two-component bridge. An old stellar ring in NGC 7714 and the post-starburst nucleus of NGC 7715 (Bernlohr 1993) are no longer star-forming. M ore about the A pp 284 interaction m ay be found in the models of Struck & Sm ith (2003).

We use high-resolution HST data to study the star clusters and lower-resolution data from the Galaxy Evolution Explorer (GALEX) and ground-based

H to study the giant H ii regions in which these clusters are found. A more detailed description of this project, including m id- \mathbb{R} data from Spitzer and X-ray data from Chandra, may be found in Peterson et al. (2009).

2 Data and Analysis

The HST archives have in ages of A rp 284 taken with the W ide Field and P lanetary C am era 2 (W FPC2) in four broadband lters. There are four in ages in F380W, two in F555W, one in F606W, and four in F814W. The observations do not provide uniform coverage of the system.

The ground-based H data were obtained using the 1.8 m Perkins Telescope of the O hio State University (Sm ith, Struck, & Pogge 1997). The GALEX data include a 4736 s exposure in the FUV (1516 A) and 520 s in the NUV (2267 A) bands.

C lusters were selected using the $IRAF^1$ task dao nd, while aperture photom etry was perform ed using the phot task. The colors in the HST lters were then t by ² m inimization to models from the Starburst99 (Leitherer et al. 1999; V azquez & Leitherer 2005) evolutionary synthesis code, giving an estimate of the age and extinction for each cluster. All clusters was assumed to have form ed in a single, instantaneous burst of star form ation with a K roupa (2002) initialm ass function. M odels with m etallicities of both 0.2Z and 0.4Z were t. These abundances correspond to those m easured in parts of the NGC 7714 disk by G onzalez D elgado et al. (1995).

The giant H ii regions (labeled A –I) were measured in the 4 HST bands, 2 GALEX bands, and H . The analysis was the same as for the HST clusters, except that continuous star form ation models were also t. The apertures for these regions are shown in Figure 1.

3 Cluster Ages

The clusters in the tidal features of NGC 7714 are generally found to be young, with only 8 of 124 signi cantly older than 20 M yr. In contrast, the bridge appears to host an older cluster population, with nearly 50% of the clusters older than 100 M yr. This is apparent in Figure 2, which plots the lum inosity of each cluster against its age for the 0.22 m odel, with NGC 7714 clusters drawn as open circles and bridge clusters as asterisks. The di erence between the populations is striking, but it should be noted that the ages in the bridge are m ore uncertain due to poorer coverage, higher photom etric uncertainties, and the lack of m etallicity data. New observations will be required to better determ ine the ages of the bridge clusters. If the older population is con m ed, it will be strong evidence that infant m ortality has acted m ore weakly in the bridge than within the NGC 7714 disk and m ay suggest that environm ental in uences on early-stage cluster disruption are m ore in portant than presently believed.

C on mation of infant mortality in A np 284 is complicated by evolutionary fading. Clusters become dimmer as they age, so that only high mass clusters are detected at high ages. The completeness of a lum inosity-limited sample is therefore also a function of the cluster ages. The curves in Figure 2 show the

lum inosity as a function of age for clusters with m asses 10^4 , 10^5 , and 5, 10^5 M, while the dashed line is our completeness lim it. Only the most massive clusters remain above our completeness lim it after 100 M yr.

Due to the e ects of evolutionary fading, our sample may be incomplete for older clusters, so the apparent e ects of infant mortality in the system need con mation.

4 H ii R egion A ges

The age estimates for the H ii regions were determined using Starburst99 both by color thing of the HST and GALEX data and by the H equivalent widths. The EW (H) ages for the H ii regions were generally quite young (< 15 M yr) and in good agreement with the median age of clusters found in the regions for those regions with more than a few clusters (A, B, D, and F), and were also in agreement with the ages determined spectroscopically by previous authors (G arc a-Vargas et al.1997; G onzalez D elgado et al. 1995, 1999).

The color-based age estimates for regions B, D, and F were > 100 M yr, signi cantly older than the median cluster ages, likely indicating a signi cant contribution from unresolved sources. These may be older clusters too faint to be detected or the remnants of a previous generation of clusters that has already dissolved.
