# A Spitzer Census of Star Form ation Activity in the Pipe Nebula

# ABSTRACT

The Pipe Nebula, a large nearby molecular cloud lacks obvious signposts of star form ation in all but one of more than 130 dust extinction cores that have been identied within it. In order to quantitatively determ ine the current level of star form ation activity in the Pipe Nebula, we analyzed 13 square degrees of sensitive mid-infrared maps of the entire cloud, obtained with the Multiband Imaging Photom eter for Spitzer (MIPS) at wavelengths of 24 m and 70 m to search for candidate Y oung Stellar O bjects (YSO s) in the high-extinction regions. We argue that our search is complete for class I and typical class II YSO s with luminosities of  $L_{bol}$  0.2 L and greater. We nd only 18 candidate YSO s in the high-extinction regions of the entire Pipe cloud. Twelve of these sources are previously known mem bers of a small cluster associated with B amard 59, the largest and most massive dense core in the cloud. With only six candidate class I and class II YSO s detected towards extinction cores outside of this cluster, our notings emphatically con m the notion of an extrem ely low level of star form ation activity in the Pipe Nebula. The resulting star form ation e ciency for the entire cloud mass is only 0.06%.

#### 1. Introduction

The most critical but least understood aspects of the star formation process concern its initial conditions and earliest stages. In particular, little is known about the initial phases of protostellar development within dense molecular cloud cores and even less is known about the origin of the dense cores them selves. This is largely due to an apparent absence of nearby (d < 2.5 kpc) massive  $(> 10^4 \text{ M})$  m olecular clouds in a su ciently early evolutionary state so that little or no star form ation activity is present within them. This is then taken as evidence that the onset of star form ation in molecular clouds is extrem ely rapid and that clouds in the earliest evolutionary states must be exceedingly rare. C learly the identi cation and detailed study of such clouds provides invaluable inform ation about the earliest phases of star for-

m ation .

W ith a m ass of  $10^4$  M and a distance of 130 pc (Lom bardiet al. 2006), the Pipe Nebula is one of the massive clouds nearest to the Sun and yet has received little attention and has only been studied in detail within the last few years. With the exception of Barnard 59, the region is lacking the m ost obvious signposts of star form ation, such as bright H II regions, re ection nebulae, lum inous infrared sources and large populations of emissionline stars and m ay be a prim e exam ple of a m olecular cloud in an early stage of evolutionary developm ent. As such, it constitutes a critical laboratory for star form ation studies (for a review, see A lves et al. 2008b). The rst wide-area study of the region consisted of CO m apping carried out by Onishiet al. (1999) who identied 14  $\rm C^{18}O$  cores in a large low-resolution and undersampled map. Subsequently, Lom bardiet al. (2006) presented a high-resolution completely sampled dust extinction m ap (based on 2M ASS near-infrared data) to study general properties of the cloud. This extinction m ap was also used to study its dense core population: A lyes et al. (2007) identi ed a population of roughly 150 extinction cores and found that the shape of the core mass function (CMF) is nearly identical to the stellar initial mass function  $(\mathbb{M} F)$ , but shifted to higher masses by a factor of three, suggesting that the CMF is a direct evolutionary precursor to the stellar IM F. Most recently, Rathborne et al. (2009) have further re ned the core identi cation by taking into account additionalm easurem ents of C<sup>18</sup>O strength and velocity towards single cores as indicators of dense material and cloud membership. Their list contains 134 dense cores in the Pipe Nebula. To more reliably detect the extinction peaks, R athbome et al. (2009) have used a background-subtracted version of the near-infrared extinction m ap, produced by

Itering out structures surpassing a given size (see also A lyes et al. 2007). Note that in the following, we we will generally refer to this backgroundsubtracted m ap as the extinction m ap, except as otherwise noted.

The only previously known region of active star formation in the Pipe Nebula is the dark cloud Barnard 59 (B 59, Barnard 1927). Early studies found indications of ongoing star form ation in B 59: H emission line stars (Herbig 2005, and references therein), a millimeter continuum source (Reipurth et al. 1996), and a CO out ow (O nishi et al. 1999). M ore recently, Spitzer observations revealed a young cluster inside of B 59 (Brooke et al. 2007). Riaz et al. (2009) studied the cluster's most deeply embedded object, [BHB2007] 11, in m ore detail. In order to quantify the star form ation activity for the whole cloud com plex, we present a m id-infrared survey carried out with the Multiband Im aging Photom eter for Spitzer (M IPS) as well as with the Infrared Array C am era (IRAC), both onboard the Spitzer Space Telescope.

#### 2. Observations and D ata R eduction

W e present large-area m apping observations of the Pipe Nebula, carried out with Spitzer-MIPS (Rieke et al. 2004), at wavelengths of 24 m and 70 m. The observations were obtained between April 2004 and October 2006. The data consist of 44 A stronom ical O bservation R equests (A O R s). They com e from three di erent program s: the Cycle 1 G T O observations of B 68 (Program Identi cation PID 53, 1 A O R), six m ipsphot observations from Legacy observations (PID 139, c2d) and 35 mipsscan as well as 3 mipsphot maps from the Cycle 2 G O Pipe C loud Survey (P ID 20119). W e use Spitzer-IRAC data that were mostly collected as part of program PID 20119, but also as programsPD 139 and PD 30570. The observations were designed to cover the most highly extincted regions of the Pipe Nebula. In total, the 24 m data cover an area of 13.4 square degrees, with the 70 m data covering a very similar area (to within 2응).

The data reduction was performed with the MOPEX software package, v181.5<sup>1</sup>. The 24 m data were self-calibrated by dividing each Basic Calibrated Data (BCD) in age with a at eld created by stacking all the BCDs in an AOR. All MIPS BCDs were from release S16. Self calibrations in this way removes large scale sky variations and some articats. The at eld pl tool provided as part of MOPEX. Brie y, the BCD stack aremedian litered in order to detect sources, mask bright sources, and then median stack the original frames into a at, clipping out the bright sources. No overlap correction was applied to the

24 m data since at elding appeared to be su cient. The AORs were individually processed into m osaics to preserve the two-epoch nature of most of the 24 m data, allowing the rejection of asteroids in the nal source catalog. The mosaicking produced im ages with a nalpixel size of  $2.5^{\circ\circ}$ and included steps to mask faulty bits and reject outliers. No self-calibration or overlap corrections were applied to the 70 m BCDs where we work with the median-litered (fbcd) frames produced by the Spitzer Science Center pipeline process. The pixel size at 70 m is  $4^{\circ\circ}$ .

Source detection was performed on the individual 24 m mosaics, using MOPEX multi-frame PRF-tting photometry. Given the Pipe Nebula's location close to the ecliptic and thus an increased probability to detect asteroids, we required source detections in both of the two observation epochs, if two observing epochs were available. The concatenated list of source detections contains nearly 80000 sources above a signal-to-noise ratio of four. In contrast, the 70 m map mostly has only singleepoch coverage. Source detection was carried out on a single, large map produced from the medianltered BCD les. In this map, a total of 5308

sources were detected above a signal-to-noise ratio of four. A cross-correlation of the two lists with a search radius of  $4^{00}$  yields a list of 546 sources detected in both M IPS bands.

For the identi ed candidate Y SO s, we obtained Spitzer-IRAC m id-infrared aperture photom etry from corresponding post-basic calibrated data (PBCD) sets for use in the tting of their spectral energy distributions (SED s), allowing a photom etric accuracy of 10%. Post-BCD mosaics from the Spitzer Science Center (pipeline S14) were used without modi cation. A perture radii used were either two or three pixels (the form er only for sources 22 and 24 to exclude neighboring sources), with a pixel size of  $1.2^{00}$  and the corresponding aperture corrections. In a few cases, this required the use of a tool<sup>2</sup> to rectify saturated sources.

W hile we processed and analyzed the crowded young cluster region Barnard 59 in the same way as all other data, we make use of the IRAC and M IPS photom etry from Brooke et al. (2007) for two reasons: rst, the crowding is especially problem atic in the M IPS data that we use for source detection, causing us to m iss a few sources. However, no comparable crowding occurs in the entire remaining areas in the Pipe Nebula. Second, the most clearly saturated sources are in B 59, requiring m ore e ort to extract reliable photom etry. As was pointed out by Brooke et al. (2007), the three brightest 24 m sources in B 59 (BHB2007] 1, 7, and 11) are saturated while at 70 m, only BHB2007] 11 is saturated. Outside of B 59, am ong the sources we are studying, only KK Oph is saturated at 24 m.

In addition to crowding of bright sources, our reliance on M IPS data for the identi cation of Y SOs also su ers from the relatively low angular resolution: the detectability of multiple systems is reduced even when compared to 2M ASS. For example, KK Oph is a known binary with a separation of  $1.6^{00}$  (see below), but we cannot resolve the two components.

#### 3. A nalysis

# 3.1. Selection of candidate Y SO s

W e expect to nd any candidate protostars in the relatively high-extinction regions of the cloud. These regions correspond to only a small percentage of the full coverage. In line with earlier analysis (R athbome et al. 2009, in particular), we use the following threshold to de ne the highextinction regions: in an extinction m ap in which extended structure has been rem oved by m eans of wavelet subtraction (Alves et al. 2007) we use a m in imum extinction of  $A_v > 12$  m aq. An area of 0.98 square degrees is above this threshold out of which the identied dense cores (Rathborne et al. 2009) com prise an area of 0.75 square degrees. In the following, we will constrain the star form ation activity in these high-extinction regions. It will become clear that we can constrain the sizes of the populations of both class I protostars and class II Y SO s (as de ned by Lada 1987) in the high-extinction regions.

G iven the location of the Pipe Nebula, projected onto the vicinity of the G alactic center, the background source density in the region is enormous and selection criteria for candidate YSOs are of particular in portance. Com pared to source detection at near-infrared wavelengths, the lower source density in the mid-infrared at 24 m and

70 m allow sus to work with a sensitivity-limited (rather than confusion-lim ited) sample of objects. W hen boking for candidate protostars at these wavelengths, we rst have to establish whether the mid-infrared mosaics are sensitive enough for this purpose. A good rst test is to look at the low est-lum inosity protostellar objects known, the Very Low Lum inosity Objects (VeLLOs). These objects were only discovered recently, with the unprecedented sensitivity of Spitzer. The four VeL-LOs that have been studied in detail (Young et al. 2004; Bourke et al. 2006; Dunham et al. 2006; Lee et al. 2009, , L1014-IRS, L1521F-IRS, IRAM 04191, and L328-IRS, respectively) have been detected with M IPS at both 24 m and 70 m, and their mean bolom etric lum inosity is 0.25 L (the extrem e values being 0.15 L , IRAM 04191, and 0.36 L , L1521F-IRS). Note that the bolom etric lum inosities are signi cantly higher than the intrinsic lum inosities of the corresponding central objects. Detections at both 24 m and 70 m are also used as criteria by Dunham et al. (2008) who list a total of 15 candidate VeLLO s as a result of surveying the Spitzer c2d data. The fact that the four above-m entioned VeLLOs are located nearby and at least as distant as the Pipe Nebula means that we can use them to de ne ux cut-o values at both 24 m and 70 m to include these currently known VeLLOs. These ux limits ensure that we can detect even the lowest-mass protostellar ob jects.

As our rst selection criterion we thus require candidate Y SO s to have ux densities of at least 10 m Jy at 24 m and 100 m Jy at 70 m. It turns out that both cut-o values are com fortably above the detection limits in both bands. In the list of sources detected in both M IPS bands, the typical photom etric uncertainties determ ined by MOPEX are 0.09 m Jy at the 24 m ux cuto and 5.65 m Jy at the 70 m ux cuto . As a second step, we are using a direct application of the original definition of YSO SED classes of Lada (1987), although im plem ented in longer-wavelength (M IPS) bands. Thus, we require a positive spectral index, = dlog F = dlog , in the two M IPS bands, in order to nd the earliest (class I) protostellar stages. In this case, a positive spectral index in F corresponds to a ux ratio of F (70 m)=F (24 m) > 70=24. A similar criterion can be used to select candidate class II sources, dom inated by their disk

em ission. They are expected to have ux ratios of F (70 m)=F (24 m) > 1=3, corresponding to a spectral index of > 2. Sources above our ux cut-o values but below this minimum spectral index include candidate class III sources. Since these presum ably become di cult to distinguish from stellar photospheres of eld stars, we do not discuss these in further detail, focusing only on candidate class I and II sources as possible products of recent star form ation. Only these sources, as de ned by our M IP S-based criteria, will be referred to in the follow ing as candidate Y SO s.

U sing these criteria, we identify in Fig. 1 a total of only 25 candidate Y SO s in the high-extinction regions of the entire com plex, 12 of which are located in B 59. These sources were matched with the 2MASS point source catalog, using a search radius of  $3^{00}$ . The median di erence in position is  $1.5^{00}$ . We found one additional candidate YSO in a region without coverage at 70 m. This source is listed as candidate 26. Lacking 70 m coverage, source 26 was identied by its K s [24] color of 10.459 0.082 m ag. There are no further sources with comparably extrem e K<sub>S</sub> [24] colors that are not already covered by the above criteria. Given the superior sensitivity of the above method, which does not depend on near-infrared detections, we do not further discuss K s [24] colors. The resulting 26 candidate YSOs and their photom etry are listed in Tables 1 and 2, sorted by descending 70 m ux. The photom etric errors consist of the tting errors reported by MOPEX, with the absolute errors<sup>3</sup> added in quadrature (for the saturated sources, a larger error is assumed). In order to allow us to compare the photom etry, we have added these absolute uncertainties also to the errors reported by Brooke et al. (2007) for the non-saturated sources, since the errors in their source table are the form al tting errors. For all candidate YSOs we con med their detection in two di erent epochs of M IP S24 observations, ensuring that they were not caused by asteroids. Source 26 was con med by the presence of a midinfrared IRAC counterpart.

For B 59, when applying our criteria to the 12 sources from Brooke et al. (2007) that have M IP S24 and M IP S70 photom etry, we nd four

candidate class I sources and eight candidate class II sources. This leaves eight sources from the Brooke et al. (2007) list of 20 that do not appear to qualify as candidate YSOs according to our M IP S-based criteria. W hile in some cases, these objects are genuinely excluded by our method, in other cases, no suitable M IPS photom etry is available. One of these sources, [BHB2007] 20 is not covered at 70 m so that it is not selected by our criteria. Three sources (BHB2007] 2, 6, and 12) are too close to bright neighboring sources for any reliable photom etry in either of the M IPS bands to be extracted (and no such photom etry is listed in Brooke et al. 2007); therefore, these sources do not appear in our list. The remaining four sources are the outerm ost objects which are not detected at 70 m; only upper lim its were given by Brooke et al. (2007). These include [BHB2007] 5 and 17, which Covey et al. (2009) determined to be background giants, using near-infrared spectroscopy. The source [BHB2007] 17 is very close to the chip edge in the 70 m coverage, and not detected in spite of its bright 24 m counterpart.

The sensitivity of our M IPS mosaics, as we have argued, is enough to even detect VeLLOs at the distance of the Pipe Nebula. Therefore, we estim ate that our survey is complete for candidate class I protostars of L > 0.2L . We note that even for candidate class II sources, our selection m ethod is very sensitive. Note that we used a conservative limit of  $_{24}$   $_{70}$  > 2 to nd all possible candidate class II sources. This index corresponds to the ideal case of an optically thick, spatially at disk. In reality, observed class II SEDs often have signi cantly atter slopes due to disk aring and viscuous heating, resulting in = 0.7 0.3(Kenyon & Hartmann 1987, for a spectral range of 2 { 60 m ). In Section 3.4, when we study their SEDs, we will see from the nalclassi cation (Table4) that our candidate class II sources have a median<sup>4</sup> spectral index of  $_{K}$  <sub>24</sub> = 0:73. We can thus roughly estimate the completeness for such typical class II sources by comparing with an observed example, the uxes of FM Tau, a K 3 class II source (  $_{K}$  24 = 0:65) in Taurus at a sim ilar distance as the Pipe. FM Tau has a total lum inosity of 0.5 L (e.g., Strom et al. 1988)

and a 70 m ux density of 0.29 Jy (from the Taurus Spitzer Legacy Project). Scaling that to our ux density cut-o at 70 m (0.1 Jy) and assuming the same distance for the sake of this com parison yields a com pleteness lim it for class II SED sofonly  $L_{bol}$  0.2 L. The ux density ratio F (70 m)=F (24 m) in this case is 0.59. A sim ilar check with two late-type class II objects, FN Tau  $(M5, K_{24} = 0.53)$  and FP Tau  $(M25, K_{24})$  $_{\rm K}$  24 = 1:12), yields even lower limiting luminosities for our ux limits (i.e., 0.05L and 0.12L , respectively), corroborating our estim ate of L<sub>bol</sub> 02L . The com pleteness level for typical observed class II sources is comparable to the one for class I protostars discussed above.

W hile all candidate sources by de nition are in regions with  $A_V > 1.2 \text{ m}$  ag (in the extinction m ap without extended structure, see above), not all of them are projected onto what Rathborne et al. (2009) de ne as dense cores, see Table 1. Five of our sources either lie in extinction cores that do not ful 11 the minimum size requirement set by Rathborne et al. (2009) or were excluded due to their C<sup>18</sup>O em ission properties: O ne source is close to an extinction peak without detected C<sup>18</sup>O em ission (source 16), and, most interestingly, the extinction core onto which source 17 is projected, aswellasits neigboring cores, have C<sup>18</sup>O em ission at a velocity that is signi cantly di erent from the cloud velocity (v =  $21 \text{ km s}^{-1}$  vs. a range for the Pipe Nebula of v = 2:8 km s<sup>1</sup>, Rathborne et al. 2009). This candidate YSO therefore apparently does not belong to the P ipe Nebula com plex. For the ve cases where cores and their masses are not listed by Rathborne et al. (2009), Table 1 lists corresponding mass estimates, derived according to the procedure outlined in Section 3.6. These estimates take into account all pixels of the background-subtracted extinction map with  $A_V > 1.2$  m ag if they have not been assigned to neighboring cores. Note that some of the changes in the rened core list are due to the intricacies of de ning the core population, a process that is not unam biguous.

#### 3.2. C om parison to control regions

W hile we have estim ated the sensitivity of our selection m ethod, we still have to determ ine the am ount of contam ination by background sources. A s control region, we use those parts of our M IP S

m osaics that are not covering the high-extinction regions, i.e., regions with  $A_V < 12$ . Applying the selection criteria to these sources allow s us to approximately predict how many detections in each category could be due to background objects and to judge whether the number of identied candidates exceeds the num ber of expected background sources. As m entioned above, about 94% of our m ap is not covering high-extinction regions. G iven the proximity of the Pipe Nebula to the Galactic center, there is a high density of background sources, presum ably mainly in the Galactic bulge. W hile 56 sources were detected at both 24 m and 70 m in regions with extinctions above 1.2 m ag (not applying any ltering), 490 such sources were detected in the remainder of the map. Fig. 2 depicts the sources in the control region in the sam e way as the high-extinction sources were plotted in Fig. 1. Some of the sources in the control region technically ful llour candidate YSO selection criteria, indicating that there is contam ination in our list of candidate Y SO s. Table 3 contains a com parison of the control region and the high-extinction regions in the Pipe Nebula in terms of candidate YSOs. Taking into account that regions with extinctions above 1.2 m ag cover only 7% of the map (see above), we nd that that in the three ranges of ux ratios corresponding to YSOs, we nd more candidates than can be expected from background contam ination alone. In particular, and most importantly, we detect nine candidate class I sources while the expected background contam ination is 2.9 sources. This relative overdensity of candidate YSOs in the high-extinction regions suggests that their occurence is indeed related to the presence of dense material and supports the notion that som e of these objects really are YSOs.

# 3.3. C om parison to other star-form ing regions

There are two obvious possibilities to compare the application of our candidate YSO identi cation m ethod to other star-forming regions. First of all, given its location at about the same distance, it is interesting to compare the Pipe N ebula to the Taurus star-forming region. W hile a full application of our m ethod to the Taurus data is beyond the scope of this paper, we can at least check whether known objects occupy the region of ux space that we use to identify candidate Y SO s. In a prelim inary version of their source list, the Taurus Spitzer legacy project<sup>5</sup> lists 693 sources that are detected at both 24 m and 70 m, a precondition for our candidate Y SO selection m ethod. The Taurus m ap covers a total of about 40 square degrees, four times larger than our map of the Pipe Nebula. We correlate the Spitzer source list with the list of YSOs in Taurus-Auriga given by Kenyon et al. (2008). This table contains 383 low mass YSOs of which 98 have counterparts in the Spitzer list with detections in both M IPS bands (within a search radius of  $1^{\circ\circ}$ , see above; note that the two lists cover di erent areas). The K enyon et al. list does not distinguish the di erent evolutionary stages, but as shown in Fig. 3, this selection of sources is well constrained by the regions in the 70 m vs. 24 m plot that we use for the selection of candidate Y SO s. To illustrate that prototypical class I sources fall into the corresponding selection region, we note that L1551 IRS5 (not covered by the Taurus Spitzer Legacy P roject), already based on its IRAS data, ful 11s the criteria, but lies outside of our plot lim its due to its brightness: its 60 m ux is 373 Jy, and its 25 m ux is 106 Jy, i.e., the ux ratio is 3.5. This example once more underlines the sensitivity of the Spitzer M IPS observations.

For a second com parison, we consider the candidate Y SO s that have been identied by the \C ores to disks" (c2d) Spitzer Legacy Project. This com parison is di erent, since it allows us to select already identi ed candidate Y SO s and look at their properties at 24 m and 70 m. The c2d \Ensemble C ores" list of candidate Y SO s contains 106 objects with both 24 m and 70 m uxes out of 122 candidate Y SO s that were observed at both wavelengths<sup>6</sup>. Reassuringly, when we plot the sources in the sam e way as we plotted the candidate Y SO s in the P ipe, the sources roughly fall into the region of ux space where we expect candidate YSOs in the Pipe cloud (Fig. 3). This is reassuring since the M IPS spectral index is not part of the selection criteria that were used by the c2d team . Note that the data have not been corrected for the di erent

distances (  $120{250 \text{ pc}}$ ) of the several di erent nearby star-form ing regions that were part of the survey.

These two examples demonstrate that using the 24 m and 70 m M IPS bands and their high sensitivity constitutes a powerfulm ethod to look for candidate Y SOs in the Pipe cloud. The draw-back of relatively low angular resolution is in our case overcompensated by the enorm ous reduction of sources to survey (while keeping a high sensitivity) compared to the use of IRAC data which in this direction of the Galaxy are a ected by source crowding.

# 3.4. A closer look at the candidate Y SO s

A cross-correlation of the 26 candidate YSOs with catalogs, using SIM BAD and Vizier, allows us to identify a rst subset of sources that can be refected as YSO candidates. Source 10 is a 1.4 GHz radio continuum source in the NRAO VLA Sky Survey and listed as a possible preplanetary nebula by K ohoutek (2001). Sources 13, 14, and 15 are all listed as high m ass-loss asym ptotic giant branch stars by 0 tha et al. (2007). After a comparison with typical Spitzer galaxy SEDs, in particular looking at the in uence of PAH features on the IRAC photometry (e.g., Rowan-Robinson et al. 2005), three additional sources, namely 19, 20, and 22 have been rejected as being likely galaxies. We note that their IRAC colors are [5.8 m]-[8.0 m] and [3.6 m]-[4.5 m] < 0.9, supporting this conclusion (e.g., Robitaille et al. 2008). Source 25 looks photospheric except for its 70 m ux which is the weakest in this selection. In fact, the 70 m detection is surrounded by weak extended em ission leading to an overestim ate of the ux in the PRF t. The source has been rejected as not being a true excess source; it is clearly not a class I or class II Y SO . The use of catalogs also allow s us to con m the selection of a YSO : source 5 is the Herbig AeBe star KK Oph which is very likely associated to B 59; it appears to have a T Tau companion (Herbig 2005; Carmona et al. 2007). Additionally, Covey et al. (2009) have analyzed near-infrared spectroscopy of our sources 11 and 16, con ming only the latter as a YSO (their source 2, a binary system unresolved in our data), while leaving open the identi cation of the form er (source 1 in their designation). R iaz et al. (2009)

con m the protostellar nature of source 1. Thus, after this rst cross-correlation with catalogs and previously obtained data as well as comparison to galaxy SED s, 18 candidate Y SO s remain, only six of them outside of B 59. W e note that the two B rooke et al. (2007) sources rejected as giant stars by C ovey et al. (2009), [BHB2007] 5 and 17, are not detected at 70 m and thus did not appear in our list.

In order to better characterize the candidate YSOs, we have determ ined their infrared SEDs, based on 2MASS, IRAC and MIPS photometry. For comparison, we have also determined SEDs for som e sources in the control regions that would qualify as candidate YSOs. Subsequently, to test whether the SED s can be explained as protostellar, we have attempted to t the SEDs of candidate YSOs with models from Robitaille et al. (2007). These pre-computed radiative-transfer models cover a large region of parameter space. Since most of the sources are relatively bright 2M ASS sources and thus do not look like edgeon disk con gurations, we excluded such models in the grid from the tting process, realizing that allSED s can still be well tted and explained. For the ts, photom etric errors larger than the nom inalerrors were assumed: 0.1 m ag for 2M ASS and 10% for all Spitzer photom etry except for data corrected for saturation, where we assume 20%. The SEDs and t results are shown in Figs. 4, 5, and 6. Table 4 lists the range of total extinction and the range of bolom etric lum inosities for all candidate YSOs. The parameter ranges are simply giving the extrem e values for all ts within a relatively strict goodness-of-t criterion7,  $n_{\text{data}}^2$  <  $n_{\text{data}}$ . The tresults show that the candidate YSOs can be reasonably described as a mostly low-mass YSO population. The lowestlum inosity candidate class I protostar, source 26, might be a VeLLO in its own right. A lso, the low est lum inosities deduced from the model ts are of the same order as our estim ated com pleteness lim it.

We use the full SEDs and the model ts to reexam ine and re ne our initial classi cation of the candidate YSOs which was based solely on

the MIPS spectral index. In particular, Figs. 4 and 5 show that two candidate YSOs, sources 9 and 24, initially identied as candidate class I sources, exhibit com plex double-peaked SED s that cannot be adequately described by a single spectral index. The full SEDs show, however, that these two sources are more aptly described as class II objects. Additionally, an examination of the SED s of sources initially selected as candidate class II objects shows that several of these have SED s that are atter than expected for prototypical class II objects with shapes sim ilar to those of the at-spectrum protostellar class de ned by G reene et al. (1994). Since their SEDs are wellbehaved, we use the wide K {24 m spectral index, as described in a footnote to Table 2, to re ne our classi cation to include at-spectrum protostars. The re ned YSO classi cations are listed in Table2.

In an attempt to characterize the 48 control sources that technically ful 11 our criteria for being candidate class I protostars, we used SIM BAD to identify counterparts. Such counterparts are found for only nine sources within a search radius of  $4^{\circ\circ}$ . Eight of these appear to be planetary nebulae and one is an OH/IR star. These 48 sources have a m ean extinction of 0.1 m ag in the extinction m ap where extended structure has been rem oved, and a mean extinction of 4.0 mag in the full extinction map. A sample of control SED s is shown in Fig. 6. W hile many sources remain unidentied and the multi-wavelength coverage is not the sam e for all of these objects, most of the sam pled sources appear to be galaxies based on their SED shapes, following the sam e argum ents also used in rejecting candidate Y SO s above (m ainly the in uence of PAH features on the IRAC photom etry).

# 3.5. Location of the candidate Y SO s relative to extinction peaks

Very young candidate Y SO s would most likely be found at or in close proximity of the extinction peaks. Fig. 7 shows the identi ed candidate Y SO s overlaid onto the corresponding sections of the extinction map. G iven that the candidate Y SO s were selected for being inside areas of the extinction map that are above a minimum threshold, it is not surprising to see them close to the extinction peaks, but few are centered on peaks, the best case being source 26. Since one would expect the youngest sources (class I) to be located at or very near to the extinction peaks, the observed o sets indicate that the candidate Y SO s are likely predom inantly in later evolutionary stages (i.e., class II). This is compatible with our ux-based characterization which found that most of the candidate YSOs are class II rather than class I (see above). It is interesting to note that while veofthe six candidate YSO soutside of B 59 are within 2.3 of the cluster, a single candidate (source 17) is 5.9 away, at the  $\rho$ of the cloud. W e note again that the corresponding core as well as the surrounding cores were rejected by Rathborne et al. (2009) as being part of the Pipe complex since their C<sup>18</sup>0 velocities are signi cantly o set from the system velocity. W hile source 17 nevertheless is a candidate Y SO, it probably does not belong to the P ipe N ebula com plex. Fig. 8 shows the six candidate YSOs outside of B 59 on the extinction map from Lombardiet al. (2006). It is indeed interesting to note that most of them are located in the \stem " of the P ipe, none having been detected in the \bow 1", even though there are regions of considerable extinction in that area. This suggests that the area around B 59 at the tip of the stem is the most evolved region, followed by the stem , leaving the entire \bow 1" in a very early evolutionary stage. Interestingly, this is in line with the conclusions of A lves et al. (2008a) who presented an optical polarization study of the Pipe Nebula. From a strong polarization gradient across the Pipe Nebula, with the lowest amounts of polarization found towards B 59, they propose a very sim ilar picture. W hile they also suggest that the entire \bow 1" region is in a very early stage, they conclude that the \stem " is about to form stars while B 59 has actively ongoing star form ation.

# 3.6. Star formation e ciency in the Pipe Nebula

In total, we have found 21 candidate YSOs in the Pipe Nebula. Fifteen<sup>8</sup> of these are in B 59 and only six in the entire remaining cloud com – plex. Star formation e ciencies (SFEs) are usu-

ally given as SFE =  $M = (M + M_{cbud})$ , i.e., they are compared to the totalm assofthe cloud (in this case,  $M = 10^4 M_{\odot}$ , Onishiet al. 1999). A ssum – ing stellar masses of 0:3M each, this translates into an extremely low star formation e – ciency when compared to the mass of the entire cloud, it is only 0:06%. Typical values are a few percent; the median of 2% given by M yers et al. (1986) is 33 times higher than our value for the Pipe Nebula.

Furtherm ore, we can estim ate the star form ation e ciency for the densest material, considering that the high-extinction regions represent the dense component of the cloud. We can estim ate the corresponding cloud mass from the summed pixels in the extinction map, taking into account the high-extinction regions with  $A_V > 1.2$  mag (in the background-corrected map) that were surveyed for candidate Y SO s:

$$M = m_{H} A_{pix} A_{V}$$

Here, is the mean molecular weight (1.37),  $m_{\rm H}$  is the mass of the hydrogen atom, is the conversion from optical extinction to column density, and  $A_{V}$  is the sum m ed optical extinction.  $A_{pix}$  is the area of a pixel in cm<sup>2</sup> at the distance of the source, for extinction pixels with a side length of  $s_{pix}$  [<sup>0</sup>]:  $A_{pix} = (=180=3600)^2 s_{pix}^2 d^2$ , where d is the distance in cm. W hile there are 14066 pixels in the extinction m ap above a threshold of  $A_v > 1.2 \text{ mag}$  (each of size  $30^{00}$ 30<sup>00</sup>), only 11063 of these are covered by both the 24 m and the 70 m maps. The summed  $A_V$  in these pixels is 29751 m ag. U sing a conversion factor of =  $2 \ 10^{21} \,\mathrm{cm}^{2} \,\mathrm{mag}^{1}$  (e.g., Bohlin et al. 1978), the resulting m ass is 230 M . A ssum ing an upper lim it of 21 candidate Y SO s, each approxim ately of

0:3M, again yields an extrem ely low star form ation e ciency of 2.7% when compared to the densest m aterial. This is considerably lower than typical values for clusters which are on the order of  $10\{40\%$  (e.g., Lada & Lada 1991). We note that at most ve of the identi ed 134 extinction cores (or 3.7%) have candidate Y SO s, not counting three additional candidate Y SO s in extinction cores projected onto high-extinction regions not part of cores as de ned by R athbome et al. (2009). For the com bined data of the Spitzer c2d project, the average star form ation e ciency is 4.8% while it is much higher when compared to the dense material, as derived from dust continuum observations (E vans et al. 2009).

#### 4. Sum m ary

We have used very sensitive mid-infrared mapping of the Pipe Nebula to obtain a sensitive census of its extremely low star formation activity. Using the 24 m and 70 m M IPS bands to identify candidate Y SOs is a powerful tool, allowing us to search the cloud for protostars down to objects with very low luminosities. For both class I and typical class II Y SOs the search is estimated to be complete down to luminosities of 0.2 L . The star formation e ciency in the Pipe Nebula is only

0:06% when compared to the total cloud m ass and 2.7% when compared to the mass of the highextinction regions. This is more than an order of magnitude lower than in typical star-forming regions. Candidate YSOs are found in at most ve of the 134 identi ed extinction cores, leaving the overwhelming majority of cores apparently starless. Outside of Barnard 59, where a previously known cluster of YSOs resides, we nd only six new candidate Y SO s in the entire rem aining P ipe Nebula, one of which has already been con med as a Y SO by near-infrared spectroscopy (C ovey et al. 2009, in prep.). One of these candidate Y SO s very likely is not a member of the Pipe Nebula complex. Using our M IPS-based selection criteria, we nd an upper lim it of 15 candidate Y SO s in B 59, all of them previously known. Interestingly, the Pipe candidate Y SO s outside of B 59 are not evenly distributed over the remaining cloud, but they are within 2.3 of B 59, leaving large regions of the cloud, particularly the bow l region, without any candidate Y SO s. These results clearly dem onstrate that apart from B 59, the Pipe Nebula is a region with extrem ely low star form ation activity. W e conclude that it appears to be an ideal region to study the initial conditions and earliest stages of star form ation.
