# R otation $V$ elocities for $M-d w \operatorname{arfs}^{1}$

## ABSTRACT

W e present spectroscopic rotation velocities (v sin i) for 56 M dwarf stars using high resolution HET HRS red spectroscopy. In addition we have also determ ined photom etric e ective tem peratures, $m$ asses and $m$ etallicities ( $\mathbb{F e} / \mathrm{H}]$ ) for som e stars observed here and in the literature where we could acquire accurate parallax $m$ easurem ents and relevant photom etry. W e have increased the num ber ofknow $n v \sin$ is form id $M$ stars by around 80\% and can con $m$ a weakly increasing rotation velocity with decreasing e ective tem perature. Our sam ple of $v \sin$ is peak at low velocities ( $3 \mathrm{~km} \mathrm{~s}{ }^{1}$ ). We nd a change in the rotational velocity distribution betw een early M and late M stars, which is likely due to the changing eld topology between partially and fully convective stars. There is also a possible further change in the rotationaldistribution tow ards the late $M$ dwarfs where dust begins to play a role in the stellar atm ospheres. W e also link $v \sin i$ to age and show how it can be used to provide $m$ id M star age lim its.

W hen all literature velocities for M dwarfs are added to our sample there are 198 w ith $v \sin i \quad 10 \mathrm{~km} \mathrm{~s}^{1}$ and 124 in the m id-to-late M star regim e ( M 3.0 M 9.5 ) where m easuring precision optical radial-velocities is di cult. In addition we also search the spectra for any signi cant H em ission or absonption. 43\% were found to exhibit such em ission and could represent young, active ob jects w ith high levels of radial-velocity noise. W e acquired tw o epochs of spectra for the star G J1253 spread by alm ost one month and the H pro le changed from show ing no clear signs of em ission, to exhibiting a clear em ission peak. Four stars in our sam ple appear to be low -m ass binaries (G J1080, G J3129, G 1802 and LH S3080), w ith both G J3129 and G 1802 exhibiting double $H$ em ission features. The tables presented here will aid any future M star planet search target selection to extract stars that w ill exhibit low radial-velocity \#̈tter.

## 1. Introduction

In the past 10 years radial-velocity $m$ easure$m$ ents in the optical have $m$ ade great strides by utilising a num ber of techniques and $m$ ethodolo-

[^0]gies to generate precisions of $3 \mathrm{~m} \mathrm{~s}{ }^{1}$ in the long term (e.g. Butler et al, 2006) and sub-m $s^{1}$ in the short term (e.g. B ouchy et al, 2005). U se of an iodine cell (e.g. M arcy \& Butler 1992) or ThA r gas lam p (e.g. Pepe et al, 2000) have allow ed detection of around 300 extrasolar planets (exoplanets), w th that num ber increasing each $m$ onth (see http://exoplanet.eu/). A large param eter space has been studied but since these observations are
lim ited to the optical regim e, where $M$ dwarfs are intrinsically faint, a vast am ount of stars are left unobserved, particularly the $M$ star population that constitutes the bulk of stars in the local galactic neighbourhood. R adial-velocity studies of early M dw arfs have detected planets w ell into the terrestrialm ass regim e, down below 10M (e.g. R ivera et al 2005; U dry et al 2007; M ayor et al 2009). There is considerably im proved $m$ ass contrast w th such stars (am plitude of a given $m$ ass planet / $M_{\text {star }}{ }^{0: 5}$ ) and obtaining precision radialvelocities of these ob jects $m$ ay enable E arth-m ass planets to be detected in their habitable zones.

The largest uncertainty associated with precision radial-velocity $m$ easurem ents is that of stellar activity. The association betw een stellar activity and rotation velocity ( $v \sin i$ ) is well established $\mathbb{N}$ oves et al 1984) and $m$ easuring this param eter is an exœellent proxy of the level of activity. For a xed resolution, $S / N$ and calibration $m$ ethod, starsw ith higher rotationalvelocities have radial-velocity m easurem ents w th low er precision since the larger rotation serves to w ash out the spectral features Bouchy et al, 2001). C oupled to this, the com bination of activity and rotation can cause false positives to appear in the data (e.g. Henry et al 2002) but in general it serves to increase the level of 所ter (W right 2005). H ow ever, the rotation-activity connection has been show $n$ to saturate quickly around $M$ stars, occuring at $5 \mathrm{~km} \mathrm{~s}{ }^{1}$ form 2 ob jects $\mathbb{P}$ atten \& $\operatorname{Sim}$ on 1996). Since we are probing later M stars ( M 3), where observations of various activity indicators have shown that the percentage of active stars will increase dram atically, up to $100 \%$ at M 7 (Flem ind et al, 2000; M ohanty et al 2002), we are focused on selecting the slowest rotators within each spectralbin, in order to select the narrow est line pro les. An increase in radial-velocity uncertainty of around 3-4 tim es was found by Bouchy et al . when increasing the $\mathrm{v} \sin$ i of stellarm odels from $1-10 \mathrm{~km} \mathrm{~s}{ }^{1}$. The larger uncertainty arises due to the loss of spectral in form ation in the stars $w$ ith higher $v \sin i$ since the blending factor is increased w ith in the stellar forrest, to the detrem ent of the radial-velocity inform ation.

B ased on the above description any future precision radial-velocity planet search survey targeting cool M stars should have a fairly strict selection based on the rotation velocity of their sam -
ple stars, particularly w hen targeting E arth-m ass planets in the habitable zones. For instance, a search em ployed using a PRVS-like instrum ent (Jones et al, 2008; R am sey et al, 2008) would focus on selecting the brightest $M$ stars $w$ th rotational velocities in the sub- $10 \mathrm{~km} \mathrm{~s}{ }^{1}$ regim e, which would allow high $\mathrm{S} / \mathrm{N}$ spectra to be acquired in the shortest possible observationaltim es, gaining in the num ber of $M$ stars observed in a single observing run, and also allow ing the highest precisions to be reached to detect the low est m ass rocky planets, in particular E arth-like planets in their habitable zones. W e do note that such a $10 \mathrm{~km} \mathrm{~s}^{1}$ upper lim it should probably be raised when $m$ oving into the ultracool/brown dw arf regim e to increase the num ber of such objects on any planet search sam ple since previous studies have show $n$ that rotation velocities appear to system atically increase (e.g. M ohanty \& B asr2003; Reiners \& B asr 2008).

## 2. Observations \& Reduction

All observations in this study were $m$ ade over the period 2006 D ecem ber 252007 N ovem ber 04 utilising the queue scheduling m ode at the 92 m Hobby Eberly Telescope (HET; Ram sey et al, 1998) at M cD onald O bservatory in Texas. U sing the High Resolution Spectrograph (HRS; TuI). 1998) red chip ( 8100-9900A) operating at a resolution of R 37,000 and spatial binning of $2 \times 2$, 53 ob jects w ere observed, ranging in spectral type from M 3 V to M 6.5 V . The HRS observing m ode em ployed the use oftw o $3^{\infty}$ bers since the ob jects were so faint, with one on ob ject and one on sky. $B$ right telluric standards taken from the HET list of rapidly rotating B stars were also observed on $m$ ost of the nights, which allowed us to characterize the level of telluric contam ination in the data. Since even close by $m$ id-to-late $M$ stars are relatively faint, our HRS integration tim es ranged in duration from $5-25 \mathrm{~m}$ inutes and for some of the fainter ob jects $m$ ultiple exposures w ere taken and combined to generate a high $\mathrm{S} / \mathrm{N}$ spectrum . H ow ever, $m$ ost of the $v$ sin im easurem ents, when com paring the individual fram es to the com bined fram e, were w thin $0.5 \mathrm{~km} \mathrm{~s}^{1}$ since the deconvolution $m$ ethod we em ploy boosts the $S / \mathrm{N}$ in the nal line pro le used in the $m$ easurem ents.
The reduction of all data was perform ed using
ccdpack and starlink techniques. First the bias and overscan signals were rem oved and the overscan region was clipped o each im age. A master at eld was created by median ltering all ats taken in the standard HRS calibration plan. This usually consisted of a few bias frames, at elds and ThAr arc observations taken before and after the nights observing, how ever for one night no ats were observed and a at eld from a night close to the observing night w as used in the reduction. A lso the num ber of at elds were increased to 10 for the last six $m$ onths or so ofdata, which signi cantly aids in fringe rem oval. Indeed, the fringing in the red chip of $R$ RS can reach 10-20\% and hence well exposed, high S/N H alogen at elds are used to correct these.

The starlink package echomop M ills et al 1996) w as used to extract the echelle data. F irstly, all 14 orders were located and traced using the $m$ aster at eld, and any stray pixels w ere clipped from this trace. The dekker lim its were deter$m$ ined using the $m$ aster at eld to ensure the entire ob ject order and the adjoining sky order are included in the reduction. T hem aster at eld was then norm alized to determ ine the balance factors and these were $m$ ultiplied into all other observations. The sky light was rem oved by utilising the sky ber and subtracting out any sky lines that appeared in the ob ject spectra. The orders were then extracted using an optim alextraction routine (H ome 1986) and wavelength calibrated using the ThAr arc in ages.

A sm all portion of spectra for the M 4.5 V star G 121-028, centered on the sodium doublet at 8182-8194A, is shown in Fig. 1 (solid line). The dashed spectrum is the telluric standard HD 1839, which is a fast rotating B star, therefore all the strong features are due to telluric contam ination. The sodium doublet is heavily blended w ith a num ber of telluric features, which without good sky subtraction, could serve to contam inate any $m$ easurem ent of the line properties. This is one of the reasons that we use a spectral deconvolution routine to help rem ove the telluric features in our nal analysis. These nal spectra have a lim iting resolution of betw een $020-0.35 \mathrm{~A}$ ( $7-$ $13 \mathrm{~km} \mathrm{~s}{ }^{1}$ ), which was determ ined individually for each star by deconvolving the telluric lines in each im age.

## 3. $v \sin i D$ eterm ination

A llv sin is in thisw ork are determ ined by deriving an optim al line pro le for each star, and then convolving a non-rotating tem plate (LH S1950 is our tem plate) w ith rotational pro les of various velocities to $n d$ the best $m$ atch. A deconvolution $m$ ethod (D onati \& C ollier C am eron 1997; B ames et al. 1998; C ollier C am eron et al, 2002) is used to determ ine the optim al line pro le. A continuum $t$ is perform ed using the cont inuum routine in iraf to norm alize the spectra and to provide inverse variance weights for the deconvolution procedure. This least squares deconvolution uses a line list which best $m$ atches the spectral type of each star. T he w avelength positions and line depths used were taken from VA LD (V ienna A tom ic Line Database; Kupka \& Ryabchikova 1999). A ny de ciencies in the line list data for coolm stars, such asm issing opacities, should not a ect the nalv sin ivalues since the same list is used on the non-rotating tem plate star LH S1950. $T$ he use of fewer $m$ odel lines for deconvolution than actually observed will sim ply give rise to pro les with lower $S / \mathrm{N}$ than a m ore com plete model would a ord. The line strengths of the nal pro les m ay also vary from star to star but can be corrected for by scaling the non-rotating tem plate to the line strength of each stellar deconvolved pro le. The m ethod of least squares deconvolution is used to determ ine the $m$ ean line pro le which when convolved w th the line depth pattem gives the optim alm atch to the observed spectrum .

Fig. 2 represents the naldeconvolved line pro-
le for G 121-028 (solid line) w ith velocity on the $x$-axis and nom alized $u x$ on the $y$-axis. $G$ 121028 is one of the slow er rotating stars in our sam $\mathrm{ple}\left(\mathrm{v} \sin \mathrm{i}=3.8 \quad 0.7 \mathrm{~km} \mathrm{~s}{ }^{1}\right.$ ) as the narrow line pro le show s . To determ ine the v sin $i$ values we perform a Levenberg $-M$ arquardt least squares minim isation using MPFIT in $\mathbb{D} L$ (Markwardt. 2009) to nd the best $t$ for each observed line pro le. The $t$ is represented by the dashed line in the gure and for this example a reduced ${ }^{2}$ $\left({ }^{2}\right)$ of 12 is found. This best $t$ is used to determ ine both the pro le centroid and scaling factor. T he centroid allow s each star to be shifted to the rest fram e for use in the tem plate com parison, whilst the scaling factor allow sus to scale our non-

rotating tem plate to $m$ atch the pro le strength of each star. LH S1950 w as found to be our narrow est pro le (determ ined from the fullwidth at half maxim um ( $F W$ HM) of the best $t$ to each pro le) and hence below the resolution lim it of the instru$m$ ent. This tem plate is then broadened in steps of $0.5 \mathrm{~km} \mathrm{~s}{ }^{1}$, between velocities of $0.5-50 \mathrm{~km} \mathrm{~s}{ }^{1}$, using a grid of rotationalpro lesw ith a lim b darkening coe cient of 0.6. An example is shown in Fig.3. A zoom ed in region of the pro le of $121-$ 028 is represented by the dotted curve, w ith tem plate pro les marked by the solid curves. From inner to outer (narrowest to broadest) the solid curves have been broadened by rotationalpro les of $3.5,5.0$ and $10.0 \mathrm{~km} \mathrm{~s}{ }^{1}$ respectively. This highlights the good $t$ betw een the inner pro le com pared to the outer pro les w thin the uncertainties and highlights the robust nature of the
tting technique. A ll rotationalpro les are generated follow ing the description in $G$ ray (1992), and a ${ }^{2}$ value is determ ined at each $v \sin i$ step.

Fig. 4 shows our ${ }^{2} \quad t$ to the data points in the analysis of the star G 180-011. Each lled circle represents one of the $0.5 \mathrm{~km} \mathrm{~s}{ }^{1}$ steps used to broaden the tem plate to $t$ the pro le of G 180011. T he solid curve represents the best quadratic $t$ to the data, and follow ing the procedure in Jenkins et al. (2008), them inim um of this curve is the $m$ easured $v \sin i$, high lighted here by the verticalsolid line. T he verticaldotted, dot-dashed and dashed lines represent the 1,2 and 3 internal uncertainties respectively. The 1 uncertainty value was determ ined by $m$ easuring the $w$ idth of the curve at a 1 step (i.e. ${ }_{1}^{2}={ }_{\mathrm{m} \text { in }}^{2}+1$ ), after the curve has been broadened by a factor determ ined from the di erence betw een the $m$ inimum of the ${ }^{2}$ and 1 (where ${ }^{2}$ is the best $t$ ). D ue to the nature of the dataset this factor has a m edian of only 2.1 and standard deviation of 1.5 , indicating the goodness of the $m$ ethodology. We em ploy this arti cial broadening to the ${ }^{2}$ curve to help alleviate uncertainties that are di cult to address in the analysis procedure e.g. m acroturbulence variations, spectral type di erences, etc. For $G$ 180-011 shown in the gure the form al uncertainty is found to be $0.4 \mathrm{~km} \mathrm{~s}{ }^{1}$. We use this procedure to determ ine alll uncertainties quoted in Table 3 .

The 1 uncertainties $m$ entioned show we have good intemal precision and since we have a few

stars where multiple observations were taken we can test this in a brute force $m$ annerby looking at the values for these multiple m easurem ents individually. W hen we do thiswe nd that the $v \sin$ is tend to agree to w thin the uncertainties deter$m$ ined by the 2 tting procedure on each individualm easurem ent. This gives us con dence in the analysis procedure. W e note that for the star G J1253 the v sin ivalues agree to w ithin 1 ,which for this star was $1 \mathrm{~km} \mathrm{~s}^{1}$, and as these were $m$ easured over two observations a m onth apart, they are probably the best indicator of the overallrandom uncertainties in the analysis procedure. Therefore, all velocities for objects $10 \mathrm{~km} \mathrm{~s}{ }^{1}$ are accurate to $1 \mathrm{~km} \mathrm{~s}{ }^{1}$. For the ob jects rotating much faster than this, particularly above $20 \mathrm{~km} \mathrm{~s}{ }^{1}$, 迷 is di cult to $t$ theirpro les to better than 10-20\% at the adopted resolution and $S / N$ and therefore this should be taken as the accuracy for such fast rotators.

### 3.1. In strum ental P ro le

A lthough we estim ate our resolution lim it to be around $2.5 \mathrm{~km} \mathrm{~s}{ }^{1}$, we note that this is not the case for allofour sample. Sinceweuse a xed tem plate spectrum thatwasm easured on our rst night and not on every night of our observations, there will be e ects due to the changes of the instrum ental response. Tom onitor this w eused the telluric lines in each of our spectra as a proxy for the instru$m$ entalpro le ( $\mathbb{P}$ ). W e assum e that the intrinsic width of weak telluric lines are sm aller than the instrum ental resolution. W e then perform ed the same tting routine to these deconvolved pro les which retumed an instrum entalFW HM for each stellar spectrum . W e decided not to use the arc lines for the $\mathbb{P} m$ easurem ents since the calibrations are taken through a di erent optical path than the science im ages and therefore would not accurately model the intrinsic instrum entalw idth (see Tul 1998 for H R S design). This procedure allow ed us to determ ine that there was an increase in the instrum ental width of alm ost a factor two betw een 2007 A ugust $9^{\text {th }}$ and 2007 O ctober $17^{\text {th }}$ due to poor them alcontrol in the HET spectrograph that lead to P SF instability through focus drift. T he stars observed betw een these dates have a typical resolution lim it of around $4-5 \mathrm{~km} \mathrm{~s}^{1}$, therefore we em ploy a correction to each star to correct for the e ects of the broadening of the $\mathbb{P}$.

Fig. 5 show s the average change in the FW HM of a selection six stars $w$ ith the highest $S / \mathrm{N}$ ratios as a function of $v \sin i$. Each of the data points $m$ ark the average of the FW HM di erence ( $F W$ HM FW HM O) for the six stars, along $w$ ith the associated scatter of the values, after broadening by rotation pro les in steps of $0.5 \mathrm{~km} \mathrm{~s}{ }^{1}$, where FW HM 0 is the intialFW HM before any broadening has been applied. T he solid line show s the best straight line $t$ to the data that we em ployed to correct for the $\mathbb{P}$, and is described by $1.08 x-2.03$, w ith an RMS scatter of only $0.46 \mathrm{~km} \mathrm{~s}{ }^{1}$.

To em ploy these corrections we determ ine the di erence betw een the tem plate telluric FW HM and that of each star. We then use the $t$ to determ ine which $v$ sin i pro le we must broaden the tem plate pro le by initially to correct for the changing $\mathbb{P}$ width. Due to our resolution this only becom es signi cant on the data mentioned above where the $\mathbb{P}$ alm ost doubled in w idth, leaving such stars with a resolution of $4.5 \mathrm{~km} \mathrm{~s}{ }^{1}$. $T$ hese ts can also be used to determ ine the actual $v \sin i$ from the change in the FW HM com pared to the tem plate, at least in the low $v \sin i$ regim $e$, and a test of this reveals agreem ent betw een both $m$ ethods. The ts could be extended into the high $v \sin i$ regim $e$ in order to use this $m$ ethod to determ ine the rotation velocities for rapidly rotating stars also. Allv sin is and their associated uncertainties are show $n$ in colum $n 11$ of Table 3, w ith the telluric FW HM s shown in column 12 for reference.

Fig. 6 show s the overallspread in the $m$ easured $v \sin i$ values as a function of the changing $\mathbb{P}$ of the instrum ent. A s m entioned above the change in the $\mathbb{P}$ is $m$ onitored by $m$ easuring the FW HM of the telluric lines in each spectrum (FW H $M_{\text {Tell }}$ ) and from the plot there appears no signi cant correlation betw een $m$ easured rotation values and the width of the $\mathbb{P} . T$ he linear correlation coe cient (r) for the entire sample is -0.12 and is still only 0.36 when rem oving allstars w ith $m$ easured upper lim its, which are represented in the gure by the dow nw ard pointing arrows. This test highlights the lack of any signi cant correlation betw een the $m$ easured $v \sin$ is and the changing width of the $\mathbb{P}$. In fact, only one of the stars $m$ easured during the period of increased $\mathbb{P}$ values is found to be above the detection threshold of our $m$ ethod, and as will be seen later, this correlates $w$ ith the

presence of $H$ in em ission in this star.
N one of these objects have previously deter$m$ ined $v \sin$ is $w$ th which to com pare our values for an accuracy check. H ow ever, R ockenfeller et al (2006) determ ined the I-band variability for the star LH S2930 and found the period to be 13 2hrs. They also quote the radius of the star to be 0.33 R , from which we can estim ate the rotation velocity assum ing the variability is induced by the rotation of surface features such as star spots. E stim ating this velocity in pure spherical geom etry retums a value for the equatorial rotation velocty of $30^{+}{ }_{3}^{6} \mathrm{~km} \mathrm{~s}{ }^{1}$. W e m easure a velocity of $18.71 .5 \mathrm{~km} \mathrm{~s}^{1}$, which is signi cantly low er than the photom etrically derived value. W e note that the deconvolved line pro le for this star is agged as low S/N.H ow ever, given these values this w ould indicate the star is inclined to our line of sight by around $51^{+100}$ (i 39 ${ }^{\circ}$ ). M arcy \& Butler (1996) show that for random stellar alignm ents, $68 \%$ of stars will have inclinations to our line of sight of below $47^{\circ}$, with 95\% having inclinations above $20^{\circ}$, placing LH S2930 in betw een this 1 and 2 result and in agreem ent w the 1 value w thin the estim ated uncertainty.

### 3.2. H A bsorption/Em ission

In addition to selecting against stars w ith a large $v \sin i$, one $m$ ight also like to $m$ onitor each star'sm agnetic activity through the absonption or em ission in the $H$ line. The correlation betw een H em ission, age, activity and rotation velocity has been wellstudied (e.g. M ohanty \& B asr 2003; Reiners \& B asr-2008 and refs therein), how ever the magnetic eld structure of M dwarfs, particularly slow ly rotating $M$ dwarfs, could be com plex, w ith m agnetically active regions rotating in and out of view and the presence of strong aring events. A lso there is the possibility that a sm allpercentage ofourM dw arfs are being view ed close to pole-on and instead of $m$ easuring their true $v \sin i$, which could be very high, we m easure a sm aller value and place these in the good planet search target bracket. T herefore, we searched for any em ission, and also signi cant absonption, in the $H$ line ( 6562A) in each ofour target stars. 24 (43\%) stars were found to show H em ission, which includes the double pro les found for the active binary stars, and since such stars could be young and highly active, these $m$ ay not be
ideal stars to include in a precision radial-velocity planet search. Of these only six have rotation velocities below $10 \mathrm{~km} \mathrm{~s}^{1}$ ( $12 \%$ of the total). H ow ever, we do caution that we m ight be view ing active regions on these stars, or aring outbursts, since num erous $M$ stars across the spectral dom ain have been found to exhibit such phenom ena (e.g. see Tinney et al 1998; $M$ art $n \& A$ rdila 2001; O sten et al, 2005). Further $m$ easurem ents $m$ ay reveal these to vanish and therefore $m$ ore epochs $m$ ay be required to test if such stars have continuous H em ission and are probably highly inclined young and active stars, or are sim ply going through a aring event. Reiners (2009) has show $n$ that ares only create signi cant noise at velocity precisions below $10 \mathrm{~m} \mathrm{~s}{ }^{1}$ for m oderate events and at the levelofa few hundreds ofm $\mathrm{s}^{1}$ for giant ares. However, giant ares are also heavily correlated $w$ ith $H$ variation and so can be easily rem oved from a radial-velocity cam paign, albeit at the cost of precious observing tim e. Indeed, we m ay have view ed such a scenario in one of our stars G J1253.

Fig. 7 show stw o epochs of spectroscopic m easurem ents of the region around the $H$ line for the star G J1253. T he upper panel is the rst observation, m ade on 08/30/2008, whereas the lower panel show s the sam e region only one $m$ onth later (09/26/2008). In the rst observation there is no indication of any $H$ em ission present, how ever only 27 days later $w$ hen the second $m$ easurem ent was obtained, there is clear evidence for the $H$ line in em ission. Such a short period evolution of the line, coupled w th the relatively low v sin i of the star ( $4.5 \mathrm{~km} \mathrm{~s}{ }^{1}$ ) m ay indicate that a sm all m agnetic region is rotating in and out of view. If con m ed continuous m onitoring of such H line changes could lead to the true rotation period of the star, rem oving the sin i degeneracy and giving both the true velocity and, for any discovered com panions, their true $m$ asses $w$ thout the need for continuous photom etric $m$ onitoring. $N$ ote that B yme et al, (1996) found variable $H$ em ission in the activeM starHK A quariiw hich they attribute to prom inence like clouds above the stellar surface that have characteristic tim escales less than half the photom etrically determ ined rotation period. It $m$ ay be the case that such variability of $H$
ux ism ainly generated through ares or a changing $m$ agnetic eld structure. Indeed, H vari-
ability for $M$ stars is signi cant across the spectral dom ain, even on relatively short tim e scales (<60 m inutes). Lee et al, (2009) nd that 80\% of their $m$ id-to-late $M$ star sam ple exhibited statistically signi cant H variability. Therefore, if any correlation does exhist betw een H variabilty and rotation velocity the characteristics $m$ ust be su ciently large such that typical short period sm all scale variations do not $m$ ask it out.
$F$ inally, we also searched for signi cant $H$ absorption and found eight stars ( $14 \%$ ) that show signi cant absonption. All of these have $v \sin$ is that would $m$ eet our criteria for planet search selection, as would be expected from a rotationactivity connection. Only, 2 out of the 8 ob jects that exhibit signi cant $H$ absorption are below our resolution lim it, w ith a further 3 in agreem ent w ith the adopted resolution lim it to w ithin the estim ated total uncertainty of the analysis technique. A ll stars w ith no $H$ em ission would $m$ eet our criteria for planet search selection, w ith the largest rotation rate of these com ing from the M 5 dwarf G J1182 (v sin i=6.8 $0.5 \mathrm{~km} \mathrm{~s}{ }^{1}$ ). Column 13 of Table 3 shows the H em ission ag, where either a detection was made or not, and stars w ith no signi cant em ission which have asterisks show evidence for H absonption.

### 3.3. Spectroscop ic B inaries

There is the possibility that stars $w$ ith $m$ iss shapen pro les are spectroscopic binaries of sim ilar spectral type or stars w ith pow erfulm agnetic
elds. Fig 8 show sblended pro les found forboth G J1080 (upper panel) and LH S3080 (low er panel). It is clear that for both of these system $s$ there is a prim ary deconvolved pro le and a weaker secondary. To test if these are real rather than deconvolution artifacts, we split the spectra into two w avelength ranges, one spectrum covering the blue orders and one covering the red orders. By deconvolving both the red and blue spectra independently, we were able to con $m$ that these stars still exhibit double line pro les, lending w eight to fact that the double pro les are due to real phenom ena. The spectra for G J1080 show s doublelined pro les for atom ic and $m$ olecular lines. The double-lined pro les for LH S3080 were di cult to con m by eye in the spectrum. A long with both of these, there are another two binary system s , those of G J3129 and G 1802. B oth of these stars
have double pro les, but w ith much w ider separations, even though they exhibit noisier spectra. $T$ hese are $m$ ore clear cases than the previous tw o since they also have double $H$ em ission pro les.

G 1802 was known to have a low-m ass com panion w ith an onbital period of $3.14 \quad 0.03 \mathrm{yrs}$ (P ravdo et al, 2005), which was directly im aged by L loyd et al, (2006). In addition, Ireland et al, (2008) has recently found this star to be part of a triple system, w ith a short period (P 19 hrs ) spectroscopic com panion. Our nal deconvolution for this star is very noisy, in part due to the blended light from three di erent com ponents w ith di erent spectral pro les. W e do note how ever that there are two strong pro les in the nal deconvolution (properties listed in Table 1) and potentially a further two weaker pro les. The weak pro les are only borderline signi cant due to the associated noise, but one $m$ ight explain the short period binary found by Ireland et al and the other, which is widely separated from the pro le of G 1802A, could be an additional longer period com panion.

M © arthy \& Zuckerm an (2004) surveyed both G J3129 and LHS3080 as part of their AO cam paign to detect substellar com panions to a host of nearby young $M$ dwarfs. They found no vi$a b l e$ candidate to these stars betw een around $5^{\infty}$ to $15^{\infty}$ arcseconds. The lack of any viable detection around these, apparently young, stars is probably explained by the close separation of the objects, since the detectability of spectroscopic binaries are skew ed tow ards short period com panions. Indeed, the LH S3080 pro les are blended w ith each other and since the secondary pro le is signi cantly weaker than the prim ary, it is probably a much later and fainter com panion object. $T$ he properties of these spectroscopic binaries are listed in Table 1, which include the $H$ ipparcos $V$, 2MASS J,H and $K_{s}$ apparent $m$ agnitudes, their spectraltypes, the velocity separation of the double peaks along with their combined uncertainties, the $v \sin i$ estim ates for both the prim ary star ( $v \sin i_{\text {pri }}$ ) and the secondary ( $v \sin i_{\text {sec }}$ ) and the $H \quad$ ag. $N$ ote the $s m$ all uncertainties are an artifact of the blended tting procedure and do not necessarily $m$ ean these values are $m$ ore precise than the single pro les.

## 4. Tem perature, $M$ ass and $M$ etallicity

W hen perform ing radial-velocity searches for exoplanets other characteristics of the star deter$m$ ine radial-velocity lim its e.g. the stellar $m$ ass. $T$ he $m$ ass of the prim ary determ ines the lower lim it to the planetary $m$ ass for a given radialvelocity am plitude and therefore know ledge of the $m$ ass of any planet search target star is essential. We have determ ined the stellar $m$ ass for the bulk of our sam ple by utilising relations between M star mass and their absolute magnitudes. To generate accurate absolute magnitudes we searched the Yale Trigonom etric $P$ arallax pro ject (van A ltena et al. 1995), the RECONS list (Henry et al, 2006) and any parallaxes in the $G$ liese C atalogue of $N$ earby Stars to obtain accurate parallax $m$ easurem ents for all our candidates. The parallaxes, along w th their associated uncertainties, are shown in column 8 of Table 3 and these w ere used to determ ine the absolute $m$ agnitudes by converting them to distance and $m$ easuring the distance $m$ odulus. The photom etry was acquired using both the Simbad ${ }^{2}$ and $V$ iziet $\sqrt{3}$ astronom ical databases. T he near infrared photom etry wastaken from the 2M A SS catalogue (Skrutskie et al, 2006) and the $\mathrm{K}_{\mathrm{s}} \mathrm{m}$ agnitudes were converted to $K$ using the calibrations in C anpenter (2001). T he absolute $V$ and $K \mathrm{~m}$ agnitudes were then input into the em piricalm ass relations from D elfosse et al. (2000), and tw $o m$ easurem ents of the $m$ ass for each star w ere determ ined. B oth these $m$ easurem ents were averaged to get the nal combined $m$ ass estim ates for all ob jects w ith known parallax and their uncertainties were taken as the standard deviation of the two $m$ easurem ents. T he uncertainties are typically 10-15\%, w ith a few of the closest stars having uncertainties dow $n$ to the $1 \%$ level. B oth the $m$ asses and their uncertainties are show $n$ in colum n 9 of Table 3 .

A long w ith the m ass, both the ective tem peratures and $m$ etallicities ( $\mathrm{Fe} / \mathrm{H}]$ ) were estim ated for the sam ple. The e ective tem peratures were determ ined using the $V \quad K_{s}$ relation taken from C asagrande et al, (2008) and has a typical internal uncertainty of 17 K , how ever the uncertainty on the overallaccuracy of the technique will prob-

[^1]ably be substantially larger than this. The values $w$ ith question $m$ arks next to them ag highly suspect e ective tem peratures. The $\mathbb{F e} / \mathrm{H}]$ abundancesw ere rstly determ ined photom etrically using the colourm agnitude relation in B on ls et al. (2005). They quote the typical uncertainty for this $m$ ethod as 02 dex which we assign to all our m etallicities shown in colum n 10 of $T$ able 3. C asagrande et al also provide $m$ etallicities using their $m$ ethod and these agree with the Bon ls et al. values within the quoted uncertainties. N ote that recently Johnson \& A pps (2009) claim that the $B$ on ls et al. relation $m$ ay underestim ate the $m$ etallicities of $M$ dwarfs by as much as 0.3 dex. Finally, Table 3 also show seach star's $V$; J; $H$ and $K_{s}$ photom etry.

## 5. R esults: v sin iD istributions

Fig. 9 shows the distribution of early-tolate $M$ star rotation rates against their spectral type. The led circles represent the stars in this work and the open circles represent literature v sin is (from Stau er \& H artm anr 1986; M arcy \& C hen 1992; D elfosse et al. 1998; G izis et al 2002; M ohanty \& B asr 2003; B ailer-Jones 2004; Fuhm eister \& Schm itt 2004; Jones et al, 2005; Reiners 2007; W est \& B asr-2009). A ll literature $v \sin$ is are shown in Table 4 along w ith any m easured $V \mathrm{~m}$ agnitudes, $2 \mathrm{MASS} \mathrm{J}, \mathrm{H}$ and $K_{s}$ photom etry, spectraltypes, e ective tem peratures, parallaxes, $m$ asses and $\mathbb{F e} / \mathrm{H}]$ abundances, all determ ined using the sam e m ethods outlined above.
$T$ here is a large spread in $v$ sin i across the $m$ id $M$ star regim e (M4.0-M 6.5) com pared w ith early $M$ stars (<M4). Them id $M$ ob jects range from al$m$ ost as high as over $50 \mathrm{~km} \mathrm{~s}{ }^{1}$ and down as low as essentially zero $\mathrm{km} \mathrm{s}{ }^{1}$. Them edian dispersion of the $v \sin i$ distributions in the spectral type bins betw een M $0-\mathrm{M} 3$ is $3.70 \quad 0.79 \mathrm{~km} \mathrm{~s}{ }^{1}$, com pared to the m edian dispersion of $9.00 \quad 8.31 \mathrm{~km} \mathrm{~s}{ }^{1}$ for bins at M $4-\mathrm{M} 9.5$. H ow ever, if we allow for a spectraltyping uncertainty of 0.5 sub-types and exclude both the M 0 and M 9.5 spectralbins, since they could be contam inated by $K$ and $L$ dwarfs, we nd the dispersions are $3.70 \quad 0.87 \mathrm{~km} \mathrm{~s}^{1}$ and $9.004 .37 \mathrm{~km} \mathrm{~s}^{1}$ respectively. A $\mathrm{K}-\mathrm{S}$ test is run to com pare these distributions and this retums a D -statistic of 0.539 , giving an extrem ely low prob-

ability ofonly $1.396 \times 10{ }^{8}$ \% that the rotation rates for stars betw een M $0.5-\mathrm{M} 3$ are drawn from the sam e parent population as those betw een M 4 M 9 . A lso, a large fraction of stars $w$ ith spectral types below M 6.5, and particularly below the convective boundary region, only have $m$ easured upper $\lim$ its. This will bias this result tow ards a noncorrelation and so we can expect that with further detections at low velocities for these stars, this correlation $w i l l$ becom e $m$ ore pronounced.

This step from low to high dispersions between M 3 to M 4 spectral types is thought to be due to the increased spin-down tim escale tow ards decreasing $m$ ass D elfosse et al, 1998; M ohanty \& B asm 2003) and that the spin-down tim escale is a signi cant fraction of the age of the young disk. Indeed, D onatiet al, (2008) and M orin et al. (2008) have shown that the $m$ agnetic
eld topologies of early M's (M 0-M 3) and midM 's (M4) are signi cantly di erent, w ith the early $M$ 's having $m$ ainly toroidaland non-axisym $m$ etric poloidal elds, whereas the M 4s mainly exhibit axisym $m$ etric poloidal elds. This result indicates a change in the $m$ agnetic eld properties at the classicalboundary betw een partially radiative and fiully convective envelopes. If the spin dow $n$ tim es are govemed by the $m$ agnetic elds in this regim e then a di ering $v \sin i d i s t r i b u t i o n ~ m i g h t ~ b e ~ e x-~$ pected. It $m$ ight be the case that axisym $m$ etric poloidal elds interact $w$ ith the stellar $w$ ind $m$ ore weakly than the toroidal, non-axisym $m$ etric elds, driving a less e cient braking $m$ echanism. Interestingly, a probe of the spindow $n$ tim escale and the $m$ echanism driving it can be $m$ ade if $w e$ take the $D$ elfosse et al and $M$ ohanty \& Basriv sin i and $\log \left(L_{H} / L_{B o l}\right)$ values $(M$ ohanty \& Basrishow the activities in these tw o w orks to be in excellent agreem ent). W e can use these values to trace the rotational history for the fully convective, m id$M$ star regin e (M4M7). W hen the stars are binned into their respective spectral types, the trend found betw een these tw o quantaties reveals a shanp saturation boundary (e.g. F ig. 9 in M O hanty \& B asri). By using Eqn. 3.1 in W est et al, (2009), one can use the activity values to gain a statisticalinsight into the age distribution of these sam ples. In particular, the saturation boundary changes as a function of spectral type, increasing in velocity w ith increasing spectral type. Table 2 show s the spectral type bins, along w ith the sat-
uration boundary in velocity and activity lifetim e (l) given in $W$ est et al. $D$ ue to the spindown of stars by the $w$ ind braking $m$ echanism we can use this table to say that from a statistical footing, the average age of M 4 stars $w$ ith $v \sin$ is
$8 \mathrm{~km} \mathrm{~s}{ }^{1}$ is older than $5 \mathrm{Gyrs}, \mathrm{M} 5 \mathrm{~s}$ w th velocities $10 \mathrm{~km} \mathrm{~s}{ }^{1}$, and M 6s with velocities
$12 \mathrm{~km} \mathrm{~s}{ }^{1}$, are older than 7 G yrs and M 7sw ith velocities $13 \mathrm{~km} \mathrm{~s}{ }^{1}$ are older than 8 G yrs.

F ig. 10 show $s$ the v sin $i$ values against spectral type for all stars in this study $w$ ith a split m ade by their H status. The led circles represent all stars w ith no signi cant H em ission or absorption, the open circles represent stars w ith H absorption and the open stars represent objectsw ith H em ission. The rotation-activity connection suggests a correlation between $H$ em ission and the rotation velocity of coolm stars and this is clearly seen in this plot. All stars with $\mathrm{v} \sin \mathrm{i} \quad 7 \mathrm{~km} \mathrm{~s}{ }^{1}$ are found to exhibit significant H em ission. Indeed, we have just shown that, on average, $m$ id-to-late $M$ stars $w$ ith velocities $8 \mathrm{~km} \mathrm{~s}{ }^{1}$ are still in their young, active phase of evolution. N o stars later than M 5 were found to exhibit H absorption, w ith ve of these exhibiting no signi cant H em ission (55\%). Such num bers correlatew ith previous results w hich suggest a high frequency of active $M$ stars tow ards the latest spectraltypes (e.g. F lem ing et al 2000; M ohanty et al 2002), even though we nd a sim ilar fraction of active $M$ stars in all of our spectral bins. H ow ever, in our nalm 6.5 bin both stars are found to exhibit H em ission which agrees w ith the increasing trend of activity tow ards values approaching 100\% at a spectral type of around M 7 . $T$ his increase in stars w ith H in em ission tow ards later spectral types appears to be a product of the fraction of young disk stars in this regim $e$ and also the increase in activity lifetim e w ith increasing spectral type. From Table 2 we see that both the activity lifetim $e$ and the tim e spent in a state of high rotation increases w ith increasing spectral

type. Such trends would naturally give rise to a larger fraction of stars w ith $H$ pro les in em ission tow ards the latest $M$ stars.

The led stars in F ig. 9 represent the m edian values in each spectralbin along $w$ ith their associated P oisson errors. The solid line connects the points and visually highlights the increasing trend tow ards later spectral types. Reid et al, (2002) suggest a at distribution of rotation rates betw een stars of M 6 M 9 , whereas larger sam ples indicate this $m$ ay not be the case $(M$ ohanty et al; Reiners \& B asr-2008) . The m edians indicate a rising trend through the m id-to-late M dwarfs,
attening $\circ$ tow ards the end. D ue to the change in distributions at the fully convective boundary we perform two straight line ts to the $m$ edians in the spectral ranges $\mathrm{M} 0-\mathrm{M} 3.5$ and $\mathrm{M} 4-\mathrm{M} 9$. The best $t$ to the early $M$ stars clearly shows a at trend across the whole regim e, whereas the $t$ to the late M s show a rising trend, appearing to
atten tow ards the later M stars (note the curvature due to logarithm ic plotting). T he ts to the early and late $M$ star sam ples are described by $v \sin i=0.09(0.30) x S p T+3.41(0.67) \mathrm{km} \mathrm{s}^{1}$ and $v \sin i=2.10(0.53) \times S p T-4.54(3.56) \mathrm{km} \mathrm{s}^{1}$, $w$ ith standard uncertainties, represented by the dotted lines in the plot, of $0.89 \mathrm{~km} \mathrm{~s}{ }^{1}$ and
$2.79 \mathrm{~km} \mathrm{~s}{ }^{1}$ respectively. The total sam ple of less than 300 is still rather sm all, especially when binned. Indeed there appears a dearth of objects betw een M 6.5 M 8.5 w th rotation rates above
$15 \mathrm{~km} \mathrm{~s}{ }^{1}$, which m ay indicate another population change above M 6.5. The evidence for this gap is weak at present due to the low number of stars in these spectral bins, therefore further observations and are needed and any biases studied to fully validate the existence of this feature.

At temperatures below around 2800K (approxim ately M 6-M 7 type ob jects) dust form ation and opacity are im portant in stellar/substellar atm ospheres (T suïet al, 1996; Jones \& T suit1997; T inney et al 1998; C habrier et al, 2000; B ara e et al. 2002 and references therein). B erger et al, (2008) have show $n$ that late $-M$ starsm ark a transition in the properties of the $m$ agnetic eld and its dissipation, along w ith high tem perature plasm a being generated in the outer atm osphere. They go on to hypothesize that the stellar rotation $m$ ay play a part in this process and indeed the di erence show $n$ here betw een the $m$ id and late type
$M$ stars seem $s$ to add to this conclusion. A $K-S$ test reveals a D -statistic of 0.639 , or $5.413 \times 10{ }^{6} \%$, that stars in the range M 0.0 M 6.5 and those in the range M $7.0-\mathrm{M} 9.5$ are drawn from the sam e parent distribution. H ow ever, given that we have already show $n$ there to be a large di erence betw een early M s (M 0-M 3.5), this w ill bias this probability test. W hen we rem ove all stars earlier than M 4 we nd a D statistic of 0.544 , which relates to a probability ofonly $1.437 \times 10{ }^{3} \%$ that these are draw $n$ from the sam e parent population. This $>5$ result $m$ ay indicate that at tem peratures when dust opacity becom es im portant there is a change in the rotationalbraking $m$ echanism $s$ and hence the $m$ agnetic properties of ultracool dw arfs. This $m$ ight give rise to the attening trend indicated betw een M 6.5 M 9 stars, how ever a m ore com prehensive study is needed, particularly to decouple the age of these stars by studying the space $m$ otion to detem ine if they are young or old disk stars. A lso the biases of the literature surveys are im portant. For instance, studies like those of W est \& B asr(2009) focus only on selecting inactive, and hence slow ly rotating, late type $M$ stars. In addition, current m odels show that the late M star regim e can also be populated by young brown dwarfs. $F$ inally, this relation also su ers from the lack of low v sin i detections already mentioned above, even more so given the M 6.5 detection boundary. Therefore we expect this result $m$ ight also becom em ore pronounced w ith further low $v$ sin $i$ detections at spectral types below M 6.5.

The norm alized distribution of $v \sin$ is are represented by the histogram s in Fig. 11, where the solid histogram is for allstars in the spectral range between M 0-M 3.5 and the dashed histogram is for all stars in the range M 4 M 9.5 . These include all values determ ined in this work combined w ith those in the literature. It is apparent that both distributions peak at low rotation rates ( $3 \mathrm{~km} \mathrm{~s}{ }^{1}$ ), w ith peak values of 55 and 42 stars respectively. We nd that the total num ber of $\mathrm{v} \sin$ is $10 \mathrm{~km} \mathrm{~s}{ }^{1}$ is 198 and these should represent usefiul stars for future near infrared radial-velocity planet search pro jects such as PRVS. Bouchy et al, (2001) show that the inform ation content drops by a factor of 3.5 between rotation velocities of $2-10 \mathrm{~km} \mathrm{~s}{ }^{1}, \mathrm{mak}^{-}$ ing $\quad 10 \mathrm{~km} \mathrm{~s}{ }^{1}$ a reasonable M star radialvelocity selection cut. This sam ple is still large
(124) when we include all m id-to-late M stars in the range M 3-M 9.5 (stars where obtaining optical precision radial-velocities becom es extrem ely di cult). $N$ ote the binary system s have been left out of $F$ igs. 11 and 9 since the com bined lum inosities w ill generate inaccurate photom etry and therefore inaccurate spectral types. A lso, binary system s like these $m$ ake radial-velocity exoplanet searches $m$ uch harder since any sm allplanetary signature is $m$ asked by the large short period binary velocity, $m$ eaning these are not ideal planet search targets for precision radial-velocity program sm oving into an unexplored param eter space.

C om paring the distributions ofboth histogram s helps to probe the possible changing rotation properties ofM stars at the fully convective boundary. W e have em ployed tw o pow er law ts to each distribution separately in order to test the changing velocity distribution betw een these two regim es. The red (dark grey) $\sqrt[4]{4}$ curve is $t$ to the sample of early M dwarfs between M 0-M 3.5, whereas the green (light grey) curve is $t$ to the $m$ id-to-late $M$ dw arfsam ple. The ts are $m$ ade to the bins by including $P$ oisson uncertainties w hich are not show $n$ in the plot for clarity. It can be seen that the $t$ to the early $M$ stars drops $m$ uch $m$ ore rapidly than the $t$ to the later M S. T he power laws are described by $N / v \sin i / x^{3: 13}$ for the early M $S$, whereas for the later MS it is only found to be / $x^{1: 12}$, highlighting the di ering steepness of each slope. T he early M s have a much longer tail than the later M s due to this faster decay of the distribution and this is also probably an underestim ate since we included all upper lim its in the data to increase the sam ple size, which included a number of stars from the Stau er \& $H$ artm anr (1986) sam ple with detection lim its of $10 \mathrm{~km} \mathrm{~s}{ }^{1}$. W e note that the curvature of these slopes are also a ected by the activity lifetim es shown in Table 2 since they change w ith spectral type.

The di erence of 2.01 in the exponent betw een the tw o spectral sam ples allow s us an insight into the $e$ ciency of the braking $m$ echanism between partially and fully convective stars, assum ing the larger $m$ easured rotation in the later $M$ star sam ple is not due to increased line blending from

[^2]increased $m$ olecular bands and instrum ental resolution argum ents. D elfosse et al (1998) have show $n$ that them a jority of rapidly rotating $m$ id $-M$ stars are $m$ em bers of the young disk population, $w$ hereas the older population tend to rotate $m$ ore slow ly. If this is indeed the case, then the braking $m$ echanism is at play in later $M$ stars but the e ciency has dropped across the fully convective boundary. As m entioned earlier, the change in the eld topology betw een the partially and fully convective boundary is probably the driving factor which govems the e ciency of the wind braking $m$ echanism since einers \& B asm (2007) have shown that fully convective stars produce eld strengths as strong as partially convective stars. To better probe the braking $m$ echanism in this fashion, in addition to gaining $m$ ore data, it is necessary to also fold in an age proxy for the sam ple, and decouple both the young and old disk populations to com pare these ob jects. A long w ith this a better understanding of the activity lifetim es and how these change with spectral type should be considered. M ore $m$ agnetic eld topology studies are required for later $M$ stars which can help to con m if the later M s also have axisym etric poloidal elds and add weight to the topology argum ent. F inally, $m$ ore detailed testing of changes around the dusty regim e ( M 6.5) where stars can also be young brow $n$ dwarfs $m$ ight usefiully be investigated.

## 6. C onclusions

W e present the in itial results from our study of rotation rates for a range of $M$ stars as part of our target selection for a P RV S-like planet search pro ject. W e observed over 50 M stars w ith HRS on the HET with the aim of selecting the slowest rotators in order that a near infrared planet search survey, such as PRV S, shall have a statistically large sam ple of $M$ stars where highly precise radial-velocity $m$ easurem ents can be accrued. Of our sam ple of 49 suspected single $M$ stars betw een M 3 M 6.5 , we nd 36 have $\mathrm{v} \sin$ is $10 \mathrm{~km} \mathrm{~s}{ }^{1}$ which will represent good radial-velocity targets. W hen we include all literature $M$ stars in the optically di cult radial-velocity regim e (M 3-M 9.5) we nd this value increases to 124.
W ealso con $m$ the increase ofrotationalvelocities betw een early to m id $M$ stars. This change at
the fully convectiveboundary seem sto be linked to a change in the topology of the $m$ agnetic elds betw een such stars, indicating axisym etric poloidal
elds drive a less e cient wind braking $m$ echanism. A lso there is an initial indication that stars w ith spectraltypes in the range M 6.5 M 8.5 have a di erent rotationalvelocity distribution com pared w th those ofbelow M 6.5, as the distribution appears to atten o beyond this regim e. Since this is around the tem perature where dust opacity becom es im portant ( 2800 K ), there $m$ ay be another change in the $e$ ciency of the braking $m$ echanism in such stars which could indicate another m agnetic eld topology change. In addition, we also show how know ledge of the $v \sin i$ can be used to put a lower, or upper, lim it on the age ofm idM dwarfstars, since the rotation-activity relation has a tem perature dependent saturation level.

W e also highlight the rotation-activity relation through em ission, or lack thereof, of the $H$ line. $T$ here appears a boundary of around $7 \mathrm{~km} \mathrm{~s}{ }^{1}$ between stars w ith and w thout H em ission, w ith the fast rotators alm ost alw ays exhibiting such em ission, how ever since the sin i degeneracy is present it is di cult to account for any m em piricalboundaries w ith sm all num bers. W e observed the star G J1253 over tw o epochs and found the H em ission had sw itched on over a period of less than one $m$ onth. This $m$ ay be due to an active region rotating in and out of our eld of view with a period equal to the rotation period of the star, or due to a aring event.

W e have also discovered three spectroscopic binary system $s$ and con $m$ ed another. Both com ponents in the G J1080 system produce fairly sim ilar pro les, indicating they are of sim ilar spectral type, the secondary likely a little cooler and less lum inous. The pro les for G J3129 and G 1802 are w idely separated and both of these exhibit double H em ission features. G 1802 is also a known triple system, but we nd evidence for another com panion in the system, how ever given the noise due to blended light from at least three separate sources the evidence is weak. In com parison to these fairly strong pro les the secondary pro le in the LH S3080 system is signi cantly weaker, indicating the companion is signi cantly cooler than its host star. Finally, we have agged other M dwarfs where there is som e evidence for binary com panions in these system s .
