G as D ynam ics and Star Form ation in the G alaxy Pair NGC 1512/1510?

ABSTRACT

Here we present H i line and 20-cm radio continuum data of the nearby galaxy pair NGC 1512/1510 as obtained with the Australia Telescope Compact Array (ATCA). These are complemented by GALEX UV-, SINGG H - and Spitzer mid-infrared in - ages, allowing us to compare the distribution and kinematics of the neutral atom ic gas with the locations and ages of the stellar clusters within the system.

For the barred, double-ring galaxy NGC 1512 we nd a very large H idisk, 4 its optical diam eter, with two pronounced spiral/tidalarm s.B oth its gas distribution and the distribution of the star-form ing regions are a ected by gravitational interaction with the neighbouring blue compact dwarf galaxy NGC 1510.W hile the inner disk of NGC 1512 show squite regular rotation, deviations are visible along the outer arm s and at the position of NGC 1510.From the H i rotation curve of NGC 1512 we estimate a dynam ical mass of M $_{\rm dyn}$ $^>$ 3 10^{11} M , compared to an H i mass of M $_{\rm H\,I}$ = 5:7 10^9 M (2% M $_{\rm dyn}$).

The twom ost distant H iclumps, at radii of 80 kpc, show signs of star form ation and are likely tidal dwarf galaxies (TDGs). Both lie along an extrapolation of the eastern-most H i arm, with the most compact H icloud located at the tip of the arm.

The 20-cm radio continuum m ap indicates extended star form ation activity not only in the central regions of both galaxies but also in between them . Star form ation (SF) in the outer disk of NGC 1512 is revealed by deep optical- and two-color ultraviolet im ages. U sing the latter we determ ine the properties of > 200 stellar clusters and explore their correlation with dense H i clumps in the even larger 2X H i disk. Outside the inner star-form ing ring of NGC 1512, which m ust contain a large reservoir of m olecular gas, H i turns out to be an excellent tracer of SF activity.

The multi-wavelength analysis of the NGC 1512/1510 system, which is probably in the rst stages of a minor merger having started 400 M yr ago, links stellar and gaseous galaxy properties on scales from one to 100 kpc.

1 IN TRODUCTION

The Local Volum e (LV), generally considered as the sphere of radius 10 M pc centred on the LocalG roup, contains m ore than 500 galaxies. For the m a prity of these galaxies reliable distances are currently available (K arachentsev et al. 2004, 2008). Independent distances, such as those obtained from the lum inosity of C epheids, the tip of the red giant branch (TRGB), and surface brightness uctuations (SBF) are an

essential ingredient, together with accurate velocities and detailed multi-wavelength studies of each LV galaxy, for the assembly of a dynam ic 3D view of the Local Universe. This, in turn, leads to a better understanding of the local ow eld, the localm ass density and the local star-form ation density. Interferom etric H im easurem ents, in particular, provide insight into the overall matter distribution (baryonic and non-baryonic) in the Local Volum e.

The galaxy pair NGC 1512/1510 is located in the outskirts of the Local Volume and its study forms part of the Local Volume H i Survey' (LVHIS; Koribalski et al. 2008). Since no TRGB distance is currently available for NGC 1512, we use its Local Group velocity, v_{LG} =

712 km s¹, to compute a Hubble distance of 9.5 M pc. | LV H IS is a large project^Y that aim s to provide detailed H idistributions, velocity elds and star form ation rates for a complete sample of nearby, gas-rich galaxies. W ith the A ustralia Telescope Compact A rray (ATCA), we observed all LV galaxies that were detected in the H iParkes A ll-Sky Survey (H IPASS; Barnes et al. 2001, K oribalski et al. 2004) and reside south of approx. {30 declination.

The closest neighbours to the NGC 1512/1510 system are (1) the edge-on spiralgalaxy NGC 1495 (H \square ASS J0358(44), (2) the galaxy pair NGC 1487 (H \square ASS J0355(42) and (3) the galaxy ESO 249-G 026 (H \square ASS J0354(43), all located at projected distances of more than 1:5. W ithin 3 (0.5 M pc) we nd 15 neighbours, suggesting that the NGC 1512/1510 system is part of a loose (spiral) galaxy group (LGG 108; G arcia 1993).

The barred galaxy NGC 1512 and the blue compact dwarf (BCD) galaxy NGC 1510 are an interacting galaxy pair, separated by only 5^0 (13.8 kpc).At the adopted distance of 9.5 M pc, 1^0 corresponds to 2.76 kpc.Table 1 gives som e basic properties of both galaxies.

The optical appearances of both galaxies are well described by H awarden et al. (1979).NGC 1512 (IRAS 04022{4329) is a large, strongly barred galaxy with two prom innent star-form ing rings. Its morphological type is generally given as SB (r)a or SB (r)b. The companion, NGC 1510 (IRAS 04019{4332}), is a much smaller, peculiar S0 or lenticular galaxy. Their respective optical diam eters are 8° 9 5% and 1% 0%7, i.e. NGC 1512's stellar disk is about seven tim es larger than that of NGC 1510.

Beautiful multi-color HST images of NGC 1512 by

M aoz et al. (2001) clearly show the structure of the nuclear region (< 20^{00} 1 kpc): a bright nucleus surrounded by a smooth, dusty disk which is enveloped by a highly ordered and narrow starburst ring of diam eter 16^{00} 12^{00} with a position angle (PA) of 90 . This nuclear ring is also evident in the J K map by Laurikainen et al. (2006) and in the Spitzer m id-infrared im ages obtained as part of the SINGS project (K ennicutt et al. 2003). The dust lanes hint at a tight inner spiral structure within the nuclear disk. Fabry-Perot H observations of NGC 1512 by Buta (1988) show that the nuclear ring has a rotational velocity of v_{rot} 200{ 220 km s¹ (assum ing an inclination angle of 35). Beyond the nuclear ring, which lies within the bulge (< $1^0 = 2.8$ kpc) at the centre of the bar, v_{rot} appears to be roughly constant.

H in ages of the inner region (< 4^{0} 11 kpc) of NGC 1512 (SINGG project; M eurer et al. 2006) reveal a second star-forming ring of approxim ate diam eter 3^{0} 2^{0} at PA 45, i.e. about ten times larger than the nuclear starburst ring; its width is 20^{00} 40^{00} . This inner ring is composed of dozens of independent H ii regions with typical sizes of 2^{00} 5^{00} . The bar, which has a length of 3^{0} (8.3 kpc), lies roughly along its m a jor axis. Som e enhancem ent of the star form ation is seen at both ends of the bar where the spiral arm s com m ence.

The optical data presented by K inm an (1978) and H awarden et al. (1979) revealed, for the rst time, signs of tidal interaction between NGC 1510 and NGC 1512. Sandage & Bedke (1994) describe NGC 1512 as an alm ostnorm al SBb(r) where interaction with NGC 1510 distorts the outer thin arm pattern. The stellar spiralarm s are m ost prom inent in deep optical im ages (see Fig. 1) as well as the GALEX ultraviolet (UV) im ages by Gilde Paz et al. (2007a), allofwhich give a stunning view of the star-form ing regions in NGC 1512's outer disk. A sketch identifying im portant stellar and H i features of the interacting system NGC 1512/1510 is provided on the right side of Fig. 1.

NGC 1510 is a low m etallicity (Z 0.2 Z) BCD galaxy (see also Section 4.6). H aw arden et al. (1979) suggested that its em ission line spectrum and blue colors are the consequence of star form ation activity in the m aterial | basically H i gas | recently (300 M yr) accreted from NGC 1512, m in icing the properties of a red am orphous dwarf elliptical galaxy. This hypothesis is also supported by E ichendorf & N ieto (1984), who identi ed several low m etallicity starform ing regions in NGC 1510. O ne of them (the SW com – ponent) reveals a broad 4686 H e ii line which is attributed to the presence of an important population of W olf-R ayet (W R) stars in the burst.NGC 1510 is therefore classi ed as

W olfRayet galaxy (Contil991; Schaerer, Contini& Pindao 1999).

H aw arden et al. (1979) also present rem arkable H idata for the galaxy pair. Their 24-pointing H im ap obtained with the 64-m Parkes telescope reveals a large neutral hydrogen envelope around NGC 1512, encom passing its neighbour, NGC 1510.K oribalskiet al. (2004) m easure an integrated H i ux density of $F_{\rm H\,I}$ = 259 17 Jy km s¹ for the galaxy pair, nam ed H IPA SS J0403{43 in the H IPA SS B right G alaxy C atalog (see Table 1). The detected H i em ission is centered on NGC 1512 and signi cantly extended with respect to the Parkes gridded beam of 15%5. H aw arden et al. (1979) m easured F_{H I} = 232 20 Jy km s¹ (sam e as Reif et al. 1982), slightly low er than the H IPA SS value.

Here we present high-resolution ATCA H i line and 20cm radio continuum data of the galaxy pair NGC 1512/1510 as well as complimentary GALEX UV-, SINGG H - and Spitzer m id-infrared images. The paper is organised as follows: in Section 2 we sum marise the observations and data reduction; in Section 3 we present the H i line and the 20cm radio continuum results, including our discovery of two tidal dwarf galaxy candidates. The discussion in Section 4 exploits the available multi-wavelength data sets, com paring the H i gas density with the properties of star-form ing regions out to radii of 80 kpc. Section 5 contains our conclusions and Section 6 a brief outlook towards H i surveys with the Australian SKA Path nder (ASKAP).

2 OBSERVATIONS AND DATA REDUCTION

H i line and 20-cm radio continuum observations of the galaxy pair NGC 1512/1510 were obtained with the Australia Telescope C om pact A rray (ATCA) using multiple congurations and four (overlapping) pointings. The observing details are given in Table 2. The rst frequency band (IF1) was centered on 1415 M Hz with a bandwidth of 8 M Hz, divided into 512 channels. This gives a channel width of 3.3 km s¹ and a velocity resolution of 4 km s¹. The ATCA prim ary beam is 33% at 1415 M Hz. The second frequency band (IF2) was centered on 1384 M Hz (20-cm) with a bandwidth of 128 M Hz divided into 32 channels.

The ATCA is a radio interferom eter consisting of six 22-m dishes, creating 15 baselines in a single con guration, equipped with seven receiver systems covering wavelengths from 3-m m to 20-cm. W hile ve antennas (CA 01 to CA 05) are movable along a 3-km long east-west track (and a 214-m long north-south spur, allowing us to create hybrid arrays),

one antenna (CA06) is xed at a distance of 3-km from the end of the track. By combining data from several array con guration (see Table 2) we achieve excellent uv-coverage generated by over 100 baselines ranging from 30-m to 6-km. U sing Fourier transform ation, this allows us to make data cubes and images at a large range of angular resolutions (up to 6^{00} at 20-cm) by choosing di erent weights for short, m edium and long baselines which in turn are sensitive to di erent structure scales. The weighting of the data a ects not only the resolution, but also the m s noise and sensitivity to di use em ission.

D ata reduction was carried out with the miriad software package (Sault, Teuben & Wright 1995) using standard procedures. A fler calibration the IF1 data were split into a narrow band 20-cm radio continuum and an H i line data set using a rst order t to the line-free channels. H i cubes were made using hatural' (na) and 'robust' (r= 0) weighting of the uv-data in the velocity range covered by the H i em ission using steps of 10 km s¹. The longest baselines to the distant antenna six (CA 06) were excluded when making the low-resolution cubes. B road-band 20-cm radio continuum im ages were made using 'robust' (r= 0) and 'uniform' weighting of the IF2 uv-data. The data were analysed using miriad, apart from the rotation curve twhich was obtained using the gipsy software package (van der Hulst et al. 1992).

3 RESULTS

The NGC 1512/1510 galaxy pair is an impressive system. OurATCA H imosaic (see Figs. 2{4) shows a very extended gas distribution, spanning a diameter of 40° (or 110 kpc). Two prominent spiral arms, which appear to wrap around

1.5 tim es, are am ong them ost rem arkable H i features. The brightness and width of both H i arm s varies with radius: m ost notably, in the south, A m 1 splits into three branches, followed by a broad region of H i debris towards the west before continuing on as a single feature towards the north. These disturbances in the outer disk of NGC 1512 are likely caused by tidal interaction with and accretion of the dwarf com panion, NGC 1510.

Individual H i clouds belonging to the NGC 1512/1510 system are found out to projected radii of 30° (83 kpc). The velocity gradient detected within the extended clumps agrees with that of the neighbouring spiralarm s, suggesting that they are condensations within the outerm ost parts of the disk. Their H i properties and evidence for optical and UV counterparts are discussed in Section 3.3.

In regions of high H icolum n density, mostly within the arm s and the bridge, star form ation is most prominent. We will analyse the relation between the star form ation rate and the H icolum n density in Section 4.3.

3.1 H i in NGC 1512

The H iem ission from the galaxy NGC 1512 covers a velocity range from about 750 to 1070 km s¹. W e measure an integrated H i ux density of $F_{\rm H\,I}$ = 268 Jy km s¹, which

agrees very wellw ith the H IPA SS F_{H I} reported by K oribalski et al. (2004; see Table 1). This agreem ent indicates that very little di use H iem ission has been litered out by the interferom etric observation. A dopting a distance of 9.5 M pc, the H i ux density corresponds to an H im ass of 5:7 10^9 M . The m a prity of the detected neutral gas clearly belongs to NGC 1512; this is evident from the center and symmetry of the gas distribution and the gas kinem atics. The H i extent of NGC 1512 is at least a factor four larger than its optical B₂₅ size. The H im ass to blue lum inosity ratio is 1.See Table 3 for a summary of the galaxy properties as determ ined from the ATCA H i data.

The interferom etric H i data allow us to determ ine the gas dynam ics of the system . In F ig. 4 we display the H i channelm aps (sm oothed to 20 km s¹ resolution) which show a relatively regular rotating inner disk of NGC 1512 and a m ore disturbed outer disk. Near the system ic velocity the change in the kinem atics at a radius of 5° appears particularly abrupt. The extent and kinem atics of the (spiral) am curving towards the east are spectacular, nearly m atched by a broader, less well-de ned arm curving towards the west. A nother view of the galaxy kinem atics is presented in F ig.5 in form of a m a jor axis position-velocity (pv) diagram . This was obtained by sum m ing the central 20° along PA = 90 us-

ing a 3 cuto to avoid adding excessive noise to the H i signal. It shows the line-of-sight rotation velocity of NGC 1512 as a function of radius. The observed decrease of the H i velocities beyond a radius of $8\{10^{\circ}, \text{ com pared to the inner$ disk, is most likely caused by an increase in the inclination $of the H i disk. This warping of the outer spiral/tidalarm s {$ $which is quite common in spiral galaxies { could be related$ to or potentially caused by the interaction with NGC 1510.

We used the gipsy program rotcur (Begem an 1987) to t the H i rotation curve of the galaxy NGC 1512. As a rst step, we tried to obtain its centre position and system ic velocity, v_{sys}, using verings within the inner velocity eld $(r < 7^{\circ})$. A s the results did not converge, we proceeded with the GALEX peak position for NGC 1512, ; (J2000) = $04^{h} 03^{m} 54^{s}$; 2, {43 $20^{0} 56^{c0}$; 5.W ith this centre position held xed we nd $v_{sys} = 900 5 \text{ km s}^1$. We might expect the kinematic centre position of the NGC 1512/1510 system to shift with radius from the core of NGC 1512 towards its interaction partner, NGC 1510 ($v_{opt} = 989$ km s¹), now located 5° to the southwest. Furtherm ore, we nd the position angle, PA, of NGC 1512 appears reasonably constant 1, while the inclination angle, i, varies sigaround 262 ni cantly.W ith the centre position, $v_{\mbox{\scriptsize sys}}$, and P A set to the values given above, we nd the inclination angle to increase from 30 $(r < 8^{\circ})$ to 46 $(r > 10^{\circ})$. The latter is consistent with the apparent change in the ellipticity (i.e. increasing m a jor to m inor axis ratio) of NGC 1512's gas distribution with radius.

The resulting rotation curve, v_{rot} (r), is shown in Fig.6. The maximum rotational velocities of v_{rot} 225 km s¹ are reached at radiibetween $300^{\circ\circ}$ and $500^{\circ\circ}$. Beyond that v_{rot} rapidly decreases, reaching 110 km s¹ at r = $1200^{\circ\circ}$ (55 kpc). The residual velocity eld (see Fig.7) shows deviations up to approximately 30 km s¹, most notably near the position of NGC 1510 and in the outer spiral/tidal arms. The inner disk also shows deviations along an eastern arc (sim ilar to a one-arm ed spiral) which roughly agrees with the elongated star-forming spiral arm of NGC 1512 seen in the GALEX UV im ages. The passage of the com panion would have unsettled the mass distribution, possibly causing

a density wave or one-arm ed spiral (as seen in the residual velocity eld).

W e estim ate a dynam ical m ass of about 3 10^{11} M for NGC 1512, based on a galaxy radius of r = 55 kpc and a rotational velocity of $v_{\rm rot}$ = 150 km s 1 . If the outer H i clouds at r = 83 kpc are bound to NGC 1512, the dynam ical m ass increases to 4:3 10^{11} M $_{\odot}$

W e note that the rotation velocity of NGC 1512 is com – parable or higher (200 { 220 km s 1) in the nuclear ring than in the inner disk, and signi cantly higher than in the outer H ienvelope. The M_{HI} to M_{dyn} ratio indicates that < 2% of them ass of NGC 1512 is in the form of H igas. No estimate of the molecular gas mass in NGC 1512 or NGC 1510 is currently available.

3.2 H i in NGC 1510

NGC 1510 lies at a projected distance of 5^0 (13.8 kpc) from the centre of NGC 1512. This places it well inside NGC 1512's Hidisk, which shows an enhancement of the Hicolumn density at the position of NGC 1510. The o set in the residual velocity eld of NGC 1512 (see Fig. 7) also suggests that NGC 1510 contains a sm allam ount of H igas and/or left the signature of its interaction with the inner disk of NGC 1512. Gallagher et al. (2005) speculate that NGC 1510 may have captured gas from NGC 1512, contributing to its enhanced SF activity. A ssum ing the H i distribution of NGC 1510 is unresolved in the H im aps shown here, we measure an H i ux density of F_{HI} 2 Jy km s¹, corresponding to an H im ass of M $_{\rm H\,I}$ $~4~~10^{7}$ M $% 10^{7}$ M $_{\rm m}$. This estim ate is very uncertain and does not account for any gas NGC 1510 m ay have lost during the interaction, and is likely to include som e H i from the disk of NGC 1512. The estimated H imass (if correct) is less than 1% of NGC 1512's

H im ass. The H im ass to blue lum inosity ratio of NGC 1510 would be 0.07, within the range (0.02 { 0.8) observed for BCD galaxies (the average ratio is 0.3; Huchtmeier et al. 2005, 2007).

At the position of NGC 1510, the H i em ission ranges from 970 to 1060 km s¹. Note that the optical system ic velocity of NGC 1510 is 990 23 km s¹ (de Vaucouleurs et al. 1991, Lindblad & Jorsater 1981), about 100 km s¹ higher than that of NGC 1512.

3.3 TidalDwarfGalaxyCandidates

Individual H i clouds belonging to the NGC 1512/1510 system are found out to projected radii of 30° (83 kpc). Their velocities agree with the general rotation of the disk gas (see F igs. 2 & 4), suggesting that these clum ps are condensations within the outerm ost parts of the disk. It is likely that they were or are embedded in a very low surface brightness disk that rem ains undetected in our observations.

In the following we study the three most isolated H i clouds which lie roughly along an extension of the eastern-most H iarm .The rst cloud, at ; $(J2000) = 04^{h} 04^{m} 20^{\circ}.4, \{43 \ 34^{\circ}16^{\circ}.7 \ (\ 875 \ \text{km s}^{1}), \text{ is located only } 14^{\circ}.2 \ (39 \ \text{kpc}) from the center of NGC 1512.W e m easure an approxim ate H i ux density of 0.56 Jy km s^{1}.N o stellar counterpart is detected.$

The second cloud, which is the brightest and most extended of the three H i cloud, is located at ; (J2000) =

04^h 02^m 37^s, {43 39⁰ 32⁰⁰ (H i peak position), 23⁰3 (64 kpc) from the center of NGC 1512. It has an H i peak ux of 1 Jybeam¹ and a total H i ux density 3 Jy km s¹ (M_{HI} = 6 10^7 M). There is a clear velocity gradient along the cloud (940 { 970 km s¹) which agrees with the general rotation pattern of NGC 1512; its centre velocity is 950 km s¹. The deep optical im age (see Fig. 8, top right) reveals the faint optical counterpart^Z: a di use knot coinciding with the H im axim um , barely visible in the second-generation D igitised Sky Survey (DSS2). In addition, we nd clear evidence of star form ation in the GALEX FUV and NUV images (see also Section 4.2). Fig. 8 (top) shows the locations of the optical and ultraviolet em ission with respect to the H i em ission.W e suggest that the core of this H i cloud (with an H im ass of $2 \ 10^7 \text{ km s}^1$) is a tidal dwarf galaxy (TDG) and refer to it as N 1512-south.

The third H i cloud is located at ; $(J2000) = 04^{h} 01^{m} 19^{s}$, $(43 \ 20^{0} 03^{00} \ (10^{00})$, 28^{9} 2 (78 kpc) from the center of NGC 1512. | Note that this puts it near the edge of the eld well-m apped by our four overlapping ATCA pointings, and H is ensitivity is reduced; prim ary beam correction is tapered to avoid excessive noise. | W e suggest

that this compact H i cloud is a second, more evolved tidal dwarf galaxy in the NGC 1512/1510 system and refer to it as N1512-west. It has an H i ux density of at least 0.3 Jy km s¹ (M_{HI} > 0.6 10⁷ M) and a centre velocity of 960 km s¹. Unfortunately, M alin's deep optical in – age does not extend this far west of NGC 1512. Nevertheless, clear evidence of star form ation is again found in the GALEX FUV and NUV im ages (see Fig. 8, bottom).

Both N 1512-south and N 1512-west are detected in the highest resolution (13%0 11%3) ATCA H i cubes.We nd H i peak uxes 10 m Jybeam ¹ over 15{30 km s¹. The resulting H i colum n densities are > 10^{21} atom s cm ² (or > 8 M pc²), i.e. near the local star formation threshold (e.g., Skillm an 1987).H idata with higher angular & velocity resolution (and sensitivity) are needed to study the TDG candidates in m ore detail.

A fiter careful calibration, we estimate FUV NUV colors of $0.35\{0.43 \text{ mag} \text{ for N } 1512\text{-south}$ (there are two distinct star forming knots within this TDG) and 0.45 mag for N 1512-west (see also Section 4.2). Despite the large uncertainties (0.2 mag) in the color estimates in these areas (which are outside the published images by G ilde Paz et al. 2007a), we nd that the derived average ages of the detected stellar populations within the TDG s are no younger than 150 M yr and possibly as old as 300 M yr. N 1512-west appears

to be slightly older (m ore evolved) than N 1512-south which would be expected given its com pactness and location at the outerm ost tip of the extrapolated eastern arm .

Following B raine et al. (2004) we can estim ate the expected molecular gas mass (as traced by CO emission) of TDGs to be less than 30% of the H i mass, i.e. < 2 3 10^6 M (for N1512-west). Assuming a velocity width of 10 km s¹ (approx.half the width found in H i), a CO peak ux of 30 m K beam ¹ would be expected with a typical single dish telescope.

If the star-form ing H i clumps in the outskirts of the NGC 1512/1510 are indeed TDGs, we would expect to detect H em ission from stars recently formed in the tidal debris. This young stellar population must exist in addition to the (on average) older population inferred from the GALEX FUV NUV colors.

3.4 20-cm Radio Continuum Emission

Figure 9 shows the 20-cm radio continuum em ission towards the galaxy pair NGC 1512/1510 and its surroundings. Both galaxies are clearly detected. The eld contains a large num – ber of unresolved radio sources as well as a few head-tail and wide-angle tail radio galaxies (incl. PM N J040150.3 { 425911).

The barred spiral galaxy NGC 1512 shows extended continuum emission (5^0 3^0) and a bright core while the much smaller BCD galaxy NGC 1510 appears unresolved at 30^{00} resolution. The 'sh' shaped radio continuum emission is due to enhanced star-form ation in the region between the two galaxies which corresponds to the tail of the sh. NGC 1512's inner star-form ing ring which is well de ned in the optical-, H - and UV -im ages is embedded within the radio continuum emission (see Fig. 10). At high resolution, our surface brightness sensitivity is insu cient to fully map the structure of the inner ring, but NGC 1512's nuclear ring is clearly detected as well as the extended disk of emission from NGC 1510.

To estim ate the star form ation rate (SFR) of a galaxy from our 20-cm data we use two approaches: (1) the form ation rate of recent, high mass stars (M > 5 M) is calculated using SFR [M yr¹] = $0.03 D^2 S_{20cm}$ (C ondon et al. 2002), where D is the distance in M pc and S_{20cm} the 20-cm radio continuum ux density in Jy. W e measure $S_{20cm} = 38.8 \text{ mJy for NGC}$ 1512 and 4.5 mJy for NGC 1510, resulting in 0.11 M yr¹ and 0.012 M yr¹, respectively. (2) In order to derive the form ation rate of all stars (M > 0.1 M)

we multiply by 4.76 (see C ondon et al. 2002), resulting in 0.50 M $~\rm{yr^{1}}$ (NGC 1512) and 0.06 M $~\rm{yr^{1}}$ (NGC 1510).

4 D ISC U SSIO N

The H idiam eter of the galaxy NGC 1512 is large (40° or 110 kpc), but sim ilar in size to the largest H idisks found in the LocalVolum e.For exam ple, ATCA H im osaics of the spiral galaxies M 83 (K oribalski et al. 2009) and C ircinus (Curran et al. 2008) reveal diam eters of 70° (80 kpc) and

 65° (80 kpc), respectively. Even larger H i diam eters have been found for som e of the most H i-m assive galaxies currently known, e.g. M alin 1 (Pickering et al. 1997), NGC 6872 (H orellou & K oribalski2007), and H IZOA J0836{43 (D on ley et al. 2006; C luver et al. 2008). Possibly the deepest singledish H im ap recently obtained with the A recibo multibeam system for the nearby spiral galaxy NGC 2903 also shows a very large H i envelope and a neighbouring H i cloud (Irw in et al. 2009).

A multi-wavelength study of the grand-design spiral galaxy M 83 (H IPASS J1337{29} and its neighbours \mid sim -

ilar to the one presented here | is under way; rst Parkes and ATCA H i results were presented by Koribalski (2005, 2007) and are shown on the LV H IS webpages. The H i gas dynam ics of the C incinus galaxy (H IPASS J1413{65) were studied by Jones et al. (1999), using high resolution data, and m ore recently by Curran et al. (2008), using a lowresolution m osaic. C incinus appears to be rather isolated and is di cult to study in the optical due to its location behind the G alactic P lane.

4.1 The 2X H ivs X UV disk of NGC 1512

A multi-wavelength colorcomposite in age of the NGC 1512/1510 system is shown in Fig. 11. The combination of the large-scale H i distribution with deep optical and UV em ission maps is an excellent way to highlight the locations of star formation within the gaseous disk. NGC 1512's H i envelope is four times larger than its B₂₅ optical size (see Table 1) and about twice as large as the stellar extent m easured from M alin's deep optical in age and from the GALEX UV in ages.

Calibrated FUV (1350{1750A) and NUV (1750{ 2750A) in ages are provided by G il de Paz et al. (2007a) as part of the GALEX Atlas of Nearby Galaxies. The data were obtained on the 29th of December 2003, with an exposure time in both bands of 2380 seconds. The GALEX full eld-of-view is 1:2 in diameter, and the pixel size is 1° . The GALEX point-spread function in the central 0:5 has a FW HM of 5° .

Figure 12 gives a multi-wavelength view of the NGC 1512/1510 system, shown with high resolution $(15^{00} = 700 \text{ pc})$ over the main star-forming disk (similar in size to Fig. 1). Our main purpose here is to emphasize how the observed extent and distribution of stars and gas depend on the tracer. The H i distribution is by far the largest and extends well beyond the area shown here. The GALEX FUV and NUV images, shown here sm oothed to an angular resolution of 15^{00} , trace star forming regions out to a radius

of 10° . Malin's deep optical image (see Fig. 1) shows a very similar distribution. We expect that a deep H mosaic would also match this, as hinted at by the faint chains of H ii regions seen in the rather limited SINGG H image. The Spitzer 8 m image allow sus to see the inner spiralarm s as they connect to the bar, but detects no emission in the outer disk. M ost obviously missing is a map of the molecular gas in the system (e.g., as traced by CO (1{0) emission) which is expected to be similar to the H image.

The large gas reservoir provides copious fuel for star form ation, which should be most prom inent in areas of high column density (see Section 4.4). Given a high-sensitivity, high-resolution H i distribution, we can pinpoint the locations of star form ing activity in the outer disks of galaxies.

The correspondence between regions of high H icolum n density and bright UV em ission (see Fig. 12) is excellent throughout the extended disk of NGC 1512, apart from the central area which shows an H i depression (but must be rich in m olecular gas). The large m a jority of the observed UV-com plexes lie in regions where the H i colum n density is above 2 10^{21} atom s cm² (as m easured in the high-resolution H i m ap). For com parison, the dwarf irregular galaxy ESO 215-G 2009 has a very extended H i disk (W arren et al. 2004) but no signs of signi cant star form ation in the outer disk; its H i colum n density reaches above 10^{21} atom s cm² in only a few locations.

Deep GALEX in ages of nearby galaxies show that the UV proles ofm any spiral galaxies extend beyond their H – or B₂₅ optical radius (Thilker et al. 2005; Gilde Paz et al. 2005, 2007b). In fact, Zaritsky & Christlein (2007) suggest that X UV-disks exist in 30% of the local spiral galaxy population. We contend that these spectacular X UV-disks must be located within even larger H ienvelopes, here called 2X -H i disks, which provide the fuel for continued star form ation. Ultimately, it may just be a question of sensitivity that limits our observations of the outer edges of stellar and gaseous disks. We note that Inw in et al. (2009) detect H igas out to column densities of 3 10^{17} atoms cm² (assuming the gas lls the 270^{00} beam).

4.2 Stellar cluster ages

We use the GALEX FUV and NUV in ages to estimate the ages of the UV -rich star clusters in the NGC 1512/1510 system. This is done by integrating the counts per second (CPS) in 200 selected regions (> 100 arcsec², average size = 320 arcsec²) using the same polygon for both in ages and applying m = 2:5 log (CPS) + a (M orrissey et al. 2005), where $a_{FUV} = 18.82$ m ag and $a_{NUV} = 20.08$ m ag (all magnitudes are expressed in the AB system). We did not correct for extinction which is negligible when computing the FUV NUV color: $A_{FUV} = A_{NUV} = 0:1 E$ (B V) = 0:0011.

Figure 13 shows the spatial distribution and color of the analysed star clusters. We use dierent symbols to identify ve distinct areas within the system : the ring, the internal arm, the bridge to NGC 1510, the western debris and Arm 1 (see Fig. 1). The FUV NUV colors (blue to red) range from {0.06 (youngest stellar population) at the southern end of the bridge to + 0.68 (oldest stellar population) for

the farthest cluster in the NW region. Uncertainties in the

color estim ates strongly depend on the brightness of the star

clusters (0.06 for the brightest and 0.50 for the weakest objects). For the analysed clusters in the NGC 1512/1510 system we adopt an uncertainty of 0.20.

A s extinction is negligible when computing the FUV NUV colors (see above), higher values correspond to older ages for the last star-forming burst hosted by the UV-rich clusters. We have used the same procedure as described in B ianchi et al. (2005) and H ibbard et al. (2005) to estimate the age of the last star-forming event, assuming an instantaneous burst, and evolutionary synthesism odels provided by B nuzual & Charlot (2003). Table 4 lists the results obtained for distinct areas.

W hile the UV colors suggest that the average stellar population in the core of NGC 1512 (red circle) is about twice as old as that of NGC 1510 (green circle), the high H em ission in both galaxies also indicates signi cant recent star form ation.W e conclude that NGC 1512 and NGC 1510 contain both a young stellar population and an older, m ore evolved stellar population.

As shown in Fig. 13, there are de nite color gradients along the spiral arms and other regions within the NGC 1512/1510 system . For example, while regions within the inner star-form ing ring of NGC 1512 generally have sim ilar colors, (FUV NUV)_{ring} = 0.28 0.06 (age 180 M yr), slightly younger ages are found tow ards both ends of the bar, ie. at the start of the inner arm s. Regions located within the bridge between NGC 1512 and NGC 1510 are { on average { even younger, (FUV NUV)_{bridge} = 0:21 0:12 (age 120 M yr), with ages of 10 M yr (the youngest regions in the whole system) near NGC 1512, and 270 M yr near NGC 1510. As shown in Fig. 12, UV-bright regions close to NGC 1512 coincide well with the H i column density m axim a; their young derived age is consistent with the H em ission found in these knots. A UV-color gradient is also observed along the prominent eastern arm (A m 1). In the eastern-most regions, which also show some H emission, we measure FUV NUV colors around {0.05 (age 10 M yr). As the arm curves towards the south, the UV-rich clusters appear to get older, reaching FUV NUV 0:66 (age 380 M yr) within the two streams of the outermost regions.

W ithin the debris in the NW area, stellar clusters near NGC 1510 tend to have younger ages (FUV NUV 0.2 0.3, ages of 100 (200 M yr) than those located towards the north of NGC 1512 (FUV NUV 0.5 0.7, ages of 300 (400 M yr). The broadening of the H i spiral arm at the position of the NW debris suggests that something has dispersed both the neutral gas and the stellar component

in this region. The age gradient found in the stellar clusters indicates that it probably is due to the gravitational interaction with the BCD galaxy NGC 1510.

The overall gas distribution together with the star formation history of the system provides some hints as to the gravitational interaction between the large spiral NGC 1512 and the BCD galaxy NGC 1510 and its e ects on the surrounding medium. The youngest star forming regions are found mostly to the east & west of NGC 1512, while regions towards the north & south of NGC 1512 are generally older. This east-west (young) versus north-south (old) symmetry m ight indicate the passage of NGC 1510 as it is accreted by NGC 1512. This interaction m ight have (1) triggered the bar in NGC 1512 (unless this was the result of previous interactions or m inor m ergers) causing gas within the co-rotation radius to ow towards the nuclear region, thus providing fuel for continuous star form ation, (2) a ected the spiral arm pattern causing broadening and splitting as well as enhanced star form ation, and (3) led to the ejection of m aterial to large radii where it m ay becom e unbound, form ing dense clumps able to form new stars. Evidence of the latter is the observation of two tidal dwarf galaxies at the outerm ost regions of the NGC 1512/1510 system .

4.3 The global star form ation rate

There are num erous ways to estim ate the star form ation rate (SFR) of a galaxy. To study the global and local SFRs, we use a range of line and continuum measurem ents at di erent wavelengths (ultraviolet, optical, infrared, and radio). A combination of these data together with an understanding of which stellar populations are detected at each wavelength is essential to obtain the full picture. Nevertheless, we are som ew hat limited by the sensitivity, quality and eld-of-view of the existing observations.

Star form ation tends to be localised and varies within galaxies. W hile the nuclear region and inner spiral arms of a galaxy are generally locations of signi cant star form ation, we also nd new stars forming in other areas such as interaction zones and occasionally in isolated clumps (presum ably of high m olecular gas density) in the far outskirts of galaxies. The NGC 1512/1510 system is an excellent laboratory to study the locations and properties of its m any star form ing regions, from the galaxy nuclei out to the largest radii where detached H i clouds are found (see Section 3.3) as well as in the interaction zone between the two galaxies.

Here we use a range of tracers to study the global SFR of both NGC 1512 and NGC 1510 (results are sum marised in Table 5 and Fig. 14), before investigating the local star form ation activity within various parts of the NGC 1512/1510 system (see Section 4.4).

From our 20-cm radio continuum data we derive a recent global SFR of 0.105 M yr 1 for NGC 1512 and 0.012 M yr 1 for NGC 1510 (see Section 3.4). Another extinction-free SFR estimate is derived from the far-in frared (FIR) lum inosity. U sing the IRAS ux densities (M oshir et al. 1990) together with the relations given by Sanders & M irabel (1996) and K ennicutt (1998), we derive SFR FR 0.12 M yr 1 for NGC 1512 and 0.02 M yr 1 for NGC 1510.

F IR emission comes from the thermal continuum reradiation of dust grains which absorb the visible and UV radiation emitted by massive young stars. In contrast, radio continuum em ission is mainly due to synchrotron radiation from relativistic electrons accelerated in the rem nants of core-collapse supernovae, therefore also associated with the presence of massive stars. B oth estimates trace the star formation activity in the last 100 M yr. However, as relativistic electrons have lifetimes of 100 M yr (Condon et al. 2002), we should expect that the 20-cm radio continuum em ission traces SFR s with som ew hat extended ages.

H emission traces the most massive, ionising stars, and timescales of 10 Myr, i.e. the most recent events of star form ation in the galaxy. The H ux given by M eurer et al. (2006) was corrected for Galactic extinction but not for internal extinction or for the contribution of the [N ii] emission lines adjacent to H (see Lopez-Sanchez & Esteban 2008)^X. U sing the relation by K ennicutt (1998), we nd SFR_H = 0.19 and 0.07 M yr¹ for NGC 1512 and NGC 1510, respectively. Slighter lower values, SFR_H = 0.13 and 0.05 M yr¹, result when using the more recent Calzetti et al. (2007) calibration.

UV -em ission probes star form ation over tim escales of 100 Myr, the life-time of the massive OB stars. Using the extinction-corrected GALEX UV -m agnitude, m FUV, as given by Gilde Paz et al. (2007a), we derive the UVux as follows: f_{FUV} [erg s¹ cm² A¹] = 1:40 10¹⁵ $10^{0:4}~^{(18:82\ m}~_{\rm FUV})$. We have corrected m $_{\rm FUV}$ for extinction assuming the Galactic value provided by Schlegel et al. (1998), E (B V) = 0.011, and $A_{FUV} = 7.9 E$ (B V). Applying the Salim et al. (2007) relation between the FUV lum inosity and the SFR, we obtain $SFR_{FUV} = 0.12$ and 0.04 M yr¹ for NGC 1512 and NGC 1510, respectively. For com parison, applying the Kennicutt (1998) relation results in values that are a 1.3 tim es higher. Here we prefer to use Salim et al. (2007) relation because it was derived using GALEX data.

The SINGS Legacy project (Kennicutt et al. 2003) promid-infrared (MIR) vides Spitzer im ages of NGC 1512/1510. M IR em ission, which traces the dust distribution within galaxies, also agrees well with the position of the UV -rich star clusters in the system . Because of its higher intrinsic brightness, the M IR em ission is mainly detected in the cores of both galaxies and in the inner ring of NGC 1512. Using the Spitzer 24 m ux density measurem ents of NGC 1512 (Dale et al. 2007) and NGC 1510 (obtained by us; see Table 5) together with the relations by Calzettiet al. (2007) we derive SFR_{24 m} = 0.075 M yr¹ for NGC 1512 and 0.041 M yr 1 for NGC 1510.

Combining the 24 m luminosity (which traces the dust-absorbed star formation) with the H luminosity (which probes the unobscured star formation) we derive SFR_H + 24 m = 0.22 M yr¹ and 0.07 M yr¹ for NGC 1512 and NGC 1510, respectively.

Figure 14 shows the star form ation rates as derived for NGC 1512 and NGC 1510 at various wavelength, arranged along the x-axis by the approximate timescales in which the SFR is considered: from the H emission, tracing the very young (10 Myr) star form ation to the radio continuum emission, tracing the old stellar population

(100 M yr).We nd that for NGC 1510 our derived SFR estimates are in agreement (0.05 M yr¹).The fact that the SFR derived from the 20-cm radio continuum ux considering all masses, SFR_{20cm} (M 0.1 M) = 0.058 M yr¹, is close to the SFR found using FUV, H and 24 m data reinforces the starburst nature of this BCD galaxy. For NGC 1512, the SFR estimates obtained from H , FUV, 24 m, FIR and 20-cm radio continuum (M > 5 M) data agree (0.12 M yr¹). However, SFR_{20cm} is about four times higher when we consider all masses. This can be explained by the non-starbursting nature of NGC 1512, which has been form ing stars over a long period of time (Gyr).

Following Helou, Soifer & Rowan-Robinson (1985) we calculate the q parameter which is dened as the logarithmic ratio of the FIR to 20-cm radio ux density. We nd q = 2.25 and 2.44 for NGC 1512 and NGC 1510, respectively, consistent with them ean value of 2.3 for norm also iral galax-ies (C ondon 1992). This result con m s the star-form ing nature of both galaxies.

Using the H ux given by M eurer et al. (2006) and the relation provided by C ondon et al. (2002), we derive the therm al ux at 1.4 G H z for NGC 1512 and NGC 1510: 2.7 and 1.0 m Jy, respectively. The ratio of the non-therm al to therm al radio em ission, $\log R$, is 1.1 and 0.54, respectively. The value derived for NGC 1512 agrees with that of typical star-form ing galaxies ($\log R = 1.3$ 0.4, D op ita et al. 2002) but is relatively low for NGC 1510. This indicates that the therm alem ission from H ii regions in NGC 1510 is m ore im portant than the non-therm alem ission from supernovae explosions (i.e., the starburst is very recent, and there has not been enough tim e to convert m any m assive stars into supernovae). This fact agrees with the detection of W R features in NGC 1510 (E ichendorf & Nieto 1984).

4.4 The local star form ation activity

We have estimated the star formation rate of each UVrich stellar cluster in the NGC 1512/1510 system using the extinction-corrected FUV luminosity and the assumptions given before. In general, we nd that regions closer to NGC 1512 display higher star formation activity, in agreement with their young ages (see Fig. 13).

Considering only stellar clusters with both H and UV emission, we compare SFR_H (C 07) with SFR_{FUV} (S07). Fig.15 shows a good correlation between both estimates for small values of SFR / area (0.002 M yr¹ kpc²), how ever, SFR_{FUV} is always low er than SFR_H for regions with high SFR / area (i.e. within the inner ring of NGC 1512 and in NGC 1510). Given that the ages of the latter are similar, this must be a consequence of internal extinction within these regions which are denser and possess a larger amount of dust, as seen in Spitzer images, than other areas. Fig. 16 con rm s this as SFR_H + 24 m is systematically higher than SFR_H.

Next, we investigate if the UV -rich clusters within the NGC 1512/1510 system do obey the Schmidt-Kennicutt scaling laws of star form ation (Kennicutt 1998). Boissier et al. (2007), for example, nd that the stellar and gas radial proles of galaxies with XUV disks follow such relations. Fig. 17 shows a comparison between SFR_{FUV} /area and the

H im ass density. | This analysis can be improved by adding high-resolution ATCA H i data, obtained for the southerm THINGS project (Deanne, de Blok, et al.), to improve the sensitivity to sm all scale structure,

Overall, we nd that SFR $_{\rm FUV}$ /area increases with M $_{\rm H~I}$ /area, i.e. the higher the H i gas density the m ore stars

are forming. However, this is not true for regions located within the inner star-forming ring of NGC 1512, where there is clearly a lack of H igas (see Fig. 13). We conclude that in the inner region of NGC 1512 a large amount of m olecular gas must be present to boost the overall gas density to the critial value or above.

In the following we check if the Toom re Q gravitational stability criterion is satis ed at the locations of the UVrich clusters. Ideally, we would use the H i velocity eld (corrected for inclination) and the velocity dispersion of NGC 1512, to compute the critical gas density, $_{crit}$ = $_{\rm Q}$ $_{\rm G}$ (see K ennicutt 1989, M artin & K ennicutt 2001), at every pixel in the disk.Here $_{Q}$ is a scaling constant, is the velocity dispersion, and is the epicyclic frequency. The low -resolution H idistribution (0.m om ent) and the m ean H i velocity eld (1.m om ent) of NGC 1512 are shown in Fig. 3. The H i velocity dispersion (2.m om ent, not shown) varies between $7{22 \text{ km s}^1}$ in the spiral/tidal arm sofNGC 1512. As a rst step, we compare the radially averaged H i gas distribution with the critical density and the radially averaged FUV emission. For a at rotation curve (i.e., vrot (r) = constant), which is a reasonable assumption for $r > 15^{\circ\circ}$ (see Fig. 6), and a velocity dispersion of 6 km s $^{\rm 1}$ (as used in previous work), the above equation reduces to crit = 0.6 $_{Q}$ v_{rot}/r, where r is the radius in kpc. U sing the derived H i inclination (i = 35) and position angle (PA = 265), the de-projected H i radial surface density, HI of NGC 1512 is shown in Fig. 18. The critcal density was computed for $_{Q}$ = 0.7 and v_{rot} = 150 km s 1 . W e nd that the radially averaged H i gas alone lies just below the computed critical density.

At radii less than 10 kpc, an increasing amount of molecular gas is needed to reach critical gas density and feed

the star form ation in the nuclear region and the inner ring. The radially integrated FUV ux drops below the noise at r = 28 kpc, the likely SF threshold.

In the inner region of NGC 1512, the gas motions are strongly a ected by the stellar bar, which would affect the critical density estimate. Using NGC 1512's angular velocity, (r) = $v_{rot}(r)/r$, we can also determ ine the locations of the inner and outer Lindblad resonances: p = (r) (r)=2, where p is the bar pattern speed and (r) = $2 v_{rot}/r$. At r 4 kpc (bar radius) its pattern speed is 50 km s¹ kpc¹, suggesting that the ILR (s) lie at r < 1.2 kpc, and the OLR at r 6.8 kpc.

Figure 19 shows the logarithm ic ratio of the m easured H igas density, $_{\rm H\,I}$, to the critical density, $_{\rm crit}$, for all analysed UV -rich clusters together and within the previously dened distinct regions. Taking all clusters, a peak is found at < log($_{\rm H\,I}=_{\rm crit}$) > = 0.06, indicating that local star form ation is, on average, happening at the local critical density. The m easured H i densities are slightly higher than critical along A m 1 (0.33) and within the NW debris (0.17), but signi cantly lower than critical in the inner star-form ing ring ({0.44}) where the m olecular gas density m ust be high.

Finally, Fig. 20 shows { on a logarithm ic scale { the SFR_{FUV} density versus the gas density for UV -rich clusters in the NGC 1512/1510 system (derived here) and in the nearby Sbc galaxy M 51 (K ennicutt et al. 2007; for r < 8 kpc). Because no molecular data are currently available for NGC 1512, only the H igas density is shown. Regions within the inner star-form ing ring of NGC 1512 (located at $r = 90^{\circ\circ}$) are { as stated before { signi cantly o set. Tripling the H i m ass of each region achieves an approxim ate alignem ent. For M 51, m olecular data are taken into account and are found to be essential for the observed correlation (K ennicutt et al. 2007). D ong et al. (2008) found that the UV -selected regions in two sm all elds within the large gaseous disk of M 83,

20 kpc from its centre, follow a similar trend. M olecular gas was not taken into account (for comparison, see M artin & K ennicutt 2001).

4.5 G lobal chem ical properties

Here we estimate the metallicities of NGC 1512 and NGC 1510 using data available in the literature.Calzettiet al. (2007) and M oustakas & K ennicutt (2006) give an oxygen abundance between 8.37 and 8.81, in units of 12+ log (O /H), for the chemical abundance of NGC 1512. The rst value was derived using optical spectroscopy and the Pilyugin & Thuan (2005) calibration. The second value was obtained com paring with the predictions given by the photoionised evolutionary synthesis models provided by Kobulnicky & Kewley (2004). However, som e recent analysis using direct estim ates of the electron tem perature (Te) of the ionised gas (e.g., Lopez-Sanchez 2006) suggest that these models overestim ate the oxygen abundance by 0.2 dex.W e conclude that the metallicity of NGC 1512 is between 8.4 and 8.6, slightly lower than for the M ilky W ay, but within the range typicalobserved for spiralgalaxies (Henry & W orthey 1999).

On the other hand, we have used the emission line intensity data for NGC 1510, provided by Storchi-Bergm ann et al. (1995), to compute its chemical abundance. We used the H H ratio to correct the data for reddening and ob-

tained C (H $\,$) = 0.54.W ith the help of tasks in the iraf hebular package', we compute T_e = 15700 K, using the [D iii] 5007/4363 ratio. Assuming an electron density of n_e = 100 cm 3 we compute the ionic abundances for O $^+$ /H $^+$ and O $^{++}$ /H $^+$ and derive a total oxygen abundance of12+ log(O /H) = 7.95 ($\,$ 0.2 Z $\,$), typical for BCD galaxies.

The large m etallicity di erence between NGC 1512 and NGC 1510 indicates that both galaxies have experienced a very di erent chem ical evolution, and that NGC 1510 has been in a quiescent state for a long time while NGC 1512 was form ing stars continuously.

The N /O ratio found in NGC 1510, $\log (N /O)$ {12, is rather high for a galaxy with its oxygen abundance. For com – parison, Izotov & Thuan (2004) typically obtain $\log (N /O)$

{1.5 for low m etallicity BCD galaxies. Sim ilar results are also found for other BCD galaxies with a signi cant population of W R stars (Brinchm ann et al. 2008). It is thought that the nitrogen enrichm ent is a consequence of a very recent chem ical pollution event probably connected with the onset of W R winds (Lopez-Sanchez et al. 2007). It m ay also be related to the interaction between galaxies (Pustilnik et al. 2004, Lopez-Sanchez et al. 2009), but deeper optical spectroscopic data with a higher spectral resolution are needed to con m this issue.

4.6 Interaction-induced star form ation

Star form ation depends on the gravitational instability of galaxy disks, both locally and globally. M inor mergers and tidal interactions a ect the gas distribution and dynam ics of galaxies, leading to the form ation of bars, gas in ow as well as the ejection of gas, and { as a consequence { locally en-

hanced star form ation. Together, these phenom ena are key ingredients to the understanding of galaxy evolution. The often extended H i envelopes of spiral galaxies are particularly useful as sensitive tracers of tidal interactions and gas accretion. The gas distribution and dynam ics are easily inuenced by the environm ent, resulting in asym m etries, line broadening and/or splitting etc.

The developm ent of a strong two-arm ed spiral pattern and star-form ing regions in disk galaxies (here NGC 1512) which accrete low-m ass dwarf com panions (here NGC 1510) has been explored by M ihos & H emquist (1994) using num erical simulations. Their m odels, which use a m ass ratio of 10:1 for the disk galaxy and its com panion, resemble the galaxy pair NGC 1512/1510 after 40 time units (ie. $52 \, 10^8$ years). At that stage, them odeldisk galaxy has developed a pronounced, slightly asym m etric two-arm ed spiral pattern with signi cant star-form ation along the arm s and the nuclear region.

M inor m ergers are common. The M iky W ay and the A ndrom eda galaxy are prominent exam ples; both have m any satellites and show evidence for continuous accretion of sm all companions. The multitude of stellar streams detected in our G alaxy as well as some other galaxies (e.g., NGC 5907, M artinez-D elgado et al. 2008) are hinting at a rich accretion history. M inor m ergers contribute signi cantly to galaxy assem bly, accretion, and evolution.

5 CONCLUSIONS

W e analysed the distribution and kinem atics of the H i gas as well as the star form ation activity in the galaxy pair NGC 1512/1510 and its surroundings.

For the barred, double-ring galaxy NGC 1512 we nd a very large H idisk, about four times the optical diam eter, with two pronounced spiralarms, possibly tidally induced by the interaction with the neighbouring blue compact dwarf galaxy NGC 1510. It is possible that the interaction also triggered the form ation of the bar in NGC 1512 (unless the bar already existed, maybe from a previous accretion or interaction event) which would then cause gas to fall towards the nuclear regions, feeding the star form ation, as well as induces torques in the outer spiralarm s.

W e detect two tidal dwarf galaxies with H i m asses of $<10^7$ M and clear signs of star form ation in the outer-m ost regions of the system . The m ost distant TDG, N 1512-west, is rather compact and lies at a distance of 80 kpc from the centre of NGC 1512, potentially at the tip of an extra polated eastern H i arm of NGC 1512. The second TDG, 1512-south, is form ing within an extended H i cloud, and is located slightly closer (64 kpc), within the extrapolated eastern H i arm .

W e regard these two TDGs as typical with respect to their H i m ass, star form ing activity and detachment from the interacting system .W hile TDGs are often found in m ajorm ergers, we nd that they can form in mildly interacting system such as NGC 1512/1510. In this case, the interaction is e ectly an accretion of a blue compact dwarf galaxy (NGC 1510) by the large spiral galaxy NGC 1512.

NGC 1512 hosts an extended UV disk with > 200 of clusters with recent star form ation activity. The comparison of our H im ap with the GALEX im ages clearly shows that

these clumps are located within the maxima of neutral gas density. We have derived the ages and star formation rates of the UV-rich clusters.

We nd that generally only the youngest UV clusters are associated with high H icolum n densities, while in older UV clusters only di use H i gas is detected. This might suggest that as the hydrogen gas depleted, star form ation stopped in the latter regions. As a consequence we expect to detect H emission in all high density H i regions or equivalent in all young UV clusters.

O ur analysis supports a scenario in which the interaction between the BCD galaxy NGC 1510 and the large spiral galaxy NGC 1512 has triggered star form ation activity in the outskirts of the disk and enhanced the tidal distortion in the H i arm s. The interaction seems to occur in the north western areas of the system because of the broadening of the H i arm and the spread of the UV -rich star clusters in this region. The system is probably in the rst stages of a minor m erger which started 400 M yr ago.

6 OUTLOOK

Future H i surveys, such as those planned with the Australian SKA Path nder (ASKAP; Johnston et al. 2008) will produce sim ilar H i cubes and in ages than obtained here, but over much larger areas. E g., the proposed shallow ASKAP H i survey of the sky will reach a sensitivity of 1 m Jybeam¹ at an angular resolution of 30^{00} in a 12-h integration per eld. Focal plane arrays will provide a very large, instantaneous eld-of-view of 5:5 5:5. This m eans that H i im ages sim ilar to those shown in this paper will be obtained for the entire Local Volum e. Furtherm ore, the correlator bandw idth of 300 M H z (divided into 16,000 channels) will allow us to study the H i content of galaxies and their surroundings out to $60,000 \text{ km s}^1$ (z = 0.2). In addition, very deep 20-cm radio continuum im ages are obtained for the same area.
