The M agellanic Stream to H alo Interface: P rocesses that shape our nearest gaseous H alo Stream

Understanding the hydrodynam ical processes and conditions at Abstract. the interface between the Magellanic Stream (MS) and the Galactic halo is critical to understanding the M S and by extension, gaseous tails in other interacting galaxies. These processes operate on relatively sm all scales and not only help shape this clumpy stream, but also a ect the neutral gas dynamics and transfer of mass from the stream to the halo, thus a ecting metal enrichment and gas replenishm ent of the Galaxy. We describe an observational program to place constraints on these processes through high-resolution m easurem ents of HI em ission, HI absorption and H em ission with unprecedented sensitivity. M ethods will include structural analysis, searching for cold gas cores in clum ps and analyzing gas kinem atics as it transitions to the halo. The latter m ethod includes sophisticated spatial integration techniques to deeply probe the neutral gas, which we apply to a new HIM ap obtained from the Green Bank Telescope with the highest sensitivity HI observations of the MS to date. We dem onstrate that the integration techniques enhance sensitivity even further, thus allowing detection of apparent M S gas components with density approaching that of the Galactic halo.

1 Introduction

The M agellanic Stream (M S) is our nearest m a jor gaseous interaction rem nant. It trails across much of the southern galactic sky for > 100 behind the M agellanic C buds (M C s), passing near the Southern G alactic Pole at its m idpoint. The M S head is presumed to be nom inally between 52 and 61 kpc away, the distances to the M C s established by K oerwer (2009) and H ilditch et al. (2005). The distance to the tip is not well-constrained but estimates are of the same order as distances to the M C s. These distances are about 15 times closer than the nearest extragalactic tidal features of the A ndrom eda system, therefore the M S presents us with the opportunity to closely study star form ation potential (or lack thereof), m ass transfer, and kinem atics of a m a jor interaction feature on ne scales inaccessible elsewhere. No signs of stars or even star form ation have been found in the M S to date. The m ean colum n density of the M S ranges

from 4 10^{18} to 4 10^{19} cm² along its length, which is an order of m agnitude below the tidal debris star-form ation threshold (4 10^{20} cm²) found by M aybhate et al. (2007). Unlike H igh Velocity C buds (HVCs), whose H em ission can be explained by G alactic UV radiation, the M S is brighter in H , particularly near the M C s, suggesting another ionizing source. G lobalm odels of the M S using Sm oothed Particle H ydrodynam ics (SPH) and N-B ody techniques have reproduced its large-scale structure with some degree of success with the then-current assumption of multiple M C orbits of the G alaxy (M oore & D avis 1994; C onnors et al. 2006; M astropietro et al. 2005). The new m easurem ent of M C properm otions by K allivayalil et al. (2006a) and K allivayalil et al. (2006b) led B esla et al. (2007) to propose the likelihood of unbound M C orbits. Subsequently, M astropietro (2008) presented revised results for the new orbits.

Som ething that the global models do not capture is the very rich, nescale structure revealed in recent H IM S maps such as Putm an et al. (2003) and Bruns et al. (2005). Even ner structure was revealed by Stanim irovic et al. (2008) in a high-resolution map of the northern tip of the M S using the 305 m dish at A recibo. These observations revealed extended ne lam entary structure and clumps down to the angular resolution of the telescope $(3:5^{\circ})$. They also highlighted the importance of K elvin-H elm holtz and Therm al Instabilities in form ing the clumps suggesting star form ation potential and providing clues to halo pressure and dark matter con nem ent of these clumps. Processes are clearly at work on these small scales that could a ect star form ation, the transfer of gas to the halo, and also may provide additional drag a ecting M S global dynam ics.

The global simulations mentioned above can miss these processes since SPH can suppress instabilities due to smoothing (Agertz et al. 2007), and N-body simulations ignore gas processes altogether. Grid-based modeling can capture these small-scale instabilities better, exemplied by simulations exploring mechanisms for excess H emission in the MS (Bland-Hawthorn et al. 2007), galaxy replenishment (Bland-Hawthorn 2009; Heitsch & Putman 2009), and HVCs in the halo (Quilis & Moore 2001). Grid-based modeling on these scales is producing some exciting insights into the possible processes at work.

We present here a research program aim ed at setting som e observational constraints on these processes that act on the MS at its interface with the G alactic halo and then using them to test these models. Towards this end, we have obtained the most sensitive HI emission m ap of portions of the MS to date and have begun to analyze the structure and kinematics of the gas. We are in the process of obtaining high resolution, high sensitivity m easurem ents of H emission for insight into higher energy processes at the halo interface, and HI absorption to look for cold gas cores and characterize gas tem peratures.

2 Observations: Completed, ongoing and planned

We have completed a program at the G reen Bank Telescope¹ (beam width = 9:1⁰) where we obtained deep H I spectra across two separate 12 deg² regions. One region (Region 1) is located in the northern tip and the other (Region 2) is 20 deg further up in the mid-M S region. On-the- y (OTF) mapping and in-band frequency switching was employed. Region 1 data have been reduced with a fairly successful initial pass at baseline rem oval resulting in a cube with 3:53⁰ square pixels, and velocity resolution of 0:161 km sec¹ from 200 to 518 km sec¹. Noise was measured at $_{\rm T}$ = 4:2 m K corresponding to column density noise $_{\rm N}$ = 1:14 10¹⁷ cm² for a 15 km sec¹ FW HM pro le. At less than half the noise of the G alactic A ll-Sky Survey (GASS) (M cc lure-G ri ths et al. 2009) scaled to the same pro le, the map presented here is the most sensitive of the M S to date. C olumn density and velocity eld maps are shown in Figure 1.

Further plans include observations of the ne-scale signature of ionization process on selected clumps and features by obtaining deeply integrated, high-resolution H observations. We will compare our results to those expected in models of ionization through Galactic UV radiation or energetic gas processes such as those proposed by Bland-Hawthorn et al. (2007). We also plan to obtain deep absorption measurements in the direction of several background radio sources within the tip of the MS coinciding with clumps identi ed by Stanim irovic et al. (2008). In addition to possibly identifying cold, potentially star-forming cores, these sensitive absorption measurements on the analysis of gas kinematics.

3 Results & Discussion

The Region 1 H I column density in age of Figure 1 (left), show s the main lament extending from the lower left to the upper right, which is part of the longer lam ent S2 identi ed by Stanim irovic et al. (2008). The Region 1 velocity eld (Figure 1 right) shows the general velocity gradient of the main lament, but also reveals some di erentiation in places, suggesting some complexity in the projected dimension. Several prominent and interesting features are labeled in Figure 1: (A) and (B) appear as head-tail clum ps; (C) is a narrow lam ent that apparently connects to the main lament; (D) are a series of relatively dense \spokes" at the edge of the main lament; (E) is a large, apparently coherent cloud that is signi cantly more diuse than other clum ps of its size in the map. M ost of these features (A through D) have a strong component transverse to the main lament, suggesting that this lamentary substructure may represent ram pressure or ablation shreds coming o the main cloud. It is interesting to note that most of the transverse substructure appears in the form of short laments, instead of di use cloud envelopes. In the future, these structures will be analyzed further both spatially and kinem atically to see what the deprojected structures

m ight look like and what they m ight say about the processes at work here. We will also statistically compare the structure of this region to simulations from B land-Hawthorn et al. (2007) by using Fourier Transform methods.

We are in the process of characterizing properties of the di use neutral gas in the MS-hab transition region. Pro les of gas properties (temperature and column density) as a function of distance from the clump centers will be compared with analytical and simulation results for various hydrodynam ic processes, each of which will have a particular \signature" pro le. For instance, the temperature vs. radial distance in an isolated cloud in the hab is quite di erent if experiencing saturated evaporation or if radiatively stabilized, as shown by Cow ie & M cK ee (1977) and M cK ee & Cow ie (1977).

These proles are conventionally obtained by looking at observed spectra along a cross-section and thing to a curve, as in Bruns et al. (2001). Further from the center, brightness decreases and velocity dispersion increases, causing measurement uncertainty to increase rapidly. In order to improve upon this method, we average spatially along a symmetry dimension under the assumption that the clump symmetry extends past its apparent boundaries. For instance, an isolated circular clump in a map is assumed spherical and can be integrated along concentric rings where each column of gas is nom inally the same. Similarly

for a linear feature, we assume cylindrical symmetry and average along lines parallel to the lament. More advanced techniques include integrating along N_{H I} contours or optimizing to taparametric 3D gasmodel.

To dem onstrate the sensitivity of this approach, we show initial results from applying thism ethod in Figure 2. Here a portion of the main lament of Region 1 is assumed to be roughly cylindrical along the axis indicated on the image. The spectra along a parallel path to the left were integrated (averaged) after removing the velocity gradient of the main lament. The spectrum sampled at a a single location, as used in a simple cross-section prole, show s no sign of a detectable gas component, while the corresponding averaged spectrum of the cylindrical model clearly shows two gaussian components, with FW HM = 10 and 26 km sec¹, respectively. Each is detected well above their 3 detection limits (dashed line) with corresponding N_{H I} = 3:4 10¹⁷ cm² and 1:1 10¹⁸ cm², respectively.

A lthough detection of these apparent gas components clearly demonstrates the sensitivity of the technique, veri cation as actual low column density gas is still in progress. Their shape, width and velocity are roughly consistent with MS gas, and are not likely artifacts of the baseline procedure. However, at such high sensitivity, system atic artifacts not norm ally seen must be considered (N idever et al. 2009, in prep.). Should either of these detections prove valid, it would suggest that a signi cant am ount of low column density HIgas, wellbelow thresholds of previous observations, exists in this part of the MS. If not, it will still establish unprecedented limits on a di use neutralgas component. In either case, this approach will provide valuable insight into the history, dynam ics and hydrodynam ic processes of the MS (N igra et al. 2009, in prep.).

To gauge how close these detections are to the halo interface, an order of magnitude estimate of the number density is made. The lament's scale is 1 on the sky. A ssuming a distance of 60 kpc, the scale width is then

1 kpc = 3:1 10^{21} cm. The number density for the 26 km sec¹ FW HM component is then on the order of 1:1 10^{18} 3:1 10^{21} = 3:5 10^{4} cm³. This is on the same order as the upper range of ionized halo number density estimates (Sem bach et al. 2003) and we can detect even weaker lines, so we may indeed be probing H I very close to the halo interface.

4 Conclusions

The rich ne, clum py and lam entary structure on arcm inute scales revealed in modern H Im aps of the M S are not reproduced in global SPH and N-body simulations. Observations and grid-based local simulations reveal that this structure is likely produced by hydrodynam ical instabilities at the interface between the cool, stripped gas as it moves through the hot halo gas. These processes may be an important source of M S structure, a mechanism for ionizing the M S gas as well as a signi cant means of transferring gas from the M S to the halo, and eventually to the G alactic disk.

A program is in progress to place observational constraints on these processes and on the modeling of them by obtaining the most sensitive measurements to date of the MS gas in both HI and H emission, as well as in HI absorption, on the periphery of the MS where it is closest to the ambient halo environment. We have already obtained maps of two regions of the MS with unprecedented sensitivity. Using these data, we have demonstrated spatial integration techniques allowing detection of HI components at densities of 10⁴ cm³, within an order of magnitude of estimated halo density upper limits. We will apply these techniques to characterize gas kinematics and then compare to models to determ ine what processes are operating on the MS periphery.
