The non linear perturbation of the Kerr spacetime in an external region.

A bstract

W eprove, outside the in uence region of a ballofradius R_0 centered in the origin of the initial data hypersurface, $_0$, the existence of global solutions near to K err spacetime, provided that the initial data are su ciently near to those of K err; T his external region is the \far" part of the outer region of the perturbed K err spacetime. Moreover if we assume that the corrections to the K errm etric decay su ciently fast, o (r 3), we prove that the various null components of the R iem ann tensor decay in agreement with the \P eeling theorem ".

1 Introduction

1.1 The problem and the results

The problem of the global stability for the Kerr spacetime is a very dicult and open problem. The more dicult issue is that of proving the existence of solutions of the vacuum E instein equations with initial data $\ensuremath{\mathsf{near}}$ to Kerr" in the whole outer region up to the event horizon, which is also an unknown of the problem.

W hat is known up to now relative to the whole outer region are some relevant uniform boundedness results for solutions to the wave equation in the Kerr spacetime used as a background spacetime, see Daferm os-Rodnianski, [Da-Ro] and references therein¹

If we consider the existence problem in a external region su ciently far from the K err event horizon for a slow rotating K err spacetime the result is included, in the version of M inkowski stability result proved by S K lainerm an and one of the present author, F N., see [K l-N il] and also [C h-K l]. In this case one of the present authors, F N., recently proved, [N i2], that the asymptotic behaviour of the R iem ann components is in agreement with the \P eeling theorem " if the corrections to the K err initial data decay su ciently fast.

In this paper we face and solve a more di cult problem, namely we prove in an external region which will be de ned in detail later on, see the remark after the statement of Theorem 4.1 in Section 4, but basically is the region where² r R₀ and M = R₀ with su ciently small, the non linear stability of the Kerr spacetime for any J M² for an appropriate class of initial data near to Kerr.

M oreover if we restrict the class of initial data, once subtracted the initial data of the K err part, to those which decay toward the spacelike in nity faster than r³, we show again that the null asymptotic decay of the R iem ann tensor is in agreem ent with the Peeling theorem ". We can now state our main result in a som ewhat prelim inary version, the full version of the theorem can be found in Section 4.

Theorem 1.1. Assume that initial data are given on $_0$ such that, outside of a ball centered in the origin of radius R₀, they are dimensioned in the \Kerrinitial data of a Kerr spacetime with mass M satisfying

where > 0. Let us assume that the metric correction q_j , the second fundamental form correction k_{ij} are su ciently small, namely a function made by L^2 norms on $_0$ of these quantities is small,

then this initial data set has a unique development, M^{f} , de ned outside the domain of in uence of B_{R_0} . Moreover M^{f} can be foliated by a canonical double null foliation fC (u); C (u) g whose outgoing leaves C (u) are complete ⁴ and the various null components of the R iem ann tensor relative to a null frame associated to this foliation decay as expected from the P eeling theorem .

The proof of this result depends on m any previous results, the result on the stability for the M inkowski spacetime in the external region proved by S.K lainerm an and F N., in [K l-N il], a result which, at its turn, is based on the sem inal work by D \mathcal{L} hristodoulou and S K lainerm an, [C h-K l] and, concerning the proof of the peeling decay, in portant ideas of the proof come from the previous work by S K lainerm an and F N., [K l-N i2], and the recent [N i2].

Before presenting the main new ideas used in this paper we observe that the two results proved in this work, the global stability in the external region and the asym ptotic R iem ann decay in agreem ent with the peeling, are basically independent; relaxing the decay conditions on the initial data we can prove the stability with a worst null asym ptotic decay. In this paper we prove the two results together, but it should be easy to realize how to enlarge the class of initial data to prove only the rst one, proceeding as in [K HN i2] where it has been shown in detail, for the perturbed M inkowski spacetime, how the space-like decays of the initial data are connected to the null decay of the R iem ann components.

Finally, as we said, m any steps to prove Theorem 1.1 have been discussed in previous works, here we prove in every detail the new part of this result, namely Theorem 3.1 which is the core result to obtain, via a bootstrap mechanism, the global existence and the decay satisfying the Peeling theorem ".

In the remaining part of the introduction we exam ine the di culties one encounters to prove this result and how they have been overcom ed.

1.2 The global existence in an external region around the K err spacetim e

To understand the problem s arising perturbing around the K err spacetim e solution of the E instein equations it is appropriate rst to remember how the problem of perturbing around the M inkowski spacetime solution has been solved. The general strategy is usually called \bootstrap m echanism ": one proves with a local existence result that there is a nite region V, whose metric satis es the E instein equations, endowed with some speci c properties, mainly that some

norm s associated to the metric components and its derivatives are bounded by a (sm all) constant, then assumes that the largest possible region, V, where these bounds, we call bootstrap bounds", hold is nite and nally proves that, if the initial data are su ciently sm all, this region can be extended showing that the previous bounds can be improved. Therefore, to avoid a contradiction, this region should coincide with the whole spacetime.

To be a little less schem atic we assume that V is endowed with a foliation m ade by outgoing and incoming null cones, fC ()g and f<u>C</u> ()g, and that the norm s we assume bounded are those relative to the connection coe cients and to the components of the R iem ann tensor.

The central part of the proof is, therefore, to show that these norms can have better bounds. To do it we use in the manifold V the structure equations and the B ianchi equations. The structure equations take the form of transport equations for the connection coe cients along the incom ing and outgoing cones and of elliptic H odge systems on the two dimensional surfaces intersections of the incom ing and an outgoing cones, $S = C \setminus \underline{C}$. These equations can be seen as inhom ogeneous equations whose inhom ogeneous part depends on the R iem ann com ponents. The B ianchi equations, at their turn, can be written as transport equations for the R iem ann com ponents along the cones whose inhom ogeneous part is made by products of the R iem ann com ponents and the connection coefficients.

To use these equations we make a sort of linearization, namely we consider the R iem ann components as external sources satisfying the \bootstrap bounds" and show, using the equations for connection coe cients, that these bounds (of the connection coe cients) can be improved. Then we control the R iem ann components; to do it we use in a crucial way the fact that it is possible to de ne for the R iem ann components some quantities which play the role of the energy norms, in association to the B ianchi equations. These norms are basically weighted L^2 integrals, along the outgoing and incoming cones, of the BelR obinson tensor. A ssum ing the connection coe cients satisfying the \bootstrap bounds" we can prove that these energy norms are bounded by the corresponding initial data norms and using also the B ianchi equations obtain, nally, better norms for the R iem ann components.

This is a very schematic description of some of the main ideas developed in $[K \mapsto 1]$ to prove the M ikow ski stability result for the external region.

If we ask ourselves how to transport this strategy to perturb non linearly around the K err spacetime solution instead than around the M inkowski solution, we realize immediately that the main di erence is, in broad terms, that now we are perturbing around a solution di erent from zero, while the M inkowski spacetime can be considered a \zero solution". W ith that we mean that in the M inkowski spacetime all the connection coe cients are identically zero with the exception of the second null fundamental forms and _ which, due to the M inkowski spherical simmetry, reduce to the two scalar functions tr = $2r^{-1}$ and tr =

2r¹. M oreover all the R ism ann components are identically zero. Therefore to prove that the norm s are bounded and sm all we do not have to subtract the

connection coe cients or the R iem ann com ponents associated to the M inkowski solution as they are (with the exception of tr and tr) identically zero.

As the K err spacetime is not a \zero solution" some \overline{kind} of subtraction has to be done. This \subtraction" mechanism is delicate as we are not looking for a linearly perturbed solution⁵ and it is realized through four di erent steps:

i) The rst step consists in dening the \bootstrap assumptions" for V not for the connection coe cients and the Riemann tensor norms, but for their corrections, that is for the connection coe cients and the Riemann tensor com - ponents to which we have subtracted their K err parts.⁶ Sim bolically,

ii) The second step consists in writing the structure equation (in the V region) instead that for the connection coe cients , ; ; ;!;!:::: for their corrections.⁷

A swe said before, recalling the proof for the M inkow skistability, these equations have inhom ogeneous term swhich depend on the R iem ann tensor and, in this case, on the correction to the R iem ann tensor

Once we have these modiled structure equations we can use them to obtain better estimates for the norm s of these connection coecients corrections, O, provided we have a control for the norm s of the Riem ann components corrections, R.

iii) The third step consists in obtaining estimates for the R iemann components corrections. This requires to subtract the K err part of the R iemann tensor. This cannot be done in a direct way as the basic step to control the R iemann norms is to prove the boundedness of the energy type norms, generically denoted by Q. These norms are weighted L^2 integrals of the Bel-R obinson tensor which is a quadratic expression on the R iemann tensor.

We would need analogous norms for the R corrections and we also would like a well de nite positivity for the integrand, see the explicite expression of the Q norms in M inkowski case in [K lN i1], Chapter 3, to get from them estimates for the (correction of the) null R iem ann components norms. To obtain it we have to proceed in a di erent way based, intuitively, on the fact that the K err spacetime is stationary and $\frac{\theta}{\theta t}$ is a K illing vector edd. Therefore if, instead of considering the R iem ann components, we consider their time derivatives, they do not depend anym ore on the K err part of the R iem ann tensor, their initial data can have a better decay and if we could control their Q norms we could then obtain a good control of the R norms in V and also a good asymptotic decay along the null directions.

This argument as presented is not rigorous, in the perturbed K err spacetime $\frac{\theta}{\theta t}$ is not anymore a K illing vector eld, but it turns out that the basic idea can be implemented in the following sense:

Let us consider instead of the time derivative of the R iem ann tensor its (m odied) Lie derivative $\hat{L}_{T_0}R$, ⁸ where T_0 , whose precise de nition will be given later on, equal to $\frac{\theta}{\theta t}$ in the K err spacetime, is not anymore a Killing vector edd, but only \nearly Killing",⁹ then we de ne som e Q norm s relative to $\hat{L}_{T_0}R$ with appropriate weights and prove that they are bounded in terms of the corresponding quantities written in terms of the initial data; from it we can prove, after quite a few steps, that the R norm s are small and satisfy appropriate decays.

The steps just sketched require, to be fully understood, som em ore details; as we said the region V is the largest possible region where the so called \bootstrap assumptions" hold, in this region there is a foliation m ade by null incoming and outgoing cones f<u>C</u>();C()g, which are the level surfaces $u = , \underline{u} =$ of the functions $u(p);\underline{u}(p)$ solutions of the eikonal equations, see later and [K lN il], Chapter 3, for a detailed discussion. The foliation suggests to use the a ne param eters of the null geodesics generating the null cones, ; , as coordinates, hereafter denoted again $u;\underline{u}$, and som e angular variables $!^1;!^2$ to de ne an arbitrary point on the two dimensional surface S $(u;\underline{u}) = C (u) \setminus C (\underline{u})$. In V, thought as a subset of R⁴ where $(u;\underline{u};!^1;!^2)$ is a generic point, we can de ne two metrics the rst being the Kerrm etric, the other being the perturbed

where the K err m etric written in these coordinates is the one used in [IsPr]. This means that fV ;g_(K err)g can be thought as a region of the (outer) K err spacetime, while fV ;g_(pert:K err)g a region of the perturbed external K err spacetime whose existence we want to prove. The choice of the same coordinates will turn out important to get, subtracting the K err part, the transport equations for the connection coe cients corrections 0.

M oreover in V we can build a null fram e adapted to this foliation fe₃;e₄;e₁;e₂g where $e_1;e_2$ are vector elds orthonorm al and tangent to the two dimensional surfaces $S = C() \setminus \underline{C}()$ while $e_3;e_4$ are proportional to the null geodesics generating the cones and in the previous coordinates have the following expressions, as discussed in detail later on,

The last important thing to point out is that the integrands of the Q norms have to be a sum of non negative terms, see for instance [K lN il], Chapter 3 equations (3.5.1), ..., (3.5.3), which requires that the BelR obinson tensor have to be saturate by appropriate vector elds, linear combinations of e_3 , e_4 with positive weights. Therefore as in [K lN il] we saturate the BelR obinson tensor with the following vector elds

These vector elds, when we perturb M inkowski spacetime, are nearly K illing, while here they are not K illing vectors even in the Kerr spacetime.¹⁰ The

relevance of the T;S;K vector elds in the present case is connected to the fact that they are non spacelike elds in the region outside the ergosphere, m ade by e_3 and e_4 , the null vectors of the fram e adapted to the foliation which have the property that the elds $N = e_4$; $N = e_3$ are equivariant vector elds.

1.3 The decay of the R iem ann components, the Peeling

Beside the proof of the K err stability in a region with r $_{\rm R_0}>> M$, we prove that the null R iem ann components have a null asymptotic decay consistent with the \Peeling theorem ". This result has already been obtained by one of the authors, F N., [N i2], if we restrict ourselves to the perturbation of a very slow rotating K err spacetime or to a \very external region" which was de ned through the condition

where \sim is a small number depending on the smallness of the initial data. As discussed in [N i2], the advantage of restricting to this \much far" region is that, in this case, we do not have to prove again a global existence result as, in that case, the K err part of the metric can be considered itself a perturbation of the M inkow ski spacetime satisfying the conditions of [K l-N i1]. In the present paper, once we have proved a global existence result, the way to prove again the \peeling decay" is basically the same as the one discussed in [N i2], we sketch now the main ideas involved and we refer to [N i2] and to the next sections for a more detailed discussion.

In [Ch-K 1] and in [K HN i1], the null asymptotic behaviour of some of the null components of the R iem ann tensor, speci cally the and the components, see later for their de nitions, is di erent from the one expected from the \P eeling T heorem ", [W], as the decay proved there is slower. M ore precisely the com – ponents and ¹¹ do not follow the \P eeling theorem "as they decay as $r^{\frac{7}{2}}$ while we expect r ⁵ and r ⁴ respectively.¹² In a subsequent paper, [K HN i2], S K lainerm an and F N .proved that the decay suggested from the \P eeling theorem " could be obtained assum ing a stronger spacelike decay for the initial data. Unfortunately that result requires an initial data decay too strong for proving the \peeling decay" in spacetimes near to K err. To show how this result has to be improved let us rst recall it in some m ore detail. In [K HN i2] the following result was proved:

This result was obtained, basically, in two steps. The rst one consisted in proving that a fam ily of energy-type norms, Q, made with the BelR obinson tensor associated to the R iem ann tensor R, of the same type as those used to prove the global existence near M inkowski in [K lN il], but with a di erent weight in the integrand, were bounded in terms of the same norms relative to the initial data. The new weights are obtained multiplying the previous weights by a function juj with appropriate > 0 and the central point is that the extra term s appearing in the \E rror" we have to estim ate to control the boundedness of the Q norm shave a de nite sign and can be discarded. This allow ed to prove, from the boundedness of the Q norm s, that the various null components of the R iem ann tensor, beside the decay in r, have a decay factor in the jujvariable. In the second step it was proved that, integrating along the incom ing cones, the extra decay in the jujvariable can be transform ed in an extra decay in the r variable proving the nal result.

A s we said this result cannot be in mediately translated to the present case as the required decay for the initial data does not adm it initial data near to K err. The way out, which was already used in [N i2], is the one already used to prove global stability: we have to subtract the K err part, namely instead of looking directly to the decay of the R iem ann components we look to the decay of their tim e derivatives, m ore precisely the (m odi ed) Lie derivative w ith respect to the nearly K illing vector eld T_0 . This basically subtracts the K err part, allow s to prove the boundedness of the m odi ed Q norm s and nally proves that, with a \tim e" integration, rst, R satis es bounds which allow to extend the region V and prove globale existence and, second, show s that the null components of the R iem ann tensor satisfy the peeling decay. M ore details are given in the introduction to [N i2] and the com plete proof is given in the follow ing sections.

2 The Bootstrap assum ptions

The main di erence with [K \vdash N i1] and also [K \vdash N i2] are that in this case the initial data we are considering are a perturbation of K err initial data (in the external region of $_0$) and that, therefore, we do not assume the ADM mass small; moreover due to the K err m etric the decay of the initial data m etric does not satisfy the assumptions required in [K \vdash N i2].

We denote with 0 the connection coe cient norms de ned as in [K HN i1] and we make specic assumptions on them. We denote by R the norms associated to the various null R iem ann components, where and are in place of and .

The choice of norm s as $j_1j_jj_pj_s$ or j_Lj norm s follows the scheme of [K HN i1] and will be discussed later on, here we are interested to their weight factors and to their sm allness, therefore we denote all the norm s with j_j and which kind of norm s they represent follows exactly the pattern of [K HN i1].

2.1 The null canonical foliation and the metric in V

A swe said in the introduction di erently from [N i2] one has to prove again the existence of a global (external) spacetime, non linear perturbation of the K err one. This is done with a strategy similar to the one used in [K HN i1] with some important di erences. First the Q norms for the R iem ann tensor de ned in [K HN i1] are substituted by some Q norms associated to the \time derivative" of the R iem ann tensor, $\hat{L}_{T_0}R$, second, to rebuild from the know ledge of $\hat{L}_{T_0}R$ the complete R iem ann tensor one has to control the connection coe cients in a very detailed way, namely to have norm estimates for the di erence. O between the control of the complete connection coe cients in [K HN i1], is made writing the transport equations for these terms which are obtained starting from the structure equations for the whole connection coe cients and subtracting their K err parts.

M ore precisely it is clear that the K err connection coe cients satisfy transport equations sim ilar to those in [K HN i1] with respect to a double null cone foliation of the K err spacetime. On the other side the connection coe cients of the perturbed K err spacetime e satisfy the transport equations written with respect to a double null cone foliation of the perturbed K err spacetime. This is plies that to subtract the K err part (to these trasport equations) we have also to control the difference between the double null cone foliation associated to the K err spacetime e and the one associated to the perturbed K err spacetime e and prove that this is sm all. This also has to be part of the bootstrap mechanism and requires that the bootstrap assumptions on the connection coe cients term s im – ply analogous estimates at the level of the corrections to the metric components, we denote hereafter globally $O^{(0)}$.

The subtraction of the K err part to the transport equations for the connection $\cos e$ cients is a crucial step of the proof. The transport equations on the other side require V endowed with a double null cone canonical foliation which is the rst of the \B ootstrap assumptions" we make.

2.2 The connection coe cients and R iem ann tensor bootstrap assum ptions:

Once that V is endowed with a double null canonical foliation we have to specify the remaining conditions we assume satis ed in V. The O connection coe cients are tensor elds tangent to the S two dimensional surfaces associated to the double null cone foliation of the perturbed K err spacetime, while the O $^{(K err)}$ connection coe cients are tensor elds tangent to the S $_{(K err)}$ two dimensional surfaces. Therefore their di erence would not be an S-tangent tensor. To avoid this problem we recall that each O $^{(K err)}$ can be written as, assuming it, for instance, a (0;2) covariant tensor,

Therefore hereafter with r we always mean the quantity de ned in 2.46, a well de ned function of u and \underline{u} .

O beserve that the norm estim ates in 2.50 refer to those connection coe cients which are di erent from zero in M inkowski, the norm sestim ates in 2.51 refer to those connection coe cients which are di erent from zero in Schwarzschild, but zero in M inkowski and the norm estim ates in 2.52 refer to those connection coe cients or derivatives of connection coe cients which are di erent from zero in K err, but zero in Schwarzschild and in M inkowski.

These \K err decays" can be easily obtained by dimensional arguments recalling that the K err metric, written in the Boyer-Lindquist coordinates, in the limit M ! 0, a kept xed and dierent from zero, reduces to the M inkowskimetric written in the \oblate coordinates" and as we know that in M inkowskispacetime all connection coe cients, with the exception of tr and tr _, are zero, it follows that performing an $\frac{1}{r}$ expansion of the connection coe cients which are zero in M inkowski, all the coe cients of the terms in $\frac{1}{r^k}$ which depend only on a and not on M must be identically zero.

ii) The second fundam entaldi erence is that we are considering these norms s not associated to the R iem ann tensor R, but to the W eyl tensor $\vec{R} = \hat{L}_{T_0}R$ which can be interpreted as the \tim e derivative" of R; this is one of the steps, as discussed in the introduction, required to separate the K errpart of the R iem ann tensor from the whole R iem ann tensor.

iii) The third di erence is that the weights of these Q norm s have an extra decay factor, $j_{1}j_{1}^{j_{+}}$, with > 0. This factor has the e ect, in a complicated way shown in the following lemmas, of giving a better decay for the various null components of $\hat{L}_{T_0}R$. This better decay is required for two reasons, the rst one is to guarantee that the decay of R iem ann tensor be in agreement with the <code>\peeling decay"</code>, this requires the exponent 5+ , and the second one that it has to allow to recover the decay of the R iem ann tensor by <code>\time integration"</code>.²⁵ The central point in the de nition of these Q norm s is that the exponent 5+ is chosen in such a way that, once we prove that these norms are bounded in V , which depends only on the assumption that M =R₀ be su ciently small, then the null components of $\hat{L}_{T_0}R$, ; ;::: decay with an exponent 5+ $\frac{1}{2}$; $4 + \frac{1}{2}$; $3 + \frac{1}{2}$; :::: depending on the null components we are considering where

Nevertheless the proof we sketch here is restricted to the zero and rst derivatives of the connection coe cients as the control of the higher derivatives is simpler and is just a repetition of what has been done in [K lN il].

To control the 0 norm swe have to subtract to the connection coe cients their K err part so to obtain some transport equations and some H odge equations relative to the 0 correction parts. This operation which we call \K err decoupling" is a central step of the whole procedure and we rst discuss it in some generality. Then we will exam ine a typical case.

3.6 V step: The initial data

3.7 VI step: The extension of the region V

As previously said once we have proved that in the region V the estimates for the norm s of the connection coe cients and for the R iem ann tensor are better than those assumed in the \B ootstrap assumptions" we have done the basic step to conclude that a region larger than V does exist where the previous quantity satisfy again the \B ootstrap assumptions". To obtain this result, nevertheless, something m ore is needed. In fact the bootstrap argument requires that two conditions be satis ed. First that a region with the assumed properties of the V region does exists, possibly a very small one, second it requires to prove that this region can be extended.

The rst condition can be implemented by a local existence result in a small strip above $_0=B_{R_0}$ and, in fact, of this solution we are interested only to the dependence region V associated to the annulus in $_0$ with r 2 $[R_0;R_0 + R]$, with R arbitrary small and it is clear that starting from appropriate initial data we can satisfy in V all the \bootstrap assumptions".

The second condition to be satis ed requires to solve again an existence problem starting from the upper boundary of V. The strategy is not completely standard, but it has been already discussed in [K HN i1], C hapter 3, section 3.7.8, see also [N i]. Therefore we sketch here only the more relevant points and the di erences from the situation discussed there.

The region whose existence we have to prove is a strip" above the last slice of the region V of arbitrary small width. Nevertheless as there is no bound for the size of the region V this existence problem is not a local problem in both directions, it is local in the <code>\outgoing cones</code>" direction, but not local in the <code>\incom</code> ing cones" directions. Moreover this is a characteristic problem as its initial data are on the intersection of the portions of two cones, one outgoing starting at the intersection of the last slice of V with <code>0</code>, the other one being exactly the last slice. A s the last slice can be very extended, to prove this result will require again a bootstrap argum ent, the di erence being now that once we assum e (again by a bootstrap assumption) that a portion of this strip does exist then to prove that it can be extended, therefore proving that the whole strip does exists requires in this case a real characteristic local problem which is easy to obtain. We do not give more details on it as this problem has already been treated an solved in two previous papers by the same authors, see [Ca-Nil], [Ca-Ni2]. Observe nally that the initial data in this case automatically satisfy the constraints for the characteristic probelm as they are the restriction on these hypersurfaces of the E instein solutions; the di erence with respect to the discussion on [Ca-Ni2] is that in this case the \initial data" are near to Kerr instead than to M inkow ski, but this is not a problem.

Finally to complete the result we have to prove that, again, in the extended region, V + V, the estimates R $_0$; O $_0$ hold. This requires some care, in fact from the \last slice initial data" one would be tempted to infer that the Q norm s, to be nite avoiding possible logarithm ic divergences, would require a weight juj with ~< , the analogous of the loss of decay from the initial data to the solutions. The problem is cured observing that once we have a solution in V + V and a new double null canonical foliation we can, exactly as before, to estimate the Q on the outgoing and incom ing cones in term s of the same norm s on $_0$ and repeat all the previous lemmas to reobtain the correct decay for the

R norm s. Once this is done we repeat exactly the same procedure done in V for the connection coe cients so that, nally, we have proved that in V + V all the bootstrap assumptions are still valid and, by contradiction, that V has to coincide with the global (external) spacetime.

In fact trying to go near to the event horizon or even to the \photosphere region", see [B1] and references therein, we would immediately not serious problem strying to control the Q norm s in terms of the initial data ones.

5 Conclusions

As said in the introduction the global existence proof is separated from the \peeling result". The global existence near K err spacetime required, in a broad sense, to subtract the K err part. This is done concerning the R iem ann components looking for the estimates for the \time derivative" of the R iem ann tensor, which eliminates the contribution of the K err spacetime, or m ore in general of any stationary spacetime. The subtraction for the connection coe cients is viceversa m ade in a more general way as the subtracted part has not to be time independent.⁵⁶ This is in some sense the more original part as, in a more external region, the peeling decay has been already proved in Ni2].

Lem m a 6.4. In the Kerr spacetime the deformation tensor components of $T_{\rm 0}$ are all identically zero.

P roof: This follows in m ediately from the stationarity of the K err spacetime, we prove it directly by computation as these are useful when we do perturb the spacetime.

C orollary 6.1. From the previous Lemma and 6.479 it follows that in the K err spacetime
