REDUCTIONS OF THE DISPERSIONLESS 2D TODA HIERARCHY AND THEIR HAM ILTONIAN STRUCTURES

Abstract. We study nite-dimensional reductions of the dispersionless 2D Toda hierarchy showing that the consistency conditions for such reductions are given by a system of radial Loewner equations. We then construct their Hamiltonian structures, following an approach proposed by Ferapontov.

1. Introduction

The dispersionless KP and 2D Toda hierarchies are two main examples of hierarchies of equations of hydrodynamic type with an in nite number of dependent variables [9]. The problem of the nite-dimensional reduction of these hierarchies consists in nding constraints which are compatible with the owsofthe hierarchy and such that the constrained ows are described by a system of equations hydrodynamic type with a nite number of dependent variables.

In the case of the dispersionless KP hierarchy (or Benney hierarchy) it was shown [5,6] that the equations describing the compatibility of the constraints are a system of chordal Loewner equations. Recently, the Hamiltonian formulation of such reductions have been studied, in terms of nonlocal [3] and purely nonlocal [4] Poisson brackets.

In this paper we consider N -dim ensional reductions of the dispersionless 2D Toda hierarchy. In Section 3 we show that the consistency of a reduction is equivalent to a system of radial Loewner equations. We show that the compatibility conditions for such system is given by G ibbons-T sarev equations from which it follows that the reductions are semith amiltonian. We present generating functions for the lows (or symmetries) of the reductions and give a proof of the functional dependence of the two Lax functions. In Section 4 we consider the Hamiltonian structures of the reductions. Following an approach of Ferapontov we show that it is possible to factorize the Riemann curvature tensor, associated with some diagonal metric, in terms of the symmetries of the reduction. From such factorization the existence of nonlocal Hamiltonian structures follows. In Section 5 purely nonlocal Hamiltonian structures for the reductions are studied and in Section 6 an example is considered.

2. The dispersionless 2D Toda hierarchy

The Lax representation of the dispersionless two-dimensional Toda hierarchy [9] is de ned in terms of two formal Laurent power series in p

where the dependent variables u_k and u_k depend on the spatial variable x and on two in nite sets of independent variables t_n and t_n for n>0. The Lax equations are

We denote by ()₊ and () the projections of a power series in p to positive and strictly negative powers of prespectively. In this form alsetting the Lax equations are considered as generating functions of an in nite set of involutive evolutionary equations of hydrodynam ic type for the ∞ e cients u_k and u_k .

In the following we will consider and as univalent analytic functions on certain domains in the complex plane, having the expansions (1) at p = 1; 0 respectively.

3. Reductions of the 2D Toda hierarchy

In this section we consider the reductions of the dispersionless 2D Toda hierarchy and their relation with systems of radial Loewner equations. Similar results were rst obtained for the dispersionless KP case by G ibbons and T sarev [5, 6]; other examples { including the dispersionless 2D Toda hierarchy { have been studied, for instance, in [14, 7, 8, 10, 11].

A reduction of the dispersionless 2D Toda hierarchy is given by a choice of two families of functions

where $v_{(n)}^i$ and $v_{(n)}^i$ are suitable functions of $_1;:::;_N$, depending on the choice of and . We will denote by $v^i=v_{(1)}^i$ the rst of these functions.

Proposition 1. The functions (3) with (4) provide a reduction of the dispersionless 2D Toda hierarchy if and only if the following system of Loewner equations is satisfied

For n=1 we have $B_1=p+u_0$; therefore, in this case equations (7) are exactly the Loewner system (5). We prove now that the other conditions (7) { for n>2 { and (8), follow from (5). To see this, consider the rst equation in (7) for n>2. Using Loewner equations, we have

The Loewner equations can be equivalently written in terms of $' \models \log u_1$ instead of u_0 . Indeed, expanding both sides of the Loewner equations (5) at p=1, we get

where we have used the notation $\theta_i = \frac{\theta}{\theta_i}$. The G ibbons-T sarev equations can be recovered as the two leading one cients of the expansion for p v^i . It is easily checked by direct substitution in (12) that the G ibbons-T sarev are also su cient for the compatibility.

U sing the G ibbons-T sarev system (11), it is easy to prove that the characteristic velocities v^i of the reduction of the dispersionless 2D Toda hierarchy satisfy the condition 0 1

known in the literature as sem i-H am iltonian condition [12]. The above system arises as the compatibility condition of the linear system

which gives the characteristic velocities w^i of the symmetries of the reduction. Therefore, every N-tuple of functions de ned in (6) automatically satisfies the sem i-H am illinoian condition (13).

Next, we de ne a pair of generating functions for the sym metries.

In the reductions of the dispersionless 2D Toda hierarchy one needs only one of the two Lax functions , ; indeed, we have the following

4. Hamiltonian formulation

We have seen that the reductions of the dispersionless 2D Toda hierarchy are sem i-H am iltonian systems of hydrodynamic type. In [1] Ferapontov conjectured that any sem i-H am iltonian system is always H am iltonian with respect to suitable, possibly nonlocal, H am iltonian operators (see also [2]), which are obtained by the following construction:

1. Find the general solution of the system

To this purpose is sulcient to indicate one solution g_{ii} of (17), since the general solution is $\frac{g_{ii}}{1}$, where i are arbitrary functions of one argument. The functions g^{ii} denerthe non-vanishing controvariant components of a diagonal metric.

2. W rite the non-vanishing components of the curvature tensor in terms of solutions w^i of the linear system (14):

We now apply the above procedure to nd a Ham iltonian formulation for reductions of the dispersionless 2D Toda hierarchy. Using the Gibbons-Tsarev equations it is easy to check that

Proposition 8. The general solution of the system (17) is given by

$$R_{ij}^{ij} = \frac{1}{2i} \frac{F(p)v^{i}v^{j}}{(p + v^{i})^{2}(p + v^{j})^{2}} dp; \quad i \in j;$$

Due to (21), the above integral splits in two

$$\frac{1}{2 \text{ i}} \frac{Z}{(p \text{ } v^{i})^{2} (p \text{ } v^{j})^{2}} dp = \frac{v^{i}v^{j}}{2 \text{ i}} \frac{Z}{(p \text{ } v^{i})^{2} (p \text{ } v^{j})^{2}} dp = \frac{v^{i}v^{j}}{2 \text{ i}} \frac{Z}{(p \text{ } v^{i})^{2} (p \text{ } v^{j})^{2}} dp = \frac{v^{i}v^{j}}{2 \text{ i}} \frac{Z}{(p \text{ } v^{i})^{2} (p \text{ } v^{j})^{2}} dp$$

and the second term of the right hand side above is zero, for all poles of the rational integrand lie inside the contour . Hence, we have

$$R_{ij}^{ij} = \frac{v^{i}v^{j}}{2 i}^{Z} \frac{\frac{1}{0(p)}}{(p v^{i})^{2}(p v^{j})^{2}} dp;$$

after a change of the variable of integration, we get

$$R_{ij}^{ij} = \frac{1}{2i} \left[\frac{v^{i} \frac{\partial p}{\partial e}}{(p(x) v^{i})^{2}} \frac{v^{j} \frac{\partial p}{\partial e}}{(p(x) v^{j})^{2}} d \right];$$

which is exactly formula (26).

We can now formulate our main theorem on the Hamiltonian representation of the hierarchy in the case of potential metric.

Theorem 11. The reduction of the Toda hierarchy associated with the function $(p; _1; :::; _N)$ is Ham iltonian with the Ham iltonian structure

H ere

are the Christo elsym bols of the metric.

In the general case, with the non-potential metric

we can prove that we have a sim ilar expansion of the curvature tensor, given by

$$R_{ij}^{ij} = \frac{v^{i}v^{j}}{2i} \sum_{k=1}^{N} \frac{\frac{1}{p}}{(p - v^{i})^{2}(p - v^{j})^{2}} k (p) dp$$

Therefore, we have the following family of Hamiltonian structures

for any choice of the functions i.

5. Purely nonlocal Hamiltonian structures

In addition to the nonlocal Ferapontov-type H am iltonian operators, we can associate to any reduction of the dispersionless 2D Toda hierarchy a fam ily of purely nonlocal H am iltonian operators. In the sem i-H am iltonian case, it has been shown in [4] that if W^i are the characteristic velocities of pairw ise commuting diagonal hydrodynamic ows, the operator

For the reductions of the dispersionless 2D Toda hierarchy, the following result holds:

Lem m a 12. The contravariant components of the metric (29) adm it the following quadratic expansion

where the W i () are the generating functions of the sym m etries (15).

Proof The proof is a straightforward computation of the integral:

the last step being due to the fact that $p = v^k$ are critical points of , so that the di erential turns out to be regular at all these points for $i \in j$, and also for i = j and $k \in i$. M aking use of Lem m a 7, we obtain the desired result.

Therefore the purely nonlocal operators associated to the reductions of the dispersionless 2D Toda hierarchy are

6. An example: the Dispersionless Toda chain

The simplest example of reduction is the dispersionless Toda chain, which is given by the constraint.

The characteristic velocities are given by the critical points

and the Riem ann invariants by the critical values of =

In this simple example we can explicitly write $\,$, $\,$, the characteristic velocities, u_0 and ' in terms of the R iem ann invariants, i.e.

 $= p + \frac{1+2}{2} + \frac{1}{4} = p^{-1}$

and

$$v^1 = \frac{1}{4}; \quad v^2 = \frac{2}{4}; \quad u_0 = v = \frac{1+2}{2}; \quad u_0 = u = 2\log \frac{1}{4}:$$

It is easy to check that these functions satisfy Loewner (5) and G ibbons-T sarev (11) equations. Let us compute the H am iltonian operators associated to the m etrics

$$g_{ij} = \frac{\theta_i u}{\frac{k}{i}} ij$$

for k > 0, which clearly solve (17). Explicitly

In this case the curvature can be expressed as

$$R_{12}^{12} = \frac{v^{1}v^{2}}{2 \text{ i}} \frac{Z}{(p())} \frac{\frac{\theta p}{\theta}^{2} k}{(p())^{2}(p())^{2}(p())^{2}} d;$$

or alternatively as

$$R_{12}^{12} = v^{1}v^{2} R_{12}^{2} = v^{1}v^{2} R_{12}^{2} = v^{1} (p)^{k} \frac{1}{(p + v^{1})^{2} (p + v^{2})^{2}} dp^{A} :$$

For k = 0;1;2, the abelian di erential

$$\frac{(p)^{k} \frac{1}{0(p)}}{(p v^{1})^{2} (p v^{2})^{2}} dp$$

has poles only at the points $p = v^1$; $p = v^2$; and therefore the curvature vanishes and the associated H am iltonian operators are local.

For k>2 new poles appear at p=0 and p=1. Since the sum of the residues of an abelian di erential on a compact R iem ann surface is zero, we can substitute the sum of residues at $p=v^1$; v^2 with m inus the sum of residues at p=0 and p=1, obtaining

$$R_{12}^{12} = v^{1}v^{2}$$

Taking into account that (0) = (1) = 1, we easily obtain the counterpart of the above form ulae in the -plane

Since the expansions of w^1 () and w^2 () near = 1 have the form

$$w^{1}() = \sum_{k=1}^{X^{1}} kv_{(k)}^{1} \qquad k^{1} = \frac{1}{4^{2}} + \frac{(1}{2})(3_{1} + 2)}{8^{3}} + \dots$$

$$w^{2}() = \sum_{k=1}^{X^{1}} kv_{(k)}^{2} \qquad k^{1} = \frac{2}{4^{2}} + \frac{(2}{3})(3_{2} + 1)}{8^{3}} + \dots$$

we obtain the quadratic expansion of the Riem ann tensor

$$R_{12}^{12} = 2$$
 $w_{(1)}^{1} s v_{(s)}^{2}$

and we can im m ediately write the corresponding nonlocal H am iltonian operator ij . From the last form ula we have that the nonlocal tail of e.g. 12 is given by

Sim ilar formulas can be obtained in this example for purely nonlocal Ham iltonian structures.
