Stochastic Stability: a Review and Some Perspectives.

A bstract

A review of the stochastic stability property for the Gaussian spin glass models is presented and som e perspectives discussed.

1 Introduction

In this paper we review the property of stochastic stability originally introduced for the Sherrington-Kirkpatrick spin-glass mean eld model in [AC]. Here we show some of its consequences expressed in terms of the quenched equilibrium state both in the form of identities for the overlap distribution and of quenched additivity of the free energy. O verlaps between two spin con gurations ⁽¹⁾ and ⁽²⁾ are usually de ned as

but our treatment is given in full generality since it is by now well known [Co] that every G aussian spin glass model has an equilibrium state well expressed by the properties of a probability measure of a suitable overlap structure given by its covariance matrix. Stochastic stability provided a rst and simple method to produce an in nite family of identities for the overlap variables. Identities for random variables with respect to the quenched state reduce the degrees of freedom of the model and go toward the core of the Parisi m ean-eld theory: spin glasses are described by a probability distribution of a single overlap variable and the collections of copies necessary to describe the whole equilibrium state can be obtained by a suitable combinatorial rule called ultram etric which holds for classes of equivalent overlap structures (overlap equivalence). A lthough a sim ilar research project is not even completed for the Sherrington-K inkpatrick m odel in portant progresses have been done toward it and there are clear indications, som e based on num erical work [CGGV, CGGPV1, CGGPV2] som e on rigorous grounds (see the last section), that m ean eld m odels and short-range nite-dimensional ones behave quite sim ilarly as far as the factorization rules are concerned. Stochastic stability is deeply rooted also within the physics community. It has immediately been used in fact in [FM PP1, FM PP2] to determ in a relation between the o -equilibrium dynam ics which is experimentally accessible and the static properties and is considered, from the theoretical point of view, a structural property of the spin glass phase [Pa1, Pa2].

The paper is organized as follows: the rst section introduce the basic notions of a spin glass systems and the relative notations, the second the property of stochastic stability and its consequences. The third exam ines some perspectives in the light of some interesting recent development and provides some perspective.

2 De nitions

We consider a disordered model of Ising congurations $_n = 1, n 2$ L for some subset (volume j) of some in nite graph L. We denote by the set of all = $f_n g_{n2}$, and j j= $2^{j j}$. In the sequel the following de nitions will be used.

1. Ham iltonian.

For every L let fH ()g $_{2_{N}}$ be a fam ily of 2^{j} translation invariant (in distribution) G aussian random variables de ned according to the general representation

2. A verage and C ovariance m atrix.

The Hamiltonian H () has covariance matrix

The two classical examples are the covariances of the Sherrington-K irkpatrick m odel and the Edwards-Anderson m odel. A simple computation shows that the rst is the square of the function (1.1) and the second is the link-overlap

9. Quenched overlap observables.

For any smooth bounded function G (c) (without loss of generality we consider jGj 1 and no assumption of permutation invariance on G is made) of the covariance matrix entries we introduce (with a small abuse of notation) the random R R matrix of elements $fq_{k,l}g$ (called generalized overlap) and its measure h i by the formula

3 Stochastic Stability

G iven the G aussian process H () of covariance C (;) we introduce an independent G aussian process, K (), de ned by the covariance c (;), the deform ed random state

and its relative deform ed quenched state h $i^{()} = Av$ $i^{()}$ ().

De nition 3.1 Stochastic Stability [AC, CGi]

A Gaussian spin glass model is stochastically stable if the deformed quenched state and the original one do coincide in the thermodynamic limit:

R em ark 1 In spin glass models the existence of the therm odynam ic lim it has been settled only at the level of the free energy [GT, CL]. For the correlation functions there are only abstract results using compactness arguments or, equivalently, existence along subsequences. In comparison with models without disorder, for instance the ferrom agnetic ones, what is lacking is the control of the local correlation functions in terms of the interaction parameters. W hile ferrom agnetic correlations increase motononically when varying any spin interactions (Gri ths, K elly and Sherm an inequalities of type II [Gr, KS]) nothing is know about a spin glass correlation functions are not monotonic in the volum e [CUV] when the interaction is centered. For non zero average of the interaction a special result exists in the N ishim ori line where motononicity is recovered [CMN].

Since the Hamiltonian H and the eld K have a mutually rescaled distribution

the addition law for the Gaussian variables implies

i.e. the deform ation with a eld K is equivalent to a change of the order O $\left(\frac{1}{N}\right)$ in the tem perature. The previous identity shows that the deform ed m easures do coincide, a part on points of discontinuity with respect to the tem perature, with the original unperturbed one. Let consider some consequences of the stochastic stability that have been proved in a series of works.

Proposition 3.1 Zero-average polynom ials.

For every monomial Q of the overlap algebra (e.g. $c_{1;2}$, or $c_{1;2}^2 c_{2;3}$) for a gaussian spin glass model de ned by the covariance in (2.6) the following property hold:

where the quantities Q are polynomials which can be computed with a graph-theoretical algorithm or with the standard Parisi replica limit n ! 0 formula (see [AC]). Moreover the property (3.23) implies

A simple computation allows to deduce that, for every interval $\begin{bmatrix} 0 & 1 \end{bmatrix}$

i.e. the vanishing in 2^{-} -average of the quantities h Q i when the therm odynam ic lim it is considered. See also Ba] for an independent m ethod to obtain the previous result which works for general (including non G aussian) distributions and BaGe] for an interpretation of the identities as the N oether's conserved quantities in a classical m echanics theory.

The consequences seen so far derive from the computation of the rst two derivatives and basically mean that for a stochastic perturbation tuned by a parameter not only the rst derivative vanishes when computed in zero (which is obvious for symmetry reasons) but also the second one in the therm odynamic limit does i.e. the curvature of the perturbed state is a vanishing function for increasing volumes.

The possibility that the computation of higher order derivatives could lead to new results beyond (3.26) has been investigated in [Co2, BCK] and has a negative answer due to the following result

which implies that the vanishing of higher order derivatives provides the same information of the second one at the level of the whole algebra of observables.

In the paper [AC] it has been proved that stochastic stability is equivalent to the following property:

Proposition 3.2 Quenched additivity.

Given any nite collection of independent Gaussian elds $K_{(1)}(); K_{(2)}(); \ldots; K_{(1)}()$ (independent also on the Ham iltonian) with the same covariance (2.6), and any smooth polynom ially bounded functions $F_1; F_2; \ldots; F_1$ a Gaussian spin glass model fulls the following relation

where the Gaussian measure Av() include the integration on all the elds $K_{(i)}$ and the Ham iltonian, and the state () is de ned in (2.17). The previous formula would be trivial if the elds F_i would be independent with respect to the measure which is not the case for the class of elds considered here. Equivalently, denoting the truncated expectations (cum ulants) of order p of the G ibbs-Boltzm ann state by (; p), the previous relation says that

for every integer p, i.e. the linearity in average of the truncated correlation functions of every order.

4 Som e perspectives: tow ard ultram etricity

The method of stochastic stability is strictly related to the uctuation method introduced in [Gu] and developed in [GhiGu]. The main idea of that method is to show that from the simple control of the uctuations for the H amiltonian perparticle, which parallels the law of large numbers, one can deduce a set of identities. The relation between stochastic stability and the method of the uctuations is developped in the paper [CGi2] where it was proved that the linear part of the Ghirlanda-Guerra identities coincide with the identities produced by stochastic stability (see also [Ar] for a further interesting result in the fram ework of the competing particle system s).

The relation between stochastic stability and the method of uctuation is still under investigation, in particular one would like to know if the two properties su ce to prove a much stronger property called ultram etricity: an overlap distribution is called ultram etric if it is supported (in the therm odynam ic lim it) only on isoceles and equilateral overlap con gurations. For such distributions the measure of scalenes con gurations is zero.

Some recent interesting developments are approching the solution of the problem. To explain them it is important to report a stronger de nition of stochastic stability introduced in [AC]

De nition 4.2 Extended Stochastic Stability

A Gaussian spin glass model is stochastically stable in the extended sense if it is stochastically stable under deform ation with respect to all K^(p) () whose covariance are c^{p} (;). Its consequences clearly extend to every power of the covariance c the results already proved with the standard stochastic stability.

In the fram ework of the competing particle systems it has been proved [ArAi] that the extended stochastic stability if applied to overlaps which take only a nte number of values implies ultram etricity. The same result has been obtained, for the same class of overlap distribution, using an extended version of the uctuation method in [Pa, Ta].

It is in portant to stress that the form alism developed so far is not limited to the mean eld spin glasses. Indeed all the results which we have shortly reviewed hold for a general

G aussian spin glass model in terms of the proper covariance matrix. In particular the recent developments, in which ultrametricity under certain hypotheses has been proved, do not distinguish between the mean eld case or the short-range nite-dimensional one like the Edwards-Anderson model. They give indeed a clear indication that the factorization structure of the two cases is likely to be the same. Of course even such similarity for the factorization structure wouldn't be enough to guarantee the same be -temperature phase for the two models. The celebrated Parisi self-consistence equation [M PV], which in plies that the overlap distribution of the Sherrington-K inpatrick model has a non-trivial support, is in fact very specie c for the mean eld case with its strong permutation invariance symmetry. It is still not clear what would be the structure of the link-overlap distribution for the Edwards-Anderson model if a complete ultrametric factorization would take place.
