ARPES spectral functions and Ferm i surface for $La_{1:86}Sr_{0:14}CuO_4$ compared with LDA+DMFT+ k calculations

Slightly underdoped high-T_c system La_{1:86}Sr_{0:14}CuO₄ (LSCO) is studied by means of high energy high resolution angular resolved photoem ission spectroscopy (ARPES) and combined computational scheme LDA+DMFT+ $_k$. Corresponding one band Hubbard model is solved via dynamical meaneld theory (DMFT), while model parameters needed are obtained from rst principles within boal density approximation (LDA). An \external" k-dependent self-energy $_k$ describes interaction of correlated electrons with antiferrom agnetic (AFM) pseudogap uctuations. Experimental and theoretical data clearly show \destruction" of the LSCO Ferm i surface in the vicinity of the (,0) point and form ation of \Ferm i arcs" in the nodal directions. ARPES energy distribution curves (EDC) as well as momentum distribution curves (MDC) demonstrate deviation of the quasiparticle band from the Ferm i level around (,0) point. The same behavior of spectral functions follows from theoretical calculations suggesting AFM origin of the pseudogap state.

I. IN TRODUCTION

O ne of the not yet solved puzzles of cuprate hightem perature superconductors (HTSC) is a nature of underdoped normal state - the pseudogap regim e¹. Perhaps most powerful experim ental tool to access electronic properties of the pseudogap state is angular resolved photoem ission spectroscopy (ARPES)^{2,3,4}. Common understanding is the uctuating origin of the pseudogap state, how ever type of the uctuations is still under discussion. Whether these are superconducting uctuations or som e order parameter uctuations (AFM (SDW), CDW, stripes, etc.)^{6,7} coexisting or competing with Cooper pairing is up to now undecided.

There are several prototype compounds among high- T_c system s e.g. hole doped $B_2Sr_2CaCu_2O_8$ (Bi2212) system or the electron doped one { $Nd_2 \ x Ce_xCuO_4$ (NCCO). Now a lot of experimental ARPES data on Bi2212 and NCCO is available (see the review Ref. 2). For instance Ferm isurface (FS) maps, quasiparticle band dispersions and even self-energy lineshapes mapped onto som emodels are obtained from modern ARPES measurements⁶. Into this list of prototype componds should be of course included the rst ever high- T_c hole doped system La_{2 x} Sr_xCuO₄ (LSCO) which was also investigated both in theory and experiment with great details.²

W ithin the normal underdoped phase (pseudogap regin e) a number of interesting physical phenom enawere discovered. For example, FS is partially \destructed" in the vicinity of the so-called \hot-spots" (points of crossing between FS and AFM um klapp surface). \Shadow bands" (partial folding of band dispersion) appear apparently as a result of short range AFM order. Form ation of the so called Ferm i \arcs" around Brillouin zone (BZ) diagonal rem iniscent of the parts of noninteracting FS is experim entally detected in num erous ARPES experiments². Despite apparently the same physics behind, pseudogap regime demonstrates some material species of features. For Bi2212 Ferm i \arcs" go almost up to BZ border where they are strongly blurred. The NCCO also has Ferm i \arcs" but FS \destruction" boks dierent. The "hot-spots" are well observed in NCCO while towards the BZ border FS is almost restored as a non interacting one.⁸

The present paper is devoted to pseudogap behavior in the underdoped LSCO and its comparison with Bi2212 and NCCO.

According to common knowledge high-T_c systems are usually doped M ott insulators, e ectively described by the Hubbard model. Most common method to solve the Hubbard model in our days is dynamical mean-eld theory $(DMFT)^{9}$. Its exactness in the in nite spatial dim ensions lim it makes DMFT a local approach. Since high-T_c compounds as it is well established have quasity o-dimensional nature spatial uctuations play important role for their physics. To overcom e this di culty we introduced DMFT+ k computational schem e^{10,11,12} which supplies conventional DMFT with \external" k-dependent self-energy. M ain assumption of the DMFT + $_k$ is additive form of the self-energy which allows one to keep conventional DMFT self-consistent set of equations. The DMFT+ $_k$ approach was used to address the pseudogap problem¹¹, electron-phonon coupling in strongly correlated system s¹³ and disorder induced metal-insulator transition within the Hubbard-Anderson model¹⁴. For the pseudogap state this selfenergy k describes the interaction of correlated electrons with non-local (quasi) static short-ranged collective Heisenberg-like antiferrom agnetic (AFM or SDW like) spin uctuations¹⁵. DMFT+ $_{k}$ approximation was also shown to be appropriate to describe two-particle properties e.g. optical conductivity.¹⁶

As a possible way of theoretical simulation of the pseudogap regime for real materials we proposed LDA+DMFT+ $_{\rm k}$ hybrid method⁷. It combines rst principle one-electron density functional theory calculations within local density approximation (DFT/LDA)¹⁷ with DMFT+ $_{\rm k}.^{18}$

LDA+DMFT+ $_{\rm k}$ m ethod allowed us to obtain Ferm i arcs and \hot-spots" behavior for both electron doped e.g. Nd_{1:85}Ce_{0:15}CuO₄⁸ (NCCO) and Pr_{1:85}Ce_{0:15}CuO₄ (PCCO)¹⁹ as well as hole doped Bi₂Sr₂CaCu₂O₈ (Bi2212)⁷ high-T_c cuprates. Pseudogap behavior of dynamic optical conductivity within LDA+DMFT+ $_{\rm k}^{16}$ was also discussed for B12212⁷ and NCCO⁸.

This communication reports LDA+DMFT+ $_{\rm k}$ computations of Ferm i surface and spectral functions for hole underdoped La_{1:86}Sr_{0:14}CuO₄ (LSCO) system supported by high energy, high resolution bulk sensitive ARPES³.

II. COMPUTATIONALDETAILS

The La₂CuO₄ system has base-centered orthorhom – bic crystal structure with space group B m ab with two form ula units per cell²⁰. Corresponding lattice parameters are a= 5.3346, a= 5.4148 and c= 13.1172 A. A tom ic positions are the following: La(0.0, -0.0083, 0.3616), Cu(0,0,0), O (1/4,1/4, -0.0084), O 2(0.0,0.0404, 0.1837).

As a rst step of LDA + DMFT + k method we perform ed density functional theory calculations in the local density approximation (LDA) for these crystallographic data. Band structure was obtained within the linearized mu n-tin orbitals (LM TO) method²¹. It is well known for these compounds that Ferm i level is crossed by antibonding 0.2p-Cu3d partially led orbital of x^2 y² sym m etry. T ight-binding param eters for this band were calculated by N -th order LM TO (NM TO) m ethod²² as $(in eV units) t = 0.476, t^0 = 0.077, t^{00} =$ 0:025, $t^{000} = 0.015$. These values agree well with previous studies.²³ Coulomb interaction value on e ective Cu- $3d(x^2 y^2)$ orbital was calculated by constrained LDA $approach^{24}$ and was found to be U = 1.1 eV. These LDA obtained parameters are used to set up corresponding one-band Hubbard model.

The second step is further treatment of the above dened Hubbard model within the dynamical mean-eld theory (DMFT) self-consistent set of equations⁹ supplied by \external" momentum -dependent self-energy k¹¹. Using the additive form of self-energy (main approxim ation of the scheme neglecting the interference between Hubbard interaction and pseudogap uctuations, which allows one to preserve conventional DMFT equations) one can de ne LDA+DMFT+ k G reen function as:

where bare electron dispersion "(k) is de ned by LDA calculated hopping parameters listed above. To calculate $_{\rm k}$ we used a two-dimensional pseudogap model^{1,15}

describing nonlocal correlations induced by (quasi) static short-range collective H eisenberg-like AFM spin uctuations. Thus we introduce correlation length dependence of the pseudogap uctuations into conventional DM FT loop.

There are two points which make DMFT+ $_k$ di erent from the usual DMFT.First, momentum dependent $_k$ is recalculated on each DMFT iteration ($_k$ (;!;[(!)]) is in fact the function of DMFT chemical potential and DMFT self-energy).Second, DMFT+ $_k$ lattice problem is de ned at each DMFT iteration as:

A fier numerical self-consistency is reached we get the G reen's function (1) with corresponding (!) and $_k$ (!) taken on the last DMFT iteration. A ll further computational details can be found e.g. in Refs. 7,8,11.

As an \impurity solver" for DM FT equations num erical renormalization group (NRG 25,26) was employed. Temperature of DM FT (NRG) computations was taken to be 0.011 eV and electron concentration used was n= 0.86. Self-energy $_{\rm k}$ (!) due to pseudogap uctuations depends, in general, on two parameters: the pseudogap amplitude , and the correlation length 1,15 The value of was calculated as in Ref. 11

where local densities n_{i^*} ; $n_{i\#}$ and double occupancy $< n_{i^*}n_{i\#} > w$ ere calculated within the standard DMFT⁹. Behavior of as a function of hopping integrals and C oulom b interaction was studied in our previous work¹¹, while as a function of occupancy n was investigated in Ref. 7. For we believe it is more safe to take experimental values. In this work the value of was calculated to be 0.275 eV and was taken to be 10a, where a - lattice constant.²⁷

III. EXPERIMENTAL DETAILS

The high-energy ARPES measurements were carried out at BL25SU in SP ring-8, using incident photons of 500 eV, on single crystal samples. The normal to the cleaved sample surface was set almost parallel to the axis of the lens of the analyzer and the sample was set to about 45 from the incident light direction. The photoelectrons within polar angles of about 6 around the norm alto the sample were simultaneously collected using a GAM MADATASC IENTA SES200 analyzer, thereby covering more than a whole B rillouin zone along the directions of the analyzer slit. The Ferm i surface m apping was performed by changing the angle along the perpendicular direction to the analyzer slit. The base pressure was about 4 x 10 ⁸ Pa. The (001) clean surface was obtained by cleaving the sam ples in situ in vacuum at the m easuring tem perature of 20 K. The overall energy resolution was set to 100 and 170 m eV for highresolution m easurem ents and Ferm i surface m apping, respectively. The angular resolution was 0.1 (0.15) for the perpendicular (parallel) direction to the analyzer slit. These values correspond to the momentum resolution of

0.024 = a (0.036 = a) at h = 500 eV, where a is twice the Cu-O bondlength within the CuO₂ plane. By virtue of the longer photoelectron m can free path of 12 A at the kinetic energy of 500 eV than that for conventional ARPES at h 20-60 eV, the bulk contribution to the spectral weight is estim ated as about 60%. The position of the Ferm i level was calibrated with Pd spectra.

IV. RESULTS AND DISCUSSION

In case of nite temperature and interaction strength we have to take into account the nite life time e ects of quasiparticles. Thus instead of just a dispersions "(k)one should rather work with the spectral function A (!;k) given by

with retarded G reen's function G (!;k) obtained via LDA + DMFT + k schem $e^{10,11,16}$. Of course there are considerable lifetime e ects originating from the k corresponding to interaction with AFM uctuations (substituted in our approach by the quenched random eld).

In Fig.1 contourm ap of spectral function (4) obtained from LDA+DMFT+ $_k$ for Cu-3d(x² y²) band is presented. The width of the spectral function is inversely proportional to the lifetime. Around (,0) point one can clearly see splitting of the spectra by AFM pseudogap uctuations of the order of 2 . A lso AFM nature of the pseudogap uctuations leads to form ation of the \shadow" band which is much weaker in intensity and becom ing the real quasiparticle band in case of com plete folding in case of long-range AFM order.

Figure 2 displays experimental energy distribution curves (EDC) on the panel (a) along (0,0){(,0) direc-

tion. A round (,0)-point as shown by stars certain deviation of the A (!;k) maxim a from the Ferm i level a kind of \tum-back" is observed. We attribute such behavior of the A (!;k) to pseudogap uctuations. Sim ilar theoretical behavior is shown on panel (b)²⁸ of Fig. 2 as calculated by our LDA+DMFT+ $_{\rm k}$ approach (see also Fig.1). The same behavior is also observed as traced by circles in experimental ARPES momentum distribution curves (MDC) demonstrated on panel (c) of Fig. 2.

The bulk-sensitive high-energy ARPES data for La_{1:86}Sr_{0:14}CuO₄ show a clear \tum-back" structure of the EDC peak as a function of momentum near (0,), which were not seen in the previous low-energy ARPES data for La_{1:85}Sr_{0:15}CuO₄⁴. The contour map of the spectral weight in the vicinity of E_F seems to be essentially sim ilar in overall features for this doping level between the high-energy and low-energy ARPES studies.

Experimental and theoretical Ferm i surface maps are shown in Fig. 3 at panels (a) and (b) correspondingly. Both pictures reveal strong scattering around (,0)-point which we associate with scattering in the vicinity of the so-called \hot-spots" (cross-points of a Ferm i and AFM um klapp surfaces) which are close to the (,0)^{7,8}. Such strong scattering comes from scattering processes with momentum transfer of the order of $Q = (;)^{1,15}$, corre-

sponding to AFM pseudogap uctuations. A long nodal directions we observe typical Ferm iarcs. They are pretty well seen in the theoretical data while for experiment we have just narrow traces of them.

V. CONCLUSION

O ur LDA + DM FT + $_{\rm k}$ hybrid approach was shown to be an e ective num erical tool to describe short-range ordered state in quasi-two dim ensional system s.^{7,8,19} M aterial speci c m odel param eters such as hopping integrals (which de ne bare electronic band dispersion of e ective Cu3d (x² y²) orbital) were calculated via LDA based NM TO m ethod.²² C oulom b interaction param eter U was obtained from constrained LDA m ethod. P seudogap am – plitude was com puted using LDA + DM FT schem e.^{8,11} Supplem enting conventionalDM FT self-energy by _k (!) describes non-local dynam ical correlations due to short ranged collective H eisenberg like AFM spin uctuations.

In this work we perform ed LDA+DMFT+ $_{\rm k}$ calculations for hole-doped La_{1:84}Sr_{0:14}CuO₄ compound in the pseudogap regime. Because of uctuations of AFM short-range order we clearly observe form ation of the so called \shadow bands" aspartially folded bare dispersion. Pseudogap is form ed around (,0) point which is qualitatively the same as in Bi2212⁷, NCCO⁸ and PCCO¹⁹. As to Ferm isurface of LSCO it is alike that obtained for Bi2212⁷. Namely the \hot spots" are not well resolved

since the crossing point of the bare Ferm i surface and AFM um klapp surface are very close to Brillouin zone border. This fact is essentially due to the shape and size of LDA Ferm i surface. In this respect, situation here is di erent from that for NCCO⁸ and PCCO¹⁹, where \hot spots" are clearly seen. To support these theoretical results we present here the new high energy, high resolution ARPES data for LSCO. Typical pseudogap-like e ects of Ferm i surface destruction were observed in both theory and experim ent. The same is true for spectral functions. The overall sem iquantitative agreem ent between theory and experim ents basically supports our general picture of the pseudogap state as due to strong scattering of carriers by short-range AFM order uctuations.
