C onventional description of U n conventional C ou lom b-C rystal phase transition in three-dim ensional classical O (N) spin-ice

W e study the phase transition between the high tem perature C oulom b phase and the low temperature staggered crystal phase in three dimensional classical O (N) spin-ice model. C om pared with the previously proposed CP (1) formalism on the C oulom b-crystal transition of the classical dimermodel, our description based on constrained order parameter is more conventional, due to a fundamental di erence between the O (N) and the dimermodel. A systematic = 4 d and 1=N expansion are used to study the universality class of the phase transition, and a stable xed point is found based on our calculations for large enough N.

The three dimensional classical dimermodel (CDM), as the simplest model with an algebraic liquid phase (usually called the C oulom b phase), has attracted m any analytical and numerical studies [1, 2, 3, 4]. The ensemble of 3d CDM is all the congurations of dimer coverings, which are subject to a local constraint on every site: every site is connected to precisely n dimers with 0 < n < 6 (denoted as CDM -n), and most studies are focused on the case with n = 1. The partition function of the CDM is a summation of all the allowed dimer coverings, with a Boltzm ann weight that favors certain types of dimer congurations. For instance, the most standard CDM -1 takes the following form:

 n_{xy} , n_{yz} and n_{zx} are numbers de ned on each unit plaquette in xy, yz and zx planes, they take value 1 when this plaquette contains two parallel dimers, and take value 0 otherwise. When U > 0, the ground state of this model favors to have as many parallel dimers as possible, therefore when T < T_c, the system develops columnar crystalline dimer patterns in Fig. 1a, while when T > T_c the system is in the C oulom b phase with power law correlation between dimer densities, which according to the standard G inzburg-Landau theory can only occur at critical points instead of stable phases. This phase diagram has been con rm ed by a number of numerical simulations [1, 2, 3, 4].

The nature of the transition at T_c attracts most efforts. If U > 0, num erical studies con m that this transition is continuous, and the data suggest that at this transition the discrete cubic symmetry is enlarged to an 0 (3) rotation symmetry [4]. Analytically, to describe this locally constrained dimer system, we can introduce the \magnetic eld" $B = n_{i;+}$ i, where $i = (1)^i$ is a staggered sign distribution on the cubic lattice. The

num ber $n_{i;}$ is de ned on each link (i;) (Fig. 1a), and $n_{i:} = 1; 0$ represents the presence and absence of dim er. Notice that link (i;) and (i ;+) are identical. Now the local constraint of the dimer system can be rewritten as a Gauss law constraint $\tilde{r} = \tilde{B}_i = \tilde{I}_i$. The mapping between the dimer pattern and the magnetic eld con guration is depicted in Fig. 1. The standard way to solve this G auss law constraint is to introduce vector potential A de ned on the unit plaquettes of the cubic lattice, and $B = \hat{r}$ A [5, 6]. The background staggered m agnetic charge i can be ignored in the C oulom b phase after coarse-graining, though it plays crucial role in the crystal phase. Since vector A is no longer subject to any constraint, it is usually assumed that at low energy the system can be described by a local eld theory of A, for instance the eld theory of the Coulom b phase reads F d³x (r̃ $\tilde{A})^{2} +$, which is invariant under gauge transform at ion A ! A + \tilde{r} f.

Now the Coulomb-crystal phase transition can be described by the condensation of the matter elds which couple minimally to the vector potential eld A: cos(r̃^m A), and mathematically this matter eld is introduced because of the discrete nature of A. Due to the staggered background m agnetic charge i, the matter elds move on a nonzero background magnetic eld, the band structure of the matter elds have multiple minima in the Brillouin zone, and the transform ation between these m in in a encodes the inform ation of the lattice sym metry. For instance the transition of the CDM -1 model is described by the CP (1) m odel with an enlarged SU (2) global symmetry [2, 7]. This eld theory is highly unconventional, in the sense that it is not form ulated in term s of physical order param eters. It is expected that more generalCDM -n m odels can also be described by sim ilar Higgs transition, although the detailed lattice symmetry transform ation for matter elds would depend on n.

In this paper we will study an O (N) generalization of the CDM m gdel. We de ne an O (N) spin vector S^a with unit length $(S^a)^2 = 1$ on each link (i;) of the cubic lattice, with a = 1 N, and we assume that the largest term of the Hamiltonian in poses an ice-rule constraint [8] for 0 (N) spins on six links shared by every site:

System swith this constraint is usually called the spin-ice. If N = 1, each spin can only take value 1, therefore every site of the cubic lattice connects to three spins with +1 and three spins with 1, which is equivalent to the CDM -3 m odel. Just like the CDM, at high tem perature, there is a C cubm b phase with algebraic correlation between the O (N) vector S^a, while the low tem perature crystal phase is controlled by other interactions.

In addition to the large constraint Eq. 2, we can design the H am iltonian as following:

J₁ is a H eisenberg coupling between spins along the sam e lattice axis, J2 is a H eisenberg coupling between spins on two parallel links across a unit square. If $J_1 > 0$ and $J_2 < 0$, in the ground state spins are antiparallel along the same axis, but parallel between parallel links across a unit square, which is an O (N) analogue of the colum nar state of the CDM in Fig. 1a. If J_1 and J_2 are both positive, in the ground state the spins are antiparallel between nearest neighbor links on the same axis, as well as between parallel links across a unit square, which is an analogue of the staggered dimer con guration in Fig. 1c. Since in the J_1 J_2 m odel Eq. 3 there is no coupling between di erent axes along di erent directions, for both cases the zero tem perature ground state of m odel Eq. 3 has large degeneracy, because the spins on x, y and z axes are ordered independently, and the energy does not depend on the relative angle between S_{ix}^{a} , S_{iv}^{a} and S_{iz}^{a} i:e: the ground state manifold has an enlarged $[0 (N)]^3$ sym m etry. C om pared with the dim er system, the O (N) spin vector is not discrete, therefore we cannot use the Higgs mechanism as we did for the dimermodel, which encodes the inform ation of the discreteness of the dim er variables. Instead, we are going to describe the transition with a Ginzburg-Landau (GL) theory with order param eters. The applicability of our GL theory to the original CDM -n will be discussed later.

In this paper we will focus on the staggered spin order. Following the magnetic eld formalism of the CDM mentioned before, in order to describe this system compactly, we introduce three avors of O(N) vector eld $^{a} = S_{i;+}^{a}$ i with = x;y;z, and now the constraint Eq. 2 can be rewritten concisely as

Under the lattice symmetry transformation, $\ensuremath{\,^a}$ transforms as

T is the translation symmetry along direction, R $_{,s}$ is the site centered relection symmetry, and R $\,$ is the relection along a diagonal direction.

The mapping between $S_{i;}^{a}$ and ^a is very similar to the dimer case in Fig. 1, and the staggered spin order corresponds to the uniform order of ^a, and all avors of spin vectors are ordered. Therefore presumably ^a are the low energy modes close to the transition, and we can write down the following symmetry allowed trial eld theory for ^a with softened unit length constraint:

W hen we take g ! 1 , the constraint Eq. 4 is e ectively in posed. In Eq. 6 when = 0, the quadratic part of the eld theory is invariant under O (N) O (3) transform ation, the O (3) sym m etry is a combined avor-space rotation symmetry. term will break the O (3) symmetry down to the cubic lattice symmetry. However, to the accuracy of our calculation in this paper, the RG ow of is negligible. Therefore is a constant instead of a scaling function in the RG equation, we will tentatively take = 0 for simplicity. In the limit with g ! 1, when r > 0 the correlation function of ^a reads:

P is a projection matrix that projects a vector to the direction perpendicular to its momentum. A fler Fourier

transform ation, this correlation function gives us the $1=r^3$ power-law spin correlation of the C oulom b phase. W hen r < 0, the vector ^a is ordered.

 F_4 in Eq. 6 includes all the sym m etry allowed quartic term s of $\ensuremath{\,^a}$:

The u and v term s are invariant under an enlarged sym – metry $[D(N)]^3$, while the w term breaks this sym metry down to one single O(N) sym metry plus lattice sym metry. A s already mentioned, the ground state manifold of model Eq. 3 has the same enlarged $[D(N)]^3$ sym metry. However, the w term can be induced with them al uctuation through order-by-disorder mechanism [9], or we can simply turn on such extra bi-quadratic term energetically in the J_1 J_2 model Eq. 3. Just like the J_1 J_2 model eq. 3. Just like the J_1 J_2 model on the square lattice [9], the quadratic coupling $\begin{bmatrix} a & a & w \\ p & del \\ a & x & y \end{bmatrix} \begin{bmatrix} b & b \\ b & z \end{bmatrix}$ break the rejust energy - metry of the system, and hence are forbidden.

Solving this equation at r = 0, we not stable xed point for large enough N . Expanded to the order of $= N^2$, the stable xed point is located at

This expansion is valid in the lim it $1=N^2$ 1, and the xed point values are determined by solving the equation Eq. 9 to the order of $^2=N^2$ $1=N^6$. Close to the stable xed point, the three eigenvectors of the RG ow have scaling dimensions

 $_3$ is the largest scaling dimension, and according to Eq. 11 the critical N is N $_{\rm c}$ = 44. In addition to this stable xed point, there are seven other instable xed points for N > N $_{\rm c}$. For instance, in the large-N lim it there is a xed point at u = =(24N), v = =(12N) and w = 0, which has the enlarged O (N) O (3) symmetry.

In the large-N lim it, the RG equation for w is decoupled from u and v, hence four of the eight xed points have w = 0, and all the others have w = 3 = (7N). If we take w = w = 3 = (7N), the RG ow diagram for u and v in the large-N lim it is depicted in Fig. 2. At the stable xed point Eq. 10, r is the only relevant perturbation, with scaling dimension

Since at the ground state all three avors of spin vectors are ordered, in the eld theory F_4 , v should be smaller than 2u, which is well consistent with the stable xed point in Eq. 10 with negative v. This xed point has positive w, which favors noncollinear alignment between spins on dierent axes. Therefore the transition between C oulom b and noncollinear staggered state has a better chance to be described by this xed point.

Notice that had we included the anisotropic velocity into account, its leading RG ow will be at order of $^{2}=N$ $1=N^{5}$, and the ow of will contribute to the RG ow of u, v and w at order of $^{3}=N^{2}$ $1=N^{8}$, therefore it is justile d to take a constant in our calculation. When is nonzero but small, the RG ow swill only change quantitatively. For instance, expanded to the rst order of , the scaling dimensions of the three eigenvectors of the RG equation at the stable xed point become $_{1} =$

, $_2$ = $+\frac{4448}{567N} + \frac{2849936}{3988845}$, $_3$ = $+\frac{24950}{567N}$ $\frac{30088528}{27921915N}$, and the scaling dimension of r becomes [r] = $\frac{1}{2} = 2 + \frac{158}{7N} - \frac{1032}{1715N}$.

If we take N = 1, the v and w terms are identical. In this case in addition to the trivial Gaussian xed

point, there is only one other xed point at v = 2u ==34 with 0 (3) avor-space combined rotation symmetry, which is the same xed point as the ferrom agnetic transition with dipolar interaction [10, 11]. In 3d space, the dipolar interaction also projects a spin wave to its transverse direction. The dipolar xed point is instable against the O (3) to cubic symmetry breaking, therefore when N = 1 our rst order expansion predicts a rst order transition. W e already m entioned that the case with N = 1 is equivalent to the CDM -3. However, in our GL form alism, in the ordered phase, the power law spin-spin correlation still persists if the long range correlation is subtracted. For instance, the uctuation = h i is still subject to the constraint = 0, therer fore although the uctuation is gapped, it still leads to the 1=r³ power-law correlation.But in CDM, the ordered phase only has short range connected dim er correlation on top of the long range order [12]. This di erence is due to the fact that our form alism does not encode the discreteness of the dimers. Therefore one possible scenario for the CDM -3 with staggered ground state is that, if we lower the tem perature from the Coulomb phase, after the rst order transition of ^a, there has to be another \H iggs" like phase transition that destroys the power-law connected correlation. Or there can be one single strong rst order transition that connects the Coulomb phase and staggered dim er crystal directly.

In this correlation function the scaling dimension $[q_z] = 2[q_x] = 2[q_y] = 2$, therefore this transition is electively a z = 2 transition, and F_4 is marginal according to power-counting. This cubic symmetry breaking situation has been studied in Ref. [13].

In this work we studied the transition between high temperature C oulom b phase and the low temperature staggered spin ordered phase in the O (N) spin-ice m odel. Higher order and 1=N expansion are demanded to obtain m ore quantitatively accurate results. The m odelEq. 3 can be simulated directly numerically, and our RG calculation can be tested. The columnar phase with $J_1 > 0$ and $J_2 < 0$ is also interesting. But since the columnar order does not correspond to the uniform order of ^a, the order param eter description ism ore complicated. W ew ill study this situation in future.

The CDM is also considered as a simple analogue of the spin-ice materials such as $Ho_2T \downarrow O_7$ and $Dy_2T \downarrow O_7$ [14, 15, 16], where the Ho^{3+} and Dy^{3+} magnetic moments reside on the sites of a pyrochlore lattice, and the ground state of these moments satisfies the same ice-rule constraint as Eq. 2. The Coulomb phase of the spin ice materials with fractionalized \monopole" like defect excitation has been observed experimentally [17]. The formalism developed in our work is largely applicable to the pyrochlore lattice, while the symmetry analysis and the number of quartic terms are different. A complete symmetry analysis is demanded in order to correctly understand the O (N) spin-ice on the pyrochlore lattice.
