# C onventional description of U nconventional C ou lom b-C rystal phase transition in three-dim ensional classical $O$ ( N ) spin-ice

#### Abstract

W e study the phase transition betw een the high tem perature C oulomb phase and the low tem perature staggered crystal phase in three dim ensional classical $O(\mathbb{N})$ spin-ice model. Com pared w th the previously proposed CP (1) form alism on the Coulomb-crystal transition of the classical dim er model, our description based on constrained order param eter is $m$ ore conventional, due to a fundam ental di erence betw een the $O(N)$ and the dim er model. A system atic $=4 \quad d$ and $1=N$ expansion are used to study the univensality class of the phase transition, and a stable xed point is found based on our calculations for large enough N .

The three dim ensional classical dim er m odel (CDM), as the sim plestm odelw ith an algebraic liquid phase (usually called the $C$ oulom b phase), has attracted $m$ any analytical and num erical studies [1, 2, 3, 4]. T he ensem ble of 3 d CDM is all the con gurations of dim er coverings, which are sub ject to a local constraint on every site: every site is connected to precisely $n$ dim ens w ith $0<n<6$ (denoted as CDM $-n$ ), and $m$ ost studies are focused on the case $w$ th $n=1$. The partition function of the CDM is a sum $m$ ation of all the allow ed dim er coverings, $w$ ith a Boltzm ann weight that favors certain types of dim er con gurations. For instance, the m ost standard CDM -1 takes the follow ing form :

$\mathrm{n}_{\mathrm{xy}}, \mathrm{n}_{\mathrm{yz}}$ and $\mathrm{n}_{\mathrm{zx}}$ are num bers de ned on each unit plaquette in $x y, y z$ and $z x$ planes, they take value 1 w hen this plaquette contains two parallel dim ers, and take value 0 otherw ise. $W$ hen $U>0$, the ground state of this m odel favors to have asm any paralleldim ers as possible, therefore when $T<T_{c}$, the system develops colum nar crystalline dim er pattems in Fig. 1 a, while when $T>T_{c}$ the system is in the C oulomb phase w ith power law correlation betw een dim er densities, which according to the standard G inzburg-Landau theory can only occur at critical points instead of stable phases. This phase diagram hasbeen con $m$ ed by a num ber ofnum ericalsim ulations [1, 2, 3, 4].
$T$ he nature of the transition at $T_{c}$ attracts $m$ ost efforts. If $U>0$, num ericalstudies con $m$ that this transition is continuous, and the data suggest that at this transition the discrete cubic sym $m$ etry is enlarged to an O (3) rotation symm etry [4]. A nalytically, to describe this locally constrained dim er system, we can introduce the $\backslash m$ agnetic eld" $B=n_{i ;+} \quad i$, where $i=(1)^{i}$ is a staggened sign distribution on the cubic lattice. T he
number $n_{i}$; is de ned on each link ( $i ;$ ) ( $F$ ig. 13 ), and $\mathrm{n}_{\mathrm{i}} ;=1 ; 0$ represents the presence and absence of dim er. N otice that link ( $i ; \quad$ ) and ( $i \quad$; + ) are identical. N ow the local constraint of the dim er system can be rew ritten as a Gauss law constraint $\tilde{r} B_{i}={ }_{i}$. The $m a p-$ ping betw een the dim er pattem and the $m$ agnetic eld con guration is depicted in Fig. 11. The standard way to solve this $G$ auss law constraint is to introduce vector potential $\AA$ de ned on the unit plaquettes of the cubic lattice, and $\bar{B}=\tilde{\mathrm{r}} \mathbb{A}[5,[6]$. The background staggered $m$ agnetic charge $i$ can be ignored in the $C$ oulom b phase after coarse-graining, though it plays crucial role in the crystal phase. Since vector $\bar{A}$ is no longer sub ject to any constraint, it is usually assum ed that at low energy the system can be described by a local eld theory of $\mathbb{A}$, for instance the eld theory of the C oulom b phase reads $\mathrm{F} \quad \mathrm{d}^{3} \mathrm{X}(\tilde{\mathrm{r}} \quad \mathbb{A})^{2}+\quad$, which is invariant under gauge transform ation $\mathbb{A}!\tilde{A}+\tilde{r} f$.

Now the Coulomb-crystal phase transition can be described by the condensation of the $m$ atter elds which couple minim ally to the vector potential eld $\mathbb{A}$ : $\cos \left(\widetilde{r}{ }^{m} \mathbb{A}\right)$, and $m$ athem atically this $m$ atter eld is introduced because of the discrete nature of $\mathbb{A}$. D ue to the staggered background $m$ agnetic charge $i$, the $m$ atter elds $m$ ove on a nonzero background $m$ agnetic eld, the band structure of the $m$ atter elds have $m u l t i p l e m$ inim a in the B rillouin zone, and the transform ation between these $m$ inim a encodes the inform ation of the lattioe sym $m$ etry. For instance the transition of the CDM -1 m odel is described by the CP (1) m odelw ith an enlarged SU (2) globalsym $m$ etry [2, 7]. This eld theory is highly unconventional, in the sense that it is not form ulated in term $s$ of physical order param eters. It is expected that $m$ ore generalCDM -n m odels can also be described by sim ilar $H$ iggs transition, although the detailed lattice sym $m$ etry transform ation for $m$ atter elds would depend on $n$.

In this paper we will study an $O(\mathbb{N})$ generalization of the CDM m $\beta$ del. $W$ e de nean $O(\mathbb{N})$ spin vector $S^{a}$ w th unit length ${ }_{a}\left(S^{a}\right)^{2}=1$ on each link $(i ;)$ of the cubic
lattice, w ith $\mathrm{a}=1 \mathrm{~N}$, and we assum e that the largest term of the H am iltonian im poses an ice-rule constraint [8] for $O(\mathbb{N})$ spins on six links shared by every site:

System sw ith this constraint is usually called the spin-ice. IfN $=1$, each spin can only take value 1 , therefore every site of the cubic lattioe connects to three spins w ith +1 and three spins w ith 1 , which is equivalent to the CD M -3 m odel. Just like the CD M, at high tem perature, there is a Coulom b phase with algebraic correlation betw een the $O(\mathbb{N})$ vector $S^{a}$, while the low tem perature crystal phase is controlled by other interactions.

In addition to the large constraint E q. 2 , we can design the H am iltonian as follow ing:

$J_{1}$ is a $H$ eisenberg coupling betw een spins along the sam e lattioe axis, $J_{2}$ is a $H$ eisenberg coupling betw een spins on tw o parallel links across a unit square. If $J_{1}>0$ and $J_{2}<0$, in the ground state spins are antiparallel along the sam e axis, but parallelbetw een parallel links across a unit square, which is an $O(\mathbb{N})$ analogue of the colum nar state of the CDM in $F$ ig. 1 l . If $J_{1}$ and $J_{2}$ are both positive, in the ground state the spins are antiparallel betw een nearest neighbor links on the sam e axis, as well as between parallel links across a unit square, which is an analogue of the staggered dim er con guration in Fig. 11c. Since in the $J_{1} \quad J_{2} \mathrm{~m}$ odelE $q$. 3 there is no coupling betw een di erent axes along di erent directions, for both cases the zero tem perature ground state of model Eq. 3 has large degeneracy, because the spins on $x, y$ and $z$ axes are ordered independently, and the energy does not depend on the relative angle betw een $S_{i ; x}^{a}, S_{i ; y}^{a}$ and $S_{i ; z}^{a}$ i:e: the ground state $m$ anifold has an enlarged $[0(\mathbb{N})]^{3}$ sym $m$ etry. C om pared w the the dim er system, the $O(\mathbb{N})$ spin vector is not discrete, therefore we cannot use the $H$ iggs $m$ echanism as we did for the dim er $m$ odel, which encodes the inform ation of the discreteness of the dim er variables. Instead, we are going to describe the transition w ith a G inzburg-Landau (GL) theory w ith order param eters. The applicability of our G L theory to the original CDM -n will ibe discussed later.

In this paper we will focus on the staggered spin order. Follow ing the $m$ agnetic eld form alism of the CDM $m$ entioned before, in order to describe this system com pactly, we introduce three avors of $O(\mathbb{N})$ vector eld ${ }^{a}=S_{i ;+}^{a} \quad i w$ th $=x ; y ; z$, and now the constraint Eq. 2 can be rew ritten concisely as

U nder the lattioe symmetry transform ation, a transform $s$ as
$T$ is the translation symmetry along direction, $R$; is the site centered re ection sym $m$ etry, and $R$ is the re ection along a diagonaldirection.

The mapping between $S_{i}^{a}$ and ${ }^{a}$ is very sim ilar to the dim er case in Fig. 1, and the staggered spin order corresponds to the uniform order of ${ }^{a}$, and all avors of spin vectors are ordered. Therefore presum ably a are the low energy $m$ odes close to the transition, and we can $w$ rite dow $n$ the follow ing sym $m$ etry allow ed trial eld theory for ${ }^{a}$ w ith softened unit length constraint:

W hen we take g! 1 , the constraint Eq. 4 is e ectively im posed. In Eq. $6 \mathrm{when}=0$, the quadratic part of the eld theory is invariant under $O(\mathbb{N}$ ) $O$ (3) transfor$m$ ation, the $O$ (3) sym $m$ etry is a combined avor-space rotation sym $m$ etry. term will break the $O$ (3) sym $m e-$ try dow $n$ to the cubic lattioe sym $m$ etry. H ow ever, to the accuracy of our calculation in this paper, the RG ow of is negligible. T herefore is a constant instead of a scaling function in the RG equation, we w ill tentatively take $=0$ for simplicity. In the lim 辻 $w$ ith $g!1$,when $r>0$ the correlation function of ${ }^{\text {a }}$ reads:

$P \quad$ is a projection $m$ atrix that projects a vector to the direction penpendicular to its $m$ om entum. A fter Fourier
transform ation, this correlation function givesus the $1=r^{3}$ power-law spin correlation of the Coulom b phase. W hen $r<0$, the vector ${ }^{a}$ is ordered.
$\mathrm{F}_{4}$ in Eq. 6 includes all the sym m etry allow ed quartic term s of ${ }^{a}$ :
$T$ he $u$ and $v$ term $s$ are invariant under an enlarged sym $m$ etry $[0(\mathbb{N})]^{3}$, while the w term breaks this sym $m$ etry dow $n$ to one single $O(N)$ sym $m$ etry plus lattice sym $m e-$ try. A s already $m$ entioned, the ground state $m$ anifold of m odeleq. 3 has the sam e enlarged $[\mathrm{O}(\mathrm{N})]^{3}$ sym m etry. H ow ever, the w term can be induced w th therm al uctuation through order-by-disorder m echanism [9], or we can sim ply tum on such extra bi-quadratic term energetically in the $J_{1} \quad J_{2} \mathrm{~m}$ odelEq. 3. Just like the $J_{1} \quad J_{2}$ m odel on the square lattice [9], the quadratic coupling $a^{a}{ }^{a}$ with $\underset{P}{\text { th }}$ as wellasm ore com plicated quartic term s like $\left[\begin{array}{lllll}{[ } & a & \mathrm{a} \\ \mathrm{a} & \mathrm{x} & \mathrm{y}\end{array}\right]\left[\begin{array}{lll}\mathrm{b} & \mathrm{b} \\ \mathrm{b}\end{array}\right]$ break the re ection sym $m$ etry of the system, and hence are forbidden.

Now a system atic renorm alization group ( $\mathrm{R} G$ ) equation can be com puted $w$ th four param eters $u, v, w$ and $r$, at criticalpoint $r=0 \mathrm{w}$ th the correlation fiunction Eq . 7. In our calculation we willuse $=4$ dexpansion, and keep the accuracy to the rst order expansion. Based on the spirit of expansion, all the loop integrals should be evaluated at $d=4$, and because of the avor-space coupling im posed by the constraint Eq. 2, we should generalize our system to four dim ension, and also increase the avor number to $=1$ 4. The full coupled RG equation reads

Solving this equation at $r=0$, we nd stable xed point for large enough N. Expanded to the order of $=\mathrm{N}^{2}$, the stable xed point is located at

This expansion is valid in the lim it $\quad 1=\mathrm{N}^{2} \quad 1$, and the xed point values are determ ined by solving the equation Eq. 9 to the order of ${ }^{2}=\mathrm{N}^{2} \quad 1=\mathrm{N}^{6}$. C lose to the stable xed point, the three eigenvectors of the RG ow have scaling dim ensions

3 is the largest scaling dim ension, and according to Eq. 11 the critical N is $\mathrm{N}_{\mathrm{C}}=44$. In addition to this stable xed point, there are seven other instable xed points for $N>N_{C}$. For instance, in the large $N$ lim it there is a xed point at $u==(24 \mathrm{~N}), v==(12 \mathrm{~N})$ and $\mathrm{w}=0$, which has the enlarged $O(\mathbb{N}) \quad O$ (3) sym m etry.

In the large-N lim it, the RG equation for $w$ is decoupled from $u$ and $v$, hence four of the eight $x e d$ points have $w=0$, and all the others have $w=3=(7 \mathrm{~N})$. Ifwe take $w=w=3=(7 \mathrm{~N})$, the RG ow diagram foru and $v$ in the large-N lim it is depicted in F ig. 2. At the stable xed point Eq. 10, $r$ is the only relevant perturbation, w ith scaling dim ension

Since at the ground state all three avors of spin vectors are ordered, in the eld theory $\mathrm{F}_{4}$, v should be sm aller than 2 u , which is well consistent w ith the stable xed point in Eq. 10 w ith negative v . This xed point has positive w, which favors noncollinear alignm ent betw een spins on di erent axes. Therefore the transition betw een C oulom b and noncollinear staggered state has a better chance to be described by this xed point.
$N$ otice that had we included the anisotropic velocity into account, its leading RG ow will be at order of ${ }^{2}=\mathrm{N} \quad 1=\mathrm{N}^{5}$, and the ow of w illcontribute to the RG ow of $u, v$ and $w$ at order of ${ }^{3}=\mathrm{N}^{2} \quad 1=\mathrm{N}^{8}$, therefore it is justi ed to take a constant in our calculation. W hen is nonzero but sm all, the RG ows will only change quantitatively. For instance, expanded to the rst order of , the scaling dim ensions of the three eigenvectors of the RG equation at the stable xed point become ${ }_{1}=$ $, 2=+\frac{4448}{567 \mathrm{~N}}+\frac{2849936}{3988845}, 3=+\frac{24950}{567 \mathrm{~N}}$ $\frac{30088528}{27921915 \mathrm{~N}}$, and the scaling dim ension of r becom es $[\mathrm{r}]=$ $\begin{array}{lll}1=2 & +\frac{158}{7 \mathrm{~N}} & \frac{1032}{1715 \mathrm{~N}} .\end{array}$

If we take $\mathrm{N}=1$, the v and w term s are identical. In this case in addition to the trivial Gaussian $x e d$

point, there is only one other xed point at $v=2 u=$ $=34 \mathrm{w}$ th O (3) avor-space combined rotation sym $\mathrm{me} \mathrm{e}^{-}$ try, which is the same xed point as the ferrom agnetic transition $w$ ith dipolar interaction [10, 11]. In 3d space, the dipolar interaction also projects a spin wave to its transverse direction. The dipolar xed point is instable against the $O$ (3) to cubic sym $m$ etry breaking, therefore when $N=1$ our rstorder expansion predictsa rst order transition. $W$ e already $m$ entioned that the case $w$ ith $\mathrm{N}=1$ is equivalent to the CDM -3. H ow ever, in our G L form alism, in the ordered phase, the pow er law spin-spin correlation still persists if the long range correlation is subtracted. For instance, the ucturation $=\mathrm{h}$ i is still sub ject to the constraint $r \quad=0$, therefore although the uctuation is gapped, it still leads to the $1=r^{3}$ pow er-law correlation. B ut in CDM, the ordered phase only has short range connected dim er correlation on top of the long range order [12]. This di erence is due to the fact that our form alism does not encode the discreteness of the dim ers. Therefore one possible scenario for the CDM -3 w ith staggered ground state is that, if we low er the tem perature from the C oulom b phase, after the rst order transition of ${ }^{a}$, there has to be another \H iggs" like phase transition that destroys the pow er-law connected correlation. O r there can be one single strong rst order transition that connects the Coulom b phase and staggered dim er crystal directly.
$T$ he $J_{1} \quad J_{2} \mathrm{~m}$ odeleq. 3 is invariant under cubic sym $m$ etry transform ation. O ne can tum on various types of cubic sym $m$ etry breaking anisotropy to this $m$ odel, and the energy favors one of the three avors of vector eld
${ }^{\text {a }}$ to order. Let us assum $e{ }_{z}^{a}$ is ordered at low tem perature. To describe this transition we can tum on an extra $m$ ass gap $m$ for ${ }_{x}^{a}$ and ${ }_{y}^{a}$ in Eq. 6, and by taking the lim it $g!1$, at the criticalpoint $r=0$ the renorm alized correlation function for ${ }_{z}^{a}$ becom es

In this correlation function the scaling dim ension $\left[q_{z}\right]=$ $2\left[q_{x}\right]=2\left[q_{y}\right]=2$, therefore this transition is e ectively a $\mathrm{z}=2$ transition, and $\mathrm{F}_{4}$ is m arginalaccording to powercounting. This cubic sym $m$ etry breaking situation has been studied in Ref. [13].

In this work we studied the transition betw een high tem perature Coulomb phase and the low tem perature staggered spin ordered phase in the $O(\mathbb{N})$ spin-ice m odel. H igher order and $1=\mathrm{N}$ expansion are dem anded to $\mathrm{ob}-$ tain $m$ ore quantitatively accurate results. T hem odelE q. 3 can be sim ulated directly num erically, and our RG calculation can be tested. T he colum nar phase w ith $J_{1}>0$ and $J_{2}<0$ is also interesting. But since the colum nar order does not correspond to the uniform order of ${ }^{a}$, the order param eter description ism ore com plicated. W ew ill study this situation in future.

The CDM is also considered as a sim ple analogue of the spin-ice $m$ aterials such as $\mathrm{H}_{2} \mathrm{~T}_{2} \mathrm{O}_{7}$ and $\mathrm{D}_{\mathrm{y}_{2} \mathrm{~T}}^{\mathrm{T}} \mathrm{i}_{2} \mathrm{O}_{7}$ [14, 15, 16], where the $\mathrm{H} \mathrm{o}^{3+}$ and $\mathrm{Dy}^{3+} \mathrm{m}$ agnetic mo $m$ ents reside on the sites of a pyrochlore lattice, and the ground state of these $m$ om ents satis es the sam e ioe-rule constraint as Eq. 2. The Coulomb phase of the spin ice $m$ aterials $w$ th fractionalized $\backslash m$ onopole" like defect excitation has been observed experim entally [17]. The form alism developed in our work is largely applicable to the pyrochlore lattice, while the sym $m$ etry analysis and the num ber of quartic term $s$ are di erent. A com plete sym $m$ etry analysis is dem anded in order to correctly understand the $O(\mathbb{N})$ spin-ice on the pyrochlore lattice.
