Self-consistent perturbation expansion for Bose-Einstein condensates satisfying Goldstone's theorem and conservation laws

Quantum — eld-theoretic descriptions of interacting condensed bosons have su ered from the lack of self-consistent approximation schemes satisfying Goldstone's theorem and dynamical conservation laws simultaneously. We present a procedure to construct such approximations systematically by using either an exact relation for the interaction energy or the Hugenholtz-Pines relation to express the thermodynamic potential in a Luttinger-Ward form. Inspection of the self-consistent perturbation expansion up to the third order with respect to the interaction shows that the two relations yield a unique identical result at each order, reproducing the conserving-gapless mean—eld theory [F.Kita, J.Phys. Soc. Jpn. 74, 1891 (2005)] as the lowest-order approximation. The uniqueness implies that the series becomes exact when in nite terms are retained. We also derive useful expressions for the entropy and super uid density in terms of Green's function and a set of real-time dynamical equations to describe thermalization of the condensate.

I. INTRODUCTION

Broken symmetry and self-consistency are among the most fundamental concepts in modern theoretical physics. The former brings a drastic change in the system with the appearances of the order parameter 1,2 and the corresponding Nambu-Goldstone boson. 2,3,4 The order parameter has to be determined self-consistently together with quasiparticles responsible for the excitation. Thus, the latter concept is also essential for describing broken symmetry phases.

Self-consistency plays crucial roles even in normal systems as exemplied in the Landau theory of Ferm i liquids^{5,6} where an external perturbation produces a self-consistent molecular eld to yield an enhanced response in some cases. It is also adopted commonly in various practical approximation schemes such as the Hartree-Fock theory and the density-functional theory; with some in nite series incorporated in terms of the latter, self-consistent approximations can be far more elective than the simple perturbation expansion. It is worth pointing out that the Landau theory of Fermi liquids has been justified microscopically with the self-consistent quantumed theory, which in turn enabled Leggett to extend the Landau theory to super uid Fermi liquids.

Among those self-consistent approximations is Baym's -derivable approximation with a unique property of obeying various dynamical conservation laws automatically. This is certainly a character indispensable for describing nonequilibrium phenomena but not met by the simple perturbation expansion. Indeed, the -derivable approximation seems the only systematic microscopic scheme within the quantum eld theory which enables us to study equilibrium and nonequilibrium phenomena on an equal footing. It includes the Hartree-Fock theory and the Bardeen-Cooper-Schrie er (BCS) theory of superconductivity as notable examples. Moreover, the Boltzmann equation can be derived as a special case of the -derivable approximation. 10,11

The key functional = [G] above was introduced

by Luttinger and W ard¹² as part of the exact equilibrium them odynam ic potential for the normal state in terms of the M atsubara G reen's function G. Based on a self-consistent perturbation expansion, the expression also provides a systematic approximation scheme with the desirable property of including the exact theory as a limit. Indeed, Luttinger subsequently used the Luttinger ard functional to obtain some general results on normal Fermi systems such as the Fermi surface sum rule anticipated by Landau. Note that nonequilibrium systems can be handled with essentially the same techniques as equilibrium cases by a mere change from the imaginary-time M atsubara contour into the real-time K eldysh contour. Thus, it would be useful to have a practical derivable approximation of Bose-Einstein condensates (BECs) with broken U (1) sym m etry, where quite a few dynam ical experim ents have been carried out 17,18,19 since the realization of the Bose-Einstein condensation with a trapped atom ic gas in 1995.20 Another key ingredient here is the presence of a gapless excitation in the long wave-length lim it, as rst proved by Hugenholtz and Pines. This branch, which corresponds to the Bogoliubov mode in the weak-coupling regim e,22 can be identied now as the Nambu-Goldstone boson of the spontaneously broken U (1) sym m etry. The im portance of the two features, i.e., \conserving" and \gapless," for describing interacting condensed bosons was already pointed out by Hohenberg and Martin²³ in 1965 and also em phasized by Grin 24 soon after the realization of the Bose-Einstein condensation in the trapped atom ic gases. Despite considerable e orts, however, few system atic approximation schemes for BEC have been known to date which satisfy the two fundam ental properties simultaneously.

A notable exception may be the dielectric formalism . ^{25,26,27,28} It is designed specifically to describe another important feature of interacting condensed bosons that the single-particle spectrum and the two-particle density spectrum coincide, as instanced in the spectrum coincide, and the spectrum coincide in th

G avoret and Noziere. By incorporating local number conservation additionally, it has provided the gapless spectrum of a weakly interacting hom ogeneous Bose gas beyond the leading order. However, a generalization of the formalism to inhom ogeneous or nonequilibrium situations seems not straightforward when experiments on atomic gases are carried out with trap potentials dynamically. 17,18,19

Now, the main purpose of the present paper is to develop a self-consistent perturbation expansion for BEC satisfying Goldstone's theorem 4 and dynamical conservation laws simultaneously. This will be carried out by extending the normal-state Luttinger-Ward functional 12 so as to obey a couple of exact relations for BEC, i.e., that for the interaction energy and the Hugenholtz-P ines relation. The two relations will be shown to yield a unique identical result for the functional of BEC at least up to the third order in the self-consistent perturbation expansion. The fact indicates that the series becomes exact when in nite terms are retained. It also turns out that the expansion reproduces the conserving-gapless mean eld theory developed earlier with a subtraction procedure^{30,31} as the lowest-order approximation. The formulation will be carried out in the coordinate space so that it is applicable to inhom ogeneous systems such as those under trap potentials and with vortices. Using the Keldysh Green's functions, we will also extend it to describe nonequilibrium behaviors. Those are subjects with many unresolved issues 19 which cannot be treated by other theoretical methods for BEC such as the variational approach 32,33 and the M onte-C arlom ethod. 34 The whole contents here are relevant to single-particle properties, and we are planning to discuss two-particle properties in the near future.

The form alism will nd a wide range of applications on BEC. They include: (i) clarifying molecular elde ects in condensed Bose systems corresponding to the Landau theory of Fermi liquids; (ii) nonequilibrium phenomena of BEC such as thermalization with full account of the quasiparticle collisions; (iii) microscopic derivation of Landau two-uid equations with denite interaction and temperature dependences of the viscosity coecient, etc. It will also be helpful to construct a practical functional for BEC within the density-functional formalism, which still seems absent.

It is worth pointing out nally that the Luttinger-W ard functional is known as the \two-particle irreducible (2P I) action" in the relativistic quantum – eld theory, 35,36 and the di culties mentioned above are also encountered in describing its broken symmetry phases such as that of the 4 theory. 37,38 Thus, the present issue is relevant to a wide range of theoretical physics beyond BEC .

This paper is organized as follows. Section II summarizes exact results on an interacting Bose system including an expression of the thermodynamic potential for BEC with . Section III presents a denite procedure to construct . It is subsequently used to obtain a rst few series of the self-consistent perturbation expansion ex-

plicitly. Section IV derives form ally exact expressions of entropy and super uid density in terms of G reen's function which may also be useful for their approximate evaluations. Section V extends the formulation to describe nonequilibrium dynamical evolutions of BEC. Section V I sum marizes the paper. We put \sim = k_B = 1 throughout with k_B the Boltzmann constant.

II. EXACT RESULTS

W e consider identical B ose particles with mass m and spin 0 described by the H am iltonian:

Here y and are eldoperators satisfying the Bose commutation relations, K $_{1}$ $\frac{1}{2m}$ r $_{1}^{2}$ with as the chemmical potential, and V is the interaction potential with the property V (r 0) = V (r 0 r). Though dropped here, the elect of the trap potential can be included easily in K $_{1}$.

Let us introduce the H eisenberg representation of the eld operators by 8

with h idenoting the grand-canonical average in terms of H . Note h (1) i = 0 by de nition.

where T denotes the \time"-ordering operator⁸ and 3 is the third Pauli matrix. Every 2 2 matrix in the Nambu space will be distinguished with the symbol 4 on top of it like 6 . The o-diagonal elements 4 (1;2) = 4 T (1) (2) i and 4 F (1;2) = 4 T (1) (2) i were introduced by Beliaev, 39 which describe the pair annihilation and creation of quasiparticles inherent in BEC.

The factor $^{\circ}_{3}$ in Eq. (5) is usually absent in the denition of $\hat{G}_{r}^{23,24}$ it brings an advantage that poles of \hat{G} directly correspond to the Bogoliubov quasiparticles. 30,31

It is easily checked that the elements of \hat{G} satisfy G (1;2) = G (r_{2} 1; r_{1} 2), F (1;2) = F (2;1), G (1;2) = G (2;1), and F (1;2) = F (r_{2} 1; r_{1} 2), with superscript denoting complex conjugate. These four relations are expressed compactly in terms of \hat{G} as

where superscript y denotes Herm itian conjugate in the matrix algebra. Using $\hat{G}^{1}\hat{G}=\hat{1}$, one can show that \hat{G}^{1} also obeys the relations of Eq. (6).

Total particle number N is calculated by integrating h (1) (1) i over the whole space of the system, i.e.,

where the subscript of 1_+ denotes an extra in nitesim al positive constant in the argument $_1$ to put the creation operator to the left for the equal-time average. Equation (7) may also be used to eliminate in favor of N . To be explicit, we will proceed by choosing (T;) as independent variables, which will be dropped in most cases.

We sum marize relevant exact results on the system below. Those of Secs. IIA and IIB have been known from the late 1950s. However, they often have been proved or reviewed only for uniform systems with dierent notations. We hence provide in Appendix A detailed derivations of those results together with that of Sec. IIC for general inhom ogeneous systems so as to be compatible with de nition (5) of our Green's function.

B. Hugenholtz-Pines theorem

As shown in Appendix A 4, the Hugenholtz-P ines theorem 21 can be extended to inhom ogeneous systems as

This is the condition for the excitation spectra to have a gapless mode as compatible with Goldstone's theorem . 2,4 In the hom ogeneous case of (1) = $\frac{p}{n_0}$ with n_0 as the condensate density, the sst row of Eq. (11) in the Fourier space reduces to the familiar Hugenholtz-Pines relation ²¹ = p = 0p=0, where p the four momentum with "n 2n T as the Matsubara frequency (n = 0; 1; 2;). Note that Eq1)(is given here in terms of the same operator as the Dyson-Beliaev equation (8); see the comment below Eq. (39) for its relevance to Goldstone's theorem. Equation (11) can also be regarded as the generalized G ross-P itaevskii equation 40,41 to incorporate the quasiparticle contribution into the self-energies.

It is worth pointing out that our proof of Eq. (11) in Appendix A 4 has been carried out by using the gauge transform ation relevant to the broken U (1) symmetry without making any specic assumptions on the structure of the self-energies. Especially, it has removed the implicit supposition by Hugenholtz and Pines²¹ that the self-energies in condensed Bose systems also be proper in the conventional sense.¹²

It is shown in Appendix A 5 that the interaction energy $hH_{int}i$, i.e., the grand-canonical average of Eq. (2b), can be expressed in terms of the self-energies as

This is one of the key relations indispensable below.

D. Luttinger-W ard functional

Luttinger and W ard 12 gave an expression of the thermodynamic potential $\,$ T $\ln T\, re^{\,\,H\,\,=T}\,$ for an interacting normal Ferm i system as a functional of the self-energy . Their consideration can be extended easily to the normal Bose system of $\,=\,0$. It is more convenient to regard the resultant $\,$ as a functional of G , which reads as

The quantity denotes contribution of all the skeleton diagram s in the simple perturbation expansion for $\,$ w ith the replacement G $_0$! G 12 Its functional derivative w ith respect to G yields the self-energy $\,$ as

It hence follows from Dyson's equation $G = (G_0^1)^1$ that is stationary with respect to G as = G(2;1) = 0.

Luttinger and W ard also put Eq. (15) into an integral form with the nth-order self-energy $^{(n)}$ in term s of the interaction. To be explicit, $^{(n)}$ is de ned as the contribution of all the nth-order skeleton diagram s in the simple perturbation expansion for the proper self-energy with the replacement G_0 ! G. Noting that there are G_0 1 G reen's-function lines in the diagram s of G_0 1.

Comparing this expression with Eq. (12) of the normal state (=0,F=0), we obtain a relation between the nth-order terms as

The factor 1=n is due to the extra H $_{int}$ present in the evaluation of hH $_{int}i^{(n)}$ compared with that of $^{(n)}$. Hence the relation will hold true generally in self-consistent perturbation expansions beyond the normal phase.

E. De Dom inicis-M artin theorem

Using a series of Legendre transform ations, it was shown by de Dominicis and Martin⁴² (see also Refs. 35 and 36) that the thermodynamic potential in the condensed phase can be expressed as a functional [G;F;F;;] such that

Thus, the exact them odynam ic potential is stationary with respect to variations in both the condensate wave function and G reen's functions. Equation (18) generalizes = G(2;1) = 0 of the normal-state Luttinger-W and functional Eq. (13)] to condensed Bose systems. However, no explicit has been known for BEC which satises Eq. (18) via Eqs. (8) and (11) and also includes Eq. (13) as the limit! 0.

Following Eq. (13) for the normal state, we now express of the condensed phase as

The subscript of 1 denotes an extra in nitesimal negative constant in $_1$ to put the creation operator to the left for equal-time averages, and the second Tr denotes the usual trace in the matrix algebra. Equation (19) appropriately reduces to Eq. (13) as $\!\!\!!$ 0. Whereas the rst two terms in Eq. (19) remain nite even for the ideal Bose gas, is made up only of contribution due to the interaction. This is one of the advantages for adopting expression (19).

Once is written as Eq. (19), one can show by using Eq. (8), Eq. (11), G (1;2) = G (2;1), and (1;2) = (2;1) that condition (18) can be expressed equivalently with respect to as

These are direct generalizations of Eq. (15) for the normal state into the condensed phase.

Now, our gapless -derivable approximation denotes (i) constructing so as to reproduce Eq. (21) and (ii) determining \hat{G} , and ^self-consistently with Eqs. (8), (11), and (21). It will obey dynamical conservation laws 10,31 as well as Goldstone's theorem, 10,41 thereby enabling us to handle equilibrium and nonequilibrium phenomena of BEC on an equal footing with the Nambu-Goldstone boson.

It is worth pointing out that expression (19) becomes exact when satis es Eq. (17) at each order up to n = 1 in the self-consistent perturbation expansion. With Hint! H int in Eq. (1), the proof proceeds in exactly the same way as that of the normal state12 as follows. First, we nd with Eqs. (17) and (18) that the corresponding expression of Eq. (19) obeys the sam e rst order di erential equation @ =@ = h H inti = $T \ln Tre^{(H_0 + H_{int})=T}$, where as the de ning one denotes the grand-canonical average in terms of $H_0 + H_{int}$. Second, the two expressions yield the same initial value = 0. We hence arrive at the above conclusion. Thus, the gapless -derivable scheme obeying Eq. (17) also includes the exact theory as a lim it.

We now present a couple of exact relations in terms of to be satisted in the condensed phase. Let us substitute the nth-order contribution of Eq. (12) into Eq. (17) and subsequently use Eq. (21a). We thereby obtain

Next, substitution of Eq. (21a) into Eq. (21b) yields

The above two equalities will play a crucial role below for writing down explicitly.

III. CONSTRUCTING

One of the basic di culties in developing the self-consistent perturbation expansion for BEC may be attributed to the absence of a de nite concept of \skeleton diagram s," which were clear in normal system s, 12 due to the appearance of nite one-particle average (1) h (1)i. It brings an am biguity as to how to count the contribution with F and adequately in the renormalization process. Our approach here is to determ ine the contribution to inherent in BEC with the exact relation of Eq. (22) or Eq. (23) so as to reproduce the Luttinger-W and functional for ! O, thereby avoiding the conceptual diculty to de ne \skeleton diagram s" explicitly. The two relations will be shown to yield a unique result at each order in the self-consistent perturbation expansion in terms of the interaction.

satisfying $^{(0)}$ (11°;22°) = $^{(0)}$ (22°;11°) = $^{(0)}$ (1°1;2°2) = $^{(0)}$ (12°;21°). It helps us to reduce relevant Feynm an diagram s substantially at the expense of introducing some cum bersom eness in the calculation of num erical factors. Our consideration below will be carried out in terms of topologically distinct diagrams, where G, F, and F are expressed in the sameway as those of superconductivity, and $^{(0)}$ is denoted by a led circle. Following Popov, we also suppress drawing symbols for and in those diagrams; they can be recovered easily with the fact that Eq. (2b) originally contains two pairs of creation and annihilation operators.




FIG. 1: D iagram s contributing to $^{(1)}$. Here (a)-(c) distinguish three kinds of diagram s considered at dierent stages of the procedure in Sec. IIIA, and numbers and unknown variables $c^{(1)}$ (= 2b;1a;1b) denote relative weights of those diagram s. Each coe cient should be multiplied by T=4 to obtain the absolute weight.




FIG. 2: D iagram s contributing to $^{(2)}$. Here (a)-(c) distinguish three kinds of diagram s considered at dierent stages of the procedure in Sec. IIIA, and the number 1 and unknown variables $c^{(2)}$ (= 4b; ;2e) denote relative weights of those diagram s. Each coecient should be multiplied by T=8 to obtain the absolute weight.

Consider the nth-order contribution. The procedure to construct $^{(n)}$ is sum marized as (a)-(d) below. See Figs. 1 and 2 as explicit examples of relevant diagrams for n=1 and 2, respectively.

(a) D raw all the norm al-state diagram s contributing to $^{(n)}$, i.e., those diagram s which appear in the Luttinger-W ard functional. W ith each such diagram, associate the factor of the norm al state.

(b) D raw all the distinct diagram sobtained from those of (a) by successively changing the directions of a pair of incom ing and outgoing arrows at each vertex. This enumerates all the processes where F or F is relevant in place of G. With each such diagram, associate an unknown coecient.

(c1) D raw all the distinct diagram s obtained from those of (a) and (b) by successively removing a G reen's-function line so as to meet the condition that a further removalofany line from each diagram would not break it into two unconnected parts. The procedure incorporates all the processes where the condensate wave function participates explicitly. The latter condition guarantees that the self-energies obtained by Eq. (21a) are composed of connected diagrams.

(c2) A ssociate an unknown coe cient with each such diagram, except the one consisting only of a single vertex in the rst order, i.e., the rightmost diagram in Fig. 1, for which the coe cient is easily identied to be T=4. Indeed, the latter represents the term obtained from Eq. (2b) by replacing every eld operator by its expectation value, i.e., the condensate wave function.

(d) D eterm ine the unknown coe cients of (b) and (c) by requiring that either Eq. (22) or Eq. (23) be satis ed.

It is worth pointing out that, with Eq. (21a), the diagram s of (c1) necessarily yields those self-energies which are separated into two parts by cutting a single line, i.e., those classi ed as \improper" in the conventional sense. A coording to Eq. (12), however, we surely need to consider this kind of self-energy diagrams in the self-consistent perturbation expansion for BEC. It should also be mentioned that our proof of Eq. (11) in Appendix A 4

B. Expression of $^{(1)}$

The rst-order contribution to is given by the diagram s of Fig. 1. They can be expressed analytically as

IV. EXPRESSIONS OF ENTROPY AND SUPERFLUID DENSITY

The analysis of the preceding section has clarified that we can generally express the thermodynam is potential of interacting condensed bosons as Eq. The above consideration with the mean-eld approximation has exemplied that the structure of \hat{G} (") near "= 0 is directly relevant to the entropy of BEC at low temperatures. It also tells us that the Bogoliubov mode will be connected continuously to the quasiparticle mode which dominates the low-temperature thermal properties of super uid $^4{\rm H\,e.}^{46}$ Further investigations seem required about the general properties of the self-energy near "= 0 to elucidate this connection.

B. Super uid density

We next derive an expression of the super uid density. for example, the form ula reproduces the expression given by Fetter for the weakly interacting condensed Bose gas. It is also worth pointing out that Eq. (44) is identical in form with that of Ferm i super uids findling the BCS-BEC crossover regime.

V. REAL-TIME EQUATIONS OF MOTION

The formulation of Secs. II and III can be extended straightforwardly to describe nonequilibrium dynamical evolutions of BEC. Formally, we only need to replace the integration contour 0 T 1 by the closed time path contour. We here follow Keldysh 14,16 to distinguish the forward and backward branches so that every time integration is limited to 1 < t < 1. The present transformation from equilibrium to nonequilibrium is a direct extension of the normal-state consideration. 45

Equations (47), (48), and (51) form self-consistent equations for nonequilibrium time evolutions of BEC satisfying conservation laws and Goldstone's theorem simultaneously. VI. SUMMARY

W e have developed a self-consistent perturbation expansion for BEC with broken U (1) symmetry so as to obey Goldstone's theorem and dynamical conservation laws simultaneously. First, the Luttinger-W ard them odynam ic functional for the norm al state 12 has been extended to a system of interacting condensed bosons as Eq. (19). Next, we have presented a procedure to construct in the functional order by order with exact relations (22) and (23) in Sec. IIIA. It has been shown subsequently up to the third order of the self-consistent perturbation expansion that both of the relations yield a unique identical result at each order as Eq. (25) with Eq. (26), Eq. (27) with Eq. (29), and Eq. (B1) with Eq. (B5). This fact im plies that the expansion converges to the exact therm odynamic potential when in nite terms are retained in . Using Eq. (19), we have also derived useful expressions for the entropy and super uid density in term sofG reen's function as Eqs. (37) and (44), respectively. Finally, we have derived a set of real-time dynamical equations for BEC as Eqs. (47), (48), and (51).

An expansion scheme like the present one may have been anticipated since the work of de Dominicis and M artin⁴² in 1964 to prove the existence of the functional satisfying Eq. (18). However, no explicit expression for the functional seems to have been known to date. As already noted in Introduction, one of the advantages of the present expansion scheme over the simple perturbation expansion lies in its ability to describe nonequilibrium phenom ena. A nother point to be m entioned is that it incorporates e ects of the anom alous G reen's function F(1;2) = hT(1)(2)i m ore e ciently than the simpleperturbation expansion.8 This fact may be realized by noting that F (1;2) becomes nite with at least a single

interaction line in the latter scheme. Thus, nth-order terms with F or F in the present expansion contain effects which show up only after the (n+1)th order in the simple perturbation expansion.

We are planning to apply the present form alism to a wide range of system s/phenomena in BEC to elucidate their properties microscopically. It also remains to be performed to clarify two-particle correlations within the present form alism.

Following the procedure sketched by Hohenberg and Martin, ²³ we here derive the Dyson-Beliaev Eq. (8) and the Hugenholtz-Pines relation (11) for general inhom ogeneous systems so as to be compatible with our denition [Eq. (5)] of Green's function. We also prove expression (12) for the interaction energy.
