# Self-consistent perturbation expansion for B ose E instein condensates satisfy ing G oldstone's theorem and conservation law s

#### Abstract

Q uantum - eld-theoretic descriptions of interacting condensed bosons have su ered from the lack ofself-consistent approxim ation schem es satisfying G oldstone's theorem and dynam icalconservation law s sim ultaneously. W e present a procedure to construct such approxim ations system atically by using either an exact relation for the interaction energy or the $H$ ugenholtz- P ines relation to express the them odynam ic potential in a Luttinger-W ard form. Inspection of the self-consistent perturbation expansion up to the third order w ith respect to the interaction shows that the two relations yield a unique identical result at each order, reproducing the conserving-gapless $m$ ean- eld theory [T.K ita, J. Phys. Soc. Jpn. 74, 1891 (2005)] as the low est-order approxim ation. The uniqueness im plies that the series becom es exact when in nite term $s$ are retained. W e also derive usefiul expressions for the entropy and super uid density in term $s$ of $G$ reen's function and a set of real-tim e dynam ical equations to describe them alization of the condensate.


## I. INTRODUCTION

B roken symmetry and self-consistency are am ong the $m$ ost fundam ental concepts in $m$ odem theoretical physics. The form er brings a drastic change in the system $w$ th the appearances of the order param eter ${ }^{1,2}$ and the corresponding N am bu-G oldstone boson 2,3,4 T he order param eter has to be determ ined self-consistently together w ith quasiparticles responsible for the excitation. Thus, the latter concept is also essential for describing broken sym $m$ etry phases.

Self-consistency plays crucial roles even in norm al system s as exem pli ed in the Landau theory of Ferm i liquids, ${ }^{5,6}$ w here an extemalperturbation produces a selfconsistent $m$ olecular eld to yield an enhanced response in some cases. It is also adopted com $m$ only in various practical approxim ation schem es such as the H artreeFock theory and the density-fiunctional theory ${ }^{7}$ w ith som e in nite series inconporated in term s of the latter, self-consistent approxim ations can be far $m$ ore e ective than the simple perturbation expansion. It is worth pointing out that the Landau theory of Ferm i liquids has been justi ed $m$ icroscopically w ith the self-consistent quantum eld theory, ${ }^{8}$ which in tum enabled Leggett to extend the Landau theory to super uid Ferm i liquids.?

Among those self-consistent approxim ations is Baym 's -derivable approxim ation w ith a unique property of obeying various dynam ical conservation laws autom atically 10 his is certainly a character indispensable for describing nonequilibrium phenom ena but not $m$ et by the sim ple perturbation expansion. Indeed, the -derivable approxim ation seems the only system atic $m$ icroscopic scheme within the quantum eld theory which enables us to study equilibrium and nonequilibrium phenom ena on an equal footing. It includes the H artree Fock theory and the B ardeen-C ooper-Schrie er (BCS) theory of superconductivity as notable exam ples. $M$ oreover, the Boltzm ann equation can be derived as a special case of the -derivable approxim ation. 10,11

The key functional $=[G]$ above was introduced
by Luttinger and $W$ ard ${ }^{12}$ as part of the exact equilibrium therm odynam ic potential for the nom al state in term $s$ of the $M$ atsubara $G$ reen's function $G$. B ased on a self-consistent perturbation expansion, the expression also provides a system atic approxim ation schem e w ith the desirable property of including the exact theory as a lim it. ${ }^{13}$ Indeed, Luttinger ${ }^{13}$ subsequently used the LuttingerW ard functionalto obtain som e generalresults on norm alFerm isystem s such as the Ferm i-surface sum rule anticipated by Landau $\frac{5}{N}$ ote that nonequilibrium system s can be handled w ith essentially the sam e techniques as equilibrium cases by a $m$ ere change from the im aginary-tim eM atsubara contour into the real-tim e K eldysh contour 14,15,16

Thus, it would be useful to have a practical derivable approxim ation of Bose E instein condensates (BECs) w ith broken $U$ (1) sym $m$ etry, where quite a few dynam icalexperim ents have been carried out ${ }^{17,18,19}$ since the realization of the Bose $E$ instein condensation $w$ ith a trapped atom ic gas in 1995.20 A nother key ingredient here is the presence of a gapless excitation in the long w ave-length lim it, as rst proved by H ugenholtz and P ines. ${ }^{21}$ This branch, which corresponds to the B ogoliubov $m$ ode in the weak-coupling regim $e_{r}^{22}$ can be identied now as the Nam bu-G oldstone boson ${ }^{4}$ of the spontaneously broken $U$ (1) sym $m$ etry. T he im portance of the tw o features, i.e., \conserving" and \gapless," for describing interacting condensed bosons was already pointed out by $H$ ohenberg and $M$ artin ${ }^{23}$ in 1965 and also em phasized by G ri $\mathrm{n} \xlongequal{24}$ soon after the realization of the B ose $E$ instein condensation in the trapped atom ic gases. D espite considerable e orts, how ever, few system atic approxim ation schem es for BEC have been known to date which satisfy the tw ofindam ental properties sim ultaneously.

A notable exception $m$ ay be the dielectric form alism 25,26,27,28 It is designed speci cally to describe another im portant feature of interacting condensed bosons that the single-particle spectrum and the two-particle density spectrum coincide, as rst show $n$ by

G avoret and Noziere. 29 By incorporating local num ber conservation additionally, it has provided the gapless spectrum of a weakly interacting hom ogeneous B ose gas beyond the leading order. ${ }^{27}$ H ow ever, a generalization of the form alism to inhom ogeneous or nonequilibrium situations seem s not straightforw ard w hen experim ents on atom ic gases are carried out with trap potentials dynam ically $17,18,19$

N ow, the $m$ ain purpose of the present paper is to develop a self-consistent perturbation expansion for BEC satisfying Goldstone's theorem ${ }^{4}$ and dynam ical conservation law s sim ultaneously. This will be carried out by extending the nom al-state LuttingerW ard functional ${ }^{\frac{112}{2}}$ so as to obey a couple ofexact relations for B EC , i.e., that for the interaction energy and the $H$ ugenholtz-P ines relation. The tw o relations $w$ illlbe show $n$ to yield a unique identical result for the functional of BEC at least up to the third order in the self-consistent perturbation expansion. The fact indicates that the series becom es exact when in nite term s are retained. It also tums out that the expansion reproduces the conserving-gapless $m$ ean eld theory developed earlier $w$ ith a subtraction procedure ${ }^{30,31}$ as the low est-order approxim ation. The form ulation will be carried out in the coordinate space so that it is applicable to inhom ogeneous system s such as those under trap potentials and $w$ ith vortices. U sing the K eldysh G reen's functions, we will also extend it to describe nonequilibrium behaviors. Those are sub jects w th m any unresolved issues ${ }^{19}$ w hich cannot be treated by other theoreticalm ethods for BEC such as the variationalapproach ${ }^{32,33}$ and the $M$ onte- $C$ arlo $m$ ethod ${ }^{34} \mathrm{~T}$ he whole contents here are relevant to single-particle properties, and we are planning to discuss two-particle properties in the near future.

The form alism will nd a wide range of applications on BEC.They include: (i) clarifying $m$ olecular eld $e$ ects in condensed Bose systems corresponding to the Landau theory ofFerm iliquids; (ii) nonequilibrium phenom ena of BEC such as therm alization w ith full account of the quasiparticle collisions; (iii) m icroscopic derivation of Landau two-uid equations $w$ ith de nite interaction and tem perature dependences of the viscosity coe cient, etc. It $w$ ill also be helpful to construct a practical functional for BEC w thin the density-functional form alism, which still seem $s$ absent.

It is worth pointing out nally that the LuttingerF F ard functional is known as the \two-particle irreducible (2P I) action" in the relativistic quantum - eld theory, ${ }^{35,36}$ and the di culties $m$ entioned above are also encountered in describing its broken sym $m$ etry phases such as that of the ${ }^{4}$ theory. ${ }^{37,38} \mathrm{~T}$ hus, the present issue is relevant to a w ide range of theoretical physics beyond BEC .

This paper is organized as follows. Section m arizes exact results on an interacting B ose system including an expression of the them odynam ic potential for BEC w ith. Section IIIpresents a de nite procedure to construct. It is subsequently used to obtain a rst few series of the self-consistent perturbation expansion ex-
plicitly. Section IV derives form ally exact expressions of entropy and super uid density in tem sof $G$ reen's function which $m$ ay also be useful for their approxim ate evaluations. Section $V$ extends the form ulation to describe nonequilibrium dynam icalevolutions of BEC. Section V I sum $m$ arizes the paper. $W$ e put $\sim=k_{B}=1$ throughout w ith $\mathrm{k}_{\mathrm{B}}$ the Boltzm ann constant.

## II. EXACT RESULTS

W e consider identicalB ose particles w th m ass m and spin 0 described by the H am iltonian:

where $T$ denotes the $\backslash$ tim e"-ordering operator ${ }^{8}$ and $\wedge_{3}$ is the third Pauli matrix. Every 22 m atrix in the Nam bu space w ill be distinguished w th the sym bol ${ }^{\wedge}$ on top of it like $\hat{G}$. The o -diagonal elem ents $\mathrm{F}(1 ; 2)=\mathrm{hT} \quad$ (1) (2)i and $\mathrm{F}(1 ; 2)=\mathrm{hT} \quad$ (1) (2)i were introduced by Beliaev, 39 which describe the pair annihilation and creation of quasiparticles inherent in BEC.

The factor ${ }_{\wedge}{ }_{3}$ in Eq. (5) is usually absent in the de nition of $\hat{G}, 23,24$ it brings an advantage that poles of $\hat{G}$ directly correspond to the B ogoliubov quasiparticles. 30,31

It is easily checked that the elem ents of $\hat{G}$ satisfy $G(1 ; 2)=G\left(r_{2} ; r_{1} 2\right), F(1 ; 2)=F(2 ; 1), G(1 ; 2)=$ $G(2 ; 1)$, and $F(1 ; 2)=F\left(r_{2} ; r_{1} 2\right), w$ th supenscript denoting com plex con jugate. To be explicit, we w illproced by choosing ( T ; ) as independent variables, which $w$ ill be dropped in $m$ ost cases.
$W$ e sum $m$ arize relevant exact results on the system below. Those of Secs. IIA and IIB have been known from the late 1950s. H ow ever, they often have been proved or review ed only for uniform system $s$ w th di erent notations. W e hence provide in A ppendix A detailed derivations of those results together with that of Sec. IIC for general inhom ogeneous system s so as to be com patible $w$ ith de nition (5) of our $G$ reen's function.

## A. D yson $-B$ eliaev equation

## B. H ugenholtz-P ines theorem

As shown in Appendix A 4, the Hugenholtz $-P$ ines theorem $\stackrel{21}{ }$ can be extended to inhom ogeneous system $s$ as

$T$ his is the condition for the excitation spectra to have a gaplessm ode as com patible w ith G oldstone's theorem 2,4 In the hom ogeneous case of $(1)=\mathrm{P} \overline{\mathrm{n}_{0}}$ w ith $\mathrm{n}_{0}$ as the condensate density, the rst row of Eq. N ote that E (1) ( is given here in term $s$ of the sam e operator as the D ysonBeliaev equation (8); see the com $m$ ent below Eq. (39) for its relevance to $G$ oldstone's theorem. Equation (11) can also be regarded as the generalized $G$ ross $P$ itaevskii equation ${ }^{40,41}$ to inconporate the quasiparticle contribution into the self-energies.

It is worth pointing out that our proof of Eq. (11) in A ppendix A 4 has been carried out by using the gauge transform ation relevant to the broken $U$ (1) sym $m$ etry $w$ ithout $m$ aking any speci $c$ assum ptions on the structure of the selfenergies. Especially, it has rem oved the im plicit supposition by $H$ ugenholtz and $P$ ines $s^{21}$ that the selfenergies in condensed B ose system salso be proper in the conventional sense. ${ }^{12}$

> C. Interaction energy

It is show $n$ in A ppendix $\mathbb{A}$ that the interaction energy hH inti, i.e., the grand-canonical average of Eq. (2b), can be expressed in term $s$ of the self-energies as

This is one of the key relations indispensable below.
D. Luttinger-W ard functional

Luttinger and $W$ ard ${ }^{12}$ gave an expression of the therm odynam ic potential $\quad \mathrm{T} \ln$ Tre ${ }^{\mathrm{H}=\mathrm{T}}$ for an interacting norm al Ferm i system as a functional of the selfenergy . Their consideration can be extended easily to the nom alBose system of $=0$. It is $m$ ore convenient to regard the resultant as a functional of $G$, which reads as

It hence follow s from $D$ yson's equation $G=\left(G_{0}{ }^{1}\right)^{1}$ that is stationary w th respect to G as $=\mathrm{G}(2 ; 1)=0$. Luttinger and $W$ ard also put Eq. (15) into an integral form w th the nth-order self-energy ${ }^{(n)}$ in term $s$ of the interaction. To be explicit, $(n)$ is de ned as the contribution of all the nth-order skeleton diagram $s$ in the sim ple perturbation expansion for the proper selfenergy w ith the replacem ent $\mathrm{G}_{0}!\mathrm{G} \cdot \frac{12}{2} \mathrm{~N}$ oting that there are 2 n 1 G reen's-function lines in the diagram sof ${ }^{(n)}$, Eq. (15) can be integrated order by order into ${ }^{12}$

The factor $1=n$ is due to the extra $H$ int present in the evaluation of hH int $\mathrm{i}^{(n)}$ com pared w th that of ${ }^{(n)}$. Hence the relation w illhold true generally in self-consistent perturbation expansions beyond the norm alphase.

## E. De D om in icis-M artin theorem

U sing a series of Legendre transform ations, it was shown by de $D$ om inicis and $M$ artin ${ }^{42}$ (see also Refs. 35 and 36) that the therm odynam ic potential in the condensed phase can be expressed as a functional

Thus, the exact therm odynam ic potential is stationary w ith respect to variations in both the condensate wave function and $G$ reen's functions. Equation (18) generalizes $=G(2 ; 1)=0$ of the nom al-state Luttinger-W ard functional Eq. (13)] to condensed B ose system s. H ow ever, no explicit has been known for BEC which satises Eq. (18) via Eqs. (8) and (11) and also includes Eq. (13) as the lim it ! 0.

Follow ing Eq. (13) for the norm alstate, we now express of the condensed phase as

$T$ he subscript of 1 denotes an extra in nitesim al negative constant in 1 to put the creation operator to the left for equal-tim e averages, and the second Tr denotes the usualtrace in the $m$ atrix algebra. Equation (19) appropriately reduces to Eq. (13) as ! 0. W hereas the rst tw o term s in Eq. (19) rem ain nite even for the ideal Bose gas, is m ade up only of contribution due to the interaction. $T$ his is one of the advantages for adopting expression (19).

O nce is written as Eq. (19), one can show by using Eq. (8), Eq. (11), G $(1 ; 2)=G(2 ; 1)$, and $(1 ; 2)=(2 ; 1)$ that condition (18) can be expressed equivalently $w$ ith respect to as

These are direct generalizations ofE q. (15) for the nom al state into the condensed phase.

Now, our gapless -derivable approxim ation denotes (i) constructing so as to reproduce Eq. (21) and (ii) determ ining $\hat{G}$, , and ${ }^{\wedge}$ self-consistently with Eqs. (8), (11), and (21). It will obey dynam ical conservation law $s^{10,31}$ as well as G oldstone's theorem 2,4,4 thereby enabling us to handle equilibrium and nonequilibrium phenom ena of BEC on an equal footing w the the Nam buGoldstone boson.

It is worth pointing out that expression (19) becom es exact when satis es Eq. (17) at each order up to $\mathrm{n}=1$ in the self-consistent perturbation expansion. W ith $\mathrm{H}_{\text {int }}$ ! $\mathrm{H}_{\text {int }}$ in Eq. (1), the proof proceeds in exactly the same way as that of the nom al state ${ }^{12}$ as follows. First, we nd w ith Eqs. (17) and (18) that the corresponding expression of Eq. (19) obeys the sam e rst order di erential equation @ $=@=\mathrm{hH}_{\text {int }} \mathrm{i}=$ as the de ning one $\quad T \ln T r e{ }^{\left(\mathrm{H}_{0}+H_{\text {int }}\right)=T}$, where $h \quad$ denotes the grand-canonical average in term $s$ of $H_{0}+H_{\text {int }}$. Second, the tw o expressions yield the sam e initial value $=0$. We hence arrive at the above conclusion. Thus, the gapless -derivable schem e obeying Eq. (17) also includes the exact theory as a lim it.
F. E xact relations w ith

W e now present a couple of exact relations in term sof to be satis ed in the condensed phase. Let us substitute the nth-order contribution of Eq. (12) into Eq. (17) and subsequently use Eq. (21a). W e thereby obtain

## III. CONSTRUCTING

O ne of the basic di culties in developing the selfconsistent perturbation expansion for BEC $m$ ay be attributed to the absence of a de nite concept of \skeleton diagram $s, "$ which were clear in norm al system $s, \frac{12}{}$ due to the appearance of nite one-particle average (1) $h$ (1)i. It brings an am biguity as to how to count the contribution $w$ ith $F$ and adequately in the renorm alization process. O ur approach here is to determ ine the contribution to inherent in BEC w ith the exact relation of Eq. (22) or Eq. (23) so as to reproduce the Luttinger-W ard functional for ! 0 , thereby avoiding the conœeptual di culty to de ne \skeleton diagram s" explicitly. The tw o relations w ill be shown to yield a unique result at each order in the self-consistent perturbation expansion in term $s$ of the interaction.

Follow ing P opov, ${ }^{43}$ we also suppress draw ing sym bols for and in those diagram s; they can be recovered easily $w$ ith the fact that Eq. (2b) originally contains tw o pairs of creation and annihilation operators.
A. De nite procedure for ${ }^{(n)}$

C onsider the $n$ th-order contribution. The procedure to construct $(n)$ is sum $m$ arized as (a)-(d) below. See Figs. 1 and 2 as explicit exam ples of relevant diagram $s$ for $n=1$ and 2 , respectively.
(a) D raw allthe norm al-state diagram scontributing to
( $n$ ) , i.e., those diagram $s$ which appear in the LuttingerW ard functional ${ }^{12}$ W ith each such diagram, associate the factor of the norm al state.
(b) D raw all the distinct diagram sobtained from those of (a) by successively changing the directions of a pair of incom ing and outgoing arrows at each vertex. This enum erates all the processes where $F$ or $F$ is relevant in place of $G$. W ith each such diagram, associate an unknown coe cient.
(c1) D raw all the distinct diagram s obtained from those of (a) and (b) by successively rem oving a G reen'sfunction line so as to $m$ eet the condition that a further rem ovalofany line from each diagram would not break it into two unconnected parts. T he procedure incorporates all the processes w here the condensate $w$ ave function participates explicitly. T he latter condition guarantees that the self-energies obtained by Eq. (21a) are com posed of connected diagram s.
(c2) A ssociate an unknown coe cient with each such diagram, except the one consisting only of a single vertex in the rst order, i.e., the rightm ost diagram in Fig. 1, for which the coe cient is easily identi ed to be $T=4$. Indeed, the latter represents the term obtained from Eq. (2b) by replacing every eld operator by its expectation value, i.e., the condensate w ave function.
(d) D eterm ine the unknow $n$ coe cients of (b) and (c) by requiring that either Eq. (22) or Eq. (23) be satis ed.

It is worth pointing out that, w ith Eq. (21a), the diagram s of (c1) necessarily yields those selfenergies which are separated into two parts by cutting a single line, i.e., those classi ed as \im proper" in the conventional sense. 12 A ccording to Eq. (12), how ever, we surely need to consider this kind of self-energy diagram $s$ in the selfconsistent perturbation expansion forBEC. It should also be m entioned that our proofofEq. (11) in A ppendix A 4

This cancellation is characteristic of those diagram swith no condensate wave function and holds order by order in Eq. (22). H ence relevant to Eq. (22) in $F$ ig. 1 are the last three diagram $s$, which yield

Tem s in the resultant equation can be expressed graphically by the last three diagram s of F ig. 1 w ith an extra symbol for the $m$ issing at each vertex. $W$ e obtain the sam e equations as above in term $s$ of $C_{2 b}^{(1)}, C_{1 a}^{(1)}$, and $C_{1 b}^{(1)} \cdot W$ e henœe arrive at Eq. (26) again.

It is worth pointing out that, except for the signs of $F$ and $F$ in the de nition of $E q$. [5), functional (25) w ith coe cient (26) is exactly identical to that of the conserving-gapless m ean- eld theory ${ }^{30,31}$ developed earlier w ith a subtraction procedure. M oreover, those signs have been shown not to a ect the physical quantities at all with in the rst order. ${ }^{31}$ Thus, the $m$ ean- eld theory has been identi ed here as the only self-consistent theory of the rst order com patible w ith exact relations (22) and (23).

W e m ay altematively require that Eq. (23) be satised. Tem swhich appear in the calculation of Eq. (23) can also be expressed graphically. They are obtained from the diagram $s$ in the second and third row of $F i g$. 2 and those of Fig . 3 by adding a broken-line arrow for the $m$ issing at a vertex in all possible ways. T he insertion is topologically unique for $m$ ost of the diagram $s$, e.g., those in the second row of Fig .2 ; in this case the corresponding equation for each diagram tums out to be the sam e as that in Eq. (28). T here are three exceptions. The rst of them corresponds to the pair of diagram $s$ $w$ ith the coe cient $C_{2 c}^{(2)}$ in Fig .2 , which yields three distinct diagram soffig. 4. Thus, $2 c_{2 c}^{(2)}+c_{3 c}^{(2)}+2 c_{3 b}^{(2)}=0$ in Eq. 28 b ) is now replaced by the three equations:

The relevant diagram s are given in F ig. 5 w ithout arrow s , and Fig. 6 show s additionaldiagram s necessary for the evaluation ofE q. (22) orE q. (23) . T he tw o relations have been checked to yield a unique result, which is sum $m$ arized in A ppendix B .

## IV . EXPRESSIONS OFENTROPY AND SUPERFLU DD ENSITY

T he analysis of the preceding section has clari ed that we can generally express the them odynam ic potential of interacting condensed bosons as Eq. (19), and can be constructed order by order uniquely so as to satisfy both of exact relations (22) and (23). The fact im plies that Eq. (19) becom es exact when term s up to $\mathrm{n}=1$ are retained in . U sing Eq. (19), we now derive form ally exact expressions of entropy and super uid density in term sofg reen's function (5), which are also valid w ith in the gapless -derivable approxim ation. W e set (1) !

It also tells us that the B ogoliubov m ode w ill.be connected continuously to the quasiparticle m ode which dom inates the low -tem perature them alproperties of super uid ${ }^{4} \mathrm{He} .{ }^{46}$ Further investigations seem required about the generalproperties of the self-energy near " $=0$ to elucidate this connection.

## B. Super uid density

W e next derive an expression of the super uid density. ## V. REAL-TIMEEQUATIONSOFMOTION

The form ulation of Secs. II and III can be extended straightforw ardly to describe nonequilibrium dynam ical evolutions of B EC. Form ally, we only need to replace the integration contour $0 \quad \mathrm{~T}^{1}$ by the closed tim e-path contour. ${ }^{15,16} \mathrm{~W}$ e here follow K eldysh ${ }^{14,16}$ to distinguish the forw ard and backw ard branches so that every time integration is lim ited to $1<t<1$. The present transform ation from equilibrium to nonequilibrium is a direct extension of the nom al-state consideration ${ }^{45}$

Equations (47), (48), and (51) form self-consistent equations for nonequilibrium tim e evolutions of B E C satisfying conservation law s and G oldstone's theorem sim ultaneously. Approxim ating by ${ }^{(1)}+\quad{ }^{(2)}$ yields a nonvanishing collision integral, for exam ple. U sing it, we can describe them alization of weakly interacting BEC microscopically, i.e., a topic which seem s not to have been clari ed su ciently. See, e.g., a recent book by G ri n, N ikuni, and Zarem ba ${ }^{19}$ for the present status on this issue.

## VI. SUMMARY

W e have developed a self-consistent perturbation expansion for BEC w ith broken $U(1)$ symm etry so as to obey G oldstone's theorem and dynam ical conservation law s sim ultaneously. Finst, the Luttinger-W ard them odynam ic functional for the norm al state ${ }^{12}$ has been extended to a system ofinteracting condensed bosonsasEq. (19). N ext, w e have presented a procedure to construct in the functionalorder by order $w$ th exact relations (22) and (23) in Sec. IIIA. It has been shown subsequently up to the third order of the self-consistent perturbation expansion that both of the relations yield a unique identical result at each order as Eq. (25) w ith Eq. (26), Eq. (27) w ith Eq. (29), and Eq. (B 1) w ith Eq. (B5). This fact im plies that the expansion converges to the exact therm odynam ic potential when in nite term s are retained in . U sing Eq. (19), we have also derived useful expressions for the entropy and super uid density in term sofG reen's function as Eqs. (37) and (44), respectively. F inally, we have derived a set of real-tim e dynam ical equations for $B E C$ as Eqs. (47), (48), and (51).

An expansion schem e like the present one $m$ ay have been anticipated since the work of de D om inicis and $M \operatorname{artin}^{42}$ in 1964 to prove the existence of the functional satisfying Eq. (18). H ow ever, no explicit expression for the functional seem $s$ to have been known to date. As already noted in Introduction, one of the advantages of the present expansion schem e over the sim ple perturbation expansion lies in its ability to describe nonequiliorium phenom ena. A nother point to be $m$ entioned is that it inconporates e ects of the anom alous G reen's function $F(1 ; 2)=h T \quad$ (1) (2)i m ore e ciently than the simple perturbation expansion 8 Th is fact m ay be realized by noting that $F(1 ; 2)$ becom es nite $w$ ith at least a single
interaction line in the latter schem e. Thus, nth-order term $S$ w ith $F$ or $F$ in the present expansion contain effects which show up only after the ( $n+1$ )th order in the sim ple perturbation expansion.

W e are planning to apply the present form alism to a w ide range of system $\mathrm{s} /$ phenom ena in BEC to elucidate their properties m icroscopically. It also rem ains to be perform ed to clarify two-particle correlations $w$ thin the present form alism.
