M agnetic impurity resonance states and symmetry of the superconducting order parameter in iron-based superconductors

W e investigate the e ect ofm agnetic in purities on the local quasiparticle density of states (LDOS) in iron-based superconductors. Employing the two-orbital model where 3d electron and hole conduction bands are hybridizing with the localized f-orbital of the impurity spin, we investigate how various sym metries of the superconducting gap and its nodal structure in uence the quasiparticle excitations and in purity bound states. We show that the bound states behave qualitatively di erent for each sym metry. Most importantly we nd that the impurity-induced bound states can be used to identify the nodal structure of the extended s-wave sym metry (S) that is actively discussed in ferropnictides.

I. IN TRODUCTION

The problem of magnetic in purities in a superconductor has been extensively discussed in the literature^{1,2,3,4,5}. The magnetic in purity and its moment can interact with the conduction electrons of the metal in the norm all or superconducting state. In the former case this leads to the K ondo e ect and a resonance state at the Fermi level. In the latter case it is well known that a single magnetic in purity doped into a superconductor produces a localized bound state within the quasiparticle excitation gap¹. The spectrum is sensitive to the sym – metry of the order parameter and is therefore a powerful tool to probe the pairing symmetry.

The discovery of new Fe-based superconductors⁶ with distinct multi-orbital band structure^{7,8,9} have opened a new horizon to high tem perature superconductivity. O ne of the most signi cant questions for these materials is the symmetry of the superconducting gap and the underlying Cooper-pairing mechanism. The latter is believed to arise due to purely electronic mechanism and a variety of models have been investigated with various weakcoupling approaches within random phase approximation RPA^{10,11,12} and renorm alization group techniques^{13,14}. It was concluded that the fully gapped extended s-wave state with the -shift of the gap between electron and hole Ferm i surface sheets is the most natural outcom e of these theories. It is believed to be driven by the interband spin uctuations at the antiferrom agnetic wave vector (;) in folded Brillouin zone and it also competes with the spin density wave instability at the same wave vector which leads to the columnar or striped AF state for low doping.

However, despite intensive experimental e orts, the pairing symmetry of this new class of superconducting materials is not completely settled. Some experimental groups have reported the fully gapped behavior^{15,16,17,18,19}, but some measurements, in partic-

ular NMR relaxation and penetration depth suggest existence of gap nodes^{20,21,22}. From the theoretical side it has also been realized^{11,23} that the superconducting gap structure m ay be non-universal in ferropnictides due to the large intraband Coulomb repulsion. Its inclusion may force the superconducting gap to develop a node which crosses one of the Ferm isurfaces. At the same time the symmetry of the superconducting gap will, how ever, still remain extended s-wave though higher harm onics are acquired. M oreover, in som e scenarios^{24,25} the superconducting gap even changes from the extended s-wave towards either d_{x^2} v^2 - or d_{xy} -wave symmetries depended ing on the slight variation of parameters. Recently it has been found that isoelectronic substitution of As by P in $BaFe_2 (As_1 xP_x)_2$ changes the gap structure in Fe pnictide compounds from nodeless to nodal¹⁶. It seems that whereas electron- and hole doping leads to a fully gapped state, isoelectronic doping (equivalent to chem ical pressure) leads to the presence of line nodes in the gap function. Therefore it is desirable to investigate the magnetic impurity e ect in Fe pnictide compounds for di erent candidates of gap symmetries. The resulting characteristics of the LDOS which is sensitive to the nodal structure may provide a clue to distinguish between the various proposed gap symmetries. In previous investigations for FeAs compounds the e ect of nonmagnetic in purities on the quasiparticle spectrum in the state^{26,27} has been studied. Magnetic impurity ef-S fects have so far only been discussed for the single band model with d_{x^2} v^2 order parameter¹⁹, and for the twoband model for a classical local moment²⁸. At the same time, it is known that the local density of state around the magnetic impurity can provide signi cant inform ation on the local electronic structure in the unconventional superconductor²⁹. Note also that the in uence of nonmagnetic^{30,31} and magnetic³² impurities on the reduction of superconducting transition temperature has been recently analyzed.

In this paper we investigate the e ect of a single m agnetic in purity on the local quasiparticle excitations around the impurity site. We use a minimal two-band m odel for the electronic structure of Fe pnictides which leads to the (0;0)-centered hole and M (;)-centered electron pockets. In section II the Anderson model with a strong Hubbard repulsion for the localized f-electron at the impurity site, and a hybridization between conduction bands and localized state will be introduced. Wew ill treat thism odel in the in niteU lim it where a slave boson representation m ay be used sim ilar to R ef. 19 where the And erson in purity in the single band model with d_{x^2} v² order parameter has been studied. We then calculate the local density of states (LD O S) and discuss the signatures of possible Fe pnictide order parameter symmetry in its spectral and spatial characteristics. This quantity is accessible in STM tunneling spectroscopy⁵. The num erical results for the various cases will be discussed in section III. Finally in section IV we give a summary of our results and a conclusion.

II. THEORETICAL MODEL

A coording to the band structure calculations³³ as well as num erous ARPES results³⁴ the Ferm isurface topology of iron-based superconductors consists of the small size circular hole and elliptic electron Ferm i surface pockets centered around the and (;)-points of the folded BZ, respectively. The pockets are nearly of the same size which results in the nesting properties of the electron and hole bands at the antiferrom agnetic wave vector, Q $_{\rm A\,F}$, $\mathbf{W}^{h}_{k+Q_{h,F}}$. Despite the fact that there are two .e. 📌 = electron and two hole pockets it has been argued¹³ that it is enough to consider only two of them (one electron and one hole pocket) because the instabilities of the two-band m odel are the sam e as in the four-band m odel. Follow ing this suggestion we consider two bands that are given by diagonalized tight binding expression including hoppings up to the next nearest neighbors:

where c_k^y creates an electron with spin in band (= 1;2 refer to the electron and hole band, respectively) with wave vector $k = (k_x; k_y)$. The dispersion "_k is then given in the tight-binding form³⁵

Here, "_{k1} dispersion yields the hole Ferm i surface pocket around the point and "_{k2} gives the elliptic electron Ferm i surface pocket around the M = (;) point, see Fig.1. The parameters have been chosen from the available t to the ARPES data³⁶ (all in eV) and correspond to the hole doping of about 10%. The f^y operator create the localized electron at the in purity site at the origin and U is its on-site C oulom b repulsion. Finally f is the fband position, V_k is the hybridization energy between localized electron and the conduction bands, and k is the singlet superconducting gap function. We choose values for f, and V_k (Fig.2) such that the forbital is alm ost lled (n_f = 1).

O ur model assumes the limit U ! 1 where doubly occupied f-states are excluded. This limit may be represented by introducing the auxiliary boson b, with the constraint $Q = b^{y}b^{+}$ f^yf = 1³⁷. In the mean eld approximation (b = hbi = hb^yi), the total H am iltonian including the constraint is given by H_{M F} + (b² 1). Here H_{M F} is obtained as

Here $_{\rm i}$ are the Pauli matrices acting in spin space, $\delta_{\rm i}$ are the Pauli matrices in the orbital space, and $\delta_{\rm i}$ $_{\rm j}$ denotes a direct product of the matrices operating on the 4-dimensional N am bu space. Furtherm ore $\sim_{\rm f}$ = ($_{\rm f}$ +)=2, and $V_{\rm k}$ = bV_{\rm k} are elective hybridization and energy position of the in purity f-level, respectively.

The local density of states (LDOS) near the magnetic impurity is obtained from analytic continuation i! $_n$! E + $i0^+$ according to

where $!_n = T(2n + 1)$ is the M atsubara frequency, and $G^{c}(r; r^0; !_n)$ is a Fourier transform ation of the m atrix of the conduction electrons G reen's function.

M in imization of the ground state energy with respect to b and the Lagrange multiplier leads to the mean eld equations

By solving the set of equations (11)–(17), num erically one can $\,$ nd the values of $\sim_{\rm f}$ and b which are used as an input for the t-m atrix .

III. NUMERICAL RESULTS

W e now discuss the results of numerical calculations for the central quantity N^c (E;r) based on the previous analysis (obtained from Eqs. 11-17). In this section we focus on the energy and also spatial dependence of the local density of states (LDOS) (Eq. 5) at T = 0 for various gap symmetries. As the main candidates we include different types of the extended s-wave gaps which are fully

gapped on the hole pocket but possibly have accidental nodes on the electron pockets due to higher harm onics contributions. For com pleteness, we also include d-wave gap functions which have nodes on both electron and hole pockets. The latter how ever are not supported by ARPES results^{15,38,39} which suggest nodeless gaps on the hole pockets.

We begin our discussion with the anisotropic nodeless extended s-wave pairing function (S). The Fermi surface illustration with respective node positions indicated by dashed lines is shown in Fig.1.(a). This gap function is given by

and we show the result for the LDOS at the origin $(r_x; r_y) = (0; 0)$ in Fig.2 (a) for $_0 = 6 \text{ meV}$ and $_f =$

 $_0=3,$ with di erent hybridization energies V_1 = V_2 = 0 (green), V_1 = V_2 = 0.5 $_0$ (red), and V_1 = V_2 = $_0$ (blue). W hile the overall structure of the spectrum stays the same the increased hybridization leads to more pronounced bound state peaks within the gap. We observe that an increase of the hybridization energy, V, causes the position of peaks to move to higher absolute values of E, and a corresponding increase of their line width. By increasing the absolute value of the impurity energy level, $_{\rm f}$, the bound state also moves to higher absolute values of E. Notice that by restricting to the rst order perturbation theory in elective hybridization (B om approximation), we did not indication of V.

Furtherm ore, due to the di erent size of electron and hole pockets the onset of the continuum around $\underline{E} = jis$ split into a double peak structure. For E > 0 the lower and upper peaks correspond to hole and electron pockets, respectively.

The addition of higher harm onics in the S_1 gap function allows to tune the modulus of the gaps on hole and electron pockets independently while keeping the basic property of having an opposite signs. As seen from F ig.1 (a) this is equivalent to shift of the nodal line position closer to the electron pockets and increasing higher harm onic amplitude continuously one eventually produce an accidental node on this sheet. This gap function is

given by

and the result for the LDOS is plotted in Fig.(2(b)-(f) for dierent parameters. At the symmetry points one has $_{(0;0)} = _{0}(1 +)$ and (;)) = $_0$. Then $j_{(0;0)}j_{(;)}j = which also means that the dif$ ference between the absolute values of the gaps on centered hole pockets and M -centered electron pockets increases with . This can be clearly seen in Fig. 2(b) (=1) where the peak at larger $E = _0$ joriginating from the hole pocket is pushed to larger energies and for = 3is no longer visible on the scale of Fig. 2 (c). On the other hand the peak due to gap m axim um on the electron pocket stays xed around $f = _0 j'$ 1 while grows. At the same time a deep minimum and nally an accidental node of the gap develops on the electron pocket and leads to the increase of the low energy LDOS in Figs 2(b)-(f). This type of low energy DOS may explain power laws for NMR relaxation rate and penetration depth observed in som e pnictides^{20,21,22}. On the other hand the position of bound state peaks caused by the magnetic impurity is apparently insensitive to the variation of and the change of the underlying quasiparticle spectrum .

However, the $\rm S_1~gap$ function is not unique and accidental nodes on the electron pocket m ay be obtained with a di erent type ofm odi cation with higher harm onics. This leads us to extended $\rm S_2$ -wave pairing described by another gap function

Its nodal structure is shown in (Fig. 1(b). Now there are two nodal lines, one located between the pockets which leads to an anisotropic but fully gapped order parameter on the hole pockets. The other accidental nodal line centered around the M point cuts the electron pocket and leads to a nite low energy quasiparticle DOS as seen in the results of the Figs. (3 (a) and 3 (b) for = 1.2; $^{0} = 0.15$ and = 1.17; $^{0} = 0.08$ respectively. The bound states due to impurity scattering appear again as pairs at sim ilar energies as for the S₁ case.

Finally for completeness we also consider two simple anisotropic d-wave order parameters, namely $d_{x^2\ y^2}$ (Fig. 1(d)) and d_{xy} (Fig. 1(e)) which have symmetry enforced gap nodes. This leads to sign change of the gap function on the same FS pocket rather than between them . We consider the two candidates

In each case the nodal lines cross both Ferm i surface pockets in contrast to the extended swave model. We

note that current ARPES experim ents have show n a fully gapped hole $pocket^{15,38,39}$ though no experim ents yet are available for P-based system s.

The background of the LD OS is given by the typicalV – shape of a d-w ave order param eter. On top of it a single bound state peak due to the impurity scattering appears below the Ferm i level. This is distinctly di erent from the extended s-w ave case where always two bound states below and above the Ferm i level appear sym metrically. A partly similar observation for a $d_{x^2-y^2}$ order param – eter with only a single sheet FS intended for cuprates was made in R ef. 19. There one bound state peak was found for $(r_x; r_y)$ along the anti-nodal direction and two peaks for the nodal direction. In our present d-w ave case considered for the two-sheet FS of Fe pnictides the single peak appears for both nodal and anti-nodal directions.

For clarifying of the position dependence of resonance peaks, Fig.5 displays the spatial variation of the LDOS N_c(!;r_x;r_y) around the magnetic in purity at the resonance energies, (a) ! = !_r and (b) ! = !_r, for S gap symmetry with $_0 = 6 \text{meV}$; $_f = _0=3$, and V₁ = V₂ = $_0$. It shows that the maximum amplitude of the LDOS appears close to the in purity site and decays non-monotonically further away from the in purity site. W hile the LDOS at !_r is rather isotropic the peak for

 $!_r$ shows a signi cant anisotropic LDOS in the plane. This anisotropy does not seem to result from special FeAs Ferm is urface feature since it is also observed in the single parabolic band case in Ref. 19.

IV. SUMMARY

We have investigated the e ect of magnetic in purity scattering in the FeAs pnictide superconductors. We used a simple two band model Ferm i surface and calculated LDOS spectral and spatial dependence close to the in purity site for two types of extended s-wave superconducting order parameters with inter-band sign change and for two d-wave order parameters with intra-band sign change. In the form er two impurity bound states appear symmetrically around the Fermi energy at positions

 $!_{\rm r}$. The modulus of the bound state energy increases with hybridization strength V and impurity orbital energy $_{\rm f}$ monotonically. In the latter case only the lower bound state pole at $!_{\rm r}$ appears in the LDOS for any direction from the impurity site. The background variation of the LDOS is determined by the characteristics of the superconducting gap on the two FS sheets. The extended S-wave order parameters may be tuned such that fully gapped behavior on the central hole sheet and acci-

dental node structure on the zone boundary hole sheets appear naturally. In this case the spatial dependence of the LDOS for the two bound state peaks shows signi cant di erences in the degree of spatial anisotropy. W e conclude that the observation of two bound state peaks in tunneling experiments would be an important support for the extended s-wave gap function with interband sign change. The ne structure of the background continuum LDOS may give more detailed information on the type of the accidental nodal structure.
