# The q-exponential fam ily in statistical physics

A bstract. The Boltzm ann-G ibbs probability distribution, seen as a statistical model, belongs to the exponential fam ily. Recently, the latter concept has been generalized. The q-exponential fam ily has been shown to be relevant for the statistical description of sm all isolated systems. Two m ain applications are reviewed: 1. The distribution of the momentum of a single particle is a q-G aussian, the distribution of its velocity is a deform ed M axwellian; 2. The con gurational density distribution belongs to the q-exponential fam ily.

The de nition of the temperature of sm all isolated systems is discussed. It depends on de ning the therm odynamic entropy of a microcanonical ensemble in a suitable manner. The simple example of non-interacting harm onic oscillators shows that Renyi's entropy functional leads to acceptable results.

## 1. Introduction

In statistics, a model is a probability distribution which depends on a number of parameters. The probability distributions of statistical physics usually depend on parameters and can therefore be seen as statistical models. Typical parameters are the total energy U in the microcanonical ensemble, or the inverse temperature in the canonical ensemble. This parameter dependence is important in order to understand why certain models belong to the exponential family and others do not. In particular, all models described by a Boltzm ann-G ibbs distribution belong to the exponential family because they have the right dependence on the inverse temperature .

Recently, the notion of the exponential fam ily has been generalized by the present author in a series of papers [1, 2, 3, 4, 5, 6]. The same de nition of generalized exponential fam ily has been introduced in the m athem atics literature [1, 7, 8, 9, 5]. This class of m odels was also derived using the m axim um entropy principle in [10, 11] and in the context of gam e theory [12, 13]. Here we concentrate on the m ore speci c notion of the q-exponential fam ily and review the evidence that this fam ily appears in a natural m anner in the context of the m icrocanonical description of a classical gas.

The notion of q-exponential fam ily is connected with Am ari's -fam ily [14], studied in the context of inform ation geom etry. The geom etric approach is very appealing also in the context of statistical physics. See for instance [15, 16]. However, this topic will not be discussed in the present paper.

Note that in m any of the formulas given below Boltzm ann's constant  $k_B$  is set equal to 1, which m eans that tem peratures are m easured in units of energy.

# 2. The Boltzm ann-G ibbs distribution The Boltzm ann-G ibbs (BG) distribution is given by

$$f(x) = \frac{c(x)}{Z(x)}e^{-H(x)}$$
; x in phase space

The Ham iltonian H (x) is a given function. It determ ines the physical model. is a parameter, corresponding with the inverse temperature of therm odynamics. The function c(x) quite often is just a constant. Z () is called the partition sum. It norm alizes the probability distribution:

$$Z() = dx c(x) e^{H(x)}$$
: (2)

() ln Z () corresponds in therm odynam ics with M assieu's function. It satis as the identity

$$\frac{d}{d} = U$$
(3)

(1)

with U the energy, this is, the expected value of the H am iltonian H (x)

$$U = E H = dx f (x)H (x)$$
: (4)

The second derivative of Massieu's function satis es

$$\frac{d^2}{d^2} = E (H U)^2 0:$$
 (5)

Therefore, () is a convex function, as expected from therm odynam ics. Indeed, in therm odynam ics M assieu's function is by de nition [17] the Legendre transform of the therm odynam ic entropy S (U), which is a function of the energy U.W ithin statistical physics the therm odynam ic entropy can be de ned by m eans of an entropy functional, I (f), which is a function over the space of all probability distributions f. The m ost com m on entropy functional is that of Boltzm ann-G ibbs-Shannon (BGS)

$$I(f) = dx f(x) \ln \frac{f(x)}{c(x)};$$
(6)

It is well-known that I(f) takes its maximal value at f = f within the set of all f satisfying  $E_{f}H = U$ . This maximal value of I(f) is then identied with the therm odynamic entropy S(U). It satisfies

S (U) 
$$\max_{Z^{f}} I(f) : E_{f}H = Ug = I(f)$$
  
=  $dx f(x) (ln Z() + H(x))$   
=  $ln Z() + U:$  (7)

C om parison with

$$() = \max_{U} fS(U) Ug$$
 (8)

then yields () =  $\ln Z$  (). From (7,8) follows the inverse transform ation

$$S(U) = \inf f(t) + Ug$$
 (9)

and an identity, which is the dual expression of (3),

$$= \frac{\mathrm{dS}}{\mathrm{dU}}:$$
 (10)

The latter relation is often used as the denition of the inverse temperature. Another consequence of (9) is that S (U) is a concave function.

## 3. The exponential fam ily

A model of classical (statistical) mechanics is determined by a Hamiltonian H (x). On the other hand, a statistical model is de ned as a parameterized probability distribution function (pdf). It is now immediately clear that the Boltzm ann-G ibbs distribution (1) de nes a statistical model with one parameter . Moreover, it belongs to a very special class of models called the exponential family. In fact, a model belongs to the exponential family with parameters = (1; 2; n) when its pdff (x) can be written into the canonical form

$$f(x) = c(x) \exp^{\binom{0}{2}} \sum_{j=1}^{X^{n}} (x) \quad ()^{A};$$
(11)

where c(x),  $K_j()$ , and () are known functions.

M odels belonging to the exponential fam ily share a num ber of nice properties. For instance, they satisfy the identities, which generalize (3),

$$\frac{\varrho}{\varrho_{j}} = E K_{j} = \frac{Z}{dx f(x)K_{j}(x)}$$
(12)

Note that the functions K<sub>j</sub>(x) may not depend on the parameters  $\cdot$ . In statistical physics one uses sometimes elective H am iltonians which depend on the tem perature  $^{-1}$ . The corresponding statistical models may exhibit therm odynamic instabilities which cannot occur in models belonging to the exponential family.

## 4. D eform ed logarithm ic and exponential functions

The Boltzm ann-G ibbs distribution is so dom inant in statistical physics that one can get the impression that this is the only relevant statistical model. However there exists a much larger class of models, sharing most of the nice properties of the exponential family. Some of these more generalm odels appear in a naturalm anner in statistical physics, as will be shown further on. One way to get access to this larger class is by replacing the exponential function in the de nition (11) by some other function. This can be done in a fairly general way [1, 11]. Here, a one-parameter deform ation is considered, which is the basis for the generalization known as non-extensive statistical mechanics [18].

Fix a real number q for 1. The q-deform ed logarithm is de ned by [19, 20]

$$\ln_{q}(u) = \frac{1}{1 q} u^{1 q} 1 ; \quad u > 0:$$
 (13)

The basic properties of the q-deform ed logarithm ic function are that  $\ln_q (1) = 0$  and that it is a strictly increasing function. Indeed, its rst derivative is always positive

$$\frac{d}{du} \ln_{q}(u) = \frac{1}{u^{q}} > 0$$
(14)

For q > 0 the q-logarithm is a concave function. In the limit q = 1 it reduces to the natural logarithm  $\ln u$ .

The inverse function is the deform ed exponential function

$$\exp_{q}(u) = [1 + (1 \quad q)u]_{+}^{1=(1 \quad q)} :$$
 (15)

The notation  $[u]_{+} = m \exp(u)$  is used. One has  $0 \exp_q(u) + 1$  for all u. For  $q \in 1$  the range of  $\ln_q(u)$  is not the full line. By putting  $\exp_q(u) = 0$  when u is below the range of  $\ln_q(u)$ ,




Figure 1. The q-deformed logarithm  $\ln_q(u)$  for q-values 0.5 (red), 1 (black), and 2 (blue).

and equal to +1 when it is above,  $\exp_q(u)$  is an increasing function of u, de ned for all values of u. W ith this extended de nition one has

$$\exp_{q}(\ln_{q}(u)) = u \quad \text{for all } u > 0:$$
(16)

However, the relation  $\ln_q (\exp_q (u)) = u$  is only dened when  $\exp_q (u)$  is neither 0 or +1.

The basic properties of the q-deform ed exponential are that  $\exp_q(0) = 1$  and that it is an increasing function. Indeed, one has

$$\frac{d}{du} \exp_q (u) = \exp_q (u)^q \quad 0:$$
(17)

For q > 0 it is a convex function.

### 5. The q-exponential fam ily

The deform ed logarithm ic and exponential functions can be used in more than one way to develop a generalized form alism of statistical physics. The original approach of non-extensive statistical physics [21] was to rst generalize the Boltzm ann-G ibbs-Shannon entropy functional (6) by deform ing the logarithm contained in it. Next one studies pdfs which maxim ize this entropy functional under given constraints. However, it turns out to be advantageous to generalize im mediately the notion of exponential fam ily by deform ing the exponential function appearing in (11). This leads to the de nition that the one-parameter model f (x) belongs to the qexponential fam ily if there exist functions c(x); (); H (x) such that one can write

$$f(x) = c(x) \exp_{\alpha} ((x) + h(x))$$
: (18)

In the lim it q = 1 this reduces to the standard de nition of the exponential fam ily with =. Note that we take into account the possibility that the parameter does not necessarily coincide with the inverse temperature as it is de ned by the therm odynamic relation (10).

Introduce the q-deform ed entropy functional

$$I_{q}(f) = dx f(x) \ln_{q} \frac{f(x)}{c(x)}$$

$$= \frac{1}{1 q} 1 \frac{Z}{dx c(x)} \frac{f(x)}{c(x)} : \qquad (19)$$

In the lim it q = 1 it reduces to the BGS-entropy functional (6). Note that this de nition is almost the entropy functional originally introduced by T sallis [21], but di ers from it by the fact that the parameter q has been substituted by 2 q.

Assume now 0 < q < 2. Then one can show that the pdff = f (x) maxim izes the quantity

$$\frac{1}{2 q} I_q(f) \qquad E_f H:$$
(20)

In the q = 1-case this result is known as the variational principle. A proof of this statement involves the introduction of an appropriate B regm an divergence | see [1, 5]. Note that the variational principle implies the maximum entropy principle:  $I_q(f) = I_q(f)$  for all f which satisfy  $E_f H = E H$  (using the notation  $E = E_f$ ). A well-known problem is now that f also maximizes  $(I_q(f))$ , where (u) is an arbitrary monotonically increasing function. Therefore a meaningful ansatz is to assume that the therm odynam ic entropy S (U) is given by

$$S(U) = (I_q(f)) = (() + EH):$$
 (21)

The therm odynamic expression for the inverse temperature can then be calculated using (10). It is clear that the resulting relation between energy U and temperature  $^{1}$  will depend on the choice of the monotonic function (u). Physical arguments are needed to decide which choice is the right one.

## 6.q-G aussians

The q-G aussian distribution in one variable is given by (see for instance [22, 23, 24])

$$f(x) = \frac{1}{c_q} \exp_q(x^2 = 2);$$
 (22)

with

$$c_{q} = \sum_{1}^{Z} dx \exp_{q}(x^{2}) = \frac{r}{\frac{1}{q-1}} \frac{\frac{1}{2} + \frac{1}{q-1}}{\frac{1}{q-1}} \text{ if } 1 < q < 3;$$
$$= \frac{r}{\frac{1}{1-q}} \frac{1 + \frac{1}{1-q}}{\frac{3}{2} + \frac{1}{1-q}} \text{ if } q < 1; \qquad (23)$$

It can be brought into the form (18) with  $c(x) = 1 = c_q$ , H (x) =  $x^2$ , = <sup>3</sup> q, and

$$() = \frac{q \ 1}{q \ 1} = \ln_2 q ():$$
 (24)

The q = 1-case reproduces the conventional G auss distribution. For q < 1 the distribution vanishes outside an interval. Take for instance q = 1=2. Then (22) becomes

$$f(x) = \frac{15^{p} \overline{2}}{32} \cdot 1 \cdot \frac{x^{2}}{2} + \frac{x^{2}}{2$$

This distribution vanishes outside the interval [; ]. In the range 1 q < 3 the q-G aussian is strictly positive on the whole line and decays with a power law in jxj instead of exponentially. For q = 2 one obtains

$$f(x) = \frac{1}{x^2 + 2^2}$$
(26)

This is the Cauchy distribution. The function (26) is also called a Lorentzian and is often used in physics to t the shape of spectral lines. For q 3 the distribution cannot be normalized because

$$f(x) = \frac{1}{jx j^{-(q-1)}} \text{ as } jx j! 1$$
 (27)

is not integrable anym ore.

# 7. A q-deform ed M axwelldistribution

The most straightforward way to produce an important example of q-G aussians in statistical physics is by considering marginals of the uniform distribution on a hypersphere { see [25]. The H am iltonian of an N-particle classical ideal gas is given by

$$H(p) = \frac{1}{2m} \sum_{j=1}^{N} \dot{p}_{j} \dot{f}; \qquad (28)$$

where m is the mass of the particles and  $p_j$  is the momentum of the j-th particle. Given the value E for the total energy, the phase space consists of all points of the 3N -dimensional sphere with radius 2m E. A ssum e equal probability of all points of phase space. Let  $B_n$  (r) denote the volume of a sphere with radius r in dimension n. The probability distribution for the momentum of a single particle becomes

$$f(p_{1}) = \frac{1}{(2m)^{3N} = 2B_{3N}^{0}(E)} d^{3}p_{2} d^{3}p_{3} (E + H(p))$$

$$= \frac{1}{(2m)^{3-2}} \frac{B_{3N}^{0}(E)}{B_{3N}^{0}(E)} (E + p_{1}p_{2} = 2m)$$

$$= \frac{1}{c_{q}} \exp_{q}(p_{1}p_{1}p_{3} = 2^{-2})$$
(29)

with

$$q = \frac{3N}{3N} \frac{6}{4}$$
 and  $^{2} = \frac{2m E}{3N} \frac{1}{4}$ : (30)

This is a q-Gaussian with q < 1. The appearance of a cuto can be easily understood. A rbitrary large momenta are not possible because of the obvious upperbound  $\dot{p}_1 \dot{f}$  2m E. The probability distribution of the scalar velocity  $v = \dot{p}_1 \dot{f}m$  becomes

$$f_q(v) = \frac{4 m^3}{c_q} v^2 \exp_q \frac{1}{2^2} m v^2$$
 : (31)

Only in the lim it of large systems it converges to the M axwell distribution. One concludes that the M axwell distribution is an approximation and is only valid in the lim it N ! 1.

# 8. Con gurational density of classical gases

The con gurational density of a gas of classical particles always belongs to the q-exponential fam ily [26]. The idea behind the calculation is the same as that of the previous section. This kind of non-extensivity of a classical gas was observed already quite some time ago [27, 28]. It becomes a strong statement in the language of q-exponential fam ilies.

A classical gas of N interacting particles is described by the Ham iltonian

$$H(q;p) = \frac{1}{2m} \sum_{j=1}^{N} \dot{p}_{j} \dot{f} + V(q);$$
(32)

where V(q) is the potential energy due to interaction among the particles and between the particles and the walls of the system. The microcanonical ensemble is then by de nition the following singular probability distribution

$$f_{U}(q;p) = \frac{1}{!(U)} (U H(q;p));$$
(33)

where () is D irac's delta function and ! (U) is the norm alization

$$! (U) = \frac{1}{h^{3N}} \sum_{R^{3N}}^{Z} dp_1 \qquad \sum_{R^{3N}}^{Z} dq_1 \qquad N dq_{R^{3N}} dq_1 \qquad N dq (U \quad H (q;p)):$$
(34)

The constant h is introduced for dimensional reasons. Because of the quadratic nature of the kinetic energy term it is possible to integrate out the momenta  $p_j$ . The resulting function is called the congurational density function and is evaluated as follows

$$\begin{aligned} f_{U}^{conf}(q) &= \frac{1}{h^{3N}} \sum_{\substack{R^{3N} \\ R^{3N} \\ R^{3N}$$

$$= q_{V} \exp_{q} ((V) V(q));$$
(35)

with

$$q_{N} = \frac{2m}{h^{2}} \stackrel{3N=2}{;} = \frac{1}{1 q} \frac{1}{[(3N=2)! (U)]^{1 q}};$$
  
() =  $\frac{3}{2}N$  1 U;  $q = 1 \frac{2}{3N 2};$  (36)

Assume now that ! (U) is a strictly increasing function. Then it can be inverted to obtain U as a function of . Under this assumption the con gurational density function belongs to the q-exponential family. As a consequence, one immediately knows that  $f_U^{\rm conf}(q)$  maximizes the entropy functional  $I_q(f)$ . It is then tempting to identify  $I_q(f_U^{\rm conf})$  with the con gurational entropy. However, as noted before,  $(I_q(f_U^{\rm conf}))$  could serve as well, where (u) is an arbitrary monotonic function.

## 9. On the de nition of tem perature

There is no consensus in the literature what is the correct de nition of the therm odynamic entropy S(U) for isolated system s. The question is of importance because it directly determ ines the de nition of the therm odynamic temperature via the relation (10). Most often one quotes the de nition known as Boltzmann's entropy

$$S(U) = k_B \ln ! (U);$$
 (37)

where ! (U) is the density of states (34). However, this choice of de nition of entropy has some drawbacks. For instance, for the pendulum the entropy S (U) as a function of internal energy U is a piecew ise convex function instead of a concave function [2]. The lack of concavity can be interpreted as a microcanonical instability [29, 30]. But there is no physical reason why the pendulum should be classified as being instable at all energies.

The shortcom ings of Boltzm ann's entropy have been noticed long ago. A slightly di erent de nition of entropy is [28, 31, 32, 33] (see also in [34] the reference to the work of A. Schluter)

$$S(U) = k_B \ln (U);$$
 (38)

where (U) is the integral of ! (U) and is given by

$$(U) = \frac{1}{h^{3N}} \sum_{R^{3N}}^{Z} dp_1 \qquad \sum_{R^{3N}}^{Z} dq_1 \qquad N dq(U \quad H \quad (q;p)):$$
(39)

An immediate advantage of (38) is that the resulting expression for the temperature T , de ned by the therm odynam ical formula % f(x) = 0

$$\frac{1}{T} = \frac{dS}{dU};$$
(40)

coincides with the notion of tem perature as used by experim entalists. Indeed, one nds

$$k_{\rm B} T = \frac{(U)}{! (U)}$$
: (41)

For a harm onic oscillator the density of states ! (U) is a constant. Hence, (41) in plies  $k_B T = U$ , as wanted. It is well-known that for classical monoatom ic gases the r.h.s. of (41) coincides with twice the average kinetic energy per degree of freedom. Its signi cance is that the equipartition

theorem, assigning  $(1=2)k_B T$  to each degree of freedom, does hold for the kinetic energy also in the m icrocanonical ensemble. Quite often the average kinetic energy per degree of freedom is experim entally accessible and provides a unique way to measure accurately the tem perature of the system.

But also (38) and (41) are subject to criticism. In small systems nite size corrections appear [34, 35] for a number of reasons. As argued in [35], the problem is not the equipartition of the kinetic energy over the various degrees of freedom, but the relation between temperature and kinetic energy.

### 10. Exam ple

Let us follow [26] and consider the example of 3N non-interacting harm onic oscillators. The potential energy equals

$$V(q) = \frac{1}{2}m !^{2} \prod_{j=1}^{X^{N}} q_{j}^{2}:$$
(42)

0 ne calculates

$$(U) = \frac{1}{h^{3N}} \begin{bmatrix} Z & Z & 0 & 1 \\ g_{N} & g_{N} & dp_{1} & g_{N} & dq_{1} & g_{N} & g_{N}$$

From (36) and (43) now follows

$$\frac{1}{-1} = (1 \quad q) \quad \frac{(3N=2)}{(3N)} \frac{1}{!^{3N}} \quad \frac{4}{h} \quad U^{3N-1} \qquad (44)$$

U sing Stirling's approximation one obtains

...

$$\begin{array}{ccc} (3N = 2) & P - 2 & e & {}^{3N = 2} \\ \hline (3N) & & & & & \\ \end{array}$$
(45)

so that

$$\frac{1}{1} = \frac{4}{h!} \frac{U}{3N}^{2};$$
 (46)

which shows that 1= is roughly proportional to  $U^2$ . This is not what one expects. In the canonical ensemble is the tem perature 1= proportional to U

$$\frac{1}{3N} = \frac{U}{3N} :$$
 (47)

O ne therefore concludes that the parameter cannot be the inverse tem perature . Note that  $= dS^{conf} = dU^{conf}$  holds with  $S^{conf}$   $I_q(f_U^{conf})$  and  $U^{conf} = E V = \frac{1}{2}U$ . Therefore one concludes that  $S^{conf}$  cannot be the therm odynamic con gurational entropy  $S^{conf}$ , but the two entropies must be related by a non-trivial function (u). From (47) follows

$$S^{conf} = \frac{3N}{2} \ln U^{conf} + A; \qquad (48)$$

for som e constant A. But (46) in plies that

$$S^{\text{conf}} = \frac{1}{e} \frac{h!}{4} - \frac{2}{U} \frac{(3N)^2}{U^{\text{conf}}} + \text{ constant.}$$
(49)

Therefore the relation between  $S^{conf}$  and  $S^{conf}$  is logarithm ic. M ore precisely,  $S^{conf} = G^{conf}$ , with (x) of the form (x) = 3N ln (B x) + C, with constants B and C. This suggests that Renyi's entropy functional is the right one to start with. Indeed, let = 2 q. The relation between Renyi's I (f) and  $I_{q}(f)$ , as given by (19), is I (f) =  $(I_{q}(f))$  with

$$(u) = \frac{1}{1 q} \ln (1 (1 q)u) :$$
 (50)

Take the constant in (49) equal to 1=(1 q). Then one obtains

$$S^{conf}$$
  $S^{conf}$  '  $\frac{3N}{2}$  1  $\ln \frac{U^{conf}}{6N}$  + constant : (51)

Thisyields

$$\frac{\mathrm{dS}^{\,\mathrm{conf}}}{\mathrm{dU}^{\,\mathrm{conf}}} = \frac{3\mathrm{N}}{2} \quad 1 \quad \frac{1}{\mathrm{U}^{\,\mathrm{conf}}} = \frac{3\mathrm{N}}{\mathrm{U}}^{2}; \tag{52}$$

which is an acceptable expression for the inverse tem perature .

#### 11. Concluding rem arks

The notion of a q-exponential fam ily of statistical models has been reviewed. The q-G aussian distribution belongs to this fam ily. The probability distribution of the momentum of a single particle in a classical gas is such a q-G aussian. An immediate consequence is that the velocity distribution of a classical particle is a q-deformed M axwell distribution. In particular, the standard M axwell distribution is an approximation which is only valid in the limit of large system s.

The con gurational probability distribution of a classical gas always belongs to the q-exponential fam ily. The non-extensivity parameter q is given by

$$\frac{1}{1 q} = \frac{3}{2} N \qquad 1; \tag{53}$$

where N is the number of particles. The latter expression has appeared quite often in the literature, see for instance [27, 36, 37].

Finally, a system of 3N independent harmonic oscillators is considered. It is known that T sallis' entropy and Renyi's entropy are equivalent in the context of the maximal entropy principle. But they make a di erence from a thermodynamical point of view. The example suggests that the correct therm odynam ical de nition of tem perature requires the use of Renyi's entropy. This observation has been made before in a di erent setting [28, 33].
