# Periodic-cylinder vesicle $w$ ith $m$ in im al energy

#### Abstract

W e gìve som e details about the periodic cylindrical solution found by Zhang and Ou-Yang in $\mathbb{P}$ hys. Rev. E 53, 4206 (1996)] for the general shape equation of vesicle. Three di erent kinds of periodic cylindrical surfaces and a special closed cylindrical surface are obtained. U sing the elliptic functions contained in $m$ athem atic, we nd that this periodic shape has the $m$ in im al total energy for one period when the period-am plitude ratio $\quad$ 1:477, and point out that it is a discontinuous deform ation betw een plane and this periodic shape. O ur results also are suitable for DNA and multi-w alled carbon nanotubes (M W NTs).

## I. INTRODUCTION

Lipid bilayer m em branes have abundant shapes in aqueous environm ent. T he equilibrium shape of a vesicle is determ ined by the $m$ inim ization of the H elfrich free energy: $:^{[1]} \mathrm{F}_{\mathrm{H}}=$ R R
$\left[\frac{k_{c}}{2}\left(2 H+C_{0}\right)^{2}+k\right] d A . W$ here $H$; and $C$ o are the $m$ ean curvature, $G$ aussian curvature and spontaneous curvature, respectively, $d A$ is the surface area elem ent, and $k_{c}$ and $k$ are constants. For close shapes, we need the surface constraint and volum e constraint:
$F_{S}={ }^{H} d A$ and $F_{V}=P^{H} d V$, respectively. $H$ ere $d V$ is the volum e elem ent for the vesicle, and $P$ are constants. The total energy is $F=F_{H}+F_{S}+F_{V}$. By studying the rst variation of the totalenergy ${ }^{(1)} \mathrm{F}=0, \mathrm{O} u-y a n g$ and H elfrich obtained the general shape equation of closed $m$ em branes ${ }^{[2 ; 3]}$

where the $r^{2}$ is the LaplaceBeltram i operator. Eq.(1) is a high order nonlinear partial di erential equation. It is a hard task to solve it analytically. O nly the general solution for cylindrical vesicles has been discussed ${ }^{[4 ; 5]}$ and other special solutions including the C li ord tonus, ${ }^{[6]}$ the discounts, ${ }^{[7]}$ and the beyond $-D$ elaunay surface ${ }^{[8]}$ have been given. Since the num eric $m$ ethods, such as nite elem ent $m$ ethod using the Surface Evolyer, ${ }^{[9]}$ were used to search solutions for this equation, $m$ any interesting shapes were obtained in Refs.[10-18]. C om pared w ith those com plicate shapes obtained by num eric $m$ ethods, present know $n$ analytical solutions are only the tip of iadberg in the abundant solutions of Eq.(1). In addition, a generalized $m$ odelw ith an arbitrary energy density function $\mathrm{F}=\mathrm{F}(\mathrm{H} ;)$ was considered and the corresponding equilibrium equation was obtained. ${ }^{[19]} \mathrm{M}$ oreover, in Refs [20-22], Tu and O u-Y ang obtained the basic equations for open vesicle w ith free edges using the exterior di erential method. T hese basic equations are also com plicated and we can suppose that they also have abundant solutions.

## II. PERIOD IC-CYLINDER VESICLEW ITH M IN IM ALENERGY

In cylindrical case, Eq.(1) is reduced to an elliptical equation which was fully discussed in $R$ ef. [5]. Let a cylindrical surface along the $y$ axis and tan $(x)=\frac{d z}{d x}$, here $(x)$ is the
angle betw een the $x$ axis and the tangent to the curve at point $x$, the $m$ ean curvature and G aussian curvature of this surface are

Besides the planar solution $d=d x=0$, the shape equation is reduced to

where $g=\left(\frac{d}{d x}\right)^{2}$ and $x_{0}$ de ned by $\frac{1}{2 x_{0}^{2}}=\frac{k_{c}}{k_{c}}+\frac{C_{0}^{2}}{2}$. Here we let $x_{0}=\frac{q}{\frac{k_{c}}{k_{c} C_{0}^{2}+2}}$. Furtherm ore, elastic theory is also used to analysis the shape ofD NA chain and MWNTs. In planar case, totalenergy ofDNA ${ }^{[23]}$ andMWNT $T^{[24]}$ can be written asF $=\frac{k_{c}}{2} \quad\left(\mathbb{K} \quad C_{0}\right)^{2} d s+\quad{ }^{R}$ ds (K is the curvature of the central line ofDNA and MWNT and ds is the elem ent of arc length), which induces the sam e shape equation as Eq.(3). Zhang and $\mathrm{O} u-Y$ ang found a solution for Eq.(3)) w th the form ${ }^{[4]}$

here and $\mathrm{C}_{1}$ are constants and we choose $\mathrm{C}_{1}=0$ because it is corresponding to a rem ove along x axis. Choosing the reduced value $\mathrm{X}=\mathrm{x}=\mathrm{x}_{0}$, expression (4) can be written as

The cross section of this cylinder can be obtained by

where $Z=z=x_{0}$. Choosing di erent, we nd that this solution can give us four kinds of di erent shapes as been shown in F ig [1. H ere we only discuss the case $>0$, because we w illobtain the sim ilar results when $<0$. Valid shapes are only in the range $0 \ll 0: 462$. W hen $0: 462$, the shape w illbe self-intersected. In Fig. 2 , we give a new kind of periodic shape using Fig (c). Speci cally, when $\quad 0: 652$, the points A and B in Fig. 1 (a) will be superposed and we get a closed cylinder w ith the width-high ratio $D=\left(2 \mathrm{X}_{\mathrm{m}}\right)^{\prime} \quad 0: 328$ in Fig[1(b) . Sim ultaneously we need

where $X_{m}=2^{P} \overline{(+1)}$ and $X_{n}=2^{P} \frac{(1)}{(1)}$.
N ow , we tum to discuss the totalenergy of this solution. For sim plicity, we only consider the case $0 \ll 1$. Then, the total energy (actually the energy density along y axis) for a period is

where $F[x, y]$ and $E[x, y]$ are the elliptic integral of the rst kind and the seconde kind, respectively. We nd that ( ) has the minimum min'2:235 at r 0:256 (see Fig 3). Thus, the $m$ inim al total energy for one period is

Sense it is di cult to discuss the stability of this in nite periodic solution, we only can think that the stable shapes satisfy $\quad$ 0:256.
$T$ he reduced period $T$ is

 H ere we should note that the realperiod which can be m easured in experim ent is $T^{0}=x_{0} T$ and we have $\mathrm{T}_{\mathrm{max}}^{0}$, $1: 672 \mathrm{x}_{0}$. Further, it is interesting to know why $\mathrm{F}_{1}(\mathrm{I}$ ) and $\mathrm{T}(\mathrm{I}$ ) have the $m$ inim um and $m$ axim um when $\quad 0.256$, respectively. H ow ever, because the elliptic function is everyw here continuous but everyw here non-derivable, it is di cult to discuss this coincidence.

An im portant characteristic param eter for this periodic shape is the period-am plitude ratio, it is

W e nd that ( ) has them axim um (for not self-intersected shapes) max $2: 4 \mathrm{when}$ ! 0 (see Fig[5]), which is in accord w ith the value in Ref.[4]. Specially, when $=0.256$, we get $=1: 477$. Through $m$ easuring the shapes in $R$ ef.[26], we obtain 2 for $F i g .9, \quad 3: 3$ for Fig. 11 (a), and $2: 7$ for $F i g .11$ (b) and (c). It indicates that not all these shapes can be explained by this solution. M oreover, in $R$ ef.[26] the authors found that planar surface can gradually change into periodic cylinder. B ut in this solution, it seem s that the planar surface cannot change into periodic cylinder continuously, because planar surface means ! 1 which is out of the range $<2: 4$. C onsidering planar surface is alw ays stable scam pered $w$ ith any periodic surface, ${ }^{[27]}$ we think there is an energy barrier betw een this two kinds of surfaces. Supposing that a plane with $C_{0}$ and ${ }^{\sim}$ changes into a periodic cylinder w ith $C_{0}$ and , then the energy change betw een this deform ation can be obtained by the follow ing way.

For this periodic cylinder, the length for one period of the cross section line is

C onsider the energy density for planar surface solution is $F_{p}=\frac{\mathrm{k}_{c}}{2} \mathrm{C}_{0}^{2}+{ }^{\sim}$, the energy change

We show ( ) in Fig. 6 and nd that ( ) has a minimum $\mathrm{m}_{\mathrm{in}}{ }^{\prime}$ 1:325 at $\quad$ 0:652, which is corresponding to the closed shape in Fig. (b). Sim ply let the barrier be equal to the energy di erence, then the $m$ inim a barrier is betw een the planar and the self-intersected 8 -shape in Fig (b). C leary, in phase space, if we want that a planer drop to a periodic cylinder, we need $\mathrm{F}_{\mathrm{p}}<0$ in Eq.(16). It cannot be satis ed if $\mathrm{C}_{0}=\mathrm{C}_{0}$ and $\sim=$, because ( ) > 0.Thus, in this dow nw ard transition process, (or Co)will change.

W hen $>1$ we nd that $F_{1}()$ is monotone decreasing follow ing the increase of and $\mathrm{F}_{1}=4 \mathrm{k}_{\mathrm{c}} \mathrm{C}_{0}$ when ! 1 . A nother way, when $\mathrm{P}=0$, a circular cylinder solution w th radii R needs $\mathrm{C}_{0} \mathrm{R}=1 . .^{[28]}$ Its total energy is $\mathrm{F}={ }^{\mathrm{H}} \frac{\mathrm{k}_{\mathrm{c}}}{2}\left(1=\mathrm{R}+\mathrm{C}_{0}\right) \mathrm{ds}=4 \mathrm{k}_{\mathrm{c}} \mathrm{C}_{0}$ which is in accordance w ith the above result (note that ! 1 is corresponding to a circular cylinder ${ }^{[4]}$ ).

Rem arkably, although the shape in $F$ ig ( 1 (b) is self-intersected for 2D surface, it is useful to describe the DNA and MW NT shapes, because that any perturbations on the binorm al direction will probably lead it to be not self-intersected. A ring solution: $x=R$ sin for Eq.(3) induces

If a DNA ring changes into the shape in $F$ ig $1(b)$ and $C_{0}$ and $\sim$ change to $C_{0}$ and, respectively, we have

Eqs.(18) and (19) yield the relationship

If $C_{0}=C_{0}=0$, expression (20) indicates that the tension $w$ illincrease in this deform ation.
III. D ISC USSION AND CONCLUSION

In conclusion, we have studied the particulars about the periodic cylinder in Ref.[4] for closed shape equation of vesicle. Several characteristics for this periodic shape are obtained, which give us som e interesting details about this solution. For instance, when the periodam plitude ratio , 1:477, this periodic shape hasm inim al totalenergy for one period. W e
hope the shape w ith period-am plitude ratio $1: 477$ can be found in experim ent. As for the other periodic surface: beyond-D elaunay surface, ${ }^{[8]}$ because there isn't analytic integral function of its total energy, we don't know whether there is sim ilar result.

F inally, we point out an interesting revelation. W e know that if the energy density of an one-dim ensional structure, such as DNA ${ }^{[23]}$ and M W NT s, ${ }^{[24]}$ can be written as

the corresponding shape equation in planar case is

where $\mathrm{K}_{\mathrm{L}}=\mathrm{dK}=\mathrm{ds}$. This equation is equal to Eq .(3) (except the straight line solution $K=0)$. The shapes of DNA and MWNT in planar case satisfy this equation. Thus, the solutions of Eq.(3) have broad $m$ eaning. O $u-Y$ ang et al proved that the energy density of M W NTs can be w ritten as $F=K^{2}{ }^{[24]}$ but this $m$ odel seem $s$ not suitable for singlew alled carbon nanotubes (SW NTs), because the constant willbe zero for SW NTs. H ow ever, we note that the shape in $F$ ig 2 ofR ef.[4] and the new shape in $F$ ig 2 of this paper seem $s$ to be in good agreem ent w ith the experim entalSW N T shapes in Fig. 1 ofR ef.[25]. T hus, we suppose that the energy density of SW NTs satis es expression (21) under suitable approxim ation. W ew ill try to prove this supposition in our future work.
