# Periodic-cylinder vesicle with minim alenergy

## Abstract

We give some details about the periodic cylindrical solution found by Zhang and Ou-Yang in [Phys. Rev. E 53, 4206(1996)] for the general shape equation of vesicle. Three di erent kinds of periodic cylindrical surfaces and a special closed cylindrical surface are obtained. U sing the elliptic functions contained in m athem atic, we nd that this periodic shape has the m inim al total energy for one period when the period-am plitude ratio ' 1:477, and point out that it is a discontinuous deform ation between plane and this periodic shape. Our results also are suitable for DNA and multi-walled carbon nanotubes (MWNTs).

#### I. IN TRODUCTION

Lipid bilayerm em branes have abundant shapes in aqueous environm ent. The equilibrium shape of a vesicle is determ ined by the m inim ization of the Helfrich free energy:  $^{[L]}F_{H} = ^{R}R_{\frac{k_{c}}{2}}(2H + C_{0})^{2} + k$  JdA. W here H; and C  $_{0}$  are the m ean curvature, G aussian curvature and spontaneous curvature, respectively, dA is the surface area element, and k<sub>c</sub> and k are constants. For close shapes, we need the surface constraint and volum e constraint:

 $F_s = {}^{H} dA \text{ and } F_V = P {}^{H} dV$ , respectively. Here dV is the volume element for the vesicle, and P are constants. The total energy is  $F = F_H + F_S + F_V$ . By studying the rst variation of the total energy  ${}^{(1)}F = 0$ , Ou-yang and Helfrich obtained the general shape equation of closed mem branes<sup>[2;3]</sup>

where the r<sup>2</sup> is the Laplace-Beltram i operator. Eq.(1) is a high order nonlinear partial di erential equation. It is a hard task to solve it analytically. Only the general solution for cylindrical vesicles has been discussed<sup>[4,5]</sup> and other special solutions including the C li ord torus,<sup>[6]</sup> the discounts,<sup>[7]</sup> and the beyond-D elaunay surface<sup>[8]</sup> have been given. Since the num eric m ethods, such as nite element m ethod using the Surface Evolver,<sup>[9]</sup> were used to search solutions for this equation, m any interesting shapes were obtained in Refs.[10–18]. C on pared with those complicate shapes obtained by num eric m ethods, present known analytical solutions are only the tip of iceberg in the abundant solutions of Eq.(1). In addition, a generalized m odel with an arbitrary energy density function F = F (H; ) was considered and the corresponding equilibrium equation was obtained.<sup>[19]</sup> M oreover, in Refs.[20–22], Tu and O u-Y ang obtained the basic equations are also complicated and we can suppose that they also have abundant solutions.

# II. PERIODIC-CYLINDER VESICLE WITH MINIMALENERGY

In cylindrical case, Eq.(1) is reduced to an elliptical equation which was fully discussed in Ref.[5]. Let a cylindrical surface along the y axis and tan  $(x) = \frac{dz}{dx}$ , here (x) is the angle between the x axis and the tangent to the curve at point x, the m ean curvature and G aussian curvature of this surface are

B esides the planar solution d = dx = 0, the shape equation is reduced to

$$\frac{d^2g}{d^2} = 4 \tan \frac{dg}{d} = (1 + 2 \tan^2) g = \frac{\sec^2}{x_0^2};$$

where  $g = (\frac{d}{dx})^2$  and  $x_0$  de ned by  $\frac{1}{2x_0^2} = \frac{1}{k_c} + \frac{C_0^2}{2}$ . Here we let  $x_0 = \frac{q}{\frac{k_c}{k_c C_0^2 + 2}}$ . Furtherm ore, elastic theory is also used to analysis the shape of DNA chain and MW NTs. In planar case, total energy of DNA <sup>[23]</sup> and MW NT<sup>[24]</sup> can be written as  $F = \frac{k_c}{2}^R$  (K  $C_0$ )<sup>2</sup>ds +  $R^R$  ds (K is the curvature of the central line of DNA and MW NT and ds is the element of arc length), which induces the same shape equation as Eq.(3). Zhang and Ou-Yang found a solution for Eq.(3) with the form <sup>[4]</sup>

here and  $C_1$  are constants and we choose  $C_1 = 0$  because it is corresponding to a rem ove along x axis. Choosing the reduced value  $X = x = x_0$ , expression (4) can be written as

The cross section of this cylinder can be obtained by

where  $Z = z=x_0$ . Choosing dierent, we not that this solution can give us four kinds of dierent shapes as been shown in Fig.1. Here we only discuss the case > 0, because we will obtain the similar results when < 0. Valid shapes are only in the range 0 < < 0.462. When 0.462, the shape will be self-intersected. In Fig.2, we give a new kind of periodic shape using Fig.1 (c). Speci cally, when ' 0.652, the points A and B in Fig.1 (a) will be superposed and we get a closed cylinder with the width-high ratio  $D = (2X_m)'$  0.328 in Fig.1 (b). Simultaneously we need

where  $X_m = 2^p$  (+1) and  $X_n = 2^p$  (1).

Now, we turn to discuss the total energy of this solution. For simplicity, we only consider the case 0 < < 1. Then, the total energy (actually the energy density along y axis) for a period is

the function () is

where F[x,y] and E[x,y] are the elliptic integral of the rst kind and the seconde kind, respectively. We nd that () has the minimum  $_{min}$  ' 2:235 at ' 0:256 (see Fig.3). Thus, the minimal total energy for one period is

Sense it is di cult to discuss the stability of this in nite periodic solution, we only can think that the stable shapes satisfy ' 0.256.

The reduced period T is

$$T() = 2 \int_{X_{m}}^{Z_{X_{m}}} \tan dX = \frac{8i}{(+1)} (+1) E[;k] F[;k]: (13)$$

We show T() in Fig.4 and nd that T() has the maximum  $T_{max}$  ' 1:672 at ' 0.256. Here we should note that the real period which can be measured in experiment is  $T^0 = x_0 T$  and we have  $T_{max}^0$  ' 1:672 $x_0$ . Further, it is interesting to know why  $F_1$ () and T() have the minimum and maximum when ' 0.256, respectively. However, because the elliptic function is everywhere continuous but everywhere non-derivable, it is di cult to discuss this coincidence.

An important characteristic parameter for this periodic shape is the period-amplitude ratio, it is

We nd that () has the maximum (for not self-intersected shapes) max '2:4 when ! 0 (see Fig.5), which is in accord with the value in Ref.[4]. Specially, when = 0.256, we get = 1:477. Through m easuring the shapes in Ref. [26], we obtain 2 for Fig.9, 3:3 for Fig.11(a), and 2:7 for Fig.11 (b) and (c). It indicates that not all these shapes can be explained by this solution. M oreover, in Ref. [26] the authors found that planar surface can gradually change into periodic cylinder. But in this solution, it seems that the planar surface cannot change into periodic cylinder continuously, because planar surface m eans ! 1 which is out of the range < 2:4. Considering planar surface is always stable scampered with any periodic surface,<sup>[27]</sup> we think there is an energy barrier between this two kinds of surfaces. Supposing that a plane with C  $_0$  and  $\,\widetilde{}\,$  changes into a periodic cylinder with C  $_0$ and , then the energy change between this deform ation can be obtained by the following way.

For this periodic cylinder, the length for one period of the cross section line is

Consider the energy density for planar surface solution is  $F_p = \frac{k_c}{2}C_0^2 + \tilde{r}$ , the energy change

for a period is

We show () in Fig.6 and nd that () has a minimum  $_{min}$  ' 1:325 at ' 0:652, which is corresponding to the closed shape in Fig.1(b). Simply let the barrier be equal to the energy di erence, then the minim a barrier is between the planar and the self-intersected 8-shape in Fig.1(b). Clearly, in phase space, if we want that a planer drop to a periodic cylinder, we need F  $_{p} < 0$  in Eq.(16). It cannot be satis ed if  $C_{0} = C_{0}$  and  $\sim =$ , because () > 0. Thus, in this downward transition process, (or C  $_{0}$ ) will change.

When > 1 we nd that  $F_1()$  is monotone decreasing following the increase of and  $F_1 = 4 \ k_c C_0$  when ! 1. Another way, when P = 0, a circular cylinder solution with radii R needs  $C_0 R = 1$ .<sup>[28]</sup> Its total energy is  $F = \frac{H}{2} (1=R + C_0) ds = 4 \ k_c C_0$  which is in accordance with the above result (note that ! 1 is corresponding to a circular cylinder<sup>[4]</sup>).

Remarkably, although the shape in Fig.1(b) is self-intersected for 2D surface, it is useful to describe the DNA and MWNT shapes, because that any perturbations on the binorm al direction will probably lead it to be not self-intersected. A ring solution:  $x = R \sin for$  Eq.(3) induces

If a DNA ring changes into the shape in Fig.1(b) and  $C_0$  and  $\sim$  change to  $C_0$  and , respectively, we have

Eqs.(18) and (19) yield the relationship

If  $C_0 = C_0 = 0$ , expression (20) indicates that the tension will increase in this deform ation.

## III. DISCUSSION AND CONCLUSION

In conclusion, we have studied the particulars about the periodic cylinder in Ref.[4] for closed shape equation of vesicle. Several characteristics for this periodic shape are obtained, which give us some interesting details about this solution. For instance, when the period-am plitude ratio ' 1:477, this periodic shape has minimal total energy for one period. We

hope the shape with period-am plitude ratio ' 1:477 can be found in experiment. As for the other periodic surface: beyond-D elaunay surface,<sup>[8]</sup> because there isn't analytic integral function of its total energy, we don't know whether there is sim ilar result.

F inally, we point out an interesting revelation. We know that if the energy density of an one-dimensional structure, such as DNA  $^{[23]}$  and MWNTs,  $^{[24]}$  can be written as

$$F = \frac{1}{2}k_{c}(K - C_{0})^{2}; \qquad (21)$$

the corresponding shape equation in planar case is

$$2K + K^{3} \quad (C_{0}^{2} + 2 = k_{c})K = 0;$$

where  $K_{-} = dK = ds$ . This equation is equal to Eq.(3) (except the straight line solution K = 0). The shapes of DNA and MWNT in planar case satisfy this equation. Thus, the solutions of Eq.(3) have broad meaning. Ou-Yang et al. proved that the energy density of MWNTs can be written as  $F = K^2$ ,<sup>[24]</sup> but this model seems not suitable for single-walled carbon nanotubes (SWNTs), because the constant will be zero for SWNTs. However, we note that the shape in Fig.2 of Ref.[4] and the new shape in Fig.2 of this paper seems to be in good agreem ent with the experimental SWNT shapes in Fig.1 of Ref.[25]. Thus, we suppose that the energy density of SWNTs satis es expression (21) under suitable approximation. We will try to prove this supposition in our future work.
