# GENERALIZED ELLIPTIC FUNCTIONS AND THEIR APPLICATION TO A NONLINEAR EIGENVALUE PROBLEM WITH $p$-LAPLACIAN

#### Abstract

The Jacobian elliptic functions are generalized and applied to a nonlinear eigenvalue problem with $p$-Laplacian. The eigenvalue and the corresponding eigenfunction are represented in terms of common parameters, and a complete description of the spectra and a closed form representation of the corresponding eigenfunctions are obtained. As a by-product of the representation, it turns out that a kind of solution is also a solution of another eigenvalue problem with $p / 2$-Laplacian.


## 1. Introduction

In this paper we generalize the Jacobian elliptic functions and apply them to a nonlinear eigenvalue problem
$\left(\mathrm{PE}_{p q}\right)$

where $T, \lambda>0, p, q>1$ and $\phi_{m}(s)=|s|^{m-2} s(s \neq 0),=0(s=0)$.
Problem ( $\left(\mathrm{PE}_{p q}\right)$ appears frequently in various articles as stationary problems. In particular, the equation for $p=q=2$ is called, e.g., the Allen-Cahn equation, the Chafee-Infante equation [3], and a bistable reaction-diffusion equation with logistic effect. The equation for $p=2<q$ is said to be a bistable reaction-diffusion equation with Allee effect. In case $p=n$ and $q=2$ with an $n$-dimensional domain, an equation of this type is known as the Euler-Lagrange equation of functional related to models introduced by Ginzburg and Landau for the study of phase transitions (cf. Problem 17 in [2]).

As to (PE $\mathrm{PE}_{p q}$ ) for general $p>1$, we have to mention the work [8] by Guedda and Véron [8]. They showed that if $p=q>1$ then there exists a positive increasing sequence $\left\{\lambda_{n}\right\}$ such that a pair of solutions $\pm u_{n}$ of

[^0]( $\left.\overline{\mathrm{PE}_{p q}}\right)$ with $(n-1)$-zeros $z_{j}=j T / n(j=1,2, \ldots, n-1)$ bifurcates from the trivial solution at $\lambda=\lambda_{n}$ and $\left|u_{n}\right| \rightarrow 1$ uniformly on any compact set of $(0, T) \backslash\left\{z_{1}, z_{2}, \ldots, z_{n-1}\right\}$ as $\lambda \rightarrow \infty$. Moreover, they proved that if $p=q>2$ then for each $n \in \mathbb{N}$ there exists $\Lambda_{n}>\lambda_{n}$ such that $\lambda>\Lambda_{n}$ implies $\left|u_{n}\right|=1$ on flat cores $\left[z_{j-1}+\frac{T}{2 n}\left(\frac{\Lambda_{n}}{\lambda}\right)^{1 / p}, z_{j}-\frac{T}{2 n}\left(\frac{\Lambda_{n}}{\lambda}\right)^{1 / p}\right](j=$ $1,2, \ldots, n)$ of $u_{n}$, where $z_{0}=0$ and $z_{n}=T$. This is a great contrast to case $1<p=q \leq 2$, where $\left|u_{n}\right|<1$ in $[0, T]$. Since the equation in ( $\left.\overline{\mathrm{PE}_{p q}}\right)$ is autonomous, if $u_{n}(n \geq 2)$ has flat cores, then there exists uncountable solution with $(n-1)$-zeros near $u_{n}$, which is produced by expanding and contracting the flat cores with preserving its total length $T\left(1-\left(\frac{\Lambda_{n}}{\lambda}\right)^{1 / p}\right)$. In this sense, the $n$-th branch $\left(\lambda, u_{n}\right)$ bifurcating from $\left(\lambda_{n}, 0\right)$ causes the second bifurcation at $\left(\Lambda_{n}, u_{\Lambda_{n}}\right)$ for each $n \geq 2$.

The phenomena of flat core in [8] above was generalized to case $p>2$ and $q>1$ by the author and Yamada [11]. They also studied change in bifurcation depending on the relation between $p$ and $q$ (as far as the first bifurcation is concerned, their proof can be applied to case $1<p \leq 2$ ), and showed that for each $n \in \mathbb{N}$, if $p>q$ then there exists a pair of solutions $\pm u_{n}$ of $\left(\mathrm{PE}_{p q}\right)$ with $(n-1)$-zeros for $\lambda>0$; if $p=q$ then there exists $\lambda_{n}>0$ such that $\left(\mathrm{PE}_{p q}\right)$ has no solution with $(n-1)$ zeros for $\lambda \leq \lambda_{n}$ and ( $\overline{\left.\mathrm{PE}_{p q}\right)}$ has a pair of solutions $\pm u_{n}$ for $\lambda>\lambda_{n}$ (the same result as [8]); if $p<q$ then there exists $\lambda_{n}^{*}>0$ such that ( $\overline{\left.\mathrm{PE}_{p q}\right)}$ has no solution with $(n-1)$-zeros for $\lambda<\lambda_{n}^{*}$ and $\left(\overline{\left.\mathrm{PE}_{p q}\right)}\right.$ has a pair of solutions $\pm u_{n}$ for $\lambda=\lambda_{n}^{*}$ and $\left(\mathrm{PE}_{p q}\right)$ has two pairs of solutions $\pm u_{n}, \pm v_{n}$ satisfying $\left|u_{n}(t)\right|>\left|v_{n}(t)\right|$ with $t \neq z_{j}(j=0,1, \ldots, n)$ for $\lambda>\lambda_{n}^{*}$. In this sense, the point $\left(\lambda_{n}^{*}, u_{\lambda_{n}^{*}}\right)$ causes the spontaneous bifurcation. In any case, each solution $u_{n}$ has flat cores for sufficiently large $\lambda$.

The purpose of this paper is to obtain a complete description of the spectra and a closed form representation of the corresponding eigenfunctions of ( $\mathrm{PE}_{p q}$ ), while the studies [8] and [11] above are done in the way of phase-plane analysis and no exact solution is given there.

For the description and representation, we first recall that the Jacobian elliptic function $\operatorname{sn}(t, k)$ with modulus $k \in[0,1)$ satisfies

(e.g., Example 4 of p. 516 in the book [13] of Whittaker and Watson). Eq. (1.1) reminds that the solution of nonlinear eigenvalue problem ( $\mathrm{PE}_{p q}$ ) with $p=q=2$ can be represented explicitly by using $\operatorname{sn}(t, k)$. Indeed, for any given $k \in(0,1)$, the set of eigenvalues of $\left(\mathrm{PE}_{22}\right)$ is given
by

\lambda_{n}(k)=\left(1+k^{2}\right)\left(\frac{2 n K(k)}{T}\right)^{2} \tag{1.2}
\end{equation*}
$$

for each $n \in \mathbb{N}$, with corresponding eigenfunctions $\pm u_{n, k}$, where

$$
\begin{equation*}
u_{n, k}(t)=\sqrt{\frac{2 k^{2}}{1+k^{2}}} \operatorname{sn}\left(\frac{2 n K(k)}{T} t, k\right) \tag{1.3}
\end{equation*}
$$

and $K(k)$ is the complete elliptic integral of the first kind

$$
K(k)=\int_{0}^{1} \frac{d s}{\sqrt{\left(1-s^{2}\right)\left(1-k^{2} s^{2}\right)}}
$$

(cf. Section 2 in [1]). Conversely, all nontrivial solutions are given by Eqs. (1.2) and (1.3), and in particular, it follows from Eq. (1.3) that all solutions satisfy $|u|<1$.

In our study on ( $\overline{\mathrm{PE}_{p q}}$ ), after the fashion of $\operatorname{Jacobi's} \operatorname{sn}(t, k)$, we introduce a new transcendental function $\operatorname{sn}_{p q}(t, k)$ with modulus $k \in$ $[0,1)$. This satisfies

\begin{equation*}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\frac{q}{p^{*}} \phi_{q}(u)\left(1+k^{q}-2 k^{q}|u|^{q}\right)=0 \tag{1.4}
\end{equation*}
$$

where $p^{*}:=p /(p-1)$. Using $\mathrm{sn}_{p q}(t, k)$, we can obtain a complete description of the set of eigenvalues and the corresponding eigenfunctions of $\left(\overline{\mathrm{PE}}_{p q}\right)$ as Eqs. (1.2) and (1.3) with

K_{p q}(k)=\int_{0}^{1} \frac{d s}{\sqrt[p]{\left(1-s^{q}\right)\left(1-k^{q} s^{q}\right)}}
$$

It is important that $K_{p q}(k)$ converges to $K_{\frac{p}{2}, q}(0)$ as $k \rightarrow 1-0$ if and only if $p>2$. Indeed,

$$
\lim _{k \rightarrow 1-0} K_{p q}(k)=\int_{0}^{1} \frac{d s}{\left(1-s^{q}\right)^{\frac{2}{p}}}=K_{\frac{p}{2}, q}(0)
$$

Similarly, $\mathrm{sn}_{p q}(t, k)$ converges to $\mathrm{sn}_{\frac{p}{2}, q}(t, 0)$ as $k \rightarrow 1-0$. These convergent properties yield the existence of special solutions, not necessarily $|u|<1$, and we can really construct the solutions of $\left(\mathrm{PE}_{p q}\right)$ with flat cores. Moreover, $\mathrm{sn}_{\frac{p}{2}, q}(t, 0)$ satisfies Eq. (1.4) with $k=0$ and $p$ replaced by $p / 2$ as well as Eq. (1.4) with $k=1$. Thus, we obtain the following (curious) property: a kind of solution of $\left(\overline{\mathrm{PE}_{p q}}\right)$ is also a solution of the nonlinear eigenvalue problem with $p / 2$-Laplacian

\left(\phi_{\frac{p}{2}}\left(u^{\prime}\right)\right)^{\prime}+\lambda \phi_{q}(u)=0, \quad t \in(0, T) \\
u(0)=u(T)=0
\end{array}\right.
$$

This paper is organized as follows. In Section 2, we introduce a generalized trigonometric function $\sin _{p q}(t)$ given by Drábek and Manásevich [7] and define a new transcendental function $\mathrm{sn}_{p q}(t, k)$, which is a generalization of the Jacobian elliptic function $\operatorname{sn}(t, k)$ and an extension of $\sin _{p q}(t)$ as $\mathrm{sn}_{p q}(t, 0)=\sin _{p q}(t)$. In Section 3, we apply them to nonlinear eigenvalue problems, particularly to the problem considered in [8] and [11], and obtain complete descriptions of the set of eigenvalues and the corresponding eigenfunctions.

## 2. Transcendental Functions

2.1. Generalized trigonometric functions. Generalized trigonometric functions were introduced by Drábek and Manásevich 7] (see also [6]). For $\sigma \in[0,1]$, we define (in a slightly different way from [7])

\arcsin _{p q}(\sigma):=\int_{0}^{\sigma} \frac{d s}{\left(1-s^{q}\right)^{\frac{1}{p}}}, \tag{2.1}
\end{equation*}
$$

where $p>1, q>0$. Letting $s=z^{1 / q}$, we have

$$
\arcsin _{p q}(\sigma)=\frac{1}{q} \int_{0}^{\sigma^{q}} z^{\frac{1}{q}-1}(1-z)^{-\frac{1}{p}} d z=\frac{1}{q} \tilde{B}\left(\frac{1}{q}, \frac{1}{p^{*}}, \sigma^{q}\right),
$$

where $\tilde{B}(s, t, u)$ denotes the incomplete beta function

$$
\tilde{B}(s, t, u)=\int_{0}^{u} z^{s-1}(1-z)^{t-1} d z
$$

We define the constant $\pi_{p q}$ as

$$
\pi_{p q}:=2 \arcsin _{p q}(1)=\frac{2}{q} B\left(\frac{1}{q}, \frac{1}{p^{*}}\right),
$$

where $B(s, t)$ denotes the beta function

$$
B(s, t)=\tilde{B}(s, t, 1)=\int_{0}^{1} z^{s-1}(1-z)^{t-1} d z
$$

We have that $\arcsin _{p q}:[0,1] \rightarrow\left[0, \pi_{p q} / 2\right]$, and is strictly increasing. Let us denote its inverse by $\sin _{p q}$. Then, $\sin _{p q}:\left[0, \pi_{p q} / 2\right] \rightarrow[0,1]$ and is strictly increasing. We extend $\sin _{p q}$ to all $\mathbb{R}$ (and still denote this extension by $\sin _{p q}$ ) in the following form: for $t \in\left[\pi_{p q} / 2, \pi_{p q}\right]$, we set $\sin _{p q}(t):=\sin _{p q}\left(\pi_{p q}-t\right)$, then for $t \in\left[-\pi_{p q}, 0\right]$, we define $\sin _{p q}(t):=$ $-\sin _{p q}(-t)$, and finally we extend $\sin _{p q}$ to all $\mathbb{R}$ as a $2 \pi_{p q}$ periodic function.

When $0<p \leq 1$, we also define $\arcsin _{p q}$ as Eq. (2.1) for $\sigma \in[0,1)$. We have that $\arcsin _{p q}:[0,1) \rightarrow[0, \infty)$, and is strictly increasing. Let us denote its inverse by $\sin _{p q}$. Then, $\sin _{p q}:[0, \infty) \rightarrow[0,1)$ and is
strictly increasing. We extend $\sin _{p q}$ to all $\mathbb{R}$ as $\sin _{p q}(t):=-\sin _{p q}(-t)$ for $t \in(-\infty, 0]$ and still denote this extension by $\sin _{p q}$.

Remark 2.1. We immediately find that $\sin _{22}(t)=\sin (t)$ and $\pi_{22}=\pi$ from the properties of the beta function. Moreover, $\sin _{p p}(t)=\sin _{p}(t)$ and $\pi_{p p}=\pi_{p}=\frac{2 \pi}{p \sin \frac{\pi}{p}}$, where $\sin _{p}$ and $\pi_{p}$ are the generalized sine function and its half-period, respectively, appearing in 4], [5] and [6].

We define for $t \in\left[0, \pi_{p q} / 2\right]$ (in case $0<p \leq 1$, for $t \in[0, \infty)$ )

$$
\cos _{p q}(t):=\left(1-\sin _{p q}^{q}(t)\right)^{\frac{1}{p}},
$$

then we obtain

$$
\begin{aligned}
& \cos _{p q}^{p}(t)+\sin _{p q}^{q}(t)=1 \\
& \frac{d}{d t} \sin _{p q}(t)=\cos _{p q}(t)
\end{aligned}
$$

Proposition 2.1. For $p, q>1$, $\sin _{p q}$ satisfies for all $\mathbb{R}$

$$
\begin{equation*}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\frac{q}{p^{*}} \phi_{q}(u)=0 . \tag{2.2}
\end{equation*}
$$

Proof. For $t \in\left(0, \pi_{p q} / 2\right)$ we have

$$
\begin{aligned}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime} & =\left(\phi_{p}\left(\cos _{p q}(t)\right)\right)^{\prime} \\
& =\left(\left(1-\sin _{p q}^{q}(t)\right)^{\frac{1}{p^{*}}}\right)^{\prime} \\
& =\frac{1}{p^{*}}\left(1-\sin _{p q}^{q}(t)\right)^{-\frac{1}{p}} \cdot\left(-q \sin _{p q}^{q-1}(t)\right) \cdot \cos _{p q}(t) \\
& =-\frac{q}{p^{*}} \phi_{q}(u) .
\end{aligned}
$$

By symmetry of $\sin _{p q}$, Eq. (2.2) holds true for $t \neq t_{n}:=n \pi_{p q} / 2, n \in \mathbb{Z}$. Since $\lim _{t \rightarrow t_{n}}\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}$ exists, $\phi_{p}\left(u^{\prime}\right)$ is differentiable also at $t=t_{n}$ and satisfies Eq. (2.2) for all $\mathbb{R}$ in the classical sense.
2.2. Generalized Jacobian elliptic functions. We shall introduce new transcendental functions, which generalize the Jacobian elliptic functions. For $\sigma \in[0,1]$ and $k \in[0,1)$, we define

\operatorname{arcsn}_{p q}(\sigma)=\operatorname{arcsn}_{p q}(\sigma, k):=\int_{0}^{\sigma} \frac{d s}{\sqrt[p]{\left(1-s^{q}\right)\left(1-k^{q} S^{q}\right)}} \tag{2.3}
\end{equation*}
$$

where $p>1, q>0$. We define the constant $K_{p q}(k)$ as

$$
K_{p q}=K_{p q}(k):=\operatorname{arcsn}_{p q}(1, k)=\int_{0}^{1} \frac{d s}{\sqrt[p]{\left(1-s^{q}\right)\left(1-k^{q} s^{q}\right)}}
$$

We have that $\operatorname{arcsn}_{p q}:[0,1] \rightarrow\left[0, K_{p q}\right]$, and is strictly increasing. Let us denote its inverse by $\mathrm{sn}_{p q}(\cdot)=\mathrm{sn}_{p q}(\cdot, k)$. Then, $\mathrm{sn}_{p q}:\left[0, K_{p q}\right] \rightarrow$ $[0,1]$ and is strictly increasing. We extend $\mathrm{sn}_{p q}$ to all $\mathbb{R}$ (and still denote this extension by $\mathrm{sn}_{p q}$ ) in the following form: for $t \in\left[K_{p q}, 2 K_{p q}\right]$, we set $\mathrm{sn}_{p q}(t):=\operatorname{sn}_{p q}\left(2 K_{p q}-t\right)$, then for $t \in\left[-2 K_{p q}, 0\right]$, we define $\mathrm{sn}_{p q}(t):=-\mathrm{sn}_{p q}(-t)$, and finally we extend $\mathrm{sn}_{p q}$ to all $\mathbb{R}$ as a $4 K_{p q}$ periodic function.

When $0<p \leq 1$, we also define $\operatorname{arcsn}_{p q}$ as Eq. (2.3) for $\sigma \in[0,1)$. We have that $\operatorname{arcsn}_{p q}:[0,1) \rightarrow[0, \infty)$, and is strictly increasing. Let us denotes its inverse by $\mathrm{sn}_{p q}(\cdot)=\mathrm{sn}_{p q}(\cdot, k)$. Then, $\mathrm{sn}_{p q}:[0, \infty) \rightarrow$ $[0,1)$ and is strictly increasing. We extend $\mathrm{sn}_{p q}$ to all $\mathbb{R}$ as $\mathrm{sn}_{p q}(t):=$ $-\mathrm{sn}_{p q}(-t)$ for $t \in(-\infty, 0]$ and still denote this extension by $\mathrm{sn}_{p q}$.

The following proposition is crucial to our study.
Proposition 2.2. For $p, q>0, K_{p q}$ is continuous and strictly increasing in $[0,1), 2 K_{p q}(0)=\pi_{p q}$ and $\operatorname{sn}_{p q}(t, 0)=\sin _{p q}(t)$. Moreover,

$$
\begin{aligned}
& \lim _{k \rightarrow 1-0} 2 K_{p q}(k)= \begin{cases}\pi_{\frac{p}{2}, q} & \text { if } p>2 \\
\infty & \text { if } 0<p \leq 2,\end{cases} \\
& \lim _{k \rightarrow 1-0} \operatorname{sn}_{p q}(t, k)=\sin _{\frac{p}{2}, q}(t)
\end{aligned}
$$

Proof. The first half is trivial from the definitions of $K_{p q}$ and $\mathrm{sn}_{p q}$. If $p>2$, then the monotone convergence theorem of Beppo Levi gives

$$
\lim _{k \rightarrow 1-0} 2 K_{p q}(k)=2 \int_{0}^{1} \frac{d s}{\left(1-s^{q}\right)^{\frac{2}{p}}}=2 \arcsin _{\frac{p}{2}, q}(1)=\pi_{\frac{p}{2}, q} .
$$

If $0<p \leq 2$, then $2 K_{p q}(k)$ diverges to $\infty$ as $k \rightarrow 1-0$ by Fatou's lemma.

The last property is proved as follows. By the symmetry of $\mathrm{sn}_{p q}(\cdot, k)$, we may assume $t>0$. Suppose $p>2$ and that there exist $t_{0}, \varepsilon>0$ and $\left\{k_{j}\right\}$ such that $k_{j} \rightarrow 1$ as $j \rightarrow \infty$ and

$$
\begin{equation*}
\left|\sigma_{k_{j}}-\sin _{\frac{p}{2}, q}\left(t_{0}\right)\right| \geq \varepsilon \tag{2.4}
\end{equation*}
$$

where $\sigma_{k_{j}}=\operatorname{sn}_{p q}\left(t_{0}, k_{j}\right)$. Let $n \in \mathbb{Z}$ be the number satisfying $t_{0} \in$ $I_{n}:=\left[n \pi_{\frac{p}{2}, q} / 2,(n+1) \pi_{\frac{p}{2}, q} / 2\right)$ and $j \in \mathbb{N}$ a large number satisfying $t_{0} \in$ $I_{n}\left(k_{j}\right):=\left[n K_{p q}\left(k_{j}\right),(n+1) K_{p q}\left(k_{j}\right)\right)$. We write $\operatorname{sn}_{p q}^{(n)}\left(\cdot, k_{j}\right)$ as $\mathrm{sn}_{p q}\left(\cdot, k_{j}\right)$ on $I_{n}\left(k_{j}\right)$ and $\sin _{p q}^{(n)}(\cdot)$ as $\sin _{p q}(\cdot)$ on $I_{n}$. Now, since $\sigma_{k_{j}}$ is bounded, we can choose a subsequence $\left\{k_{j^{\prime}}\right\}$ of $\left\{k_{j}\right\}$ such that $\sigma_{k_{j^{\prime}}} \rightarrow \sigma$ for some $\sigma \in[-1,1]$ as $j^{\prime} \rightarrow \infty$. Thus, as $j^{\prime} \rightarrow \infty$

$$
t_{0}=n K_{p q}\left(k_{j^{\prime}}\right)+\operatorname{arcsn}_{p q}\left(\sigma_{k_{j^{\prime}}}\right) \rightarrow \frac{n \pi \frac{p}{2}, q}{2}+\arcsin _{\frac{p}{2}, q}(\sigma),
$$

and hence $\sigma=\sin _{\frac{p}{2}, q}^{(n)}\left(t_{0}\right)$, which contradicts (2.4). The proof to case $0<p \leq 2$ is similar and we omit it.

Remark 2.2. In case $p>2,2 K_{p q}(k)$ and $\mathrm{sn}_{p q}(\cdot, k)$ converge to the finite value $\pi_{\frac{p}{2}, q}$ and to the finite-periodic function $\sin _{\frac{p}{2}, q}$ as $k \rightarrow 1-0$, respectively. This is quite different from case $p=2$, where $2 K_{2 q}(k)$ diverges to $\infty$ and $\mathrm{sn}_{22}(t, k)$ converges to the monotone increasing function $\sin _{12}(t)=\tanh (t)$ as $k \rightarrow 1-0$.

We define for $t \in\left[0, K_{p q}\right]$ (in case $0<p \leq 1$, for $t \in[0, \infty)$ )

$$
\begin{aligned}
\mathrm{cn}_{p q}(t) & :=\left(1-\mathrm{sn}_{p q}^{q}(t)\right)^{\frac{1}{p}} \\
\operatorname{dn}_{p q}(t) & :=\left(1-k^{q} \mathrm{sn}_{p q}^{q}(t)\right)^{\frac{1}{p}}
\end{aligned}
$$

then we obtain

$$
\begin{aligned}
& \mathrm{cn}_{p q}^{p}(t)+\mathrm{sn}_{p q}^{q}(t)=1, \\
& \frac{d}{d t} \mathrm{sn}_{p q}(t)=\mathrm{cn}_{p q}(t) \mathrm{dn}_{p q}(t)
\end{aligned}
$$

Proposition 2.3. For $p, q>1, \mathrm{sn}_{p q}$ satisfies for all $\mathbb{R}$

$$
\begin{equation*}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\frac{q}{p^{*}} \phi_{q}(u)\left(1+k^{q}-2 k^{q}|u|^{q}\right)=0 \tag{2.5}
\end{equation*}
$$

which includes Eq.(2.2) as case $k=0$.
Proof. For $t \in\left(0, K_{p q}(k)\right)$ we have

$$
\begin{aligned}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}= & \left(\phi_{p}\left(\mathrm{cn}_{p q}(t) \mathrm{dn}_{p q}(t)\right)\right)^{\prime} \\
= & \left(\left(\left(1-\sin _{p q}^{q}(t)\right)\left(1-k^{q} \sin _{p q}^{q}(t)\right)\right)^{\frac{1}{p^{*}}}\right)^{\prime} \\
= & \frac{1}{p^{*}}\left(\left(1-\sin _{p q}^{q}(t)\right)\left(1-k^{q} \sin _{p q}^{q}(t)\right)\right)^{-\frac{1}{p}} \\
& \quad \times\left(-q \sin _{p q}^{q-1}(t) \cdot\left(1+k^{q}-2 k^{q} \sin _{p q}^{q}(t)\right)\right) \cdot \mathrm{cn}_{p q}(t) \mathrm{dn}_{p q}(t) \\
= & -\frac{q}{p^{*}} \phi_{q}(u)\left(1+k^{q}-2 k^{q} u^{q}\right) .
\end{aligned}
$$

By symmetry of $\mathrm{sn}_{p q}$, Eq. (2.5) holds true for $t \neq t_{n}:=n K_{p q}(k), n \in \mathbb{Z}$. Since $\lim _{t \rightarrow t_{n}}\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}$ exists, $\phi_{p}\left(u^{\prime}\right)$ is differentiable also at $t=t_{n}$ and satisfies Eq. (2.5) for all $\mathbb{R}$ in the classical sense.

Remark 2.3. Letting $s=\sin _{p q}(t)$ in Eq. (2.3), we have

$$
\operatorname{arcsn}_{p q}(\sigma, k)=\int_{0}^{\arcsin _{p q}(\sigma)} \frac{d t}{\sqrt[p]{1-k^{q} \sin _{p q}^{q}(t)}}
$$

We define the amplitude function $\operatorname{am}_{p q}(\cdot, k):\left[0, K_{p q}(k)\right] \rightarrow\left[0, \pi_{p q} / 2\right]$ by

$$
t=\int_{0}^{\operatorname{am}_{p q}(t, k)} \frac{d \theta}{\sqrt[p]{1-k^{q} \sin _{p q}^{q}(\theta)}}
$$

thus $\mathrm{sn}_{p q}$ is represented by $\sin _{p q}$ as

$$
\mathrm{sn}_{p q}(t, k)=\sin _{p q}\left(\operatorname{am}_{p q}(t, k)\right) .
$$

## 3. Applications

3.1. The $(p, q)$-eigenvalue problem. Let $T, \lambda>0$ and $p, q>1$. We consider the nonlinear eigenvalue problem
$\left(\mathrm{E}_{p q}\right) \quad\left\{\begin{array}{l}\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\lambda \phi_{q}(u)=0, \quad t \in(0, T), \\ u(0)=u(T)=0 .\end{array}\right.$
Problem ( $\mathrm{E}_{p q}$ has been studied by many authors. In particular, in paper [10] of Otani, the existence of infinitely many multi-node solutions was proved by using subdifferential operators method and phase-plane analysis combined with symmetry properties of the solutions. After that, Drábek and Manásevich [7] provided explicit forms of the whole spectrum and the corresponding eigenfunctions for $\left(\mathrm{E}_{p q}\right)$ (see also [6]). We follow [7] to understand completely the set of all solutions of ( $\mathrm{E}_{p q}$ ).

It will be convenient to find first the solution to the initial value problem

$$
\left\{\begin{array}{l}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\lambda \phi_{q}(u)=0,  \tag{3.1}\\
u(0)=0, u^{\prime}(0)=\alpha,
\end{array}\right.
$$

where without loss of generality we may assume $\alpha>0$.
Let $u$ be a solution to Eq. (3.1) and let $t(\alpha)$ be the first zero point of $u^{\prime}(t)$. On interval $(0, t(\alpha)), u$ satisfies $u(t)>0$ and $u^{\prime}(t)>0$, and thus

$$
\frac{u^{\prime}(t)^{p}}{p^{*}}+\lambda \frac{u(t)^{q}}{q}=\lambda \frac{R^{q}}{q}=\frac{\alpha^{p}}{p^{*}},
$$

where $R=u(t(\alpha))>0$. Solving for $u^{\prime}$ and integrating, we find

$$
\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \int_{0}^{t} \frac{u^{\prime}(s)}{\left(R^{q}-u(s)^{q}\right)^{\frac{1}{p}}} d s=t
$$

which after a change of variable can be written as

$$
t=\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \frac{1}{R^{\frac{q}{p}-1}} \int_{0}^{\frac{u(t)}{R}} \frac{d s}{\left(1-s^{q}\right)^{\frac{1}{p}}}=\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \frac{1}{R^{\frac{q}{p}-1}} \arcsin _{p q}\left(\frac{u(t)}{R}\right)
$$

Thus we obtain the solution to Eq. (3.1) can be written as

$$
\begin{equation*}
u(t)=R \sin _{p q}\left(\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}} R^{q}-1\right) \tag{3.2}
\end{equation*}
$$

where $R=\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{q}} \alpha^{\frac{p}{q}}$.
Theorem 3.1. All nontrivial solutions of $\left(\overline{\mathrm{E}_{p q}}\right)$ are given as follows. For any given $R>0$, the set of eigenvalues of $\left(\mathrm{E}_{p q}\right)$ is given by

$$
\begin{equation*}
\lambda_{n}(R)=\frac{q}{p^{*}}\left(\frac{n \pi_{p q}}{T}\right)^{p} R^{p-q} \tag{3.3}
\end{equation*}
$$

for each $n \in \mathbb{N}$, with corresponding eigenfunctions $\pm u_{n, R}$, where

$$
\begin{equation*}
u_{n, R}(t)=R \sin _{p q}\left(\frac{n \pi_{p q}}{T} t\right) \tag{3.4}
\end{equation*}
$$

Proof. For given $R>0$, by imposing that $u$ in Eq. (3.2) satisfies the boundary conditions in $\left(\mathrm{E}_{p q}\right)$, we obtain that $\lambda$ is an eigenvalue of $\left(\mathrm{E}_{p q}\right)$ if and only if

$$
\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}} R^{\frac{q}{p}-1} T=n \pi_{p q}, \quad n \in \mathbb{N}
$$

and hence Eq. (3.3) follows. Expression (3.4) for the eigenfunctions follows directly from Eq. (3.2).
3.2. A perturbed $(p, q)$-eigenvalue problem. Let $T, \lambda>0$ and $p, q>1$. We consider the nonlinear eigenvalue problem
$\left(\mathrm{PE}_{p q}\right)$

$$
\left\{\begin{array}{l}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\lambda \phi_{q}(u)\left(1-|u|^{q}\right)=0, \quad t \in(0, T) \\
u(0)=u(T)=0
\end{array}\right.
$$

Problem ( $\left.\overline{\mathrm{PE}_{p q}}\right)$ has been studied by Berger and Fraenkel [1] and Chafee and Infante [3] $(p=q=2)$, Wang and Kazarinoff [12] and Korman, Li and Ouyang [9] $(p=2<q)$, Guedda and Véron [8] $(p=q>1)$, and Takeuchi and Yamada [11 $(p>2, q>1)$. However, there is no study providing explicit forms of the whole spectrum and the corresponding eigenfunctions for ( $\mathrm{PE}_{p q}$ ).

As we have done for $\left(\overline{\mathrm{E}_{p q}}\right)$, it will be convenient to find first the solution to the initial value problem

$$
\left\{\begin{array}{l}
\left(\phi_{p}\left(u^{\prime}\right)\right)^{\prime}+\lambda \phi_{q}(u)\left(1-|u|^{q}\right)=0  \tag{3.5}\\
u(0)=0, u^{\prime}(0)=\alpha
\end{array}\right.
$$

where without loss of generality we may assume $\alpha>0$.

Let $u$ be a solution to Eq. (3.5) and let $t(\alpha)$ be the first zero point of $u^{\prime}(t)$. On interval $(0, t(\alpha)), u$ satisfies $u(t)>0$ and $u^{\prime}(t)>0$, and thus

$$
\frac{u^{\prime}(t)^{p}}{p^{*}}+\lambda \frac{F(u)}{q}=\lambda \frac{F(R)}{q}=\frac{\alpha^{p}}{p^{*}},
$$

where $F(s)=s^{q}-\frac{1}{2} s^{2 q}$ and $R=u(t(\alpha))$. Since we are interested in functions satisfying the boundary condition of $\left(\overline{\mathrm{PE}} \mathrm{pq}_{q}\right)$, it suffices to assume $0<R \leq 1$, which means $|u| \leq 1$. Moreover, we restrict to $0<R<1$ and concentrate solutions satisfying $|u|<1$ for a while.

Solving for $u^{\prime}$ and integrating, we find

$$
\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \int_{0}^{t} \frac{u^{\prime}(s)}{\sqrt[p]{F(R)-F(u(s))}} d s=t
$$

which after a change of variable can be written as

$$
\begin{equation*}
t=\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \int_{0}^{\frac{u(t)}{R}} \frac{R}{\sqrt[p]{F(R)-F(R s)}} d s \tag{3.6}
\end{equation*}
$$

It is easy to verify that

$$
F(R)-F(R s)=F(R)\left(1-s^{q}\right)\left(1-\frac{R^{q}}{2-R^{q}} s^{q}\right),
$$

and hence

$$
\begin{aligned}
t & =\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \frac{R}{F(R)^{\frac{1}{p}}} \int_{0}^{\frac{u(t)}{R}} \frac{d s}{\sqrt[p]{\left(1-s^{q}\right)\left(1-k^{q} s^{q}\right)}} \quad\left(k^{q}:=\frac{R^{q}}{2-R^{q}}\right) \\
& =\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{p}} \frac{R}{F(R)^{\frac{1}{p}}} \operatorname{arcsn}_{p q}\left(\frac{u(t)}{R}, k\right) .
\end{aligned}
$$

Then we obtain that the solution to Eq. (3.5) can be written as

$$
\begin{equation*}
u(t)=R \operatorname{sn}_{p q}\left(\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}} \frac{F(R)^{\frac{1}{p}}}{R} t, k\right) \tag{3.7}
\end{equation*}
$$

where

$$
\begin{align*}
k & =\left(\frac{R^{q}}{2-R^{q}}\right)^{\frac{1}{q}}  \tag{3.8}\\
R & =\left(\frac{q}{\lambda p^{*}}\right)^{\frac{1}{q}} \alpha^{\frac{p}{q}}\left(\frac{1}{2}+\frac{1}{2} \sqrt{1-\frac{2 q}{\lambda p^{*}} \alpha^{p}}\right)^{-\frac{1}{q}} .
\end{align*}
$$

We first observe the structure of the set of all nontrivial solutions of ( $\left.\overline{\mathrm{PE}_{p q}}\right)$ satisfying $|u|<1$.

Theorem $3.2(|u|<1)$. All nontrivial solutions for $p \in(1,2]$ and all nontrivial solutions with $|u|<1$ for $p>2$ are given as follows. For any given $k \in(0,1)$, the set of eigenvalues of $\left(\mathrm{PE}_{p q}\right)$ is given by

$$
\begin{equation*}
\lambda_{n}(k)=\frac{q}{p^{*}}\left(1+k^{q}\right)\left(\frac{2 k^{q}}{1+k^{q}}\right)^{\frac{p}{q}-1}\left(\frac{2 n K_{p q}(k)}{T}\right)^{p} \tag{3.9}
\end{equation*}
$$

for each $n \in \mathbb{N}$, with corresponding eigenfunctions $\pm u_{n, k}$, where

$$
\begin{equation*}
u_{n, k}(t)=\left(\frac{2 k^{q}}{1+k^{q}}\right)^{\frac{1}{q}} \operatorname{sn}_{p q}\left(\frac{2 n K_{p q}(k)}{T} t, k\right) \tag{3.10}
\end{equation*}
$$

Proof. For $k \in(0,1)$ given, we impose that Function (3.7) with $R \in$ $(0,1)$ decided from Eq. (3.8) satisfies the boundary conditions in ( $\left.\overline{\mathrm{PE}_{p q}}\right)$. Then, we obtain that $\lambda$ is an eigenvalue of $\left(\overline{\mathrm{PE}_{p q}}\right)$ if and only if

$$
\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}} \frac{F(R)^{\frac{1}{p}}}{R} T=2 n K_{p q}(k), \quad n \in \mathbb{N}
$$

From Eq. (3.8) again we have

$$
\frac{F(R)^{\frac{1}{p}}}{R}=\left(\frac{2 k^{q}}{1+k^{q}}\right)^{\frac{1}{p}-\frac{1}{q}}\left(1+k^{q}\right)^{-\frac{1}{p}}
$$

and hence we obtain Eq. (3.9) . Expression (3.10) for the eigenfunctions follows then directly from Eq. (3.7).

It remains to show that no other nontrivial solution of $\left(\overline{\mathrm{PE}_{p q}}\right)$ is obtained when $1<p \leq 2$. Assume the contrary. Then there exist $t_{*}>0$ and a nontrivial solution $u$ of $\left(\overline{\left.\mathrm{PE}_{p q}\right)}\right.$ with $R=u\left(t_{*}\right)=1$. However, the right-hand side of Eq. (3.6) with $t=t_{*}$ diverges because $\sqrt[p]{F(1)-F(s)}=O\left(\left(1-s^{q}\right)^{\frac{2}{p}}\right)$ as $s \rightarrow 1-0$. Thus, $t_{*}=\infty$, which is a contradiction.

Next we find solutions of $\left(\overline{\mathrm{PE}_{p q}}\right)$ with $|u| \leq 1$, except the solutions given by Theorem 3.2, From Proposition 2.2, one of solutions of Eq. (3.5) is obtained by $k \rightarrow 1-0$ in Eq. (3.7) with Eq. (3.8), namely

$$
u(t)=\sin _{\frac{p}{2}, q}\left(\left(\frac{\lambda p^{*}}{2 q}\right)^{\frac{1}{p}} t\right) .
$$

Now we assume $p>2$ and take a number $t_{*}$ as $\left(\frac{\lambda p^{*}}{2 q}\right)^{\frac{1}{p}} t_{*}=\pi_{\frac{p}{2}, q} / 2$, then $u$ attains 1 at $t=t_{*}$ (note that it is impossible to obtain such a solution when $1<p \leq 2$ ). Using this $u$, we can make the other solutions of Eq. (3.5) as follows. In the phase-plane, the orbit $\left(u(t), u^{\prime}(t)\right)$ arrives at the equilibrium point $(1,0)$ at $t=t_{*}$ and can stay there for any finite time $\tau$ before it begins to leave there. Then, the interval $\left[t_{*}, t_{*}+\tau\right]$ is a
flat core of the solution. Similarly, there is the other equilibrium point $(-1,0)$, where the orbit can stay, and the solution has another flat core of any finite length. Thus we have solutions of Eq. (3.5) attaining $\pm 1$ with any number of flat cores.

Theorem $3.3(|u| \leq 1)$. Let $p>2$, then all nontrivial solutions are given as follows, in addition to Theorem 3.2. For any given $\tau \in[0, T)$, the set of eigenvalues of $\left(\mathrm{PE}_{p q}\right)$ is given by

$$
\Lambda_{n}(\tau)=\frac{2 q}{p^{*}}\left(\frac{n \pi \frac{p}{2}, q}{T-\tau}\right)^{p}
$$

for each $n \in \mathbb{N}$, with corresponding eigenfunctions $\pm u_{n,\left\{\tau_{i}\right\}}$, where $u_{n,\left\{\tau_{i}\right\}}$ is any function given as follows: for any $\left\{\tau_{i}\right\}_{i=1}^{n}$ with $\tau_{i} \geq 0$ and $\sum_{i=1}^{n} \tau_{i}=\tau$
$u_{n,\left\{\tau_{i}\right\}}(t)= \begin{cases}(-1)^{j-1} \sin \frac{p}{2}, q \\ (-1)^{j-1}\left(\frac{n \pi_{2}, q}{T-\tau}\left(t-T_{j-1}\right)\right) & \text { if } T_{j-1} \leq t \leq T_{j-1}+\frac{T-\tau}{2 n}, \\ (-1)^{j-1} \sin \frac{p}{2}, q \\ \left.j=1 \frac{n \pi_{\frac{p}{2}, q}}{T-\tau}\left(T_{j}-t\right)\right) & \text { if } T_{j-1}+\frac{T-\tau}{2 n} \leq t \leq T_{j}-\frac{T-\tau}{2 n}, \\ j=2, \ldots, n, & \text { if } T_{j}-\frac{T-\tau}{2 n} \leq t \leq T_{j},\end{cases}$
where $T_{0}=0$ and $T_{j}=\frac{(T-\tau) j}{n}+\sum_{i=1}^{j} \tau_{i}$ for $j=1,2, \ldots, n$.
Proof. For each $n \in \mathbb{N}$, it suffices to construct solutions with ( $n-1$ )zeros. Let $\tau \in[0, T)$. They are all generated by the eigenvalue and the corresponding eigenfunction of $\left(\mathrm{PE}_{p q}\right)$ with $T$ replaced by $T-\tau$

$$
\begin{aligned}
& \Lambda_{n}(\tau)=\frac{2 q}{p^{*}}\left(\frac{n \pi \frac{p}{2}, q}{T-\tau}\right)^{p}, \\
& u_{n, \tau}(t)=\sin _{\frac{p}{2}, q}\left(\frac{n \pi \frac{p}{2}, q}{T-\tau} t\right),
\end{aligned}
$$

which are obtained from Eqs. (3.9) and (3.10) with $k \rightarrow 1-0$, respectively. In the phase-plane, the orbit $\left(u_{n, \tau}(t), u_{n, \tau}^{\prime}(t)\right)$ goes through the equilibrium points $( \pm 1,0)$ in $n$-times without staying there as $t$ increases from 0 to $T-\tau$. Therefore, if the orbit stays the $i$-th equilibrium point for time $\tau_{i}$, where $\tau_{1}+\tau_{2}+\cdots+\tau_{n}=\tau$, then we can obtain Solution (3.11) with $n$-flat cores in $[0, T]$.

In Theorems 3.2 and 3.3, we give parameters $k$ and $\tau$ to obtain the eigenvalue and the corresponding eigenfunction of ( $\left.\overline{\mathrm{PE}_{p q}}\right)$. Conversely, giving any $\lambda>0$, we can observe the set $S_{\lambda}$ of all solutions of ( $\mathrm{PE}_{p q}$ ) by considering the inverses of $\lambda_{n}$ and $\Lambda_{n}$.

Theorem 3.4. Let $p>1$ and $q>1$.
Case $p>q$. For any $\lambda>0$ there exists a strictly decreasing positive sequence $\left\{k_{j}\right\}_{j=1}^{\infty}$ such that $k_{j} \rightarrow 0$ as $j \rightarrow \infty$ and

$$
S_{\lambda}=\{0\} \cup \bigcup_{j=1}^{\infty}\left\{ \pm u_{j, k_{j}}\right\} .
$$

Case $p=q$. If

$$
0<\lambda \leq \frac{q}{p^{*}}\left(\frac{\pi_{p q}}{T}\right)^{p},
$$

then $S_{\lambda}=\{0\}$. If

$$
\frac{q}{p^{*}}\left(\frac{n \pi_{p q}}{T}\right)^{p}<\lambda \leq \frac{q}{p^{*}}\left(\frac{(n+1) \pi_{p q}}{T}\right)^{p}, \quad n \in \mathbb{N}
$$

then there exists a strictly decreasing positive sequence $\left\{k_{j}\right\}_{j=1}^{n}$ such that

$$
S_{\lambda}=\{0\} \cup \bigcup_{j=1}^{n}\left\{ \pm u_{j, k_{j}}\right\}
$$

Case $p<q$. There exists $\lambda_{1}>0$ such that if $0<\lambda<\lambda_{1}$, then $S_{\lambda}=\{0\}$. If $n^{p} \lambda_{1} \leq \lambda<(n+1)^{p} \lambda_{1}, n \in \mathbb{N}$, then there exist a strictly decreasing positive sequence $\left\{k_{j}\right\}_{j=1}^{n}$ and a strictly increasing positive sequence $\left\{\ell_{j}\right\}_{j=1}^{n}$ such that $k_{j}>\ell_{j}, j=1,2, \ldots, n-1$ and

$$
S_{\lambda}=\{0\} \cup \bigcup_{j=1}^{n}\left\{ \pm u_{j, k_{j}}\right\} \cup \bigcup_{j=1}^{n}\left\{ \pm u_{j, \ell_{j}}\right\}
$$

where $u_{n, k_{n}}=u_{n, \ell_{n}}$ with $k_{n}=\ell_{n}$ for $\lambda=n^{p} \lambda_{1}$ and $\left|u_{n, k_{n}}\right|>\left|u_{n, \ell_{n}}\right|(t \neq$ $j T / n, j=1,2, \ldots, n-1)$ with $k_{n}>\ell_{n}$ otherwise.

In any case, each $k_{j}$, $\ell_{j}$ is calculated by Eq.(3.9) for $\lambda_{j}$, and the corresponding solution is given in Form (3.10).

When $1<p \leq 2$, we have $k_{j}<1$. When $p>2$, in addition, if

$$
\lambda \geq \frac{2 q}{p^{*}}\left(\frac{m \pi_{\frac{p}{2}, q}}{T}\right)^{p}, \quad m \in \mathbb{N}
$$

then for each $j=1,2, \ldots, m$, the set $\left\{ \pm u_{j, k_{j}}\right\}$ above is replaced by $\cup_{\left\{\tau_{i}\right\}}\left\{ \pm u_{j,\left\{\tau_{i}\right\}}\right\}$, where $\cup_{\left\{\tau_{i}\right\}}$ is the union for all $\left\{\tau_{i}\right\}_{i=1}^{j}$ satisfying $\tau_{i} \geq 0$ and

$$
\sum_{i=1}^{j} \tau_{i}=T-j \pi_{\frac{p}{2}, q}\left(\frac{2 q}{\lambda p^{*}}\right)^{\frac{1}{p}}
$$

The nontrivial solution $u_{j,\left\{\tau_{i}\right\}}$ is given in Form (3.11).

Proof. First we assume $1<p \leq 2$. In this case, we have already known that all nontrivial solutions of $\left(\frac{\left.\mathrm{PE}_{p q}\right)}{}\right)$ are obtained by Theorem 3.2.

Now we fix $\lambda>0$. We obtain that $\lambda$ is the $j$-th eigenvalue of ( $\mathrm{PE}_{p q}$ ) if and only if from Eq. (3.9) there exists $k \in(0,1)$ such that

$$
\begin{equation*}
\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}=\left(1+k^{q}\right)^{\frac{1}{p}}\left(\frac{2 k^{q}}{1+k^{q}}\right)^{\frac{1}{q}-\frac{1}{p}} K_{p q}(k)=: \Phi(k) . \tag{3.12}
\end{equation*}
$$

Case $p>q . \Phi(k)$ is strictly increasing in $(0,1)$ and it follows from Proposition 2.2 that $\Phi(0)=0$ and $\lim _{k \rightarrow 1-0} \Phi(k)=\infty$. Thus, there exists a unique $k=k_{j}(\lambda)$ satisfying Eq. (3.12). For $j$ and $k_{j}$, a unique solution $u_{j, k_{j}}$ of $\left(\overline{\mathrm{PE}_{p q}}\right)$ is obtained by Eq. (3.10).

Case $p=q . \Phi(k)$ is strictly increasing in $(0,1)$ and it follows from Proposition 2.2 that $\Phi(0)=\pi_{p q} / 2$ and $\lim _{k \rightarrow 1-0} \Phi(k)=\infty$. Thus, if

$$
\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}>\frac{\pi_{p q}}{2}
$$

namely,

$$
\lambda>\frac{q}{p^{*}}\left(\frac{j \pi_{p q}}{T}\right)^{p},
$$

then there exists a unique $k=k_{j}(\lambda)$ satisfying Eq. (3.12). For $j$ and $k_{j}$, a unique solution $u_{j, k_{j}}$ of $\left(\overline{\mathrm{PE}_{p q}}\right)$ is obtained by Eq. (3.10) .

Case $p<q$. It is clear that $\lim _{k \rightarrow+0} \Phi(k)=\lim _{k \rightarrow 1-0} \Phi(k)=\infty$. Changing variable $r=\frac{k^{q}}{1+k^{q}}$, we can write $\Phi$ as

$$
\Psi(r)=\int_{0}^{1} \frac{\left(1+s^{q}\right)^{\frac{1}{p}-\frac{1}{q}}}{\left(1-s^{q}\right)^{\frac{1}{p}}} \psi\left(\left(1+s^{q}\right) r\right) d s, \quad r \in(0,1 / 2),
$$

where $\psi(t)=t^{\frac{1}{q}-\frac{1}{p}}(1-t)^{-\frac{1}{p}}$. It is easy to see that $\psi$ is convex in $(0,1)$ because $\psi(t)>0$ and

$$
(\log \psi(t))^{\prime \prime}=\left(\frac{1}{p}-\frac{1}{q}\right) \frac{1}{t^{2}}+\frac{1}{p} \frac{1}{(1-t)^{2}}>0
$$

Then, $\Psi$ is twice-differentiable in $(0,1 / 2)$ and

$$
\Psi^{\prime \prime}(r)=\int_{0}^{1} \frac{\left(1+s^{q}\right)^{\frac{1}{p}-\frac{1}{q}+2}}{\left(1-s^{q}\right)^{\frac{1}{p}}} \psi^{\prime \prime}\left(\left(1+s^{q}\right) r\right) d s>0
$$

Thus, $\Psi$ is convex and there exists $k_{*} \in(0,1)$ such that $\Phi\left(k_{*}\right)$ is the only one critical value, and hence the minimum of $\Phi$ in $(0,1)$.

If

$$
\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}=\Phi\left(k_{*}\right)
$$

namely,

$$
\lambda=j^{p} \lambda_{1}:=\frac{q}{p^{*}}\left(\frac{2 j \Phi\left(k_{*}\right)}{T}\right)^{p},
$$

then $k_{*}$ satisfies Eq. (3.12). For $j$ and $k_{*}$, a unique solution $u_{j, k_{*}}$ of $\left(\mathrm{PE}_{p q}\right)$ is obtained by Eq. (3.10). Moreover, if

$$
\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}>\Phi\left(k_{*}\right)
$$

namely, $\lambda>j^{p} \lambda_{1}$, then there exist $k=k_{j}(\lambda)$ and $\ell_{j}(\lambda)$ such that

$$
\begin{aligned}
k_{j}(\lambda) & =\Phi^{-1}\left(\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}\right) \in\left(k_{*}, 1\right), \\
\ell_{j}(\lambda) & =\Phi^{-1}\left(\frac{T}{2 j}\left(\frac{\lambda p^{*}}{q}\right)^{\frac{1}{p}}\right) \in\left(0, k_{*}\right) .
\end{aligned}
$$

For $j, k_{j}$ and $\ell_{j}$, solutions $u_{j, k_{j}}$ and $u_{j, \ell_{j}}$ of $\left(\overline{\left.\mathrm{PE}_{p q}\right)}\right.$ are obtained by Eq. (3.10).

Next, we assume $p>2$. In any case, a similar proof as above with $\lim _{k \rightarrow 1-0} \Phi(k)=2^{\frac{1}{p}-1} \pi_{\frac{p}{2}, q}$ instead of $\lim _{k \rightarrow 1-0} \Phi(k)=\infty$ gives that it is impossible to find $k_{m} \in(0,1)$ above satisfying Eq. (3.12), provided

$$
\lambda \geq \frac{2 q}{p^{*}}\left(\frac{m \pi_{\frac{p}{2}, q}}{T}\right)^{p}, \quad m \in \mathbb{N} .
$$

Then, however, for each $j=1,2, \ldots, m$, we can take $\tau \in[0, T)$ such that

$$
\lambda=\frac{2 q}{p^{*}}\left(\frac{j \pi_{\frac{p}{2}, q}}{T-\tau}\right)^{p},
$$

and Theorem 3.3 yields the solutions $u_{j,\left\{\tau_{i}\right\}}$, where $\left\{\tau_{i}\right\}_{i=1}^{j}$ is any sequence satisfying that $\tau_{i} \geq 0, \sum_{i=1}^{j} \tau_{i}=\tau$.

It follows directly from Representation (3.11) of Theorem 3.3 that a kind of solution of $\left(\overline{\mathrm{PE}_{p q}}\right)$ with $p$-Laplacian is also an eigenfunction of ( $\mathrm{E}_{\frac{p}{2}, q}$ ) with $p / 2$-Laplacian.

Corollary 3.1. Let $p>2$. For each $n \in \mathbb{N}$, any solution $u_{n,\left\{\tau_{i}\right\}}$ of ( $\mathrm{PE}_{p q}$ ) in Theorem 3.3 satisfies

$$
\left(\phi_{\frac{p}{2}}\left(u^{\prime}\right)\right)^{\prime}+\frac{(p-2) q}{p}\left(\frac{n \pi \frac{p}{2}, q}{T-\tau}\right)^{\frac{p}{2}} \phi_{q}(u)=0
$$

in the intervals where $\left|u_{n,\left\{\tau_{i}\right\}}\right|<1$, where $\tau=\sum_{i=1}^{n} \tau_{i}$. In particular, for each $n \in \mathbb{N}$, the solution $u_{n,\{0\}}$ of $\left(\overline{\left.\mathrm{PE}_{p q}\right)}\right.$ with $\tau=0$ is an eigenfunction of $\left(\mathrm{E}_{\frac{p}{2}, q}\right)$, that is,

$$
\left\{\begin{array}{l}
\left(\phi_{\frac{p}{2}}\left(u^{\prime}\right)\right)^{\prime}+\frac{(p-2) q}{p}\left(\frac{n \pi \frac{p}{2}, q}{T}\right)^{\frac{p}{2}} \phi_{q}(u)=0, \quad t \in(0, T), \\
u(0)=u(T)=0
\end{array}\right.
$$

Moreover, $u_{n,\{0\}}$ is characterized by $u_{n, R}$ with $R=1$ in Eq. (3.4) with $p$ replaced by $p / 2$.
