# SEMICLASSICAL SPECTRAL ASYMPTOTICS FOR A TWO-DIMENSIONAL MAGNETIC SCHRÖDINGER OPERATOR: THE CASE OF DISCRETE WELLS

#### Abstract

We consider a magnetic Schrödinger operator $H^{h}$, depending on the semiclassical parameter $h>0$, on a two-dimensional Riemannian manifold. We assume that there is no electric field. We suppose that the minimal value $b_{0}$ of the magnetic field $b$ is strictly positive, and there exists a unique minimum point of $b$, which is non-degenerate. The main result of the paper is a complete asymptotic expansion for the low-lying eigenvalues of the operator $H^{h}$ in the semiclassical limit. We also apply these results to prove the existence of an arbitrary large number of spectral gaps in the semiclassical limit in the corresponding periodic setting.


## 1. Preliminaries and main Results

Let $M$ be a compact oriented manifold of dimension $n \geq 2$ (possibly with boundary). Let $g$ be a Riemannian metric and $\mathbf{B}$ a real-valued closed 2-form on $M$. Assume that $\mathbf{B}$ is exact and choose a real-valued 1 -form $\mathbf{A}$ on $M$ such that $d \mathbf{A}=\mathbf{B}$. Thus, one has a natural mapping

$$
u \mapsto i h d u+\mathbf{A} u
$$

from $C_{c}^{\infty}(M)$ to the space $\Omega_{c}^{1}(M)$ of smooth, compactly supported one-forms on $M$. The Riemannian metric allows to define scalar products in these spaces and consider the adjoint operator

$$
(i h d+\mathbf{A})^{*}: \Omega_{c}^{1}(M) \rightarrow C_{c}^{\infty}(M)
$$

A Schrödinger operator with magnetic potential $\mathbf{A}$ is defined by the formula

$$
H^{h}=(i h d+\mathbf{A})^{*}(i h d+\mathbf{A}) .
$$

Here $h>0$ is a semiclassical parameter. If $M$ has non-empty boundary, we will assume that the operator $H^{h}$ satisfies the Dirichlet boundary conditions.

We are interested in semiclassical asymptotics of the low-lying eigenvalues of the operator $H^{h}$. This problem was studied in [3, 8, 10, 11, 12, 13, 14, 23, 25, 26, 27, 29, 30, 31 (see [4, 9] for surveys).

[^0]In this paper, we study the problem in a particular situation. We come back to the case considered in [11. We suppose that $M$ is two-dimensional. Then we can write $\mathbf{B}=b d x_{g}$, where $b \in C^{\infty}(M)$ and $d x_{g}$ is the Riemannian volume form. Let

$$
b_{0}=\min _{x \in M} b(x) .
$$

We furthermore assume that:
(1) $b_{0}>0$;
(2) there exist a unique point $x_{0}$, which belongs to the interior of $M, k \in \mathbb{N}$ and $C>0$ such that for all $x$ in some neighborhood of $x_{0}$ the estimates hold:

$$
C^{-1} d\left(x, x_{0}\right)^{2} \leq b(x)-b_{0} \leq C d\left(x, x_{0}\right)^{2}
$$

Denote

$$
a=\operatorname{Tr}\left(\frac{1}{2} \operatorname{Hess} b\left(x_{0}\right)\right)^{1 / 2}, \quad d=\operatorname{det}\left(\frac{1}{2} \operatorname{Hess} b\left(x_{0}\right)\right) .
$$

Denote by $\lambda_{0}\left(H^{h}\right) \leq \lambda_{1}\left(H^{h}\right) \leq \lambda_{2}\left(H^{h}\right) \leq \ldots$ the eigenvalues of the operator $H^{h}$ in $L^{2}(M)$.

Theorem 1.1. Under current assumptions, for any natural $j$, there exist $C_{j}>0$ and $h_{j}>0$ such that, for any $h \in\left(0, h_{j}\right]$,
$h b_{0}+h^{2}\left[\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}\right]-C_{j} h^{19 / 8} \leq \lambda_{j}\left(H^{h}\right) \leq h b_{0}+h^{2}\left[\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}\right]+C_{j} h^{5 / 2}$.
In particular, we have lower and upper bounds for the groundstate energy $\lambda_{0}\left(H^{h}\right):$

$$
h b_{0}+h^{2} \frac{a^{2}}{2 b_{0}}-C_{0} h^{19 / 8} \leq \lambda_{0}\left(H^{h}\right) \leq h b_{0}+h^{2} \frac{a^{2}}{2 b_{0}}+C_{0} h^{5 / 2}, \quad h \in\left(0, h_{0}\right]
$$

and the asymptotics of the splitting between the groundstate energy and the first excited state :

$$
\lambda_{1}\left(H^{h}\right)-\lambda_{0}\left(H^{h}\right) \sim h^{2} \frac{2 d^{\frac{1}{2}}}{b_{0}}
$$

The previous statement can be completed in the following way.
Theorem 1.2. Under current assumptions, for any natural $j$, there exists a sequence $\left(\alpha_{j, \ell}\right)_{\ell \in \mathbb{N}}$, and for any $N$, there exist $C_{j, N}>0$ and $h_{j, N}>0$ such that, for any $h \in\left(0, h_{j, N}\right]$,

$$
\begin{equation*}
\left|\lambda_{j}\left(H^{h}\right)-h \sum_{\ell=0}^{N} \alpha_{j, \ell} h^{\frac{\ell}{2}}\right| \leq C_{j, N} h^{\frac{N+3}{2}} \tag{1.1}
\end{equation*}
$$

with $\alpha_{j, 0}=b_{0}, \alpha_{j, 1}=0, \alpha_{j, 2}=\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}$.
This theorem improves the result of [11] which only gives a two-terms asymptotics for the ground state energy in the flat case.

The scheme of the proof is to first prove the weak version, given by Theorem 1.1 with $N=2$, permitting to determine $j_{0}$ disjoint intervals in which the first $j_{0}$ eigenvalues are localized, for $h$ small enough, and then to determine a complete expansion of each eigenvalue lying in a given interval.

The paper is organized as follows. In Section 2 we construct approximate eigenfunctions of the operator $H^{h}$ with any order of precision. This allows us to prove
accurate upper bounds for the $j$ th eigenvalue of $H^{h}$. In Section 3 we prove a lower bound for the $j$ th eigenvalue of $H^{h}$ and complete the proofs of Theorems 1.1 and 1.2 In Section 4 we consider the case when the magnetic field is periodic. We combine the construction of approximate eigenfunctions given in Section 2 with the results of [6] to prove the existence of arbitrary large number of gaps in the spectrum of the periodic operator $H^{h}$ in the semiclassical limit.

## 2. Upper bounds

2.1. Approximate eigenfunctions: main result. The purpose of this section is to prove the following accurate upper bound for the eigenvalues of the operator $H^{h}$.

Theorem 2.1. Under current assumptions, for any natural $j$ and $k$, there exists a sequence $\left(\mu_{j, k, \ell}\right)_{\ell \in \mathbb{N}}$ with

$$
\mu_{j, k, 0}=(2 k+1) b_{0}, \quad \mu_{j, k, 1}=0
$$

and

$$
\mu_{j, k, 2}=(2 j+1)(2 k+1) \frac{d^{1 / 2}}{b_{0}}+\left(2 k^{2}+2 k+1\right) \frac{t}{2 b_{0}}+\frac{1}{2}\left(k^{2}+k\right) R\left(x_{0}\right)
$$

where $R$ is the scalar curvature, and

$$
t=\operatorname{Tr}\left(\frac{1}{2} \operatorname{Hess} b\left(x_{0}\right)\right)
$$

and for any $N$, there exist $\phi_{j k N}^{h} \in C^{\infty}(M), C_{j k, N}>0$ and $h_{j k, N}>0$ such that

$$
\begin{equation*}
\left(\phi_{j_{1} k_{1} N}^{h}, \phi_{j_{2} k_{2} N}^{h}\right)=\delta_{j_{1} j_{2}} \delta_{k_{1} k_{2}}+\mathcal{O}_{j_{1}, j_{2}, k_{1}, k_{2}}(h) \tag{2.1}
\end{equation*}
$$

and, for any $h \in\left(0, h_{j k, N}\right]$,

$$
\begin{equation*}
\left\|H^{h} \phi_{j k N}^{h}-\mu_{j k N}^{h} \phi_{j k N}^{h}\right\| \leq C_{j k N} h^{\frac{N+3}{2}}\left\|\phi_{j k N}^{h}\right\| \tag{2.2}
\end{equation*}
$$

where

$$
\mu_{j k N}^{h}=h \sum_{\ell=0}^{N} \mu_{j, k, \ell} h^{\frac{\ell}{2}}
$$

Since the operator $H^{h}$ is self-adjoint, using Spectral Theorem, we immediately deduce the existence of eigenvalues near the points $\mu_{j k}^{h}$.
Corollary 2.2. For any natural $j, k$ and $N$, there exist $C_{j k, N}>0$ and $h_{j k, N}>0$ such that, for any $h \in\left(0, h_{j k, N}\right)$,

$$
\operatorname{dist}\left(\mu_{j k N}^{h}, \operatorname{Spec}\left(H^{h}\right)\right) \leq C_{j k, N} h^{\frac{N+3}{2}}
$$

Remark 2.3. The low-lying eigenvalues of the operator $H^{h}$, as $h \rightarrow 0$, are obtained by taking $k=0$ in Theorem [2.1 Therefore, as an immediate consequence of Theorem [2.1] we deduce that, for any natural $j$ and $N$, there exists $h_{j, N}>0$ such that, for any $h \in\left(0, h_{j, N}\right]$, we have

$$
\lambda_{j}\left(H^{h}\right) \leq \mu_{j 0 N}^{h}+C_{j 0, N} h^{\frac{N+3}{2}}
$$

In particular, this implies the upper bound in Theorem 1.1

Remark 2.4. Our interest in the case of arbitrary $k$ in Theorem 2.1 is motivated by its importance for proving the existence of gaps in the spectrum of the operator $H^{h}$ in the semiclassical limit. This will be discussed in Section 4.
Proof of Theorem 2.1. The proof is long, so we will split it in different steps in the next subsections.
2.2. Expanding operators in fractional powers of $h$. The approximate eigenfunctions $\phi_{j k}^{h} \in C^{\infty}(M)$, which we are going to construct, will be supported in a small neighborhood of $x_{0}$. So, in a neighborhood of $x_{0}$, we will consider some special local coordinate system with coordinates $(x, y)$ such that $x_{0}$ corresponds to $(0,0)$. We will only apply our operator on functions which are a product of cut-off functions with functions of the form of linear combinations of terms like $h^{\nu} w\left(h^{-1 / 2} x, h^{-1 / 2} y\right)$ with $w$ in $\mathcal{S}\left(\mathbb{R}^{2}\right)$. These functions are consequently $O\left(h^{\infty}\right)$ outside a fixed neighborhood of $(0,0)$. We will start by doing the computations formally in the sense that everything is determined modulo $O\left(h^{\infty}\right)$, and any smooth function will be replaced by its Taylor's expansion. It is then easy to construct non formal approximate eigenfunctions.

First, we recall that in local coordinates $X=\left(X^{1}, X^{2}\right)=(x, y)$ on $M$ the 1-form A is written as

$$
\mathbf{A}=A_{1}(X) d X_{1}+A_{2}(X) d X_{2}
$$

the matrix of the Riemannian metric $g$ as

$$
g(X)=\left(g_{j \ell}(X)\right)_{1 \leq j, \ell \leq 2}
$$

and its inverse as

$$
g(X)^{-1}=\left(g^{j \ell}(X)\right)_{1 \leq j, \ell \leq 2}
$$

Denote $|g(X)|=\operatorname{det}(g(X))$. Then the magnetic field $\mathbf{B}$ is given by

$$
\mathbf{B}=B d x \wedge d y, \quad B=\frac{\partial A_{2}}{\partial x}-\frac{\partial A_{1}}{\partial y}
$$

and

$$
B=b \sqrt{|g|} .
$$

Finally, the operator $H^{h}$ has the form

$$
H^{h}=\frac{1}{\sqrt{|g(X)|}} \sum_{1 \leq \alpha, \beta \leq 2} \nabla_{\alpha}^{h}\left(\sqrt{|g(X)|} g^{\alpha \beta}(X) \nabla_{\beta}^{h}\right)
$$

where

$$
\nabla_{\alpha}^{h}=i h \frac{\partial}{\partial X^{\alpha}}+A_{\alpha}(X), \quad \alpha=1,2
$$

or, equivalently,

$$
H^{h}=\sum_{1 \leq \alpha, \beta \leq 2} g^{\alpha \beta}(X) \nabla_{\alpha}^{h} \nabla_{\beta}^{h}+i h \sum_{1 \leq \alpha \leq 2} \Gamma^{\alpha} \nabla_{\alpha}^{h}
$$

where, for $\alpha=1,2$,

$$
\begin{equation*}
\Gamma^{\alpha}=\frac{1}{\sqrt{|g(X)|}} \sum_{1 \leq \beta \leq 2} \frac{\partial}{\partial X^{\beta}}\left(\sqrt{|g(X)|} g^{\beta \alpha}(X)\right) \tag{2.3}
\end{equation*}
$$

We will consider normal local coordinates near $x_{0}$ such that $x_{0}$ corresponds to $(0,0)$ and, in a neighborhood of $x_{0}$,

$$
b(X)=b_{0}+\alpha_{1} x^{2}+\beta_{1} y^{2}+O\left(|X|^{3}\right)
$$

Thus, we have

$$
a=\left(\alpha_{1}\right)^{1 / 2}+\left(\beta_{1}\right)^{1 / 2}, \quad d=\alpha_{1} \beta_{1}, \quad t=\alpha_{1}+\beta_{1} .
$$

By well-known properties of normal coordinates we have

$$
g_{11}(X)=1+O\left(|X|^{2}\right), \quad g_{12}(X)=O\left(|X|^{2}\right), \quad g_{22}(X)=1+O\left(|X|^{2}\right)
$$

Moreover (see, for instance, [1, Proposition 1.28]), we have

$$
g_{i j}(X)=\delta_{i j}-\frac{1}{3} \sum_{k l} R_{i k j l}\left(x_{0}\right) X^{k} X^{l}+O\left(|X|^{3}\right)
$$

where $R_{i j k l}$ is the Riemann curvature tensor. Therefore, Taylor's expansion of $g^{\alpha \beta}$ has the form

$$
\begin{equation*}
g^{\alpha \beta}(X)=\delta^{\alpha \beta}+\sum_{k=2}^{\infty} g_{(k)}^{\alpha \beta}(X) \tag{2.4}
\end{equation*}
$$

where

$$
g_{(2)}^{\alpha \beta}(X)=\frac{1}{3} \sum_{k l} R_{\alpha k \beta l}\left(x_{0}\right) X^{k} X^{l} .
$$

In the two-dimensional case, due to its symmetries, the Riemann curvature tensor is determined by a single component

$$
R_{1212}=-R_{2112}=R_{2121}=-R_{1221}
$$

The other components equal zero. We have

$$
2 R_{1212}=R\left(g_{11} g_{22}-g_{12}^{2}\right)
$$

where $R$ is the scalar curvature. So we have

$$
R_{1212}\left(x_{0}\right)=\frac{1}{2} R\left(x_{0}\right)
$$

Thus we have

$$
\begin{equation*}
g_{(2)}^{11}(X)=\frac{1}{6} R\left(x_{0}\right) y^{2}, \quad g_{(2)}^{12}(X)=-\frac{1}{6} R\left(x_{0}\right) x y, \quad g_{(2)}^{22}(X)=\frac{1}{6} R\left(x_{0}\right) x^{2} \tag{2.5}
\end{equation*}
$$

We also have

$$
\begin{equation*}
\sqrt{|g(X)|}=1-\frac{1}{12} R\left(x_{0}\right) x^{2}-\frac{1}{12} R\left(x_{0}\right) y^{2}+O\left(|X|^{3}\right) \tag{2.6}
\end{equation*}
$$

Let us write Taylor's expansion of $\Gamma^{\alpha}$ in the form

$$
\begin{equation*}
\Gamma^{\alpha}(X)=\sum_{k=0}^{\infty} \Gamma_{(k)}^{\alpha}(X), \quad \alpha=1,2 \tag{2.7}
\end{equation*}
$$

Using (2.5) and (2.6), one can show that

$$
\Gamma_{(0)}^{\alpha}(X)=0, \quad \alpha=1,2
$$

and

$$
\begin{equation*}
\Gamma_{(1)}^{1}(X)=-\frac{1}{3} R\left(x_{0}\right) x, \quad \Gamma_{(1)}^{2}(X)=-\frac{1}{3} R\left(x_{0}\right) y \tag{2.8}
\end{equation*}
$$

If we write $\mathbf{B}=B(x, y) d x d y$ then

$$
B(X)=b(X) \sqrt{|g(X)|}=b_{0}+\alpha x^{2}+\beta y^{2}+O\left(|X|^{3}\right)
$$

where

$$
\alpha_{1}=\alpha+\frac{1}{12} b_{0} R\left(x_{0}\right)>0, \quad \beta_{1}=\beta+\frac{1}{12} b_{0} R\left(x_{0}\right)>0
$$

We can also choose a gauge $A$ such that

$$
A_{1}(X)=0 \text { and } A_{2}(X)=b_{0} x+\frac{\alpha}{3} x^{3}+\beta x y^{2}+O\left(|X|^{4}\right)
$$

We expand $A_{2}$ into the Taylor series:

$$
A_{2}(X)=b_{0} x+\sum_{j=3}^{\infty} S_{j}(x, y)
$$

with

$$
S_{j}(x, y)=\sum_{\ell=0}^{j} S_{j \ell} x^{\ell} y^{j-\ell}
$$

In particular, we have

$$
S_{3}(x, y)=\frac{\alpha}{3} x^{3}+\beta x y^{2}
$$

Next we move the operator $H^{h}$ into the Hilbert space $L^{2}\left(\mathbb{R}^{n}\right)$ equipped with the Euclidean inner product, considering the operator

$$
\begin{aligned}
\hat{H}^{h} & =|g(X)|^{1 / 4} H_{h}|g(X)|^{-1 / 4} \\
& =\sum_{1 \leq \alpha, \beta \leq 2} g^{\alpha \beta}(X) \hat{\nabla}_{\alpha}^{h} \hat{\nabla}_{\beta}^{h}+i h \sum_{1 \leq \alpha \leq 2} \Gamma^{\alpha} \hat{\nabla}_{\alpha}^{h}
\end{aligned}
$$

where, for $\alpha=1,2$,

$$
\begin{equation*}
\left.\hat{\nabla}_{\alpha}^{h}=|g(X)|^{1 / 4} \nabla_{\alpha}^{h}|g(X)|^{-1 / 4}=\nabla_{\alpha}^{h}+\frac{1}{12} i h R\left(x_{0}\right) X^{\alpha}+O\left(h|X|^{2}\right)\right) \tag{2.9}
\end{equation*}
$$

Now we use the scaling $x=h^{1 / 2} x_{1}, y=h^{1 / 2} y_{1}$ and expand the resulting operator $\hat{H}^{h}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)$ into a formal power series of $h^{1 / 2}$. By (2.9), we have

$$
\begin{aligned}
& \hat{\nabla}_{1}^{h}=h^{1 / 2}\left(-D_{x_{1}}+\frac{1}{12} i h R\left(x_{0}\right) x_{1}+O\left(h^{3 / 2}\right)\right) \\
& \hat{\nabla}_{2}^{h}=h^{1 / 2}\left(-D_{y_{1}}+b_{0} x_{1}+\frac{1}{12} i h R\left(x_{0}\right) y_{1}+h S_{3}\left(x_{1}, y_{1}\right)+O\left(h^{3 / 2}\right)\right)
\end{aligned}
$$

From (2.4) and (2.7), we get

$$
\begin{aligned}
g^{\alpha \beta}\left(x_{1}, y_{1}\right) & =\delta^{\alpha \beta}+h g_{(2)}^{\alpha \beta}\left(x_{1}, y_{1}\right)+\sum_{k=3}^{\infty} h^{k / 2} g_{(k)}^{\alpha \beta}\left(x_{1}, y_{1}\right) \\
\Gamma^{\alpha}\left(x_{1}, y_{1}\right) & =h^{1 / 2} \Gamma_{(1)}^{\alpha}\left(x_{1}, y_{1}\right)+\sum_{k=2}^{\infty} h^{k / 2} \Gamma_{(k)}^{\alpha}\left(x_{1}, y_{1}\right), \quad \alpha=1,2
\end{aligned}
$$

Using these expansions, one can check that the operator $\hat{H}^{h}$ has the form

$$
\hat{H}^{h}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)=h Q^{h}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)
$$

with

$$
Q^{h}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)=\sum_{k=0}^{\infty} h^{k / 2} Q_{k}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)
$$

where

$$
\begin{aligned}
& Q_{0}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)=D_{x_{1}}^{2}+\left(D_{y_{1}}-b_{0} x_{1}\right)^{2} \\
& Q_{1}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)=0
\end{aligned}
$$

and

$$
\begin{aligned}
Q_{2}\left(x_{1}, y_{1}, D_{x_{1}}, D_{y_{1}}\right)= & -\frac{1}{12} i R\left(x_{0}\right)\left(x_{1} D_{x_{1}}+D_{x_{1}} x_{1}\right) \\
& -\frac{1}{12} i R\left(x_{0}\right)\left(y_{1}\left(D_{y_{1}}-b_{0} x_{1}\right)+\left(D_{y_{1}}-b_{0} x_{1}\right) y_{1}\right) \\
& -\left(\left(D_{y_{1}}-b_{0} x_{1}\right) S_{3}\left(x_{1}, y_{1}\right)+S_{3}\left(x_{1}, y_{1}\right)\left(D_{y_{1}}-b_{0} x_{1}\right)\right) \\
& +g_{(2)}^{11}\left(x_{1}, y_{1}\right) D_{x_{1}}^{2} \\
& +g_{(2)}^{12}\left(x_{1}, y_{1}\right) D_{x_{1}}\left(D_{y_{1}}-b_{0} x_{1}\right) \\
& +g_{(2)}^{12}\left(x_{1}, y_{1}\right)\left(D_{y_{1}}-b_{0} x_{1}\right) D_{x_{1}} \\
& +g_{(2)}^{22}\left(x_{1}, y_{1}\right)\left(D_{y_{1}}-b_{0} x_{1}\right)^{2} \\
& -i \Gamma_{(1)}^{1}\left(x_{1}, y_{1}\right) D_{x_{1}} \\
& -i \Gamma_{(1)}^{2}\left(x_{1}, y_{1}\right)\left(D_{y_{1}}-b_{0} x_{1}\right) .
\end{aligned}
$$

Using the Fourier transform in $y_{1}$, we can write the operator $Q^{h}$ as

Q^{h}\left(x_{1},-D_{\xi}, D_{x_{1}}, \xi\right)=\sum_{k=0}^{\infty} h^{k / 2} Q_{k}\left(x_{1},-D_{\xi}, D_{x_{1}}, \xi\right)
$$

where

$$
\begin{aligned}
& Q_{0}\left(x_{1},-D_{\xi}, D_{x_{1}}, \xi\right)=D_{x_{1}}^{2}+\left(\xi-b_{0} x_{1}\right)^{2} \\
& Q_{1}\left(x_{1},-D_{\xi}, D_{x_{1}}, \xi\right)=0
\end{aligned}
$$

and

$$
\begin{aligned}
Q_{2}\left(x_{1},-D_{\xi}, D_{x_{1}}, \xi\right)= & -\frac{1}{12} i R\left(x_{0}\right)\left(2 x_{1} D_{x_{1}}-i\right) \\

The system $\left\{u_{j k}^{(0)}\right\}$ is an orthonormal system. Since each change of variables, which we use, is unitary, this implies the condition (2.1).

## 3. LOWER BOUNDS

In this section, we will prove the lower bound in Theorem 1.1 First, we recall a general lower bound due to Montgomery [27]. Suppose that $U$ is a domain in $M$. Then, for any $u \in C_{c}^{\infty}(U)$, the following estimate holds:

This fact is an immediate consequence of a Weitzenböck-Bochner type identity.
From (3.1), it follows that we can restrict our considerations by any sufficiently small neighborhood $\Omega$ of $x_{0}$. Denote by $H_{D}^{h}$ the Dirichlet realization of the operator $H^{h}$ in $L^{2}\left(\Omega, d x_{g}\right)$.

The estimate (3.1) implies that

q(v)=\int_{\Omega} \sum_{1 \leq \alpha \leq 2}\left|\left(\nabla_{\alpha}^{h}-\frac{1}{4} i h|g(X)|^{-1} \frac{\partial}{\partial X_{\alpha}}|g(X)|\right) v(X)\right|^{2} d X
$$

Then we have

$$
\begin{align*}
& \left|\left(\hat{P}_{D}^{h} v, v\right)-q(v)\right|  \tag{3.4}\\
& \quad \leq \int_{\Omega} \sum_{1 \leq \alpha \leq 2}|X|^{2}\left|\left(\nabla_{\alpha}^{h}-\frac{1}{4} i h|g(X)|^{-1} \frac{\partial}{\partial X_{\alpha}}|g(X)|\right) v(X)\right|^{2} d X \\
& \quad+C_{1} h \int_{\Omega}|v(X)|^{2} d X+C_{2} h^{1 / 2} \int_{\Omega}|X|^{2}|v(X)|^{2} d X
\end{align*}
$$

Consider the Dirichlet realization $P_{\text {flat }, D}^{h}$ of the operator

$$
P_{\text {flat }}^{h}=\left(i h \frac{\partial}{\partial x}-\frac{1}{2} b_{0} y\right)^{2}+\left(i h \frac{\partial}{\partial y}+\frac{1}{2} b_{0} x\right)^{2}-h b_{0}+h^{1 / 2} b_{2}(X)
$$

in the space $L^{2}(\Omega, d X)$. So its quadratic form is given by

$$
\left(P_{f l a t}^{h} v, v\right)=q^{f l a t}(v)-h b_{0} \int_{\Omega}|v(X)|^{2} d X+h^{1 / 2} \int_{\Omega} b_{2}(X)|v(X)|^{2} d X
$$

where

$$
q^{f l a t}(v)=\int_{\Omega}\left|\left(i h \frac{\partial}{\partial x}-\frac{1}{2} b_{0} y\right) v(X)\right|^{2} d X+\int_{\Omega}\left|\left(i h \frac{\partial}{\partial y}+\frac{1}{2} b_{0} x\right) v(X)\right|^{2} d X
$$

So we have

$$
\begin{align*}
& \left|\left(\hat{P}_{D}^{h} v, v\right)-\left(P_{\text {flat }}^{h} v, v\right)\right| \leq\left|q(v)-q^{f l a t}(v)\right|  \tag{3.5}\\
+ & \sum_{\alpha} \int_{\Omega}|X|^{2}\left|\nabla_{\alpha}^{h} v(X)\right|^{2} d X+h \int_{\Omega}|X|^{2}|v(X)|^{2} d X+h^{1 / 2} \int_{\Omega}|X|^{3}|v(X)|^{2} d X
\end{align*}
$$

Finally, we have

$$
\begin{align*}
& \left|q(v)-q^{f l a t}(v)\right|  \tag{3.6}\\
& \quad \leq C(q(v))^{1 / 2}\left[h\left(\int_{\Omega}|X|^{2}|v(X)|^{2} d X\right)^{1 / 2}+\left(\int_{\Omega}|X|^{6}|v(X)|^{2} d X\right)^{1 / 2}\right]
\end{align*}
$$

For a fixed $j \in \mathbb{N}$, consider the subspace $V^{h, j}$ of $L^{2}\left(\Omega, d x_{g}\right)$, generated by all eigenfunctions of the operator $P_{D}^{h}$ associated to the eigenvalue $\lambda_{\ell}\left(P_{D}^{h}\right)$ with $\ell=$ $0,1, \ldots, j$. Thus, $V^{h, j}$ is a $(j+1)$-dimensional space such that

$$
\begin{equation*}
\left(P_{D}^{h} u_{h}, u_{h}\right) \leq \lambda_{j}\left(P_{D}^{h}\right)\left\|u_{h}\right\|_{L^{2}\left(\Omega, d x_{g}\right)}^{2}, \quad u_{h} \in V^{h, j} \tag{3.7}
\end{equation*}
$$

Moreover, by Lemma 3.2, for any real $k \geq 0$, there exists $C_{k}>0$ such that, for any $u_{h} \in V^{h, j}$,

$$
\begin{equation*}
\left\||X|^{k} u_{h}\right\|_{L^{2}\left(\Omega, d x_{g}\right)} \leq C_{k}\left(h^{k / 2}+h^{(3 k+1) / 8}\right)\left\|u_{h}\right\|_{L^{2}\left(\Omega, d x_{g}\right)} \tag{3.8}
\end{equation*}
$$

for any $\alpha=1,2$ and any $k \geq 0$,

$$
\begin{equation*}
\left\||X|^{k} \nabla_{\alpha}^{h} u_{h}\right\|_{L^{2}\left(\Omega, d x_{g}\right)} \leq C_{k}\left(h^{(k+1) / 2}+h^{(3 k+5) / 8}\right)\left\|u_{h}\right\|_{L^{2}\left(\Omega, d x_{g}\right)} \tag{3.9}
\end{equation*}
$$

By (3.8) and (3.9), for any real $k \geq 0$, there exists $C_{k}>0$ such that, for any $v_{h} \in L^{2}(\Omega, d X)$ of the form $v_{h}=|g(X)|^{1 / 4} u_{h}$ with $u_{h} \in V^{h, j}$,

$$
\begin{equation*}
\left\||X|^{k} v_{h}\right\|_{L^{2}(\Omega, d X)} \leq C_{k}\left(h^{k / 2}+h^{(3 k+1) / 8}\right)\left\|v_{h}\right\|_{L^{2}(\Omega, d X)} \tag{3.10}
\end{equation*}
$$

for any $\alpha=1,2$ and for any $k \geq 0$.

$$
\begin{align*}
\left(\int_{\Omega}|X|^{2 k} \mid\right. & \left.\left.\left(i h \frac{\partial}{\partial x}-\frac{1}{2} b_{0} y\right) v_{h}(X)\right|^{2} d X\right)^{1 / 2}  \tag{3.11}\\
+ & \left(\int_{\Omega}|X|^{2 k}\left|\left(i h \frac{\partial}{\partial y}+\frac{1}{2} b_{0} x\right) v_{h}(X)\right|^{2} d X\right)^{1 / 2} \\
& \leq C_{k}\left(h^{(k+1) / 2}+h^{(3 k+5) / 8}\right)\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}
\end{align*}
$$

The estimates (3.10) and (3.11) allow us show for any $v_{h} \in L^{2}(\Omega, d X)$ of the form $v_{h}=|g(X)|^{1 / 4} u_{h}$ with $u_{h} \in V^{h, j}$, first, using (3.7), (3.3) and (3.4), that,

$$
q\left(v_{h}\right) \leq C h^{3 / 2}\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}^{2}
$$

next, using (3.6), that

$$
\left|q\left(v_{h}\right)-q^{f l a t}\left(v_{h}\right)\right| \leq C h^{2}\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}^{2}
$$

and finally, using (3.5), that

$$
\begin{equation*}
\left(P_{f l a t}^{h} v_{h}, v_{h}\right) \leq\left(\lambda_{j}\left(P_{D}^{h}\right)+C_{j} h^{15 / 8}\right)\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}^{2} \tag{3.12}
\end{equation*}
$$

Let $\chi$ be a function from $C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ such that supp $\chi \subset \Omega$ and $\chi \equiv 1$ in a neighborhood of zero. By (3.10) and (3.11), it follows that, for any $k \in \mathbb{N}$ there exists $C_{k}>0$ such that, for any $v_{h} \in L^{2}(\Omega, d X)$ of the form $v_{h}=|g(X)|^{1 / 4} u_{h}$ with $u_{h} \in V^{h, j}$,

$$
\begin{align*}
&\left\|(1-\chi) v_{h}\right\|_{L^{2}(\Omega, d X)}+\left\|\frac{\partial \chi}{\partial x} v_{h}\right\|_{L^{2}(\Omega, d X)}+\left\|\frac{\partial \chi}{\partial y} v_{h}\right\|_{L^{2}(\Omega, d X)}  \tag{3.13}\\
& \leq C_{k} h^{k}\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}
\end{align*}
$$

and

$$
\begin{align*}
&\left(\int_{\Omega}(1-\chi(X))\left|\left(i h \frac{\partial}{\partial x}-\frac{1}{2} b_{0} y\right) v_{h}(X)\right|^{2} d X\right)^{1 / 2}  \tag{3.14}\\
& \quad+\left(\int_{\Omega}(1-\chi(X))\left|\left(i h \frac{\partial}{\partial y}+\frac{1}{2} b_{0} x\right) v_{h}(X)\right|^{2} d X\right)^{1 / 2} \\
& \leq C_{k} h^{k}\left\|v_{h}\right\|_{L^{2}(\Omega, d X)}
\end{align*}
$$

Using (3.13) and (3.14), it is easy to check that, for any $k>0$, there exists $C_{k}>0$ such that

$$
\begin{equation*}
\left|\left(P_{\text {flat }}^{h}\left(\chi v_{h}\right), \chi v_{h}\right)-\left(P_{\text {flat }}^{h} v_{h}, v_{h}\right)\right| \leq C_{k} h^{k}\left\|v_{h}\right\|^{2} \tag{3.15}
\end{equation*}
$$

Consider the self-adjoint realization of the operator $P_{\text {flat }}^{h}$ in $L^{2}\left(\mathbb{R}^{2}, d X\right)$. We will the same notation $P_{\text {flat }}^{h}$ for this operator. Consider the $(j+1)$-dimensional subspace $W^{h, j}$ of $C_{c}^{\infty}\left(\mathbb{R}^{2}\right)$, which consists of all functions $w_{h} \in C_{c}^{\infty}\left(\mathbb{R}^{2}\right)$ of the form $w_{h}=\chi|g(X)|^{1 / 4} u_{h}$ with $u_{h} \in V^{h, j}$. By (3.12) and (3.15), it follows that, for any $w_{h} \in W^{h, j}$,

$$
\left(P_{f l a t}^{h} w_{h}, w_{h}\right) \leq\left(\lambda_{j}\left(P_{D}^{h}\right)+C_{j} h^{15 / 8}\right)\left\|w_{h}\right\|_{L^{2}(\Omega, d X)}^{2}
$$

By the mini-max principle, this immediately implies that, for any $j>0$, there exists $C_{j}>0$ such that, for $j$-th eigenvalue $\lambda_{j}\left(P_{\text {flat }}^{h}\right)$ of $P_{\text {flat }}^{h}$, we have

$$
\begin{equation*}
\lambda_{j}\left(P_{\text {flat }}^{h}\right) \leq \lambda_{j}\left(P_{D}^{h}\right)+C_{j} h^{15 / 8} \tag{3.16}
\end{equation*}
$$

It remains to recall that the eigenvalues of the Schrödinger operator with constant magnetic field and positive quadratic potential in $\mathbb{R}^{n}$ can be computed explicitly. More precisely (see, for instance, [26. Theorem 2.2]), the eigenvalues of the operator

$$
H_{b, K}=\left(i \frac{\partial}{\partial x}-\frac{1}{2} b y\right)^{2}+\left(i \frac{\partial}{\partial y}+\frac{1}{2} b x\right)^{2}+\sum_{i j} K_{i j} X_{i} X_{j}
$$

are given by

$$
\lambda_{n_{1} n_{2}}=\left(2 n_{1}+1\right) s_{1}+\left(2 n_{2}+1\right) s_{2}, \quad n_{1}, n_{2} \in \mathbb{N}
$$

where

$$
\begin{aligned}
& s_{1}=\frac{1}{\sqrt{2}}\left[t_{K}+b^{2}-\left[\left(t_{K}+b^{2}\right)^{2}-4 d_{K}\right]^{1 / 2}\right]^{1 / 2} \\
& s_{2}=\frac{1}{\sqrt{2}}\left[t_{K}+b^{2}+\left[\left(t_{K}+b^{2}\right)^{2}-4 d_{K}\right]^{1 / 2}\right]^{1 / 2}
\end{aligned}
$$

and

$$
t_{K}=\operatorname{Tr} K, \quad d_{K}=\operatorname{det} K
$$

Applying this formula to the operator $P_{\text {flat }}^{h}$, we obtain that its eigenvalues have the form:

$$
\lambda_{n_{1} n_{2}}=\left(2 n_{1}+1\right) s_{1}+\left(2 n_{2}+1\right) s_{2}-h b_{0}, \quad n_{1}, n_{2} \in \mathbb{N}
$$

where

$$
\begin{aligned}
s_{1} & =\frac{h}{\sqrt{2}}\left[h^{1 / 2} t+b_{0}^{2}-\left[\left(h^{1 / 2} t+b_{0}^{2}\right)^{2}-4 h^{1 / 2} d\right]^{1 / 2}\right]^{1 / 2} \\
& =d^{1 / 2} b_{0}^{-1} h^{3 / 2}+O\left(h^{2}\right),
\end{aligned}
$$

and

$$
\begin{aligned}
s_{2} & =\frac{h}{\sqrt{2}}\left[h^{1 / 2} t+b_{0}^{2}+\left[\left(h^{1 / 2} t+b_{0}^{2}\right)^{2}-4 h^{1 / 2} d\right]^{1 / 2}\right]^{1 / 2} \\
& =h b_{0}+\frac{1}{2} t b_{0}^{-1} h^{3 / 2}+O\left(h^{2}\right)
\end{aligned}
$$

Thus, we obtain

$$
\lambda_{n_{1} n_{2}}=2 n_{2} h b_{0}+\left[n_{1} \frac{2 d^{1 / 2}}{b_{0}}+n_{2} \frac{t}{b_{0}}+\frac{a^{2}}{2 b_{0}}\right] h^{3 / 2}+O\left(h^{2}\right), \quad n_{1}, n_{2} \in \mathbb{N}
$$

For $j$ th eigenvalue $\lambda_{j}\left(P_{\text {flat }}^{h}\right)$ of $P_{\text {flat }}^{h}$, we obtain

$$
\begin{equation*}
\lambda_{j}\left(P_{\text {flat }}^{h}\right)=\left[\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}\right] h^{3 / 2}+O\left(h^{2}\right) \tag{3.17}
\end{equation*}
$$

Combining (3.16) and (3.17), we immediately complete the proof of Theorem 3.1,
Proof of Theorem 1.2. Fix $j \in \mathbb{N}$. By Theorem 1.1] there exist $C>0$ and $h_{0}>0$ such that, for any $h \in\left(0, h_{0}\right]$,

$$
I_{j} \bigcap \operatorname{Spec}\left(H^{h}\right)=\left\{\lambda_{j}\left(H^{h}\right)\right\}
$$

where

$$
I_{j}=\left(h b_{0}+h^{2}\left[\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}\right]-C h^{19 / 8}, h b_{0}+h^{2}\left[\frac{2 d^{1 / 2}}{b_{0}} j+\frac{a^{2}}{2 b_{0}}\right]+C h^{5 / 2}\right)
$$

On the other hand, by Corollary 2.2, for any natural $N$, there exist $C^{\prime}>0$ and $h_{0}^{\prime}>0$ such that, for any $h \in\left(0, h_{0}^{\prime}\right]$,

$$
\operatorname{dist}\left(\mu_{j 0 N}^{h}, \operatorname{Spec}\left(H^{h}\right)\right) \leq C^{\prime} h^{\frac{N+3}{2}}
$$

Without loss of generality, we can assume that, for any $h \in\left(0, \min \left(h_{0}, h_{0}^{\prime}\right)\right]$,

$$
\left(\mu_{j 0 N}^{h}-C^{\prime} h^{\frac{N+3}{2}}, \mu_{j 0 N}^{h}+C^{\prime} h^{\frac{N+3}{2}}\right) \cap I_{\ell}=\emptyset, \forall \ell \neq j
$$

Hence, for any $h \in\left(0, \min \left(h_{0}, h_{0}^{\prime}\right)\right], \lambda_{j}\left(H^{h}\right)$ is the point of $\operatorname{Spec}\left(H^{h}\right)$, closest to $\mu_{j 0 N}^{h}$. It follows that

$$
\left|\lambda_{j}\left(H^{h}\right)-\mu_{j 0 N}^{h}\right| \leq C^{\prime} h^{\frac{N+3}{2}}, \quad h \in\left(0, \min \left(h_{0}, h_{0}^{\prime}\right)\right],
$$

that proves (1.1) with $\alpha_{j, \ell}=\mu_{j, 0, \ell}$.

## 4. Periodic case and spectral gaps

In this Section, we apply the results of Section 2 to the problem of existence of gaps in the spectrum of a periodic magnetic Schrödinger operator. Some related results on spectral gaps for periodic magnetic Schrödinger operators can be found in [2, 5, 15, 16, 17, 18, 19, 20, 21, 22, 24, 28, (see also the references therein).

Let $M$ be a two-dimensional noncompact oriented manifold of dimension $n \geq 2$ equipped with a properly discontinuous action of a finitely generated, discrete group $\Gamma$ such that $M / \Gamma$ is compact. Suppose that $H^{1}(M, \mathbb{R})=0$, i.e. any closed 1 -form on $M$ is exact. Let $g$ be a $\Gamma$-invariant Riemannian metric and $\mathbf{B}$ a real-valued $\Gamma$-invariant closed 2-form on $M$. Assume that $\mathbf{B}$ is exact and choose a real-valued 1 -form $\mathbf{A}$ on $M$ such that $d \mathbf{A}=\mathbf{B}$. Write $\mathbf{B}=b d x_{g}$, where $b \in C^{\infty}(M)$ and $d x_{g}$ is the Riemannian volume form. Let

$$
b_{0}=\min _{x \in M} b(x) .
$$

Assume that there exist a (connected) fundamental domain $\mathcal{F}$ and a constant $\epsilon_{0}>0$ such that

$$
b(x) \geq b_{0}+\epsilon_{0}, \quad x \in \partial \mathcal{F}
$$

We will consider the magnetic Schrödinger operator $H^{h}$ as an unbounded selfadjoint operator in the Hilbert space $L^{2}(M)$. Using the results of [6], one can immediately derive from Theorem 2.1 the following result on existence of gaps in the spectrum of $H^{h}$ in the semiclassical limit.

We will use the above notation

$$
t=\operatorname{Tr}\left(\frac{1}{2} \operatorname{Hess} b\left(x_{0}\right)\right), \quad d=\operatorname{det}\left(\frac{1}{2} \operatorname{Hess} b\left(x_{0}\right)\right) .
$$

For any $k \in \mathbb{N}$, put

$$
c_{k}=(2 k+1) \frac{d^{1 / 2}}{b_{0}}+\left(2 k^{2}+2 k+1\right) \frac{t}{2 b_{0}}+\frac{1}{2}\left(k^{2}+k\right) R\left(x_{0}\right) .
$$

Theorem 4.1. Assume that $b_{0}>0$ and there exist $x_{0} \in \mathcal{F}$ and $C>0$ such that for all $x$ in some neighborhood of $x_{0}$ the estimates hold:

$$
C^{-1} d\left(x, x_{0}\right)^{2} \leq b(x)-b_{0} \leq C d\left(x, x_{0}\right)^{2}
$$

Then, for any natural $k$ and $N$, there exist $C_{k, N}>c_{k}$ and $h_{k, N}>0$ such that the spectrum of $H^{h}$ in the interval

$$
\left[(2 k+1) h b_{0}+h^{2} c_{k},(2 k+1) h b_{0}+h^{2} C_{k, N}\right]
$$

has at least $N$ gaps for any $h \in\left(0, h_{k, N}\right]$.
