# GIBBS MEASURE FOR THE PERIODIC DERIVATIVE NONLINEAR SCHRÖDINGER EQUATION

#### Abstract

In this paper we construct a Gibbs measure for the derivative Schrödinger equation on the circle. The construction uses some renormalisations of Gaussian series and Wiener chaos estimates, ideas which have already been used by the second author in a work on the Benjamin-Ono equation.


}

## 1. Introduction

Denote by $\mathbb{T}=\mathbb{R} / 2 \pi \mathbb{Z}$ the circle. The purpose of this work is to construct a Gibbs measure associated to the derivative nonlinear Schrödinger equation

\left\{\begin{array}{l}
i \partial_{t} u+\partial_{x}^{2} u=i \partial_{x}\left(|u|^{2} u\right), \quad(t, x) \in \mathbb{R} \times \mathbb{T}  \tag{1.1}\\
u(0, x)=u_{0}(x)
\end{array}\right.
$$

Many recent results (see the end of Section (1.2)) show that a Gibbs measure is an efficient tool to construct global rough solutions of nonlinear dispersive equations. This is the main motivation of this paper: we hope that our result combined with a local existence theory for (1.1) (e.g. a result like GrünrockHerr [6]) on the support of the measure will give a global existence result for irregular initial conditions. A second motivation is the fact that an invariant measure is an object which fits well in the study of recurrence properties given by the Poincaré theorem, of the flow of (1.1).

[^0]For $f \in L^{2}(\mathbb{T})$, denote by $\int_{\mathbb{T}} f(x) \mathrm{d} x=\frac{1}{2 \pi} \int_{0}^{2 \pi} f(x) \mathrm{d} x$. The following quantities are conserved (at least formally) by the flow of the equation

- The mass

M(u(t))=\|u(t)\|_{L^{2}}=\left\|u_{0}\right\|_{L^{2}}=M\left(u_{0}\right)
$$

- The energy

H(u(t)) & =\int_{\mathbb{T}}\left|\partial_{x} u\right|^{2} \mathrm{~d} x+\frac{3}{2} \operatorname{Im} \int_{\mathbb{T}}|u|^{2} u \partial_{x} \bar{u} \mathrm{~d} x+\frac{1}{2} \int_{\mathbb{T}}|u|^{6} \mathrm{~d} x \\
& =\int_{\mathbb{T}}\left|\partial_{x} u\right|^{2} \mathrm{~d} x-\frac{3}{4} \operatorname{Im} \int_{\mathbb{T}} \bar{u}^{2} \partial_{x}\left(u^{2}\right) \mathrm{d} x+\frac{1}{2} \int_{\mathbb{T}}|u|^{6} \mathrm{~d} x \\
& =\int_{\mathbb{T}}\left|\partial_{x} u\right|^{2} \mathrm{~d} x+\frac{3}{4} i \int_{\mathbb{T}} \bar{u}^{2} \partial_{x}\left(u^{2}\right) \mathrm{d} x+\frac{1}{2} \int_{\mathbb{T}}|u|^{6} \mathrm{~d} x \\
& =H\left(u_{0}\right)
\end{aligned}
$$

The conservation of the energy can be seen by a direct computation (see also the appendix of this paper.)
Notice that the momentum

$$
\begin{aligned}
P(u(t)) & =\frac{1}{2} \int_{\mathbb{T}}|u|^{4} \mathrm{~d} x+i \int_{\mathbb{T}} \bar{u} \partial_{x} u \mathrm{~d} x \\
& =\frac{1}{2} \int_{\mathbb{T}}|u|^{4} \mathrm{~d} x-\operatorname{Im} \int_{\mathbb{T}} \bar{u} \partial_{x} u \mathrm{~d} x=P\left(u_{0}\right)
\end{aligned}
$$

is also formally conserved by (1.1). Indeed it is the Hamiltonian of (1.1) associated to a symplectic structure involving $\partial_{x}$ (see [7]). However, we won't use this fact here. Instead, our measure will be deduced from a Hamiltonian formulation based on $H$ of a transformed form of (1.1).

Let us define the complex vector space $E_{N}=\operatorname{span}\left(\left(\mathrm{e}^{i n x}\right)_{-N \leq n \leq N}\right)$. Then we introduce the spectral projector $\Pi_{N}$ on $E_{N}$ by

\Pi_{N}\left(\sum_{n \in \mathbb{Z}} c_{n} \mathrm{e}^{i n x}\right)=\sum_{n=-N}^{N} c_{n} \mathrm{e}^{i n x} \tag{1.2}

Let $(\Omega, \mathcal{F}, \mathbf{p})$ be a probability space and $\left(g_{n}(\omega)\right)_{n \in \mathbb{Z}}$ a sequence of independent complex normalised gaussians, $g_{n} \in \mathcal{N}_{\mathbb{C}}(0,1)$. We can write

g_{n}(\omega)=\frac{1}{\sqrt{2}}\left(h_{n}(\omega)+i l_{n}(\omega)\right) \tag{1.3}
\end{equation*}
$$

where $\left(h_{n}(\omega)\right)_{n \in \mathbb{Z}},\left(l_{n}(\omega)\right)_{n \in \mathbb{Z}}$ are independent standard real Gaussians $\mathcal{N}_{\mathbb{R}}(0,1)$.

### 1.1. Definition of the measure for (1.1). -

In the sequel we will use the notation $\langle n\rangle=\sqrt{n^{2}+1}$.
Now write $c_{n}=a_{n}+i b_{n}$.
For $N \geq 1$, consider the probability measure on $\mathbb{R}^{2(2 N+1)}$ defined by

\mathrm{d} \mu_{N}=d_{N} \prod_{n=-N}^{N} e^{-\langle n\rangle^{2}\left(a_{n}^{2}+b_{n}^{2}\right)} \mathrm{d} a_{n} \mathrm{~d} b_{n} \tag{1.4}
\end{equation*}
$$

where $d_{N}$ is such that

\begin{align*}
& \frac{1}{d_{N}}=\prod_{n=-N}^{N} \int_{\mathbb{R}^{2}} e^{-\langle n\rangle^{2}\left(a_{n}^{2}+b_{n}^{2}\right)} \mathrm{d} a_{n} \mathrm{~d} b_{n}  \tag{1.5}\\
&=\pi^{2 N+1}\left(\prod_{n=-N}^{N} \frac{1}{\langle n\rangle}\right)^{2}=\pi^{2 N+1}\left(\prod_{n=1}^{N} \frac{1}{\langle n\rangle}\right)^{4}
\end{align*}
$$

The measure $\mu_{N}$ defines a measure on $E_{N}$ via the map

$$
\left(a_{n}, b_{n}\right)_{n=-N}^{N} \longmapsto \sum_{n=-N}^{N}\left(a_{n}+i b_{n}\right) e^{i n x}
$$

which will still be denoted by $\mu_{N}$. Then $\mu_{N}$ may be seen as the distribution of the $E_{N}$ valued random variable

\omega \longmapsto \sum_{|n| \leq N} \frac{g_{n}(\omega)}{\langle n\rangle} \mathrm{e}^{i n x} \equiv \varphi_{N}(\omega, x), \tag{1.6}
\end{equation*}
$$

where $\left(g_{n}\right)_{n=-N}^{N}$ are Gaussians as in (1.3).

Let $\sigma<\frac{1}{2}$. Then $\left(\varphi_{N}\right)$ is a Cauchy sequence in $L^{2}\left(\Omega ; H^{\sigma}(\mathbb{T})\right)$ which defines

\begin{equation*}
\varphi(\omega, x)=\sum_{n \in \mathbb{Z}} \frac{g_{n}(\omega)}{\langle n\rangle} \mathrm{e}^{i n x} \tag{1.7}
\end{equation*}
$$

as the limit of $\left(\varphi_{N}\right)$. Indeed, the map

$$
\omega \longmapsto \sum_{n \in \mathbb{Z}} \frac{g_{n}(\omega)}{\langle n\rangle} \mathrm{e}^{i n x}
$$

defines a (Gaussian) measure on $H^{\sigma}(\mathbb{T})$ which will be denoted by $\mu$.

For $u \in L^{2}(\mathbb{T})$, we will write $u_{N}=\Pi_{N} u$. Now define

f_{N}(u)=\operatorname{Im} \int_{\mathbb{T}} \overline{u_{N}^{2}(x)} \partial_{x}\left(u_{N}^{2}(x)\right) \mathrm{d} x
$$

Let $\kappa>0$, and let $\chi: \mathbb{R} \longrightarrow \mathbb{R}, 0 \leq \chi \leq 1$ be a continuous function with support supp $\chi \subset[-\kappa, \kappa]$ and so that $\chi=1$ on $\left[-\frac{\kappa}{2}, \frac{\kappa}{2}\right]$. We define the density

G_{N}(u)=\chi\left(\left\|u_{N}\right\|_{L^{2}(\mathbb{T})}\right) \mathrm{e}^{\frac{3}{4} f_{N}(u)-\frac{1}{2} \int_{\mathbb{T}}\left|u_{N}(x)\right|^{6} \mathrm{~d} x} \tag{1.8}
\end{equation*}
$$

and the measure $\rho_{N}$ on $H^{\sigma}(\mathbb{T})$ by

$$
\begin{equation*}
\mathrm{d} \rho_{N}(u)=G_{N}(u) \mathrm{d} \mu(u) . \tag{1.9}
\end{equation*}
$$

1.2. Statement of the main result. -

Our main result which defines a formally invariant measure for (1.1) reads
Theorem 1.1. - The sequence $G_{N}(u)$ defined in (1.8) converges in measure, as $N \rightarrow \infty$, with respect to the measure $\mu$. Denote by $G(u)$ the limit of (1.8) as $N \rightarrow \infty$, and we define $d \rho(u) \equiv G(u) d \mu(u)$.

Moreover, for every $p \in\left[1, \infty\left[\right.\right.$, there exists $\kappa_{p}>0$ so that for all $0<\kappa \leq \kappa_{p}$, $G(u) \in L^{p}(d \mu(u))$ and the sequence $G_{N}$ converges to $G$ in $L^{p}(d \mu(u))$, as $N$ tends to infinity.

Remark 1.2. - In particular, for any Borel set $A \subset H^{\sigma}(\mathbb{T}), \lim _{N \rightarrow \infty} \rho_{N}(A)=$ $\rho(A)$.

It is not clear to us how to prove the convergence property, if we define $\rho_{N}$ as follows : For any Borel set $A \subset H^{\sigma}(\mathbb{T}), \rho_{N}(A)=\tilde{\rho}_{N}\left(A \cap E_{N}\right)$ where $\mathrm{d} \tilde{\rho}_{N}=G_{N}(u) \mathrm{d} \mu_{N}(u)$. In particular, the convergence stated in [11, Theorem 1] is not proven there. However, if we define in the context of [11] $\rho_{N}$ as we did here, the convergence property holds true. In addition the measure $\rho_{N}$ defined here (see also [4]) is more natural, since it is invariant by the truncated flow $\Phi_{N}(t)$ of equation (A.16).

One can show that by varying the cut-off $\chi$, the support of $\rho$ describes the support of $\mu$ (see Lemma 4.3 below).

The main ideas of this paper come from the work of the second author [11] where a similar construction is made for the Benjamin-Ono equation using the pioneering work of Bourgain [3]. In [11], one of the main difficulties is that on the support of the measure $\mu$, the $L^{2}$ norm is a.s. infinite, which is not the case in our setting, since for any $\sigma<\frac{1}{2}, \varphi(\omega) \in H^{\sigma}(\mathbb{T})$, for almost all $\omega \in \Omega$. Here the difficulty is to treat the term $\int_{\mathbb{T}} \bar{u}^{2} \partial_{x}\left(u^{2}\right) \mathrm{d} x$ in the conserved
quantity $H$. Roughly speaking, it should be controlled by the $H^{\frac{1}{2}}$ norm, but this is not enough, since $\|u\|_{H^{\frac{1}{2}}(\mathbb{T})}=\infty$ on the support of $\mathrm{d} \mu$. However, we will see in Section 2, that we can handle this term thanks to an adapted decomposition and thanks to the integrability properties of the Gaussians. This is the main new idea in this paper.

The result of Theorem 1.1 may be the first step to obtain almost sure global well-posedness for (1.1), with initial conditions of the form (1.7). To reach such a result, we will also need a suitable local existence theory on the statistical set, and prove the invariance of the measure $\mathrm{d} \rho$ under this flow. For instance, this program was fruitful for Bourgain [2, 3] and Zhidkov $[14]$ for NLS on the torus, Tzvetkov [12, 13 for NLS on the disc, BurqTzvetkov [5] for the wave equation, Oh [8, $\mathbf{9}$ for Schrödinger-Benjamin-Ono and KdV systems, and Burq-Thomann-Tzvetkov [4] for the one-dimensional Schrödinger equation. For the DNLS equation, we plan to pursue this issue in a subsequent work.

### 1.3. Notations and structure of the paper. -

Notations. - In this paper c, C denote constants the value of which may change from line to line. These constants will always be universal, or uniformly bounded with respect to the other parameters.
We denote by $\mathbb{Z}$ (resp. $\mathbb{N}$ ) the set of the integers (resp. non negative integers), and $\mathbb{N}^{*}=\mathbb{N} \backslash\{0\}$.
For $x \in \mathbb{R}$, we write $\langle x\rangle=\sqrt{x^{2}+1}$. For $u \in L^{2}(\mathbb{T})$, we usually write $u_{N}=$ $\Pi_{N} u$, where $\Pi_{N}$ is the projector defined in (1.2).
The notation $L^{q}$ stands for $L^{q}(\mathbb{T})$ and $H^{s}=H^{s}(\mathbb{T})$.
The paper is organised as follows. In Section 2 we give some large deviation bounds and some results on the Wiener chaos at any order. In Section 3 we study the term of the Hamiltonian containing the derivative, and Section 4 is devoted to the proof of Theorem 1.1.
In the appendix, we give the Hamiltonian formulation of the transformed form of (1.1).

## 2. Preliminaries : some stochastic estimates

### 2.1. Large deviation estimates. -

Lemma 2.1. - Let $\left(\gamma_{n}(\omega)\right)_{n \in \mathbb{Z}} \in \mathcal{N}_{\mathbb{R}}(0,1)$ be a sequence of independent, normalised real Gaussians. Let $\left(c_{n}\right)_{n \in \mathbb{Z}},\left(d_{n}\right)_{n \in \mathbb{Z}}$ be two bounded sequences of real numbers. Then there exist $c, C>0$ so that for all $1 \leq N \leq \lambda$

\mathbf{p}\left(\omega \in \Omega:\left|\sum_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \frac{c_{n_{1}} d_{n_{2}}}{\left\langle n_{1}\right\rangle} \gamma_{n_{1}}(\omega) \gamma_{n_{2}}(\omega)\right|>\lambda\right) \leq C e^{-c \lambda}
$$

Proof. - We estimate

$$
A_{\lambda, N} \equiv \mathbf{p}\left(\omega \in \Omega: \sum_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \frac{c_{n_{1}} d_{n_{2}}}{\left\langle n_{1}\right\rangle} \gamma_{n_{1}}(\omega) \gamma_{n_{2}}(\omega)>\lambda\right)
$$

For all $t>0$ and all r.v. $X$ we have, by the Tchebychev inequality

$$
\begin{equation*}
\mathbf{p}(\omega \in \Omega: X>\lambda) \leq \mathrm{e}^{-\lambda t} \mathbb{E}\left[\mathrm{e}^{t X}\right] \tag{2.1}
\end{equation*}
$$

Thus we obtain that for all $\varepsilon>0$

$$
\begin{align*}
A_{\lambda, N} & \leq \mathrm{e}^{-t \lambda} \mathbb{E}\left[\prod_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \mathrm{e}^{t \frac{c_{1} d_{n_{2}} \gamma_{n_{1}} \gamma_{n_{2}}}{\left\langle n_{1}\right\rangle} \gamma^{2}}\right] \\
& \leq \mathrm{e}^{-t \lambda} \mathbb{E}\left[\prod_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \mathrm{e}^{\frac{\varepsilon}{2} \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}} \gamma_{n_{1}}^{2}+\frac{1}{2 \varepsilon} t^{2} d_{n_{2}}^{2} \gamma_{n_{2}}^{2}}\right] \\
& =\mathrm{e}^{-t \lambda} \mathbb{E}\left[\left(\prod_{\left|n_{1}\right| \leq N} \mathrm{e}^{\frac{\varepsilon}{2} \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}} \gamma_{n_{1}}^{2}}\right)\left(\prod_{\left|n_{2}\right| \leq N} \mathrm{e}^{\frac{1}{2 \varepsilon} t^{2} d_{n_{2}}^{2} \gamma_{n_{2}}^{2}}\right)\right] \tag{2.2}
\end{align*}
$$

Now, the Cauchy-Schwarz inequality and the independence of the $\gamma_{n}$ give

$$
\begin{align*}
A_{\lambda, N} & \leq \mathrm{e}^{-t \lambda} \mathbb{E}\left[\prod_{\left|n_{1}\right| \leq N} \mathrm{e}^{\varepsilon \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}} \gamma_{n_{1}}^{2}}\right]^{\frac{1}{2}} \mathbb{E}\left[\prod_{\left|n_{2}\right| \leq N} \mathrm{e}^{t^{2} d_{n_{2}}^{2} \gamma_{n_{2}}^{2} / \varepsilon}\right]^{\frac{1}{2}} \\
& =\mathrm{e}^{-t \lambda}\left(\prod_{\left|n_{1}\right| \leq N} \mathbb{E}\left[\mathrm{e}^{\varepsilon \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}} \gamma_{n_{1}}^{2}}\right] \prod_{\left|n_{2}\right| \leq N} \mathbb{E}\left[\mathrm{e}^{t^{2} d_{n_{2}}^{2} \gamma_{n_{2}}^{2} / \varepsilon}\right]\right)^{\frac{1}{2}} \tag{2.3}
\end{align*}
$$

Thanks to a change of variables we can compute explicitly the expectations in the right hand side of (2.3). In fact for $\mu<\frac{1}{2}$

$$
\mathbb{E}\left[\mathrm{e}^{\mu \gamma_{n}^{2}}\right]=(1-2 \mu)^{-\frac{1}{2}}
$$

For $0 \leq x \leq \frac{1}{2}$, we have the inequality $(1-x)^{-1} \leq \mathrm{e}^{2 x}$, hence we deduce that for $\mu<\frac{1}{4}$

\begin{equation*}
\mathbb{E}\left[\mathrm{e}^{\mu \gamma_{n}^{2}}\right] \leq \mathrm{e}^{2 \mu} \tag{2.4}
\end{equation*}
$$

Recall that $\left(c_{n}\right),\left(d_{n}\right)$ are bounded. We now fix $\varepsilon>0$ so that for all $|n| \leq N$, $\varepsilon \frac{c_{n}^{2}}{\langle n\rangle^{2}} \leq \frac{1}{2}$. Then the bound (2.4) implies

\begin{equation*}
\prod_{\left|n_{1}\right| \leq N} \mathbb{E}\left[\mathrm{e}^{\varepsilon \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}} \gamma_{n_{1}}^{2}}\right] \leq \exp \left(2 \varepsilon \sum_{\left|n_{1}\right| \leq N} \frac{c_{n_{1}}^{2}}{\left\langle n_{1}\right\rangle^{2}}\right) \leq C \tag{2.5}
\end{equation*}
$$

With the previous choice of $\varepsilon>0$ and $t>0$ small enough we also have

$$
\begin{equation*}
\prod_{\left|n_{2}\right| \leq N} \mathbb{E}\left[\mathrm{e}^{t^{2} d_{n_{2}}^{2} \gamma_{n_{2}}^{2} / \varepsilon}\right] \leq \exp \left(2 t^{2} \sum_{\left|n_{2}\right| \leq N} d_{n_{2}}^{2} / \varepsilon\right) \leq \mathrm{e}^{C t^{2} N} \tag{2.6}
\end{equation*}
$$

Finally, from (2.5), (2.6) and (2.3) we infer

$$
A_{\lambda, N} \leq C \mathrm{e}^{-t \lambda+C t^{2} N} \leq C \mathrm{e}^{-c \lambda}
$$

for some $c>0$, if $t>0$ is chosen small enough and $N \leq \lambda$.
Similarly for $\lambda>0$,

$$
\mathbf{p}\left(\omega \in \Omega: \sum_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \frac{c_{n_{1}} d_{n_{2}}}{\left\langle n_{1}\right\rangle} \gamma_{n_{1}}(\omega) \gamma_{n_{2}}(\omega)<-\lambda\right) \leq C \mathrm{e}^{-c \lambda}
$$

and this yields the result.

Lemma 2.2. - Fix $\sigma<\frac{1}{2}$ and $p \in[2, \infty)$. Then
$\exists C>0, \exists c>0, \forall \lambda \geq 1, \forall N \geq 1$,

$$
\mu\left(u \in H^{\sigma}:\left\|\Pi_{N} u\right\|_{L^{p}(\mathbb{T})}>\lambda\right) \leq C e^{-c \lambda^{2}}
$$

Moreover there exists $\beta>0$ such that

$$
\begin{aligned}
& \exists C>0, \exists c>0, \forall \lambda \geq 1, \forall M \geq N \geq 1 \\
& \quad \mu\left(u \in H^{\sigma}:\left\|\Pi_{M} u-\Pi_{N} u\right\|_{L^{p}(\mathbb{T})}>\lambda\right) \leq C e^{-c N^{\beta} \lambda^{2}} .
\end{aligned}
$$

Proof. - This result is consequence of the hypercontractivity of the Gaussian random variables : There exists $C>0$ such that for all $r \geq 2$ and $\left(c_{n}\right) \in l^{2}(\mathbb{N})$

$$
\left\|\sum_{n \geq 0} g_{n}(\omega) c_{n}\right\|_{L^{r}(\Omega)} \leq C \sqrt{r}\left(\sum_{n \geq 0}\left|c_{n}\right|^{2}\right)^{\frac{1}{2}}
$$

See e.g. 4, Lemma 3.3] for the details of the proof.

### 2.2. Wiener chaos estimates. -

The aim of this subsection is to obtain $L^{p}(\Omega)$ bounds on Gaussian series. These are obtained thanks to the smoothing effects of the Ornstein-Uhlenbeck semi-group. The following considerations are inspired from [11]. See also [1, 10] for more details on this topic.

For $d \geq 1$, denote by $L$ the operator

L=\Delta-x \cdot \nabla=\sum_{j=1}^{d}\left(\frac{\partial^{2}}{\partial x_{j}^{2}}-x_{j} \frac{\partial}{\partial x_{j}}\right)
$$

This operator is self adjoint on $\mathcal{K}=L^{2}\left(\mathbb{R}^{d}, \mathrm{e}^{-|x|^{2} / 2} \mathrm{~d} x\right)$ with domain

$$
\mathcal{D}=\left\{u: u(x)=\mathrm{e}^{|x|^{2} / 4} v(x), \quad v \in \mathcal{H}^{2}\right\}
$$

where $\mathcal{H}^{2}=\left\{u \in L^{2}\left(\mathbb{R}^{d}\right), x^{\alpha} \partial_{x}^{\beta} v(x) \in L^{2}\left(\mathbb{R}^{d}\right), \quad \forall(\alpha, \beta) \in N^{2 d},|\alpha|+|\beta| \leq 2\right\}$. Denote by $\mathbf{k}=k_{1}+\cdots+k_{d}$ and by $\left(P_{n}\right)_{n \geq 0}$ the Hermite polynomials defined by

P_{n}(x)=(-1)^{n} \mathrm{e}^{x^{2}} \frac{\mathrm{~d}^{n}}{\mathrm{~d} x^{n}}\left(\mathrm{e}^{-x^{2}}\right)
$$

Then a Hilbertian basis of eigenfunctions of $L$ on $\mathcal{K}$ is given by

$$
P_{\mathbf{k}}\left(x_{1}, \ldots, x_{d}\right)=P_{k_{1}}\left(x_{1}\right) \ldots P_{k_{d}}\left(x_{d}\right)
$$

with eigenvalue $-\mathbf{k}=-\left(k_{1}+\cdots+k_{d}\right)$.
Finally define the measure $\gamma_{d}$ on $\mathbb{R}^{d}$ by

$$
\mathrm{d} \gamma_{d}(x)=(2 \pi)^{-d / 2} \mathrm{e}^{-|x|^{2} / 2} \mathrm{~d} x
$$

The next result is a direct consequence of [11, Proposition 3.1]. See [1] for the proof.

Lemma 2.3. - Let $d \geq 1$ and $k \in \mathbb{N}$. Assume that $\widetilde{P}_{k}$ is an eigenfunction of $L$ with eigenvalue $-k$. Then for all $p \geq 2$

$$
\left\|\widetilde{P}_{k}\right\|_{L^{p}\left(\mathbb{R}^{d}, d \gamma_{d}\right)} \leq(p-1)^{\frac{k}{2}}\left\|\widetilde{P}_{k}\right\|_{L^{2}\left(\mathbb{R}^{d}, d \gamma_{d}\right)}
$$

Thanks to Lemma 2.3, we will prove the following $L^{p}$ smoothing effect for some stochastic series.

## Proposition 2.4 (Wiener chaos). -

Let $d \geq 1$ and $c\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{C}$. Let $\left(g_{n}\right)_{1 \leq n \leq d} \in \mathcal{N}_{\mathbb{C}}(0,1)$ be complex $L^{2}$ normalised independent Gaussians.
For $k \geq 1$ denote by $A(k, d)=\left\{\left(n_{1}, \ldots, n_{k}\right) \in\{1, \ldots, d\}^{k}, n_{1} \leq \cdots \leq n_{k}\right\}$ and

$$
\begin{equation*}
S_{k}(\omega)=\sum_{A(k, d)} c\left(n_{1}, \ldots, n_{k}\right) g_{n_{1}}(\omega) \cdots g_{n_{k}}(\omega) . \tag{2.7}
\end{equation*}
$$

Then for all $d \geq 1$ and $p \geq 2$

$$
\left\|S_{k}\right\|_{L^{p}(\Omega)} \leq \sqrt{k+1}(p-1)^{\frac{k}{2}}\left\|S_{k}\right\|_{L^{2}(\Omega)}
$$

Proof. - Let $g_{n} \in \mathcal{N}_{\mathbb{C}}(0,1)$. Then we can write $g_{n}=\frac{1}{\sqrt{2}}\left(\gamma_{n}+i \widetilde{\gamma}_{n}\right)$ with $\gamma_{n}, \widetilde{\gamma}_{n} \in \mathcal{N}_{\mathbb{R}}(0,1)$ mutually independent Gaussians. Hence, up to a change of indexes (and with $d$ replaced with $2 d$ ) we can assume that the random variables in (2.7) are real valued. Thus in the following we assume that $g_{n} \in \mathcal{N}_{\mathbb{R}}(0,1)$ and are independent.
Denote by

$$
\Sigma_{k}\left(x_{1}, \ldots, x_{d}\right)=\sum_{A(k, d)} c\left(n_{1}, \ldots, n_{k}\right) x_{n_{1}} \cdots x_{n_{k}}
$$

Then obviously for all $p \geq 1$,

$$
\begin{equation*}
\left\|S_{k}\right\|_{L^{p}(\Omega)}=\left\|\Sigma_{k}\right\|_{L^{p}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)} . \tag{2.8}
\end{equation*}
$$

Let $\left(n_{1}, \ldots, n_{k}\right) \in A(k, d)$. Then we can write

$$
x_{n_{1}} \cdots x_{n_{k}}=x_{m_{1}}^{p_{1}} \cdots x_{m_{l}}^{p_{l}},
$$

where $l \leq k, p_{1}+\cdots+p_{l}=k$ and $n_{1}=m_{1}<\cdots<m_{l} \leq n_{k}$. Now, each monomial $x_{m_{j}}^{p_{j}}$ can be expanded on the Hermite polynomials $\left(P_{n}\right)_{n \geq 0}$

x_{m_{j}}^{p_{j}}=\sum_{k_{j}=0}^{p_{j}} \alpha_{j, k_{j}} P_{k_{j}}\left(x_{m_{j}}\right) .
$$

Therefore there exists $\beta\left(k_{1}, \ldots, k_{l}\right) \in \mathbb{C}$ so that

x_{n_{1}} \cdots x_{n_{k}}=\sum_{j=0}^{k} \sum_{\substack{k_{1}+\cdots+k_{l}=j \\ 0 \leq k_{i} \leq p_{i}}} \beta\left(k_{1}, \ldots, k_{l}\right) P_{k_{1}}\left(x_{m_{1}}\right) \cdots P_{k_{l}}\left(x_{m_{l}}\right),
$$

and we have

\begin{equation*}
\Sigma_{k}\left(x_{1}, \ldots, x_{d}\right)=\sum_{j=0}^{k} \widetilde{P}_{j}\left(x_{1}, \ldots, x_{d}\right), \tag{2.9}
\end{equation*}
$$

where the polynomial $\widetilde{P}_{j}$ is given by

\begin{aligned}
\widetilde{P}_{j}\left(x_{1}, \ldots,\right. & \left.x_{d}\right) \\
& =\sum_{A(k, d)} \sum_{\substack{k_{1}+\ldots+k_{l}=j \\
0 \leq k_{i} \leq p_{i}}} c\left(n_{1}, \ldots, n_{k}\right) \beta\left(k_{1}, \ldots, k_{l}\right) P_{k_{1}}\left(x_{m_{1}}\right) \cdots P_{k_{l}}\left(x_{m_{l}}\right) .
\end{aligned}
$$

For $0 \leq k_{i} \leq p_{i}$ so that $k_{1}+\cdots+k_{l}=j$, the polynomial $\widetilde{P}_{j}$ is an eigenfunction of $L$ with eigenvalue $-j$, hence by Lemma 2.3 we have that for all $p \geq 2$

$$
\left\|\widetilde{P}_{j}\right\|_{L^{p}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)} \leq(p-1)^{\frac{j}{2}}\left\|\widetilde{P}_{j}\right\|_{L^{2}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)}
$$

Therefore, by (2.9) and by the Cauchy-Schwarz inequality,

\begin{aligned}
\left\|\Sigma_{k}\right\|_{L^{p}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)} & \leq(p-1)^{\frac{k}{2}} \sum_{j=0}^{k}\left\|\widetilde{P}_{j}\right\|_{L^{2}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)} \\
& \leq \sqrt{k+1}(p-1)^{\frac{k}{2}}\left(\sum_{j=0}^{k}\left\|\widetilde{P}_{j}\right\|_{L^{2}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)}^{2}\right)^{\frac{1}{2}} \\
& \leq \sqrt{k+1}(p-1)^{\frac{k}{2}}\left\|\Sigma_{k}\right\|_{L^{2}\left(\mathbb{R}^{d}, \mathrm{~d} \gamma_{d}\right)},
\end{aligned}
$$

where in the last line we used that the polynomials $\widetilde{P}_{j}$ are orthogonal. This concludes the proof by (2.8)

We will need the following lemma which is proved in [11, Lemma 4.5]
Lemma 2.5. - Let $F: H^{\sigma}(\mathbb{T}) \longrightarrow \mathbb{R}$ be a measurable function. Assume that there exist $\alpha>0, N>0, k \geq 1$, and $C>0$ so that for every $p \geq 2$

$$

Then there exist $\delta>0, C_{1}$ independent of $N$ and $\alpha$ such that

$$

As a consequence, for all $\lambda>0$,

\mu\left(u \in H^{\sigma}(\mathbb{T}):|F(u)|>\lambda\right) \leq C_{1} e^{-\delta N^{\frac{2 \alpha}{k}} \lambda^{\frac{2}{k}}}
$$

## 3. Study of the sequence $\left(f_{N}(u)\right)_{N \geq 1}$

Recall that $f_{N}(u)$ is defined by $f_{N}(u)=\operatorname{Im} \int_{\mathbb{T}} \overline{u_{N}^{2}(x)} \partial_{x}\left(u_{N}^{2}(x)\right) \mathrm{d} x$.
The main result of this section is the following
Proposition 3.1. - The sequence $\left(f_{N}\right)_{N \geq 1}$ is a Cauchy sequence in $L^{2}\left(H^{\sigma}(\mathbb{T}), \mathcal{B}, d \mu\right)$. Indeed for all $0<\varepsilon<\frac{1}{2}$ there exists $C>0$ so that for all $M>N \geq 1$

$$
\begin{equation*}
\left\|f_{M}(u)-f_{N}(u)\right\|_{L^{2}\left(H^{\sigma}(\mathbb{T}), \mathcal{B}, d \mu\right)} \leq \frac{C}{N^{\frac{3}{2}-\varepsilon}} . \tag{3.1}
\end{equation*}
$$

Moreover, for all $p \geq 2$ and $M>N \geq 1$

$$
\begin{equation*}
\left\|f_{M}(u)-f_{N}(u)\right\|_{L^{p}\left(H^{\sigma}(\mathbb{T}), \mathcal{B}, d \mu\right)} \leq \frac{C(p-1)^{2}}{N^{\frac{3}{2}-\varepsilon}} . \tag{3.2}
\end{equation*}
$$

Then a combination of the estimate (3.2) and Lemma (2.5) yields the following large deviation estimate

Corollary 3.2. - For every $\alpha<\frac{3}{2}$, there exist $C, \delta>0$ such that for all $M>N \geq 1$ and $\lambda>0$

$$
\mu\left(u \in H^{\sigma}(\mathbb{T}):\left|f_{M}(u)-f_{N}(u)\right|>\lambda\right) \leq C e^{-\delta\left(N^{\alpha} \lambda\right)^{\frac{1}{2}}}
$$

Thanks to Proposition 3.1, we are able to define the limit in $L^{2}(\Omega)$ of the sequence $\left(f_{N}\right)_{N \geq 1}$, which will be denoted by

$$
\begin{equation*}
f(u)=\operatorname{Im} \int_{\mathbb{T}} \overline{u^{2}(x)} \partial_{x}\left(u^{2}(x)\right) \mathrm{d} x . \tag{3.3}
\end{equation*}
$$

This gives a sense to the r.h.s. of (3.3) for $u$ in the support of $\mu$.
Notice that Corollary 3.2 implies in particular the convergence in measure

\forall \varepsilon>0, \quad \lim _{N \rightarrow \infty} \mu\left(u \in \mathcal{H}^{-\sigma}:\left|f_{N}(u)-f(u)\right|>\varepsilon\right)=0 \tag{3.4}
\end{equation*}

For the proof of Proposition [3.1, we have to put $\int_{\mathbb{T}} \overline{\varphi_{N}^{2}(\omega)} \partial_{x}\left(\varphi_{N}^{2}(\omega)\right) \mathrm{d} x$ in a suitable form.
Recall the notation (1.6), then

$$
\begin{equation*}
\varphi_{N}^{2}(\omega)=\sum_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} \frac{g_{n_{1}}(\omega) g_{n_{2}}(\omega)}{\left\langle n_{1}\right\rangle\left\langle n_{2}\right\rangle} \mathrm{e}^{i\left(n_{1}+n_{2}\right) x} \tag{3.5}
\end{equation*}
$$

Therefore we deduce that

$$
\begin{equation*}
\partial_{x}\left(\varphi_{N}^{2}(\omega)\right)=\sum_{\left|m_{1}\right|,\left|m_{2}\right| \leq N} i\left(m_{1}+m_{2}\right) \frac{g_{m_{1}}(\omega) g_{m_{2}}(\omega)}{\left\langle m_{1}\right\rangle\left\langle m_{2}\right\rangle} \mathrm{e}^{i\left(m_{1}+m_{2}\right) x} \tag{3.6}
\end{equation*}
$$

Now, by (3.5), (3.6) and the fact that $\left(e^{i n x}\right)_{n \in \mathbb{Z}}$ is an orthonormal family in $L^{2}(\mathbb{T})$ (endowed with the scalar product $\langle f, g\rangle=\int_{\mathbb{T}} f(x) \bar{g}(x) \mathrm{d} x=$ $\left.\frac{1}{2 \pi} \int_{0}^{2 \pi} f(x) \bar{g}(x) \mathrm{d} x\right)$, we obtain

\int_{\mathbb{T}} \overline{\varphi_{N}^{2}(\omega)} \partial_{x}\left(\varphi_{N}^{2}(\omega)\right) \mathrm{d} x=\sum_{A_{N}} i\left(n_{1}+n_{2}\right) \frac{g_{m_{1}}(\omega) g_{m_{2}}(\omega) \overline{g_{n_{1}}(\omega)} \overline{g_{n_{2}}(\omega)}}{\left\langle m_{1}\right\rangle\left\langle m_{2}\right\rangle\left\langle n_{1}\right\rangle\left\langle n_{2}\right\rangle}, \tag{3.7}
\end{equation*}
$$

where
$A_{N}=\left\{\left(m_{1}, m_{2}, n_{1}, n_{2}\right) \in \mathbb{Z}^{4}\right.$ s.t. $\left|m_{1}\right|,\left|m_{2}\right|,\left|n_{1}\right|,\left|n_{2}\right| \leq N$ and $\left.m_{1}+m_{2}=n_{1}+n_{2}\right\}$.
We now split the sum (3.7) in two parts, by distinguishing the cases $m_{1}=n_{1}$ and $m_{1} \neq n_{1}$ in $A_{N}$ and write

\int_{\mathbb{T}} \overline{\varphi_{N}^{2}(\omega)} \partial_{x}\left(\varphi_{N}^{2}(\omega)\right) \mathrm{d} x=S_{N}^{1}+S_{N}^{2}
$$

with

S_{N}^{1}=\sum_{B_{N}} i\left(n_{1}+n_{2}\right) \frac{g_{m_{1}}(\omega) g_{m_{2}}(\omega) \overline{g_{n_{1}}(\omega)} \overline{g_{n_{2}}(\omega)}}{\left\langle m_{1}\right\rangle\left\langle m_{2}\right\rangle\left\langle n_{1}\right\rangle\left\langle n_{2}\right\rangle} \tag{3.8}
\end{equation*}
$$

where $B_{N}=A_{N} \cap\left\{m_{1}=n_{1}\right.$ or $\left.m_{1}=n_{2}\right\}$, and

$$
\begin{equation*}
S_{N}^{2}=\sum_{\substack{A_{N}, m_{1} \neq n_{1} \\ m_{1} \neq n_{2}}} i\left(n_{1}+n_{2}\right) \frac{g_{m_{1}}(\omega) g_{m_{2}}(\omega) \overline{g_{n_{1}}(\omega)} \overline{g_{n_{2}}(\omega)}}{\left\langle m_{1}\right\rangle\left\langle m_{2}\right\rangle\left\langle n_{1}\right\rangle\left\langle n_{2}\right\rangle} \tag{3.9}
\end{equation*}
$$

### 3.1. Study of $S_{N}^{1}$. -

Lemma 3.3. - Let $S_{N}^{1}$ be defined by (3.8). Then there exists $C>0$ so that for all $M>N>0$,

Proof. - Let $\left(m_{1}, m_{2}, n_{1}, n_{2}\right) \in B_{N}$. Then as $m_{1}+m_{2}=n_{1}+n_{2}$, we have $\left(m_{1}, m_{2}\right)=\left(n_{1}, n_{2}\right)$ or $\left(m_{1}, m_{2}\right)=\left(n_{2}, n_{1}\right)$, and deduce that

S_{N}^{1}=\sum_{\left|n_{1}\right|,\left|n_{2}\right| \leq N} 2 i\left(n_{1}+n_{2}\right) \frac{\left|g_{n_{1}}(\omega)\right|^{2}\left|g_{n_{2}}(\omega)\right|^{2}}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{2}}=X_{N}+Y_{N}
$$

where

$$
X_{N}=\sum_{|n| \leq N} 4 i n \frac{\left|g_{n}(\omega)\right|^{4}}{\langle n\rangle^{4}}
$$

and

$$
Y_{N}=\sum_{\substack{\left|n_{1}\right|,\left|n_{2}\right| \leq N, n_{1} \neq n_{2}}} 2 i\left(n_{1}+n_{2}\right) \frac{\left|g_{n_{1}}(\omega)\right|^{2}\left|g_{n_{2}}(\omega)\right|^{2}}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{2}}
$$

© First we will show that there exists $C>0$ so that for all $M>N>0$,

\left\|X_{M}-X_{N}\right\|_{L^{2}(\Omega)} \leq \frac{C}{N^{2}} \tag{3.10}
\end{equation*}
$$

Let $M>N \geq 1$. Then

\left|X_{M}-X_{N}\right|^{2}=\sum_{N<\left|n_{1}\right|,\left|n_{2}\right| \leq M} 16 n_{1} n_{2} \frac{\left|g_{n_{1}}(\omega)\right|^{4}\left|g_{n_{2}}(\omega)\right|^{4}}{\left\langle n_{1}\right\rangle^{4}\left\langle n_{2}\right\rangle^{4}}
$$

Thus

\left\|X_{M}-X_{N}\right\|_{L^{2}(\Omega)}^{2} \leq C \sum_{N<\left|n_{1}\right|,\left|n_{2}\right| \leq M} \frac{1}{\left\langle n_{1}\right\rangle^{3}\left\langle n_{2}\right\rangle^{3}} \leq \frac{C}{N^{4}}
$$

which proves (3.10).
$\boldsymbol{\phi}$ To complete the proof of Lemma 3.3, it remains to check that there exists $C>0$ so that for all $M>N>0$,

\left\|Y_{M}-Y_{N}\right\|_{L^{2}(\Omega)} \leq \frac{C}{N^{\frac{3}{2}}} \tag{3.11}
\end{equation*}

For $M \geq N \geq 1$ we write

& =Y_{N}^{1}+Y_{N}^{2}+Y_{N}^{3}
\end{aligned}

with

\begin{align*}
& Y_{N}^{1}=\sum_{\substack{\left|n_{1}\right|,\left|n_{2}\right| \leq N, n_{1} \neq n_{2}}} i\left(n_{1}+n_{2}\right) \frac{\left(\left|g_{n_{1}}(\omega)\right|^{2}-1\right)\left(\left|g_{n_{2}}(\omega)\right|^{2}-1\right)}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{2}}  \tag{3.12}\\
& Y_{N}^{2}=\sum_{\substack{\left|n_{1}\right|,\left|n_{2}\right| \leq N, n_{1} \neq n_{2}}} i\left(n_{1}+n_{2}\right) \frac{\left(\left|g_{n_{1}}(\omega)\right|^{2}-1\right)+\left(\left|g_{n_{2}}(\omega)\right|^{2}-1\right)}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{2}} \tag{3.13}
\end{align*}
$$

and

$$
Y_{N}^{3}=\sum_{\substack{\left|n_{1}\right|,\left|n_{2}\right| \leq N, n_{1} \neq n_{2}}} i\left(n_{1}+n_{2}\right) \frac{1}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{2}} .
$$

By the symmetry $\left(n_{1}, n_{2}\right) \mapsto\left(-n_{1},-n_{2}\right)$, we have that $Y_{N}^{3}=0$. For $n \in \mathbb{Z}$, denote by

G_{n}(\omega)=\left|g_{n}(\omega)\right|^{2}-1
$$

Let $n \neq m$. Then, since $g_{n}$ and $g_{m}$ are independent and since $\mathbb{E}\left[\left|g_{n}(\omega)\right|^{2}\right]=1$, we have

\begin{aligned}
C_{M, N}=\left\{\left(m_{1}, m_{2}, n_{1}, n_{2}\right) \in \mathbb{Z}^{4} \text { s.t. } N<\left|m_{1}\right|,\right. & \left|m_{2}\right|,\left|n_{1}\right|,\left|n_{2}\right| \leq M \\
& \text { and } \left.m_{1} \neq m_{2}, \quad n_{1} \neq n_{2}\right\} .
\end{aligned}
$$

We compute $\mathbb{E}\left[\left|Y_{M}^{1}-Y_{N}^{1}\right|^{2}\right]$, and thanks to (3.14) we see that only the terms ( $n_{1}=m_{1}$ and $n_{2}=m_{2}$ ) or ( $n_{1}=m_{2}$ and $n_{2}=m_{1}$ ) give some contribution, hence

& \leq C \sum_{N<\left|n_{1}\right|,\left|n_{2}\right| \leq M}\left(\frac{1}{\left\langle n_{1}\right\rangle^{2}\left\langle n_{2}\right\rangle^{4}}+\frac{1}{\left\langle n_{1}\right\rangle^{4}\left\langle n_{2}\right\rangle^{2}}\right) \leq \frac{C}{N^{4}} .

and using the symmetries in ( $n_{1}, n_{2}, m_{1}, m_{2}$ ), and with (3.14) we obtain

with $s_{M, N}=\sum_{N<\left|n_{2}\right| \leq M} \frac{1}{\left\langle n_{2}\right\rangle^{2}} \leq \frac{C}{N}$.
Similarly, using that $\sum_{N<\left|m_{2}\right| \leq M} \frac{m_{2}}{\left\langle m_{2}\right\rangle^{2}}=0$, we obtain

\left|n_{1}\right|,\left|n-n_{1}\right| \geq N}}\left(\frac{1}{\left\langle n_{1}\right\rangle^{\frac{3}{2}+\varepsilon}}+\frac{1}{\left\langle n-n_{1}\right\rangle^{\frac{3}{2}+\varepsilon}}\right) \leq \frac{C}{N^{\frac{3}{2}-\varepsilon}\langle n\rangle^{\frac{3}{2}+\varepsilon}},
\end{aligned}

where

D_{M, N}=\left\{\left(m_{1}, m_{2}, n_{1}, n_{2}\right)\right. & \in \mathbb{Z}^{4} \text { s.t. } N<\left|m_{1}\right|,\left|m_{2}\right|,\left|n_{1}\right|,\left|n_{2}\right| \leq M \\
& \text { and } \left.m_{1}+m_{2}=n_{1}+n_{2}, \quad m_{1} \neq n_{1}, \quad m_{1} \neq n_{2}\right\} .
\end{aligned}

The expectation of each term of the previous sum vanishes, unless $\left(\left(m_{1}, m_{2}\right)=\right.$ $\left(q_{1}, q_{2}\right)$ or $\left.\left(q_{2}, q_{1}\right)\right)$ and $\left(\left(n_{1}, n_{2}\right)=\left(p_{1}, p_{2}\right)\right.$ or $\left.\left(p_{2}, p_{1}\right)\right)$. Hence

& =C \sum_{n \in \mathbb{Z}} n^{2}\left(\sum_{\left|n_{1}\right|,\left|n-n_{1}\right|>N} \frac{1}{\left\langle n_{1}\right\rangle^{2}\left\langle n-n_{1}\right\rangle^{2}}\right)^{2} \\
& \leq \frac{C}{N^{3-2 \varepsilon}} \sum_{n \in \mathbb{Z}} \frac{n^{2}}{\langle n\rangle^{3+2 \varepsilon}} \leq \frac{C}{N^{3-2 \varepsilon}}
\end{aligned}

The results of Lemmas 3.3 and 3.5 imply (3.1).
To complete the proof of Proposition 3.1, it remains to show (3.2). But this is a direct consequence of (3.1) and Proposition 2.4

We are now able to define the density $G: H^{\sigma}(\mathbb{T}) \longrightarrow \mathbb{R}$ (with respect to the measure $\mu$ ) of the measure $\rho$. By (3.4) and Proposition 3.1 and Lemma 2.2, we have the following convergences in the $\mu$ measure : $f_{N}(u)$ converges to $f(u)$ and $\left\|u_{N}\right\|_{L^{6}(\mathbb{T})}$ to $\|u\|_{L^{6}(\mathbb{T})}$. Then, by composition and multiplication of continuous functions, we obtain
$\chi\left(\left\|u_{N}\right\|_{L^{2}(\mathbb{T})}\right) \mathrm{e}^{\frac{3}{4} f_{N}(u)-\frac{1}{2} \int_{\mathbb{T}}\left|u_{N}(x)\right|^{6} \mathrm{~d} x} \longrightarrow \chi\left(\|u\|_{L^{2}(\mathbb{T})}\right) \mathrm{e}^{\frac{3}{4} f(u)-\frac{1}{2} \int_{\mathbb{T}}|u(x)|^{6} \mathrm{~d} x} \equiv G(u)$, in measure, with respect to the measure $\mu$. As a consequence, $G$ is measurable from $\left(H^{\sigma}(\mathbb{T}), \mathcal{B}\right)$ to $\mathbb{R}$.

## 4. Integrability of the density of $\mathrm{d} \rho$

We now state a result which will be useful for the $L^{p}$ estimates in Theorem 1.1.

Proposition 4.1. - There exist $\kappa_{0}>0$ and $c, C>0$ so that for all $0<\kappa \leq$ $\kappa_{0}, \lambda \geq 2$ and $1 \leq N \leq \lambda$

\mu\left(u \in H^{\sigma}(\mathbb{T}):\left\|\partial_{x}\left(u_{N}^{2}\right)\right\|_{L^{\infty}(\mathbb{T})}>\lambda, \quad\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa\right) \leq C e^{-c \lambda}
$$

Proof. - We can follow the mains lines of the proof of [11, Proposition 4.1]. For $j \in\left\{0, \cdots,\left[\lambda^{5}\right]\right\}$, we define the points $x_{j} \in \mathbb{T}$ by $x_{j}=\frac{2 \pi j}{\lambda^{5}}$.
Denote by dist the distance on $\mathbb{T}$. Then by construction, $\operatorname{dist}\left(x_{j}, x_{j+1}\right) \leq \frac{2 \pi}{\lambda^{5}}$, with $x_{\left[\lambda^{5}\right]+1} \equiv x_{0}$. We define the set $K_{\lambda}$ by

and the sets $K_{\lambda, j}$ by

- As in [11] we will show that

Let $u \in K_{\lambda}$, and denote by $v_{N}=\partial_{x}\left(u_{N}^{2}\right)$. Let $x^{\star} \in \mathbb{T}$ be such that

& \leq C N^{\frac{5}{2}}\left\|u_{N}\right\|_{L^{2}(\mathbb{T})}^{2} \leq C \lambda^{\frac{5}{2}} \kappa^{2} \tag{4.4}
\end{align*}

Therefore, from (4.2), (4.3) and (4.4) we deduce that for $\kappa>0$ small enough

As in [11, we can forget the $L^{2}$ constraint and write

& \quad\left\{\omega \in \Omega:\left|\operatorname{Re} \partial_{x}\left(\varphi_{N}^{2}\right)\left(x_{j}\right)\right| \geq \frac{\lambda}{4}\right\} \cup\left\{\omega \in \Omega:\left|\operatorname{Im} \partial_{x}\left(\varphi_{N}^{2}\right)\left(x_{j}\right)\right| \geq \frac{\lambda}{4}\right\} .
\end{aligned}

Indeed we can describe the previous sets by the following way. Write

and use that $g_{n}(\omega)=\frac{1}{\sqrt{2}}\left(h_{n}(\omega)+i l_{n}(\omega)\right)$ where $\left(h_{n}\right)_{n \in \mathbb{Z}},\left(l_{n}\right)_{n \in \mathbb{Z}} \in \mathcal{N}_{\mathbb{R}}(0,1)$ are independent. Then a straightforward computation enables us to put $\operatorname{Re} \partial_{x}\left(\varphi_{N}^{2}\right)\left(x_{j}\right)$ and $\operatorname{Im} \partial_{x}\left(\varphi_{N}^{2}\right)\left(x_{j}\right)$ in the form

with $\left|c_{n}\right|,\left|d_{n}\right| \leq C$ and where $\left(\gamma_{n}\right)_{n \in \mathbb{Z}} \in \mathcal{N}_{\mathbb{R}}(0,1)$ is an independent family of real Gaussians (indeed $\gamma_{n}=h_{n}$ or $\gamma_{n}=l_{n}$ ). Therefore we can apply the Lemma 2.1 to get

Proof. - Here we can follow the proof of [11, Proposition 4.9]. To prove the proposition, it is sufficient to show that the integral

On the support of $\chi,\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa$, thus we have

Then by Proposition4.1 (which can be applied, since $N \leq N_{0}=\ln \lambda \leq \frac{c_{1}}{\kappa^{2}} \ln \lambda$ for $\kappa>0$ small enough), we obtain

\mu\left(A_{\lambda, N}\right) & \leq \mu\left(u \in H^{\sigma}:\left|f_{N}(u)\right|>\frac{4}{3} \ln \lambda,\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa\right) \\
& \leq \mu\left(u \in H^{\sigma}:\left\|\partial_{x}\left(u_{N}^{2}\right)\right\|_{L^{\infty}(\mathbb{T})}>\frac{c_{1}}{\kappa^{2}} \ln \lambda,\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa\right) \\
& \leq C \mathrm{e}^{-\frac{c_{2}}{\kappa^{2}} \ln \lambda}=C \lambda^{-\frac{c_{2}}{\kappa^{2}}}
\end{aligned}
$$

where $c_{2}$ is independent of $\kappa$. Hence the integral (4.6) is convergent if $\kappa=$ $\kappa_{p}>0$ is small enough.

- Assume now $N>N_{0}$.

Thanks to the triangle inequality $A_{\lambda, N} \subset B_{\lambda, N} \cup C_{\lambda, N}$, where

B_{\lambda, N} \equiv\left\{u \in H^{\sigma}:\left|f_{N_{0}}(u)\right|>\frac{1}{2} \ln \lambda, \quad\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa\right\}

C_{\lambda, N} \equiv\left\{u \in H^{\sigma}:\left|f_{N}(u)-f_{N_{0}}(u)\right|>\frac{1}{2} \ln \lambda,\left\|u_{N}\right\|_{L^{2}(\mathbb{T})} \leq \kappa\right\}
$$

The measure of $B_{\lambda, N}$ can be estimated exactly as we did in the analysis of the case $N_{0} \geq N$. Finally, by Corollary 3.2, as $N_{0}=\ln \lambda$, we obtain that for all
$1<\alpha<\frac{3}{2}$

$$
\mu\left(C_{\lambda, N}\right) \leq C e^{-\delta(\ln \lambda)^{\frac{1+\alpha}{2}}} \leq C_{L} \lambda^{-L}
$$

for all $L \geq 1$. This completes the proof of the proposition.
Proof of Theorem 1.1. - Recall (3.21). Let $p \in[1,+\infty)$ and choose $\kappa_{p}>0$ so that Proposition 4.2 holds. Then there exists a subsequence $G_{N_{k}}(u)$ so that $G_{N_{k}}(u) \longrightarrow G(u), \mu$ a.s. Then by Fatou's lemma,

\int_{H^{\sigma}(\mathbb{T})}|G(u)|^{p} \mathrm{~d} \mu(u) \leq \liminf _{k \rightarrow \infty} \int_{H^{-\sigma}(\mathbb{T})}\left|G_{N_{k}}(u)\right|^{p} \mathrm{~d} \mu(u) \leq C
$$

thus $G(u) \in L^{p}(\mathrm{~d} \mu(u))$.
Now it remains to check the convergence in $L^{p}(\mathrm{~d} \mu(u))$ for $1 \leq p<\infty$. As in [11], for $N \geq 0$ and $\varepsilon>0$, we introduce the set

A_{N, \varepsilon}=\left\{u \in H^{\sigma}(\mathbb{T}):\left|G_{N}(u)-G(u)\right| \leq \varepsilon\right\}
$$

and denote by $\overline{A_{N, \varepsilon}}$ its complement.
Firstly, there exists $C>0$ so that for all $N \geq 0, \varepsilon>0$

\int_{A_{N, \varepsilon}}\left|G_{N}(u)-G(u)\right|^{p} \mathrm{~d} \mu(u) \leq C \varepsilon^{p}
$$

Secondly, by Cauchy-Schwarz, Proposition 4.2 and as $G(u) \in L^{2 p}(\mathrm{~d} \mu(u))$, we obtain

\begin{aligned}
\int_{\overline{A_{N, \varepsilon}}}\left|G_{N}(u)-G(u)\right|^{p} \mathrm{~d} \mu(u) & \leq\left\|G_{N}-G\right\|_{L^{2 p}(\mathrm{~d} \mu)}^{p} \mu\left(\overline{A_{N, \varepsilon}}\right)^{\frac{1}{2}} \\
& \leq C \mu\left(\overline{A_{N, \varepsilon}}\right)^{\frac{1}{2}} .
\end{aligned}
$$

By (3.21), we deduce that for all $\varepsilon>0$,

\mu\left(\overline{A_{N, \varepsilon}}\right) \longrightarrow 0, \quad N \longrightarrow+\infty
$$

which yields the result. This ends the proof of Theorem 1.1.
Lemma 4.3. - The measure $\rho$ is not trivial
Proof. - First observe that for all $\kappa>0$

\mu\left(u \in H^{\sigma}(\mathbb{T}):\|u\|_{L^{2}(\mathbb{T})} \leq \kappa\right)=\mathbf{p}\left(\omega \in \Omega: \sum_{n \in \mathbb{Z}} \frac{1}{\langle n\rangle^{2}}\left|g_{n}(\omega)\right|^{2} \leq \kappa^{2}\right)>0
$$

Then, by Lemma 2.2 and Proposition 3.1, the quantities $\|u\|_{L^{6}(\mathbb{T})}$ and $f(u)$ are $\mu$ almost surely finite. Hence, the density of $\rho$ does not vanish on a set of positive $\mu$ measure. In other words, $\rho$ is not trivial.

## Appendix

A.1. Hamiltonian structure of the transformed form of (1.1). - In this section we give the Hamiltonian structure of the equation related to (1.1). First we define the projection $\Pi$ on the 0 -mean functions :

Proposition A.2. - The system (A.4) is a Hamiltonian formulation of the equation

& =-i \partial_{x}^{2} v+\partial_{x}\left(u v^{2}\right)-v \int_{\mathbb{T}}\left(v \partial_{x} u-u \partial_{x} v\right)-\frac{3}{2} i u \int_{\mathbb{T}} u^{2} v^{2}
\end{aligned}
$$

Now assume that $v=\bar{u}$. This yields the result, as

## A.2. Invariance of the measure $\rho_{N}$ under a truncated flow of (A.5).

 - We present here a natural finite dimensional approximation of (A.5) for which $\rho_{N}$ is an invariant measure.Let $N \geq 1$. Recall that $E_{N}$ is the the complex vector space $E_{N}=\operatorname{span}\left(\left(\mathrm{e}^{i n x}\right)_{-N \leq n \leq N}\right)$, and that $\Pi_{N}$ is the spectral projector from $L^{2}(\mathbb{T})$ to $E_{N}$.

Let $K$ be given by (A.1), and consider the following system

Proposition A.4. - The equation (A.16) has a well-defined global flow $\Phi_{N}$. Moreover, the measure $\rho_{N}$ is invariant under $\Phi_{N}$ : For any Borel set $A \subset$ $H^{\sigma}(\mathbb{T})$ and for all $t \in \mathbb{R}, \rho_{N}\left(\Phi_{N}(t)(A)\right)=\rho_{N}(A)$.

For the proof of Proposition A.4 we first need the following result

is an Hamiltonian ODE. Moreover, the mass $\|u(t)\|_{L^{2}(\mathbb{T})}$ is conserved under the flow of (A.17). As a consequence, (A.17) has a well-defined global flow $\widetilde{\Phi}_{N}$.
Proof. - The first statement is clear by the previous construction. We now check that the $L^{2}$-norm of $u$ is conserved. Finally by ( $\left(\widehat{\text { A.18) }}\right.$, (A.19) and ( $\left(\widehat{\mathrm{A} .20)}\right.$ we obtain that $\frac{d}{d t}\|u(t)\|_{L^{2}(\mathbb{T})}^{2}=0$ which yields the result.

Recall the definitions (1.4) of $\mu_{N}$ and (1.8) of $G_{N}$. Then we define the measure $\widetilde{\rho}_{N}$ on $E_{N}$ by

$$
\mathrm{d} \widetilde{\rho}_{N}(u)=G_{N}(u) \mathrm{d} \mu_{N}(u) .
$$

Then we have
Lemma A.6. - The measure $\widetilde{\rho}_{N}$ is invariant under the flow $\widetilde{\Phi}_{N}$ of (A.17).
Proof. - The proof is a direct application of the Liouville thereom. See e.g. 4, Section 8] for a similar argument.

Proof of Proposition A.4 - We decompose the space $H^{\sigma}(\mathbb{T})=E_{N}^{\perp} \oplus E_{N}$. From the previous analysis, we observe that the flow $\Phi_{N}$ of (A.16) is given by $\Phi_{N}=\left(I d, \widetilde{\Phi}_{N}\right)$. Finally, the invariance of $\rho_{N}$ follows from Lemma A. 6 and invariance of the Gaussian measure under the trivial flow on the high frequency part.
