# Infinitely many positive solutions for a Schrödinger-Poisson system *

#### Abstract

We are interested in the existence of infinitely many positive solutions of the Schrödinger-Poisson system $$
\begin{cases}-\Delta u+u+V(|x|) \phi u=|u|^{p-1} u, & x \in \mathbb{R}^{3} \\ -\Delta \phi=V(|x|) u^{2}, & x \in \mathbb{R}^{3}\end{cases}
$$ where $V(|x|)$ is a positive bounded function, $1<p<5$ and $V(r), r=|x|$ has the following decay property: $$
V(r)=\frac{a}{r^{m}}+O\left(\frac{1}{r^{m+\theta}}\right)
$$ with $a>0, m>\frac{3}{2}, \theta>0$. The solutions founded are non-radial.


Keywords. Non autonomous Schrödinger-Poisson system; Perturbation Method.

## 1 Introduction and main results

In this paper we consider the following nonlinear Schrödinger-Poisson system

$$
\begin{cases}-\Delta u+u+V(x) \phi u=|u|^{p-1} u, & x \in \mathbb{R}^{3}  \tag{SP}\\ -\Delta \phi=V(x) u^{2}, & x \in \mathbb{R}^{3}\end{cases}
$$

where $p \in(1,5)$ and $V: \mathbb{R}^{3} \rightarrow \mathbb{R}$ is a non-negative bounded function.
This kind of problem has been introduced in [6] and arises in an interesting physical context. In fact, according to a classical model, the interaction of a charge particle with an electromagnetic field can be described by coupling the nonlinear Schrödinger and the Maxwell equations and so it is also known as Schrödinger-Maxwell system. In our case, $V(x)$ can be interpreted as a changing pointwise charge distribution. There is a wide literature concerning this type of problem in different situations, see for example $[3,4,5,7,8,9,10,12,13,15$, $16,17,19,22]$.

[^0]The equations in $(\mathcal{S P})$ are the Eulero-Lagrange equations of the $C^{2}$-functional $G: H^{1}\left(\mathbb{R}^{3}\right) \times D^{1,2}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$ where

$$
\begin{aligned}
G(u, \phi)= & \frac{1}{2} \int_{\mathbb{R}^{3}}\left(|\nabla u|^{2}+|u|^{2}\right) d x+\frac{1}{2} \int_{\mathbb{R}^{3}} V(x) \phi u^{2} d x-\frac{1}{4} \int_{\mathbb{R}^{3}}|\nabla \phi|^{2} d x \\
& -\frac{1}{p+1} \int_{\mathbb{R}^{3}}|u|^{p+1} d x
\end{aligned}
$$

and the critical points of $G$ are the solutions of $(\mathcal{S P})$. Let us observe that the functional $G$ is unbounded both from above and from below, also modulo compact perturbations. As we shall see in Section 2, for all $u \in H^{1}\left(\mathbb{R}^{3}\right)$, the Poisson equation in $(\mathcal{S P})$ admits a unique solution $\phi_{u} \in D^{1,2}\left(\mathbb{R}^{3}\right)$. Hence we can reduce ourselves to the study of the $C^{2}$ one variable functional $I: H^{1}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$, defined by

$$
\begin{aligned}
I(u) & =G\left(u, \phi_{u}\right) \\
& =\frac{1}{2} \int_{\mathbb{R}^{3}}\left(|\nabla u|^{2}+|u|^{2}\right) d x+\frac{1}{4} \int_{\mathbb{R}^{3}} V(x) \phi_{u} u^{2} d x-\frac{1}{p+1} \int_{\mathbb{R}^{3}}|u|^{p+1} d x .
\end{aligned}
$$

The critical points of $I$ are the solutions of the problem

$$
-\Delta u+u+V(x) \phi_{u} u=|u|^{p-1} u
$$

If $u \in H^{1}\left(\mathbb{R}^{3}\right)$ is a solution of $\left(\mathcal{S P}{ }^{\prime}\right)$, then $\left(u, \phi_{u}\right) \in H^{1}\left(\mathbb{R}^{3}\right) \times D^{1,2}\left(\mathbb{R}^{3}\right)$ is a solution of $(\mathcal{S P})$ and so we will look for solutions of $\left(\mathcal{S P}^{\prime}\right)$.

In this paper we assume that $V$ is a radial function, that is $V(x)=V(|x|)=$ $V(r)$. Moreover we assume that $V$ satisfies the following condition:
(V) there are constants $a>0, m>\frac{3}{2}, \theta>0$ such that

$$
V(r)=\frac{a}{r^{m}}+O\left(\frac{1}{r^{m+\theta}}\right)
$$

as $r \rightarrow+\infty$.
In what follows, without any loss of generality, we assume $a=1$.
The main result of this paper can be stated as follows:
Theorem 1.1. If $V$ satisfies $(V)$, then the problem $\left(\mathcal{S P}^{\prime}\right)$ has infinitely many non-radial positive solutions.

To prove Theorem 1.1 we will construct solutions with large number of bumps near infinity. In fact, since $V(r) \rightarrow 0$ as $r \rightarrow+\infty$, the solutions of ( $\mathcal{S P}^{\prime}$ ) can be approximated by using the solution $U$ of the following limit problem

$$
\begin{cases}-\Delta u+u=u^{p}, & \text { in } \mathbb{R}^{3},  \tag{1.1}\\ u>0, & \text { in } \mathbb{R}^{3}, \\ u(x) \rightarrow 0, & \text { as }|x| \rightarrow+\infty\end{cases}
$$

For any positive integer $k$, let us define

$$
P_{j}=\left(r \cos \frac{2(j-1) \pi}{k}, r \sin \frac{2(j-1) \pi}{k}, 0\right) \in \mathbb{R}^{3}, \quad j=1, \ldots, k
$$

with $r \in\left[r_{0} k \log k, r_{1} k \log k\right]$ for some $r_{1}>r_{0}>0$ and

$$
z_{r}(x)=\sum_{j=1}^{k} U_{P_{j}}(x),
$$

where $U_{P_{j}}(\cdot):=U\left(\cdot-P_{j}\right)$.
If $x=\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}$, we set
$H_{s}=\left\{\begin{array}{l|l}u \in H^{1}\left(\mathbb{R}^{3}\right) \left\lvert\, \begin{array}{l}u \text { is even in } x_{2}, x_{3} ; \\ u\left(r \cos \theta, r \sin \theta, x_{3}\right)=u\left(r \cos \left(\theta+\frac{2 \pi j}{k}\right), r \sin \left(\theta+\frac{2 \pi j}{k}\right), x_{3}\right) \\ j=1, \ldots, k-1\end{array}\right.\end{array}\right\}$.
Theorem 1.1 is a direct consequence of the following result.
Theorem 1.2. If $V$ satisfies $(V)$, then there exists an integer $k_{0}>0$ such that for all $k \geqslant k_{0},\left(\mathcal{S P}^{\prime}\right)$ has a positive solution $u_{k}$ of the form

$$
u_{k}=z_{r_{k}}+w_{k},
$$

where $r_{k} \in\left[r_{0} k \log k, r_{1} k \log k\right], w_{k} \in H_{s}$ and, as $k \rightarrow+\infty,\left\|w_{k}\right\| \rightarrow 0$.
The proof of Theorem 1.2 relies on a Lyapunov-Schmidt reduction. This technique is almost standard in the perturbation methods, prevalently in the presence of a small parameter (see [2]) and it has been applied to SchrödingerPoisson type system by several authors (see, for example, $[9,15,17]$ ). Here we use $k$ as parameter, that is we use the number of bumps of the solutions in the construction of spike solutions for $\left(\mathcal{S P}^{\prime}\right)$. This idea has been introduced by J. Wei and S. Yan ([20]). They consider the nonlinear Schrödinger equation

$$
-\Delta u+V(|x|) u=u^{p}
$$

with $V(r) \rightarrow V_{0}>0$ as $r \rightarrow+\infty$ and they prove the existence of infinitely many positive non-radial solutions for such equation by using the technique outlined above. This method has also been applied for the study of different problems (see for example [18, 21]). In our case, however, many technical difficulties arise due to the presence of the non-local term $\phi_{u}$ and a more careful analysis of the interaction between the bumps is required.

## 2 Notation and preliminaries

Hereafter we use the following notations:

- $H^{1}\left(\mathbb{R}^{3}\right)$ is the usual Sobolev space endowed with the standard scalar product and norm

$$
(u, v)=\int_{\mathbb{R}^{3}}[\nabla u \nabla v+u v] d x, \quad\|u\|^{2}=\int_{\mathbb{R}^{3}}\left[|\nabla u|^{2}+u^{2}\right] d x ;
$$

- $D^{1,2}\left(\mathbb{R}^{3}\right)$ is the completion of $C_{0}^{\infty}\left(\mathbb{R}^{3}\right)$ with respect to the norm

$$
\|u\|_{D^{1,2}}^{2}=\int_{\mathbb{R}^{3}}|\nabla u|^{2} d x
$$

- $L^{q}\left(\mathbb{R}^{3}\right), 1 \leqslant q \leqslant+\infty$ denotes the usual Lebesgue space with the standard norm $|u|_{q}$;
- for any $\rho>0$ and for any $z \in \mathbb{R}^{3}, B_{\rho}(z)$ denotes the ball of radius $\rho$ centered at $z$ and $B_{\rho}=B_{\rho}(0)$;
- $C, C^{\prime}, C_{i}, \bar{C}$ are various positive constants which may also vary from line to line;
- $A=O\left(\frac{1}{h}\right)$ means that there exists a constant $C>0$ such that $|A| \leqslant C \cdot \frac{1}{h}$. Let us summarize some properties of $\phi_{u}$.

Lemma 2.1. For every $u \in H^{1}\left(\mathbb{R}^{3}\right)$, there exists a unique $\phi_{u} \in D^{1,2}\left(\mathbb{R}^{3}\right)$ solution of $-\Delta \phi=V(x) u^{2}$. Such a solution $\phi_{u}$ is non-negative and the following representation formula holds

$$
\phi_{u}(x)=\int_{\mathbb{R}^{3}} \frac{1}{|x-y|} V(y) u^{2}(y) d y
$$

Moreover:
i) there exist $C, C^{\prime}>0$ independent of $u \in H^{1}\left(\mathbb{R}^{3}\right)$ such that

$$
\left\|\phi_{u}\right\|_{D^{1,2}} \leqslant C|u|_{\frac{12}{5}}^{2}
$$

and

$$
\int_{\mathbb{R}^{3}} V(x) \phi_{u} u^{2} \leqslant C^{\prime}|u|_{\frac{12}{5}}^{4} ;
$$

ii) if $u \in H_{s}$, then $\phi_{u} \in D_{s}$, where

$$
D_{s}=\left\{\begin{array}{l|l}
\phi \in D^{1,2}\left(\mathbb{R}^{3}\right) & \begin{array}{l}
\phi \text { is even in } x_{2}, x_{3} ; \\
\phi\left(r \cos \theta, r \sin \theta, x_{3}\right) \\
j=1, \ldots, k-1
\end{array}
\end{array}=\phi\left(r \cos \left(\theta+\frac{2 \pi j}{k}\right), r \sin \left(\theta+\frac{2 \pi j}{k}\right), x_{3}\right)\right\} ;
$$

iii) for all $v_{1}, v_{2} \in H^{1}\left(\mathbb{R}^{3}\right)$ there holds

$$
\begin{equation*}
\left\|\phi_{v_{1}}-\phi_{v_{2}}\right\|_{D^{1,2}} \leqslant C\left(\left\|v_{1}\right\|+\left\|v_{2}\right\|\right)\left\|v_{1}-v_{2}\right\| \tag{2.1}
\end{equation*}
$$

Proof. The existence and uniqueness of $\phi_{u} \in D^{1,2}\left(\mathbb{R}^{3}\right)$ is a direct application of the Lax-Milgram theorem. Moreover the inequalities in i) are well known (see, for instance, $[6,8,16])$ and here we give the proofs only of ii) and iii).
ii) If $g \in O(3)$ and $u: \mathbb{R}^{3} \rightarrow \mathbb{R}$, let us set

$$
\begin{equation*}
\left(T_{g} u\right)(x)=u(g x) \tag{2.2}
\end{equation*}
$$

Fixed $g \in O(3)$, if $T_{g} u=u$, we have that

$$
-\Delta\left(T_{g} \phi_{u}\right)=T_{g}\left(-\Delta \phi_{u}\right)=T_{g}\left(V(|x|) u^{2}(x)\right)=V(|g x|) u^{2}(g x)=V(|x|) u^{2}(x)=-\Delta \phi_{u}
$$

## and then $T_{g} \phi_{u}=\phi_{u}$.

Since $H_{s}$ and $D_{s}$ are the sets of the fixed points with respect to the action (2.2) for all $g=\left(g_{i, j}\right) \in O(3)$ with

$$
g_{i j}=\left\{\begin{array}{ll}
-1 & i=j, i=2,3 \\
\delta_{i j} & \text { otherwise }
\end{array} \quad \text { or } g=\left(\begin{array}{ccc}
\cos \frac{2 \pi j}{k j} & -\sin \frac{2 \pi j}{k} & 0 \\
\sin \frac{22 j}{k} & \cos \frac{2 \pi j}{k} & 0 \\
0 & 0 & 1
\end{array}\right)\right.
$$

we conclude that if $u \in H_{s}$, then $\phi_{u} \in D_{s}$.
iii) We have

$$
\begin{aligned}
\left\|\phi_{v_{1}}-\phi_{v_{2}}\right\|_{D^{1,2}}^{2} & =\int_{\mathbb{R}^{3}}\left|\nabla\left(\phi_{v_{1}}-\phi_{v_{2}}\right)\right|^{2} d x=\int_{\mathbb{R}^{3}}\left(v_{1}^{2}-v_{2}^{2}\right)\left(\phi_{v_{1}}-\phi_{v_{2}}\right) d x \\
& \leqslant C\left|v_{1}^{2}-v_{2}^{2}\right|_{\frac{6}{5}}\left\|\phi_{v_{1}}-\phi_{v_{2}}\right\|_{D^{1,2}} \\
& \leqslant C\left|v_{1}+v_{2}\right|_{\frac{12}{5}}\left|v_{1}-v_{2}\right|_{\frac{12}{5}}\left\|\phi_{v_{1}}-\phi_{v_{2}}\right\|_{D^{1,2}} \\
& \leqslant C\left(\left\|v_{1}\right\|+\left\|v_{2}\right\|\right)\left\|v_{1}-v_{2}\right\|\left\|\phi_{v_{1}}-\phi_{v_{2}}\right\|_{D^{1,2}} .
\end{aligned}
$$

Analogously, the following lemma holds.
Lemma 2.2. For any $u, v \in H^{1}\left(\mathbb{R}^{3}\right)$, let $\bar{\phi}$ be the solution in $D^{1,2}\left(\mathbb{R}^{3}\right)$ of $-\Delta \bar{\phi}=V(x) u v$. Then

$$
\|\bar{\phi}\|_{D^{1,2}} \leqslant C|V(x) u v|_{\frac{6}{5}} \leqslant C\|u\|\|v\|
$$

and for any $z, w \in H^{1}\left(\mathbb{R}^{3}\right)$

$$
\begin{equation*}
\int_{\mathbb{R}^{3}} V(x) \bar{\phi} z w d x \leqslant C\|\bar{\phi}\|_{D^{1,2}}|V(x) z w|_{\frac{6}{5}} \leqslant C\|u\|\|v\|\|z\|\|w\| . \tag{2.3}
\end{equation*}
$$

Let $\alpha \in(0,1)$, by $(\mathrm{V})$, for any $x \in B_{\alpha r}$ and for $i=1, \ldots, k$, we have that

$$
\begin{equation*}
V\left(x+P_{i}\right)=\frac{1}{\left|x+P_{i}\right|^{m}}+O\left(\frac{1}{\left|x+P_{i}\right|^{m+\theta}}\right) \tag{2.4}
\end{equation*}
$$

Moreover, for any $x \in B_{\alpha r}$ and $\beta>0$

$$
\begin{equation*}
\frac{1}{\left|x+P_{i}\right|^{\beta}}=\frac{1}{\left|P_{i}\right|^{\beta}}\left(1+O\left(\frac{|x|}{\left|P_{i}\right|}\right)\right) . \tag{2.5}
\end{equation*}
$$

Let us evaluate now the distance between the various $P_{i}, i=1, \ldots, k$. Indeed, for $i \neq j$, by making a simple computation, we find

$$
\begin{equation*}
\left|P_{i}-P_{j}\right|=2 r\left|\sin \frac{(i-j) \pi}{k}\right| . \tag{2.6}
\end{equation*}
$$

Finally, let us recall the following elementary inequalities which hold for all $a, b, b_{1}, b_{2} \in \mathbb{R}$ and $p>1$ :

$$
\begin{equation*}
|a+b|^{p} \leqslant C\left(|a|^{p}+|b|^{p}\right) \tag{2.7}
\end{equation*}
$$

and, if $|a| \leqslant 1$,

$$
\begin{array}{rlr}
\left|\left|a+b_{1}\right|^{p}\right. & -\left|a+b_{2}\right|^{p}-p|a|^{p-1}\left(b_{1}-b_{2}\right) \mid \\
& \leqslant \begin{cases}C\left(\left|b_{1}\right|^{p-1}+\left|b_{2}\right|^{p-1}\right)\left|b_{1}-b_{2}\right|, & \text { if } p \leqslant 2, \\
C\left(\left|b_{1}\right|^{p-1}+\left|b_{2}\right|^{p-1}+\left|b_{1}\right|+\left|b_{2}\right|\right)\left|b_{1}-b_{2}\right|, & \text { if } p>2\end{cases} \tag{2.8}
\end{array}
$$

where the constant $C$ depends only on $p$.

As mentioned in the introduction, we denote by $U$ the unique positive radial solution in $H^{1}\left(\mathbb{R}^{3}\right)$ of the problem (1.1). This solution satisfies the following decay property (see [14]):

$$
\lim _{r \rightarrow+\infty} U(r) r e^{r}=C>0, \quad \lim _{r \rightarrow+\infty} \frac{U^{\prime}(r)}{U(r)}=-1, \quad r=|x|
$$

for some constant $C$.
The function $U$ is a critical point of the $C^{2}$ functional $I_{0}: H^{1}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$ defined as

$$
I_{0}(u)=\frac{1}{2}\|u\|^{2}-\frac{1}{p+1} \int_{\mathbb{R}^{3}}|u|^{p+1} d x .
$$

Furthermore the solution $U$ is nondegenerate (up to translations).
More specifically, there holds
Lemma 2.3. Define the operator $Q: H^{1}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$ as

$$
Q[v]:=I_{0}^{\prime \prime}(U)[v, v]=\int_{\mathbb{R}^{3}}\left[|\nabla v|^{2}+v^{2}-p U^{p-1} v^{2}\right] d x
$$

We denote by $U_{j}=\frac{\partial U}{\partial x_{j}}$. Then there hold:

- $Q[U]=(1-p)\|U\|^{2}<0$;
- $Q\left[U_{j}\right]=0, j=1,2,3$;
- $Q[v] \geqslant C\|v\|^{2}$ for all $v \perp U, v \perp U_{j}, j=1,2,3$.

For the proof we refer, for instance, to [2, Lemma 8.6].
Finally, let us recall the following results (see [11, Corollary 3.2] and [1, Lemma 3.7]).

Lemma 2.4. Let $\beta_{1} \geqslant 1$ and $\beta_{2} \geqslant 1$ be two positive numbers. Then we have

$$
\int_{\mathbb{R}^{3}} U_{P_{i}}^{\beta_{1}} U_{P_{j}}^{\beta_{2}} d x=O\left(e^{-\left(\min \left\{\beta_{1}, \beta_{2}\right\}-\delta\right)\left|P_{i}-P_{j}\right|}\right), \quad i \neq j
$$

where $\delta>0$ is any small number.
Lemma 2.5. For all $i, j=1, \ldots, k, i \neq j$, we have

$$
\int_{\mathbb{R}^{3}} U_{P_{i}}^{p} U_{p_{j}} d x=C \frac{e^{-\left|P_{i}-P_{j}\right|}}{\left|P_{i}-P_{j}\right|}(1+o(1))
$$

## 3 Proof of Theorem 1.2

The proof of Theorem 1.2 relies on a Lyapunov-Schmidt reduction. Let

$$
Z_{i, j}=\frac{\partial U_{P_{i}}}{\partial x_{j}}, \quad i=1, \ldots, k \text { and } j=1,2,3
$$

and define

$$
W:=\left\{w \in H_{s}: \int_{\mathbb{R}^{3}} U_{P_{i}}^{p-1} Z_{i, j} w d x=0, i=1, \ldots, k ; j=1,2,3\right\}
$$

and $P_{W}$ the orthogonal projection onto $W$. Our approach is to find first a solution $w \in W$ of the auxiliary equation

$$
P_{W} I^{\prime}\left(z_{r}+w\right)=0
$$

and then to solve the remaining finite dimensional equation, namely the bifurcation equation

$$
\left(I-P_{W}\right) I^{\prime}\left(z_{r}+w\right)=0
$$

In what follows we always assume that $V$ satisfies $(\mathrm{V})$ and

$$
r \in S_{k}:=\left[\left(\frac{m}{\pi}-\beta\right) k \log k,\left(\frac{m}{\pi}+\beta\right) k \log k\right]
$$

where $m$ is the constant in $(\mathrm{V})$ and $\beta>0$ is a small constant.

### 3.1 The auxiliary equation

In the sequel we find a solution of the auxiliary equation, namely we prove the following proposition.

Proposition 3.1. There exists an integer $k_{0}>0$, such that for each $k \geqslant k_{0}$, there is a $C^{1}$ map $w: S_{k} \rightarrow H_{s}, w=w(r)$, satisfying $w \in W$ and $P_{W} I^{\prime}\left(z_{r}+\right.$ $w)=0$. Moreover, there is a small $\sigma>0$, such that

$$
\|w\| \leqslant \frac{C}{k^{m-\frac{1}{2}+\sigma}}
$$

We begin with some estimates.
Lemma 3.2. There exists an integer $k_{0}>0$, such that for each $k \geqslant k_{0}$, there is a small $\sigma>0$ such that

$$
\begin{equation*}
\left\|I^{\prime}\left(z_{r}\right)\right\| \leqslant \frac{C}{k^{m-\frac{1}{2}+\sigma}} \tag{3.1}
\end{equation*}
$$

Proof. Let $v \in H_{s}$, with $\|v\|=1$. Taking into account that $U_{P_{i}}$ are solutions of (1.1), we have

$$
I^{\prime}\left(z_{r}\right)[v]=\underbrace{\int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} z_{r} v d x}_{(I)}-\underbrace{\int_{\mathbb{R}^{3}}\left[z_{r}^{p}-\sum_{i=1}^{k} U_{P_{i}}^{p}\right] v d x}_{(I I)}
$$

Let us evaluate separately the two terms. By using Hölder inequality we obtain:

$$
\begin{aligned}
|(I)| & =\left|\sum_{i=1}^{k} \int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} U_{P_{i}} v d x\right| \leqslant \sum_{i=1}^{k}\left[\left(\int_{\mathbb{R}^{3}}\left(V(x) \phi_{z_{r}} U_{P_{i}}\right)^{2} d x\right)^{1 / 2}|v|_{2}\right] \\
& \leqslant C\left\|\phi_{z_{r}}\right\|_{D^{1,2}} \sum_{i=1}^{k}\left(\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}}\right)^{3} d x\right)^{1 / 3} .
\end{aligned}
$$

Now, let be $\alpha \in(0,1)$. By (2.4) and (2.5) and since $U$ decays exponentially outside a ball we find

$$
\begin{align*}
\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}}(x)\right)^{3} d x & =\int_{\mathbb{R}^{3}}\left(V\left(x+P_{i}\right) U(x)\right)^{3} d x \\
& =\int_{B_{\alpha r}}\left(V\left(x+P_{i}\right) U(x)\right)^{3} d x+\int_{\mathbb{R}^{3} \backslash B_{\alpha r}}\left(V\left(x+P_{i}\right) U(x)\right)^{3} d x \\
& \leqslant \frac{C}{r^{3 m}} \tag{3.2}
\end{align*}
$$

and

$$
\begin{aligned}
\left\|\phi_{z_{r}}\right\|_{D^{1,2}}^{2}= & \int_{\mathbb{R}^{3}}\left|\nabla \phi_{z_{r}}\right|^{2} d x=\int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} z_{r}^{2} d x \\
= & \sum_{i=1}^{k} \int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} U_{P_{i}}^{2} d x+\sum_{i \neq j} \int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} U_{P_{i}} U_{P_{j}} d x \\
\leqslant & C\left\|\phi_{z_{r}}\right\|_{D^{1,2}} \sum_{i=1}^{k}\left(\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}}^{2}\right)^{6 / 5} d x\right)^{5 / 6} \\
& +C\left\|\phi_{z_{r}}\right\|_{D^{1,2}} \sum_{i \neq j}\left(\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}} U_{P_{j}}\right)^{6 / 5} d x\right)^{5 / 6}
\end{aligned}
$$

As done in (3.2) we find

& \leqslant C k\left(\int_{\Omega_{1}} U_{P_{1}}^{\frac{(p-1)(p+1)}{p}}\left(\sum_{j=2}^{k} U_{P_{j}}\right)^{\frac{p+1}{p}} d x\right)^{\frac{p}{p+1}}\left(\int_{\Omega_{1}}|v|^{p+1} d x\right)^{\frac{1}{p+1}} \\
& \leqslant C k^{\frac{p}{p+1}}\left(\int_{\Omega_{1}} U_{P_{1}}^{\frac{(p-1)(p+1)}{p}}\left(\sum_{j=2}^{k} U_{P_{j}}\right)^{\frac{1}{p}} \sum_{j=2}^{k} U_{P_{j}} d x\right)^{\frac{p}{p+1}} \\
& \leqslant C k^{\frac{p}{p+1}} e^{-\frac{\eta r \pi}{(p+1) k}}\left(\sum_{j=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{\frac{p^{2}-\eta}{p}} U_{P_{j}} d x\right)^{\frac{p}{p+1}} \\
& \leqslant C k^{\frac{p}{p+1}} e^{-\frac{\eta r \pi}{(p+1) k}}\left(\sum_{j=2}^{k} e^{-(1-\delta)\left|P_{1}-P_{j}\right|}\right)^{\frac{p}{p+1}} \\
& \leqslant C k^{\frac{p}{p+1}} e^{-\frac{\pi}{p+1}(\eta+2 p(1-\delta))\left(\frac{m}{\pi}-\beta\right) \log k} \\
& \leqslant C \frac{1}{k^{\left[-\frac{p}{p+1}+\frac{\pi}{p+1}(\eta+2 p(1-\delta))\left(\frac{m}{\pi}-\beta\right)\right]}}
\end{aligned}
$$

(a) $I^{\prime \prime}\left(z_{r}\right)[u, u] \leqslant-C_{1}\|u\|^{2}$, for all $u \in A$;
(b) $I^{\prime \prime}\left(z_{r}\right)[u, u] \geqslant C_{2}\|u\|^{2}$, for all $u \in B$.

Proof. The proof is very similar to [17, Lemma 3.4]. We sketch it for the sake of completeness.
Let $u \in A$. Then

Since for $k \rightarrow+\infty$ we have $\left|P_{i}-P_{l}\right| \rightarrow+\infty$, we get $\left(U_{P_{i}}, Z_{l, j}\right)=o(1)$ as $k \rightarrow+\infty$. This implies $\left\|\psi_{i}\right\|=o(1)$ as $k \rightarrow+\infty$ for $i=1, \ldots, k$.
Applying the bilinear form given by $I^{\prime \prime}\left(z_{r}\right)$, using the fact that $I^{\prime \prime}\left(z_{r}\right)$ maps bounded sets onto bounded sets and that $\left\|\psi_{i}\right\|=o(1)$ we obtain that

Then $I^{\prime \prime}\left(z_{r}\right)$ is negative definite on $A$.
We now prove that $I^{\prime \prime}\left(z_{r}\right)$ is positive definite on $B$. Choose an arbitrary $u \in B$ and we assume, for simplicity, that $\|u\|=1$. We denote by $\hat{\phi}$ the solution of $-\Delta \hat{\phi}=V(x) z_{r} u$. Then

& \leqslant C \sum_{i=1}^{k}\left(\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}}^{2}\right)^{6 / 5} d x\right)^{5 / 6}+C \sum_{i \neq j}\left(\int_{\mathbb{R}^{3}}\left(V(x) U_{P_{i}} U_{P_{j}}\right)^{6 / 5} d x\right)^{5 / 6} \\
& =o(1)
\end{aligned}
$$

for $k$ sufficiently large. In the same way one can prove that for $k \rightarrow+\infty$

& -\frac{1}{p+1} \int_{\mathbb{R}^{3}}\left[\left|z_{r}+w\right|^{p+1}-z_{r}^{p+1}-\frac{p(p+1)}{2} z_{r}^{p-1} w^{2}-(p+1) z_{r}^{p} w\right] d x .
\end{aligned}

Since $l(w)$ is a bounded linear functional in $W$, by Riesz Theorem there exists an $l_{k} \in W$ such that

& \left.+\int_{\mathbb{R}^{3}}| | z_{r}+\left.w\right|^{p}-p z_{r}^{p-1} w-z_{r}^{p}|\cdot| v \mid d x\right] .
\end{aligned}
$$

If $p \leqslant 2$ then, by (2.3) and (2.8),

If, now, $p>2$ then, by using again (2.3) and (2.8),

Finally, let us prove that $A$ is a contraction. Let be $w_{1}, w_{2} \in B$. Then

& \leqslant \bar{C}\left(\frac{C}{k^{m-\frac{1}{2}+\sigma}}\left\|w_{1}-w_{2}\right\|+\left\|R_{z_{r}}^{\prime}\left(w_{1}\right)-R_{z_{r}}^{\prime}\left(w_{2}\right)\right\|\right)
\end{aligned}
$$

Moreover we have

\begin{aligned}
\left\|R_{z_{r}}^{\prime}\left(w_{1}\right)-R_{z_{r}}^{\prime}\left(w_{2}\right)\right\|= & \sup _{\|v\|=1}\left|R_{z_{r}}^{\prime}\left(w_{1}\right)[v]-R_{z_{r}}^{\prime}\left(w_{2}\right)[v]\right| \\
\leqslant & \sup _{\|v\|=1}\left[\int_{\mathbb{R}^{3}} V(x) \phi_{w_{1}}\left|w_{1}-w_{2}\right| \cdot|v| d x+2 \int_{\mathbb{R}^{3}} V(x)\left|\bar{\phi}_{1}\right| z_{r}\left|w_{1}-w_{2}\right| d x\right. \\
& +\int_{\mathbb{R}^{3}} V(x)\left|\phi_{w_{1}}-\phi_{w_{2}}\right| z_{r}|v| d x+2 \int_{\mathbb{R}^{3}} V(x)\left|\bar{\phi}_{1}-\bar{\phi}_{2}\right| z_{r}\left|w_{2}\right| d x \\
& +\int_{\mathbb{R}^{3}} V(x)\left|\phi_{w_{1}}-\phi_{w_{2}}\right| \cdot\left|w_{2} v\right| d x \\
& \left.+\int_{\mathbb{R}^{3}}| | z_{r}+\left.w_{1}\right|^{p}-\left|z_{r}+w_{2}\right|^{p}-p z_{r}^{p-1}\left(w_{1}-w_{2}\right)|\cdot| v \mid d x\right]
\end{aligned}
$$

where $\bar{\phi}_{i}$ is the solution in $D^{1,2}\left(\mathbb{R}^{3}\right)$ of $-\Delta \bar{\phi}_{i}=V(x) z_{r} w_{i}, i=1,2$. If now $p \leqslant 2$, by iii) of Lemma 2.1 and (2.8)

\left\|R_{z_{r}}^{\prime}\left(w_{1}\right)-R_{z_{r}}^{\prime}\left(w_{2}\right)\right\| & \leqslant C \sup _{\|v\|=1}\left[\frac{1}{k^{m-\frac{1}{2}+\sigma}}\left\|w_{1}-w_{2}\right\|+\int_{\mathbb{R}^{3}}\left(\left|w_{1}\right|^{p-1}+\left|w_{2}\right|^{p-1}\right)\left|w_{1}-w_{2}\right| \cdot|v| d x\right] \\
& \leqslant C\left[\frac{1}{k^{m-\frac{1}{2}+\sigma}}+\frac{1}{k^{(p-1)\left(m-\frac{1}{2}+\sigma\right)}}\right]\left\|w_{1}-w_{2}\right\| \\
& \leqslant \frac{C}{k^{(p-1)\left(m-\frac{1}{2}+\sigma\right)}}\left\|w_{1}-w_{2}\right\|
\end{aligned}
$$

If $p>2$ by using again iii) of Lemma 2.1 and (2.8)

\left\|R_{z_{r}}^{\prime}\left(w_{1}\right)-R_{z_{r}}^{\prime}\left(w_{2}\right)\right\| \leqslant & C \sup _{\|v\|=1}\left[\frac{1}{k^{m-\frac{1}{2}+\sigma}}\left\|w_{1}-w_{2}\right\|\right. \\
& \left.+\int_{\mathbb{R}^{3}}\left(\left|w_{1}\right|^{p-1}+\left|w_{2}\right|^{p-1}+\left|w_{1}\right|+\left|w_{2}\right|\right)\left|w_{1}-w_{2}\right| \cdot|v| d x\right] \\
\leqslant & \frac{C}{k^{\left(m-\frac{1}{2}+\sigma\right)}}\left\|w_{1}-w_{2}\right\| .
\end{aligned}

In both cases $A$ is a contraction since for $k$ large $\frac{C}{k^{s\left(m-\frac{1}{2}+\sigma\right)}} \ll 1$ for $s=1$ and $s=p-1$.

### 3.2 The reduced functional

This section is devoted to solve the finite dimensional equation, namely the bifurcation equation.
To this aim, let us define the reduced functional $F: S_{k} \rightarrow \mathbb{R}$ such that for all $r \in S_{k}$

where $w=w(r, k)$ is the unique solution of the auxiliary equation. By Proposition 3.1 let us recall that

where $\sigma>0$ is small. Then by Proposition A. 1 the reduced functional is given by

where $C_{0}, B_{1}, B_{2}, B_{3}$ are positive constants. The problem

has a solution since $F$ is continuous on a compact set. We have to show that this maximum is an interior point of $S_{k}$.
Let us denote with $\bar{F}$ the function

C_{1} \frac{e^{-\frac{2 \pi r}{k}}}{\log k} \leqslant \sum_{i=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{p} U_{P_{i}} d x \leqslant C_{2} e^{-\frac{2 \pi r}{k}}
$$

So we define

& F_{2}(r):=\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}-B_{4} \frac{e^{-\frac{2 \pi r}{k}}}{\log k} .
\end{aligned}

For $k$ sufficiently large,

$$

and, moreover, we have

& \bar{F}\left(\left(\frac{m}{\pi}-\beta\right) k \log k\right) \leqslant F_{2}\left(\left(\frac{m}{\pi}-\beta\right) k \log k\right)<0
\end{aligned}
$$

and

\bar{F}\left(\left(\frac{m}{\pi}+\frac{\beta}{2}\right) k \log k\right)-\bar{F}\left(\left(\frac{m}{\pi}+\beta\right) k \log k\right) \geqslant \frac{C}{k^{2 m} \log ^{2 m} k}>0

Hence $\bar{F}$ possesses a critical point (a maximum point)

in the interior of $\mathcal{S}_{k}$.
Finally it is easy to check that (3.4) is achieved by some $r_{k}$, which is in the interior of $S_{k}$, and so we infer that $r_{k}$ is a critical point of $F(r)$. As a consequence, we can conclude that $z_{r_{k}}+w\left(r_{k}\right)$ is a solution of $\left(\mathcal{S P}{ }^{\prime}\right)$. This prove the existence of infinitely many non-trivial non radial solutions of $\left(\mathcal{S P}^{\prime}\right)$.
In order to get positive solutions, it suffices to repeat the whole procedure for the functional

where $u^{+}=\max \{0, u\}$. It can be checked that Proposition 3.1, Lemmas 3.2, 3.3 and Proposition A. 1 can be applied to $I_{+}$. Therefore we get infinitely many non-radial and non-negative solutions for the problem

Keeping in mind that $\phi_{u}>0$ when $u \neq 0$ then the maximum principle allows to find infinitely many positive solutions of $\left(\mathcal{S P}^{\prime}\right)$ of the form $z_{r_{k}}+w\left(r_{k}\right)$, and so the proof of Theorem 1.2 is concluded.

\lim _{k}\left(\frac{1}{k \log k} \sum_{i=1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{i \pi}{k}}\right)=\frac{1}{\pi} \tag{A.11}
\end{equation*}
$$

Since, for every $i=1, \ldots,\left[\frac{k-1}{2}\right]-1$ and $s \in[i, i+1]$,

$$
\sin \frac{i \pi}{k} \leqslant \sin \frac{s \pi}{k} \leqslant \sin \frac{(i+1) \pi}{k},
$$

then

$$
\frac{1}{\sin \frac{(i+1) \pi}{k}}=\int_{i}^{i+1} \frac{1}{\sin \frac{(i+1) \pi}{k}} d s \leqslant \int_{i}^{i+1} \frac{1}{\sin \frac{s \pi}{k}} d s \leqslant \int_{i}^{i+1} \frac{1}{\sin \frac{i \pi}{k}} d s=\frac{1}{\sin \frac{i \pi}{k}}
$$

Hence, adding on $i$, we have that

$$
\frac{1}{\sin \left(\left[\frac{k-1}{2}\right] \frac{\pi}{k}\right)} \leqslant \sum_{i=1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{i \pi}{k}}-\int_{1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{s \pi}{k}} d s \leqslant \frac{1}{\sin \frac{\pi}{k}}
$$

and so

$$
\lim _{k}\left[\frac{1}{k \log k}\left(\sum_{i=1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{i \pi}{k}}-\int_{1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{s \pi}{k}} d s\right)\right]=0
$$

Therefore (A.11) follows, being

$$
\lim _{k}\left(\frac{1}{k \log k} \int_{1}^{\left[\frac{k-1}{2}\right]} \frac{1}{\sin \frac{s \pi}{k}} d s\right)=\frac{1}{\pi} \lim _{k}\left(\frac{1}{\log k} \log \left(\frac{\tan \left(\left[\frac{k-1}{2}\right] \frac{\pi}{2 k}\right)}{\tan \frac{\pi}{2 k}}\right)\right)=\frac{1}{\pi} .
$$

We are now ready to prove Proposition A.1.
Proof of Proposition A.1. By (A.2) and using Lemmas A.2, A.3, A.4, A.5, A. 6 we find

$$
\begin{aligned}
\frac{1}{4} \int_{\mathbb{R}^{3}} V(x) \phi_{z_{r}} z_{r}^{2} d x= & k\left[\frac{B_{1}}{r^{2 m}}+\frac{B_{2}}{r^{2 m}} \sum_{i=2}^{k} \frac{1}{\left|P_{1}-P_{i}\right|}\right] \\
& +k\left[\frac{1}{r^{2 m+\theta}} O\left(\sum_{i=2}^{k} \frac{1}{\left|P_{1}-P_{i}\right|}\right)+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] \\
= & k\left[\frac{B_{1}}{r^{2 m}}+\frac{B_{2}}{r^{2 m}}\left(\frac{k \log k}{r}+o(1)\right)+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] \\
= & k\left[\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] .
\end{aligned}
$$

Then, by (A.1), we have

$$
\begin{aligned}
I\left(z_{r}\right)= & \frac{1}{2} \sum_{j=1}^{k} \sum_{i=1}^{k} \int_{\mathbb{R}^{3}} U_{P_{j}}^{p} U_{P_{i}} d x+k\left[\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] \\
& -\frac{1}{p+1} \int_{\mathbb{R}^{3}}\left|z_{r}\right|^{p+1} d x \\
= & \frac{k}{2} \int_{\mathbb{R}^{3}} U^{p+1} d x+\frac{k}{2} \sum_{i=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{p} U_{P_{i}} d x+k\left[\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] \\
& -\frac{1}{p+1} \int_{\mathbb{R}^{3}}\left|z_{r}\right|^{p+1} d x .
\end{aligned}
$$

As done in [20, Proof of Proposition A.3], for all $r \in S_{k}$, one can prove

$$
\int_{\mathbb{R}^{3}}\left|z_{r}\right|^{p+1} d x=k\left(\int_{\mathbb{R}^{3}} U^{p+1} d x+(p+1) \sum_{i=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{p} U_{P_{i}} d x+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right) .
$$

At the end we find

$$
\begin{aligned}
I\left(z_{r}\right)=k & {\left[\left(\frac{1}{2}-\frac{1}{p+1}\right) \int_{\mathbb{R}^{3}} U^{p+1} d x+\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}\right.} \\
& \left.-B_{3} \sum_{i=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{p} U_{P_{i}} d x+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] \\
=k & {\left[C_{0}+\frac{B_{1}}{r^{2 m}}+\frac{B_{2} k \log k}{r^{2 m+1}}-B_{3} \sum_{i=2}^{k} \int_{\mathbb{R}^{3}} U_{P_{1}}^{p} U_{P_{i}} d x+O\left(\frac{1}{k^{2 m+\sigma}}\right)\right] . }
\end{aligned}
$$
