# GENERATORS FOR RINGS OF COMPACTLY SUPPORTED DISTRIBUTIONS

#### Abstract

Let $C$ denote a closed convex cone $C$ in $\mathbb{R}^{d}$ with apex at 0 . We denote by $\mathcal{E}^{\prime}(C)$ the set of distributions having compact support which is contained in $C$. Then $\mathcal{E}^{\prime}(C)$ is a ring with the usual addition and with convolution. We give a necessary and sufficient analytic condition on $\widehat{f}_{1}, \ldots, \widehat{f}_{n}$ for $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}(C)$ to generate the ring $\mathcal{E}^{\prime}(C)$. (Here $\widehat{\text {. }}$ denotes Fourier-Laplace transformation.) This result is an application of a general result on rings of analytic functions of several variables by Hörmander. En route we answer an open question posed by Yutaka Yamamoto.


## 1. Introduction

Let $R$ be a commutative ring with identity. Elements $a_{1}, \ldots, a_{n}$ of $R$ are said to generate $R$ if the ideal generated by $a_{1}, \ldots, a_{n}$ is equal to $R$, or equivalently, if there exist $b_{1}, \ldots, b_{n}$ such that $a_{1} b_{1}+\cdots+a_{n} b_{n}=1$.

For instance, if $R=H^{\infty}(\mathbb{D})$, the set of all bounded and holomorphic functions on the open unit disc $\mathbb{D}$ centered at 0 in $\mathbb{C}$, then the corona theorem says that $f_{1}, \ldots, f_{n} \in H^{\infty}(\mathbb{D})$ generate $H^{\infty}(\mathbb{D})$ iff there exists a $C>0$ such that $\left|f_{1}(z)\right|+\cdots+\left|f_{n}(z)\right|>C$ for all $z \in \mathbb{D}$; see [2].

In this note we address this question when the ring $R$ consists of compactly supported distributions.

Let $C$ denote a closed convex cone $C$ in $\mathbb{R}^{d}$ with apex at 0 . Recall that a convex cone is a subset of $\mathbb{R}^{d}$ with the following properties:
(1) If $x, y \in C$, then $x+y \in C$.
(2) If $x \in C$ and $t>0$, then $t x \in C$.

Let $\mathcal{E}^{\prime}(C)$ be the set consisting of all distributions having a compact support which is contained in $C$. Then $\mathcal{E}^{\prime}(C)$ is a commutative ring with the usual addition of distributions and the operation of convolution. The Dirac delta distribution $\delta$ supported at 0 serves as an identity in the ring $\mathcal{E}^{\prime}(C)$.

Recall that a distribution $f$ with compact support has a finite order, and its Fourier-Laplace transform is an entire function given by

$$
\widehat{f}(z)=\left\langle f, e^{-i z \cdot}\right\rangle, \quad z \in \mathbb{C}^{d}
$$

[^0]We use the notation $\|\cdot\|$ for the usual Euclidean 2-norm in $\mathbb{C}^{d}$. The same notation is also used for the Euclidean norm in $\mathbb{R}^{d}$.

The supporting function of a convex, compact set $K\left(\subset \mathbb{R}^{d}\right)$ is defined by

$$
H_{K}(\xi)=\sup _{x \in K}\langle x, \xi\rangle, \quad \xi \in \mathbb{R}^{d} .
$$

Our main result is the following:
Theorem 1.1. Let $C$ denote a closed convex cone in $\mathbb{R}^{d}$ with apex at 0 , and $H$ denote the supporting function of the compact convex set

$$
B:=C \cap\left\{x \in \mathbb{R}^{d}:\|x\| \leq 1\right\},
$$

that is, $H(\xi)=\sup _{x \in B}\langle\xi, x\rangle$.
Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}(C)$. There exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}(C)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta
$$

iff there are positive constants $C, N, M$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d},\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right| \geq C\left(1+\|z\|^{2}\right)^{-N} e^{-M H(\operatorname{Im}(z))} \tag{1.1}
\end{equation*}
$$

Theorem 1.1, in the case when $d=1$ and $C=\mathbb{R}$ was known; see [5].

## 2. Proof of the main result

We will show that our main result follows from the main result given in [3]. We will use the Payley-Wiener-Schwartz theorem, which is recalled below.

Proposition 2.1 (Payley-Wiener-Schwartz). Let $K$ be a convex compact subset of $\mathbb{R}^{d}$ with supporting function $H$. If $u$ is a distribution with support contained in $K$, then there exists a positive $N$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d}, \widehat{u}(z) \leq C\left(1+\|z\|^{2}\right)^{N} e^{H(\operatorname{Im}(z))} . \tag{2.1}
\end{equation*}
$$

Conversely, every entire analytic function in $\mathbb{C}^{d}$ satisfying an estimate of the form (2.1) is the Fourier-Laplace transform of a distribution with support contained in $K$.

Proof. See for instance [4, Theorem 7.3.1]. The only difference is that we have the term $\left(1+\|z\|^{2}\right)^{N}$ instead of $(1+\|z\|)^{N}$ in the estimate (2.1), which follows from the observation that $1+\|z\|^{2} \leq(1+\|z\|)^{2} \leq 2\left(1+\|z\|^{2}\right)$ for every $z \in \mathbb{C}^{d}$ (and by replacing $N / 2$ by $N$ ).

We also recall the main result from Hörmander [3, Theorem 1, p. 943], which we will use.

Let $p$ be a nonnegative function defined in $\mathbb{C}^{d}$. Let $A_{p}$ denote the set of all entire functions $F: \mathbb{C}^{d} \rightarrow \mathbb{C}$ such that there exist positive constants $C_{1}$ and $C_{2}$ (which in general depend on $F$ ) such that

$$
\text { for all } z \in \mathbb{C}^{d},|F(z)| \leq C_{1} e^{C_{2} p(z)}
$$

It is clear that $A_{p}$ is a ring with the usual pointwise operations.

Proposition 2.2 (Hörmander). Let $p$ be a nonnegative plurisubharmonic function in $\mathbb{C}^{d}$ such that
(1) all polynomials belong to $A_{p}$
(2) there exist nonnegative $K_{1}, K_{2}, K_{3}, K_{4}$ such that whenever $z, \zeta \in \mathbb{C}^{d}$ satisfy $\|z-\zeta\| \leq e^{-K_{1} p(z)-K_{2}}$, there holds that $p(\zeta) \leq K_{3} p(z)+K_{4}$.
If there exist positive constants $C_{1}, C_{2}$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d},\left|F_{1}(z)\right|+\cdots+\left|F_{n}(z)\right| \geq C_{1} e^{-C_{2} p(z)} \tag{2.2}
\end{equation*}
$$

then $F_{1}, \ldots, F_{n} \in A_{p}$ generate $A_{p}$.
Lemma 2.3. Let $C$ denote a closed convex cone in $\mathbb{R}^{d}$ with apex at 0 , and $H$ denote the supporting function of the compact convex set

$$
B:=C \cap\left\{x \in \mathbb{R}^{d}:\|x\| \leq 1\right\}
$$

that is, $H(\xi)=\sup _{x \in B}\langle\xi, x\rangle$.
Let $p(z):=\log \left(1+\|z\|^{2}\right)+H(\operatorname{Im}(z))$. Then we have the following:
(1) $p$ is nonnegative and subharmonic.
(2) $A_{p}=\widehat{\mathcal{E}^{\prime}(C)}$.
(3) $A_{p}$ contains the polynomials.
(4) There exist nonnegative $K_{1}, K_{2}, K_{3}, K_{4}$ such that whenever $z, \zeta \in \mathbb{C}^{d}$ satisfy $\|z-\zeta\| \leq e^{-K_{1} p(z)-K_{2}}$, there holds that $p(\zeta) \leq K_{3} p(z)+K_{4}$. (That is, condition (2) of Proposition 2.2 is satisfied.)

Proof. (1) Clearly $p$ is nonnegative. Also, the complex Hessian at $z$ of the $\operatorname{map} z \mapsto \log \left(1+\|z\|^{2}\right)$ is easily seen to be

$$
F(z):=\frac{1}{1+\|z\|^{2}} I-\frac{1}{\left(1+\|z\|^{2}\right)^{2}} z z^{*} .
$$

So for $w \in \mathbb{C}^{d}$, we have that

$$
\begin{aligned}
w^{*} F(z) w & =\frac{1}{1+\|z\|^{2}}\|w\|^{2}-\frac{1}{\left(1+\|z\|^{2}\right)^{2}}\left|w^{*} z\right|^{2} \\
& =\frac{\|w\|^{2}+\|w\|^{2}\|z\|^{2}-\left|w^{*} z\right|^{2}}{\left(1+\|z\|^{2}\right)^{2}} \geq 0
\end{aligned}
$$

by the Cauchy-Schwarz inequality. So the map $z \mapsto \log \left(1+|z|^{2}\right)$ is plurisubharmonic; see [6, Proposition 4.9, p.88].

We will use the fact that a map $\varphi: \mathbb{C}^{d} \rightarrow \mathbb{R}$ that depends only on the imaginary part of the variable is plurisubharmonic iff the map is convex; see [6, E.4.8, p.92]. The supporting function $H_{K}$ of any convex compact set $K$ satisfies the properties that

$$
H_{K}(\xi+\eta) \leq H_{K}(\xi)+H_{K}(\eta), \quad H_{K}(t \xi)=t H_{K}(\xi)
$$

for all $\xi, \eta \in \mathbb{R}^{d}$ and $t \geq 0$. It is then clear that $H_{K}$ is a convex function. In particular our $H$ (the supporting function of $B$ ) is convex too. Thus
$z \mapsto H(\operatorname{Im}(z))$ is plurisubharmonic. Consequently, $p$, which is the sum of the plurisubharmonic maps $z \mapsto \log \left(1+\|z\|^{2}\right)$ and $z \mapsto H(\operatorname{Im}(z))$, is plurisubharmonic as well; [6, p.88].
(2) Suppose that $f \in \mathcal{E}^{\prime}(C)$ has support contained in the compact set $K$ contained in $C$. Then by the Payley-Wiener-Schwartz Theorem, there exist positive $C, N, M$ such that

$$
|\widehat{f}(z)| \leq C\left(1+\|z\|^{2}\right)^{N} e^{H_{K}(\operatorname{Im}(z))}
$$

Let $\epsilon>0$ be such that $\epsilon K \subset B$. Then we have for $\xi \in \mathbb{R}^{d}$ that

$$
H_{K}(\xi)=\sup _{x \in K}\langle x, \xi\rangle \leq \sup _{x \in \epsilon^{-1} B}\langle x, \xi\rangle=\epsilon^{-1} \sup _{y \in B}\langle y, \xi\rangle=\epsilon^{-1} H(\xi)
$$

Thus with $M:=\epsilon^{-1}$, we have

$$
\begin{aligned}
|\widehat{f}(z)| & \leq C\left(1+\|z\|^{2}\right)^{N} e^{M H(\operatorname{Im}(z))}=C e^{N \log \left(1+\|z\|^{2}\right)+M H(\operatorname{Im}(z))} \\
& \leq C e^{\max \{N, M\} p(z)}
\end{aligned}
$$

So $\widehat{f} \in A_{p}$.
Conversely, if $F \in A_{p}$, then

$$
|F(z)| \leq C_{1} e^{C_{2} p(z)}=C_{1}\left(1+\|z\|^{2}\right)^{C_{2}} e^{C_{2} H(\operatorname{Im}(z))}
$$

But for $\xi \in \mathbb{R}^{d}$ we have

$$
C_{2} H(\xi)=C_{2} \sup _{x \in B}\langle x, \xi\rangle=\sup _{y \in C_{2} B}\langle y, \xi\rangle=H_{C_{2} B}(\xi)
$$

So by the Payley-Wiener-Schwartz theorem, there exists an $f \in \mathcal{E}^{\prime}\left(\mathbb{R}^{d}\right)$ such that $\widehat{f}=F$ and the support of $f$ is contained in $C_{2} B \subset C$. Thus $F \in \widehat{\mathcal{E}^{\prime}(C)}$.
(3) Let $\mathbb{Z}_{+}=\{0,1,2,3, \ldots\}$. Let

$$
Q(z)=\sum_{k \in \mathbb{Z}_{+}^{n},|k| \leq N} a_{k} z^{k}
$$

where for a multi-index $k=\left(k_{1}, \ldots, k_{n}\right) \in \mathbb{Z}_{+}^{n}$,

$$
|k|:=k_{1}+\cdots+k_{n}, \quad z^{k}=z_{1}^{k_{1}} \ldots z_{n}^{k_{n}}, \quad \text { and } \quad a_{k} \in \mathbb{C}
$$

Consider

$$
q=\sum_{k \in \mathbb{Z}_{+}^{n},|k| \leq N} a_{k} \frac{1}{i^{|k|}} \frac{\partial^{|k|}}{\partial x_{1}^{k_{1}} \ldots \partial x_{n}^{k_{n}}} \delta \in \mathcal{E}^{\prime}(C)
$$

Then $Q=\widehat{q} \in \widehat{\mathcal{E}^{\prime}(C)}=A_{p}$, and so $Q \in A_{p}$.
(4) Let $K_{1}$ and $K_{2}$ be nonnegative, and let $z, \zeta$ satisfy $\|z-\zeta\| \leq e^{-K_{1} p(z)-K_{2}}$. Then

$$
\|z-\zeta\| \leq e^{-K_{1} p(z)-K_{2}}=e^{-K_{1} p(z)} e^{-K_{2}} \leq 1 \cdot 1=1
$$

In particular, $\|\zeta\| \leq\|z\|+1$. Also,

$$
\begin{aligned}
H(\operatorname{Im}(\zeta-z)) & =\sup _{x \in B}\langle x, \operatorname{Im}(\zeta-z)\rangle \leq \sup _{x \in B}\|x\|\|\operatorname{Im}(\zeta-z)\| \\
& \leq \sup _{x \in B}\|x\|\|\zeta-z\| \leq 1 \cdot 1=1 .
\end{aligned}
$$

Thus

$$
\begin{aligned}
p(\zeta) & =\log \left(1+\|\zeta\|^{2}\right)+H(\operatorname{Im}(\zeta)) \leq 2 \log (1+\|\zeta\|)+H(\operatorname{Im}(z+\zeta-z)) \\
& \leq 2 \log (2+\|z\|)+H(\operatorname{Im}(z))+H(\operatorname{Im}(\zeta-z)) \\
& \leq \log \left(8\left(1+|z|^{2}\right)\right)+H(\operatorname{Im}(z))+1=p(z)+\log 8+1
\end{aligned}
$$

This completes the proof.
Proof of Theorem 1.1. Necessity of the condition (1.1) is not hard to check. Indeed, if there are $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}(C)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta,
$$

then upon taking Fourier-Laplace transforms, we obtain

$$
\widehat{f}_{1}(z) \widehat{g}_{1}(z)+\cdots+\widehat{f}_{n}(z) \widehat{g}_{n}(z)=1 \quad\left(z \in \mathbb{C}^{d}\right)
$$

By the triangle inequality,

$$
1=\left|\widehat{f}_{1}(z) \widehat{g}_{1}(z)+\cdots+\widehat{f}_{n}(z) \widehat{g}_{n}(z)\right| \leq\left|\widehat{f}_{1}(z)\right|\left|\widehat{g}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right|\left|\widehat{g}_{n}(z)\right| .
$$

Suppose that $g_{k}$ has support contained in the compact convex set $L_{k}(\subset C)$, where $k=1, \ldots, n$. Then by the Payley-Wiener-Schwartz theorem, we have an estimate

$$
\left|\widehat{g}_{k}(z)\right| \leq C_{k}\left(1+\|z\|^{2}\right)^{N_{k}} e^{H_{L_{k}}(\operatorname{Im}(z))}
$$

for each $k$. Let $\epsilon>0$ be small enough so that $\epsilon L_{k} \subset B$ for all the $k$. Then we have for $\xi \in \mathbb{R}^{d}$ that

$$
H_{L_{k}}(\xi)=\sup _{x \in L_{k}}\langle x, \xi\rangle \leq \sup _{x \in \epsilon^{-1} B}\langle x, \xi\rangle=\epsilon^{-1} \sup _{y \in B}\langle y, \xi\rangle=\epsilon^{-1} H(\xi) .
$$

Thus we have that for all $k$,

$$
\left|\widehat{g}_{k}(z)\right| \leq C\left(1+\|z\|^{2}\right)^{N} e^{M H(\operatorname{Im}(z))}
$$

where $M:=\epsilon^{-1}, C:=\max _{k} C_{k}$ and $N:=\max _{k} N_{k}$. Consequently,

$$
1 \leq\left(\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right|\right) C\left(1+\|z\|^{2}\right)^{N} e^{M H(\operatorname{Im}(z))},
$$

and this yields (1.1), completing the proof of the necessity part.
We now show the sufficiency of (1.1). Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}(C)$ be such that their Fourier-Laplace transforms satisfy (1.1). Then by Lemma [2.3, $\widehat{f_{1}}, \ldots, \widehat{f_{n}} \in A_{p}$ with $p(z)=\log \left(1+\|z\|^{2}\right)+H(\operatorname{Im}(z))\left(z \in \mathbb{C}^{d}\right)$. Moreover,
this $p$ satisfies the conditions (1) and (2) of Proposition 2.2. The condition (1.1) gives

$$
\begin{aligned}
\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right| & \geq C\left(1+\|z\|^{2}\right)^{-N} e^{-M H(\operatorname{Im}(z))} \\
& \geq C e^{-N \log \left(1+\|z\|^{2}\right)-M H(\operatorname{Im}(z))} \\
& \geq C e^{-\max \{N, M\} p(z)} .
\end{aligned}
$$

It then follows from Proposition 2.2 that there are some $G_{1}, \ldots, G_{n}$ in $A_{p}$ such that $\widehat{f}_{1} G_{1}+\cdots+\widehat{f}_{n} G_{n}=1$ on $\mathbb{C}$. But $A_{p}=\widehat{\mathcal{E}^{\prime}(C)}$. Hence there exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}(C)$ such that $f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta$.

## 3. Special cases of the main result

3.1. The full space $\mathbb{R}^{d}$. The supporting function $H$ of the unit ball $B$ in $\mathbb{R}^{d}$ is given by $H(\xi)=\|\xi\|$. So we obtain the following consequence of Theorem 1.1

Corollary 3.1. Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}^{d}\right)$. There exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}^{d}\right)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta
$$

iff there are positive constants $C, N, M$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d},\left|\widehat{f_{1}}(z)\right|+\cdots+\left|\widehat{f_{n}}(z)\right| \geq C\left(1+\|z\|^{2}\right)^{-N} e^{-M\|\operatorname{Im}(z)\|} . \tag{3.1}
\end{equation*}
$$

3.2. The nonnegative orthant in $\mathbb{R}^{d}$. Let

$$
\mathbb{R}_{+}^{d}=\left\{x=\left(x_{1}, \ldots, x_{d}\right) \in \mathbb{R}^{d}: x_{k} \geq 0, \text { for all } k=1, \ldots, d\right\} .
$$

The supporting function $H$ of $B=\left\{x \in \mathbb{R}_{+}^{d}:\|x\| \leq 1\right\}$ in $\mathbb{R}^{d}$ is given by

$$
H(\xi)=\left\|\xi^{+}\right\|
$$

where

$$
\xi^{+}:=\left(\max \left\{\xi_{1}, 0\right), \ldots, \max \left\{\xi_{d}, 0\right\}\right)
$$

for $\xi=\left(\xi_{1}, \ldots, \xi_{d}\right) \in \mathbb{R}^{d}$. Theorem 1.1 gives the following.
Corollary 3.2. Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}_{+}^{d}\right)$. There exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}_{+}^{d}\right)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta
$$

iff there are positive constants $C, N, M$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d},\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right| \geq C\left(1+\|z\|^{2}\right)^{-N} e^{-M\left\|(\operatorname{Im}(z))^{+}\right\|} \tag{3.2}
\end{equation*}
$$

In particular, in the case when $d=1$, we obtain:
Corollary 3.3. Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}_{+}\right)$. There exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}\left(\mathbb{R}_{+}\right)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta
$$

iff there are positive constants $C, N, M$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C},\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right| \geq C\left(1+|z|^{2}\right)^{-N} e^{-M \max \{\operatorname{Im}(z), 0\}} . \tag{3.3}
\end{equation*}
$$

3.3. The future light cone in $\mathbb{R}^{d+1}$. Let $C$ be the future light cone, namely,

$$
\Gamma:=\left\{(x, t) \in \mathbb{R}^{d} \times \mathbb{R}:\|x\| \leq c t, t \geq 0\right\}
$$

where $c$ denotes the speed of light. Then the supporting function of the intersection of $\Gamma$ and the unit ball in $\mathbb{R}^{d+1}$ is given by

$$
\Phi(\xi, \tau)= \begin{cases}\sqrt{\|\xi\|^{2}+\tau^{2}} & \text { if } c^{-1}\|\xi\| \leq \tau \\ \frac{\tau+c\|\xi\|}{\sqrt{c^{2}+1}} & \text { if }-c\|\xi\| \leq \tau \leq c^{-1}\|\xi\| \\ 0 & \text { if } \tau \leq-c\|\xi\|\end{cases}
$$

for $(\xi, \tau) \in \mathbb{R}^{d} \times \mathbb{R}$. Then we have:
Corollary 3.4. Let $f_{1}, \ldots, f_{n} \in \mathcal{E}^{\prime}(\Gamma)$. There exist $g_{1}, \ldots, g_{n} \in \mathcal{E}^{\prime}(\Gamma)$ such that

$$
f_{1} * g_{1}+\cdots+f_{n} * g_{n}=\delta
$$

iff there are positive constants $C, N, M$ such that

$$
\begin{equation*}
\text { for all } z \in \mathbb{C}^{d},\left|\widehat{f}_{1}(z)\right|+\cdots+\left|\widehat{f}_{n}(z)\right| \geq C\left(1+\|z\|^{2}\right)^{-N} e^{-M \Phi(\operatorname{Im}(z))} \tag{3.4}
\end{equation*}
$$

## 4. Answer to Yamamoto's question

We remark that Theorem 1.1 answers an open question of Y. Yamamoto; see question number 2 [7, p.282]. There it was asked if for $f_{1}, f_{2} \in \mathcal{E}^{\prime}(\mathbb{R})$, the condition that $\widehat{f_{1}}, \widehat{f_{2}}$ have no common zeros in $\mathbb{C}$ is enough to guarantee that there are $g_{1}, g_{2} \in \mathcal{E}^{\prime}(\mathbb{R})$ such that $f_{1} * g_{1}+f_{2} * g_{2}=\delta$.

In light of Theorem 1.1 above, the answer is no, since our analytic condition (3.1) (in the case when $d=1$ ) is not equivalent to (and is stronger) than the condition that there is no common zero, as seen in the following example. (The idea behind this example is taken from [5].)

Example 4.1. Let $c \in \mathbb{R}_{+}$be the Liouville constant, that is,

$$
c=\sum_{n=1}^{\infty} \frac{1}{10^{n!}} .
$$

(See for example, [1].) Then it can be seen that $c$ is irrational. Also, for $K \in \mathbb{N}$, with $p_{K}, q_{K}$ defined by

$$
p_{K}=10^{K!} \sum_{k=1}^{K} \frac{1}{10^{k!}}, \quad q_{K}=10^{K!}
$$

we have that

$$
\begin{align*}
0<\left|c-\frac{p_{K}}{q_{K}}\right| & =\sum_{k=K+1}^{\infty} \frac{1}{10^{k!}}=\frac{1}{10^{(K+1)!}}+\frac{1}{10^{(K+2)!}}+\frac{1}{10^{(K+3)!}}+\ldots \\
& \leq \frac{1}{10^{(K+1)!}} \cdot \sum_{m=0}^{\infty} \frac{1}{10^{m}}=\frac{1}{10^{(K+1)!}} \cdot \frac{10}{9}=\frac{10 / 9}{\left(10^{K!}\right)^{K} 10^{K!}} \\
& \leq \frac{1}{\left(10^{K!}\right)^{K}}=\frac{1}{q_{K}^{K}} . \tag{4.1}
\end{align*}
$$

Take $f_{1}=\delta-\delta_{c}$ and $f_{2}=\mathbf{1}_{[\mathbf{0 , 1 ]}}$, where $\mathbf{1}_{[\mathbf{0 , 1 ]}]}$ denotes the indicator function of the interval $[0,1]$. Then $f_{1}, f_{2}$ belong to $\mathcal{E}^{\prime}(\mathbb{R})$ and we have that

$$
\widehat{f}_{1}(z)=1-e^{-i c z}, \quad \widehat{f_{2}}(z)= \begin{cases}\frac{e^{-i z}-1}{--i z} & \text { if } z \neq 0 \\ \left.i \frac{d e^{-i z}}{d z}\right|_{z=0}=1 & \text { if } z=0\end{cases}
$$

Then $\widehat{f}_{1}$ and $\widehat{f}_{2}$ have no common zeros (otherwise $c$ would be rational!). We now show that (3.1) does not hold. Suppose, on the contrary that there exist $C, N, M$ positive such that

$$
\begin{equation*}
\left|\widehat{f}_{1}(z)\right|+\left|\widehat{f}_{2}(z)\right| \geq C\left(1+|z|^{2}\right)^{-N} e^{-M|\operatorname{Im}(z)|} \tag{4.2}
\end{equation*}
$$

for all $z \in \mathbb{C}$. If $z=2 \pi q_{K}$, then we have $\widehat{f}_{2}\left(2 \pi q_{K}\right)=0$. On the other hand,

$$
\left|\widehat{f}_{1}\left(2 \pi q_{K}\right)\right|=\left|1-e^{-i c\left(2 \pi q_{K}\right)}\right|=\left|\sin \left(\pi c q_{K}\right)\right|=\left|\sin \left(\pi c q_{K}-\pi p_{K}\right)\right| .
$$

The inequality (4.2) now yields that

$$
\left|\sin \left(\pi\left(c q_{K}-p_{K}\right)\right)\right| \geq C\left(1+4 \pi^{2} q_{K}^{2}\right)^{-N}
$$

But $|\sin \Theta| \leq|\Theta|$ for all real $\Theta$, and so we obtain

$$
\pi q_{K}\left|c-\frac{p_{K}}{q_{K}}\right| \geq C\left(1+4 \pi^{2} q_{K}^{2}\right)^{-N}
$$

In light of (4.1), we now obtain

$$
\pi q_{K} \frac{1}{q_{K}^{K}} \geq C\left(1+4 \pi^{2} q_{K}^{2}\right)^{-N}
$$

and rearranging, we have

$$
\pi \frac{q_{K}\left(1+4 \pi^{2} q_{K}\right)^{N}}{q_{K}^{K}} \geq C
$$

Passing the limit $K \rightarrow \infty$, we arrive at the contradiction that $0 \geq C$.
We remark that in this example $f_{1}, f_{2}$ actually belong to $\mathcal{E}^{\prime}\left(\mathbb{R}_{+}\right)$, and with the same argument given above, it can be seen that $\widehat{f_{1}}, \widehat{f_{2}}$ don't satisfy (3.3) either. This also gives another example answering question number 1 in [7], namely, for $f_{1}, f_{2}$ in $\mathcal{E}^{\prime}\left(\mathbb{R}_{+}\right)$, whether the condition that $\widehat{f}_{1}, \widehat{f}_{2}$ have no common zeros is enough to guarantee that there are $g_{1}, g_{2} \in \mathcal{E}^{\prime}\left(\mathbb{R}_{+}\right)$such that $f_{1} * g_{1}+f_{2} * g_{2}=\delta$.
