# On stabilization and control for the critical Klein-Gordon equation on a 3-D compact manifold

#### Abstract

In this article, we study the internal stabilization and control of the critical nonlinear KleinGordon equation on 3-D compact manifolds. Under a geometric assumption slightly stronger than the classical geometric control condition, we prove exponential decay for some solutions bounded in the energy space but small in a lower norm. The proof combines profile decomposition and microlocal arguments. This profile decomposition, analogous to the one of Bahouri-Gérard [2] on $\mathbb{R}^{3}$, is performed by taking care of possible geometric effects. It uses some results of S . Ibrahim [21] on the behavior of concentrating waves on manifolds.

## Introduction

In this article, we study the internal stabilization and exact controllability for the defocusing critical nonlinear Klein-Gordon equation on some compact manifolds.

$$
\left\{\begin{align*}
\square u=\partial_{t}^{2} u-\Delta u & =-u-|u|^{4} u \quad \text { on } \quad[0,+\infty[\times M  \tag{1}\\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) \in \mathcal{E} .
\end{align*}\right.
$$

where $\Delta$ is the Laplace-Beltrami operator on $M$ and $\mathcal{E}$ is the energy space $H^{1}(M) \times L^{2}(M)$. The solution displays a conserved energy

\begin{equation*}
E(t)=\frac{1}{2}\left(\int_{M}\left|\partial_{t} u\right|^{2}+\int_{M}|u|^{2}+\int_{M}|\nabla u|^{2}\right)+\frac{1}{6} \int_{M}|u|^{6} . \tag{2}
\end{equation*}

This problem was already treated in the subcritical case by B. Dehman, G. Lebeau and E. Zuazua [11. The problem is posed in a different geometry but their proof could easily be transposed in our setting. Yet, their result fails to apply to the critical problem for two main reasons, as explained in their paper :
(a) The boot-strap argument they employ to improve the regularity of solutions vanishing in the zone of control $\omega$ so that the existing results on unique continuation apply, does not work for this critical exponent.
(b) They can not use the linearizability results by P. Gérard [19] to deduce that the microlocal defect measure for the nonlinear problem propagates as in the linear case.

In this paper, we propose a strategy to avoid the second difficulty at the cost of an additional condition for the subset $\omega$. It was already performed by B. Dehman and P. Gérard 8 in the case of $\mathbb{R}^{3}$ with a flat metric. In fact, in that case, this defect of linearisability is described by the profile decomposition of H. Bahouri and P. Gérard [2]. The purpose of this paper is to extend a part of this proof to the case of a manifold with a variable metric. This more complicated geometry leads to extra difficulties, in the profile decomposition and the stabilization argument. We also mention the recent result of L. Aloui, S. Ibrahim and K. Nakanishi [1] for $\mathbb{R}^{d}$. Their method of proof is very different and uses Morawetz-type estimates. They obtain uniform exponential decay for a damping around spatial infinity for any nonlinearity, provided the solution exists globally. This result is stronger than ours, but their method does not seem to apply to the more complicated geometries we deal with.

We will need some geometrical condition to prove controllability. The first one is the classical geometric control condition of Rauch and Taylor [32] and Bardos Lebeau Rauch [3], while the second one is more restrictive.

Assumption 0.1 (Geometric Control Condition). There exists $T_{0}>0$ such that every geodesic travelling at speed 1 meets $\omega$ in a time $t<T_{0}$.

Definition 0.1. We say that $\left(x_{1}, x_{2}, t\right) \in M^{2} \times \mathbb{R}$ is a couple of focus at distance $t$ if the set

of directions of geodesics stemming from $x_{1}$ and reaching $x_{2}$ in a time $t$, has a positive surface measure.

We denote $T_{\text {focus }}$ the infimum of the $t \in \mathbb{R}$ such that there exists a couple of focus at distance $t$.
If $M$ is compact, we have necessarily $T_{\text {focus }}>0$.
Assumption 0.2 (Geometric control before refocusing). The open set $\omega$ satisfies the Geometric Control Condition in a time $T_{0}<T_{\text {focus }}$.

For example, for $\mathbb{T}^{3}$, there is no refocusing and the geometric assumption is the classical Geometric Control Condition. Yet, for the sphere $S^{3}$, our assumption is stronger. For example, it is fulfilled if $\omega$ is a neighborhood of $\left\{x_{4}=0\right\}$. We can imagine some geometric situations where the Geometric Control Condition is fulfilled while our condition is not, for example if we take only a a neighborhood of $\left\{x_{4}=0, x_{3} \geq 0\right\}$ (see Remark 0.1 and Figure 1 for $S^{2}$ ). We do not know if the exponential decay is true in this case.

The main result of this article is the following theorem.
Theorem 0.1. Let $R_{0}>0$ and $\omega$ satisfying Assumption 0.2. Then, there exist $T>0$ and $\delta>0$ such that for any $\left(u_{0}, u_{1}\right)$ and $\left(\tilde{u}_{0}, \tilde{u}_{1}\right)$ in $H^{1} \times L^{2}$, with

there exists $g \in L^{\infty}\left([0, T], L^{2}\right)$ supported in $[0, T] \times \omega$ such that the unique strong solution of

\square u+u+|u|^{4} u & =g \quad \text { on } \quad[0, T] \times M \\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) .
\end{aligned}\right.
$$

satisfies $\left(u(T), \partial_{t} u(T)\right)=\left(\tilde{u}_{0}, \tilde{u}_{1}\right)$.
Let us discuss the assumptions on the size. In some sense, our theorem is a high frequency controllability result and expresses in a rough physical way that we can control some "small noisy data". In the subcritical case, two similar kind of results were proved : in Dehman Lebeau Zuazua [11] similar results were proved for the nonlinear wave equation but without the smallness assumption in $L^{2} \times H^{-1}$ while in Dehman Lebeau [10], they obtain similar high frequency controllability results for the subcritical equation but in a uniform time which is actually the time of linear controllability (see also the work of the author [29] for the Schrödinger equation). Actually, this smallness assumption is made necessary in our proof because we are not able to prove the following unique continuation result.

Missing theorem. $u \equiv 0$ is the unique strong solution in the energy space of

In the subcritical case, this kind of theorem can be proved with Carleman estimates under some additional geometrical conditions and once the solution is known to be smooth. Yet, in the critical case, we are not able to prove this propagation of regularity. Note also that H. Koch and D. Tataru [26] managed to prove some unique continuation result in the critical case, but in the case $u=0$ on $\omega$ instead of $\partial_{t} u=0$. In the case of $\mathbb{R}^{3}$ with flat metric and $\omega$ the complementary of a ball, B. Dehman and P. Gérard [8] prove this theorem using the existence of the scattering operator proved by K. Nakanishi [31, which is not available on a manifold.

Moreover, as in the subcritical case, we do not know if the time of controllability does depend on the size of the data. This is actually still an open problem for several nonlinear evolution equations such as nonlinear wave or Schrödinger equation (even in the subcritical case). Note that for certain nonlinear parabolic equations, it has been proved that we can not have controllability in arbitrary short time, see [15] or [14].

The strategy for proving Theorem 0.1 consists in proving a stabilization result for a damped nonlinear Klein-Gordon equation and then, by a perturbative argument using the linear control, to bring the solution to zero once the energy of the solution is small enough. Namely, we prove

Theorem 0.2. Let $R_{0}>0$, $\omega$ satisfying Assumption 0.2 and $a \in C^{\infty}(M)$ satisfying $a(x)>\eta>0$ for all $x \in \omega$. Then, there exist $C, \gamma>0$ and $\delta>0$ such that for any $\left(u_{0}, u_{1}\right)$ in $H^{1} \times L^{2}$, with

\left\|\left(u_{0}, u_{1}\right)\right\|_{H^{1} \times L^{2}} \leq R_{0} ; \quad\left\|\left(u_{0}, u_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq \delta ;

the unique strong solution of

$$
\left\{\begin{align*}
\square u+u+|u|^{4} u+a(x)^{2} \partial_{t} u & =0 \quad \text { on } \quad[0, T] \times M  \tag{3}\\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) .
\end{align*}\right.
$$

satisfies $E(u)(t) \leq C e^{-\gamma t} E(u)(0)$.
This theorem is false for the classical nonlinear wave equation (see subsection 3.1.1) and it is why we have chosen the Klein-Gordon equation instead.

Let us now discuss the proof of Theorem 0.2, following B. Dehman and P. Gérard 8 for the case of $\mathbb{R}^{3}$. We have the energy decay

E(u)(t)=E(u)(0)-\int_{0}^{t} \int_{M}\left|a(x) \partial_{t} u\right|^{2}
$$

So, the exponential decay is equivalent to an observability estimate for the nonlinear damped equation. We prove it by contradiction. We are led to proving the strong convergence to zero of a normalized sequence $u_{n}$ of solutions contradicting observability. In the subcritical case, the argument consisted in two steps

- to prove that the limit is zero by a unique continuation argument
- to prove that the convergence is actually strong by linearization and linear propagation of compactness thanks to microlocal defect measures of P. Gérard [18] and L. Tartar [35].

By linearization, we mean (according to the terminology of P. Gérard [19]) that we have $\left\|\mid u_{n}-v_{n}\right\| \underset{n \rightarrow \infty}{\longrightarrow} 0$ where $v_{n}$ is solution of the linear Klein-Gordon equation with same initial data :

In our case, the smallness assumption in the lower regularity $L^{2} \times H^{-1}$ makes that the limit is automatically zero, which allows to skip the first step. In the subcritical case, any sequence weakly convergent to zero is linearizable. Yet, for critical nonlinearity, there exists nonlinearizable sequences. Hopefully, in the case of $\mathbb{R}^{3}$, this defect can be precisely described. It is linked to the non compact action of the invariants of the equation : the dilations and translations. More precisely, the work of H. Bahouri and P. Gérard [2] states that any bounded sequence $u_{n}$ of solutions to the nonlinear critical wave equation can be decomposed into an infinite sum of : the weak limit of $u_{n}$, a sequence of solutions to the free wave equation and an infinite sum of profiles which are translations-dilations of fixed nonlinear solutions. This decomposition was used by the authors of [8] to get the expected result in $\mathbb{R}^{3}$. Therefore, we are led to make an analog of this profile deomposition for compact manifolds. We begin by the definition of the profiles.

Definition 0.2. Let $x_{\infty} \in M$ and $(f, g) \in \mathcal{E}_{x_{\infty}}=\left(\dot{H}^{1} \times L^{2}\right)\left(T_{x_{\infty}} M\right)$. Given $[(f, g), \underline{h}, \underline{x}] \in \mathcal{E}_{x_{\infty}} \times$ $\left(\mathbb{R}_{+}^{*} \times M\right)^{\mathbb{N}}$ such that $\lim _{n}\left(h_{n}, x_{n}\right)=\left(0, x_{\infty}\right)$ We call the associated concentrating data the class of equivalence, modulo sequences convergent to 0 in $\mathcal{E}$, of sequence in $\mathcal{E}$ that take the form

in some coordinate patch $U_{M} \approx U \subset \mathbb{R}^{d}$ containing $x_{\infty}$ and for some $\Psi_{U} \in C_{0}^{\infty}(U)$ such that $\Psi_{U}(x)=1$ in a neighborhood of $x_{\infty}$. (Here, we have identified $x_{n}, x_{\infty}$ with its image in $U$ ).

We will prove later (Lemma 1.3) that this definition does not depend on the coordinate charts and on $\Psi_{U}$ : two sequences defined by (4) in different coordinate charts are in the same class. In what follows, we will often call concentrating data associated to $[(f, g), \underline{h}, \underline{x}]$ an arbitrary sequence in this class.

Definition 0.3. Let $\left(t_{n}\right)$ a bounded sequence in $\mathbb{R}$ converging to $t_{\infty}$ and $\left(f_{n}, g_{n}\right)$ a concentrating data associated to $[(f, g), \underline{h}, \underline{x}]$. A damped linear concentrating wave is a sequence $v_{n}$ solution of

\left(v_{n}\left(t_{n}\right), \partial_{t} v_{n}\left(t_{n}\right)\right) & =\left(f_{n}, g_{n}\right) .
\end{align*}\right.
$$

The associated damped nonlinear concentrating wave is the sequence $u_{n}$ solution of

\square u_{n}+u_{n}+a(x) \partial_{t} u_{n}+\left|u_{n}\right|^{4} u_{n} & =0 \quad \text { on } \quad \mathbb{R} \times M  \tag{6}\\
\left(u_{n}(0), \partial_{t} u_{n}(0)\right) & =\left(v_{n}(0), \partial_{t} v_{n}(0)\right) .
\end{align*}\right.
$$

If $a \equiv 0$, we will only write linear or nonlinear concentrating wave.
Energy estimates yields that two representants of the same concentrating data have the same associated concentrating wave modulo strong convergence in $L_{l o c}^{\infty}(\mathbb{R}, \mathcal{E})$. This is not obvious for the nonlinear evolution but will be a consequence of the study of nonlinear concentrating waves.

It can be easily seen that this kind of nonlinear solutions are not linearizable. Actually, it can be shown that this concentration phenomenon is the only obstacle to linearizability. We begin with the linear decomposition.

Theorem 0.3. Let ( $v_{n}$ ) be a sequence of solutions to the damped Klein-Gordon equation (5) with initial data at time $t=0\left(\varphi_{n}, \psi_{n}\right)$ bounded in $\mathcal{E}$. Then, up to extraction, there exist a sequence of damped linear concentrating waves $\left(\underline{p}^{(j)}\right)$, as defined in Definition 0.3, associated to concentrating
data $\left[\left(\varphi^{(j)}, \psi^{(j)}\right), \underline{h}^{(j)}, \underline{x}^{(j)}, \underline{t}^{(j)}\right]$, such that for any $l \in \mathbb{N}^{*}$,

\left.\left\|\left(v_{n}, \partial_{t} v_{n}\right)\right\|_{\mathcal{E}}^{2}=\sum_{j=1}^{l}\left\|\left(p_{n}^{(j)}, \partial_{t} p_{n}^{(j)}\right)\right\|_{\mathcal{E}}^{2}+\|\left(w_{n}^{(l)}\right), \partial_{t} w_{n}^{(l)}\right) \|_{\mathcal{E}}^{2}+o(1), \text { as } n \rightarrow \infty, \tag{9}

where $o(1)$ is uniform for $t \in[-T, T]$.
The nonlinear flow map follows this decomposition up to an error term in the strong following norm

\|u\|_{I}=\|u\|_{L^{\infty}\left(I, H^{1}(M)\right)}+\left\|\partial_{t} u\right\|_{L^{\infty}\left(I, L^{2}(M)\right)}+\|u\|_{L^{5}\left(I, L^{10}(M)\right)} .

Theorem 0.4. Let $T<T_{\text {focus }} / 2$. Let $u_{n}$ be the sequence of solutions to damped non linear KleinGordon equation (6) with initial data, at time $0,\left(\varphi_{n}, \psi_{n}\right)$ bounded in $\mathcal{E}$. Denote $p_{n}^{(j)}$ (resp $v$ the weak limit) the linear damped concentrating waves given by Theorem 0.3 and $q_{n}^{(j)}$ the associated nonlinear damped concentrating wave (resp $u$ the associated solution of the nonlinear equation with $\left.\left(u, \partial_{t} u\right)_{t=0}=\left(v, \partial_{t} v\right)_{t=0}\right)$. Then, up to extraction, we have

where $w_{n}^{(l)}$ is given by Theorem 0.3.
The same theorem remains true if $M$ is the sphere $S^{3}$ and $a \equiv 0$ (undamped equation) without any assumption on the time $T$.

The more precise result we get for the sphere $S^{3}$ will not be useful for the proof of our controllability result. Yet, we have chosen to give it because it is the only case where we are able to describe what happens when some refocusing occurs.

This profile decomposition has already been proved for the critical wave equation on $\mathbb{R}^{3}$ by H . Bahouri and P. Gerard [2] and on the exterior of a convex obstacle by I. Gallagher and P. Gérard [17]. The same decomposition has also been performed for the Schrödinger equation by S. Keraani [25] and quite recently for the wave maps by Krieger and Schlag [27]. Note that such decomposition has proved to be useful in different contexts : the understanding of the precise behavior near the threshold for well-posedness for focusing nonlinear wave see Kenig Merle [24] and Duyckaerts Merle [13], the study of the compactness of Strichartz estimates and maximizers for Strichartz estimates, (see Keraani [25]), global existence for wave maps [27]... May be our decomposition on manifolds could be useful in one of these contexts. Let us also mention that, this kind of decomposition appears for a long time in the context of Palais-Smale sequences for critical elliptic equation and optimal constant for Sobolev embedding, but with a finite number of profiles, see Brezis Coron [4], the book [12] and the references therein ...

Let us describe quickly the proof of the decomposition. The linear decomposition of Theorem 0.3 is made in two steps : first, we decompose our sequence in a sum of an infinite number of
sequences oscillating at different rate $h_{n}^{(j)}$. Then, for each part oscillating at a fixed rate, we extract the possible concentration at certain points. We only have to prove that this process produces a rest $w_{n}^{l}$ that gets smaller in the norm $L^{\infty} L^{6}$ at each stage. Once the linear decomposition is established, Theorem 0.4 says, roughly speaking, that the nonlinear flow map acts almost linearly on the linear decomposition. To establish the nonlinear decomposition we have to prove that each element of the decomposition do not interact with the others. For each element of the linear decomposition, we are able to describe the nonlinear solution arizing from this element as initial data. The linear rest $w_{n}^{l}$ is small in $L^{\infty}\left([-T, T], L^{6}\right)$ for $l$ large enough and so the associated nonlinear solution with same initial data is very close to the linear one. The behavior of nonlinear concentrating waves is described in [21] (see subsection 2.2.1 for a short review). Before the concentration, linear and nonlinear waves are very close. For times close to the time of concentration, the nonlinear rescaled solution behaves as if the metric was flat and is subject to the scattering of $\mathbb{R}^{3}$. After concentration, the solution is close to a linear concentrating wave but with a new profile obtained by the scattering operator on $\mathbb{R}^{3}$.

We finish this introduction by a discussion on the geometric conditions we imposed to get our main theorem. For the linear wave equation, the controllability is known to be equivalent to the so called Geometric Control Condition (Assumption 0.1). This was first proved by Rauch and Taylor [32] in the case of a compact manifold and by Bardos Lebeau Rauch [3] for boundary control (see Burq Gérard for the necessity [5]). For the nonlinear subcritical problem, the result of [10] only requires the classical Geometric Control Condition. Our assumption is stronger and we can naturally wonder if it is really necessary. It is actually strongly linked with the critical behavior and nonlinear concentrating waves. Removing this stronger assumption would require a better understanding of the scattering operator of the nonlinear equation on $\mathbb{R}^{3}$ (see Remark 0.1). However, we think that the same result could be obtained with the following weaker assumption.

Assumption 0.3. $\omega$ satisfies the Geometric Control Condition. Moreover, for every couple of focus $\left(x_{1}, x_{2}, t\right)$ at distance $t$, according to Definition 0.1, each geodesic starting from $x_{1}$ in direction $\xi$ such that exp $x_{x_{1}} t \xi=x_{2}$ meets $\omega$ in a time $0 \leq s<t$.

Finally, we note that our theorem can easily be extended to the case of $\mathbb{R}^{3}$ with a metric flat at infinity. In this case, our stabilization term $a(x)$ should fulfill the both assumptions

- there exist $R>0$ and $\rho>0$ such that $a(x)>\rho$ for $|x|>R$
- $a(x)>\rho$ for $x \in \omega$ where $\omega$ satisfies Assumption 0.2.

The proof would be very similar. The only difference would come from the fact that the domain is not compact. So the profile decomposition would require the "compactness at infinity" (see property (1.6) of [2]). Moreover, the equirepartition of the energy could not be made only with measures but with an explicit computation (see (3.14) of [8])

Remark 0.1. In order to know if our stronger Assumptions 0.2 or 0.3 are really necessary compared to the classical Geometric Control Condition, we need to prove that the following scenario can not happen. We take the example of $S^{3}$ with $\omega$ a neighborhood of $\left\{x_{4}=0, x_{3} \geq 0\right\}$.

Take some data concentrating on the north pole, with a Fourier transform (on the tangent plane) supported around a direction $\xi_{0}$. The nonlinear solution will propagate linearly as long as it does not concentrate : at time $t$ it will be supported in an neighborhood of the point $x(t)$ where $x(t)$ follows the geodesic stemming from the north pole at time 0 in direction $\xi_{0}$. Then, if $\xi_{0}$ is well chosen, it can avoid $\omega$ during that time. Yet, at time $\pi$, the solution will concentrate again in the south pole. According to the description of S. Ibrahim [21], in a short time, the solution will be transformed following the
nonlinear scattering operator on $\mathbb{R}^{3}$. So, at time $\pi+\varepsilon$ the solution is close to a linear concentrating wave but it concentrates with a new profile which is obtained with the nonlinear scattering operator on $\mathbb{R}^{3}$. This operator is strongly nonlinear and we do not know whether the new profile will be supported in Fourier near a new direction $\xi_{1}$. If it happens, the solution will then be supported near the point $y(t)$ where $y(t)$ follows the geodesic stemming from the south pole at time $\pi$ in direction $\xi_{1}$. In this situation, it will be possible that the trajectory $y(t)$ still avoids $\omega$. If this phenomenon happens several times, we would have a sequence that concentrates periodically on the north and south pole but always avoiding the region $\omega$ (which in that case satisfies Geometric Control Condition).


Figure 1: Possible situation on the sphere
We are led to the following informal question. If $S$ is the scattering operator on $\mathbb{R}^{3}$, is that possible that for some data $(f, g) \in \dot{H}^{1} \times L^{2}$ supported in Fourier near a direction $\xi_{0}$, the Fourier transform of $S(f, g)$ is supported near another direction $\xi_{1}$. In other words, can the nonlinear wave operator change the direction of the light?

The structure of the article is as follows. The first section contains some preliminaries that will be used all along the article : the existence theorem for damped nonlinear equation, the description of the main properties of concentrating waves and the useful properties of the scales necessary for the linear decomposition. The second section contains the proof of the profile decomposition of Theorem 0.3 and 0.4. It is naturally divided in two steps corresponding to the linear decomposition and the nonlinear one. We close this section by some useful consequences of the decomposition. The third section contains the proof of the main theorems : the control and stabilization.

Note that the main argument for the proof of stabilization is contained in the last section 3 : in Proposition 3.1 we apply the linearization argument to get rid of the profiles while Theorem 3.1 contains the proof of the weak observability estimates. We advise the hurried reader to have a first glance at these two proofs in order to understand the global argument.

### 0.1 Notation

For $I$ an interval, denote

The energy spaces are denoted

We will denote $\langle\cdot, \cdot\rangle_{\mathcal{E}}$ and $\langle\cdot, \cdot\rangle_{\mathcal{E}_{\infty}}$ the associated scalar product.
When dealing with solutions of non linear wave equations on $M$ (or on $T_{x_{\infty}} M$ ), "the unique strong solution" will mean the unique solution in the Strichartz space $L_{\text {loc }}^{5}\left(\mathbb{R}, L^{10}(M)\right)\left(\right.$ or $L_{\text {loc }}^{5}\left(\mathbb{R}, L^{10}\left(T_{x_{\infty}} M\right)\right)$ ) such that $\left(u, \partial_{t} u\right) \in C(\mathbb{R}, \mathcal{E})\left(\right.$ or $C\left(\mathbb{R}, \mathcal{E}_{x_{\infty}}\right)$.

All along the article, for a point $x \in M$, we will sometime not distinguish $x$ with its image in a coordinate patch and will write $\mathbb{R}^{3}$ instead of $T_{x_{\infty}} M . M$ will always be smooth, compact and the number of coordinate charts we use is always assumed to be finite. We also assume that all the charts are relatively compact. In all the article, $C$ will denote any constant, possibly depending on the manifold $M$ and the damping function $a$. We will also write $\lesssim$ instead of $\leq C$ for a constant $C$. $B_{2, \infty}^{s}(M)$ denotes the Besov space on $M$ defined by

Of course, $B_{2, \infty}^{s}(M)$ is linked with $B_{2, \infty}^{s}\left(\mathbb{R}^{3}\right)$ by the expression in coordinate charts. This will be precised in Lemma 2.1.

From now on, $a=a(x)$ will always denote a smooth real valued function defined on $M$.

## 1 Preliminaries

### 1.1 Existence theorem

The existence of solutions to our equation is proved using two tools: Strichartz and Morawetz estimates. Strichartz estimates take the following form.

Proposition 1.1 (Strichartz and energy estimates). Let $T>0$ and $(p, q)$ satisfying

Proof. The case with $a \equiv 0$ for the wave equation can be found in L.V. Kapitanski [23]. To treat the case of damped Klein-Gordon, we only have to absorb the additional terms and get the desired estimate for $T$ small enough. We can then reiterate the operation to get the result for large times.

Then, we are going to prove global existence for the equation

with $g \in L^{1}\left([-T, T], L^{2}(M)\right)$ and $a \in C^{\infty}(M)$.
The proof is now very classical, see for example [36] for a survey of the subject. The critical defocusing nonlinear wave equation on $\mathbb{R}^{3}$ was proved to be globally well posed by Shatah and Struwe [34, 33] using Morawetz estimates. Later, S. Ibrahim an M. Majdoub managed to apply this strategy in the case of variable coefficients in [22], but without damping and forcing term. In this subsection, we extend this strategy to the case with these additional terms. We also refer to the appendix of [2] where the computation of Morawetz estimates on $\mathbb{R}^{3}$ is made with a forcing term. We also mention the result of N. Burq, G. Lebeau and F. Planchon [7 in the case of 3-D domains.

We only have to check that the two additional terms do not create any trouble. Actually, the main difference is that the energy in the light cones is not decreasing, but it is locally "almost decreasing" (see formula (13)) and this will be enough to conclude with the same type of arguments.

As usual in critial problems, the local problem is well understood thanks to Strichartz estimates while we have to prove global existence. We only consider Shatah Struwe solutions, that is satisfying Strichartz estimates and we wave uniqueness for local solutions in this class. We assume that there is a maximal time of existence $t_{0}$ and we want to prove that it is infinite. The solution considered will be limit of smooth solutions of the nonlinear equation with smoothed initial data and nonlinearity. Therefore, the integrations by part are licit by a limiting argument.

We need some notations. To simplify the notations, the space-time point where we want to extend the solution will be $z_{0}=\left(t_{0}, x_{0}\right)=(0,0) . \varphi$ is the geodesic distance on $M$ to $x_{0}=0$ defined in a neighborhood $U$ of 0 . Denote for some small $\alpha<\beta<0$

The identity is obtained by multiplying the equation by $\partial_{t} \bar{u}$ to get $\partial_{t} e(u)-\Re d i v\left(\partial_{t} \bar{u} \nabla_{x} u\right)=$ $a(x)\left|\partial_{t} u\right|^{2}-u \partial_{t} \bar{u}+\Re g \partial_{t} \bar{u}$, then, we integrate over the truncated cone $K_{\alpha}^{\beta}$ and use Stokes formula. Denote $f(t)=E(u, D(t))$. Using the positivity of the flux and Hölder inequality, we estimate

This property will replace the decreasing of the energy that occurs without damping and forcing term in all the rest of the proof. It easily implies that $f$ has a left limit.

where we have used the notation $f(t)=E(u, D(t))$.
Proof. It is a consequence of Morawetz estimates. The only difference is the presence of the forcing term $g$ and the metric. The case of flat metric is treated in [2]. The metric leads to the same estimates with an additional term $(\beta-\alpha) \sup _{t \in[\alpha, \beta]} f(t)+f(t)^{1 / 3}$ as treated in [22]. Another minor difference is that in the presence of a forcing term, the energy does not decrease and $f(\beta)+f(\beta)^{1 / 3}$ have to be replaced by the supremum on the interval. Note also that our estimate is made in the backward cone while the computation is made in the future cone in these references. We leave the easy modifications to the reader.

The previous estimates will be the main tools of the proof. It will be enough to prove some non concentration property in the light cone for $L^{\infty} L^{6}, L^{5} L^{10}$ and finally in energy space. It is the object of the following three corollaries.

## Corollary 1.1.

which tends to 0 as $\beta$ tends to 0 . This yields

A boot-strap argument and Corollary 1.1 give that for $s$ sufficiently close to $0,\|u\|_{L^{4} L^{12}\left(K_{s}^{0}\right)}$ is bounded. We get the announced result by interpolation between $L^{4} L^{12}$ and $L^{\infty} L^{6}$.

## Corollary 1.3.

Since $v_{s}$ is solution of the free damped linear equation, we have $E_{0}\left(v_{s}, D(t)\right) \underset{t \rightarrow 0}{\longrightarrow} 0$. This yields the result with $E_{0}$ instead of $E$. The final result is obtained thanks to Corollary 1.1.

We can now finish the proof of global existence.
Let $\varepsilon>0$ to be chosen later. By Corollary [1.3, $E(u, D(s)) \leq \varepsilon$ for $s$ close enough to 0 . By dominated convergence, for any $s<0$ close to 0 , there exists $\eta>0$ so that

Remark 1.1. It is likely that global existence can also be proved using the Kenig-Merle argument [24] and the profile decomposition below (assuming only local existence) as is done for example in [27] for the wave maps.

### 1.2 Concentration waves

In this section, we give details about concentrating waves that will be useful in the profile decomposition. The first lemma states that Definition 0.2 of concentrating data does not depend on the choice of coordinate patch and cut-off function $\Psi_{U}$.

Lemma 1.3. Let $[(f, g), \underline{h}, \underline{x}] \in \mathcal{E} \times\left(\mathbb{R}_{+}^{*} \times M \times\right)^{\mathbb{N}}$ such that $\lim _{n}\left(h_{n}, x_{n}\right)=\left(0, x_{\infty}\right)$ then, all the sequences defined by formula (4) in different coordinates charts and the cut-off function $\Psi_{U}$ are equivalent, modulo convergence in $\mathcal{E}$.

Proof. It is very close to the one of S . Ibrahim [21] where the concentrating data are given in geodesic coordinates. So, let $V_{M} \approx V$ be another coordinate patch and $\Phi: V \mapsto U$ the associated transition map. Without loss of generality, we can suppose that $x_{\infty}$ is represented by 0 in $U$ and $V$. We have to prove that the sequences

h_{n}^{-\frac{1}{2}} \Phi^{*} \Psi_{U}(x)\left(f, \frac{1}{h_{n}} g\right)\left(\frac{x-\Phi\left(x_{n}\right)}{h_{n}}\right)=h_{n}^{-\frac{1}{2}} \Psi_{U}(\Phi(x))\left(f, \frac{1}{h_{n}} g\right)\left(\frac{\Phi(x)-\Phi\left(x_{n}\right)}{h_{n}}\right)
$$

and

$$
h_{n}^{-1 / 2} \Psi_{V}(x)\left(f \circ D \Phi(0), \frac{1}{h_{n}} g \circ D \Phi(0)\right)\left(\frac{x-x_{n}}{h_{n}}\right)
$$

are equivalent in the energy space associated to $M$ or $\mathbb{R}^{3}$ (the volume form and the gradient are not the same but the energies are equivalent). By approximation, we can assume $(f, g) \in\left(C_{0}^{\infty}\left(\mathbb{R}^{3}\right)\right)^{2}$. We make the proof for the $\dot{H}^{1}$ part for $f$, the proof being simpler for $g$. We remark that the terms coming from derivatives hitting on $\Psi_{U}(x)$ tend to 0 in $L^{2}$. Therefore, we have to prove the convergence to 0 of

h_{n}^{-3}\left\|\Psi_{U}(\Phi(x)) D \Phi(x) \nabla f\left(\frac{\Phi(x)-\Phi\left(x_{n}\right)}{h_{n}}\right)-\Psi_{V}(x) D \Phi(0) \nabla f\left(\frac{D \Phi(0) x-D \Phi(0) x_{n}}{h_{n}}\right)\right\|_{L^{2}(V)}^{2}
$$

First, we prove that the cut-off functions $\Psi_{U}$ and $\Psi_{V}$ can be replaced by a unique $\Psi$. Let $\delta$ so that $B(0, \delta) \subset V$. Let $\Psi \in C_{0}^{\infty}(B(0, \delta))$ such that $\Psi \equiv 1$ in a neighborhood of 0 and has a support included in the set of $x$ such that $\Psi_{V}(x)=\Psi_{U}(\Phi(x))=1$, so that $\Psi \Psi_{V}=\Psi$ and $\Psi\left(\Psi_{U} \circ \Phi\right)=\Psi$. Then, on the support of $1-\Psi$, we have $\left\|\Phi(x)-\Phi\left(x_{n}\right)\right\|>\varepsilon$ for some $\varepsilon>0$ and some $n$ large enough. Therefore, we have

& h_{n}^{-3}\left\|(1-\Psi(x)) \Psi_{U}(\Phi(x)) D \Phi(x) \nabla f\left(\frac{\Phi(x)-\Phi\left(x_{n}\right)}{h_{n}}\right)\right\|_{L^{2}(V)}^{2} \\
\leq & C h_{n}^{-3}\left\|\nabla f\left(\frac{\Phi(x)-\Phi\left(x_{n}\right)}{h_{n}}\right)\right\|_{L^{2}\left(\left\|\Phi(x)-\Phi\left(x_{n}\right)\right\|>\varepsilon\right)}^{2}
\end{aligned}
$$

which is 0 for $n$ large enough since $f$ has compact support. Making the same proof for the other term, we are led to prove the convergence to 0 of

$$
\begin{align*}
& h_{n}^{-3}\left\|\Psi(x) D \Phi(x) \nabla f\left(\frac{\Phi(x)-\Phi\left(x_{n}\right)}{h_{n}}\right)-\Psi(x) D \Phi(0) \nabla f\left(\frac{D \Phi(0) x-D \Phi(0) x_{n}}{h_{n}}\right)\right\|_{L^{2}(B(0, \delta))}^{2} \\
& \left\|D \Phi\left(h_{n} x+x_{n}\right) \nabla f\left(\frac{\Phi\left(h_{n} x+x_{n}\right)-\Phi\left(x_{n}\right)}{h_{n}}\right)-D \Phi(0) \nabla f(D \Phi(0) x)\right\|_{L^{2}\left(\left\{x:\left|x_{n}+h_{n} x\right| \leq \delta\right\}\right.}^{2} \tag{14}
\end{align*}
$$

By the fundamental theorem of calculus, there exists $z_{n}(x) \in\left[x_{n}, h_{n} x+x_{n}\right]$ such that $\left|\frac{\Phi\left(h_{n} x+x_{n}\right)-\Phi\left(x_{n}\right)}{h_{n}}\right|=\left|D \Phi\left(z_{n}\right) x\right|>C|x|$ for some uniform $C>0$. As $\nabla f$ is compactly supported, we deduce that for $|x|$ large enough, the integral is zero. So, we are led with the norm (14) with $L^{2}(B(0, C))$ instead of $L^{2}\left(\left\{x:\left|x_{n}+h_{n} x\right| \leq \delta\right\}\right)$. We conclude by dominated convergence.

Using the previous lemma in geodesic coordinates, we get that our definition of concentrating data is the same as Definition 1.2 of S . Ibrahim [21].

Remark that for a concentrating data, $x_{n}-x_{\infty}$ can not be defined invariantly on $T_{x_{\infty}} M$, we can only define the limit of $\left(x_{n}-x_{\infty}\right) / h_{n}$. The change of coordinates must act on $x_{n}$ as an element of $M$ and not $T_{x_{\infty}} M$ even if it converges to $x_{\infty}$. Yet, the functions $(f, g)$ of a concentrating data "live" on the tangent space. Moreover, the norm in energy of a concentrating data is the one of its data.

Lemma 1.4. Let $\left(u_{n}, v_{n}\right)$ a concentrating data associated to $[(\varphi, \psi), \underline{h}, \underline{x}]$, then, we have

\left\|\left(u_{n}, v_{n}\right)\right\|_{\mathcal{E}}=\|(\varphi, \psi)\|_{\mathcal{E}_{x_{\infty}}}+o(1)
$$

where $\nabla_{x_{\infty}}$ and $L^{2}\left(T_{x_{\infty}} M\right)$ are computed with respect to the frozen metric.
The proof is a direct consequence of Lemma 1.5 and 1.6 below or by a direct computation in coordinates.

The next definition is the tool that will be used to "track" the concentrations.
Definition 1.1. Let $x_{\infty} \in M$ and $(f, g) \in \mathcal{E}_{x_{\infty}}$. Given $[(f, g), \underline{h}, \underline{x}] \in \mathcal{E}_{x_{\infty}} \times\left(\mathbb{R}_{+}^{*} \times M\right)^{\mathbb{N}}$ such that $\lim _{n}\left(h_{n}, x_{n}\right)=\left(0, x_{\infty}\right)$. Let $\left(f_{n}, g_{n}\right)$ be a sequence bounded in $\mathcal{E}$, we set

D_{h_{n}}\left(f_{n}, g_{n}\right) \rightharpoonup(f, g)
$$

if in some coordinate patch $U_{M} \approx U \subset \mathbb{R}^{d}$ containing $x_{\infty}$ and for some $\Psi_{U} \in C_{0}^{\infty}(U)$ such that $\Psi_{U}(x)=1$ in a neighborhood of $x_{\infty}$, we have

$$
h_{n}^{\frac{1}{2}}\left(\Psi_{U} f_{n}, h_{n} \Psi_{U} g_{n}\right)\left(x_{n}+h_{n} x\right) \rightharpoonup(f, g) \quad \text { weakly in } \mathcal{E}_{x_{\infty}}
$$

where we have identified $\Psi_{U}\left(f_{n}, g_{n}\right)$ with its representation on $T_{x_{\infty}} M$ in the local trivialisation.
If this holds for one $\left(U, \Psi_{U}\right)$, it holds for any other coordinate chart with the induced transition map.

We denote $D_{h_{n}}^{1} f_{n} \rightharpoonup f$ if we only consider the first part concerning $\dot{H}^{1}$ and $D_{h_{n}}^{2} g_{n} \rightharpoonup g$ for the $L^{2}$ part convergence.

Of course, this definition depends on the core of concentration $\underline{h}$ and $\underline{x}$. In the rest of the paper, the rate $\underline{h}$ and $\underline{x}$ will always be implicit. When several rate of concentration $\left[\underline{h}^{(j)}, \underline{x}^{(j)}\right], j \in \mathbb{N}$, are used in a proof, we use the notation $D_{h}^{(j)}$ to distinguish them.

The fact that this definition is independent of the choice of a coordinate chart can be seen with the following lemma which will also be useful afterward.

Lemma 1.5. $D_{h_{n}}\left(f_{n}, g_{n}\right) \rightharpoonup(f, g)$ is equivalent to

\int_{M} g_{n} v_{n} & \underset{n \rightarrow \infty}{\longrightarrow} \int_{T_{x_{\infty}} M} g \psi
\end{aligned}

where $\left(u_{n}, v_{n}\right)$ is any concentrating data associated with $[(\varphi, \psi), \underline{h}, \underline{x}]$.
The $\nabla$ is computed with respect to the metric on $M$ when the integral is over $M$ and with respect to the frozen metric in $x_{\infty}$ when the integral is over $T_{x_{\infty}} M$.

Proof. We only compute the first term for the $H^{1}$ norm and assume $\varphi \in C_{0}^{\infty}\left(\mathbb{R}^{3}\right)$. $d \omega(y)$ denotes the Riemannian volume form at the point $y,{ }_{y}$ the scalar product at the point $y$ and $\nabla_{h_{n} x+x_{n}}=$ $g\left(h_{n} x+x_{n}\right)^{-1} \nabla$.

We denote $V_{h}=\frac{V-x_{n}}{h}$ and $L_{n, V}=h_{n}^{\frac{1}{2}} \int_{V_{h}} \nabla_{x_{\infty}}\left[\Psi_{V} f_{n}\left(x_{n}+h_{n} x\right)\right] \cdot \nabla_{x_{\infty}} \varphi(x) d \omega(0)$.

$$
\begin{aligned}
L_{n, V} & =h_{n}^{\frac{1}{2}} \int_{V_{h}} \nabla_{x_{n}+h_{n} x}\left[\Psi_{V} f_{n}\left(x_{n}+h_{n} x\right)\right] \cdot{ }_{\left(x_{n}+h_{n} x\right)} \nabla_{x_{n}+h_{n} x} \varphi(x) d \omega\left(x_{n}+h_{n} x\right)+o(1) \\
& =h_{n}^{\frac{3}{2}} \int_{V_{h}} \Psi_{V}\left(x_{n}+h_{n} x\right)\left(\nabla_{x_{n}+h_{n} x} f_{n}\right)\left(x_{n}+h_{n} x\right) \cdot{ }_{\left(x_{n}+h_{n} x\right)} \nabla_{x_{n}+h_{n} x} \varphi(x) d \omega\left(x_{n}+h_{n} x\right)+o(1) \\
& =h_{n}^{-\frac{3}{2}} \int_{V} \nabla_{y} f_{n}(y) \cdot{ }_{y} \Psi_{V}(y) \nabla_{y} \varphi\left(\frac{y-x_{n}}{h_{n}}\right) d \omega(y)+o(1) \\
& =h_{n}^{-\frac{1}{2}} \int_{V} \nabla_{y} f_{n}(y) \cdot y \nabla_{y}\left[\Psi_{V}(y) \varphi\left(\frac{y-x_{n}}{h_{n}}\right)\right] d \omega(y)+o(1)=\int_{M} \nabla_{M} f_{n} \cdot \nabla_{M} u_{n}+o(1) .
\end{aligned}
$$

Therefore, $L_{n, V}$ tends to $\int \nabla f(x) \cdot \nabla \varphi(x) d \omega(0)$ if and only if $\int_{M} \nabla_{M} f_{n} \cdot \nabla_{M} u_{n}$ has the same limit.
An easy consequence of this lemma is the link with concentrating waves.
Lemma 1.6. Let $\left(f_{n}, g_{n}\right)$ be some concentrating data associated with $[(f, g), \underline{h}, \underline{x}]$, then, we have

Proof. Lemma 1.3 permits to work in geodesic coordinates so that the metric $g$ is the identity at the point $x_{\infty}$. In this chart, we have $f_{n}\left(x_{n}+h_{n} x\right)=\Psi_{U}\left(x_{n}+h_{n} x\right) h_{n}^{-\frac{1}{2}} f$. So, the computation of Lemma 1.5 gives $\int \nabla_{\infty} f \cdot \nabla_{\infty} \varphi d \omega(0)=\int_{M} \nabla_{M} f_{n} \cdot \nabla_{M} u_{n}+o(1)$ which gives the result.

We conclude this subsection by a definition of orthogonality that will discriminate concentrating data.

Definition 1.2. We say that two sequences $\left[\underline{h}^{(1)}, \underline{x}^{(1)}, \underline{t}^{(1)}\right]$ and $\left[\underline{h}^{(2)}, \underline{x}^{(2)}, \underline{t}^{(2)}\right]$ are orthogonal if either

- $\log \left|\frac{h_{n}^{(1)}}{h_{n}^{(2)}}\right| \underset{n \rightarrow \infty}{\longrightarrow}+\infty$
- $x_{\infty}^{(1)} \neq x_{\infty}^{(2)}$
- $h_{n}^{(1)}=h_{n}^{(1)}=h$ and $x_{\infty}^{(1)}=x_{\infty}^{(2)}=x_{\infty}$ and in some coordinate chart around $x_{\infty}$, we have

$$
\frac{\left|t_{h}^{(1)}-t_{h}^{(2)}\right|}{h}+\frac{\left|x_{h}^{(1)}-x_{h}^{(2)}\right|}{h} \underset{h \rightarrow 0}{\longrightarrow}+\infty
$$

We note $\left[\underline{h}^{(1)}, \underline{x}^{(1)}, \underline{t}^{(1)}\right] \perp\left[\underline{h}^{(2)}, \underline{x}^{(2)}, \underline{t}^{(2)}\right]$ and $\left(\underline{x}^{(1)}, \underline{t}^{(1)}\right) \perp_{h}\left(\underline{x}^{(2)}, \underline{t}^{(2)}\right)$ if $\underline{h}^{(1)}=\underline{h}^{(2)}=h$.
This definition does not depend on the coordinate chart. This can be seen because we have the estimate $\frac{1}{C}\left|x_{h}^{(1)}-x_{h}^{(2)}\right| \leq\left|\Phi\left(x_{h}^{(1)}\right)-\Phi\left(x_{h}^{(2)}\right)\right| \leq C\left|x_{h}^{(1)}-x_{h}^{(2)}\right|$ if $\Phi$ is the transition map.

### 1.3 Scales

In this subsection, we precise a few facts that will be useful in the first part of the proof of linear profile decomposition which consists of the extration of the scales of oscillation $h_{n}^{j}$.

On the Hilbert space $\mathcal{E}=H^{1}(M) \times L^{2}(M)$, we define the self-adjoint operator $A_{M}$ by :

We define similarly $A_{\mathbb{R}^{d}}$ with the flat laplacian. We denote $A_{\mathbb{R}^{d}, N}$ the obvious operator on $\left(H^{1}\left(\mathbb{R}^{d}\right) \times\right.$ $\left.L^{2}\left(\mathbb{R}^{d}\right)\right)^{N}$ obtained by applying $A_{\mathbb{R}^{d}}$ on each "coordinate".

The following definition is taken from Gallagher-Gérard[17].
Definition 1.3. Let $A$ be a selfadjoint (unbounded) operator on a Hilbert space H. Let $\left(h_{n}\right) a$ sequence of positive numbers converging to 0 . A bounded sequence $\left(u_{n}\right)$ in $H$ is said $\left(h_{n}\right)$-oscillatory with respect to $A$ if

$\left(u_{n}\right)$ is said stricly $\left(h_{n}\right)$-oscillatory with respect to $A$ if it satisfies (15) and

\varlimsup_{n \rightarrow \infty}\left\|1_{|A| \leq \frac{\varepsilon}{h_{n}}} u_{n}\right\|_{H} \underset{\varepsilon \rightarrow 0}{\longrightarrow} 0 .
$$

At the contrary, $\left(u_{n}\right)$ is said $\left(h_{n}\right)$-singular with respect to $A$ if we have

$$
\left\|1_{\frac{a}{h_{n}}}|A| \leq \frac{b}{h_{n}} u_{n}\right\|_{H} \underset{n \rightarrow \infty}{\longrightarrow} 0 \quad \text { for all } 0<a<b .
$$

Remark that $1_{|x| \leq 1}$ can easily be replaced by a well chosen function $\varphi \in C_{0}^{\infty}(\mathbb{R})$. Moreover, if a sequence $\left(u_{n}\right)$ is stricly $\left(h_{n}\right)$-oscillatory while a second sequence $\left(v_{n}\right)$ is $\left(h_{n}\right)$-singular, then we have the interesting property that $\left\langle u_{n}, v_{n}\right\rangle_{H} \xrightarrow[n \rightarrow \infty]{\longrightarrow} 0$.

Proposition 1.2. Let $M=\cup_{i=1}^{N} U_{i}$ a finite covering of $M$ with some associated local coordinate patch $\Phi_{i}: U_{i} \rightarrow V_{i} \subset \mathbb{R}^{3}$. Let $1=\sum_{i} \Psi_{i}$ be an associated partition of the unity of $M$ with $\Psi_{i} \in C_{0}^{\infty}\left(U_{i}\right)$. Let $\left(u_{n}, v_{n}\right)$ a bounded sequence in the $M$ energy space and $h_{n}$ a sequence converging to 0 . Then $\left(u_{n}, v_{n}\right)$ is (stricly) $\left(h_{n}\right)$-oscillatory with respect to $A_{M}$, if and only if all the $\Phi_{i *} \Psi_{i}\left(u_{n}, v_{n}\right)$ are (strictly) ( $h_{n}$ )-oscillatory with respect to $A_{\mathbb{R}^{d}}$.

Proof. First, we remark that a sequence is (strictly) $\left(h_{n}\right)$-oscillatory with respect to $A$ if and only if it is (strictly) $\left(h_{n}^{2}\right)$-oscillatory with respect to $A^{2}$. So we can replace $A_{M}$ and $A_{\mathbb{R}^{3}}$ by $-\left(\Delta_{M}, \Delta_{M}\right)$ and $-\left(\Delta_{\mathbb{R}^{3}}, \Delta_{\mathbb{R}^{3}}\right)$. We apply a proposition taken from [17] that makes the link between oscillation with different operators.
Proposition 1.3 (Proposition 2.2.3 of [17]). Let $\Lambda: H_{1} \rightarrow H_{2}$ be a continuous linear map between Hilbert spaces $H_{1}, H_{2}$. Let $A_{1}$ be a selfadjoint operator on $H_{1}, A_{2}$ be a selfadjoint operator on $H_{2}$. Assume there exists $C>0$ such that $\Lambda\left(D\left(A_{1}\right)\right) \subset D\left(A_{2}\right), \Lambda^{*}\left(D\left(A_{2}\right)\right) \subset D\left(A_{1}\right)$ and for any $u \in D\left(A_{1}\right), v \in D\left(A_{2}\right)$,

\left\|A_{2} \Lambda u\right\| & \leq C\left(\left\|A_{1} u\right\|+\|u\|\right)  \tag{16}\\
\left\|A_{1} \Lambda^{*} v\right\| & \leq C\left(\left\|A_{2} v\right\|+\|v\|\right) . \tag{17}
\end{align*}

If a bounded sequence ( $u_{n}$ ) in $H_{1}$ is (strictly) ( $h_{n}$ )-oscillatory with respect to $A_{1}$, then $\left(\Lambda u_{n}\right)$ is (strictly) ( $h_{n}$ )-oscillatory with respect to $A_{2}$.

To prove the first implication, we apply the proposition with
$\Lambda(u, v)=\left(\Phi_{1 *} \Psi_{1}(u, v), \cdots, \Phi_{N *} \Psi_{N}(u, v)\right)$. We only prove the necessary estimates, the inclusions of domains being a direct consequence of the inequalities and of the density of smooth functions. To simplify the notation, we denote $\left(u_{i}, v_{i}\right)=\Phi_{i *} \Psi_{i}(u, v)$. The proof of (16) mainly uses the equivalent definitions of the $H^{s}$ norm on a manifold.

& \lesssim\|u\|_{H_{M}^{1}}+\left\|\Delta_{M} u\right\|_{H_{M}^{1}}+\|v\|_{L_{M}^{2}}+\left\|\Delta_{M} v\right\|_{L_{M}^{2}} \\
& \lesssim\left\|A_{M}^{2}(u, v)\right\|_{H_{M}^{1} \times L_{M}^{2}}+\|(u, v)\|_{H_{M}^{1} \times L_{M}^{2}} .
\end{aligned}
$$

Let us prove (17) for the duality $H^{1} \times L^{2}$ of the scalar product. Let $(f, g)=\left(f_{i}, g_{i}\right)_{i=1 \cdots N} \in$ $\left(C_{0}^{\infty}\left(\mathbb{R}^{3}\right) \times C_{0}^{\infty}\left(\mathbb{R}^{3}\right)\right)^{N}$ and $(u, v) \in C^{\infty}(M)$.

\begin{aligned}
&\left((u, v), A_{M}^{2} \Lambda^{*}(f, g)\right)_{H^{1}(M) \times L^{2}(M)}=\left(\Lambda A_{M}^{2}(u, v),(f, g)\right)_{\left(H^{1}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)\right)^{N}} \\
&= \sum_{i}\left(\Phi_{i *} \Psi_{i} \Delta_{M} u, f_{i}\right)_{H_{\mathbb{R}^{3}}^{1}}+\sum_{i}\left(\Phi_{i *} \Psi_{i} \Delta_{M} v, g_{i}\right)_{L^{2}} \\
& \lesssim \sum_{i}\left\|\Phi_{i *} \Psi_{i} \Delta_{M} u\right\|_{H_{\mathbb{R}^{3}}^{-1}}\left\|f_{i}\right\|_{H_{\mathbb{R}^{3}}^{3}}+\sum_{i}\left\|\Phi_{i *} \Psi_{i} \Delta_{M} v\right\|_{H_{\mathbb{R}^{3}}^{-2}}\left\|g_{i}\right\|_{H_{\mathbb{R}^{3}}^{2}} \\
& \lesssim\|u\|_{H_{M}^{1}} \sum_{i}\left\|f_{i}\right\|_{H_{\mathbb{R}^{3}}^{3}}+\left\|\Delta_{M} v\right\|_{H_{M}^{-2}} \sum_{i}\left\|g_{i}\right\|_{H_{\mathbb{R}^{3}}^{2}} \\
& \lesssim\|(u, v)\|_{H_{M}^{1} \times L_{M}^{2}}\left(\sum_{i}\left\|\left(\Delta_{\mathbb{R}^{3}} f_{i}, \Delta_{\mathbb{R}^{3}} g_{i}\right)\right\|_{H_{\mathbb{R}^{3}}^{1} \times L_{\mathbb{R}^{3}}^{2}}+\left\|\left(f_{i}, g_{i}\right)\right\|_{H_{\mathbb{R}^{3}}^{1} \times L_{\mathbb{R}^{3}}^{2}}\right) .
\end{aligned}

Therefore, we get $\left\|A_{M}^{2} \Lambda^{*}(f, g)\right\|_{H_{M}^{1} \times L_{M}^{2}} \leq C\left(\left\|A_{\mathbb{R}^{3}, N}^{2}(f, g)\right\|_{\left(H_{\mathbb{R}^{3}}^{1} \times L_{\mathbb{R}^{3}}^{2}\right)^{N}}+\|(f, g)\|_{\left(H_{\mathbb{R}^{3}}^{1} \times L_{\mathbb{R}^{3}}^{2}\right)^{N}}\right)$ and Proposition 1.3 implies that (strict) $\left(h_{n}\right)$-oscillation of $\left(u_{n}\right)$ with respect to $A_{M}$ implies (strict) $\left(h_{n}\right)$ oscillation of $\Lambda u_{n}$ with respect to $A_{\mathbb{R}^{3}, N}$.

To prove the other implication, we use a quite similar operator. Denote $\varphi_{i}$ some other cut-off functions in $C_{0}^{\infty}\left(V_{i}\right) \subset C_{0}^{\infty}\left(\mathbb{R}^{3}\right)$ such that $\varphi_{i} \equiv 1$ on $\operatorname{Supp}\left(\Phi_{i *} \Psi_{i}\right)$. We define $\Gamma$ the bounded operator from $\left(H_{\mathbb{R}^{3}}^{1} \times L_{\mathbb{R}^{3}}^{2}\right)^{N}$ to $H_{M}^{1} \times L_{M}^{2}$ given by

Then, we have $\Gamma \circ \Lambda=I d$ and we only have to prove that (strict) $\left(h_{n}\right)$-oscillation of ( $f_{n}, g_{n}$ ) with respect to $A_{\mathbb{R}^{3}, N}$ implies (strict) $\left(h_{n}\right)$-oscillation of $\Gamma\left(f_{n}, g_{n}\right)$ with respect to $A_{M}$. The needed estimates are quite similar and we omit them.

Remark 1.2. Another way to prove Proposition 1.2 would have been to use the pseudodifferential operators $\varphi\left(h^{2} \Delta_{M}\right)$ as in [6].

Now, we will prove that the $\left(h_{n}\right)$-oscillation is conserved by the equation, even with a damping term.

Proposition 1.4. Let $T>0$. Let $\left(\varphi_{n}, \psi_{n}\right)$ a bounded sequence of $\mathcal{E}$ that is (stricly) $\left(h_{n}\right)$-oscillatory with respect to $A_{M}$. Let $u_{n}$ be the solution of

Then, $\left(u_{n}(t), \partial_{t} u_{n}(t)\right)$ are (strictly) $\left(h_{n}\right)$-oscillatory with respect to $A_{M}$, uniformly on $[0, T]$.
At the contrary, if $\left(\varphi_{n}, \psi_{n}\right)$ is $\left(h_{n}\right)$-singular with respect to $A_{M},\left(u_{n}(t), \partial_{t} u_{n}(t)\right)$ is $\left(h_{n}\right)$-singular with respect to $A_{M}$, uniformly on $[0, T]$.

Proof. Let $\chi \in C_{0}^{\infty}(\mathbb{R})$ such that $0 \leq \chi(s) \leq 1$ and $\chi(s)=1$ for $|s| \leq 1$. The $\left(h_{n}\right)$-oscillation (resp strict oscillation) is equivalent to $\varlimsup_{n \rightarrow \infty}\left\|(1-\chi)\left(R^{2} h_{n}^{2} \Delta\right)\left(u_{n}, \partial_{t} u_{n}\right)\right\|_{\mathcal{E}} \underset{R \rightarrow \infty}{ } 0$
(resp $\left.\varlimsup_{n \rightarrow \infty}\left\|\chi\left(\frac{h_{n}^{2} \Delta}{R^{2}}\right)\left(u_{n}, \partial_{t} u_{n}\right)\right\|_{\mathcal{E} \quad}^{\longrightarrow} 0\right)$.

v_{n}=(1-\chi)\left(R^{2} h_{n}^{2} \Delta\right) u_{n} \text { is solution of }
$$

and energy estimates give

& \leq C_{T}\left\|(1-\chi)\left(R^{2} h_{n}^{2} \Delta\right)\left(\varphi_{n}, \psi_{n}\right)\right\|_{\mathcal{E}}+C_{T} R h_{n} .
\end{aligned}

where the last inequality comes from the fact that $\chi\left(-h^{2} \Delta\right)$ is a semiclassical pseudodifferential operator, as proved in Burq, Gérard and Tzvetkov [6, Proposition 2.1 using the Helffer-Sjöstrand formula.

Therefore, passing to the limitsup in $n$ and using the oscillation assumption, we get the expected result uniformly in $t$ for $0 \leq t \leq T$. The results for strict oscillation and singularity are proved similarly.

Proposition 1.5. There exists $C_{T}>0$ such that for every $\left(\varphi_{n}, \psi_{n}\right)$ bounded sequence of $\mathcal{E}$ weakly convergent to 0 , we have the estimate

where $u_{n}$ is the solution of (18).
Proof. Without loss of generality and since the equation is linear, we can assume that $\left\|\left(\varphi_{n}, \psi_{n}\right)\right\|_{\mathcal{E}}$ is bounded by 1 . Let $\varepsilon>0$. Let $\chi_{0}, \chi \in C_{0}^{\infty}(\mathbb{R})$ so that $1=\chi_{0}+\sum_{k=1}^{\infty} \chi\left(2^{-2 k} x\right)$. We denote $u_{n}^{k}=\chi\left(2^{-2 k} \Delta\right) u_{n}$. Using the same estimates as in the previous lemma, we get

We get the expected result with an additional $\varepsilon$ by combining (20) and (21).
We end this subsection by two lemma that will be useful in the nonlinear decomposition. The first one is lemma 3.2 of [17.

Let $h_{n}$ and $\tilde{h_{n}}$ be two orhogonal scales, and let $\left(f_{n}\right)$ and $\tilde{f}_{n}$ be two sequences such that such $\nabla f_{n}\left(\right.$ resp $\left.\left.\nabla \tilde{f}_{n}\right)\right)$ is strictly $\left(h_{n}\right)\left(\right.$ resp $\left.\tilde{h}_{n}\right)$-oscillatory with respect to $\Delta_{\mathbb{R}^{3}}$. Then, we have :

Lemma 1.8. Let $h_{n}$ and $\tilde{h_{n}}$ be two orhogonal scales and $v_{n}, \tilde{v}_{n}$ be two sequences that are strictly $h_{n}$ (resp $\tilde{h_{n}}$ ) oscillatory with respect to $\Delta_{M}$ (considered on the Hilbert space $H^{1}$ ), uniformly on $[-T, T]$. Then, we have

Moreover, the same result remains true if $\tilde{v}_{n}$ is a constant sequence $v \in H^{1}$ and $\tilde{h}_{n}=1$.
Proof. Using a partition of unity $1=\sum_{i} \Psi_{i}^{2}$ adapted to coordinate charts, we have to compute

Using Proposition 1.2, we infer that $\Phi_{i *} \Psi_{i} v_{n}$ is strictly $\left(h_{n}\right)$-oscillatory with respect to $\Delta_{\mathbb{R}^{3}}$ (defined on $H^{1}$ ) and the same result holds for $\nabla\left(\Phi_{i *} \Psi_{i} v_{n}\right)$ with respect to $\Delta_{\mathbb{R}^{3}}$ defined on $L^{2}$. We conclude by applying Lemma [1.7 to $\Phi_{i *} \Psi_{i} v_{n}$ and $\Phi_{i *} \Psi_{i} v_{n}$.

### 1.4 Microlocal defect measure and energy

In this subsection, we state without proof the propagation of the measure for the damped wave equation. We refer to [18] for the definition and to [19] Section 4 or [16] in the specific context of the wave equation). It will be used several times in the article.

Lemma 1.9. [Measure for the damped equation and equicontinuity of the energy] Let $u_{n}, \tilde{u}_{n}$ be two sequences of solution to

Then, there exists a subsequence (still denoted $u_{n}, \tilde{u}_{n}$ ) such that for any $t \in[0, T]$ there exists a (nonnegative if $u_{n}=\tilde{u}_{n}$ ) Radon measure $\mu^{t}$ on $S^{*} M$ such that for any classical pseudodifferential operator $B$ of order 0 , we have with a uniform convergence in $t$
$(22)\left(B(-\Delta)^{1 / 2} u_{n}(t),(-\Delta)^{1 / 2} \tilde{u}_{n}(t)\right)_{L^{2}(M)}+\left(B \partial_{t} u_{n}(t), \partial_{t} \tilde{u}_{n}(t)\right)_{L^{2}(M)}^{\longrightarrow} \underset{n \rightarrow \infty}{\longrightarrow} \int_{S^{*} M} \sigma_{0}(B) d \mu^{t}$.
Moreover, one can decompose

The microlocal defect measure of a concentrating data $[(\varphi, \psi), \underline{h}, \underline{x}]$ can be explicitely computed, as follows

Proof. We only give a sketch of proof for $B\left(x, D_{x}\right) \psi_{n}$. By approximation, we can assume that $\widehat{\psi} \in C_{0}^{\infty}\left(\mathbb{R}^{3} \backslash 0\right)$. In local coordinates centered at $x_{\infty}=0$, we have for a o(1) small in $L^{2}$

where $B_{n}\left(y, D_{y}\right)$ is the operator of symbol $b_{n}(y, \xi)=b_{0}\left(h_{n} y+x_{n}, \xi / h_{n}\right)$. Here $b_{0}$ is the principal symbol of $B$, homogeneous for large $\xi$. We write $b_{0}\left(h_{n} y+x_{n}, \xi / h_{n}\right)=b_{0}\left(x_{n}, \xi / h_{n}\right)+h_{n} y \int_{0}^{1}\left(\partial_{y} b_{0}\right)\left(x_{n}+\right.$ $\left.t h_{n}, \xi / h_{n}\right) d t$. The first term converges to $b_{0}(0, \xi)$ by homogeneity while the second produces a term small in $L^{2}$.

The previous lemma is made interesting when combined with the propagation of microlocal defect measure.
Lemma 1.11. Let $u_{n}$ a sequence of solutions of $\square u_{n}+u_{n}=a(x) \partial_{t} u_{n}$ weakly convergent to 0 and $p_{n}=[(\varphi, \psi), \underline{h}, \underline{x}, \underline{t}]$ a linear damped concentrating wave. We assume $D_{h}\left(u_{n}, \partial_{t} u_{n}\right) \rightharpoonup 0$. Then, for any classical pseudodifferential operators $A\left(x, D_{x}\right)$ of order 0 , we have uniformly for $t \in[-T, T]$

In particular, we have

Proof. We first check the property for $t=t_{n}$. Using Lemma 1.10 several times, we are led to estimate

where $\left(\varphi_{n}, \psi_{n}\right)$ are the concentrating data associated with $\left[\left(A\left(x_{\infty}, D_{x}\right) \varphi, B\left(x_{\infty}, D_{x}\right) \psi\right), \underline{h}, \underline{x}\right]$. Then, the hypotheses $D_{h}\left(u_{n}, \partial_{t} u_{n}\right) \rightharpoonup 0$ and Lemma 1.5 yields the convergence to 0 for this particular case $t=t_{n}$. We conclude by equicontinuity and by the propagation of joint measures stated in Lemma 1.9 .

## 2 Profile Decomposition

### 2.1 Linear profile decomposition

The main purpose of this section is to establish Theorem 0.3. It is completed in two main steps : the first one is the extraction of the scales $h_{n}^{(j)}$ where we decompose $v_{n}$ in an infinite sum of sequence $v_{n}^{(j)}$ which are respectively $h_{n}^{(j)}$-oscillatory and the second steps consists in decomposing each $v_{n}^{(j)}$ in an infinite sum of concentrating wave at the rate $h_{n}^{(j)}$. Actually, in order to perform the nonlinear decomposition, we will need that, in some sense, each profile of the decomposition do not interact with the other. It is stated in this orthogonality result.
Theorem 0.3. With the notation of Theorem 0.3, we have the additional following properties. If $2 T<T_{\text {focus }}$, we have $\left(\underline{h}^{(k)}, \underline{x}^{(k)}, \underline{t}^{(k)}\right) \perp\left(\underline{h}^{(j)}, \underline{x}^{(j)}, \underline{t}^{(j)}\right)$ for any $j \neq k$, according to Definition 1.2. If $M=S^{3}$ and $a \equiv 0$ (undamped solutions), but with $T$ eventually large, we have $\left(\underline{h}^{(k)},(-1)^{m} \underline{x}^{(k)}, \underline{t}^{(k)}+m \pi\right)$ orthogonal to $\left(\underline{h}^{(j)}, \underline{x}^{(j)}, \underline{t}^{(j)}\right)$ for any $m \in \mathbb{Z}$ and $j \neq k$.

### 2.1.1 Extraction of scales

Proposition 2.1. Let $T>0$. Let $\left(\varphi_{n}, \psi_{n}\right)$ a bounded sequence of $\mathcal{E}$ and $v_{n}$ the solution of

Then, up to an extraction, $v_{n}$ can be decomposed in the following way: for any $l \in \mathbb{N}^{*}$

where $v_{n}^{(l)}$ is a strictly $\left(h_{n}^{(j)}\right)$-oscillatory solution of the damped linear wave equation (23) on $M$. The scales $h_{n}^{(j)}$ satisfy $h_{n}^{(j)} \underset{n \rightarrow \infty}{\longrightarrow} 0$ and are orthogonal :

& \left\|\left(v_{n}, \partial_{t} v_{n}\right)(t)\right\|_{\mathcal{E}}^{2}=\left\|\left(v, \partial_{t} v\right)(t)\right\|_{\mathcal{E}}^{2}+\sum_{j=1}^{l}\left\|\left(v_{n}^{(j)}, \partial_{t} v_{n}^{(j)}\right)(t)\right\|_{\mathcal{E}}^{2}+\left\|\left(\rho_{n}^{(l)}, \partial_{t} \rho_{n}^{(l)}\right)(t)\right\|_{\mathcal{E}}^{2}+o(1)(t) \tag{26}
\end{align*}

where $o(1)(t) \underset{n \rightarrow \infty}{\longrightarrow} 0$ uniformly for $t \in[-T, T]$.
Proof. We first make this decomposition for the initial data as done in [20] (see also [2]). Then, using the propagation of $\left(h_{n}\right)$-oscillation proved in Proposition 1.4, we extend it for all time.

More precisely, by applying the same procedure as in [20], with the operator $A_{M}$, we decompose

This decomposition for the initial data can be extended to the solution by

Thanks to Proposition 1.4, each $\left(v_{n}^{(j)}(t), \partial_{t} v_{n}^{(j)}(t)\right)$ is strictly $\left(h_{n}^{(j)}\right)$-oscillatory and $\left(\rho_{n}^{(l)}(t), \partial_{t} \rho_{n}^{(l)}(t)\right)$ is $\left(h_{n}^{(j)}\right)$ - singular for $1 \leq j \leq l$. So, we easily infer for instance that $\left\langle\left(\rho_{n}^{(l)}(t), \partial_{t} \rho_{n}^{(l)}(t)\right),\left(v_{n}^{(j)}(t), \partial_{t} v_{n}^{(j)}(t)\right)\right\rangle_{\mathcal{E}} \underset{n \rightarrow \infty}{\longrightarrow} 0$ uniformly on $[-T, T]$ where $\langle,\rangle_{\mathcal{E}}$ is the scalar product on $\mathcal{E}$. This is also true for the product between $v_{n}^{(j)}$ and $v_{n}^{(k)}, j \neq k$ thanks to the orthogonality (24). The same convergence holds for the product with $v$ by weak convergence to 0 of the other terms. Then, we get

Let us now prove estimate (25) of the remaining term in $L^{\infty}\left(L^{6}\right)$. (27) gives the convergence to zero of $\left(\rho_{n}^{(l)}(0), \partial_{t} \rho_{n}^{(l)}(0)\right)$ in $B_{2, \infty}^{1}(M) \times B_{2, \infty}^{0}(M)$. We extend this convergence for all time with Proposition 1.5 and get

We postpone the proof of this lemma and continue the proof of the proposition. Using this lemma, we get for every coordinate patch $\left(U_{i}, \Phi_{i}\right)$ and $\Psi_{i} \in C_{0}^{\infty}\left(U_{i}\right)$.

Proof of Lemma 2.1. We essentially use the following fact: see Lemma 3.1 of [2]. Let $f_{n}$ be a sequence of $L^{2}\left(\mathbb{R}^{3}\right)$ weakly convergent to 0 and compact at infinity

Actually, the same result holds $\Delta_{M}$, with the same demonstration. The compactness at infinity in $\mathbb{R}^{3}$ is only assumed to ensure

Using Proposition 1.2, we obtain that $f_{n}$ is $\left(h_{n}\right)$-singular with respect to $\Delta_{M}$ if and only if $\Lambda f_{n}$ is $\left(h_{n}\right)$-singular with respect to $\Delta_{\mathbb{R}^{3}}$. Combining both previous results, we obtain that the two norms we consider have the same converging sequences and are therefore equivalent.

### 2.1.2 Description of linear concentrating waves (after S. Ibrahim)

In this subsection, we describe the assymptotic behavior of linear concentrating waves as described in [21] of S. Ibrahim. In [21], it is stated for the linear wave equation without damping. We give some sketch of proof when necessary to emphasize the tiny modifications.

The following lemma yields that for times close to concentration, the linear damped concentrating wave is close to the solution of the wave equation with flat metric and without damping. It is Lemma 2.2 of [21], except that there is an additional damping term which disappears after rescaling. We do not give the proof and refer to the more complicated nonlinear case (see estimate (531) ).

Lemma 2.2. Let $\left.v_{n}=[(\varphi, \psi), \underline{h}, \underline{x}, \underline{t})\right]$ be a linear damped concentrating wave and $v$ solution of

Denote $\tilde{v}_{n}$ the rescaled function associated to $v$, that is $\tilde{v}_{n}=\Phi^{*} \Psi \frac{1}{\sqrt{h_{n}}} v\left(\frac{t-t_{n}}{h_{n}}, \frac{x-x_{n}}{h_{n}}\right)$ where $(U, \Phi)$ is a coordinate chart around $x_{\infty}$ and $\Psi \in C_{0}^{\infty}(U)$ is constant equal to 1 around $x_{\infty}$. Then, we have

Moreover, Lemma 2.3 of S. Ibrahim [21] yields the "non reconcentration" property for linear concentrating waves.

Lemma 2.3. Let $\underline{v}=[(\varphi, \psi, \underline{h}, \underline{x}, \underline{t})]$ be a linear (possibly damped) concentrating wave. Consider the interval $[-T, T]$ containing $t_{\infty}$, satisfying the following non-focusing property (see Definition 0.1)

Sketch of the proof of Lemma 2.3 in the damped case. To simplify the notation, we can assume $t_{n}=$ 0 . In [21], the proof is made by contradiction, assuming the existence of a subsequence (still denoted $v_{n}$ ) such that $\left\|v_{n}\left(s_{n}\right)\right\|_{L^{6}(M)} \rightarrow C>0$ and $\frac{\left|s_{n}\right|}{h_{n}} \rightarrow \infty$. If $s_{n} \rightarrow \tau \neq 0$, using ConcentrationCompactness principle of [30], we are led to prove that the microlocal defect measure $\mu$ associated to $v_{n}\left(t_{n}\right)$ satisfies $\mu\left(\{y\} \times S^{2}\right)=0$ for any $y \in M$. We use the same argument for the damped equation except that in that case, the measure $\mu^{t}$ associated to $v_{n}(t)$ is not solution of the exact transport equation but of a damped transport equation (see for Lemma 1.9). Yet, the non focusing assumption (29) still implies $\mu^{t}\left(\{y\} \times S^{2}\right)=0$ for all $y \in M$ and $t \neq 0$, which allows to conclude similarly.

In the case $\tau=0$, we use in local coordinates the rescaled function $\tilde{v}_{n}(s, y)=\sqrt{s_{n}} v_{n}\left(s_{n} s, s_{n} y+x_{n}\right)$. $\tilde{v}_{n}$ at time $s=0$ is a concentrating data at scale $h_{n} / s_{n}$. We prove $\lim \left\|\tilde{v}_{n}(1, \cdot)\right\|_{L^{6}\left(\mathbb{R}^{3}\right)}=0$. Again by concentration compactness, it is enough to prove that the microlocal defect measure $\mu^{s}$ of $\tilde{v}_{n}$ propagates along the curves of the hamiltonian flow with constant coefficient $H_{|\xi|}$. Since $v_{n}$ is solution of $\square v_{n}+v_{n}+a(x) \partial_{t} v_{n}=0, \tilde{v}_{n}$ is solution of $\square_{n} \tilde{v}_{n}+s_{n}^{2} \tilde{v}_{n}+s_{n} a\left(s_{n} \cdot+x_{n}\right) \partial_{t} \tilde{v}_{n}=0$ where $\square_{n}$ is a suitably rescaled D'Alembert operator. Since the additional terms $s_{n}^{2} \tilde{v}_{n}+s_{n} a\left(s_{n} \cdot+x_{n}\right) \partial_{t} \tilde{v}_{n}$ converges to 0 in $L^{1} L^{2}$, we can finish the proof as in Lemma 2.3 of 21] by proving that $\mu^{s}$ propagates as if $\square_{n}$ was replaced by $\square_{\infty}$, that is along the hamiltonian $H_{|\xi|}$.

The estimate in norm $L^{5} L^{10}$ is obtained by interpolation of $L^{\infty} L^{6}$ with another bounded Strichartz norm.

In the specific case of $S^{3}$, Lemma 4.2 of [21] allows to describe precisely the behavior of concentrating wave for large times, as follows.

Lemma 2.4. Let $\underline{p}$ be a sequence of solutions of

In particular, if $\underline{p}$ is a concentrating wave associated with data $[(\varphi, \psi, \underline{h}, \underline{x}, \underline{t})]$, then, for any $j \in \mathbb{N}$, $p_{n}(t+j \pi, x)$ is a linear concentrating wave associated with $\left.\left[(-1)^{j}(\varphi, \psi)\left((-1)^{j}.\right), \underline{h},(-1)^{j} \underline{x}, \underline{t}\right)\right]$

In the previous lemma, $-x$ refers to the embedding of $S^{3}$ into $\mathbb{R}^{4}$. Moreover, the notation $(\varphi, \psi)(-$.$) could be written more rigorously (\varphi, \psi)\left(D_{\infty} I\right.$.) where $D_{\infty} I$ is the differential at the point $x_{\infty}$ of the application $I: x \mapsto-x$ defined from $S^{3}$ into itself. Actually, we are identifying the tangent plane at the south pole with the one on the north pole by the application $x \mapsto-x$ on $\mathbb{R}^{4}$.

The fact that the result remains true for the equation $\square u+u=0$ comes from the fact that for initial data weakly convergent to zero, the solutions of $\square u=0$ and $\square v+v=0$ with same data are asymptotically close in the energy space. This can be proved by observing that for a weakly convergent sequence of solutions $u_{n}$ the Aubin-Lions Lemma yields that $u_{n}$ converges strongly to 0 in $L^{\infty}\left([-T, T], L^{2}\right)$. So $r_{n}=u_{n}-v_{n}$ is solution of $\square r_{n}=u_{n}$ and converges strongly in $\mathcal{E}$.

### 2.1.3 Extraction of times and cores of concentration

In this section, $h_{n}$ is a fixed sequence in $\mathbb{R}_{+}^{*}$ converging to 0 . For simplicity, we will denote it by $h$ and $u_{h}$ for sequences of functions. The main purpose of this subsection is the proof of the following proposition, which is the profile decomposition for $h$-oscillatory sequences. It easily implies Theorem 0.3 when combined with Proposition 2.1 .

Proposition 2.2. Let ( $u_{h}$ ) be a h-oscillatory sequence of solutions to the damped Klein-Gordon equation (23). Then, up to extraction, there exist damped linear concentrating waves $p_{h}^{k}$, as defined in Definition [0.3, associated to concentrating data $\left[\left(\varphi^{(k)}, \psi^{(k)}\right), \underline{h}, \underline{x}^{(k)}, \underline{t}^{(k)}\right]$, such that for any $l \in \mathbb{N}^{*}$, and up to a subsequence,

Moreover, if $2 T<T_{\text {focus }}$, for any $j \neq k$, we have $\left(\underline{x}^{(k)}, \underline{t}^{(k)}\right) \perp_{h}\left(\underline{x}^{(j)}, \underline{t}^{(j)}\right)$ according to Definition 1.2.

If $M=S^{3}$ and $a \equiv 0$ (undamped solutions), but with $T$ eventually large, $\left((-1)^{m} \underline{x}^{(k)}, \underline{t}^{(k)}+m \pi\right)$ is orthogonal to $\left(\underline{x}^{(j)}, \underline{t}^{(j)}\right)$ for any $m \in \mathbb{Z}$ and $j \neq k$.

Remark 2.1. The assumptions to get the orthogonality of the cores of concentration are related to our lack of understanding of the solutions concentrating in a point $x_{1}$ where $\left(x_{1}, x_{2}, t\right)$ is a couple of focus at distance $t$. We know that the solution reconcentrates after a time $t$ in the other focus $x_{2}$ but we do not know precisely how : can it split into several concentrating waves on $x_{2}$ with different "rate of concentration"? That is to say with some different $x_{n}$ converging to $x_{2}$ but which are orthogonal.

Before getting into the proof of the proposition, we state two lemmas that will be useful in the proof. Using the notation of Definition 1.1, denote

This lemma is already known in the case of $\mathbb{R}^{3}$ where the definition of $\delta_{\mathbb{R}^{3}}^{x}$ is the same except that $D_{h}^{1}$ is only considered in the trivial coordinate chart. It is estimate (4.19) of [20] in the case of a 1-oscillatory sequence, which can be easily extended to $\left(h_{n}\right)$ - oscillatory sequence by dilation.

Let $\Psi_{i} \in C_{0}^{\infty}\left(U_{i}\right)$ associated to a coordinate patch $\Phi_{i}$. By Proposition 1.2, $\Phi_{i}^{*} \Psi_{i} v_{h}$ is still $\left(h_{n}\right)-$ oscillatory and we can apply the estimate on $\mathbb{R}^{3}$. We get

\leq & C \delta_{\mathbb{R}^{3}}^{x}\left(\Phi_{i}^{*} \Psi_{i} \underline{v}\right)^{1 / 3} \varlimsup_{n \rightarrow+\infty}\left\|v_{h}\right\|_{H^{1}(M)}^{1 / 6}
\end{aligned}

Then, by definition of the convergence $D_{h}$, we easily get

by definition of $\delta$ and by energy estimates.
Proof of Proposition [2.2, It is based on the same extraction argument as [2] and [17] : the concentration will be tracked using our tool $D_{h}$ and we will extract concentrating waves so that $\delta(\underline{v})$ decreases. We conclude with Lemma 2.7 to estimate the $L^{\infty}\left(L^{6}\right)$ norm of the remainder term.

More precisely, if $\delta(\underline{v})=0$, Lemma 2.7 shows that there is nothing to be proved. Otherwise, pick $\left(x_{h}^{(1)}, t_{h}^{(1)}\right)$ converging to $\left(x_{\infty}^{(1)}, t_{\infty}^{(1)}\right)$ and $\left(\varphi^{(1)}, \psi^{(1)}\right) \in \mathcal{E}_{x_{\infty}}$, such that

The existence of the weak limit $\psi^{(1)}$ (up to a subsequence) is ensured by the boundedness in $L^{2}\left(\mathbb{R}^{3}\right)$ of $\partial_{t} v_{h}$ (considered in a coordinate chart) by conservation of energy.

Then, we choose $p_{h}^{(1)}$ as the damped linear concentrating profile associated with $\left[\left(\varphi^{(1)}, \psi^{(1)}\right), \underline{h}, \underline{x}^{(1)}, \underline{t}^{(1)}\right]$ (actually, we pick one representant in the equivalence class modulo sequences converging to 0 in the energy space as in Definition 0.2). Remark here that the assumption $t_{h}^{(1)} \in$ $[-T, T]$ ensures $t_{\infty}^{(1)} \in[-T, T]$, which will always be the case for all the concentrating waves we consider. Then, we give a lemma that will be the main step to the orthogonality of energies.
Lemma 2.8. Let $w_{h}^{(1)}=v_{h}-p_{h}^{(1)}$. Then,

By construction and Lemma 1.6, we have $D_{h}^{(1)}\left(v_{h}, \partial_{t} v_{h}\right)\left(t_{h}^{(1)}\right) \underset{h \rightarrow 0}{\stackrel{\rightharpoonup}{*}}\left(\varphi^{(1)}, \psi^{(1)}\right)$ and $D_{h}^{(1)}\left(p_{h}^{(1)}, \partial_{t} p_{h}^{(1)}\right) \underset{h \rightarrow 0}{\rightharpoonup}$ $\left(\varphi^{(1)}, \psi^{(1)}\right)$. Therefore, $D_{h}^{(1)}\left(w_{h}^{(1)}, \partial_{t} w_{h}^{(1)}\right)\left(t_{h}^{(1)}\right) \underset{h \rightarrow 0}{\rightharpoonup}(0,0)$. Lemma 1.11 gives the expected result. Remark that if $a \equiv 0$, this is just a consequence of the conservation of scalar product for solution of linear wave equation.

We get the expansion of $u_{h}$ announced in Proposition 2.2 by induction iterating the same process. Let us assume that

and where $p_{h}^{(j)}$ is a linear damped concentrating wave, associated with data $\left[\left(\varphi^{(k)}, \psi^{(k)}\right), \underline{h}, \underline{x}^{(k)}, \underline{t}^{(k)}\right]$ mutually orthogonal.

We argue as before : we can assume $\delta\left(\underline{w}^{(l)}\right)>0$ and we can pick $\left(\varphi^{(l+1)}, \psi^{(l+1)}\right), \underline{x}^{(l+1)}, \underline{t}^{(l+1)}$ such that:

and we define $p_{h}^{(l+1)}$ as a linear damped concentrating wave, associated with data $\left[\left(\varphi^{(l+1)}, \psi^{(l+1)}\right), \underline{h}, \underline{x}^{(l+1)}, \underline{t}^{(l+1)}\right]$. Again, Lemma 2.8 applied to $w_{h}^{(l)}$ and $p_{h}^{(l+1)}$ implies estimates (32) with $w_{h}^{(l+1)}=w_{h}^{(l)}-p_{h}^{(l+1)}$.

Let us now deal with estimate (31). Lemma 1.4 combined with energy estimates gives for some $C>0$ only depending on $T$ and $a$

So, the series of general term $\left(\left\|\nabla \varphi^{(j)}\right\|_{L^{2}\left(T_{x_{\infty}^{(j)}}^{2} M\right)}^{2}+\left\|\psi^{(j)}\right\|_{L^{2}\left(T_{x_{\infty}(j)} M\right)}^{2}\right)$ converges. Using estimate (34), we get

Since the wave equation is reversible and $(\varphi, \psi)$ is arbitrary, we have proved that for any concentrating data $\left(f_{h}, g_{h}\right)$ associated with $\left[\left(\tilde{\varphi}, \tilde{\psi}, \underline{h}, \underline{x}^{(1)}\right]\right.$, we have

In the general case $\underline{x}^{(1)} \not \underline{\chi}_{h} \underline{x}^{(2)}$, we have in a local coordinate chart and up to a subsequence $x_{h}^{(2)}=x_{h}^{(1)}+(\vec{D}+o(1)) h$ where $\vec{D} \in T_{x_{\infty}} M$ is a constant vector. We remark that if a bounded sequence $\left(f_{h}, g_{h}\right)$ satisfies $D_{h}^{(1)}\left(f_{h}, g_{h}\right) \underset{h \rightarrow 0}{\rightharpoonup}(\varphi, \psi)$, it also fulfills $D_{h}^{(2)}\left(f_{h}, g_{h}\right) \underset{h \rightarrow 0}{\rightharpoonup}(\varphi(.+\vec{D}), \psi(.+\vec{D}))$.

We will also need the following lemma which is the analog of Lemma 3.7 of [17]. We keep the notation of the algorithm of extraction for further use.

Moreover, if we assume $\left|t_{\infty}^{(j)}-t_{\infty}^{\left(j^{\prime}\right)}\right|<T_{\text {focus }}$ (see Definition 0.11), then $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup$ $(0,0)$ for any concentrating wave $p_{h}^{\left(j^{\prime}\right)}$ associated with $\left[\left(\varphi^{\left(j^{\prime}\right)}, \psi^{\left(j^{\prime}\right)}\right), \underline{h}, \underline{x} \underline{j}^{\left(j^{\prime}\right)}, \underline{t}^{\left(j^{\prime}\right)}\right]$.

Proof. The first result is a particular case of Lemma 2.9, The proof of the second part is very similar to Lemma 3.7 of [17]. To simplify the notation, we can assume by translation in time that $t_{h}^{\left(j^{\prime}\right)}=0$. We have to distinguish two cases : time and space orthogonality.

In the case of time orthogonality, that is $\left|\frac{t_{h}^{(j)}}{h}\right| \underset{h \rightarrow 0}{\longrightarrow}+\infty$, we first prove $D_{h}^{1,(j)}\left(p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup 0$ (recall that the exponent 1 in $D_{h}^{1,(j)}$ means that we only consider the $H^{1}$ part of the weak limit). Then, $\left\|\Psi_{U} p_{h}^{\left(j^{\prime}\right)}\left(t_{h}^{(j)}, .\right)\right\|_{L^{6}(M)} \underset{h \rightarrow 0}{\longrightarrow} 0$ and $h^{\frac{1}{2}}\left\|\Psi_{U} p_{h}^{\left(j^{\prime}\right)}\left(t_{h}^{(j)}, x_{h}+h x\right)\right\|_{L^{6}\left(\mathbb{R}^{3}\right)} \xrightarrow[h \rightarrow 0]{\longrightarrow} 0$ (here, we have identified $\Psi_{U} p_{h}^{\left(j^{\prime}\right)}$ with its local representation in $\left.\mathbb{R}^{3}\right)$. In particular $h^{\frac{1}{2}} \Psi_{U} p_{h}^{\left(j^{\prime}\right)}\left(t_{h}^{(j)}, x_{h}+h x\right) \rightharpoonup 0$ and $D_{h}^{1,(j)}\left(p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup 0$. Now, we want to prove more precisely $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup 0$. Suppose $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup(0, \psi)$. Take $s \in \mathbb{R}$ arbitrary. $\tilde{t}_{h}^{(j)}=t_{h}^{(j)}+s h$ fulfills the same assumption $\left|\frac{\tilde{t}_{h}^{(j)}}{h}\right| \underset{h \rightarrow 0}{\longrightarrow}+\infty$ and the nonfocusing property $\left|\tilde{t}_{\infty}^{(j)}\right|<T_{\text {focus }}$. So, we conclude similarly that $D_{h}^{1,(j)}\left(p_{h}^{\left(j^{\prime}\right)}\right)\left(\tilde{t}_{h}^{(j)}\right) \rightharpoonup 0$. But the proof of Lemma 2.9 gives that $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(\tilde{t}_{h}^{(j)}\right) \rightharpoonup\left(v, \partial_{t} v\right)(s)$ where $v$ is solution of

D_{\infty} v=0, \quad\left(v, \partial_{t} v\right)(0)=(0, \psi)
$$

So, we have $v(s)=0$ for any $s \in \mathbb{R}$, which gives $\psi=0$ and $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup(0,0)$.
In the case of $t_{h}^{(j)} \not \chi_{h} t_{h}^{\left(j^{\prime}\right)}$ and space orthogonality, Lemma 2.9 allows us to assume that $t_{h}^{(j)}=$ $t_{h}^{\left(j^{\prime}\right)}=0$. In local coordinates, we have

$$

If $x_{\infty}^{\left(j^{\prime}\right)} \neq x_{\infty}^{(j)}$, the conclusion is obvious. If it is not the case, take $g \in C_{0}^{\infty}\left(\mathbb{R}^{3}\right)$. For the first part, we have to estimate

which goes to 0 as $h$ tends to 0 because $g$ is compactly supported. The same result holds for the second part for $\partial_{t} p_{h}^{\left(j^{\prime}\right)}$.

Let us come back to the proof of the orthogonality of cores in Proposition 2.2. Define :

w_{h}^{(l)} & =p_{h}^{(l+1)}+w_{h}^{(l+1)}  \tag{39}\\
w_{h}^{\left(j_{K}\right)} & =\sum_{j=j_{K}+1}^{K+1} p_{h}^{(j)}+w_{h}^{(K+1)} \tag{40}
\end{align*}
$$

The definition of $p_{h}^{(l)}$ and Lemma 1.6 implies $D_{h}^{(l)}\left(p_{h}^{(l)}, \partial_{t} p_{h}^{(l)}\right)\left(t_{h}^{(l)}\right) \rightharpoonup\left(\varphi^{(l)}, \psi^{(l)}\right)$. Then, we get from (38) and (39) that $D_{h}^{(l+1)}\left(w_{h}^{(l+1)}, \partial_{t} w_{h}^{(l+1)}\right)\left(t_{h}^{(l+1)}\right) \rightharpoonup(0,0)$. We apply this to $l+1=j_{K}$ and it gives $D_{h}^{(K+1)}\left(w_{h}^{\left(j_{K}\right)}, \partial_{t} w_{h}^{\left(j_{K}\right)}\right)\left(t_{h}^{(K+1)}\right) \rightharpoonup(0,0)$ thanks to the first part of Lemma 2.10 and the definition of $j_{K}$.

The definition of $j_{K}$ and the second part of Lemma 2.10 gives $D_{h}^{1,(K+1)}\left(p_{h}^{(l)}, \partial_{t} p_{h}^{(l)}\right)\left(t_{h}^{(K+1)}\right) \rightharpoonup$ $(0,0)$ for $j_{K}+1 \leq l \leq K$.

To conclude, we "apply" $D_{h}^{1,(K+1)}$ to equality (40) and get $D_{h}^{1,(K+1)} w_{h}^{\left(j_{K}\right)}\left(t_{h}^{(K+1)}\right) \rightharpoonup \varphi^{(K+1)}$ while we have just proved $D_{h}^{(K+1)}\left(w_{h}^{\left(j_{K}\right)}, \partial_{t} w_{h}^{\left(j_{K}\right)}\right)\left(t_{h}^{(K+1)}\right) \rightharpoonup(0,0)$ which is a contradiction and complete the proof of the proposition for $2 T<T_{\text {focus }}$.

In the case of $S^{3}$ and large times, the orthogonality result is a consequence of the orthogonality in short times and the almost periodicity. Denote

and we denote $m^{\left(j_{K}\right)} \in \mathbb{Z}$ such that $\left(t_{h}^{\left(j_{K}\right)}+m^{\left(j_{K}\right)} \pi,(-1)^{m^{\left(j_{K}\right)}} x_{h}^{\left(j_{K}\right)}\right) \not \chi_{h}\left(t_{h}^{(K+1)}, x_{h}^{(K+1)}\right)$. We remark that $p_{h}^{(j)}\left(t_{h}^{(j)}+m^{(j)} \pi,.\right)$ is still a non zero concentrating data associated with $\left[(-1)^{m^{(j)}}(\varphi, \psi)\left((-1)^{m^{(j)}}.\right), \underline{h},(-1)^{j} \underline{x}\right]$ thanks to Lemma 2.4 (note that it is at this stage that we use $M=S^{3}$ and $a \equiv 0$ : it is the only case where we are able to describe this phenomenon of reconcentration). So, we are in the same situation as before, and we get a contradition.

This completes the proof of Proposition 2.2.

Proof of Theorem 0.3. We only have to combine the both decompositions we made. Denote $v_{n}^{j}$ (and the rest $\rho_{n}^{(l)}$ the $h_{n}^{(j)}$ oscillatory component obtained by decomposition (24) and $p_{n}^{(j, \alpha)}$ the concentrating waves obtained from decomposition (30) (and the rest $w_{n}^{\left(j, A_{j}\right)}$ ). We enumerate them by the bijection $\sigma$ from $\mathbb{N}^{2}$ into $\mathbb{N}$ defined by

To get the result, it suffices to prove that for $l_{0}$ large enough, $\left\|w_{n}^{\left(l, A_{1}, \cdots, A_{l}\right)}\right\|_{L^{\infty}\left(L^{6}\right)} \leq \varepsilon$ for all $\left(l, A_{1}, \cdots, A_{l}\right)$ satisfying $l \geq l_{0}$ and $\sigma\left(j, A_{j}\right) \geq \sigma\left(l_{0}, 1\right)$.
(9) can easily be deduced from the same orthogonality result in the both other decomposition. In particular, it gives that the series of general term $\sum_{(j, \alpha)} \varlimsup_{n \rightarrow \infty}\left\|\left(p_{n}^{(j, \alpha)}, \partial_{t} p_{n}^{(j, \alpha)}\right)_{t=0}\right\|_{\mathcal{E}}^{2}$ is convergent. In particular, we can find $l_{0}$ large enough such that we have

S_{n}^{\left.\left(j, A_{1}, \cdots, A_{l}\right)\right)}=\sum_{1 \leq j \leq l, A_{j}<B_{l}}\left(w_{n}^{\left(j, A_{j}\right)}-w_{n}^{\left(j, B_{l}\right)}\right)=\sum_{j=1}^{l} \sum_{A_{j}<\alpha \leq B_{l}} p_{n}^{j, \alpha} .
$$

Since $S_{n}^{\left.\left(j, A_{1}, \cdots, A_{l}\right)\right)}$ is solution of the damped wave equation, energy estimates and Sobolev embedding give

& \leq C \sum_{j=1}^{l} \sum_{A_{j}<\alpha \leq B_{l}}\left\|\left(p_{n}^{(j, \alpha)}, \partial_{t} p_{n}^{j, \alpha}\right)_{t=0}\right\|_{\mathcal{E}}^{2}
\end{aligned}
$$

where we have used almost orthogonality in the last estimate. But the sum is restricted to some $(j, \alpha)$ satisfying $\sigma(j, \alpha)>\sigma\left(j, \alpha_{j}\right)>\sigma\left(l_{0}, 1\right)$ and is indeed smaller than $C \varepsilon$ thanks to (41).

Combining our estimates, we get that $\varlimsup_{n \rightarrow \infty}\left\|w_{n}^{\left(l, A_{1}, \cdots, A_{l}\right)}\right\|_{L^{\infty}\left(L^{6}\right)}$ is smaller than $(2+C) \varepsilon$ for all $\left(l, A_{1}, \cdots, A_{l}\right)$ satisfying $l \geq l_{0}$ and $\sigma\left(j, A_{j}\right) \geq \sigma\left(l_{0}, 1\right)$. We get the same estimates with the $L^{5}\left(L^{10}\right)$ norm by interpolation between $L^{\infty}\left(L^{6}\right)$ and $L^{4}\left(L^{12}\right)$. The second norm being bounded by Strichartz estimates and the fact that $w_{n}^{\left(l, A_{1}, \cdots, A_{l}\right)}$ is uniformly bounded in the energy space.

We also state a few consequences of the algorithm of Theorem 0.3 that will be used below. The following both lemmas use the notation and the assumptions of Theorem 0.3.

Lemma 2.11. Let $2 T<T_{\text {focus. }}$. For any $l \in \mathbb{N}$ and $1 \leq j \leq l$, we have, with the notation and assumptions of Theorem 0.3

Otherwise, if $h_{n}^{(j)}=h_{n}^{(i)}$ and $\left(\underline{x}^{(j)}, \underline{t}^{(j)}\right) \perp_{h}\left(\underline{x}^{(i)}, \underline{t}^{(i)}\right)$, Lemma 2.10 gives the same result. Therefore, $D_{n}^{(j)}\left(w_{n}^{(L)}, \partial_{t} w_{n}^{(L)}\right)\left(t_{n}^{(j)}\right) \rightharpoonup(\varphi, \psi)$. Since $\varlimsup_{n \rightarrow \infty}\left\|w_{n}^{(L)}\right\|_{L^{\infty}\left([-T, T], L^{6}\right)} \underset{L \rightarrow \infty}{\longrightarrow} 0$, we have $\varphi=0$. We finish the proof as in Lemma 2.10. We use the same argument for times $t_{n}^{(j)}+s h_{n}^{(j)}$ and get $\psi \equiv 0$ by the proof of Lemma 2.9. Remark that Lemma 2.9 requires that $w_{n}^{(l)}$ is strictly $h_{n}^{(j)}$-oscillatory, but this can be easily avoided by decomposing $w_{n}^{(l)}=f_{n}+g_{n}$ with $f_{n}\left(h_{n}^{(j)}\right)$-oscillatory and $g_{n}$ $\left(h_{n}^{(j)}\right)$-singular.

Lemma 2.12. With the notation and assumptions of Theorem 0.3, we have, for any $j \in \mathbb{N}$

Actually, in the case of $\mathbb{R}^{3}$, the result is proved using the fact that the $p_{n}^{(j)}$ are some concentration of some weak limit of a dilation of $v_{n}$. The proof for a manifold follows the same path with a little more care due to the fact that dilation only have a local meaning.

For any $\varepsilon>0$, we prove

For each $1 \leq i \leq l$, we decompose $[-T, T]=I_{n, i}^{1, \Lambda} \cup I_{n, i}^{2, \Lambda} \cup I_{n, i}^{3, \Lambda}$ according to Lemma 2.3, For any $i$ such that $x_{\infty}^{i}=x_{\infty}^{j}$, for $\Lambda$ large enough, we have

Thanks to (42) and (43), the conclusion of the lemma will be obtained if we prove

We argue by duality. Take $f \in C_{0}^{\infty}\left(\mathbb{R} \times T_{x_{\infty}^{j}} M\right)$ with $\|f\|_{L^{5 / 4}\left(\mathbb{R}, L^{10 / 9}\right)}=1$.
From now on, we work in local coordinates around $x_{\infty}^{(j)}$ and we will not distinguish a function defined on $U \subset M$ with its representant in $\mathbb{R}^{3} \approx T_{x_{\infty}^{j}} M$. Denote $W^{j}$ the operator defined on functions on $\mathbb{R}_{t} \times \mathbb{R}^{3}$ by

For any $1 \leq i \leq l$, with $x_{\infty}^{(i)} \neq x_{\infty}^{(j)}$, using again Lemma 2.3 and 2.2 and the fact that we can choose $\Psi_{U}$ with $\Psi_{U}\left(x_{\infty}^{(i)}\right)=0$, we easily get

Since this expression is uniformly continuous in $v^{i} \in L^{5}\left(\mathbb{R}, L^{10}\left(\mathbb{R}^{3}\right)\right)$, we may assume $v^{i}$ in $C_{0}^{\infty}\left(\mathbb{R} \times \mathbb{R}^{3}\right)$. Then, if $\frac{h_{n}^{j}}{h_{n}^{i}} \underset{n \rightarrow \infty}{\longrightarrow} 0$, we have

The case of $S^{3}$ is proved by considering subintervals of length smaller than $T_{\text {focus }}$ where the former result can be applied.

### 2.2 Nonlinear profile decomposition

### 2.2.1 Behavior of nonlinear concentrating waves (after S. Ibrahim)

In this subsection, we recall the description of nonlinear concentrating waves. As explained in the introduction, the behavior for times close to concentration is rulled by the scattering operator on $\mathbb{R}^{3}$ with a flat metric. So, we first state the existence of the wave operator on $\mathbb{R}^{3}$, following the notation of [2]. We state it for any constant metric on the tangent plane $T_{x_{\infty}} M \approx \mathbb{R}^{3}$.
Proposition 2.3 (Scattering operators on $\mathbb{R}^{3}$ ). Let $x_{\infty} \in M$ and $\square_{\infty}$ the d'Alembertian operator (constant) on $T_{x_{\infty}} M \approx \mathbb{R}^{3}$ induced by the metric on $M$. To every solution of

are bijective from $\mathcal{E}_{x_{\infty}}$ onto itself.
The scattering operator $S$ is defined as $S=\left(\Omega_{+}\right)^{-1} \circ \Omega_{-}$.
The analysis of nonlinear concentrating waves computed by S. Ibrahim in [21] shows that there are three different periods to be considered : before, during and after the time of concentration. Roughly speaking, for times close to the concentrating time, the solution is closed to nonlinear concentrating waves on $\mathbb{R}^{3}$ with flat metric and without damping, as described in Bahouri-Gérard [2]: in the fast time $h_{n} t$, it follows the scattering on $\mathbb{R}^{3}$. Before and after the time of concentration, the nonlinear concentrating wave is "close" to some linear damped concentrating waves as defined in Table 2.1 below. This is precised in the following theorem whose proof can be found in S. Ibrahim [21]. Yet, in [21], the result is stated for an equation without damping and we give a sketch of the proof in the damped case in Section 2.2.2.

Theorem 2.1. Let $\underline{v}=[(\varphi, \psi), \underline{h}, \underline{x}, \underline{t})]$ be a linear damped concentrating wave. We denote by $\underline{u}$ its associated nonlinear damped concentrating wave (same data at $t=0$ ). There exist three linear damped concentrating waves denoted by $\left.\left[\left(\varphi_{i}, \psi_{i}\right), \underline{h}, \underline{x}, \underline{t}\right)\right], i=1,2$ or 3 such that : for all interval $[-T, T]$ containing $t_{\infty}$, satisfying the following non-focusing property (see Definition 0.1)

Remark 2.2. Note that the transition from the first column to the third one represents the modification of profile due to the concentration and the concentrating functions are modified according to the scattering operator $S$. To go from the first column to the second one, we apply the operator $\Omega_{-}$ while we apply $\Omega_{+}^{-1}$ to get from the second to the third one.

Remark 2.3. The behavior for times close to concentration is not written this way in the article [21] of $S$. Ibrahim, but is a byproduct of its proof. We refer to the next section which contains a sketch of the proof.

Corollary 2.2. A nonlinear damped concentrating wave $q_{h}$ is strictly ( $h$ )-oscillatory with respect to $A_{M}$ and bounded in all Strichartz norms, uniformly on any bounded interval.

Proof of Corollary 2.2. The boundedness of all Strichartz norms is a counsequence of Duhamel formula and Strichartz estimates once the result is known in the case of $L^{5} L^{10}$. On the intervals $I_{n}^{1, \Lambda}$ and $I_{n}^{3, \Lambda}$ when $q_{h}$ is closed to a linear concentrating wave, the result follows from Proposition 1.4 and linear Strichartz estimates. On $I_{n}^{2, \Lambda}, q_{h}$ behaves like a concentration of a nonlinear solution on $T_{x_{\infty}} M$. The strict ( $h$ )-oscillation is obvious and the Strichartz estimates follow from global estimates on $\mathbb{R}^{3}$.

In the case of $S^{3}$, thanks to a better knowledge of the behavior of nonlinear concentrating waves we can avoid assumption (45). This is Theorem 1.8 from [21]. It will allow us to perform the profile decomposition for large times.

Theorem 2.2. Let $\underline{v}=[(\varphi, \psi), \underline{h}, \underline{x}, \underline{t})]$ be a linear (not damped, that is $a(x) \equiv 0$ ) concentrating wave on $S^{3}$. We denote by $\underline{u}$ its nonlinear associated concentrating wave (same data at $t=0$ ). We assume that $\left.t_{\infty} \in\right] 0, \pi[$. Then, for all $j \in \mathbb{Z}$, we have

Moreover, the cases $\left.t_{\infty} \in\right]-\pi, 0\left[\right.$ and $t_{\infty}=0$ can be deduced similarly to Theorem [2.1] with some changes on the concentration data in the same spirit as Table 2.1.

### 2.2.2 Modification of the proof of S. Ibrahim for Theorem 2.1 in the case of damped equation

In this subsection, we give some sketch of proof for the behavior of nonlinear damped concentrating waves announced in subsection [2.2.1. These results are proved in [21] in the undamped case $a(x) \equiv 0$ and so we only briefly emphasize the main necessary modifications of proof. To simplify, we only treat the case $\frac{t_{n}}{h_{n}} \xrightarrow[n \rightarrow+\infty]{\longrightarrow} \infty$.

Sketch of the proof of estimate (46) of Theorem 2.1: Behavior before concentration. The proof is exactly the same as Corollary 3.2 of [21]. $w_{n}=u_{n}-v_{n}$ is solution of

Using Strichartz and energy estimates, we are able to use a bootstrap argument if $\varlimsup_{n \rightarrow \infty}\left\|v_{n}\right\|_{L^{5}\left(I_{n}^{1, \Lambda}, L^{10}\right)}$ is small enough. This can be achieved thanks to Lemma 2.3 and gives the result.

Sketch of the proof of estimate (48) of Theorem [2.1: Behavior for times close to concentration. By definition of $v_{n}$ and finite propagation speed, the main energy part of $v_{n}$ is concentrated near $x_{\infty}$ for times close to $t_{\infty}$. By estimate (46), it is also the case for $u_{n}$. Therefore, for times $t \in\left[t_{n}-\Lambda h_{n}, t_{n}+\right.$ $\Lambda h_{n}$ ], we can neglect the energy outside of a fixed open set and work in local coordinates. Moreover, in that case, we can use the norm $\left|\|\cdot|\cdot|\|_{I \times \mathbb{R}^{3}}\right.$ instead of $\||\cdot|\| \|_{I}$ and use the fact that is is invariant by translation and scaling up to a modification of the interval of time.

Denote $\tilde{u}_{n}\left(\operatorname{resp} \tilde{v}_{n}\right)$ the rescaled function associated to $u_{n}\left(\operatorname{resp} v_{n}\right)$, so that $u_{n}(t, x)=\frac{1}{\sqrt{h_{n}}} \tilde{u}_{n}\left(\frac{t-t_{n}}{h_{n}}, \frac{x-x_{n}}{h_{n}}\right)$. We need to prove $\varlimsup_{n \rightarrow \infty}\| \| \tilde{u}_{n}-w \mid \|_{[-\Lambda, \Lambda] \times \mathbb{R}^{3}} \underset{\Lambda \rightarrow \infty}{\longrightarrow} 0$ where $w$ is solution of

For (52), we observe that $\tilde{u}_{n}^{\Lambda}$ and $\tilde{u}_{n}$ are solutions of the same equation but with different initial data which satisfy thanks to estimate (46)

\varlimsup_{n \rightarrow \infty}\left\|\left(\tilde{u}_{n}^{\Lambda}-\tilde{u}_{n}, \partial_{t}\left(\tilde{u}_{n}^{\Lambda}-\tilde{u}_{n}\right)\right)(-\Lambda)\right\|_{\mathcal{E}}=\varlimsup_{n \rightarrow \infty}\left\|\left(\tilde{v}_{n}-\tilde{u}_{n}, \partial_{t}\left(\tilde{v}_{n}-\tilde{u}_{n}\right)\right)(-\Lambda)\right\|_{\mathcal{E}} \underset{\Lambda \rightarrow \infty}{\longrightarrow} 0
$$

Then, Strichartz and energy estimates allow us to use a boot strap argument on subintervals $I$ such that $\left\|\tilde{u}_{n}^{\Lambda}\right\|_{L^{5}\left(I, L^{10}\right)}$ is small. (51) allows to complete the proof.

### 2.2.3 Proof of the decomposition

This subsection is devoted to the proof of Theorem 0.4
Let us define the function $\beta$ in the following way:

Proposition 2.4. Let $0<2 T<T_{\text {focus }}$ (see Definition (0.1). Let $p_{n}^{(j)}, 1 \leq j \leq l$, linear damped concentrating waves, associated with data $\left[\left(\varphi^{(j)}, \psi^{(j)}\right), \underline{h}^{(j)}, \underline{x}^{(j)}, \underline{t}^{(j)}\right]$ (we can have $h^{(j)}=1$ for one of it), which are orthogonal according to Definition 1.2 and such that $t_{\infty}^{(j)} \in[-T, T]$. Denote $q_{n}^{(j)}$ the associated nonlinear damped concentrating waves (same data at $t=0$ ).

Then, we have

\begin{equation*}
\varlimsup_{n \rightarrow \infty}\left\|\beta\left(\sum_{j=1}^{l} q_{n}^{(j)}\right)-\sum_{j=1}^{l} \beta\left(q_{n}^{(j)}\right)\right\|_{L^{1}\left([-T, T], L^{2}\right)}=0 \tag{53}
\end{equation*}
$$

Proof. We follow closely Lemma 4.2 of [17.

$$
\left\|\beta\left(\sum_{j=1}^{l} q_{n}^{(j)}\right)-\sum_{j=1}^{l} \beta\left(q_{n}^{(j)}\right)\right\|_{L^{1}\left([-T, T], L^{2}\right)} \leq \sum_{1 \leq j_{1}, \cdots, j_{5} \leq l}\left\|\prod_{k=1}^{5} q_{n}^{\left(j_{k}\right)}\right\|_{L^{1}\left([-T, T], L^{2}\right)}
$$

where at least two $q_{n}^{\left(j_{k}\right)}$ are different. In the case of othogonality of scales, we use Hölder inequality

$$
\left\|\prod_{k=1}^{5} q_{n}^{\left(j_{k}\right)}\right\|_{L^{1}\left([-T, T], L^{2}\right)} \leq C\left\|q_{n}^{1} q_{n}^{2}\right\|_{L^{\infty}\left([-T, T], L^{3}\right)} \prod_{k=3}^{5}\left\|q_{n}^{\left(j_{k}\right)}\right\|_{L^{3}\left([-T, T], L^{18}\right)}
$$

Then, Corollary 2.2 and Lemma 1.8 yield the result (note that $L^{3} L^{18}$ is a pair of Strichartz norm). So now, we can assume $h_{n}^{1}=h_{n}^{2}=h_{n}$. By Hölder and Corollary 2.2, we get

\left\|\prod_{k=1}^{5} q_{n}^{\left(j_{k}\right)}\right\|_{L^{1}\left([-T, T], L^{2}\right)} \leq C\left\|q_{n}^{1} q_{n}^{2}\right\|_{L^{5 / 2}\left([-T, T], L^{5}\right)} \prod_{k=3}^{5}\left\|q_{n}^{\left(j_{k}\right)}\right\|_{L^{5}\left([-T, T], L^{10}\right)} \leq C\left\|q_{n}^{1} q_{n}^{2}\right\|_{L^{5 / 2}\left([-T, T], L^{5}\right)}
$$

We apply Theorem [2.1] to $q_{n}^{1}$. We obtain three couples $\left(\varphi^{i}, \psi^{i}\right), i=1,2,3$ and split the interval $[-T, T]=\cup_{j=1}^{3} I_{n}^{j, \Lambda}$. We first deal with the interval $I_{n}^{1, \Lambda}$. Denote $\left.\underline{v_{1}}=\left[\left(\varphi_{1}, \psi_{1}\right), \underline{h}, \underline{x}, \underline{t}\right)\right]$ so that

\left\|q_{n}^{1} q_{n}^{2}\right\|_{L^{5 / 2}\left(I_{n}^{1, \Lambda}, L^{5}\right)} \leq\left\|q_{n}^{1}\right\|_{L^{5}\left(I_{n}^{1, \Lambda}, L^{10}\right)} \leq C\left\|q_{n}^{1}-v_{1, n}\right\|_{L^{5}\left(I_{n}^{1, \Lambda}, L^{10}\right)}+\left\|v_{1, n}\right\|_{L^{5}\left(I_{n}^{1, \Lambda}, L^{10}\right)}
$$

So, combining Theorem 2.1 and Lemma 2.3 yields

\varlimsup_{n}\left\|q_{n}^{1} q_{n}^{2}\right\|_{L^{5 / 2}\left(I_{n}^{1, \Lambda}, L^{5}\right)} \underset{\Lambda \rightarrow \infty}{\longrightarrow} 0
$$

The same result holds for $I_{n}^{3, \Lambda}$ and we are led with the interval $I_{n}^{2, \Lambda}$. In the case of time orthogonality, say $\frac{\left|t_{n}^{2}-t_{n}^{1}\right|}{h_{n}} \underset{n \rightarrow \infty}{\longrightarrow}+\infty$, the two intervals $\left[t_{n}^{1}-\Lambda h_{n}, t_{n}^{1}+\Lambda h_{n}\right]$ and $\left[t_{n}^{2}-\Lambda h_{n}, t_{n}^{2}+\Lambda h_{n}\right]$ have empty intersection for fixed $\Lambda$ and $n$ large enough, which yields the result by the same estimates applied to $q_{n}^{2}$, once $\Lambda$ is chosen large enough.

We can now assume, up to a translation in time, that $t_{n}^{1}=t_{n}^{2}$. On $I_{n}^{2, \Lambda}$, Theorem 2.1 allows us to replace $q_{n}^{1}$ by $w_{n}^{1}(t, x)=\Psi_{U}^{1}(x) w^{1}\left(\frac{t-t_{n}^{1}}{h_{n}}, \frac{x-x_{n}^{1}}{h_{n}}\right)$ on a coordinate patch where $w^{1}$ is solution of a nonlinear wave equation on the tangent plane $T_{x_{\infty}^{1}} M$ and similarly for $q_{n}^{2}$. In the first case of space orthogonality, that is $x_{\infty}^{1} \neq x_{\infty}^{2}$, the result is obvious on the interval $I_{n}^{2, \Lambda}$ by taking $\Psi_{U}^{1}$ and $\Psi_{U}^{2}$ with empty intersection. In the case $x_{\infty}^{1}=x_{\infty}^{2}$, we are left with the estimate of

$$
\int_{I_{n}^{2}}\left(\int_{\mathbb{R}^{3}}\left|w_{n}^{1}(t, x) w_{n}^{2}(t, x)\right|^{5}\right)^{1 / 2} d s \leq \int_{[-\Lambda, \Lambda]}\left(\int_{\mathbb{R}^{3}}\left|w^{1}(t, x) w^{2}\left(t, x+\frac{x_{n}^{1}-x_{n}^{2}}{h_{n}}\right)\right|^{5}\right)^{1 / 2} d s
$$

This yields the result in the last case of space orthogonality by approximating $w^{1}$ and $w^{2}$ by compactly supported functions.

In the case of the sphere, we are able to state the same result without any restriction on the time.
Corollary 2.3. Let $M=S^{3}$ and $T>0$ (eventually large). We make the same assumptions as Proposition 2.4, except for the time $T$, with the additional hypothesis:
$\left[\underline{h}^{(i)},(-1)^{m} \underline{x}^{(i)}, \underline{t}^{(i)}+m \pi\right]$ is orthogonal to $\left[\underline{h}^{(j)}, \underline{x}^{(j)}, \underline{t}^{(j)}\right]$ for any $m \in \mathbb{Z}$ and $i \neq j$. Moreover, we assume $a(x) \equiv 0$ (undamped equation).
Then, the same conclusion as Proposition 2.4 is true.
Proof. We build a covering of the interval $[-T, T]$ with a finite number of intervals of length stricly less than $T_{\text {focus }}=\pi$ so that on each of this interval $I=[\alpha, \beta]$ and for any $1 \leq i \leq l$, there exists at most one $m^{(i)} \in \mathbb{Z}$ such that $t_{\infty}^{(i)}+m^{(i)} \pi \in I$. Moreover, one can also impose $\alpha \neq t_{\infty}^{(i)}+m^{(i)} \pi$.

Therefore, $\left.\alpha \in] t_{n}^{(i)}+\left(m^{i}-1\right) \pi+\Lambda h_{n}^{(i)}, t_{n}^{(i)}+m^{(i)} \pi-\Lambda h_{n}^{(i)}\right]$ for large fixed $\Lambda$ and $n$ large enough. Theorem 2.2 yields $\left\|\left(q_{n}^{(i)}-v_{n}^{(i)}, \partial_{t}\left(q_{n}^{(i)}-v_{n}^{(i)}\right)\right)_{t=\alpha}\right\|_{\mathcal{E}} \xrightarrow[n \rightarrow \infty]{\longrightarrow} 0$ for a linear concentrating wave $v_{n}^{(i)}=$ $\left.\left[\tilde{S}^{m^{(i)}} S\left(\varphi^{(i)}, \psi^{(i)}\right), \underline{h}^{(i)}, \underline{x}^{(i)}, \underline{t}^{(i)}\right)\right]$. In each interval, we are in the same situation as in Proposition 2.4 which yields the desired result.

Now, we are ready for the proof of the nonlinear profile decomposition. We give it in a quite sketchy way since it is very similar to the one of [2] or [17]. First, we obtain it in the particular case where the linear solution is small in Strichartz norm.

Lemma 2.13. There exists $\delta_{1}>0$ such that if

then the conclusion of Theorem 0.4 is true.
Proof. The proof is essentially the same as Lemma 4.3 of [2]. We have to estimate the rest $r_{n}^{(l)}$ solution of

\left\{\begin{aligned}
\square r_{n}^{(l)}+r_{n}^{(l)}+a(x) \partial_{t} r_{n}^{(l)} & =\beta(u)+\sum_{j=1}^{l} \beta\left(q_{n}^{(j)}\right)-\beta\left(u+\sum_{j=1}^{l} q_{n}^{(j)}+w_{n}^{(l)}+r_{n}^{(l)}\right) \\
\left(r_{n}^{(l)}, \partial_{t} r_{n}^{(l)}\right)_{t=0} & =(0,0) .
\end{aligned}\right.
$$

We conclude as in [2] using Proposition 2.4 and Lemma 2.12 which is not immediate on a manifold. In the case of $S^{3}$ and $a \equiv 0$ for large $T$, we use Corollary 2.3 instead of Proposition 2.4.

Once the result is obtained when Strichartz norms are small, we divide $[-T, T]$ in a finite number of intervals where the Strichartz norms are small enough. This is done in the following lemma.

Lemma 2.14. Let $2 T<T_{\text {focus. }}$. Let $\delta>0$ and $\tilde{q}_{n}$ be a sequence in $L^{5}\left([-T, T], L^{10}(M)\right)$, such that

\varlimsup_{n \rightarrow \infty}\left\|\tilde{q}_{n}\right\|_{L^{5}\left([-T, T], L^{10}\right)} \leq \delta
$$

Fix also $l \in \mathbb{N}$ and $l$ sequences of nonlinear concentrating wave $q_{n}^{(j)}, j=1, \ldots, l$.
Then, for any $\delta^{\prime}>\delta$, there exists $L \in \mathbb{N}$ such that for any $n \in \mathbb{N}$, we have the decomposition of $[-T, T]$ in closed intervals $I_{n}^{(i)}$

$$
[-T, T]=\bigcup_{i=1}^{L} I_{n}^{(j)}
$$

such that the sequence

$$
\Gamma_{n}=\sum_{j=1}^{l} q_{n}^{(j)}+\tilde{q}_{n}
$$

satisfies on each interval $I_{n}^{(i)}$

$$
\varlimsup_{n \rightarrow \infty}\left\|\Gamma_{n}\right\|_{L^{5}\left(I_{n}^{(j)}, L^{10}\right)} \leq \delta^{\prime}
$$

Proof. We first treat the case $l=1$. We divide $[-T, T]=I_{n}^{1, \Lambda} \cup I_{n}^{2, \Lambda} \cup I_{n}^{3, \Lambda}$ according to Theorem 2.1 (one of these intervals being possibly empty). Then, a combination of estimate (46) of Theorem 2.1 (comparison with linear concentrating wave) and Lemma 2.3 (non reconcentration) gives for $\Lambda$ large enough

The same result holds for $I_{n}^{3, \Lambda}$ and we are left with the interval $I_{n}^{2, \Lambda}$. Once $\Lambda$ is fixed, we can divide $[-\Lambda, \Lambda]$ in a finite number of intervals $I^{(i), \Lambda}$ such that $\|w\|_{L^{5}\left(I^{(i), \Lambda}, L^{10}\right.} \leq \delta-\delta^{\prime}$ where $w$ is the function defined by equation (49) of Theorem 2.1. Then, we replace each $I^{(i), \Lambda}$ by $I_{n}^{(i), \Lambda}$ obtained by translation dilation. We conclude by the approximation (48) of $q_{n}^{(1)}$ by translation dilation of $w$ on the interval $I_{n}^{2, \Lambda}$.

Note that the previous lemma also applies for large times on $S^{3}$ with $a \equiv 0$ by doing a first decomposition of $[-T, T]$ in a finite number of intervals of length strictly less than $\pi$.

End of the proof of Theorem 0.4 in the general case. We choose $l \in \mathbb{N}$ such that $\left\|w_{n}^{(l)}\right\| \leq \delta_{1}$ and use Lemma 2.14 in order to be able to apply Lemma 2.13 on each interval $I_{n}^{(j)}$. See 2] or, in the different context of Schrödinger equation, [25].

### 2.3 Applications

### 2.3.1 Strichartz estimates and Lipschitz bounds for the nonlinear evolution group

Proposition 2.5. Let $T>0$ be fixed. There exist a non-decreasing function, $A:[0, \infty[\rightarrow[0, \infty[$, such that any solution of

\square u+u+a(x) \partial_{t} u & =-|u|^{4} u \quad \text { on } \quad[-T, T] \times M  \tag{54}\\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) \in \mathcal{E}
\end{align*}\right.
$$

fulfills

$$
\|u\|_{L^{8}\left([-T, T], L^{8}(M)\right.}+\|u\|_{L^{5}\left([-T, T], L^{10}(M)\right.}+\|u\|_{L^{4}\left([-T, T], L^{12}(M)\right.} \leq A\left(\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}}\right) .
$$

Proof. The proof is exactly the same as Corollary 2 of [2]. Using Strichartz estimates, it is enough to get the result for $L^{5} L^{10}$. We argue by contradiction and suppose that there exists a sequence $u_{n}$ of strong solutions of equation (54) satisfying

$$
\sup _{n}\left\|\left(u_{0, n}, u_{1, n}\right)\right\|_{\mathcal{E}}<+\infty, \quad\left\|u_{n}\right\|_{L^{5}\left([-T, T], L^{10}(M)\right.} \underset{n \rightarrow \infty}{\longrightarrow}+\infty
$$

We apply the profile decomposition of Theorem 0.4 to our sequence. We get a contradiction by the fact that the $L^{5}\left([-T, T], L^{10}(M)\right)$ norm of a nonlinear concentrating wave is uniformly bounded thanks to Corollary [2.2. This argument works for times $2 T<T_{\text {focus }}$ and can be reiterated since the nonlinear energy at times $T$ can be bounded with respect to the one at time 0 thanks to almost conservation (we can also use energy estimates once we know $u$ is uniformly bounded in $L^{5} L^{10}$ ).

Lemma 2.15. Let $R_{0}>0$ and $T>0$. Then, there exists $C>0$ such any solution $u$ satisfying

\square u+u+a(x) \partial_{t} u+|u|^{4} u & =0 \text { on }[-T, T] \times M  \tag{55}\\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) \in \mathcal{E} \\
\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} & \leq R_{0} .
\end{align*}\right.
$$

fulfills

$$
\left\|\left(u(t), \partial_{t} u(t)\right)\right\|_{L^{2} \times H^{-1}} \leq C\left\|\left(u(0), \partial_{t} u(0)\right)\right\|_{L^{2} \times H^{-1}} \quad \forall t \in[-T, T] .
$$

Proof. Proposition 2.5 yields a uniform bound for $u$ in $L^{4}\left([-T, T], L^{12}(M)\right)$ and so for $V=|u|^{4}$ in $L^{1}\left([0, T], L^{3}(M)\right)$. We prove uniform estimates for some solutions of the linear equation

$$
\left\{\begin{array}{r}
\square u+u+a(x) \partial_{t} u=V u \quad \text { on } \quad[-T, T] \times M  \tag{56}\\
\left(u(0), \partial_{t} u(0)\right)=\left(u_{0}, u_{1}\right) \in L^{2} \times H^{-1}
\end{array}\right.
$$

where $V$ satisfies $\|V\|_{L^{1}\left([-T, T], L^{3}(M)\right)} \leq A\left(R_{0}\right)^{4}$. The product of functions in $L^{\infty}\left([-T, T], L^{2}\right)$ and $L^{1}\left([-T, T], L^{3}\right)$ is in $L^{1}\left([-T, T], L^{6 / 5}\right)$ and so in $L^{1}\left([-T, T], H^{-1}\right)$ by Sobolev embedding. Standard estimates yields
$\left\|\left(u, \partial_{t} u\right)\right\|_{L^{\infty}\left([0, t], L^{2} \times H^{-1}\right)} \leq C\left\|\left(u(0), \partial_{t} u(0)\right)\right\|_{L^{2} \times H^{-1}}+C\left(t+\|V\|_{L^{1}\left([0, t], L^{3}\right)}\right)\left\|\left(u, \partial_{t} u\right)\right\|_{L^{\infty}\left([0, t], L^{2} \times H^{-1}\right)}$.
We can divide the interval $[-T, T]$ into a finite number of intervals $\left[a_{i}, a_{i+1}\right]_{i=1 \cdots N}$ such that $C(t+$ $\left.\|V\|_{L^{1}\left(\left[a_{i}, a_{i+1}\right], L^{3}(M)\right)}\right)<1 / 2 . N$ depends only on $R_{0}$ and $T$ (not on $\left.V\right)$.

Then, on each of these intervals, we have

$$
\left\|\left(u, \partial_{t} u\right)\right\|_{L^{\infty}\left(\left[a_{i}, a_{i+1}\right], L^{2} \times H^{-1}\right)} \leq 2 C\left\|\left(u\left(a_{i}\right), \partial_{t} u\left(a_{i}\right)\right)\right\|_{L^{2} \times H^{-1}}
$$

We obtain the expected result by iteration. The final constant $C$ only depends on $R_{0}$ and $T$ since it is also the case for $N$.

Corollary 2.4. Let $R_{0}>0$ and $T>0$. For any $\varepsilon>0$, there exists $\delta>0$ such that any solution $u$ satisfying (55) and $\left\|\left(u_{0}, u_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq \delta$ satisfies

$$
\left\|\left(u(T), \partial_{t} u(T)\right)\right\|_{L^{2} \times H^{-1}} \leq \varepsilon
$$

We will also need the following lemma which states the local uniform continuity of the flow map. Note that it can be proved to be locally Lipschitz with a slightly more complicated argument (see Corollary 2 of [17]). We will note need this for our purpose.

Lemma 2.16. Let $u_{n}, \tilde{u}_{n}$ be two sequences of solutions of

\end{aligned}\right.
$$

with $\left\|\left(u_{n, 0}-\tilde{u}_{n, 0}, u_{n, 1}-\tilde{u}_{n, 1}\right)\right\|_{\mathcal{E}}+\left\|g_{n}-\tilde{g}_{n}\right\|_{L^{1}\left([-T, T], L^{2}\right)} \underset{n \rightarrow \infty}{\longrightarrow} 0$. Then, we have

$$
\left\|\left\|u_{n}-\tilde{u}_{n}\right\|_{[-T, T]} \underset{n \rightarrow \infty}{\longrightarrow} 0\right.
$$

Proof. $r_{n}=u_{n}-\tilde{u}_{n}$ is solution of

$$
\left\{\begin{aligned}
\square r_{n}+r_{n}+\left|u_{n}\right|^{4} u_{n}-\left|\tilde{u}_{n}\right|^{4} \tilde{u}_{n} & =g_{n}-\tilde{g}_{n} \quad \text { on }[-T, T] \times M \\
\left(r_{n}, \partial_{t} r_{n}\right)_{t=0} & =\left(u_{n, 0}-\tilde{u}_{n, 0}, u_{n, 1}-\tilde{u}_{n, 1}\right) .
\end{aligned}\right.
$$

Using energy and Strichartz estimates, we get

$$
\begin{aligned}
\left\|r_{n}\right\| \|_{[-T, T]} \leq & C\left\|\left(u_{n, 0}-\tilde{u}_{n, 0}, u_{n, 1}-\tilde{u}_{n, 1}\right)\right\|_{\mathcal{E}}+C\left\|g_{n}-\tilde{g}_{n}\right\|_{L^{1}\left([-T, T], L^{2}\right)} \\
& +C\left\|r_{n}\right\|_{L^{5}\left([-T, T], L^{10}\right)}\left(\left\|u_{n}\right\|_{L^{5}\left([-T, T], L^{10}\right)}^{4}+\left\|\tilde{u}_{n}\right\|_{L^{5}\left([-T, T], L^{10}\right)}^{4}\right) .
\end{aligned}
$$

Using Proposition [2.5, we can divide the interval $[-T, T]$ in a finite number of intervals $I_{i, n}=$ $\left[a_{i, n}, a_{i+1, n}\right], 1 \leq i \leq N$, such that $C\left(\left\|u_{n}\right\|_{L^{5}\left(I_{i, n}, L^{10}\right)}^{4}+\left\|\tilde{u}_{n}\right\|_{L^{5}\left(I_{i, n}, L^{10}\right)}^{4}\right)<1 / 2$ so that the third term can be absorbed. We iterate this estimate $N$ times, which gives the result.

### 2.3.2 Profile decomposition of the limit energy

For $u$ solution of the nonlinear wave equation, we denote its nonlinear energy density

$$
e(u)(t, x)=\frac{1}{2}\left[\left|\partial_{t} u(t, x)\right|^{2}+|\nabla u(t, x)|^{2}+|u(t, x)|^{2}\right]+\frac{1}{6}|u(t, x)|^{6} .
$$

For a sequence $u_{n}$ of solution with initial data bounded in $\mathcal{E}$, the corresponding non linear energy density is bounded in $L^{\infty}\left([-T, T], L^{1}\right)$ and so in the space of bounded measures on $[-T, T] \times M$. This allows to consider, up to a subsequence, its weak* limit.

The following theorem is the equivalent of Theorem 7 in [8]. It proves that the energy limit follows the same profile decomposition as $u_{n}$. It will be the crucial argument that will allow to use microlocal defect measure on each profile and then to apply the linearization argument.

Theorem 2.3. Assume $2 T<T_{\text {focus }}$.
Let $u_{n}$ be a sequence of solutions of

where $e^{(j)}$ is the limit energy limit density of $q_{n}^{(j)}$ (following the notation of Theorem 0.4) and

where both limit are considered up to a subsequence and in the weak $*$ sense.
In particular, $e_{f}$ can be written

where $G_{t}$ is the flow map of the vector field $H_{|\xi|_{x}}$ on $S^{*} M$, that is the Hamiltonian of the Riemannian metric.

Moreover, $e$ is also the limit of the linear energy density

Proof. Proposition [2.5 yields $\left\|u_{n}\right\|_{L^{8}([-T, T] \times M)} \leq C$. Then, compact embedding and Lemma 2.15 yields $\left\|u_{n}\right\|_{L^{2}([-T, T] \times M)}^{\longrightarrow} 0$ and so $\left\|u_{n}\right\|_{L^{6}([-T, T] \times M)}^{\longrightarrow} 0$ by interpolation. Therefore, $e$ is the limit of $b\left(u_{n}, u_{n}\right)$, with

Now, we have to compute the limit of $b\left(u_{n}, u_{n}\right)$ using decomposition (10) of Theorem 0.4. We set for any $l \in \mathbb{N}$

Because of (11), $\varlimsup_{n \rightarrow \infty}\left\|2 b\left(u_{n}, r_{n}^{(l)}\right)-b\left(r_{n}^{(l)}, r_{n}^{(l)}\right)\right\|_{L^{1}([-T, T] \times M)}$ converges to zero as $l$ tends to infinity. So, if we define $e_{r}^{(l)}=w^{*} \lim _{n \rightarrow \infty}\left(2 b\left(u_{n}, r_{n}^{(l)}\right)-b\left(r_{n}^{(l)}, r_{n}^{(l)}\right)\right)$, we have

Let $\varphi \in C_{0}^{\infty}(]-T, T[\times M)$. For fixed $l$, it remains to estimate

Since $b\left(q_{n}^{(j)}, w_{n}^{(l)}\right)$ is bounded in $L^{\infty}(]-T, T\left[, L^{1}\right)$, we can assume, up to an error arbitrary small, that $\varphi$ is supported in $\left\{t<t_{\infty}^{(j)}\right\}$ or $\left\{t>t_{\infty}^{(j)}\right\}$ (replace $\varphi$ by $(1-\Psi)(t) \varphi$ with $\Psi\left(t_{\infty}^{(j)}\right)=1$ and $\|\Psi\|_{\left.L^{1}(]-T, T\right]}$ small). On each interval, Theorem 2.1 allows to replace $q_{n}^{(j)}$ by a linear concentrating wave. Then, we combine Lemma 2.11 and Lemma 1.11 to get the weak convergence to zero of $b\left(s_{n}^{(l)}, w_{n}^{(l)}\right)$ for fixed $l$.

Lemma 2.10 and the orthogonality of the cores of concentration give $D_{h}^{(j)}\left(p_{h}^{\left(j^{\prime}\right)}, \partial_{t} p_{h}^{\left(j^{\prime}\right)}\right)\left(t_{h}^{(j)}\right) \rightharpoonup$ $(0,0)$ for $j \neq j^{\prime}$ and $p_{h}^{\left(j^{\prime}\right)}$ a concentrating wave at rate $\left[h^{\left(j^{\prime}\right)}, t^{\left(j^{\prime}\right)}, x^{\left(j^{\prime}\right)}\right]$. Then, the same argument as before yields

So we have proved that for any $l \in \mathbb{N}$

where $e_{w}^{(l)}$ is the weak* limit of $b\left(w_{n}^{(l)}, w_{n}^{(l)}\right)$ and $e_{r}^{(l)}$ satisfies $\left\|e_{r}^{(l)}\right\|_{T V} \xrightarrow[l \rightarrow \infty]{\longrightarrow} 0 . e_{w}^{(l)}$ is the weak* limit of a sequence of solutions of the linear wave equation weakly convergent to 0 in energy space. Therefore, it has the announced form using the link with microlocal defect measure (see Lemma 1.9).

We get the final result by letting $l$ tend to infinity.
Remark 2.4. The fact that $\left|u_{n}\right|^{6}$ is weakly convergent to 0 is false if we consider the limit in $\mathcal{D}^{\prime}(M)$ time by time. For example, for a nonlinear concentrating wave with $t_{n}=0$, the weak limit in $\mathcal{D}^{\prime}(]-T, T[\times M)$ of $\left|u_{n}\right|^{6}$ is of course still zero but the weak limit of $\left|u_{n}\right|^{6}(t)$ in $\mathcal{D}^{\prime}(M)$ is zero if $t \neq 0$ and a multiple of a Dirac function if $t=0$. So the limit in $\mathcal{D}^{\prime}(M)$ of $e_{n \mid t=0}$ is not the same as the
one of $b\left(u_{n}, u_{n}\right)_{\mid t=0}$. This comes from the fact that the limit of $b\left(u_{n}, u_{n}\right)(t)$ is not equicontinuous as a function of $t$ while it is the case for the nonlinear energy. Yet, in the proof, we are only interested in its limit in the space-time distributional sense which will be continuous. Actually, the discontinuity at $t=0$ of the limit of $b\left(u_{n}, u_{n}\right)(t)$ can be described explicitely from the scattering operator. At the contrary, the fact that the nonlinear energy density $e(t)$ is continuous in time can, in this case, be seen as a consequence of the conservation of the nonlinear energy of the scattering operator.

## 3 Control and stabilization

### 3.1 Weak observability estimates, stabilization

### 3.1.1 Why Klein-Gordon and not the wave?

In this subsection, we prove that the expected observability estimate

$$
E(u)(0) \leq C \iint_{[0, T] \times M}\left|a \partial_{t} u\right|^{2} d t d x .
$$

does not hold for the nonlinear damped wave equation $\square u+\partial_{t} u+u^{5}=0$ (in the simpler case $a \equiv 1$ ), even for small data. It explains why we have chosen the Klein-Gordon equation instead. The main point is that for small data, the nonlinear solution is close to the linear one which has the constants (in space-time) as undamped solutions (which is obviously false for $\square u+u=0$ ).

We take $a \equiv 1$ and initial data constant equal to $(\varepsilon, 0)$. The nonlinear wave equation takes the form of the following ODE

Decreasing of energy yields for any $t \geq 0$

E(t)=\frac{1}{2} \dot{u}^{2}+\frac{1}{6} u^{6}(t) \leq E(0)=\frac{1}{6} \varepsilon^{6}
$$

and so

Then, $c=\dot{u}$ is solution of

Therefore,

\text { and } \quad|\dot{u}(t)|=|c(t)| \leq \varepsilon^{5} .
\end{gathered}
$$

For any $T>0$, we have

$$

Therefore, the observability estimate

T \varepsilon^{10} \geq \int_{0}^{T}|\dot{u}(s)|^{2} \geq C E(0)=C \frac{1}{6} \varepsilon^{6}
$$

can not hold if $\varepsilon$ is taken small enough.

### 3.1.2 Weak observability estimate

As explained in the introduction, the proof of stabilization consists in the analysis of possible sequences contradicting an observability estimate. The first step is to prove that such sequence is linearizable in the sense that its behavior is close to solutions of the linear equation.

Proposition 3.1. Let $\omega$ satisfying Assumption 0.2 and $a \in C^{\infty}(M)$ satisfying $a(x)>\eta>0$ for all $x \in \omega$. Let $T>T_{0}$ and $u_{n}$ be a sequence of solutions of

\end{align*}\right.
$$

satisfying

$$
\begin{array}{r}
\quad\left(u_{0, n}, u_{1, n}\right) \underset{n \rightarrow \infty}{\vec{\rightarrow}} 0 \text { weakly in } \mathcal{E} \\
\iint_{[0, T] \times M}\left|a(x) \partial_{t} u_{n}\right|^{2} d t d x \underset{n \rightarrow \infty}{\longrightarrow} 0 \tag{58}
\end{array}
$$

Then, $u_{n}$ is linearizable on $[0, t]$ for any $t<T-T_{0}$, that is

$$
\left\|\left|\left\|u_{n}-v_{n} \mid\right\|_{[0, t]} \underset{n \rightarrow \infty}{\longrightarrow} 0\right.\right.
$$

where $v_{n}$ is the solution of

$$
\left\{\begin{aligned}
\square v_{n} & =0 \text { on }[0, T] \times M \\
\left(v_{n}, \partial_{t} v_{n}\right)_{t=0} & =\left(u_{0, n}, u_{1, n}\right) .
\end{aligned}\right.
$$

Proof. Denote $t_{*}=\sup \left\{s \in[0, T]\left|\lim _{n \rightarrow \infty}\right|\left\|u_{n}-v_{n} \mid\right\|_{[0, s]}=0\right\}$ and we have to prove $t_{*} \geq T-T_{0}$. If it is not the case, we can find an interval $\left[t_{*}-\varepsilon, t_{*}-\varepsilon+L\right] \subset[0, T]$ with $T_{0}<L<T_{\text {focus }}$ and $0<2 \varepsilon<L-T_{0}$ (if $t_{*}=0$, take the interval $[0, L] \subset[0, T]$ ). Then, Lemma 3.1] below gives that $u_{n}$ is linearizable on $\left[t_{*}-\varepsilon, t_{*}+\varepsilon\right]$. We postpone the proof of Lemma 3.1 and finish the proof of the proposition. The definition of $t_{*}$ gives $\lim _{n \rightarrow \infty}\| \| u_{n}-v_{n}\| \|_{\left[0, t_{*}-\varepsilon\right]}=0$ and we have proved that $\lim _{n \rightarrow \infty}\left|\left\|u_{n}-\tilde{v}_{n} \mid\right\|_{\left[t_{*}-\varepsilon, t_{*}+\varepsilon\right]}=0\right.$ where $\tilde{v}_{n}$ is solution of

$$
\square \tilde{v}_{n}=0 \quad ; \quad\left(\tilde{v}_{n}, \partial_{t} \tilde{v}_{n}\right)_{t=t_{*}-\varepsilon}=\left(u_{n}, \partial_{t} u_{n}\right)_{t=t_{*}-\varepsilon} .

Since the norm $\left|\left\|\cdot|\||\right.\right.$ controls the energy norm, this easily yields $\left.\lim _{n \rightarrow \infty}\right\|\left\|u_{n}-v_{n} \mid\right\|_{\left[0, t_{*}+\varepsilon\right]}=0$ which is a contradiction to the definition of $t_{*}$.

Lemma 3.1. With the assumptions of Proposition 3.1. Consider the profile decomposition according to Theorem 0.4 of $u_{n}$ on a subinterval $\left[t_{0}, t_{0}+L\right] \subset[0, T]$ with $T_{0}<L<T_{\text {focus }}$.

Then, for any $0<\varepsilon<L-T_{0}$, this decomposition does not contain any non linear concentrating wave with $t_{\infty}^{(j)} \in\left[t_{0}, t_{0}+\varepsilon\right]$ and $u_{n}$ is linearizable on $\left[t_{0}, t_{0}+\varepsilon\right]$.

Proof. To simplify the notation, we work on the interval $[0, L]$. Moreover, since $a(x) \partial_{t} u_{n}$ tends to 0 in $L^{1} L^{2}$, Lemma 2.16 allows to assume with the same assumptions that $u_{n}$ is solution of the nonlinear equation without damping. Proposition 2.5 and Lemma 2.15 (with Rellich Theorem) give that $u_{n}$ is bounded in $L^{8}([0, T] \times M)$ and convergent to 0 in $L^{2}([0, T] \times M)$. Therefore, $u_{n}$ tends to 0 in $L^{7}([0, T] \times$ $M)$ and so $\left|u_{n}\right|^{4} u_{n}$ is convergent to 0 in $L^{7 / 5}([0, T] \times M) \hookrightarrow L^{4 / 3}([0, T] \times M) \hookrightarrow H_{l o c}^{-1}(] 0, l[\times M)$. Then, if we consider the (space-time) microlocal defect measure of $u_{n}$, the elliptic regularity and
the equation verified by $u_{n}$ gives that $\mu$ is supported in $\left\{\tau^{2}=|\xi|_{x}^{2}\right\}$ as in the linearizable case. So, combining this with (58), we get

Using the notation of Theorem [2.3, this gives $e=0$ on $] 0, L[\times \omega$. Since all the measures in the decomposition of $e$ are positive, we get the same result for any nonlinear concentrating wave in the decomposition of $u_{n}$, that is

Assume that $t_{\infty}^{(j)} \in[0, \varepsilon]$ for one $j \in \mathbb{N}$, so that the interval $\left[t_{\infty}^{(j)}, L\right]$ has length greater that $T_{0}$. Denote $p_{n}^{(j)}$ the linear concentrating wave approaching $q_{n}^{(j)}$ in the interval $I_{n}^{3, \Lambda}$ according to the notation of Theorem [2.1, so that for any $t_{\infty}^{(j)}<t<L$ (here, we use the fact that $L<T_{\text {focus }}$ ), we have

In particular, $\mu^{(j)}$ is also attached to $p_{n}^{(j)}$ on the time interval $\left.] t_{\infty}^{(j)}, L\right]$. Since $p_{n}^{(j)}$ is solution of the linear wave equation, its measure propagates along the hamiltonian flow. Assumption 0.2 and $\left|L-t_{\infty}^{(j)}\right|>T_{0}$ ensure that the geometric control condition is still verified on the interval $\left[t_{\infty}^{(j)}, L\right]$ which gives $\mu^{(j)} \equiv 0$ when combined with ( $(59)$. That means $p_{n}^{(j)} \equiv 0$ and so $q_{n}^{(j)} \equiv 0$ as expected.

Then, for the profile decomposition of $u_{n}$ on the interval $[0, L]$ (here the weak limit $u$ is necessarily zero)

$$
u_{n}=\sum_{j=1}^{l} q_{n}^{(j)}+w_{n}^{(l)}+r_{n}^{(l)},
$$

we have proved that $\left.\left.t_{n}^{(j)} \in\right] \varepsilon, L\right]$. Then Theorem [2.1 and $L<T_{\text {focus }}$ provides a linear concentrating wave $p_{n}^{(j)}$ such that $\varlimsup_{n \rightarrow \infty}\| \| q_{n}^{(j)}-p_{n}^{(j)}\| \|_{[0, \varepsilon]}=0$ while Lemma 2.3 give $\varlimsup_{n \rightarrow \infty}\left\|p_{n}^{(j)}\right\|_{L^{5}\left([0, \varepsilon], L^{10}\right)}=0$. Moreover, the conclusion of Theorem 2.1 give $\varlimsup_{n \rightarrow \infty}\left\|w_{n}^{(l)}+r_{n}^{(l)}\right\|_{L^{5}\left([0, \varepsilon], L^{10}\right)} \underset{l \rightarrow \infty}{ } 0$. This finally yields $\varlimsup_{n \rightarrow \infty}\left\|u_{n}\right\|_{L^{5}\left([0, \varepsilon], L^{10}\right)}=0$ and therefore

$$
\left\|\left|u_{n}\right|^{4} u_{n}\right\|_{L^{1}\left([0, \varepsilon], L^{2}\right)} \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

This gives exactly that $u_{n}$ is linearizable on $[0, \varepsilon]$.
We are now ready for the proof of some weak observability estimates. We recall the notation $E(u)$ for the nonlinear energy defined in (2).

Theorem 3.1. Let $\omega$ satisfying Assumption 0.2 with $T_{0}$ and $a \in C^{\infty}(M)$ satisfying $a(x)>\eta>0$ for all $x \in \omega$. Let $T>2 T_{0}$ and $R_{0}>0$. Then, there exists $C>0$ such that for any $u$ solution of

\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} & \leq R_{0}
\end{align*}\right.
$$

satisfies

$$
E(u)(0) \leq C\left(\iint_{[0, T] \times M}\left|a(x) \partial_{t} u\right|^{2} \quad d t d x+\left\|\left(u_{0}, u_{1}\right)\right\|_{L^{2} \times H^{-1}} E(u)(0)\right)
$$

Proof. We argue by contradiction : we suppose that there exists a sequence $u_{n}$ of solutions of (60) such that

\left(\iint_{[0, T] \times M}\left|a(x) \partial_{t} u_{n}\right|^{2} d t d x+\left\|\left(u_{0, n}, u_{1, n}\right)\right\|_{L^{2} \times H^{-1}} E\left(u_{n}\right)(0)\right) \leq \frac{1}{n} E\left(u_{n}\right)(0)
$$

Denote $\alpha_{n}=\left(E\left(u_{n}\right)(0)\right)^{1 / 2}$. By Sobolev embedding for the $L^{6}$ norm, we have $\alpha_{n} \leq C\left(R_{0}\right)$. So, up to extraction, we can assume that $\alpha_{n} \longrightarrow \alpha \geq 0$.

We will distinguish two cases : $\alpha>0$ and $\alpha=0$.

- First case : $\alpha_{n} \longrightarrow \alpha>0$

The second part of the estimate gives $\left\|\left(u_{0, n}, u_{1, n}\right)\right\|_{L^{2} \times H^{-1}} \underset{n \rightarrow \infty}{\longrightarrow} 0$ and so $\left(u_{0, n}, u_{1, n}\right) \underset{n \rightarrow \infty}{\longrightarrow} 0$ in $H^{1} \times L^{2}$. Therefore, we are in position to apply Proposition 3.1 and get that $u_{n}$ is linearizable on an interval $[0, L]$ with $L>T_{0}$. We get a contradiction to $\alpha>0$ by applying the following classical linear proposition, which can be easily proved using microlocal defect measure as in Lemma 3.1.
Proposition 3.2. Let $\omega$ satisfying Assumption 0.2 with $T_{0}$. Let $T>T_{0}$ and $v_{n}$ be a sequence of solutions of

Then, $\left(v_{n}(0), \partial_{t} v_{n}(0)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0$ for the strong topology of $H^{1} \times L^{2}$. The same result holds with $\square u_{n}$ replaced by $\square u_{n}+u_{n}$.

- Second case : $\alpha_{n} \longrightarrow 0$

Let us make the change of unknown $w_{n}=u_{n} / \alpha_{n} . w_{n}$ is solution of the system

We have for a large constant $C>0$ depending on $R_{0}$ and for all $t \in[0, T]$,

\frac{1}{C}\left\|\left(u_{n}, \partial_{t} u_{n}\right)\right\|_{\mathcal{E}}^{2} \leq E\left(u_{n}\right) \leq C\left\|\left(u_{n}, \partial_{t} u_{n}\right)\right\|_{\mathcal{E}}^{2} .
$$

Therefore, we have

$$
\begin{array}{r}
\left\|\left(w_{n}(t), \partial_{t} w_{n}(t)\right)\right\|_{\mathcal{E}}=\frac{\left\|\left(u_{n}(t), \partial_{t} u_{n}(t)\right)\right\|_{\mathcal{E}}}{\sqrt{E\left(u_{n}(0)\right)}} \leq C \frac{\sqrt{E\left(u_{n}(t)\right)}}{\sqrt{E\left(u_{n}(0)\right)}} \leq C \\
\left\|\left(w_{n}(0), \partial_{t} w_{n}(0)\right)\right\|_{\mathcal{E}}=\frac{\left\|\left(u_{n}(0), \partial_{t} u_{n}(0)\right)\right\|_{\mathcal{E}}}{\sqrt{E\left(u_{n}(0)\right)}} \geq \frac{1}{\sqrt{C}}>0 . \tag{62}
\end{array}
$$

Thus, we have $\left\|\left(w_{n}(0), \partial_{t} w_{n}(0)\right)\right\|_{\mathcal{E}} \approx 1$ and $\left(w_{n}, \partial_{t} w_{n}\right)$ is bounded in $L^{\infty}([0, T], \mathcal{E})$.
Applying Strichartz estimates to equation (61), we get for $C=C\left(R_{0}\right)>0$

$$
\left\|w_{n}\right\|_{L^{5}\left([0, T], L^{10}\right)} \leq C\left(1+\alpha_{n}^{4}\left\|w_{n}\right\|_{L^{5}\left([0, T], L^{10}\right)}^{5}\right)
$$

Then, using a bootstrap argument, we deduce that $\left\|w_{n}\right\|_{L^{5}\left([0, T], L^{10}\right)}$ is bounded and therefore

$$
\square w_{n}+w_{n} \underset{n \rightarrow \infty}{\longrightarrow} 0 \text { in } L^{1}\left([0, T], L^{2}\right) .
$$

Proposition 3.2 yields that $w_{n}$ converges strongly to some $w$ solution of

$$
\square w+w=0 ; \quad \partial_{t} w \equiv 0 \text { on } \omega .
$$

We deduce as in J. Rauch and M. Taylor [32] or C. Bardos, G. Lebeau, J. Rauch [3] that the set of such solutions is finite dimensional and admits an eigenvector $w$ for $\Delta$. By unique continuation for second order elliptic operator, we get $\partial_{t} w \equiv 0$. Multiplying the equation by $\bar{w}$ and integrating, we obtain $w \equiv 0$ (note that, at this stage, the choice of the Klein-Gordon equation instead of the wave equation is crucial to avoid the constant solutions). We conclude that ( $\left.w_{n}(0), \partial_{t} w_{n}(0)\right)$ tends to 0 strongly in $\mathcal{E}$ which gives a contradiction to (62).

### 3.2 Controllability

### 3.2.1 Linear control

In this section, we recall some well known results about linear control theory and HUM method. Let $\left(\Phi_{0}, \Phi_{1}\right) \in L^{2} \times H^{-1}$. We solve the system

$$
\left\{\begin{align*}
\square \Phi+\Phi & =0 \text { on }[0, T] \times M  \tag{63}\\
\left(\Phi, \partial_{t} \Phi\right)_{\mid t=0} & =\left(\Phi_{0}, \Phi_{1}\right) .
\end{align*}\right.
$$

and

$$
\left\{\begin{align*}
\square v+v & =a^{2} \Phi \quad \text { on } \quad[0, T] \times M  \tag{64}\\
\left(v, \partial_{t} v\right)_{\mid t=T} & =(0,0) .
\end{align*}\right.
$$

The HUM operator $S$ from $L^{2} \times H^{-1}$ to $L^{2} \times H^{1}$ is defined by

$$
S\left(\Phi_{0}, \Phi_{1}\right)=\left(-\partial_{t} v(0), v(0)\right) .
$$

Lemma 3.2. If $\omega$ satisfies the geometric control Assumption 0.1, then $S$ is an isomorphism.

Proof. Multiplying equation (64) by $\bar{\Phi}$, integrating over $[0, T] \times M$ and integrating by part, we get the formula

$$
\int_{0}^{T} \int_{M}|a \Phi|^{2}=-\int_{M} \partial_{t} v(0) \bar{\phi}(0)+\int_{M} v(0) \partial_{t} \bar{\phi}(0)=\left\langle S\left(\Phi_{0}, \Phi_{1}\right),\left(\Phi_{0}, \Phi_{1}\right)\right\rangle
$$

where $\langle.,$.$\rangle denotes the duality between L^{2} \times H^{1}$ and $L^{2} \times H^{-1}$. We get the conclusion thanks to the following observability estimate which can be proved by the same techniques used in the nonlinear problem

$$
\left\|\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}}^{2} \leq \int_{0}^{T} \int_{M}|a \Phi|^{2}
$$

### 3.2.2 Controllability for small data

Theorem 3.2. Let $\omega$ satisfying Assumption 0.1 and $T>T_{0}$. Then, there exists $\delta>0$ such that for any $\left(u_{0}, u_{1}\right)$ and $\left(\tilde{u}_{0}, \tilde{u}_{1}\right)$ in $H^{1} \times L^{2}$, with

$$
\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} \leq \delta ; \quad\left\|\left(\tilde{u}_{0}, \tilde{u}_{1}\right)\right\|_{\mathcal{E}} \leq \delta
$$

there exists $g \in L^{\infty}\left([0,2 T], L^{2}\right)$ supported in $[0,2 T] \times \omega$ such that the unique strong solution of

$$
\left\{\begin{aligned}
\square u+u+|u|^{4} u & =g \text { on }[0,2 T] \times M \\
\left(u(0), \partial_{t} u(0)\right) & =\left(u_{0}, u_{1}\right) .
\end{aligned}\right.
$$

satisfies $\left(u(2 T), \partial_{t} u(2 T)\right)=\left(\tilde{u}_{0}, \tilde{u}_{1}\right)$
Proof. The proof is very similar to [11] except that the critical exponent do not allow to use compactness argument and we use the classical Picard fixed point instead of Schauder, as done in 9] or [28, [29] for NLS. By a compactness argument, we can select $a \in C_{0}^{\infty}(\omega)$ with $a(x)>\eta>0$ for $x$ in $\tilde{\omega}$ where $\tilde{\omega}$ satisfies Assumption 0.1. Since the equation is reversible, we can assume ( $\left.\tilde{u}_{0}, \tilde{u}_{1}\right) \equiv(0,0)$ and take the time $T$ instead of $2 T$. We seek $g$ of the form $a^{2}(x) \Phi$ where $\Phi$ is solution of the free wave equation as in linear control theory with initial datum $\left(\Phi_{0}, \Phi_{1}\right) \in L^{2} \times H^{-1}$. The purpose will be to choose the right $\left(\Phi_{0}, \Phi_{1}\right) \in L^{2} \times H^{-1}$ to get the expected data. We consider the solutions of the two systems

$$
\left\{\begin{aligned}
\square \Phi+\Phi & =0 \text { on }[0, T] \times M \\
\left(\Phi, \partial_{t} \Phi\right)_{\mid t=0} & =\left(\Phi_{0}, \Phi_{1}\right)
\end{aligned}\right.
$$

and

$$
\left\{\begin{align*}
\square u+u+|u|^{4} u & =a^{2} \Phi \quad \text { on } \quad[0, T] \times M  \tag{65}\\
\left(u, \partial_{t} u\right)_{\mid t=T} & =(0,0) .
\end{align*}\right.
$$

Let us define the operator

$$
\begin{align*}
L: \quad L^{2} \times H^{-1} & \rightarrow H^{1} \times L^{2}  \tag{66}\\
\left(\Phi_{0}, \Phi_{1}\right) & \mapsto L\left(\Phi_{0}, \Phi_{1}\right)=\left(u, \partial_{t} u\right)_{\mid t=0} .
\end{align*}
$$

We split $u=v+\Psi$ with $\Psi$ solution of

$$
\left\{\begin{align*}
\square \Psi+\Psi & =a^{2} \Phi \quad \text { on } \quad[0, T] \times M  \tag{67}\\
\left(\Psi, \partial_{t} \Psi\right)_{\mid t=T} & =(0,0)
\end{align*}\right.
$$

This corresponds to the linear control, and $\left(-\partial_{t} \Psi, \Psi\right)_{\mid t=0}=S\left(\Phi_{0}, \Phi_{1}\right)$. As for function $v$, it is solution of

$$
\left\{\begin{align*}
\square v+v & =-|u|^{4} u \quad \text { on } \quad[0, T] \times M  \tag{68}\\
\left(v, \partial_{t} v\right)_{\mid t=T} & =(0,0) .
\end{align*}\right.
$$

$\Phi$ belongs to $C\left([0, T], L^{2}\right)$. So, $u, v$ and $\Psi$ belong to $C\left([0, T], H^{1}\right) \cap C^{1}\left([0, T], L^{2}\right) \cap L^{5}\left([0, T], L^{10}\right)$. We can write

$$
L\left(\Phi_{0}, \Phi_{1}\right)=K\left(\Phi_{0}, \Phi_{1}\right)+S\left(\Phi_{0}, \Phi_{1}\right)
$$

where $K\left(\Phi_{0}, \Phi_{1}\right)=\left(-\partial_{t} v, v\right)_{\mid t=0} . L\left(\Phi_{0}, \Phi_{1}\right)=\left(-u_{1}, u_{0}\right)$ is equivalent to $\left(\Phi_{0}, \Phi_{1}\right)=-S^{-1} K\left(\Phi_{0}, \Phi_{1}\right)+$ $S^{-1}\left(-u_{1}, u_{0}\right)$. Defining the operator $B: L^{2} \times H^{-1} \rightarrow L^{2} \times H^{-1}$ by

$$
B\left(\Phi_{0}, \Phi_{1}\right)=-S^{-1} K\left(\Phi_{0}, \Phi_{1}\right)+S^{-1}\left(-u_{1}, u_{0}\right),
$$

the problem $L\left(\Phi_{0}, \Phi_{1}\right)=\left(-u_{1}, u_{0}\right)$ is equivalent to finding a fixed point of $B$. We will prove that if $\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}}$ is small enough, $B$ is a contraction and reproduces a small ball $B_{R}$ of $L^{2} \times H^{-1}$.

Since $S$ is an isomorphism, we have

$$
\left\|B\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq C\left(\left\|K\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{1}}+\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}}\right)
$$

So we are led to estimate $\left\|K\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{1}}=\left\|\left(v, \partial_{t} v\right)_{\mid t=0}\right\|_{\mathcal{E}}$. Energy estimates applied to equation (68) and Hölder inequality give

$$
\left\|\left(v, \partial_{t} v\right)_{\mid t=0}\right\|_{\mathcal{E}} \leq C\left\||u|^{4} u\right\|_{L^{1}\left([0, T], L^{2}\right)} \leq C\|u\|_{L^{5}\left([0, T], L^{10}\right)}^{5} .
$$

But Strichartz estimates applied to equation (65) give

$$
\|u\|_{L^{5}\left([0, T], L^{10}\right)} \leq C\left(\left\|a^{2} \Phi\right\|_{L^{1}\left([0, T], L^{2}\right)}+\|u\|_{L^{5}\left([0, T], L^{10}\right)}^{5}\right) \leq C\left(\left\|\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}}+\|u\|_{L^{5}\left([0, T], L^{10}\right)}^{5}\right) .
$$

Using a bootstrap argument, we get that for $\left\|\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq R$ small enough, we have

$$
\begin{equation*}
\|u\|_{L^{5}\left([0, T], L^{10}\right)} \leq C\left\|\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}} . \tag{69}
\end{equation*}
$$

We finally obtain

$$
\left\|B\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq C\left(\left\|\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}}^{5}+\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}}\right) .
$$

Choosing $R$ small enough and $\left\|\left(u_{0}, u_{1}\right)\right\|_{H^{1} \times L^{2}} \leq R / 2 C$, we obtain $\left\|B\left(\Phi_{0}, \Phi_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq R$ and $B$ reproduces the ball $B_{R}$. Let us now prove that $B$ is contracting. We examine the system

$$
\left\{\begin{align*}
& \square(u-\tilde{u})+(u-\tilde{u})+|u|^{4} u-|\tilde{u}|^{4} \tilde{u}=a^{2}(\Phi-\tilde{\Phi}) \quad \text { on } \quad[0, T] \times M  \tag{70}\\
&\left(u-\tilde{u}, \partial_{t}(u-\tilde{u})\right)_{\mid t=T}=(0,0) .  \tag{71}\\
&\left\{\begin{array}{rll}
\square(v-\tilde{v})+(v-\tilde{v})+|u|^{4} u-|\tilde{u}|^{4} \tilde{u} & =0 \quad \text { on } \quad[0, T] \times M \\
\left(v-\tilde{v}, \partial_{t}(v-\tilde{v})\right)_{\mid t=T} & =(0,0) .
\end{array}\right.
\end{align*}\right.
$$

We obtain similarly

$$
\begin{align*}
\left\|B\left(\Phi_{0}, \Phi_{1}\right)-B\left(\tilde{\Phi}_{0}, \tilde{\Phi}_{1}\right)\right\|_{L^{2} \times H^{-1}} & \leq C\left\|\left(v-\tilde{v}, \partial_{t}(v-\tilde{v})\right)_{\mid t=0}\right\|_{\mathcal{E}} \\
& \leq C\left\||u|^{4} u-|\tilde{u}|^{4} \tilde{u}\right\|_{L^{1}\left([0, T], L^{2}\right)} \\
& \leq C\|u-\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)}\left(\|u\|_{L^{5}\left([0, T], L^{10}\right)}^{4}+\|\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)}^{4}\right) \\
& \leq C R^{4}\|u-\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)}^{4} \tag{72}
\end{align*}
$$

where we have used estimate (69) for the last inequality. Applying Strichartz estimates to equation (70), we get

$$
\begin{aligned}
\|u-\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)} & \leq C\left(\left\||u|^{4} u-|\tilde{u}|^{4} \tilde{u}\right\|_{L^{1}\left([0, T], L^{2}\right)}+\left\|a^{2}(\Phi-\tilde{\Phi})\right\|_{L^{1}\left([0, T], L^{2}\right)}\right) \\
& \leq C R^{4}\|u-\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)}+C\left\|\left(\Phi_{0}, \Phi_{1}\right)-\left(\tilde{\Phi}_{0}, \tilde{\Phi}_{1}\right)\right\|_{L^{2} \times H^{-1}}
\end{aligned}
$$

If $R$ is taken small enough, it yields

$$
\begin{equation*}
\|u-\tilde{u}\|_{L^{5}\left([0, T], L^{10}\right)} \leq C\left\|\left(\Phi_{0}, \Phi_{1}\right)-\left(\tilde{\Phi}_{0}, \tilde{\Phi}_{1}\right)\right\|_{L^{2} \times H^{-1}} . \tag{73}
\end{equation*}
$$

Combining (72) and (731), we finally obtain for $R$ small enough

$$
\left\|B\left(\Phi_{0}, \Phi_{1}\right)-B\left(\tilde{\Phi}_{0}, \tilde{\Phi}_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq C R^{4}\left\|\left(\Phi_{0}, \Phi_{1}\right)-\left(\tilde{\Phi}_{0}, \tilde{\Phi}_{1}\right)\right\|_{L^{2} \times H^{-1}}
$$

and $B$ is a contraction for $R$ small enough, which completes the proof of Theorem 3.2,

### 3.2.3 Controllability of high frequency data

This subsection is devoted to the proof of the both main theorem of the article : Theorem 0.2 and 0.1 .

Proof of Theorem 0.2. First, by decreasing of the energy and Sobolev embedding, there exists some constant $C\left(R_{0}\right)$ such that the assumption $\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} \leq R_{0}$ implies

$$
\begin{equation*}
E(u)(t) \leq C\left(R_{0}\right) \text { and }\left\|\left(u, \partial_{t} u\right)(t)\right\|_{\mathcal{E}} \leq C\left(R_{0}\right) ; \quad \forall t \geq 0 \tag{74}
\end{equation*}
$$

Fix $T$ such that Theorem 3.1 applies. Then, there exists $\varepsilon>0$ such that for any $\left(u_{0}, u_{1}\right)$ satisfying

$$
\begin{equation*}
\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} \leq C\left(R_{0}\right) ; \quad\left\|\left(u_{0}, u_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq \varepsilon \tag{75}
\end{equation*}
$$

we have the strong observability estimate

$$
E(u)(0) \leq C \iint_{[0, T] \times M}\left|a(x) \partial_{t} u\right|^{2} d t d x .
$$

for any solution of the damped equation (3). That means that there exists $0<C$ such that any solution of the damped equation satisfying (75) fulfills

$$
\begin{equation*}
E(u)(T) \leq(1-C) E(u)(0) \tag{76}
\end{equation*}
$$

Pick $N \in \mathbb{N}$ large enough such that $(1-C)^{N} C\left(R_{0}\right) \leq \varepsilon^{2} / 2$.
Corollary 2.4 and (74) allow us to choose $\delta$ small enough such that the assumption

$$
\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{E}} \leq R_{0} ; \quad\left\|\left(u_{0}, u_{1}\right)\right\|_{L^{2} \times H^{-1}} \leq \delta
$$

implies

$$
\begin{equation*}
\left\|\left(u(n T), \partial_{t} u(n T)\right)\right\|_{L^{2} \times H^{-1}} \leq \varepsilon, \quad 0 \leq n \leq N . \tag{77}
\end{equation*}
$$

So, with that choice, we have $E(u)(N T) \leq(1-C)^{N} E(u)(0)$. Then, by the energy decreasing, for any $t \geq N T$, we have

$$
\left\|\left(u, \partial_{t} u\right)(t)\right\|_{L^{2} \times H^{-1}}^{2} \leq 2 E(u)(t) \leq 2 E(u)(N T) \leq \varepsilon^{2} .
$$

Therefore, the decay estimate (76) is true on each interval $[n T,(n+1) T], n \in \mathbb{N}$ and we have

$$
E(u)(n T) \leq(1-C)^{n} E(u)(0)
$$

which yields the result.

Proof of Theorem 0.1. Since the equation is reversible, we can assume ( $\left.\tilde{u}_{0}, \tilde{u}_{1}\right)=(0,0)$. By a compactness argument, we can select $a \in C_{0}^{\infty}(\omega)$ with $a(x)>\eta>0$ for $x$ in $\tilde{\omega}$ where $\tilde{\omega}$ satisfies Assumption 0.2. We will first use the damping term $a(x)^{2} \partial_{t} u$ as a term of control. We apply Theorem 0.2 and Theorem 3.2 once the energy is small enough.
