# High-dimensional Covariance Estimation Based On Gaussian Graphical Models

#### Abstract

Undirected graphs are often used to describe high dimensional distributions. Under sparsity conditions, the graph can be estimated using $\ell_{1}$-penalization methods. We propose and study the following method. We combine a multiple regression approach with ideas of thresholding and refitting: first we infer a sparse undirected graphical model structure via thresholding of each among many $\ell_{1}$-norm penalized regression functions; we then estimate the covariance matrix and its inverse using the maximum likelihood estimator. We show that under suitable conditions, this approach yields consistent estimation in terms of graphical structure and fast convergence rates with respect to the operator and Frobenius norm for the covariance matrix and its inverse. We also derive an explicit bound for the Kullback Leibler divergence.


Keywords: Graphical model selection, covariance estimation, Lasso, nodewise regression, thresholding

## 1. Introduction

There have been a lot of recent activities for estimation of high-dimensional covariance and inverse covariance matrices where the dimension $p$ of the matrix may greatly exceed the sample size $n$.

High-dimensional covariance estimation can be classified into two main categories, one which relies on a natural ordering among the variables [Bickel and Levina, 2004, 2008; Furrer and Bengtsson, 2007; Huang et al., 2006; Levina et al., 2008; Wu and Pourahmadi, 2003] and one where no natural ordering is given and estimators are permutation invariant with respect to indexing the variables [Banerjee et al., 2008; d'Aspremont et al., 2008; Friedman et al., 2007; Rothman et al., 2008; Yuan and Lin, 2007]. We focus here on the latter class with permutation invariant estimation and we aim for an estimator which is accurate for both the covariance matrix $\Sigma$ and its inverse, the precision matrix $\Sigma^{-1}$. A popular approach for obtaining a permutation invariant estimator which is sparse in the estimated precision matrix $\widehat{\Sigma}^{-1}$ is given by the $\ell_{1}$-norm regularized maximumlikelihood estimation, also known as the GLasso [Banerjee et al., 2008; Friedman et al., 2007; Yuan and Lin, 2007]. The GLasso approach is simple to use, at least when relying on publicly available software such as the glasso package in R. Further improvements have been reported when using some SCAD-type penalized maximum-likelihood estimator [Lam and Fan, 2009] or an adaptive GLasso procedure [Fan et al., 2009], which can be thought of as a two-stage procedure. It is well-known from linear regression that such two- or multi-stage methods effectively address some bias problems which arise from $\ell_{1}$-penalization [Bühlmann and Meier, 2008; Candès and Tao, 2007; Meinshausen, 2007; Zhou, 2009, 2010b; Zou, 2006; Zou and Li, 2008].

In this paper we develop a new method for estimating graphical structure and parameters for multivariate Gaussian distributions using a multi-step procedure, which we call Gelato (Graph estimation with Lasso and Thresholding). Based on an $\ell_{1}$-norm regularization and thresholding method in a first stage, we infer a sparse undirected graphical model, i.e. an estimated Gaussian conditional independence graph, and we then perform unpenalized maximum likelihood estimation (MLE) for the covariance $\Sigma$ and its inverse $\Sigma^{-1}$ based on the estimated graph. We make the following theoretical contributions: (i) Our method allows us to select a graphical structure which is sparse. In some sense we select only the important edges even though there may be many nonzero edges in the graph. (ii) Secondly, we evaluate the quality of the graph we have selected by showing consistency and establishing a fast rate of convergence with respect to the operator and Frobenius norm for the estimated inverse covariance matrix; under sparsity constraints, the latter is of lower order than the corresponding results for the GLasso [Rothman et al., 2008] and for the SCAD-type estimator [Lam and Fan, 2009]. (iii) We show predictive risk consistency and provide a rate of convergence of the estimated covariance matrix. (iv) Lastly, we show general results for the MLE, where only approximate graph structures are given as input. Besides these theoretical advantages, we found empirically that our graph based method performs better in general, and sometimes substantially better than the GLasso, while we never found it clearly worse. Moreover, we compare it with an adaptation of the method Space [Peng et al., 2009]. Finally, our algorithm is simple and is comparable to the GLasso both in terms of computational time and implementation complexity.

There are a few key motivations and consequences for proposing such an approach based on graphical modeling. We will theoretically show that there are cases where our graph based method can accurately estimate conditional independencies among variables, i.e. the zeroes of $\Sigma^{-1}$, in situations where GLasso fails. The fact that GLasso easily fails to estimate the zeroes
of $\Sigma^{-1}$ has been recognized by Meinshausen [2008] and it has been discussed in more details in Ravikumar et al. [2008]. Closer relations to existing work are primarily regarding our first stage of estimating the structure of the graph. We follow the nodewise regression approach from Meinshausen and Bühlmann [2006] but we make use of recent results for variable selection in linear models assuming the much weaker restricted eigenvalue condition [Bickel et al., 2009; Zhou, 2010b] instead of the restrictive neighborhood stability condition [Meinshausen and Bühlmann, 2006] or the equivalent irrepresentable condition [Zhao and Yu, 2006]. In some sense, the novelty of our theory extending beyond Zhou [2010b] is the analysis for covariance and inverse covariance estimation and for risk consistency based on an estimated sparse graph as we mentioned above. Our regression and thresholding results build upon analysis of the thresholded Lasso estimator as studied in Zhou [2010b]. Throughout our analysis, the sample complexity is one of the key focus point, which builds upon results in Rudelson and Zhou [2011]; Zhou [2010a]. Once the zeros are found, a constrained maximum likelihood estimator of the covariance can be computed, which was shown in Chaudhuri et al. [2007]; it was unclear what the properties of such a procedure would be. Our theory answers such questions. As a two-stage method, our approach is also related to the adaptive Lasso [Zou, 2006] which has been analyzed for high-dimensional scenarios in Huang et al. [2008]; van de Geer et al. [2010]; Zhou et al. [2009]. Another relation can be made to the method by Rütimann and Bühlmann [2009] for covariance and inverse covariance estimation based on a directed acyclic graph. This relation has only methodological character: the techniques and algorithms used in Rütimann and Bühlmann [2009] are very different and from a practical point of view, their approach has much higher degree of complexity in terms of computation and implementation, since estimation of an equivalence class of directed acyclic graphs is difficult and cumbersome. There has also been work that focuses on estimation of sparse directed Gaussian graphical model. Verzelen [2010] proposes a multiple regularized regression procedure for estimating a precision matrix with sparse Cholesky factors, which correspond to a sparse directed graph. He also computes non-asymptotic Kullback Leibler risk bound of his procedure for a class of regularization functions. It is important to note that directed graph estimation requires a fixed good ordering of the variables a priori.

Notation. We use the following notation. Given a graph $G=\left(V, E_{0}\right)$, where $V=\{1, \ldots, p\}$ is the set of vertices and $E_{0}$ is the set of undirected edges. we use $s^{i}$ to denote the degree for node $i$, that is, the number of edges in $E_{0}$ connecting to node $i$. For an edge set $E$, we let $|E|$ denote its size. We use $\Theta_{0}=\Sigma_{0}^{-1}$ and $\Sigma_{0}$ to refer to the true precision and covariance matrices respectively from now on. We denote the number of non-zero elements of $\Theta$ by $\operatorname{supp}(\Theta)$. For any matrix $W=\left(w_{i j}\right)$, let $|W|$ denote the determinant of $W, \operatorname{tr}(W)$ the trace of $W$. Let $\varphi_{\max }(W)$ and $\varphi_{\min }(W)$ be the largest and smallest eigenvalues, respectively. We write $\operatorname{diag}(W)$ for a diagonal matrix with the same diagonal as $W$ and offd $(W)=W-\operatorname{diag}(W)$. The matrix Frobenius norm is given by $\|W\|_{F}=\sqrt{\sum_{i} \sum_{j} w_{i j}^{2}}$. The operator norm $\|W\|_{2}^{2}$ is given by $\varphi_{\max }\left(W W^{T}\right)$. We write $|\cdot|_{1}$ for the $\ell_{1}$ norm of a matrix vectorized, i.e., for a matrix $|W|_{1}=\|\operatorname{vec} W\|_{1}=\sum_{i} \sum_{j}\left|w_{i j}\right|$, and sometimes write $\|W\|_{0}$ for the number of non-zero entries in the matrix. For an index set $T$ and a matrix $W=\left[w_{i j}\right]$, write $W_{T} \equiv\left(w_{i j} I((i, j) \in T)\right)$, where $I(\cdot)$ is the indicator function.

## 2. The model and the method

We assume a multivariate Gaussian model

$$
\begin{equation*}
X=\left(X_{1}, \ldots, X_{p}\right) \sim \mathcal{N}_{p}\left(0, \Sigma_{0}\right), \quad \text { where } \Sigma_{0, i i}=1 \tag{1}
\end{equation*}
$$

The data is generated by $X^{(1)}, \ldots, X^{(n)}$ i.i.d. $\sim \mathcal{N}_{p}\left(0, \Sigma_{0}\right)$. Requiring the mean vector and all variances being equal to zero and one respectively is not a real restriction and in practice, we can easily center and scale the data. We denote the concentration matrix by $\Theta_{0}=\Sigma_{0}^{-1}$.

Since we will use a nodewise regression procedure, as described below in Section 2.1, we consider a regression formulation of the model. Consider many regressions, where we regress one variable against all others:

V_{i} & \sim \mathcal{N}\left(0, \sigma_{V_{i}}^{2}\right) \text { independent of }\left\{X_{j} ; j \neq i\right\}(i=1, \ldots, p) \tag{3}
\end{align*}

There are explicit relations between the regression coefficients, error variances and the concentration matrix $\Theta_{0}=\left(\theta_{0, i j}\right)$ :

\beta_{j}^{i}=-\theta_{0, i j} / \theta_{0, i i}, \operatorname{Var}\left(V_{i}\right):=\sigma_{V_{i}}^{2}=1 / \theta_{0, i i}(i, j=1, \ldots, p) \tag{4}
\end{equation*}

Furthermore, it is well known that for Gaussian distributions, conditional independence is encoded in $\Theta_{0}$, and due to (4), also in the regression coefficients:

& X_{i} \text { is conditionally dependent of } X_{j} \text { given }\left\{X_{k} ; k \in\{1, \ldots, p\} \backslash\{i, j\}\right\} \\
\Longleftrightarrow & \theta_{0, i j} \neq 0 \Longleftrightarrow \beta_{i}^{j} \neq 0 \text { and } \beta_{j}^{i} \neq 0 \tag{5}
\end{align*}
$$

For the second equivalence, we assume that $\operatorname{Var}\left(V_{i}\right)=1 / \theta_{0, i i}>0$ and $\operatorname{Var}\left(V_{j}\right)=1 / \theta_{0, j j}>0$. Conditional (in-)dependencies can be conveniently encoded by an undirected graph, the conditional independence graph which we denote by $G=\left(V, E_{0}\right)$. The set of vertices is $V=\{1, \ldots, p\}$ and the set of undirected edges $E_{0} \subseteq V \times V$ is defined as follows:
there is an undirected edge between nodes $i$ and $j$

Note that on the right hand side of the second equivalence, we could replace the word "and" by "or". For the second equivalence, we assume $\operatorname{Var}\left(V_{i}\right), \operatorname{Var}\left(V_{j}\right)>0$ following the remark after (5).

We now define the sparsity of the concentration matrix $\Theta_{0}$ or the conditional independence graph. The definition is different than simply counting the non-zero elements of $\Theta_{0}$, for which we have $\operatorname{supp}\left(\Theta_{0}\right)=p+2\left|E_{0}\right|$. We consider instead the number of elements which are sufficiently large. For each $i$, define the number $s_{0, n}^{i}$ as the smallest integer such that the following holds:

where essential sparsity $s_{0, n}^{i}$ at row $i$ describes the number of "sufficiently large" non-diagonal elements $\theta_{0, i j}$ relative to a given $(n, p)$ pair and $\theta_{0, i i}, i=1, \ldots, p$. The value $S_{0, n}$ in (8) is summing essential sparsity across all rows of $\Theta_{0}$,

Due to the expression of $\lambda$, the value of $S_{0, n}$ depends on $p$ and $n$. For example, if all nonzero non-diagonal elements $\theta_{0, i j}$ of the $i$ th row are larger in absolute value than $\lambda \sqrt{\theta_{0, i}}$, the value $s_{0, n}^{i}$ coincides with the node degree $s^{i}$. However, if some (many) of the elements $\left|\theta_{0, i j}\right|$ are non-zero but small, $s_{0, n}^{i}$ is (much) smaller than its node degree $s^{i}$; As a consequence, if some (many) of $\left|\theta_{0, i j}\right|, \forall i, j, i \neq j$ are non-zero but small, the value of $S_{0, n}$ is also (much) smaller than $2\left|E_{0}\right|$, which is the "classical" sparsity for the matrix $\left(\Theta_{0}-\operatorname{diag}\left(\Theta_{0}\right)\right)$. See Section A for more discussions.

### 2.1 The estimation procedure

The estimation of $\Theta_{0}$ and $\Sigma_{0}=\Theta_{0}^{-1}$ is pursued in two stages. We first estimate the undirected graph with edge set $E_{0}$ as in (6) and we then use the maximum likelihood estimator based on the estimate $\widehat{E}_{n}$, that is, the non-zero elements of $\widehat{\Theta}_{n}$ correspond to the estimated edges in $\widehat{E}_{n}$. Inferring the edge set $E_{0}$ can be based on the following approach as proposed and theoretically justified in Meinshausen and Bühlmann [2006]: perform $p$ regressions using the Lasso to obtain $p$ vectors of regression coefficients $\widehat{\beta}^{1}, \ldots, \widehat{\beta}^{p}$ where for each $i, \widehat{\beta}^{i}=\left\{\widehat{\beta}_{j}^{i} ; j \in\{1, \ldots, p\} \backslash i\right\}$; Then estimate the edge set by the "OR" rule,

Nodewise regressions for inferring the graph. In the present work, we use the Lasso in combination with thresholding [Zhou, 2009, 2010b]. Consider the Lasso for each of the nodewise regressions

\beta_{\text {init }}^{i}=\operatorname{argmin}_{\beta^{i}} \sum_{r=1}^{n}\left(X_{i}^{(r)}-\sum_{j \neq i} \beta_{j}^{i} X_{j}^{(r)}\right)^{2}+\lambda_{n} \sum_{j \neq i}\left|\beta_{j}^{i}\right| \text { for } i=1, \ldots, p, \tag{10}
\end{equation*}
$$

where $\lambda_{n}>0$ is the same regularization parameter for all regressions. Since the Lasso typically estimates too many components with non-zero estimated regression coefficients, we use thresholding to get rid of variables with small regression coefficients from solutions of (10):

where $\tau>0$ is a thresholding parameter. We obtain the corresponding estimated edge set as defined by (9) using the estimator in (11) and we use the notation

We note that the estimator depends on two tuning parameters $\lambda_{n}$ and $\tau$.
The use of thresholding has clear benefits from a theoretical point of view: the number of false positive selections may be much larger without thresholding (when tuned for good prediction). and a similar statement would hold when comparing the adaptive Lasso with the standard Lasso. We refer the interested reader to Zhou [2009, 2010b] and van de Geer et al. [2010].

Maximum likelihood estimation based on graphs. Given a conditional independence graph with edge set $E$, we estimate the concentration matrix by maximum likelihood. Denote by $\widehat{S}_{n}=$ $n^{-1} \sum_{r=1}^{n} X^{(r)}\left(X^{(r)}\right)^{T}$ the sample covariance matrix (using that the mean vector is zero) and by

the sample correlation matrix. The estimator for the concentration matrix in view of (1) is:

$$
\begin{align*}
& \widehat{\Theta}_{n}(E)=\operatorname{argmin}_{\Theta \in \mathcal{M}_{p, E}}\left(\operatorname{tr}\left(\Theta \widehat{\Gamma}_{n}\right)-\log |\Theta|\right), \text { where } \\
& \mathcal{M}_{p, E}=\left\{\Theta \in \mathbb{R}^{p \times p} ; \Theta \succ 0 \text { and } \theta_{i j}=0 \text { for all }(i, j) \notin E, \text { where } i \neq j\right\} \tag{14}
\end{align*}

defines the constrained set for positive definite $\Theta$. If $n \geq q^{*}$ where $q^{*}$ is the maximal clique size of a minimal chordal cover of the graph with edge set $E$, the MLE exists and is unique, see, for example Uhler [2011, Corollary 2.3]. We note that our theory guarantees that $n \geq q^{*}$ holds with high probability for $G=(V, E)$, where $E=\widehat{E}_{n}\left(\lambda_{n}, \tau\right)$ ), under Assumption (A1) to be introduced in the next section. The definition in (14) is slightly different from the more usual estimator which uses the sample covariance $\widehat{S}_{n}$ rather than $\widehat{\Gamma}_{n}$. Here, the sample correlation matrix reflects the fact that we typically work with standardized data where the variables have empirical variances equal to one. The estimator in (14) is constrained leading to zero-values corresponding to $E^{c}=\{(i, j): i, j=1, \ldots, p, i \neq j,(i, j) \notin E\}$.

If the edge set $E$ is sparse having relatively few edges only, the estimator in (14) is already sufficiently regularized by the constraints and hence, no additional penalization is used at this stage. Our final estimator for the concentration matrix is the combination of (12) and (14):

Choosing the regularization parameters. We propose to select the parameter $\lambda_{n}$ via crossvalidation to minimize the squared test set error among all $p$ regressions:

$$
\widehat{\lambda}_{n}=\operatorname{argmin}_{\lambda} \sum_{i=1}^{p}(\operatorname{CV}-\operatorname{score}(\lambda) \text { of } i \text { th regression })
$$

where CV-score ( $\lambda$ ) of $i$ th regression is with respect to the squared error prediction loss. Sequentially proceeding, we then select $\tau$ by cross-validating the multivariate Gaussian log-likelihood, from (14). Regarding the type of cross-validation, we usually use the 10 -fold scheme. Due to the sequential nature of choosing the regularization parameters, the number of candidate estimators is given by the number of candidate values for $\lambda$ plus the number of candidate value for $\tau$. In Section 4 , we describe the grids of candidate values in more details. We note that for our theoretical results, we do not analyze the implications of our method using estimated $\widehat{\lambda}_{n}$ and $\widehat{\tau}$.

## 3. Theoretical results

In this section, we present in Theorem 1 convergence rates for estimating the precision and the covariance matrices with respect to the Frobenius norm; in addition, we show a risk consistency result for an oracle risk to be defined in (17). Moreover, in Proposition 4, we show that the model we select is sufficiently sparse while at the same time, the bias term we introduce via sparse approximation is sufficiently bounded. These results illustrate the classical bias and variance tradeoff. Our analysis is non-asymptotic in nature; however, we first formulate our results from an asymptotic point of view for simplicity. To do so, we consider a triangular array of data generating random variables

where $\Sigma_{0}=\Sigma_{0, n}$ and $p=p_{n}$ change with $n$. Let $\Theta_{0}:=\Sigma_{0}^{-1}$. We make the following assumptions.
(A0) The size of the neighborhood for each node $i \in V$ is upper bounded by an integer $s<p$ and the sample size satisfies for some constant $C$

(A1) The dimension and number of sufficiently strong non-zero edges $S_{0, n}$ as in (8) satisfy: dimension $p$ grows with $n$ following $p=o\left(e^{c n}\right)$ for some constant $0<c<1$ and

S_{0, n}=o(n / \log \max (n, p))(n \rightarrow \infty)
$$

(A2) The minimal and maximal eigenvalues of the true covariance matrix $\Sigma_{0}$ are bounded: for some constants $M_{\text {upp }} \geq M_{\text {low }}>0$, we have

\varphi_{\min }\left(\Sigma_{0}\right) \geq M_{\mathrm{low}}>0 \text { and } \varphi_{\max }\left(\Sigma_{0}\right) \leq M_{\mathrm{upp}} \leq \infty
$$

Moreover, throughout our analysis, we assume the following. There exists $v^{2}>0$ such that for all $i$, and $V_{i}$ as defined in (3): $\operatorname{Var}\left(V_{i}\right)=1 / \theta_{0, i i} \geq v^{2}$.

Before we proceed, we need some definitions. Define for $\Theta \succ 0$

where minimizing (17) without constraints gives $\Theta_{0}$. Given (8), (7), and $\Theta_{0}$, define

C_{\mathrm{diag}}^{2}:=\min \left\{\max _{i=1, \ldots p} \theta_{0, i i}^{2}, \max _{i=1, \ldots, p}\left(s_{0, n}^{i} / S_{0, n}\right) \cdot\left\|\operatorname{diag}\left(\Theta_{0}\right)\right\|_{F}^{2}\right\} \tag{18}
\end{equation*}
$$

We now state the main results of this paper. We defer the specification on various tuning parameters, namely, $\lambda_{n}, \tau$ to Section 3.2, where we also provide an outline for Theorem 1.

Theorem 1 Consider data generating random variables as in (16) and assume that (A0), (A1), and (A2) hold. We assume $\Sigma_{0, i i}=1$ for all $i$. Then, with probability at least $1-d / p^{2}$, for some small constant $d>2$, we obtain under appropriately chosen $\lambda_{n}$ and $\tau$, an edge set $\widehat{E}_{n}$ as in (12), such that

$$
\begin{equation*}
\left|\widehat{E}_{n}\right| \leq 4 S_{0, n}, \text { where }\left|\widehat{E}_{n} \backslash E_{0}\right| \leq 2 S_{0, n} \tag{19}
\end{equation*}
$$

and for $\widehat{\Theta}_{n}$ and $\widehat{\Sigma}_{n}=\left(\widehat{\Theta}_{n}\right)^{-1}$ as defined in (15) the following holds,

$$
\begin{aligned}
\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{2} \leq\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{F} & =O_{P}\left(\sqrt{S_{0, n} \log \max (n, p) / n}\right) \\
\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{2} \leq\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F} & =O_{P}\left(\sqrt{S_{0, n} \log \max (n, p) / n}\right) \\
R\left(\widehat{\Theta}_{n}\right)-R\left(\Theta_{0}\right) & =O_{P}\left(S_{0, n} \log \max (n, p) / n\right)
\end{aligned}
$$

where the constants hidden in the $O_{P}()$ notation depend on $\tau, M_{\text {low }}, M_{\text {upp }}, C_{\text {diag }}$ as in (18), and constants concerning sparse and restrictive eigenvalues of $\Sigma_{0}$ (cf. Section 3.2 and B).

We note that convergence rates for the estimated covariance matrix and for predictive risk depend on the rate in Frobenius norm of the estimated inverse covariance matrix. The predictive risk can be interpreted as follows. Let $X \sim \mathcal{N}\left(0, \Sigma_{0}\right)$ with $f_{\Sigma_{0}}$ denoting its density. Let $f_{\widehat{\Sigma}_{n}}$ be the density for $\mathcal{N}\left(0, \widehat{\Sigma}_{n}\right)$ and $D_{\mathrm{KL}}\left(\Sigma_{0} \| \widehat{\Sigma}_{n}\right)$ denotes the Kullback Leibler (KL) divergence from $\mathcal{N}\left(0, \Sigma_{0}\right)$ to $\mathcal{N}\left(0, \widehat{\Sigma}_{n}\right)$. Now, we have for $\Sigma, \widehat{\Sigma}_{n} \succ 0$,

$$
\begin{equation*}
R\left(\widehat{\Theta}_{n}\right)-R\left(\Theta_{0}\right):=2 \mathbf{E}_{0}\left[\log f_{\Sigma_{0}}(X)-\log f_{\widehat{\Sigma}_{n}}(X)\right]:=2 D_{\mathrm{KL}}\left(\Sigma_{0} \| \widehat{\Sigma}_{n}\right) \geq 0 \tag{20}
\end{equation*}
$$

Actual conditions and non-asymptotic results that are involved in the Gelato estimation appear in Sections B, C, and D respectively.

Remark 2 Implicitly in (A1), we have specified a lower bound on the sample size to be $n=$ $\Omega\left(S_{0, n} \log \max (n, p)\right)$. For the interesting case of $p>n$, a sample size of

$$
\begin{equation*}
n=\Omega\left(\max \left(S_{0, n} \log p, s \log (p / s)\right)\right) \tag{21}
\end{equation*}
$$

is sufficient in order to achieve the rates in Theorem 1. As to be shown in our analysis, the lower bound on $n$ is slightly different for each Frobenius norm bound to hold from a non-asymptotic point of view (cf. Theorem 19 and 20).

Theorem 1 can be interpreted as follows. First, the cardinality of the estimated edge set exceeds $S_{0, n}$ at most by a factor 4 , where $S_{0, n}$ as in (8) is the number of sufficiently strong edges in the model, while the number of false positives is bounded by $2 S_{0, n}$. Note that the factors 4 and 2 can be replaced by some other constants, while achieving the same bounds on the rates of convergence (cf. Section D.1). We emphasize that we achieve these two goals by sparse model selection, where only important edges are selected even though there are many more non-zero edges in $E_{0}$, under conditions that are much weaker than (A2). More precisely, (A2) can be replaced by conditions on sparse and restrictive eigenvalues (RE) of $\Sigma_{0}$. Moreover, the bounded neighborhood constraint
(A0) is required only for regression analysis (cf. Theorem 15) and for bounding the bias due to sparse approximation as in Proposition 4. This is shown in Sections B and C. Analysis follows from Zhou [2009, 2010b] with earlier references to Bickel et al. [2009]; Candès and Tao [2007]; Meinshausen and Yu [2009] for estimating sparse regression coefficients.

We note that the conditions that we use are indeed similar to those in Rothman et al. [2008], with (A1) being much more relaxed when $S_{0, n} \ll\left|E_{0}\right|$. The convergence rate with respect to the Frobenius norm should be compared to the rate $O_{P}\left(\sqrt{\left|E_{0}\right| \log \max (n, p) / n}\right)$ in case $\operatorname{diag}\left(\Sigma_{0}\right)$ is known, which is the rate in Rothman et al. [2008] for the GLasso and for SCAD [Lam and Fan, 2009]. In the scenario where $\left|E_{0}\right| \gg S_{0, n}$, i.e. there are many weak edges, the rate in Theorem 1 is better than the one established for GLasso [Rothman et al., 2008] or for the SCAD-type estimator [Lam and Fan, 2009]; hence we require a smaller sample size in order to yield an accurate estimate of $\Theta_{0}$.

Remark 3 For the general case where $\Sigma_{0, i i}, i=1, \ldots, p$ are not assumed to be known, we could achieve essentially the same rate as stated in Theorem 1 for $\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{2}$ and $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{2}$ under $\left(A_{0}\right),\left(A_{1}\right)$ and $\left(A_{2}\right)$ following analysis in the present work (cf. Theorem 6) and that in Rothman et al. [2008, Theorem 2]. Presenting full details for such results are beyond the scope of the current paper. We do provide the key technical lemma which is essential for showing such bounds based on estimating the inverse of the correlation matrix in Theorem 6; see also Remark 7 which immediately follows.

In this case, for the Frobenius norm and the risk to converge to zero, a too large value of $p$ is not allowed. Indeed, for the Frobenius norm and the risk to converge, $(A 1)$ is to be replaced by:

p \asymp n^{c} \text { for some constant } 0<c<1 \text { and } p+S_{0, n}=o(n / \log \max (n, p)) \text { as } n \rightarrow \infty \tag{A3}
\end{equation*}
$$

In this case, we have

$$
\begin{aligned}
\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{F} & =O_{P}\left(\sqrt{\left(p+S_{0, n}\right) \log \max (n, p) / n}\right) \\
\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F} & =O_{P}\left(\sqrt{\left(p+S_{0, n}\right) \log \max (n, p) / n}\right) \\
R\left(\widehat{\Theta}_{n}\right)-R\left(\Theta_{0}\right) & =O_{P}\left(\left(p+S_{0, n}\right) \log \max (n, p) / n\right)
\end{aligned}
$$

Moreover, in the refitting stage, we could achieve these rates with the maximum likelihood estimator based on the sample covariance matrix $\widehat{S}_{n}$ as defined in (22):

$$
\begin{align*}
& \widehat{\Theta}_{n}(E)=\operatorname{argmin}_{\Theta \in \mathcal{M}_{p, E}}\left(\operatorname{tr}\left(\Theta \widehat{S}_{n}\right)-\log |\Theta|\right), \text { where } \\
& \mathcal{M}_{p, E}=\left\{\Theta \in \mathbb{R}^{p \times p} ; \Theta \succ 0 \text { and } \theta_{i j}=0 \text { for all }(i, j) \notin E, \text { where } i \neq j\right\} \tag{22}
\end{align*}
$$

A real high-dimensional scenario where $p \gg n$ is excluded in order to achieve Frobenius norm consistency. This restriction comes from the nature of the Frobenius norm and when considering e.g. the operator norm, such restrictions can indeed be relaxed as stated above.

It is also of interest to understand the bias of the estimator caused by using the estimated edge set $\widehat{E}_{n}$ instead of the true edge set $E_{0}$. This is the content of Proposition 4. For a given $\widehat{E}_{n}$, denote by

$$
\widetilde{\Theta}_{0}=\operatorname{diag}\left(\Theta_{0}\right)+\left(\Theta_{0}\right)_{\widehat{E}_{n}}=\operatorname{diag}\left(\Theta_{0}\right)+\Theta_{0, \widehat{E}_{n} \cap E_{0}}
$$

where the second equality holds since $\Theta_{0, E_{0}^{c}}=0$. Note that the quantity $\widetilde{\Theta}_{0}$ is identical to $\Theta_{0}$ on $\widehat{E}_{n}$ and on the diagonal, and it equals zero on $\widehat{E}_{n}^{c}=\left\{(i, j): i, j=1, \ldots, p, i \neq j,(i, j) \notin \widehat{E}_{n}\right\}$. Hence, the quantity $\Theta_{0, \mathcal{D}}:=\widetilde{\Theta}_{0}-\Theta_{0}$ measures the bias caused by a potentially wrong edge set $\widehat{E}_{n}$; note that $\widetilde{\Theta}_{0}=\Theta_{0}$ if $\widehat{E}_{n}=E_{0}$.

Proposition 4 Consider data generating random variables as in expression (16). Assume that (A0), (A1), and (A2) hold. Then we have for choices on $\lambda_{n}, \tau$ as in Theorem 1 and $\widehat{E}_{n}$ in (12),

$$
\left\|\Theta_{0, \mathcal{D}}\right\|_{F}:=\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{F}=O_{P}\left(\sqrt{S_{0, n} \log \max (n, p) / n}\right)
$$

We note that we achieve essentially the same rate for $\left\|\left(\widetilde{\Theta}_{0}\right)^{-1}-\Sigma_{0}\right\|_{F}$; see Remark 27 . We give an account on how results in Proposition 4 are obtained in Section 3.2, with its non-asymptotic statement appearing in Corollary 17.

### 3.1 Discussions and connections to previous work

It is worth mentioning that consistency in terms of operator and Frobenius norms does not depend too strongly on the property to recover the true underlying edge set $E_{0}$ in the refitting stage. Regarding the latter, suppose we obtain with high probability the screening property

$$
\begin{equation*}
E_{0} \subseteq E \tag{23}
\end{equation*}
$$

when assuming that all non-zero regression coefficients $\left|\beta_{j}^{i}\right|$ are sufficiently large ( $E$ might be an estimate and hence random). Although we do not intend to make precise the exact conditions and choices of tuning parameters in regression and thresholding in order to achieve (23), we state Theorem 5, in case (23) holds with the following condition: the number of false positives is bounded as $\left|E \backslash E_{0}\right|=O(S)$.

Theorem 5 Consider data generating random variables as in expression (16) and assume that (A1) and (A2) hold, where we replace $S_{0, n}$ with $S:=\left|E_{0}\right|=\sum_{i=1}^{p} s^{i}$. We assume $\Sigma_{0, i i}=1$ for all $i$. Suppose on some event $\mathcal{E}$, such that $\mathbb{P}(\mathcal{E}) \geq 1-d / p^{2}$ for a small constant $d$, we obtain an edge set $E$ such that $E_{0} \subseteq E$ and $\left|E \backslash E_{0}\right|=O(S)$. Let $\widehat{\Theta}_{n}(E)$ be the minimizer as defined in (14). Then, we have $\left\|\widehat{\Theta}_{n}(E)-\Theta_{0}\right\|_{F}=O_{P}(\sqrt{S \log \max (n, p) / n})$.

It is clear that this bound corresponds to exactly that of Rothman et al. [2008] for the GLasso estimation under appropriate choice of the penalty parameter for a general $\Sigma \succ 0$ with $\Sigma_{i i}=1$ for all $i$ (cf. Remark 3). We omit the proof as it is more or less a modified version of Theorem 19, which proves the stronger bounds as stated in Theorem 1 . We note that the maximum node-degree bound in (A0) is not needed for Theorem 5.

We now make some connections to previous work. First, we note that to obtain with high probability the exact edge recovery, $E=E_{0}$, we need again sufficiently large non-zero edge weights and some restricted eigenvalue (RE) conditions on the covariance matrix as defined in Section A even for the multi-stage procedure. An earlier example is shown in Zhou et al. [2009], where the second stage estimator $\widehat{\beta}$ corresponding to (11) is obtained with nodewise regressions using adaptive Lasso [Zou, 2006] rather than thresholding as in the present work in order to recover the edge set $E_{0}$ with high probability under an assumption which is stronger than (A0). Clearly, given an accurate $\widehat{E}_{n}$, under (A1) and (A2) one can then apply Theorem 5 to accurately estimate $\widehat{\Theta}_{n}$. On the other hand, it is known that GLasso necessarily needs more restrictive conditions on $\Sigma_{0}$ than the nodewise regression approach with the Lasso, as discussed in Meinshausen [2008] and Ravikumar et al. [2008] in order to achieve exact edge recovery.

Furthermore, we believe it is straightforward to show that Gelato works under the RE conditions on $\Sigma_{0}$ and with a smaller sample size than the analogue without the thresholding operation in order to achieve nearly exact recovery of the support in the sense that $E_{0} \subseteq \widehat{E}_{n}$ and $\max _{i} \mid \widehat{E}_{n, i} \backslash$ $E_{0, i} \mid$ is small, that is, the number of extra estimated edges at each node $i$ is bounded by a small constant. This is shown essentially in Zhou [2009, Theorem1.1] for a single regression. Given such properties of $\widehat{E}_{n}$, we can again apply Theorem 5 to obtain $\widehat{\Theta}_{n}$ under (A1) and (A2). Therefore, Gelato requires relatively weak assumptions on $\Sigma_{0}$ in order to achieve the best sparsity and bias tradeoff as illustrated in Theorem 1 and Proposition 4 when many signals are weak, and Theorem 5 when all signals in $E_{0}$ are strong.

### 3.2 An outline for Theorem 1

Let $s_{0}=\max _{i=1, \ldots, p} s_{0, n}^{i}$. We note that although sparse eigenvalues $\rho_{\max }(s), \rho_{\max }\left(3 s_{0}\right)$ and restricted eigenvalue for $\Sigma_{0}$ (cf. Section A) are parameters that are unknown, we only need them to appear in the lower bounds for $d_{0}, D_{4}$, and hence also that for $\lambda_{n}$ and $t_{0}$ that appear below. We simplify our notation in this section to keep it consistent with our theoretical non-asymptotic analysis to appear toward the end of this paper.
Regression. We choose for some $c_{0} \geq 4 \sqrt{2}, 0<\theta<1$, and $\lambda=\sqrt{\log (p) / n}$,

$$
\lambda_{n}=d_{0} \lambda, \text { where } d_{0} \geq c_{0}(1+\theta)^{2} \sqrt{\rho_{\max }(s) \rho_{\max }\left(3 s_{0}\right)}
$$

Let $\beta_{\text {init }}^{i}, i=1, \ldots, p$ be the optimal solutions to (10) with $\lambda_{n}$ as chosen above. We first prove an oracle result on nodewise regressions in Theorem 15.

Thresholding. We choose for some constants $D_{1}, D_{4}$ to be defined in Theorem 15,

$$
t_{0}=f_{0} \lambda:=D_{4} d_{0} \lambda \quad \text { where } D_{4} \geq D_{1}
$$

where $D_{1}$ depends on restrictive eigenvalue of $\Sigma_{0}$; Apply (11) with $\tau=t_{0}$ and $\beta_{\text {init }}^{i}, i=1, \ldots, p$ for thresholding our initial regression coefficients. Let

$$
\mathcal{D}^{i}=\left\{j: j \neq i,\left|\beta_{j, \text { init }}^{i}\right|<t_{0}=f_{0} \lambda\right\},
$$

where bounds on $\mathcal{D}^{i}, i=1, \ldots, p$ are given in Lemma 16. In view of (9), we let

$$
\begin{equation*}
\mathcal{D}=\left\{(i, j): i \neq j:(i, j) \in \mathcal{D}^{i} \cap \mathcal{D}^{j}\right\} \tag{24}
\end{equation*}
$$

Selecting edge set $E$. Recall for a pair $(i, j)$ we take the $O R$ rule as in (9) to decide if it is to be included in the edge set $E$ : for $\mathcal{D}$ as defined in (24), define

$$
\begin{equation*}
E:=\{(i, j): i, j=1, \ldots, p, i \neq j,(i, j) \notin \mathcal{D}\} . \tag{25}
\end{equation*}
$$

to be the subset of pairs of non-identical vertices of $G$ which do not appear in $\mathcal{D}$; Let

$$
\begin{equation*}
\widetilde{\Theta}_{0}=\operatorname{diag}\left(\Theta_{0}\right)+\Theta_{0, E_{0} \cap E} \tag{26}
\end{equation*}
$$

for $E$ as in (25), which is identical to $\Theta_{0}$ on all diagonal entries and entries indexed by $E_{0} \cap E$, with the rest being set to zero. As shown in the proof of Corollary 17, by thresholding, we have identified a sparse subset of edges $E$ of size at most $4 S_{0, n}$, such that the corresponding bias $\left\|\Theta_{0, \mathcal{D}}\right\|_{F}:=\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{F}$ is relatively small, i.e., as bounded in Proposition 4.

Refitting. In view of Proposition 4, we aim to recover $\widetilde{\Theta}_{0}$ given a sparse subset $E$; toward this goal, we use (14) to obtain the final estimator $\widehat{\Theta}_{n}$ and $\widehat{\Sigma}_{n}=\left(\widehat{\Theta}_{n}\right)^{-1}$. We give a more detailed account of this procedure in Section D, with a focus on elaborating the bias and variance tradeoff. We show the rate of convergence in Frobenius norm for the estimated $\widehat{\Theta}_{n}$ and $\widehat{\Sigma}_{n}$ in Theorem 6, 19 and 20, and the bound for Kullback Leibler divergence in Theorem 21 respectively.

### 3.3 Discussion on covariance estimation based on maximum likelihood

The maximum likelihood estimate minimizes over all $\Theta \succ 0$,

$$
\begin{equation*}
\widehat{R}_{n}(\Theta)=\operatorname{tr}\left(\Theta \widehat{S}_{n}\right)-\log |\Theta| \tag{27}
\end{equation*}
$$

where $\widehat{S}_{n}$ is the sample covariance matrix. Minimizing $\widehat{R}_{n}(\Theta)$ without constraints gives $\widehat{\Sigma}_{n}=\widehat{S}_{n}$. We now would like to minimize (27) under the constraints that some pre-defined subset $\mathcal{D}$ of edges are set to zero. Then the follow relationships hold regarding $\widehat{\Theta}_{n}(E)$ defined in (22) and its inverse $\widehat{\Sigma}_{n}$, and $\widehat{S}_{n}$ : for $E$ as defined in (25),

$$
\begin{aligned}
\widehat{\Theta}_{n, i j} & =0, \forall(i, j) \in \mathcal{D} \text { and } \\
\widehat{\Sigma}_{n, i j} & =\widehat{S}_{n, i j}, \forall(i, j) \in E \cup\{(i, i), i=1, \ldots, p\} .
\end{aligned}
$$

Hence the entries in the covariance matrix $\widehat{\Sigma}_{n}$ for the chosen set of edges in $E$ and the diagonal entries are set to their corresponding values in $\widehat{S}_{n}$. Indeed, we can derive the above relationships via the Lagrange form, where we add Lagrange constants $\gamma_{j k}$ for edges in $\mathcal{D}$,

$$
\begin{equation*}
\ell_{C}(\Theta)=\log |\Theta|-\operatorname{tr}\left(\widehat{S}_{n} \Theta\right)-\sum_{(j, k) \in \mathcal{D}} \gamma_{j k} \theta_{j k} \tag{28}
\end{equation*}
$$

Now the gradient equation of (28) is:

$$
\Theta^{-1}-\widehat{S}_{n}-\Gamma=0,
$$

where $\Gamma$ is a matrix of Lagrange parameters such that $\gamma_{j k} \neq 0$ for all $(j, k) \in \mathcal{D}$ and $\gamma_{j k}=0$ otherwise.

Similarly, the follow relationships hold regarding $\widehat{\Theta}_{n}(E)$ defined in (14) in case $\Sigma_{0, i i}=1$ for all $i$, where $\widehat{S}_{n}$ is replaced with $\widehat{\Gamma}_{n}$, and its inverse $\widehat{\Sigma}_{n}$, and $\widehat{\Gamma}_{n}$ : for $E$ as defined in (25),

$$
\begin{aligned}
\widehat{\Theta}_{n, i j} & =0, \forall(i, j) \in \mathcal{D} \text { and } \\
\widehat{\Sigma}_{n, i j} & =\widehat{\Gamma}_{n, i j}=\widehat{S}_{n, i j} / \widehat{\sigma}_{i} \widehat{\sigma}_{j}, \forall(i, j) \in E \text { and } \\
\widehat{\Sigma}_{n, i i} & =1, \forall i=1, \ldots, p
\end{aligned}
$$

Finally, we state Theorem 6, which yields a general bound on estimating the inverse of the correlation matrix, when $\Sigma_{0,11}, \ldots, \Sigma_{0, p p}$ take arbitrary unknown values in $\mathbb{R}^{+}=(0, \infty)$. The corresponding estimator is based on estimating the inverse of the correlation matrix, which we denote by $\Omega_{0}$. We use the following notations. Let $\Psi_{0}=\left(\rho_{0, i j}\right)$ be the true correlation matrix and let $\Omega_{0}=\Psi_{0}^{-1}$. Let $W=\operatorname{diag}\left(\Sigma_{0}\right)^{1 / 2}$. Let us denote the diagonal entries of $W$ with $\sigma_{1}, \ldots, \sigma_{p}$ where $\sigma_{i}:=\Sigma_{0, i i}^{1 / 2}$ for all $i$. Then the following holds:

$$
\Sigma_{0}=W \Psi_{0} W \text { and } \Theta_{0}=W^{-1} \Omega_{0} W^{-1}
$$

Given sample covariance matrix $\widehat{S}_{n}$, we construct sample correlation matrix $\widehat{\Gamma}_{n}$ as follows. Let $\widehat{W}=\operatorname{diag}\left(\widehat{S}_{n}\right)^{1 / 2}$ and

$$
\begin{equation*}
\widehat{\Gamma}_{n}=\widehat{W}^{-1}\left(\widehat{S}_{n}\right) \widehat{W}^{-1}, \text { where } \widehat{\Gamma}_{n, i j}=\frac{\widehat{S}_{n, i j}}{\widehat{\sigma}_{i} \widehat{\sigma}_{j}}=\frac{\left\langle X_{i}, X_{j}\right\rangle}{\left\|X_{i}\right\|_{2}\left\|X_{j}\right\|_{2}} \tag{29}
\end{equation*}
$$

where $\widehat{\sigma}_{i}^{2}:=\widehat{S}_{n, i i}$. Thus $\widehat{\Gamma}_{n}$ is a matrix with diagonal entries being all 1 s and non-diagonal entries being the sample correlation coefficients, which we denote by $\widehat{\rho}_{i j}$.

The maximum likelihood estimate for $\Omega_{0}=\Psi_{0}^{-1}$ minimizes over all $\Omega \succ 0$,

$$
\begin{equation*}
\widehat{R}_{n}(\Omega)=\operatorname{tr}\left(\Omega \widehat{\Gamma}_{n}\right)-\log |\Omega| \tag{30}
\end{equation*}
$$

To facilitate technical discussions, we need to introduce some more notation. Let $\mathcal{S}_{++}^{p}$ denote the set of $p \times p$ symmetric positive definite matrices:

$$
\mathcal{S}_{++}^{p}=\left\{\Theta \in \mathbb{R}^{p \times p} \mid \Theta \succ 0\right\} .
$$

Let us define a subspace $\mathcal{S}_{E}^{p}$ corresponding to an edge set $E \subset\{(i, j): i, j=1, \ldots, p, i \neq j\}$ :

Minimizing $\widehat{R}_{n}(\Theta)$ without constraints gives $\widehat{\Psi}_{n}=\widehat{\Gamma}_{n}$. Subject to the constraints that $\Omega \in \mathcal{S}_{n}$ as defined in (31), we write the maximum likelihood estimate for $\Omega_{0}$ :

which yields the following relationships regarding $\widehat{\Omega}_{n}(E)$, its inverse $\widehat{\Psi}_{n}=\left(\widehat{\Omega}_{n}(E)\right)^{-1}$, and $\widehat{\Gamma}_{n}$. For $E$ as defined in (25),

\begin{aligned}
\widehat{\Omega}_{n, i j} & =0, \forall(i, j) \in \mathcal{D} \\
\widehat{\Psi}_{n, i j} & =\widehat{\Gamma}_{n, i j}:=\widehat{\rho}_{i j} \quad \forall(i, j) \in E \\
\text { and } \quad \widehat{\Psi}_{n, i i} & =1 \quad \forall i=1, \ldots, p .
\end{aligned}
$$

Given $\widehat{\Omega}_{n}(E)$ and its inverse $\widehat{\Psi}_{n}=\left(\widehat{\Omega}_{n}(E)\right)^{-1}$, we obtain

\widehat{\Sigma}_{n}=\widehat{W} \widehat{\Psi}_{n} \widehat{W} \text { and } \widehat{\Theta}_{n}=\widehat{W}^{-1} \widehat{\Omega}_{n} \widehat{W}^{-1}

and therefore the following holds: for $E$ as defined in (25),

\widehat{\Sigma}_{n, i j} & =\widehat{\sigma}_{i} \widehat{\sigma}_{j} \widehat{\Psi}_{n, i j}=\widehat{\sigma}_{i} \widehat{\sigma}_{j} \widehat{\Gamma}_{n, i j}=\widehat{S}_{n, i j} \quad \forall(i, j) \in E \\
\text { and } \quad \widehat{\Psi}_{n, i i} & =\widehat{\sigma}_{i}^{2}=\widehat{S}_{n, i i} \quad \forall i=1, \ldots, p
\end{aligned}
$$

The proof of Theorem 6 appears in Section E.
Theorem 6 Consider data generating random variables as in expression (16) and assume that (A1) and (A2) hold. Let $\sigma_{\max }^{2}:=\max _{i} \Sigma_{0, i i}<\infty$ and $\sigma_{\min }^{2}:=\min _{i} \Sigma_{0, i i}>0$. Let $\mathcal{E}$ be some event such that $\mathbb{P}(\mathcal{E}) \geq 1-d / p^{2}$ for a small constant d. Let $S_{0, n}$ be as defined in (8). Suppose on event $\mathcal{E}$ :

1. We obtain an edge set $E$ such that its size $|E|=\operatorname{lin}\left(S_{0, n}\right)$ is a linear function in $S_{0, n}$.
2. And for $\widetilde{\Theta}_{0}$ as in (26) and for some constant $C_{\text {bias }}$ to be specified in (71), we have

Let $\widehat{\Omega}_{n}(E)$ be as defined in (32) Suppose the sample size satisfies for $C_{3} \geq 4 \sqrt{5 / 3}$,

Then with probability $\geq 1-(d+1) / p^{2}$, we have for $M=\left(9 \sigma_{\max }^{4} /\left(2 \underline{k}^{2}\right)\right) \cdot\left(4 C_{3}+13 M_{\mathrm{upp}} /\left(12 \sigma_{\min }^{2}\right)\right)$

$$
\begin{equation*}
\left\|\widehat{\Omega}_{n}(E)-\Omega_{0}\right\|_{F} \leq(M+1) \max \left\{\sqrt{2|E| \log \max (n, p) / n}, C_{\text {bias }} \sqrt{2 S_{0, n} \log (p) / n}\right\} \tag{35}
\end{equation*}

Remark 7 We note that the constants in Theorem 6 are by no means the best possible. From (35), we can derive bounds on $\left\|\widehat{\Theta}_{n}(E)-\Theta_{0}\right\|_{2}$ and $\left\|\widehat{\Sigma}_{n}(E)-\Sigma_{0}\right\|_{2}$ to be in the same order as in (35) following the analysis in Rothman et al. [2008, Theorem 2]. The corresponding bounds on the Frobenius norms on covariance estimation would be in the order of $O_{P}\left(\sqrt{\frac{p+S_{0}}{n}}\right)$ as stated in Remark 3.

## 4. Numerical results

We consider the empirical performance for simulated and real data. We compare our estimation method with the GLasso, the Space method and a simplified Gelato estimator without thresholding for inferring the conditional independence graph. The comparison with the latter should yield some evidence about the role of thresholding in Gelato. The GLasso is defined as:

\widehat{\Theta}_{\mathrm{GLasso}}=\underset{\Theta \succ 0}{\operatorname{argmin}}\left(\operatorname{tr}\left(\widehat{\Gamma}_{n} \Theta\right)-\log |\Theta|+\rho \sum_{i<j}\left|\theta_{i j}\right|\right)
$$

where $\widehat{\Gamma}_{n}$ is the empirical correlation matrix and the minimization is over positive definite matrices. Sparse partial correlation estimation (Space) is an approach for selecting non-zero partial correlations in the high-dimensional framework. The method assumes an overall sparsity of the partial correlation matrix and employs sparse regression techniques for model fitting. For details see Peng et al. [2009]. We use Space with weights all equal to one, which refers to the method type space in Peng et al. [2009]. For the Space method, estimation of $\Theta_{0}$ is done via maximum likelihood as in (14) based on the edge set $\widehat{E}_{n}^{(S \text { Pace })}$ from the estimated sparse partial correlation matrix. For computation of the three different methods, we used the R-packages glmnet [Friedman et al., 2010], glasso [Friedman et al., 2007] and space [Peng et al., 2009].

### 4.1 Simulation study

In our simulation study, we look at three different models.

- An $\operatorname{AR}(1)$-Block model. In this model the covariance matrix is block-diagonal with equalsized $\operatorname{AR}(1)$-blocks of the form $\Sigma_{\text {Block }}=\left\{0.9^{|i-j|}\right\}_{i, j}$.
- The random concentration matrix model considered in Rothman et al. [2008]. In this model, the concentration matrix is $\Theta=B+\delta I$ where each off-diagonal entry in $B$ is generated independently and equal to 0 or 0.5 with probability $1-\pi$ or $\pi$, respectively. All diagonal entries of $B$ are zero, and $\delta$ is chosen such that the condition number of $\Theta$ is $p$.
- The exponential decay model considered in Fan et al. [2009]. In this model we consider a case where no element of the concentration matrix is exactly zero. The elements of $\Theta_{0}$ are given by $\theta_{0, i j}=\exp (-2|i-j|)$ equals essentially zero when the difference $|i-j|$ is large.

We compare the three estimators for each model with $p=300$ and $n=40,80,320$. For each model we sample data $X^{(1)}, \ldots, X^{(n)}$ i.i.d. $\sim \mathcal{N}\left(0, \Sigma_{0}\right)$. We use two different performance measures. The Frobenius norm of the estimation error $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F}$ and $\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{F}$, and the Kullback Leibler divergence between $\mathcal{N}\left(0, \Sigma_{0}\right)$ and $\mathcal{N}\left(0, \widehat{\Sigma}_{n}\right)$ as defined in (20).

For the three estimation methods we have various tuning parameters, namely $\lambda, \tau$ (for Gelato), $\rho$ (for GLasso) and $\eta$ (for Space). We denote the regularization parameter of the Space technique by $\eta$ in contrary to Peng et al. [2009], in order to distinguish it from the other parameters. Due to the computational complexity we specify the two parameters of our Gelato method sequentially.

That is, we derive the optimal value of the penalty parameter $\lambda$ by 10 -fold cross-validation with respect to the test set squared error for all the nodewise regressions. After fixing $\lambda=\lambda_{C V}$ we obtain the optimal threshold $\tau$ again by 10 -fold cross-validation but with respect to the negative Gaussian log-likelihood $\left(\operatorname{tr}\left(\widehat{\Theta} \widehat{S}^{\text {out }}\right)-\log |\widehat{\Theta}|\right.$, where $\widehat{S}^{\text {out }}$ is the empirical covariance of the holdout data). We could use individual tuning parameters for each of the regressions. However, this turned out to be sub-optimal in some simulation scenarios (and never really better than using a single tuning parameter $\lambda$, at least in the scenarios we considered). For the penalty parameter $\rho$ of the GLasso estimator and the parameter $\eta$ of the Space method we also use a 10 -fold crossvalidation with respect to the negative Gaussian log-likelihood. The grids of candidate values are given as follows:

& \eta_{r}=1.56 \sqrt{n} \Phi^{-1}\left(1-\frac{D_{r}}{2 p^{2}}\right) \quad r=1, \ldots, 7
\end{aligned}
$$

where $A_{k}, B_{k}, C_{k} \in\{0.01,0.05,0.1,0.3,0.5,1,2,4,8,16\}$ and $D_{r} \in\{0.01,0.05,0.075,0.1,0.2$, $0.5,1\}$. The two different performance measures are evaluated for the estimators based on the sample $X^{(1)}, \ldots, X^{(n)}$ with optimal CV-estimated tuning parameters $\lambda, \tau, \rho$ and $\eta$ for each model from above. All results are based on 50 independent simulation runs.

### 4.1.1 THE AR(1)-BLOCK MODEL

We consider two different covariance matrices. The first one is a simple auto-regressive process of order one with trivial block size equal to $p=300$, denoted by $\Sigma_{0}^{(1)}$. This is also known as a Toeplitz matrix. That is, we have $\Sigma_{0 ; i, j}^{(1)}=0.9^{|i-j|} \forall i, j \in\{1, \ldots, p\}$. The second matrix $\Sigma_{0}^{(2)}$ is a block-diagonal matrix with $\operatorname{AR}(1)$ blocks of equal block size $30 \times 30$, and hence the blockdiagonal of $\Sigma_{0}^{(2)}$ equals $\Sigma_{B l o c k ; i, j}=0.9^{|i-j|}, i, j \in\{1, \ldots, 30\}$. The simulation results for the AR(1)-block models are shown in Figure 1 and 2.

The figures show a substantial performance gain of our method compared to the GLasso in both considered covariance models. This result speaks for our method, especially because AR(1)block models are very simple. The Space method performs about as well as Gelato, except for the Frobenius norm of $\widehat{\Sigma}_{n}-\Sigma_{0}$. There we see an performance advantage of the Space method compared to Gelato. We also exploit the clear advantage of thresholding in Gelato for a small sample size.

### 4.1.2 THE RANDOM PRECISION MATRIX MODEL

For this model we also consider two different matrices, which differ in sparsity. For the sparser matrix $\Theta_{0}^{(3)}$ we set the probability $\pi$ to 0.1 . That is, we have an off diagonal entry in $\Theta^{(3)}$ of 0.5

with probability $\pi=0.1$ and an entry of 0 with probability 0.9 . In the case of the second matrix $\Theta_{0}^{(4)}$ we set $\pi$ to 0.5 which provides us with a denser concentration matrix. The simulation results for the two performance measures are given in Figure 3 and 4.
From Figures 3 and 4 we see that GLasso performs better than Gelato with respect to $\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{F}$ and the Kullback Leibler divergence in both the sparse and the dense simulation setting. If we consider $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F}$, Gelato seems to keep up with GLasso to some degree. For the Space method we have a similar situation to the one with GLasso. The Space method outperforms Gelato for $\left\|\widehat{\Theta}_{n}-\Theta_{0}\right\|_{F}$ and $D_{\mathrm{KL}}\left(\Sigma_{0} \| \widehat{\Sigma}_{n}\right)$ but for $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F}$, Gelato somewhat keeps up with Space.

### 4.1.3 The exponential decay model

In this simulation setting we only have one version of the concentration matrix $\Theta_{0}^{(5)}$. The entries of $\Theta_{0}^{(5)}$ are generated by $\theta_{0, i j}^{(5)}=\exp (-2|i-j|)$. Thus, $\Sigma_{0}$ is a banded and sparse matrix.

Figure 5 shows the results of the simulation. We find that all three methods show equal performances in both the Frobenius norm and the Kullback Leibler divergence. This is interesting because even with a sparse approximation of $\Theta_{0}$ (with GLasso or Gelato), we obtain competitive performance for (inverse) covariance estimation.

### 4.1.4 SUMMARY

Overall we can say that the performance of the methods depend on the model. For the models $\Sigma_{0}^{(1)}$ and $\Sigma_{0}^{(2)}$ the Gelato method performs best. In case of the models $\Theta_{0}^{(3)}$ and $\Theta_{0}^{(4)}$, Gelato gets outperformed by GLasso and the Space method and for the model $\Theta_{0}^{(5)}$ none of the three methods has a clear advantage. In Figures 1 to 4 , we see the advantage of Gelato with thresholding over the one without thresholding, in particular, for the simulation settings $\Sigma_{0}^{(1)}, \Sigma_{0}^{(2)}$ and $\Theta_{0}^{(3)}$. Thus thresholding is a useful feature of Gelato.

### 4.2 Application to real data

### 4.2.1 ISOPRENOID GENE PATHWAY IN ARABIDOBSIS THALIANA

In this example we compare the two estimators on the isoprenoid biosynthesis pathway data given in Wille et al. [2004]. Isoprenoids play various roles in plant and animal physiological processes and as intermediates in the biological synthesis of other important molecules. In plants they serve numerous biochemical functions in processes such as photosynthesis, regulation of growth and development.
The data set consists of $p=39$ isoprenoid genes for which we have $n=118$ gene expression patterns under various experimental conditions. In order to compare the two techniques we compute the negative log-likelihood via 10 -fold cross-validation for different values of $\lambda, \tau$ and

$\rho$. In Figure 6 we plot the cross-validated negative log-likelihood against the logarithm of the average number of non-zero entries (logarithm of the $\ell_{0}$-norm) of the estimated concentration matrix $\widehat{\Theta}_{n}$. The logarithm of the $\ell_{0}$-norm reflects the sparsity of the matrix $\widehat{\Theta}_{n}$ and therefore the figures show the performance of the estimators for different levels of sparsity. The plots do not allow for a clear conclusion. The GLasso performs slightly better when allowing for a rather dense fit. On the other hand, when requiring a sparse fit, the Gelato performs better.

### 4.2.2 Clinical status of human breast cancer

As a second example, we compare the two methods on the breast cancer dataset from West et al. [2001]. The tumor samples were selected from the Duke Breast Cancer SPORE tissue bank. The data consists of $p=7129$ genes with $n=49$ breast tumor samples. For the analysis we use the 100 variables with the largest sample variance. As before, we compute the negative log-likelihood via 10 -fold cross-validation. Figure 6 shows the results. In this real data example the interpretation of the plots is similar as for the arabidopsis dataset. For dense fits, GLasso is better while Gelato has an advantage when requiring a sparse fit.

## 5. Conclusions

We propose and analyze the Gelato estimator. Its advantage is that it automatically yields a positive definite covariance matrix $\widehat{\Sigma}_{n}$, it enjoys fast convergence rate with respect to the operator and Frobenius norm of $\widehat{\Sigma}_{n}-\Sigma_{0}$ and $\widehat{\Theta}_{n}-\Theta_{0}$. For estimation of $\Theta_{0}$, Gelato has in some settings a

better rate of convergence than the GLasso or SCAD type estimators. From a theoretical point of view, our method is clearly aimed for bounding the operator and Frobenius norm of the inverse covariance matrix. We also derive bounds on the convergence rate for the estimated covariance matrix and on the Kullback Leibler divergence. From a non-asymptotic point of view, our method has a clear advantage when the sample size is small relative to the sparsity $S=\left|E_{0}\right|$ : for a given sample size $n$, we bound the variance in our re-estimation stage by excluding edges of $E_{0}$ with small weights from the selected edge set $\widehat{E}_{n}$ while ensuring that we do not introduce too much bias. Our Gelato method also addresses the bias problem inherent in the GLasso estimator since we no longer shrink the entries in the covariance matrix corresponding to the selected edge set $\widehat{E}_{n}$ in the maximum likelihood estimate, as shown in Section 3.3.

Our experimental results show that Gelato performs better than GLasso or the Space method for AR-models while the situation is reversed for some random precision matrix models; in case of an exponential decay model for the precision matrix, all methods exhibit the same performance. For Gelato, we demonstrate that thresholding is a valuable feature. We also show experimentally how one can use cross-validation for choosing the tuning parameters in regression and thresholding. Deriving theoretical results on cross-validation is not within the scope of this paper.

## Appendix A. Theoretical analysis and proofs

In this section, we specify some preliminary definitions. First, note that when we discuss estimating the parameters $\Sigma_{0}$ and $\Theta_{0}=\Sigma_{0}^{-1}$, we always assume that

\varphi_{\max }\left(\Sigma_{0}\right):=1 / \varphi_{\min }\left(\Theta_{0}\right) \leq 1 / \underline{c}<\infty \text { and } 1 / \varphi_{\max }\left(\Theta_{0}\right)=\varphi_{\min }\left(\Sigma_{0}\right) \geq \underline{k}>0 \tag{36}
\end{equation*}
$$

where we assume $\underline{k}, \underline{c} \leq 1$ so that $\underline{c} \leq 1 \leq 1 / \underline{k}$.
It is clear that these conditions are exactly that of (A2) in Section 3 with

$$
M_{\mathrm{upp}}:=1 / \underline{c} \quad \text { and } \quad M_{\mathrm{low}}:=\underline{k},
$$

where it is clear that for $\Sigma_{0, i i}=1, i=1, \ldots, p$, we have the sum of $p$ eigenvalues of $\Sigma_{0}$, $\sum_{i=1}^{p} \varphi_{i}\left(\Sigma_{0}\right)=\operatorname{tr}\left(\Sigma_{0}\right)=p$. Hence it will make sense to assume that (37) holds, since otherwise, (36) implies that $\varphi_{\min }\left(\Sigma_{0}\right)=\varphi_{\max }\left(\Sigma_{0}\right)=1$ which is unnecessarily restrictive.

We now define parameters relating to the key notion of essential sparsity $s_{0}$ as explored in Candès and Tao [2007]; Zhou [2009, 2010b] for regression. Denote the number of non-zero non-diagonal entries
in each row of $\Theta_{0}$ by $s^{i}$. Let $s=\max _{i=1, \ldots, p} s^{i}$ denote the highest node degree in $G=\left(V, E_{0}\right)$. Consider nodewise regressions as in (2), where we are given vectors of parameters $\left\{\beta_{j}^{i}, j=\right.$ $1, \ldots, p, j \neq i\}$ for $i=1, \ldots, p$. With respect to the degree of node $i$ for each $i$, we define $s_{0}^{i} \leq s^{i} \leq s$ as the smallest integer such that

\begin{equation*}
\sum_{j=1, j \neq i}^{p} \min \left(\left(\beta_{j}^{i}\right)^{2}, \lambda^{2} \operatorname{Var}\left(V_{i}\right)\right) \leq s_{0}^{i} \lambda^{2} \operatorname{Var}\left(V_{i}\right), \text { where } \lambda=\sqrt{2 \log p / n} \tag{38}
\end{equation*}
$$

where $s_{0}^{i}$ denotes $s_{0, n}^{i}$ as defined in (7).
Definition 8 (Bounded degree parameters.) The size of the node degree $s^{i}$ for each node $i$ is upper bounded by an integer $s<p$. For $s_{0}^{i}$ as in (38), define

$$
\begin{equation*}
s_{0}:=\max _{i=1, \ldots, p} s_{0}^{i} \leq s \text { and } S_{0, n}:=\sum_{i=1, \ldots, p} s_{0}^{i} \tag{39}
\end{equation*}
$$

where $S_{0, n}$ is exactly the same as in (8), although we now drop subscript $n$ from $s_{0, n}^{i}$ in order to simplify our notation.

We now define the following parameters related to $\Sigma_{0}$. For an integer $m \leq p$, we define the smallest and largest $\mathbf{m}$-sparse eigenvalues of $\Sigma_{0}$ as follows:

\sqrt{\rho_{\min }(m)}:=\min _{t \neq 0 ; m-\text { sparse }} \frac{\left\|\Sigma_{0}^{1 / 2} t\right\|_{2}}{\|t\|_{2}}, \quad \sqrt{\rho_{\max }(m)}:=\max _{t \neq 0 ; m-\text { sparse }} \frac{\left\|\Sigma_{0}^{1 / 2} t\right\|_{2}}{\|t\|_{2}}
$$

Definition 9 (Restricted eigenvalue condition $R E\left(s_{0}, k_{0}, \Sigma_{0}\right)$ ). For some integer $1 \leq s_{0}<p$ and a positive number $k_{0}$, the following condition holds for all $v \neq 0$,

$$
\begin{equation*}
\frac{1}{K\left(s_{0}, k_{0}, \Sigma_{0}\right)}:=\min _{\substack{J \subseteq\{1, \ldots, p\},\left\|v_{J}\right\|\left\|_{1} \leq k_{0}\right\| v_{J} \|_{1} \\|J J| \leq s_{0}}} \frac{\left\|\Sigma_{0}^{1 / 2} v\right\|_{2}}{\left\|v_{J}\right\|_{2}}>0, \tag{40}
\end{equation*}
$$

where $v_{J}$ represents the subvector of $v \in \mathbb{R}^{p}$ confined to a subset $J$ of $\{1, \ldots, p\}$.
When $s_{0}$ and $k_{0}$ become smaller, this condition is easier to satisfy. When we only aim to estimate the graphical structure $E_{0}$ itself, the global conditions (36) need not hold in general. Hence up till Section D, we only need to assume that $\Sigma_{0}$ satisfies (40) for $s_{0}$ as in (38), and the sparse eigenvalue $\rho_{\min }(s)>0$. In order of estimate the covariance matrix $\Sigma_{0}$, we do assume that (36) holds, which guarantees that the $R E$ condition always holds on $\Sigma_{0}$, and $\rho_{\max }(m), \rho_{\min }(m)$ are upper and lower bounded by some constants for all $m \leq p$. We continue to adopt parameters such as $K, \rho_{\max }(s)$, and $\rho_{\max }\left(3 s_{0}\right)$ for the purpose of defining constants that are reasonable tight under condition (36). In general, one can think of

\rho_{\max }\left(\max \left(3 s_{0}, s\right)\right) \ll 1 / \underline{c}<\infty \text { and } K^{2}\left(s_{0}, k_{0}, \Sigma_{0}\right) \ll 1 / \underline{k}<\infty,
$$

for $\underline{c}, \underline{k}$ as in (36) when $s_{0}$ is small.

## Zhou, Rütimann, Xu, and Bühlmann

Roughly speaking, for two variables $X_{i}, X_{j}$ as in (1) such that their corresponding entry in $\Theta_{0}=$ $\left(\theta_{0, i j}\right)$ satisfies: $\theta_{0, i j}<\lambda \sqrt{\theta_{0, i i}}$, where $\lambda=\sqrt{2 \log (p) / n}$, we can not guarantee that $(i, j) \in \widehat{E}_{n}$ when we aim to keep $\asymp s_{0}^{i}$ edges for node $i, i=1, \ldots, p$. For a given $\Theta_{0}$, as the sample size $n$ increases, we are able to select edges with smaller coefficient $\theta_{0, i j}$. In fact it holds that

$$
\begin{equation*}
\left|\theta_{0, i j}\right|<\lambda \sqrt{\theta_{0, i i}} \text { which is equivalent to }\left|\beta_{j}^{i}\right|<\lambda \sigma_{V_{i}}, \text { for all } j \geq s_{0}^{i}+1+\mathbb{I}_{i \leq s_{0}^{i}+1} \tag{41}
\end{equation*}
$$

where $\mathbb{I}_{\{\cdot\}}$ is the indicator function, if we order the regression coefficients as follows:

$$
\left|\beta_{1}^{i}\right| \geq\left|\beta_{2}^{i}\right| \ldots \geq\left|\beta_{i-1}^{i}\right| \geq\left|\beta_{i+1}^{i}\right| \ldots \geq\left|\beta_{p}^{i}\right|
$$

in view of (2), which is the same as if we order for row $i$ of $\Theta_{0}$,

$$
\begin{equation*}
\left|\theta_{0, i 1}\right| \geq\left|\theta_{0, i, 2}\right| \ldots \geq\left|\theta_{0, i, i-1}\right| \geq\left|\theta_{0, i, i+1}\right| \ldots \geq\left|\theta_{0, i, p}\right| \tag{42}
\end{equation*}
$$

This has been show in [Candès and Tao, 2007]; See also Zhou [2010b].

## A. 1 Concentration bounds for the random design

For the random design $X$ generated by (16), let $\Sigma_{0, i i}=1$ for all $i$. In preparation for showing the oracle results of Lasso in Theorem 33, we first state some concentration bounds on $X$. Define for some $0<\theta<1$

\mathcal{F}(\theta):=\left\{X: \forall j=1, \ldots, p, 1-\theta \leq\left\|X_{j}\right\|_{2} / \sqrt{n} \leq 1+\theta\right\} \tag{43}

where $X_{1}, \ldots, X_{p}$ are the column vectors of the $n \times p$ design matrix $X$. When all columns of $X$ have an Euclidean norm close to $\sqrt{n}$ as in (43), it makes sense to discuss the RE condition in the form of (44) as formulated in [Bickel et al., 2009]. For the integer $1 \leq s_{0}<p$ as defined in (38) and a positive number $k_{0}, R E\left(s_{0}, k_{0}, X\right)$ requires that the following holds for all $v \neq 0$,

\begin{equation*}
\frac{1}{K\left(s_{0}, k_{0}, X\right)} \triangleq \min _{\substack{J \subset\{1, \ldots, p\},\left\|v_{J} c \\|J| \leq\right\|_{1} \leq k_{0}\left\|v_{J}\right\|_{1}}} \frac{\|X v\|_{2}}{\sqrt{n}\left\|v_{J}\right\|_{2}}>0 \tag{44}
\end{equation*}
$$

The parameter $k_{0}>0$ is understood to be the same quantity throughout our discussion. The following event $\mathcal{R}$ provides an upper bound on $K\left(s_{0}, k_{0}, X\right)$ for a given $k_{0}>0$ when $\Sigma_{0}$ satisfies $R E\left(s_{0}, k_{0}, \Sigma_{0}\right)$ condition:

\begin{equation*}
\mathcal{R}(\theta):=\left\{X: R E\left(s_{0}, k_{0}, X\right) \text { holds with } 0<K\left(s_{0}, k_{0}, X\right) \leq \frac{K\left(s_{0}, k_{0}, \Sigma_{0}\right)}{1-\theta}\right\} \tag{45}
\end{equation*}
$$

For some integer $m \leq p$, we define the smallest and largest $m$-sparse eigenvalues of $X$ to be

$$
\begin{align*}
\Lambda_{\min }(m) & :=\min _{v \neq 0 ; m-\text { sparse }}\|X v\|_{2}^{2} /\left(n\|v\|_{2}^{2}\right) \text { and }  \tag{46}\\
\Lambda_{\max }(m) & :=\max _{v \neq 0 ; m-\text { sparse }}\|X v\|_{2}^{2} /\left(n\|v\|_{2}^{2}\right) \tag{47}
\end{align*}
$$

upon which we define the following event:

$$
\begin{array}{r}
\mathcal{M}(\theta):=\left\{X:(49) \text { holds } \forall m \leq \max \left(s,\left(k_{0}+1\right) s_{0}\right)\right\}, \text { for which } \\
0<(1-\theta) \sqrt{\rho_{\min }(m)} \leq \sqrt{\Lambda_{\min }(m)} \leq \sqrt{\Lambda_{\max }(m)} \leq(1+\theta) \sqrt{\rho_{\max }(m)} . \tag{49}
\end{array}
$$

Formally, we consider the set of random designs that satisfy all events as defined, for some $0<$ $\theta<1$. Theorem 10 shows concentration results that we need for the present work, which follows from Theorem 1.6 in Zhou [2010a] and Theorem 3.2 in Rudelson and Zhou [2011].

Theorem 10 Let $0<\theta<1$. Let $\rho_{\min }(s)>0$, where $s<p$ is the maximum node-degree in $G$. Suppose $R E\left(s_{0}, 4, \Sigma_{0}\right)$ holds for $s_{0}$ as in (39), where $\Sigma_{0, i i}=1$ for $i=1, \ldots, p$. Let $f\left(s_{0}\right)=\min \left(4 s_{0} \rho_{\max }\left(s_{0}\right) \log \left(5 e p / s_{0}\right), s_{0} \log p\right)$. Let $c, \alpha, c^{\prime}>0$ be some absolute constants. Then, for a random design $X$ as generated by (16), we have

\begin{equation*}
\mathbb{P}(\mathcal{X}):=\mathbb{P}(\mathcal{R}(\theta) \cap \mathcal{F}(\theta) \cap \mathcal{M}(\theta)) \geq 1-3 \exp \left(-c \theta^{2} n / \alpha^{4}\right) \tag{50}
\end{equation*}
$$

as long as the sample size satisfies

$$
\begin{equation*}
n>\max \left\{\frac{9 c^{\prime} \alpha^{4}}{\theta^{2}} \max \left(36 K^{2}\left(s_{0}, 4, \Sigma_{0}\right) f\left(s_{0}\right), \log p\right), \frac{80 s \alpha^{4}}{\theta^{2}} \log \left(\frac{5 e p}{s \theta}\right)\right\} \tag{51}
\end{equation*}
$$

Remark 11 We note that the constraint $s<p / 2$, which has appeared in Zhou [2010a, Theorem 1.6] is unnecessary. Under a stronger $R E$ condition on $\Sigma_{0}$, a tighter bound on the sample size $n$, which is independent of $\rho_{\max }\left(s_{0}\right)$, is given in Rudelson and Zhou [2011] in order to guarantee $\mathcal{R}(\theta)$. We do not pursue this optimization here as we assume that $\rho_{\max }\left(s_{0}\right)$ is a bounded constant throughout this paper. We emphasize that we only need the first term in (51) in order to obtain $\mathcal{F}(\theta)$ and $\mathcal{R}(\theta)$; The second term is used to bound sparse eigenvalues of order $s$.

## A. 2 Definitions of other various events

Under (A1) as in Section 3, excluding event $\mathcal{X}^{c}$ as bounded in Theorem 10 and events $\mathcal{C}_{a}, \mathcal{X}_{0}$ to be defined in this subsection, we can then proceed to treat $X \in \mathcal{X} \cap \mathcal{C}_{a}$ as a deterministic design in regression and thresholding, for which $\mathcal{R}(\theta) \cap \mathcal{M}(\theta) \cap \mathcal{F}(\theta)$ holds with $\mathcal{C}_{a}$, We then make use of event $\mathcal{X}_{0}$ in the MLE refitting stage for bounding the Frobenius norm. We now define two types of correlations events $\mathcal{C}_{a}$ and $\mathcal{X}_{0}$.

Correlation bounds on $X_{j}$ and $V_{i}$. In this section, we first bound the maximum correlation between pairs of random vectors $\left(V_{i}, X_{j}\right)$, for all $i, j$ where $i \neq j$, each of which corresponds to a pair of variables $\left(V_{i}, X_{j}\right)$ as defined in (2) and (3). Here we use $X_{j}$ and $V_{i}$, for all $i, j$, to denote both random vectors and their corresponding variables.
Let us define $\sigma_{V_{j}}:=\sqrt{\operatorname{Var}\left(V_{j}\right)} \geq v>0$ as a shorthand. Let $V_{j}^{\prime}:=V_{j} / \sigma_{V_{j}}, j=1, \ldots, p$ be a standard normal random variable. Let us now define for all $j, k \neq j$,

Z_{j k}=\frac{1}{n}\left\langle V_{j}^{\prime}, X_{k}\right\rangle=\frac{1}{n} \sum_{i=1}^{n} v_{j, i}^{\prime} x_{k, i},
$$

where for all $i=1, \ldots, n v_{j, i}^{\prime}, x_{k, i}, \forall j, k \neq j$ are independent standard normal random variables. For some $a \geq 6$, let event

$$
\begin{equation*}
\mathcal{C}_{a}:=\left\{\max _{j, k}\left|Z_{j k}\right|<\sqrt{1+a} \sqrt{(2 \log p) / n} \text { where } a \geq 6\right\} \tag{52}
\end{equation*}
$$

Bounds on pairwise correlations in columns of $X$. Let $\Sigma_{0}:=\left(\sigma_{0, i j}\right)$, where we denote $\sigma_{0, i i}:=$ $\sigma_{i}^{2}$. Denote by $\Delta=X^{T} X / n-\Sigma_{0}$. Consider for some constant $C_{3}>4 \sqrt{5 / 3}$,

$$
\begin{equation*}
\mathcal{X}_{0}:=\left\{\max _{j, k}\left|\Delta_{j k}\right|<C_{3} \sigma_{i} \sigma_{j} \sqrt{\log \max \{p, n\} / n}<1 / 2\right\} . \tag{53}
\end{equation*}
$$

We first state Lemma 12 , which is used for bounding a type of correlation events across all regressions; see proof of Theorem 15. It is also clear that event $\mathcal{C}_{a}$ is equivalent to the event to be defined in (54). Lemma 12 also justifies the choice of $\lambda_{n}$ in nodewise regressions (cf. Theorem 15). We then bound event $\mathcal{X}_{0}$ in Lemma 13. Both proofs appear in Section A.3.

Lemma 12 Suppose that $p<e^{n / 4 C_{2}^{2}}$. Then with probability at least $1-1 / p^{2}$, we have

\forall j \neq k,\left|\frac{1}{n}\left\langle V_{j}, X_{k}\right\rangle\right| \leq \sigma_{V_{j}} \sqrt{1+a} \sqrt{(2 \log p) / n} \tag{54}
\end{equation*}
$$

where $\sigma_{V_{j}}=\sqrt{\operatorname{Var}\left(V_{j}\right)}$ and $a \geq 6$. Hence $\mathbb{P}\left(\mathcal{C}_{a}\right) \geq 1-1 / p^{2}$.
Lemma 13 For a random design $X$ as in (1) with $\Sigma_{0, j j}=1, \forall j \in\{1, \ldots, p\}$, and for $p<e^{n / 4 C_{3}^{2}}$, where $C_{3}>4 \sqrt{5 / 3}$, we have

$$
\mathbb{P}\left(\mathcal{X}_{0}\right) \geq 1-1 / \max \{n, p\}^{2}
$$

We note that the upper bounds on $p$ in Lemma 12 and 13 clearly hold given (A1). For the rest of the paper, we prove Theorem 15 in Section B for nodewise regressions. We proceed to derive bounds on selecting an edge set $E$ in Section C. We then derive various bounds on the maximum likelihood estimator given $E$ in Theorem 19-21 in Section D, where we also prove Theorem 1. Next, we prove Lemma 12 and 13 in Section A.3.

## A. 3 Proof of Lemma 12 and 13

We first state the following large inequality bound on products of correlated normal random variables.

Lemma 14 Zhou et al. [2008, Lemma 38] Given a set of identical independent random variables $Y_{1}, \ldots, Y_{n} \sim Y$, where $Y=x_{1} x_{2}$, with $x_{1}, x_{2} \sim N(0,1)$ and $\sigma_{12}=\rho_{12}$ with $\rho_{12} \leq 1$ being their correlation coefficient. Let us now define $Q=\frac{1}{n} \sum_{i=1}^{n} Y_{i}=: \frac{1}{n}\left\langle X_{1}, X_{2}\right\rangle=\frac{1}{n} \sum_{i=1}^{n} x_{1, i} x_{2, i}$. Let $\Psi_{12}=\left(1+\sigma_{12}^{2}\right) / 2$. For $0 \leq \tau \leq \Psi_{12}$,

$$
\begin{equation*}
\mathbb{P}(|Q-\mathbb{E} Q|>\tau) \leq \exp \left\{-\frac{3 n \tau^{2}}{10\left(1+\sigma_{12}^{2}\right)}\right\} \tag{55}
\end{equation*}
$$

## High-dimensional Covariance Estimation

Proof of Lemma 12. It is clear that event (54) is the same as event $\mathcal{C}_{a}$. Clearly we have at most $p(p-1)$ unique entries $Z_{j k}, \forall j \neq k$. By the union bound and by taking $\tau=C_{2} \sqrt{\frac{\log p}{n}}$ in (55) with $\sigma_{j k}=0, \forall j, k$, where $\sqrt{2(1+a)} \geq C_{2}>2 \sqrt{10 / 3}$ for $a \geq 6$.

$$
\begin{aligned}
1-\mathbb{P}\left(\mathcal{C}_{a}\right) & =\mathbb{P}\left(\max _{j k}\left|Z_{j k}\right| \geq \sqrt{2(1+a)} \sqrt{\frac{\log p}{n}}\right) \\
& \leq \mathbb{P}\left(\max _{j k}\left|Z_{j k}\right| \geq C_{2} \sqrt{\frac{\log p}{n}}\right) \leq\left(p^{2}-p\right) \exp \left(-\frac{3 C_{2}^{2} \log p}{10}\right) \\
& \leq p^{2} \exp \left(-\frac{3 C_{2}^{2} \log p}{10}\right)=p^{-\frac{3 C_{2}^{2}}{10}+2}<\frac{1}{p^{2}}
\end{aligned}
$$

where we apply Lemma 14 with $\rho_{j k}=0, \forall j, k=1, \ldots, p, j \neq k$ and use the fact that $\mathbb{E} Z_{j k}=0$. Note that $p<e^{n / 4 C_{2}^{2}}$ guarantees that $C_{2} \sqrt{\frac{\log p}{n}}<1 / 2$.

In order to bound the probability of event $\mathcal{X}_{0}$, we first state the following large inequality bound for the non-diagonal entries of $\Sigma_{0}$, which follows immediately from Lemma 14 by plugging in $\sigma_{i}^{2}=\sigma_{0, i i}=1, \forall i=1, \ldots, p$ and using the fact that $\left|\sigma_{0, j k}\right|=\left|\rho_{j k} \sigma_{j} \sigma_{k}\right| \leq 1, \forall j \neq k$, where $\rho_{j k}$ is the correlation coefficient between variables $X_{j}$ and $X_{k}$. Let $\Psi_{j k}=\left(1+\sigma_{0, j k}^{2}\right) / 2$. Then

$$
\begin{equation*}
\mathbb{P}\left(\left|\Delta_{j k}\right|>\tau\right) \leq \exp \left\{-\frac{3 n \tau^{2}}{10\left(1+\sigma_{0, j k}^{2}\right)}\right\} \leq \exp \left\{-\frac{3 n \tau^{2}}{20}\right\} \text { for } 0 \leq \tau \leq \Psi_{j k} \tag{56}
\end{equation*}
$$

We now also state a large deviation bound for the $\chi_{n}^{2}$ distribution [Johnstone, 2001]:

$$
\begin{equation*}
\mathbb{P}\left(\frac{\chi_{n}^{2}}{n}-1>\tau\right) \leq \exp \left(\frac{-3 n \tau^{2}}{16}\right), \text { for } 0 \leq \tau \leq \frac{1}{2} \tag{57}
\end{equation*}
$$

Lemma 13 follows from (56) and (57) immediately.
Proof of Lemma 13. Now it is clear that we have $p(p-1) / 2$ unique non-diagonal entries $\sigma_{0, j k}, \forall j \neq k$ and $p$ diagonal entries. By the union bound and by taking $\tau=C_{3} \sqrt{\frac{\log \max \{p, n\}}{n}}$ in (57) and (56) with $\sigma_{0, j k} \leq 1$, we have

\begin{aligned}
\mathbb{P}\left(\left(\mathcal{X}_{0}\right)^{c}\right) & =\mathbb{P}\left(\max _{j k}\left|\Delta_{j k}\right| \geq C_{3} \sqrt{\frac{\log \max \{p, n\}}{n}}\right) \\
& \leq p \exp \left(-\frac{3 C_{3}^{2} \log \max \{p, n\}}{16}\right)+\frac{p^{2}-p}{2} \exp \left(-\frac{3 C_{3}^{2} \log \max \{p, n\}}{20}\right) \\
& \leq p^{2} \exp \left(-\frac{3 C_{3}^{2} \log \max \{p, n\}}{20}\right)=(\max \{p, n\})^{-\frac{3 C_{3}^{2}}{20}+2}<\frac{1}{(\max \{p, n\})^{2}}
\end{aligned}
$$

for $C_{3}>4 \sqrt{5 / 3}$, where for the diagonal entries we use (57), and for the non-diagonal entries, we use (56). Finally, $p<e^{n / 4 C_{3}^{2}}$ guarantees that $C_{3} \sqrt{\frac{\log \max \{p, n\}}{n}}<1 / 2$.

## Appendix B. Bounds for nodewise regressions

In Theorem 15 and Lemma 16 we let $s_{0}^{i}$ be as in (38) and $T_{0}^{i}$ denote locations of the $s_{0}^{i}$ largest coefficients of $\beta^{i}$ in absolute values. For the vector $h^{i}$ to be defined in Theorem 15, we let $T_{1}^{i}$ denote the $s_{0}^{i}$ largest positions of $h^{i}$ in absolute values outside of $T_{0}^{i}$; Let $T_{01}^{i}:=T_{0}^{i} \cup T_{1}^{i}$. We suppress the superscript in $T_{0}^{i}, T_{1}^{i}$, and $T_{01}^{i}$ throughout this section for clarity.

Theorem 15 (Oracle inequalities of the nodewise regressions) Let $0<\theta<1$. Let $\rho_{\min }(s)>0$, where $s<p$ is the maximum node-degree in $G$. Suppose $R E\left(s_{0}, 4, \Sigma_{0}\right)$ holds for $s_{0} \leq s$ as in (39), where $\Sigma_{0, i i}=1$ forall $i$. Suppose $\rho_{\max }\left(\max \left(s, 3 s_{0}\right)\right)<\infty$. The data is generated by $X^{(1)}, \ldots, X^{(n)}$ i.i.d. $\sim \mathcal{N}_{p}\left(0, \Sigma_{0}\right)$, where the sample size $n$ satisfies $(51)$.

Consider the nodewise regressions in (10), where for each $i$, we regress $X_{i}$ onto the other variables $\left\{X_{k} ; k \neq i\right\}$ following (2), where $V_{i} \sim N\left(0, \operatorname{Var}\left(V_{i}\right)\right)$ is independent of $X_{j}, \forall j \neq i$ as in (3).

Let $\beta_{\mathrm{init}}^{i}$ be an optimal solution to (10) for each $i$. Let $\lambda_{n}=d_{0} \lambda=d_{0}^{i} \lambda \sigma_{V_{i}}$ where $d_{0}$ is chosen such that $d_{0} \geq 2(1+\theta) \sqrt{1+a}$ holds for some $a \geq 6$. Let $h^{i}=\beta_{\mathrm{init}}^{i}-\beta_{T_{0}}^{i}$. Then simultaneously for all $i$, on $\mathcal{C}_{a} \cap \mathcal{X}$, where $\mathcal{X}:=\mathcal{R}(\theta) \cap \mathcal{F}(\theta) \cap \mathcal{M}(\theta)$, we have

\left\|h_{T_{01}}\right\|_{2} & \leq D_{0} d_{0} \lambda \sqrt{s_{0}^{i}} \quad \text { and } \quad\left\|h_{T_{0}^{c}}^{i}\right\|_{1}=\left\|\beta_{\mathrm{init}, T_{0}^{c}}^{i}\right\|_{1} \leq D_{1} d_{0} \lambda s_{0}^{i} \tag{58}
\end{align*}
$$

where $D_{0}, D_{1}$ are defined in (109) and (110) respectively.
Suppose we choose for some constant $c_{0} \geq 4 \sqrt{2}$ and $a_{0}=7$,

$$
d_{0}=c_{0}(1+\theta)^{2} \sqrt{\rho_{\max }(s) \rho_{\max }\left(3 s_{0}\right)}
$$

where we assume that $\rho_{\max }\left(\max \left(s, 3 s_{0}\right)\right)<\infty$ is reasonably bounded. Then

D_{0} \leq \frac{5 K^{2}\left(s_{0}, 4, \Sigma_{0}\right)}{(1-\theta)^{2}} \text { and } D_{1} \leq \frac{49 K^{2}\left(s_{0}, 4, \Sigma_{0}\right)}{16(1-\theta)^{2}}
$$

The choice of $d_{0}$ will be justified in Section F , where we also the upper bound on $D_{0}, D_{1}$ as above.
Proof Consider each regression function in (10) with $X_{\cdot \backslash i}$ being the design matrix and $X_{i}$ the response vector, where $X_{. \backslash i}$ denotes columns of $X$ excluding $X_{i}$. It is clear that for $\lambda_{n}=d_{0} \lambda$, we have for $i=1, \ldots, p$ and $a \geq 6$,

such that (108) holds given that $\sigma_{V_{i}} \leq 1, \forall i$, where it is understood that $\sigma:=\sigma_{V_{i}}$.
It is also clear that on $\mathcal{C}_{a} \cap \mathcal{X}$, event $\mathcal{T}_{a} \cap \mathcal{X}$ holds for each regression when we invoke Theorem 33, with $Y:=X_{i}$ and $X:=X_{\cdot \backslash i}$, for $i=1, \ldots, p$. By definition $d_{0}^{i} \sigma_{V_{i}}=d_{0}$. We can then invoke bounds for each individual regression as in Theorem 33 to conclude.

## Appendix C. Bounds on thresholding

In this section, we first show Lemma 16, following conditions in Theorem 15.

Suppose $\rho_{\max }\left(\max \left(s, 3 s_{0}\right)\right)<\infty$. Let $S^{i}=\left\{j: j \neq i, \beta_{j}^{i} \neq 0\right\}$. Let $c_{0} \geq 4 \sqrt{2}$ be some absolute constant. Suppose $n$ satisfies (51). Let $\beta_{\text {init }}^{i}$ be an optimal solution to (10) with

Suppose for each regression, we apply the same thresholding rule to obtain a subset $I^{i}$ as follows,

where $f_{0}:=D_{4} d_{0}$ for some constant $D_{4}$ to be specified. Then we have on event $\mathcal{C}_{a} \cap \mathcal{X}$,

\left|I^{i}\right| & \leq s_{0}^{i}\left(1+D_{1} / D_{4}\right) \text { and }\left|I^{i} \cup S^{i}\right| \leq s^{i}+\left(D_{1} / D_{4}\right) s_{0}^{i} \text { and }  \tag{59}\\
\left\|\beta_{\mathcal{D}}^{i}\right\|_{2} & \leq d_{0} \lambda \sqrt{s_{0}^{i}} \sqrt{1+\left(D_{0}+D_{4}\right)^{2}} \tag{60}
\end{align*}
$$

where $\mathcal{D}$ is understood to be $\mathcal{D}^{i}$ and $D_{0}, D_{1}$ are the same constants as in Theorem 15.
We now show Corollary 17, which proves Proposition 4 and the first statement of Theorem 1. Recall $\Theta_{0}=\Sigma_{0}^{-1}$. Let $\Theta_{0, \mathcal{D}}$ denote the submatrix of $\Theta_{0}$ indexed by $\mathcal{D}$ as in (24) with all other positions set to be 0 . Let $E_{0}$ be the true edge set.

& \leq \sqrt{\min \left\{S_{0, n}\left(\max _{i=1, \ldots p} \theta_{0, i i}^{2}\right), s_{0}\left\|\operatorname{diag}\left(\Theta_{0}\right)\right\|_{F}^{2}\right\}} \sqrt{\left(1+\left(D_{0}+D_{4}\right)^{2}\right)} d_{0} \lambda  \tag{62}\\
& :=\sqrt{S_{0, n}\left(1+\left(D_{0}+D_{4}\right)^{2}\right)} C_{\text {diag }} d_{0} \lambda
\end{align*}
$$

where $C_{\text {diag }}^{2}:=\min \left\{\max _{i=1, \ldots p} \theta_{0, i i}^{2},\left(s_{0} / S_{0, n}\right)\left\|\operatorname{diag}\left(\Theta_{0}\right)\right\|_{F}^{2}\right\}$, and $D_{0}, D_{1}$ are understood to be the same constants as in Theorem 15. Clearly, for $D_{4} \geq D_{1}$, we have (19).

Proof By the OR rule in (9), we could select at most $2\left|I_{i}\right|$ edges. We have by (59)

& \leq \min \left\{S_{0, n}\left(\max _{i=1, \ldots p} \theta_{0, i i}^{2}\right), s_{0}\left\|\operatorname{diag}\left(\Theta_{0}\right)\right\|_{F}^{2}\right\}\left(1+\left(D_{0}+D_{4}\right)^{2}\right) d_{0}^{2} \lambda^{2}
\end{aligned}
$$

Remark 18 Note that if $s_{0}$ is small, then the second term in $C_{\text {diag }}$ will provide a tighter bound.

& \leq\left\|\left(\beta^{i}-\beta_{\text {init }}^{i}\right)_{T_{0}}\right\|_{2}+t_{0} \sqrt{\left|T_{0} \cap \mathcal{D}\right|} \leq\left\|h_{T_{0}}\right\|_{2}+t_{0} \sqrt{s_{0}^{i}} \\
& \leq D_{0} d_{0} \lambda \sqrt{s_{0}^{i}}+D_{4} d_{0} \lambda \sqrt{s_{0}^{i}} \leq\left(D_{0}+D_{4}\right) d_{0} \lambda \sqrt{s_{0}^{i}} .
\end{aligned}

## Appendix D. Bounds on MLE refitting

Recall the maximum likelihood estimate $\widehat{\Theta}_{n}$ minimizes over all $\Theta \in \mathcal{S}_{n}$ the empirical risk:

which gives the "best" refitted sparse estimator given a sparse subset of edges $E$ that we obtain from the nodewise regressions and thresholding. We note that the estimator (64) remains to be a convex optimization problem, as the constraint set is the intersection the positive definite cone $\mathcal{S}_{++}^{p}$ and the linear subspace $\mathcal{S}_{E}^{p}$. Implicitly, by using $\widehat{\Gamma}_{n}$ rather than $\widehat{S}_{n}$ in (64), we force the diagonal entries in $\left(\widehat{\Theta}_{n}(E)\right)^{-1}$ to be identically 1 . It is not hard to see that the estimator (64) is equivalent to (14), after we replace $\widehat{S}_{n}$ with $\widehat{\Gamma}_{n}$.

## High-dimensional Covariance Estimation

Theorem 19 Consider data generating random variables as in expression (16) and assume that (A1), (36), and (37) hold. Suppose $\Sigma_{0, i i}=1$ for all $i$. Let $\mathcal{E}$ be some event such that $\mathbb{P}(\mathcal{E}) \geq$ $1-d / p^{2}$ for a small constant d. Let $S_{0, n}$ be as defined in (39); Suppose on event $\mathcal{E}$ :

1. We obtain an edge set $E$ such that its size $|E|=\operatorname{lin}\left(S_{0, n}\right)$ is a linear function in $S_{0, n}$.
2. And for $\widetilde{\Theta}_{0}$ as in (26) and for some constant $C_{\text {bias }}$ to be specified, we have

\left\|\Theta_{0, \mathcal{D}}\right\|_{F}:=\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{F} \leq C_{\text {bias }} \sqrt{2 S_{0, n} \log (p) / n}<\underline{c} / 32 . \tag{65}
\end{equation*}
$$

Let $\widehat{\Theta}_{n}(E)$ be as defined in (64). Suppose the sample size satisfies for $C_{3} \geq 4 \sqrt{5 / 3}$,

n>\frac{106}{\underline{k}^{2}}\left(4 C_{3}+\frac{32}{31 \underline{c}^{2}}\right)^{2} \max \left\{2|E| \log \max (n, p), C_{\text {bias }}^{2} 2 S_{0, n} \log p\right\} \tag{66}
\end{equation*}
$$

Then on event $\mathcal{E} \cap \mathcal{X}_{0}$, we have for $M=\left(9 /\left(2 \underline{k}^{2}\right)\right) \cdot\left(4 C_{3}+32 /\left(31 \underline{c}^{2}\right)\right)$

$$
\begin{equation*}
\left\|\widehat{\Theta}_{n}(E)-\Theta_{0}\right\|_{F} \leq(M+1) \max \left\{\sqrt{2|E| \log \max (n, p) / n}, C_{\text {bias }} \sqrt{2 S_{0, n} \log (p) / n}\right\} . \tag{67}
\end{equation*}
$$

We note that although Theorem 19 is meant for proving Theorem 1, we state it as an independent result; For example, one can indeed take $E$ from Corollary 17, where we have $|E| \leq c S_{0, n}$ for some constant $c$ for $D_{4} \asymp D_{1}$. In view of (62), we aim to recover $\widetilde{\Theta}_{0}$ by $\widehat{\Theta}_{n}(E)$ as defined in (64). In Section D.2, we will focus in Theorem 19 on bounding for $W$ suitably chosen,

We now state bounds for the convergence rate on Frobenius norm of the covariance matrix and for KL divergence. We note that constants have not been optimized. Proofs of Theorem 20 and 21 appear in Section D. 3 and D. 4 respectively.

Theorem 20 Suppose all conditions, events, and bounds on $|E|$ and $\left\|\Theta_{0, \mathcal{D}}\right\|_{F}$ in Theorem 19 hold. Let $\widehat{\Theta}_{n}(E)$ be as defined in (64). Suppose the sample size satisfies for $C_{3} \geq 4 \sqrt{5 / 3}$ and $C_{\text {bias }}, M$ as defined in Theorem 19

n>\frac{106}{\underline{c}^{2} \underline{k}^{4}}\left(4 C_{3}+\frac{32}{31 \underline{c}^{2}}\right)^{2} \max \left\{2|E| \log \max (p, n), C_{\text {bias }}^{2} 2 S_{0, n} \log p\right\} \tag{68}
\end{equation*}
$$

Then on event $\mathcal{E} \cap \mathcal{X}_{0}$, we have $\varphi_{\min }\left(\widehat{\Theta}_{n}(E)\right)>\underline{c} / 2>0$ and for $\widehat{\Sigma}_{n}(E)=\left(\widehat{\Theta}_{n}(E)\right)^{-1}$,

$$
\begin{equation*}
\left\|\widehat{\Sigma}_{n}(E)-\Sigma_{0}\right\|_{F} \leq \frac{2(M+1)}{\underline{c}^{2}} \max \left\{\sqrt{\frac{2|E| \log \max (n, p)}{n}}, C_{\text {bias }} \sqrt{\frac{2 S_{0, n} \log (p)}{n}}\right\} \tag{69}
\end{equation*}
$$

## Zhou, RÜtimann, Xu, and Bühlmann

Theorem 21 Suppose all conditions, events, and bounds on $|E|$ and $\left\|\Theta_{0, \mathcal{D}}\right\|_{F}:=\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{F}$ in Theorem 19 hold. Let $\widehat{\Theta}_{n}(E)$ be as defined in (64). Suppose the sample size satisfies (66) for $C_{3} \geq 4 \sqrt{5 / 3}$ and $C_{\text {bias }}, M$ as defined in Theorem 19. Then on event $\mathcal{E} \cap \mathcal{X}_{0}$, we have for $R\left(\widehat{\Theta}_{n}(E)\right)-R\left(\Theta_{0}\right) \geq 0$,

C_{\text {bias }}^{2} & :=\min \left\{\max _{i=1, \ldots p} \theta_{0, i i}^{2}, \frac{s_{0}}{S_{0, n}}\left\|\operatorname{diag}\left(\Theta_{0}\right)\right\|_{F}^{2}\right\} d_{0}^{2}\left(1+\left(D_{0}+D_{4}\right)^{2}\right) \\
& =C_{\text {diag }}^{2} d_{0}^{2}\left(1+\left(D_{0}+D_{4}\right)^{2}\right) \tag{71}
\end{align*}
$$

Clearly the last inequality in (65) hold so long as $n>32^{2} C_{\text {bias }}^{2} 2 S_{0, n} \log (p) / \underline{c}^{2}$, which holds given (66). Plugging in $|E|$ in (67), we have on $\mathcal{E} \cap \mathcal{X}_{0}$,

& \leq W \sqrt{S_{0, n} \log \max (n, p) / n}
\end{aligned}

where $W \leq \sqrt{2}(M+1) \max \left\{C_{\text {diag }} d_{0} \sqrt{1+\left(D_{0}+D_{4}\right)^{2}}, 2\right\}$. Similarly, we get the bound on $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F}$ with Theorem 20, and the bound on risk following Theorem 21. Thus all statements in Theorem 1 hold.

Remark 22 Suppose event $\mathcal{E} \cap \mathcal{X}_{0}$ holds. Now suppose that we take $D_{4}=1$, that is, if we take the threshold to be exactly the penalty parameter $\lambda_{n}$ :

\left\|\widehat{\Theta}_{n}(E)-\Theta_{0}\right\|_{F} \leq M \max \left\{\sqrt{\frac{4\left(1+D_{1}\right) S_{0, n} \log \max (n, p)}{n}}, C_{\mathrm{bias}}^{\prime} \sqrt{\frac{2 S_{0, n} \log p}{n}}\right\}
$$

It is not hard to see that we achieve essential the same rate as stated in Theorem 1, with perhaps slightly more edges included in $E$.

## D. 2 Proof of Theorem 19

Suppose event $\mathcal{E}$ holds throughout this proof. We first obtain the bound on spectrum of $\widetilde{\Theta}_{0}$ : It is clear that by (36) and (65), we have on $\mathcal{E}$,

& \varphi_{\min }\left(\widetilde{\Theta}_{0}\right) \geq \varphi_{\min }\left(\Theta_{0}\right)-\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{2} \geq \varphi_{\min }\left(\Theta_{0}\right)-\left\|\Theta_{0, \mathcal{D}}\right\|_{F}>31 \underline{c} / 32  \tag{72}\\
& \varphi_{\max }\left(\widetilde{\Theta}_{0}\right)<\varphi_{\max }\left(\Theta_{0}\right)+\left\|\widetilde{\Theta}_{0}-\Theta_{0}\right\|_{2} \leq \varphi_{\max }\left(\Theta_{0}\right)+\left\|\Theta_{0, \mathcal{D}}\right\|_{F}<\frac{\underline{c}}{32}+\frac{1}{\underline{k}} \tag{73}
\end{align*}
$$

Throughout this proof, we let $\Sigma_{0}=\left(\sigma_{0, i j}\right):=\Theta_{0}^{-1}$. In view of (72), define $\widetilde{\Sigma}_{0}:=\left(\widetilde{\Theta}_{0}\right)^{-1}$. We use $\widehat{\Theta}_{n}:=\widehat{\Theta}_{n}(E)$ as a shorthand.

Given $\widetilde{\Theta}_{0} \in \mathcal{S}_{++}^{p} \cap \mathcal{S}_{E}^{p}$ as guaranteed in (72), let us define a new convex set:

which is a translation of the original convex set $\mathcal{S}_{++}^{p} \cap \mathcal{S}_{E}^{p}$. Let $\underline{0}$ be a matrix with all entries being zero. Thus it is clear that $U_{n}\left(\widetilde{\Theta}_{0}\right) \ni \underline{0}$ given that $\widetilde{\Theta}_{0} \in \mathcal{S}_{++}^{p} \cap \mathcal{S}_{E}^{p}$. Define for $\widehat{R}_{n}$ as in expression (64)

\widetilde{Q}(\Theta) & :=\widehat{R}_{n}(\Theta)-\widehat{R}_{n}\left(\widetilde{\Theta}_{0}\right)=\operatorname{tr}\left(\Theta \widehat{\Gamma}_{n}\right)-\log |\Theta|-\operatorname{tr}\left(\widetilde{\Theta}_{0} \widehat{\Gamma}_{n}\right)+\log \left|\widetilde{\Theta}_{0}\right| \\
& =\operatorname{tr}\left(\left(\Theta-\widetilde{\Theta}_{0}\right)\left(\widehat{\Gamma}_{n}-\widetilde{\Sigma}_{0}\right)\right)-\left(\log |\Theta|-\log \left|\widetilde{\Theta}_{0}\right|\right)+\operatorname{tr}\left(\left(\Theta-\widetilde{\Theta}_{0}\right) \widetilde{\Sigma}_{0}\right)
\end{aligned}
$$

For an appropriately chosen $r_{n}$ and a large enough $M>0$, let

\begin{align*}
\mathbb{T}_{n} & =\left\{\Delta \in U_{n}\left(\widetilde{\Theta}_{0}\right),\|\Delta\|_{F}=M r_{n}\right\}, \text { and }  \tag{74}\\
\Pi_{n} & =\left\{\Delta \in U_{n}\left(\widetilde{\Theta}_{0}\right),\|\Delta\|_{F}<M r_{n}\right\} \tag{75}
\end{align*}
$$

It is clear that both $\Pi_{n}$ and $\mathbb{T}_{n} \cup \Pi_{n}$ are convex. It is also clear that $\underline{0} \in \Pi_{n}$. Throughout this section, we let

\begin{equation*}
r_{n}=\max \left\{\sqrt{\frac{2|E| \log \max (n, p)}{n}}, C_{\mathrm{bias}} \sqrt{\frac{2 S_{0, n} \log p}{n}}\right\} \tag{76}
\end{equation*}
$$

Define for $\Delta \in U_{n}\left(\widetilde{\Theta}_{0}\right)$,

\begin{equation*}
\widetilde{G}(\Delta):=\widetilde{Q}\left(\widetilde{\Theta}_{0}+\Delta\right)=\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\widetilde{\Sigma}_{0}\right)\right)-\left(\log \left|\widetilde{\Theta}_{0}+\Delta\right|-\log \left|\widetilde{\Theta}_{0}\right|\right)+\operatorname{tr}\left(\Delta \widetilde{\Sigma}_{0}\right) \tag{77}
\end{equation*}
$$

It is clear that $\widetilde{G}(\Delta)$ is a convex function on $U_{n}\left(\widetilde{\Theta}_{0}\right)$ and $\widetilde{G}(\underline{0})=\widetilde{Q}\left(\widetilde{\Theta}_{0}\right)=0$.
Now, $\widehat{\Theta}_{n}$ minimizes $\widetilde{Q}(\Theta)$, or equivalently $\widehat{\Delta}=\widehat{\Theta}_{n}-\widetilde{\Theta}_{0}$ minimizes $\widetilde{G}(\Delta)$. Hence by definition,

Indeed, consider $B_{\epsilon}:=(1+\epsilon) \widetilde{\Theta}_{0}$, where $\epsilon>0$; it is clear that $B_{\epsilon}-\widetilde{\Theta}_{0} \in \mathcal{S}_{++}^{p} \cap \mathcal{S}_{E}^{p}$ and $\left\|B_{\epsilon}-\widetilde{\Theta}_{0}\right\|_{F}=|\epsilon|\left\|\widetilde{\Theta}_{0}\right\|_{F}=M r_{n}$ for $|\epsilon|=$ $M r_{n} /\left\|\widetilde{\Theta}_{0}\right\|_{F}$. Note also if $\Delta \in \mathbb{T}_{n}$, then $\Delta_{i j}=0 \forall(i, j: i \neq j) \notin E$; Thus we have $\Delta \in \mathcal{S}_{E}^{p}$ and

We now show the following two propositions. Proposition 23 follows from standard results.
Proposition 23 Let $B$ be a $p \times p$ matrix. If $B \succ 0$ and $B+D \succ 0$, then $B+v D \succ 0$ for all $v \in[0,1]$.

Proposition 24 Under (36), we have for all $\Delta \in \mathbb{T}_{n}$ such that $\|\Delta\|_{F}=M r_{n}$ for $r_{n}$ as in (76), $\widetilde{\Theta}_{0}+v \Delta \succ 0, \forall v \in$ an open interval $I \supset[0,1]$ on event $\mathcal{E}$.

Proof In view of Proposition 23, it is sufficient to show that $\widetilde{\Theta}_{0}+(1+\varepsilon) \Delta, \widetilde{\Theta}_{0}-\varepsilon \Delta \succ 0$ for some $\varepsilon>0$. Indeed, by definition of $\Delta \in \mathbb{T}_{n}$, we have $\varphi_{\min }\left(\widetilde{\Theta}_{0}+\Delta\right) \succ 0$ on event $\mathcal{E}$; thus

\end{aligned}

for $\varepsilon>0$ that is sufficiently small.
Thus we have that $\log \left|\widetilde{\Theta}_{0}+v \Delta\right|$ is infinitely differentiable on the open interval $I \supset[0,1]$ of $v$. This allows us to use the Taylor's formula with integral remainder to obtain the following:
Lemma 25 On event $\mathcal{E} \cap \mathcal{X}_{0}, \widetilde{G}(\Delta)>0$ for all $\Delta \in \mathbb{T}_{n}$.
Proof Let us use $\widetilde{A}$ as a shorthand for

where $\otimes$ is the Kronecker product (if $W=\left(w_{i j}\right)_{m \times n}, P=\left(b_{k \ell}\right)_{p \times q}$, then $W \otimes P=\left(w_{i j} P\right)_{m p \times n q}$ ), and vec $\Delta \in \mathbb{R}^{p^{2}}$ is $\Delta_{p \times p}$ vectorized. Now, the Taylor expansion gives for all $\Delta \in \mathbb{T}_{n}$,

\log \left|\widetilde{\Theta}_{0}+\Delta\right|-\log \left|\widetilde{\Theta}_{0}\right| & \left.=\frac{d}{d v} \log \left|\widetilde{\Theta}_{0}+v \Delta \|_{v=0} \Delta+\int_{0}^{1}(1-v) \frac{d^{2}}{d v^{2}} \log \right| \widetilde{\Theta}_{0}+v \Delta \right\rvert\, d v \\
& =\operatorname{tr}\left(\widetilde{\Sigma}_{0} \Delta\right)-\widetilde{A}
\end{aligned}
$$

Hence for all $\Delta \in \mathbb{T}_{n}$,

$$
\begin{equation*}
\widetilde{G}(\Delta)=\widetilde{A}+\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\widetilde{\Sigma}_{0}\right)\right)=\widetilde{A}+\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\Sigma_{0}\right)\right)-\operatorname{tr}\left(\Delta\left(\widetilde{\Sigma}_{0}-\Sigma_{0}\right)\right) \tag{79}
\end{equation*}
$$

where we first bound $\operatorname{tr}\left(\Delta\left(\widetilde{\Sigma}_{0}-\Sigma_{0}\right)\right)$ as follows: by (65) and (72), we have on event $\mathcal{E}$

\left|\operatorname{tr}\left(\Delta\left(\widetilde{\Sigma}_{0}-\Sigma_{0}\right)\right)\right| & =\left|\left\langle\Delta,\left(\widetilde{\Sigma}_{0}-\Sigma_{0}\right)\right\rangle\right| \leq\|\Delta\|_{F}\left\|\widetilde{\Sigma}_{0}-\Sigma_{0}\right\|_{F} \\
& \leq\|\Delta\|_{F} \frac{\left\|\Theta_{0, \mathcal{D}}\right\|_{F}}{\varphi_{\min }\left(\widetilde{\Theta}_{0}\right) \varphi_{\min }\left(\Theta_{0}\right)} \\
& <\|\Delta\|_{F} \frac{32 C_{\text {bias }} \sqrt{2 S_{0, n} \log p / n}}{31 \underline{c}^{2}} \leq\|\Delta\|_{F} \frac{32 r_{n}}{31 \underline{c}^{2}} . \tag{80}
\end{align*}
$$

Now, conditioned on event $\mathcal{X}_{0}$, by (89) and (66)

\max _{j, k}\left|\widehat{\Gamma}_{n, j k}-\sigma_{0, j k}\right| \leq 4 C_{3} \sqrt{\log \max (n, p) / n}=: \delta_{n}
$$

and thus on event $\mathcal{E} \cap X_{0}$, we have $\left|\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\Sigma_{0}\right)\right)\right| \leq \delta_{n}|\operatorname{offd}(\Delta)|_{1}$, where $|\operatorname{offd}(\Delta)|_{1} \leq$ $\sqrt{\|\operatorname{offd}(\Delta)\|_{0}} \|$ offd $(\Delta)\left\|_{F} \leq \sqrt{2|E|}\right\| \Delta \|_{F}$, and

$$
\begin{equation*}
\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\Sigma_{0}\right)\right) \geq-4 C_{3} \sqrt{\log \max (n, p) / n} \sqrt{2|E|}\|\Delta\|_{F} \geq-4 C_{3} r_{n}\|\Delta\|_{F} \tag{81}
\end{equation*}
$$

Finally, we bound $\widetilde{A}$. First we note that for $\Delta \in \mathbb{T}_{n}$, we have on event $\mathcal{E}$,

given (66): $n>\left(\frac{16}{7} \cdot \frac{9}{2 \underline{k}}\right)^{2}\left(4 C_{3}+\frac{32}{31 \underline{c}^{2}}\right)^{2} \max \left\{(2|E|) \log (n), C_{\text {bias }}^{2} 2 S_{0, n} \log p\right\}$. Now we have by (73) and (37) following Rothman et al. [2008] (see Page 502, proof of Theorem 1 therein): on event $\mathcal{E}$,

\widetilde{A} & \geq\|\Delta\|_{F}^{2} /\left(2\left(\varphi_{\max }\left(\widetilde{\Theta}_{0}\right)+\|\Delta\|_{2}\right)^{2}\right) \\
& \geq\|\Delta\|_{F}^{2} /\left(2\left(\frac{1}{\underline{k}}+\frac{\underline{c}}{32}+\frac{7}{16 \underline{k}}\right)^{2}\right)>\|\Delta\|_{F}^{2} \frac{2 \underline{k}^{2}}{9} \tag{83}
\end{align*}
$$

Now on event $\mathcal{E} \cap \mathcal{X}_{0}$, for all $\Delta \in \mathbb{T}_{n}$, we have by (79),(83), (81), and (80),

\widetilde{G}(\Delta) & >\|\Delta\|_{F}^{2} \frac{2 \underline{k}^{2}}{9}-4 C_{3} r_{n}\|\Delta\|_{F}-\|\Delta\|_{F} \frac{32 r_{n}}{31 \underline{c}^{2}} \\
& =\|\Delta\|_{F}^{2}\left(\frac{2 \underline{k}^{2}}{9}-\frac{1}{\|\Delta\|_{F}}\left(4 C_{3} r_{n}+\frac{32 r_{n}}{31 \underline{c}^{2}}\right)\right) \\
& =\|\Delta\|_{F}^{2}\left(\frac{2 \underline{k}^{2}}{9}-\frac{1}{M}\left(4 C_{3}+\frac{32}{31 \underline{c}^{2}}\right)\right)
\end{aligned}
$$

hence we have $\widetilde{G}(\Delta)>0$ for $M$ large enough, in particular $M=\left(9 /\left(2 \underline{k}^{2}\right)\right)\left(4 C_{3}+32 /\left(31 \underline{c}^{2}\right)\right)$ suffices.

We next state Proposition 26, which follows exactly that of Claim 12 of Zhou et al. [2008].
Proposition 26 Suppose event $\mathcal{E}$ holds. If $\widetilde{G}(\Delta)>0, \forall \Delta \in \mathbb{T}_{n}$, then $\widetilde{G}(\Delta)>0$ for all $\Delta$ in

$$

for $r_{n}$ as in (76); Hence if $\widetilde{G}(\Delta)>0$ for all $\Delta \in \mathbb{T}_{n}$, then $\widetilde{G}(\Delta)>0$ for all $\Delta \in \mathbb{T}_{n} \cup \mathbb{W}_{n}$.
Note that for $\widehat{\Theta}_{n} \in \mathcal{S}_{++}^{p} \cap \mathcal{S}_{E}^{p}$, we have $\widehat{\Delta}=\widehat{\Theta}_{n}-\widetilde{\Theta}_{0} \in U_{n}\left(\widetilde{\Theta}_{0}\right)$. By Proposition 26 and the fact that $\widetilde{G}(\widehat{\Delta}) \leq \widetilde{G}(\underline{0})=0$ on event $\mathcal{E}$, we have the following: on event $\mathcal{E}$, if $\widetilde{G}(\Delta)>0, \forall \Delta \in \mathbb{T}_{n}$
then $\|\widehat{\Delta}\|_{F}<M r_{n}$, given that $\widehat{\Delta} \in U_{n}\left(\widetilde{\Theta}_{0}\right) \backslash\left(\mathbb{T}_{n} \cup \mathbb{W}_{n}\right)$. Therefore

\begin{aligned}
\mathbb{P}\left(\|\widehat{\Delta}\|_{F} \geq M r_{n}\right) & \leq \mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}(\mathcal{E}) \cdot \mathbb{P}\left(\|\widehat{\Delta}\|_{F} \geq M r_{n} \mid \mathcal{E}\right) \\
& =\mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}(\mathcal{E}) \cdot\left(1-\mathbb{P}\left(\|\widehat{\Delta}\|_{F}<M r_{n} \mid \mathcal{E}\right)\right) \\
& \leq \mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}(\mathcal{E}) \cdot\left(1-\mathbb{P}\left(\widetilde{G}(\Delta)>0, \forall \Delta \in \mathbb{T}_{n} \mid \mathcal{E}\right)\right) \\
& \leq \mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}(\mathcal{E}) \cdot\left(1-\mathbb{P}\left(\mathcal{X}_{0} \mid \mathcal{E}\right)\right) \\
& =\mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}\left(\mathcal{X}_{0}^{c} \cap \mathcal{E}\right) \leq \mathbb{P}\left(\mathcal{E}^{c}\right)+\mathbb{P}\left(\mathcal{X}_{0}^{c}\right) \\
& \leq \frac{c}{p^{2}}+\frac{1}{\max (n, p)^{2}} \leq \frac{c+1}{p^{2}}
\end{aligned}
$$

We thus establish that the theorem holds.

## D. 3 Frobenius norm for the covariance matrix

We use the bound on $\left\|\widehat{\Theta}_{n}(E)-\Theta_{0}\right\|_{F}$ as developed in Theorem 19; in addition, we strengthen the bound on $M r_{n}$ in (82) in (85). Before we proceed, we note the following bound on bias of $\left(\widetilde{\Theta}_{0}\right)^{-1}$.

Remark 27 Clearly we have on event $\mathcal{E}$, by (80)

\end{equation*}

Proof of Theorem 20. Suppose event $\mathcal{E} \cap \mathcal{X}_{0}$ holds. Now suppose

which clearly holds given (68). Then in addition to the bound in (82), on event $\mathcal{E} \cap \mathcal{X}_{0}$, we have

given that sample bound in (66) is clearly satisfied. We now proceed to bound $\left\|\widehat{\Sigma}_{n}-\Sigma_{0}\right\|_{F}$ given (67). First note that by (85), we have on event $\mathcal{E} \cap \mathcal{X}_{0}$ for $M>7$

& \geq \underline{c}-(M+1) r_{n}>\underline{c} / 2 .
\end{aligned}

Now clearly on event $\mathcal{E} \cap \mathcal{X}_{0}$, (69) holds by (67) and

## D. 4 Risk consistency

We now derive the bound on risk consistency. Before proving Theorem 21, we first state two lemmas given the following decomposition of our loss in terms of the risk as defined in (17):

\end{equation*}

where clearly $R\left(\widehat{\Theta}_{n}(E)\right) \geq R\left(\Theta_{0}\right)$ by definition. It is clear that $\widetilde{\Theta}_{0} \in \mathcal{S}_{n}$ for $\mathcal{S}_{n}$ as defined in (31), and thus $\widehat{R}_{n}\left(\widetilde{\Theta}_{0}\right) \geq \widehat{R}_{n}\left(\widehat{\Theta}_{n}(E)\right)$ by definition of $\widehat{\Theta}_{n}(E)=\arg \min _{\Theta \in S_{n}} \widehat{R}_{n}(\Theta)$.
We now bound the two terms on the RHS of (86), where clearly $R\left(\widetilde{\Theta}_{0}\right) \geq R\left(\Theta_{0}\right)$.

for $r_{n}$ as in (76), where the last inequality holds given that $M \geq 9 / 2\left(4 C_{3}+32 /\left(31 \underline{c}^{2}\right)\right)$.
Lemma 29 Under $\mathcal{E} \cap \mathcal{X}_{0}$, we have for $r_{n}$ as in (76) and $M, C_{3}$ as in Theorem 19

where $\widetilde{B}=0$ holds when $\left\|\Delta_{0}\right\|_{F}=0$, and in the last equation, we bound the difference between two $\log |\cdot|$ terms using the Taylor's formula with integral remainder following that in proof of Theorem 19; Indeed, it is clear that on $\mathcal{E}$, we have

& \quad=\frac{1}{2} \sup _{v \in[0,1]} \frac{1}{\varphi_{\min }^{2}\left(\Theta_{0}+v \Delta_{0}\right)}=\frac{1}{2 \inf _{v \in[0,1]} \varphi_{\min }^{2}\left(\Theta_{0}+v \Delta_{0}\right)} \\
& \quad \leq \frac{1}{2\left(\varphi_{\min }\left(\Theta_{0}\right)-\left\|\Delta_{0}\right\|_{2}\right)^{2}} \leq \frac{1}{2(31 \underline{c} / 32)^{2}}
\end{aligned}

& =\operatorname{tr}\left(\left(\widehat{\Theta}_{n}(E)-\widetilde{\Theta}_{0}\right)\left(\Sigma_{0}-\widehat{\Gamma}_{n}\right)\right)=\operatorname{tr}\left(\widehat{\Delta}\left(\Sigma_{0}-\widehat{\Gamma}_{n}\right)\right)

\end{aligned}

where $\|\operatorname{offd}(\widehat{\Delta})\|_{0} \leq 2|E|$ by definition, and $r_{n}$ is as defined in (76).

## Appendix E. Proof of Theorem 6

& \quad=\left|\frac{\frac{1}{n}\left\langle X_{i} / \sigma_{i}, X_{j} / \sigma_{j}\right\rangle-\rho_{0, i j}}{\left(\left\|X_{i}\right\|_{2} /\left(\sigma_{i} \sqrt{n}\right)\right) \cdot\left(\left\|X_{j}\right\|_{2} /\left(\sigma_{j} \sqrt{n}\right)\right)}+\frac{\rho_{0, i j}}{\left(\left\|X_{i}\right\|_{2} /\left(\sigma_{i} \sqrt{n}\right)\right) \cdot\left(\left\|X_{j}\right\|_{2} /\left(\sigma_{j} \sqrt{n}\right)\right)}-\rho_{0, i j}\right| \\
& \quad \leq\left|\frac{\frac{1}{n}\left\langle X_{i} / \sigma_{i}, X_{j} / \sigma_{j}\right\rangle-\rho_{0, i j}}{\left(\left\|X_{i}\right\|_{2} /\left(\sigma_{i} \sqrt{n}\right)\right) \cdot\left(\left\|X_{j}\right\|_{2} /\left(\sigma_{j} \sqrt{n}\right)\right)}\right|+\left|\frac{\rho_{0, i j}}{\left(\left\|X_{i}\right\|_{2} /\left(\sigma_{i} \sqrt{n}\right)\right) \cdot\left(\left\|X_{j}\right\|_{2} /\left(\sigma_{j} \sqrt{n}\right)\right)}-\rho_{0, i j}\right| \\
& \quad \leq \frac{\tau}{1-\tau}+\left|\rho_{0, i j}\right|\left|\frac{1}{1-\tau}-1\right| \leq \frac{2 \tau}{1-\tau}<4 \tau . \tag{89}

\end{aligned}

For an appropriately chosen $r_{n}$ and a large enough $M>0$, let

It is clear that both $\Pi_{n}$ and $\mathbb{T}_{n} \cup \Pi_{n}$ are convex. It is also clear that $\underline{0} \in \Pi_{n}$. Define for $\Delta \in$ $U_{n}\left(\widetilde{\Omega}_{0}\right)$,

Note also if $\Delta \in \mathbb{T}_{n}$, then $\Delta_{i j}=0 \forall(i, j: i \neq j) \notin E$; Thus we have $\Delta \in \mathcal{S}_{E}^{p}$ and

Proposition 31 Under (36), we have for all $\Delta \in \mathbb{T}_{n}$ such that $\|\Delta\|_{F}=M r_{n}$ for $r_{n}$ as in (76), $\widetilde{\Omega}_{0}+v \Delta \succ 0, \forall v \in$ an open interval $I \supset[0,1]$ on event $\mathcal{E}$.

Proof In view of Proposition 23, it is sufficient to show that $\widetilde{\Omega}_{0}+(1+\varepsilon) \Delta, \widetilde{\Omega}_{0}-\varepsilon \Delta \succ 0$ for some $\varepsilon>0$. Indeed, by definition of $\Delta \in \mathbb{T}_{n}$, we have $\varphi_{\min }\left(\widetilde{\Omega}_{0}+\Delta\right) \succ 0$ on event $\mathcal{E}$; thus

for $\varepsilon>0$ that is sufficiently small.
Thus we have that $\log \left|\widetilde{\Omega}_{0}+v \Delta\right|$ is infinitely differentiable on the open interval $I \supset[0,1]$ of $v$. This allows us to use the Taylor's formula with integral remainder to obtain the following:

Now, the Taylor expansion gives for all $\Delta \in \mathbb{T}_{n}$,

& \leq \frac{1}{\sigma_{\min }^{2}} \frac{\left\|\Theta_{0, \mathcal{D}}\right\|_{F}}{\varphi_{\min }\left(\widetilde{\Theta}_{0}\right) \varphi_{\min }\left(\Theta_{0}\right)} \\
& \leq \frac{C_{\text {bias }} \sqrt{2 S_{0, n} \log p / n}}{12 \sigma_{\min }^{2} \underline{c}^{2} / 13} \leq \frac{13 r_{n}}{12 \sigma_{\min }^{2} \underline{c}^{2}}
\end{aligned}
$$

Now, conditioned on event $\mathcal{X}_{0}$, by (89)

and thus on event $\mathcal{E} \cap X_{0}$, we have $\left|\operatorname{tr}\left(\Delta\left(\widehat{\Gamma}_{n}-\Psi_{0}\right)\right)\right| \leq \delta_{n}|\operatorname{offd}(\Delta)|_{1}$, where $|\operatorname{offd}(\Delta)|_{1} \leq$ $\sqrt{\|\operatorname{offd}(\Delta)\|_{0}}\|\operatorname{offd}(\Delta)\|_{F} \leq \sqrt{2|E|}\|\Delta\|_{F}$, and

Now we have by (91) and (37) following Rothman et al. [2008] (see Page 502, proof of Theorem 1 therein): on event $\mathcal{E}$,

Now on event $\mathcal{E} \cap \mathcal{X}_{0}$, for all $\Delta \in \mathbb{T}_{n}$, we have by (98),(102), (100), and (99),

& =\|\Delta\|_{F}^{2}\left(\frac{2 \underline{k}^{2}}{9 \sigma_{\max }^{4}}-\frac{1}{\|\Delta\|_{F}}\left(4 C_{3} r_{n}+\frac{13 r_{n}}{12 \sigma_{\min }^{2} \underline{c}^{2}}\right)\right) \\
& =\|\Delta\|_{F}^{2}\left(\frac{2 \underline{k}^{2}}{9 \sigma_{\max }^{4}}-\frac{1}{M}\left(4 C_{3}+\frac{13}{12 \sigma_{\min }^{2} \underline{c}^{2}}\right)\right)
\end{aligned}

hence we have $\widetilde{G}(\Delta)>0$ for $M$ large enough, in particular $M=\left(9 \sigma_{\max }^{4} /\left(2 \underline{k}^{2}\right)\right)\left(4 C_{3}+13 /\left(12 \sigma_{\min }^{2} \underline{c}^{2}\right)\right)$ suffices.

The rest of the proof follows that of Theorem 19, see Proposition 26 and the bounds which follow. We thus establish that the theorem holds.

where $\lambda_{\sigma, a, p}=\sigma \sqrt{1+a} \sqrt{(2 \log p) / n}$, where $a \geq 0$. We have (cf. Lemma 34)

We now state Theorem 33, which may be of independent interests as the bounds on $\ell_{2}$ and $\ell_{1}$ loss for the Lasso estimator are stated with respect to the actual sparsity $s_{0}$ rather than $s=|\operatorname{supp}(\beta)|$ as in Bickel et al. [2009, Theorem 7.2]. The proof is omitted as on event $\mathcal{T}_{a} \cap \mathcal{X}$, it follows exactly that of Zhou [2010b, Theorem 5.1] for a deterministic design matrix $X$ which satisfies the RE condition, with some suitable adjustments on the constants.

Theorem 33 (Oracle inequalities of the Lasso) Zhou [2010b] Let $Y=X \beta+\epsilon$, for $\epsilon$ being i.i.d. $N\left(0, \sigma^{2}\right)$ and let $X$ follow (16). Let $s_{0}$ be as in (105) and $T_{0}$ denote locations of the $s_{0}$ largest coefficients of $\beta$ in absolute values. Suppose that $R E\left(s_{0}, 4, \Sigma_{0}\right)$ holds with $K\left(s_{0}, 4, \Sigma_{0}\right)$ and $\rho_{\min }(s)>0$. Fix some $1>\theta>0$. Let $\beta_{\text {init }}$ be an optimal solution to (104) with

\end{aligned}

where $D_{0}$ and $D_{1}$ are defined in (109) and (110) respectively, and $\mathbb{P}\left(\mathcal{X} \cap \mathcal{T}_{a}\right) \geq 1-3 \exp \left(-\bar{c} \theta^{2} n / \alpha^{4}\right)-$ $\left(\sqrt{\pi \log p} p^{a}\right)^{-1}$.

Let $T_{1}$ denote the $s_{0}$ largest positions of $h$ in absolute values outside of $T_{0}$; Let $T_{01}:=T_{0} \cup T_{1}$. The proof of Theorem 33 yields the following bounds on $\mathcal{X} \cap \mathcal{T}_{a}:\left\|h_{T_{01}}\right\|_{2} \leq D_{0} d_{0} \lambda \sigma \sqrt{s_{0}}$ where

We note that implicit in these constants, we have used the concentration bounds for $\Lambda_{\max }\left(3 s_{0}\right)$, $\Lambda_{\max }\left(s-s_{0}\right)$ and $\Lambda_{\min }\left(2 s_{0}\right)$ as derived in Theorem 10, given that (49) holds for $m \leq \max \left(s,\left(k_{0}+\right.\right.$ 1) $s_{0}$ ), where we take $k_{0}>3$. In general, these maximum sparse eigenvalues as defined above will increase with $s_{0}$ and $s$; Taking this issue into consideration, we fix for $c_{0} \geq 4 \sqrt{2}, \lambda_{n}=d_{0} \lambda \sigma$ where
