# ON THE ZEROS OF WENG ZETA FUNCTIONS FOR CHEVALLEY GROUPS 

HASEO KI, YASUSHI KOMORI, AND MASATOSHI SUZUKI


#### Abstract

We prove that all but finitely many zeros of Weng's zeta function for a Chevalley group defined over $\mathbb{Q}$ are simple and on the critical line under some reasonable geometric hypothesis.


## 1. Introduction

Weng zeta functions are new objects in the theory of zeta functions arose from the theory of (periods of) Eisenstein series of reductive algebraic groups $G$ defined over $\mathbb{Q}$. They are defined for every standard maximal parabolic subgroup $P$ of $G$. Roughly Weng zeta functions are linear combinations of products of the complete Riemann zeta-function with rational function coefficients, but they have amazing structures that may come from their origin. We start from the most simple example.

Let $\zeta(s)$ be the Riemann zeta function, and let

$$
\hat{\zeta}(s)=\pi^{-s / 2} \Gamma(s / 2) \zeta(s) .
$$

Let $G=S L(2), P=B=P_{1,1}=\left\{\left(\begin{array}{c}* \\ 0 \\ 0\end{array}\right)\right\} \subset G$ and $K=S O(2)$. (In this case, the Borel subgroup $B$ coincides with the maximal parabolic subgroup $P$.) Let $\mathcal{H}$ be the upper half plane. Usual non-holomorphic Eisenstein series attached to this pair $(G, P)$ is defined by the series

E(s, z)=\sum_{\gamma \in P(\mathbb{Z}) \backslash G(\mathbb{Z})} \Im(\gamma z)^{s}
$$

for $z \in \mathcal{H}, \operatorname{Re}(s)>1$, and then it is continued meromorphically to the whole complex $\mathbb{C}$.
To understand the integral

$$
\int_{\mathcal{F}} E(s, z) d \mu(z)
$$

in a suitable sense is a fundamental problem for the theory of harmonic analysis on $S L(2, \mathbb{Z}) \backslash \mathcal{H}$, where $\mathcal{F}$ is a standard fundamental domain of the action of $G(\mathbb{Z})=S L(2, \mathbb{Z})$ on $\mathcal{H}$. Usually the above integral is studied by using the analytic truncation

\Lambda^{\tau} E(s, z)= \begin{cases}E(s, z), & y \leqslant e^{\tau}, z \in \mathcal{F}, \\ E(s, z)-\left(y^{s}+\frac{\hat{\zeta}(2 s-1)}{\tilde{\zeta}(2 s)} y^{1-s}\right), & y>e^{\tau}, z \in \mathcal{F} .\end{cases}
$$

For every $\tau \geqslant 0$ we have

\int_{\mathcal{F}} \Lambda^{\tau} E(s, z) d \mu(z)=\frac{e^{\tau(s-1)}}{s-1}-\frac{e^{-\tau s}}{s} \frac{\hat{\zeta}(2 s-1)}{\hat{\zeta}(2 s)} .
$$

[^0](Therefore $\int_{\mathcal{F}} E(s, z) d \mu(z)=0$ if $0<\Re(s)<1$.) Multiplying by $s(s-1) \hat{\zeta}(2 s)$ on both sides, we define
\[

\begin{aligned}
Z(s, \tau) & =s(s-1) \cdot \hat{\zeta}(2 s) \cdot \int_{\mathcal{F}} \Lambda^{\tau} E(s, z) d \mu(z) \\
& =e^{\tau(s-1)} s \hat{\zeta}(2 s)-e^{-\tau s}(s-1) \hat{\zeta}(2 s-1)
\end{aligned}
$$
\]

for $\tau \geqslant 0$. The functional equation of $E(z, s)$ derives $Z(s, \tau)=Z(1-s, \tau)$ automatically, but we mention that the functional equation of $E(z, s)$ coming from the symmetry of the Weyl group of $S L(2)$.

A remarkable fact is that all zeros of $Z(s, \tau)$ lie on the line $\Re(s)=1 / 2$ and simple for every fixed $\tau \geqslant 0$ (see [11, [14). Weng zeta functions are of a generalization of the specialization of $Z(s, \tau)$ for $\tau=0$.

Let $G$ be a connected semisimple algebraic group defined and split over $\mathbb{Q}$ and $T$ a ( $\mathbb{Q}$-split) maximal torus of $G$. Let $\Phi$ be the root system with respect to $(G, T)$. Fix a Borel subgroup $B$ of $G$ containing $T$. Then it determines the fundamental system $\Delta$ of $\Phi$. Let $X^{*}(T)$ be the group of characters of $T$ defined over $\mathbb{Q}$ that is a free module of rank $r=\operatorname{dim} T$. Let $\mathfrak{a}_{0}^{*}=X^{*}(T) \otimes \mathbb{R}$ and $\mathfrak{a}_{0}=\operatorname{Hom}\left(X^{*}(T), \mathbb{R}\right)$. Then $\mathfrak{a}_{0}$ and $\mathfrak{a}_{0}^{*}$ are real vector spaces of dimension $r$. The root system $\Phi$ is a finite subset of $X^{*}(T)$, therefore it is canonically embedded in $\mathfrak{a}_{0}^{*}$. For every simple root $\alpha \in \Delta$, we have the coroot $\alpha^{\vee} \in \mathfrak{a}_{0}$.

Let $E(\lambda, g)=E^{G / B}(\mathbf{1}, \lambda, g)$ be Langlands' Eisenstein series for $\lambda \in \mathfrak{a}_{0}^{*} \otimes \mathbb{C} \simeq \mathbb{C}^{r}$ and $g \in G(\mathbb{A})$. Let $\tau \in \mathfrak{a}_{0}$ be a sufficiently regular point in the sense of [2], that is, $\alpha(\tau)$ is positive and large enough for all $\alpha \in \Phi$. Then, by using Arthur's truncation operators $\Lambda^{\tau}$ acting on a space of continuous functions on $G(\mathbb{Q}) \backslash G(\mathbb{A})^{1}$ (see [1, 2]), we obtain the well-defined integral

$$
\int_{G(\mathbb{Q}) \backslash G(\mathbb{A})^{1}} \Lambda^{\tau} E(\lambda, g) d g
$$

which is often called the period of $E(\lambda, g)$. The integral can be calculated explicitly by using the root system $\Phi$ and its Weyl group $W$ of $\Phi$ :

& \int_{G(\mathbb{Q}) \backslash G(\mathbb{A})^{1}} \Lambda^{\tau} E(\lambda, g) d g \\
& \quad=v \sum_{w \in W} e^{\langle w \lambda-\rho, \tau\rangle} \prod_{\alpha \in \Delta} \frac{1}{\left\langle w \lambda-\rho, \alpha^{v}\right\rangle} M(w, \lambda), \tag{1.1}
\end{align*}
$$

where $v$ is the volume of $\left\{\sum_{\alpha \in \Delta} a_{\alpha} \alpha^{\vee} \mid 0 \leqslant a_{\alpha}<1\right\}, \rho$ is the half sum of all positive roots and $M(w, \lambda)$ are usual (unnormalized) intertwining operators $M(w, \lambda): I_{B}(\lambda) \rightarrow I_{B}(w \lambda)$ for $\lambda \in \mathfrak{a}_{0}^{*} \otimes \mathbb{C}$ and $w \in W$. If $G$ is a split semisimple group, we have

$$
M(w, \lambda)=\prod_{\alpha \in \Phi_{w}} \frac{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle\right)}{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle+1\right)}
$$

where $\Phi_{w}=\Phi^{+} \cap w^{-1} \Phi^{-}$(see Chapter 5 of Langlands [15], Jacquet-Lapid-Rogawski [8], and Weng [25]).

Note that we assumed that $G$ is split. Standing on the above formula for the period of $E(\lambda, g)$, Weng introduced the "period" $\omega_{\mathbb{Q}, B}^{(G, T)}: \mathfrak{a}_{0}^{*} \otimes \mathbb{C} \simeq \mathbb{C}^{r} \rightarrow \mathbb{C}$ by

$$
\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)=\sum_{w \in W} \prod_{\alpha \in \Delta} \frac{1}{\left\langle w \lambda-\rho, \alpha^{\vee}\right\rangle} \prod_{\alpha \in \Phi_{w}} \frac{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle\right)}{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle+1\right)}
$$

In this definition, we ignored the volume $v$ and took $\tau=0$ in the right hand side of (1.1). We do not know $\tau=0$ is sufficiently regular or not in general. Therefore we should note that $\omega_{\mathbb{Q}, B}^{(G, T)}$ may not be a period of Eisenstein series in a rigorous meaning. However, we will find that $\omega_{\mathbb{Q}, B}^{(G, T)}$ itself is an interesting object apart from its origin. For instance,
a priori, there is no obvious reason for the restriction $\tau=0$. However it is known that the point $\tau=0$ has a quite special meaning for the distribution of zeros of Weng zeta functions by studying $\tau$-version $\omega_{\mathbb{Q}, B}^{(S L(3), T)}(\lambda ; \tau)$. More precisely, a Weng zeta function corresponding to $\omega_{\mathbb{Q}, B}^{(S L(3), T)}(\lambda ; \tau)$ also satisfies a functional equation for a well-chosen $\tau$ including $\tau=0$, but it may not satisfy the Riemann hypothesis unless $\tau=0$ (see A. 4 of [25] for details). Probably, the most intrinsic reason for $\tau=0$ is the notion of stability which makes a connection between $\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)$ and the theory of semi-stable principal $G$-lattices. One of the consequences of such connection is formulated as the parabolic reduction conjecture ([26, Conjecture 10 and 11] or [27, section 3]) which consists of two basic relations between total volumes of fundamental domains of reductive algebraic groups and semi-stable volumes corresponding to parabolic subgroups. It is a natural and deep conjecture for structures of algebraic groups and is proved for $G=S L(n)$ by Siegel, Kontsevich-Soibelman and Weng [27, Section 2.1]. In particular, (1.1) is justified for $\tau=0$ by the parabolic reduction conjecture if $G=S L(n)$ ([26, Section 2.1]).

The second part of the parabolic reduction conjecture claims that the semi-stable volume can be written as "an alternating sum" of total volumes associated with simple Levi factors of parabolic subgroups, and it brings about the volume hypothesis (6.1) in Section 6 which is a keystone of the main result Theorem 1.1 below. The first part of the parabolic reduction conjecture is a formula of total volume by semi-stable volumes and it is a generalization of classical results of Siegel and Langlands.
$>$ From the point of view for the theory of periods of automorphic functions, it is natural to consider more general "period" by replacing $\hat{\zeta}$ by (completed) $L$-functions attached to Dirichlet characters or automorphic representations. However we restrict our interest only on the above $\omega_{\mathbb{Q}, B}^{(G, T)}$ for the simplicity of arguments.

By definition, the period $\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)$ has a large symmetry with respect to the Weyl group, but it is an $r$-variable function in general $(r=\operatorname{dim} T)$. A priori there is no obvious way to derive a single-variable function from $\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)$ preserving the symmetry of the Weyl group. A discovery of Weng was that there is a canonical way to derive a (conjecturally) nice single-variable function from $\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)$ if we use a standard maximal parabolic subgroup of $G$. The key fact is the bijection

$$
\begin{array}{ccc}
\Delta=\left\{\alpha_{1}, \cdots, \alpha_{\ell}\right\} & \rightarrow & \{\text { maximal parabolic subgroups } P\} \\
\alpha_{j} & \mapsto & P_{j}
\end{array}
$$

We denote by $\alpha_{P}$ the simple root corresponding to the standard maximal parabolic subgroup $P$. Following Weng, we define

$$
\omega_{\mathbb{Q}, P / B}^{(G, T)}(s)=\operatorname{Res}_{\lambda} \omega_{\mathbb{Q}, B}^{(G, T)}(\lambda) \quad\left(s=\left\langle\lambda-\rho, \alpha_{P}^{\vee}\right\rangle\right),
$$

where Res means taking residues along $(r-1)$ many hyperplanes

$$
\left\langle\lambda-\rho, \beta^{\vee}\right\rangle=0, \quad \beta \in \Delta \backslash\left\{\alpha_{P}\right\} .
$$

Then zeta functions for $((G, T) ; P / B) / \mathbb{Q}$ are defined by

$$
\hat{\zeta}_{P}(s):=\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s):=\prod_{k, h} \hat{\zeta}(k s+h) \cdot \omega_{\mathbb{Q}, P / B}^{(G, T)}(s),
$$

where $\prod_{k, h} \hat{\zeta}(k s+h)$ is the "minimal" finite product of $\hat{\zeta}(k s+h)$ in the sense that $\hat{\zeta}_{P}(s)$ has no $\hat{\zeta}(a s+b)$ or $\hat{\zeta}(c)$ in its denominators.

Remark The functions $\omega_{\mathbb{Q}, P / B}^{(G, T)}(\lambda), \omega_{\mathbb{Q}, P / B}^{(G, T)}(s), \hat{\zeta}_{P}(s)$ are written as $\omega_{\mathbb{Q}}^{G}(\lambda), \omega_{\mathbb{Q}}^{G / P}(s)$, $\xi_{\mathbb{Q}, o}^{G / P}(s)$ respectively in [25] and [13].

Here we mention several examples of $\hat{\zeta}_{P}(s)$. Let $P_{n_{1}, n_{2}} \subset S L(n)$ be the maximal parabolic subgroup attached to $n=n_{1}+n_{2}$. Then we find that

$$
\hat{\zeta}_{\mathbb{Q}, P_{n-1,1}}^{S L(n)}(s)=\hat{\zeta}_{\mathbb{Q}, P_{1, n-1}}^{S L(n)}(s)=\sum_{h=1}^{n} \frac{Q_{h}(s)}{P_{h}(s)} \cdot \hat{\zeta}(s+h)
$$

where $P_{h}, Q_{h}$ are polynomials satisfying $\operatorname{deg} P_{h} \leqslant n-1, \operatorname{deg} Q_{h}<\operatorname{deg} P_{h}$ (see also section (4). For example,

$$
\begin{gathered}
\hat{\zeta}_{\mathbb{Q}, P_{1,1}}^{S L(2)}(s)=\frac{\hat{\zeta}(s+2)}{s}-\frac{\hat{\zeta}(s+1)}{s+2} \\
\hat{\zeta}_{\mathbb{Q}, P_{2,1}}^{S L(3)}(s)=\left(\frac{\hat{\zeta}(2)}{s}-\frac{1}{2(s+1)}\right) \hat{\zeta}(s+3)-\frac{\hat{\zeta}(s+2)}{s(s+3)}-\left(\frac{\hat{\zeta}(2)}{s+3}-\frac{1}{2(s+2)}\right) \hat{\zeta}(s+1)
\end{gathered}
$$

In the following examples, each term of $\hat{\zeta}_{P}(s)$ consists of the product of several $\hat{\zeta}(s)$ :

& \hat{\zeta}_{\mathbb{Q}, P_{2,2}}^{S L(4)}(s)=R_{1}(s) \hat{\zeta}(s+3) \hat{\zeta}(s+4)+R_{2}(s) \hat{\zeta}(s+3)^{2} \\
& \quad+R_{3}(s) \hat{\zeta}(s+1) \hat{\zeta}(s+2)+R_{4}(s) \hat{\zeta}(s+2)^{2}+R_{5}(s) \hat{\zeta}(s+2) \hat{\zeta}(s+3) \\
& \hat{\zeta}_{\mathbb{Q}, P_{\text {long }}}^{S p(4)}(s)= \\
& \quad R_{1}(s) \hat{\zeta}(s+3) \hat{\zeta}(2 s+4)+R_{2}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+4) \\
& \quad+R_{3}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+3)+R_{4}(s) \hat{\zeta}(s+1) \hat{\zeta}(2 s+3), \\
& \hat{\zeta}_{\mathbb{Q}, P_{\text {long }}}^{G_{2}}(s)=R_{1}(s) \hat{\zeta}(s+3) \hat{\zeta}(2 s+4) \hat{\zeta}(3 s+6)+R_{2}(s) \hat{\zeta}(s+1) \hat{\zeta}(2 s+3) \hat{\zeta}(3 s+4) \\
& \quad+R_{3}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+4) \hat{\zeta}(3 s+5)+R_{4}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+3) \hat{\zeta}(3 s+5) \\
& \quad+R_{5}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+3) \hat{\zeta}(3 s+4)+R_{6}(s) \hat{\zeta}(s+2) \hat{\zeta}(2 s+4) \hat{\zeta}(3 s+6)

where $R_{i}$ 's are certain rational functions. For more examples, see Appendix A of 25], but note that a changing of variable $s \mapsto a s+b$ is necessary in order to be consistent with the notation in this paper and the right hand sides of (7) and (8) in [25, §A.2] should be exchanged. More generally, if $G=S L(n)$ and $P=P_{n-1,1}$, under certain normalization, the zeta function $\hat{\zeta}_{P}(s)$ is equal to the rank $n$ zeta function over the rational number field $\mathbb{Q}$ which was introduced in [23] as a generalization of Dedekind zeta functions and Artin-Weil zeta functions from a geometric point of view (see [27, Section 1] and also section (4).

By definition, $\hat{\zeta}_{P}(s)$ are meromorphic functions in $\mathbb{C}$ having only finitely many poles. In addition Weng observed that $\hat{\zeta}_{P}(s)$ satisfy standard functional equations for several examples of $((G, T) ; P / B)$, and conjectured that it holds for general pairs (if $G$ is a classical semisimple group at least):
Conjecture 1 There exists $c=c((G, T) ; P / B) \in \mathbb{Q}$ such that $\hat{\zeta}_{P}(-c-s)=\hat{\zeta}_{P}(s)$.
The conjectural functional equation derives the corresponding Riemann hypothesis:
Conjecture 2 All zeros of $\hat{\zeta}_{P}(s)$ lie on the critical line $\Re(s)=-c / 2$.
As for Conjecture 1, initially, Weng proved it for $S L(n)(n=2,3,4,5), S p(4), S O(8)$ and $G_{2}$. Successively, H. Kim-Weng proved the case of ( $S L(n), P_{n-1,1}$ ) for arbitrary $n \geqslant 2$ (unpublished). Finally, the second author established the conjectural functional equations of $\hat{\zeta}_{P}(s)$ for general $((G, T) ; P / B)$, and determined the value $c((G, T) ; P / B)$ explicitly in [13]. As for Conjecture 2, its validity was known for ten examples of $((G, T) ; P / B)$, namely, $G=S L(n)(n=2,3,4,5), S p(4), G_{2}$ and their arbitrary maximal parabolic subgroup $P$, and further, the simplicity of zeros was also known for these pairs (11, 12, 14, 19, 20, 21). This is surprising, because a linear combination of zeta functions has a lot of off-line zeros in general even if it has a functional equation (e.g. [5, 6, 17]).

Roughly, the known proof of Conjecture 2 for the above special cases consists of two parts. The first one is to show that all but finitely many zeros of $\hat{\zeta}_{P}(s)$ lie on the critical line, and the second one is to remove the possibility of off-line zeros. Methods for these two parts have different nature. We may say that the first part is of the problem for the zeros of higher position, and the other part is of the problem for low-lying zeros. The latter problem is difficult and interesting than the former one as well as in the theory of classical zeta/ $L$-functions. In fact, though the proof of the first part for the above ten examples were improved and unified in [12, unfortunately we still need a numerical computation for the latter part. In the present paper, we prove the following result for the first part of Conjecture 2 by generalizing the method of 12 and by using the theory of 13:
Theorem 1.1 (Weak Riemann Hypothesis) Let $G$ be a Chevalley group defined over $\mathbb{Q}$, in other words, $G$ is a connected semisimple algebraic group defined over $\mathbb{Q}$ endowed with a maximal $(\mathbb{Q}$-) split torus $T$. Let $B$ be a Borel subgroup of $G$ containing $T$. Let $P$ be a maximal parabolic subgroup of $G$ defined over $\mathbb{Q}$ containing $B$.

Assume the volume hypothesis (6.1) in Section 6 below if $G \neq S L(n)$.
Then all but finitely many zeros of $\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s)$ are simple and on the critical line of its functional equation.

Remark It is expected that $\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s)$ has no zeros outside the critical line as well as in known cases $G=S L(n)(n=2,3,4,5), S p(4), G_{2}$ that correspond to root systems of type $A_{n}(n=1,2,3,4), C_{2}\left(\simeq B_{2}\right)$ and $G_{2}$. However we have no idea how to prove it in general.
Remark Similar results hold if we replace $\hat{\zeta}(s)$ by a suitable (completed) $L$-function, because we use only standard analytic properties of $\hat{\zeta}(s)$ in the proof.

Remark The volume hypothesis (6.1) is essential for our proof of Theorem 1.1 and is not a technical hypothesis. In fact, it is a part of the parabolic reduction conjecture as mentioned above. Unfortunately, to the best of the authors' knowledge, the volume hypothesis has not been yet proved except for the case $G=S L(n)$ in spite of its significance, but we believe that it is natural and reasonable one. Therefore, we leave it for other work. Conversely, Theorem 1.1 shows a relation between the Riemann hypothesis and the deep structure of algebraic group like the parabolic reduction conjecture.

We note that the known proof of Conjecture 2 about ten examples mentioned just before Theorem 1.1 depends on explicit formulas of $\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s)$ presented by Weng (see [25]). On the other hand, the method of the proof of the functional equation in [13] is completely abstract, and hence it does not depend on an individual root system. In this paper, we will prove the above main theorem in such a way that we refine the proof of the Riemann hypothesis of $\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s)$ demonstrated in [12, 14, 19, 20, 21] by using terms of the abstract root system as well as in the proof of the functional equations in [13].

The paper is organized as follows. In section 2, we rewrite zeta functions $\hat{\zeta}_{\mathbb{Q}, P / B}^{(G, T)}(s)$ in terms of abstract root systems, and define zeta functions more rigorously. In section 3, we sketch the outline of the proof of Theorem [1.1. In section 4, we briefly review the story of the proof of Theorem 1.1 restricting on the most simple cases $\left(S L(n), P_{n-1,1}\right)$. In sections 5 to 7 , we carry out the scheme of section 3 without proofs of lemmas and propositions. The section that the proof of each lemma or proposition is accomplished is mentioned here. In section 8 , we prepare further notations and auxiliary lemmas for the proofs of results in sections 5 to 7 . Finally, in sections 9 to 15 , we fill the details of proofs of lemmas and propositions in sections 5 to 7, and complete the proof of Theorem

## 2. Definition of Weng zeta functions for ( $G, P$ )

2.1. Root system and the Weyl group. Let $V$ be an $r$-dimensional real vector space equipped with an inner product $\langle\cdot, \cdot\rangle$. Let $\Phi \subset V$ be a (reduced) root system of rank $r$ and $\Delta=\left\{\alpha_{1}, \cdots, \alpha_{r}\right\}$, its fundamental system. Let $\alpha^{\vee}=2 \alpha /\langle\alpha, \alpha\rangle$ be the coroot associated with $\alpha \in \Phi$. Let $\Lambda=\left\{\lambda_{1}, \cdots, \lambda_{r}\right\}$ be the set of fundamental weights satisfying $\left\langle\lambda_{i}, \alpha_{j}^{\vee}\right\rangle=\delta_{i j}$. Let $\Phi^{+}$be the corresponding positive system of $\Phi$ and $\Phi^{-}=-\Phi^{+}$so that $\Phi=\Phi^{+} \cup \Phi^{-}$. Let

$$
\rho=\frac{1}{2} \sum_{\alpha \in \Phi^{+}} \alpha=\sum_{j=1}^{r} \lambda_{j}
$$

be the Weyl vector. Let ht $\alpha^{\vee}=\left\langle\rho, \alpha^{\vee}\right\rangle$ be the height of $\alpha^{\vee}$.
Let $W$ be the Weyl group generated by simple reflections $\sigma_{j}=\sigma_{\alpha_{j}}: V \rightarrow V$ attached to simple roots $\alpha_{j} \in \Delta$. We denote the identity of $W$ by id. For $w \in W$, we put

$$
\Phi_{w}=\Phi^{+} \cap w^{-1} \Phi^{-}
$$

and let $l(w)=\left|\Phi_{w}\right|$ be the length of $w$. Let $w_{0}$ be the longest element of $W$. Then we have $w_{0}^{2}=\mathrm{id}, w_{0} \Delta=-\Delta$ and $w_{0} \Phi^{+}=\Phi^{-}$.

We fix an integer $p$ with $1 \leqslant p \leqslant r$. Let $\Phi_{p}$ be the root system normal to the fundamental weight $\lambda_{p}$. A fundamental system of $\Phi_{p}$ is given by $\Delta_{p}=\Delta \backslash\left\{\alpha_{p}\right\}$. Let $\Phi_{p}^{+}=\Phi^{+} \cap \Phi_{p}\left(\subset \Phi^{+}\right)$be the corresponding positive system of $\Phi_{p}$. Then $\Phi_{p}=\Phi_{p}^{+} \cup \Phi_{p}^{-}$ with $\Phi_{p}^{-}=-\Phi_{p}^{+}$. Let

$$
\rho_{p}=\frac{1}{2} \sum_{\alpha \in \Phi_{p}^{+}} \alpha .
$$

Let $W_{p}$ be the subgroup of $W$ generated by simple reflections $\left\{\sigma_{j}=\sigma_{\alpha_{j}} \mid \alpha_{j} \in \Delta_{p}\right\}$. Let $w_{p}$ be the longest element of $W_{p}$. Then $w_{p}^{2}=\mathrm{id}, w_{p} \Delta_{p}=-\Delta_{p}$ and $w_{p} \Phi_{p}^{+}=\Phi_{p}^{-}$.
Definition 2.1 Define the subset $\mathfrak{W}_{p}$ of $W$ by

\mathfrak{W}_{p}:=\left\{w \in W \mid \Delta_{p} \subset w^{-1}\left(\Delta \cup \Phi^{-}\right)\right\} .
$$

Clearly id, $w_{0}, w_{p}$ belong to $\mathfrak{W}_{p}$. The condition

$$
\begin{equation*}
\Delta_{p} \subset w^{-1}\left(\Delta \cup \Phi^{-}\right) \tag{2.1}
\end{equation*}
$$

plays an important role in several places of the proof of Theorem 1.1.
To describe the functional equation, we introduce the constants

$$
\begin{equation*}
c_{p}=2\left\langle\lambda_{p}-\rho_{p}, \alpha_{p}^{\vee}\right\rangle \tag{2.2}
\end{equation*}
$$

as well as [131, section 2]. Then $c_{p}$ is a positive integer for every $1 \leqslant p \leqslant r$.

### 2.2. Definition of Weng zeta functions in terms of abstract root system.

Let $G$ be a connected semisimple algebraic group and let $\mathfrak{g}$ be its Lie algebra of $G$. Let $T$ be a maximal torus of $G$, and let $\mathfrak{g}_{\alpha}=\{X \in \mathfrak{g} \mid \operatorname{Ad}(t) X=\alpha(t) X\}$ for each character $\alpha \in X^{*}(T)$. Then the set $\Phi=\Phi(G, T)=\left\{\alpha \in X^{*}(T) \mid \mathfrak{g}_{\alpha} \neq \emptyset\right\}$ is finite, and makes a root system (in the vector space $X^{*}(T) \otimes \mathbb{R}$ ). Conversely, for a given root system $\Phi$, there exists a connected semisimple algebraic group $G=G(\Phi)$ defined over a prime field having $\Phi$ as its root system with respect to a split maximal torus $T$ of $G$ by the
fundamental theorem of Chevalley. The group $G(\Phi)$ is called a Chevalley group of type $\Phi$ (or split group, since it has a maximal torus which is split over the prime field).

Therefore we can deal with Weng zeta functions for Chevalley groups defined over $\mathbb{Q}$ by using the language of abstract root systems only. Now we define Weng zeta functions again in terms of abstract root systems.

Let $\zeta(s), \hat{\zeta}(s)$ as above, and let

$$
\xi(s)=s(s-1) \hat{\zeta}(s)=s(s-1) \pi^{-s / 2} \Gamma(s / 2) \zeta(s)
$$

Note that Weng [25] and Komori [13] use the notation $\xi(s)$ to indicate our $\hat{\zeta}(s)$ as well as Langlands [15] et al.

Definition 2.2 (Periods for $(\Phi, \Delta)$ ) Let $\Phi$ be an irreducible root system and let $\Delta$ be a fundamental system of $\Phi$. For $\lambda \in V$, we define

\omega_{\Delta}^{\Phi}(\lambda)=\sum_{w \in W} \prod_{\alpha \in \Delta} \frac{1}{\left\langle w \lambda-\rho, \alpha^{\vee}\right\rangle} \prod_{\alpha \in \Phi_{w}} \frac{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle\right)}{\hat{\zeta}\left(\left\langle\lambda, \alpha^{\vee}\right\rangle+1\right)}
$$

Here we understand that the second product equals 1 if $\Phi_{w}=\Phi^{+} \cap w^{-1} \Phi^{-}=\emptyset$.
Definition 2.3 (Periods for $(\Phi, \Delta, p)$ ) Let $\Phi$ be an irreducible root system of rank $r$ with a fundamental system $\Delta=\left\{\alpha_{1}, \cdots, \alpha_{r}\right\}$. Let $1 \leqslant p \leqslant r$. Take the coordinate of $V$ as

$$
\lambda=\sum_{j=1}^{r}\left(1+s_{j}\right) \lambda_{j}=\rho+\sum_{j=1}^{r} s_{j} \lambda_{j} \quad(\lambda \in V)
$$

so that $\left\langle\lambda-\rho, \alpha^{\vee}\right\rangle=\sum_{j=1}^{r} a_{j} s_{j}$ for $\alpha^{\vee}=\sum_{j=1}^{r} a_{j} \alpha_{j}^{\vee}$, and write $\Delta_{p}=\left\{\beta_{1}, \cdots, \beta_{r-1}\right\}$. Then we define $\omega_{p}: \mathbb{C} \rightarrow \mathbb{C}$ by

$$
\begin{align*}
\omega_{p}(s)=\omega_{\Delta, p}^{\Phi}(s) & =\underset{\left\langle\lambda-\rho, \beta_{1}^{V}\right\rangle=0}{\operatorname{Res}} \cdots \underset{\left\langle\lambda-\rho, \beta_{r-1}^{\vee}\right\rangle=0}{\operatorname{Res}} \omega_{\Delta}^{\Phi}(\lambda) \\
& =\underset{s_{1}=0}{\operatorname{Res}} \cdots \underset{s_{p-1}=0}{\operatorname{Res}} \underset{s_{p+1}=0}{\operatorname{Res}} \cdots \operatorname{Res}_{s_{r}=0}^{\operatorname{Res}} \omega_{\Delta}^{\Phi}(\lambda), \tag{2.3}
\end{align*}
$$

where the variable $s_{p}$ is written as $s$.
Remark The function $\omega_{p}(s)$ is well defined, since it does not depend on the ordering of the set of simple roots $\Delta_{p}$ by Proposition 2.2 of [13].
Remark Let $G=G(\Phi)$ be a Chevalley group, and let $B$ a Borel subgroup containing the maximal split torus $T$. Let $P(\supset B)$ be a maximal parabolic subgroup of $G$ corresponding to the simple root $\alpha_{p}$. Then functions $\omega_{\Delta}^{\Phi}(\lambda)$ and $\omega_{\Delta, p}^{\Phi}(s)$ are the periods $\omega_{\mathbb{Q}, B}^{(G, T)}(\lambda)$ and $\omega_{\mathbb{Q}, P / B}^{(G, T)}(s)$ respectively.

Definition 2.4 For $w \in \mathfrak{W}_{p}$ and $(k, h) \in \mathbb{Z}^{2}$, we define

$$
\begin{aligned}
N_{p, w}(k, h) & =\sharp\left\{\alpha \in w^{-1} \Phi^{-} \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle=k, \text { ht } \alpha^{\vee}=h\right\}, \\
N_{p}(k, h) & =\sharp\left\{\alpha \in \Phi \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle=k, \text { ht } \alpha^{\vee}=h\right\}
\end{aligned}
$$

and

$$
M_{p}(k, h)=\max _{w \in \mathfrak{W}_{p}}\left(N_{p, w}(k, h-1)-N_{p, w}(k, h)\right)
$$

If $k \geqslant 1$ or $h \geqslant 1$, we have

$$
\begin{aligned}
& N_{p, w}(k, h)=\sharp\left\{\alpha \in \Phi_{w} \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle=k, \text { ht } \alpha^{\vee}=h\right\}, \\
& N_{p}(k, h)=\sharp\left\{\alpha \in \Phi^{+} \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle=k, \text { ht } \alpha^{\vee}=h\right\},
\end{aligned}
$$

because a root $\alpha \in \Phi$ is either $\alpha \in \Phi^{+}$or $\alpha \in \Phi^{-}$.

Definition 2.5 (Weng zeta function for $(\Phi, \Delta, p)$ ) Using the above notation, we define

$$
\hat{\zeta}_{p}(s)=\hat{\zeta}_{\Delta, p}^{\Phi}(s)=\omega_{p}(s) \prod_{k=0}^{\infty} \prod_{h=2}^{\infty} \hat{\zeta}(k s+h)^{M_{p}(k, h)}
$$

Remark Note that $M_{p}(k, h)=0$ except for finitely many pairs of integers $(k, h)$. The function $\hat{\zeta}_{p}(s)$ coincides with the zeta function $\xi_{\mathbb{Q}, o}^{G / P}(s)$ of [25] if $\Phi$ is the root system attached to $(G, T)$ and $\alpha_{p}$ corresponds to the maximal parabolic $P$. Moreover, we find that the numbers $I(G / P)$ and $J(G / P)$ defined in [25, section 2] are given by

$$
I(G / P)=\sum_{(k, h) \in \mathbb{Z}^{2}, k \neq 0} M_{p}(k, h), \quad J(G / P)=\sum_{h \in \mathbb{Z}} M_{p}(0, h)
$$

because the product $\prod_{k=0}^{\infty} \prod_{h=2}^{\infty} \hat{\zeta}(k s+h)^{M_{p}(k, h)}$ is minimal in the sense that it eliminates all $\hat{\zeta}(a s+b)$ and $\hat{\zeta}(c)$ appearing in the denominators of $\omega_{p}(s)$ ( 13 , Theorem 2.3, section 5]).

Remark We will have $M_{p}(k, h)=N_{p, w_{0}}(k, h-1)-N_{p, w_{0}}(k, h)$ in Corollary 8.7 below.
Theorem 2.6 (Komori, Theorem 2.4 of (13]) Let $c_{p}$ be the constant defined in (2.2). Then $\hat{\zeta}_{p}(s)$ satisfies the functional equation

$$
\hat{\zeta}_{p}(s)=\hat{\zeta}_{p}\left(-c_{p}-s\right)
$$

Remark See Appendix 2 for table of numbers $c_{p}$. The numbers $c_{p}$ can be interpreted geometrically in terms of the first Chern class of tangent bundles on a homogeneous space or an index of a homogeneous space. See Appendix 3 for details.

Now the reformulation of Theorem 1.1 in terms of $\hat{\zeta}_{p}(s)$ is obvious, thus we omit such a direct reformulation of Theorem 1.1. See Theorem 7.4 and Theorem 7.5 that are reformulations of Theorem 1.1 in terms of entire functions $\xi_{p}(s)$ defined below.

## 3. Outline of the proof

Define the entire function $\xi_{p}(s)=Q(s) \hat{\zeta}_{p}(s)$ by multiplying a suitable polynomial.

1. At first we construct an entire function $\varepsilon_{p}(s)$ satisfying
$(\star) \quad \xi_{p}(s)=\varepsilon_{p}(s) \pm \varepsilon_{p}\left(-c_{p}-s\right)$.
Here the sign $\pm$ depends on the degree of $Q(s)$. The formula ( $\star$ ) plays a central role on the current line of the proof. More precisely, Theorem 1.1 is reduced to a study of the location of zeros of $\varepsilon_{p}(s)$ by $(\star)$, and fortunately, it is less hard to investigate the zeros of $\varepsilon_{p}(s)$ than $\hat{\zeta}_{p}(s)$. A kind of the formula $(\star)$ was used in every (known) proof of the Riemann hypothesis of $\hat{\zeta}_{p}(s)$ for $G=S L(n)(n=2,3,4,5), S p(4), G_{2}$. This step is described more precisely in section 5 .
2. Successively we investigate the location of the zeros of $\varepsilon_{p}(s)$. The aim of this second step is to show that
(i) the number of zeros of $\varepsilon_{p}(s)$ in $\Re(s) \geqslant-c_{p} / 2$ is finitely many,
(ii) in a left half-plane, $\varepsilon_{p}(s)$ has no zero in a region $\Re(s) \leqslant-\kappa \log (|\Im(s)|+10)$.

This step is described more precisely in section 6 .
3. Finally we prove Theorem 1.1 by using the results of the second step. The main tool of this step is the Hadamard product formula of $\varepsilon_{p}(s)$. Essentially this part is a modification of the method which was established in [12] by the first author. This step is described more precisely in section 7

The most essential part of our proof of Theorem 1.1 is in the second step. To complete the proof of the second step, we need a detailed study of a structure of $\mathbb{Z}$-grading of root
systems $\Phi($ or $\operatorname{Lie}(G))$ induced from fundamental weights $\lambda_{p}$. We review the flow from the first step to the second step in the next section by taking up the cases of ( $S L(n), P_{n-1,1}$ ) as an example.

The first step is established by an algebraic way via the general theory of root systems and Weyl groups attached to maximal parabolic subgroups $P$. The argument of the final step is achieved by a purely analytic way. Frequently, basic analytic properties of $\zeta(s)$ will be used in demonstrating Theorem 1.1.

## 4. Cases of $\left(S L(n), P_{n-1,1}\right)$

Let $P=P_{n-1,1}=\left\{\left.\left(\begin{array}{cc}A & B \\ 0 & D\end{array}\right) \in S L(n) \right\rvert\, A \in G L(n-1), D \in G L(1)\right\}$ be the standard maximal parabolic subgroup of $G=S L(n)$ attached to the partition $n=(n-1)+1$. For these special cases, Theorem 1.1 was established by Weng (unpublished) after the work of the first author [12]. As a review of the proof of general cases, we sketch the proof of Theorem 1.1 for these special cases restricting it on the first and the second step.

Let $B$ be the standard Borel subgroup consisting of upper triangular matrices, and let $T$ be the standard split torus in $B$, that is, the torus consisting of diagonal matrices. The root system $\Phi$ associated with $T$ is of type $A_{n-1}$, and is realized as $\Phi^{+}=\left\{e_{i}-e_{j} \mid 1 \leqslant\right.$ $i<j \leqslant n\}$, where $\left\{e_{i} \mid 1 \leqslant i \leqslant n\right\}$ is the standard orthonormal basis of $\mathbb{R}^{n}$. The set of simple roots $\Delta$ associated with $B$ is $\Delta=\left\{\alpha_{1}:=e_{1}-e_{2}, \cdots, \alpha_{n-1}:=e_{n-1}-e_{n}\right\}$, and the half sum of positive roots is

$$
\rho=\frac{1}{2}\left((n-1) e_{1}+(n-3) e_{2}+\cdots-(n-3) e_{n-1}-(n-1) e_{n}\right) .
$$

The Weyl group $W$ is identified with the symmetric group on $n$ letters $S_{n}$ by the convention $w\left(e_{i}-e_{j}\right)=e_{w(i)}-e_{w(j)}\left(w \in S_{n}\right)$. The longest element $w_{0}$ of $W$ is given by the permutation $\left(\begin{array}{cccc}1 & 2 & \cdots & n \\ n & n-1 & \cdots & 1\end{array}\right)$, and $-w_{0} \rho=\rho$. The maximal parabolic subgroup $P=P_{n-1,1}$ corresponds to the simple root $\alpha_{n-1}=e_{n-1}-e_{n}$, and has the Levi decomposition $P=M N$ with $M \simeq G L(n-1)$. We have

$$
\begin{aligned}
\Phi_{P}^{+} & =\Phi_{n-1}^{+}=\left\{e_{i}-e_{j} \mid 1 \leqslant i<j \leqslant n-1\right\}, \quad \Delta_{P}=\Delta_{n-1}=\left\{\alpha_{1}, \cdots, \alpha_{n-2}\right\}, \\
\rho_{P} & =\rho_{n-1}=\frac{1}{2}\left((n-2) e_{1}+(n-4) e_{2}+\cdots-(n-4) e_{n-2}-(n-2) e_{n-1}\right),
\end{aligned}
$$

and the fundamental weight corresponding to $P$ is

$$
\lambda_{P}=\lambda_{n-1}=\frac{1}{n}\left(e_{1}+\cdots+e_{n-1}-(n-1) e_{n}\right) .
$$

The Weyl group $W_{P}=W_{n-1}$ is the subgroup of $W$ which corresponds to the symmetric group on ( $n-1$ ) letters $\{1,2, \cdots, n-1\}$. The longest element $w_{P}=w_{n-1}$ of $W_{P}$ is given by the permutation $\left(\begin{array}{cccc}1 & 2 & \cdots & n-1 \\ n-1 & n-2 & \cdots & 1\end{array}\right)$, and $-w_{P} \rho_{P}=\rho_{P}$.

Comparing with general cases, structures of $\left(\Phi^{+} \backslash \Phi_{P}^{+}\right) \cap w^{-1} \Phi^{ \pm}$and $\Phi_{P}^{+} \cap w^{-1} \Phi^{ \pm}$ $(w \in W)$ in the present case are rather simple, therefore it is not hard to find that $\prod_{h=2}^{n-1} \hat{\zeta}(h) \cdot \hat{\zeta}(s+n)$ is the minimal product of zeta functions and zeta values which eliminates all zeta functions and zeta values in the denominator of each term of $\omega_{\mathbb{Q}, P / B}^{(G, T)}(s)$. Hence we have

$$
\hat{\zeta}_{P}(s)=\omega_{\mathbb{Q}, P / B}^{(G, T)}(s) \prod_{h=2}^{n-1} \hat{\zeta}(h) \cdot \hat{\zeta}(s+n) .
$$

More precisely, we obtain

$$
\hat{\zeta}_{P}(s)=\sum_{h=1}^{n} R_{h}(s) \hat{\zeta}(s+h)
$$

with rational functions

$$
R_{h}(s)=\sum_{\substack{w \in \mathfrak{N S}_{P} \\\left|\left(\Phi^{+} \backslash \Phi_{P}^{+}\right) \cap w^{-1} \Phi^{+}\right|=h-1}} C_{w} \prod_{\alpha \in\left(w^{-1} \Delta\right) \backslash \Phi_{P}} \frac{1}{\left\langle\lambda_{P}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}-1},
$$

where $\mathfrak{W}_{P}=\left\{w \in W \mid w \Delta_{P} \subset \Delta \cup \Phi^{-}\right\}$and

$$
C_{w}=\prod_{\alpha \in\left(w^{-1} \Delta\right) \cap\left(\Phi_{P} \backslash \Delta_{P}\right)} \frac{1}{\mathrm{ht} \alpha^{\vee}-1} \quad \hat{\zeta}(2)^{\left|\Delta_{P}^{+} \cap w^{-1} \Phi^{+}\right|} \prod_{\alpha \in\left(\Phi_{P}^{+} \backslash \Delta_{P}\right) \cap w^{-1} \Phi^{+}} \frac{\hat{\zeta}\left(\mathrm{ht} \alpha^{\vee}+1\right)}{\hat{\zeta}\left(\mathrm{ht} \alpha^{\vee}\right)}
$$

The constant $c_{p}$ appearing in the functional equation (2.2) is calculated as follows:

c_{P}=2\left\langle\lambda_{P}-\rho_{P}, \alpha_{P}^{\vee}\right\rangle=n
$$

We have $R_{h}(-n-s)=R_{h}(s)$ for every $1 \leqslant h \leqslant n$ by considering the involution $w \mapsto w_{0} w w_{P}$ of $\mathfrak{W}_{P}$ according to [13, section 4]. Hence we obtain the functional equation

$$
\hat{\zeta}_{P}(s)=\hat{\zeta}_{P}(-n-s)
$$

by using the functional equation of $\hat{\zeta}(s)$. Define

$$
\xi_{P}(s)=\prod_{k=0}^{n}(s+k) \cdot \hat{\zeta}_{P}(s)
$$

Then we find that $\xi_{P}(s)$ is an entire function, and each

$$
P_{h}(s):=\frac{1}{(s+h)(s+h-1)} R_{h}(s) \prod_{k=0}^{n}(s+k) \quad(1 \leqslant h \leqslant n)
$$

is a polynomial. Set

$$
\varepsilon_{P}(s)= \begin{cases}\sum_{h=n / 2}^{n} P_{h}(s) \xi(s+h) & n \text { is even } \\ \sum_{h=(n+3) / 2}^{n} P_{h}(s) \xi(s+h)+\frac{1}{2} P_{\frac{n+1}{2}}(s) \xi\left(s+\frac{n+1}{2}\right), & n \text { is odd }\end{cases}
$$

with $\xi(s)=s(s-1) \hat{\zeta}(s)$. Then we have

$$
\xi_{P}(s)=\varepsilon_{P}(s)+(-1)^{n-1} \varepsilon_{P}(-n-s)
$$

by the functional equation of $\hat{\zeta}_{P}(s)$. This is the formula $(\star)$ of section 3 ,
By definition, we have

\varepsilon_{P}(s)=\left\{\begin{array}{l}
P_{2}(s) \xi(s+2), \quad n=2 \\
P_{n}(s) \xi(s+n)\left(1+\sum_{h=n / 2}^{n-1} \frac{P_{h}(s)}{P_{n}(s)} \frac{\xi(s+h)}{\xi(s+n)}\right) \\
n>2 \text { is even, } \\
P_{n}(s) \xi(s+n)\left(1+\sum_{h=(n+3) / 2}^{n-1} \frac{P_{h}(s)}{P_{n}(s)} \frac{\xi(s+h)}{\xi(s+n)}+\frac{1}{2} \frac{P_{\frac{n+1}{2}}^{P_{n}(s)}}{P_{n}(s)} \frac{\xi\left(s+\frac{n+1}{2}\right)}{\xi(s+n)}\right) \\
n \text { is odd. }
\end{array}\right.
$$

It is well known that $\xi(s)$ has no zeros in the right half plane $\Re(s) \geqslant 1$. Thus $\xi(s+n)$ has no zeros in the right half plane $\Re(s) \geqslant-n / 2$. Furthermore $|\xi(s+h) / \xi(s+n)|<1$ for $\Re(s)>-(h+n-1) / 2$ (see Lemma 9.1 below). Therefore, if

$$
\begin{equation*}
\operatorname{deg} P_{n}(s) \geqslant \operatorname{deg} P_{h}(s)+1 \quad \text { for every } 1<h<n \tag{4.1}
\end{equation*}
$$

we can conclude that the number of zeros of $\varepsilon_{P}(s)$ in the right half plane $\Re(s) \geqslant-n / 2$ is finitely many. This is $\mathbf{2}$ (i) of section 3. It is not hard to find that $\operatorname{deg} P_{h}(s) \leqslant n-3$ for every $1<h<n(n \geqslant 3)$ (see Lemma 10.1). Therefore, we have inequality (4.1) if $\operatorname{deg} P_{n}(s)=n-2$. However, it is not trivial to prove $\operatorname{deg} P_{n}(s)=n-2$ for general $n \geqslant 2$. In fact, by definition of $P_{n}(s)$, it is equivalent to the nonvanishing of the $\mathbb{Q}$-linear combination of products of special values of $\hat{\zeta}(s)$ :

\sum_{\substack{w \in \mathfrak{W J}_{P} \\\left|\left(\Phi+\backslash \Phi_{P}^{+}\right) \cap w^{-1} \Phi^{+}\right|=n-1}} C_{w} \prod_{\substack{\alpha \in\left(w^{-1} \Delta\right) \backslash \Phi_{P} \\\left|\left(w^{-1} \Delta\right) \backslash \Phi_{P}\right|=1}} \frac{1}{\left\langle\lambda_{P}, \alpha^{\vee}\right\rangle} \neq 0
$$

and it is highly nontrivial. Fortunately, in the case of $S L(n)$, this problem were solved by using the volume formula of [24, section 4.7] (see the volume hypothesis (6.1) in section 6 and the proof of Lemma 10.3 in section 10). In contrast with 2 (i), 2 (ii) is provided easily by using the Stirling formula for the gamma function.

## 5. The first step of the proof of Theorem 1.1

5.1. A modification to entire functions. The zeta function $\hat{\zeta}_{\Delta, p}^{\Phi}(s)$ is meromorphic on $\mathbb{C}$ and has finitely many poles. In order to prove Theorem 1.1 we consider the entire function $\xi_{\Delta, p}^{\Phi}(s)$ which is a polynomial multiple of $\hat{\zeta}_{\Delta, p}^{\Phi}(s)$.

At first, we recall formula (2.8) of [13]:

& \times \prod_{\alpha \in \Phi_{w} \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right) \prod_{\alpha \in\left(-\Phi_{w}\right)} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right)^{-1}
\end{aligned}
$$

Here we understand that each product equals 1 if its index set is empty.
Definition 5.1 We define the product of zeta functions

$$
F_{p}(s):=\prod_{\alpha \in \Phi^{-}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\operatorname{ht} \alpha^{\vee}\right)
$$

and the meromorphic function

$$
Z_{p}(s):=F_{p}(s) \omega_{\Delta, p}^{\Phi}(s)
$$

Then we have

$$
Z_{p}(s)=\sum_{w \in \mathfrak{W}_{p}} f_{p, w}(s) g_{p, w}(s)
$$

with rational functions $f_{p, w}$ and products of zeta functions $g_{p, w}$ :

$$
\begin{aligned}
& f_{p, w}(s)=\prod_{\alpha \in\left(w^{-1} \Delta\right) \backslash \Delta_{p}} \frac{1}{\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\operatorname{ht} \alpha^{\vee}-1}, \\
& g_{p, w}(s)=\prod_{\alpha \in\left(w^{-1} \Phi^{-}\right) \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\operatorname{ht} \alpha^{\vee}\right),
\end{aligned}
$$

since $\Phi^{-} \backslash \Phi_{w}=\Phi^{-} \cap w^{-1} \Phi^{-}$and $\left(\Phi_{w} \backslash \Delta_{p}\right) \cup\left(\Phi^{-} \backslash \Phi_{w}\right)=\left(w^{-1} \Phi^{-}\right) \backslash \Delta_{p}$.

We modify the above formula of $g_{p, w}$ so that all coefficients $\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle$ of $s$ in $g_{p, w}$ will be nonnegative integers. We see that $g_{p, w}(s)$ is

\begin{aligned}
& \prod_{\alpha \in\left(w^{-1} \Phi^{-}\right) \cap \Phi^{-}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right) \prod_{\alpha \in\left(\left(w^{-1} \Phi^{-}\right) \cap \Phi^{+}\right) \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right) \\
= & \prod_{\alpha \in\left(w^{-1} \Phi^{-}\right) \cap \Phi^{-}} \hat{\zeta}\left(1-\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s-\mathrm{ht} \alpha^{\vee}\right) \prod_{\alpha \in\left(\left(w^{-1} \Phi^{-}\right) \cap \Phi^{+}\right) \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right) \\
= & \prod_{\alpha \in\left(w^{-1} \Phi^{-}\right) \cap \Phi^{-}} \hat{\zeta}\left(\left\langle\lambda_{p},-\alpha^{\vee}\right\rangle s+\mathrm{ht}\left(-\alpha^{\vee}\right)+1\right) \prod_{\alpha \in\left(\left(w^{-1} \Phi^{-}\right) \cap \Phi^{+}\right) \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right) \\
= & \prod_{\alpha \in\left(w^{-1} \Phi^{+}\right) \cap \Phi^{+}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right) \prod_{\alpha \in\left(\left(w^{-1} \Phi^{-}\right) \cap \Phi^{+}\right) \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right)
\end{aligned}
$$

for each $w \in \mathfrak{W}_{p}$ by using the functional equation $\hat{\zeta}(s)=\hat{\zeta}(1-s)$. Then all coefficients $\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle$ in the last line are nonnegative integers:

\end{equation*}
$$

for each $w \in \mathfrak{W}_{p}$. Note that $\Phi^{+} \backslash \Phi_{w}=\Phi^{+} \cap w^{-1} \Phi^{+}$. Define

\delta_{\alpha, w}= \begin{cases}1 & \text { if } \alpha \in w^{-1} \Phi^{+}  \tag{5.2}\\ 0 & \text { if } \alpha \in w^{-1} \Phi^{-}\end{cases}

Then formula (5.1) is written as

g_{p, w}(s)=\hat{\zeta}(2)^{\left|\Delta_{p} \cap w^{-1} \Phi^{+}\right|} \prod_{\alpha \in \Phi^{+} \backslash \Delta_{p}} \hat{\zeta}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)
$$

We define entire functions $\tilde{X}_{p, w}(s)$ by replacing $\hat{\zeta}(s)$ of $g_{p, w}$ by $\xi(s)$ :

\tilde{X}_{p, w}(s)=\xi(2)^{\left|\Delta_{p} \cap w^{-1} \Phi^{+}\right|} \prod_{\alpha \in \Phi^{+} \backslash \Delta_{p}} \xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}\right) \tag{5.3}
\end{equation*}
$$

Obviously, we have

& \tilde{X}_{p, w}(s)=2^{\left|\Delta_{p} \cap w^{-1} \Phi^{+}\right|} g_{p, w}(s) \\
& \times \prod_{\alpha \in \Phi^{+} \backslash \Delta_{p}}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\operatorname{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}-1\right) .
\end{aligned}
$$

Define the polynomial $Q_{p}(s)$ by

$$
\begin{aligned}
Q_{p}(s)=\prod_{w \in \mathfrak{W}_{p}} & {\left[2^{\left|\Delta_{p} \cap w^{-1} \Phi^{+}\right|} \prod_{\alpha \in\left(w^{-1} \Delta\right) \backslash \Delta_{p}}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}-1\right)\right.} \\
& \left.\times \prod_{\alpha \in \Phi^{+} \backslash \Delta_{p}}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}-1\right)\right]
\end{aligned}
$$

Definition 5.2 Under the above notation, we define

X_{p}(s):=Q_{p}(s) Z_{p}(s)
$$

By definitions $X_{p}(s)$ is an entire function having the form

$$
X_{p}(s)=\sum_{w \in \mathfrak{W}_{p}} \tilde{Q}_{p, w}(s) \tilde{X}_{p, w}(s)
$$

where $\tilde{Q}_{p, w}(s)$ are polynomials given by

\begin{aligned}
\tilde{Q}_{p, w}(s)=\prod_{w \neq v \in \mathfrak{W}_{p}} & {\left[2^{\left|\Delta_{p} \cap v^{-1} \Phi^{+}\right|} \prod_{\alpha \in\left(v^{-1} \Delta\right) \backslash \Delta_{p}}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}-1\right)\right.} \\
& \left.\times \prod_{\alpha \in \Phi^{+} \backslash \Delta_{p}}\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, v}\right)\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, v}-1\right)\right]
\end{aligned}
$$

Remark Note that the polynomial $Q_{p}(s)$ is not minimal in the sense that the polynomial of the lowest degree such that $Q(s) Z_{p}(s)$ has no poles. In fact $\tilde{Q}_{p, w}(s)\left(w \in \mathfrak{W}_{p}\right)$ has a lot of common divisors as well as $\tilde{X}_{p, w}(s)$.

Now we modify $\tilde{X}_{p, w}(s)$ and $\tilde{Q}_{p, w}(s)$ a little. Define

$$
\begin{align*}
& C_{p, w}=\xi(2)^{\left|\Delta_{p} \cap w^{-1} \Phi^{+}\right|} \prod_{\alpha \in \Phi_{p}^{+} \backslash \Delta_{p}} \xi\left(\operatorname{ht} \alpha^{\vee}+\delta_{\alpha, w}\right),  \tag{5.4}\\
& X_{p, w}(s)=\prod_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\operatorname{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)
\end{align*}
$$

and

$$
Q_{p, w}(s)=C_{p, w} \tilde{Q}_{p, w}(s)
$$

Then we have

$$
\tilde{X}_{p, w}(s)=C_{p, w} X_{p, w}(s)
$$

and

$$
X_{p}(s)=\sum_{w \in \mathfrak{W}_{p}} Q_{p, w}(s) X_{p, w}(s)
$$

Lemma 5.3 Let $c_{p}$ be the number defined in (2.2). Let $w_{0}$ (resp. $w_{p}$ ) be the longest element of $W$ (resp. $W_{p}$ ). Then the functional equations

Q_{p}\left(-c_{p}-s\right) & =\epsilon_{p} Q_{p}(s)
\end{aligned}
$$

hold for every $w \in \mathfrak{W}_{p}$ for a suitable choice of sign $\epsilon_{p} \in\{ \pm 1\}$ depending only on $p$. In particular we have the functional equation

X_{p}\left(-c_{p}-s\right)=\epsilon_{p} X_{p}(s)
$$

Proof. This is a consequence of Lemma 5.3 of 13 .
5.2. Decomposition of $X_{p}(s)$. The aim of this part is a construction of an entire function $E_{p}(s)$ satisfying

where $\epsilon_{p}$ is the sign of Lemma 5.3,
Definition 5.4 For $w \in \mathfrak{W}_{p}$, we define the number $l_{p}(w)$ by

Remark Compare $l_{p}(w)$ with the length $l(w)=\left|\Phi^{+} \cap w^{-1} \Phi^{-}\right|$of $w \in W$.

Lemma 5.5 Let $w_{p}$ be the longest element of $W_{p}$. Then we have

l_{p}(w)+l_{p}\left(w_{0} w w_{p}\right)=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|

for every $w \in \mathfrak{W}_{p}$.
Proof. We have

\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap\left(w_{0} w w_{p}\right)^{-1} \Phi^{-}\right|=\left|w_{p}\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{+}\right|=\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{+}\right|
$$

Hence we obtain

l_{p}(w)+l_{p}\left(w_{0} w w_{p}\right) & =\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}\right|+\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap\left(w_{0} w w_{p}\right)^{-1} \Phi^{-}\right| \\
& =\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}\right|+\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{+}\right|=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|
\end{aligned}
$$

for every $w \in \mathfrak{W}_{p}$.
Definition 5.6 We divide the subset $\mathfrak{W}_{p}$ of $W$ into three parts:

$$
\mathfrak{W}_{p}=\mathfrak{W}_{p}^{+} \amalg \mathfrak{W}_{p}^{-} \amalg \mathfrak{W}_{p}^{0},
$$

where $\amalg$ means the disjoint union, and

$$
\begin{aligned}
\mathfrak{W}_{p}^{+} & :=\left\{w \in \mathfrak{W}_{p}\left|l_{p}(w)<\left|\Phi^{+} \backslash \Phi_{p}^{+}\right| / 2\right\}\right. \\
\mathfrak{W}_{p}^{-} & :=\left\{w \in \mathfrak{W}_{p}\left|l_{p}(w)>\left|\Phi^{+} \backslash \Phi_{p}^{+}\right| / 2\right\}\right. \\
\mathfrak{W}_{p}^{0} & :=\left\{w \in \mathfrak{W}_{p}\left|l_{p}(w)=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right| / 2\right\} .\right.
\end{aligned}
$$

Note that $\mathfrak{W}_{p}^{0}=\emptyset$ is possible, and

$$
w_{0} \mathfrak{W}_{p}^{-} w_{p}=\mathfrak{W}_{p}^{+}, \quad w_{0} \mathfrak{W}_{p}^{0} w_{p}=\mathfrak{W}_{p}^{0}
$$

by Lemma 5.5.
Definition 5.7 Define

$$
E_{p}(s)=\sum_{w \in \mathfrak{W}_{p}^{+}} Q_{p, w}(s) X_{p, w}(s)+\frac{1}{2} \sum_{w \in \mathfrak{W}_{p}^{0}} Q_{p, w}(s) X_{p, w}(s)
$$

Here we understand that the second sum equals zero if the subset $\mathfrak{W}_{p}^{0}$ is empty.
Proposition 5.8 We have

$$
X_{p}(s)=E_{p}(s)+\epsilon_{p} E_{p}\left(-c_{p}-s\right)
$$

where $\epsilon_{p}$ is the sign of Lemma 5.3 .
Proof. This is obvious by the above definitions and lemmas.
The decomposition of Proposition 5.8 is useful for our proof of Theorem 1.1 (the weak Riemann hypothesis). However we do not know whether this choice of $E_{p}(s)$ is best possible for the Riemann hypothesis for $\hat{\zeta}_{P}(s)$.
5.3. Reduction of $X_{p}(s)$. By definition of $Q_{p, w}(s)$ and $X_{p, w}(s)$, component terms $Q_{p, w}(s) X_{p, w}(s)$ of $X_{p}(s)$ have a lot of "common factors". Now we define "the greatest common divisor" of these terms.

Definition 5.9 Define

$$
\begin{aligned}
D_{p}(s) & =\prod_{k=1}^{\infty} \prod_{h=2}^{\infty} \xi(k s+h)^{N_{p}(k, h-1)-M_{p}(k, h)} \\
R_{p}(s) & =\text { g.c.d }\left\{Q_{p, w}(s) \mid w \in \mathfrak{W}_{p}\right\}
\end{aligned}
$$

where "g.c.d" means the monic polynomial of the maximal degree which divides all polynomials $Q_{p, w}(s)$ in the polynomial ring $\mathbb{C}[s]$.

Remark The above definition of $D_{p}(s)$ is different from the one of [13, (5.36)], since we use the notation $\xi(s)=s(s-1) \pi^{-s / 2} \Gamma(s / 2) \zeta(s)$ in this article.
Definition 5.10 Define

$$
\xi_{p}(s)=\frac{X_{p}(s)}{R_{p}(s) D_{p}(s)}, \quad \varepsilon_{p}(s)=\frac{E_{p}(s)}{R_{p}(s) D_{p}(s)} .
$$

We have

$$
\xi_{p}(s)=\varepsilon_{p}(s) \pm \varepsilon_{p}\left(-c_{p}-s\right)
$$

The entire function $\xi_{p}(s)$ equals the zeta function $\hat{\zeta}_{p}(s)$ times a polynomial. Hence Theorem 1.1 is equivalent to the statement that all but finitely many zeros of $\xi_{p}(s)$ lie on the line $\Re(s)=-c_{p} / 2$.

## 6. The second step of the proof Theorem 1.1

Roughly the second step is a consequence of the result that $X_{p, \text { id }}(s)$ is dominant in $\Re(s) \geqslant-c_{p} / 2$ and $X_{p, \text { id }}(s) / D_{p}(s)$ has no zeros in $\Re(s) \geqslant-c_{p} / 2$, since

E_{p}(s)=\left[\sum_{w \in \mathfrak{W}_{p}^{\ddagger}} Q_{w}(s)\right] \cdot X_{p, \mathrm{id}}(s) \cdot\left[1+\sum_{\substack{w \in \mathfrak{W}_{p} \backslash \mathfrak{W}_{p}^{\ddagger} \\ 2 l_{p}(w) \leqslant\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|}} R_{w}(s) \frac{X_{p, w}(s)}{X_{p, \mathrm{id}}(s)}\right]
$$

where $\mathfrak{W}_{p}^{\ddagger}$ is a subset of $\mathfrak{W}_{p}$ defined below and $R_{w}(s)$ are some rational functions. The analytic behavior of $E_{p}(s)$ in the right half-plane $\Re(s)>-c_{p} / 2$ is less difficult than that of the left.
6.1. Behavior of $E_{p}(s)$ in a right half-plane. In this part we construct the dominant term of $\varepsilon_{p}(s)$ in a right half-plane via $E_{p}(s)$ of Definition 5.7
Lemma 6.1 Let $\left\{v_{1}=\mathrm{id}, v_{2}, \cdots, v_{l}\right\}$ be the left minimal coset representative of $W_{p}$ :

W=\bigsqcup_{j=1}^{l} v_{j} W_{p} .
$$

Then $l_{p}(w)$ depends only on the coset $v_{j} W_{p}$.
Proof. For $w \in v_{j} W_{p}$, we have $l_{p}(w)=\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}\right|=\left|w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap \Phi^{-}\right|=$ $\left|v_{j}\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap \Phi^{-}\right|=\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap v_{j}^{-1} \Phi^{-}\right|=l_{p}\left(v_{j}\right)$.
Lemma 6.2 Let $w_{0}$ be the longest element of $W$. We have

$$
l_{p}(\mathrm{id})=0, \quad l_{p}\left(w_{0}\right)=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right| .
$$

In other words the minimum value and the maximum value of $l_{p}(w)$ are attained by the identity element id and the longest element $w_{0}$ respectively.

Proof. We have $l_{p}(\mathrm{id})=\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap \Phi^{-}\right|=0$ and $l_{p}\left(w_{0}\right)=\left|\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap \Phi^{+}\right|=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|$ by definition of $l_{p}(w)$.

Note that from Lemmas 6.1 and 6.2, $w \in W_{p}$ implies $l_{p}(w)=0$.
Lemma 6.3 Define

$$
\mathfrak{W}_{p}^{\ddagger}=\left\{w \in \mathfrak{W}_{p} \mid l_{p}(w)=0\right\} .
$$

Then $\mathrm{id} \in \mathfrak{W}_{p}^{\ddagger}$ and

$$
\mathfrak{W}_{p}^{\ddagger}=\left\{w \in \mathfrak{W}_{p} \mid\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{+}=\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)\right\} .
$$

In particular $X_{p, w}(s)=X_{p, \mathrm{id}}(s)$ for every $w \in \mathfrak{W}_{p}^{\ddagger}$.
Proof. This lemma immediately follows from Definition 5.4 and (5.2).

By Lemmas 6.1, 6.2 and 6.3

$$
\mathfrak{W}_{p}^{\ddagger}=\left(W_{p} \amalg v_{2} W_{p} \amalg \cdots \amalg v_{m} W_{p}\right) \cap \mathfrak{W}_{p}^{\ddagger},
$$

for some $1 \leqslant m<l\left(=\left|W / W_{p}\right|\right)$. (In fact, $m=1$ because from the proof of Lemma 10.2, we have $\mathfrak{W}_{p}^{\ddagger} \subset W_{p}$.)
Definition 6.4 (the dominant term in a right half-plane) We define

$$
X_{p}^{\ddagger}(s):=X_{p, \mathrm{id}}(s), \quad Q_{p}^{\ddagger}(s):=\sum_{w \in \mathfrak{W}_{p}^{\ddagger}} Q_{p, w}(s) .
$$

By definition

$$
X_{p}^{\ddagger}(s)=X_{p, \mathrm{id}}(s)=\prod_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right)=\prod_{k=1}^{\infty} \prod_{h=2}^{\infty} \xi(k s+h)^{N_{p}(k, h-1)}
$$

The following two propositions assert that

$$
Q_{p}^{\ddagger}(s) X_{p}^{\ddagger}(s)=\left(\sum_{w \in \mathfrak{W}_{p}^{\ddagger}} Q_{p, w}(s)\right) \prod_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right)
$$

is the dominant term of $E_{p}(s)$ in a right half-plane.
Now we introduce an important hypothesis.
Volume Hypothesis. We have

$$
\begin{equation*}
\underset{\lambda=\rho_{p}}{\operatorname{Res}} \omega_{\Delta_{p}}^{\Phi_{p}}(\lambda)>0 \quad \text { for every } 1 \leqslant p \leqslant r \tag{6.1}
\end{equation*}
$$

As in the name of the hypothesis, residues $\operatorname{Res}_{\lambda=\rho_{p}}^{\omega_{\Delta_{p}}^{\Phi_{p}}}(\lambda)$ are expected to be volumes of certain subsets of a fundamental domain of $G(\mathbb{Q}) \backslash G(\mathbb{A})^{1}$ for $G=G(\Phi)$. The volume hypothesis is a consequence of the second part of the parabolic reduction conjecture [26, Section 2.3, Conjecture 11] (or [27, Section3, Conjecture 2]) that was proved in the case $G=S L(n)$ by using the theory of Eisenstein series ([24, section 4.7]). This is a quite important piece of Theorem [1.1. In fact, the following result plays an essential role in the proof of Theorem 1.1, but is not proved without (6.1) at present (see the proof of Lemma 10.3 in section 10).

Proposition 6.5 Assume the volume hypothesis (6.1). Then, we have

$$
\operatorname{deg} Q_{p}^{\ddagger}(s) \geqslant \operatorname{deg} Q_{p, w}(s)+1
$$

for every $w \in\left(\mathfrak{W}_{p}^{+} \cup \mathfrak{W}_{p}^{0}\right) \backslash \mathfrak{W}_{p}^{\ddagger}$.
Proposition 6.6 We have

$$
\left|\frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}\right|<1 \quad \text { for } \quad \Re(s)>-\frac{c_{p}}{2}
$$

and

$$
\left|\frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}\right| \leqslant 1 \quad \text { for } \quad \Re(s)=-\frac{c_{p}}{2}
$$

for every $w \in \mathfrak{W}_{p} \backslash \mathfrak{W}_{p}^{\ddagger}$.
The dominant term $X_{p}^{\ddagger}(s)$ has the following property.

Proposition 6.7 Let $D_{p}(s)$ be the function defined in Definition 5.9. Then

$$
\frac{X_{p}^{\ddagger}(s)}{D_{p}(s)} \neq 0 \quad \text { for } \quad \Re(s) \geqslant-\frac{c_{p}}{2} .
$$

Furthermore, there exists a positive function $\delta(t)$ defined on the real line satisfying $\delta(t) \log |t| \rightarrow \infty(|t| \rightarrow \infty)$ such that $X_{p}^{\ddagger}(s) / D_{p}(s)$ has no zero in $\Re(s) \geqslant-c_{p} / 2-\delta(t)$.
Remark By a known result [22, p.135] obtained by Vinogradov's method, we could take $\delta(t)$ such that

$$
\delta(t) \ll \frac{1}{(\log t)^{2 / 3}(\log \log t)^{1 / 3}}
$$

as $t \rightarrow \infty$.
We prove Proposition 6.5 in section 10, and Propositions 6.6 and 6.7 in section 9 . These three propositions derive the following result.

Proposition 6.8 The number of zeros of $\varepsilon_{p}(s)$ lying in right half-plane $\Re(s) \geqslant-c_{p} / 2$ is finitely many at most. Furthermore, there exists a positive function $\delta(t)$ on the real line satisfying $\delta(t) \log |t| \rightarrow \infty(|t| \rightarrow \infty)$ such that the number of zeros of $\varepsilon_{p}(s)$ in $\Re(s) \geqslant-c_{p} / 2-\delta(t)$ is finitely many at most.

Proof. We have

$$
\begin{equation*}
E_{p}(s)=Q_{p}^{\ddagger}(s) X_{p}^{\ddagger}(s)\left[1+r_{p}(s)\right] \tag{6.2}
\end{equation*}
$$

with

$$
r_{p}(s)=\sum_{w \in \mathfrak{W}_{p}^{+} \backslash \mathfrak{W}_{p}^{\ddagger}} \frac{Q_{p, w}(s)}{Q_{p}^{\ddagger}(s)} \cdot \frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}+\frac{1}{2} \sum_{w \in \mathfrak{W}_{p}^{0}} \frac{Q_{p, w}(s)}{Q_{p}^{\ddagger}(s)} \cdot \frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}
$$

Define

$$
\mathfrak{D}_{p}=\left\{\left.s \in \mathbb{C}\left|\sum_{w \in \mathfrak{W}_{p}^{+} \backslash \mathfrak{U}_{p}^{\ddagger}}\right| \frac{Q_{p, w}(s)}{Q_{p}^{\ddagger}(s)}\left|+\frac{1}{2} \sum_{w \in \mathfrak{D}_{p}^{j}}\right| \frac{Q_{p, w}(s)}{Q_{p}^{\ddagger}(s)} \right\rvert\, \geqslant 1\right\} .
$$

Then $\mathfrak{D}_{p}$ is a bounded region in $\mathbb{C}$ by Proposition 6.5. Therefore we have

$$
\begin{equation*}
\left|r_{p}(s)\right|<1 \quad \text { for } \quad \Re(s) \geqslant-\frac{c_{p}}{2} \text { with } s \notin \mathfrak{D}_{p}, \tag{6.3}
\end{equation*}
$$

by Proposition 6.6. Hence Proposition 6.7 and (6.3) implies Proposition 6.8.
The final proposition of the second step is about the zero-free region of $E_{p}(s)$ on a left half-plane.

Proposition 6.9 There exists a positive real number $\kappa$ such that $E_{p}(s)$ has no zeros in the region $\Re(s) \leqslant-\kappa \log (|\Im(s)|+10)$.

This will be proved in section by using the Stirling formula. Combining Propositions 6.8 and 6.9 we find that all but finitely many zeros of $\varepsilon_{p}(s)$ lie in the region

$$
\left\{s=\sigma+i t \in \mathbb{C} \left\lvert\,-\kappa \log (|t|+10)<\sigma<-\frac{c_{p}}{2}\right.\right\} .
$$

## 7. The third step of the proof Theorem 1.1

The final step of the proof of (the front half of) Theorem 1.1 consists of three parts. The first one is about the number of zeros of $\varepsilon_{p}(s)$ in a given region. The second one is the Hadamard factorization formula of $\varepsilon_{p}(s)$. The third one is an application of a result of de Bruijn [3, p.215] (see also Lemma 3.1 of [12]) which was established by the first author in [12.

Proposition 7.1 Let $T>1$, and $\sigma>c_{p} / 2$. Denote by $N(T ; \sigma)$ the number of zeros of $\varepsilon_{p}(s)$ in the region

$$
-\sigma<\Re(s)<-c_{p} / 2-\delta(t), \quad 0<\Im(s)<T
$$

Then there exist a positive number $\sigma_{\mathrm{L}}>0$ such that

$$
N\left(T ; \sigma_{\mathrm{L}}\right)=C_{1} T \log T+C_{2} T+O(\log T)
$$

for some positive real number $C_{1}>0$ and real number $C_{2}$, and

$$
N(T ;+\infty)=C_{1} T \log T+C_{3} T+O\left(\log ^{2} T\right)
$$

for some real number $C_{3}$.
Thus we have $N(T ;+\infty)-N\left(T ; \sigma_{\mathrm{L}}\right)=O(T)$. Also, we can justify this by applying and modifying the method in [22, p.230]. This will be proved in section 12 ,
Proposition 7.2 Define

$$
W_{p}(z)=\varepsilon_{p}\left(-c_{p} / 2+i z\right)
$$

Then it has the product formula

$$
W_{p}(z)=\omega e^{\alpha z} V(z) W_{1}(z) W_{2}(z)
$$

where $\omega$ is a nonzero real number, $\alpha$ is a real number, $V(z)$ is a polynomial having no zeros in $\Im(z)>0$ except for purely imaginary zeros,

$$
\begin{aligned}
& W_{1}(z)=\prod_{n=1}^{\infty}\left[\left(1-\frac{z}{\rho_{n}}\right)\left(1+\frac{z}{\bar{\rho}_{n}}\right)\right] \\
& W_{2}(z)=\prod_{n=1}^{\infty}\left[\left(1-\frac{z}{\eta_{n}}\right)\left(1+\frac{z}{\bar{\eta}_{n}}\right)\right]
\end{aligned}
$$

with $\Re\left(\rho_{n}\right)>0, \Re\left(\eta_{n}\right)>0$ and $0<\delta(t)<\Im\left(\rho_{n}\right)<\sigma_{\mathrm{L}}+1<\Im\left(\eta_{n}\right)<\kappa \log \left(\Re\left(\eta_{n}\right)+10\right)$ for every $n \geqslant 1$. Here $\delta(t)$ is the function of Proposition 6.8, $\kappa$ is the positive number of Proposition 6.9, and $\sigma_{\mathrm{L}}$ is the positive number of Proposition 7.1. The products $W_{1}$ and $W_{2}$ converge uniformly on every compact subset in $\mathbb{C}$.

This will be proved in section 13 by using Proposition 7.1.
Proposition 7.3 (Proposition 3.1 of [12]) Let $W(z)$ be a function in $\mathbb{C}$. Suppose that $W(z)$ has the product factorization

$$
W(z)=h(z) e^{\alpha z} \prod_{n=1}^{\infty}\left[\left(1-\frac{z}{\rho_{n}}\right)\left(1+\frac{z}{\bar{\rho}_{n}}\right)\right]
$$

where $h(z)$ is a nonzero polynomial having $N$ many zeros counted with multiplicity in the lower half-plane, $\alpha \in \mathbb{R}, \Im\left(\rho_{n}\right)>0(n=1,2, \cdots)$, and the product converges uniformly in any compact subset of $\mathbb{C}$. Then, $W(z)+\overline{W(\bar{z})}$ and $W(z)-\overline{W(\bar{z})}$ has at most $N$ pair of conjugate complex zeros counted with multiplicity.

Now we achieve the following goal which is an immediate consequence of Propositions 7.2 and 7.3 . Note that the realness of the exponent $\alpha$ of Proposition 7.2 is crucial.

Theorem 7.4 (Weak Riemann Hypothesis for $\xi_{p}$ ) Assume the volume hypothesis (6.1). Then, there exists a bounded region $\mathfrak{B}_{p}$ such that all zeros of $\xi_{p}(s)$ outside $\mathfrak{B}_{p}$ lie on the line $\Re(s)=-c_{p} / 2$.

By studying of the behavior of the argument of $\varepsilon_{p}\left(-c_{p} / 2+i t\right)(t>0)$, we obtain the following additional result.

Theorem 7.5 (Simple zeros of $\xi_{p}$ ) Assume the volume hypothesis (6.1). Then, there exists a bounded region $\mathfrak{B}_{p}^{\prime}\left(\supset \mathfrak{B}_{p}\right)$ such that all zeros of $\xi_{p}(s)$ outside $\mathfrak{B}_{p}^{\prime}$ lie on the line $\Re(s)=-c_{p} / 2$ and simple.

This will be proved in section 14. Theorems 7.4 and 7.5 imply the main result Theorem 1.1 because of Chevalley's fundamental theorem.

## 8. Preliminaries for proof of Propositions 6.6 and 6.7

In this section, we prepare several lemmas for the proof of Propositions 6.6 and 6.7 , Indeed, Lemmas 8.1, 8.4 and 8.15 will play an important role for it. The condition (2.1) in Definition 2.1 is essential for Lemma 8.1

For integers $k$ and $l$, we define

$$
\left.\left.\begin{array}{rl}
\Sigma_{p}(k) & =\left\{\alpha \in \Phi \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle\right.
\end{array}=k\right\}, \quad \begin{array}{l}
\Sigma_{p}(k, h)
\end{array}\right)=\left\{\alpha \in \Phi \mid\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle=k, \text { ht } \alpha^{\vee}=h\right\} . ~ l
$$

They are not empty for finitely many $(k, h)$. The set of positive roots $\Phi^{+}$is decomposed into the disjoint union

$$
\Phi^{+} \backslash \Phi_{p}^{+}=\bigsqcup_{k=1}^{\infty} \Sigma_{p}(k), \quad \Sigma_{p}(k)=\bigsqcup_{h=1}^{\infty} \Sigma_{p}(k, h)
$$

By definition, $N_{p}(k, h)$ is the cardinality of $\Sigma_{p}(k, h)$.
Lemma 8.1 Let $w \in \mathfrak{W}_{p}$. Let $\alpha$ be a positive root. Suppose that $\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$ and $\alpha+\alpha_{j} \in \Phi^{+} \backslash \Phi_{p}^{+}$for some $\alpha_{j} \in \Delta_{p}$. Then $\alpha+\alpha_{j} \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$.
Note. Besides $\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$and $\alpha+\alpha_{p} \in \Phi^{+} \backslash \Phi_{p}^{+}$does not imply $\alpha+\alpha_{p} \in$ $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$in general.

Proof. It suffices to show that $w\left(\alpha+\alpha_{j}\right) \in \Phi^{-}$under the assumption. By the assumption and the definition of $\mathfrak{W}_{p}$, we have $w \alpha \in \Phi^{-}$and $w \alpha_{j} \in \Delta \cup \Phi^{-}$. If $w \alpha_{j} \in \Phi^{-}$, we have $w\left(\alpha+\alpha_{j}\right) \in \Phi^{-}$, since $\alpha+\alpha_{j}$ is a root. If $w \alpha_{j} \in \Delta$, we also have $w \alpha+w \alpha_{j} \in \Phi^{-}$. In fact, it is impossible that $w \alpha_{j} \in \Delta$ and $w \alpha+w \alpha_{j} \in \Phi^{+}$, since $w \alpha \in \Phi^{-}$. In each case, we have $w\left(\alpha+\alpha_{j}\right) \in \Phi^{-}$.

Lemma 8.2 Let $\alpha$ be a positive root in $\Phi^{+} \backslash \Phi_{p}^{+}$. Suppose that $\left\langle\rho_{p}, \alpha^{\vee}\right\rangle<0$. Then there exists $\alpha_{j} \in \Delta_{p}$ such that $\alpha^{\vee}+\alpha_{j}^{\vee} \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)^{\vee}$. In particular, there exists $\alpha_{j} \in \Delta_{p}$ such that $\alpha^{\vee}+\alpha_{j}^{\vee} \in\left(\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}\right)^{\vee}$, if $\left\langle\rho_{p}, \alpha^{\vee}\right\rangle<0$ for $\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$.
Proof. By $\left\langle\rho_{p}, \alpha^{\vee}\right\rangle<0$, there exists $\alpha_{j} \in \Delta_{p}$ such that $\left\langle\alpha_{j}, \alpha^{\vee}\right\rangle<0$, since

$$
2 \rho_{p}=\sum_{\beta \in \Phi_{p}^{+}} \beta=\sum_{\substack{j=1 \\ j \neq p}}^{r} n_{j} \alpha_{j} \quad\left(n_{j} \in \mathbb{Z}_{>0}\right)
$$

Thus $\left\langle\alpha_{j}^{\vee}, \alpha^{\vee}\right\rangle<0$ by $\alpha_{j}^{\vee}=2 \alpha_{j} /\left\langle\alpha_{j}, \alpha_{j}\right\rangle$. Hence $\alpha^{\vee}+\alpha_{j}^{\vee}$ is a positive root in $\Phi^{\vee}$, ([7], §9]). Moreover $\alpha^{\vee}+\alpha_{j}^{\vee}$ is a positive root in $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)^{\vee}$, since $\alpha^{\vee} \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)^{\vee}$ and $\alpha_{p}^{\vee} \in \Phi_{p}^{+}$. The second statement follows from the first statement and Lemma 8.1.
Lemma 8.3 Let $k \geqslant 1$. Then
(1) $N_{p}(k, h)=N_{p}\left(k, k c_{p}-h\right)$ for every $h \geqslant 1$, and
(2) $N_{p}(k, h) \leqslant N_{p}(k, h+1)$ if $2 h+1 \leqslant k c_{p}$.

Proof. See Proposition 1 of [16]. See also Lemma 4.3 (1) of [13] for (1).
Lemma 8.4 Let $k$ and $h$ be positive integers. Write

$$
\Sigma_{p}(k, h)=\left\{\beta_{1}, \cdots, \beta_{N}\right\} \quad\left(N=N_{p}(k, h)\right)
$$

if $\Sigma_{p}(k, h)$ is not empty. Suppose that $k \geqslant 1$ and $2 h+1 \leqslant k c_{p}$. Then there exists simple roots $\alpha_{j_{1}}, \cdots, \alpha_{j_{N}}$ (not necessary distinct) such that

- $\alpha_{j_{n}} \in \Delta_{p}(1 \leqslant n \leqslant N)$,
- $\beta_{n}^{\vee}+\alpha_{j_{n}}^{\vee} \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)^{\vee}(1 \leqslant n \leqslant N)$, and
- $\beta_{m}^{\vee}+\alpha_{j_{m}}^{\vee} \neq \beta_{n}^{\vee}+\alpha_{j_{n}}^{\vee}(m \neq n)$.

Proof. See the proof of Lemma 8.15,
Lemma 8.5 Let $k \geqslant 1$ and $w \in \mathfrak{W}_{p}$. Then $N_{p, w}(k, h) \leqslant N_{p, w}(k, h+1)$ if $2 h+1 \leqslant k c_{p}$. In particular, $M_{p}(k, h)=0$ if $2 h-1 \leqslant k c_{p}$

Proof. This is a consequence of Lemmas 8.1 and 8.4 .
Lemma 8.6 Let $k \geqslant 1$. Then we have

$$
M_{p}(k, h)= \begin{cases}0 & \text { if } 2 h-1 \leqslant k c_{p} \\ N_{p}(k, h-1)-N_{p}(k, h) & \text { if } 2 h-1>k c_{p}\end{cases}
$$

Proof. We put

$$
D_{p}^{(1)}(s)=\prod_{k=1}^{\infty} \prod_{h=2}^{\infty} \xi(k s+h)^{N_{p}(k, h-1)-M_{p}(k, h)}
$$

(cf. Definition 5.9). Then we have

$$
\begin{aligned}
D_{p}^{(1)}(s)=\prod_{k=1}^{\infty} & \prod_{h \leqslant\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h-1)} \\
& \times \prod_{h>\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h-1)-M_{p}(k, h)}
\end{aligned}
$$

by Lemma 8.5. On the other hand, we have

$$
\begin{aligned}
D_{p}^{(1)}\left(-c_{p}-s\right)= & \prod_{k=1}^{\infty} \prod_{h<\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h)-M_{p}\left(k, k c_{p}-h+1\right)} \\
& \times \prod_{h \geqslant\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h)}
\end{aligned}
$$

by using Lemma 4.3 (1) of [13]. Because of $D_{p}^{(1)}\left(-c_{p}-s\right)=D_{p}^{(1)}(s)$ by Lemma 5.5 of [13], we have $M_{p}(k, h)=N_{p}(k, h-1)-N_{p}(k, h)$ for $h>\left(k c_{p}+1\right) / 2$.
Corollary 8.7 In the definition of $M_{p}(k, h)$, the longest element $w_{0}$ attains the maximum

$$
\max _{w \in 2 \mathcal{J}_{p}}\left(N_{p, w}(k, h-1)-N_{p, w}(k, h)\right) .
$$

Proof. This is a consequence of Lemmas 8.3 and 8.6, since $N_{p}(k, h)=N_{p, w_{0}}(k, h)$.
Let $\widetilde{\alpha}$ be the highest root of $\Phi^{+}$. Define integers $k_{1}, \cdots, k_{r}$ by

$$
\begin{equation*}
\widetilde{\alpha}=\sum_{i=1}^{r} k_{i} \alpha_{i} \quad\left(k_{i}>0\right) . \tag{8.1}
\end{equation*}
$$

For a positive integer $k$ with $\Sigma_{p}(k) \neq \emptyset$, a lowest root $\alpha_{p}^{-}(k)$ for $\Sigma_{p}(k)$ is the root such that $\beta-\alpha_{p}^{-}(k)$ is a (possibly empty) sum of simple roots for every $\beta \in \Sigma_{p}(k)$. A highest root $\alpha_{p}^{+}(k)$ for $\Sigma_{p}(k)$ is defined by a similarly way. Lowest roots and highest roots always exist and are unique if $\Sigma_{p}(k)$ is not empty ([4, Proposition 1.4.2]).
Lemma 8.8 (Lemma 1.4.5 of [4]) Let $k$ be a positive integer. Then $\Sigma_{p}(k)$ is not empty if and only if $1 \leqslant k \leqslant k_{p}$, where $k_{p}$ is the number defined in (8.1).

Lemma 8.9 (Lemma 1.4.6 of [4) Suppose that $1 \leqslant k \leqslant k_{p}$. Let $w_{p}$ be the longest element of $W_{p}$, i.e., $w_{p} \Delta_{p}=-\Delta_{p}$. Then we have $\alpha_{p}^{-}(1)=\alpha_{p}$ and $w_{p} \alpha_{p}^{-}(k)=\alpha_{p}^{+}(k)$.

For a positive integer $k$ with $\Sigma_{p}(k) \neq \emptyset$, we write

$$
\alpha_{p}^{ \pm}(k)^{\vee}=k \alpha_{p}^{\vee}+\gamma_{p}^{ \pm}(k)^{\vee} \quad\left(\gamma_{p}^{ \pm}(k)^{\vee} \in Q^{+}\left(\Delta_{p}^{\vee}\right)\right)
$$

where $Q^{+}\left(\Delta_{p}^{\vee}\right)=\sum_{j=1}^{r} \mathbb{Z}_{\geqslant 0} \alpha_{j}^{\vee}$. Then the heights ht $\gamma_{p}^{+}(k)^{\vee}$ and ht $\gamma_{p}^{-}(k)^{\vee}$ are nonnegative, since they must be written as a combination of simple roots $\alpha_{j}^{\vee} \in \Delta_{p}^{\vee}$ with nonnegative integer coefficients. We define

$$
\begin{equation*}
\hbar_{k}^{ \pm}=\mathrm{ht} \gamma_{p}^{ \pm}(k)^{\vee}=\left\langle\rho, \gamma_{p}^{ \pm}(k)^{\vee}\right\rangle \tag{8.2}
\end{equation*}
$$

for $1 \leqslant k \leqslant k_{p}$. For an element $\alpha \in \Sigma_{p}(h)$, the height ht $\left(\alpha-k \alpha_{p}\right)^{\vee}$ is called the $(p$ - $)$ level of $\alpha$. In this terminology, $\hbar_{k}^{+}$(resp. $\hbar_{k}^{-}$) is the highest (resp. lowest) level of $\Sigma_{p}(k)$. Note that $\gamma_{p}^{-}(1)=0$, since $\alpha_{p}^{-}(1)=\alpha_{p}$.
Lemma 8.10 For every $1 \leqslant k_{1}<k_{2} \leqslant k_{p}$, we have $\hbar_{k_{1}}^{+} \leqslant \hbar_{k_{2}}^{+}$.
Proof. We have $\alpha_{p}^{+}\left(k_{2}\right)^{\vee}-\alpha_{p}^{+}\left(k_{1}\right)^{\vee} \in \Phi^{\vee}$ by Corollary 1.2 of [10] and

$$
\alpha_{p}^{+}\left(k_{2}\right)^{\vee}-\alpha_{p}^{+}\left(k_{1}\right)^{\vee}=\left(k_{2}-k_{1}\right) \alpha_{p}^{\vee}+\left(\gamma_{p}^{+}\left(k_{2}\right)^{\vee}-\gamma_{p}^{+}\left(k_{1}\right)^{\vee}\right)
$$

Therefore $\gamma_{p}^{+}\left(k_{2}\right)-\gamma_{p}^{+}\left(k_{1}\right) \in Q^{+}\left(\Delta_{p}\right)$, since $k_{2}-k_{1}>0$ and $\gamma_{p}^{+}(k) \in Q^{+}\left(\Delta_{p}\right)$. This implies the result by definition of $\hbar_{k}^{+}$.
Lemma 8.11 Let $w_{p}$ be the longest element of $W_{p}$. Then we have

$$
\gamma_{p}^{-}(k)-w_{p} \gamma_{p}^{+}(k)=k \gamma_{p}^{+}(1)
$$

In particular, $w_{p} \gamma_{p}^{+}(1)=-\gamma_{p}^{+}(1)$ and $\gamma_{p}^{+}(k)-w_{p} \gamma_{p}^{-}(k)=k \gamma_{p}^{+}(1)$.
Proof. We have $w_{p} \alpha_{p}^{-}(k)^{\vee}=\alpha_{p}^{+}(k)^{\vee}=k \alpha_{p}^{\vee}+\gamma_{p}^{+}(k)^{\vee}$. Therefore

$$
\begin{aligned}
\alpha_{p}^{-}(k)^{\vee} & =w_{p}\left(w_{p} \alpha_{p}^{-}(k)^{\vee}\right)=k w_{p} \alpha_{p}^{\vee}+w_{p} \gamma_{p}^{+}(k)^{\vee} \\
& =k \alpha_{p}^{+}(1)^{\vee}+w_{p} \gamma_{p}^{+}(k)^{\vee}=k \alpha_{p}^{\vee}+k \gamma_{p}^{+}(1)^{\vee}+w_{p} \gamma_{p}^{+}(k)^{\vee}
\end{aligned}
$$

Hence $k \alpha_{p}^{\vee}+\gamma_{p}^{-}(k)^{\vee}=k \alpha_{p}^{\vee}+k \gamma_{p}^{+}(1)^{\vee}+w_{p} \gamma_{p}^{+}(k)^{\vee}$. This implies the assertion.
Lemma 8.12 Let $c_{p}$ be the number of (2.2). Then we have

$$
c_{p}=2+\hbar_{1}^{+}=1+\operatorname{ht} \alpha_{p}^{+}(1)^{\vee}=1+\operatorname{ht}\left(w_{p} \alpha_{p}^{\vee}\right)
$$

where $w_{p}$ is the longest element of $W_{p}$.
Proof. We have

$$
\begin{aligned}
c_{p} & =2\left\langle\lambda_{p}-\rho_{p}, \alpha_{p}^{\vee}\right\rangle=2-\left\langle 2 \rho_{p}, \alpha_{p}^{\vee}\right\rangle=2-\left\langle\rho-w_{p} \rho, \alpha_{p}^{\vee}\right\rangle \\
& =1+\left\langle w_{p} \rho, \alpha_{p}^{\vee}\right\rangle=1+\left\langle\rho, w_{p} \alpha_{p}^{\vee}\right\rangle=1+\left\langle\rho, \alpha_{p}^{\vee}+\gamma_{p}^{+}(1)^{\vee}\right\rangle \\
& =2+\left\langle\rho, \gamma_{p}^{+}(1)^{\vee}\right\rangle=2+\hbar_{1}^{+}
\end{aligned}
$$

Then the second (resp. the third) equality of Lemma 8.12 follows from definition of $\hbar_{1}^{+}$ (resp. Lemma 8.9).
Lemma 8.13 Let $k \geqslant 1$. We have $2 h=k c_{p}+m$ if $2\left\langle\rho_{p}, \alpha^{\vee}\right\rangle=m \in \mathbb{Z}$ for $\alpha \in \Sigma_{p}(k, h)$. In particular if $\alpha \in \Sigma_{p}(k, h)$ for $h<k c_{p} / 2$ (resp. $h>k c_{p} / 2$ ), $\left\langle\rho_{p}, \alpha^{\vee}\right\rangle<0$ (resp. $>0$ ).
Proof. Because of $c_{p} \lambda_{p}=2 \rho-2 \rho_{p}$ from the proof of Lemma 4.1 of [13], we have

$$
2 \mathrm{ht} \alpha^{\vee}-\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle c_{p}=2 \operatorname{ht} \alpha^{\vee}-\left\langle 2 \rho-2 \rho_{p}, \alpha^{\vee}\right\rangle=2\left\langle\rho_{p}, \alpha^{\vee}\right\rangle
$$

This implies the assertion by definition of $\Sigma_{p}(k, h)$.
Lemma 8.14 Let $1 \leqslant k \leqslant k_{p}$ and let $\hbar_{k}^{ \pm}$be numbers in (8.2). We have

$$
\hbar_{k}^{+}+\hbar_{k}^{-}=k \hbar_{1}^{+} .
$$

Therefore we have
$k+1 \leqslant \operatorname{ht} \alpha^{\vee} \leqslant k c_{p}-k-1 \quad(k \geqslant 2) \quad$ and $\quad 1 \leqslant h t \alpha^{\vee} \leqslant c_{p}-1 \quad(k=1)$
for $\alpha \in \Sigma_{p}(k)$ if $c_{p} \geqslant 3$, and $\hbar_{k}^{+} \leqslant h_{k+1}^{+} \leqslant(k+1) \hbar_{1}^{+}-1$.

Remark If $c_{p}=2, \alpha_{p}^{+}(1)=\alpha_{p}^{-}(1)=\alpha_{p}$ by Lemma 8.12. Hence $\Phi$ is of type $A_{1}$, and the case $k \geqslant 2$ does not appear.

Proof. We note that

$$
\operatorname{ht}\left(w_{p} \gamma^{\vee}\right)=-\mathrm{ht} \gamma^{\vee}
$$

for every $\gamma^{\vee} \in Q^{+}\left(\Delta_{p}^{\vee}\right)$. In fact, we have

$$
\text { ht } \gamma^{\vee}=\left\langle\rho_{p}, \gamma^{\vee}\right\rangle=\left\langle w_{p} \rho_{p}, w_{p} \gamma^{\vee}\right\rangle=-\left\langle\rho_{p}, w_{p} \gamma^{\vee}\right\rangle=-\operatorname{ht}\left(w_{p} \gamma^{\vee}\right)
$$

for $\gamma^{\vee} \in Q^{+}\left(\Delta_{p}^{\vee}\right)$, since $\left\langle\rho_{p}, \alpha_{i}^{\vee}\right\rangle=1$ for $i \neq p$ from the proof of Lemma 4.1 in [13]. Therefore we have

$$
\begin{aligned}
k+\hbar_{k}^{-} & =\operatorname{ht}\left(\alpha_{p}^{-}(k)\right)^{\vee}=\operatorname{ht}\left(w_{p} \alpha_{p}^{+}(k)^{\vee}\right)=\operatorname{ht}\left(w_{p}\left(k \alpha_{p}^{\vee}+\gamma_{p}^{+}(k)^{\vee}\right)\right) \\
& =k \operatorname{ht}\left(w_{p} \alpha_{p}^{\vee}\right)+\operatorname{ht}\left(w_{p} \gamma_{p}^{+}(k)^{\vee}\right)=k \mathrm{ht}\left(w_{p} \alpha_{p}^{\vee}\right)-\mathrm{ht}\left(\gamma_{p}^{+}(k)\right)^{\vee} \\
& =k\left(1+\hbar_{1}^{+}\right)-\hbar_{k}^{+} .
\end{aligned}
$$

Here we used Lemmas 8.11 and 8.12 This implies Lemma 8.14 ,
Lemma 8.15 Let $1 \leqslant k \leqslant k_{p}$. Then $\Sigma_{p}(k)$ is divided into the disjoint union

$$
\Sigma_{p}(k)=\bigsqcup_{m=1}^{M_{k}} L_{m}(k)
$$

satisfying the following conditions:
(1) $\alpha_{p}^{ \pm}(k) \in L_{1}(k)$ and $\left|L_{1}(k)\right|=\operatorname{ht} \alpha_{p}^{+}(k)^{\vee}-\operatorname{ht} \alpha_{p}^{-}(k)^{\vee}+1$,
(2) $\left|L_{1}(k)\right|>\left|L_{2}(k)\right|,\left|L_{3}(k)\right|, \ldots,\left|L_{M_{k}}(k)\right| \geqslant 1$,
(3) we have

$$
L_{m}(k)^{\vee}=\left\{\beta_{m}(k)^{\vee}\right\} \cup\left\{\beta_{m}(k)^{\vee}+\sum_{j=1}^{J} \alpha_{m, j}(k)^{\vee}\left|1 \leqslant J \leqslant\left|L_{m}(k)\right|-1\right\}\right.
$$

for some $\beta_{m}(k) \in \Sigma_{p}(k)\left(1 \leqslant m \leqslant M_{k}\right)$ with $\beta_{1}(k)=\alpha_{p}^{-}(k)$, and for some $\alpha_{m, j}(k) \in \Delta_{p}\left(1 \leqslant m \leqslant M_{k}, 1 \leqslant j \leqslant\left|L_{m}(k)\right|-1\right)$,
(4) $k+\hbar_{k}^{-}=$ht $\beta_{1}(k)^{\vee}<\operatorname{ht} \beta_{2}(k)^{\vee} \leqslant \operatorname{ht} \beta_{3}(k)^{\vee} \leqslant \cdots \leqslant \operatorname{ht} \beta_{M}(k)^{\vee} \leqslant k c_{p} / 2$,
(5) ht $\widetilde{\beta}_{m}(k)^{\vee}=k c_{p}-\operatorname{ht} \beta_{m}(k)^{\vee}\left(1 \leqslant m \leqslant M_{k}\right)$, where

$$
\widetilde{\beta}_{m}(k)^{\vee}=\beta_{m}(k)^{\vee}+\sum_{j=1}^{\left|L_{m}(k)\right|-1} \alpha_{m, j}(k)^{\vee} .
$$

Proof. At first we note that the problem is reduced to the cases of irreducible root systems with $\Sigma_{p}(1)$ by using results of section 1.4 of [4. Then we see that the assertions of Lemmas 8.4 and 8.15 for $\Sigma_{p}(1)$ hold by constructing explicitly the required disjoint union directly. See Appendix 1.

## 9. Proof of Propositions 6.6 and 6.7

### 9.1. Proof of Proposition 6.6,

Lemma 9.1 Let $a, b$ be real numbers satisfying $a \leqslant b$. Then

$$
\left|\frac{\xi(s+a)}{\xi(s+b+1)}\right|<1 \quad \text { for } \Re(s)>-\frac{a+b}{2}
$$

and

$$
\left|\frac{\xi(s+a)}{\xi(s+b+1)}\right|=1 \quad \text { for } \quad \Re(s)=-\frac{a+b}{2} .
$$

Proof. This is equivalent to $|\xi(s+(a-b-1) / 2)|<|\xi(s-(a-b-1) / 2)|$ for $\Re(s)>1 / 2$ by shifting $s+(a+b+1) / 2$ to $s$, and it holds by applying Theorem 4 of [14] to $F(s)=\xi(s)$ and $c=(a-b-1) / 2$. The second statement immediately follows from the functional equation for $\xi(s)$.

Now we prove Proposition 6.6. We recall

$$
\begin{equation*}
X_{p}^{\ddagger}(s)=X_{p, \mathrm{id}}(s)=\prod_{\alpha \in \Phi_{+} \backslash \Phi_{p}^{+}} \xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right) \tag{9.1}
\end{equation*}
$$

by Lemma 6.3. From (5.3) and (9.1), we have

$$
\begin{equation*}
\frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}=\prod_{\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}} \frac{\xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right)}{\xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right)} . \tag{9.2}
\end{equation*}
$$

Using the notation of Lemma 8.15, we define

$$
L_{m}(k)_{w}=L_{m}(k) \cap w^{-1} \Phi^{-}
$$

and put $\Lambda_{w}(k)=\left\{m \mid 1 \leqslant m \leqslant M_{k}, L_{m}(k)_{w} \neq \emptyset\right\}$. In addition, we define

$$
h_{m}(k)=\max \left\{\text { ht } \alpha^{\vee} \mid \alpha \in L_{m}(k)\right\}, \quad h_{m, w}(k)=\min \left\{\text { ht } \alpha^{\vee} \mid \alpha \in L_{m}(k)_{w}\right\}
$$

for $m \in \Lambda_{w}(k)$. Note that $h_{m}(k)$ is attained by one of $\alpha \in L_{m}(k)_{w}$ by Lemma 8.2, Then the right-hand side of (9.2) equals

$$
\prod_{k=1}^{k_{p}} \prod_{m \in \Lambda_{w}(k)} \prod_{h_{m}=h_{m, w}(k)}^{h_{m}(k)} \frac{\xi\left(k s+h_{m}\right)}{\xi\left(k s+h_{m}+1\right)}=\prod_{k=1}^{k_{p}} \prod_{m \in \Lambda_{w}(k)} \frac{\xi\left(k s+h_{m, w}(k)\right)}{\xi\left(k s+h_{m}(k)+1\right)}
$$

by Lemma 8.2 and Lemma 8.15 (3). Now, by Lemma 9.1, we have

$$
\left|\frac{\xi\left(k s+h_{m, w}(k)\right)}{\xi\left(k s+h_{m}(k)+1\right)}\right|<1 \quad \text { for } \quad \Re(s)>-\frac{h_{m, w}(k)+h_{m}(k)}{2 k}
$$

for every $m \in \Lambda_{w}(k)$. We have

$$
\frac{h_{m, w}(k)+h_{m}(k)}{2 k} \geqslant \frac{c_{p}}{2},
$$

for every $m \in \Lambda_{w}(k)$, since $h_{m, w}(k) \geqslant \mathrm{ht} \beta_{m}(k)^{\vee}=k c_{p}-h_{m}(k)$ by Lemma 8.15 (5). Also, we obtain

$$
\left|\frac{\xi\left(k s+h_{m, w}(k)\right)}{\xi\left(k s+h_{m}(k)+1\right)}\right|<1 \quad \text { for } \quad \Re(s)=-\frac{c_{p}}{2} .
$$

unless $h_{m, w}(k)+h_{m}(k)=k c_{p}$. If $h_{m, w}(k)+h_{m}(k)=k c_{p}$,

$$
\left|\frac{\xi\left(k s+h_{m, w}(k)\right)}{\xi\left(k s+h_{m}(k)+1\right)}\right|=1 \quad \text { for } \quad \Re(s)=-\frac{c_{p}}{2} .
$$

Now we complete the proof of Proposition 6.6
Thus, we see that Proposition 6.6 follows from Lemma 8.15 whose the essential part is due to Lemmas 8.1 and explicit descriptions of root systems.
9.2. Proof of Proposition 6.7. We have

$$
D_{p}(s)=\prod_{k=1}^{\infty} \prod_{h \leqslant\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h-1)} \prod_{h>\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h)}
$$

by Lemma 8.6. Hence we have

$$
\begin{equation*}
\frac{X_{p}^{\ddagger}(s)}{D_{p}(s)}=\prod_{k=1}^{\infty} \prod_{h>\left(k c_{p}+1\right) / 2} \xi(k s+h)^{N_{p}(k, h-1)-N_{p}(k, h)} \tag{9.3}
\end{equation*}
$$

Note that $N_{p}(k, h-1)-N_{p}(k, h) \geqslant 0$ by Lemma 8.3. (This non-negativity should be hold by the construction of $M_{p}(k, h)$.) It is well-known that $\xi(s) \neq 0$ for $\Re(s) \geqslant 1$. Therefore, $\xi(k s+h) \neq 0$ for $\Re(s) \geqslant(1-h) / k$. On the other hand, we have $(1-h) / k \leqslant-c_{p} / 2$, since $k c_{p}$ and $h$ are both integers. If $k c_{p}$ is odd, $h>\left(k c_{p}+1\right) / 2$ implies $(1-h) / k \leqslant$ $-c_{p} / 2-1 /(2 k)<-c_{p} / 2$. Hence $X_{p}^{\ddagger}(s) / D_{p}(s) \neq 0$ for $\Re(s) \geqslant-c_{p} / 2$. If $k c_{p}$ is even, $h>\left(k c_{p}+1\right) / 2$ implies $(1-h) / k \leqslant-c_{p} / 2$. It also derives $X_{p}^{\ddagger}(s) / D_{p}(s) \neq 0$ for $\Re(s) \geqslant-c_{p} / 2$. We complete the proof of Proposition 6.7.

Thus, Proposition 6.7 is a simple consequence of Lemma 8.6 As well as Proposition 6.6, the essential part of Lemma 8.6 is due to Lemmas 8.1 and 8.4 .

## 10. Proof of Proposition 6.5

As mentioned before, the most essential part of the proof of Proposition 6.5 is the volume hypothesis (6.1) (or Theorem of [24, section 4.7]) which plays a key role in the proof of Lemma 10.3 below.
Lemma 10.1 Let $w \in \mathfrak{W}_{p}$. If $\left|w^{-1} \Delta \backslash \Phi_{p}\right|=1$, the set $\Phi^{+} \backslash \Phi_{p}^{+}$equals to either $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{+}$or $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$.
Proof. We show that $\Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$or $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$ if $\left|\Delta \backslash w \Phi_{p}\right|=1$. Suppose $\left|\Delta \backslash w \Phi_{p}\right|=1$, and denote by $\alpha_{w}$ the only one simple root in $\Delta \backslash w \Phi_{p}$. Then $\alpha_{w}$ belongs to $\Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$or $\Phi^{+} \cap w\left(\Phi^{-} \backslash \Phi_{p}^{-}\right)$, and hence $\alpha_{w}$ belongs to $\Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$or $-\alpha_{w}$ belongs to $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$.

Put $\Delta_{w}^{+}=\Delta \cap w \Phi_{p}^{+}$and $\Delta_{w}^{-}=\Delta \cap w \Phi_{p}^{-}$so that

$$
\Delta=\Delta_{w}^{+} \cup \Delta_{w}^{-} \cup\left\{\alpha_{w}\right\}
$$

(disjoint). Then we claim $\Delta_{w}^{+}=\Delta \cap w \Delta_{p}$. In fact $\Delta_{w}^{+} \supset \Delta \cap w \Delta_{p}$ is obvious. An arbitrary $\alpha \in \Delta_{w}^{+}$has the form

$$
\alpha=\sum_{j \neq p} n_{j} w \alpha_{j} \quad\left(n_{j} \geqslant 0, w \alpha_{j} \in \Phi^{-} \cup \Delta\right),
$$

since $w \Delta_{p} \subset \Phi^{-} \cup \Delta$. The right-hand side decomposes into two parts according to $w \alpha_{j} \in \Phi^{-}$or $w \alpha_{j} \in \Delta:$

$$
\alpha=\sum_{\substack{j \neq p \\ w \alpha_{j} \in \Phi^{-}}} n_{j} w \alpha_{j}+\sum_{\substack{j \neq p \\ w \neq j \in \Delta}} n_{j} w \alpha_{j} .
$$

We note that the left-hand side is a simple root. Therefore, $\alpha$ should be one of $\Delta \cap w \Delta_{p}$, and hence $\Delta_{w}^{+}=\Delta \cap w \Delta_{p}$.

Now we prove the assertion of the lemma by using a different way according to two cases $w \alpha_{p} \in \Phi^{+}$or $w \alpha_{p} \in \Phi^{-}$.

First we deal with the case $w \alpha_{p} \in \Phi^{+}$. Assume $\alpha_{w} \in \Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$. Then we will have a contradiction unless $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=\emptyset$. If $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \neq \emptyset$, there exists at least one simple root $\alpha_{k}$ such that

The simple root $\alpha_{k}$ belongs to one of $\Delta_{w}^{+}, \Delta_{w}^{-}$or $\left\{\alpha_{w}\right\}$. If $\alpha_{k} \in \Delta_{w}^{+}$, we have $\alpha_{k} \in$ $\Delta \cap w \Delta_{p} \subset \Phi^{+} \cap w \Phi^{+}$. This contradicts (10.1). If $\alpha_{k} \in \Delta_{w}^{-}$, we have $\alpha_{k} \in \Phi^{+} \cap w \Phi_{p}^{-}$. This contradicts (10.1). If $\alpha_{k}=\alpha_{w}$, we have $\alpha_{k}=\alpha_{w} \in \Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$by assumption. This also contradicts (10.1). Hence $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=\emptyset$ which implies $\Phi^{+} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=$ $w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$.

On the other hand, we have $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)=w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$if we assume that $-\alpha_{w}$ belongs to $\Phi^{-} \cap w\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$by a way similar to the above.

Finally we deal with the case $w \alpha_{p} \in \Phi^{-}$. We show that $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}=\left(\Phi^{+} \backslash \Phi_{p}^{+}\right)$ by induction on $k$ for $\Sigma_{p}(k)$ if $w \alpha_{p} \in \Phi^{-}$(i.e. $\left.\alpha_{p} \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}\right)$. By Lemma 8.1. we have $\Sigma_{p}(1) \subset\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$if $w \alpha_{p} \in \Phi^{-}$. Suppose that $\sum_{p}(k-1) \subset$ $\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$for $1<k \leqslant k_{p}$. Let $\alpha_{p}^{-}(k)$ be the lowest element of $\Sigma_{p}(k)$. Then there exists $\beta \in \Sigma_{p}(k-1)$ such that

Therefore $w \alpha_{p}^{-}(k)=\left(w \beta^{\vee}+w \alpha_{p}^{\vee}\right)^{\vee} \in \Phi^{-}$, i.e. $\alpha_{p}^{-}(k) \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$. Hence $\Sigma_{p}(k) \subset\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}$by Lemma 8.1.

Therefore the left-hand side is contained in the right-hand side.

Next we prove the right-hand side is contained in the left-hand side. We see that $\Delta_{p} \subset w^{-1}\left(\Delta_{p} \cup \Phi_{p}^{-}\right)$implies $\Delta_{p} \subset w^{-1}\left(\Delta \cup \Phi^{-}\right)$. Hence the right-hand side is contained in $\mathfrak{W}_{p}$. $>$ From the proof of Lemma 6.1, we see that $w \in W_{p} \operatorname{implies} l_{p}(w)=0$, which shows that the right-hand side is contained in $\mathfrak{W}_{p}^{\ddagger}$. Furthermore for $w \in W_{p}$, we have

\sum_{\mu=\mu_{0}+1}^{\infty} \frac{1}{\left(\mu / \mu_{0}\right)^{-\sigma}}\left|\frac{\mathcal{Q}_{\mu}\left(s^{1 / 2}\right)}{\mathcal{Q}_{\mu_{0}}\left(s^{1 / 2}\right)}\right|\left|1+\sum_{k=1}^{n} \frac{c_{k}(\mu)}{s^{k / 2}}+O\left(|s|^{-(n+1) / 2}\right)\right|<\frac{1}{2} .
$$

holds for $\Re(s)<-\sigma_{0}$ and $|\Im(s)|>1$. On the other hand

$$
\sum_{\mu=1}^{\mu_{0}-1} \frac{1}{\left(\mu / \mu_{0}\right)^{-\sigma}}\left|\frac{\mathcal{Q}_{\mu}\left(s^{1 / 2}\right)}{\mathcal{Q}_{\mu_{0}}\left(s^{1 / 2}\right)}\right|\left|1+\sum_{k=1}^{n} \frac{c_{k}(\mu)}{s^{k / 2}}+O\left(|s|^{-(n+1) / 2}\right)\right|=O\left(\mu_{0}^{-\sigma}|s|^{-1 / 2}\right)
$$

as $|\Im(s)| \rightarrow \infty$ in $\Re(s)<-\sigma_{0}$ by the choice of $\mu_{0}$. Hence we have

Q_{p}^{\ddagger}(s)+V_{p}(s)=\frac{\mathcal{Q}_{\mu_{0}}\left(s^{1 / 2}\right)}{\mu_{0}^{-s}}\left[1+\Theta(1 / 2)+O\left(\mu_{0}^{-\sigma}|s|^{-1 / 2}\right)\right]
$$

for $\Re(s)<-\sigma_{0}$ and $|\Im(s)|>R$, where $R$ is a large positive number and $\Theta(1 / 2)$ means a function whose absolute value is bounded by $1 / 2$. Therefore

\varepsilon_{p}(s)=\frac{X_{p}^{\ddagger}(s)}{D_{p}(s)} \frac{1}{R_{p}(s)}\left(Q_{p}^{\ddagger}(s)+V_{p}(s)\right)=\frac{X_{p}^{\ddagger}(s)}{D_{p}(s)} \frac{Q_{p}^{\ddagger}(s)}{R_{p}(s)} \frac{\mathcal{Q}_{\mu_{0}}\left(s^{1 / 2}\right)}{Q_{p}^{\ddagger}(s)} \mu_{0}^{s}[1+g(s)],
$$

and $|g(s)|<1$ as $|s| \rightarrow \infty$ with $\sigma<\kappa \log (|t|+10)$. This formula implies Proposition 6.9 by making $\kappa>0$ large if necessary.

## 12. Proof of Proposition 7.1

We need the following lemma.
Lemma 12.1 Let $\sigma_{0}>0, T>10$. Let $0 \leqslant \alpha<\beta<\sigma_{0}$, where $\alpha$ and $\beta$ can be depending on $T$. Let $f(s)$ be an analytic function, real for real, regular for $\sigma \geqslant \alpha$, except at finitely many poles on the real line; let

for $\sigma \geqslant \beta$.

Proof. We readily prove this by the similar method as in [22, p. 213].
Proof of Proposition 7.1. It suffices to show the proposition for large $T$, since we shall make $T$ large if necessary. $>$ From the proof of Proposition 6.9, we have

$$

where $r_{p}(s)$ is of (6.2). Recall the bound (6.3) for $r_{p}(s)$. Note that $Q_{p}^{\ddagger}(s) / R_{p}(s)$ is a polynomial by Definition 5.9 of $R_{p}(s)$.

For $N\left(T ; \sigma_{\mathrm{L}}\right)$, we consider the rectangle $R_{T}$ with vertices at $-\sigma_{\mathrm{L}}+c i, \sigma_{\mathrm{R}}+c i, \sigma_{\mathrm{R}}+i T$, $-\sigma_{\mathrm{L}}+i T$, where $\sigma_{\mathrm{R}}$ is a positive real number and $c>0$ is a positive constant. We take $\sigma_{\mathrm{R}}$ and $c$ large positive real numbers such that $\varepsilon_{p}(s)$ has no zeros on the line from $-\sigma_{\mathrm{L}}+c i$ to $\sigma_{\mathrm{R}}+c i$ and $\left|g\left(-\sigma_{\mathrm{L}}+i t\right)\right|,\left|r_{p}\left(\sigma_{\mathrm{R}}+i t\right)\right|<1$ for $|t| \geqslant c$. Also, we can assume that $\varepsilon_{P}(s)$ has no zeros on the rectangle.

We apply the standard method of the counting of zeros to the above rectangle with (6.3) and (12.1) (see [22, p. 212]). We have

\end{aligned}
$$

where $\Delta_{1}, \Delta_{2}, \Delta_{3}, \Delta_{4}$ denote the variations from $\sigma_{\mathrm{R}}+c i$ to $\sigma_{\mathrm{R}}+i T$, from $\sigma_{\mathrm{R}}+i T$ to $-\sigma_{\mathrm{L}}+i T$, from $-\sigma_{\mathrm{L}}+i T$ to $-\sigma_{\mathrm{L}}+i c$, from $-\sigma_{\mathrm{L}}+i c$ to $\sigma_{\mathrm{R}}+c i$, respectively. Clearly, $\Delta_{4} \arg \varepsilon_{p}(s)=O(1)$. Using (6.3) and (12.1), we can readily compute $\Delta_{1} \arg \varepsilon_{p}(s)$ and $\Delta_{3} \arg \varepsilon_{p}(s)$. For $\Delta_{2} \arg \varepsilon_{p}(s)$, referring to (9.3), we define

L^{*}(s) & =L(s)\left(1+r_{p}(s)\right) ;
\end{aligned}
$$

where $\gamma(s)=s(s-1) \pi^{-s / 2} \Gamma(s / 2)$. Then

$$
\varepsilon_{p}(s)=\Gamma^{*}(s) L^{*}(s)
$$

by definition, and

$$
\Delta_{2} \arg \varepsilon_{p}(s)=\Delta_{2} \arg \Gamma^{*}(s)+\Delta_{2} \arg L^{*}(s) .
$$

The valuation $\Delta_{2} \arg \Gamma^{*}(s)$ is computed easily by the Stirling formula. On the other hand, we have

& L(s) r_{p}(s)= \sum_{w \in \mathfrak{W}_{p}^{+} \cup \mathfrak{W}_{p}^{0} \backslash \mathfrak{W}_{p}^{\ddagger}} \frac{\tilde{Q}_{p, w}(s)}{R_{p}(s)} \prod_{\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}} \frac{\gamma\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right)}{\gamma\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+1\right)}  \tag{12.3}\\
& \times \prod_{\alpha \in\left(\Phi^{+} \backslash \Phi_{p}^{+}\right) \cap w^{-1} \Phi^{-}} \zeta\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}\right),
\end{align*}
$$

where $\tilde{Q}_{p, w}(s) / R_{p}(s)$ are polynomials by definition of $R_{p}(s)$. Therefore we see that

L^{*}(s) \ll T^{M} \quad\left(-\sigma_{\mathrm{L}} \leqslant \Re(s) \leqslant \sigma_{\mathrm{R}}\right)
$$

for some positive $M$ if $T$ is sufficiently large ([22, Chap.V]). Hence we have

by Lemma 12.1. Thus, we get the formula for $N\left(T ; \sigma_{\mathrm{L}}\right)$.
For $N(T ;+\infty)$, it suffices to consider $N(T ;-\kappa \log T)$ by Proposition 6.9. We form the rectangle $-\kappa \log T+c_{1} i, \sigma_{\mathrm{R}}+c_{1} i, \sigma_{\mathrm{R}}+i T,-\kappa \log T+i T$, where $c_{1}>0$ is taken such that $\varepsilon_{p}(s)$ has no zeros on the boundary of this rectangle. We follow the method as above. We similarly have

and $\Delta_{2}^{*} \arg \varepsilon_{p}(s)=\Delta_{2}^{*} \arg \Gamma^{*}(s)+\Delta_{2}^{*} \arg L^{*}(s)$, where where $\Delta_{1}^{*}, \Delta_{2}^{*}, \Delta_{3}^{*}, \Delta_{4}^{*}$ denote the variations from $\sigma_{\mathrm{R}}+c_{1} i$ to $\sigma_{\mathrm{R}}+i T$, from $\sigma_{\mathrm{R}}+i T$ to $-\kappa \log T+i T$, from $-\kappa \log T+i T$ to $-\kappa \log T+i c_{1}$, from $-\sigma_{\mathrm{L}}+i c_{1}$ to $\sigma_{\mathrm{R}}+i c_{1}$, respectively. Using (6.3) and (12.2), we can readily compute $\Delta_{1}^{*} \arg \varepsilon_{p}(s), \Delta_{3}^{*} \arg \varepsilon_{p}(s)$ and $\Delta_{4}^{*} \arg \Gamma^{*}(s)$. We see that

L^{*}(s) \ll T^{\kappa^{*} \log T} \quad\left(\sigma=-\kappa \log T \leqslant \Re(s) \leqslant \sigma_{\mathrm{R}}\right)
$$

by (12.3) (and [22, Chap.V]), where $\kappa^{*}>\kappa$ is a constant depending on $\kappa$. Thus we obtain

## 13. Proof of Proposition 7.2

The function $\varepsilon_{p}(s)$ is a linear combination of products of several zeta functions $\xi(k s+h)$ with coefficients of rational functions. Therefore $W_{p}(s)$ is an entire function of the order at most one, since $\xi(s)$ is an entire function of order one (and maximal type). Note that if $\rho$ is a zero of $W_{p}(z),-\bar{\rho}$ is so, since $\varepsilon_{p}(s)$ is real for real $s$. Thus, Propositions 6.8 and 6.9 imply the product factorization of $W_{p}(s)$ of the form

& w_{2}(z)=\prod_{n=1}^{\infty}\left[\left(1-\frac{z}{\eta_{n}}\right)\left(1+\frac{z}{\bar{\eta}_{n}}\right)\right] \exp \left(\frac{z}{\eta_{n}}-\frac{z}{\bar{\eta}_{n}}\right)
\end{aligned}
$$

where $\omega$ is a nonzero real number, $\beta$ is a complex number, $V(z)$ is a nonzero polynomial having no zeros in $\Im(z)>0$ except for purely imaginary zeros, $\Re\left(\rho_{n}\right)>0$, $\Re\left(\eta_{n}\right)>0$, $\Im\left(\eta_{n}\right) \geqslant 0$, and $0<\delta(t)<\Im\left(\rho_{n}\right)<\sigma_{L}+1<\Im\left(\eta_{n}\right)<\kappa \log \left(\Re\left(\eta_{n}\right)+10\right)$ for every $n \geqslant 1$. Here $\delta(t)$ is the function of Proposition 6.8, and $\kappa$ is the positive number of Proposition 6.9, and $\sigma_{L}$ is the positive number of Proposition 7.1. The products of the right-hand
sides converge uniformly on every compact subset in $\mathbb{C}$. Write $\rho_{n}=a_{n}+i b_{n}\left(b_{n}>0\right)$, and $\eta_{n}=c_{n}+i d_{n}\left(d_{n}>0\right)$. Then

\sum_{n=1}^{\infty}\left|\frac{1}{\rho_{n}}-\frac{1}{\bar{\rho}_{n}}\right| \leqslant 2 \sum_{n=1}^{\infty} \frac{b_{n}}{\left|\rho_{n}\right|^{2}} \leqslant 2\left(\sigma_{L}+1\right) \sum_{n=1}^{\infty} \frac{1}{\left|\rho_{n}\right|^{2}},
$$

and

$$
\sum_{n=1}^{\infty}\left|\frac{1}{\eta_{n}}-\frac{1}{\bar{\eta}_{n}}\right| \leqslant 2 \sum_{n=1}^{\infty} \frac{d_{n}}{\left|\eta_{n}\right|^{2}} \leqslant 2 \kappa \sum_{n=1}^{\infty} \frac{\log \left(c_{n}+10\right)}{\left|\eta_{n}\right|^{2}} \ll \epsilon_{\epsilon} \sum_{n=1}^{\infty} \frac{1}{\left|\eta_{n}\right|^{2-\epsilon}} .
$$

Because the sum on the right-hand side is finite, we can take factors $\sum_{n=1}^{\infty} \exp \left(\frac{z}{\rho_{n}}-\frac{z}{\overline{\rho_{n}}}\right)$ and $\sum_{n=1}^{\infty} \exp \left(\frac{z}{\eta_{n}}-\frac{z}{\bar{\eta}_{n}}\right)$ out of the infinite product. Hence we obtain the desired product formula except for the requirement for the exponent

$$

of the new exponential factor.
Now we prove $\Im(\alpha)=0$ to complete the proof of Proposition 7.2, We have

& =2 y \cdot \Im(\alpha)+O(\log y) \quad(y \rightarrow+\infty) .
\end{aligned}

In fact $\log |V(-i y) / V(i y)|=o(1)$,

\sum_{n=1}^{\infty} \log \frac{a_{n}^{2}+\left(y+b_{n}\right)^{2}}{a_{n}^{2}+\left(y-b_{n}\right)^{2}} \leqslant \sum_{n=1}^{\infty} \frac{4 y b_{n}}{a_{n}^{2}+\left(y-b_{n}\right)^{2}}=O\left(\sum_{\rho=1}^{\infty} \frac{y \log \rho}{\rho^{2}+y^{2}}\right)=O(\log y)
$$

as $y \rightarrow+\infty$ by $0<b_{n}<\sigma_{L}+1$ and Proposition 7.1. and

\sum_{n=1}^{\infty} \log \frac{c_{n}^{2}+\left(y+d_{n}\right)^{2}}{c_{n}^{2}+\left(y-d_{n}\right)^{2}} \leqslant \sum_{n=1}^{\infty} \frac{4 y d_{n}}{c_{n}^{2}+\left(y-d_{n}\right)^{2}}=O\left(\sum_{\rho=1}^{\infty} \frac{y \log \rho}{\left(\rho^{2}+y^{2}\right)^{1-\epsilon}}\right)=O(\log y)
$$

as $y \rightarrow+\infty$ by $0<d_{n}<\kappa \log \left(c_{n}+10\right)$ and Proposition 7.1. Hence, in order to prove $\Im(\alpha)=0$, it suffices to show

for some $A \neq 0$ and $m \geqslant 0$. Because of $D_{p}\left(-c_{p}-s\right)=D_{p}(s)$ and $R_{p}\left(-c_{p}-s\right)=R_{p}(s)$,

as $y \rightarrow+\infty$ for some $A \neq 0$ and $m \geqslant 0$, where the summation $\sum_{w}$ taken over all $w \in \mathfrak{W}_{p}^{+} \cup \mathfrak{W}_{p}^{0}, Q_{p, w}^{\prime}(s)=Q_{p, w}(s)$ for $w \in \mathfrak{W}_{p}^{+}$and $Q_{p, w}^{\prime}(s)=Q_{p, w}(s) / 2$ for $w \in \mathfrak{W}_{p}^{0}$.

By Propositions 6.5 and 6.6, we have

as $y \rightarrow+\infty$ for some $A \neq 0$ and $m>0$. We have

for some real numbers $a_{1}(w), \cdots, c_{n}(w)$, where $\delta_{w}=1$ if $w \in \mathfrak{W}_{p}^{\ddagger}$ and $\left|w^{-1} \Delta \backslash \Phi_{p}\right|=1$, and $\delta_{w}=0$ otherwise. We write

\frac{X_{p, w}(s)}{X_{p}^{\ddagger}(s)}=B_{p, w} s^{-\frac{A_{p, w}}{2}}\left(1+\frac{b_{1}(w)}{s}+\cdots+\frac{b_{n}(w)}{s^{n}}+O\left(|s|^{-n-1}\right)\right)\left(1+O\left(2^{-\sigma}\right)\right)
$$

as $\sigma \rightarrow+\infty$ for some real numbers $B_{p, w}>0, b_{1}(w), \cdots, b_{n}(w)$, and positive integers $A_{p, w}$ of (11.1) by a way similar to the proof of Proposition 6.9) On the other hand,

$$
\begin{aligned}
& \frac{\xi\left(k\left(-c_{p}-s\right)+h+\delta\right)}{\xi(k s+h+\delta)}=\frac{\xi\left(k s+k c_{p}-h-\delta+1\right)}{\xi(k s+h+\delta)} \\
& =(2 \pi / k)^{-\frac{k c_{p}-2 h-2 \delta+1}{2}} s^{\frac{k c_{p}-2 h-2 \delta+1}{2}}\left(1+\frac{c_{1}(k, h)}{s}+\cdots+\frac{c_{n}(k, h)}{s^{n}}+O\left(|s|^{-n-1}\right)\right)\left(1+O\left(2^{-\sigma}\right)\right)
\end{aligned}
$$

as $\sigma \rightarrow+\infty$. Therefore we obtain

& \frac{X_{p, w}\left(-c_{p}-s\right)}{X_{p, w}(s)}=\prod_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \frac{\xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle\left(-c_{p}-s\right)++\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)}{\xi\left(\left\langle\lambda_{p}, \alpha^{\vee}\right\rangle s+\mathrm{ht} \alpha^{\vee}+\delta_{\alpha, w}\right)} \\
& =\prod_{k=1}^{k_{p}} \prod_{h=1}^{k c_{p}+\hbar_{k}^{+}}\left(\frac{\xi\left(k\left(-c_{p}-s\right)+h\right)}{\xi(k s+h)}\right)^{N_{p, w}(k, h)}\left(\frac{\xi\left(k\left(-c_{p}-s\right)+h+1\right)}{\xi(k s+h+1)}\right)^{N_{p}(k, h)-N_{p, w}(k, h)} \\
& =B_{p, w}^{\prime} s^{-\frac{A_{p, w}^{\prime}}{2}}\left(1+\frac{b_{1}^{\prime}(w)}{s}+\cdots+\frac{b_{n}^{\prime}(w)}{s^{n}}+O\left(|s|^{-n-1}\right)\right)\left(1+O\left(2^{-\sigma}\right)\right)
\end{aligned}
$$

as $\sigma \rightarrow+\infty$ for some real numbers $B_{p, w}^{\prime}>0$ and integers $A_{p, w}^{\prime}$ given by

-A_{p, w}^{\prime}=\sum_{k=1}^{k_{p}} \sum_{h=k+\hbar_{k}^{-}}^{k+\hbar_{k}^{+}}\left(N_{p, w}(k, h)\left(k c_{p}-2 h+1\right)+\left(N_{p}(k, h)-N_{p, w}(k, h)\right)\left(k c_{p}-2 h-1\right)\right)
$$

Now we calculate $A_{p, w}^{\prime}$. We have

& =\sum_{k=1}^{k_{p}} \sum_{h=k+\hbar_{k}^{-}}^{k+\hbar_{k}^{+}} N_{p}(k, h)\left(k c_{p}-2 h\right)-\sum_{k=1}^{k_{p}} \sum_{h=k+\hbar_{k}^{-}}^{k c_{p}+\hbar_{k}^{+}}\left(N_{p}(k, h)-2 N_{p, w}(k, h)\right) .
\end{aligned}
$$

The first sum on the right-hand side is zero, since $N_{p}(k, h)=N_{p}\left(k, k c_{p}-h\right)$ and $\hbar_{k}^{-}+\hbar_{k}^{+}=$ $k\left(c_{p}-2\right)$ by Lemmas 8.3 and 8.14 . Therefore, we get

& =2\left(\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|-l_{p}(w)\right)-\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|=\left|\Phi^{+} \backslash \Phi_{p}^{+}\right|-2 l_{p}(w) .
\end{aligned}
$$

Hence $A_{p, w}^{\prime}>0$ for $w \in \mathfrak{W}_{p}^{+}$and $A_{p, w}^{\prime}=0$ for $w \in \mathfrak{W}_{p}^{0}$.
Combining the above facts, we obtain

\end{aligned}
$$

as $y \rightarrow+\infty$ for some positive integers $B_{p, w}^{*}$ and real numbers $b_{1}^{*}(w), \cdots, b_{n}^{*}(w)$. Now we obtain (13.1), and complete the proof of Proposition 7.2 ,

## 14. Proof of Theorem 7.5

In order to prove that all but finitely many zeros of $\xi_{p}(s)$ are simple, it suffices to show that $\theta(t)=\arg \varepsilon_{p}\left(-c_{p} / 2+i t\right)$ is strictly increasing as $t \rightarrow+\infty$, since we already know that all but finitely many zeros of $\xi_{p}(s)$ lie on the line $\Re(s)=-c_{p} / 2$, and

\xi_{p}\left(-c_{p} / 2+i t\right)=\left|\varepsilon_{p}\left(-c_{p} / 2+i t\right)\right|\left(e^{i \theta(t)} \pm e^{-i \theta(t)}\right)
$$

holds for a suitable choice of sign. We have

E_{p}(s)=Q_{p}^{\ddagger}(s) X_{p}^{\ddagger}(s)(1+o(1))
$$

as $|s| \rightarrow \infty$ on $\Re(s)=-c_{p} / 2$ by Propositions 6.5 and 6.6, and hence

$$
\varepsilon_{p}(s)=\frac{Q_{p}^{\ddagger}(s)}{R_{p}(s)} \frac{X_{p}^{\ddagger}(s)}{D_{p}(s)}(1+o(1))
$$

as $|s| \rightarrow \infty$ on $\Re(s)=-c_{p} / 2$. Note that $Q_{p}^{\ddagger}(s) / R_{p}(s)$ and $X_{p}^{\ddagger}(s) / D_{p}(s)$ are entire by Definitions 5.9 and 5.10. Using the above asymptotic formula and (9.3) of $X_{p}^{\ddagger}(s) / D_{p}(s)$, we can see that

\frac{d \arg \varepsilon_{p}\left(-c_{p} / 2+i t\right)}{d t}=\kappa \log t(1+o(1)) \quad(t \rightarrow+\infty)
$$

for some positive constant $\kappa$. Here the factor $\log t$ comes from the gamma factors of $X_{p}^{\ddagger}(s) / D_{p}(s)$ (see (9.3)), and we need to use the fact that

$$
\frac{\zeta^{\prime}}{\zeta}(1+i t)=O\left(\frac{\log t}{\log \log t}\right)=o(\log t) \quad(t \rightarrow+\infty)
$$

(see Theorem 5.7 of [22], for example), if $k c_{p}$ is even and $N_{p}(k, h-1)-N_{p}(k, h)>0$ for some $1 \leqslant k \leqslant k_{p}$ with $h=1+k c_{p} / 2$. In any case $\theta(t)=\arg \varepsilon_{p}\left(-c_{p} / 2+i t\right)$ is strictly increasing as $t \rightarrow \infty$. Hence we obtain the desired result.

The worst case of the proof could occur. In fact the zeta function of $A_{1}$ is

$$
\hat{\zeta}_{1}^{A_{1}}(s)=\frac{\hat{\zeta}(s+2)}{s}-\frac{\hat{\zeta}(s+1)}{s+2}
$$

In this case, we have the factor $\zeta(1+i t)$ in $\varepsilon_{1}(s)=\xi(s+2)$ on $\Re(s)=-1\left(c_{p}=2\right)$.

## 15. Appendix 1: Decomposition of $\Sigma_{p}(1)$

We use the same numbering as in [9, p.53]. In the following, we abbreviate $L_{j}^{\vee}(1)$ of Lemma 8.15 as $L_{j}^{\vee}$, and $\alpha^{\vee}=\sum_{i=1}^{r} a_{i} \alpha_{i}^{\vee}$ as the sequence $a_{1} \cdots a_{r}$ with $a_{p}=1$. We will give explicit forms of the sets $L_{j}^{\vee}$ according to the type of the root system $\Phi^{\vee}$.
15.1. $A_{n}$ case. Due to the symmetry of the root system, it is sufficient to consider the case $1 \leqslant p \leqslant[n / 2+1]$. Let $\alpha_{i, j}^{\vee}=\sum_{k=i}^{j} \alpha_{k}^{\vee}$. Then for $1 \leqslant j \leqslant p$,

## 17. Appendix 3: Homogeneous vector bundles

We present basic facts on homogeneous vector bundles according to [18]. Let $G$ be a semisimple complex Lie group of type $\Phi$ with a maximal torus $T$. Let $B$ be a Borel subgroup containing $T$, and let $P$ be a maximal parabolic subgroup of $G$ corresponding a simple root $\alpha_{p}$ in the fundamental system $\Delta$ attached to $B$.

Then $X_{p}=G / P$ is a connected compact complex manifold with the Picard number one, and the homogeneous line bundles on $X_{p}$ are in one-to-one correspondence with the set of weights $\Lambda_{p}=\mathbb{Z} \lambda_{p}$ and $\operatorname{Pic}\left(X_{p}\right) \simeq \Lambda_{p}$, where $\lambda_{p}$ is the fundamental weight corresponding to $\alpha_{p}$.

Let $L$ be a holomorphic line bundle on $X_{p}$, and let $c_{1}(L) \in H^{2}\left(X_{p}, \mathbb{R}\right)$ be the first Chern class of $L$. The first Chern class of a line bundle $L$ is identified with its associated weight $\lambda \in \Lambda_{p} \simeq \operatorname{Pic}\left(X_{p}\right)$ as follows:

$$
c_{1}(L)=\frac{i}{2 \pi} \sum_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}}\left\langle\lambda, \alpha^{\vee}\right\rangle d x_{\alpha} \wedge d \bar{x}_{\alpha},
$$

and hence we shall just write $c_{1}(L)=\lambda$. Let $T_{X_{p}}$ be the tangent bundle of $X_{p}$. Then we find that

$$
c_{1}\left(T_{X_{p}}\right)=\sum_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \alpha=c_{p} \lambda_{p},
$$

where $c_{p}$ is the number of (2.2).
The index $\mathfrak{i}_{p}$ of $X_{p}$ is defined by the identity $-K_{X_{p}}=\mathfrak{i}_{p} L_{\lambda_{p}}$ for the canonical bundle $K_{X_{p}}$ and the (ample) line bundle $L_{\lambda_{p}}$ associated with the fundamental weight. For the first Chern class of $K_{X_{p}}$, we have

$$
c_{1}\left(K_{X_{p}}\right)=-\sum_{\alpha \in \Phi^{+} \backslash \Phi_{p}^{+}} \alpha=-c_{1}\left(T_{X_{p}}\right)=-c_{p} \lambda_{p} .
$$

This derives the identity

$$
-K_{X_{p}}=c_{p} L_{\lambda_{p}} \quad\left(\mathfrak{i}_{p}=c_{p}\right) .
$$

Now the functional equation of the zeta function $\hat{\zeta}_{p}(s)$ associated with $(\Phi, \Delta, p)$ can be written as

$$
\hat{\zeta}_{p}\left(\left\langle c_{1}\left(K_{X_{p}}\right), \alpha_{p}^{\vee}\right\rangle-s\right)=\hat{\zeta}_{p}(s)
$$
