# Addition theorems for spin spherical harmonics. I Preliminaries

#### Abstract

We develop a systematic approach to deriving addition theorems for, and some other bilocal sums of, spin spherical harmonics. In this first part we establish some necessary technical results. We discuss the factorization of orbital and spin degrees of freedom in certain products of Clebsch-Gordan coefficients, and obtain general explicit results for the matrix elements in configuration space of tensor products of arbitrary rank of the position and angular-momentum operators. These results are the basis of the addition theorems for spin spherical harmonics obtained in part II.


## 1 Introduction

The importance of the representation theory of the three-dimensional rotation group [1-7] in the study of all natural quantum systems hardly needs to be mentioned. That central role is due to the fact that the four fundamental interactions of nature, and their effective interactions relevant to nuclear, atomic and molecular physics, are all invariant under the rotation group. It is also for that reason that partial-wave expansions are essential tools in the analysis of both classical and quantum scattering processes.

The algebraic aspects of the computation of partial-wave expansions with spin states are best codified by the addition theorems for spin spherical harmonics. Spin-s spherical harmonics $Y_{j j_{z}}^{\ell s}(\widehat{r})$ [4, 6] are the angular-momentum eigenfunctions relevant to the description of spin-s particles subject to spin-dependent central interactions 1 As such, they are of interest in their own right beyond their above-mentioned specific application to partial-wave expansions that constitutes our main motivation for their study. In this paper, together with its second part [10] (hereafter referred to as II), we develop a systematic framework to derive addition theorems for spin spherical harmonics, and employ it to obtain those addition theorems for low spins, $0<s^{\prime}, s \leq 3 / 2$, and for arbitrary integer spin $s^{\prime}$ if $s=0$.

In this first part we establish the preliminary results that will be used as basic building blocks for constructing addition theorems for spin spherical harmonics in II. We consider first the factorization of orbital and spin degrees of freedom in products of Clebsch-Gordan (henceforth CG) coefficients of the form $\left\langle\ell^{\prime}, \ell_{z}^{\prime} ; s^{\prime}, s_{z}^{\prime} \mid j, j_{z}\right\rangle\left\langle\ell, \ell_{z} ; s, s_{z} \mid j, j_{z}\right\rangle$. We obtain a general factorization result, make its tensor and spinor structure explicit, and discuss the particular cases relevant to spins $1 / 2,1$ and $3 / 2$. Such products of CG coefficients occur in the computation of physical quantities, such as scattering amplitudes or other matrix elements, related to transitions among states with definite orbital and spin quantum numbers. Thus, these results may be of interest independently of the addition theorems considered here and in II. We study also the matrix elements of arbitrary tensor products of orbital operators between angular-momentum projections of position eigenstates, for which we obtain completely general results. These are the other main ingredient in our derivation of addition theorems for spin spherical harmonics in II. Those matrix elements are closely related to bilocal spherical harmonics and other bilocal sums of ordinary spherical harmonics, as discussed in detail in II, so we expect that these results and the approach used to derive them should be applicable in other contexts as well.

[^0]The outline of the paper is as follows. In the next section we discuss the factorization of orbital and spin degrees of freedom in products of CG coefficients. In section 3 we introduce the angular-momentum projector operator and obtain general expressions for its matrix elements with orbital tensor operators. In appendix A we state our notation and conventions. In appendix B we give the definitions and main properties of the standard bases of irreducible tensors and spinors, of arbitrary spin, used as spin wavefunctions throughout the paper. A detailed list of general results for reduced matrix elements of arbitrary tensor products of orbital and spin operators, needed in the main sections of the paper, are given in appendix C Finally, appendix $D$ gathers some ancillary calculations needed in sect. 3.

## 2 Factorization of orbital and spin dependence

We begin by considering products of CG coefficients of the form

with $\ell^{\prime}, \ell$ integer and $s^{\prime}, s$ integer or half-integer. We will usually write $S\left(j, \ell^{\prime}, \ell, s^{\prime}, s\right)$, omitting the last arguments for brevity. For the purpose of obtaining addition theorems for spin spherical harmonics we need to rewrite $S\left(j, \ell^{\prime}, \ell, s^{\prime}, s\right)$ as a sum of terms with a completely factorized dependence on orbital and spin angular-momentum projections, and to make explicit the tensor structure of those terms. The first goal is achieved by making use of relation (A.1) to write (see appendix A for our notation and conventions),

In order to make the tensor structure of each term on the r.h.s. explicit, we use the Wigner-Eckart (henceforth WE) theorem [1] 6, 8] to write the CG coefficients in terms of appropriate irreducible tensor operators,

where $\Delta_{\text {min, max }}$ are as in (2), and our notation for the standard basis tensors $\widehat{\varepsilon}^{i_{1} \ldots i_{n}}$ and for irreducible tensor operators is explained in appendix B. The operators appearing in (3) are the orbital $\vec{L}$ and spin $\vec{S}$ angular momenta, the position versor $\widehat{r}=\vec{r} / r$, and the spin-transition operator $\vec{T}$ defined here as the spin analog of $\widehat{r}$ (see sect. 2.4 below for a detailed discussion of this operator). The reduced matrix elements appearing in (3) are explicitly given for arbitrary values of their parameters in appendix C]

Whereas (3) is completely general, it is not yet explicit enough for the purpose of deriving addition theorems for spin spherical harmonics. From a practical point of view, we need only consider low values of $s^{\prime}, s$ since quantum states with high values of spin occur infrequently in nature. In this paper we restrict ourselves to $s^{\prime}, s=0,1 / 2,1,3 / 2$, and $|\Delta s| \leq 1$. For those spins the coefficients $C_{\ell^{\prime} \ell j}^{s^{\prime} s \Delta}$ can be drastically simplified by exploiting the fact that $j-\ell^{\prime}$ and $j-\ell$ can take only a small set of values. The spin matrix elements in (3) can be compactly evaluated in terms of standard tensors and spinors, and spin matrices. (The orbital matrix elements could, in principle, also be expressed in that way, but it would be impractical because $\ell^{\prime}$, $\ell$ are not bounded above thus requiring tensor wave functions of arbitrarily large rank. We evaluate those matrix elements with a completely different technique below in section 3) Clearly, we must
discuss separately the different values of $s^{\prime}$ and $s$, as those will determine the kind of spin spherical harmonics involved in the addition theorem. For fixed $s^{\prime}$ and $s$, different values of $\Delta \ell$ correspond to different addition theorems, so we must consider those cases separately as well. Furthermore, both in addition theorems for spin spherical harmonics and in partial wave expansions, terms with different $|\Delta \ell|$ have different tensor and spin structure.

## $2.1 \quad s^{\prime}=1 / 2=s$

For $s^{\prime}=1 / 2=s$ there are two possible values of $|\Delta \ell|=0,1$.
$\Delta \boldsymbol{\ell}=\mathbf{0}$ In the case $s=1 / 2, j$ can take only two values and (3) reduces to

which is a well-known result (see e.g., [11]). Notice that, due to the conservation of $j_{z}$, the product $\widehat{\varepsilon}^{k}\left(\Delta \ell_{z}\right) \widehat{\varepsilon}^{h}\left(\Delta \ell_{z}\right)^{*}$ in (4) can be replaced by $\delta^{k h}$. We quote here also the simplified form of (2) in this case,

which results from (4) by applying the WE theorem.
$|\boldsymbol{\Delta} \ell|=1 \quad$ In this case $S\left(j, \ell^{\prime}, \ell, 1 / 2,1 / 2\right)$ can be non-vanishing only if $\ell^{\prime}=\ell+1$ and $j=\ell+1 / 2$, or if $\ell^{\prime}=\ell-1$ and $j=\ell-1 / 2$. Equation (3) takes the simplified form,

which is appropriate to derive an addition theorem for spin $-1 / 2$ spherical harmonics. As in the previous case, the product of standard versors can be substituted by $\delta^{k h}$. Similarly, (2) reduces to

As a side remark, we notice that in this case $(2\langle\ell\rangle+1) /\left(2 \ell_{1}+1\right)=(2 j+1) /(2 j+1+\Delta \ell)$, which provides an alternate form for (7).

## $2.2 s^{\prime}=1=s$

The general result (3) is greatly simplified in the case of $S\left(j, \ell^{\prime}, \ell, 1,1\right)$ because, for fixed $\ell, j-\ell$ can take only the three values $\pm 1,0$. The spin matrix elements are given by

There are three possible values for $\Delta \ell=0,1,2$.

This form of (3) is needed in the derivation of addition theorems for vector spherical harmonics. Notice that in the term multiplied by $C_{\ell \ell j}^{111}$ we can replace $\widehat{\varepsilon}^{k}\left(\Delta \ell_{z}\right) \widehat{\varepsilon}^{h}\left(\Delta \ell_{z}\right)^{*}$ by $\delta^{k h}$, and in the term multiplied by $C_{\ell \ell j}^{112}$ we can rewrite the matrix elements as

$|\boldsymbol{\Delta} \ell|=\mathbf{1} \quad$ In this case $S\left(j, \ell^{\prime}, \ell, 1,1\right)$ can be non-vanishing only if $\ell^{\prime}=\ell+1$ and $j=\ell+1, \ell$, or if $\ell^{\prime}=\ell-1$ and $j=\ell, \ell-1$. With that discrete set of values for $j-\ell$, the spin matrix elements (8), and the reduced matrix elements in appendix C, from (3) we obtain

As before, on the first line of (12) we can replace $\widehat{\varepsilon}^{k}\left(\Delta \ell_{z}\right) \widehat{\varepsilon}^{h}\left(\Delta \ell_{z}\right)^{*}$ by $\delta^{k h}$, and on the second line we can rewrite the matrix elements as

## 3 Angular momentum projection operators

We define the angular momentum projection operators as

It is immediate that $\mathcal{P}_{\ell}$ are a sequence of orthogonal projectors, which commute with $\vec{L}$ and resolve the identity,

From (52)-(54) the matrix elements of $\mathcal{P}_{\ell}$ with other orbital operators can be computed. Those matrix elements, together with the results on products of CG coefficients of the previous section, are the basic building blocks needed in our derivation of addition theorems for spin spherical harmonics. As will be discussed in II, however, the results for $\mathcal{P}_{\ell}$ matrix elements constitute by themselves addition theorems for spherical harmonics.

### 3.1 Matrix elements with tensor powers of $\vec{L}$

The matrix elements of $\mathcal{P}_{\ell}$ with tensor powers of $\vec{L}$ will be used in the derivation of addition theorems for spin spherical harmonics. For the irreducible components, from which the full tensor matrix elements can be reconstructed, we have

with $P_{\ell}^{(k)}$ the $k^{\text {th }}$ derivative of $P_{\ell}$ and,

For notational simplicity in what follows we adopt the following useful conventions. In $Z^{i_{1} \ldots i_{n_{1}} ; j_{1} \ldots j_{n_{2}}}$ one or both sets of indices may be empty,

In the term $q=0$ in (56a) the index sets are empty, $Z^{h_{1} \ldots h_{0} ; h_{1} \ldots h_{0}} \equiv Z^{\text {; }}$. Similarly, in the term $q=[p / 2]$, when $p$ is even, we set $v^{h_{2 q+1}} \ldots v^{h_{p}}=v^{h_{p+1}} \ldots v^{h_{p}} \equiv 1$.

The cases $n=1,2,3$ will be needed for the derivation of addition theorems for spherical harmonics of spin $1 / 2,1$ and $3 / 2$ so we quote them here explicitly,

### 3.2 Matrix elements with tensor powers of $\widehat{\boldsymbol{r}}$

The matrix element $\left\langle\widehat{p}^{\prime}\right| \mathcal{P}_{\ell^{\prime}} \widehat{r}^{i_{1}} \ldots \widehat{r}^{i_{n}} \mathcal{P}_{\ell}|\widehat{p}\rangle$ is an irreducible tensor if $\ell^{\prime}=\ell \pm n$, otherwise reducible. The irreducible matrix elements will be used in the derivation of addition theorems for spin spherical harmonics. They satisfy the recursion relation,

In these equations we used the notation $\ell_{k}=\ell \pm k$, see appendix A. Eqs. (58), (59) are established in appendix (D. The recursion relation (58) can be solved with the initial condition (59) to give

A_{n}=\frac{\left(\ell_{1}-\ell\right)^{n}}{4 \pi} \frac{2 \ell+1}{\prod_{k=0}^{n-1}\left(2 \ell_{k}+1\right)}=\frac{1}{4 \pi}\left(\frac{\ell_{n}-\ell}{n}\right)^{n}(2 \ell+1) \frac{\left(\ell_{n}+\ell-n-\frac{\ell_{n}-\ell}{n}\right)!!}{\left(\ell_{n}+\ell+n-\frac{\ell_{n}-\ell}{n}\right)!!},
\end{gather*}

with $Z^{i_{1} \ldots i_{n_{1}} ; j_{1} \ldots j_{n_{2}}}$ defined in (56b), (56c). As before, we adopt the convention that in the term with $k_{1}=n$, $k_{2}=0$ in (60) the first index set in $Z$ is empty, $Z^{i_{1} \ldots i_{0} ; i_{1} \ldots i_{n}} \equiv Z^{; i_{1} \ldots i_{n}}$ and, in the term with $k_{1}=0, k_{2}=n$, the second index set is empty $Z^{i_{1} \ldots i_{n} ; i_{n+1} \ldots i_{n}} \equiv Z^{i_{1} \ldots i_{n}}$; .

The particular cases $n=1,2,3$ will be needed for the derivation of addition theorems for spherical harmonics of spin $1 / 2,1$ and $3 / 2$, so we give them here explicitly,

& \left.-\frac{1}{2} \widehat{p}^{\left\{i_{1}\right.} \widehat{p}^{\prime i_{2}} \widehat{p}^{\left.\prime i_{3}\right\}_{0}} P_{\ell_{2}}^{\prime \prime \prime}(x)+\frac{1}{6} \widehat{p}^{\prime\left\{i_{1}\right.} \widehat{p}^{\prime i_{2}} \widehat{p}^{\left.\prime i_{3}\right\}_{0}} P_{\ell_{3}}^{\prime \prime \prime}(x)\right) . \tag{61c}

### 3.3 Mixed matrix elements

We consider now matrix elements of $\mathcal{P}_{\ell}$ with tensor products of both $\vec{L}$ and $\widehat{r}$. The matrix elements of the irreducible tensor operator $\widehat{r} i_{1} \ldots \widehat{r}^{i_{n}} L^{h_{1}} \ldots L^{\left.h_{p}\right\}_{0}}$ are of the form

From this equation and (60), for $t=1$ we obtain

For $s>1$, equation (62) leads to the recursion relation

&=\frac{i}{(n+t-1)!}\left(\widehat{p} \wedge \nabla_{p}\right)^{\left\{h_{t}\right.}\left\langle\widehat{p}^{\prime}\right| \mathcal{P}_{\ell_{n}} \widehat{r}^{\left\{i_{1}\right.} \ldots \widehat{r}^{i_{n}} L^{h_{1}} \ldots L^{\left.\left.h_{t-1}\right\}_{0}\right\}_{0}} \mathcal{P}_{\ell}|\widehat{p}\rangle \tag{64}
\end{align*}
$$

which can be solved with the initial condition (63) to yield

k_{1}+k_{2}=n}}^{n}(-1)^{k_{2}}\binom{n}{k_{1}} \sum_{q=0}^{[t / 2]} C_{t, q} Z^{\left\{i_{1} \ldots i_{k_{2}} h_{1} \ldots h_{q} ; i_{k_{2}+1} \ldots i_{n} h_{q+1} \ldots h_{2 q}\right.} v^{h_{2 q+1}} \ldots v^{\left.h_{t}\right\}_{0}} P_{\ell_{k_{1}}}^{(n+t-q)}(x), \tag{65}
\end{align*}
$$

with [ ] in the inner summation denoting integer part, $A_{n}$ as defined in (60), and $C_{s, q}, x, \vec{v}$, and $Z^{i_{1} \ldots i_{n_{1}} ; j_{1} \ldots j_{n_{2}}}$ as defined in (56b), with $\widehat{p}$ instead of $\widehat{r}$. As before, for notational simplicity, we have not separated from the sum the terms with $\left(k_{1}, k_{2}\right)=(n, 0),(0, n)$, those with $q=0$ and, for even $s$, those with $q=[s / 2]$. In those cases we apply the same conventions as explained after eqs. (56) and (60).

Particular cases of importance for the derivation of addition theorems for spherical harmonics of spin $1 / 2,1$ and $3 / 2$, are

\left\langle\widehat{p}^{\prime}\right| \mathcal{P}_{\ell_{2}} \widehat{r}^{\{i} \widehat{r}^{j} L^{k\}_{0}} \mathcal{P}_{\ell}|\widehat{p}\rangle= & \frac{i}{4 \pi} \frac{1}{2 \ell_{1}+1}\left(\widehat{p}^{\prime\{i} \widehat{p}^{\prime j} v^{k\}_{0}} P_{\ell_{2}}^{\prime \prime \prime}(x)-2 \widehat{p}^{\prime\{i} \widehat{p}^{j} v^{k\}_{0}} P_{\ell_{1}}^{\prime \prime \prime}(x)+\widehat{p}^{\{i} \widehat{p}^{j} v^{k\}_{0}} P_{\ell}^{\prime \prime \prime}(x)\right),  \tag{66b}\\
\left\langle\widehat{p}^{\prime}\right| \mathcal{P}_{\ell_{1}} \widehat{r}^{\{i} L^{j_{1}} L^{\left.j_{2}\right\}_{0}} \mathcal{P}_{\ell}|\widehat{p}\rangle= & -\frac{\ell_{1}-\ell}{4 \pi}\left(\widehat{p}^{\prime\{i} v^{j_{1}} v^{\left.j_{2}\right\}_{0}} P_{\ell_{1}}^{\prime \prime \prime}(x)-\widehat{p}^{\{i} v^{j_{1}} v^{\left.j_{2}\right\}_{0}} P_{\ell}^{\prime \prime \prime}(x)+\widehat{p}^{\prime\{i} \widehat{p}^{\prime j_{1}} \widehat{p}^{\left.j_{2}\right\}_{0}} P_{\ell_{1}}^{\prime \prime}(x)\right. \\
& \left.-\widehat{p}^{\prime\{i} \widehat{p}^{j_{1}} \widehat{p}^{\left.j_{2}\right\}_{0}} P_{\ell}^{\prime \prime}(x)\right) . \tag{66c}

## 4 Final remarks

We have presented in the foregoing sections preliminary results needed for the systematic derivation of addition theorems for spin spherical harmonics in II. In sect. 2 we obtained the factorization of orbital and spin degrees of freedom in products of CG coefficients of the form (1) in general form, and discussed the particular cases with $0 \leq s^{\prime}, s \leq 3 / 2$. In those cases the coefficients $C_{\ell^{\prime} \ell j}^{s^{\prime} s \Delta}$, given in full generality in (3), were reduced to much smaller forms, and the tensor and spinor structures of each term in the expansion given explicitly.

In sect. 3 the matrix elements of the angular-momentum projector operator with the irreducible components of arbitrary tensor products of $\widehat{r}$ and $\vec{L}$ are given in general form, for all values of their parameters. Those matrix elements will be used in II to obtain general expressions for bilocal spherical harmonics, and to derive addition theorems for spin spherical harmonics. Their applicability is even wider, however, when they are appropriately combined to obtain matrix elements of reducible tensor operators. Some examples of those applications will also be considered in II.

As a side remark we point out that an unexpected byproduct of the results of sect. 2 is an improvement in computational efficiency, at least in the specific case of infinite-precision computation 13 in which the results are given as a rational number times the square root of a rational number. Consider, for example, the computation of both sides of (19), at fixed $\ell$ and $j$, for all possible values of $-\ell \leq \ell_{z}^{\prime}, \ell_{z} \leq \ell$ and $-3 / 2 \leq s_{z}^{\prime}, s_{z} \leq 3 / 2$. If the l.h.s. of (19) is computed as written on the second line of (11), we find that the ratio of CPU times $\tau_{\text {r.h.s. }} / \tau_{\text {l.h.s. }}$ begins at $\sim 2$ at $\ell=1$, monotonically decreasing with $\ell$ to reach 1 at $\ell \sim 20, \sim 0.5$ at $\ell \sim 100$, and $\sim 0.25$ at $\ell \sim 200$. We remark that those numbers are subject to statistical fluctuations.

## A Notation and conventions

Throughout the paper we set $\hbar=1$. We denote tensor product states of orbital and spin angular momentum by $\left|\ell, \ell_{z} ; s, s_{z}\right\rangle=\left|\ell, \ell_{z}\right\rangle \otimes\left|s, s_{z}\right\rangle$, and states coupled to total angular momentum $j, j_{z}$ by $\left|\ell, s, j, j_{z}\right\rangle$. We follow the notation of [7] for CG coefficients,

(Different notations are used, e.g., in [1, 6, 8, 12].) We adopt the usual convention that $\left\langle\ell, \ell_{z} ; s, s_{z} \mid j, j_{z}\right\rangle=0$ if $\ell_{z}+s_{z} \neq j_{z}$, or $j<|\ell-s|$, or $j>\ell+s$. For Wigner $6 j$-symbols [1, 4-6] we use the definition and notation of [1,6]. The most important property of $6 j$-symbols for our purposes is the relation [1]

This relation is satisfied by the implementation of CG coefficients and $6 j$-symbols in the software system [13]. Our notation for the reduced matrix elements entering the WE theorem is explained in appendix B.1. For spherical harmonics $Y_{\ell m}$ and Legendre polynomials $P_{\ell}$ we use the standard definitions [1,6, 8 . Furthermore, we adopt the convention, usual in numerical computations [13], $Y_{\ell m}(\widehat{r}) \equiv 0$ if $|m|>\ell$. When states with different angular momenta or spins are considered, we use the notations,

We also find useful the notation $\ell_{k}=\ell \pm k$ for orbital angular-momentum quantum numbers, with the convention that when several $\ell_{k_{1}}, \ldots, \ell_{k_{p}}$ appear in the same equation, then either the upper or the lower sign is chosen for all of them simultaneously. Thus, $\ell_{n+1}-\ell_{n}=\ell_{p+1}-\ell_{p}= \pm 1$ for any $n$ and $p$.

We denote tensor indices by lower-case latin superindices, $A^{i_{1} \ldots i_{n}}$, and spinor indices by upper-case latin subindices, $\chi_{A}$. Since we consider only tensors and spinors of the su(2) algebra (as opposed to the sl(2) algebra), there is no need to raise spinor indices or lower tensor ones. We denote normal spinors and tensors by a caret, e.g., $\widehat{r}=\vec{r} / r$. Our choice of orthonormal bases for spinors and tensors is explained in appendix B.

Given a numeric or operator tensor $A^{i_{1} \ldots i_{n}}$, we denote its associated totally symmetrized and antisymmetrized tensors as,

We denote the traceless part of $A^{i_{1} \ldots i_{n}}$ by $A^{\left(i_{1} \ldots i_{n}\right)_{0}}$. The cases of importance in this paper are rank-2 and 3 tensors,

The same notation applies to tensor products, such as $\widehat{r}^{(i} \widehat{r}^{j)_{0}}=\widehat{r}^{i} \widehat{r}^{j}-1 / 3 \delta^{i j}$. We denote by $A^{\left\{i_{1} \ldots i_{n}\right\}_{0}}$ the traceless part of $A^{\left\{i_{1} \ldots i_{n}\right\}}$. Thus, the irreducible component of $A^{i_{1} \ldots i_{n}}$ is $1 / n!A^{\left\{i_{1} \ldots i_{n}\right\}_{0}}$. A more systematic approach to irreducible tensors is given in the following section.

## B Standard tensor and spinor bases

In this appendix we introduce the standard bases for irreducible spinors and tensors of the su(2) algebra used as spin wavefunctions throughout the paper. We use spin wavefunctions of the Rarita-Schwinger type [14], which carry only vector indices varying from 1 to 3 and spinor indices from 1 to 2 , and whose components are linearly related by symmetry and tracelessness and, for spinors, by transversality conditions. In fact, the spinors discussed in sect. B. 2 are the non-relativistic version of Rarita-Schwinger spinors. The standard bases are defined so that they are orthonormal, have definite complex-conjugation properties and satisfy the Condon-Shortley phase conventions [1, 2, 4, 8 .

Our starting point is the usual basis for Pauli spinors,

The second equality in (B.7b) follows from the first one by using the explicit expression for CG coefficients coupling angular momenta differing in one unit [7, 8]. From (B.7) it is clear that $\widehat{\varepsilon}^{i_{1} \ldots i_{n}}(m)$ is totally symmetric. Explicit evaluation shows that $\widehat{\varepsilon}^{i_{1} i_{2}}(m),-2 \leq m \leq 2$, are traceless and therefore it follows from (B.6) by induction that $\widehat{\varepsilon}^{i_{1} \ldots i_{n}}(m)$ are totally traceless for all $n \geq 2,-n \leq m \leq n$. Thus, (B.6) defines a set of $2 n+1$ irreducible tensors of rank $n$. From (B.4) and (B.6) we obtain by induction the orthonormality and complex-conjugation relations

The orthogonal complement of the spin- $(n+1 / 2)$ subspace in $\mathbb{C}^{(2 n+1) \times 2}$ is $\operatorname{ker}(X)$, which can be parameterized as $\sigma_{A B}^{\left\{i_{1}\right.} \widehat{\chi}_{B}^{\left.i_{2} \ldots i_{n}\right\}_{0}}$ with $\widehat{\chi}_{A}^{i_{1} \ldots i_{(n-1)}}$ a spin- $(n-1 / 2)$ spinor. This is the spin- $(n-1 / 2)$ subspace of $\mathbb{C}^{(2 n+1) \times 2}$.

The spin operator for $s=(n+1 / 2)$ spinors is given by the operator tensor product of the spin- $n$ and spin- $1 / 2$ operators, its matrix being
