Erratum: QCD sum rules study of the $J^{PC} = 1^{--}$ charmonium Y mesons

We correct a mistake in the analytical expression given in Nucl. Phys. **A** 815, 53 (2009) [arXiv:0804.4817] for the $D_{s0}\bar{D}_s^*$ and $D_0\bar{D}^*$ molecular currents. As a consequence, the mass obtained for the $D_0\bar{D}^*$ molecular current: $m_{D_0\bar{D}^*}=(4.96\pm0.11)$ GeV is no longer compatible with the experimental mass of the meson Y(4260).

An error was made when calculating the spectral density of the mixed condensate for the $D_{s0}(2317)\bar{D}_s^*(2110)$ molecular current, with $J^{PC}=1^{--}$, in ref. [1]. Although the difference is only a signal inone part of the mixed condensate, the result for the mass of the state changes significantly. The correct expression is

$$\rho_1^{mix}(s) = -\frac{m_c \langle \bar{s}g\sigma.Gs \rangle}{2^7 \pi^4 s} \int_{\alpha_{min}}^{\alpha_{max}} \frac{d\alpha}{\alpha} \int_{\beta_{min}}^{1-\alpha} \frac{d\beta}{\beta^2} (2\alpha + \beta) \left[(\alpha + \beta) m_c^2 - \alpha \beta s \right]. \tag{1}$$

Doing the same analyses as done in ref. [1] we arrive at

$$m_{D_{s0}\bar{D}_s^*} = (5.12 \pm 0.10) \text{ GeV} ,$$
 (2)

which is not in agreement with the Y(4350) mass [2, 3] neither with the Y(4660) mass [3]. The above result was obtained using $5.5 \le \sqrt{s_0} \le 5.7$ GeV. For values of $\sqrt{s_0} \le 5.4$ GeV we do not find an available Borel window.

For the molecular current $D_0\bar{D}^*$, using $5.4 \le \sqrt{s_0} \le 5.6$ GeV we get

$$m_{D_0\bar{D}^*} = (4.96 \pm 0.11) \text{ GeV} ,$$
 (3)

which is much bigger than the mass of the meson Y(4260) [4].

Therefore, we conclude that it is not possible to describe the Y(4260) meson with a $D_0\bar{D}^*$ molecular current.
