# Nonparametric tests for pathwise properties of semimartingales

We propose two nonparametric tests for investigating the pathwise properties of a signal modeled as the sum of a Lévy process and a Brownian semimartingale. Using a nonparametric threshold estimator for the continuous component of the quadratic variation, we design a test for the presence of a continuous martingale component in the process and a test for establishing whether the jumps have finite or infinite variation, based on observations on a discrete-time grid. We evaluate the performance of our tests using simulations of various stochastic models and use the tests to investigate the fine structure of the DM/USD exchange rate fluctuations and SPX futures prices. In both cases, our tests reveal the presence of a non-zero Brownian component and a finite variation jump component.

Keywords: high frequency data; jump processes; nonparametric tests; quadratic variation; realized volatility; semimartingale

## 1. Introduction

Continuous-time stochastic models based on discontinuous semimartingales have been increasingly used in many applications, such as financial econometrics, option pricing and stochastic control. Some of these models are constructed by adding i.i.d. jumps to a continuous process driven by Brownian motion [16, 22], while others are based on purely discontinuous processes which move only through jumps [8, 18]. Even within the class of purely discontinuous models, one finds a variety of models with different path properties - finite/infinite jump intensity, finite/infinite variation - which turn out to have an importance in applications, such as optimal stopping [5] and the asymptotic behavior of option prices $[9,10]$. It is therefore of interest to investigate which class of models - diffusion, jump-diffusion or pure-jump - is the most appropriate for a given data set. Nonparametric procedures have been recently proposed for investigating the presence of jumps $[2,6,17]$ and studying some fine properties of the jumps $[3,4,25,26]$

in a signal. Here, we address related, but different, issues: for a semimartingale whose jump component is a Lévy process, we propose a test for the presence of a continuous martingale component in the price process, which allows us to discriminate between purejump and jump-diffusion models, and a test for determining whether the jump component has finite or infinite variation. Our tests are based on a nonparametric threshold estimator [20] for the integrated variance (defined as the continuous component of the quadratic variation) based on observations on a discrete-time grid. Without imposing restrictive assumptions on the continuous martingale component, we obtain a central limit theorem for this threshold estimator (Section 3) and use it to design our tests (Section 4).

Using simulations of stochastic models commonly used in finance, we check the performance of our tests for realistic sample sizes (Section 5). Applied to time series of the DM/USD exchange rate and SPX futures prices (Section 6), our tests reveal, in both cases, the presence of a non-zero Brownian component, combined with a finite variation jump component. These results suggest that these asset prices may be modeled as the sum of a Brownian martingale and a jump component of finite variation.

## 2. Definitions and notation

We consider a semimartingale $\left(X_{t}\right)_{t \in[0, T]}$, defined on a (filtered) probability space $\left(\Omega,\left(\mathcal{F}_{t}\right)_{t \in[0, T]}, \mathcal{F}, P\right)$ with paths in $D([0, T], \mathbb{R})$, driven by a (standard) Brownian motion $W$ and a pure-jump Lévy process $L$ :

where $a, \sigma$ are adapted processes with right-continuous paths with left limits (cadlag processes), such that (1) admits a unique strong solution $X$ on $[0, T]$ which is adapted and cadlag [11]. $L$ has Lévy measure $\nu$ and may be decomposed as $L_{t}=J_{t}+M_{t}$, where

$J$ is a compound Poisson process representing the "large" jumps of $X, \mu$ is a Poisson random measure on $[0, T] \times \mathbb{R}$ with intensity measure $\nu(\mathrm{d} x) \mathrm{d} t, N$ is a Poisson process with intensity $\nu(\{x,|x|>1\})<\infty, \gamma_{\ell}$ are i.i.d. and independent of $N$ and the martingale $M$ is the compensated sum of small jumps of $L$. We will define $\mu(\mathrm{d} x, \mathrm{~d} t)-\nu(\mathrm{d} x) \mathrm{d} t=$ : $\tilde{\mu}(\mathrm{d} x, \mathrm{~d} t)$, the compensated Poisson random measure associated to $\mu$. We allow for the infinite activity (IA) case $\nu(\mathbb{R})=\infty$, where small jumps of $L$ occur infinitely often. For a semimartingale $Z$, we denote by $\Delta_{i} Z=Z_{t_{i}}-Z_{t_{i-1}}$ its increments and by $\Delta Z_{t}=$ $Z_{t}-Z_{t-}$ its jump at time $t$. The Blumenthal-Getoor $(B G)$ index of $L$, defined as

measures the degree of activity of small jumps. A compound Poisson process has $\alpha=0$, while an $\alpha$-stable process has BG index equal to $\alpha \in] 0,2[$. The gamma process and the variance gamma (VG) process are examples of infinite activity Lévy processes with $\alpha=0$. A pure-jump Lévy process with BG index $\alpha<1$ has paths with finite variation, while for $\alpha>1$, the sample paths have infinite variation a.s. When $\alpha=1$, the paths may have either finite or infinite variation [7]. The normal inverse Gaussian process (NIG) and the generalized hyperbolic Lévy motion (GHL) have infinite variation and $\alpha=1$. Tempered stable processes [8, 10] allow for $\alpha \in\left[0,2\left[\right.\right.$. We call $I V=\int_{0}^{T} \sigma_{u}^{2} \mathrm{~d} u$ the integrated variance of $X$ and $I Q=\int_{0}^{T} \sigma_{u}^{4} \mathrm{~d} u$ the integrated quarticity of $X$, and we write

We will use the following assumption.

## Assumption A1.

where $f(h) \sim g(h)$ means that $f(h)=\mathrm{O}(g(h))$ and $g(h)=\mathrm{O}(f(h))$ as $h \rightarrow 0$.
This assumption implies that $\alpha$ is the BG index of $L$. A1 is satisfied if, for instance, $\nu$ has a density which behaves as $\frac{K_{ \pm}}{|x|^{1+\alpha}}$ when $x \rightarrow 0 \pm$, where $K_{ \pm}>0$. In particular, A1 holds for all Lévy processes commonly used in finance [10]: NIG, variance gamma, tempered stable processes or generalized hyperbolic processes.

Typically, we observe $X_{t}$ in the form of a discrete record $\left\{x_{0}, X_{t_{1}}, \ldots, X_{t_{n-1}}, X_{t_{n}}\right\}$ on a time grid $t_{i}=i h$ with $h=T / n$. Our goal is to provide, given such a discrete observations, nonparametric tests for:

- detecting the presence of a continuous martingale component in the price process;
- analyzing the qualitative nature of the jump component, that is, whether it has finite or infinite variation.


## 3. Central limit theorem for a threshold estimator of integrated variance

The "realized variance" $\sum_{i=1}^{n}\left(\Delta_{i} X\right)^{2}$ of the semimartingale $X$ converges in probability [24] to

A threshold estimator $[19,20]$ of the integrated variance $I V=\int_{0}^{T} \sigma_{t}^{2} \mathrm{~d} t$ is based on the idea of summing only some of the squared increments of $X$, those whose absolute value is smaller than some threshold $r_{h}$ :

The term $\int_{0}^{T} \int_{\mathbb{R}-\{0\}} x^{2} \mu(\mathrm{~d} x, \mathrm{~d} s)$, due to jumps, vanishes as $h \rightarrow 0$ for an appropriate choice of the threshold. P. Lévy's law for the modulus of continuity of the Brownian paths implies that

and allows such a threshold to be chosen. It is shown in [20], Corollary 2, Theorem 4, that, under the above assumptions, if we choose a deterministic threshold $r_{h}$ such that

then $\hat{V}_{h} \xrightarrow{P} I V$ as $h \rightarrow 0$. If the jumps have finite intensity, then the thresholding procedure allows as $h \rightarrow 0$, a jump to be detected in $\left.] t_{i-1}, t_{i}\right]$. In fact, since $a$ and $\sigma$ are cadlag (or caglad), their paths are a.s. bounded on $[0, T]$, so

It follows from [20] that

Since realistic values of $\sigma$ for asset prices belong to [0.1, 0.8] (in annual units), we have that for small $h$, the r.v. $\Lambda$ has order of magnitude of 1 , thus, in the finite jump intensity case, a.s. for sufficiently small $h,\left(\Delta_{i} X\right)^{2}>r_{h}>2 h \log \frac{1}{h}$ indicates the presence of jumps in $\left.] t_{i-1}, t_{i}\right]$.

When $L$ has infinite activity, $\sum_{i=1}^{n}\left(\Delta_{i} X\right)^{2} I_{\left\{\left(\Delta_{i} X\right)^{2} \leq r_{h}\right\}}$ behaves like $\sum_{i=1}^{n}\left(\Delta_{i} X\right)^{2} \times$ $I_{\left\{\Delta_{i} N=0,\left|\Delta_{i} M\right| \leq 2 \sqrt{r}_{h}\right\}}$ for small $h$ (Lemma A.2). Moreover, for any $\delta>0$, the jumps contributing to the increments $\Delta_{i} X$ such that $\left(\Delta_{i} X\right)^{2} \leq r_{h}$ for small $h$ have size smaller than $c \sqrt{r_{h}+\delta}([20]$, Lemma 1), so their contribution vanishes when $h \rightarrow 0$. Note that
$r_{h}=c h^{\beta}$ satisfies condition (5) for any $\left.\beta \in\right] 0,1[$ and any constant $c$. Since $\sqrt{2} \sigma \simeq 1$ in most applications, we use $c=1$. Define

Let us remark that if $\lim _{h \rightarrow 0} r_{h}=0$, then, by A1, we have, as $h \rightarrow 0$,

where $\alpha$ is the BG index of $L$. The following lemma, proved in the Appendix, states that under (5), each increment $\Delta_{i} M$ such that $\left|\Delta_{i} M\right| \leq 2 \sqrt{r_{h}}$ only contains jumps of magnitude less than $2 \sqrt{r_{h}}$ if $\alpha \leq 1$, or smaller than $2 h^{1 /(2 \alpha)} \log ^{1 /(2 \alpha)} \frac{1}{h}$ if $\alpha>1$.

Lemma 3.1. Define, for $h>0, v_{h}:=h^{1 /(2 \alpha)} \log ^{1 /(2 \alpha)} \frac{1}{h}$. Under (5). there exists a sequence $h_{k}=T / n_{k}$ tending to zero as $k \rightarrow \infty$ such that, for $k_{0}$ sufficiently large and $h \in\left\{h_{k}, k \geq k_{0}\right\}:$
(i) if $\alpha \leq 1$, then for all $i=1, \ldots, n$,

(ii) if $\alpha>1$, then for all $i=1, \ldots, n$, we have

Remark 3.2. Note that $v_{h} \leq r_{h}^{1 / 4}$ so that in the case (ii) above $(\alpha>1)$, for all $i=$ $1, \ldots, n$, the jumps of $M$ on $\left\{\left(\Delta_{i} M\right)^{2} \leq 4 r_{h}\right\}$ are bounded by $r_{h}^{1 / 4}$.

Definition. Define

L_{t}^{(h)}:=\int_{0}^{t} \int_{|x| \leq 2 \sqrt[4]{r} \bar{r}_{h}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t)-\int_{0}^{t} \int_{2 \sqrt[4]{r_{h}<|x| \leq 1}} x \nu(\mathrm{~d} x) \mathrm{d} t
$$

\Delta_{i} M^{(h)}:=\int_{t_{i-1}}^{t_{i}} \int_{|x| \leq 2 \sqrt[4]{r_{h}}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t) \tag{10}

By Lemma 3.1, on a subsequence, a.s. for sufficiently small $h, \forall i=1, \ldots, n$, on $\left\{\left(\Delta_{i} M\right)^{2} \leq\right.$ $\left.4 r_{h}\right\}$, we have

$\Delta_{i} M^{(h)}$ is the compensated sum of jumps smaller in absolute value than $2 \sqrt[4]{r} h$, while $h d\left(2 \sqrt[4]{r_{h}}\right)$ is the compensator of the (missing) jumps larger than $2 \sqrt[4]{r_{h}}$.

In [20], a central limit theorem for $I \hat{V}_{h}$ was shown in the case of finite intensity jumps and cadlag adapted $\sigma$. Theorem 3.5 extends this to the case of infinite activity without extra assumptions on $\sigma$. In particular, when $\alpha<1$, the error $I \hat{V}_{h}-I V$ has the same rate of convergence and asymptotic variance as in the case of finite intensity jumps. The following proposition gives the asymptotic variance of $\left(I \hat{V}_{h}-I V\right) / \sqrt{2 h}$ when $\alpha<1$.

Proposition 3.3. If $r_{h}=h^{\beta}$ with $1>\beta>\frac{1}{2-\alpha / 2} \in[1 / 2,1[$, then, as $h \rightarrow 0$,

The following result will be used to prove Theorem 3.5.

Theorem 3.4. Under Assumption A1, as $h \rightarrow 0$,

where $\varepsilon=h^{u}, 0<u \leq 1 / 2, \ell_{j, h}=\int_{|x| \leq \varepsilon} x^{j} \nu(\mathrm{~d} x) / \varepsilon^{j-\alpha}$ for $j=2,4$ and $\ell_{1, h}=\int_{\varepsilon<|x| \leq 1} x \nu(\mathrm{~d} x) /$ $\left[\left(c+\varepsilon^{1-\alpha}\right) I_{\{\alpha \neq 1\}}+\ln \frac{1}{2 \varepsilon} I_{\{\alpha=1\}}\right]$ tend to non-zero constants depending on $\nu$.

We are now ready to state our central limit theorem for the estimator $I \hat{V}_{h}$. A sequence $\left(X_{n}\right)$ is said to converge stably in law to a random variable $X$ (defined on an extension $\left(\Omega^{\prime}, \mathcal{F}^{\prime}, P^{\prime}\right)$ of the original probability space) if $\lim E\left[U f\left(X_{n}\right)\right]=E^{\prime}[U f(X)]$ for every bounded continuous function $f: \mathbb{R} \rightarrow \mathbb{R}$ and all bounded random variables $U$. This is obviously stronger than convergence in law [15].

Theorem 3.5. Assume A1 and $\sigma \not \equiv 0$; choose $r_{h}=h^{\beta}$ with $\beta>\frac{1}{2-\alpha / 2} \in[1 / 2,1[$. Then:
(a) if $\alpha<1$, we have, with $\xrightarrow{\text { st }}$ denoting stable convergence in law,

Remark. For $\alpha<1$, Jacod [13], Theorem 2.10(i), has shown a related central limit result for the threshold estimator of $I V$, where $L$ is a semimartingale, but under the additional assumption that $\sigma$ is an Itô semimartingale. The proof of Theorem 3.5 in the case $\alpha<1$ does not rely on [13], Theorem 2.10(i). An alternative proof under the Itô semimartingale assumption for $\sigma$ could combine the results [20] with [13], Theorem 2.10(i), in that

\hat{I V}\left(X_{1}\right) \doteq \sum_{i=1}^{n}\left(\Delta_{i} X_{1}\right)^{2} I_{\left\{\left(\Delta_{i} X_{1}\right)^{2} \leq r_{h}\right\}}, \quad \hat{V}(M) \doteq \sum_{i=1}^{n}\left(\Delta_{i} M\right)^{2} I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h}\right\}}

The first term converges stably in law by [20], the second one converges stably to zero by [13], Theorem 2.10(i). That the remaining terms are negligible requires some further work (see the proof of Theorem 3.5).

## 4. Statistical tests

### 4.1. Test for the presence of a continuous martingale component

We now use the above results to design a test to detect the presence of a continuous martingale component $\int_{0}^{t} \sigma_{t} \mathrm{~d} W_{t}$, given discretely recorded observations. Our test is feasible in the case where $L$ has BG index $\alpha<1$, that is, the jumps are of finite variation (see

Section 4.2). The test proceeds as follows. First, we choose a coefficient $\beta \in[1 / 2,1[$ close to 1 . If we have an estimate $\hat{\alpha}$ of the BG index [3, 25, 26], then we may choose $\beta>\frac{1}{2-\hat{\alpha}}$ (recall that $\frac{1}{2-\alpha} \in\left[1 / 2,1\left[\right.\right.$ ). We choose a threshold $r_{h}=h^{\beta}$ and use the estimator $\hat{I Q_{h}}$ of the integrated quarticity defined in Proposition 3.3. We have shown in Theorem 3.5 that, when $\sigma \not \equiv 0$ in the case $\alpha<1$, the estimator $\hat{V}_{h}$ is asymptotically Gaussian as $h \rightarrow 0$. However, if $\sigma \equiv 0$, then both the numerator and the denominator of (13) tend to zero. To handle this case, we add an i.i.d. noise term:

Note that if, on the contrary, $\sigma \not \equiv 0$, then we have that the limit in probability of $\hat{V}_{h}^{v}$ is strictly larger than $v^{2} T$ and, by Lemma A.2, passing to a subsequence, a.s.

Therefore, under the alternative $\left(H_{1}\right) \sigma \not \equiv 0, U_{h} \rightarrow+\infty$ and $P\left\{\left|U_{h}\right|>1.96\right\} \rightarrow 1$, so the test is consistent.

Local power of the test. To investigate the local power of the test $U_{h}$, we consider a sequence of alternatives $\left(H_{1}^{h}\right) \sigma=\sigma^{h}$, where $\sigma^{h} \downarrow 0$. We denote by $\hat{I Q_{\sigma^{h}}^{v}}, U_{\sigma^{h}}$ the statistics analogous to $\hat{I Q}_{h}^{v}, U_{h}$, but constructed from $\left.\left.X_{t}^{h}=x_{0}+\int_{0}^{t} a_{s} \mathrm{~d} s+\int_{0}^{t} \sigma_{s}^{h} \mathrm{~d} W_{s}+L_{t}, t \in\right] 0, T\right]$. In the case of constant $\sigma$ and $\sigma^{h}$, and finite jump intensity, using standard results on convergence of sums of a triangular array [14], Lemmas 4.1 and 4.3, we have

where $\xrightarrow{\text { ucp }}$ denotes uniform convergence in probability on compacts subsets of $[0, T][24]$ and $Z$ is a standard Brownian motion. So, either $U_{\sigma^{h}}$ tends in distribution to $c+\sqrt{2} v^{2} Z_{T}$, if $\sigma^{h}=\mathrm{O}\left(h^{1 / 4}\right)$, or $U_{\sigma^{h}} \rightarrow \infty$, if $h^{1 / 4}=\mathrm{o}\left(\sigma^{h}\right)$. Thus, if $c$ is a (possibly zero) constant, we have:

For values of $v$ in Section 5, we have $1.64 / \sqrt{2 T} v^{2}=\mathrm{O}\left(10^{8}\right)$ and thus the local power of the test is small if $\sigma^{h}=\mathrm{O}\left(h^{1 / 4}\right)$.

### 4.2. Testing whether the jump component has finite variation

To construct a test for discriminating $\alpha<1$ from $\alpha \geq 1$, Theorem 3.5 suggests the use of $\left(\hat{I} \hat{V}_{h}-I V\right) / \sqrt{2 h \hat{I Q_{h}}}$, but this requires knowing the process $\sigma$ to compute $I V$. We propose a feasible alternative. Consider, instead, the estimator

is an estimator of the integrated variance $v^{2} T$ of $H^{v}$, so, under the null hypothesis $\left(\mathrm{H}_{0}\right)$ $\alpha<1$, we can find $\left.\beta>\frac{1}{2-\alpha} \in\right] \frac{1}{2}, 1[$ such that

where $\hat{I Q_{h}^{H^{v}}}:=\frac{1}{3 h} \sum_{i}\left(\Delta_{i} \hat{H}^{v}\right)^{4} I_{\left\{\left(\Delta_{i} \hat{H}^{v}\right)^{2} \leq r_{h}\right\}}$ and $r_{h}=h^{\beta}$. In particular, $P\left\{\left|U_{h}^{(\alpha)}\right|>1.96\right\} \rightarrow$ $5 \%$.

If, on the contrary, $\alpha \geq 1$, then reasoning as in Theorem 3.5, for any $\beta \in] 0,1[$, we have $U_{h}^{(\alpha)} \xrightarrow{P}+\infty$, so the test is consistent. If $\left|U_{h}^{(\alpha)}\right|>1.96$, then we reject $\left(\mathrm{H}_{0}\right) \alpha<1$ at the $95 \%$ confidence level.

Remark. To apply this test, we first need to decide whether $\alpha<1$, using the previously described test.

## 5. Numerical experiments

### 5.1. Testing the finite variation of the jump component

We simulate $n$ increments $\Delta_{i} X$ of a process $X=\sigma W+L$, where $L$ is a symmetric $\alpha$-stable Lévy process, $\sigma=0.2$. We generate 1000 independent samples containing $n$ increments each and compute $U_{h}^{(\alpha)}$ as in (15) for a range of values of $v, h(1$ minute, 5 minutes, 1 hour, 1 day) and number of observations $n$. Table 1 reports the percentage ( $p c t$ ) of outcomes where $\left|U_{h(j)}^{(\alpha)}\right|>1.96, j=1, \ldots, 1000$, for threshold exponent $\beta=0.999$. Note that with $n=1000$ and $h$ equal to five minutes $(h=1 /(252 \times 84))$, we have $T<1$ year;

for $\alpha=0.6$, the lower bound for $\beta$ is $\frac{1}{2-\alpha}=0.71$; when $n=1000, h=1 /(84 \times 252)$ and the BG index of $L$ is 0.6 (resp., 1.6), the ratio of $v=10^{-4}$ to the standard deviation of the increments $\Delta_{i} X$ is 0.074 (resp., 0.022 ).

The test results are observed to be reliable if we use $n=10000$ observations, a time resolution of five minutes and $v=10^{-4}$. In fact, when the data-generating process has BG index 0.6 , the test leads us to accept the hypothesis $\left(\mathrm{H}_{0}\right) \alpha<1$ in about 94 cases out of 100 . On the contrary, when the process has BG index 1.6 , the test tells us to reject $\left(\mathrm{H}_{0}\right)$ in 92 cases out of 100 .

### 5.2. Test for the presence of a Brownian component

We simulate 1000 independent paths of a process $X_{t}=\int_{0}^{t} \sigma_{u} \mathrm{~d} W_{u}+L$, for different Lévy processes $L$ and constant or stochastic $\sigma$, on a time grid with $n$ steps. We take threshold $r_{h}=h^{0.999}$. For each trial $j=1, \ldots, 1000$, we compute $U_{h(j)}$ given in (14) and report the percentage (pct) of cases where $\left|U_{h(j)}\right|>1.96$.

Example 5.1 (Brownian motion plus compound Poisson process, BG index $\boldsymbol{\alpha}=\mathbf{0}$ ). We consider here constant $\sigma$ and $L=\sum_{i=1}^{N_{t}} B_{i}$, a compound Poisson process with i.i.d. $N\left(0,0.6^{2}\right)$ sizes of jump and jump intensity $\lambda=5$ (as in [1]). Table 2 illustrates the performance of our test for various time steps $h$, numbers of observations $n$ and noise levels $v$ : Note that when $\sigma=0$ (resp., 0.2 ), $n=1000$ and $h=1 /(84 \times 252)$ the ratio of $v=10^{-4}$ to the standard deviation of the returns $\Delta_{i} X$ equals 0.007 (resp., 0.052 ).

We find that the test is reliable for values $n=1000, h=5$ minutes and $v=10^{-4}$ since it correctly accepts $\left(\mathrm{H}_{0}\right)$ in 95 cases out of 100 and rejects $\left(\mathrm{H}_{0}\right)$ in all cases when it is false.

Example 5.2 (Brownian motion plus $\alpha$-stable jumps: $\alpha \in] 0,2[$ ). Here, $L$ is a symmetric $\alpha$-stable Lévy process and $\sigma$ is constant. The results in Table 3 confirm the sat-

isfactory performance of the test when $\alpha=0.3<1$ for $n=1000, h=5$ minutes and $v=10^{-4}$.

Table 4, for the case $\alpha=1.2>1$, confirms that we cannot rely on the test results in this case: even when $\sigma \equiv 0$, the statistic $U_{h}$ diverges if $\alpha \geq 1$.

The main point here is that we may use a model-free choice of threshold.

Example 5.3 (Stochastic volatility plus variance gamma jumps: $\alpha=0$ ). Let us now consider a model $X$ with stochastic volatility $\sigma_{t}$, correlated with the Brownian motion driving $X$ and with jumps given by an independent variance gamma process:

$W^{(\ell)}$ are standard Brownian motions, $\ell=1,2,3$, and $L_{t}=c G_{t}+\eta W_{G_{t}}^{(3)}$ is an independent variance gamma process, a pure-jump Lévy process with BG index $\alpha=0$ [18]; $G$ is a gamma subordinator independent of $W^{(3)}$ with $G_{h} \sim \Gamma(h / b, b)$. For $\sigma$, we choose $K_{0}=$ $\ln (0.3), k=0.09, \bar{K}=\ln (0.25), \varsigma=0.05$ to ensure that $\sigma$ fluctuates in the range $0.2-$ 0.4. As for the jump part of $X$, we use $\operatorname{Var}\left(G_{1}\right)=b=0.23, \eta=0.2, c=-0.2$, estimated from the S\&P 500 index in [18]. The remaining parameters are $\rho=-0.7$ and $\mu=0$. The following results in Table 5 confirm the reliability of the test for the presence of a Brownian component with $n=1000, h=5$ minutes and $v=10^{-4}$.

Remark. In [21], a variable threshold function is used to estimate the volatility, in order to account for heteroscedasticity and volatility clustering, with results very similar to the ones obtained with a constant threshold. This is justified by the fact that in most applications, values of $\sigma$ are within the range $[0.1,0.8]$, thus the order of magnitude of $\Lambda$ in (7) is o 1 .

## 6. Applications to financial time series

We apply our tests to explore the fine structure of price fluctuations in two financial time series. We consider the DM/USD exchange rate from October 1st, 1991 to November 29th, 1994 and the SPX futures prices from January 3rd, 1994 to December 18th, 1997. From high-frequency time series, we build five-minute log-returns (excluding, in the case of SPX futures, overnight log-returns). This sampling frequency avoids many microstructure effects seen at shorter time scales (e.g., seconds), while leaving us with a relatively large sample.

### 6.1. Deutsche Mark/USD exchange rate

The DM/USD exchange rate time series was compiled by Olsen \& Associates. We consider the series of 64284 equally spaced five-minute log-returns, with $h=\frac{1}{252 \times 84} \approx 4.7 \times 10^{-5}$, displayed in Figure 1.

Barndorff-Nielsen and Shephard [6] provide evidence for the presence of jumps in this series using nonparametric methods. Using as threshold $r_{h}=h^{0.999}$, we apply the test of Section 5.1 to the degree of activity of the jump component. As in the simulation study, we divide the data into 64 non-overlapping batches of $n=1000$ observations each and compute, for each batch, the statistic $U_{h(j)}^{(\alpha)}, j=1, \ldots, 64$, with $v=10^{-4}$. Only $4.7 \%$ of the values observed are outside the interval $[-1.96,1.96]$, hence we cannot reject the assumption $\left(\mathrm{H}_{0}\right) \alpha<1$. Given this result, we can now use the test in Section 5.2 for the presence of a Brownian component in the price process. Computation of the statistic $U_{h}$ shows values much larger than 1.96 for all batches: we reject $\left(\mathrm{H}_{0}\right) \sigma \equiv 0$. These results indicate, for instance, that a variance gamma model, with no Brownian component, would be inadequate for the DM/USD time series.

### 6.2. S\&P 500 index

We consider a series of 78497 non-overlapping five-minute log-returns, as displayed in Figure 2. Using as threshold $r_{h}=h^{0.999}$, we decompose the series into periods displaying jumps and other periods, as displayed in Figure 2 (central and right panels).

We divide the data into 78 non-overlapping batches of $n=1000$ observations each and compute, for each batch, the statistic $U_{h(j)}^{(\alpha)}, j=1, \ldots, 64$, with $v=10^{-4} .5 .1 \%$ of the values observed are outside the interval $[-1.96,1.96]$ : for this period, we cannot reject the assumption $\left(\mathrm{H}_{0}\right) \alpha<1$. Given this result, we can use the test for the presence of a Brownian component in the price process. Computation of the statistic $U_{h}$ shows values

much larger than 1.96 for all batches: we reject $\left(\mathrm{H}_{0}\right) \sigma \equiv 0$. The test thus indicates the presence of a Brownian martingale component.

We note that our findings contradict the conclusion of Carr et al. [8] who model the (log-) SPX index from 1994 to 1998 as a tempered stable Lévy process plus a Brownian motion and propose a pure-jump model using a parametric estimation method. Under less restrictive assumptions on the structure of the process and using our nonparametric test, we find evidence for a non-zero Brownian component in the index.

## Appendix: Technical results and proofs

where the term $R_{h}$ has variance $\sim c r_{h}^{\alpha / 2} \rightarrow 0$ and so converges to zero in probability. Since $\frac{r_{h}^{1-\alpha / 2}}{\sqrt{h}} \rightarrow 0$, we arrive at

(b) If $\alpha>1$, define $R_{t}:=\sum_{s \leq t} I_{\left\{\left|\Delta M_{s}\right|>\sqrt{h}\right\}}$. Then, by (37), the last term (times $\sqrt{2 I Q}$ ) in (46) dominates

= & \frac{1}{\sqrt{h}}\left[\sum_{i}\left(\Delta_{i} M\right)^{2} I_{\left\{\Delta_{i} R=0\right\}}+\sum_{i}\left(\Delta_{i} M\right)^{2}\left[I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h} / 16\right\}}-I_{\left\{\Delta_{i} R=0\right\}}\right]\right]-\mathrm{o}_{P}\left(h^{1 / 2-\alpha / 2}\right) \\
\geq & -\mathrm{o}_{P}\left(h^{1 / 2-\alpha / 2}\right)+\frac{\sum_{i}\left(\int_{t_{i-1}}^{t_{i}} \int_{|x| \leq \sqrt{h}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t)-h \int_{\sqrt{h}<|x| \leq 1} x \nu(\mathrm{~d} x)\right)^{2}}{\sqrt{h}}  \tag{48}\\
& -\frac{\sum_{i}\left(\Delta_{i} M\right)^{2} I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\}}}{\sqrt{h}}
\end{align*}
$$

First,

$$
\begin{aligned}
& \sum_{i}\left(\Delta_{i} M\right)^{2} I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\}} \\
& \quad=\sum_{i}\left[\Delta_{i}[M]+2 \int_{t_{i-1}}^{t_{i}}\left(M_{s_{-}}-M_{t_{i-1}}\right) \mathrm{d} M_{s}\right] I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\}}
\end{aligned}
$$

As in Lemma 3.1, the sum of the right-hand terms within brackets is of order $u_{n}=$ $(n / \log n)^{1 / \alpha}$ so that

\frac{\sum_{i}\left|\int_{t_{i-1}}^{t_{i}}\left(M_{s_{-}-}-M_{t_{i-1}}\right) \mathrm{d} M_{s}\right|}{\sqrt{h}}=\frac{u_{n} \sum_{i}\left|\int_{t_{i-1}}^{t_{i}}\left(M_{s_{-}}-M_{t_{i-1}}\right) \mathrm{d} M_{s}\right|}{u_{n} \sqrt{h}} \xrightarrow[\rightarrow]{P} 0
$$

since $u_{n} \sqrt{h}=\left(\frac{n^{(1-\alpha / 2)}}{\log n}\right)^{1 / \alpha} \rightarrow+\infty$. Theorem 3.4 applied with $u=1 / 2$ yields that with $\varepsilon=h^{1 / 2}$,

\sum_{i}\left(\int_{t_{i-1}}^{t_{i}} \int_{|x| \leq \sqrt{h}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t)-h \int_{\sqrt{h}<|x| \leq 1} x \nu(\mathrm{~d} x)\right)^{2}=\varepsilon^{2-\alpha / 2} Y_{h}+T c \varepsilon^{2-\alpha}+T_{c h} \varepsilon^{2-2 \alpha}
$$

where $\operatorname{var}\left(Y_{h}\right) \rightarrow 1$. Therefore, in (48), we remain with

$$
h^{1 / 2-\alpha / 2}\left[-\mathrm{o}_{P}(1)+h^{\alpha / 4} Y+T c+T c h^{1-\alpha / 2}-\frac{\sum_{i} \Delta_{i}[M] I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\}}}{h^{1-\alpha / 2}}\right] \xrightarrow{\text { a.s. }}+\infty,
$$

where the divergence is due to the fact that $h^{1 / 2-\alpha / 2} \rightarrow+\infty$ while $\frac{\sum_{i} \Delta_{i}[M] I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\}}}{h^{1-\alpha / 2}}$ tends to zero in probability since its expected value is dominated by

\begin{aligned}
& \frac{n}{h^{1-\alpha / 2}} E^{1 / 2}\left[\left(\Delta_{i}[M] I_{\left\{\Delta_{i} R=0\right\}}\right)^{2}\right] P^{1 / 2}\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} R=0\right\} \\
& \quad \leq \frac{n}{h^{1-\alpha / 2}}\left(h \int_{|x| \leq \sqrt{h}} x^{4} \nu(\mathrm{~d} x)\right)^{1 / 2} h^{(2-\alpha / 2-\beta) 1 / 2}=h^{(1-\beta) / 2} \rightarrow 0
\end{aligned}
$$

having used the fact that

$$
P\left\{\left(\Delta_{i} M\right)^{2}>r_{h}, \Delta_{i} R=0\right\}=P\left\{\left(\Delta_{i} M\right)^{2} I_{\left\{\Delta_{i} R=0\right\}}>r_{h}\right\} \leq \frac{E\left[\left(\Delta_{i} M\right)^{2} I_{\left\{\Delta_{i} R=0\right\}}\right]}{r_{h}}
$$

$$
\begin{equation*}
=\frac{h \int_{|x| \leq \sqrt{h}} x^{2} \nu(\mathrm{~d} x)}{r_{h}}=h^{2-\alpha / 2-\beta} . \tag{49}
\end{equation*}
$$

On the other hand, the first term in (46) is negligible with respect to $h^{1 / 2-\alpha / 2}$ (the speed of divergence of $\left.\left(\sum_{i=1}^{n}\left(\Delta_{i} M\right)^{2} I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h} / 16\right\}}-\mathrm{o}_{P}\left(h^{1-\alpha / 2}\right)\right) / \sqrt{h}\right)$ because
$\frac{\sum_{i=1}^{n}\left(\int_{t_{i-1}}^{t_{i}} \sigma_{u} \mathrm{~d} W_{u}\right)^{2} I_{\left\{\left(\Delta_{i} X\right)^{2}>r_{h},\left(\Delta_{i} X_{1}\right)^{2} \leq 4 r_{h}\right\}}}{\sqrt{h} h^{1 / 2-\alpha / 2}} \leq \frac{h \log (1 / h) h^{-\alpha \beta / 2}}{h^{1-\alpha / 2}}=h^{(\alpha / 2)(1-\beta)} \log \frac{1}{h} \rightarrow 0$.
Therefore, (46) explodes to $+\infty$. Finally, if $\alpha=1$ in (46), then the first term is negligible, as

\frac{\sum_{i=1}^{n}\left(\int_{t_{i-1}}^{t_{i}} \sigma_{u} \mathrm{~d} W_{u}\right)^{2} I_{\left\{\left(\Delta_{i} X\right)^{2}>r_{h},\left(\Delta_{i} X_{1}\right)^{2} \leq 4 r_{h}\right\}}}{\sqrt{h}}=\mathrm{O}_{p}\left(h^{(1-\beta) / 2} \log \frac{1}{h}\right) \rightarrow 0
$$

For the second term, we take a $\delta>0$ such that $2 / 3<\beta+\delta<1$, we choose $\varepsilon=h^{(\beta+\delta) / 2}$ and we use the same steps as were used to reach (48) for $\alpha>1$, but we consider $\tilde{R}_{t}=$ $\sum_{s \leq t} I_{\left\{\left|\Delta M_{s}\right|>\varepsilon\right\}}$ in place of $R_{t}$. Also using Theorem 3.4, we obtain that the second term in (46) dominates

$$
\begin{aligned}
& \frac{Y_{h} \varepsilon^{3 / 2}}{\sqrt{2 h I Q}}+\frac{\varepsilon}{\sqrt{2 h I Q}}-\frac{\sum \Delta_{i}[M] I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} \tilde{R}=0\right\}}}{\sqrt{2 h I Q}} \\
& -\frac{2 \sum_{i=1}^{n} \int_{t_{i-1}}^{t_{i}}\left(M_{s_{-}}-M_{t_{i-1}}\right) \mathrm{d} M_{s} I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} \tilde{R}=0\right\}}}{\sqrt{2 h I Q}}
\end{aligned}
$$

where the variance of $Y_{h}$ tends to 1 so that $Y_{h} \varepsilon^{3 / 2} / \sqrt{h}$ tends to zero in probability. The second term tends to $+\infty$ at rate $\varepsilon / \sqrt{h}$. The third term is negligible with respect to $\varepsilon / \sqrt{h}$ : applying (49) with $\tilde{R}$ in place of $R$ and the Cauchy-Schwarz inequality, we get

E\left[\frac{1}{\varepsilon} \sum \int_{t_{i-1}}^{t_{i}} \int_{|x| \leq 1} x^{2} \mu(\mathrm{~d} x, \mathrm{~d} t) I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h} / 16, \Delta_{i} \tilde{R}=0\right\}}\right]=\mathrm{O}\left(h^{\delta / 2}\right) \rightarrow 0
$$

Finally, the last term is also negligible since the speed of convergence to zero of the numerator is $u_{n}=n / \log ^{2} n$ (as in the proof of Lemma 3.1) and $u_{n} \sqrt{h} \rightarrow+\infty$. So, even for $\alpha=1$, the normalized bias $\left(I \hat{V}_{h}-I V\right) / \sqrt{2 h \hat{I Q_{h}}}$ diverges to $+\infty$.

Proof of Proposition 4.1. As in Lemma A. 2 with $\sqrt{r_{h}}$ in place of $r_{h}$ as bound for $\max _{i=1, \ldots, n}\left|a_{n i}\right|$, using the fact that $\alpha<1$ and applying Lemma 3.1(i), we deduce that $\hat{H}_{h}$ has the same limit in probability as

$$
X_{T}-\sum_{i=1}^{n}\left(\Delta_{i} X_{0}+\Delta_{i} M\right) I_{\left\{\Delta_{i} N=0,\left(\Delta_{i} M\right)^{2} \leq r_{h}\right\}}
$$

when $h \rightarrow 0$. Moreover, since a.s. $N_{T}<\infty$ and $\left.\sum_{i=1}^{n} \Delta_{i} X_{0} I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h}\right\}}\right)=\mathrm{O}_{P}\left(h^{(1-\alpha \beta) / 2} \times\right.$ $\sqrt{\log (1 / h)}) \rightarrow 0$, taking $\tilde{R}_{t}=\sum_{s \leq t} I_{\left\{\left|\Delta M_{s}\right|>\sqrt{r_{h}}\right\}}$, the above term has limit in probability equal to

$$
\begin{aligned}
& X_{T}-\lim _{h} \sum_{i=1}^{n}\left(\Delta_{i} X_{0}+\Delta_{i} M I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h}\right\}}\right) \\
& =X_{T}-X_{0 T}-\lim _{h}\left[\sum_{i=1}^{n} \int_{t_{i-1}}^{t_{i}} \int_{|x| \leq \sqrt{r_{h}}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t)-T \int_{\sqrt{r_{h}}<|x| \leq 1} x \nu(\mathrm{~d} x)\right] \\
& \quad-\lim _{h} \sum_{i} \Delta_{i} M\left(I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h}\right\}}-I_{\left\{\Delta_{i} \tilde{R}=0\right\}}\right) .
\end{aligned}
$$

Using the fact that $P\left\{\Delta_{i} \tilde{R} \geq 1\right\}=\mathrm{O}\left(h^{1-\alpha \beta / 2}\right)$, as was used after (25), we deduce that $\sum_{i} \Delta_{i} M I_{\left\{\left(\Delta_{i} M\right)^{2} \leq r_{h}, \Delta_{i} \tilde{R} \geq 1\right\}}=\mathrm{O}_{P}\left(h^{(1-\alpha) \beta / 2}\right) \rightarrow 0$. Using the Hölder inequality with exponents $p=q=2$, we have $\sum_{i} \Delta_{i} M I_{\left\{\left(\Delta_{i} M\right)^{2}>r_{h}, \Delta_{i} \tilde{R}=0\right\}}=\mathrm{O}_{P}\left(r_{h}^{(1-\alpha) \beta / 2}\right) \rightarrow 0$. Finally, $\int_{0}^{T} \int_{|x| \leq \sqrt{r_{h}}} x \tilde{\mu}(\mathrm{~d} x, \mathrm{~d} t) \xrightarrow{L^{2}} 0$ and $\int_{\sqrt{r_{h}}<|x| \leq 1} x \nu(\mathrm{~d} x) \rightarrow m$ so that $\hat{H}_{h, T} \xrightarrow{P} J_{T}+m T$.
