# On the Liouville type theorem for stationary compressible Navier-Stokes-Poisson equations in $\mathbb{R}^{N}$

#### Abstract

In this paper we prove Liouville type result for the stationary solutions to the compressible Navier-Stokes-Poisson equations(NSP) and the compressible Navier-Stokes equations(NS) in $\mathbb{R}^{N}, N \geq 2$. Assuming suitable integrability and the uniform boundedness conditions for the solutions we are led to the conclusion that $v=0$. In the case of (NS) we deduce that the similar integrability conditions imply $v=0$ and $\rho=$ constant on $\mathbb{R}^{N}$. This shows that if we impose the the nonvacuum boundary condition at spatial infinity for (NS), $v \rightarrow 0$ and $\rho \rightarrow \rho_{\infty}>0$, then $v=0, \rho=\rho_{\infty}$ are the solutions.

## 1 Introduction

We are concerned on the stationary Navier-Stokes-Poisson equations in $\mathbb{R}^{N}$, $N \geq 2$.

$$
\begin{align*}
& \operatorname{div}(\rho v)=0  \tag{1.1}\\
& \operatorname{div}(\rho v \otimes v)=-\nabla p+k \rho \nabla \Phi+\mu \Delta v+(\mu+\lambda) \nabla \operatorname{div} v  \tag{1.2}\\
& \Delta \Phi=\rho-\rho_{0}  \tag{1.3}\\
& p=a \rho^{\gamma}, \gamma>1 \tag{1.4}
\end{align*}
$$

The system (NSP) describes compressible gas flows, and $\rho, v, \Phi$ and $p$ denote the density, velocity, the potential of the underlying force and the pressure respectively. The constant $\rho_{0} \geq 0$ is called the background state. The viscosity constants $\lambda, \mu$ satisfy $\mu>0, \lambda+\mu>0$. Here $k$ is also a physical constant, which signifies the property of the forcing, repulsive if $k>0$ and attractive if $k<0$. In particular, in the case $k=0$ ( and without (1.3)) the system reduces to the following stationary compressible Navier-Stokes equations(NS).

$$
\begin{align*}
& \operatorname{div}(\rho v)=0  \tag{1.5}\\
& \operatorname{div}(\rho v \otimes v)=-\nabla p+\mu \Delta v+(\mu+\lambda) \nabla \operatorname{div} v  \tag{1.6}\\
& p=a \rho^{\gamma}, \gamma>1 \tag{1.7}
\end{align*}
$$

For the general treatment of the system (NSP) and (NS), including the Cauchy problem of the time dependent equations we refer e.g. [2, 4, 5, 6]. Here we prove a Liouville type theorem of the stationary systems (NSP) and (NS) as follows.

Theorem 1.1 Let $N \geq 2$.
(i) (Navier-Stokes Poisson equations): Suppose $(\rho, v, \Phi)$ is a smooth solution to (NSP) with $k \neq 0$, satisfying

$$
\begin{equation*}
\|\rho\|_{L^{\infty}}+\|\Phi\|_{L^{\infty}}+\|\nabla v\|_{L^{2}}+\|v\|_{L^{\frac{N}{N-T}}}<\infty \tag{1.8}
\end{equation*}
$$

and the additional condition

$$
\begin{equation*}
v \in L^{\frac{3 N}{N-1}}\left(\mathbb{R}^{N}\right) \tag{1.9}
\end{equation*}
$$

if $N \geq 7$. Then, $v=0$ on $\mathbb{R}^{N}$. The functions $\Phi$ and $\rho$ are determined by solving the system:

$$
\left\{\begin{array}{l}
\rho \nabla \Phi=\frac{a}{k} \nabla \rho^{\gamma}  \tag{1.10}\\
\Delta \Phi=\rho-\rho_{0}
\end{array}\right.
$$

(ii) (Navier-Stokes equations): Suppose $(\rho, v)$ is a smooth solution to $(N S)$ satisfying

$$
\begin{equation*}
\|\rho\|_{L^{\infty}}+\|\nabla v\|_{L^{2}}+\|v\|_{L^{\frac{N}{N-1}}}<\infty \tag{1.11}
\end{equation*}
$$

and the additional condition (1.9) if $N \geq 7$. Then, $v=0$ and $\rho=$ constant on $\mathbb{R}^{N}$.

Remark 1.1 Let us compare the above theorem with the previous result in [1], which says that a solution to (NS) satisfying

$$
\begin{equation*}
\|\sqrt{\rho} v\|_{L^{2}}+\|v\|_{L^{\frac{N}{N-1}}}+\left\|\rho^{\gamma}\right\|_{L^{1}}<\infty \tag{1.12}
\end{equation*}
$$

is vacuum, $\rho=0$. The main difference between (1.12) and (1.11) is that in (1.12) we are assuming the spatial infinity is vacuum,

$$
\begin{equation*}
\rho(x) \rightarrow 0 \quad \text { as } \quad|x| \rightarrow \infty, \tag{1.13}
\end{equation*}
$$

while in (1.11) it is allowed to have

$$
\begin{equation*}
\rho(x) \rightarrow \rho_{\infty} \quad \text { as } \quad|x| \rightarrow \infty \tag{1.14}
\end{equation*}
$$

for a constant $\rho_{\infty}>0$. Even with such non-vacuum condition at infinity the Liouville type result holds. In particular for the 2D stationary Navier-Stokes equations if $v \in H^{1}\left(\mathbb{R}^{2}\right)$ and $\rho$ satisfies (1.14), then $v=0$ and $\rho=\rho_{\infty}$ on $\mathbb{R}^{2}$.

## 2 Proof of Theorem 1.1

Proof of Theorem 1.1 Let us consider a radial cut-off function $\sigma \in$ $C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ such that

$$
\sigma(|x|)= \begin{cases}1 & \text { if }|x|<1  \tag{2.1}\\ 0 & \text { if }|x|>2\end{cases}
$$

and $0 \leq \sigma(x) \leq 1$ for $1<|x|<2$. Then, for each $R>0$, we define

$$
\begin{equation*}
\sigma\left(\frac{|x|}{R}\right):=\sigma_{R}(|x|) \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right) \tag{2.2}
\end{equation*}
$$

We multiply (1.2) by $v \sigma_{R}(x)$, and integrate over $\mathbb{R}^{N}$, and integrate by part to obtain,

$$
\begin{align*}
& \mu \int_{\mathbb{R}^{N}}|\nabla v|^{2} \sigma_{R} d x+(\mu+\lambda) \int_{\mathbb{R}^{N}}(\operatorname{div} v)^{2} \sigma_{R} d x \\
& \quad=-\mu \int_{\mathbb{R}^{N}} v \cdot\left(\nabla \sigma_{R} \cdot \nabla\right) v d x-(\mu+\lambda) \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \operatorname{div} v(v \cdot \nabla) \sigma_{R} d x \\
& \quad+k \int_{\mathbb{R}^{N}} \sigma_{R} \rho(v \cdot \nabla) \Phi d x-\int_{\mathbb{R}^{N}} \sigma_{R}(v \cdot \nabla) p d x-\int_{\mathbb{R}^{N}} \sigma_{R} v \cdot \operatorname{div}(\rho v \otimes v) d x \\
& :=I_{1}+\cdots+I_{5} . \tag{2.3}
\end{align*}
$$

Let us estimate $I_{1}, \cdots, I_{5}$ term by term.

$$
\begin{align*}
\left|I_{1}\right| & \leq \frac{\mu}{R} \int_{\{R \leq|x| \leq 2 R\}}|\nabla \sigma\|v\| \nabla v| d x \\
& \leq \frac{\mu\|\nabla \sigma\|_{L^{\infty}}}{R}\left(\int_{\{R \leq|x| \leq 2 R\}} d x\right)^{\frac{1}{N}}\|v\|_{L^{\frac{2 N}{N-2}}(R \leq|x| \leq 2 R)}\|\nabla v\|_{L^{2}(R \leq|x| \leq 2 R)} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|\nabla v\|_{L^{2}}\|\nabla v\|_{L^{2}(R \leq|x| \leq 2 R)} \rightarrow 0 \tag{2.4}
\end{align*}
$$

as $R \rightarrow \infty$, where we used the Sobolev inequality, $\|v\|_{L^{2 N} N} \leq C\|\nabla v\|_{L^{2}}$. Estimate of $I_{2}$ is similar to $I_{1}$ and we have

$$
\begin{align*}
\left|I_{2}\right| & \leq \frac{\mu+\lambda}{R} \int_{\{R \leq|x| \leq 2 R\}}|\nabla \sigma\|v\| \nabla v| d x \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|\nabla v\|_{L^{2}}\|\nabla v\|_{L^{2}(R \leq|x| \leq 2 R)} \rightarrow 0 \tag{2.5}
\end{align*}
$$

as $R \rightarrow \infty$. In order to estimate $I_{3}$ we first integrate by part to obtain

$$
\begin{aligned}
I_{3}= & -k \int_{\mathbb{R}^{N}} \sigma_{R} \operatorname{div}(\rho v) \Phi d x-k \int_{\mathbb{R}^{N}} \Phi \rho(v \cdot \nabla) \sigma_{R} d x \\
= & -k \int_{\mathbb{R}^{N}} \Phi \rho(v \cdot \nabla) \sigma_{R} d x
\end{aligned}
$$

where we used (1.1). Therefore,

$$
\begin{align*}
\left|I_{3}\right| & \leq \frac{k}{R}\|\nabla \sigma\|_{L^{\infty}}\|\Phi\|_{L^{\infty}}\|\rho\|_{L^{\infty}} \int_{\{R \leq|x| \leq 2 R\}}|v| d x \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|\Phi\|_{L^{\infty}}\|\rho\|_{L^{\infty}}\|v\|_{L^{\frac{N}{N-1}}(R \leq|x| \leq 2 R)} \rightarrow 0 \tag{2.6}
\end{align*}
$$

as $R \rightarrow \infty$. In order to estimate $I_{4}$ we write the pressure term in the following form:

$$
\nabla p=a \nabla \rho^{\gamma}=\frac{a \gamma}{\gamma-1} \rho \nabla \rho^{\gamma-1}
$$

Then, we have

$$
\begin{aligned}
I_{4} & =-\frac{a \gamma}{\gamma-1} \int_{\mathbb{R}^{N}} \sigma_{R} \rho v \cdot \nabla \rho^{\gamma-1} d x \\
& =\frac{a \gamma}{\gamma-1} \int_{\mathbb{R}^{N}} \sigma_{R} \operatorname{div}(\rho v) \rho^{\gamma-1} d x+\frac{a \gamma}{\gamma-1} \int_{\mathbb{R}^{N}} \rho^{\gamma}(v \cdot \nabla) \sigma_{R} d x \\
& =\frac{a \gamma}{\gamma-1} \int_{\mathbb{R}^{N}} \rho^{\gamma}(v \cdot \nabla) \sigma_{R} d x
\end{aligned}
$$

thanks to (1.1). Thus, we estimate

$$
\begin{align*}
\left|I_{4}\right| & \leq \frac{a \gamma}{(\gamma-1) R}\|\rho\|_{L^{\infty}}^{\gamma} \int_{\{R \leq|x| \leq 2 R\}}|v \| \nabla \sigma| d x \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|\rho\|_{L^{\infty}}^{\gamma}\|v\|_{L^{N}{ }^{N-1}(R \leq|x| \leq 2 R)} \rightarrow 0 \tag{2.7}
\end{align*}
$$

as $R \rightarrow \infty$. For the term $I_{5}$ we first compute by integration by part

$$
\begin{aligned}
I_{5} & =\int_{\mathbb{R}^{N}} \sigma_{R}|v|^{2} \operatorname{div}(\rho v) d x+\frac{1}{2} \sum_{i, j=1}^{N} \int_{\mathbb{R}^{N}} \sigma_{R} \rho(v \cdot \nabla)|v|^{2} d x \\
& =-\frac{1}{2} \int_{\mathbb{R}^{N}} \sigma_{R} \operatorname{div}(\rho v)|v|^{2} d x-\frac{1}{2} \int_{\mathbb{R}^{N}}|v|^{2}(v \cdot \nabla) \sigma_{R} d x \\
& =-\frac{1}{2} \int_{\mathbb{R}^{N}}|v|^{2}(v \cdot \nabla) \sigma_{R} d x
\end{aligned}
$$

Therefore, we estimate

$$
\begin{equation*}
\left|I_{5}\right| \leq \frac{1}{2 R} \int_{\{R \leq|x| \leq 2 R\}}|v|^{3}|\nabla \sigma| d x \tag{2.8}
\end{equation*}
$$

We estimate the right hand side of (2.8), depending on $N$.
(i) For $N=2$ we use the following Ladyzenskaya's inequality( 3 ),

$$
\|v\|_{L^{4}} \leq 2\|v\|_{L^{2}}^{\frac{1}{2}}\|\nabla v\|_{L^{2}}^{\frac{1}{2}}
$$

to estimate

$$
\begin{align*}
\left|I_{5}\right| & \leq \frac{\|\nabla \sigma\|_{L^{\infty}}}{2 R}\left(\int_{\mathbb{R}^{2}}|v|^{4} d x\right)^{\frac{3}{4}}\left(\int_{\{R \leq|x| \leq 2 R\}} d x\right)^{\frac{1}{4}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|v\|_{L^{4}}^{3} R^{-\frac{1}{2}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|v\|_{L^{2}}^{\frac{3}{2}}\|\nabla v\|_{L^{2}}^{\frac{3}{2}} R^{-\frac{1}{2}} \rightarrow 0 \tag{2.9}
\end{align*}
$$

as $R \rightarrow \infty$.
(ii) For $N=3$ we use the $L^{p}$-interpolation followed by the Sobolev inequality

$$
\begin{align*}
\left|I_{5}\right| & \leq \frac{\|\nabla \sigma\|_{L^{\infty}}}{2 R}\left(\int_{\{R \leq|x| \leq 2 R\}}|v|^{\frac{9}{2}} d x\right)^{\frac{2}{3}}\left(\int_{\{R \leq|x| \leq 2 R\}} d x\right)^{\frac{1}{3}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|v\|_{L^{\frac{9}{2}}(R \leq|x| \leq 2 R)}^{3} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|v\|_{L^{\frac{3}{2}}(R \leq|x| \leq 2 R)}^{\frac{1}{3}}\|v\|_{L^{6}}^{\frac{8}{3}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}}\|v\|_{L^{\frac{3}{2}}(R \leq|x| \leq 2 R)}^{\frac{1}{3}}\|\nabla v\|_{L^{2}}^{\frac{8}{3}} \rightarrow 0 \tag{2.10}
\end{align*}
$$

as $R \rightarrow \infty$.
(iii) For $4 \leq N \leq 6$ we estimate

$$
\begin{align*}
\left|I_{5}\right| & \leq \frac{\|\nabla \sigma\|_{L^{\infty}}}{2 R}\left(\int_{\{R \leq|x| \leq 2 R\}}|v|^{\frac{2 N}{N-2}} d x\right)^{\frac{3(N-2)}{2 N}}\left(\int_{\{R \leq|x| \leq 2 R\}} 1 d x\right)^{\frac{6-N}{2 N}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}\|v\|_{L^{\frac{2 N}{N-2}}}^{3}(R \leq|x| \leq 2 R)} R^{2-\frac{N}{2}} \rightarrow 0 \tag{2.11}
\end{align*}
$$

as $R \rightarrow \infty$, since $\|v\|_{L^{2 N}} \leq C\|\nabla v\|_{L^{2}}<\infty$.
(iv) For $N \geq 7$ we use the additional hypothesis $v \in L^{\frac{3 N}{N-1}}\left(\mathbb{R}^{N}\right)$.

$$
\begin{align*}
\left|I_{5}\right| & \leq \frac{\|\nabla \sigma\|_{L^{\infty}}}{2 R}\left(\int_{\{R \leq|x| \leq 2 R\}}|v|^{\frac{3 N}{N-1}} d x\right)^{\frac{N-1}{N}}\left(\int_{\{R \leq|x| \leq 2 R\}} 1 d x\right)^{\frac{1}{N}} \\
& \leq C\|\nabla \sigma\|_{L^{\infty}\|v\|_{L^{\frac{3 N}{N-1}}(R \leq|x| \leq 2 R)}^{3} \rightarrow 0} \rightarrow 2.12 \tag{2.12}
\end{align*}
$$

as $R \rightarrow \infty$.
Thus passing $R \rightarrow \infty$ in (2.3), we find from (2.4)-(2.12) that

$$
\mu \int_{\mathbb{R}^{N}}|\nabla v|^{2} d x+(\mu+\lambda) \int_{\mathbb{R}^{N}}(\operatorname{div} v)^{2} d x=0
$$

and $v=$ constant vector in $\mathbb{R}^{N}$, which combined with the integrability conditions provides us with $v=0$. Thus the equation (1.2) is reduced to the first part of (1.10). In the case of (ii) the reduced equation is $\nabla p=0$, which implies that $\rho=$ constant.
