# Study of $\bar{B} \rightarrow \Lambda \bar{p} \rho(\phi)$ and $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$

#### Abstract

We examine the three-body baryonic $\bar{B} \rightarrow \mathbf{B B}^{\prime} V$ decays with $V$ vector mesons in the standard model. We can simultaneously explain the recent experimental data on the decays of $B^{-} \rightarrow \Lambda \bar{p} \rho^{0}$ and $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$ based on the QCD counting rules and $S U(3)$ flavor symmetry. We also predict that the decay branching ratios of $\bar{B}^{0} \rightarrow \Lambda \bar{p} \rho^{+}$and $B^{-} \rightarrow \Lambda \bar{p} \phi$ are 3.0 and $1.5 \times 10^{-6}$, respectively, which are promising to be observed by BELLE and BABAR at the $B$ factories.


## I. INTRODUCTION

Large decay branching ratios as well as angular distribution asymmetries have been measured in the charmless three-body baryonic $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime} M$ decays, where $M$ can be either pesudo-scalar $(P)$ or vector $(V)$ mesons [1-8]. In particular, the threshold effect of the sharp peak around the threshold area in the dibaryon invariant mass spectrum has been observed as a common feature in these baryonic decays [1 8] , which makes the decay branching ratios reach to the magnitude of order $10^{-6}$, accessible to the detection at the $B$ factories. Furthermore, it partly gives the answer of the non-observations of the two-body baryonic $\bar{B}$ decays [9], such as $\bar{B}^{0} \rightarrow p \bar{p}, \Lambda \bar{\Lambda}$, and $B^{-} \rightarrow \Lambda \bar{p}$ [10], since the dibaryon of the two-body decays can only be created at the $m_{\bar{B}}$ scale without an extra meson to release the energy, which is far from the enhancement of the dibaryon threshold area.

In this note, we consider the baryonic decays of $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime} V$, which have not been fully analyzed theoretically, unlike the corresponding pesudoscalar modes of $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime} P$. Currently, the decay branching ratios of the vector modes have been measured to be [4 8]

at the $B$ factories, respectively. It is interesting to note that $B^{-} \rightarrow p \bar{p} K^{*-}$ is among the first predicted baryonic modes in Ref. [11] with the predicted decay branching ratio around $2 \times 10^{-6}$. The relation of $\mathcal{B}\left(B^{-} \rightarrow p \bar{p} K^{*-}\right)>\mathcal{B}\left(\bar{B}^{0} \rightarrow p \bar{p} \bar{K}^{* 0}\right)$ can be traced to the deviation between the transition form factors of $B^{-} \rightarrow p \bar{p}$ and $\bar{B}^{0} \rightarrow p \bar{p}$ in the pQCD counting rules [12]. In addition, $C P$ violation for $B^{-} \rightarrow p \bar{p} K^{*-}$ [13, 14] is found to be nearly $20 \%$ of the world average [4, 5] even though it is still inconclusive experimentally due to the data errors. It is clear that a theoretical examination on $\bar{B} \rightarrow \mathbf{B}^{\prime} V$ is needed in order to fit the experimental data. In this paper, we shall develop a systematic study of the $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime} V$ decays to not only explain the measured data but also explore some other vector modes to
see if they are also accessible to the $B$ factories.
The paper is organized as follows. In Sec. II, we provide the formalism, in which we show the decay amplitudes of $\bar{B} \rightarrow \Lambda \bar{p} \rho, B^{-} \rightarrow \Lambda \bar{p} \phi$, and $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$. We also parameterize the matrix elements and define the timelike and $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime}$ transition form factors. The numerical results are performed in Sec. III. In Sec. IV, we present the conclusions.

## II. FORMALISM

In terms of the effective Hamiltonian [15, 16] at quark level, the decay amplitudes of $\bar{B} \rightarrow \Lambda \bar{p} \rho$ and $B^{-} \rightarrow \Lambda \bar{p} \phi$ can be factorized as

with the Fermi constant $G_{F}$, the CKM matrix elements $V_{q_{i} q_{j}}$, and the various currents as $\left(\bar{q}_{i} q_{j}\right)_{V \pm A}=\bar{q}_{i} \gamma_{\mu}\left(1 \pm \gamma_{5}\right) q_{j}$ and $\left(\bar{q}_{i} q_{j}\right)_{S \pm P}=\bar{q}_{i}\left(1 \pm \gamma_{5}\right) q_{j}$. The subscripts of $\mathcal{C}$ and $\mathcal{T}$ in Eq. (2) denote the quark current and the $\bar{B}$ transition, respectively, responsible for the creation of a baryon pair in the final states. For $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$, its decay amplitude is separated into two parts,

with $q^{\prime}=u(d)$, corresponding to $B^{-} \rightarrow \Lambda \bar{\Lambda} K^{*-}\left(\bar{B}^{0} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{* 0}\right)$, and

In Eqs. (2)-(5), the parameters $a_{i}$ are given by $a_{i}=c_{i}^{e f f}+c_{i \pm 1}^{e f f} / N_{c}$ for $i=$ odd (even) with the color number $N_{c}=3$, where we adopt the values of the effective Wilson coefficients $c_{i}^{e f f}$ from Refs. [15, 16].

To evaluate the decay branching ratios, one requires to know the form factors and decay constants of the matrix elements in Eq. (4). In $\mathcal{A}_{\mathcal{C}}(\bar{B} \rightarrow \Lambda \bar{p} \rho)$ and $\mathcal{A}_{\mathcal{C}}\left(\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}\right)$, the form factors of the $\bar{B} \rightarrow \rho$ and $\bar{K}^{*}$ transitions are given to incorporate with the timelike baryonic form factors in the matrix elements of $0 \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime}$ with $\mathbf{B} \overline{\mathbf{B}}^{\prime}=\Lambda \bar{p}$ and $\Lambda \bar{\Lambda}$. The matrix elements of the $\bar{B} \rightarrow V$ transition are written as [17]

where $t \equiv q^{2}$ with $q=p_{\bar{B}}-p_{V}=p_{\mathbf{B}}+p_{\overline{\mathbf{B}}^{\prime}}, V_{1}$ and $A_{0,1,2}$ are the form factors, and $\varepsilon_{\mu}^{*}$ is the polarization of $V=\rho\left(K^{*}\right)$ with $q_{3}=u(s)$, respectively. For the dibaryon creations, we write

where $\mathbf{B} \overline{\mathbf{B}}^{\prime}=\Lambda \bar{p}$ with $\bar{q}_{1} q_{2}=\bar{s} u, \mathbf{B} \overline{\mathbf{B}}^{\prime}=\Lambda \bar{\Lambda}$ with $\bar{q}_{1} q_{2}=\bar{u} u, \bar{d} d$, or $\bar{s} s$, and $F_{1}, F_{2}, g_{A}, h_{A}, f_{S}$ and $g_{P}$ are the form factors. In terms of the pQCD counting rules [18-20], the momentum
dependences of the form factors $F_{1}(t)$ and $g_{A}(t)$ behave as $1 / t^{2}$, which characterizes two hard gluon exchanges between the valence quarks. Explicitly, one obtains

where $\gamma=2+4 /(3 \beta)=2.148$ with $\beta$ being the QCD $\beta$ function and $\Lambda_{0}=0.3 \mathrm{GeV}$. Under the $S U(3)$ flavor and $S U(2)$ spin symmetries, the constants $C_{F_{1}}$ and $C_{g_{A}}$ can be related by another set of constants, given by [21]

which are derived in equation of motion, all the timelike baryonic form factors can be connected. With the inputs of the values of $C_{\|}$and $C_{\Pi}$ in Eq. (9), we are able to estimate the values of the other timelike form factors by the relations in Eqs. (8)-(11). Note that $F_{2}$ is suppressed by $1 /\left(t \ln \left[t / \Lambda_{0}^{2}\right]\right)$ in comparison with $F_{1}[23,24]$ and can be safely ignored in the discussion.

For $\mathcal{A}_{\mathcal{T}}\left(B^{-} \rightarrow \Lambda \bar{p} \phi\right)$ and $\mathcal{A}_{\mathcal{T}}\left(\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}\right)$, the $0 \rightarrow V\left(V=\phi, \bar{K}^{*}\right)$ transitions can be parameterized as

with the decay constants $f_{V}$. The most general forms of the $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime}$ transitions are expressed as [25]

with $p=p_{\bar{B}}-p_{\mathbf{B}}-p_{\overline{\mathbf{B}}^{\prime}}$, and $f_{i}$ and $g_{i}$ the form factors. The momentum dependences of $f_{i}$ and $g_{i}$ are represented as [26, 27]

with $n=3$, where $D_{f_{i}}$ and $D_{g_{i}}$ are the constants to be determined by the $\bar{B} \rightarrow p \bar{p} M$ data, while the form factors of $B^{-} \rightarrow \Lambda \bar{p}, \bar{B} \rightarrow \Lambda \bar{\Lambda}$, and $\bar{B} \rightarrow p \bar{p}$ are in the same forms. We note that the number $n=3$ is set for three hard gluons as the propagators to form a baryon pair in the approach of the pQCD counting rules, where two of them attach to valence quarks in $\mathbf{B} \overline{\mathbf{B}}^{\prime}$, while the third one kicks and speeds up the spectator quark in $\bar{B}$. Again, with the $S U(3)$ flavor and $S U(2)$ spin symmetries, $D_{g_{i}}$ and $D_{f_{i}}$ from the vector currents are related by another set of constants $D_{\|}$and $D_{\Pi}$ of the chiral currents. Explicitly, we have [21, 28]

for $\langle\Lambda \bar{\Lambda}|(\bar{d} b)_{V(A)}\left|\bar{B}^{0}\right\rangle$ and $\langle\Lambda \bar{\Lambda}|(\bar{u} b)_{V(A)}\left|B^{-}\right\rangle$.

## III. NUMERICAL ANALYSIS

We now specify various input parameters for our numerical analysis. The vector decay constants in Eq. (12) are given by [29]

and the $\bar{B} \rightarrow V$ transition form factors in Eq. (6) as the functions of $t$ are written as 30]

V_{1}\left[A_{0}\right](t) & =\frac{V_{1}\left[A_{0}\right](0)}{\left(1-t / M_{1[2]}^{2}\right)\left(1-\sigma_{1} t / M_{1[2]}^{2}+\sigma_{2} t^{2} / M_{1[2]}^{4}\right)}, \\
A_{1,2}(t) & =\frac{A_{1,2}(0)}{1-\sigma_{1} t / M_{2}^{2}+\sigma_{2} t^{2} / M_{2}^{4}}, \tag{18}

where the values of $V_{1}(0), A_{0,1,2}(0), \sigma_{1,2}$ and $M_{1,2}$ are shown in Table $\square$ [30].
Based on the approach in Ref. [31], we refit the baryonic form factors with the measured branching ratios of $\bar{B}^{0} \rightarrow n \bar{p} D^{*+}, \bar{B}^{0} \rightarrow \Lambda \bar{p} \pi^{+}$and $B^{-} \rightarrow \Lambda \bar{\Lambda} K^{-}$, and obtain

Note that since $\mathcal{A}_{\mathcal{T}}\left(B^{-} \rightarrow \Lambda \bar{p} \phi\right), \mathcal{A}_{\mathcal{T}}\left(\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}\right)$, and $\mathcal{A}_{\mathcal{T}}(\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K})$ [32] are in association with the $\bar{B} \rightarrow p \bar{p} M$ decays with $M=D^{(*)}, \bar{K}^{*}$, and $\pi$, we have adopted the values of the $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime}$ transition form factors in Refs. [21, 28, 33, 34], given by

& (-187.3 \pm 26.6,-840.1 \pm 132.1,-10.1 \pm 10.8,-157.0 \pm 27.1) \mathrm{GeV}^{4} \tag{20}

The squared amplitudes by summing over baryon spins denoted as $|\overline{\mathcal{A}}|^{2}$ now become available, of which the integration over the phase space in three-body decays is required. Explicitly, by using

d \Gamma=\frac{1}{(2 \pi)^{3}} \frac{|\overline{\mathcal{A}}|^{2}}{32 M_{B}^{3}} d m_{\mathbf{B}_{\overline{\mathbf{B}}^{\prime}}^{2}}^{2} d m_{\overline{\mathbf{B}}^{\prime} V}^{2} \tag{21}
\end{equation*}

with $m_{\mathbf{B}^{\prime}}^{2}=\left(P_{\mathbf{B}}+P_{\overline{\mathbf{B}}^{\prime}}\right)^{2}$ and $m_{\overline{\mathbf{B}}^{\prime} V}^{2}=\left(P_{\overline{\mathbf{B}}^{\prime}}+P_{V}\right)^{2}$, we get the numerical results for the branching ratios, summarized in Table II.

It is worth to point out that the measured values of $\mathcal{B}\left(\bar{B}^{-} \rightarrow \Lambda \bar{p} \rho^{0}\right)$ and $\mathcal{B}\left(\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}\right)$ are not involved in the fitting. As seen from Table II, our result of $\mathcal{B}\left(B^{-} \rightarrow \Lambda \bar{p} \rho^{0}\right)=$ $3.28 \times 10^{-6}$ is now able to explain the data. This is mainly due to the relation of $g_{P}=f_{S}$ in Eq. (10) to fully take into account $g_{P}$, whereas the use of equation of motion with the chiral behavior may underestimate $g_{P}$ [22]. It is interesting to note that the decay of $\bar{B}^{0} \rightarrow \Lambda \bar{p} \pi^{+}$ is similar to its corresponding vector mode, which was measured to be ten times bigger than the previous calculation [11, 26]. The contributions of the scalar and pseudo-scalar currents are thus compatible, and the $a_{6}$ term in $\mathcal{A}_{\mathcal{C}}$ of Eq. (21) gives the main contribution due to the chiral enhancement. In fact, $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$ is also dominated by the $a_{6}$ term in $\mathcal{A}_{\mathcal{C}}$ since the contribution of $g_{2}\left(f_{2}\right) \sigma_{\mu \nu} q^{\nu}$ prevails over those of the other terms in the $\bar{B} \rightarrow \mathbf{B} \overline{\mathbf{B}}^{\prime}$ transition form factors with $D_{g_{2}}=D_{f_{2}}=0$ in Eq. (16) as demonstrated in the study of $\bar{B} \rightarrow p \bar{p} \bar{K}^{*}$. Apart from $\mathcal{B}\left(B^{-} \rightarrow p \bar{p} \rho^{-}\right) \sim 2 \times 10^{-5} \quad$ [12], $\mathcal{B}\left(\bar{B}^{0} \rightarrow \Lambda \bar{p} \rho^{+}\right)=3.01 \times 10^{-6}$ and $\mathcal{B}\left(B^{-} \rightarrow \Lambda \bar{p} \phi\right)=1.51 \times 10^{-6}$ can be within reach with the data sample accumulated by BELLE and BABAR at the $B$ factories.

## IV. CONCLUSIONS

We have analyzed the $\bar{B} \rightarrow \mathbf{B B}^{\prime} V$ decays based on the approach of the pQCD counting rules and $S U(3)$ flavor and $S U(2)$ spin symmetries. We have found that the decay branching ratio of $B^{-} \rightarrow \Lambda \bar{p} \rho^{0}$ is ten times bigger than the previous theoretical prediction and agrees with the current experimental data. We have also shown that $\bar{B} \rightarrow \Lambda \bar{\Lambda} \bar{K}^{*}$ is dominated by the $a_{6}$ term in $\mathcal{A}_{\mathcal{C}}$, and its value is comparable to the measured data as well. In addition, we predict $\mathcal{B}\left(\bar{B}^{0} \rightarrow \Lambda \bar{p} \rho^{+}\right)=3.0 \times 10^{-6}$ and $\mathcal{B}\left(B^{-} \rightarrow \Lambda \bar{p} \phi\right)=1.5 \times 10^{-6}$, which are promising to be observed by BELLE and BABAR as well as LHCb.
