# CKM Matrix Elements

The current analysis of the Cabibbo-Kobayashi-Maskawa(CKM) quark mixing matrix uses the standard parametrisation by 3 mixing angles and the CP-violating KM phase. However it would be more convenient to express these mixing angle parameters in terms of the known CKM matrix elements like $V_{u d}, V_{u s}, V_{u b}, V_{c b}$ and the CP-violating phase $\delta$. The other CKM matrix elements are then expressed in terms of these known matrix elements instead of the standard mixing angles. In this paper, using $V_{u d}, V_{u s}, V_{u b}$ and $V_{c b}$ from the current global fit, we show that the measured values for $\left|V_{t d} / V_{t s}\right|$ and $\sin \beta$ imply $\gamma=(68 \pm 3)^{\circ}$ at which $\sin \beta$ and $\sin \alpha$ are near its maximum, consistent with the global fit.

The current global fit of the CKM matrix elements in the Standard Model with imposed unitarity constraints [1, 2] seems to allow a rather precise determination of some of the less known CKM matrix elements like $V_{c b}$ and $V_{u b}$. It would then be possible to directly express the mixing angle parameters in terms of the known CKM matrix elements like $V_{u d}, V_{u s}, V_{u b}, V_{c b}$ and the phase $\delta$, rather than using a parametrization for the mixing angles as usually done in the current studies of the CKM matrix elements. The remaining CKM matrix elements $V_{c d}, V_{c s}, V_{t d}, V_{t s}$ and $V_{t b}$ are thus completely determined directly in terms of these known quantities and the CP-violating phase $\delta$, the main feature of our approach. Furthermore, the CP-violating phase $\delta$ can also be expressed in terms of the known CKM matrix elements and the angle $\gamma, \gamma$ being one of the angle of the ( $d b$ ) unitarity triangle [2, 3] as shown in Fig. (11). The other angles $\beta$ and $\alpha$ as well as the ratio $\left|V_{t d} / V_{t s}\right|$ are then given as functions of $\gamma$. In this paper we shall present our calculation of ratio $\left|V_{t d} / V_{t s}\right|$, $\sin \beta$ and $\sin \alpha$ in terms of $\gamma$ using $V_{u d}, V_{u s}, V_{u b}, V_{c b}$ from the global fit. We find that the measured values for $\left|V_{t d} / V_{t s}\right|$ and $\sin \beta$ imply that $\gamma=(68.6 \pm 3)^{\circ}$ and $\alpha \approx(89 \pm 3)^{\circ}$ consistent with the global fit values for these quantities.

We begin by writing down the Cabibbo-Kobayashi-Maskawa(CKM) [4, 5] quark mixing matrix as:

V_{\mathrm{CKM}}=\left(\begin{array}{ccc}
V_{u d} & V_{u s} & V_{u b}  \tag{1}\\
V_{c d} & V_{c s} & V_{c b} \\
V_{t d} & V_{t s} & V_{t b}
\end{array}\right)
$$

To impose unitarity for the CKM matrix, we take the standard parametrization as used in [2] which is given as [6]:

$$
V_{\mathrm{CKM}}=\left(\begin{array}{ccc}
c_{12} c_{13} & s_{12} c_{13} & s_{13} \exp (-i \delta)  \tag{2}\\
-s_{12} c_{23}-c_{12} s_{23} s_{13} \exp (i \delta) & c_{12} c_{23}-s_{12} s_{23} s_{13} \exp (i \delta) & s_{23} c_{13} \\
s_{12} s_{23}-c_{12} c_{23} s_{13} \exp (i \delta) & -c_{12} s_{23}-s_{12} c_{23} s_{13} \exp (i \delta) & c_{23} c_{13}
\end{array}\right)
$$

where $s_{i j}=\sin \left(\theta_{i j}, c_{i j}=\cos \left(\theta_{i j}\right.\right.$ and $\delta$ is the CP-violating KM phase. The angles $\theta_{i j}$ can be chosen to be in the first quadrant, so $s_{i j}$ and $c_{i j}$ can be taken as positive [2]. The current global fit gives for the magnitudes of all 9 CKM matrix elements [1, 2]:

\left|V_{\mathrm{CKM}}\right|=\left(\begin{array}{ccc}
0.97428 \pm 0.00015 & 0.2253 \pm 0.0007 & 0.00347_{-0.00012}^{+0.00016}  \tag{3}\\
0.2252 \pm 0.0007 & 0.97345_{-0.00016}^{+0.00015} & 0.0410_{-0.0007}^{+0.0011} \\
0.00862_{-0.00020}^{+0.00026} & 0.0403_{-0.0007}^{+0.0011} & 0.999152_{-0.000045}^{+0.00030}
\end{array}\right)
$$

Instead of using the current parametrization [2, 7], which is a form of Wolfenstein parametrization [8] and is unitary to all order in $s_{12}=\lambda$, we shall now express $s_{i j}$ and $c_{i j}$ in terms of $V_{u d}, V_{u s}$, $V_{u b}$ and $V_{c b}$. As these quantities are assumed to be positive, they can be obtained directly from the measured absolute values. For simplicity, we shall put $s_{13}=V_{u b}$ and the matrix element $V_{u b}$ of the CKM matrix in Eq. (11) is now written with the phase $\delta$ taken out ( $V_{u b} \rightarrow V_{u b} \exp (-i \delta)$. We have:

\begin{align*}
& s_{12}=\frac{V_{u s}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)}}, \quad c_{12}=\frac{V_{u d}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)}} \\
& s_{13}=V_{u b}, \quad c_{13}=\sqrt{\left(1-V_{u b}^{2}\right)} \\
& s_{23}=\frac{V_{c b}}{\sqrt{\left(1-V_{u b}^{2}\right)}}, \quad c_{23}=\frac{\sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}}{\sqrt{\left(1-V_{u b}^{2}\right)}} . \tag{4}
\end{align*}

Since $s_{12}^{2}+c_{12}^{2}=1$, we have

$$
\begin{equation*}
V_{u d}^{2}+V_{u s}^{2}=c_{13}^{2}=1-V_{u b}^{2} \tag{5}
\end{equation*}
$$

The matrix elements of the CKM matrix in Eq.(1) are then given by:

$$
\begin{aligned}
& V_{u s}=\frac{V_{u s} \sqrt{\left(1-V_{u b}^{2}\right)}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)}}, \quad V_{u d}=\frac{V_{u d} \sqrt{\left(1-V_{u b}^{2}\right)}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)}}, \quad V_{u b} \rightarrow V_{u b} \exp (-i \delta) \\
& V_{c d}=-\frac{V_{u s} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}-\frac{V_{u d} V_{c b} V_{u b} \exp (i \delta)}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}, \\
& V_{c s}=\frac{V_{u d} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}-\frac{V_{u s} V_{c b} V_{u b} \exp (i \delta)}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}, \quad V_{c b} \rightarrow V_{c b}
\end{aligned}
$$

$$
\begin{align*}
V_{t d} & =\frac{V_{u s} V_{c b}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}-\frac{V_{u d} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)} V_{u b} \exp (i \delta)}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}} \\
V_{t s} & =-\frac{V_{u d} V_{c b}}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}}-\frac{V_{u s} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)} V_{u b} \exp (i \delta)}{\sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)} \sqrt{\left(1-V_{u b}^{2}\right)}} \\
V_{t b} & =\sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)} \tag{6}
\end{align*}
$$

Since $s_{12}^{2}+c_{12}^{2}=1$, we have

$$
\begin{equation*}
V_{u d}^{2}+V_{u s}^{2}=c_{13}^{2}=1-V_{u b}^{2} \tag{7}
\end{equation*}
$$

We note that this expression could be used to obtain $V_{u b}$ provided that $V_{u d}$ and $V_{u s}$ could be measured with great precision which could be achieved in future experiments. With this relation, we recover the expressions for $V_{u d}$ and $V_{u s}$ in Eq. (6), given here with the factor $\sqrt{\left(1-V_{u b}^{2}\right)} / \sqrt{\left(V_{u d}^{2}+V_{u s}^{2}\right)}$ included so that unitarity for the CKM matrix is explicitly satisfied.

The above expressions allow a direct determination of $V_{c d}, V_{c s}, V_{t d}, V_{t s}$ and $V_{t b}$ in terms of $V_{u d}$, $V_{u s}, V_{u b}, V_{c b}$. In the following we shall present expressions and results of our analysis for $\left|V_{t d} / V_{t s}\right|$, $\sin \beta, \sin \alpha$ and $\sin \gamma$ in terms of the known CKM matrix elements provided by the global fit and the CP -violating phase $\delta$.

As seen from the above expressions, the CP-violating phase $\delta$ originating from $V_{u b}$ enters in the quantities $V_{t d}, V_{t s}$ and also in $V_{c d}, V_{c s}$ and manifests itself in the CP-asymmetries in $B^{0}-\bar{B}^{0}$ mixing and in charmless $B$ decays, for example.

Consider now the quantity $\left|V_{t d} / V_{t s}\right|$. We have from Eq. (6)):

\begin{equation*}
\left|V_{t d} / V_{t s}\right|=\frac{V_{u s}}{V_{u d}}\left(\frac{\sqrt{\left(1-2 K_{d} \cos \delta+K_{d}^{2}\right)}}{\sqrt{\left(1+2 K_{s} \cos \delta+K_{s}^{2}\right)}}\right) \tag{8}
\end{equation*}
$$

with

$$
\begin{equation*}
K_{d}=\frac{V_{u d} V_{u b}}{V_{u s} V_{c b}} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}, \quad K_{s}=\frac{V_{u s} V_{u b}}{V_{u d} V_{c b}} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}, \tag{9}
\end{equation*}
$$

For the ( $d b$ ) unitarity triangle, the angles $\alpha, \beta, \gamma$ are given by $[2,3]$

$$
\begin{equation*}
\alpha=\arg \left(-V_{t d} V_{t b}^{*} / V_{u d} V_{u b}^{*}\right), \quad \beta=\arg \left(-V_{c d} V_{c b}^{*} / V_{t d} V_{t b}^{*}\right), \quad \gamma=\arg \left(-V_{u d} V_{u b}^{*} / V_{c d} V_{c b}^{*}\right) \tag{10}
\end{equation*}
$$

with the sides:

$$
\begin{equation*}
R_{u}=\left|V_{u d} V_{u b}^{*} / V_{c d} V_{c b}^{*}\right|, \quad R_{t}=\left|V_{t d} V_{t b}^{*} / V_{c d} V_{c b}^{*}\right|, \quad R_{c}=1 \tag{11}
\end{equation*}
$$

Using the expressions in Eq. (6), we find:

$$
\begin{align*}
& \sin \alpha=\frac{\sin \delta}{\sqrt{\left(1-2 K_{t} \cos \delta+K_{t}^{2}\right)}}, \quad \sin \gamma=\frac{\sin \delta}{\sqrt{\left(1+2 K_{c} \cos \delta+K_{c}^{2}\right)}} \\
& \sin \beta=\frac{\left(K_{t}+K_{c}\right) \sin \delta}{\sqrt{\left(1-2 K_{t} \cos \delta+K_{t}^{2}\right)} \sqrt{\left(1+2 K_{c} \cos \delta+K_{c}^{2}\right)}} \tag{12}
\end{align*}
$$

with

$$
\begin{gathered}
K_{t}=\frac{V_{u d} V_{u b}}{V_{u s} V_{c b}} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}, \quad K_{c}=\frac{V_{u d} V_{u b} V_{c b}}{V_{u s} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}}, \\
\left(K_{t}+K_{c}=V_{u d} V_{u b}\left(1-V_{u b}^{2}\right) /\left(V_{u s} V_{c b} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}\right)\right)
\end{gathered}
$$

Similarly, we have:

$$
\begin{align*}
& R_{u}=\frac{\left(K_{c}+K_{t}\right)}{\sqrt{\left(1+2 K_{c} \cos \delta+K_{c}^{2}\right)}}, \\
& R_{t}=\frac{\sqrt{\left(1-2 K_{t} \cos \delta+K_{t}^{2}\right)}}{\sqrt{\left(1+2 K_{c} \cos \delta+K_{c}^{2}\right)}}, \quad R_{c}=1 . \tag{14}
\end{align*}
$$

From the expressions for $\sin \alpha, \sin \beta$ and $\sin \gamma$ in Eq. (12), we recover the relation

$$
\begin{equation*}
\sin \beta=R_{u} \sin \alpha, \quad \sin \gamma=R_{t} \sin \alpha \tag{15}
\end{equation*}
$$

obtained previously in [7].
Eq. (12) for $\sin \gamma$ can be used to express $\delta$ in terms of $\gamma$. We have:

$$
\begin{equation*}
\cos \delta=\cos \gamma\left(\sqrt{\left(1-K_{c}^{2} \sin ^{2} \gamma\right)}\right)-K_{c} \sin ^{2} \gamma \tag{16}
\end{equation*}
$$

As can be seen from Eq. (13), $K_{c}$ is very much suppressed compared with $K_{t}\left(K_{c}=0.006\right.$, $\left.K_{t}=0.366\right), \sin \delta \approx \sin \gamma$ and $\cos \delta \approx \cos \gamma$ with $\sin ^{2} \gamma$ and $\cos \gamma$ correction terms of $O\left(10^{-4}\right)$. Hence $\delta$ can be replaced by $\gamma$ in the computed quantities with no great loss of accuracy. Thus, with $\sin \delta=\sin \gamma$ and $\cos \delta=\cos \gamma$, we obtain, with the global fit central value $V_{u b}=0.00347$ :

$$
\begin{align*}
& V_{c d}=-0.225112-0.000138 \exp (i \gamma), \quad V_{c s}=0.973467-0.000032 \exp (i \gamma)  \tag{17}\\
& V_{t d}=0.009237-0.003378 \exp (i \gamma), \quad V_{t s}=-0.039946-0.000781 \exp (i \gamma) \tag{18}
\end{align*}
$$

We see that the contribution from the suppressed CKM matrix elements $V_{c b}$ and $V_{u b}$ produces only a small contribution to $V_{c d}$ and $V_{c s}$. Thus unitarity of the CKM matrix in the standard model with 3 generations implies that $V_{c d}$ and $V_{c s}$ are rather well determined and therefore could be used in the semi-leptonic and non-leptonic decays of charmed mesons and charmed baryons. In particular the semi-leptonic $D_{s}$ and $D$ decays can be used to obtain the decays constants $f_{D}$ and $f_{D_{s}}$.

The matrix element $V_{t d}$, gets a large imaginary part from the phase $\delta$ in $V_{u b}$ as given in Eq. (18). This large imaginary part is responsible for the large time-dependent CP-asymmetry in $B$
decays. For the $\left|V_{t d} / V_{t s}\right|$, Eq. (8) gives, with $\delta$ replaced by $\gamma$ :

$$
\begin{equation*}
\left|V_{t d} / V_{t s}\right|=\frac{V_{u s}}{V_{u d}}\left(\frac{\sqrt{\left(1-2 K_{d} \cos \gamma+K_{d}^{2}\right)}}{\sqrt{\left(1+2 K_{s} \cos \gamma+K_{s}^{2}\right)}}\right) \tag{19}
\end{equation*}
$$

and by neglecting the suppressed $K_{c}$ terms, from Eq. (15):

$$
\begin{align*}
\sin \beta & =\frac{B_{u} \sin \gamma}{\sqrt{\left(1-2 K_{t} \cos \gamma+K_{t}^{2}\right)}}, \quad B_{u}=\frac{V_{u d} V_{u b}\left(1-V_{u b}^{2}\right)}{V_{u s} V_{c b} \sqrt{\left(1-V_{u b}^{2}-V_{c b}^{2}\right)}} \\
\sin \alpha & =\frac{\sin \gamma}{\sqrt{\left(1-2 K_{t} \cos \gamma+K_{t}^{2}\right)}} \tag{20}
\end{align*}
$$

It is clear from Eq. (20) that $\sin \beta$ is a measure of $\gamma, V_{u b}$ and $V_{u b} / V_{c b}$. Numerically, $B_{u}=0.366$, $\sin \beta \approx 0.366 \sin \alpha$ as seen from the plot in Fig. (2) . On the other hand, the curve for $\left|V_{t d} / V_{t s}\right|$ in the plot implies that $\gamma=(68.6 \pm 3)^{\circ}$. The middle curve for $\sin \beta$ shows the measured $\sin \beta$ at almost the same value of $\gamma$. The lower curve for $\sin \beta$ is a bit below the measured value but consistent with experiment. The upper curve is slightly above the measured value. This indicates that a value for $V_{u b}$ not too far from the global fit is favored.

In conclusion, by expressing the CKM matrix elements in terms of $V_{u d}, V_{u s}, V_{u b}, V_{c b}$ and the CP-violating phase $\delta$ instead of using the usual mixing angle parametrization, we have obtained analytical expressions for the CKM matrix elements and the angles of the ( $d b$ ) unitarity angle. Using the global fit for $V_{u d}, V_{u s}, V_{u b}, V_{c b}$ and the measured values for $\left|V_{t d} / V_{t s}\right|$ and $\sin \beta$, we find $\gamma=(68.6 \pm 3)^{\circ}$ at which $\sin \beta$ and $\sin \alpha$ are near its maximum. Our simple and direct approach could be used in any further analysis of the CKM matrix elements with more precise measured values for $V_{u b}$ and $V_{c b}$.
