

A FUNCTIONAL GENERALIZED HILL PROCESS AND APPLICATIONS

ABSTRACT. We are concerned in this paper with the functional asymptotic behaviour of the sequence of stochastic processes

$$(0.1) \quad T_n(f) = \sum_{j=1}^{j=k} f(j) (\log X_{n-j+1,n} - \log X_{n-j,n}),$$

indexed by some classes \mathcal{F} of functions $f : \mathbb{N} \setminus \{0\} \mapsto \mathbb{R}_+$ and where $k = k(n)$ satisfies

$$1 \leq k \leq n, k/n \rightarrow 0 \text{ as } n \rightarrow \infty.$$

This is a functional generalized Hill process including as many new estimators of the extremal index when F is in the extremal domain. We focus in this paper on its functional and uniform asymptotic law in the new setting of weak convergence in the space of bounded real functions. The results are next particularized for explicit examples of classes \mathcal{F} .

1. INTRODUCTION

Let X_1, X_2, \dots be a sequence of independent copies (s.i.c) of a real random variable (r.v.) $X > 1$ with d.f. $F(x) = \mathbb{P}(X \leq x)$. We will be concerned in this paper with the functional asymptotic behaviour of the sequence of stochastic processes

$$(1.1) \quad T_n(f) = \sum_{j=1}^k f(j) (\log X_{n-j+1,n} - \log X_{n-j,n}),$$

indexed by some classes \mathcal{F} of functions $f : \mathbb{N}^* = \mathbb{N} \setminus \{0\} \mapsto \mathbb{R}_+$ and where $k = k(n)$ satisfies

$$1 \leq k \leq n, k/n \rightarrow 0 \text{ as } n \rightarrow \infty.$$

The main motivation of this study is to obtain very large classes of estimators for the extreme value index when F lies in the extremal domain, all of them being margins of only one stochastic process. Indeed, for the uniform function $f(j) = j$, $k^{-1}T_n(f)$ is the famous Hill ([18]) estimator of such an index. Recently, a first step to functional forms of the Hill estimator has been done in [12] in the form $k^{-\tau}T_n(f)$ for $f(j) = j^\tau$ and respectively studied in [12] for $(\tau > 1/2)$ and in [10] for $(0 < \tau < 1/2)$ in finite distributions. Groenboom and al. ([14]) also considered a thorough study of a family of Kernel-type estimators of the extreme value index. However, they did not consider a stochastic processes view. There exists a very

large number of estimators of the extremal index. We may cite those of Csörgő-Deheuvels-Mason [7], De Haan-Resnick [6], Pickands [21], Deekkers, De Haan and Einmahl [9], Hasofer and Wang [19], etc. But they all go back to the Hill's one.

However, the asymptotic theory for the estimators of the extremal index are set for a finite number of them, in finite distributions for whole the extremal domain $(-\infty \leq \gamma \leq +\infty)$. The reader is referred to following sample citations : [7], [8], [9], [12], [6], [16], [17], [15], [19], [20], [21], etc.

Now the modern setting of functional weak convergence allows to handle more complex estimators in form of stochastic processes, say $\{T_n(f), f \in \mathcal{F}\}$, such that for any $f \in \mathcal{F}$, there exists a nonrandom sequence $a_n(f)$ such that $T_n/a_n(f)$ is an estimator of the extremal index γ . Such processes may be called stochastic processes of estimators of the extremal index.

Here, we consider one of such processes, that is (1.1). Our aim is to derive their functional asymptotic normality when possible or simply their asymptotic distribution for suitable classes. We will see that for some classes, we have non Gaussian asymptotic behavior, which will be entirely characterized. We shall mainly consider two classes of functions. The first consists of those functions f satisfying

$$(K1) \quad A(2, f) = \sum_{j=1}^{\infty} f(j)^2 j^{-2} < \infty,$$

with the general notation $A(m, f) = \sum_{j=1}^{\infty} f(j)^m j^{-m}$. The second includes functions f such that

$$(K2) \quad \limsup_{n \rightarrow +\infty} B(n, f) = 0,$$

where $B(n, f) = \sigma_n(f)^{-1} \max\{f(j)j^{-1}, 1 \leq j \leq k\}$ and $\sigma_n(f)$ is defined below in (1.2). Under these two conditions, we will be able to find the asymptotic distributions of $T_n(f)$ for a fixed f , under usual and classical hypotheses of extreme value Theory. But as to functional laws, we need uniform conditions. Define \mathcal{F}_1 the subclass of \mathcal{F} such that

$$(KU1) \quad 0 < \inf_{f \in \mathcal{F}_1} A(2, f) < \sup_{f \in \mathcal{F}_1} A(2, f) < +\infty,$$

and \mathcal{F}_2 be a subclass of \mathcal{F} such that

$$(KU2a) \quad \lim_{n \rightarrow \infty} \sup_{f \in \mathcal{F}_2} B_n(f) = 0,$$

and such that for any couple $(f_1, f_2) \in \mathcal{F}_2$,

$$(KU2b) \quad \lim_{n \rightarrow \infty} \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2} = \Gamma(f_1, f_2)$$

exists, where

$$(1.2) \quad \sigma_n^2(f) = \sum_{j=1}^k f(j)^2 j^{-2} \text{ and } a_n(f) = \sum_{j=1}^k f(j)j^{-1}, .$$

We will suppose at times that each \mathcal{F}_h is totally bounded with respect to some semimetric ρ_h .

Our best achievement is the complete description of the weak convergence of the sequence

$$\{T_n(f), f \in \mathcal{F}_h\}, \quad h = 1, 2,$$

in the spaces $\ell^\infty(\mathcal{F}_h)$ of bounded and real functions defined on \mathcal{F}_h , in the light of the modern setting of this theory. Further we provide real case studies with explicit classes in application of the general results.

This approach yields a very great number of estimators of the tail distribution $1 - F$ in the extreme value domain. But, this paper will essentially focus on the functional and uniform laws of the process described above. Including in the present work, for example, second and third order conditions as it is fashion now, and considering datadriven applications or simulations studies would extremely extend the report. These questions are to be considering in subsequent papers.

This paper will use technical results of extreme value Theory. So we will summarize some basics of this theory in the section 2. In this section, we introduce basic notation and usual representation of distribution functions lying in the extremal domain, to be used in all the remainder of the paper. Section 3 is devoted to pointwise limit distributions of $T_n(f)$, while our general functional results are stated and established in Section 4. In Section 5, we study some particular cases, especially the family $\{f(j) = j^\tau, \tau > 0\}$. The section 6 is devoted of the tools of the paper. In this latter, we state two lemmas, namely Lemmas 1 and 2, which are key tools in the earlier proofs.

2. SOME BASICS OF EXTREME VALUE THEORY

The reader is referred to de Haan ([5] and [4]), Resnick ([22]), Galambos ([13]) and Beirlant, Goegebeur and Teugels ([3]) for a modern and large account of the extreme value theory. A distribution function F is said to be attracted to a non degenerated M iff the maximum $X_{n,n} = \max(X_1, \dots, X_n)$, when appropriately centred and normalized by two sequences of real numbers $(a_n > 0)_{n \geq 0}$ and $(b_n)_{n \geq 0}$, converges to M , in the sense that

$$\begin{aligned} & \lim_{n \rightarrow +\infty} P(X_{n,n} \leq a_n x + b_n) \\ (2.1) \quad & = \lim_{n \rightarrow +\infty} F^n(a_n x + b_n) = M(x), \end{aligned}$$

for continuity points x of M .

If (2.1) holds, it is said that F is attracted to M or F belongs to the domain of attraction of M , written $F \in D(M)$. It is well-known that the three possible non-degenerate limits in (2.1), called extremal d.f., are the following

The Gumbel *d.f.*

$$(2.2) \quad \Lambda(x) = \exp(-\exp(-x)), \quad x \in \mathbb{R},$$

or the Fréchet *d.f.* of parameter $\alpha > 0$,

$$(2.3) \quad \phi_\gamma(x) = \exp(-x^{-\alpha}) \mathbb{I}_{[0, +\infty[}(x), \quad x \in \mathbb{R}$$

or the Weibull *d.f.* of parameter $\alpha > 0$

$$(2.4) \quad \psi_\gamma(x) = \exp(-(x)^{-\alpha}) \mathbb{I}_{]-\infty, 0]}(x) + (1 - \mathbb{I}_{]-\infty, 0]}(x)), \quad x \in \mathbb{R},$$

where \mathbb{I}_A denotes the indicator function of the set A . Now put $D(\phi) = \cup_{\alpha > 0} D(\phi_\gamma)$, $D(\psi) = \cup_{\alpha > 0} D(\psi_\gamma)$, and $\Gamma = D(\phi) \cup D(\psi) \cup D(\Lambda)$.

In fact the limiting distribution function M is defined by an equivalence class of the binary relation \mathcal{R} on the set of d.f.'s \mathcal{D} in \mathbb{R} defined as follows :

$$\begin{aligned} \forall (M_1, M_2) \in \mathcal{D}^2, (M_1 \mathcal{R} M_2) &\Leftrightarrow \exists (a, b) \in \mathbb{R}_+ \setminus \{0\} \times \mathbb{R}, \forall (x \in \mathbb{R}), \\ M_2(x) &= M_1(ax + b). \end{aligned}$$

One easily checks that if $F^n(ax + b_n) \rightarrow M_1(x)$, then $F^n(c_nx + d_n) \rightarrow M_1(ax + b) = M_2(x)$ whenever

$$(2.5) \quad a_n/d_n \rightarrow a \text{ and } (b_n - d_n)/c_n \rightarrow b \text{ as } n \rightarrow \infty.$$

Theses facts allow to parameterize the class of extremal distribution functions. For this purpose, suppose that (2.1) holds for the three d.f.'s given in (2.2), (2.3) and (2.4). We may take sequences $(a_n > 0)_{n \geq 1}$ and $(b_n)_{n \geq 1}$ such that the limits in (2.5) are $a = \gamma = 1/\alpha$ and $b = 1$ (in the case of Fréchet extremal domain), and $a = -\gamma = -1/\alpha$ and $b = -1$ (in the case of Weibull extremal domain). Finally, one may interprets $(1 + \gamma x)^{-1/\gamma} = \exp(-x)$ for $\gamma = 0$ (in the case of Gumbel extremal domain). This leads to the following parameterized extremal distribution function

$$(2.6) \quad G_\gamma(x) = \exp(-(1 + \gamma x)^{-1/\gamma}), \quad 1 + \gamma x \geq 0,$$

called the Generalized Pareto Distribution (GPD) of parameter $\gamma \in \mathbb{R}$.

Now we give the usual representations of *df's* lying in the extremal domain in terms of the quantile function of $G(x) = F(e^x)$, $x \geq 1$, that is $G^{-1}(1 - u) = \log F^{-1}(1 - u)$, $0 \leq u \leq 1$.

Theorem 1. *We have :*

(1) *Karamata's representation (KARARE)*

(a) *If $F \in D(\phi_{1/\gamma})$, $\gamma > 0$, then*

$$(2.7) \quad G^{-1}(1 - u) = \log c + \log(1 + p(u)) - \gamma \log u + \left(\int_u^1 b(t) t^{-1} dt \right), \quad 0 < u < 1,$$

where $\sup(|p(u)|, |b(u)|) \rightarrow 0$ as $u \rightarrow 0$ and c is a positive constant and $G^{-1}(1 - u) = \inf\{x, G(x) \geq u\}$, $0 \leq u \leq 1$, is the generalized inverse of G with $G^{-1}(0) = G^{-1}(0+)$.

(b) *If $F \in D(\psi_{1/\gamma})$, $\gamma > 0$, then $y_0(G) = \sup\{x, G(x) < 1\} < +\infty$ and*

$$(2.8) \quad y_0 - G^{-1}(1 - u) = c(1 + p(u))u^\gamma \exp\left(\int_u^1 b(t) t^{-1} dt\right), \quad 0 < u < 1,$$

where c , $p(\cdot)$ and $b(\cdot)$ are as in (2.7)

- (2) *Representation of de Haan (Theorem 2.4.1 in [5]),*
If $G \in D(\Lambda)$, then

$$(2.9) \quad G^{-1}(1-u) = d - s(u) + \int_u^1 s(t)t^{-1}dt, \quad 0 < u < 1,$$

where d is a constant and $s(\cdot)$ admits this KARARE :

$$(2.10) \quad s(u) = c(1+p(u))\exp\left(\int_u^1 b(t)t^{-1}dt\right), \quad 0 < u < 1,$$

$c, p(\cdot)$ and $b(\cdot)$ being defined as in (2.7).

We restrict ourselves here to the cases $F \in D(\Gamma) \cup D(\Phi_{1/\gamma})$, $\gamma > 0$, since the case $F \in D(\Psi_{1/\gamma})$, $\gamma > 0$, may be studied through the transform $F(x_0(F) - 1/\cdot) \in D(\Phi_{1/\gamma})$ for estimating γ . This leads to replace $X_{n-j+1,n}$ by $x_0(F) - 1/1/X_{j,n}$ in (1.1). However, a direct investigation of (1.1) for $F \in D(\Psi_{1/\gamma})$, $\gamma > 0$ is possible. This requires the theory of sums of dependent random variables while this paper uses sums of independant random variables, as it will seen shortly. We consequently consider a special handling of this cas in a dinstinct paper.

Finally, we shall also use the uniform representation of $Y_1 = \log X_1, Y_2 = \log X_2, \dots$ by $G^{-1}(1-U_1), G^{-1}(1-U_2), \dots$ where U_1, U_2, \dots are independent and uniform random variables on $(0,1)$ and where G is the *d.f.* of Y , in the sense of equality in distribution (denoted by $=_d$)

$$\{Y_j, j \geq 1\} =_d \{G^{-1}(1-U_j), j \geq 1\},$$

and hence

$$(2.11) \quad \{Y_{1,n}, Y_{2,n}, \dots, Y_{n,n}\}, n \geq 1\}$$

$$=_d \{G^{-1}(1-U_{n,n}), G^{-1}(1-U_{n-1,n}), \dots, G^{-1}(1-U_{1,n}), n \geq 1\}.$$

In connexion with this, we shall use the following Malmquist representation (see ([24]), p. 336) :

$$(2.12) \quad \{\log\left(\frac{U_{j+1,n}}{U_{j,n}}\right)^j, j = 1, \dots, n\} =_d \{E_1, \dots, E_n\},$$

where E_1, \dots, E_n are independent standard exponential random variables.

3. POINTWISE AND FINITE-DISTRIBUTION LAWS OF $T_n(f)$

Let us begin to introduce these conditions on the distribution function G , through the functions p and b in the representations (2.7), (2.8), (2.9) and (2.10). First, define for $\lambda > 1$,

$$0 \leq g_{1,n}(p, \lambda) = \sup_{0 \leq u \leq \lambda k/n} |p(u)|,$$

$$g_{2,n}(b, \lambda) = \sup_{0 \leq u \leq \lambda k/n} |b(u)|,$$

and

$$d_n(p, b, \lambda) = \max(g_{1,n}(p, \lambda), g_{2,n}(b, \lambda) \log k).$$

We will need the following conditions for some $\lambda > 1$:

$$(C1) \quad g_{1,n}(f, \lambda)(\sigma_n(f))^{-1} \sum_{j=1}^k f(j) \rightarrow 0, \text{ as } n \rightarrow \infty,$$

$$(C2) \quad g_{2,n}(b, \lambda)(\sigma_n(\tau)k^\tau)^{-1} \sum_{j=1}^k f(j) \rightarrow 0 \text{ as } n \rightarrow \infty$$

and

$$(C3) \quad \sup_{f \in \mathcal{F}_h} d_n(p, b, \lambda)(\sigma_n(f)k^\tau)^{-1} \sum_{j=1}^k f(j) \rightarrow 0 \text{ as } n \rightarrow \infty.$$

From now on, all the limits are meant as $n \rightarrow \infty$ unless the contrary is specified. We are able to state :

Theorem 2. *Let $F \in D(\Lambda)$. If (C3) holds, then*

$$(s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n)) \rightarrow \mathcal{N}(0, 1)$$

when (K2) holds and

$$(s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n)) \rightarrow \mathcal{L}(f),$$

when (K1) is satisfied, and where

$$\mathcal{L}(f) = A(2, f)^{-1/2} \sum_{j=1}^{\infty} f(j)j^{-1}(E_j - 1).$$

Let $F \in D(\phi_{1/\gamma})$. If (C1) and (C2) hold, then

$$(a_n(f)/\sigma_n(f))(T_n(f)/a_n(f) - \gamma) \rightarrow \mathcal{N}(0, \gamma^2)$$

under (K2) and

$$(a_n(f)/\sigma_n(f))(T_n(f)/a_n(f) - \gamma) \rightarrow \gamma^{-1}\mathcal{L}(f)$$

under (K1).

Proof. Let us use the representation (2.11). We thus have, for any $n \geq 1$,

$$\{\log X_{n-j+1,n} = Y_{n-j+1,n}, 1 \leq j \leq n\} =_d \{G^{-1}\{1 - U_{j,n}\}, 1 \leq j \leq n\}.$$

First, let $F \in D(\Lambda)$. By (2.8), we get

$$\begin{aligned} T_n(f) &= \sum_{j=1}^k f(j)(s(U_{j,n}) - s(U_{j+1,n})) + \sum_{j=1}^k f(j) \int_{U_{j,n}}^{U_{j+1,n}} s(t)/t \, dt \\ &\equiv S_n(1) + S_n(2). \end{aligned}$$

Using (2.10), we have for $U_{1,n} \leq v, u \leq U_{k,n}$,

$$s(u)/s(v) = (1 + p(u))/(1 + p(v)) \exp\left(-\int_{U_{1,n}}^{U_{k+1,n}} t^{-1}b(t)dt\right).$$

Putting

$$(3.1) \quad g_{1,n,0}(p) = \sup\{|p(u)|, 0 \leq u \leq U_{k+1,n}\} \text{ and } g_{2,n,0}(p) = \sup\{|b(u)|, 0 \leq u \leq U_{k+1,n}\},$$

we get, since $\log(U_{k+1,n}/U_{1,n}) = O_p(\log k)$ as $n \rightarrow \infty$,

$$s(u)/s(v) = (1 + O(g_{1,n,0})) \exp(-O_p(g_{2,n,0} \log k)).$$

This implies

$$(3.2) \quad \sup_{U_{1,n} \leq u, v \leq U_{k,n}} |s(u)/s(v) - 1| = O_p(\max(g_{1,n,0}, g_{2,n,0} \log k))$$

as $n \rightarrow \infty$ and

$$(3.3) \quad \sup_{U_{1,n} \leq u, v \leq U_{k,n}} \left| \frac{s(u) - s(v)}{s(k/n)} \right| = O_p(\max(g_{1,n,0}, g_{2,n,0} \log k)).$$

Since $nk^{-1}U_{k+1,n} \rightarrow 1$ a.s. as $n \rightarrow \infty$, we may find for any $\varepsilon > 0$ and for any $\lambda > 1$, an integer N_0 such that for any $n \geq N_0$,

$$(3.4) \quad \mathbb{P}(g_{1,n,0} \leq g_{1,n}(p, \lambda), g_{2,n,0} \leq g_{2,n}(b, \lambda)) \geq 1 - \varepsilon.$$

Hence (C3) implies

$$\frac{S_n(1)}{\sigma_n(f)s(k/n)} \leq d_n(p, b, \lambda) (\sigma_n(f))^{-1} \sum_{j=1}^k f(j) \rightarrow_P 0,$$

where $d_n(p, b, \lambda) = \max(g_{1,n}, g_{2,n} \log k)$. Next

$$\begin{aligned} \frac{S_n(2)}{\sigma_n(f)s(k/n)} &= \sigma_n(f)^{-1} \sum_{j=1}^k f(j) \int_{U_{j,n}}^{U_{j+1,n}} \{s(t)/s(k/n)\} / t \, dt \\ &= \sigma_n(f)^{-1} \sum_{j=1}^k f(j) \int_{U_{j,n}}^{U_{j+1,n}} t^{-1} \, dt \\ &+ \sigma_n(f)^{-1} \sum_{j=1}^k f(j) \int_{U_{j,n}}^{U_{j+1,n}} \{s(t)/s(k/n) - 1\} / t \, dt = S_n(2, 1) + S_n(2, 2). \end{aligned}$$

We have, by (3.2) and the Malmquist representation (2.12),

$$\begin{aligned} |S_n(2, 2)| &\leq O_p(1) d_n(p, b, \lambda) \times \sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} E_j \leq O_p(1) \times \\ &\left\{ d_n(p, b, \lambda) \times \sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} (E_j - 1) + d_n(p, b, \lambda) \times \sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} \right\}. \end{aligned}$$

The first term tends to zero since $\sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} (E_j - 1)$ converges in distribution to a finite random variable by Lemma 1 in Section 6 and $d_n(p, b, \lambda) \rightarrow_P 0$ by in probability (3.2). The second also tends to zero by (C3). Finally, by the Malmquist representation (2.12), one arrives to

$$S_n(2, 1) = \sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} E_j.$$

And this leads to

$$S_n(2, 1) - \{a_n(f)/\sigma_n(f)\} = \sigma_n(\tau)^{-1} \sum_{j=1}^k j^{\tau-1} (E_j - 1),$$

which converges in distribution to a $\mathcal{N}(0, 1)$ random variable under (K2) and to $\mathcal{L}(f)$ under (K1) by Lemma 1 in Section 6. By summerizing all these facts, we have proved that

$$(\sigma_n(f)s(k/n))^{-1}(T_n(f) - a_n(f)s(k/n))$$

converges in distribution to a $\mathcal{N}(0, 1)$ random variable under (K2) and to $\mathcal{L}(f)$ under (K1).

Now let $F \in D(\phi_{1/\gamma})$, we have by (2.7) and the usual representations,

$$\begin{aligned} T_n(f) &= \sum_{j=1}^k f(j) \{ \log(1 + p(U_{j+1,n})) - \log(1 + p(U_{j,n})) \} \\ &+ \gamma \sum_{j=1}^k f(j) \log(U_{j+1,n}/U_{j,n}) + \sum_{j=1}^k f(j) \int_{U_{j,n}}^{U_{j+1,n}} b(t)/t \, dt \\ &\equiv S_n(1) + S_n(2) + S_n(3). \end{aligned}$$

We have, for large values of k ,

$$|S_n(1)/\sigma_n(f)| \leq 2g_{1,n,0}(f)(\sigma_n(f))^{-1} \sum_{j=1}^k f(j),$$

where $g_{1,n,0}$ is defined in (3.1), which tends to zero in probability by (C1) and (3.2). Next

$$\begin{aligned} |S_n(3)/\sigma_n(f)| &\leq g_{2,n,0}(b)(\sigma_n(f))^{-1} \sum_{j=1}^k f(j) \log(U_{j+1,n}/U_{j,n}) \\ &= g_{2,n,0}(b)\sigma_n(f)^{-1} \sum_{j=1}^k f(j)j^{-1}(E_j - 1) + g_{2,n,0}(b)\sigma_n(f)^{-1} \sum_{j=1}^k f(j)j^{-1}, \end{aligned}$$

where $g_{2,n,0}$ defined in (3.1). Then $S_n(3)/\sigma_n(f) \rightarrow 0$ by (C3) and Lemma 1 and the methods described above. Finally, always by Lemma 1,

$$\{(S_n(3) - \gamma a_n(f))\}/\sigma_n(f) = \gamma \sigma_n(f)^{-1} \sum_{j=1}^k f(j)j^{-1}(E_j - 1)$$

and this converges in distribution to a $\mathcal{N}(0, \gamma^2)$ random variable under (K2) and to $\gamma L(f)$ under (K1). \square

From these proofs, we get two intermediate results towards the functional laws. The first concerns the asymptotic law in finite distributions.

Corollary 1. *Suppose that the hypotheses (C1), (C2) and (C3) hold and for any $(f_1, f_2) \in \mathcal{F}_1^2 \cup \mathcal{F}_2^2$,*

$$\lim_{n \rightarrow \infty} \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2} = \Gamma(f_1, f_2) \text{ exists.}$$

Then the finite-distributions of $\{(s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n)), f \in \mathcal{F}_1\}$ weakly converge to those of the process \mathcal{L} , for $F \in D(\Lambda)$ and the finite-distributions of $\{\sigma_n(f)^{-1}(T_n(f) - a_n(f)), f \in \mathcal{F}_1\}$ weakly converge to those of the process $\gamma\mathcal{L}$, for $F \in D(\varphi_{1/\gamma})$.

And the finite-distributions of $\{(s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n)), f \in \mathcal{F}_2\}$ weakly converge to those of a Gaussian process \mathbb{G} of covariance function

$$\Gamma(f_1, f_2) = \lim_{n \rightarrow \infty} \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2}$$

and, for $F \in D(\Lambda)$, the finite-distributions of $\{\sigma_n(f)^{-1}(T_n(f) - a_n(f)), f \in \mathcal{F}_2\}$ weakly converge to those of $\gamma\mathbb{G}$, for $F \in D(\varphi_{1/\gamma})$.

Proof. Put $V_n(0, f) = (s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n))$ and $V_n(1, f) = \sigma_n(f)^{-1}(T_n(f) - a_n(f))$ for a fixed $f \in \mathcal{F}_h, h = 1, 2$. For a finite family $(f_1, f_2, \dots, f_s) \in f \in \mathcal{F}_h^s, h = 1, 2, 0 < s \in \mathbb{N}^*$, we have by the proof of Theorem 1, for each $1 \leq i \leq s$,

$$(3.5) \quad V_n(0, f_i) = V_n^*(f_i) + o_P(1)$$

for $F \in D(\Lambda)$ and

$$(3.6) \quad V_n(1, f_i) = \gamma V_n^*(f_i) + o_P(1)$$

for $F \in D(\varphi_{1/\gamma})$. From now, we conclude by applying Lemma 2 which establishes the asymptotic laws of $(V_n^*(f_1), \dots, V_n^*(f_s))$ under the assumptions of the Lemma. \square

This corollary makes a good transition towards the functional law. In order to state a further step, we need the following uniform conditions on the distribution function F . Define for some $\lambda > 1$,

$$(CU1) \quad \sup_{f \in \mathcal{F}_h} g_{1,n}(f, \lambda)(\sigma_n(f))^{-1} \sum_{j=1}^k f(j) \rightarrow 0,$$

$$(CU2) \quad \sup_{f \in \mathcal{F}_h} g_{2,n}(b, \lambda)\sigma_n(f)^{-1} \sum_{j=1}^k f(j)$$

and

$$(CU3) \quad \sup_{f \in \mathcal{F}_h} d_n(p, b, \lambda)\sigma_n(f)^{-1} \sum_{j=1}^k f(j) \rightarrow 0.$$

These conditions are set so that the $o_P(1)$ in (3.5) and 3.6) hold uniformly in our classes. We thus begin to state this :

Corollary 2. Assume that the uniform conditions (KU1), (KU2a), (KU2b), (CU1), (CU2) and (CU3) hold - when appropriate - in Theorem 2. Put $V_n^*(f) = \sigma_n(f)^{-1}(V_n(f) - a_n(f))$. Finally let \mathcal{F}_a be a nonvoid family of functions satisfying (KU1) or, a nonvoid family of functions satisfying (KU2a-b). Suppose that $\{V_n^*(f), f \in \mathcal{F}_a\}$ weakly converges in $\ell^\infty(\mathcal{F}_a)$. Then, uniformly in $f \in \mathcal{F}_a$,

$$(s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n)) = V_n^*(f) + o_P^*(1)$$

for $F \in D(\Lambda)$ and

$$(a_n(f)/\sigma_n(f))(T_n(f)/a_n - \gamma) = \gamma V_n^*(f) + o_P^*(1)$$

for $F \in D(\phi_{1/\gamma})$.

Proof. Put

$$V_n(0, f) = (s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n))$$

and

$$V_n(1, f) = (a_n(f)/\sigma_n(f))(T_n(f)/a_n - \gamma).$$

When the uniformity hypotheses (KU1) or, (KU2a) and (KU2b) hold, we surely have

$V_n(0, f) = V_n^*(f)(1 + o_P^*(1)) + o_P^*(1)$ and $V_n(1, f) = \gamma V_n^*(f)(1 + o_P^*(1)) + o_P^*(1)$, uniformly in $f \in \mathcal{F}_h$. Now let \mathcal{F}_a a subset of \mathcal{F}_1 such that $\{V_n^*(f), f \in \mathcal{F}_a\}$ weakly converges, say to \mathbb{G} in $\ell^\infty(\mathcal{F}_a)$. Then $\|\mathbb{G}\|_{\mathcal{F}_a}^* < \infty$. Since, by the continuity theorem, $\|V_n^*\|_{\mathcal{F}_a} \rightsquigarrow \|\mathbb{G}\|_{\mathcal{F}_a}^*$, we get

$$(3.7) \quad V_n(0, f) = V_n^*(f) + o_P^*(1),$$

uniformly in $f \in \mathcal{F}_a$ for $F \in D(\Lambda)$. The other cases are proved similarly. \square

4. THE FUNCTIONAL LAW OF $T_n(f)$

We shall use here (3.7). Recall and denote

$$V_n^*(f) = \sigma_n(f)^{-1}(V_n(f) - a_n(f)) = \sum_{j=1}^k \frac{f(j)j^{-1}}{\sigma_n(f)}(E_j - 1) =: \sum_{j=1}^k Z_{j,n}(f).$$

Then, our main tools for handling these stochastic processes are Theorem 2.11.1 and Theorem 2.11.9 of ([23]) on uniform laws of sums of independant stochastic processes. We will then need the basic frame of these theorems.

Next, we shall possibly consider sub-families \mathcal{F} of \mathcal{F}_h ($h = 1, 2$) formed by functions $f : \mathbb{N}^* \mapsto \mathbb{R}_+^*$ satisfying this mesurability assumption, that is for each $h = 1, 2$, for each $\delta > 0$ and for each $(e_1, \dots, e_n) \in \{-1, 0, 1\}^n$, for each $p = 1, 2$,

$$(MES) \quad \sup_{(f_1, f_2) \in \mathcal{F}_h, \rho(f_1, f_2) \leq \delta} \sum_{j=1}^k e_j |\sigma_n^{-1}(f_1)f_1(j)j^{-1} - \sigma_n^{-1}(f_2)f_2(j)j^{-1}|^p E_j^p,$$

is measurable, where ρ is a semimetric space on \mathcal{F} . Precisely, we introduce the two classes. Let subfamilies $\mathcal{F}_{h,0}$ of \mathcal{F}_h ($h = 1, 2$) such that each of them is equipped with a semimetric ρ_h such that $(\mathcal{F}_{h,0}, \rho_h)$ is totally bounded, and that the mesurability of (MES) holds. We may also need the random semimetric

$$d_n^2(f_1, f_2) = \sum_{j=1}^k (\sigma_n^{-1}(f_1)f_1(j)j^{-1} - \sigma_n^{-1}(f_2)f_2(j)j^{-1})^2(E_j - 1)^2.$$

Now suppose that $(\mathcal{F}_{h,0}, \|\cdot\|)$ be a normed space verifying the Riesz property. Let us define, as in [23] (p. 211), the bracketing number $N_{[]}(\varepsilon, \mathcal{F}_{h,0}, L_2^n)$ as the minimal number of sets N_ε in a partition $\mathcal{F}_{h,0} = \bigcup_{j=1}^{N_\varepsilon} \mathcal{F}_{\varepsilon j}^n$ of the index set into sets $\mathcal{F}_{\varepsilon j}^n$ such that, for every partitioning set $\mathcal{F}_{\varepsilon j}^n$,

$$\sum_{i=1}^k \mathbb{E}^* \sup_{f, g \in \mathcal{F}_{\varepsilon j}^n} |Z_{ni}(f_1) - Z_{ni}(f_2)|^2 \leq \varepsilon^2.$$

We have our first version of the functional laws of $T_n(f)$.

Theorem 3. Suppose that for each $h = 1, 2$, we have

$$(L1) \quad \sup_{(f_1, f_2) \in \mathcal{F}_{h,0}^2, \rho_h(f_1, f_2) \leq \delta_n} \sum_{j=1}^{k(n)} (f_1(j)/(j\sigma_n(f)) - f_2(j)/(j\sigma_n(f)))^2 \rightarrow 0$$

as $\delta_n \downarrow 0$ as $n \uparrow +\infty$, and

$$(L2) \quad \int_0^{\delta_n} \sqrt{\log N_{[]}(\epsilon, \mathcal{F}_h, d_n)} d\epsilon \rightarrow 0,$$

as $n \uparrow \infty$, where $N_{[]}(\epsilon, \mathcal{F}_h, d_n)$ is the ϵ -entropy number of $\mathcal{F}_{h,0}$ with respect to the semi-metric d_n , that is the minimal number of d_n -balls of radius at most ϵ needed to cover \mathcal{F}_h .

Let $F \in D(\Lambda)$ and suppose that (CU3) holds. Then

$$\left\{ (s(k/n)\sigma_n(f))^{-1} (T_n(f) - s(k/n)a_n(f)), f \in \mathcal{F}_1 \right\}$$

converges to a Gaussian process in $\ell^\infty(\mathcal{F}_{2,0})$ with covariance function

$$\Gamma(f_1, f_2) = \lim_{n \rightarrow \infty} \sum_{j=1}^{k(n)} \{\sigma_n(f_1)\sigma_n(f_2)\}^{-1} f_1(j)f_2(j)j^{-2} \leq 1.$$

And $\left\{ (s(k/n)\sigma_n(f))^{-1} (T_n(f) - s(k/n)a_n(f)), f \in \mathcal{F}_{1,0} \right\}$ converges to a stochastic process $\{\mathcal{L}(f), f \in \mathcal{F}_{1,0}\}$ in $\ell^\infty(\mathcal{F}_{1,0})$ with covariance function $\Gamma(f_1, f_2)$. The finite distributions of $(\mathcal{L}(f_1), \dots, \mathcal{L}(f_S))$ are characterized by the generating moments function

$$(4.1) \quad (t_1, \dots, t_S) \mapsto \prod_{j=1}^{+\infty} \exp\left(\sum_{s=1}^S t_s f_s(j) j^{-1}\right) \left(1 - \sum_{s=1}^S t_s f_s(j) j^{-1}\right),$$

for $|t_s| \leq 1/S$, $s = 1, \dots, S$.

Let $F \in D(\phi_{1/\gamma})$ and suppose that (CU1) and (CU2) hold. Then

$$\{(a_n(f)/\sigma_n(f))(T_n(f)/a_n - \gamma), f \in \mathcal{F}_{2,0}\}$$

converges to a Gaussian process in $\ell^\infty(\mathcal{F}_{2,0})$ with covariance function Γ .

And $\{(a_n(f)/\sigma_n(f))(T_n(f)/a_n - \gamma)/\gamma, f \in \mathcal{F}_{1,0}\}$ converges to a stochastic process in $\ell^\infty(\mathcal{F}_{1,0})$ with covariance function $\gamma^2 \Gamma$ and finite distribution characterized by (4.1).

Proof. We begin by applying Corollary 2. For $T_n^*(f) = (s(k/n)\sigma_n(f))^{-1}(T_n(f) - a_n(f)s(k/n))$ for $F \in D(\Lambda)$ or $T_n^*(f) = (a_n(f)/\sigma_n(f))(T_n(f)/a_n - \gamma)$ for $F \in D(G_{1/\gamma})$, we have

$$T_n^*(f) = V_n^*(f) + o_P(1),$$

uniformly in $f \in \mathcal{F}_h$ and hence uniformly in $f \in \mathcal{F}_{h,0}$ ($h = 1, 2$). From there, we apply Theorem 2.11.1 of ([23]) on the uniform behavior of the stochastic processes

$$V_n^*(f) = \sigma_n(f)^{-1}(V_n(f) - a_n(f)) = \sum_{j=1}^k \frac{f(j)j^{-1}}{\sigma_n(f)} =: \sum_{j=1}^k Z_{j,n}(f),$$

indexed by $f \in \mathcal{F}_{h,0}$. All the assumptions of Theorem 2.11.1 of ([23]) have already been taken into account in our statement, except this one,

$$(L3) \quad \mathbb{E}^* \{ \|Z_{j,n}\|_{\mathcal{F}_h}^2 I(\|Z_{j,n}\|_{\mathcal{F}_h} > \eta) \} \rightarrow 0, \text{ as } n \rightarrow \infty,$$

for any $\eta > 0$, and the convergence of the covariance function. But the $\|Z_{j,n}\|$ are measurable and

$$\mathbb{E} \|Z_{j,n}\|_{\mathcal{F}_1} = \max\{f(j)/j, j \geq 1\} / \sigma_n(f) \rightarrow 0,$$

because of (KU1) and

$$\mathbb{E} \|Z_{j,n}\|_{\mathcal{F}_2} \leq B_n \rightarrow 0$$

because of (KU2a). This proves (L3). As to the covariance functions which are

$$\Gamma_n(f_1, f_2) = \sum_{j=1}^{k(n)} \{\sigma_n(f_1)\sigma_n(f_2)\}^{-1} f_1(j)f_2(j)j^{-2},$$

we notice by the Cauchy-Schwartz inequality that they are bounded by the unity. For $h = 1$, we have

$$\Gamma_n(f_1, f_2) = \frac{1}{\sqrt{A(2, f_1)A(2, f_2)}} \sum_{j=1}^{\infty} f_1(j)f_2(j)j^{-2} \leq 1,$$

while for $h = 2$, the condition (KU2a) guarantees the desired result. We thus conclude that $\{T_n^*(f), f \in \mathcal{F}_{h,0}\}$ weakly converges in $\ell^\infty(\mathcal{F}_{h,0})$ for each $h = 1, 2$. Now, by Theorem 2 and Corollary 1, we know that the weak limit is either \mathcal{L} defined by (4.1) or a Gaussian process \mathbb{G} of covariance function Γ . \square

Now, we present the second version which is more general since we do not require the mesurability assumption so that we consider the whole spaces \mathcal{F}_h ($h = 1, 2$).

Theorem 4. *If $(\mathcal{F}_h, |||)$ is a normed space verifying the Riesz property, then the results of Theorem 3 hold when*

$$(L4) \quad \int_0^{\delta_n} \sqrt{\log N_{[]}(\epsilon, \mathcal{F}_h, L_2^n)} d\epsilon \rightarrow 0,$$

as $n \rightarrow \infty$, in place of (L2), provided that the $Z_{j,n}$ have finite second moments

Proof. It is achieved by applying Theorem 2.11.9 of [23] in the proof of Theorem 3, that requires (L1), (L2), (L4) and that the $Z_{j,n}$ have finite second moments. But (L2) and the last condition hold. Thus (L1) and (L4) together ensure the results of the theorem. \square

5. SPECIAL CLASSES

We specialize these results for the special class of the monotone functions $f_\tau(j) = j^\tau$, $0 < \tau$. We will show here, in this example, how to derive particular laws for special classes from our general results. We know from [10] and [12] that $T_n(f_\tau)$ is asymptotically normal for $\tau > 1/2$ while it asymptotically follows a $\mathcal{L}(f_\tau)$ type-law for $0 < \tau < 1/2$, under usual conditions of the d.f. G . We handle here the uniform asymptotic behavior for these two range values of $\tau :]0, 1/2[$ and $[1/2, +\infty[$. For

the first case, we apply Theorem (3) and for the second, Theorem 4. First, let $0 < a < b < 1/2$ and put,

$$\mathcal{F}_0(a, b) = \{f(j) = j^\tau, a \leq \tau \leq b\}.$$

We have

Corollary 3. *Let $0 < a < b < 1/2$ and $\mathcal{F}_0 = \mathcal{F}_0(a, b) = \{f(j) = j^\tau, 0 < a \leq \tau \leq b < 1/2\}$. Then,*

(1) *if $F \in D(G_0)$ and if (CU2) and (CU2) hold. Then*

$$\left\{ (s(k/n)\sigma_n(f))^{-1} (T_n(f) - s(k/n)a_n(f)), f \in \mathcal{F}_0 \right\}$$

weakly converges to $\{\mathcal{L}(f), f \in \mathcal{F}_0\}$.

(2) *if $F \in D(G_{1/\gamma}), \gamma > 0$, and if (CU1) holds. Then*

$$\{(a_n/\sigma_n(f))(T_n(f)/a_n(f) - \gamma), f \in \mathcal{F}_0\}$$

weakly converges to $\{\gamma\mathcal{L}(f), f \in \mathcal{F}_0\}$.

Proof. We apply here Theorem 3. We have

$$\mathcal{F}_{0,1} = \{g(j) = j^{-(b-\tau)}, a \leq \tau \leq b\}.$$

For $f(j) = j^\tau$, denote $g_f(j) = j^{-(b-\tau)}$, that is

$$f(j)/j = g_f(j) \times j^{-(1-b)}.$$

In this case, put

$$V_n^{**}(f) = (V_n(f) - a_n(f)) = \sum_{j=1}^k g_f(j)(E_j - 1)j^{-(1-b)} =: \sum_{j=1}^k Z_{j,n}(f).$$

We have

$$\begin{aligned} \rho_n^2(f_1, f_2) &= \mathbb{E} \sum_{j=1}^k (Z_{j,n}(f_1) - Z_{j,n}(f_2))^2 = \sum_{j=1}^k (f_1(j) - f_2(j))^2 j^{-2} \\ &\leq \rho^2(f_1, f_2) = \sum_{j=1}^{\infty} (f_1(j) - f_2(j))^2 j^{-2} = \sum_{j=1}^{\infty} (g_{f_1}(j) - g_{f_2}(j))^2 j^{-2(1-b)}. \end{aligned}$$

We point out that $\rho^2(f_1, f_2)$ is nothing else but $\|g_{f_1} - g_{f_2}\|_{L_2(\mathcal{F}_{0,1}, \mathbb{Q})}^2$ for the probability measure on \mathbb{N} ,

$$\mathbb{Q} = A(2, b)^{-1} \sum_{j=1}^{\infty} j^{-2(1-b)} \delta_j$$

for

$$A(2, b) = \sum_{j=1}^{\infty} j^{-2(1-b)} < \infty,$$

For such monotone functions $g_f : \mathbb{N} \mapsto [0, 1]$, we have by virtue of Theorem 2.7.5 of [23] that for some $K > 0$, any $\epsilon > 0$,

$$N_{[]}(\epsilon, \mathcal{F}_{0,1}, L_2(\mathbb{Q})) \leq \exp(K\epsilon^{-1}).$$

This means that (\mathcal{F}_0, ρ) is totally bounded and (L1) is reduced to

$$\sup_{\rho(f_1, f_2) \leq \delta_n} \rho_n(f_1, f_2) \leq \delta_n \rightarrow 0,$$

which is trivial. In the same spirit

$$A(2, b, \omega) = \sum_{j=1}^{\infty} j^{-2(1-b)} (E_j - 1)^2(\omega)$$

is almost surely finite and

$$Q_0(\omega) = A(2, b, \omega)^{-1} \sum_{j=1}^{\infty} j^{-2(1-b)} (E_j - 1)^2(\omega) \delta_j,$$

is a probability measure for almost all ω . And we have

$$0 \leq d_n^2(f_1, f_2) \rightarrow d^2(f_1, f_2) = \|g_{f_1} - g_{f_2}\|_{L_2(\mathcal{F}_{0,1}, \mathbb{Q}_0)}^2.$$

This convergence is a continuity one since τ lies on the compact set $[a, b]$ (see Subsection 7.2. in the Appendix 7 for such results). Thus, uniformly in $\tau \in [a, b]$, for large values of n ,

$$0 \leq d_n^2(f_1, f_2) \geq 0.25 d^2(f_1, f_2).$$

We may use the same results of ([23]) to get for some $K > 0$ and for any $\epsilon > 0$,

$$\log N_{[]}(\epsilon, \mathcal{F}_0, d_n) \leq \log N_{[]}(\epsilon, \mathcal{F}_0, d/2) \leq K(\epsilon/2)^{-1}.$$

This ensures (L2). The covariance function is, for $f_1(j) = j^{\tau_1}$ and $f_2(j) = j^{\tau_2}$,

$$\Gamma^*(f_1, f_2) = \lim_{n \rightarrow \infty} \sum_{j=1}^k f_1(j) f_2(j) j^{-2} = \sum_{j=1}^{\infty} j^{-(2-\tau_1-\tau_2)} \leq \sum_{j=1}^{\infty} j^{-2(1-b)} = A(2, b).$$

As to the mesurability hypothesis, it is readily seen that the following supremum

$$(5.1) \quad \sup_{(f_1, f_2) \in \mathcal{F}_h, \rho(f_1, f_2) \leq \delta_n} \sum_{j=1}^k e_j |\sigma_n^{-1}(f_1) f_1(j) j^{-1} - \sigma_n^{-1}(f_2) f_2(j) j^{-1}|^p E_j^p$$

is achieved through the rational values of τ in $[a, b]$, and then, is measurable. This achieves the proof. \square

Corollary 4. *Let $1/2 < a < b < 1$ and $\mathcal{F}_1(a, b) = \{f(j) = j^\tau, 0 < a \leq \tau \leq b\}$.*

(1) *If $F \in D(G_0)$ and if (CU3). Then*

$$\left\{ (s(k/n) \sigma_n(f))^{-1} (T_n(f) - s(k/n) a_n(f)), f \in \mathcal{F}_0 \right\}$$

weakly converges to a Gaussian process \mathbb{G} of covariance function Γ .

(2) *If $F \in D(G_{1/\gamma})$, $\gamma > 0$, and if (CU1) holds. Then*

$$\{(a_n / \sigma_n(f))(T_n(f) / a_n(f) - \gamma), f \in \mathcal{F}_0\}$$

weakly converges to the Gaussian process $\gamma \mathbb{G}$.

Proof. We apply here Theorem 4. But, we begin by returning to the simple scheme, that is, to fixed $f \in \mathcal{F}_1(a, b)$. Let $f(j) = j^\tau$. We have

$$B(n, f) = O((\log k)^{-1}),$$

$$\tau = 1/2,$$

$$B(n, f) = O(k^{-(2\tau-1)})$$

for $0 < \tau < 1/2$ and

$$B(n, f) = O(k^{-\tau}),$$

for $\tau > 1$. Then (K1) holds and this leads to the normality case in Theorem 2 for each $\tau \geq 1/2$. Next, for $f_1(j) = j^{\tau_1}$ and $f_2(j) = j^{\tau_2}$, $\tau_1 > 1/2$, $\tau_2 > 1/2$,

$$\lim_{n \rightarrow \infty} \sum_{j=1}^{k(n)} \{\sigma_n(f_1)\sigma_n(f_2)\}^{-1} f_1(j)f_2(j)j^{-2} = \frac{\sqrt{(2\tau_1-1)(2\tau_2-1)}}{\tau_1 + \tau_2 - 1} = \Gamma(f_1, f_2) < \infty.$$

And for $\tau_1 = 1/2$ and $\tau_2 > 1/2$

$$\sum_{j=1}^{k(n)} \{\sigma_n(f_1)\sigma_n(f_1)\}^{-1} f_1(j)f_2(j)j^{-2} \sim \sqrt{2\tau_2-1}(\log k)k^{(2\tau_2-1)/2},$$

that is, $\mathcal{F}_1(a, b)$ satisfies (KU2a). This also implies that we have the finite-distributions weak normality for $\tau > 1/2$. It also fulfils (KU2b) since

$$B(n) = \sup_{f \in \mathcal{F}_1(a, b)} B(n, f) \leq k^{-b} \rightarrow 0.$$

Consider here

$$V_n^{**}(f) = \sigma_n(f)^{-1}(V_n(f) - a_n(f)) = \sum_{j=1}^k f(j)/(j\sigma_n(f))(E_j - 1) =: \sum_{j=1}^k Z_{j,n}(f)$$

We have

$$\begin{aligned} \rho_n^2(f_1, f_2) &= \mathbb{E} \sum_{j=1}^k (Z_{j,n}(f_1) - Z_{j,n}(f_2))^2 = 2 - \frac{2}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2} \\ &\rightarrow 2(1 - \Gamma(f_1, f_2)) = \sum_{j=1}^{\infty} \{(f_1(j)/(j\sigma_n(f_1)) - (f_2(j)/(j\sigma_n(f_2)))\}^2. \end{aligned}$$

By routine calculations and by a continuity argument based on the remark that our τ 's are in the compact set $[a, b]$, we may show that

$$(5.2) \quad \rho_n^2(f_1, f_2) < 3(1 - \Gamma(f_1, f_2))$$

for large values of n . Since we use this type of arguments many times, we show in Subsection 7.2 of the appendix (7) the exact proof of (5.2). But

$$1 - \Gamma(f_1, f_2) = (1 - \frac{\sqrt{(2\tau_1-1)(2\tau_2-1)}}{\tau_1 + \tau_2 - 1})$$

For $\tau_1 - \tau_2 = \delta > 0$,

$$1 - \Gamma(f_1, f_2) = \frac{(2\tau_2-1) + \delta - \sqrt{(2\tau_2-1)^2 + 2\delta(2\tau_2-1)}}{\tau_1 + \tau_2 - 1}.$$

We use a Taylor expansion of a first order, to get for $1/2 < a < \tau_1, \tau_2 < b$, $3(1 - \Gamma(f_1, f_2)) \leq B(a, b)\delta$, where $B(a, b)$ depend only on a and b . Thus for a fixed δ , for large values of k ,

$$\rho_n^2(f_1, f_2) \leq B(a, b)\delta.$$

We may now take the metric $\rho(f_1, f_2) = \|\tau_1 - \tau_2\|$, for which $(\mathcal{F}_1(a, b), \rho_2)$ is a Riesz Space totally bounded and we surely obtain

$$\sup_{\rho_2(f_1, f_2) \leq \delta_n} \rho_n(f_1, f_2) \leq 4B(a, b)\delta_n \rightarrow 0.$$

This gives the (L1) hypothesis. Now, to conclude the proof by establishing the functional law as already described in Corollary 1, we have to prove that (L4) holds

for $(\mathcal{F}_1(a, b), \rho_2)$ with partitions not depending on n , so that (L2) is unnecessary. Since the proof concerning (L4) is very technical, we state it Subsection (7.1) of the Appendix (7). \square

6. TECHNICAL LEMMAS

Define the following conditions

$$(K1) \quad A(2, f) = \sum_{j=1}^{\infty} f(j)^2 j^{-2} \in]0, +\infty[,$$

with the notation (well-defined since $f > 0$)

$$A(n, f) = \sum_{j=1}^{\infty} f(j)^n j^{-n}$$

and

$$(K2) \quad \limsup_{n \rightarrow +\infty} \sigma_n(f)^{-1} \max\{f(j)j^{-1}, 1 \leq j \leq k\} = \limsup_{n \rightarrow +\infty} B(n, f) = 0$$

We begin by this simple lemma where we suppose that we are given a sequence of independent and uniformly distributed random variables U_1, U_2, \dots as in (2.11).

Lemma 1. *Let*

$$V_n(f) = \sum_{j=1}^k f(j) \log\left(\frac{U_{j+1,n}}{U_{j,n}}\right).$$

If (K2) holds,

$$\sigma_n^{-1}(f)(V_n(f) - a_n(f)) \rightsquigarrow \mathcal{N}(0, 1)$$

and if (K1) holds,

$$\sigma_n^{-1}(f)(V_n(f) - a_n(f)) \rightsquigarrow \mathcal{L}(f),$$

where $a_n(f)$ and $\sigma_n(f)$ are defined in (1.2) and

$$\mathcal{L}(\tau) = A(2, f) \sum_{j=1}^{\infty} f(j) j^{-1} (E_j - 1),$$

is a centred and reduced random variable with all finite moments.

Proof. By using the Malmquist representation (2.12), we have

$$V_n(f) = \sum_{j=1}^k f(j) j^{-1} E_j.$$

It follows that $\mathbb{E}(V_n(f)) = a_n(f)$ and $\text{Var}(V_n(f)) = \sigma_n^2(f)$. Put

$$V_n^*(f) = \sigma_n(f)^{-1} (V_n(f) - a_n(f)).$$

Then

$$V_n^*(f) = \sigma_n(f)^{-1} \sum_{j=1}^k f(j) j^{-1} (E_j - 1).$$

First suppose that (K1) holds, that is $\sigma_n(f) \rightarrow A(2, f)^{-1/2} \in]0, 1[$. Then

$$V_n^*(f) \rightarrow A(2, f)^{-1/2} \sum_{j=1}^{\infty} f(j) j^{-1} (E_j - 1) = \mathcal{L}(f).$$

Now, we have to prove that $\mathcal{L}(f)$ is a well-defined random variable with all finite moments. The moment characteristic function of $V_n^*(f)$ is

$$\psi_{V_n^*(f)}(t) = \exp(-A(2, f)^{-1/2} \sum_{j=1}^k f(j) j^{-1} (it)) \prod_{j=1}^k (1 - it \times f(j) j^{-1} A(f)^{-1/2})^{-1}.$$

By using the development of $\log(1 - \cdot)$, and, by the Lebesgues Theorem, one readily proves that

$$\begin{aligned} \psi_{V_n^*(f)}(t) &= \exp\left(\sum_{j=1}^k \sum_{n=2}^{\infty} \frac{(it)^n}{n} f(j)^n j^{-n} A(2, f)^{-n/2}\right) \\ (6.1) \quad &\rightarrow \psi_{\infty}(t) = \exp\left(\sum_{n=2}^{\infty} \frac{(it)^n}{n} A(n, f) A(2, f)^{-n/2}\right). \end{aligned}$$

We note that if $A(2, f) < \infty$, then $A(n, f)$ is also finite for any $n \geq 2$, since the general term (in j) of $A(n, f)$ is less than that of $A(2, f)$, for large values of j . This concludes the proof when (K1) holds.

Now suppose that (K2) holds. Let us evaluate the moment generating function of $V_n^*(f)$:

$$(6.2) \quad \phi_{V_n^*(f)}(t) = \prod_{j=1}^k \phi_{(E_j-1)}(t f(j) j^{-1} \sigma_n(f)^{-1}).$$

Recall that, in this case, $\sigma_n(f) \uparrow \infty$. It follows from (K2), that for any $u_0 > 0$ for a fixed t , for k large enough,

$$(6.3) \quad |t f(j) j^{-1} \sigma_n(f)^{-1}| \leq u_0$$

uniformly in $j \geq 1$. At this step, we use the expansion of $\phi_{(E_j-1)}$ in the neighborhood of zero :

$$\psi_{(E_j-1)}(u) = 1 + u^2/2 + u^3 g(u),$$

where there exists u_0 such that

$$0 \leq u \leq u_0 \Rightarrow |g(u)| \leq 1.$$

Using the uniform bound in (6.3), we get

$$\begin{aligned} (6.4) \quad \phi_{(E_j-1)}(t f(j) j^{-1} \sigma_n(f)^{-1}) &= 1 + \frac{1}{2} (t f(j) j^{-1} \sigma_n(f)^{-1})^2 \\ &\quad + (t f(j) j^{-1} \sigma_n(f)^{-1})^3 g_{0,j,n}(t), \end{aligned}$$

where $|g_{0,j,n}(t)| \leq 1$ for all $1 \leq j \leq k$. By the uniform boundedness of the error term, we have

$$\begin{aligned} \log \phi_{(E_j-1)}(t f(j) j^{-1} \sigma_n(f)^{-1}) &= \\ \frac{1}{2} (t f(j) j^{-1} \sigma_n(f)^{-1})^2 &+ (t f(j) j^{-1} \sigma_n(f)^{-1})^3 g_{0,j,n}(t) \end{aligned}$$

$$+(t f(j)j^{-1} \sigma_n(f))^{-1})^3 g_{1,j,n}(t),$$

where, always $|g_{1,j,n}(t)| \leq 1$ for all $1 \leq j \leq k$. Finally

$$\begin{aligned} \phi_{V_n^*(f)}(t) &= \exp\left(\sum_{j=1}^k \log \phi_{(E_j-1)}(t f(j)j^{-1} \sigma_n(f))^{-1}\right) \\ &= \exp(t^2/2 + g_{2,j,n}(t) \times t^3 \sigma_n(f)^{-3} \sum_{j=1}^k f(j)^3 j^{-3}), \end{aligned}$$

with $|g_{1,j,n}(t)| \leq 2$ for all $1 \leq j \leq k$. Since

$$0 \leq \sigma_n(f)^{-3} \sum_{j=1}^k f(j)^3 j^{-3} \leq B(n, f) \times \sigma_n(f)^{-2} \sum_{j=1}^k f(j)^2 j^{-2} = B(n, f) \rightarrow 0.$$

Hence

$$\phi_{V_n^*(f)}(t) \rightarrow \exp(t^2/2)$$

and

$$V_n^*(f) \rightarrow \mathcal{N}(0, 1).$$

□

Lemma 2. Let $(a, b) \in \mathbb{R}^2$ and suppose that for any couple $(f_1, f_2) \in \mathcal{F}_h^2$, $h = 1, 2$,

$$\lim_{n \rightarrow \infty} \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2} = \Gamma(f_1, f_2) \text{ exists.}$$

Then for $h = 1$, $aV_n^*(f_1) + bV_n^*(f_2)$ weakly converges to

$$a\mathcal{L}(f_1) + b\mathcal{L}(f_2).$$

and for $h=2$, $aV_n^*(f_1) + bV_n^*(f_2)$ weakly converges to a normal random of variance :

$$v(a, b, f_1, f_2) = a^2 + b^2 + 2ab\Gamma_1(f_1, f_2).$$

In both cases, the finite-distributions of $\{V_n^*(f), f \in \mathcal{F}_h\}$ weakly converge to those of the process \mathcal{L} for $h = 1$ and, for $h = 2$, to those of a Gaussian process of covariance function

$$\Gamma(f_1, f_2) = \lim_{n \rightarrow \infty} \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2}$$

provided these numbers are finite.

Proof. The case $h = 1$ is straightforward. For $h = 2$, we slightly change the proof of the previous lemma from (6.2). Put $V_n(a, b, f_1, f_2) = aV_n^*(f_1) + bV_n^*(f_2)$ and

$$c(n, j) = \sigma_n(f_1)^{-1} a f_1(j) j^{-1} + \sigma_n(f_2)^{-1} b f_2(j) j^{-1}.$$

We alway have, for $(f_1, f_2) \in \mathcal{F}_2^2$,

$$\sup_j |c(n, j)| \rightarrow 0$$

and

$$\begin{aligned} \sum_{j=1}^k c(n, j)^2 &= a^2 + b^2 + 2ab \frac{1}{\sigma_n(f_1)\sigma_n(f_2)} \sum_{j=1}^k f_1(j)f_2(j)j^{-2} \\ &\rightarrow v(a, b, f_1, f_2) = a^2 + b^2 + 2ab\Gamma(f_1, f_2). \end{aligned}$$

By using the same arguments in (6.2) and (6.4), we have

$$\begin{aligned}\phi_{V_n(a,b,f_1,f_2)}(t) &= \exp\left(\sum_{j=1}^k \log \psi_{(E_j-1)}(t c(n,j))\right) \\ &= \exp\left(\left\{\sum_{j=1}^k c(n,j)^2\right\} t^2/2 + g_{3,j,n}(t) \times t^3\left(\sum_{j=1}^k c(n,j)^3\right)\right),\end{aligned}$$

with $|g_{3,j,n}(t)| \leq 2$ for all $1 \leq j \leq k$. Since

$$0 \leq \sum_{j=1}^k c(n,j)^3 \leq \{aB(n, f_1) + bB(n, f_2)\} \times \sum_{j=1}^k c(n,j)^2 \rightarrow 0,$$

we get

$$\phi_{V_n(a,b,f_1,f_2)}(t) \rightarrow \exp(v(a, b, f_1, f_2)t^2/2).$$

This achieves the proof. Now, these methods are reproducible for any finite linear combination

$$a_1 V_n^*(f_1) + a_2 V_n^*(f_2) + \dots + a_m V_n^*(f_m).$$

In all cases, we find the same finite distribution laws. For $h = 1$, $(V_n^*(f_1), \dots, V_n(f_m))$ converges in law to $(\mathcal{L}(f_1), \dots, \mathcal{L}(f_m))$ and for $h = 2$, $(V_n^*(f_1), \dots, V_n^*(f_m))$ converges to a Gaussian vector of variance-covariance matrix $(\Gamma(f_i, f_j), 1 \leq i, j \leq m)$ provided these numbers are finite. \square

7. APPENDIX

7.1. Check hypothesis (L4) for $\tau > 1/2$. We shall consider $\mathcal{F}_2(a, b)$ as a normed vector by identifying $f_\tau(j) = j^\tau$ with τ and setting $f_{\tau_1} + f_{\tau_2} = f_{\tau_1+\tau_2}$ and $f_{\tau_1} \leq f_{\tau_2}$ iff $\tau_1 \leq \tau_2$. We put without lost of generality that $b - a = 1$ and that $\varepsilon^2 = 1/p$. Next we devide $\mathcal{F}_2(a, b)$ into p intervals $[0, \tau_1[, [\tau_1, \tau_2[, \dots, [\tau_{p-1}, \tau_p]$. Now, put

$$\sigma_n^2(1, \tau) = k^{-2\tau+1} \sigma_n^2(f_\tau)$$

and consider $\tau_i < \nu < \tau < \tau_{i+1}$ and let $i = 1$ for short, $\tau - \nu = \delta$ and

$$\begin{aligned}(7.1) \quad d_n^2(f_\nu, f_\tau, j) &= (f_\nu(j)/\sigma_n(f_\nu) - f_\tau(j)/\sigma_n(f_\tau))^2 j^{-2} (E_j - 1)^2 \\ &\quad \left\{ \frac{k^{-2\nu+1}}{\sigma_n^2(1, \nu)} j^{2\nu-2} + \frac{k^{-2\tau+1}}{\sigma_n^2(1, \nu)} j^{2\tau-2} - 2 \frac{k^{-\nu-\tau+1}}{\sigma_n(1, \nu) \sigma_n(1, \tau)} j^{\tau+\nu-2} \right\} (E_j - 1)^2 \\ &= \{T_0(n, \tau, j) + T_0(n, \nu, j) - 2T_1(n, \nu, \tau)\} (E_j - 1)^2.\end{aligned}$$

Let us handle $T_0(n, \tau, j)$. By adding to it this null term

$$\begin{aligned}0 &= \{-\sigma_n^{-2}(1, \nu) k^{-2\tau+1} j^{2\tau-2} - \sigma_n^{-2}(1, \nu) k^{-2\tau+1} j^{2\tau-2}\} \\ &\quad + \{-\sigma_n^{-2}(1, \nu) k^{-2\nu+1} j^{2\nu-2} + -\sigma_n^{-2}(1, \nu) k^{-2\nu+1} j^{2\nu-2}\},\end{aligned}$$

we get

$$(7.2) \quad T_0(n, \tau, j) = \left(\frac{1}{\sigma_n^2(1, \tau)} - \frac{1}{\sigma_n^2(1, \nu)}\right) k^{-2\tau+1} j^{2\tau-2}$$

$$(7.3) \quad + \frac{k^{-2\nu+1}}{\sigma_n^2(1, \nu)} j^{2\nu-2} (1 - (j/k)^{2\delta}) + \frac{k^{-2\nu+1}}{\sigma_n^2(1, \nu)} j^{2\nu-2},$$

where we used in the previous line (7.2) the following identity

$$(7.4) \quad k^{-2\tau+1}j^{2\tau-2} = k^{-2\nu+1}j^{2\nu-2} + k^{-2\nu+1}j^{2\nu-2}(1 - (j/k)^{2\delta}).$$

Using again (7.4) in (7.2), we arrive at

$$(7.5) \quad \begin{aligned} T_0(n, \tau, j) &= T_0(n, \nu, j) + \left(\frac{1}{\sigma_n^2(1, \tau)} - \frac{1}{\sigma_n^2(1, \nu)}\right)k^{-2\nu+1}j^{2\nu-2} \\ &\quad + \left(\frac{1}{\sigma_n^2(1, \tau)} - \frac{1}{\sigma_n^2(1, \nu)}\right)k^{-2\nu+1}j^{2\nu-2}(1 - (j/k)^{2\delta}) + \frac{k^{-2\nu+1}}{\sigma_n^2(1, \nu)}j^{2\nu-2}(1 - (j/k)^{2\delta}). \end{aligned}$$

We use the same techniques to also get

$$(7.6) \quad \begin{aligned} T_1(n, \nu, \tau) &= T_0(n, \nu, j) + \left(\frac{1}{\sigma_n(1, \tau)\sigma_n(1, \nu)} - \frac{1}{\sigma_n^2(1, \nu)}\right)k^{-2\nu+1}j^{2\nu-2} \\ &\quad + \left(\frac{1}{\sigma_n(1, \tau)\sigma_n(1, \nu)} - \frac{1}{\sigma_n^2(1, \nu)}\right)k^{-2\nu+1}j^{2\nu-2}(1 - (j/k)^\delta) + \frac{k^{-2\nu+1}}{\sigma_n^2(1, \nu)}j^{2\nu-2}(1 - (j/k)^\delta) \end{aligned}$$

Let us handle the $\sigma_n^{-2}(1, \tau) - \sigma_n^{-2}(1, \nu)$ in (7.1). We get, by using the same methods,

$$\sigma_n^{-2}(1, \tau) - \sigma_n^{-2}(1, \nu) = \sigma_n^{-2}(1, \tau)\sigma_n^{-2}(1, \nu)k^{-2\nu+1} \sum_{j=1}^k j^{2\nu-2}(1 - (j/k)^{2\delta}).$$

We already noticed that $\sigma_n^2(1, \tau) \rightarrow (2\tau - 1)^{-1} \in [B = (2b - 1)^{-1}, A = (2a - 1)^{-1}]$ uniformly in $\tau \in [a, b]$ by a continuity convergence argument. For ε chosen such that $2a - 1 - 2\varepsilon > 0$, we get

$$\begin{aligned} k^{-2\nu+1} \sum_{j=1}^k j^{2\nu-2}(1 - (j/k)^{2\delta}) &\leq \sum_{j=1}^k j^{-1}(j/k)^{2a-1}(1 - (j/k)^{2\varepsilon^2}) \\ &= k^{2a-1} \sum_{j=1}^k j^{2a-2} - k^{2\varepsilon^2} j^{2a-2+2\varepsilon^2}. \end{aligned}$$

By using the asymptotic approximations to the corresponding integrals, we get, as $n \rightarrow \infty$,

$$\begin{aligned} &k^{2a-1} \sum_{j=1}^k j^{2a-2} - k^{2\varepsilon^2} j^{2a-2+2\varepsilon^2} \\ &= k^{-2a+1} K \left\{ (1 + o(1)) \frac{k^{2a-1} - 1}{2a - 1} \right\} - (1 + o(1)) k^{-2\varepsilon^2} \frac{k^{2a-1+2\varepsilon^2}}{2a - 1 + 2\varepsilon^2} \\ &\rightarrow \{(2a - 1)^{-1} - (2a - 1 + 2\varepsilon^2)^{-1}\} \leq (2\varepsilon^2)/(2a - 1)^2. \end{aligned}$$

We conclude that, for large value of n ,

$$(7.7) \quad k^{-2\nu+1} \sum_{j=1}^k j^{2\nu-2}(1 - (j/k)^{2\delta}) \leq K\varepsilon^2$$

and hence

$$|\sigma_n^{-2}(1, \tau) - \sigma_n^{-2}| \leq K\varepsilon^2,$$

for some positive universal constant K . This constant is generic and may change from line to line. In the same spirit, we have, for this term in (7.1),

$$\begin{aligned} \{\sigma_n(1, \tau)\sigma_n(1, \nu)\}^{-1} - \sigma_n^{-2}(1, \nu) &= \sigma_n(1, \nu)^{-1}\sigma_n(1, \tau)^{-1} - \sigma_n^{-1}(1, \nu) \\ &= -\frac{\sigma_n^{-2}(1, \tau) - \sigma_n^{-2}(1, \nu)}{\sigma_n(1, \nu)^2\sigma_n(1, \tau)(\sigma_n(1, \tau) + \sigma_n(1, \nu))}. \end{aligned}$$

The methods used above lead to

$$(7.8) \quad \left| \{\sigma_n(1, \tau)\sigma_n(1, \nu)\}^{-1} - \sigma_n^{-2}(1, \nu) \right| \leq K\varepsilon^2.$$

Now returning to Formulae (7.1), (7.2) and (7.1), we see that the terms $T_0(n, \nu, j)$ disappears as $T_0(n, \nu, j) - 2T_0(n, \nu, j) + T_0(n, \nu, j) = 0$. Computing the expectation of the remainder terms, we get

$$\begin{aligned} Ed_n^2(f_\nu, f_\tau, j) &\leq 2 \left| \frac{1}{\sigma_n^2(1, \tau)} - \frac{1}{\sigma_n^2(1, \nu)} \right| j^{-1}(j/k)^{2a-1} \\ &+ 2 \left| \frac{1}{\sigma_n(1, \tau)\sigma_n(1, \nu)} - \frac{1}{\sigma_n^2(1, \nu)} \right| j^{-1}(j/k)^{2a-1} + 2j^{-1}(j/k)^{2a-1}(1 - (j/k)^{2\delta}). \end{aligned}$$

The left-member does not depend on $(\nu, \tau) \in [\tau_{i-1}, \tau_i]$ so that, with the application (7.7) and (7.8), we obtain

$$\max_{(\nu, \tau) \in [\tau_{i-1}, \tau_i]} d_n^2(f_\nu, f_\tau, j) \leq K \left\{ (j/k)^{2a-1}\varepsilon^2 + 2j^{-1}(j/k)^{2a-1}(1 - (j/k)^{2\varepsilon^2}) \right\} (E_j - 1)^2.$$

Finally, by (7.7),

$$\sum_{j=1}^k \mathbb{E} \sup_{(\nu, \tau) \in [\tau_{i-1}, \tau_i]} d_n^2(f_\nu, f_\tau, j) \leq K\varepsilon^2,$$

for large values of n . Then

$$\log N_{[]}(\varepsilon, \mathcal{F}_h, L_2^n) \leq p \leq K\varepsilon^{-2}.$$

And this ensures (L4) of Theorem 4.

7.2. Continuous convergence. In order to prove (5.2), suppose for each $N > 0$, there exists a value $n \geq N$ and a couple (f_1, f_2) such that

$$(H) \quad \rho_n^2(f_1, f_2) < (1 - \Gamma(f_1, f_2))$$

We may lessen the notations and put $\rho_n^2(f_1, f_2) = \rho_n^2(\tau_1, \tau_2)$ for $f_1(j) = j^{\tau_1}$ and $f_2(j) = j^{\tau_2} \in (a, b)^2$. It is easy to prove that

$$\rho_n^2(\tau_1, \tau_2) \rightarrow 2(1 - \Gamma(\tau_1, \tau_2)),$$

continuously, that is,

$$\rho_n^2(\tau_{1,n}, \tau_{2,n}) \rightarrow 2(1 - \Gamma(\tau_1, \tau_2)).$$

if $(\tau_{1,n}, \tau_{2,n}) \rightarrow (\tau_1, \tau_2)$, as $n \rightarrow +\infty$. But, with our hypothesis (H), we can find a sequence of integers $n_1 < n_2 < \dots < n_k < n_{k+1} < \dots$ such that and a sequence of couples $(\tau_{1,n_k}, \tau_{2,n_k}) \in (a, b)^2$, $k = 1, 2, \dots$ such that for any k ,

$$(H1) \quad \rho_n^2(\tau_{1,n_k}, \tau_{2,n_k}) < (1 - \Gamma(\tau_{1,n_k}, \tau_{2,n_k})).$$

By the Bolzano-Weierstrass Theorem, we may extract from $(\tau_{1,n_k}, \tau_{2,n_k})$ a subsequence, denoted $(\tau_{1,n_k^*}, \tau_{2,n_k^*})$ converging to some $(\tau_1, \tau_2) \in (a, b)^2$ and by the continuity result

$$\rho_{n^*}^2(\tau_{1,n_k^*}, \tau_{2,n_k^*}) \rightarrow 2(1 - \Gamma(\tau_1, \tau_2)).$$

This violates (H1) and then proves (5.2).
