# ENTROPY AND EXACT DEVANEY CHAOS ON TOTALLY REGULAR CONTINUA 

VLADIMÍR ŠPITALSKÝ


#### Abstract

We study topological entropy of exactly Devaney chaotic maps on totally regular continua, i.e. on (topologically) rectifiable curves. After introducing the so-called $P$-Lipschitz maps (where $P$ is a finite invariant set) we give an upper bound for their topological entropy. We prove that if a non-degenerate totally regular continuum $X$ contains a free arc which does not disconnect $X$ or if $X$ contains arbitrarily large generalized stars then $X$ admits an exactly Devaney chaotic map with arbitrarily small entropy. A possible application for further study of the best lower bounds of topological entropies of transitive/Devaney chaotic maps is indicated.


## 1. Introduction

A (discrete) dynamical system is a pair $(X, f)$ where $X$ is a compact metric space and $f: X \rightarrow X$ is a continuous map. For $n \in \mathbb{N}$ we denote the composition $f \circ f \circ \cdots \circ f\left(n\right.$-times) by $f^{n}$. A point $x \in X$ is a periodic point of $f$ if $f^{n}(x)=x$ for some $n \in \mathbb{N}$. We say that a dynamical system $(X, f)$ is (topologically) transitive if for every nonempty open sets $U, V \subseteq X$ there is $n \in \mathbb{N}$ such that $f^{n}(U) \cap V \neq \emptyset$. If every iterate $f^{n}(n \geq 1)$ is transitive we say that $f$ is totally transitive. If $(X \times X, f \times f)$ is transitive then $(X, f)$ is called (topologically) weakly mixing. A system $(X, f)$ is (topologically) mixing provided for every nonempty open sets $U, V \subseteq X$ there is $n_{0} \in \mathbb{N}$ such that $f^{n}(U) \cap V \neq \emptyset$ for every $n \geq n_{0}$. Further, $(X, f)$ is (topologically) exact or locally eventually onto if for every nonempty open subset $U$ of $X$ there is $n \in \mathbb{N}$ such that $f^{n}(U)=X$. Finally, a system $(X, f)$ is Devaney chaotic (totally Devaney chaotic, exactly Devaney chaotic) provided $X$ is infinite, $f$ is transitive (totally transitive, exact, respectively) and has dense set of periodic points.

One of the main quantitative characteristics of a dynamical system $(X, f)$ is the topological entropy, denoted by $h(f)$. A challenging topic in discrete dynamics is the study of relationships between entropy and qualitative properties of dynamical systems, such as transitivity, exactness and (exact) Devaney chaos. This goes back to 1982 when Blokh in [8 showed that every transitive map on the unit interval $[0,1]$ has entropy at least $(1 / 2) \log 2$ and that this is the best possible

[^0]bound, i.e. $I^{\mathrm{T}}([0,1])=(1 / 2) \log 2$, where

I^{\mathrm{T}}(X)=\inf \{h(f): \quad f: X \rightarrow X \text { is transitive }\}
$$

Moreover, this infimum is in fact the minimum, i.e. the infimum is attainable.
Instead of $I^{\mathrm{T}}(X)$ one can study infima/minima of entropies of more restrictive classes of dynamical systems on $X$. Denote by $I^{\mathrm{D}}(X)$ and $I^{\mathrm{ED}}(X)$ the infima of entropies of Devaney chaotic and exactly Devaney chaotic systems on $X$, respectively. We see at once that $I^{\mathrm{T}}(X) \leq I^{\mathrm{D}}(X) \leq I^{\mathrm{ED}}(X)$. For (connected) graphs, these infima and the existence of corresponding minima were studied e.g. in [10, 2, 1, 4, 3, 30, 5, 27, 22, 18; see Table 1 for some of the results. (For the definition of classes $\mathcal{P}(i)$ of trees see [30].) Every transitive graph map which is not conjugate to an irrational rotation of the circle has dense periodic points [9, so $I^{\mathrm{D}}(X)=I^{\mathrm{T}}(X)$ whenever $X$ is a graph. Notice also that any exact map on a non-degenerate space $X$ has positive entropy, see e.g. [22; hence the infimum is never attained if $I^{\mathrm{ED}}(X)=0$.

In the present paper we study $I^{\mathrm{ED}}(X)$ for totally regular continua $X$. Recall that a continuum is a connected compact metric space. A continuum $X$ is totally regular [26] if for every point $x \in X$ and every countable set $P \subseteq X$ there is a basis of neighborhoods of $x$ with finite boundary not intersecting $P$. Equivalently one can define totally regular continua as those continua $X$ which admit a compatible metric $d$ such that $(X, d)$ is a rectifiable curve (i.e. $(X, d)$ has finite one-dimensional Hausdorff measure $\mathcal{H}_{d}^{1}(X)$ ). Every graph and even every local dendrite (a locally connected continuum containing only finitely many simple closed curves) is totally regular. As another example one can mention the Hawaiian earrings (an infinite wedge of circles), which is a totally regular continuum but not a local dendrite.

Recall that an arc is a homeomorphic image of $[0,1]$. A free arc in $X$ is an arc $A \subseteq X$ such that every non-end point of $A$ is an interior point of $A$ (in the topology of $X$ ). We say that a free arc $A \subseteq X$ does not disconnect $X$ if no non-end point of $A$ disconnects $X$; for locally connected continua (hence also for totally regular ones) this is equivalent to the fact that $A$ is a subset of a simple closed curve in $X$, see e.g. [29, IV.9.3]. We say that $X$ contains arbitrarily large generalized stars if for any $k \in \mathbb{N}$ there are a point $a \in X$ and $k$ components of $X \backslash\{a\}$ such that the closures of the components are homeomorphic relative to $a$ (i.e. the corresponding homeomorphisms fix the point $a$ ).

In [28] we introduced the so-called length-expanding Lipschitz maps (briefly LELmaps) and we showed that for every two non-degenerate totally regular continua $X, Y$ there exists a LEL-map $f: X \rightarrow Y$; see Section 2.6 for details. LEL-maps form "building blocks" in our constructions of exactly Devaney chaotic systems with small entropy. Our main results are summarized in the following theorem.

Main Theorem. For every non-degenerate totally regular continuum $X$ it holds that $I^{\mathrm{ED}}(X)<\infty$. Moreover, if $X$ contains arbitrarily large generalized stars or $X$ contains a free arc which does not disconnect $X$, then $X$ admits

- a Devaney chaotic map which is not totally Devaney chaotic, and
- an exactly Devaney chaotic map,
both with arbitrarily small positive entropy; hence $I^{\mathrm{ED}}(X)=0$.
Thus, in particular, $I^{\mathrm{ED}}(X)$ and hence also $I^{\mathrm{D}}(X)$ and $I^{\mathrm{T}}(X)$ are zero for many dendrites, e.g. for the $\omega$-star or the Wazewski's universal dendrite. Still, the following general question is open.

Question (Baldwin [5]). Is it true that $I^{\mathrm{T}}(X)=0$ for every dendrite $X$ which is not a tree?

Our result gives $I^{\mathrm{ED}}(X)=0$ also for many spaces $X$ which are not dendrites, say for the Hawaiian earrings. Since every graph which is not a tree contains a free non-disconnecting arc, Main Theorem is a generalization of 4, Theorems 3.7 and 4.1], cf. the last row of Table (1) Let us note that $I^{\mathrm{ED}}(X)=0$ is true also for other subclasses of the class of totally regular continua, see e.g. Lemma 18 and Remark 19. We even believe that the following conjecture is true.
Conjecture. $I^{\mathrm{ED}}(X)=0$ for every totally regular continuum $X$ which is not $a$ tree.

A potential application of our results lies in the fact that the estimates of $I^{\mathrm{T}}(X)$, $I^{\mathrm{D}}(X)$ and $I^{\mathrm{ED}}(X)$ for one-dimensional continua can be used to estimate the corresponding quantities for some higher-dimensional continua. To do that, one needs two tools. The first one is an appropriate extension theorem. For instance, in [2] and [20] it was proved that a transitive map $f: X \rightarrow X$ on a compact metric space $X$ without isolated points can be extended to a transitive map $F$ on $X \times[0,1]$ without increasing the entropy. An analogous result is true for Devaney chaotic maps [6. The second tool are procedures enabling to go from $X \times[0,1]$ to the cone or the suspension over $X$, or to the space $X \times \mathbb{S}^{1}$, similarly as in [6]. However, it is not the topic of the present paper to continue in this direction.

Finally let us notice that the study of infima of entropies of transitive/Devaney chaotic maps on a given space is naturally connected with the question whether the space admits a zero entropy transitive/Devaney chaotic map. Using techniques developed in [6] one can easily construct a Devaney chaotic map on the Cantor fan (the cone over the Cantor set) which has zero entropy. On the other hand, if $X$ is a compact metric space containing a free arc and $X$ is not a union of finitely many disjoint circles, then every transitive map on $X$ has positive entropy [14. However, the following question is still open.

Question (Baldwin [5). Is there a dendrite admitting a transitive map with zero entropy?

The paper is organized as follows. In Section 2 we recall all the needed definitions and facts. In Section 3 we introduce the so-called $P$-Lipschitz maps and we give an upper bound for their topological entropy. Finally, in Section 4 we prove Main Theorem.

## 2. Preliminaries

Here we briefly recall all the notions and results which will be needed in the rest of the paper. The terminology is taken mainly from [21, 25, 23, 15 .

If $M$ is a set, its cardinality is denoted by $\# M$. The cardinality of infinite countable sets is denoted by $\aleph_{0}$. If $M$ is a singleton set we often identify it with its only point. We write $\mathbb{N}$ for the set of positive integers $\{1,2,3, \ldots\}, \mathbb{R}$ for the set of reals and $I$ for the unit interval $[0,1]$. By an interval we mean any nonempty connected subset of $\mathbb{R}$ (possibly degenerate to a point). For intervals $J, J^{\prime}$ we write $J \leq J^{\prime}$ if $t \leq s$ for every $t \in J, s \in J^{\prime}$.

By a space we mean any nonempty metric space. A space is called degenerate provided it has only one point; otherwise it is called non-degenerate. If $E$ is a subset of a space $X=(X, d)$ we denote the closure, the interior and the boundary of $E$ by $\bar{E}, \operatorname{int}(E)$ and $\partial E$, respectively, and we write $d(E)$ for the diameter of $E$. We say that two sets $E, F \subseteq X$ are non-overlapping if they have disjoint interiors. For $x \in X$ and $r>0$ we denote the closed ball with the center $x$ and radius $r$ by $B(x, r)$.

Let $(X, f)$ be a dynamical system. A set $A \subseteq X$ is called $f$-invariant if $f(A) \subseteq A$. For the definitions of (total) transitivity, (weak, strong) mixing, exactness and (exact) Devaney chaos see Section 1
2.1. Minkowski dimension and topological entropy. A subset $S$ of a metric space $(X, d)$ is called $\varepsilon$-separated if $d(x, y)>\varepsilon$ for every points $x \neq y$ from $S$. A subset $R$ of $X$ is said to $\varepsilon$-span $X$ if for every $x \in X$ there is $y \in R$ with $d(x, y) \leq \varepsilon$. We will denote by $s(X, \varepsilon)$ and $r(X, \varepsilon)$ the maximal cardinality of $\varepsilon$-separated set and the minimal cardinality of $\varepsilon$-spanning set, respectively. We see at once that $r(X, \varepsilon) \leq s(X, \varepsilon) \leq r(X, \varepsilon / 2)$. The upper and lower Minkowski (ball) dimensions of $X$ are defined by (see e.g [24, 5.3] or [19, Definition 3.2.7])

\overline{\operatorname{dim}}(X)=\limsup _{\varepsilon \rightarrow 0} \frac{\log r(X, \varepsilon)}{-\log \varepsilon} \quad \text { and } \quad \underline{\operatorname{dim}}(X)=\liminf _{\varepsilon \rightarrow 0} \frac{\log r(X, \varepsilon)}{-\log \varepsilon}

Let $(X, f)$ be a dynamical system. For $n \in \mathbb{N}$ define a metric $d_{n}$ on $X$ by $d_{n}(x, y)=\max _{0 \leq i<n} d\left(f^{i}(x), f^{i}(y)\right)$. We say that a set $S \subseteq X$ is $(n, \varepsilon)$-separated if it is an $\varepsilon$-separated subset of $\left(X, d_{n}\right)$, i.e. if for every distinct $x, y \in S$ there is $i<n$ with $d\left(f^{i}(x), f^{i}(y)\right)>\varepsilon$. A set $R \subseteq X$ is said to $(n, \varepsilon)$-span $X$ if it $\varepsilon$-spans $\left(X, d_{n}\right)$. Let $s_{n}(X, \varepsilon, f)$ and $r_{n}(X, \varepsilon, f)$ denote the maximal cardinality of $(n, \varepsilon)$-separated subsets and the minimal cardinality of $(n, \varepsilon)$-spanning subsets of $X$, respectively. Then, by [11] and [13], the topological entropy $h(f)$ of the system $(X, f)$ is given by

h(f)=\lim _{\varepsilon \rightarrow 0} \limsup _{n \rightarrow \infty} \frac{1}{n} \log r_{n}(X, \varepsilon, f)=\lim _{\varepsilon \rightarrow 0} \limsup _{n \rightarrow \infty} \frac{1}{n} \log s_{n}(X, \varepsilon, f) . \tag{2.1}
\end{equation*}
$$

2.2. Continua. A continuum is a connected compact metric space. A cut point (or a separating point) of a continuum $X$ is any point $x \in X$ such that $X \backslash\{x\}$ is disconnected. A point $x$ of a continuum $X$ is called a local separating point of $X$ if there is a connected neighborhood $U$ of $x$ such that $U \backslash\{x\}$ is not connected.

If $a, b$ are points of $X$ then any cut point of $X$ such that $a, b$ belong to different components of $X \backslash\{x\}$ is said to separate $a, b$. The set of all such points is denoted by $\operatorname{Cut}(a, b)$ or $\operatorname{Cut}_{X}(a, b)$. If $a=b$ then obviously $\operatorname{Cut}(a, b)=\emptyset$.

Let $X$ be a continuum. A metric $d$ on $X$ is said to be convex provided for every distinct $x, y \in X$ there is $z \in X$ such that $d(x, z)=d(z, y)=d(x, y) / 2$. By [7, Theorem 8] every locally connected continuum admits a compatible convex metric.

If $X$ is a continuum, we introduce the following notion. A splitting of $X$ is any system $\mathcal{A}=\left\{X_{1}, \ldots, X_{n}\right\}$ of non-degenerate subcontinua covering $X$ such that $P_{\mathcal{A}}=\bigcup_{i \neq j} X_{i} \cap X_{j}$ is finite. In a splitting $\mathcal{A}$, every $X_{i} \in \mathcal{A}$ is regular closed (i.e. $X_{i}$ is closed and $\operatorname{int}\left(X_{i}\right)$ is dense in it $), \operatorname{int}\left(X_{i}\right)=X_{i} \backslash\left(\bigcup_{j \neq i} X_{j}\right) \supseteq X_{i} \backslash P_{\mathcal{A}}$ and $\partial X_{i} \subseteq P_{\mathcal{A}}$.

Lemma 1. Let $X$ be a continuum and $\mathcal{A}=\left\{X_{1}, \ldots, X_{n}\right\}$ be a splitting of $X$. For $i=1, \ldots, n$ let $d_{i}$ be a convex metric on $X_{i}$ satisfying $d_{i}(x, y)=d_{j}(x, y)$ whenever $i \neq j$ and $x, y \in X_{i} \cap X_{j}$. For $x, y \in X$ put

d(x, y)=\inf \left\{\sum_{k=1}^{m} d_{i_{k}}\left(x_{k-1}, x_{k}\right): m \geq 1, x_{0}=x, x_{m}=y\right.  \tag{2.2}\\
\text { and } \left.x_{k-1}, x_{k} \in X_{i_{k}} \text { for } k=1, \ldots, m\right\}
\end{gather*}
$$

Then $d$ is a convex metric on $X$ equivalent with the original one and the infimum in (2.2) is in fact the minimum. Moreover, if $d(x, y)=d_{i}(x, y)$ whenever $x, y \in$ $P_{\mathcal{A}} \cap X_{i}$, then

\left.d\right|_{X_{i} \times X_{i}}=d_{i}
$$

Proof. Using convexity of every $d_{i}$ we may assume that, in the infimum from (2.2), $i_{k} \neq i_{k+1}, x_{k} \in P_{\mathcal{A}}$ for $1 \leq k<m$ and $x_{k} \neq x_{l}$ for every $k \neq l$. Since $P_{\mathcal{A}}$ is finite we have that, for any fixed $x, y$, the infimum is in fact the minimum and there are $m \geq 1, i_{1}, \ldots, i_{m}, x_{0}=x, x_{1}, \ldots, x_{m}=y$ such that $x_{0}, \ldots, x_{m}$ are pairwise distinct, $x_{0} \in X_{i_{1}}, x_{m} \in X_{i_{m}}$,

d(x, y)=\sum_{k=1}^{m} d_{i_{k}}\left(x_{k-1}, x_{k}\right) \quad \text { and } \quad x_{k} \in X_{i_{k}} \cap X_{i_{k+1}} \cap P_{\mathcal{A}} \quad \text { for } 1 \leq k<m \tag{2.3}
\end{equation*}

The fact that $d$ is a convex pseudometric is straightforward and, by (2.3), $d(x, y)=0$ implies $x=y$. To show that $d$ is equivalent with the original metric, fix a sequence $\left(x_{k}\right)_{k}$ and a point $x$; since $X$ is compact we only need to prove that $x_{k} \rightarrow x$ implies $d\left(x_{k}, x\right) \rightarrow 0$. It is no loss of generality in assuming that, for some $i, x_{k} \in X_{i}$ for every $k$. Since $x_{k} \rightarrow x$, also $x \in X_{i}$ and $d\left(x_{k}, x\right) \leq d_{i}\left(x_{k}, x\right) \rightarrow 0$.

Now fix $i$ and assume that $d(x, y)=d_{i}(x, y)$ for every $x, y \in P_{\mathcal{A}} \cap X_{i}$. Take arbitrary $x, y \in X_{i}$. Then $d(x, y) \leq d_{i}(x, y)$ by (2.2). To show the opposite inequality take $i_{1}, \ldots, i_{m}$ and $x_{0}=x, x_{1}, \ldots, x_{m}=y$ satisfying (2.3); we can assume that $i_{1}=i_{m}=i$ (so possibly $x_{0}=x_{1}$ or $x_{m-1}=x_{m}$ ). Since $x_{1}, x_{m-1} \in P_{\mathcal{A}} \cap X_{i}$, we get $d\left(x_{1}, x_{m-1}\right)=d_{i}\left(x_{1}, x_{m-1}\right)$ and

d_{i}(x, y) \leq d_{i}\left(x, x_{1}\right)+d_{i}\left(x_{1}, x_{m-1}\right)+d_{i}\left(x_{m-1}, y\right) \leq \sum_{k=1}^{m} d_{i_{k}}\left(x_{k-1}, x_{k}\right)=d(x, y)
$$

Thus $d(x, y)=d_{i}(x, y)$ for every $x, y \in X_{i}$.
2.3. Hausdorff one-dimensional measure. For a Borel subset $B$ of a metric space $(X, d)$ the one-dimensional Hausdorff measure of $B$ is defined by

\mathcal{H}_{d}^{1}(B)=\lim _{\delta \rightarrow 0} \mathcal{H}_{d, \delta}^{1}(B), \quad \mathcal{H}_{d, \delta}^{1}(B)=\inf \left\{\sum_{i=1}^{\infty} d\left(E_{i}\right): \quad B \subseteq \bigcup_{i=1}^{\infty} E_{i}, d\left(E_{i}\right)<\delta\right\}
$$

We say that $(X, d)$ has finite length if $\mathcal{H}_{d}^{1}(X)<\infty$. By e.g. [17, Proposition 4A],

\mathcal{H}_{d}^{1}(C) \geq d(C) \quad \text { whenever } C \text { is a connected Borel subset of } X \tag{2.4}
\end{equation*}
$$

If $A \subseteq X$ is an arc then $\mathcal{H}_{d}^{1}(A)$ is equal to the length of $A$ [15, Lemma 3.2]. In the case when $(X, d)$ is the Euclidean real line $\mathbb{R}$ and $J \subset \mathbb{R}$ is an interval, $\mathcal{H}_{d}^{1}(J)$ is equal to the length of $J$ and we denote it simply by $|J|$.

If $(X, d)$ is a continuum of finite length endowed with a convex metric $d$, then it has the so-called geodesic property (see e.g. [17, Corollary 4E]): for every distinct $x, y \in X$ there is an $\operatorname{arc} A$ with end points $x, y$ such that $d(x, y)=\mathcal{H}_{d}^{1}(A)$; any such arc $A$ is called a geodesic arc or shortly a geodesic. Every subarc of a geodesic is again a geodesic. If $x, y$ are the end points of a geodesic $A$ and $z \in A$ then $d(x, y)=d(x, z)+d(z, y)$.
2.4. Lipschitz maps. A map $f:(X, d) \rightarrow(Y, \varrho)$ between metric spaces is called Lipschitz with a Lipschitz constant $L \geq 0$, shortly Lipschitz-L, provided $\varrho\left(f(x), f\left(x^{\prime}\right)\right) \leq L \cdot d\left(x, x^{\prime}\right)$ for every $x, x^{\prime} \in X$; the smallest such $L$ is denoted by $\operatorname{Lip}(f)$ and is called the Lipschitz constant of $f$. If $f: X \rightarrow Y$ is Lipschitz- $L$ then $\mathcal{H}_{\varrho}^{1}(f(B)) \leq L \cdot \mathcal{H}_{d}^{1}(B)$ for every Borel set $B \subset X$ such that $f(B)$ is Borelmeasurable [15, p. 10]. We will use the following simple fact.

Lemma 2. Let $X$ be a continuum with a convex metric d and let $\mathcal{A}=\left\{X_{1}, \ldots, X_{n}\right\}$ be a splitting of $X$. Let $(Y, \varrho)$ be a metric space. Then any map $f:(X, d) \rightarrow(Y, \varrho)$ with Lipschitz-L restrictions $\left.f\right|_{X_{i}}(i=1, \ldots, n)$ is Lipschitz-L.
Proof. By Lemma 11 for any $x, y \in X$ there are $x_{0}=x, x_{1}, \ldots, x_{m-1}, x_{m}=y$ such that $x_{k-1}, x_{k} \in X_{i_{k}}(k=1, \ldots, m)$ and $d(x, y)=\sum_{k=1}^{m} d\left(x_{k-1}, x_{k}\right)$. So

\varrho(f(x), f(y)) \leq \sum_{k=1}^{m} \varrho\left(f\left(x_{k-1}\right), f\left(x_{k}\right)\right) \leq L \cdot \sum_{k=1}^{m} d\left(x_{k-1}, x_{k}\right)=L \cdot d(x, y)
$$

2.5. Totally regular continua. By e.g. 21, 26, a continuum $X$ is called

- a dendrite if it is locally connected and contains no simple closed curve;
- a local dendrite if it is locally connected and contains at most finitely many simple closed curves;
- completely regular if it contains no non-degenerate nowhere dense subcontinuum;
- totally regular if for every $x \in X$ and every countable set $P \subseteq X$ there is a basis of neighborhoods of $x$ with finite boundary not intersecting $P$;
- regular if every $x \in X$ has a basis of neighborhoods with finite boundary;
- hereditarily locally connected if every subcontinuum of $X$ is locally connected;
- a curve if it is one-dimensional.

Notice that (local) dendrites as well as completely regular continua are totally regular and (totally) regular continua are hereditarily locally connected, hence they are locally connected curves.

We will need the following simple estimate of the maximal cardinality of $\varepsilon$ separated sets in totally regular continua $X$. Notice that an analogous estimate follows from the fact that the 1-dimensional Minkowski content is equal to $\mathcal{H}^{1}(X)$ for continua $X \subseteq \mathbb{R}^{n}$ of finite length ([16, Theorem 3.2.39], see also [24, p. 75]).

Lemma 3. Let $X=(X, d)$ be a non-degenerate totally regular continuum. Then

$$
\underline{\operatorname{dim}}(X)=\overline{\operatorname{dim}}(X)=1 \quad \text { and } \quad s(X, \varepsilon) \leq \frac{2 \cdot \mathcal{H}^{1}(X)}{\varepsilon} \quad \text { for every } 0<\varepsilon<d(X)
$$

Proof. Let us first prove the inequality for $s(X, \varepsilon)$. There is no loss of generality in assuming $\mathcal{H}^{1}(X)<\infty$. By (2.4),

$$
\begin{equation*}
\mathcal{H}^{1}(B(x, r)) \geq r \quad \text { for every } x \in X \text { and } 0<r<d(X) / 2 \tag{2.5}
\end{equation*}
$$

Take $0<\varepsilon<d(X)$ and an $\varepsilon$-separated set $S=\left\{x_{1}, \ldots, x_{k}\right\}$ of maximal cardinality $k=s(X, \varepsilon)$. Since $d\left(x_{i}, x_{j}\right)>\varepsilon$ for every $i \neq j$, the closed balls $B\left(x_{i}, \varepsilon / 2\right)$ are disjoint. Applying (2.5) we conclude that $\mathcal{H}^{1}(X) \geq \sum_{i} \mathcal{H}^{1}\left(B\left(x_{i}, \varepsilon / 2\right)\right) \geq k \varepsilon / 2$, so $s(X, \varepsilon) \leq 2 \mathcal{H}^{1}(X) / \varepsilon$.

The equality $\underline{\operatorname{dim}}(X)=\overline{\operatorname{dim}}(X)=1$ is a special case of [16, Theorem 3.2.39]. (Notice that $\overline{\operatorname{dim}}(X) \leq 1$ immediately follows from the upper estimate for $s(X, \varepsilon)$.)

The following lemma will be used in the proof of Lemma 15.
Lemma 4. If $X$ is a totally regular continuum which is not a dendrite, then there are points $a, b \in X$ and subcontinua $X_{0}, X_{1}$ of $X$ such that $X_{0} \cup X_{1}=X, X_{0} \cap X_{1}=$ $\{a, b\}$ and $\operatorname{Cut}_{X_{i}}(a, b)$ is uncountable for $i=0,1$.

Proof. By [12] we can write $X$ as the inverse $\operatorname{limit} \lim \left(X_{n}, f_{n}\right)$, where $X_{n}$ are graphs and $f_{n}: X_{n+1} \rightarrow X_{n}$ are monotone; let $\pi_{n}: X \rightarrow X_{n}(n \in \mathbb{N})$ be the natural projections. Since $X$ is not a dendrite, by [25, Theorem 10.36] there is $m$ such that $X_{m}$ contains a circle $S$. Let $C$ be the set of all points $x_{m} \in S$ which are not vertices of $X_{m}$ and are such that $\pi_{m}^{-1}\left(x_{m}\right)$ are singletons. Then $S \backslash C$ is countable since every system of disjoint non-degenerate subcontinua of $X$ is countable. Take $a_{m} \neq b_{m}$ from $C$ and put $a=\pi_{m}^{-1}\left(a_{m}\right), b=\pi_{m}^{-1}\left(b_{m}\right)$. Write $X_{m}$ as the union $X_{m, 0} \cup X_{m, 1}$ of two non-degenerate subgraphs with $X_{m, 0} \cap X_{m, 1}=\left\{a_{m}, b_{m}\right\}$. Then $X_{i}=\pi_{m}^{-1}\left(X_{m, i}\right)(i=0,1)$, being inverse limits of continua [23, Proposition 2.1.17], are subcontinua of $X$ covering $X$ and $X_{0} \cap X_{1}=\pi_{m}^{-1}\left(X_{m, 0} \cap X_{m, 1}\right)=\{a, b\}$.
2.6. Length-expanding Lipschitz maps on totally regular continua. Here we recall the main results of [28]. We say that a family $\mathcal{C}$ of non-degenerate subcontinua of $X$ is dense if every nonempty open set in $X$ contains a member of $\mathcal{C}$. By $\mathcal{C}_{I}$ we denote the system of all non-degenerate closed subintervals of $I$; the Euclidean metric on $I$ is denoted by $d_{I}$.

Definition 5 ([28]). Let $X=(X, d), X^{\prime}=\left(X^{\prime}, d^{\prime}\right)$ be non-degenerate (totally regular) continua of finite length and let $\mathcal{C}, \mathcal{C}^{\prime}$ be dense systems of subcontinua of $X, X^{\prime}$, respectively. We say that a continuous map $f: X \rightarrow X^{\prime}$ is length-expanding
with respect to $\mathcal{C}, \mathcal{C}^{\prime}$ if there exists $\varrho>1$ (called length-expansivity constant of $f$ ) such that, for every $C \in \mathcal{C}, f(C) \in \mathcal{C}^{\prime}$ and

$$
\begin{equation*}
\text { if } \quad f(C) \neq X^{\prime} \quad \text { then } \quad \mathcal{H}_{d^{\prime}}^{1}(f(C)) \geq \varrho \cdot \mathcal{H}_{d}^{1}(C) \tag{2.6}
\end{equation*}
$$

Moreover, if $f$ is surjective and Lipschitz- $L$ we say that $f:(X, d, \mathcal{C}) \rightarrow\left(X^{\prime}, d^{\prime}, \mathcal{C}^{\prime}\right)$ is $(\varrho, L)$-length-expanding Lipschitz. Sometimes we briefly say that $f$ is $(\varrho, L)$-LEL or only $L E L$.

Proposition 6 ([28]). Let $f:(X, d, \mathcal{C}) \rightarrow(X, d, \mathcal{C})$ be a LEL map. Then $f$ is exact and has finite positive entropy. Moreover, if $f$ is the composition $\varphi \circ \psi$ of some maps $\psi: X \rightarrow I$ and $\varphi: I \rightarrow X$, then $f$ has the specification property and so it is exactly Devaney chaotic.

For $k \geq 1$ let $f_{k}: I \rightarrow I$ be the piecewise linear continuous map which fixes 0 and maps every $[(i-1) / k, i / k]$ onto $I$.

Proposition 7 ([28]). For every non-degenerate totally regular continuum $X$ and every $a, b \in X$ we can find a convex metric $d=d_{X, a, b}$ on $X$ and Lipschitz surjections $\varphi_{X, a, b}: I \rightarrow X, \psi_{X, a, b}: X \rightarrow I$ with the following properties:
(a) $\mathcal{H}_{d}^{1}(X)=1$;
(b) the system $\mathcal{C}=\mathcal{C}_{X, a, b}=\left\{\varphi_{X, a, b}(J): J\right.$ is a closed subinterval of $\left.I\right\}$ is a dense system of subcontinua of $X$;
(c) for every $\varrho>1$ there are a constant $L_{\varrho}$ (depending only on $\left.\varrho\right)$ and ( $\left.\varrho, L_{\varrho}\right)$ LEL maps

$$
\varphi:\left(I, d_{I}, \mathcal{C}_{I}\right) \rightarrow(X, d, \mathcal{C}) \quad \text { and } \quad \psi:(X, d, \mathcal{C}) \rightarrow\left(I, d_{I}, \mathcal{C}_{I}\right)
$$

with $\varphi(0)=a, \varphi(1)=b, \psi(a)=0$ and such that $\varphi=\varphi_{X, a, b} \circ f_{k}, \psi=$ $f_{l} \circ \psi_{X, a, b}$ for some $k, l \geq 3$.
Moreover, if $\operatorname{Cut}_{X}(a, b)$ is uncountable, $d, \varphi, \psi$ can be assumed to satisfy
(d) $d(a, b)>1 / 2$ and $\psi(b)=1$.

Proposition 8 ([28]). Keeping the notation from Proposition 7, for every $\varrho>1$, every non-degenerate totally regular continua $X, X^{\prime}$ and every points $a, b \in X$, $a^{\prime}, b^{\prime} \in X^{\prime}$ there are a constant $L_{\varrho}$ (depending only on $\left.\varrho\right)$ and $\left(\varrho, L_{\varrho}\right)-L E L$ map

$$
f:\left(X, d_{X, a, b}, \mathcal{C}_{X, a, b}\right) \rightarrow\left(X^{\prime}, d_{X^{\prime}, a^{\prime}, b^{\prime}}, \mathcal{C}_{X^{\prime}, a^{\prime}, b^{\prime}}\right)
$$

with $f(a)=a^{\prime}$ and, provided $\operatorname{Cut}_{X}(a, b)$ is uncountable, $f(b)=b^{\prime}$. Moreover, $f$ is equal to the composition $\varphi \circ \psi$ of two LEL-maps $\psi: X \rightarrow I$ and $\varphi: I \rightarrow X^{\prime}$.

We will need Proposition 9, which is a simple generalization of Proposition 8 Before giving the formulation of it we need to introduce the following notation. If $p \geq 1, X_{i}(i=1, \ldots, p)$ are non-degenerate subcontinua of $X$ and $a_{i}(i=0, \ldots, p)$ are points of $X$ such that $a_{0} \in X_{1}, a_{p} \in X_{p}, a_{i} \in X_{i} \cap X_{i+1}$ for $1 \leq i<p$ and $\mathcal{C}_{i}=\mathcal{C}_{X_{i}, a_{i-1}, a_{i}}$ for $1 \leq i \leq p$, we write

$$
(X, d, \mathcal{C})=\coprod_{i=1}^{p}\left(X_{i}, d_{i}, \mathcal{C}_{i}\right)
$$

if $X=\bigcup_{i} X_{i}, d$ is a convex metric on $X$ such that $\left.d\right|_{X_{i} \times X_{i}}=d_{X_{i}, a_{i-1}, a_{i}}$ for $i=1, \ldots, p$ and $\mathcal{C}$ is the system of all unions $C_{i} \cup X_{i+1} \cup \cdots \cup X_{j-1} \cup C_{j}$ where $i \leq j$, $C_{i} \in \mathcal{C}_{i}, C_{j} \in \mathcal{C}_{j}$, and, if $i<j, C_{i}=\varphi_{X_{i}, a_{i-1}, a_{i}}([s, 1])$ and $C_{j}=\varphi_{X_{j}, a_{j-1}, a_{j}}([0, t])$ for some $s, t \in I$. Particularly, if $p=1$ then $d=d_{1}$ and $\mathcal{C}=\mathcal{C}_{X, a_{0}, a_{1}}$.

Proposition 9. Let $X, X^{\prime}$ be non-degenerate totally regular continua. Let $a, b \in X$ and $d=d_{X, a, b}, \mathcal{C}=\mathcal{C}_{X, a, b}$. Let $a_{0}^{\prime}, a_{1}^{\prime}, \ldots, a_{p}^{\prime}$ be points of $X^{\prime}$ such that

$$
\left(X^{\prime}, d^{\prime}, \mathcal{C}^{\prime}\right)=\coprod_{i=1}^{p}\left(X_{i}^{\prime}, d_{X_{i}^{\prime}, a_{i-1}^{\prime}, a_{i}^{\prime}}, \mathcal{C}_{X_{i}^{\prime}, a_{i-1}^{\prime}, a_{i}^{\prime}}\right)
$$

Then for every $\varrho>1$ there is a map $f: X \rightarrow X^{\prime}$ such that:
(a1) $f:(X, d) \rightarrow\left(X^{\prime}, d^{\prime}\right)$ is a Lipschitz- $\tilde{L}$ surjection, where $\tilde{L}=\tilde{L}_{p, \varrho}$ depends only on $p$ and $\varrho$;
(a2) for every $C \in \mathcal{C}$ we have $f(C) \in \mathcal{C}^{\prime}$ and

$$
\text { if } \quad f(C) \nsupseteq X_{i}^{\prime} \quad \text { for every } i \quad \text { then } \quad \mathcal{H}_{d^{\prime}}^{1}(f(C)) \geq \rho \cdot \mathcal{H}_{d}^{1}(C) \text {; }
$$

(b) $f$ is the composition $\varphi \circ \psi$ of two Lipschitz- $\tilde{L}$ surjections $\psi:(X, d) \rightarrow I$ and $\varphi: I \rightarrow\left(X^{\prime}, d^{\prime}\right)$ such that $\psi(a)=0, \varphi(0)=a_{0}^{\prime}, \varphi(1)=a_{p}^{\prime}$ and, provided $\operatorname{Cut}_{X}(a, b)$ is uncountable, $\psi(b)=1$.
Notice that, by (b), $f(a)=a_{0}^{\prime}$ and, provided $\operatorname{Cut}_{X}(a, b)$ is uncountable, $f(b)=a_{p}^{\prime}$;
Proof. We may assume that $\varrho \geq 2$. For $i=1, \ldots, p$ put $d_{i}^{\prime}=d_{X_{i}^{\prime}, a_{i-1}^{\prime}, a_{i}^{\prime}}^{\prime}$ and $\mathcal{C}_{i}^{\prime}=\mathcal{C}_{X_{i}^{\prime}, a_{i-1}^{\prime}, a_{i}^{\prime}}^{\prime}$ Let $L_{\varrho}$ be as in Proposition 8 and let $\psi:(X, d, \mathcal{C}) \rightarrow\left(I, d_{I}, \mathcal{C}_{I}\right)$, $\varphi_{i}^{\prime}=\varphi_{X_{i}^{\prime}, a_{i-1}^{\prime}, a_{i}^{\prime}} \circ f_{k_{i}}:\left(I, d_{I}, \mathcal{C}_{I}\right) \rightarrow\left(X_{i}^{\prime}, d_{i}^{\prime}, \mathcal{C}_{i}^{\prime}\right)(i=1, \ldots, p)$ be $\left(\varrho, L_{\varrho}\right)$-LEL maps with $\varphi_{i}^{\prime}(0)=a_{i-1}^{\prime}, \varphi_{i}^{\prime}(1)=a_{i}^{\prime}, \psi(a)=0$ and, provided $\mathrm{Cut}_{X}(a, b)$ is uncountable, also $\psi(b)=1$.

For $i=1, \ldots, p$ let $I_{i}=[(i-1) / p, i / p]$ and $g_{i}: I_{i} \rightarrow I$ be the increasing linear surjection. Define $f: X \rightarrow X^{\prime}$ by $f=\varphi^{\prime} \circ \psi$, where $\varphi^{\prime}: I \rightarrow X^{\prime}$ is given by $\left.\varphi^{\prime}\right|_{I_{i}}=\varphi_{i}^{\prime} \circ g_{i}$ for $i=1, \ldots, p$. Then $\varphi^{\prime}(i / p)=a_{i}^{\prime}$ for $0 \leq i \leq p, \varphi^{\prime}$ is continuous and $\operatorname{Lipschitz}$ with $\operatorname{Lip}\left(\varphi^{\prime}\right) \leq p L_{\varrho}$ by Lemma 2. Since $\operatorname{Lip}(f) \leq p L_{\varrho}^{2}, f$ satisfies (a1) and (b) with $\tilde{L}=p L_{\varrho}^{2}$.

To show that $f$ satisfies also (a2) fix any $C \in \mathcal{C}$ and put $L=\psi(C)$ and $L_{i}=L \cap I_{i}$ for $i=1, \ldots, p$; notice that $L$ and nonempty $L_{i}$ 's are closed intervals. The fact that $f(C)=\varphi^{\prime}(L) \in \mathcal{C}^{\prime}$ immediately follows from the definitions of $f$ and $\mathcal{C}^{\prime}$. If $L$ contains some $I_{i}$ then $f(C) \supseteq X_{i}^{\prime}$. Otherwise $|L| \geq \varrho \cdot \mathcal{H}_{d}^{1}(C)$ since $L \neq I$ and there is $i$ such that $L=L_{i} \cup L_{i+1}$. We may assume that $\left|L_{i}\right| \geq|L| / 2$. Then

$$
\mathcal{H}_{d^{\prime}}^{1}(f(C)) \geq \mathcal{H}_{d^{\prime}}^{1}\left(\varphi_{i}^{\prime} \circ g_{i}\left(L_{i}\right)\right) \geq \varrho p \cdot\left|L_{i}\right| \geq \frac{\varrho^{2} p}{2} \cdot \mathcal{H}_{d}^{1}(C) \geq \varrho \cdot \mathcal{H}_{d}^{1}(C)
$$

since $\varrho \geq 2$. So $f$ satisfies also (a2) and the proof is finished.

## 3. $\quad$-LipsChitz maps and an entropy bound

In this section we introduce a special class of maps called $P$-Lipschitz maps (do not confuse with Lipschitz- $L$ maps) and we show a relatively easy way of obtaining an upper bound for their entropy (see Proposition 12), which will be used in Section 4 For the definition of a splitting see Section [2.2,

Definition 10 ( $P$-Lipschitz maps). Let $X$ be a non-degenerate continuum and $f: X \rightarrow X$ be a continuous map. Let $P$ be a finite $f$-invariant subset of $X, \mathcal{A}$ be a splitting of $X$ with $P_{\mathcal{A}} \subseteq P$ and $\left(L_{A}\right)_{A \in \mathcal{A}}$ be positive constants. Then we say that $f$ is a $P$-Lipschitz map (w.r.t. the splitting $\mathcal{A}$ and the constants $\left(L_{A}\right)_{A \in \mathcal{A}}$ ) if, for every $A \in \mathcal{A}, f(A)$ is non-degenerate and $\operatorname{Lip}\left(\left.f\right|_{A}\right) \leq L_{A}$.

Roughly speaking, $P$-Lipschitz maps are "piecewise-Lipschitz" maps with the "pieces" being subcontinua intersecting only in a finite invariant subset $P$. Trivially, every non-constant Lipschitz map is $P$-Lipschitz with $P=\emptyset$ and $\mathcal{A}=\{X\}$. On the other hand, if the metric $d$ of $X$ is convex then every $P$-Lipschitz map is Lipschitz with $\operatorname{Lip}(f) \leq \max _{A \in \mathcal{A}} L_{A}$ (see Lemma (2).

Let $f$ be a $P$-Lipschitz map w.r.t. $\mathcal{A}$. For $A, B \in \mathcal{A}$ we write $A \rightarrow B$ or, more precisely, $A \xrightarrow{f} B$ provided $f(A)$ intersects the interior of $B$. So if $A \rightarrow B$ then $f(A) \cap B$ is a finite union of subcontinua of $X$ at least one of which is non-degenerate; the number of components of $f(A) \cap B$ is smaller than or equal to the cardinality of $\partial B$. Since every $f(A)$ is non-degenerate, for every $A \in \mathcal{A}$ there is $B \in \mathcal{A}$ with $A \rightarrow B$ and, provided $f$ is surjective, also $C \in \mathcal{A}$ with $C \rightarrow A$.

The $P$-transition graph $G_{f}$ of $f$ is the directed graph the vertices of which are the sets $A \in \mathcal{A}$ and the edges of which correspond to $A \rightarrow B$. The corresponding 01-transition matrix will be called the $P$-transition matrix and will be denoted by $M_{f}$. For an integer $n \geq 1$ put

$$
\mathcal{A}^{n}=\left\{\mathbb{A}=\left(A_{0}, A_{1}, \ldots, A_{n-1}\right): A_{i} \in \mathcal{A}, A_{0} \rightarrow A_{1} \rightarrow \cdots \rightarrow A_{n-1}\right\}
$$

So $\mathcal{A}^{n}$ is the set of all paths of length $n-1$ in $G_{f}$.
Lemma 11. Let $f$ be a P-Lipschitz map w.r.t. $\mathcal{A}$ and let $x \in X$. Then for every integer $n \geq 1$ there is $\mathbb{A}=\left(A_{0}, A_{1}, \ldots, A_{n-1}\right) \in \mathcal{A}^{n}$ such that

$$
f^{i}(x) \in A_{i} \quad \text { for every } i=0,1, \ldots, n-1
$$

Proof. We prove the lemma by induction. If $n=1$ then the assertion follows from the fact that $\mathcal{A}=\mathcal{A}^{1}$ covers $X$. Assume now that the assertion of the lemma is true for some $n \geq 1$; we are going to show that it is true also for $n+1$. To this end take any point $x \in X$; we want to find $\mathbb{A} \in \mathcal{A}^{n+1}$ with $f^{i}(x) \in A_{i}$ for $i \leq n$. By the induction hypothesis there is $\left(A_{0}, A_{1}, \ldots, A_{n-1}\right) \in \mathcal{A}^{n}$ such that $f^{i}(x) \in A_{i}$ for every $i \leq n-1$. Put $y=f^{n-1}(x) \in A_{n-1}$. If $f(y) \notin P$ then $f(y) \in \operatorname{int}\left(A_{n}\right)$ for some $A_{n} \in \mathcal{A}$; hence $A_{n-1} \rightarrow A_{n}$ and we can put $\mathbb{A}=\left(A_{0}, A_{1}, \ldots, A_{n-1}, A_{n}\right) \in \mathcal{A}^{n+1}$. Now assume that $f(y) \in P$. Let $B_{1}, \ldots, B_{k}(k \geq 1)$ be the collection of all sets from $\mathcal{A}$ containing $f(y)$. Since $f\left(A_{n-1}\right)$ has no isolated point (it is a non-degenerate continuum) and contains $f(y)$, it must intersect the interior of some $B_{i}$. If we put $\mathbb{A}=\left(A_{0}, A_{1}, \ldots, A_{n-1}, B_{i}\right)$, we are done.

Let $X$ be a continuum with a convex metric $d$ and let $f$ be a $P$-Lipschitz map on $X$ w.r.t. $\mathcal{A}$ and $\left(L_{A}\right)_{A \in \mathcal{A}}$. For every nonempty subset $\mathcal{B}$ of $\mathcal{A}$ put

$$
L_{\mathcal{B}}=\max _{A \in \mathcal{B}} L_{A} .
$$

Since any $P$-Lipschitz map $f$ has $\operatorname{Lip}(f) \leq L_{\mathcal{A}}$, we immediately have (see e.g. 19, Theorem 3.2.9])

$$
h(f) \leq \overline{\operatorname{dim}}(X) \cdot \log ^{+} L_{\mathcal{A}}
$$

where $\log ^{+} L=\max \{\log L, 0\}$.
Assume now that $X$ is a non-degenerate totally regular continuum and the metric $d$ of $X$ is convex with $\mathcal{H}_{d}^{1}(X)<\infty$. Then $\overline{\operatorname{dim}}(X)=1$ (see Lemma 3), hence $h(f) \leq$ $\log ^{+} L_{\mathcal{A}}$. But this upper bound is often too pessimistic. Consider e.g. the following example. Let $f$ and $\mathcal{A}=\left\{X_{0}, \ldots, X_{k-1}\right\}$ be such that $f\left(X_{i}\right) \subseteq X_{(i+1) \bmod k}$ and that $L_{X_{0}}=L>1, L_{X_{i}} \leq 1$ for $i \geq 1$. Then $L_{\mathcal{A}}=L$ and we have $h(f) \leq \log L$. But since $X_{i}$ 's are $f^{k}$-invariant and $\operatorname{Lip}\left(\left.f^{k}\right|_{X_{i}}\right) \leq L$, we have a much better estimate
$h(f) \leq(1 / k) \log L$. The key point here is the fact that the sets $A \in \mathcal{A}$ with "large" $L_{A}$ occurs "rarely" in paths $\mathbb{A} \in \mathcal{A}^{n}$ of $f$.

To formalize this idea, for nonempty $\mathcal{B} \subseteq \mathcal{A}$ put

$$
\begin{equation*}
\theta_{\mathcal{B}}=\limsup _{n \rightarrow \infty} \frac{k_{n}^{\mathcal{B}}}{n} \quad \text { where } \quad k_{n}^{\mathcal{B}}=\max _{\mathbb{A} \in \mathcal{A}^{n}} \#\left\{k=0, \ldots, n-1: A_{k} \notin \mathcal{B}\right\} \tag{3.1}
\end{equation*}
$$

This quantity measures the maximal "asymptotic frequency" of occurrences of $A \in$ $\mathcal{A} \backslash \mathcal{B}$ in paths of $f$. The following proposition asserts that if $L_{\mathcal{B}}$ is close to 1 and $\theta_{\mathcal{B}}$ is sufficiently small, then the entropy of $f$ can be small even for large $L_{\mathcal{A}}$.
Proposition 12 (Upper bound for the entropy of $P$-Lipschitz maps). Let $X$ be $a$ non-degenerate totally regular continuum endowed with a convex metric $d$ such that $\mathcal{H}_{d}^{1}(X)<\infty$. Let $f: X \rightarrow X$ be $P$-Lipschitz w.r.t. $\mathcal{A}$ and $\left(L_{A}\right)_{A \in \mathcal{A}}$. Then, for every nonempty subsystem $\mathcal{B}$ of $\mathcal{A}$,

$$
h(f) \leq \log ^{+} L_{\mathcal{B}}+2 \theta_{\mathcal{B}} \log ^{+} L_{\mathcal{A}} .
$$

Proof. Since the assertion of the proposition does not change if we replace every $L_{A}$ by $\max \left\{L_{A}, 1\right\}$, we may assume that $L_{A} \geq 1$ for every $A \in \mathcal{A}$. Fix any $0<\varepsilon<d(X)$ such that $\varepsilon<\operatorname{dist}(A, B)$ for every disjoint $A, B \in \mathcal{A}$ and $\varepsilon<d(x, y)$ for every distinct $x, y \in P$.

Let $n \in \mathbb{N}$ and let $S$ be an $(n, \varepsilon)$-separated subset of $X$ of maximal cardinality $\# S=s_{n}(X, \varepsilon, f)$. Take any $x \neq y$ from $S$. By Lemma 11 there are $\mathbb{A}^{x}=\left(A_{i}^{x}\right)_{i<n}, \mathbb{A}^{y}=\left(A_{i}^{y}\right)_{i<n} \in \mathcal{A}^{n}$ such that $x_{i}=f^{i}(x) \in A_{i}^{x}$ and $y_{i}=f^{i}(y) \in A_{i}^{y}$ for $i<n$. Put $d_{i}=d\left(x_{i}, y_{i}\right)$ for $i<n$ and $j=\min \left\{i: d_{i}>\varepsilon\right\}$; then $0 \leq j \leq n-1$.

Fix any $0 \leq i<j$. Let $B$ be a geodesic arc from $x_{i}$ to $y_{i}$. Then, by (2.4), $d(B) \leq \mathcal{H}^{1}(B)=d\left(x_{i}, y_{i}\right) \leq \varepsilon$. By the choice of $\varepsilon$ the set $B$ contains at most one point from $P$. If $B \cap P=\emptyset$ then $B$ does not intersect the boundaries of $A_{i}^{x}, A_{i}^{y}$ and so $B \subseteq \operatorname{int}\left(A_{i}^{x}\right) \cap \operatorname{int}\left(A_{i}^{y}\right)$. Hence $A_{i}^{x}=A_{i}^{y}$ and

$$
\begin{equation*}
d_{i+1} \leq L_{A_{i}^{x}} \cdot d_{i} \tag{3.2}
\end{equation*}
$$

Otherwise $B \cap P=\{z\}$ is a singleton. We claim that $z \in A_{i}^{x}$. Indeed, if $z \neq x_{i}$ then $x_{i}$ belongs to the interior of $A_{i}^{x}$. Since $B$ is connected, intersects the interior of $A_{i}^{x}$ and $\partial A_{i}^{x} \subseteq P$, the subarc $x_{i} z$ of $B$ is contained in $A_{i}^{x}$ and so $z \in A_{i}^{x}$. If $z=x_{i}$ then again $z \in A_{i}^{x}$. Analogously $z \in A_{i}^{y}$ and thus $z \in A_{i}^{x} \cap A_{i}^{y}$. Using the facts that $\left.f\right|_{A}$ is Lipschitz on every $A \in \mathcal{A}$ and that $B$ is geodesic (hence $d\left(x_{i}, z\right)+d\left(z, y_{i}\right)=d_{i}$ ) we obtain

$$
\begin{align*}
d_{i+1} & \leq d\left(x_{i+1}, f(z)\right)+d\left(f(z), y_{i+1}\right) \leq L_{A_{i}^{x}} \cdot d\left(x_{i}, z\right)+L_{A_{i}^{y}} \cdot d\left(z, y_{i}\right)  \tag{3.3}\\
& \leq \max \left\{L_{A_{i}^{x}}, L_{A_{i}^{y}}\right\} \cdot d_{i}
\end{align*}
$$

Combination of (3.2) and (3.3) for $i<j$ gives

$$
d_{j} \leq d_{0} \cdot \prod_{i<j} \max \left\{L_{A_{i}^{x}}, L_{A_{i}^{y}}\right\} \leq d_{0} \cdot \prod_{i<n} \max \left\{L_{A_{i}^{x}}, L_{A_{i}^{y}}\right\}
$$

Thus, by the definition (3.1) of $k_{n}=k_{n}^{\mathcal{B}}$,

$$
\varepsilon<d_{j} \leq d_{0} \cdot L_{\mathcal{A}}^{2 k_{n}} \cdot L_{\mathcal{B}}^{n-2 k_{n}} \leq d_{0} \cdot L_{\mathcal{A}}^{2 k_{n}} \cdot L_{\mathcal{B}}^{n}
$$

So the set $S$ is $\varepsilon^{\prime}$-separated with $\varepsilon^{\prime}=\varepsilon /\left(L_{\mathcal{A}}^{2 k_{n}} \cdot L_{\mathcal{B}}^{n}\right)$ and Lemma 3 gives

$$
s_{n}(X, \varepsilon, f) \leq s\left(X, \varepsilon^{\prime}\right) \leq \frac{2 \mathcal{H}^{1}(X)}{\varepsilon} \cdot L_{\mathcal{A}}^{2 k_{n}} \cdot L_{\mathcal{B}}^{n}
$$

From this and (2.1), $h(f) \leq 2 \theta_{\mathcal{B}} \log L_{\mathcal{A}}+\log L_{\mathcal{B}}$.

In the following example we show how Proposition 12 can be used to obtain a "good" upper estimate of the topological entropy.

Example 13. Consider a graph $X$ which is not a tree. We can write $X=I \cup G$, where $I$ is a free arc in $X$ identified with $[0,1]$ and $G$ is a subgraph of $X$ such that $I \cap G=\{0,1\}$. Let $n \geq 3$ and $g=g_{n}: X \rightarrow X$ be the map constructed in the proof of [4, Theorem 4.1]. Recall that if we put $X_{i}=[i / n,(i+1) / n]$ for $0 \leq i<n$, $i \neq 1$ and $X_{1}^{-}=\left[\frac{1}{n}, \frac{3}{2 n}\right], X_{1}^{+}=\left[\frac{3}{2 n}, \frac{2}{n}\right]$, then $g$ maps linearly $X_{0}$ onto $X_{1}^{-} \cup X_{1}^{+}$, $X_{1}^{-}$onto $X_{1}^{+}, X_{1}^{+}$onto $X_{1}^{+} \cup X_{2}$ and $X_{i}$ onto $X_{i+1}$ for $i=2, \ldots, n-2$. Moreover, $\left.g\right|_{X_{n-1}}: X_{n-1} \rightarrow G$ and $\left.g\right|_{G}: G \rightarrow X_{0}$ are piecewise linear maps with the number of pieces not depending on $n$.

Put $\lambda=\sqrt[n-2]{2}$ and define the convex metric $d=d_{n}$ on $X$ in such a way that $d(0,1)=d\left(0, \frac{1}{n}\right)=1, d\left(\frac{1}{n}, \frac{3}{2 n}\right)=d\left(\frac{3}{2 n}, \frac{2}{n}\right)=\frac{1}{2}, d\left(\frac{i}{n}, \frac{i+1}{n}\right)=\frac{1}{2} \lambda^{i-1}$ for $i=$ $2, \ldots, n-1$, and the Lipschitz constants of $\left.g\right|_{X_{n-1}},\left.g\right|_{G}$ are bounded from above by a constant $L$ not depending on $n$. Then $g$ is $P$-Lipschitz with $P=\left\{\frac{i}{n}, i=0, \ldots, n\right\} \cup$ $\left\{\frac{3}{2 n}\right\}, \mathcal{A}=\left\{X_{0}, X_{1}^{-}, X_{1}^{+}, X_{2}, \ldots, X_{n-1}, G\right\}$ and $L_{X_{0}}=L_{X_{1}^{-}}=1, L_{X_{1}^{+}}=L_{X_{2}}=$ $\cdots=L_{X_{n-2}}=\lambda, L_{X_{n-1}}=L_{G}=L$. Put $\mathcal{B}=\mathcal{A} \backslash\left\{G, X_{n-1}\right\}$. Then $L_{\mathcal{A}}=L$, $L_{\mathcal{B}}=\lambda$ and an easy computation gives that $\theta_{\mathcal{B}} \leq \frac{2}{n}$. According to Proposition 12 we have

$$
h\left(g_{n}\right) \leq \log \lambda+\frac{2}{n} \log L \leq \frac{\log \left(2 L^{2}\right)}{n-2}
$$

and thus $\lim \sup _{n} h\left(g_{n}\right)=0$.
We finish this section with a simple lemma giving a sufficient condition for transitivity and exactness of $P$-Lipschitz maps. Recall that a 01 -square matrix $M$ is called irreducible if for every indices $i, j$ there is $n>0$ with $M_{i j}^{n}>0$; i.e. the corresponding directed graph $G_{M}$ is strongly connected (there is a path from each vertex to every other vertex). The period $p_{M}$ of an irreducible matrix $M$ is the greatest common divisor of those $n>0$ for which $M_{i i}^{n}>0$ for some $i$. Equivalently, $p_{M}$ is the greatest common divisor of the lengths of cycles (closed paths) in $G_{M}$. An irreducible matrix $M$ and the corresponding graph $G_{M}$ are called primitive provided $p_{M}=1$.

Lemma 14. Let $X$ be a non-degenerate totally regular continuum endowed with a convex metric $d$ such that $\mathcal{H}_{d}^{1}(X)<\infty$. Let a map $f: X \rightarrow X$ be $P$-Lipschitz w.r.t. $\mathcal{A}$ such that $A \rightarrow B$ implies $f(A) \supseteq B$ for $A, B \in \mathcal{A}$. Assume that there is a dense system $\mathcal{D}$ of subcontinua of $X$ such that for every $D \in \mathcal{D}$ there are $n \in \mathbb{N}$, $A \in \mathcal{A}$ with $f^{n}(D) \supseteq A$. Then the following hold:
(a) $f$ is transitive but not totally transitive if and only if $M_{f}$ is irreducible but not primitive;
(b) $f$ is exact if and only if $M_{f}$ is primitive.

Proof. If $M_{f}$ is not irreducible there are $A, B \in \mathcal{A}$ such that there is no path from $A$ to $B$. Hence $f^{n}(\operatorname{int}(A)) \cap \operatorname{int}(B)=\emptyset$ for every $n>0$, which contradicts transitivity of $f$. If $M_{f}$ is irreducible with the period $p>1$, then there are $A, B \in \mathcal{A}$ such that there is no path from $A$ to $B$ of length $n p$. I.e. $f^{p}$ is not transitive and thus $f$ is not totally transitive.

Assume now that $M_{f}$ is irreducible and take any nonempty open sets $U, V$. Since $\bigcup_{A \in \mathcal{A}} \operatorname{int}(A) \supseteq X \backslash P$ is dense in $X$, there is $B \in \mathcal{A}$ intersecting $V$. By the assumption on $\mathcal{D}$ there are $D \in \mathcal{D}, n \in \mathbb{N}$ and $A \in \mathcal{A}$ such that $D \subseteq U$ and $f^{n}(D) \supseteq A$. Since $M_{f}$ is irreducible there is $m$ with $f^{m}(A) \supseteq B$. Hence
$f^{n+m}(D) \supseteq B$ and so $f^{n+m}(U)$ intersects $V$. Thus $f$ is transitive. Moreover, if $M_{f}$ is primitive there is $p$ such that, for every $C \in \mathcal{A}$, there is a path of length $p$ from $A$ to $C$. So $f^{n+p}(U) \supseteq f^{n+p}(D) \supseteq f^{p}(A)=X$ and $f$ is exact.

## 4. Proof of Main Theorem

In this section we prove Main Theorem. We use the notation from Section 2.6.

### 4.1. Lipschitz, exactly Devaney chaotic maps.

Lemma 15. There is $L>0$ such that any non-degenerate totally regular continuum $X$ admits a convex metric d with $\mathcal{H}_{d}^{1}(X)<\infty$ and Lipschitz-L, Devaney chaotic maps $f, g:(X, d) \rightarrow(X, d)$ with positive entropies such that $f$ is not totally transitive and $g$ is exact.

Proof. The existence of a map $g:(X, d) \rightarrow(X, d)$ was shown in 28, so we only need to construct $f$. If $X$ contains a circle, there are points $a \neq b$ such that $X$ is the union of two subcontinua $X_{0}, X_{1}$ with $X_{0} \cap X_{1}=\{a, b\}$ and $\operatorname{Cut}_{X_{i}}(a, b)$ is uncountable for $i=0,1$. (Such points $a, b$ can be chosen as follows. By [12] we can write $X=\lim ^{\ln }\left(X_{n}, f_{n}\right)$, where $X_{n}$ are graphs and $f_{n}: X_{n+1} \rightarrow X_{n}$ are monotone; let $\pi_{n}: X \rightarrow X_{n}(n \in \mathbb{N})$ be the natural projections. Since $X$ is not a dendrite, by [25, Theorem 10.36] there is $m$ such that $X_{m}$ contains a circle $S$. Let $C$ be the set of all points $x_{m} \in S$ which are not vertices of $X_{m}$ and are such that $\pi_{m}^{-1}\left(x_{m}\right)$ are singletons. Then $S \backslash C$ is countable since every system of disjoint non-degenerate subcontinua of $X$ is countable. Take $a_{m} \neq b_{m}$ from $C$ and put $a=\pi_{m}^{-1}\left(a_{m}\right)$, $b=\pi_{m}^{-1}\left(b_{m}\right)$. Write $X_{m}$ as the union $X_{m, 0} \cup X_{m, 1}$ of two non-degenerate subgraphs with $X_{m, 0} \cap X_{m, 1}=\left\{a_{m}, b_{m}\right\}$. Then $X_{i}=\pi_{m}^{-1}\left(X_{m, i}\right)(i=0,1)$, being inverse limits of continua [23, Proposition 2.1.17], are non-degenerate subcontinua of $X$ covering $X$ and $X_{0} \cap X_{1}=\pi_{m}^{-1}\left(X_{m, 0} \cap X_{m, 1}\right)=\{a, b\}$.)

Without loss of generality we may assume that $d_{X_{0}, a, b}(a, b)=d_{X_{1}, a, b}(a, b)$ (otherwise we replace one of the metrics by a constant multiple of it). Let $d$ be the convex metric on $X$ defined by (2.2) for the splitting $\left\{X_{0}, X_{1}\right\}$ and metrics $d_{0}=d_{X_{0}, a, b}, d_{1}=d_{X_{1}, a, b}$; by Lemman $d$ coincides with $d_{X_{i}, a, b}$ on $X_{i}$ for $i=0,1$. Let $f_{0}: X_{0} \rightarrow X_{1}, f_{1}: X_{1} \rightarrow X_{0}$ be maps from Proposition 9 (with $\varrho>1, p=1$ ) fixing points $a$ and $b$. Define $f: X \rightarrow X$ by $f(x)=f_{i}(x)$ if $x \in X_{i}$. Then, for $i=0,1,\left.f^{2}\right|_{X_{i}}: X_{i} \rightarrow X_{i}$ is LEL and so, by Proposition 6, $\left.f^{2}\right|_{X_{i}}$ is exactly Devaney chaotic. Thus $f$ is Devaney chaotic and has positive entropy. Since $f^{2}$ is not transitive, $f$ is not totally transitive.

If $X$ does not contain a circle, then $X$ is a dendrite. Take any non-end point $a \in X$ and write $X=X_{0} \cup X_{1}$, where $X_{i}$ 's are non-degenerate subdendrites with $X_{0} \cap X_{1}=\{a\}$. Fix $b_{i} \in X_{i} \backslash\{a\}$ and notice that, since $X_{i}$ 's are dendrites, the sets $\operatorname{Cut}_{X_{i}}\left(a, b_{i}\right)$ are uncountable. Now we can proceed analogously as in the nondendrite case; the only change is that instead of $f_{i}(b)=b$ we require $f_{0}\left(b_{0}\right)=b_{1}$ and $f_{1}\left(b_{1}\right)=b_{0}$.

Corollary 16. Every non-degenerate totally regular continuum admits a (not totally) Devaney chaotic, as well as an exactly Devaney chaotic map with finite positive entropy. Every compact metric space which is the disjoint union of finitely many non-degenerate totally regular continua admits a Devaney chaotic map with finite positive entropy.
4.2. Exactly Devaney chaotic maps with arbitrarily small entropy. In what follows we show that under some conditions a totally regular continuum $X$ admits (exactly) Devaney chaotic maps with arbitrarily small entropy. We consider two subclasses of totally regular continua: those containing arbitrarily large generalized stars and those containing a non-disconnecting free arc. The constructions are modifications of those for stars 2, Theorem 1.2] and for graphs which are not trees [4, Theorems 3.7 and 4.1]. The key difference is that instead of constructing piecewise linear Markov maps we construct $P$-Lipschitz maps using Proposition 9

Let $X$ be a continuum and $k \geq 2$ be an integer. We say that $X$ contains a generalized $k$-star if there are a point $a \in X$ and $k$ components $C_{1}, \ldots, C_{k}$ of $X \backslash\{a\}$ such that the closures $X_{i}=\overline{C_{i}}=C_{i} \cup\{a\}(i=1, \ldots, k)$ are homeomorphic relative to $a$; i.e. for every $i, j$ there is a homeomorphism $h_{i j}: X_{i} \rightarrow X_{j}$ fixing the point $a$ (see Figure (1). Recall that $X$ contains arbitrarily large generalized stars if it contains a generalized $k$-star for every $k \geq 2$.

Lemma 17. There is a constant $c>0$ such that any totally regular continuum $X$ containing a generalized $k$-star $(k \geq 2$ ) admits a (not totally) Devaney chaotic map $f$ as well as an exactly Devaney chaotic map $g$ with positive topological entropies bounded from above by $c / k$. Consequently, if $X$ contains arbitrarily large generalized stars then $I^{\mathrm{ED}}(X)=0$.


Figure 1. A continuum containing a generalized $k$-star

Proof. Since $X$ contains a generalized $k$-star, there is $a \in X$ such that we can write $X=X_{0} \cup X_{1} \cup \cdots \cup X_{k}$, where $X_{i}$ 's are subcontinua of $X, X_{i} \cap X_{j}=\{a\}$ for every $i \neq j$ and $X_{i}, X_{j}$ are homeomorphic relative to $a$ for $i, j \geq 1$. Further, $X_{1}, \ldots, X_{k}$ are non-degenerate and, by replacing $k$ with $k-1$ if necessary, we may assume that also $X_{0}$ is such. For $i=0, \ldots, k$ put $d_{i}=d_{X_{i}, a, a}$ and $\mathcal{C}_{i}=\mathcal{C}_{X_{i}, a, a}$.

We may assume that the metrics $d_{i}$ are such that for every $1 \leq i<k$ there is an isometry $f_{i}:\left(X_{i}, d_{i}\right) \rightarrow\left(X_{i+1}, d_{i+1}\right)$ fixing $a$. Since $\bigcup_{i \neq j} X_{i} \cap X_{j}=\{a\}$ is a singleton, by Lemma 1 there is a convex metric $d$ on $X$ such that $\left.d\right|_{X_{i} \times X_{i}}=d_{i}$ for every $i$. Let $f_{k}: X_{k} \rightarrow X_{0}, f_{0}: X_{0} \rightarrow X_{1}$ be maps from Proposition 9 (with $p=1, \varrho>1$ ) such that $f_{k}(a)=f_{0}(a)=a$. Without loss of generality we may assume that if $C \in \mathcal{C}_{i}(i=1, \ldots, k-1)$ then $f_{i}(C) \in \mathcal{C}_{i+1}$. We define the map $f: X \rightarrow X$ by $f(x)=f_{i}(x)$ for $x \in X_{i}, i=0, \ldots, k$. Proposition 6
implies that $\left.f^{k+1}\right|_{X_{0}}: X_{0} \rightarrow X_{0}$, being LEL, is exactly Devaney chaotic. Hence $h(f)>0, f$ is a (not totally) Devaney chaotic map, and, since $d$ is convex, $f$ is $\operatorname{Lipschitz}$ with $\operatorname{Lip}(f) \leq \tilde{L}$ by Lemma 2 Moreover, since $\operatorname{Lip}\left(f^{k+1}\right) \leq \tilde{L}^{2}$ we have $h(f) \leq \tilde{L}^{2} /(k+1) \leq c / k$ for some constant $c$ depending only on $\tilde{L}$.

To construct an exactly Devaney chaotic map $g: X \rightarrow X$ we take the metric $d$ on $X$ as in the previous case and we define $\left.g\right|_{X_{i}}=f_{i}$ for $i=1, \ldots, k$. The only difference is the definition of $g$ on $X_{0}$ : we put $\left.g\right|_{X_{0}}=g_{0}$, where $g_{0}: X_{0} \rightarrow\left(X_{1} \cup X_{2}\right)$ is a map obtained from Proposition 9 with $p=2, \varrho^{\prime}>2, X^{\prime}=X_{1} \cup X_{2}$ and $a_{i}^{\prime}=a$ for $i=0,1,2$. Then $g_{0}(a)=a$. By Proposition 9 we have that, for $C \in \mathcal{C}_{0}$, if $g_{0}(C)$ contains neither $X_{1}$ nor $X_{2}$, then $g_{0}(C)=C_{1} \cup C_{2}$, where $C_{1} \in \mathcal{C}_{1}$ and $C_{2} \in \mathcal{C}_{2}$ are continua and $\mathcal{H}^{1}\left(g_{0}(C)\right)=\mathcal{H}^{1}\left(C_{1}\right)+\mathcal{H}^{1}\left(C_{2}\right) \geq \varrho^{\prime} \cdot \mathcal{H}^{1}(C)$. Hence

$$
\begin{equation*}
\mathcal{H}^{1}\left(C^{\prime}\right) \geq \frac{\varrho^{\prime}}{2} \cdot \mathcal{H}^{1}(C) \quad \text { for some } \quad C^{\prime} \in \mathcal{C}_{1} \cup \mathcal{C}_{2}, C^{\prime} \subseteq g(C) \tag{4.1}
\end{equation*}
$$

Notice that $\operatorname{Lip}(g)$ is bounded from above by an absolute constant $L$, see Lemma 2
We are going to show the entropy bound for $g$ using Proposition12, Put $P=\{a\}$, $\mathcal{A}=\left\{X_{0}, \ldots, X_{k}\right\}, \mathcal{B}=\left\{X_{1}, \ldots, X_{k-1}\right\}, L_{X_{i}}=1$ for $1 \leq i<k$ and $L_{X_{0}}=L_{X_{k}}=$ $L$. Then $g$ is $P$-Lipschitz w.r.t. $\mathcal{A}$ and $\left(L_{X_{i}}\right)_{i}, L_{\mathcal{A}}=L$ and $L_{\mathcal{B}}=1$. Moreover, $X_{i} \rightarrow X_{j}$ if and only if $j=(i+1) \bmod (k+1)$ or $i=0, j=2$. Fix any $n \in \mathbb{N}$ and $\mathbb{A}=\left(A_{0}, \ldots, A_{n-1}\right) \in \mathcal{A}^{n}$ with exactly $k_{n}=k_{n}^{\mathcal{B}}$ members from $\mathcal{A} \backslash \mathcal{B}$, see (3.1). Let $l_{1}<l_{2}<\cdots<l_{k_{n}}$ be the indices $l$ with $A_{l} \notin \mathcal{B}$, i.e. with $A_{l} \in\left\{X_{0}, X_{k}\right\}$. Then, for any $l_{j}, 1 \leq i \leq k-1$ and $l_{j}+i<n$, it holds that $A_{l_{j}+i} \in\left\{X_{i-1}, X_{i}, X_{i+1}\right\}$ and thus $A_{l_{j}+2}, \ldots, A_{l_{j}+k-2} \in \mathcal{B}$. So $l_{j+2}-l_{j} \geq k-1$ for every $j \leq k_{n}-2$. We see at once that $n-1 \geq l_{k_{n}} \geq\left(k_{n}-1\right)(k-1) / 2$, i.e. $\theta_{\mathcal{B}}=\limsup _{n} k_{n} / n \leq 2 /(k-1)$. By Proposition 12, $h(g) \leq \log ^{+} L_{\mathcal{B}}+2 \theta_{\mathcal{B}} \log ^{+} L_{\mathcal{A}} \leq(4 /(k-1)) \log L \leq c / k$ for some absolute constant $c$.

To prove that $g$ is exact we use Lemma 14 with $\mathcal{D}=\cup_{i} \mathcal{C}_{i}$. To this end take any $i$ and $C \in \mathcal{C}_{i}$ and suppose that for every $n$ the set $g^{n}(C)$ does not contain any $X_{i}$. Then Proposition 9 and (4.1) give that, for every $n \geq 1$,

$$
\mathcal{H}^{1}\left(g^{n}(C)\right) \geq q^{n} \cdot \mathcal{H}^{1}(C) \quad \text { with } \quad q=\min \left\{\varrho, \varrho^{\prime} / 2\right\}>1 .
$$

(The inequality can be shown by induction as follows. Trivially it holds for $n=0$. Put $C_{0}=C$ and assume that, for some $n \geq 0$, there is $i$ such that the set $g^{n}(C)$ contains some $C_{n} \in \mathcal{C}_{i}$ with $\mathcal{H}^{1}\left(C_{n}\right) \geq q^{n} \cdot \mathcal{H}^{1}(C)$. If $i \neq 0$ then put $C_{n+1}=g\left(C_{n}\right) \in$ $\mathcal{C}_{(i+1) \bmod (k+1)}$ and use Proposition 9. If $i=0$, put $C_{n+1}=C^{\prime}$, where $C^{\prime}$ is the continuum from (4.1).) But this contradicts the fact that $\mathcal{H}^{1}(X)<\infty$. Hence $\mathcal{D}$ satisfies the assumption from Lemma 14 Notice also that $A \rightarrow B$ implies $g(A) \supseteq B$. And since the $P$-transition graph of $g$ contains cycles $X_{0} \rightarrow X_{1} \rightarrow \cdots \rightarrow X_{k} \rightarrow X_{0}$ and $X_{0} \rightarrow X_{2} \rightarrow X_{3} \rightarrow \cdots \rightarrow X_{k} \rightarrow X_{0}$ of lengths $k+1$ and $k$, the $P$-transition matrix of $g$ is primitive. Hence, by Lemma 14, $g$ is exact.

To finish it suffices to show that $g$ has dense periodic points. Let $\tilde{X}=X \cup A$ be a totally regular continuum obtained from $X$ by adding to it an arc $A$ such that $A \cap X=\{a\}$. Take a convex metric $\tilde{d}$ on $\tilde{X}$ such that it coincides with $d$ on $X$ and the length of $A$ is 1 . Then there is an isometry from $I$ onto $A$ mapping 0 to $a$. So, by the choice of $g_{0}$, there are Lipschitz maps $\psi: X_{0} \rightarrow A$ and $\varphi: A \rightarrow X_{1} \cup X_{2}$
with $\varphi \circ \psi=g_{0}$ and $\psi(a)=\varphi(a)=a$. Define the map $\tilde{g}: \tilde{X} \rightarrow \tilde{X}$ by

$$
\tilde{g}(x)= \begin{cases}g(x) & \text { if } x \in X_{1} \cup \cdots \cup X_{k} \\ \psi(x) & \text { if } x \in X_{0} \\ \varphi(x) & \text { if } x \in A\end{cases}
$$

Analogously as before, $\tilde{g}$ is exact. Since $\tilde{X}$ contains a disconnecting interval (an open set homeomorphic to $(0,1)$ such that any point of it disconnects $X$ into exactly two components), $\tilde{g}$ has dense periodic points by [2, Theorem 1.1]. Trivially, any periodic point of $\tilde{g}$ in $X$ is also a periodic point of $g$. So also the periodic points of $g$ are dense.

Lemma 18. There is $c>0$ with the following property. Let $X$ be a totally regular continuum which can be written as the union of non-degenerate subcontinua

$$
X=X_{0} \cup X_{1} \cup \cdots \cup X_{k}
$$

where $k \geq 2$ and the following hold:
(a) there are distinct points $a_{0}, \ldots, a_{k}$ with $X_{i} \cap X_{(i+1) \bmod (k+1)}=\left\{a_{i}\right\}$ for $i=0, \ldots, k$;
(b) $X_{i} \cap X_{j}=\emptyset$ whenever $2 \leq|i-j|<k$;
(c) for $i=1, \ldots, k-1$ there is a homeomorphism $h_{i}: X_{i} \rightarrow X_{i+1}$ such that $h_{i}\left(a_{i-1}\right)=a_{i}$ and $h_{i}\left(a_{i}\right)=a_{i+1}$;
(d) $\operatorname{Cut}_{X_{1}}\left(a_{0}, a_{1}\right)$ is uncountable.

Then $X$ admits a (not totally) Devaney chaotic map $f$ and an exactly Devaney chaotic map $g$ with positive topological entropies bounded from above by $c / k$.

See Figure 2 for an illustration of a continuum satisfying the assumptions of the lemma.


Figure 2. A continuum from Lemma 18

Proof. We may assume that $\operatorname{Cut}_{X_{0}}\left(a_{k}, a_{0}\right)$ is uncountable, for if not, we replace $k$ by $k^{\prime}=k-1$ and $X_{k-1}$ by $X_{k-1}^{\prime}=X_{k-1} \cup X_{k}$ (if $k^{\prime}=1$ we simply apply Lemma (15).

Consider the metrics $d_{i}=d_{X_{i}, a_{i-1}, a_{i}}$ for $i=0, \ldots, k$ (with $a_{-1}:=a_{k}$ ); in view of (c) we may assume that $f_{i}:\left(X_{i}, d_{i}\right) \rightarrow\left(X_{i+1}, d_{i+1}\right)$ are isometries for $1 \leq i<k$. Let $d$ be the convex metric on $X$ defined by (2.2). Since $\bigcup_{i \neq j} X_{i} \cap X_{j}=\left\{a_{i}: i=\right.$ $0, \ldots, k\}, 1>d_{i}\left(a_{i-1}, a_{i}\right)>1 / 2$ and $X_{i} \cap X_{j}$ are empty or singletons for $i \neq j$, Lemma 1 gives that $\left.d\right|_{X_{i} \times X_{i}}=d_{i}$ for every $i$.

Let $f_{k}: X_{k} \rightarrow X_{0}, f_{0}: X_{0} \rightarrow X_{1}$ and $g_{0}: X_{0} \rightarrow\left(X_{1} \cup X_{2}\right)$ be maps from Proposition 9 with $(\varrho>2)$ such that $f_{0}\left(a_{k}\right)=g_{0}\left(a_{k}\right)=a_{0}, f_{0}\left(a_{0}\right)=g_{0}\left(a_{0}\right)=a_{1}$, $f_{k}\left(a_{k-1}\right)=a_{k}$ and $f_{k}\left(a_{k}\right)=a_{0}$. Define $f, g: X \rightarrow X$ by

$$
f(x)=\left\{\begin{array}{ll}
f_{0}(x) & \text { if } x \in X_{0} ; \\
h_{i}(x) & \text { if } x \in X_{i}, 1 \leq i<k ; \\
f_{k}(x) & \text { if } x \in X_{k} ;
\end{array} \quad g(x)= \begin{cases}g_{0}(x) & \text { if } x \in X_{0} \\
h_{i}(x) & \text { if } x \in X_{i}, 1 \leq i<k \\
f_{k}(x) & \text { if } x \in X_{k}\end{cases}\right.
$$

Analogously as in the proof of Lemma 17 we can show that $f$ is (not totally) Devaney chaotic, $g$ is exact and the entropies of $f, g$ are positive and bounded from above by $c / k$, where $c$ is an absolute constant. What is left is to prove that $g$ has dense periodic points.

To this end put $P=\left\{a_{i}: i=0, \ldots, k\right\}$ and realize that $g(P)=P$. Let $\mathcal{D}$ be the decomposition of $X$ into $P$ and singletons $\{x\}, x \notin P$. Let $X^{\prime}=X / \mathcal{D}$ (i.e. we collapse $P$ into a point), $\pi: X \rightarrow X^{\prime}$ be the natural projection and $\left\{a^{\prime}\right\}=\pi(P)$, $X_{i}^{\prime}=\pi\left(X_{i}\right)$. Then $X^{\prime}$ is a compact metric space since the decomposition $\mathcal{D}$ is upper semicontinuous. The map $g: X \rightarrow X$ induces $g^{\prime}: X^{\prime} \rightarrow X^{\prime}$ which fixes $a^{\prime}$ and, being a factor of $g$, is exact. Notice that $\left.g^{\prime}\right|_{X_{0}^{\prime}}: X_{0}^{\prime} \rightarrow X_{1}^{\prime} \cup X_{2}^{\prime}$ can be written as the composition $\varphi \circ \psi$ with continuous $\psi: X_{0}^{\prime} \rightarrow I$ and $\varphi: I \rightarrow X_{1}^{\prime} \cup X_{2}^{\prime}$. So, analogously as in the proof of Lemma 17, $g^{\prime}$ has dense periodic points. Hence also $g$ has dense periodic points, since whenever $x^{\prime} \neq a^{\prime}$ is a periodic point of $g^{\prime}$, then its only $\pi$-preimage $x$ is a periodic point of $g$.

Finally, we are ready to prove our main result.
Main Theorem. For every non-degenerate totally regular continuum $X$ it holds that $I^{\mathrm{ED}}(X)<\infty$. Moreover, if $X$ contains arbitrarily large generalized stars or $X$ contains a free arc which does not disconnect $X$, then $X$ admits

- a Devaney chaotic map which is not totally Devaney chaotic, and
- an exactly Devaney chaotic map,
both with arbitrarily small positive entropy; hence $I^{\mathrm{ED}}(X)=0$.
Proof. Note that if $X$ contains a non-disconnecting free arc $A$ then, for every $k \geq 2$, $X$ can be written as in Lemma 18 with $X_{1}, \ldots, X_{k}$ being subarcs of $A$. So the theorem immediately follows from Corollary 16 and Lemmas 17, 18

Remark 19. Lemma 18 gives $I^{\mathrm{ED}}(X)=0$ also for some continua containing no non-disconnecting free arc. For example if, for some $m \in\left\{3,4, \ldots, \aleph_{0}\right\}, X$ contains the universal dendrite $D_{m}$ of order $m$ with two point boundary and with connected $X \backslash \operatorname{int}\left(D_{m}\right)$, we again have $I^{\mathrm{ED}}(X)=0$. (Recall that $D_{m}$ is the topologically unique dendrite such that the branch points of it are dense and all have the order m.)
