# Non-abelian Extensions of Lie 2-algebras *

#### Abstract

In this paper, we introduce the notion of derivations of Lie 2-algebras and construct the associated derivation Lie 3-algebra. We prove that isomorphism classes of non-abelian extensions of Lie 2-algebras are classified by equivalence classes of morphisms from a Lie 2-algebra to a derivation Lie 3 -algebra.


## 1 Introduction

Eilenberg and Maclane [6] developed a theory of non-abelian extensions of abstract groups in the 1940s, leading to the low dimensional non-abelian group cohomology. Then there are a lot of analogous results for Lie algebras [1, [8, 7, [16]. Nonabelian extensions of Lie algebras can be described by some linear maps regarded as derivations of Lie algebras. This result was generalized to the case of super Lie algebras in [2], and to the case of Lie algebroids in [4, 11, 15].

Lie 2-algebras are the categorification of Lie algebras 3. In a Lie 2-algebra, the Jacobi identity is replaced by a natural isomorphism, which satisfies its own coherence law, called the Jacobiator identity. The 2 -category of Lie 2-algebras is equivalent to the 2-category of 2 -term $L_{\infty}$-algebras, so people also view a 2 -term $L_{\infty}$-algebra as a Lie 2 -algebra. Associated with any Lie algebra $\mathfrak{k}$, $\mathfrak{k} \xrightarrow{\text { ad }} \operatorname{Der}(\mathfrak{k})$ is a strict Lie 2-algebra, where $\operatorname{Der}(\mathfrak{k})$ is the Lie algebra of the derivations of $\mathfrak{k}$. Any

[^0]non-abelian extension of a Lie algebra $\mathfrak{m}$ by $\mathfrak{k}$ is described by a morphism from $\mathfrak{m}$ (a trivial Lie 2-algebra) to the Lie 2-algebra $\mathfrak{k} \xrightarrow{\text { ad }} \operatorname{Der}(\mathfrak{k})$. Semidirect product Lie 2-algebras and the integration of string type Lie 2-algebras were studied in [13].

In this paper, we study the non-abelian extensions of Lie 2-algebras. To do that, first we develop the theory of derivations of Lie 2-algebras. In general, for an $L_{\infty}$-algebra $L$, degree $p$ derivations of $L$ is defined using coderivations of the coalgebra $\wedge s(L)$ [17]. Concentrate on the case of Lie 2-algebras, by truncation, we construct a strict Lie 2-algebras $\operatorname{Der}(\mathfrak{g})$ associated with derivations, which plays important role when we consider nonabelian extensions of Lie 2-algebras. Motivated by the nonabelian extension theory of Lie algebras, we construct the associated strict Lie 3 -algebra $\operatorname{DER}(\mathfrak{g})$, which we call the derivation Lie 3-algebra. Any non-abelian extension of a Lie 2-algebra $\mathfrak{g}$ by a Lie 2-algebra $\mathfrak{h}$ gives rise to a morphism from $\mathfrak{g}$ to the derivation Lie 3-algebra $\operatorname{DER}(\mathfrak{h})$. Furthermore, the isomorphism classes of extensions are classified by the equivalence classes of such morphisms.

The paper is organized as follows. In Section 2, we recall some basic definitions regarding Lie 2 -algebras and strict Lie 3-algebras. In Section 3, we give the definition of derivations of degree 0 of Lie 2-algebras using explicit formulas. Then by truncation, we obtain the strict Lie 2-algebra $\operatorname{Der}(\mathfrak{g})$ associated with derivations. At last, we construct the associated strict Lie 3-algebra DER( $\mathfrak{g}$ ), which we call the derivation Lie 3-algebra. In Section 4, we prove that by choosing a splitting, any non-abelian extension of the Lie 2-algebra $\mathfrak{g}$ by $\mathfrak{h}$ gives rise to a morphism from $\mathfrak{g}$ to the derivation Lie 3 -algebra $\operatorname{DER}(\mathfrak{h})$ and different splittings give rise to equivalent morphisms. Moreover, there is a one-to-one correspondence between the isomorphism classes of non-abelian extensions and the equivalence classes of morphisms.

## 2 Preliminaries

In this section, we recall some basic concepts and facts about Lie 2-algebras and strict Lie 3-algebras, and see [3, 9, 10] for more details. An $L_{\infty}$-algebra is a graded vector space $L=L_{0} \oplus L_{1} \oplus \cdots$ equipped with a system $\left\{l_{k} \mid 1 \leq k<\infty\right\}$ of linear maps $l_{k}: \wedge^{k} L \longrightarrow L$ of degree $\operatorname{deg}\left(l_{k}\right)=k-2$, where the exterior powers are interpreted in the graded sense and the following relation with Koszul $\operatorname{sign}$ "Ksg" is satisfied for all $n \geq 0$ :

\end{equation*}

where the summation is taken over all $(i, n-i)$-unshuffles with $i \geq 1$. A Lie 2-algebra is a 2 -term $L_{\infty}$-algebra. More precisely, we have

Definition 2.1. [3] A Lie 2-algebra $L$ is 2-term complex of vector spaces $L: L_{1} \xrightarrow{\mathrm{~d}} L_{0}$ with linear maps $\left\{l_{k}: \wedge^{k} L \longrightarrow L, k=2,3\right\}$ of degree $\operatorname{deg}\left(l_{k}\right)=k-2$ satisfying the following equalities

- $\mathrm{d} l_{2}(x, a)=l_{2}(x, \mathrm{~d} a)$,
- $l_{2}(\mathrm{~d} a, b)=l_{2}(a, \mathrm{~d} b)$,
- $l_{2}\left(x, l_{2}(y, z)\right)+l_{2}\left(y, l_{2}(z, x)\right)+l_{2}\left(z, l_{2}(x, y)\right)=\mathrm{d} l_{3}(x, y, z)$,
- $l_{2}\left(x, l_{2}(y, a)\right)+l_{2}\left(y, l_{2}(a, x)\right)+l_{2}\left(a, l_{2}(x, y)\right)=l_{3}(x, y, \mathrm{~d} a)$,
- $l_{3}\left(l_{2}(x, y), z, t\right)+c . p .=l_{2}\left(l_{3}(x, y, z), t\right)+c . p .$,
for any $x, y, z, t \in L_{0}, a, b \in L_{1}$. If $l_{3}=0, L$ is called a strict Lie 2-algebra.
Sometimes we use $[\cdot, \cdot]_{L}$ instead of $l_{2}$ and we denote a Lie 2-algebra by ( $L, \mathrm{~d}, l_{2}, l_{3}$ ).
Let $\mathbb{V}: V_{1} \xrightarrow{\mathrm{~d}} V_{0}$ be a 2-term complex of vector spaces, and we can form a new 2 -term complex of vector spaces $\operatorname{End}(\mathbb{V}): \operatorname{End}^{1}(\mathbb{V}) \xrightarrow{\delta} \operatorname{End}_{\mathrm{d}}^{0}(\mathbb{V})$ by defining $\delta(D)=\mathrm{d} \circ D+D \circ \mathrm{~d}$ for any $D \in \operatorname{End}^{1}(\mathbb{V})$, where $\operatorname{End}^{1}(\mathbb{V})=\operatorname{End}\left(V_{0}, V_{1}\right)$ and

\operatorname{End}_{\mathrm{d}}^{0}(\mathbb{V})=\left\{X=\left(X_{0}, X_{1}\right) \in \operatorname{End}\left(V_{0}, V_{0}\right) \oplus \operatorname{End}\left(V_{1}, V_{1}\right) \mid X_{0} \circ \mathrm{~d}=\mathrm{d} \circ X_{1}\right\}
$$

Define $l_{2}: \wedge^{2} \operatorname{End}(\mathbb{V}) \longrightarrow \operatorname{End}(\mathbb{V})$ by setting:

where $[\cdot, \cdot]_{C}$ is the graded commutator, for any $X, Y \in \operatorname{End}_{\mathrm{d}}^{0}(\mathbb{V})$ and $D, D^{\prime} \in \operatorname{End}^{1}(\mathbb{V})$.
Theorem 2.2. [10, 14] With the above notations, $\left(\operatorname{End}(\mathbb{V}), \delta, l_{2}\right)$ is a strict Lie 2-algebra.
Definition 2.3. Let $\left(L, \mathrm{~d}, l_{2}, l_{3}\right)$ and $\left(L^{\prime}, \mathrm{d}^{\prime}, l_{2}^{\prime}, l_{3}^{\prime}\right)$ be Lie 2-algebras. A Lie 2-algebra morphism $f: L \rightarrow L^{\prime}$ consists of:

- two linear maps $f_{0}: L_{0} \rightarrow L_{0}^{\prime}$ and $f_{1}: L_{1} \rightarrow L_{1}^{\prime}$,
- one skew-symmetric bilinear map $f_{2}: L_{0} \times L_{0} \rightarrow L_{1}^{\prime}$,
such that the following equalities hold for all $x, y, z \in L_{0}, a \in L_{1}$,
- $\mathrm{d}^{\prime} \circ f_{1}=f_{0} \circ \mathrm{~d}$,
- $f_{0} l_{2}(x, y)-l_{2}^{\prime}\left(f_{0}(x), f_{0}(y)\right)=\mathrm{d}^{\prime} f_{2}(x, y)$,
- $f_{1} l_{2}(x, a)-l_{2}^{\prime}\left(f_{0}(x), f_{1}(a)\right)=f_{2}(x, \mathrm{~d} a)$,
- $l_{2}^{\prime}\left(f_{0}(x), f_{2}(y, z)\right)+c . p .+l_{3}^{\prime}\left(f_{0}(x), f_{0}(y), f_{0}(z)\right)=f_{2}\left(l_{2}(x, y), z\right)+c . p .+f_{1}\left(l_{3}(x, y, z)\right)$,
where c.p. means cyclic permutation. If $f_{2}=0$, the morphism $f$ is called a strict morphism.
Definition 2.4. A strict Lie 3-algebra is a graded vector space $L=L_{0} \bigoplus L_{1} \bigoplus L_{2}$ with linear maps $\left\{l_{i}: \wedge^{i} L \rightarrow L, i=1,2\right\}$ of degree $\operatorname{deg}\left(l_{i}\right)=i-2$, satisfying the following equalities for any $x, y, z \in L$ :
(a) $l_{1}^{2}=0$,
(b) $l_{1} l_{2}(x, y)=l_{2}\left(l_{1}(x), y\right)+(-1)^{|x|} l_{2}\left(x, l_{1}(y)\right)$,
(c) $(-1)^{|x||z|} l_{2}\left(l_{2}(x, y), z\right)+(-1)^{|x||y|} l_{2}\left(l_{2}(y, z), x\right)+(-1)^{|y||z|} l_{2}\left(l_{2}(z, x), y\right)=0$.

Definition 2.5. Let $\left(L, \mathrm{~d}, l_{2}, l_{3}\right)$ be a Lie 2-algebra and $\left(L^{\prime}, \mathrm{d}^{\prime}, l_{2}^{\prime}\right)$ be a strict Lie 3-algebra. A morphism from $L$ to $L^{\prime}$ consists of:

- two linear maps $f_{0}: L_{0} \longrightarrow L_{0}^{\prime}$ and $f_{1}: L_{1} \longrightarrow L_{1}^{\prime}$,
- two skew-symmetric bilinear maps $f_{2}^{0}: L_{0} \times L_{0} \longrightarrow L_{1}^{\prime}$ and $f_{2}^{1}: L_{0} \times L_{1} \longrightarrow L_{2}^{\prime}$,
- one skew-symmetric trilinear map $f_{3}: L_{0} \times L_{0} \times L_{0} \longrightarrow L_{2}^{\prime}$,
such that for all $x, y, z, t \in L_{0}, a, b \in L_{1}$, we have

f_{1} l_{2}(x, a)-l_{2}^{\prime}\left(f_{0}(x), f_{1}(a)\right) & =f_{2}^{0}(x, \mathrm{~d}(a))+\mathrm{d}^{\prime} f_{2}^{1}(x, a), \\
l_{2}^{\prime}\left(f_{1}(a), f_{1}(b)\right) & =f_{2}^{1}(a, \mathrm{~d}(b))-f_{2}^{1}(\mathrm{~d}(a), b), \\
f_{2}^{0}\left(l_{2}(x, y), z\right)+c . p .+f_{1}\left(l_{3}(x, y, z)\right) & =l_{2}^{\prime}\left(f_{0}(x), f_{2}^{0}(y, z)\right)+c . p .+\mathrm{d}^{\prime} f_{3}(x, y, z), \\
f_{2}^{1}\left(l_{2}(x, y), a\right)+c . p .+f_{3}(x, y, \mathrm{~d} a) & =l_{2}^{\prime}\left(f_{0}(x), f_{2}^{1}(y, a)\right)+l_{2}^{\prime}\left(f_{0}(y), f_{2}^{1}(a, x)\right)-l_{2}^{\prime}\left(f_{1}(a), f_{2}^{0}(x, y)\right),
\end{aligned}
$$

and
$f_{2}^{1}\left(x, l_{3}(y, z, t)\right)+l_{2}^{\prime}\left(f_{0}(x), f_{3}(y, z, t)\right)+c . p .=f_{3}\left(l_{2}(x, y), z, t\right)+c . p .+\left(l_{2}^{\prime}\left(f_{2}^{0}(x, y), f_{2}^{0}(z, t)\right)+c . p.\right)$.

## 3 Derivations of Lie 2-algebras

For a graded vector space $L$, there is a natural coalgebra structure on $\wedge s(L)$, where $s(L)$ is the graded vector space shifted by 1 . Another equivalent definition of an $L_{\infty}$ structure on $L$ is a coderivation $\partial$ of degree -1 satisfying $\partial^{2}=0$ on the coalgebra $\wedge s(L)$. See [5, 10] for more details.

Definition 3.1. [17] A derivation of degree $p \geq 1$ of an $L_{\infty}$-algebra $L$ is a coderivation $f \in$ $\operatorname{Coder}^{p}(\wedge s(L))$ of degree $p$ of the coalgebra $\wedge s(L)$. A derivation of degree 0 of an $L_{\infty}$-algebra $L$ is a coderivation of degree 0 of the coalgebra $\wedge s(L)$, which is commutative with $\partial$.

Denote by $\overline{\operatorname{Der}^{p \geq 1}}(L)$ the set of degree $p$ derivations of $L$ and $\operatorname{Der}^{0}(L)$ the set of degree 0 derivations of $L$, then we have a differential graded Lie algebra [17]

\longrightarrow \overline{\operatorname{Der}^{p}}(L) \xrightarrow{[\partial, \cdot]} \cdots \xrightarrow{[\partial, \cdot]} \operatorname{Der}^{0}(L) \longrightarrow 0 .
$$

Concentrate on the case of Lie 2-algebras, we can give the definition of derivations of degree 0 of Lie 2-algebras using explicit formulas as follows.

Definition 3.2. Let $\left(\mathfrak{g}: \mathfrak{g}_{1} \xrightarrow{\mathrm{~d}_{\mathfrak{g}}} \mathfrak{g}_{0},[\cdot, \cdot]_{\mathfrak{g}}, l_{3}^{\mathfrak{g}}\right)$ be a Lie 2-algebra. A derivation of degree 0 of $\mathfrak{g}$ consists of

- an element $X \in \operatorname{End}_{\mathrm{d}}^{0}(\mathfrak{g})$,
- a skew-symmetric bilinear map $l_{X}: \mathfrak{g}_{0} \times \mathfrak{g}_{0} \longrightarrow \mathfrak{g}_{1}$,
such that for all $x, y, z \in \mathfrak{g}_{0}$ and $a \in \mathfrak{g}_{1}$
(a) $\quad X[x, y]_{\mathfrak{g}}-[X x, y]_{\mathfrak{g}}-[x, X y]_{\mathfrak{g}}=\mathrm{d}_{\mathfrak{g}} l_{X}(x, y)$,
(b) $\quad X[x, a]_{\mathfrak{g}}-[X x, a]_{\mathfrak{g}}-[x, X a]_{\mathfrak{g}}=l_{X}\left(x, \mathrm{~d}_{\mathfrak{g}} a\right)$,
(c) $\quad l_{X}\left(x,[y, z]_{\mathfrak{g}}\right)+\left[x, l_{X}(y, z)\right]_{\mathfrak{g}}+l_{3}^{\mathfrak{g}}(X x, y, z)+l_{3}^{\mathfrak{g}}(x, X y, z)+l_{3}^{\mathfrak{g}}(x, y, X z)$
$=X l_{3}^{\mathfrak{g}}(x, y, z)+l_{X}\left([x, y]_{\mathfrak{g}}, z\right)+l_{X}\left(y,[x, z]_{\mathfrak{g}}\right)+\left[l_{X}(x, y), z\right]_{\mathfrak{g}}+\left[y, l_{X}(x, z)\right]_{\mathfrak{g}}$.
We denote a derivation of degree 0 of $\mathfrak{g}$ by $\left(X, l_{X}\right)$ and the set of derivations of degree 0 of $\mathfrak{g}$ by $\operatorname{Der}^{0}(\mathfrak{g})$.

Remark 3.3. In a strict case, derivations of Lie 2-algebras can be realized as normalizers of the corresponding Dirac structures in omni-Lie 2-algebras (see Section 4 in [14] for more details).

Example 3.4. For any $x \in \mathfrak{g}_{0}$, define $\operatorname{ad}_{x} \in \operatorname{End}_{\mathrm{d}}^{0}(\mathfrak{g})$ by $\operatorname{ad}_{x}(y+a)=[x, y+a]_{\mathfrak{g}}$ for any $y \in \mathfrak{g}_{0}$ and $a \in \mathfrak{g}_{1}$, then $\left(\operatorname{ad}_{x}, l_{\operatorname{ad}_{x}}=l_{3}^{\mathfrak{g}}(x, \cdot, \cdot)\right) \in \operatorname{Der}^{0}(\mathfrak{g})$, which we call an inner derivation.

For any $\left(X, l_{X}\right),\left(Y, l_{Y}\right) \in \operatorname{Der}^{0}(\mathfrak{g})$, and $x, y \in \mathfrak{g}_{0}$, we have

= & X\left([Y x, y]_{\mathfrak{g}}+[x, Y y]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{g}} l_{Y}(x, y)\right)-Y\left([X x, y]_{\mathfrak{g}}+[x, X y]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{g}} l_{X}(x, y)\right) \\
& -[X(Y x)-Y(X x), y]_{\mathfrak{g}}-[x, X(Y y)-Y(X y)]_{\mathfrak{g}} \\
= & {[X(Y x), y]_{\mathfrak{g}}+[Y x, X y]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{g}} l_{X}(Y x, y)+[X x, Y y]_{\mathfrak{g}}+[x, X(Y y)]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{g}} l_{X}(x, Y y) } \\
& -[Y(X x), y]_{\mathfrak{g}}-[X x, Y y]_{\mathfrak{g}}-\mathrm{d}_{\mathfrak{g}} l_{Y}(X 0 x, y)-[Y x, X y]_{\mathfrak{g}}-[x, Y(X y)]_{\mathfrak{g}}-\mathrm{d}_{\mathfrak{g}} l_{Y}(x, X y) \\
& +X \mathrm{~d}_{\mathfrak{g}} l_{Y}(x, y)-Y \mathrm{~d}_{\mathfrak{g}} l_{X}(x, y)-[X(Y x), y]_{\mathfrak{g}}+[Y(X x), y]_{\mathfrak{g}}-[x, X(Y y)]_{\mathfrak{g}}+[x, Y(X y)]_{\mathfrak{g}} \\
= & \mathrm{d}_{\mathfrak{g}}\left(l_{X}(Y x, y)+l_{X}(x, Y y)-l_{Y}(X x, y)-l_{Y}(x, X y)+X l_{Y}(x, y)-Y l_{X}(x, y)\right) .
\end{aligned}
$$

It is straightforward to see that

l_{[X, Y]_{C}}(x, y) \triangleq l_{X}(Y x, y)+l_{X}(x, Y y)-l_{Y}(X x, y)-l_{Y}(x, X y)+X l_{Y}(x, y)-Y l_{X}(x, y) \tag{2}
\end{equation*}

satisfies Condition (c) in Definition 3.2. Thus, there is a well-defined bilinear skew-symmetric map $[\cdot, \cdot]_{\text {Der }}: \wedge^{2} \operatorname{Der}^{0}(\mathfrak{g}) \longrightarrow \operatorname{Der}^{0}(\mathfrak{g}):$

\left[\left(X, l_{X}\right),\left(Y, l_{Y}\right)\right]_{\mathrm{Der}} \triangleq\left([X, Y]_{C}, l_{[X, Y]_{C}}\right) \tag{3}
\end{equation*}

For any $\left(X, l_{X}\right),\left(Y, l_{Y}\right),\left(Z, l_{Z}\right) \in \operatorname{Der}^{0}(\mathfrak{g})$, it is straightforward to deduce that

l_{\left[X,[Y, Z]_{C}\right]_{C}}+l_{\left[Y,[Z, X]_{C}\right]_{C}}+l_{\left[Z,[X, Y]_{C}\right]_{C}}=0
$$

Thus, we have
Lemma 3.5. With the above notations, $\left(\operatorname{Der}^{0}(\mathfrak{g}),[\cdot, \cdot]_{\text {Der }}\right)$ is a Lie algebra.
By Definition 3.1, the degree 1-derivation $\overline{\operatorname{Der}^{1}}(\mathfrak{g})=\operatorname{Coder}^{1}(\wedge s(L))$ is given by

\overline{\operatorname{Der}^{1}}(\mathfrak{g})=\operatorname{End}^{1}(\mathfrak{g}) \oplus \operatorname{End}\left(\mathfrak{g}_{0}, \wedge^{2} \mathfrak{g}_{0}\right) \oplus \operatorname{End}\left(\mathfrak{g}_{1}, \wedge^{3} \mathfrak{g}_{0}\right) .
$$

However, we find out that a smaller, thus simpler, sub-Lie 2-algebra of the above (see Theorem 3.7) is enough for the application of non-abelian extensions in our setting. Thus by truncation, we obtain a smaller Lie 2-algebra, which plays essential role when we consider extensions of Lie 2-algebras in Section 4. To do that, first we consider the complex $\operatorname{End}^{1}(\mathfrak{g}) \xrightarrow{\bar{\delta}} \operatorname{End}^{0}(\mathfrak{g}) \oplus \operatorname{Hom}\left(\wedge^{2} \mathfrak{g}_{0}, \mathfrak{g}_{1}\right)$, where $\bar{\delta}$ is given by

Define a bilinear skew-symmetric map $[\cdot, \cdot]_{\text {Der }}: \operatorname{Der}^{0}(\mathfrak{g}) \wedge \operatorname{Der}^{1}(\mathfrak{g}) \longrightarrow \operatorname{Der}^{1}(\mathfrak{g})$ by:

Proof. By Theorem 2.2 and Lemma [3.5, we only need to prove that $\bar{\delta}$ is a graded derivation with respect to the bracket operation $[\cdot, \cdot]_{\text {Der }}$, i.e.

Equation (9) holds since we have $[\delta(D), E]_{C}=[D, \delta(E)]_{C}$. This finishes the proof.
In the classical case of Lie algebras, a nonabelian extension

can be described by a morphism from the Lie algebra $\mathfrak{g}$ to the strict Lie 2-algebra $\mathfrak{k} \xrightarrow{\text { ad }} \operatorname{Der}(\mathfrak{k})$ by choosing a splitting. Thus, we can see that only considering the derivation Lie algebra $\operatorname{Der}(\mathfrak{k})$ is not enough, we have to extend it to a Lie 2-algebra. Motivated by this, if we consider extensions of Lie 2-algebras, we have to extend the strict Lie 2-algebra $\operatorname{Der}(\mathfrak{g})$ given in Theorem 3.7 to a strict Lie 3-algebra.

Associated with the 2-term complex $\operatorname{Der}(\mathfrak{g})$, we can form a 3 -term complex of vector spaces

whose degree 0 part $\operatorname{DER}^{0}(\mathfrak{g})$ is $\operatorname{Der}^{0}(\mathfrak{g})$, degree 1 part $\operatorname{DER}^{1}(\mathfrak{g})$ is $\operatorname{Der}^{1}(\mathfrak{g}) \oplus \mathfrak{g}_{0}$, degree 2 part $\operatorname{DER}^{2}(\mathfrak{g})$ is $\mathfrak{g}_{1}$ and for any $a \in \mathfrak{g}_{1},(D, x) \in \operatorname{Der}^{1}(\mathfrak{g}) \oplus \mathfrak{g}_{0}, \mathrm{~d}_{\mathrm{D}}$ is given by

Theorem 3.8. With the above notations, $\left(\operatorname{DER}(\mathfrak{g}), \mathrm{d}_{\mathrm{D}},[\cdot, \cdot]_{\mathrm{DER}}\right)$ is a strict Lie 3-algebra, which we call the derivation Lie 3-algebra of $\mathfrak{g}$.

[^1]Proof. We only need to show that $d_{D}$ is a graded derivation with respect to the bracket operation $[\cdot, \cdot]_{\text {DER }}$, and $[\cdot, \cdot]_{\text {DER }}$ satisfies the graded Jacobi identity. The condition that $d_{D}$ is a graded derivation is equivalent to

Assume that $f=$ $\left(f_{0}, f_{1}, f_{2}^{0}, f_{2}^{1}, f_{3}\right)$ and $f^{\prime}=\left(f_{0}^{\prime}, f_{1}^{\prime}, f_{2}^{0^{\prime}}, f_{2}^{1^{\prime}}, f_{3}^{\prime}\right)$ are two morphisms from $\mathfrak{g}$ to $\operatorname{DER}(\mathfrak{h})$. We say that $f^{\prime}$ is equivalent to $f$ if there exist:

- linear maps $b_{0}: \mathfrak{g}_{0} \longrightarrow \mathfrak{h}_{0}$ and $b_{1}: \mathfrak{g}_{1} \longrightarrow \mathfrak{h}_{1}$,
- a bilinear map $b_{2}: \wedge^{2} \mathfrak{g}_{0} \longrightarrow \mathfrak{h}_{1}$,
such that $\left(b_{0}, b_{1}\right)$ is a chain homotopy from $\left(f_{0}^{\prime}, f_{1}^{\prime}\right)$ to $\left(f_{0}, f_{1}\right)$ :

\left(f_{2}^{1^{\prime}}-f_{2}^{1}\right)(x, a)= & {\left[f_{0}^{\prime}(x), b_{1}(a)\right]_{\mathrm{DER}}+\left[f_{1}^{\prime}(a), b_{0}(x)\right]_{\mathrm{DER}}-b_{1}\left([x, a]_{\mathfrak{g}}\right) } \\
& +\left[\mathrm{d}_{\mathrm{D}} b_{0}(x), b_{1}(a)\right]_{\mathrm{DER}}+b_{2}\left(x, \mathrm{~d}_{\mathfrak{g}} a\right), \\
\left(f_{3}^{\prime}-f_{3}\right)(x, y, z)= & {\left[f_{0}^{\prime}(x), b_{2}(y, z)\right]_{\mathrm{DER}}-b_{2}\left([x, y]_{\mathfrak{g}}, z\right)+c . p . } \\
& +\left[f_{2}^{0^{\prime}}(x, y), b_{0}(z)\right]_{\mathrm{DER}}+\left[\mathrm{d}_{\mathrm{D}} b_{0}(x), b_{2}(y, z)\right]_{\mathrm{DER}}+l_{f_{0}^{\prime}(x)}\left(b_{0}(y), b_{0}(z)\right)+c . p . \\
& -b_{1}\left(l_{3}^{\mathfrak{g}}(x, y, z)\right)+l_{3}^{\mathfrak{G}}\left(b_{0}(x), b_{0}(y), b_{0}(z)\right) .

Remark 3.10. Let $\mathfrak{h}=\left(0 \xrightarrow{0} \mathfrak{h}_{0},[\cdot, \cdot]_{\mathfrak{h}_{0}}, l_{3}=0\right)$ be the trivial Lie 2-algebra determined by a Lie algebra $\mathfrak{h}_{0}$, then the Lie 3-algebra $\operatorname{DER}(\mathfrak{h})$ reduces to the well-known Lie 2-algebra $\mathfrak{h}_{0} \xrightarrow{\text { ad }} \operatorname{Der}\left(\mathfrak{h}_{0}\right)$. Two morphisms $f=\left(f_{0}, f_{1}, f_{2}^{0}\right)$ and $f^{\prime}=\left(f_{0}^{\prime}, f_{1}^{\prime}, f_{2}^{0^{\prime}}\right)$ from $\mathfrak{g}$ to $\mathfrak{h}_{0} \xrightarrow{\text { ad }} \operatorname{Der}\left(\mathfrak{h}_{0}\right)$ are equivalent if and only if there is a linear map $b_{0}: \mathfrak{g}_{0} \longrightarrow \mathfrak{h}_{1}$ such that

\end{aligned}

i.e. $b_{0}$ is a 2-morphism from $f^{\prime}$ to $f$ in the sense of Baez-Crans [3].

## 4 Non-abelian Extensions of Lie 2-algebras

Definition 4.1. (i) Let $\mathfrak{g}: \mathfrak{g}_{1} \longrightarrow \mathfrak{g}_{0}, \mathfrak{h}: \mathfrak{h}_{1} \longrightarrow \mathfrak{h}_{0}$, $\hat{\mathfrak{g}}: \hat{\mathfrak{g}}_{1} \longrightarrow \hat{\mathfrak{g}}_{0}$ be Lie 2-algebras and $i=\left(i_{1}, i_{0}\right): \mathfrak{h} \longrightarrow \hat{\mathfrak{g}}, p=\left(p_{1}, p_{0}\right): \hat{\mathfrak{g}} \longrightarrow \mathfrak{g}$ be strict morphisms. The following sequence of Lie 2-algebras is a short exact sequence if $\operatorname{Im}(i)=\operatorname{Ker}(p), \operatorname{Ker}(i)=0$ and $\operatorname{Im}(p)=\mathfrak{g}$.


We call $\hat{\mathfrak{g}}$ an extension of $\mathfrak{g}$ by $\mathfrak{h}$, and denote it by $\mathrm{E}_{\hat{\mathfrak{g}}}$.
(ii) A splitting $\sigma: \mathfrak{g} \longrightarrow \hat{\mathfrak{g}}$ of $p: \hat{\mathfrak{g}} \longrightarrow \mathfrak{g}$ consists of linear maps $\sigma_{0}: \mathfrak{g}_{0} \longrightarrow \hat{\mathfrak{g}}_{0}$ and $\sigma_{1}: \mathfrak{g}_{1} \longrightarrow \hat{\mathfrak{g}}_{1}$ such that $p_{0} \circ \sigma_{0}=i d_{\mathfrak{g}_{0}}$ and $p_{1} \circ \sigma_{1}=i d_{\mathfrak{g}_{1}}$.
(iii) We say that two extensions of Lie 2-algebras $\mathrm{E}_{\hat{\mathfrak{g}}}: \mathfrak{h} \xrightarrow{i} \hat{\mathfrak{g}} \xrightarrow{p} \mathfrak{g}$ and $\mathrm{E}_{\tilde{\mathfrak{g}}}: \mathfrak{h} \xrightarrow{j} \tilde{\mathfrak{g}} \xrightarrow{q} \mathfrak{g}$ are isomorphic if there exists a Lie 2-algebra morphism $F: \hat{\mathfrak{g}} \longrightarrow \tilde{\mathfrak{g}}$ such that $F \circ i=j, q \circ F=p$ and $F_{2}(i(u), \alpha)=0$, for any $u \in \mathfrak{h}_{0}, \alpha \in \hat{\mathfrak{g}}_{0}$.

In the sequel, we will write an element $\left(X, l_{X}\right) \in \operatorname{Der}^{0}(\mathfrak{h})$, by $X$ to simplify the computation.
Given a splitting $\sigma$, we have $\hat{\mathfrak{g}}_{0} \cong \mathfrak{g}_{0} \oplus \mathfrak{h}_{0}$ and $\hat{\mathfrak{g}}_{1} \cong \mathfrak{g}_{1} \oplus \mathfrak{h}_{1}$ as vector spaces. Furthermore, $\left(i_{0}, i_{1}\right)$ are inclusions and $\left(p_{0}, p_{1}\right)$ are projections. $\sigma$ induces linear maps:

for any $x, y, z \in \mathfrak{g}_{0}, a \in \mathfrak{g}_{1}, u \in \mathfrak{h}_{0}$ and $m \in \mathfrak{h}_{1}$.

Proposition 4.2. The splitting $\sigma$ induces a morphism

from the Lie 2-algebra $\mathfrak{g}$ to the derivation Lie 3-algebra $\operatorname{DER}(\mathfrak{h})$. Moreover, different splittings give equivalent morphisms.

= & \hat{l_{3}}\left(\sigma x, \sigma y, \sigma\left(\mathrm{~d}_{\mathfrak{g}} a\right)+\varphi(a)\right) \\
= & \sigma l_{3}^{\mathfrak{g}}\left(x, y, \mathrm{~d}_{\mathfrak{g}} a\right)-\theta\left(x, y, \mathrm{~d}_{\mathfrak{g}} a\right)+\mu_{2}(x, y) \varphi(a),
\end{aligned}
$$

which implies that

$$
\begin{align*}
& {\left[f_{0}(x), f_{2}^{1}(y, a)\right]_{\mathrm{DER}}+\left[f_{0}(y), f_{2}^{1}(a, x)\right]_{\mathrm{DER}}-\left[f_{1}(a), f_{2}^{0}(x, y)\right]_{\mathrm{DER}} } \\
= & {\left[\mu_{0}(x), \nu(y, a)\right]_{\mathrm{DER}}+\left[\mu_{0}(y), \nu(a, x)\right]_{\mathrm{DER}}-\left[\left(\mu_{1}-\varphi\right)(a),\left(-\mu_{2}+\omega\right)(x, y)\right]_{\mathrm{DER}} } \\
= & \nu\left([x, y]_{\mathfrak{g}}, a\right)+\nu\left([y, a]_{\mathfrak{g}}, x\right)+\nu\left([a, x]_{\mathfrak{g}}, y\right)+\theta\left(x, y, \mathrm{~d}_{\mathfrak{g}} a\right) \\
= & f_{2}^{1}\left([x, y]_{\mathfrak{g}}, a\right)+f_{2}^{1}\left([y, a]_{\mathfrak{g}}, x\right)+f_{2}^{1}\left([a, x]_{\mathfrak{g}}, y\right)+f_{3}\left(x, y, \mathrm{~d}_{\mathfrak{g}} a\right) . \tag{33}
\end{align*}
$$

Since for any $x, y, z, t \in \mathfrak{g}_{0}$,

$$
\hat{l_{3}}\left([\sigma x, \sigma y]_{\hat{\mathfrak{g}}}, \sigma z, \sigma t\right)+c . p .=\left[\sigma x, \hat{l_{3}}(\sigma y, \sigma z, \sigma t)\right]_{\hat{\mathfrak{g}}}+c . p . .
$$

The left hand side is equal to

$$
\begin{aligned}
& \hat{l_{3}}\left(\sigma[x, y]_{\mathfrak{g}}-\omega(x, y), \sigma z, \sigma t\right)+c . p . \\
= & \sigma l_{3}^{\mathfrak{g}}\left([x, y]_{\mathfrak{g}}, z, t\right)-\theta\left([x, y]_{\mathfrak{g}}, z, t\right)-\mu_{2}(z, t) \omega(x, y)+c . p .
\end{aligned}
$$

and the right hand side is equal to

$$
\begin{aligned}
& {\left[\sigma x, \sigma l_{3}^{\mathfrak{g}}(y, z, t)-\theta(y, z, t)\right]_{\hat{\mathfrak{g}}}+c . p . } \\
= & \sigma\left[x, l_{3}^{\mathfrak{g}}(y, z, t)\right]_{\mathfrak{g}}-\nu\left(x, l_{3}^{\mathfrak{g}}(y, z, t)\right)-\mu_{0}(x) \theta(y, z, t)+c . p .
\end{aligned}
$$

Thus, we have

$$
\begin{align*}
& {\left[f_{0}(x), f_{3}(y, z, t)\right]_{\mathrm{DER}}+f_{2}^{1}\left(x, l_{3}^{\mathfrak{g}}(y, z, t)\right)+c . p . } \\
= & {\left[\mu_{0}(x), \theta(y, z, t)\right]_{\mathrm{DER}}+\nu\left(x, l_{3}^{\mathfrak{g}}(y, z, t)\right)+c \cdot p . } \\
= & \theta\left([x, y]_{\mathfrak{g}}, z, t\right)+\mu_{2}(z, t) \omega(x, y)+c \cdot p . \\
= & f_{3}\left([x, y]_{\mathfrak{g}}, z, t\right)+\left[f_{2}^{0}(x, y), f_{2}^{0}(z, t)\right]_{\mathrm{DER}}+c . p . . \tag{34}
\end{align*}
$$

By (22), (25),(27), (28), (31),(33),(34), we obtain that $f$ is a morphism from $\mathfrak{g}$ to $\operatorname{DER}(\mathfrak{h})$.
Given another splitting $\sigma^{\prime}$ of the extension, there are the induced linear maps ( $\varphi^{\prime}, \mu_{0}^{\prime}, \mu_{1}^{\prime}, \mu_{2}^{\prime}, \omega^{\prime}, \nu^{\prime}, \theta^{\prime}$ ) such that

$$
f^{\prime}=\left(f_{0}^{\prime}, f_{1}^{\prime}, f_{2}^{0^{\prime}}, f_{2}^{1^{\prime}}, f_{3}^{\prime}\right)=\left(\mu_{0}^{\prime}, \mu_{1}^{\prime}-\varphi^{\prime},-\mu_{2}^{\prime}+\omega^{\prime}, \nu^{\prime}, \theta^{\prime}\right)
$$

is a morphism from $\mathfrak{g}$ to $\operatorname{DER}(\mathfrak{h})$. Assume that

$$
\sigma(x)=\sigma^{\prime}(x)+b_{0}(x), \quad \sigma(a)=\sigma^{\prime}(a)+b_{1}(a)
$$

where $b_{0}: \mathfrak{g}_{0} \longrightarrow \mathfrak{h}_{0}$ and $b_{1}: \mathfrak{g}_{1} \longrightarrow \mathfrak{h}_{1}$ are linear maps. Then it is straightforward to deduce that

$$
\begin{aligned}
\mu_{0}(x)-\mu_{0}^{\prime}(x) & =\operatorname{ad}\left(b_{0}(x)\right) \\
\varphi^{\prime}(a)-\varphi(a) & =b_{0}\left(\mathrm{~d}_{\mathfrak{g}} a\right)-\mathrm{d}_{\mathfrak{h}} b_{1}(a) \\
\mu_{1}(a)-\mu_{1}^{\prime}(a) & =\operatorname{ad}_{b_{1}(a)} \\
\left(\mu_{2}-\mu_{2}^{\prime}\right)(x, y) & =l_{\mu_{0}^{\prime}(x)}\left(b_{0}(y), \cdot\right)-l_{\mu_{0}^{\prime}(y)}\left(b_{0}(x), \cdot\right)+l_{3}^{\mathfrak{h}}\left(b_{0}(x), b_{0}(y), \cdot\right), \\
\left(\omega^{\prime}-\omega\right)(x, y) & =\mu_{0}^{\prime}(x) b_{0}(y)-\mu_{0}^{\prime}(y) b_{0}(x)+\left[b_{0}(x), b_{0}(y)\right]_{\mathfrak{h}}-b_{0}[x, y]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{h}} \circ b_{2}(x, y), \\
\left(\nu^{\prime}-\nu\right)(x, a) & =\mu_{0}^{\prime}(x)\left(b_{1}(a)\right)-\mu_{1}^{\prime}(a)\left(b_{0}(x)\right)-b_{1}\left([x, a]_{\mathfrak{g}}\right)+\left[b_{0}(x), b_{1}(a)\right]_{\mathfrak{h}}, \\
\left(\theta^{\prime}-\theta\right)(x, y, z) & =\mu_{2}^{\prime}(x, y) b_{0}(z)+l_{\mu_{0}^{\prime}(x)}\left(b_{0}(y), b_{0}(z)\right)+c \cdot p .-b_{1}\left(l_{3}^{\mathfrak{g}}(x, y, z)\right)+l_{3}^{\mathfrak{h}}\left(b_{0}(x), b_{0}(y), b_{0}(z)\right)
\end{aligned}
$$

Then it is straightforward to see that $f^{\prime}$ is equivalent to $f$ via $\left(b_{0}, b_{1}, b_{2}=0\right)$.
Thus by choosing a splitting, we can transfer the Lie 2-algebra structure on $\hat{\mathfrak{g}}$ to $\mathfrak{g} \oplus \mathfrak{h}$, which we denote by $\left(\widehat{\mathfrak{g} \oplus \mathfrak{h}}, \hat{\mathrm{d}},\left[\cdot, \widehat{,}, \hat{l_{3}}\right)\right.$ :

\hat{\mathrm{d}}(a+m) \triangleq & \mathrm{d}_{\mathfrak{g}}(a)+\varphi(a)+\mathrm{d}_{\mathfrak{h}}(m),  \tag{35}\\
{[x+u, y+v]} & & {[x, y]_{\mathfrak{g}}-\omega(x, y)+\mu_{0}(x) v-\mu_{0}(y) u+[u, v]_{\mathfrak{h}},} \\
{[x+u, a+m] \triangleq} & {[x, a]_{\mathfrak{g}}-\nu(x, a)+\mu_{0}(x) m-\mu_{1}(a) u+[u, m]_{\mathfrak{h}},} \\
\hat{l_{3}}(x+u, y+v, z+w) \triangleq & l_{3}^{\mathfrak{g}}(x, y, z)-\theta(x, y, z)+l_{3}^{\mathfrak{h}}(u, v, w) \\
& +\mu_{2}(x, y)(w)+\mu_{2}(z, x)(v)+\mu_{2}(y, z)(u) \\
& +l_{\mu_{0}(x)}(v, w)+l_{\mu_{0}(y)}(w, u)+l_{\mu_{0}(z)}(u, v),
\end{array}\right.
$$

for any $x, y, z \in \mathfrak{g}_{0}, u, v, w \in \mathfrak{h}_{0}, a \in \mathfrak{g}_{1}$ and $m \in \mathfrak{h}_{1}$.
Thus any extension $E_{\hat{\mathfrak{g}}}$ given by (20) is isomorphic to

where the Lie 2-algebra structure on $\mathfrak{g} \oplus \mathfrak{h}$ is given by (35) for some morphism (21), ( $i_{0}, i_{1}$ ) is the inclusion and $\left(p_{0}, p_{1}\right)$ is the projection. We denote the extension (36) by $\widehat{\mathrm{E}}_{\mathfrak{g} \oplus \mathfrak{h}}$.

Theorem 4.3. There is a 1-1 correspondence between isomorphism classes of extensions of Lie 2-algebras given by (36) and equivalence classes of morphisms (21) from the Lie 2-algebra $\mathfrak{g}$ to the derivation Lie 3-algebra $\operatorname{DER}(\mathfrak{h})$.

Proof. Given two isomorphic extensions $\hat{\mathrm{E}}_{\mathfrak{g} \oplus \mathfrak{h}}$ and $\mathrm{E}_{\mathfrak{g} \oplus \mathfrak{h}}^{\prime}$. Let $F=\left(F_{0}, F_{1}, F_{2}\right): \hat{\mathrm{E}}_{\mathfrak{g} \oplus \mathfrak{h}} \longrightarrow \mathrm{E}_{\mathfrak{g} \oplus \mathfrak{h}}^{\prime}$ be the corresponding isomorphism. By choosing two splittings $\sigma$ and $\sigma^{\prime}$ respectively, we get two morphisms $f$ and $f^{\prime}$ from $\mathfrak{g}$ to $\operatorname{DER}(\mathfrak{h})$. In the following, we prove that $f^{\prime}$ is equivalent to $f$.

Since $F$ is an isomorphism of extensions, we have

$$
F_{2}(u, v)=0, \quad F_{2}(x, u)=0, \quad F_{2}(x, y) \in \mathfrak{h}_{1}
$$

and there exist two linear maps $\psi_{0}: \mathfrak{g}_{0} \longrightarrow \mathfrak{h}_{0}$ and $\psi_{1}: \mathfrak{g}_{1} \longrightarrow \mathfrak{h}_{1}$ such that

$$
F_{0}(x+u)=x+\psi_{0}(x)+u, \quad F_{1}(a+m)=a+\psi_{1}(a)+m .
$$

Set $b_{0}=\psi_{0}, b_{1}=\psi_{1}$ and $b_{2}=F_{2}$.
By

$$
\begin{aligned}
F_{0}([x, u])-\left[F_{0}(x), F_{0}(u)\right]^{\prime} & =0 \\
F_{1}([x, m])-\left[F_{0}(x), F_{1}(m)\right]^{\prime} & =0
\end{aligned}
$$

we get

$$
\begin{aligned}
\left(\mu_{0}(x)-\mu_{0}^{\prime}(x)\right)(u) & =\operatorname{ad}_{\psi_{0}(x)}(u) \\
\left(\mu_{0}(x)-\mu_{0}^{\prime}(x)\right)(m) & =\operatorname{ad}_{\psi_{0}(x)}(m)
\end{aligned}
$$

which implies that

$$
\begin{equation*}
\left(f_{0}-f_{0}^{\prime}\right)(x)=\mu_{0}(x)-\mu_{0}^{\prime}(x)=\mathrm{d}_{\mathrm{D}}\left(\psi_{0}(x)\right)=\mathrm{d}_{\mathrm{D}}\left(b_{0}(x)\right) \tag{37}
\end{equation*}
$$

We also have

$$
\begin{aligned}
\mathrm{d}^{\prime} F_{1}(a) & =F_{0} \hat{\mathrm{~d}}(a), \\
F_{1}([u, a])-\left[F_{0}(u), F_{1}(a)\right]^{\prime} & =0,
\end{aligned}
$$

which implies that

$$
\begin{aligned}
\varphi^{\prime}(a)-\varphi(a) & =\psi_{0}\left(\mathrm{~d}_{\mathfrak{g}} a\right)-\mathrm{d}_{\mathfrak{h}} \psi_{1}(a), \\
\mu_{1}(a)-\mu_{1}^{\prime}(a) & =\operatorname{ad}_{\psi_{1}(a)} .
\end{aligned}
$$

Therefore, we have

$$
\begin{align*}
\left(f_{1}-f_{1}^{\prime}\right)(a) & =\left(\mu_{1}-\varphi\right)(a)-\left(\mu_{1}^{\prime}-\varphi^{\prime}\right)(a)=\mathrm{d}_{\mathrm{D}}\left(\psi_{1}(a)\right)+\psi_{0}\left(\mathrm{~d}_{\mathfrak{g}} a\right) \\
& =\mathrm{d}_{\mathrm{D}}\left(b_{1}(a)\right)+b_{0}\left(\mathrm{~d}_{\mathfrak{g}} a\right) . \tag{38}
\end{align*}
$$

Furthermore, we have

$$
F_{0}[x, y]-\left[F_{0}(x), F_{0}(y)\right]^{\prime}=\mathrm{d}^{\prime} F_{2}(x, y)
$$

which implies that

$$
\omega^{\prime}(x, y)-\omega(x, y)=\mu_{0}^{\prime}(x) b_{0}(y)-\mu_{0}^{\prime}(y) b_{0}(x)+\left[b_{0}(x), b_{0}(y)\right]_{\mathfrak{h}}-b_{0}[x, y]_{\mathfrak{g}}+\mathrm{d}_{\mathfrak{h}} \circ b_{2}(x, y)
$$

Since $F$ is a Lie 2-algebra morphism, we have the equality:

$$
\left[F_{0}(x), F_{2}(y, u)\right]^{\prime}+c . p .+l_{3}^{\prime}\left(F_{0}(x), F_{0}(y), F_{0}(u)\right)=F_{2}([x, y], u)+c . p .+F_{1} \hat{l_{3}}(x, y, u)
$$

The left hand side is equal to

$$
-\operatorname{ad}_{F_{2}(x, y)}(u)+\mu_{2}^{\prime}(x, y)(u)+l_{3}^{\mathfrak{h}}\left(\psi_{0}(x), \psi_{0}(y), u\right)+l_{\mu_{0}^{\prime}(x)}\left(\psi_{0}(y), u\right)+l_{\mu_{0}^{\prime}(y)}\left(u, \psi_{0}(x)\right),
$$

and the right hand side is equal to $\mu_{2}(x, y)(u)$, which implies that

$$
\mu_{2}(x, y)-\mu_{2}^{\prime}(x, y)=-\operatorname{ad}_{b_{2}(x, y)}+l_{\mu_{0}^{\prime}(x)}\left(b_{0}(y), \cdot\right)-l_{\mu_{0}^{\prime}(y)}\left(b_{0}(x), \cdot\right)+l_{3}^{\mathfrak{h}}\left(b_{0}(x), b_{0}(y), \cdot\right) .
$$

Thus, we have

$$
\begin{align*}
\left(f_{2}^{0^{\prime}}-f_{2}^{0}\right)(x, y)= & \left(\left(\mu_{2}-\mu_{2}^{\prime}\right)(x, y),\left(\omega^{\prime}-\omega\right)(x, y)\right) \\
= & {\left[\mu_{0}^{\prime}(x), b_{0}(y)\right]_{\mathrm{DER}}-\left[\mu_{0}^{\prime}(y), b_{0}(x)\right]_{\mathrm{DER}}-b_{0}\left([x, y]_{\mathfrak{g}}\right) } \\
& -\mathrm{d}_{\mathrm{D}}\left(b_{2}(x, y)\right)+\left[\mathrm{d}_{\mathrm{D}}\left(b_{0}(x)\right), b_{0}(y)\right]_{\mathrm{DER}} \\
= & {\left[f_{0}^{\prime}(x), b_{0}(y)\right]_{\mathrm{DER}}-\left[f_{0}^{\prime}(y), b_{0}(x)\right]_{\mathrm{DER}}-b_{0}\left([x, y]_{\mathfrak{g}}\right) } \\
& -\mathrm{d}_{\mathrm{D}}\left(b_{2}(x, y)\right)+\left[\mathrm{d}_{\mathrm{D}}\left(b_{0}(x)\right), b_{0}(y)\right]_{\mathrm{DER}} . \tag{39}
\end{align*}
$$

Similarly, by $F_{1}\left[x, a \widehat{]}-\left[F_{0}(x), F_{1}(a)\right]^{\prime}=F_{2}(x, \hat{\mathrm{~d}} a)\right.$, we get

$$
\begin{align*}
\nu^{\prime}(x, a)-\nu(x, a)= & {\left[\mu_{0}^{\prime}(x), b_{1}(a)\right]_{\mathrm{DER}}+\left[\mu_{1}^{\prime}(a)-\varphi^{\prime}(a), b_{0}(x)\right]_{\mathrm{DER}}-b_{1}\left([x, a]_{\mathfrak{g}}\right) } \\
& +b_{2}\left(x, \mathrm{~d}_{\mathfrak{g}} a\right)+\left[\mathrm{d}_{\mathrm{D}}\left(b_{0}(x)\right), b_{1}(a)\right]_{\mathrm{DER}} \\
= & {\left[f_{0}^{\prime}(x), b_{1}(a)\right]_{\mathrm{DER}}+\left[f_{1}^{\prime}(a), b_{0}(x)\right]_{\mathrm{DER}}-b_{1}\left([x, a]_{\mathfrak{g}}\right) } \\
& +b_{2}\left(x, \mathrm{~d}_{\mathfrak{g}} a\right)+\left[\mathrm{d}_{\mathrm{D}}\left(b_{0}(x)\right), b_{1}(a)\right]_{\mathrm{DER}} . \tag{40}
\end{align*}
$$

At last, by the equality

$$
\left[F_{0}(x), F_{2}(y, z)\right]^{\prime}+c . p .+l_{3}^{\prime}\left(F_{0}(x), F_{0}(y), F_{0}(z)\right)=F_{2}([x, y], z)+c . p .+F_{1} \hat{l_{3}}(x, y, z)
$$

we have

$$
\begin{align*}
\left(\theta^{\prime}-\theta\right)(x, y, z)= & \mu_{0}^{\prime}(x) b_{2}(y, z)-b_{2}\left([x, y]_{\mathfrak{g}}, z\right)+c . p . \\
& +\mu_{2}^{\prime}(x, y) b_{0}(z)+\left[b_{0}(x), b_{2}(y, z)\right]_{\mathfrak{h}}+l_{\mu_{0}^{\prime}(x)}\left(b_{0}(y), b_{0}(z)\right)+c . p . \\
& -b_{1}\left(l_{3}^{\mathfrak{g}}(x, y, z)\right)+l_{3}^{\mathfrak{h}}\left(b_{0}(x), b_{0}(y), b_{0}(z)\right) . \tag{41}
\end{align*}
$$

By (37),(381),(39),(40), (41), we deduce that $f^{\prime}$ and $f$ are equivalent.
Conversely, assume that $f^{\prime}=\left(\mu_{0}^{\prime}, \mu_{1}^{\prime}-\varphi^{\prime},-\mu_{2}^{\prime}+\omega^{\prime}, \nu^{\prime}, \theta^{\prime}\right)$ is equivalent to $f=\left(\mu_{0}, \mu_{1}-\varphi,-\mu_{2}+\right.$ $\omega, \nu, \theta)$ in the sense of Definition 3.9. For any $u, v \in \mathfrak{h}_{0}, x, y \in \mathfrak{g}_{0}, m \in \mathfrak{h}_{1}$ and $a \in \mathfrak{g}_{1}$, set

$$
\begin{aligned}
F_{0}(x+u) & =x+b_{0}(x)+u, \\
F_{1}(a+m) & =a+b_{1}(a)+m, \\
F_{2}(x+u, y+v) & =b_{2}(x, y) .
\end{aligned}
$$

By similar computations to the first part of the proof, we can deduce that $F=\left(F_{0}, F_{1}, F_{2}\right)$ is an isomorphism from the extension $\hat{\mathrm{E}}_{\mathfrak{g} \oplus \mathfrak{h}}$ to $\mathrm{E}_{\mathfrak{g} \oplus \mathfrak{h}}^{\prime}$. This completes the proof.
