# Sharp constants in weighted trace inequalities on Riemannian manifolds

#### Abstract

We establish some sharp weighted trace inequalities $W^{1,2}\left(\rho^{1-2 \sigma}, M\right) \hookrightarrow L^{\frac{2 n}{n-2 \sigma}}(\partial M)$ on $n+1$ dimensional compact smooth manifolds with smooth boundaries, where $\rho$ is a defining function of $M$ and $\sigma \in(0,1)$. This is stimulated by some recent work on fractional (conformal) Laplacians and related problems in conformal geometry, and also motivated by a conjecture of Aubin.


## 1 Introduction

Let $\Omega$ be an open set in $\mathbb{R}^{n}, n \geq 1$, and $\rho(x)=\operatorname{dist}(x, \partial \Omega)$ for $x \in \Omega$. There have been much work devoted to the structures of weighted Sobolev spaces of the type $W^{k, p}\left(\rho^{\alpha}, \Omega\right)$ where $\alpha \in \mathbb{R}, k \in \mathbb{N}$ and $1 \leq p \leq \infty$, as well as to their applications in different areas such as (stochastic) partial differential equations and Riemannian manifolds with fractal boundaries or boundary singularities. We refer to the book [36] of Maz'ya and references therein for these topics.

In this paper, we would like to study sharp constants in weighted trace type inequalities $W^{1,2}\left(\rho^{1-2 \sigma}\right) \hookrightarrow L^{\frac{2 n}{n-2 \sigma}}(\partial M)$ on Riemannian manifolds $M$ with boundaries $\partial M$. Let us start from Euclidean spaces. Denote $\dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)$ as the $\sigma$-order homogeneous Sobolev space on $\mathbb{R}^{n}$, $n \geq 2$, which is the closure of $C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ under the norm

$$
\|f\|_{\dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)}=\left(\int_{\mathbb{R}^{n}}\left|(-\Delta)^{\sigma / 2} f(x)\right|^{2} \mathrm{~d} x\right)^{1 / 2}
$$

The sharp $\sigma$-order Sobolev inequality asserts that

$$
\|f\|_{L^{\frac{2 n}{n-2 \sigma}\left(\mathbb{R}^{n}\right)}}^{2} \leq c(n, \sigma)\|f\|_{\dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)}^{2}
$$

for all $f \in \dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)$, where

$$
c(n, \sigma)=2^{-2 \sigma} \pi^{-\sigma}\left(\frac{\Gamma((n-2 \sigma) / 2)}{\Gamma((n+2 \sigma) / 2)}\right)\left(\frac{\Gamma(n)}{\Gamma(n / 2)}\right)^{\frac{2 \sigma}{n}}
$$

and the equality holds if and only if $f(x)$ takes the form

$$
c\left(\frac{\lambda}{1+\lambda^{2}\left|x-x_{0}\right|^{2}}\right)^{\frac{n-2 \sigma}{2}}
$$

for some $c \in \mathbb{R}, \lambda>0$ and $x_{0} \in \mathbb{R}^{n}$. These have been proved by Lieb in [34]. Set $x=$ $\left(x^{\prime}, x_{n+1}\right) \in \mathbb{R}_{+}^{n+1}:=\mathbb{R}^{n} \times(0, \infty)$ and

$$
F\left(x^{\prime}, x_{n+1}\right)=\int_{\mathbb{R}^{n}} \mathcal{P}_{\sigma}\left(x^{\prime}-\xi, x_{n+1}\right) f(\xi) \mathrm{d} \xi,
$$

where

$$
\begin{equation*}
\mathcal{P}_{\sigma}\left(x^{\prime}, x_{n+1}\right)=\beta(n, \sigma) \frac{x_{n+1}^{2 \sigma}}{\left(\left|x^{\prime}\right|^{2}+x_{n+1}^{2}\right)^{\frac{n+2 \sigma}{2}}} \tag{1}
\end{equation*}
$$

with the normalization constant $\beta(n, \sigma)>0$ such that $\int_{\mathbb{R}^{n}} \mathcal{P}_{\sigma}\left(x^{\prime}, 1\right) \mathrm{d} x^{\prime}=1$. Then one has (see, e.g., [9])

$$
N_{\sigma} \int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}\left|\nabla F\left(x^{\prime}, x_{n+1}\right)\right|^{2} \mathrm{~d} x=\|f\|_{\dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)}^{2}
$$

where $N_{\sigma}=2^{2 \sigma-1} \Gamma(\sigma) / \Gamma(1-\sigma)$. Hence, we have

$$
\begin{equation*}
\|f\|_{L^{\frac{2 n}{n-2 \sigma}\left(\mathbb{R}^{n}\right)}}^{2} \leq S(n, \sigma) \int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}\left|\nabla F\left(x^{\prime}, x_{n+1}\right)\right|^{2} \mathrm{~d} x \tag{2}
\end{equation*}
$$

for all $f \in \dot{H}^{\sigma}\left(\mathbb{R}^{n}\right)$, where $S(n, \sigma)=N_{\sigma} \cdot c(n, \sigma)$. Consequently, one can show (see, e.g., Proposition 2.1]below together with a density argument) that

$$
\begin{equation*}
\|U(\cdot, 0)\|_{L^{\frac{2 n}{n-2 \sigma}\left(\mathbb{R}^{n}\right)}}^{2} \leq S(n, \sigma) \int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}\left|\nabla U\left(x^{\prime}, x_{n+1}\right)\right|^{2} \mathrm{~d} x \tag{3}
\end{equation*}
$$

for all $U \in W^{1,2}\left(x_{n+1}^{1-2 \sigma}, \mathbb{R}_{+}^{n+1}\right)$, which is the closure of $C_{c}^{\infty}\left(\overline{\mathbb{R}}_{+}^{n+1}\right)$ under the norm

$$
\|U\|_{W^{1,2}\left(x_{n+1}^{1-2 \sigma}, \mathbb{R}_{+}^{n+1}\right)}=\sqrt{\int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}\left(|U|^{2}+|\nabla U|^{2}\right) \mathrm{d} x} .
$$

Stimulated by several recent work on fractional (conformal) Laplacians and related problems in conformal geometry (see, e.g., [22, 10, 21, 26]) and a conjecture of Aubin [2], we study
weighted Sobolev trace inequalities of type (3) on Riemannian manifolds with boundaries. For $n \geq 2$, let ( $M, g$ ) be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. We say a function $\rho \in C^{\infty}(\bar{M})$ is a defining function of $M$ if

$$
\rho>0 \quad \text { in } M, \quad \rho=0 \text { and } \nabla_{g} \rho \neq 0 \quad \text { on } \partial M .
$$

Since $\rho^{1-2 \sigma}$, where $\sigma \in(0,1)$ is a constant, belongs to the Muckenhoupt $A_{2}$ class, we define the weighted Sobolev space $H^{1}\left(\rho^{1-2 \sigma}, M\right)$ as the closure of $C^{\infty}(\bar{M})$ under the norm

$$
\|u\|_{H^{1}\left(\rho^{1-2 \sigma}, M\right)}=\left(\int_{M} \rho^{1-2 \sigma}\left(|u|^{2}+|\nabla u|^{2}\right) \mathrm{d} v_{g}\right)^{\frac{1}{2}}
$$

where $\mathrm{d} v_{g}$ denote the volume form of $(M, g) . H^{1}\left(\rho^{1-2 \sigma}, M\right)$ is a Hilbert space and it has a well-defined trace operator $T$ (see, e.g., [36] or [39]) which continuously maps $H^{1}\left(\rho^{1-2 \sigma}, M\right)$ to $H^{\sigma}(\partial M)$, where $H^{\sigma}(\partial M)$ is the $\sigma$-order Sobolev space on $\partial M$.

Theorem 1.1. For $n \geq 2$, let $(M, g)$ be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. Let $\sigma \in\left(0, \frac{1}{2}\right]$, and $\rho$ be a defining function of $M$ satisfying $\left|\nabla_{g} \rho\right|=1$ on $\partial M$. Then there exists a positive constant $A=A(M, g, n, \rho, \sigma)$ such that

$$
\begin{equation*}
\left(\int_{\partial M}|u|^{\frac{2 n}{n-2 \sigma}} \mathrm{~d} s_{g}\right)^{\frac{n-2 \sigma}{n}} \leq S(n, \sigma) \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+A \int_{\partial M} u^{2} \mathrm{~d} s_{g}, \tag{4}
\end{equation*}
$$

for all $u \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$, where $\mathrm{d} s_{g}$ denotes the induced volume form on $\partial M$.
For $\sigma \in\left(\frac{1}{2}, 1\right)$, we have
Theorem 1.2. Let $\sigma \in\left(\frac{1}{2}, 1\right), n \geq 4$ and $(M, g)$ be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. Suppose in addition that $\partial M$ is totally geodesic. Let $\rho$ be a defining function of $M$ satisfying $\rho(x)=d(x)+O\left(d(x)^{3}\right)$ as $d(x) \rightarrow 0$, where $d(x)$ denotes the distance between $x$ and $\partial M$ with respect to the metric $g$. Then there exists a positive constant $A=A(M, g, n, \rho, \sigma)$ such that (4) holds for all $u \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$.

Remark 1.1. The constant $S(n, \sigma)$ in (4) is optimal for all $\sigma \in(0,1)$, see Proposition 2.2
Remark 1.2. Theorem 1.2 may fail without any geometric assumption on $\partial M$. For example, it is the case when the mean curvature of $\partial M$ is positive somewhere. In particular, (4) is false on any bounded smooth domain in $\mathbb{R}^{n+1}$ when $\sigma \in(1 / 2,1)$. However, Theorem 1.1 holds for all $\sigma \in(0,1)$ if $S(n, \sigma)$ is replaced by any $S>S(n, \sigma)$, see Proposition 2.5

Remark 1.3. It is clear that we only need to consider the case when $M$ is connected. Throughout the paper, we assume this.

When $\sigma=\frac{1}{2}$, (4) is a standard Sobolev trace inequality which has been extensively studied, see, e.g., Lions [35], Escobar [14], Beckner [5], Adimurthi-Yadava [1], Li-Zhu [32, 33] and many others. In particular, Li-Zhu [32] established Theorem 1.1 for $\sigma=\frac{1}{2}$. The sharp inequality (4) is in the same spirit of a conjecture posed by Aubin [2] which concerns the best constants in Sobolev embedding theorems on Riemannian manifolds. Aubin's conjecture had been confirmed through the work of Hebey-Vaugon [25], Aubin-Li [4] and Druet [11, 12]. Besides, various refinements of Aubin's conjecture were obtained in Druet-Hebey [13], Li-Ricciardi [31] and etc. These sharp Sobolev type inequalities play important roles in the study of nonlinear partial differential equations, see Aubin [3], Hebey [24], Schoen-Yau [42] and references therein.

For the defining function in the above theorems, $\left(M, g / \rho^{2}\right)$ is asymptotically hyperbolic in the sense that $\left(M, g / \rho^{2}\right)$ is a complete manifold and along any smooth curve in $M \backslash \partial M$ tending to a point $\xi \in \partial M$ all sectional curvatures of $g / \rho^{2}$ approach to -1 (see Mazzeo [37] or MazzeoMelrose [38]). On the conformal infinity ( $\partial M,\left[\left.g\right|_{\partial M}\right]$ ) of ( $M, g / \rho^{2}$ ), one can define fractional order conformally invariant operators $P_{\sigma}^{g}$ for $\sigma \in\left(0, \frac{n}{2}\right)$ except at most finite values, via normalized scattering operators (see Graham-Zworski [22] and Chang-González [10]), which leads to $\sigma$-scalar curvature $R_{\sigma}^{g}:=P_{\sigma}^{g}(1)$ on $\partial M$. A fractional Yamabe problem, which is to find a metric in $\left[\left.g\right|_{\partial M}\right]$ of constant $\sigma$-curvature and related ones, have been studied by Qing-Raske [41], González-Mazzeo-Sire [20] and González-Qing [21]. When $\sigma \in(0,1)$, it can be formulated (see [21]) as seeking minimizers of the energy functional

$$
\begin{equation*}
I^{\sigma}[u]=\frac{N_{\sigma} \int_{M} \rho^{1-2 \sigma}|\nabla u|^{2} \mathrm{~d} v_{g}+\int_{\partial M} R_{\sigma}^{g} u^{2} \mathrm{~d} s_{g}}{\left(\int_{\partial M}|u|^{\frac{2 n}{n-2 \sigma}} \mathrm{~d} s_{g}\right)^{\frac{n-2 \sigma}{n}}}, \quad u \in H^{1}\left(\rho^{1-2 \sigma}, M\right), u \not \equiv 0 \text { on } \partial M, \tag{5}
\end{equation*}
$$

for some proper $\rho$. For $\sigma=1 / 2$, it is the energy functional of a Yamabe problem with boundary initially studied by Escobar [15]. A fractional Nirenberg problem about prescribing $\sigma$-scalar curvature on $\mathbb{S}^{n}$ has been studied by Jin-Li-Xiong [26, 27] and a fractional Yamabe flow has been studied by Jin-Xiong [28]. Variational problems related to energy functional (5) on bounded domains in Euclidean spaces have been studied by González [19], Palatucci-Sire [40].

Finally, we provide a brief sketch of the proofs of the two main theorems. Since the right hand side of (4) does not contain terms like $\int_{M} \rho^{1-2 \sigma} u^{2} \mathrm{~d} v_{g}$, we adapt a global argument from Li-Zhu [32, 33]. By contradiction, we assume that for any $\alpha>0$,

$$
I_{\alpha}:=\frac{\int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+\alpha \int_{\partial M}|u|^{2} \mathrm{~d} s_{g}}{\left(\int_{\partial M}|u|^{\frac{2 n}{n-2 \sigma}} \mathrm{~d} s_{g}\right)^{\frac{n-2 \sigma}{n}}}<\frac{1}{S(n, \sigma)},
$$

for some $u \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$ with that $u \not \equiv 0$ on $\partial M$. It follows that there exists a minimizer $u_{\alpha}$ of $I_{\alpha}$, and $u_{\alpha}$ blows up at exactly one point as $\alpha \rightarrow \infty$. One key step is the asymptotical analysis of $u_{\alpha}$ near its blow up point. Here we have to overcome difficulties from the degeneracy and the lack of conformal invariance of the Euler-Lagrange equation of $I_{\alpha}$ satisfied by $u_{\alpha}$. Another difference from [32] (the case $\sigma=1 / 2$ ) is that some Sobolev embedding theorems for $H^{1}\left(\rho^{1-2 \sigma}, M\right)$,
which play important roles in establishing the blow-up profile of $u_{\alpha}$ in the interior of $M$ in [32] in the case $\sigma=\frac{1}{2}$, fail when $\sigma>\frac{1}{2}$ (see, e.g., Theorem 1 in page 135 or Corollary 2 in page 193 of [36]). However, we succeeded in establishing the optimal asymptotical behavior of $u_{\alpha}$ on the boundary $\partial M$ (Proposition 3.3). In this step, a Liouville type theorem in Jin-Li-Xiong [26] and Neumann functions for degenerate equations in Theorem 1.3]are used. The last step is to derive a contradiction by checking balance via a Pohozaev type inequality in some proper region, where a Harnack inequality established by Cabre-Sire [8] or Tan-Xiong [43] is used to obtain the asymptotical behavior of $u_{\alpha}$ near it blowup point in $M$ from that on $\partial M$. Some extra arguments on $\partial M$ are needed for $\sigma>\frac{1}{2}$.
Theorem 1.3. Let $f \in L^{1}(\partial M)$ with mean value zero, i.e., $\int_{\partial M} f=0$. Then there exists a weak solution $u \in W^{1,1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, M\right)$ of (59) where $\varepsilon_{0}>0$ depending only on $n$ and $\sigma$. Consequently, if $f=\delta_{x_{0}}-\frac{1}{|\partial M|_{g}}$ for some $x_{0} \in \partial M$, where $\delta_{x_{0}}$ is the delta function at $x_{0}$ and $|\partial M|_{g}$ is the area of $\partial M$ with respect to the induced metric $g$, then there exists a weak solution $u \in W^{1,1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, M\right) \cap H_{l o c}^{1}\left(\rho^{1-2 \sigma}, \bar{M} \backslash\left\{x_{0}\right\}\right)$ of (59) with mean value zero. Moreover, for all $x \in \bar{M} \backslash\left\{x_{0}\right\}$,

$$
A_{1} \operatorname{dist}_{g}\left(x, x_{0}\right)^{2 \sigma-n}-A_{0} \leq u(x) \leq A_{2} \operatorname{dist}_{g}\left(x, x_{0}\right)^{2 \sigma-n}
$$

where $A_{0}, A_{1}, A_{2}$ are positive constants depending only on $M, g, n, \sigma, \rho$.
The proof of Theorem 1.3 follows from Lemma A.5 Theorem A.5 and some approximation arguments. When $\sigma=1 / 2$, Theorem 1.3 follows directly from Brezis-Strauss [7] and KenigPipher [29].
Notations. We collect below a list of the main notations used throughout the paper.

- We always assume that $n \geq 2, \sigma \in(0,1)$, and $\rho$ is a smooth defining function as in Theorem 1.1] without otherwise stated. Denote $q=\frac{2 n}{n-2 \sigma}$.
- For a domain $D \subset \mathbb{R}^{n+1}$ with boundary $\partial D$, we denote $\partial^{\prime} D$ as the interior of $\bar{D} \cap \partial \mathbb{R}_{+}^{n+1}$ in $\mathbb{R}^{n}=\partial \mathbb{R}_{+}^{n+1}$ and $\partial^{\prime \prime} D=\partial D \backslash \partial^{\prime} D$.
- For $\bar{x} \in \mathbb{R}^{n+1}, \mathcal{B}_{r}(\bar{x}):=\left\{x \in \mathbb{R}^{n+1}:|x-\bar{x}|=\sqrt{\left(x_{1}-\bar{x}_{1}\right)^{2}+\cdots+\left(x_{n+1}-\bar{x}_{n+1}\right)^{2}}<\right.$ $r\}, \mathcal{B}_{r}^{+}(\bar{x}):=\mathcal{B}_{r}(\bar{x}) \cap \mathbb{R}_{+}^{n+1}$. If $\bar{x} \in \partial \mathbb{R}_{+}^{n+1}, B_{r}(\bar{x}):=\left\{x=\left(x^{\prime}, 0\right):\left|x^{\prime}-\bar{x}^{\prime}\right|<r\right\}$. Hence $\partial^{\prime} \mathcal{B}_{r}^{+}(\bar{x})=B_{r}(\bar{x})$ if $\bar{x} \in \partial \mathbb{R}_{+}^{n+1}$. We will not keep writing the center $\bar{x}$ if $\bar{x}=0$.

## 2 Preliminaries

Proposition 2.1. For any $u \in C_{c}^{\infty}\left(\overline{\mathbb{R}}_{+}^{n+1}\right)$, we have

$$
\left(\int_{\mathbb{R}^{n}}\left|u\left(x^{\prime}, 0\right)\right|^{q} \mathrm{~d} x^{\prime}\right)^{\frac{2}{q}} \leq S(n, \sigma) \int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}|\nabla u(x)|^{2} \mathrm{~d} x
$$

Moreover, the above inequality fails if $S(n, \sigma)$ is replaced by any smaller constant.
Proof. It follows from (3) and Lemma A. 3 of [26]. See also Corollary 5.3 of [21].
Proposition 2.2. Let $M$ be as in Theorem 1.1 Let $\sigma \in(0,1)$, and $\rho$ be a defining function of $\partial M$ with $\left|\nabla_{g} \rho\right|=1$ on $\partial M$. Suppose there exist some positive constants $\tilde{S}$ and $\tilde{A}$ such that, for all $u \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$,

$$
\left(\int_{\partial M}|u|^{q} \mathrm{~d} s_{g}\right)^{\frac{2}{q}} \leq \tilde{S} \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+\tilde{A} \int_{\partial M}|u|^{2} \mathrm{~d} s_{g}
$$

Then $\tilde{S} \geq S(n, \sigma)$.
Proof. Given Proposition 2.1, the proof is standard (see, e.g., Proposition 4.2of [24]). We include it here for completeness and to illustrate the role of $|\nabla \rho|=1$. We argue by contradiction. Suppose that there exists a Riemannian manifold $(M, g)$, a defining function $\rho$ of $\partial M$ with $\left|\nabla_{g} \rho\right|=1$ on $\partial M, \sigma \in(0,1), \tilde{S}<S(n, \sigma)$ and $\tilde{A}>0$ such that for all $u \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$,

$$
\begin{equation*}
\left(\int_{\partial M}|u|^{q} \mathrm{~d} s_{g}\right)^{\frac{2}{q}} \leq \tilde{S} \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+\tilde{A} \int_{\partial M}|u|^{2} \mathrm{~d} s_{g} \tag{6}
\end{equation*}
$$

Let $x \in \partial M$. For any $\varepsilon>0$, which will be chosen sufficiently small, there exists a chart $(\Omega, \varphi)$ of $M$ at $x$ and $\delta>0$ such that $\varphi(\Omega)=\mathcal{B}_{\delta}^{+}(0)$ the upper half Euclidean ball of center 0 and radius $\delta$ in $\mathbb{R}_{+}^{n+1}$, and

$$
\begin{equation*}
(1-\varepsilon) \delta_{i j} \leq g_{i j} \leq(1+\varepsilon) \delta_{i j} \tag{7}
\end{equation*}
$$

By assumption, (6) holds for any $u \in C_{c}^{\infty}(\Omega \cup(\partial \Omega \cap \partial M))$, i.e.,

$$
\begin{aligned}
\left(\int_{B_{\delta}(0)}|u|^{q} \sqrt{\operatorname{det}\left(g_{i j}\right)} \mathrm{d} x^{\prime}\right)^{\frac{2}{q}} \leq & \tilde{S} \int_{\mathcal{B}_{\delta}^{+}(0)} \rho^{1-2 \sigma} g^{i j} u_{i} u_{j} \sqrt{\operatorname{det}\left(g_{i j}\right)} \mathrm{d} x \\
& +\tilde{A} \int_{B_{\delta}(0)}|u|^{2} \sqrt{\operatorname{det}\left(g_{i j}\right)} \mathrm{d} x^{\prime}
\end{aligned}
$$

It follows from (7), $\left|\nabla_{g} \rho\right|=1$ and $\rho=0$ on $\partial M$ that there exists $\delta_{0}>0, \tilde{S}^{\prime}<S(n, \sigma), \tilde{A}^{\prime}>0$ such that for all $\delta \in\left(0, \delta_{0}\right)$ and $u \in C_{c}^{\infty}\left(\mathcal{B}_{\delta}(0) \cup B_{\delta}(0)\right)$, i.e.,

$$
\left(\int_{B_{\delta}(0)}|u|^{q} \mathrm{~d} x^{\prime}\right)^{\frac{2}{q}} \leq \tilde{S}^{\prime} \int_{\mathcal{B}_{\delta}^{+}(0)} x_{n+1}^{1-2 \sigma}|\nabla u|^{2} \mathrm{~d} x+\tilde{A}^{\prime} \int_{B_{\delta}(0)}|u|^{2} \mathrm{~d} x^{\prime} .
$$

By Hölder's inequality, $\int_{B_{\delta}(x)}|u|^{2} \mathrm{~d} x^{\prime} \leq\left|B_{\delta}(0)\right|^{\frac{q-2}{q}}\left(\int_{B_{\delta}(0)}|u|^{q} \mathrm{~d} x^{\prime}\right)^{\frac{2}{q}}$. By choosing $\delta$ sufficiently small, we have that there exists $\tilde{S}^{\prime \prime}<S(n, \sigma)$ such that for all $u \in C_{c}^{\infty}\left(\mathcal{B}_{\delta}(0) \cup B_{\delta}(0)\right)$

$$
\left(\int_{B_{\delta}(0)}|u|^{q} \mathrm{~d} x^{\prime}\right)^{\frac{2}{q}} \leq \tilde{S}^{\prime \prime} \int_{\mathcal{B}_{\delta}^{+}(0)} x_{n+1}^{1-2 \sigma}|\nabla u|^{2} \mathrm{~d} x .
$$

Consequently, by a scaling argument, we have

$$
\left(\int_{\mathbb{R}^{n}}\left|u\left(x^{\prime}, 0\right)\right|^{q} \mathrm{~d} x^{\prime}\right)^{\frac{2}{q}} \leq \tilde{S}^{\prime \prime} \int_{\mathbb{R}_{+}^{n+1}} x_{n+1}^{1-2 \sigma}|\nabla u(x)|^{2} \mathrm{~d} x
$$

for any $u \in C_{c}^{\infty}\left(\overline{\mathbb{R}}_{+}^{n+1}\right)$, which contradicts Proposition 2.1.
Proposition 2.3. Assume the assumptions in Proposition [2.2] Then for any $\varepsilon>0$ there exists a positive constant $B_{\varepsilon}$ such that

$$
\left(\int_{\partial M}|u|^{q} \mathrm{~d} s_{g}\right)^{\frac{2}{q}} \leq(S(n, \sigma)+\varepsilon) \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+B_{\varepsilon} \int_{M} \rho^{1-2 \sigma}|u|^{2} \mathrm{~d} v_{g} .
$$

Proof. It also follows from Proposition 2.1 and a standard partition of unity argument, see, e.g., Theorem 4.5 of [24] on page 95.

For every $\alpha>0$, consider the functional

$$
I_{\alpha}[u]=\frac{\int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+\alpha \int_{\partial M}|u|^{2} \mathrm{~d} s_{g}}{\left(\int_{\partial M}|u|^{q} \mathrm{~d} s_{g}\right)^{2 / q}}, \quad u \in H^{1}\left(\rho^{1-2 \sigma}, M\right), u \not \equiv 0 \text { on } \partial M .
$$

Proposition 2.4. Suppose that for some $\alpha>0$,

$$
\begin{equation*}
\xi_{\alpha}:=\inf _{u \in H^{1}\left(\rho^{1-2 \sigma}, M\right),\left.u\right|_{\partial M} \neq 0} I_{\alpha}[u]<\frac{1}{S(n, \sigma)}, \tag{8}
\end{equation*}
$$

then $\xi_{\alpha}$ is achieved by a nonnegative function $u_{\alpha} \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$ with

$$
\begin{equation*}
\int_{\partial M} u_{\alpha}^{q} \mathrm{~d} s_{g}=1 \tag{9}
\end{equation*}
$$

Proof. Given Proposition [2.3, the Proposition follows from standard calculus of variations, see page 452 of [32].
Proposition 2.5. Assume the assumptions in Proposition 2.2 For any $\varepsilon>0$, there exists a positive constant $A_{\varepsilon}$ such that

$$
\left(\int_{\partial M}|u|^{q} \mathrm{~d} s_{g}\right)^{\frac{2}{q}} \leq(S(n, \sigma)+\varepsilon) \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2} \mathrm{~d} v_{g}+A_{\varepsilon} \int_{\partial M}|u|^{2} \mathrm{~d} s_{g} .
$$

Proof. Given Propositions 2.3 and 2.4 and Corollary A.1 the proof of Proposition 2.5 is similar to Proposition 1.2 of [32] and we omit it here.

## 3 Asymptotic analysis

For brevity, from now on we write $S$ instead of $S(n, \sigma)$. We prove Theorem 1.1 by contradiction. Namely, assume that for any $\alpha \geq 1$,

$$
\begin{equation*}
\xi_{\alpha}<\frac{1}{S} \tag{10}
\end{equation*}
$$

where $\xi_{\alpha}$ is defined as in Proposition 2.4 Let $u_{\alpha}$ be some nonnegative minimizer of $I_{\alpha}$ obtained in Proposition 2.4 which satisfies

$$
\begin{equation*}
\xi_{\alpha}=\int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u_{\alpha}\right|^{2} \mathrm{~d} v_{g}+\alpha \int_{\partial M} u_{\alpha}^{2} \mathrm{~d} s_{g}, \quad \int_{\partial M} u_{\alpha}^{q} \mathrm{~d} s_{g}=1, \tag{11}
\end{equation*}
$$

and for any $\varphi \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$,

$$
\begin{equation*}
\int_{M} \rho^{1-2 \sigma}\left\langle\nabla_{g} u_{\alpha}, \nabla_{g} \varphi\right\rangle_{g} \mathrm{~d} v_{g}+\alpha \int_{\partial M} u_{\alpha} \varphi \mathrm{d} s_{g}=\xi_{\alpha} \int_{\partial M} u_{\alpha}^{q-1} \varphi \mathrm{~d} s_{g} . \tag{12}
\end{equation*}
$$

The geodesic distance function $d(x):=\operatorname{dist}(x, \partial M)$ determines for some $\varepsilon_{0}>0$ an identification of $\partial M \times\left[0, \varepsilon_{0}\right)$ with a neighborhood of $\partial M$ in $M:\left(x^{\prime}, d\right) \in \partial M \times\left[0, \varepsilon_{0}\right)$ corresponds to the point obtained by following the integral curve of $\nabla_{g} d$ emanating from $x^{\prime}$ for $d$ units of time. Furthermore, $\nabla_{g} d$ is orthogonal to the slices $\partial M \times\{d\}$. Define $\nu:=-\nabla_{g} d$ for $d<\varepsilon_{0}$. It follows from Theorem A.2. Theorem A.3 and Proposition A.1 that $u_{\alpha} \in C^{\gamma}(\bar{M}) \cap C^{\infty}(M) \cap C^{\infty}(\partial M)$ for some $\gamma \in(0,1)$ and $\rho^{1-2 \sigma} \frac{\partial_{g} u_{\alpha}}{\partial \nu} \in C\left(\partial M \times\left[0, \varepsilon_{0} / 2\right]\right)$. Hence, $u_{\alpha}$ satisfies the Euler-Lagrange equation

$$
\begin{cases}\operatorname{div}_{g}\left(\rho^{1-2 \sigma} \nabla_{g} u_{\alpha}\right)=0, & \text { in } M,  \tag{13}\\ \lim _{d \rightarrow 0} \rho^{1-2 \sigma}\left(x^{\prime}, d\right) \frac{\partial_{g} u_{\alpha}}{\partial \nu}\left(x^{\prime}, \rho\right)=\xi_{\alpha} u_{\alpha}^{q-1}\left(x^{\prime}\right)-\alpha u_{\alpha}\left(x^{\prime}\right), & \text { on } \partial M .\end{cases}
$$

in the pointwise sense.

It follows from the maximum principle that $\max _{\bar{M}} u_{\alpha}=\max _{\partial M} u_{\alpha}$. Let $u_{\alpha}\left(x_{\alpha}\right)=\max _{\bar{M}} u_{\alpha}$, where $x_{\alpha} \in \partial M$, and $\mu_{\alpha}=u_{\alpha}\left(x_{\alpha}\right)^{-\frac{2}{n-2 \sigma}}$. By a Hopf Lemma (see, e.g., Proposition 4.11 in [8]), we have $\xi_{\alpha} u_{\alpha}\left(x_{\alpha}\right)^{q-1}-\alpha u_{\alpha}\left(x_{\alpha}\right)>0$, that is

$$
\begin{equation*}
\alpha \mu_{\alpha}^{2 \sigma}<\xi_{\alpha} \tag{14}
\end{equation*}
$$

Hence, $\lim _{\alpha \rightarrow \infty} \mu_{\alpha}^{2 \sigma}=0$.
Lemma 3.1. As $\alpha \rightarrow \infty$, we have

$$
\begin{align*}
\xi_{\alpha} & \rightarrow \frac{1}{S}  \tag{15a}\\
\alpha\left\|u_{\alpha}\right\|_{L^{2}(\partial M)}^{2} & \rightarrow 0 \tag{15b}
\end{align*}
$$

Proof. For all small $\varepsilon>0$, it follows from Proposition 2.5 that

$$
\begin{aligned}
1 & \leq(S+\varepsilon) \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u_{\alpha}\right|^{2} \mathrm{~d} v_{g}+A_{\varepsilon} \int_{\partial M} u_{\alpha}^{2} \mathrm{~d} s_{g} \\
& =(S+\varepsilon) \xi_{\alpha}+\left(A_{\varepsilon}-(S+\varepsilon) \alpha\right) \int_{\partial M} u_{\alpha}^{2} \mathrm{~d} s_{g}
\end{aligned}
$$

Hence, for every $\alpha \geq \frac{2 A_{\varepsilon}}{S+\varepsilon}$ we have

$$
\frac{1}{S+\varepsilon} \leq \xi_{\alpha}<\frac{1}{S}, \quad \frac{S}{2} \alpha \int_{\partial M} u_{\alpha}^{2} \mathrm{~d} s_{g}<\frac{\varepsilon}{S}
$$

(15a) and (15b) follow immediately.
Let $x=\left(x_{1}, \cdots, x_{n}, x_{n+1}\right)=\left(x^{\prime}, x_{n+1}\right)$ be Fermi coordinates (see, e.g., [15]) at $x_{\alpha}$, where $\left(x_{1}, \cdots, x_{n}\right)$ are normal coordinates on $\partial M$ at $x_{\alpha}$ and $\gamma\left(x_{n+1}\right)$ is the geodesic leaving from $\left(x_{1}, \cdot, x_{n}\right)$ in the orthogonal direction to $\partial M$ and parametrized by arc length. In this coordinate system,

$$
\sum_{1 \leq i, j \leq n+1} g_{i j}(x) \mathrm{d} x_{i} \mathrm{~d} x_{j}=\mathrm{d} x_{n+1}^{2}+\sum_{1 \leq i, j \leq n} g_{i j}(x) \mathrm{d} x_{i} \mathrm{~d} x_{j}
$$

Moreover, $g^{i j}$ has the following Taylor expansion near $\partial M$ :
Lemma 3.2 (Lemma 3.2 in [15]). For $\left\{x_{k}\right\}_{k=1, \cdots, n+1}$ are small,

$$
\begin{equation*}
g^{i j}(x)=\delta^{i j}+2 h^{i j}\left(x^{\prime}, 0\right) x_{n+1}+O\left(|x|^{2}\right) \tag{16}
\end{equation*}
$$

where $i, j=1, \cdots, n$ and $h_{i j}$ is the second fundamental form of $\partial M$.

For suitably small $\delta_{0}>0$ (independent of $\alpha$ ), we define $v_{\alpha}$ in a neighborhood of $x_{\alpha}=0$ by

$$
v_{\alpha}(x)=\mu_{\alpha}^{(n-2 \sigma) / 2} u_{\alpha}\left(\mu_{\alpha} x\right), \quad x \in \mathcal{B}_{\delta_{0} / \mu_{\alpha}}^{+}
$$

It follows that

$$
\begin{cases}\operatorname{div}_{g_{\alpha}}\left(\rho_{\alpha}^{1-2 \sigma} \nabla_{g_{\alpha}} v_{\alpha}\right)=0, & \text { in } \mathcal{B}_{\delta_{0} / \mu_{\alpha}}^{+}  \tag{17}\\ \lim _{x_{n+1} \rightarrow 0^{+}} \rho_{\alpha}^{1-2 \sigma} \frac{\partial_{g_{\alpha}} v_{\alpha}}{\partial \nu}=\xi_{\alpha} v_{\alpha}^{q-1}-\alpha \mu_{\alpha}^{2 \sigma} v_{\alpha}, & \text { on } \partial^{\prime} \mathcal{B}_{\delta_{0} / \mu_{\alpha}}^{+}=B_{\delta_{0} / \mu_{\alpha}} \\ v_{\alpha}(0)=1, \quad 0 \leq v_{\alpha} \leq 1, & \end{cases}
$$

where $g_{\alpha}(x)=g_{i j}\left(\mu_{\alpha} x\right) \mathrm{d} x_{i} \mathrm{~d} x_{j}, \rho_{\alpha}(x)=\rho\left(\mu_{\alpha} x\right) / \mu_{\alpha}$. It follows from (14) and Theorem A.2 in the Appendix that for all $R>1$,

$$
\begin{equation*}
\left\|v_{\alpha}\right\|_{C^{\gamma}\left(\mathcal{B}_{R}^{+}\right)}+\left\|v_{\alpha}\right\|_{H^{1}\left(\rho_{\alpha}^{1-2 \sigma}, \mathcal{B}_{R}^{+}\right)} \leq C(R), \quad \text { for all sufficiently large } \alpha \tag{18}
\end{equation*}
$$

where $\gamma \in(0,1)$ is independent of $R$ and $\alpha$. It follows that there exists $v \in C_{l o c}^{\gamma}\left(\overline{\mathbb{R}}_{+}^{n+1}\right) \cap$ $H_{l o c}^{1}\left(x_{n+1}^{1-2 \sigma}, \overline{\mathbb{R}}_{+}^{n+1}\right)$ such that along some subsequence,

$$
\left\{\begin{align*}
v_{\alpha} & \rightarrow v \text { in } C^{\gamma / 2}\left(\mathcal{B}_{R}^{+}\right)  \tag{19}\\
v_{\alpha} & \rightharpoonup v \text { weakly in } H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{R}^{+}\right)
\end{align*}\right.
$$

for any $R>0$ as $\alpha \rightarrow \infty$. Since $v_{\alpha}(0)=1$, we have

$$
\begin{align*}
& \int_{B_{1}} v_{\alpha}^{q} \mathrm{~d} s_{g_{\alpha}} \geq 1 / C>0 \\
& \int_{B_{1}} v_{\alpha}^{2} \mathrm{~d} s_{g_{\alpha}} \geq 1 / C>0 \tag{20}
\end{align*}
$$

On the other hand,

$$
\alpha\left\|u_{\alpha}\right\|_{L^{2}(\partial M)}^{2} \geq \alpha \int_{B_{\mu_{\alpha}}\left(x_{\alpha}\right)} u_{\alpha}^{2}=\alpha \mu_{\alpha}^{2 \sigma} \int_{B_{1}} v_{\alpha}^{2}
$$

where we abused notation by denoting $B_{r}\left(x_{\alpha}\right)$ as the geodesic ball on $\partial M$ centered at $x_{\alpha}$ with radius $r$. It follows from (15b) and (20) that

$$
\begin{equation*}
\lim _{\alpha \rightarrow \infty} \alpha \mu_{\alpha}^{2 \sigma}=0 \tag{21}
\end{equation*}
$$

From (17), (21) and (15a), we conclude that $v$ is a weak solution (see Section A. 2 for the definition of weak solutions) of

$$
\begin{cases}\operatorname{div}\left(x_{n+1}^{1-2 \sigma} \nabla v\right)=0, & \text { in } \mathbb{R}_{+}^{n+1}  \tag{22}\\ -\lim _{x_{n+1} \rightarrow 0^{+}} x_{n+1}^{1-2 \sigma} \partial_{x_{n+1}} v=\frac{1}{S} v^{q-1}, & \text { on } \partial \mathbb{R}_{+}^{n+1} \\ v(0)=1, \quad 0 \leq v \leq 1 & \end{cases}
$$

By a Liouville type theorem, Theorem 1.5 in [26],

$$
v\left(x^{\prime}, 0\right)=\left(\frac{1}{1+\tilde{c}(n, \sigma)\left|x^{\prime}\right|^{2}}\right)^{\frac{n-2 \sigma}{2}}, v\left(x^{\prime}, x_{n+1}\right)=\int_{\mathbb{R}^{n}} \mathcal{P}_{\sigma}\left(x^{\prime}-y^{\prime}, x_{n+1}\right) v\left(y^{\prime}, 0\right) \mathrm{d} y^{\prime}
$$

where $\tilde{c}(n, \sigma)$ is a positive constant such that $\int_{\mathbb{R}^{n}} v^{q}(z) \mathrm{d} z=1$, and $\mathcal{P}_{\sigma}(x)$ is given in (1). Due to the uniqueness of the limit function $v$, we know that (19) holds for all $\alpha \rightarrow \infty$.
Proposition 3.1. For $\delta_{0}=\delta_{0}(M, g)>0$ small enough,

$$
\lim _{\alpha \rightarrow \infty} \int_{B_{\delta_{0} / \mu_{\alpha}}}\left|v_{\alpha}-v\right|^{q}=0
$$

Proof. Note that $v_{\alpha} \geq 0$ and

$$
\begin{equation*}
\int_{B_{\delta_{0} / \mu_{\alpha}}} v_{\alpha}^{q} \leq \int_{\partial M} u_{\alpha}^{q}=1 \tag{23}
\end{equation*}
$$

For any $\varepsilon>0$, choose $R>0$ such that $\int_{\mathbb{R}^{n} \backslash B_{R}} v^{q}\left(x^{\prime}, 0\right) \mathrm{d} x^{\prime} \leq \varepsilon$. It follows from (19) that $\int_{B_{R}}\left|v_{\alpha}-v\right|^{q} \leq \varepsilon$ and $1-\int_{B_{R}} v_{\alpha}^{q}<2 \varepsilon$ for all $\alpha$ sufficiently large. Then

$$
\begin{aligned}
& \int_{B_{\delta_{0} / \mu_{\alpha}}}\left|v_{\alpha}-v\right|^{q} \\
& =\int_{B_{\delta_{0} / \mu_{\alpha}} \cap B_{R}}\left|v_{\alpha}-v\right|^{q}+\int_{B_{\delta_{0} / \mu_{\alpha}} \cap B_{R}^{c}}\left|v_{\alpha}-v\right|^{q} \\
& \leq \int_{B_{\delta_{0} / \mu_{\alpha}} \cap B_{R}}\left|v_{\alpha}-v\right|^{q}+2^{q} \int_{B_{\delta_{0} / \mu_{\alpha}} \cap B_{R}^{c}} v_{\alpha}^{q}+2^{q} \int_{B_{\delta_{0} / \mu_{\alpha} \cap B_{R}^{c}}} v^{q} \\
& \leq \varepsilon+2^{q}\left(1-\int_{B_{R}} v_{\alpha}^{q}\right)+2^{q}\left(1-\int_{B_{R}} v^{q}\right) \leq \varepsilon\left(1+3 \cdot 2^{q}\right),
\end{aligned}
$$

which finishes the proof.
Corollary 3.1. For all $\delta_{1}>0$ we have

$$
\lim _{\alpha \rightarrow \infty} \int_{B_{\delta_{1}}\left(x_{\alpha}\right) \cap \partial M} u_{\alpha}^{q}=1
$$

Proof. It follows immediately from Proposition 3.1.
Let $\tilde{G}_{\alpha}$ be the weak solution of

$$
\begin{cases}-\operatorname{div}_{g}\left(\rho^{1-2 \sigma} \nabla_{g} \tilde{G}_{\alpha}\right)=0, & \text { in } M, \\ \lim _{y \rightarrow x \in \partial M} \rho^{1-2 \sigma}(y) \frac{\partial}{\partial \nu} \tilde{G}_{\alpha}(y)=\delta_{x_{\alpha}}-\frac{1}{|\partial M|_{g}}, & \text { on } \partial M,\end{cases}
$$

constructed in Theorem A.5 We can find a positive constant $C>0$ sufficiently large depending only on $M, g, n, \sigma, \rho$ such that $G_{\alpha}:=\tilde{G}_{\alpha}+C \geq 1$ on $\bar{M}$.

Proposition 3.2. Let $\varphi_{\alpha}(x)=\mu_{\alpha}^{\frac{n-2 \sigma}{2}} G_{\alpha}(x), \tilde{g}_{i j}=\varphi_{\alpha}^{\frac{4}{n-2 \sigma}} g_{i j}$ and $a=2-\frac{2(n-1)}{n-2 \sigma}$. Then $w_{\alpha}:=$ $\frac{u_{\alpha}}{\varphi_{\alpha}}$ satisfies

$$
\begin{cases}\operatorname{div}_{\tilde{g}}\left(\varphi_{\alpha}^{a} \rho^{1-2 \sigma} \nabla_{\tilde{g}} w_{\alpha}\right)=0, & \text { in } M,  \tag{24}\\ \lim _{y \rightarrow \bar{x} \in \partial M} \varphi_{\alpha}^{a} \rho^{1-2 \sigma} \frac{\partial_{\tilde{g}} w_{\alpha}(y)}{\partial \tilde{\nu}} \leq \xi_{\alpha} w_{\alpha}^{q-1}(\bar{x}), & \bar{x} \in \partial M \backslash\left\{x_{\alpha}\right\},\end{cases}
$$

for $\alpha \geq \frac{1}{\mid \partial M_{g}}$.
Proof. The proof follows from some direct computations. For brevity, we drop the subscript $\alpha$ of $\varphi_{\alpha}$ and $u_{\alpha}$. First of all,

$$
\begin{aligned}
& \operatorname{div}_{\tilde{g}}\left(\varphi^{a} \rho^{1-2 \sigma} \nabla_{\tilde{g}} \frac{u}{\varphi}\right) \\
& =\varphi^{a-1-\frac{4}{n-2 \sigma}} \operatorname{div}_{g}\left(\rho^{1-2 \sigma} \nabla_{g} u\right)-u \varphi^{a-2-\frac{4}{n-2 \sigma}} \operatorname{div}_{g}\left(\rho^{1-2 \sigma} \nabla_{g} \varphi\right) \\
& \quad+\left(a-2+\frac{2(n-1)}{n-2 \sigma}\right) \rho^{1-2 \sigma} \varphi^{a-2-\frac{4}{n-2 \sigma}}\left(\left\langle\nabla_{g} u, \nabla_{g} \varphi\right\rangle_{g}-u \varphi\left|\nabla_{g} \varphi\right|_{g}^{2}\right) \\
& =0
\end{aligned}
$$

On the other hand, in Fermi coordinate system centered at $\bar{x}$,

$$
\begin{aligned}
& \lim _{x_{n+1} \rightarrow 0} \varphi^{a} \rho^{1-2 \sigma} \frac{\partial_{\tilde{g}}}{\partial \tilde{\nu}}\left(\frac{u}{\varphi}\right) \\
& =\lim _{x_{n+1} \rightarrow 0} \varphi^{a} \rho^{1-2 \sigma}\left(\frac{1}{\varphi} \frac{\partial u}{\partial x_{n+1}}-\frac{u}{\varphi^{2}} \frac{\partial \varphi}{\partial x_{n+1}}\right) \tilde{g}^{n+1, n+1}\left\langle\frac{\partial}{\partial x_{n+1}}, \tilde{\nu}\right\rangle_{\tilde{g}} \\
& =\varphi^{a-1-\frac{2}{n-2 \sigma}}\left(\xi_{\alpha} u^{\frac{n+2 \sigma}{n-2 \sigma}}-\alpha u\right)+\varphi^{a-2-\frac{2}{n-2 \sigma}} u \mu_{\alpha}^{\frac{n-2 \sigma}{2}} \frac{1}{|\partial M|} \\
& \leq \xi_{\alpha}\left(\frac{u}{\varphi}\right)^{\frac{n+2 \sigma}{n-2 \sigma}}+\varphi^{a-2-\frac{2}{n-2 \sigma}} u \mu_{\alpha}^{\frac{n-2 \sigma}{2}}\left(\frac{1}{|\partial M|_{g}}-\alpha\right) \\
& \leq \xi_{\alpha}\left(\frac{u}{\varphi}\right)^{\frac{n+2 \sigma}{n-2 \sigma}}
\end{aligned}
$$

provided $\alpha \geq \frac{1}{\partial M_{g}}$.
Proposition 3.3. Suppose the assumptions in Proposition 3.2 Then there exists some constant $C$ depending only on $M, g, n, \rho, \sigma$ such that for all $\alpha \geq 1$,

$$
w_{\alpha} \leq C, \quad \text { on } \partial M .
$$

Proof. In the following, $C$ denotes some constant which may depend on $M, g, n, \rho, \sigma$ but not on $\alpha$ and may vary from line to line.

It suffices to prove the proposition for large $\alpha$, in particular, say, $\alpha \geq \max \left\{\frac{1}{\partial M_{g}}, 1\right\}$. Let $\tilde{\rho}:=\varphi_{\alpha}^{\frac{2}{n-2 \sigma}} \rho$. Then (24) can be rewritten as

$$
\begin{cases}\operatorname{div}_{\tilde{g}}\left(\tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} w_{\alpha}\right)=0, & \text { in } M,  \tag{25}\\ \lim _{y \rightarrow \bar{x}} \tilde{\rho}^{1-2 \sigma} \frac{\partial_{\tilde{g}} w_{\alpha}(y)}{\partial \tilde{\nu}} \leq \xi_{\alpha} w_{\alpha}^{q-1}(\bar{x}), & \text { for } \bar{x} \in \partial M \backslash\left\{x_{\alpha}\right\},\end{cases}
$$

where the limit is taken in the sense explained in the paragraph above (13). In the following, we shall abuse notation a little by writing $\psi^{-1}\left(\mathcal{B}_{\delta}^{+}(0)\right)$ as $\mathcal{B}_{\delta}^{+}(0)$ where $\left(\psi^{-1}\left(\mathcal{B}_{\delta}^{+}(0)\right), \psi\right)$ is a Fermi coordinate of $M$ at $x_{\alpha}$, and denoting $B_{\delta}\left(x_{\alpha}\right)$ as the geodesic ball on $\partial M$ centered at $x_{\alpha}$ with radius $\delta$ as before. Note that the interior of $\overline{\mathcal{B}}_{\delta}^{+}(0) \cap \partial M$ is $B_{\delta}\left(x_{\alpha}\right)$.
Step 1. We claim that there exist some constants $0<\delta_{2} \ll 1, s_{0}>q$ independent of $\alpha$ such that

$$
\begin{equation*}
\int_{\partial M \backslash B_{\mu_{\alpha} / \delta_{2}}\left(x_{\alpha}\right)} w_{\alpha}^{s_{0}} \mathrm{~d} s_{\tilde{g}} \leq C . \tag{26}
\end{equation*}
$$

For any $\varepsilon>0$, it follows from Proposition 3.1 that there exists a small $\delta_{2}$ such that

$$
\begin{align*}
\int_{\partial M \backslash B_{\mu_{\alpha} / \delta_{2}}\left(x_{\alpha}\right)} w_{\alpha}^{q} \mathrm{~d} s_{\tilde{g}} & =\int_{\partial M \backslash B_{\mu_{\alpha} / \delta_{2}}\left(x_{\alpha}\right)} u_{\alpha}^{q} \mathrm{~d} s_{g} \\
& =1-\int_{\partial^{\prime} \mathcal{B}_{1 / \delta_{2}}^{+}} v_{\alpha}^{q}  \tag{27}\\
& \leq \varepsilon .
\end{align*}
$$

Without loss of generality, we may assume $10 \mu_{\alpha} / \delta_{2}<\delta_{0}$ where $\delta_{0}$ is the constant such that the Fermi coordinate system centered at $x_{\alpha}$ exists in $\mathcal{B}_{\delta_{0}}^{+}\left(x_{\alpha}\right)$.

We choose $\eta$ to be some cutoff function satisfying

$$
\begin{aligned}
& \eta(x)=1 \text { if }|x| \geq \mu_{\alpha} / \delta_{2}, \quad \eta(x)=0 \text { if }|x| \leq \mu_{\alpha} /\left(2 \delta_{2}\right), \\
& \text { and } \eta=\eta(|x|) \text { in the Fermi coordinate system centered at } x_{\alpha} .
\end{aligned}
$$

Multiplying (25) by $w_{\alpha}^{k} \eta^{2}$ for $k>1$ and integrating by parts, we obtain

$$
\int_{M} \tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} w_{\alpha} \nabla_{\tilde{g}}\left(w_{\alpha}^{k} \eta^{2}\right) \mathrm{d} v_{\tilde{g}} \leq \xi_{\alpha} \int_{\partial M} w_{\alpha}^{q-1+k} \eta^{2} \mathrm{~d} s_{\tilde{g}} .
$$

By a direct computation, we see that

$$
\begin{aligned}
& \int_{M} \tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} w_{\alpha} \nabla_{\tilde{g}}\left(w_{\alpha}^{k} \eta^{2}\right) \mathrm{d} v_{\tilde{g}} \\
& =\frac{4 k}{(k+1)^{2}} \int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta\right)\right|^{2} \mathrm{~d} v_{\tilde{g}}+\frac{k-1}{(k+1)^{2}} \int_{M} w_{\alpha}^{k+1} \operatorname{div}_{\tilde{g}}\left(\tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} \eta^{2}\right) \mathrm{d} v_{\tilde{g}} \\
& \quad-\frac{4 k}{(k+1)^{2}} \int_{M} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1}\left|\nabla_{\tilde{g}} \eta\right|^{2} \mathrm{~d} v_{\tilde{g}},
\end{aligned}
$$

where we have used that $\lim _{\rho \rightarrow 0} \tilde{\rho}^{1-2 \sigma} \frac{\partial \overline{\bar{g}} \eta^{2}}{\partial \tilde{\nu}}=0$ since $\eta$ is radial. In conclusion, we obtain

$$
\begin{align*}
& \int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta\right)\right|^{2} \mathrm{~d} v_{\tilde{g}} \\
& \leq-\frac{k-1}{4 k} \int_{M} w_{\alpha}^{k+1} \operatorname{div}_{\tilde{g}}\left(\tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} \eta^{2}\right) \mathrm{d} v_{\tilde{g}}+\int_{M} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1}\left|\nabla_{\tilde{g}} \eta\right|^{2} \mathrm{~d} v_{\tilde{g}}  \tag{28}\\
& \quad+\frac{\xi_{\alpha}(k+1)^{2}}{4 k} \int_{\partial M} w_{\alpha}^{q-1+k} \eta^{2} \mathrm{~d} s_{\tilde{g}} .
\end{align*}
$$

Since $\tilde{g}^{i j} \sim \mu_{\alpha}^{2} \delta^{i j}$ in $\mathcal{B}_{2 \mu_{\alpha} / \delta_{2}}^{+}\left(x_{\alpha}\right) \backslash \mathcal{B}_{\mu_{\alpha} /\left(4 \delta_{2}\right)}^{+}\left(x_{\alpha}\right)$, we have

$$
\left|\nabla_{\tilde{g}} \eta\right|+\left|\nabla_{\tilde{g}}^{2} \eta\right| \leq C .
$$

Since $\eta$ is radial in the Fermi coordinate system, using (65a), (65b) and (65c), we have

$$
\left|\operatorname{div}_{\tilde{g}}\left(\tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} \eta^{2}\right)\right| \leq C \tilde{\rho}^{1-2 \sigma} .
$$

Taking $1<k \leq q-1$ in (28) and using Theorem A. 1 and Theorem A.5 it follows that

$$
\begin{aligned}
& \int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta\right)\right|^{2} \mathrm{~d} v_{\tilde{g}} \\
& \leq C\left(k, \delta_{2}\right)+\frac{\xi_{\alpha}(k+1)^{2}}{4 k} \int_{\partial M} w_{\alpha}^{q-1+k} \eta^{2} \mathrm{~d} s_{\tilde{g}} \\
& \leq C\left(k, \delta_{2}\right)+\frac{\xi_{\alpha}(k+1)^{2}}{4 k} \varepsilon^{(q-2) / q}\left(\int_{\partial M}\left(w_{\alpha}^{(1+k) / 2} \eta\right)^{q} \mathrm{~d} s_{\tilde{g}}\right)^{2 / q} \\
& \leq C\left(k, \delta_{2}\right)+C \varepsilon^{(q-2) / q} \int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta\right)\right|^{2} \mathrm{~d} v_{\tilde{g}},
\end{aligned}
$$

where we used

$$
\begin{aligned}
& \int_{M \cap\left(\mathcal{B}_{\mu_{\alpha} / \delta_{2}}^{+} \backslash \mathcal{B}_{\mu_{\alpha} /\left(2 \delta_{2}\right)}^{+}\right)} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1} \mathrm{~d} v_{\tilde{g}} \\
& \leq C\left(\delta_{2}\right) \int_{M \cap\left(\mathcal{B}_{\mu_{\alpha} / \delta_{2}}^{+} \backslash \mathcal{B}_{\mu_{\alpha} /\left(2 \delta_{2}\right)}^{+}\right.}\left(\frac{\rho}{\mu_{\alpha}}\right)^{1-2 \sigma}\left(\mu_{\alpha}^{(n-2 \sigma) / 2} u_{\alpha}\right)^{k+1} \mu_{\alpha}^{-(n+1)} \mathrm{d} v_{g} \\
& \leq C\left(\delta_{2}\right) \int_{1 /\left(2 \delta_{2}\right) \leq|z| \leq 1 / \delta_{2}} \rho_{\alpha}(z)^{1-2 \sigma} v_{\alpha}(z)^{k+1} \mathrm{~d} v_{g_{\alpha}} \quad \text { by changing variables } \\
& \leq C\left(k, \delta_{2}\right),
\end{aligned}
$$

and $\rho_{\alpha}(z), v_{\alpha}(z)$ are those in (17).
Taking $\varepsilon>0$ sufficiently small, we have

$$
\int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta\right)\right|^{2} \mathrm{~d} v_{\tilde{g}} \leq C
$$

The claim follows immediately from Theorem A.1 in the Appendix.
Step 2. We shall complete the proof by Moser's iterations. Set, for $\delta=\delta_{2} / 10$,

$$
R_{l}=\mu_{\alpha} \frac{\left(2-2^{-(l-1)}\right)}{\delta}, \quad l=1,2,3, \ldots
$$

We choose $\eta_{l}$ to be some cutoff function satisfying

$$
\begin{aligned}
& \eta_{l}(x)=1 \text { if }|x| \geq R_{l+1}, \quad \eta_{l}(x)=0 \text { if }|x| \leq R_{l}, \\
& \text { and } \eta_{l}=\eta_{l}(|x|) \text { in the Fermi coordinate system centered at } x_{\alpha} .
\end{aligned}
$$

Since $\tilde{g}^{i j} \sim \mu_{\alpha}^{2} \delta^{i j}$ in $\mathcal{B}_{2 \mu_{\alpha} / \delta_{2}}^{+}\left(x_{\alpha}\right) \backslash \mathcal{B}_{\mu_{\alpha} /\left(4 \delta_{2}\right)}^{+}\left(x_{\alpha}\right)$ and $\eta_{l}$ is radial in the Fermi coordinate system, we have

$$
\left|\nabla_{\tilde{g}} \eta_{l}\right| \leq C 2^{l}, \quad\left|\operatorname{div}_{\tilde{g}}\left(\tilde{\rho}^{1-2 \sigma} \nabla_{\tilde{g}} \eta_{l}^{2}\right)\right| \leq C 4^{l} \tilde{\rho}^{1-2 \sigma}, \quad \text { and } \lim _{\rho \rightarrow 0} \tilde{\rho}^{1-2 \sigma} \frac{\partial_{\tilde{g}} \eta_{l}^{2}}{\partial \tilde{\nu}}=0 .
$$

In view of (28), we have

$$
\begin{align*}
& \int_{M} \tilde{\rho}^{1-2 \sigma}\left|\nabla_{\tilde{g}}\left(w_{\alpha}^{(k+1) / 2} \eta_{l}\right)\right|^{2} \mathrm{~d} v_{\tilde{g}} \\
& \leq C 4^{l} \int_{M \cap\left(\mathcal{B}_{R_{l+1}}^{+}\left(x_{\alpha}\right) \backslash \mathcal{B}_{R_{l}}^{+}\left(x_{\alpha}\right)\right)} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1} \mathrm{~d} v_{\tilde{g}}+\frac{C(k+1)^{2}}{k} \int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{q-1+k} \mathrm{~d} s_{\tilde{g}} . \tag{30}
\end{align*}
$$

Set $r_{0}=s_{0} /(q-2)$, where $s_{0}$ is given in the step 1. It follows Hölder inequality and (26) that

$$
\begin{align*}
\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{q-1+k} \mathrm{~d} s_{\tilde{g}} & =\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{q-2} w_{\alpha}^{k+1} \mathrm{~d} s_{\tilde{g}} \\
& \leq C\left(\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{(k+1) r_{0} /\left(r_{0}-1\right)} \mathrm{d} s_{\tilde{g}}\right)^{\left(r_{0}-1\right) / r_{0}} \tag{31}
\end{align*}
$$

Computing as (29), we see that

$$
\begin{aligned}
& \int_{M \cap\left(\mathcal{B}_{R_{l+1}}^{+}\left(x_{\alpha}\right) \backslash \mathcal{B}_{R_{l}}^{+}\left(x_{\alpha}\right)\right)} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1} \mathrm{~d} v_{\tilde{g}} \\
& \leq C^{k+1} \int_{2-2^{-(l-1)} \leq \delta|z| \leq 2-2^{-l}} \rho_{\alpha}(z)^{1-2 \sigma} v_{\alpha}(z)^{k+1} \mathrm{~d} v_{g_{\alpha}} \\
& \leq C^{k+1} \delta^{-1} 2^{-l} \max _{\mathcal{B}_{2 / \delta}^{+}} v_{\alpha}^{k+1},
\end{aligned}
$$

and

$$
\begin{aligned}
& \left(\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{(k+1) r_{0} /\left(r_{0}-1\right)} \mathrm{d} s_{\tilde{g}}\right)^{\left(r_{0}-1\right) / r_{0}} \\
& \geq C^{-(k+1)}\left(\int_{1 \leq \delta\left|z^{\prime}\right| \leq 2} \rho_{\alpha}\left(z^{\prime}, 0\right)^{1-2 \sigma} v_{\alpha}(z)^{(k+1) r_{0} /\left(r_{0}-1\right)} \mathrm{d} s_{g_{\alpha}}\right)^{\left(r_{0}-1\right) / r_{0}} \\
& \geq C^{-(k+1)} \min _{\partial^{\prime} \mathcal{B}_{2 / \delta}^{+}} v_{\alpha}^{k+1} .
\end{aligned}
$$

Hence, it follows from (19) that

$$
\begin{align*}
& \left(\int_{M \cap\left(\mathcal{B}_{R_{l+1}}^{+}\left(x_{\alpha}\right) \backslash \mathcal{B}_{R_{l}}^{+}\left(x_{\alpha}\right)\right)} \tilde{\rho}^{1-2 \sigma} w_{\alpha}^{k+1} \mathrm{~d} v_{\tilde{g}}\right)^{1 /(k+1)}  \tag{32}\\
& \leq C\left(\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{(k+1) r_{0} /\left(r_{0}-1\right)} \mathrm{d} s_{\tilde{g}}\right)^{\left(r_{0}-1\right) / r_{0}(k+1)}
\end{align*}
$$

It follows from Theorem A.1 (30), (31) and (32) that

$$
\begin{align*}
& \left(\int_{\partial M \backslash B_{R_{l+1}}\left(x_{\alpha}\right)} w_{\alpha}^{(k+1) q / 2} \mathrm{~d} s_{\tilde{g}}\right)^{2 /(k+1) q} \\
& \leq\left(C 4^{l}+\frac{C(k+1)^{2}}{k}\right)^{1 /(k+1)}\left(\int_{\partial M \backslash B_{R_{l}}\left(x_{\alpha}\right)} w_{\alpha}^{(k+1) r_{0} /\left(r_{0}-1\right)} \mathrm{d} s_{\tilde{g}}\right)^{\left(r_{0}-1\right) / r_{0}(k+1)} . \tag{3}
\end{align*}
$$

Set $\chi:=\frac{r_{0}-1}{r_{0}} \cdot \frac{q}{2}=1+\frac{\left(s_{0}-q\right)(q-2)}{2 s_{0}}>1, q_{0}=\frac{2 r_{0}}{r_{0}-1}, q_{l}=q_{l-1} \cdot \chi=\chi^{l-1} q$ and $p_{l}=$ $q_{l}\left(r_{0}-1\right) / r_{0}=2 \chi^{l}$ where $l \geq 1$. Taking $k=p_{l}-1$ in (33), we obtain

$$
\left\|w_{\alpha}\right\|_{L^{q_{l+1}}\left(\partial M \backslash B_{R_{l+1}}\right)} \leq\left(C 4^{l}+\frac{C p_{l}^{2}}{p_{l}-1}\right)^{1 / p_{l}}\left\|w_{\alpha}\right\|_{L^{q_{l}}\left(\partial M \backslash B_{R_{l}}\right)}
$$

Therefore,

$$
\begin{aligned}
\left\|w_{\alpha}\right\|_{L^{q_{l+1}}\left(\partial M \backslash B_{R_{l+1}}\right)} & \leq\left\|w_{\alpha}\right\|_{L^{q_{1}}\left(\partial M \backslash B_{R_{1}}\right)} \prod_{l=1}^{\infty}\left(C 4^{l}+\frac{C p_{l}^{2}}{p_{l}-1}\right)^{1 / p_{l}} \\
& \leq\left\|w_{\alpha}\right\|_{L^{p_{1}}\left(\partial M \backslash B_{R_{1}}\right)} \prod_{l=1}^{\infty} C^{1 /\left(2 \chi^{l}\right)}(4+\chi)^{l /\left(2 \chi^{l}\right)} \\
& \leq C\left\|w_{\alpha}\right\|_{L^{p_{1}}\left(\partial M \backslash B_{R_{1}}\right)}
\end{aligned}
$$

Sending $l$ to $\infty$, we have

$$
\begin{equation*}
\left\|w_{\alpha}\right\|_{L^{\infty}\left(\partial M \backslash B_{2 \mu_{\alpha} / \delta}\left(x_{\alpha}\right)\right)} \leq C \tag{34}
\end{equation*}
$$

By the choice of $G_{\alpha}, \varphi_{\alpha}(x) \geq C^{-1} \mu_{\alpha}^{-(n-2 \sigma) / 2}$ for $x \in B_{2 \mu_{\alpha} / \delta}\left(x_{\alpha}\right)$. Hence, for $x \in$ $B_{2 \mu_{\alpha} / \delta}\left(x_{\alpha}\right)$,

$$
\begin{equation*}
w_{\alpha}(x)=\frac{u_{\alpha}(x)}{\varphi_{\alpha}(x)} \leq C \mu_{\alpha}^{(n-2 \sigma) / 2} u_{\alpha}(x) \leq C \tag{35}
\end{equation*}
$$

In view of (34) and (35), we completed the proof of the proposition.
Corollary 3.2. There exists a positive constant $C$ depending only on $M, g, n, \rho, \sigma$ such that

$$
u_{\alpha}(x) \leq C u_{\alpha}\left(x_{\alpha}\right)^{-1} \operatorname{dist}_{\partial M, g}\left(x, x_{\alpha}\right)^{2 \sigma-n}, \quad \text { for all } x \in \partial M
$$

Proof. It follows immediately from Proposition 3.3 .

## 4 Proofs of the main theorems

Let $u_{\alpha}$ and $x_{\alpha}$ be as in Section 3 We will still use Fermi coordinates $x=\left(x_{1}, \cdots, x_{n+1}\right)$ centered at $x_{\alpha}$. In this coordinate system,

$$
\sum_{1 \leq i, j \leq n+1} g_{i j}(x) \mathrm{d} x_{i} \mathrm{~d} x_{j}=\mathrm{d} x_{n+1}^{2}+\sum_{1 \leq i, j \leq n} g_{i j}(x) \mathrm{d} x_{i} \mathrm{~d} x_{j}, \quad \text { for }|x| \leq \delta_{0}
$$

where $\delta_{0}>0$ is independent of $\alpha$. Then we have

$$
\begin{cases}\operatorname{div}_{g}\left(\rho(x)^{1-2 \sigma} \nabla_{g} u_{\alpha}(x)\right)=0, & \text { in } \mathcal{B}_{\delta_{0}}^{+}  \tag{36}\\ -\lim _{x_{n+1} \rightarrow 0^{+}} \rho(x)^{1-2 \sigma} \frac{\partial u_{\alpha}}{\partial x_{n+1}}=\xi_{\alpha} u_{\alpha}^{q-1}\left(x^{\prime}, 0\right)-\alpha u_{\alpha}\left(x^{\prime}, 0\right), & \text { on } \partial^{\prime} \mathcal{B}_{\delta_{0}}^{+}\end{cases}
$$

Proposition 4.1. There exists a positive constant $C$ independent of $\alpha$ such that

$$
u_{\alpha}(x) \leq C u_{\alpha}(0)^{-1}|x|^{2 \sigma-n}, \quad \mathcal{B}_{10 \alpha^{-1 / 2 \sigma}}^{+}(0)
$$

Proof. By Corollary 3.2,

$$
\begin{equation*}
u_{\alpha}\left(x^{\prime}, 0\right) \leq C u_{\alpha}(0)^{-1}\left|x^{\prime}\right|^{2 \sigma-n}, \quad\left|x^{\prime}\right| \leq \delta_{0} \tag{37}
\end{equation*}
$$

Let $r:=|\bar{x}|<10 \alpha^{-1 / 2 \sigma}, \phi_{\alpha}(x)=r^{\frac{n-2 \sigma}{2}} u_{\alpha}(r x)$. Then $\phi_{\alpha}$ satisfies

$$
\begin{cases}\operatorname{div}_{\hat{g}}\left(\hat{\rho}(x)^{1-2 \sigma} \nabla_{\hat{g}} \phi_{\alpha}(x)\right)=0, & \text { in } \mathcal{B}_{\delta_{0} / r}^{+},  \tag{38}\\ -\lim _{x_{n+1} \rightarrow 0^{+}} \hat{\rho}(x)^{1-2 \sigma} \frac{\partial \phi_{\alpha}}{\partial x_{n+1}}=\xi_{\alpha} \phi_{\alpha}^{q-1}\left(x^{\prime}, 0\right)-\alpha r^{2 \sigma} \phi_{\alpha}\left(x^{\prime}, 0\right), & \text { on } \partial^{\prime} \mathcal{B}_{\delta_{0} / r}^{+},\end{cases}
$$

where $\hat{\rho}(x)=\rho(r x) / r, \hat{g}(x)=g_{i j}(r x) \mathrm{d} x_{i} \mathrm{~d} x_{j}$. Since $x_{\alpha}=0$ is a maximum point of $u_{\alpha}$, it follows from (37) that

Let $\mu_{\alpha}=u_{\alpha}(0)^{-\frac{2}{n-2 \sigma}}, R_{\alpha}=\left(\alpha^{1 / 2 \sigma} \mu_{\alpha}\right)^{-1}, g_{\alpha}=g_{i j}\left(\mu_{\alpha} x\right) \mathrm{d} x_{i} \mathrm{~d} x_{j}$ and $\rho_{\alpha}(x)=\frac{\rho\left(\mu_{\alpha} x\right)}{\mu_{\alpha}}$ in $\mathcal{B}_{10 R_{\alpha}}^{+}$. Set $v_{\alpha}(x)=\mu_{\alpha}^{\frac{n-2 \sigma}{2}} u_{\alpha}\left(\mu_{\alpha} x\right)$ for $x \in \mathcal{B}_{10 R_{\alpha}}^{+}$. It follows that

$$

By Proposition 4.1

& =-\int_{\partial^{\prime} \mathcal{B}_{R_{\alpha}}^{+}}\left(\sum_{i=1}^{n} x_{i} \frac{\partial v_{\alpha}}{\partial x_{i}}\right) \frac{\partial v_{\alpha}}{\partial x_{n+1}^{\sigma}} \mathrm{d} x^{\prime}+\int_{\partial^{\prime \prime} \mathcal{B}_{R_{\alpha}}^{+}} \frac{|x|}{2} x_{n+1}^{1-2 \sigma}\left(\left(\frac{\partial v_{\alpha}}{\partial \nu}\right)^{2}-\left|\partial_{\tan } v_{\alpha}\right|^{2}\right) \mathrm{d} S
\end{aligned}

where $\frac{\partial v_{\alpha}}{\partial x_{n+1}^{\sigma}}:=\lim _{x_{n+1} \rightarrow 0^{+}} x_{n+1}^{1-2 \sigma} \frac{\partial v_{\alpha}}{\partial x_{n+1}}$ and $\partial_{\text {tan }}$ denotes the tangential differentiation on $\partial^{\prime \prime} \mathcal{B}_{R_{\alpha}}^{+}$. On the other hand,

For $\sigma=1 / 2$ and $n=2$, Theorem 1.1] was proved in [32]. Hence, we may assume that $n>2 \sigma+1$. Since $\sigma \in(0,1 / 2], n>2 \sigma+1 \geq 4 \sigma$. Therefore,

0<\frac{1}{C} \leq \int_{\partial^{\prime} \mathcal{B}_{R_{\alpha}}^{+}} v_{\alpha}^{2} \mathrm{~d} x^{\prime} \rightarrow 0, \quad \text { as } \alpha \rightarrow \infty
$$

which is a contradiction.
Proof of Theorem 1.2. Since $\partial M$ is totally geodesic, Lemma 3.2 implies that

Since $\rho=d(x)+O\left(d(x)^{3}\right)$, it follows that

\left|\rho_{\alpha}(x)^{1-2 \sigma}-x_{n+1}^{1-2 \sigma}\right| & \leq C \mu_{\alpha}^{2} x_{n+1}^{3-2 \sigma}  \tag{51a}\\
\left|\frac{\partial \rho_{\alpha}(x)^{1-2 \sigma}}{\partial x_{i}}\right| & \leq C \mu_{\alpha}^{2} x_{n+1}^{2-2 \sigma}, \quad i<n+1  \tag{51b}\\
\left|\frac{\partial \rho_{\alpha}(x)^{1-2 \sigma}}{\partial x_{n+1}}-\frac{\partial x_{n+1}^{1-2 \sigma}}{\partial x_{n+1}}\right| & \leq C \mu_{\alpha}^{2} x_{n+1}^{2-2 \sigma} \tag{51c}
\end{align*}
$$

Similar to (48), we have

\begin{align*}
& \alpha \mu_{\alpha}^{2 \sigma} \int_{\partial^{\prime} \mathcal{B}_{R_{\alpha}}^{+}} v_{\alpha}^{2} \mathrm{~d} x^{\prime} \\
& \quad \leq C \mu_{\alpha}^{2} \int_{\mathcal{B}_{R_{\alpha}}^{+}} x_{n+1}^{1-2 \sigma}\left(v_{\alpha}+\left|\nabla v_{\alpha} \cdot x\right|\right)\left(|x|\left|\nabla v_{\alpha}\right|+|x|^{2}\left|\nabla_{x^{\prime}}^{2} v_{\alpha}\right|+x_{n+1}^{2}\left|\Delta v_{\alpha}\right|\right) \mathrm{d} x  \tag{52}\\
& \quad+C \int_{\partial^{\prime \prime} \mathcal{B}_{R_{\alpha}}^{+}} x_{n+1}^{1-2 \sigma}\left(|x|\left|\nabla v_{\alpha}\right|^{2}+v_{\alpha}\left|\nabla v_{\alpha}\right|\right) \mathrm{d} S+C \int_{\partial B_{R_{\alpha}}} \alpha \mu_{\alpha}^{2 \sigma} v_{\alpha}^{2} R_{\alpha} \mathrm{d} S
\end{align*}
$$

It follows from (49), (52) and Proposition 4.2 that

$$
\begin{aligned}
& \alpha \mu_{\alpha}^{2 \sigma} \int_{\partial^{\prime} \mathcal{B}_{R_{\alpha}}^{+}} v_{\alpha}^{2} \mathrm{~d} x^{\prime} \\
& \quad \leq C \mu_{\alpha}^{2} \int_{\mathcal{B}_{R_{\alpha}}^{+}} x_{n+1}^{1-2 \sigma}\left(v_{\alpha}+\left|\nabla v_{\alpha} \cdot x\right|\right)\left(|x|\left|\nabla v_{\alpha}\right|+|x|^{2}\left|\nabla_{x^{\prime}}^{2} v_{\alpha}\right|\right) \mathrm{d} x \\
& \quad+C \int_{\partial^{\prime \prime} \mathcal{B}_{R_{\alpha}}^{+}} x_{n+1}^{1-2 \sigma}\left(|x|\left|\nabla v_{\alpha}\right|^{2}+v_{\alpha}\left|\nabla v_{\alpha}\right|\right) \mathrm{d} S+C \int_{\partial B_{R_{\alpha}}} \alpha \mu_{\alpha}^{2 \sigma} v_{\alpha}^{2} R_{\alpha} \mathrm{d} S \\
& \quad \leq C \mu_{\alpha}^{2} \int_{\mathcal{B}_{R_{\alpha}}^{+}} \frac{x_{n+1}^{1-2 \sigma}}{(1+|x|)^{2 n-4 \sigma}} \mathrm{~d} x+C\left(\alpha \mu_{\alpha}^{2 \sigma}\right)^{\frac{n-2 \sigma}{2 \sigma}}+C \alpha \mu_{\alpha}^{2 \sigma} R_{\alpha}^{4 \sigma-n} \\
& \quad \leq C \mu_{\alpha}^{2}+C\left(\alpha \mu_{\alpha}^{2 \sigma}\right)^{\frac{n-2 \sigma}{2 \sigma}}+C \alpha \mu_{\alpha}^{2 \sigma} R_{\alpha}^{4 \sigma-n}
\end{aligned}
$$

provided $n>2+2 \sigma$ (i.e., $n \geq 4$ ). Therefore,

$$
0<\frac{1}{C} \leq \int_{\partial^{\prime} \mathcal{B}_{R_{\alpha}}^{+}} v_{\alpha}^{2} \mathrm{~d} x^{\prime} \rightarrow 0 \quad \text { as } \alpha \rightarrow \infty
$$

which is a contradiction.

## A Appendix

## A. 1 A trace inequality

Let $(M, g)$ be a smooth, compact Riemannian manifold of dimension $n+1(n \geq 2)$ with boundary.

Lemma A.1. For $n \geq 2$, there exists some positive constant $C=C(n, \sigma)$ such that for all $u \in H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{1}^{+}\right), u \equiv 0$ in an open neighborhood of $x=0$, we have

\left(\int_{\partial^{\prime} \mathcal{B}_{1}^{+}} \frac{\left|u\left(x^{\prime}, 0\right)\right|^{q}}{\left|x^{\prime}\right|^{2 n}} \mathrm{~d} x^{\prime}\right)^{2 / q} \leq C \int_{\mathcal{B}_{1}^{+}} \frac{x_{n+1}^{1-2 \sigma}|\nabla u|^{2}}{|x|^{2 n-4 \sigma}} \mathrm{~d} x
$$

Proof. By the assumption of $u$, there exists a positive constant $\mu=\mu(u)>0$ such that $u \equiv 0$ for $|x|<\mu$ with $x_{n+1}>0$. Consider

$$
v(y)=u\left(\frac{y}{|y|^{2}}\right), \quad|y|>1, y_{n+1}>0
$$

It is easy to see that

$$
v(y) \equiv 0, \quad \text { for all }|y|>1 / \mu, y_{n+1}>0
$$

and for some $C(n)>0$,

$$
\int_{\partial^{\prime} \mathcal{B}_{1}^{+}} \frac{\left|u\left(x^{\prime}, 0\right)\right|^{q}}{\left|x^{\prime}\right|^{2 n}} \mathrm{~d} x^{\prime}=C(n) \int_{\left|y^{\prime}\right| \geq 1}\left|v\left(y^{\prime}, 0\right)\right|^{q} \mathrm{~d} y^{\prime}
$$

and

$$
\int_{\mathcal{B}_{1}^{+}} \frac{x_{n+1}^{1-2 \sigma}|\nabla u|^{2}}{|x|^{2 n-4 \sigma}} \mathrm{~d} x=C(n) \int_{|y| \geq 1, y_{n+1}>0} y_{n+1}^{1-2 \sigma}|\nabla v(y)|^{2} \mathrm{~d} y
$$

By some appropriate extension of $v$ to $|y|<1$, it follows from (3) that

$$
\int_{\left|y^{\prime}\right| \geq 1,}\left|v\left(y^{\prime}, 0\right)\right|^{q} \mathrm{~d} y^{\prime} \leq C(n, \sigma) \int_{|y| \geq 1, y_{n+1}>0} y_{n+1}^{1-2 \sigma}|\nabla v(y)|^{2} \mathrm{~d} y
$$

The proof is completed.
Lemma A.2. For $\delta>0$, there exists $C=C(M, g, n, \sigma, \delta, \rho)>0$ such that for all $x_{0} \in \partial M$, $u \in H^{1}\left(\rho^{1-2 \sigma}, M \backslash \mathcal{B}_{\delta / 2}\left(x_{0}\right)\right)$, we have

& \left(\int_{\partial M \backslash B_{\delta}\left(x_{0}\right)}|u(x)|^{q}\right)^{2 / q}+\int_{M \backslash \mathcal{B}_{\delta}^{+}\left(x_{0}\right)} \rho^{1-2 \sigma}|u(x)|^{2}  \tag{53}\\
& \leq C\left\{\int_{M \backslash \mathcal{B}_{\delta / 2}^{+}\left(x_{0}\right)} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2}+\int_{\partial M \cap\left(B_{\delta}\left(x_{0}\right) \backslash \bar{B}_{\delta / 2}\left(x_{0}\right)\right)}|u(x)|^{2}\right\}
\end{align*}
$$

Proof. We prove (53) by contradiction. Suppose the contrary of (53) that for some $\delta>0$, there exists a sequence of points $\left\{x_{i}\right\} \in \partial M,\left\{u_{i}\right\} \in H^{1}\left(\rho^{1-2 \sigma}, M \backslash \mathcal{B}_{\delta / 2}^{+}\left(x_{i}\right)\right)$ satisfying

\left(\int_{\partial M \backslash B_{\delta}\left(x_{i}\right)}\left|u_{i}(x)\right|^{q}\right)^{2 / q}+\int_{M \backslash \mathcal{B}_{\delta}^{+}\left(x_{i}\right)} \rho^{1-2 \sigma}\left|u_{i}(x)\right|^{2}=1 \tag{54}
\end{equation*}
$$

but

$$
\begin{equation*}
\int_{M \backslash \mathcal{B}_{\delta / 2}^{+}\left(x_{i}\right)} \rho^{1-2 \sigma}\left|\nabla_{g} u_{i}\right|^{2}+\int_{\partial M \cap\left(B_{\delta}\left(x_{i}\right) \backslash \bar{B}_{\delta / 2}\left(x_{i}\right)\right)}\left|u_{i}(x)\right|^{2} \leq \frac{1}{i} \tag{55}
\end{equation*}
$$

After passing to some subsequence, $\left\{u_{i}\right\}$ converges weakly to $u$ in $H^{1}\left(\rho^{1-2 \sigma}, M \backslash \mathcal{B}_{\delta}^{+}\left(x_{i}\right)\right)$. By (55), $u \equiv 0$. It follows from a compact Sobolev embedding in Proposition A.2 that

\int_{M \backslash \mathcal{B}_{\delta}^{+}\left(x_{i}\right)} \rho^{1-2 \sigma}\left|u_{i}(x)\right|^{2} \rightarrow 0

By a trace embedding in Proposition 2.3, we also conclude that

\left(\int_{\partial M \backslash B_{\delta}\left(x_{i}\right)}|u(x)|^{q}\right)^{2 / q} \rightarrow 0
$$

Therefore, we reach a contradiction to (54).
Theorem A.1. There exists some constant $C=C(M, g, \rho, n, \sigma)$ such that for all $x_{0} \in \partial M$, $\mu>0, u \in H^{1}\left(\rho^{1-2 \sigma}, M\right), u \equiv 0$ in $\left\{x \in M: \operatorname{dist}\left(x, x_{0}\right)<\mu\right\}$, we have

\left(\int_{\partial M} \frac{|u(x)|^{q}}{\operatorname{dist}\left(x, x_{0}\right)^{2 n}} \mathrm{~d} s_{g}\right)^{2 / q} \leq C \int_{M} \frac{\rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{2}}{\operatorname{dist}\left(x, x_{0}\right)^{2 n-4 \sigma}} \mathrm{~d} v_{g}
$$

Proof. The theorem follows clearly from Lemma A. 1 and Lemma A. 2 ,

## A. 2 Regularity results for degenerate elliptic equations

Suppose that $a^{i j}(x), 1 \leq i, j \leq n+1$, is a smooth positive definite matrix-valued in $\mathcal{B}_{2}^{+}$and there exists a positive constant $\Lambda \geq 1$ such that

$$

Consider

\begin{cases}\frac{\partial}{\partial x_{i}}\left(x_{n+1}^{1-2 \sigma} a^{i j}(x) \frac{\partial}{\partial x_{j}} u(x)\right)=0, & \text { in } \mathcal{B}_{2}^{+},  \tag{56}\\ -\lim _{x_{n+1} \rightarrow 0^{+}} x_{n+1}^{1-2 \sigma} a^{n+1, n+1} \frac{\partial u(x)}{\partial x_{n+1}}=b\left(x^{\prime}\right) u+f\left(x^{\prime}\right), & \text { on } \partial^{\prime} \mathcal{B}_{2}^{+}\end{cases}
$$

We say $u \in H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)$is a weak solution of (56) if

$$
\int_{\mathcal{B}_{2}^{+}} x_{n+1}^{1-2 \sigma} a^{i j}(x) \frac{\partial u}{\partial x_{j}} \frac{\partial \varphi}{\partial x_{i}}=\int_{\partial^{\prime} \mathcal{B}_{2}^{+}} b\left(x^{\prime}\right) u\left(x^{\prime}, 0\right) \varphi\left(x^{\prime}, 0\right)+f\left(x^{\prime}\right) \varphi\left(x^{\prime}, 0\right)
$$

for all $\varphi \in C_{c}^{\infty}\left(\mathcal{B}_{2}^{+} \cup \partial^{\prime} \mathcal{B}_{2}^{+}\right)$.

Theorem A.2. Suppose that $b, f \in L^{p}\left(B_{2}\right)$ for some $p>\frac{n}{2 \sigma}$. Let $u \in H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)$be $a$ weak solution of (56). Then there exist constants $\gamma \in(0,1), C>0$ depending only on $n, \sigma, \Lambda, p,\|b\|_{L^{p}\left(B_{2}\right)}$ such that $u \in C^{\gamma}\left(\mathcal{B}_{1}^{+}\right)$and

$$
\|u\|_{C^{\gamma}\left(\mathcal{B}_{1}^{+}\right)} \leq C\left(\|u\|_{L^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)}+\|f\|_{L^{p}\left(B_{2}\right)}\right) .
$$

Proof. It follows from a modification of the proof of Proposition 2.4 in [26], which uses standard Moser iteration techniques.

Theorem A.3. Suppose that $b, f \in C^{\beta}\left(B_{2}\right)$ for some $0<\beta \notin \mathbb{N}$. Let $u \in H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)$be a weak solution of (56). Suppose that $2 \sigma+\beta$ is not an integer. Then $\left.x_{n+1}^{1-2 \sigma} \frac{\partial u(x)}{\partial x_{n+1}} \in C \overline{\mathcal{B}_{1}^{+}}\right)$, and $u(\cdot, 0) \in C^{2 \sigma+\beta}\left(B_{1}\right)$. Moreover,

\left|x_{n+1}^{1-2 \sigma} \frac{\partial u(x)}{\partial x_{n+1}}\right|_{C\left(\overline{\mathcal{B}_{1}^{+}}\right)}+\|u(\cdot, 0)\|_{C^{2 \sigma+\beta}\left(B_{1}\right)} \leq C\left(\|u\|_{L^{2}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)}+\|f\|_{C^{\beta}\left(B_{2}\right)}\right),
$$

where $C>0$ depending only on $n, \sigma, \Lambda, \beta,\|b\|_{C^{\beta}\left(B_{2}\right)}$.
Proof. It follows from modifications of the proofs of Theorem 2.3 and Lemma 2.3 in [26].
Proposition A.1. Let $b, f \in C^{k}\left(B_{2}\right), u \in H^{1}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)$be a weak solution of (56), where $k$ is a positive integer. Then we have

$$
\sum_{j=1}^{k}\left\|\nabla_{x^{\prime}}^{j} u\right\|_{L^{\infty}\left(\mathcal{B}_{1}^{+}\right)} \leq C\left(\|u\|_{L^{2}\left(x_{n+1}^{1-2 \sigma}, \mathcal{B}_{2}^{+}\right)}+\|f\|_{C^{k}\left(B_{2}\right)}\right)
$$

where $C>0$ depending only on $n, \sigma, \Lambda, \beta,\|b\|_{C^{k}\left(B_{2}\right)}$.
Proof. It follows from a modification of the proof of Proposition 2.5 in [26].

## A. 3 Degenerate elliptic equations with conormal boundary conditions involving measures

We start with some Sobolev embeddings. For every $p \in[1,+\infty)$, we define $W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$ as the closure of $C^{\infty}(\bar{M})$ under the norm

\|u\|_{W^{1, p}\left(\rho^{1-2 \sigma}, M\right)}=\left(\int_{M} \rho^{1-2 \sigma}\left(|u|^{p}+|\nabla u|^{p}\right) \mathrm{d} v_{g}\right)^{\frac{1}{p}}
$$

where $\mathrm{d} v_{g}$ denote the volume form of $(M, g) . W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$ is a Banach space for all $p \in$ $[1,+\infty)$ (see [30]). The following Proposition follows directly from Theorem 8.8 and Theorem 8.12 in [23].

Proposition A.2. Let $\Omega$ be a bounded domain in $\mathbb{R}^{n+1}$ with Lipschitz boundary $\partial \Omega$. Let $\sigma \in$ $(0,1), 1 \leq p \leq q<\infty$ with $\frac{1}{n+1}>\frac{1}{p}-\frac{1}{q}$ and $d(x)$ be the distance from $x$ to $\partial \Omega$.
(i) Suppose that $2-2 \sigma \leq p$. Then $W^{1, p}\left(d^{1-2 \sigma}, \Omega\right)$ is compactly embedded in $L^{q}\left(d^{1-2 \sigma}, \Omega\right)$ if

$$
\frac{2-2 \sigma}{p(n+2-2 \sigma)}>\frac{1}{p}-\frac{1}{q}
$$

(ii) Suppose that $2-2 \sigma>p$. Then $W^{1, p}\left(d^{1-2 \sigma}, \Omega\right)$ is compactly embedded in $L^{q}\left(d^{1-2 \sigma}, \Omega\right)$ if and only if

$$
\frac{1}{n+2-2 \sigma}>\frac{1}{p}-\frac{1}{q} .
$$

Corollary A.1. For $n \geq 2$, let $(M, g)$ be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. Let $\sigma \in(0,1)$, and $\rho$ be a defining function of $M$ with $\left|\nabla_{g} \rho\right|=1$ on $\partial M$. Let $1 \leq p \leq q<\infty$ with $\frac{1}{n+1}>\frac{1}{p}-\frac{1}{q}$.
(i) Suppose that $2-2 \sigma \leq p$. Then $W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$ is compactly embedded in $L^{q}\left(d^{1-2 \sigma}, M\right)$ if

$$
\frac{2-2 \sigma}{p(n+2-2 \sigma)}>\frac{1}{p}-\frac{1}{q} .
$$

(ii) Suppose that $2-2 \sigma>p$. Then $W^{1, p}\left(d^{1-2 \sigma}, M\right)$ is compactly embedded in $L^{q}\left(d^{1-2 \sigma}, M\right)$ if and only if

$$
\frac{1}{n+2-2 \sigma}>\frac{1}{p}-\frac{1}{q}
$$

Proof. It follows from Proposition A. 2 and partition of unity.
Proposition A.3. For $n \geq 2$, let $(M, g)$ be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. Let $\sigma \in(0,1)$, $\rho$ be a defining function of $M$ with $\left|\nabla_{g} \rho\right|=1$ on $\partial M$, and $(u)_{M, \rho}=\int_{M} \rho^{1-2 \sigma} u \mathrm{~d} V_{g} / \int_{M} \rho^{1-2 \sigma} \mathrm{~d} V_{g}$. Let $1<p<\infty$. Then there exists $a$ constant $C$, depending only on $M, g, p, n, \sigma$ and $\rho$, such that

$$
\begin{equation*}
\left\|u-(u)_{M, \rho}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)} \leq C\left\|\nabla_{g} u\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)} \tag{57}
\end{equation*}
$$

for every function $u \in W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$.
Proof. We argue by contradiction. Were the stated estimate false, there would exist for each integer $k=1,2, \cdots$ a function $u_{k} \in W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$ satisfying

$$
\left\|u_{k}-\left(u_{k}\right)_{M, \rho}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}>k\left\|\nabla_{g} u_{k}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}
$$

For each $k$, define

$$
v_{k}:=\frac{u-(u)_{M, \rho}}{\left\|u-(u)_{M, \rho}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}} .
$$

Then

$$
\left(v_{k}\right)_{M, \rho}=0, \quad\left\|v_{k}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}=1, \quad\left\|\nabla_{g} v_{k}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}<1 / k
$$

By Corollary A. 1 , there exists a subsequence of $\left\{v_{k}\right\}$, which is still denoted as $\left\{v_{k}\right\}$, and a function $v \in L^{p}\left(\rho^{1-2 \sigma}, M\right)$ such that

$$
v_{k} \rightarrow v \text { in } L^{p}\left(\rho^{1-2 \sigma}, M\right), \quad v_{k} \rightharpoonup v \text { in } W^{1, p}\left(\rho^{1-2 \sigma}, M\right)
$$

Consequently,

$$
(v)_{M, \rho}=0, \quad\|v\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}=1, \quad\left\|\nabla_{g} v\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)} \leq \liminf _{k \rightarrow \infty}\left\|\nabla_{g} v_{k}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}=0
$$

We reach a contradiction.
Corollary A.2. For $n \geq 2$, let $(M, g)$ be an $n+1$ dimensional, compact, smooth Riemannian manifold with smooth boundary $\partial M$. Let $\sigma \in(0,1)$, $\rho$ be a defining function of $M$ with $\left|\nabla_{g} \rho\right|=1$ on $\partial M$, and $(u)_{M, \rho}=\int_{M} \rho^{1-2 \sigma} u \mathrm{~d} V_{g} / \int_{M} \rho^{1-2 \sigma} \mathrm{~d} V_{g}$. Let $1<p<\infty$. Then there exists $a$ constant $\delta_{0}$ depending only on $n, \sigma, p$ such that for any $1 \leq k \leq 1+\delta_{0}$,

$$
\begin{equation*}
\left\|u-(u)_{M, \rho}\right\|_{L^{k p}\left(\rho^{1-2 \sigma}, M\right)} \leq C\left\|\nabla_{g} u\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)} \tag{58}
\end{equation*}
$$

for every function $u \in W^{1, p}\left(\rho^{1-2 \sigma}, M\right)$, where $C$ is a positive constant depending only on $M, g, p, n, \sigma$ and $\rho$,

Proof. By Corollary A. 1 there exists a constant $\delta_{0}$ depending only on $n, \sigma, p$ such that for any $1 \leq k \leq 1+\delta_{0}$,

$$
\begin{aligned}
\left\|u-(u)_{M, \rho}\right\|_{L^{k p}\left(\rho^{1-2 \sigma}, M\right)} & \leq C\left\|\nabla_{g} u\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}+C\left\|u-(u)_{M, \rho}\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)} \\
& \leq C\left\|\nabla_{g} u\right\|_{L^{p}\left(\rho^{1-2 \sigma}, M\right)}
\end{aligned}
$$

where in the last inequality we have used Proposition A. 3
Let $(M, g), \rho$ be as in Theorem 1.1. For $\sigma \in(0,1)$, we consider

$$
\left\{\begin{array}{l}
\operatorname{div}_{g}\left(\rho^{1-2 \sigma} \nabla_{g} u\right)=0, \quad \text { in } M  \tag{59}\\
\lim _{y \rightarrow x \in \partial M} \rho(y)^{1-2 \sigma} \frac{\partial_{g} u}{\partial \nu}=f(x) \quad \text { on } \partial M
\end{array}\right.
$$

We say $u \in W^{1,1}\left(\rho^{1-2 \sigma}, M\right)$ is a weak solution of (59) if

$$
\begin{equation*}
\int_{M} \rho^{1-2 \sigma}\left\langle\nabla_{g} u, \nabla_{g} \varphi\right\rangle \mathrm{d} v_{g}=\int_{\partial^{\prime} M} f \varphi \mathrm{~d} s_{g} \tag{60}
\end{equation*}
$$

for all $\varphi \in C^{\infty}(\bar{M})$. Define $\tilde{H}^{1}:=\left\{u \in H^{1}\left(\rho^{1-2 \sigma}, M\right): \int_{M} \rho^{1-2 \sigma} u \mathrm{~d} v_{g}=0\right\}$.

Lemma A.3. Let $f \in H^{-\sigma}(\partial M):=\left(H^{\sigma}(\partial M)\right)^{*}$, the dual of $H^{-\sigma}(\partial M)$, such that $\langle f, 1\rangle=0$. Then (59) admits a unique weak solution $u \in \tilde{H}^{1}$.

Proof. The lemma follows immediately from Proposition A.3 and the Lax-Milgram theorem.
Lemma A.4. Let $f \in L^{2}(\partial M)$ with zero mean value, $u \in \tilde{H}^{1}$ be the weak solution of (59). Then for any $\theta>1$,

$$
\int_{M} \rho^{1-2 \sigma} \frac{\left|\nabla_{g} u\right|^{2}}{(1+|u|)^{\theta}} \mathrm{d} v_{g} \leq \frac{1}{\theta-1}\|f\|_{L^{1}(\partial M)} .
$$

Proof. In our proofs of this and the next lemma, we adapt some arguments from [6] and [18]. For $\theta>0$, let $\phi_{\theta}(r)=\int_{0}^{r} \frac{\mathrm{~d} t}{(1+t)^{\theta}}$ if $r \geq 0$ and $\phi_{\theta}(r)=-\phi_{\theta}(-r)$ if $r<0$. It is easy to see that $\varphi_{\theta}:=\phi_{\theta}(u) \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$ and $\left|\varphi_{\theta}\right| \leq 1 /(\theta-1)$ on $\bar{M}$ if $\theta>1$. Hence, the Lemma follows from multiplying (60) by letting $\varphi=\varphi_{\theta}$.
Lemma A.5. Let $f \in L^{2}(\partial M)$ with zero mean value, $u \in \tilde{H}^{1}$ be the weak solution of (59). Then there exists $\varepsilon_{0}>0$ depending only on $n$ and $\sigma$ such that for any $1 \leq \tau \leq 1+\varepsilon_{0}$, we have

$$
\|u\|_{W^{1, \tau}\left(\rho^{1-2 \sigma}, M\right)} \leq C,
$$

where $C>0$ depends only on $M, g, \sigma, \rho,\|f\|_{L^{1}(\partial M)}$.
Proof. By the Hölder inequality,

$$
\begin{align*}
& \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{\tau} \mathrm{d} v_{g} \\
& \leq\left(\int_{M} \rho^{1-2 \sigma} \frac{\left|\nabla_{g} u\right|^{2}}{(1+|u|)^{\theta}} \mathrm{d} v_{g}\right)^{\tau / 2}\left(\int_{M} \rho^{1-2 \sigma}(1+|u|)^{\frac{\tau \theta}{2-\tau}} \mathrm{d} v_{g}\right)^{(2-\tau) / 2}  \tag{61}\\
& \leq C(\theta)\left(\int_{M} \rho^{1-2 \sigma}(1+|u|)^{\frac{\tau \theta}{2-\tau}} \mathrm{d} v_{g}\right)^{(2-\tau) / 2}
\end{align*}
$$

where we used Lemma A. 4 in the last inequality and $\theta \in(1,2)$ will be chosen later. Applying Corollary A.2 (see also [17]) to $\varphi_{\theta / 2}$ yields that for any $1 \leq k \leq 1+\delta_{0}$

$$
\begin{equation*}
\left(\int_{M} \rho^{1-2 \sigma}\left|\varphi_{\theta / 2}-f_{M} \rho^{1-2 \sigma} \varphi_{\theta / 2} \mathrm{~d} v_{g}\right|^{2 k} \mathrm{~d} v_{g}\right)^{1 / k} \leq C \int_{M} \rho^{1-2 \sigma} \frac{\left|\nabla_{g} u\right|^{2}}{(1+|u|)^{\theta}} \mathrm{d} v_{g} \tag{62}
\end{equation*}
$$

where $\delta_{0}>0$ depends only on $n, \sigma$, and $C$ depends only on $M, g, \sigma, \rho, k$. Since $\phi_{\theta / 2}(r) \approx|r|^{1-\frac{\theta}{2}}$ for $|r|$ large, it follows from (62) and Lemma A.4 that

$$
\begin{equation*}
\left(\int_{M} \rho^{1-2 \sigma}|u|^{k(2-\theta)}\right)^{1 / 2 k} \mathrm{~d} v_{g} \leq C+C \int_{M} \rho^{1-2 \sigma}|u|^{1-\frac{\theta}{2}} \mathrm{~d} v_{g} \tag{63}
\end{equation*}
$$

Choosing $\theta$ close to 1 such that $k(2-\theta)=\frac{\tau \theta}{2-\tau}$ (this can be achieved as long as $\tau$ is closed to 1 ) and inserting (63) to (61), we obtain

$$
\begin{align*}
\left(\int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right|^{\tau} \mathrm{d} v_{g}\right)^{1 / \tau} & \leq C\left(1+\int_{M} \rho^{1-2 \sigma}|u|^{1-\frac{\theta}{2}} \mathrm{~d} v_{g}\right)^{\frac{\theta}{2-\theta}}  \tag{64}\\
& \leq C+C\left(\int_{M} \rho^{1-2 \sigma}|u| \mathrm{d} v_{g}\right)^{\frac{\theta}{2}}
\end{align*}
$$

Since $\int_{M} \rho^{1-2 \sigma} u \mathrm{~d} v_{g}=0$, by the Poincaré-Sobolev inequality, Hölder inequality and (64), we have

$$
\|u\|_{L^{1}\left(\rho^{1-2 \sigma}, M\right)} \leq C \int_{M} \rho^{1-2 \sigma}\left|\nabla_{g} u\right| \mathrm{d} v_{g} \leq C\left(1+\|u\|_{L^{1}\left(\rho^{1-2 \sigma}, M\right)}^{\frac{\theta}{2}}\right) .
$$

Thus, $\|u\|_{L^{1}\left(\rho^{1-2 \sigma, M)}\right.} \leq C$ because $\frac{\theta}{2}<1$. Therefore, the lemma follows immediately from (64) and the Poincaré-Sobolev inequality.

Theorem A.4. For any bounded radon measure $f$ defined on $\partial M$ with $\langle f, 1\rangle=0$, there exists a weak solution $u \in W^{1,1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, M\right)$ of (59).

Proof. The proof follows from Lemma A. 3 and A. 5 and some standard approximating procedure, see, e.g., [18]. We omit the details here.

Theorem A.5. For $x_{0} \in \partial M$, let $f=\delta_{x_{0}}-\frac{1}{|\partial M| g}$, where $|\partial M|_{g}$ is the area of $\partial M$ with respect to the induced metric $g$. Then there exists a weak solution $u \in W^{1,1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, M\right)$ of (59) with mean value zero and for all $x \in \bar{M} \backslash\left\{x_{0}\right\}$,

$$
\begin{align*}
A_{1} \operatorname{dist}_{g}\left(x, x_{0}\right)^{2 \sigma-n}-A_{0} \leq u(x) & \leq A_{2} \operatorname{dist}_{g}\left(x, x_{0}\right)^{2 \sigma-n},  \tag{65a}\\
\left|\nabla_{t a n} u\right| & \leq A_{3} \operatorname{dist}_{g}\left(x, x_{0}\right)^{2 \sigma-n-1},  \tag{65b}\\
\left|\frac{\partial u}{\partial \nu}\right| & \leq A_{4} \rho^{2 \sigma-1} \operatorname{dist}_{g}\left(x, x_{0}\right)^{-n}, \tag{65c}
\end{align*}
$$

where $A_{0}, A_{1}, A_{2}, A_{3}, A_{4}$ are positive constants depending only on $M, g, n, \sigma, \rho$.
Proof. Let $f_{k} \in C^{1}(\partial M)$ with $\int_{\partial M} f_{k} \mathrm{~d} s_{g}=0,\left\|f_{k}\right\|_{L^{1}(\partial M)} \leq C$ independent of $k$, such that $f_{k} \rightarrow f$ in distribution sense as $k \rightarrow \infty$. We can also assume that $f_{k} \rightarrow f$ in $C_{l o c}^{1}\left(\partial M \backslash\left\{x_{0}\right\}\right)$. By Lemma A. 3 and Lemma A.5 there exists a unique solution $u_{k} \in \tilde{H}^{1}$ of (59) with $f$ replaced by $f_{k}$, and

$$
\left\|u_{k}\right\|_{W^{1,1+\varepsilon_{0}\left(\rho^{1-2 \sigma}, M\right)}} \leq C\left(\left\|f_{k}\right\|_{L^{1}(\partial M)}\right) \leq C .
$$

Moreover, it follows from Moser's iterations (see, e.g., the proof of Theorem A.2) that there exists some $\alpha>0$ such that

$$
\begin{equation*}
\left\|u_{k}\right\|_{C^{\alpha}\left(M \backslash \mathcal{B}_{r}\left(x_{0}\right)\right)} \leq C(r) \tag{66}
\end{equation*}
$$

for any $r>0$. By standard compactness arguments, $u_{k} \rightharpoonup u$ in $W^{1,1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, M\right)$ for some $u$, which is a weak solution of (59) and satisfies

$$
\|u\|_{C^{\alpha / 2}\left(M \backslash \mathcal{B}_{r}\left(x_{0}\right)\right)} \leq C(r) .
$$

Now, it suffices to establish the estimate (65a) for $x \in B_{r}\left(x_{0}\right)$. For $r$ suitably small, choose a Fermi coordinate system $\left\{y_{1}, \cdots, y_{n+1}\right\}$ centered at $x_{0}$. Then $u_{k}(y)$ satisfies

$$
\begin{cases}\partial_{i}\left(\rho^{1-2 \sigma} \sqrt{\operatorname{det} g} g^{i j} \partial_{j} u_{k}\right)=0, & \text { in } \mathcal{B}_{2 r}^{+}, \\ -\lim _{y_{n+1} \rightarrow 0} \rho^{1-2 \sigma} \sqrt{\operatorname{det} g} \frac{\partial u_{k}}{\partial y_{n+1}}=f_{k}, & \text { on } \partial^{\prime} \mathcal{B}_{2 r}^{+} .\end{cases}
$$

Let $v_{k}$ be the unique weak solution of

$$
\begin{cases}\partial_{i}\left(\rho^{1-2 \sigma} \sqrt{\operatorname{det} g} g^{i j} \partial_{j} v_{k}\right)=0, & \text { in } \mathcal{B}_{2 r}^{+} \\ -\lim _{y_{n+1} \rightarrow 0} \rho^{1-2 \sigma} \sqrt{\operatorname{det} g} \frac{\partial v_{k}}{\partial y_{n+1}}=-\frac{1}{|\partial M|}, & \text { on } \partial^{\prime} \mathcal{B}_{2 r}^{+} \\ v_{k}=u_{k} & \text { on } \partial^{\prime \prime} \mathcal{B}_{2 r}^{+}\end{cases}
$$

in $H^{1}\left(\rho^{1-2 \sigma}, M\right)$. In view of (66), $\left\|v_{k}\right\|_{L^{\infty}\left(\mathcal{B}_{2 r}\right)} \leq C(r)$ and hence $\left\|v_{k}\right\|_{C^{\alpha}\left(\mathcal{B}_{r}^{+}\right)} \leq C(r)$. Moreover, $w_{k}:=u_{k}-v_{k} \in H^{1}\left(\rho^{1-2 \sigma}, M\right)$ satisfies

$$
\begin{cases}\partial_{i}\left(\rho^{1-2 \sigma} \sqrt{\operatorname{det} g} g^{i j} \partial_{j} w_{k}\right)=0, & \text { in } \mathcal{B}_{2 r}^{+}, \\ -\lim _{y_{n+1} \rightarrow 0} \rho^{1-2 \sigma} \sqrt{\operatorname{det} g} \frac{\partial w_{k}}{\partial y_{n+1}}=f_{k}+\frac{1}{|\partial M|}, & \text { on } \partial^{\prime} \mathcal{B}_{2 r}^{+} \\ w_{k}=0 & \text { on } \partial^{\prime \prime} \mathcal{B}_{2 r}^{+}\end{cases}
$$

Recall that $g^{i, n+1}=0$ for $i<n+1$ on $\partial^{\prime} \mathcal{B}_{2 r}^{+}$. Let $\bar{w}_{k}$ be the even extension of $w_{k}$ in $\mathcal{B}_{2 r}$, i.e.,

$$
\bar{w}_{k}= \begin{cases}w_{k}\left(y^{\prime}, y_{n+1}\right), & y_{n+1} \geq 0 \\ w_{k}\left(y^{\prime},-y_{n+1}\right), & y_{n+1} \leq 0\end{cases}
$$

We also evenly extend $g$ and $\rho$ to be $\bar{g}$ and $\bar{\rho}$, respectively. It is easy to verify that the weak limit $w$ of $\bar{w}_{k}$ in $L^{1+\varepsilon_{0}}\left(\rho^{1-2 \sigma}, \mathcal{B}_{2 r}\right)$ is the weak solution vanishing on $\partial \mathcal{B}_{2 r}$ (see page 162 of [16]) of

$$
\partial_{i}\left(\bar{\rho}^{1-2 \sigma} \sqrt{\operatorname{det} \bar{g}} \bar{g}^{i j} \partial_{j} w\right)=-2 \delta_{0} \quad \text { in } \mathcal{B}_{2 r} .
$$

It follows from Theorem 3.3 of [16] that $w$ satisfies the estimates (65a) in $\mathcal{B}_{r}\left(x_{0}\right)$. Thus, $u$ satisfies (65a). Finally, (65b) and (65c) follows from (65a), Theorem A.3) Proposition A. 1 and some scaling arguments.
