Generalised Hunter–Saxton equations, optimal information transport, and factorisation of diffeomorphisms

We study geodesic equations for a family of right-invariant Riemannian metrics on the group of diffeomorphisms of a compact manifold. The metrics descend to Fisher's information metric on the space of smooth probability densities. The right reduced geodesic equations are higher-dimensional generalisations of the μ -Hunter–Saxton equation, used to model liquid crystals under influence of magnetic fields. Local existence and uniqueness results are established by proving smoothness of the geodesic spray.

The descending property of the metrics is used to obtain a novel factorisation of diffeomorphisms. Analogous to the polar factorisation in optimal mass transport, this factorisation solves an optimal information transport problem. It can be seen as an infinite-dimensional version of *QR* factorisation of matrices.

1 Introduction

Let (M,g) be a closed *n*-dimensional Riemannian manifold. Denote by vol the volume form. We assume that $\int_M \text{vol} = 1$. Denote by Diff(M) the group of diffeomorphisms of M and by $\text{Diff}_{\text{vol}}(M)$ the subgroup of volume preserving diffeomorphisms. Throughout the paper, the word "metric" always means "Riemannian metric".

The study of geodesic equations on diffeomorphism groups was initiated by Arnold [3], who discovered that Euler's equations for an incompressible perfect fluid correspond to a geodesic equation on $\text{Diff}_{vol}(M)$ with respect to a right-invariant L^2 metric. Since Arnold's discovery, many equations in mathematical physics have been found to fit the same framework. Such equations are called *Euler–Arnold equations*; see the monographs [4, 28, 24, 19] and the survey paper [39].

This paper is about geodesic equations for a family of right-invariant metrics on Diff(M) that descend to the homogeneous space $\text{Diff}_{vol}(M) \setminus \text{Diff}(M)$ of right co-sets, naturally identified with the space Dens(M) of smooth probability densities.

Riemannian metrics and geodesic equations on Dens(M) are important in optimal transport, probability theory, statistical mechanics, and quantum mechanics. The connection between geodesics on Diff(M) and Dens(M) was pointed out by Otto [34], who studied a non-invariant L^2 metric on Diff(M) that descends to Dens(M). (In Otto's setting, Dens(M) is identified with the homogeneous space $Diff(M)/Diff_{vol}(M)$ of *left* co-sets.) Remarkably, the corresponding metric on Dens(M) induces the Wasserstein distance; it is therefore called the *Wasserstein metric*. Otto's observation implies that L^2 optimal mass transport can be interpreted (at least formally) as a geodesic boundary-value problem on Dens(M) with respect to the Wasserstein metric. This follows from general result for Riemannian submersions: a minimal geodesic between two fibres is horizontal, and horizontal geodesics descend to geodesics on the base.

Another important metric on the space of probability densities is the *Fisher metric* (also called *Fisher–Rao metric*, *Fisher information metric*, and *entropy differential metric*). Classically, the Fisher metric occurs as a finite-dimensional metric on smooth statistical models (called statistical manifolds). It has a fundamental rôle in the field of information geometry [14, 36, 7, 1]. Friedrich [15] realised that statistical manifolds can be interpreted as finite-dimensional submanifolds of Dens(M) and that the Fisher metric on such submanifolds is the restriction of one and the same canonical metric on Dens(M). Friedrich also showed that this canonical metric has constant positive curvature.

When (M, J, ω) is a complex manifold, the Calabi–Yau theorem establishes an isomorphism between Dens(M) and the space of Kähler metrics on M compatible with the symplectic structure ω . Under this isomorphism, the Fisher metric corresponds to the *Calabi metric* introduced in the 1950s (see [8] for details). Results about the Fisher metric are therefore of interest also in the field of Kähler–Einstein metrics and complex Monge–Ampere equations.

Khesin, Lenells, Misiołek, and Preston [23] introduced a right-invariant degenerate \dot{H}^1 "metric" on Diff(*M*) that descends to the Fisher metric on Dens(*M*). (Dens(*M*) is here identified with the *right* co-sets Diff_{vol}(*M*)\Diff(*M*).) By taking Otto's point of view, the authors regard the geodesic boundary-value problem, with respect to the Fisher metric, as an optimal "information" transport problem, with respect to a degenerate cost function on Diff(*M*) induced by the \dot{H}^1 "metric". Since the cost function is degenerate, the transport maps are not unique.

As pointed out in [23], there are no available examples of right-invariant metrics on Diff(M) that descend to Dens(M). Our main motivation is to construct such metrics, thereby completing the analogy between optimal mass and information transport. Indeed, in this paper we introduce a 3-parameter family of right-invariant metrics on Diff(M) that descend to the Fisher metric. We give existence and uniqueness results for the geodesic equation and the corresponding optimal information transport problem. The latter result implies a novel factorisation of diffeomorphisms. This factorisation is analogous to, but different from, the polar factorisation of vector valued maps on \mathbb{R}^n , obtained by Brenier [5] and later generalised to Riemannian manifolds by McCann [29]. Our factorisation result can be understood as an infinite-dimensional version of the *QR* factorisation of matrices.

The right reduced geodesic equations for our family of metrics can be interpreted as higher-dimensional generalisations of the μ -Hunter–Saxton (μ HS) equation, studied by Khesin, Lenells, and Misiołek [22] (also called μ -Camassa–Holm in [27]). The μ HS equation is a simple model for a liquid crystal under influence of an external magnetic field.

We now present the higher-dimensional generalisations.

Let $\mathfrak{X}(M)$ and $\Omega^k(M)$, respectively, denote smooth vector fields and *k*-forms on *M*. Further, let

$$\mathfrak{F}(M) = \left\{ F \in C^{\infty}(M); \int_M F \operatorname{vol} = 0 \right\}.$$

Recall the differential d: $\Omega^k(M) \to \Omega^{k+1}(M)$ and the co-differential $\delta: \Omega^k(M) \to \Omega^{k-1}(M)$.

The Laplace-de Rham operator $\Delta := -d \circ \delta - \delta \circ d$ restricted to $d\Omega^{k-1}(M)$ or $\delta\Omega^{k+1}(M)$ is an isomorphism [37]. In particular, it is an isomorphism on $\mathcal{F}(M) = \delta\Omega^1(M)$. Let $\flat : \mathfrak{X}(M) \to \Omega^1(M)$ denote the flat map, also called the *musical isomorphism*. Its inverse, the sharp map, is denoted \sharp . We typically write u^{\flat} instead of $\flat(u)$ and correspondingly for \sharp .

Consider the pseudo-differential operator $\mathcal{A}: \mathfrak{X}(M) \to \Omega^1(M)$ defined by

$$\mathcal{A}u := \left(\mathrm{id} + \mathrm{d} \circ \Delta^{-1} \circ \delta + \gamma \delta \circ \Delta^{-1} \circ \mathrm{d} + \alpha \delta \circ \mathrm{d} + \beta \mathrm{d} \circ \delta \right) (u^{\flat}) \tag{1}$$

where $\alpha, \beta > 0$ and $\gamma \in [0, 1]$ are parameters. We are interested in the integro-differential equation

$$\dot{m} + \mathcal{L}_u m + m \operatorname{div}(u) = 0, \quad m = \mathcal{A}u,$$
 (2a)

where \mathcal{L}_u denotes the Lie derivative along u and $\dot{m} \coloneqq \frac{\partial m}{\partial t}$. A *solution* is a curve $t \mapsto u(t) \in \mathfrak{X}(M)$ that fulfils equation (2a). The equation also admits the form

$$\left(\frac{\partial}{\partial t} + \mathcal{L}_u\right)(m \otimes \text{vol}) = 0, \tag{2b}$$

because

$$\mathcal{L}_{u}(m \otimes \operatorname{vol}) = (\mathcal{L}_{u}m) \otimes \operatorname{vol} + m \otimes \operatorname{div}(u) \operatorname{vol} = (\mathcal{L}_{u}m + m\operatorname{div}(u)) \otimes \operatorname{vol}$$

The one-form density $m \otimes$ vol is therefore transported by the flow, much like vorticity is transported by the flow of a perfect fluid.

Remark 1.1. If $\alpha = \beta = \gamma = 1$ and the first de Rham cohomology of *M* is trivial, then $\mathcal{A} = -\Delta \circ \flat$. An example is $M = S^n$ (the *n*-dimensional sphere) for n > 1.

Remark 1.2. If $\alpha = \beta = \gamma = 1$ and $M = \mathbb{T}^n$ (the *n*-dimensional flat torus) then

$$\mathcal{A}u = -\Delta u^{\flat} + \sum_{i=1}^{n} \langle u, t_i \rangle_{L^2} t_i^{\flat},$$

where $t_i := \frac{\partial}{\partial x_i} \in \mathfrak{X}(\mathbb{T}^n)$, i.e., t_1, \ldots, t_n is a basis for infinitesimal translations on \mathbb{T}^n .

The paper is organised as follows. In § 2 we show that equation (2) is a right reduced geodesic equation on Diff(M), i.e., an Euler–Arnold equation. Local existence and uniqueness of the Cauchy problem is given in § 3. In §4 we discuss characterisation and construction of right-invariant and descending metrics, and we show that our family of constructed metrics descend to the Fisher metric. In §5 we present an abstract geometric framework for right-invariant optimal transport problems and polar factorisation. Then, in §5.1, we focus on optimal information transport, using as cost function the squared Riemannian distance of the new metrics, and we derive a polar factorisation result for H^s diffeomorphisms. Finally, we show in §5.2 that *QR* factorisation of matrices can be viewed as polar factorisation corresponding to optimal transport of inner products on \mathbb{R}^n . The relation to the Cholesky factorisation of symmetric matrices is pointed out.

We continue the introduction by deriving yet another form of equation (2). This form reveals structural properties and relations to other equations.

1.1 Hodge components

The Helmholtz decomposition of vector fields is

$$\mathfrak{X}(M) = \mathfrak{X}_{\mathrm{vol}}(M) \oplus \mathrm{grad}(\mathfrak{F}(M)),$$

where $\mathfrak{X}_{vol}(M)$ is the space of divergence-free vector fields; every $u \in \mathfrak{X}(M)$ can be decomposed uniquely as $u = \xi + \operatorname{grad}(f)$, with $\xi \in \mathfrak{X}_{vol}(M)$ and $f \in \mathcal{F}(M)$. Since *f* is normalised, it is unique. This decomposition is orthogonal with respect to the L^2 inner product on $\mathfrak{X}(M)$, given by

$$\langle u,v\rangle_{L^2} = \int_M \mathsf{g}(u,v)\mathrm{vol}.$$

The Hodge decomposition of *k*-forms is

$$\Omega^{k}(M) = \mathfrak{H}^{k}(M) \oplus \delta \Omega^{k+1}(M) \oplus \mathrm{d} \Omega^{k-1}(M),$$

where $\mathcal{H}^k(M) = \{a \in \Omega^k(M); \Delta a = 0\}$ is the space of harmonic *k*-forms. This decomposition is orthogonal with respect to the L^2 inner product on $\Omega^k(M)$, given by

$$\langle a,b
angle_{L^2}=\int_M a\wedge\star b,$$

where $\star : \Omega^k(M) \to \Omega^{n-k}(M)$ is the Hodge star map. Notice that $\langle u, v \rangle_{L^2} = \langle u^{\flat}, v^{\flat} \rangle_{L^2}$.

Let $D^k(M) := \mathcal{H}^k(M) \oplus \delta\Omega^{k+1}(M)$. Then $D^k(M) = \{a \in \Omega^k(M); \delta a = 0\}$ is the space of co-closed *k*-forms. The relation between the Helmholtz and Hodge decompositions is

$$\mathfrak{X}_{\text{vol}}(M)^{\flat} = \mathsf{D}^{1}(M), \quad \operatorname{grad}(\mathfrak{F}(M))^{\flat} = \mathsf{d}\Omega^{0}(M).$$

That is, the musical isomorphism $\flat \colon \mathfrak{X}(M) \to \Omega^1(M)$ is diagonal with respect to the two decompositions. The same is true for the pseudo-differential operator $\mathcal{A} \colon \mathfrak{X}(M) \to \Omega^1(M)$. That is,

$$\mathcal{AX}_{\text{vol}}(M) = \mathsf{D}^1(M), \quad \mathcal{A}\operatorname{grad}(\mathfrak{F}(M)) = \mathsf{d}\Omega^0(M).$$

From the Hodge decomposition we also obtain a finer decomposition

$$\mathfrak{X}_{\mathrm{vol}}(M) = \mathfrak{X}_{\mathcal{H}}(M) \oplus \mathfrak{X}_{\mathrm{vol},\mathrm{ex}}(M),$$

where $\mathfrak{X}_{\text{vol},\text{ex}}(M) = \delta \Omega^2(M)^{\sharp}$ is the space of *exact* volume preserving vector fields, and $\mathfrak{X}_{\mathcal{H}}(M) = \mathcal{H}^1(M)^{\sharp}$ is the space of *harmonic* vector fields. \mathcal{A} is diagonal also with respect to this finer decomposition. Indeed, the L^2 orthogonal projection operator $R: \Omega^1(M) \to \mathcal{H}^1(M)$ onto the harmonic part is given by

$$R = \mathrm{id} + \mathrm{d} \circ \Delta^{-1} \circ \delta + \delta \circ \Delta^{-1} \circ \mathrm{d},$$

and the L^2 orthogonal projection operator $P: \Omega^1(M) \to D^1(M)$ onto the co-closed part is given by

$$P = \mathrm{id} + \mathrm{d} \circ \Delta^{-1} \circ \delta.$$

From the definition of \mathcal{A} it follows that $\mathcal{A} = (\gamma R + (1 - \gamma)P + \alpha \delta \circ d + \beta d \circ \delta) \circ \flat$. If $h \in \mathfrak{X}_{\mathcal{H}}(M)$ then

$$\mathcal{A}h = \underbrace{\left(\underline{\gamma R + (1 - \gamma)P}\right)h^{\flat}}_{h^{\flat}} + \alpha \delta \underbrace{dh^{\flat}}_{0} + \beta d \underbrace{\delta h^{\flat}}_{0} = h^{\flat} \in \mathcal{H}^{1}(M).$$

If $\xi \in \mathfrak{X}_{\mathrm{vol},\mathrm{ex}}(M)$ then

$$\mathcal{A}\xi = \underbrace{\gamma \mathcal{R}\xi^{\flat}}_{0} + (1-\gamma)\underbrace{\mathcal{P}\xi^{\flat}}_{\xi^{\flat}} + \alpha \delta d\xi^{\flat} + \beta d\underbrace{\delta\xi^{\flat}}_{0} = (1-\gamma)\xi^{\flat} + \alpha \delta d\xi^{\flat} \in \delta\Omega^{2}(M).$$

If $f \in \mathcal{F}(M)$ then

$$A \operatorname{grad}(f) = \underbrace{(1-\gamma)Pdf + \gamma Rdf + \alpha \,\delta ddf}_{0} - \beta \, d\Delta f = -\beta \, d\Delta f \in d\Omega^{0}(M)$$

Thus, if we represent $u = h + \xi + \operatorname{grad}(f)$ by its unique "Helmholtz–Hodge components" $(h, \xi, f) \in \mathfrak{X}_{\mathcal{H}}(M) \times \mathfrak{X}_{\operatorname{vol}, \operatorname{ex}}(M) \times \mathfrak{F}(M)$, then

$$\mathcal{A}(h,\xi,f) = (h^{\flat}, ((1-\gamma)\mathrm{id} - \alpha\Delta)\xi^{\flat}, -\beta\Delta f) \in \mathcal{H}^{1}(M) \times \delta\Omega^{2}(M) \times \mathcal{F}(M).$$

Since both $((1-\gamma)id - \alpha\Delta) \circ \flat \colon \mathfrak{X}_{vol,ex}(M) \to \delta\Omega^2(M)$ and $\Delta \colon \mathfrak{F}(M) \to \mathfrak{F}(M)$ are invertible operators, \mathcal{A} is also invertible (see § 3 for details).

Our aim is now to write equation (2a) in terms of the Hodge components

$$\boldsymbol{\sigma} \coloneqq (\boldsymbol{\gamma} \boldsymbol{R} + (1 - \boldsymbol{\gamma}) \boldsymbol{P} + \boldsymbol{\alpha} \, \boldsymbol{\delta} \circ \mathbf{d})(\boldsymbol{u}^{\flat}) \in \mathsf{D}^{1}(\boldsymbol{M})$$

and

$$\rho \coloneqq \Delta f = \operatorname{div}(u) \in \mathcal{F}(M).$$

In these variables $m = \sigma - \beta d\rho$, so equation (2a) becomes

In general, $\mathcal{L}_u \sigma + \rho \sigma \notin D^1(M)$ and $\mathcal{L}_u \rho + \frac{\rho^2}{2} \notin \mathcal{F}(M)$. Therefore we need a Lagrange multiplier in order to find the Hodge components. We can always find a function $p \in C^{\infty}(M)$ such that $\mathcal{L}_u \xi^{\flat} + \rho \xi^{\flat} + dp \in D^1(M)$, with *p* uniquely determined up to a constant. Further, we can always determine the constant part of *p* so that $\mathcal{L}_u \rho + \frac{\rho^2}{2} + \frac{p}{\beta} \in \mathcal{F}(M)$. Continuing from above

$$\underbrace{\dot{\sigma} + \mathcal{L}_{u}\sigma + \rho\sigma + \mathrm{d}p}_{\in \mathsf{D}^{1}(M)} - \beta \operatorname{d}\left(\underbrace{\dot{\rho} + \mathcal{L}_{u}\rho + \frac{\rho^{2}}{2} + \frac{p}{\beta}}_{\in \mathcal{F}(M)}\right) = 0.$$

We now obtain equation (2a) in terms of the Hodge components

$$\dot{\sigma} + \mathcal{L}_{u}\sigma + \rho\sigma = -dp, \qquad \sigma = (\gamma R + (1 - \gamma)id - \alpha\Delta)(Pu^{\flat})$$

$$\dot{\rho} + \mathcal{L}_{u}\rho + \frac{\rho^{2}}{2} = -\frac{p}{\beta}, \qquad \rho = \operatorname{div}(u)$$

$$\delta\sigma = 0$$

$$\int_{M} \rho \operatorname{vol} = 0,$$
(2c)

where the "pressure" $p \in C^{\infty}(M)$ is a Lagrange multiplier, determined uniquely by the two constraint equations.

If $\sigma(t_0) = 0$ at some time t_0 , it follows from equation (2c) that $\dot{\sigma}(t_0) = 0$. The consequence is that $\operatorname{grad}(\mathcal{F}(M))$ is an *invariant subspace*; if $u(t_0) \in \operatorname{grad}(\mathcal{F}(M))$ then $u(t) \in \operatorname{grad}(\mathcal{F}(M))$ for all *t*. From a geometric point of view, the reason is that the corresponding right-invariant metric on Diff(*M*) descends to the homogenous space Diff_{vol}(*M*)\Diff(*M*) \simeq Dens(*M*), as described in §4. In contrast, $\rho(t_0) = 0$ does *not* imply $\rho(t) = 0$, so $\mathfrak{X}_{vol}(M)$ is *not* an invariant subspace, so Diff_{vol}(*M*) is *not* totally geodesic (see [31] for details on totally geodesic subgroups). But, if $\rho(t_0) = 0$ then it follows from equation (2c) that $\dot{\rho}(t_0)$ is arbitrarily small for large enough β . This observation suggests that solutions to equation (2) with $\gamma = 0$ may converge to solutions of the Euler- α fluid equation as $\beta \to \infty$. We do not expect good behaviour of solutions as $\beta \to 0$, since \mathcal{A} is not invertible for $\beta = 0$.

Equation (2) is a higher-dimensional generalisation of the μ HS equation, studied by Khesin, Lenells, and Misiołek [22]. Indeed, $\mathfrak{X}_{vol}(S^1) = \mathfrak{X}_{\mathcal{H}}(S^1) \simeq \mathbb{R}$ consists of the constant vector fields on the circle S^1 , so equation (2c) with $M = S^1$ becomes

$$\dot{\xi} + 2\xi u_x = -p_x$$
$$\dot{u}_x + uu_{xx} + \frac{1}{2}(u_x)^2 = -\frac{p}{\beta}.$$

From the first equation it follows that

$$0 = \int_{S^1} (\dot{\xi} + 2\xi u_x + p_x) \, \mathrm{d}x = \dot{\xi} \, \mu(S^1), \quad \mu(S^1) \coloneqq \int_{S^1} \, \mathrm{d}x,$$

which implies $\dot{\xi} = 0$. Now differentiate the second equation with respect to x to get

$$\dot{u}_{xx}+2u_xu_{xx}+uu_{xxx}=\frac{2\xi u_x}{\beta}$$

Since $\int_{S^1} u \, dx = \int_{S^1} \xi \, dx$ it follows that ξ is the mean of u over S^1 , i.e.,

$$\xi = \mu(u) \coloneqq \frac{1}{\mu(S^1)} \int_{S^1} u \, \mathrm{d}x.$$

Thus,

$$\dot{u}_{xx}+2u_xu_{xx}+uu_{xxx}=\frac{2\mu(u)u_x}{\beta},$$

which is the μ HS equation.

A different generalisation of the μ HS equation, from $M = S^1$ to $M = \mathbb{T}^n$, is given by Kohlmann [25]. It is also an Euler–Arnold equation, but the corresponding right-invariant metric does not descend to density space.

2 Euler–Arnold structure

The geodesic equation for a right-invariant (or left-invariant) metric on a Lie group G can be reduced to an equation on the Lie algebra \mathfrak{g} , called an Euler–Poincaré or Euler–Arnold equation. The abstract form of this equation, first written down by Poincaré [35], is

$$\mathcal{A}\dot{u} + \mathrm{ad}_{u}^{*}(\mathcal{A}u) = 0, \tag{3}$$

where $\mathcal{A}: \mathfrak{g} \to \mathfrak{g}^*$ is the *inertia operator* induced by the inner product on \mathfrak{g} defining the right-invariant metric, and $ad_u^*: \mathfrak{g}^* \to \mathfrak{g}^*$ is the infinitesimal action of u on \mathfrak{g}^* , i.e., the dual operator of $ad_u: \mathfrak{g} \to \mathfrak{g}$.

In our case, G = Diff(M), $\mathfrak{g} = \mathfrak{X}(M)$, and $ad_u = -\mathcal{L}_u$. The dual of $\mathfrak{X}(M)$ is identified with $\Omega^1(M)$ via the pairing

$$\langle m, u \rangle = \int_M \mathbf{i}_u m \operatorname{vol} = \langle m, v^{\flat} \rangle_{L^2}.$$

We now define an inner product on $\mathfrak{X}(M)$ with inertia operator given by (1). Indeed, consider the inner product

$$\langle u, v \rangle_{\alpha\beta\gamma} \coloneqq \langle \bar{P}_{\gamma} u^{\flat}, \bar{P}_{\gamma} v^{\flat} \rangle_{L^{2}} + \alpha \langle \mathrm{d} u^{\flat}, \mathrm{d} v^{\flat} \rangle_{L^{2}} + \beta \langle \delta u^{\flat}, \delta v^{\flat} \rangle_{L^{2}}, \tag{4}$$

where $\bar{P}_{\gamma} := \gamma R + (1 - \gamma)P$ is introduced to simplify notation. Notice that (4) is different from the Sobolev *a-b-c* inner product considered in [23], since only the divergence-free components occur in the first term. From $\langle a, \delta b \rangle_{L^2} = \langle da, b \rangle_{L^2}$ and $\langle \bar{P}_{\gamma} u^{\flat}, \bar{P}_{\gamma} v^{\flat} \rangle_{L^2} = \langle \bar{P}_{\gamma} u^{\flat}, v^{\flat} \rangle_{L^2}$ we get

$$\langle u, v \rangle_{\alpha\beta\gamma} = \langle \bar{P}_{\gamma} u^{\flat} + \alpha \, \delta \mathrm{d} u^{\flat} + \beta \, \mathrm{d} \delta u^{\flat}, v^{\flat} \rangle_{L^2} = \langle \mathcal{A} u, v \rangle_{S^2}$$

so \mathcal{A} in (1) is indeed the inertia tensor corresponding to the inner product (4).

Using the inner product (4), we define a right-invariant metric $\langle \langle \cdot, \cdot \rangle \rangle_{\alpha\beta\gamma}$ on Diff(*M*) by right translation of vectors to $\mathfrak{X}(M) = T_{id} \text{Diff}(M)$. Explicitly,

$$\langle \langle U, V \rangle \rangle_{\alpha\beta\gamma} = \langle U \circ \varphi^{-1}, V \circ \varphi^{-1} \rangle_{\alpha\beta\gamma}, \qquad (5)$$

for $U, V \in T_{\varphi} \text{Diff}(M)$.

Let us revisit the case $M = S^1$. Diff_{vol} $(S^1) = \text{Rot}(S^1)$, i.e., the one dimensional Lie group of rigid rotations, and $\mathfrak{X}_{\text{vol}}(S^1) \simeq \mathbb{R}$, i.e., the constant vector fields. The inner product (4) becomes

$$\langle u,v\rangle_{\mu\dot{H}^1} = \int_{S^1} u\,\mathrm{d}s\int_{S^1} v\,\mathrm{d}s + \int_{S^1} u_xv_x\,\mathrm{d}s,$$

which is the inner product for the μ HS metric in [22]. As expected, the α - β - γ metric (5) on Diff(*M*) is thus a generalisation of the μ HS metric on Diff(*S*¹).

The dual operator of $-\mathcal{L}_u: \mathfrak{X}(M) \to \mathfrak{X}(M)$ is computed as

$$\langle m, -\mathcal{L}_{u}v \rangle = -\int_{M} m \wedge \star (\mathcal{L}_{u}v)^{\flat} = -\int_{M} m \wedge \mathbf{i}_{\mathcal{L}_{u}v} \operatorname{vol}$$
$$= -\int_{M} m \wedge (\mathcal{L}_{u}\mathbf{i}_{v}\operatorname{vol} - \mathbf{i}_{v}\mathcal{L}_{u}\operatorname{vol})$$
$$= -\underbrace{\int_{M} \mathcal{L}_{u}(m \wedge \mathbf{i}_{v}\operatorname{vol})}_{0} + \int_{M} \mathcal{L}_{u}m \wedge (\mathbf{i}_{v}\operatorname{vol} + \operatorname{div}(u)\mathbf{i}_{v}\operatorname{vol})$$
$$= \int_{M} (\mathcal{L}_{u}m + \operatorname{div}(u)m) \wedge \mathbf{i}_{v}\operatorname{vol} = \langle \mathcal{L}_{u}m + \operatorname{div}(u)m, v \rangle.$$

Hence, $ad_u^*(m) = \mathcal{L}_u m + div(u)m$. We obtain the following result by comparing equations (2) and (3).

Proposition 2.1. Equation (2) is the Euler–Arnold equation for the geodesic flow on Diff(M) with respect to the right-invariant α - β - γ metric (5).

3 Local existence and uniqueness

In this section we show that equation (2) is well-posed as a Cauchy problem. Following Ebin and Marsden [10], the approach is to prove smoothness of the geodesic spray in Sobolev H^s topologies.

Let *N* be a smooth finite-dimensional manifold. If s > n/2 then the set $H^s(M,N)$ of maps from *M* to *N* of Sobolev differentiability H^s is a Banach manifold ($H^s(M,N)$) is even a Hilbert manifold, but that is not relevant in our analysis). Let $\pi_N : TN \to N$ be the canonical projection. The tangent space at $f \in H^s(M,N)$ is

$$T_f H^s(M,N) = \{ v \in H^s(M,TN); \pi_N \circ v = f \},$$

so $TH^{s}(M,N) = H^{s}(M,TN)$. By iteration we obtain the higher order tangent bundles as $T^{k}H^{s}(M,N) = H(M,T^{k}N)$.

If s > n/2 + 1, which is assumed throughout the remainder, then Diff^s(M), i.e., the set of bijective maps in $H^s(M,M)$ whose inverses also belong to $H^s(M,M)$, is an open subset of $H^s(M,M)$, and therefore also a Banach manifold. Since Diff^s(M) is open in $H^s(M,M)$ we have T_{φ} Diff^s(M) = $T_{\varphi}H^s(M,M)$. In particular, T_{id} Diff^s(M) = $\mathfrak{X}^s(M)$, i.e., the vector fields on M of Sobolev type H^s .

The space of *k*-forms of Sobolev type H^s is denoted $\Omega^{k,s}(M)$.

Let $\psi \in \text{Diff}^{s}(M)$. Right multiplication $\text{Diff}^{s}(M) \ni \varphi \mapsto \varphi \circ \psi \in \text{Diff}^{s}(M)$ is smooth, but $\text{Diff}^{s}(M)$ is *not* a Banach Lie group, because left multiplication is *not* smooth. Instead, $\text{Diff}^{s}(M)$ is a topological group, because the group operations are continuous [10, §2].

Consider the lifted inertia operator $\mathcal{A}^{\sharp} := \sharp \circ \mathcal{A}$, with \mathcal{A} defined in (1).

Lemma 3.1. A^{\sharp} is a smooth isomorphism $\mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-2}(M)$.

Proof. Let $R: \Omega^{1,s}(M) \to \mathcal{H}^1(M)$ and $P_{ex}: \Omega^{1,s}(M) \to \delta\Omega^{1,s+1}(M)$ be the Hodge projections onto $\mathcal{H}^1(M)$ and $\delta\Omega^{1,s+1}(M)$ respectively. These mappings are smooth, as the Hodge decomposition of $\Omega^{1,s}(M)$ is smooth [10]. Since the musical isomorphism is smooth it follows that $Z: u \mapsto (Ru^{\flat}, P_{ex}u^{\flat}, \operatorname{div}(u))$ is a smooth mapping $\mathfrak{X}^s(M) \to \mathcal{H}^1(M) \times \delta\Omega^{1,s+1}(M) \times \mathfrak{F}^{s-1}(M)$; it is in fact an isomorphism, since it has a smooth inverse given by $(h, \sigma, \rho) \mapsto h^{\sharp} + \sigma^{\sharp} + \operatorname{grad}(\Delta^{-1}(\rho))$. (Notice that $\Delta^{-1}: \mathfrak{F}^{s-1}(M) \to \mathfrak{F}^{s+1}(M)$.)

From the definition (1) of \mathcal{A} it follows that

$$\mathcal{A}^{\sharp} = Z^{-1} \circ (\mathrm{id}, (1 - \gamma)\mathrm{id} - \alpha \Delta, -\beta \Delta) \circ Z$$

This is an isomorphism $\mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-2}(M)$ since $((1-\gamma)id - \alpha\Delta): \delta\Omega^{1,s+1}(M) \to \delta\Omega^{1,s-1}(M)$ and $\Delta: \mathfrak{F}^{s-1}(M) \to \mathfrak{F}^{s-3}(M)$ are isomorphisms (see [37]). The inverse is

$$(\mathcal{A}^{\sharp})^{-1} = Z^{-1} \circ \left(\mathrm{id}, \left((1 - \gamma) \mathrm{id} - \alpha \Delta \right)^{-1}, -\frac{1}{\beta} \Delta^{-1} \right) \circ Z$$

which concludes the proof.

From the definition of *u* it follows that $u(\varphi(x)) = \dot{\varphi}(x)$ for $x \in M$. By differentiation with respect to *t* we obtain

$$\frac{\mathrm{d}}{\mathrm{d}t}\Big(u\big(\varphi(x)\big)\Big) = \ddot{\varphi}(x) \in T^2_{(\varphi(x),\dot{\varphi}(x))}M.$$
(6)

 \square

The Levi–Civita connection ∇ , induced by the Riemannian metric g on M, defines a diffeomorphism $(c, \dot{c}, \ddot{c}) \mapsto (c, \dot{c}, \nabla_{\dot{c}} \dot{c})$ between the second tangent bundle T^2M and the Whitney sum $TM \oplus TM$. By pointwise operations, this diffeomorphism identifies the second tangent bundle T^2 Diff^s(M) with the Whitney sum TDiff^s $(M) \oplus T$ Diff^s(M). By the ω -lemma (see, e.g., [10]) the identification is smooth. Using this identification and $u = \dot{\varphi} \circ \varphi^{-1}$, we express equation (6) as

$$\dot{u} + \nabla_u u = \left(\frac{D}{\mathrm{d}t}\dot{\varphi}\right)\circ \varphi^{-1},$$

where $\frac{D}{dt}\dot{\phi}(x) \coloneqq \nabla_{\dot{\phi}(x)}\dot{\phi}(x)$ is the co-variant derivative along the path itself. We now rewrite equation (2a) as

$$\mathcal{A}^{\sharp}\left(\left(\frac{D}{\mathrm{d}t}\frac{\mathrm{d}\varphi}{\mathrm{d}t}\right)\circ\varphi^{-1}\right) = -(\mathcal{L}_{u}\mathcal{A}u)^{\sharp} - (\mathcal{A}^{\sharp}u)\operatorname{div}(u) + \mathcal{A}^{\sharp}\nabla_{u}u \rightleftharpoons F(u).$$
(7)

The approach is to show that (7) defines a smooth spray on $\text{Diff}^{s}(M)$, i.e., a smooth vector field

$$\tilde{S}$$
: $TDiff^{s}(M) \to T^{2}Diff^{s}(M) \simeq TDiff^{s}(M) \oplus TDiff^{s}(M)$

Let R_{ψ} : Diff^s $(M) \to \text{Diff}^{s}(M)$ denote composition with $\psi \in \text{Diff}^{s}(M)$ from the right, i.e., $R_{\psi}(\varphi) = \varphi \circ \psi$. As already mentioned, this is a smooth mapping, so the corresponding tangent mapping TR_{ψ} , given by $T_{\varphi}\text{Diff}^{s}(M) \ni v \mapsto v \circ \psi \in T_{\varphi \circ \psi}\text{Diff}^{s}(M)$, is also smooth. Let $T\text{Diff}^{s-2}(M) \upharpoonright \text{Diff}^{s}(M)$ denote the restriction of the tangent bundle $T\text{Diff}^{s-2}(M)$ to the base Diff^s(M). This is a smooth Banach vector bundle [10, Appendix A]. If $B: \mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-2}(M)$ we denote by \tilde{B} the bundle mapping $T\text{Diff}^{s}(M) \to T\text{Diff}^{s-2}(M) \upharpoonright \text{Diff}^{s}(M)$ given by

$$ilde{B} \colon (oldsymbol{arphi}, \dot{oldsymbol{\phi}}) \mapsto (oldsymbol{arphi}, ilde{B}_{oldsymbol{arphi}}(\dot{oldsymbol{\phi}})) \coloneqq TR_{oldsymbol{arphi}} \circ B \circ TR_{oldsymbol{arphi}^{-1}}.$$

If *B* is smooth, then $\tilde{B}_{\varphi}: T_{\varphi} \text{Diff}^{s}(M) \to T_{\varphi} \text{Diff}^{s-2}(M)$ is smooth for fixed $\varphi \in \text{Diff}^{s}(M)$, but $\tilde{B}: T\text{Diff}^{s}(M) \to T\text{Diff}^{s-2}(M)$ need not be smooth, because $\varphi \mapsto \varphi^{-1}$ is not smooth. The following lemmas resolve the situation in our specific case.

Lemma 3.2. The mapping

$$\tilde{\mathcal{A}}^{\sharp} \colon T\mathrm{Diff}^{s}(M) \to T\mathrm{Diff}^{s-2}(M) \restriction \mathrm{Diff}^{s}(M)$$

is a smooth vector bundle isomorphism.

Proof. We have

$$\tilde{\mathcal{A}}^{\sharp} = \tilde{R}^{\sharp} + (1 - \gamma) \tilde{P}_{\mathrm{ex}}^{\sharp} + \tilde{W}$$

where $P_{\text{ex}}^{\sharp} = \sharp \circ P_{\text{ex}} \circ \flat$, $R^{\sharp} = \sharp \circ R \circ \flat$ are the lifted Hodge projections and $W = \alpha \sharp \circ \delta \circ d \circ \flat - \beta$ grad \circ div. $\tilde{P}_{\text{ex}}^{\sharp}$ and \tilde{R}^{\sharp} are smooth bundle maps $T\text{Diff}^{s}(M) \to T\text{Diff}^{s}(M)$ [10, Appendix A, Lemmas 2,3,6]. Thus, $\tilde{P}_{\text{ex}}^{\sharp}$ and \tilde{R}^{\sharp} are also smooth as mappings $T\text{Diff}^{s}(M) \to T\text{Diff}^{s-2}(M) \upharpoonright$ Diff^s(M). That \tilde{W} is smooth follows from [10, Appendix A, Lemma 2].

In a local chart in a neighbourhood of $\varphi \in \text{Diff}^{s}(M)$, the derivative of $\tilde{\mathcal{A}}^{\sharp}$ at $(\varphi, \dot{\varphi})$ is a smooth linear mapping of the form

$$\begin{pmatrix} \mathrm{id} & 0 \\ * & \tilde{\mathcal{A}}_{\varphi}^{\sharp} \end{pmatrix} : T_{\varphi}\mathrm{Diff}^{s}(M) \times T_{\varphi}\mathrm{Diff}^{s}(M) \to T_{\varphi}\mathrm{Diff}^{s}(M) \times T_{\varphi}\mathrm{Diff}^{s-2}(M)$$

It follows from Lemma 3.1 that $\tilde{\mathcal{A}}_{\varphi}^{\sharp}$ is a linear isomorphism, with smooth inverse given by $(\mathcal{A}^{\sharp})_{\varphi}^{-1}$. The result now follows from the inverse function theorem for Banach manifolds.

Lemma 3.3. Let $B: \mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-k}(M)$ be a smooth linear differential operator of order k. If s > n/2 + k, then

$$u \longmapsto B\nabla_u u - \nabla_u B u = [B, \nabla_u] u$$

is a smooth non-linear differential operator $\mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-k}(M)$.

Proof. If *f* and *g* are a scalar differential operators of order *k* and *l* respectively, then [f,g] is a scalar differential operator of order k + l - 1, since the order k + l differential terms in the commutator cancel each other. In general, this is not true for vector valued differential operators. Nevertheless, for a fixed *v*, the linear operator $u \mapsto \nabla_v u$ is given in components by

$$\nabla_{\mathbf{v}} u = \left(v^i u^j \Gamma^k_{ij} + v^i \frac{\partial u^k}{\partial x^i} \right) \mathbf{e}_k,$$

so the differentiating part of ∇_v is acting diagonally on the elements of u. We write $\nabla_v u = Gu + f(u^i)\mathbf{e}_i$, where $G: \mathfrak{X}^s(M) \to \mathfrak{X}^s(M)$ is tensorial and f is a scalar differential operator of order 1. If $B = (b_i^i)$, so that $B(u_1\partial_1 + \ldots + u_n\partial_n) = b_i^i(u^j)\mathbf{e}_i$, then

$$[B, \nabla_{v}]u = [B, G]u + \left([f, b_{j}^{i}]u^{j}\right)\mathbf{e}_{i}.$$

Since *G* is tensorial, [B,G] is a differential operator of the same order as *B*, i.e., order *k*. Since *f* and b_{ij} are scalar differential operators of order 1 and *k*, it holds that $[f, b_{ij}]$ is of order k + 1 - 1 = k. Since $\nabla_v Bu$ differentiates *v* zero times, and $B\nabla_v u$ differentiates *v* at most *k* times, it is now clear that the total operation $u \mapsto [B, \nabla_u u]$ differentiates *u* at most *k* times, which finishes the proof.

Lemma 3.4. Let $B: \mathfrak{X}^{s}(M) \to \mathfrak{X}^{s-k}(M)$ be a smooth linear differential operator of order k. If s > n/2 + k, then

$$\tilde{B}: T\mathrm{Diff}^{s}(M) \to T\mathrm{Diff}^{s-k}(M) \upharpoonright \mathrm{Diff}^{s}(M)$$

is a smooth bundle map.

Proof. Assume first that *B* is of order 1. Locally, $\tilde{B}(\varphi, \dot{\varphi})$ is then constructed by rational combinations of $\varphi^i, \dot{\varphi}^i, \frac{d\varphi^i}{dx^j}, \frac{d\dot{\varphi}^i}{dx^j}$. Smoothness follows since pointwise multiplications are smooth operations [10, Appendix A, Lemma 2].

We now decompose *B* into a sequence of *k* first order operators, so that $B = B_1 \cdots B_k$. Then $\tilde{B} = \tilde{B}_1 \cdots \tilde{B}_k$ and by the first part of the proof each \tilde{B}_i is smooth and drops differentiability by one. This finishes the proof.

Remark 3.5. Notice that if $Q: \mathfrak{X}^{s}(M) \times \mathfrak{X}^{s-l}(M) \to \mathfrak{X}^{s-k}$ is a bilinear differential operator of order $k \ge 0$ in its first argument and $k-l \ge 0$ in its second argument, then Lemma 3.4 implies that

$$\tilde{Q} \colon T\mathrm{Diff}^{s}(M) \times T\mathrm{Diff}^{s-l}(M) \upharpoonright \mathrm{Diff}^{s}(M) \to T\mathrm{Diff}^{s-k}(M) \upharpoonright \mathrm{Diff}^{s}(M)$$

is smooth whenever s > n/2 + k.

Lemma 3.6. *If* s > n/2 + 2, *then*

$$\tilde{F}: T\mathrm{Diff}^{s}(M) \to T\mathrm{Diff}^{s-2}(M) \upharpoonright \mathrm{Diff}^{s}(M)$$

is a smooth bundle map.

Proof. For any $v \in \mathfrak{X}(M)$ we have $(\mathcal{L}_u v^{\flat})^{\sharp} = \mathcal{L}_u v + 2\text{Def}(u)v$, where Def(u) is the type (1,1) tensor defined by $\frac{1}{2}(\mathcal{L}_u g)(v, \cdot) = g(\text{Def}(u)v, \cdot)$ (see, e.g., [37, §2.3]). Thus

$$\begin{split} F(u) &= -(\mathcal{L}_{u}\mathcal{A}u)^{\sharp} - (\mathcal{A}^{\sharp}u)\operatorname{div}(u) + \mathcal{A}^{\sharp}\nabla_{u}u \\ &= -\mathcal{L}_{u}\mathcal{A}^{\sharp}u - 2\operatorname{Def}(u)\mathcal{A}^{\sharp}u - (\mathcal{A}^{\sharp}u)\operatorname{div}(u) + \mathcal{A}^{\sharp}\nabla_{u}u \\ &= -\nabla_{u}\mathcal{A}^{\sharp}u + \nabla_{\mathcal{A}^{\sharp}u}u - 2\operatorname{Def}(u)\mathcal{A}^{\sharp}u - (\mathcal{A}^{\sharp}u)\operatorname{div}(u) + \mathcal{A}^{\sharp}\nabla_{u}u \\ &= (\underbrace{\mathcal{A}^{\sharp}\nabla_{u} - \nabla_{u}\mathcal{A}^{\sharp}}_{[\mathcal{A}^{\sharp},\nabla_{u}]})u + \nabla_{\mathcal{A}^{\sharp}u}u - 2\operatorname{Def}(u)\mathcal{A}^{\sharp}u - (\mathcal{A}^{\sharp}u)\operatorname{div}(u), \end{split}$$

where we used that $\mathcal{L}_u v = \nabla_u v - \nabla_v u$.

Let $Q: \mathfrak{X}^{s}(M) \times \mathfrak{X}^{s-2}(M) \to \mathfrak{X}^{s-2}(M)$ be the bilinear mapping

$$Q(u,v) \coloneqq \nabla_v u - 2\mathrm{Def}(u)v - v\operatorname{div}(u).$$

Notice that *Q* is tensorial in *v* and of order one in *u*. If s > n/2 + 2 then *Q* is smooth. Write $\mathcal{A}^{\sharp} = P + W$, where $P = R^{\sharp} + (1 - \gamma)P_{\text{ex}}^{\sharp}$ and *W* is a linear differential operator of order two as above. We now have

$$F(u) = [\mathcal{A}^{\sharp}, \nabla_u]u + Q(u, \mathcal{A}^{\sharp}u) = [P, \nabla_u]u + [W, \nabla_u]u + Q(u, Pu) + Q(u, Wu).$$

The approach is to show that each of these terms are maximally of order two and smooth under conjugation with right translation.

For the first term,

$$[\widetilde{P,\nabla_{(\cdot)}}] = \widetilde{P} \circ \widetilde{\nabla_{(\cdot)}} - \widetilde{\nabla_{(\cdot)}} \circ \widetilde{P}.$$

We already know that \widetilde{P} : $T\text{Diff}^{s}(M) \to T\text{Diff}^{s}(M)$ is smooth. From Lemma 3.4 and Remark 3.5 it follows that $\widetilde{\nabla_{(\cdot)}}$: $T\text{Diff}^{s}(M) \to T\text{Diff}^{s-1}(M) \upharpoonright \text{Diff}^{s}(M)$ is smooth.

For the second term, $(u, v) \mapsto [W, \nabla_v] u$ is a bilinear differential operator. From Lemma 3.3 it is of order two (since W is of order two). From Lemma 3.4 and Remark 3.5 it then follows that $[\widetilde{W}, \nabla_{(\cdot)}]$ is smooth.

For the third term, it follows from Lemma 3.4 and Remark 3.5 that \tilde{Q} is smooth of order one. Since \tilde{P} is smooth of order zero, we get that $\widetilde{Q(\cdot, P \cdot)}$ is smooth of order one.

For the fourth term, $(u, v) \mapsto Q(u, Wv)$ is a bilinear differential operator of order one and two respectively in its arguments. It follows from Lemma 3.4 and Remark 3.5 that $\widetilde{Q(\cdot, W \cdot)}$ is smooth of order two.

Altogether, we have proved that $\tilde{F}: TDiff^{s}(M) \to TDiff^{s-2}(M) \upharpoonright Diff^{s}(M)$ is smooth, which finishes the proof.

Equation (7) can be written

$$\tilde{\mathcal{A}}^{\sharp}\left(\boldsymbol{\varphi}, \frac{D}{\mathrm{d}t} \dot{\boldsymbol{\varphi}}\right) = \tilde{F}(\boldsymbol{\varphi}, \dot{\boldsymbol{\varphi}}), \tag{8}$$

from which we obtain the main result in this section.

Theorem 3.7. If s > n/2+2, then the geodesic spray

$$ilde{S} \colon T\mathrm{Diff}^s(M) \ni (oldsymbol{arphi}, \dot{oldsymbol{\phi}}) \mapsto \Big(oldsymbol{arphi}, ilde{(ilde{\mathcal{A}}^{\sharp})^{-1}} \circ ilde{F}\Big)(oldsymbol{arphi}, \dot{oldsymbol{\phi}})\Big) \in T\mathrm{Diff}^s(M) \oplus T\mathrm{Diff}^s(M),$$

corresponding to the α - β - γ metric (5), is smooth.

Proof. Follows from Lemma 3.2 and Lemma 3.6.

This result implies local well-posedness and smooth dependence on initial data.

Corollary 3.8. Under the conditions in Theorem 3.7, the Riemannian exponential

Exp: $TDiff^{s}(M) \rightarrow Diff^{s}(M)$,

corresponding to the α - β - γ metric (5), is smooth. Further, if $\phi \in \text{Diff}^{s}(M)$, then

 $\operatorname{Exp}_{\varphi} : T_{\varphi}\operatorname{Diff}^{s}(M) \to \operatorname{Diff}^{s}(M)$

is a local diffeomorphism from a neighbourhood of the origin to a neighbourhood of φ .

Proof. Follows from standard results about smooth sprays on Banach manifolds [26]. \Box

4 Descending metrics and the space of densities

Let $\pi: E \to B$ be a smooth fibre bundle. In this section we characterise pairs of metrics on *E* and *B* for which the projection π is a Riemannian submersion. We do this in three steps, introducing more and more structure to the fibre bundle:

- 1. First, the plain case $\pi: E \to B$. A characterisation of all descending metrics is given.
- 2. Second, the case when $\pi: E \to B$ is a principal *H*-bundle. This allows a characterisation of descending metrics in terms of *H*-invariance.
- 3. Third, the case when E = G, where G is a Lie group, and B is a G-homogeneous space, i.e., there is a transitive Lie group action of G on B. Then the projection π_b: g → b ⋅ g, for any fixed element b ∈ B, defines a principal G_b-bundle, where G_b is the isotropy group of b. This structure allows metrics on G that are both right-invariant and descending.

The main example is G = Diff(M) and B = Dens(M), i.e, the space of smooth densities on M (see (11) below). The main result is that the α - β - γ metric (5) on Diff(M) descends to the right-invariant canonical L^2 metric on Dens(M), i.e., the Fisher metric.

Let us begin with the first case. The kernel of the derivative of the projection map π defines the vertical distribution \mathcal{V} on E. That is, for each $x \in E$

$$\mathcal{V}_x = \{ v \in T_x E ; T_x \pi \cdot v = 0 \}.$$

If g_E is a metric on E, we can define the horizontal distribution $\mathcal{H} = \mathcal{V}^{\perp}$ as the orthogonal complement of \mathcal{V} with respect to g_E .

Definition 4.1. A metric g_E on E is called *descending* if there exists a metric g_B on B such that

$$g_E(u,v) = (\pi^* g_B)(u,v) \quad \forall u,v \in \mathcal{H}.$$

In other words, a metric on *E* is descending if and only if there exists a metric on *B* such that π is a *Riemannian submersion*, i.e., such that $T\pi: TE \to TB$ preserves the length of horizontal vectors.

If g_E is descending, then g_B is unique, since

$$T_x \pi \colon \mathcal{H}_x \to T_{\pi(x)} B$$

is an isomorphism for each $x \in E$.

Now we show how to construct descending metrics. Let g_B be a metric on B. Lift it to a positive semi-definite bilinear form π^*g_B on E. Let h be a positive semi-definite bilinear form on E such that ker(h) $\cap \mathcal{V} = \{0\}$ and the co-dimension of ker(h) is equal to the dimension of \mathcal{V} . Then

$$\mathbf{g}_E = \boldsymbol{\pi}^* \mathbf{g}_B + \mathbf{h} \tag{9}$$

is a descending metric on *E*. Notice that ker($\pi^* g_B$) = \mathcal{V} and ker(h) = \mathcal{H} . Consequently, $g_E(u,v) = \pi^* g_B(u,v)$ for all $u, v \in \mathcal{H}$, so g_E is indeed descending. Also notice that the horizontal distribution is independent of the choice of g_B .

The form (9) characterises all descending metrics. Indeed, if g_E is a descending metric, let g_B be the corresponding metric on B, and let $P: TE \to \mathcal{V}$ be the orthogonal projection onto \mathcal{V} with respect to g_E . Then g_E is of the form (9) with $h(u, v) := g_E(u, Pv)$.

Consider now the second case. That is, let H be a Lie group and consider the case when $\pi: E \to B$ is a principal H-bundle, with a left action $L_h: E \to E$ for $h \in H$. Being a principal bundle, the fibres are parameterised by H, so $\pi \circ L_h = \pi$ and if $\pi(x) = \pi(y)$ then there exists a unique $h \in H$ such that $y = L_h(x)$. Thus, if g_B is a metric on B, then $\pi^*g_B = (\pi \circ L_h)^*g_B = L_h^*\pi^*g_B$. Thus, if g_E is descending, then

$$(L_h^* \mathsf{g}_E)(u, v) = \mathsf{g}_E(u, v) \quad \forall u, v \in \mathcal{H}.$$
(10)

The converse is also true.

Proposition 4.2. Let g_E be a metric on E. Then g_E is descending if and only if it fulfils (10).

Proof. We have shown " \Rightarrow ", so " \Leftarrow " remains. Assuming (10), define g_B as follows. For $\bar{u}, \bar{v} \in T_{\pi(x)}B$, take any point $y \in \pi^{-1}(\{x\})$. The linear map $T_y\pi : \mathcal{H}_y \to T_{\pi(x)}B$ is an isomorphism, so we get $u, v \in \mathcal{H}_y$ by $u = T_y\pi^{-1} \cdot \bar{u}$ and $v = T_y\pi^{-1} \cdot \bar{v}$. Define g_B by

$$\mathsf{g}_B(\bar{u},\bar{v})\coloneqq\mathsf{g}_E(u,v).$$

This is a well-defined metric on g_E , i.e., it is independent on which $y \in \pi^{-1}(\{x\})$ we use. Indeed, for another $y' \in \pi^{-1}(\{x\})$ we get $u', v' \in \mathcal{H}_{y'}$ as above. Also, $y' = L_h(y)$ for some $h \in H$. From (10) it follows that $g_E(u,v) = g_E(u',v')$. By construction, $g_E(u,v) = (\pi^*g_B)(u,v)$ for all $u, v \in \mathcal{H}$, so g_E is indeed descending.

4 Descending metrics and the space of densities

We now specialise further, to the third case. Let *G* be a Lie group with identity *e*. Denote by L_g and R_g respectively the left and right action of $g \in G$ on *G*. Assume that *G* has a right transitive action \overline{R}_g on a manifold *B*. (*B* is then called a *G*-homogeneous space.) If $b \in B$, then $G_b = \{g \in G; \overline{R}_g(b) = b\}$ denotes the isotropy Lie subgroup of *G*. For every $b \in B$ we obtain a principal G_b -bundle $\pi_b: G \to B$, with $\pi_b(g) := \overline{R}_g(b)$. This structure implies that *B* is diffeomorphic to the homogeneous space $G_b \setminus G$ of right co-sets. The map π_b , which is well-defined on $G_b \setminus G$, provides a diffeomorphism. (If $b, b' \in B$, then G_b and $G_{b'}$ are conjugate subgroups, i.e., there exists $g \in G$ such that $gG_bg^{-1} = G_{b'}$.)

We are interested in right-invariant metrics on G, i.e., metrics g_G that fulfil

$$\mathsf{g}_G(u,v) = \mathsf{g}_G(TR_g \cdot u, TR_g \cdot u),$$

or, equivalently, $R_g^* g_G = g_G$. Being right-invariant does *not* imply being descending. For a right-invariant metric g_G to be descending (with respect to π_b), it follows from Proposition 4.2 that g_G must fulfil

$$L_h^* R_{\rho}^* g_G(u, v) = g_G(u, v) \quad \forall u, v \in \mathcal{H}^b, \quad \forall g \in G, \quad \forall h \in G_b,$$

where \mathcal{H}^b denotes the horizontal distribution. Since g_G is right-invariant and since the right action descends to $G_b \setminus G$, i.e., R_g maps fibres to fibres, it is enough to check the condition for $g = h^{-1}$ and for vectors $u, v \in \mathcal{H}_e^b = \mathfrak{g}_b^{\perp}$, where \mathfrak{g}_b is the Lie algebra of G_b . Indeed, the following result is given in [23].

Proposition 4.3. Let g_G be a right-invariant metric on G. Then g_G is descending (with respect to π_b) if and only if

$$\mathsf{g}_G(\mathsf{ad}_{\xi}(u),v) + \mathsf{g}_G(u,\mathsf{ad}_{\xi}(v)) = 0 \quad \forall u,v \in \mathfrak{g}_b^{\perp}, \, \xi \in \mathfrak{g}_b.$$

Consider now the reverse question: If $g_G = \pi^* g_B + h$ is descending, when is it rightinvariant? Since right invariance means that $g_G = R_g^* g_G$ it must hold that $R_g^* \pi^* g_B = \pi^* g_B$ and $R_g^* h = h$. Also, since

$$R_g^*\pi^*\mathsf{g}_B = (\pi \circ R_g)^*\mathsf{g}_B = (\bar{R}_g \circ \pi)^*\mathsf{g}_B = \pi^*\bar{R}_g^*\mathsf{g}_B$$

we obtain the following result.

Proposition 4.4. Let $g_G = \pi^* g_B + h$ be a descending metric on G. Then g_G is right-invariant if and only if both g_B and h are right-invariant, i.e.,

$$\bar{R}_g^* g_B = g_B$$
 and $R_g^* h = h$

for all $g \in G$.

Let us now investigate our case of interest, i.e., G = Diff(M). First, consider the manifold of smooth probability densities on M, which takes the rôle of B above. It is given by

$$\operatorname{Dens}(M) = \left\{ \mathbf{v} \in \Omega^n(M) \, ; \, \mathbf{v} > 0, \, \int_M \mathbf{v} = 1 \right\}.$$
(11)

The tangent spaces of Dens(*M*) are T_{ν} Dens(*M*) = $\Omega_0^n(M) := \{a \in \Omega^n(M); \int_M a = 0\}$. Diff(*M*) acts on Dens(*M*) from the right by pullback $\bar{R}_{\varphi}(\nu) = \varphi^* \nu$. The corresponding lifted action is again given by pullback, i.e., $T\bar{R}_{\varphi}(\nu, a) = (\varphi^* \nu, \varphi^* a)$.

Recall the volume form vol \in Dens(*M*) corresponding to the Riemannian structure on *M*. Using \bar{R}_{φ} and vol, we define the projection map π_{vol} : Diff(*M*) \rightarrow Dens(*M*) by $\pi_{\text{vol}}(\varphi) = \bar{R}_{\varphi}(\text{vol}) = \varphi^*$ vol. Moser [33] proved that π_{vol} is surjective, which implies that π_{vol} is a submersion (see Remark 4.5). The corresponding isotropy group is Diff_{vol}(*M*), i.e.,

$$\pi_{\text{vol}}(\psi \circ \varphi) = \pi_{\text{vol}}(\varphi)$$
 if and only if $\psi \in \text{Diff}_{\text{vol}}(M)$.

Accordingly, with $\text{Diff}_{vol}(M)$ acting on Diff(M) from the left, we have a principal bundle structure

$$\operatorname{Diff}_{\operatorname{vol}}(M) \longrightarrow \operatorname{Diff}(M) \xrightarrow{\pi_{\operatorname{vol}}} \operatorname{Dens}(M).$$
 (12)

The vertical distribution \mathcal{V} of this bundle structure is given by vectors in TDiff(M) that are divergence-free when right translated to $T_{id}Diff(M) = \mathfrak{X}(M)$. That is,

$$\mathcal{V}_{\boldsymbol{\varphi}} = \{ v \in T_{\boldsymbol{\varphi}} \operatorname{Diff}(M) ; v \circ \boldsymbol{\varphi}^{-1} \in \mathfrak{X}_{\operatorname{vol}}(M) \}.$$

Relative to the abstract formulation presented above, G = Diff(M), B = Dens(M), and $G_b = \text{Diff}_{\text{vol}}(M)$. In particular, $\text{Diff}_{\text{vol}}(M) \setminus \text{Diff}(M) \simeq \text{Dens}(M)$.

Remark 4.5. The analysis involved in the bundle structure (12) can be made precise in the category of Sobolev manifolds. Indeed,

$$\operatorname{Diff}_{\operatorname{vol}}^{s}(M) \setminus \operatorname{Diff}^{s}(M) \simeq \operatorname{Dens}^{s-1}(M)$$
 if $s > n/2 + 1$,

where the projection π_{vol} : Diff^s $(M) \to Dens^{s-1}(M)$ is smooth. These results can be used to prove that π_{vol} : Diff $(M) \to Dens(M)$ is smooth with respect to an inverse limit Hilbert (ILH) topology. Notice that the principal bundle structure

$$\operatorname{Diff}_{\operatorname{vol}}^{s}(M) \hookrightarrow \operatorname{Diff}^{s}(M) \longrightarrow \operatorname{Diff}_{\operatorname{vol}}^{s}(M) \setminus \operatorname{Diff}^{s}(M)$$

is only C^0 , since the left action of Diff^s(M) on itself is only continuous. See Ebin and Marsden [10, §5] for details. By using the Nash–Moser inverse function theorem, Hamilton [17, §III.2.5] showed directly that π_{vol} : Diff(M) \rightarrow Dens(M) is a smooth principal Diff_{vol}(M)– bundle with respect to a Fréchet topology.

Remark 4.6. The choice of reference element vol \in Dens(*M*) is not canonical; it specifies which point we consider to be the "identity density". If $v \in$ Dens(*M*) is another density, then Diff_{vol}(*M*) and Diff_v(*M*) are conjugate subgroups: Diff_v(*M*) = $\psi^{-1} \circ$ Diff_{vol}(*M*) $\circ \psi$ for any $\psi \in \{\varphi \in$ Diff(*M*); φ^* vol = $v\}$.

We now turn to right-invariant and descending metrics on Diff(M). There is a natural L^2 metric on Dens(M) given by

$$\langle\langle a,b \rangle\rangle_{\mathbf{v}} = \int_{M} \frac{a}{\mathbf{v}} \frac{b}{\mathbf{v}} \mathbf{v}, \qquad a,b \in \Omega_{0}^{n}(M),$$
(13)

where $a/v \in \Omega^0(M)$ is defined by a = (a/v)v and correspondingly for b/v. (Equivalently, a/v is the Radon–Nikodym derivative of the measure induced by a with respect to the measure induced by v.) The metric (13) is called the Fisher metric. As already mentioned, it is fundamental in the theory of information geometry. In addition, it is used in statistical mechanics for measuring "thermodynamic length" [9, 13], and in the geometrical formulation of quantum mechanics [12]. The Fisher metric is canonical: it is independent of the Riemannian structure on M.

Remark 4.7. One can also write the Fisher metric (13) as

$$\langle\langle a,b\rangle\rangle_{\mathbf{v}} = \int_{M} (\star_{\mathbf{v}} a)b,$$

where $\star_{v} : \Omega^{n}(M) \to \Omega^{0}(M)$ is the Hodge star on *n*-forms corresponding to *v*.

Proposition 4.8. The Fisher metric (13) on Dens(M) is invariant with respect to the action \bar{R}_{φ} .

Proof.

$$\langle\langle \varphi^* a, \varphi^* b \rangle\rangle_{\varphi^* \nu} = \int_M (\star_{\varphi^* \nu} \varphi^* a) \varphi^* b = \int_M \varphi^* ((\star_\nu a) b) = \langle\langle a, b \rangle\rangle_{\nu}.$$

We now come to the main result of this section.

Theorem 4.9. The α - β - γ metric (5) on Diff(M) descends to a metric on Dens(M), that, up to multiplication with β , is the Fisher metric (13).

Proof. First, since the inner product (4) on $\mathfrak{X}(M)$ corresponding to the α - β - γ metric preserves orthogonality with respect to the Helmholtz decomposition, it follows that the horizontal distribution is given by

$$\mathcal{H}_{\varphi} = \big\{ v \in T_{\varphi} \mathrm{Diff}(M) \, ; \, v \circ \varphi^{-1} \in \mathrm{grad}(\mathcal{F}(M)) \big\},\$$

i.e., vectors that, when translated to the identity, are given by gradient vector fields. If $u \in \mathcal{V}_{id} = \mathfrak{X}_{vol}(M)$ and $f, g \in \mathfrak{F}(M)$, then

$$\langle \mathcal{L}_{u} \operatorname{grad}(f), \operatorname{grad}(g) \rangle_{\alpha\beta\gamma} = \int_{M} \beta \, \delta(\mathcal{L}_{u} \operatorname{grad}(f))^{\flat} \delta \operatorname{grad}(g)^{\flat} \operatorname{vol}$$

$$= \int_{M} \beta \operatorname{di}_{\mathcal{L}_{u} \operatorname{grad}(f)} \operatorname{vol} \wedge \star \operatorname{di}_{\operatorname{grad}(g)} \operatorname{vol}$$

$$= -\int_{M} \beta \operatorname{di}_{\operatorname{grad}(f)} \operatorname{vol} \wedge \star \operatorname{di}_{\mathcal{L}_{u} \operatorname{grad}(g)} \operatorname{vol}$$

$$= -\langle \operatorname{grad}(f), \mathcal{L}_{u} \operatorname{grad}(g) \rangle_{\alpha\beta\gamma},$$

where we have used $\mathcal{L}_u \text{vol} = 0$ and $\mathcal{L}_u \star a = \star \mathcal{L}_u a$ for any $a \in \Omega^n(M)$. From Proposition 4.3 it follows that the α - β - γ metric is descending.

The tangent map $T\pi_{vol}$ restricted to $T_{id}Diff(M) = \mathfrak{X}(M)$ is given by $u \mapsto \mathcal{L}_u vol$. Now,

$$\langle \operatorname{grad}(f), \operatorname{grad}(g) \rangle_{\alpha\beta\gamma} = \int_{M} \beta \operatorname{i}_{\operatorname{grad}(f)} \operatorname{vol} \wedge \star \operatorname{i}_{\operatorname{grad}(g)} \operatorname{vol}$$
$$= \int_{M} \beta \mathcal{L}_{\operatorname{grad}(f)} \operatorname{vol} \wedge \star \mathcal{L}_{\operatorname{grad}(f)} \operatorname{vol}$$
$$= \beta \langle \langle \mathcal{L}_{\operatorname{grad}(f)} \operatorname{vol}, \mathcal{L}_{\operatorname{grad}(g)} \operatorname{vol} \rangle \rangle_{\operatorname{vol}}.$$

Therefore, the α - β - γ metric for horizontal vectors at the identity tangent space is given by the Fisher metric multiplied by β of the projection of the horizontal vectors to the tangent space $T_{\text{vol}}\text{Dens}(M)$. Since this holds at one tangent space, it follows from Proposition 4.8 that it holds at every tangent space (both the α - β - γ metric and the Fisher metric are right-invariant). This concludes the proof.

A consequence of Theorem 4.9 is a geometric explanation of the observation in § 1.1, that solutions that are initially gradients remain gradients. Indeed, Hermann [18] proved that initially horizontal geodesics remain horizontal for any descending metric.

Remark 4.10. The "components" g_B and h of the α - β - γ metric are identified as follows:

$$\langle u, v \rangle_{\alpha\beta\gamma} = \underbrace{\langle \bar{P}_{\gamma} u^{\flat}, \bar{P}_{\gamma} v^{\flat} \rangle_{L^{2}} + \alpha \langle du^{\flat}, dv^{\flat} \rangle_{L^{2}}}_{\mathsf{h}} + \underbrace{\beta \langle \delta u^{\flat}, \delta v^{\flat} \rangle_{L^{2}}}_{\pi^{*}\mathsf{g}_{B}},$$

with the same notation as in equation (4).

5 Optimal transport and factorisation

Optimal mass transport has a long history, going back to Monge [32] and Kantorovich [21, 20]. For a modern treatise, see the lecture notes by Evans [11], Ambrosio and Gigli [2], or McCann [30], or the monograph by Villani [38].

In this section we study the relation between "distance square" optimal transport problems and descending metrics. Typically, optimal transport problems are formulated with minimal regularity restrictions. In contrast, we consider smooth formulations (more precisely Sobolev H^s with s > n/2 + 1). We take the point of view of Otto [34, § 4], but Dens(M) is identified with right co-sets instead of left. A central topic is the correspondence between optimal transport problems and polar factorisations. The main result is given in § 5.1, where we establish existence and uniqueness results for optimal information transport, and a matching polar factorisation of Diff^s(M). As a finite-dimensional analogue, we show in § 5.2 that QR factorisation of square matrices can be seen as polar factorisation corresponding to optimal transport of inner products.

Abstract geometric optimal transport problems are formulated as follows. Let *G* be a Lie group acting transitively on a manifold *B*. Assume *G* is equipped with a cost function $c: G \times G \to \mathbb{R}^+$. This renders a geometric formulation of Monge's original problem:

Given
$$b, b' \in B$$
, find $T \in \{g \in G; g \cdot b = b'\}$ minimising $c(e, T)$. (14)

We are interested in the case $c = \text{dist}_G^2$, where dist_G is the geodesic distance of a metric g_G . In particular, we are interested in the case when g_G is descending with respect to a fibre bundle structure $\pi: G \to B$. Then, the optimal transport problem (14) is simplifies to: (i) find the shortest curve on *B* connecting *b* and *b'*, (ii) lift that curve to a horizontal curve on *G*, and (iii) take the endpoint as the solution. This simplification is possible because a shortest curve between two fibres must be horizontal:

Lemma 5.1. Let $\pi: G \to B$ be a Riemannian submersion, and let $\zeta: [0,1] \to G$ be an arbitrary smooth curve. Then there exists a unique horizontal curve $\zeta_h: [0,1] \to G$ such that $\zeta_h(0) = \zeta(0)$ and $\pi \circ \zeta = \pi \circ \zeta_h$. The length of ζ_h is less than or equal the length of ζ , with equality if and only if ζ is horizontal.

Proof. For each $t \in [0,1]$ there is a unique decomposition $\dot{\zeta}(t) = v(t) + h(t)$, where $v(t) \in \mathcal{V}_{\zeta(t)}$ and $h(t) \in \mathcal{H}_{\zeta(t)}$. Thus, we have the curves $t \mapsto v(t) \in \mathcal{V}$ and $t \mapsto h(t) \in \mathcal{H}$. By the projection π we also get a curve $\bar{\zeta}(t) = \pi(\zeta(t)) \in B$. This curve can be lifted to a horizontal curve as follows. Take any time-dependent smooth vector field \bar{X}_t on B for which $\bar{\zeta}$ is an integral curve, i.e., $\dot{\zeta}(t) = \bar{X}_t(\bar{\zeta}(t))$. Now lift \bar{X}_t to its corresponding horizontal section $X_t(g) = (T_g \pi)^{-1} \cdot \bar{X}_t(\pi(g))$. (We can do this since $T_g \pi \colon \mathcal{H}_g \to T_{\pi(g)}B$ is an isomorphism.) Next, let ζ_h be the unique integral curve of X_t with $\zeta_h(0) = \zeta(0)$. By construction, $\pi(\zeta_h(t)) = \pi(\zeta(t))$ and $g_G(\dot{\zeta}_h(t), \dot{\zeta}_h(t)) = g_G(h(t), h(t))$. Thus, $g_G(\dot{\zeta}_h(t), \dot{\zeta}_h(t)) \leq g_G(\dot{\zeta}(t), \dot{\zeta}(t))$, with equality if and only if $\dot{\zeta}(t) \in \mathcal{H}$.

It remains to show that ζ_h is unique. Assume $\zeta'_h : [0,1] \to G$ is another horizontal curve with $\pi \circ \zeta'_h = \overline{\zeta}$ and $\zeta'_h(0) = \zeta(0)$. By differentiation with respect to *t* we obtain

$$T_{\zeta_h'(t)}\pi\cdot\dot{\zeta}_h'(t)=\bar{\zeta}(t)=\bar{X}_t(\bar{\zeta}(t))=\bar{X}_t(\pi(\zeta_h'(t)))=T_{\zeta_h'(t)}\pi\cdot X_t(\zeta_h'(t)).$$

Since ζ'_h is horizontal, it is an integral curve of X_t . Since ζ'_h and ζ_h have the same initial conditions, uniqueness of integral curves yield $\zeta'_h = \zeta_h$. This concludes the proof.

Remark 5.2. Lemma 5.1 is independent of the group structure of *G*. Indeed, *G* and *B* can be Banach manifolds with a smooth fibre bundle structure $\pi: G \to B$. The metrics can be weak, which is important for the main example in §5.1.

For cost functions given by the square distance of a descending metric, Lemma 5.1 reduces the optimal transport problem (14) to a problem entirely on *B*: find a shortest curve between two given elements $b'', b' \in B$. This problem is not always easier to solve. If, however, the geometry of the Riemannian manifold (B, g_B) is well understood, for example if any two elements in *B* are connected by a minimal geodesic, then problem (14) simplifies significantly (see Proposition 5.3 below).

The concept of *polar factorisation* is strongly related to optimal transport. Following Brenier [5], we introduce the *polar cone*

$$K = \{k \in G; \operatorname{dist}_G(e,k) \le \operatorname{dist}_G(h,k), \forall h \in G_b\}.$$
(15)

Expressed in words, the polar cone (15) consists of elements in G whose closest point on the identity fibre is e.

Proposition 5.3. Let g_G be a right-invariant metric on G that descends to a metric g_B on B with respect to the fibre bundle $\pi_b(g) = \overline{R}_g(b)$ for some fixed $b \in B$. Then the following statements are equivalent:

- 1. For any $b' \in B$, there exists a unique minimal geodesic from b to b'.
- 2. For any $b'', b' \in B$, there exists a unique minimal geodesic from b'' to b'.
- 3. There exists a unique solution to the optimal transport problem (14) with $c = \text{dist}_{G}^{2}$, and that solution is connected to e by a unique minimal geodesic.
- 4. Every $g \in G$ has a unique factorisation g = hk, with $h \in G_b$ and $k \in K$, and every $k \in K$ is connected to e by a unique minimal geodesic.

Proof. $1 \Rightarrow 2$. Since g_G is right-invariant we get that if $\zeta : [0,1] \rightarrow G$ is a minimal geodesic, then so is $\overline{R}_g \circ \zeta$ for any $g \in G$. Since the action \overline{R} is transitive, $b'' = \overline{R}_g(b)$ for some $g \in G$.

 $2 \Rightarrow 3$. Let $\zeta : [0,1] \to B$ be the minimal geodesic from *b* to *b'*. By Lemma 5.1, there is a unique corresponding horizontal geodesic $\zeta : [0,1] \to G$ with $\zeta(0) = e$ and $\pi_b(\zeta(t)) = \bar{\zeta}(t)$. There cannot be any curve from *e* to $\pi_b^{-1}(\{b'\})$ shorter than ζ , because then $\bar{\zeta}$ would not be a minimal geodesic. A curve from *e* to $\pi_b^{-1}(\{b'\})$ of the same length as ζ must be horizontal (by Lemma 5.1), and therefore equal to ζ (also by Lemma 5.1). Thus, if $q \in \pi_b^{-1}(\{b'\}) \setminus \{\zeta(1)\}$ then dist $_G(e,q) > \text{dist}_G(e,\zeta(1))$, so $\zeta(1)$ is the unique solution to problem (14). Also, ζ is a unique minimal geodesic between *e* and $\zeta(1)$.

 $3 \Rightarrow 4$. Let *k* be the unique solution to (14) with $b' = \pi_b(g)$. Then *k* and *g* belong to the same fibre, so g = hk for some unique element $h \in G_b$. There cannot be another such factorisation g = h'k', because then *k* would not be a unique solution to (14). Now take any $k \in K$. Then *k* is the unique solution to (14) with $b' = \pi_b(k)$, and that solution is connected to *e* by a unique minimal geodesic. Thus, any $k \in K$ is connected to *e* by a unique minimal geodesic.

 $4 \Rightarrow 1$. For any $b' \in B$ we can find $g \in G$ such that $b' = \bar{R}_g(b) = \pi_b(g)$, which follows since the action \bar{R} is transitive. Let g = hk be the unique factorisation, and let $\zeta : [0,1] \to G$ be the unique minimal geodesic from e to k. Assume now that ζ is not horizontal. Then, by Lemma 5.1, we can find a horizontal curve $\zeta_h : [0,1] \to G$ with $\zeta_h(0) = k$ and $\zeta_h(1) \in G_b$ that is strictly shorter than ζ . Since ζ is a unique minimal geodesic between e and k, it cannot hold that $\zeta_h(1) = e$. Thus, $k \notin K$ since there is a point $\zeta_h(1)$ on the identity fibre closer to k than e, so we reach a contradiction. Therefore, ζ must be horizontal, so it descends to a corresponding geodesic $\bar{\zeta}$ between b and b'. $\bar{\zeta}$ must be unique minimal, otherwise ζ cannot be unique minimal. This finalises the proof.

Remark 5.4. If the metric g_B is not right-invariant, then Proposition 5.3 is still valid in the case b'' = b.

5.1 Optimal information transport

We now return to the example of main interest, namely $G = \text{Diff}^s(M)$ and $B = \text{Dens}^{s-1}(M)$. Recall Theorem 4.9, that the α - β - γ metric on $\text{Diff}^s(M)$ descends to the Fisher metric on $\text{Dens}^{s-1}(M)$ up to multiplication with β . For simplicity, we assume $\beta = 1$ throughout this section. Also recall

- $\bar{R}_{\varphi}(v) = \varphi^* v$, so $\pi_{vol}(\varphi) = \varphi^* vol$;
- Diff^s(M) and Dens^{s-1}(M) are Banach manifolds if s > n/2 + 1;
- the projection π_{vol} : Diff^s $(M) \rightarrow Dens^{s-1}(M)$ is smooth.

Thus, all prerequisites in Proposition 5.3 are fulfilled.

Khesin, Lenells, Misiołek, and Preston [23] showed that the geodesic boundary-value problem on Dens^{*s*-1}(*M*), with respect to the Fisher metric, can be formulated as an optimal transport problem, with respect to a degenerate cost function. Since the cost function is degenerate, solutions are not unique, so there is no corresponding polarisation result. The α - β - γ metric on Diff^{*s*-1}(*M*) allows us to obtain a non-degenerate optimal transport formulation in accordance with the framework in §5. In particular, we obtain a factorisation result for diffeomorphisms.

Let $\lambda, v \in \text{Dens}^{s-1}(M)$. We consider the following optimal transport problem:

Find
$$\varphi \in \{\eta \in \text{Diff}^s(M); \eta^* \lambda = \nu\}$$
 minimising $\text{dist}^2_{\alpha\beta\gamma}(\text{id}, \varphi)$. (16)

Here, dist_{$\alpha\beta\gamma$} is the Riemannian distance corresponding to the α - β - γ metric (5). Since the α - β - γ metric descends to Fisher's information metric, we refer to problem (16) as *optimal information transport*; find the most optimal diffeomorphism pulling the probability density λ to ν . For simplicity, we assume that $\lambda = \text{vol}$.

As mentioned in the introduction, Friedrich [15] showed that the Fisher metric has constant curvature. Therefore, its geodesics are easy to analyse. Indeed, following [23], we introduce the infinite-dimensional sphere of radius $r = \sqrt{\text{vol}(M)}$

$$S^{\infty,s}(M) = \Big\{ f \in H^s(M,\mathbb{R}); \langle f, f \rangle_{L^2} = \operatorname{vol}(M) \Big\}.$$

If s > n/2, then $S^{\infty,s}(M)$ is a Banach submanifold of $H^s(M,\mathbb{R})$. The L^2 inner product on $H^s(M,\mathbb{R})$, restricted to $S^{\infty,s}(M)$, provides a weak Riemannian metric. Although weak, the geodesic spray is smooth. The geodesics are given by great circles, so $S^{\infty,s}(M)$ is geodesic cally complete and its diameter is given by $\pi \sqrt{\operatorname{vol}(M)}$.

Let $\mathcal{O}^{s}(M) = \{f \in S^{\infty,s}(M); f > 0\}$ denote the set of positive functions of radius $\sqrt{\operatorname{vol}(M)}$. $\mathcal{O}^{s}(M)$ is an open subset of $S^{\infty,s}(M)$ and therefore a Banach manifold itself. The following result is given in [23]. **Theorem 5.5.** *If* s > n/2, *then the map*

$$\Phi \colon \mathrm{Dens}^{s}(M) \ni v \longmapsto \sqrt{\frac{v}{\mathrm{vol}}}$$

is an isometric diffeomorphism $\text{Dens}^{s}(M) \to \mathbb{O}^{s}(M)$. The diameter of $\mathbb{O}^{s}(M)$, thus $\text{Dens}^{s}(M)$, is $\frac{\pi}{2}\sqrt{\text{vol}(M)}$.

If $f, g \in \mathbb{O}^{s}(M)$, then there is a unique minimal geodesic $\sigma \colon [0, 1] \to S^{\infty, s}(M)$ from f to g, and that geodesic is contained in $\mathbb{O}^{s}(M)$, i.e., $\mathbb{O}^{s}(M)$ is a convex subset of $S^{\infty, s}(M)$. Indeed, the minimal geodesic is given by

$$\sigma \colon [0,1] \ni t \longmapsto \frac{\sin((1-t)\theta)}{\sin\theta} f + \frac{\sin(t\theta)}{\sin\theta} g, \quad \theta = \arccos\left(\frac{\langle f,g \rangle_{L^2}}{\operatorname{vol}(M)}\right).$$
(17)

The polar cone of Diff^s(*M*) with respect to the α - β - γ metric is

$$K^{s}(M) = \left\{ \varphi \in \operatorname{Diff}^{s}(M); \operatorname{dist}_{\alpha\beta\gamma}(\operatorname{id}, \varphi) \leq \operatorname{dist}_{\alpha\beta\gamma}(\eta, \varphi), \, \forall \, \eta \in \operatorname{Diff}^{s}_{\operatorname{vol}}(M) \right\}.$$
(18)

There is a unique minimal geodesic between vol and any $v \in \text{Dens}^{s-1}(M)$, so from Proposition 5.3 every $\psi \in K^s(M)$ is the endpoint of a minimal horizontal geodesic $\zeta : [0,1] \rightarrow \text{Diff}^s(M)$ with $\zeta(0) = \text{id.}$ Since ζ is horizontal, it is of the form $\zeta(t) = \text{Exp}_{\text{id}}(t \operatorname{grad}(w_0))$ for a unique $w_0 \in \mathcal{F}^{s+1}(M)$, where Exp: $T\text{Diff}^s(M) \rightarrow \text{Diff}^s(M)$ denotes the Riemannian exponential corresponding to the α - β - γ metric.

Let $\varphi \in \text{Diff}^s(M)$. Due to the explicit form (17) of minimal geodesics in $\mathbb{O}^{s-1}(M)$, thus $\text{Dens}^{s-1}(M)$, we can compute the function $w_0 \in \mathcal{F}^{s+1}(M)$ such that $\text{Exp}_{id}(\text{grad}(w_0))$ is the unique element in $K^s(M)$ belonging to the same fibre as φ . Indeed,

$$T_{\mathrm{id}}\pi_{\mathrm{vol}} \cdot \mathrm{grad}(w_0) = \frac{\mathrm{d}}{\mathrm{d}t}\Big|_{t=0} \pi_{\mathrm{vol}}(\mathrm{Exp}_{\mathrm{id}}(t\,\mathrm{grad}(w_0)))$$
$$= \frac{\mathrm{d}}{\mathrm{d}t}\Big|_{t=0} \pi_{\mathrm{vol}}(\zeta(t)) = \frac{\mathrm{d}}{\mathrm{d}t}\Big|_{t=0} \sigma(t)^2 \mathrm{vol} = 2\dot{\sigma}(0)\sigma(0)\mathrm{vol},$$

where $\sigma(t)$ is the curve (17) with f = 1 and $g = \sqrt{\text{Jac}(\varphi)}$ (the Jacobian is defined by $\text{Jac}(\psi)$ vol = ψ^* vol). Since $\sigma(0) = 1$ and $T_{\text{id}}\pi_{\text{vol}} \cdot \text{grad}(w_0) = \mathcal{L}_{\text{grad}(w_0)}$ vol = Δw_0 vol, we get

$$\Delta w_0 = \frac{2\theta \sqrt{\operatorname{Jac}(\varphi)} - 2\theta \cos(\theta)}{\sin \theta}, \quad \theta = \arccos\left(\frac{\int_M \sqrt{\operatorname{Jac}(\varphi)} \operatorname{vol}}{\operatorname{vol}(M)}\right). \tag{19}$$

How do we compute the horizontal geodesic $\zeta(t) = \operatorname{Exp}_{id}(t \operatorname{grad}(w_0))$?

One way is to solve equation (2) with $u(0) = \operatorname{grad}(w_0)$, and reconstruct $\zeta(t)$ by integrating the non-autonomous equation $\dot{\zeta}(t) = u(t) \circ \zeta(t)$ with $\zeta(0) = \operatorname{id.}$ From [23, Proposition 4.5] and the isomorphism $T_{\operatorname{id}}\pi_{\operatorname{vol}}$: $\operatorname{grad}(\mathcal{F}^{s+1}(M)) \to T_{\operatorname{vol}}\operatorname{Dens}^{s-1}(M)$, the solution exists for $t \in [0, 1]$ (for details on the maximal existence time, see [23, §4.2]).

Another way is to directly lift the geodesic curve (17) by the technique in the proof of Lemma 5.1. Indeed, the geodesic $\bar{\zeta}(t)$ in Dens^{*s*-1}(*M*) corresponding to $\zeta(t)$ is given by $\bar{\zeta}(t) = \Phi^{-1}(\sigma(t)) = \sigma(t)^2$ vol. Since $\pi_{vol}(\zeta(t)) = \bar{\zeta}(t)$ and

$$TR_{\zeta(t)^{-1}}(\zeta(t),\dot{\zeta}(t)) = (\mathrm{id},\dot{\zeta}(t)\circ\zeta(t)^{-1}) = (\mathrm{id},\mathrm{grad}(w_t)), \quad w_t \in \mathcal{F}^{s+1}(M)$$

we conclude

$$\begin{split} \dot{\bar{\zeta}}(t) &= T_{\mathrm{id}}(\bar{R}_{\zeta(t)} \circ \pi_{\mathrm{vol}}) \cdot \mathrm{grad}(w_t) \\ &= \zeta(t)^* \big(\mathcal{L}_{\mathrm{grad}(w_t)} \mathrm{vol} \big) \\ &= \mathrm{div}(\mathrm{grad}(w_t)) \circ \zeta(t) \, \mathrm{Jac}(\zeta(t)) \mathrm{vol} \end{split}$$

From $\dot{\zeta}(t) = 2\dot{\sigma}(t)\sigma(t)$ vol and $Jac(\zeta(t)) = \sigma(t)^2$, we get $2\dot{\sigma}(t)\sigma(t) = (\Delta w_t \circ \zeta(t))\sigma(t)^2$.

The horizontal geodesic $\zeta(t)$ is now constructed by solving the following non-autonomous ordinary differential equation on Diff^s(*M*)

$$\begin{aligned} \zeta(t) &= \operatorname{grad}(w_t) \circ \zeta(t), \quad \zeta(0) = \operatorname{id} \\ \Delta w_t &= \frac{2\dot{\sigma}(t)}{\sigma(t)} \circ \zeta(t)^{-1} \\ \sigma(t) &= \frac{\sin((1-t)\theta)}{\sin\theta} + \frac{\sin(t\theta)}{\sin\theta} \sqrt{\operatorname{Jac}(\varphi)}, \quad \theta = \arccos\left(\frac{\int_M \sqrt{\operatorname{Jac}(\varphi)}\operatorname{vol}}{\operatorname{vol}(M)}\right). \end{aligned}$$
(20)

Explicitly, the vector field X_t on Diff^s(M) is

$$X_t: \zeta \mapsto \widetilde{\operatorname{grad}} \circ \widetilde{\Delta}^{-1}\left(\zeta, \frac{2\dot{\sigma}(t)}{\sigma(t)}\right) = \operatorname{grad}\left(\Delta^{-1}\left(\frac{2\dot{\sigma}(t)}{\sigma(t)} \circ \zeta^{-1}\right)\right) \circ \zeta$$

That is, equation (20) is the non-autonomous ordinary differential equation

$$\dot{\zeta}(t) = X_t(\zeta(t)), \quad \zeta(0) = \mathrm{id}.$$

Smoothness of X_t is obtained by the same techniques as in the proofs of Lemma 3.2 and Lemma 3.4.

In summary, we have proved the following result.

Theorem 5.6. Let s > n/2+1. Every $\varphi \in \text{Diff}^s(M)$ admits a unique factorisation $\varphi = \eta \circ \psi$, with $\eta \in \text{Diff}^s_{\text{vol}}(M)$ and $\psi \in K^s(M)$. We have $\psi = \text{Exp}_{\text{id}}(\text{grad}(w_0))$ with w_0 given by equation (19). There is a unique minimal geodesic $\zeta(t)$ with $\zeta(0) = \text{id}$ and $\zeta(1) = \psi$; it can be computed by solving equation (20). The geodesic $\zeta(t)$ is horizontal.

Remark 5.7. The factorisation in Theorem 5.6 is independent of α , β , and γ , because each parameter choice yields the same horizontal distribution and horizontal geodesics.

5.2 Optimal transport of inner products and *QR* factorisation

In this section we show how the QR factorisation of square matrices is related to optimal transport of inner products on \mathbb{R}^n . The example provides a finite-dimensional analogue of optimal information transport described in §5.1. We do not address questions of global existence and uniqueness of geodesics (local existence and uniqueness follows automatically). The aim is to provide geometric insight into the QR and Cholesky factorisations.

Let G = GL(n) over the field \mathbb{R} . Let $B = Sym(n)^+$ be the manifold of inner products on \mathbb{R}^n . Sym $(n)^+$ is identified with the space of symmetric positive definite $n \times n$ matrices; if M is a symmetric positive definite matrix, then its corresponding inner product is $\langle \mathbf{x}, \mathbf{y} \rangle_M = \mathbf{x}^\top M \mathbf{y}$. Sym $(n)^+$ is a convex open subset of the vector space Sym(n) of all symmetric $n \times n$ matrices.

The group GL(n) acts on $Sym(n)^+$ from the right by $\bar{R}_A(M) = A^\top M A$. This action is transitive. The lifted action is $T_M \bar{R}_A \cdot U = A^\top U A$, where $U \in T_M Sym(n)^+ = Sym(n)$.

Let *I* denote the identity matrix (which is an element in both GL(n) and $Sym(n)^+$). Consider the projection $\pi_I : GL(n) \to Sym(n)^+$ given by $\pi_I(A) = \bar{R}_A(I) = A^\top A$. The corresponding isotropy group is $G_I = SO(n)$, because

$$\pi_I(QA) = A^\top Q^\top QA = A^\top A = \pi_I(A)$$

for all $Q \in SO(n)$. Thus, we have a principal bundle

$$SO(n) \hookrightarrow GL(n) \xrightarrow{\pi_l} Sym(n)^+.$$
 (21)

There is natural metric g_B on $Sym(n)^+$ given by

$$\mathbf{g}_{B,M}(U,V) = \operatorname{tr}(UM^{-2}V), \quad U,V \in T_M \operatorname{Sym}(n)^+.$$
(22)

This metric is invariant with respect to the \bar{R}_A action. Indeed,

$$g_{B,\bar{R}_A(M)}(T_M\bar{R}_A \cdot U, T_M\bar{R}_A \cdot V) = tr(A^\top UA(A^\top MA)^{-2}A^\top VA)$$

$$= tr((A^\top MA)^{-1}A^\top UA(A^\top MA)^{-1}A^\top VA)$$

$$= tr(A^{-1}M^{-1}A^{-\top}A^\top UAA^{-1}M^{-1}A^{-\top}A^\top VA)$$

$$= tr(A^{-1}M^{-1}UM^{-1}VA)$$
(using cyclic property: tr(ABC) = tr(BCA))

$$= tr(M^{-1}UM^{-1}VA^{-1})$$

$$= tr(M^{-1}UM^{-1}V)$$

$$= tr(UM^{-2}V) = g_{B,M}(U,V)$$

We proceed by constructing a metric on GL(n). Consider the projection operator ℓ : $Mat(n,n) \rightarrow Mat(n,n)$ given by

$$\ell(U)_{ij} = \begin{cases} U_{ij} & \text{if } i \ge j, \\ 0 & \text{otherwise.} \end{cases}$$

In words, $\ell(U)$ is zero on the strictly upper triangular entries and equal to U elsewhere. Let g_G be the right-invariant metric on GL(n) defined by

$$\mathbf{g}_{G,I}(u,v) = \operatorname{tr}\left(\ell(u)^{\top}\ell(v)\right) + \operatorname{tr}\left((u+u^{\top})(v+v^{\top})\right).$$
(23)

By right translation $g_{G,A}(U,V) = g_{G,I}(UA^{-1}, VA^{-1})$. The orthogonal complement of $T_I SO(n) = \mathfrak{so}(n)$ with respect to $g_{G,A}$ consists of the upper triangular matrices. This follows since matrices in $\mathfrak{so}(n)$ are skew symmetric, so the second term in (23) vanishes if either *u* or *v* belong to $\mathfrak{so}(n)$. In mathematical terms

$$\mathfrak{so}(n)^{\top} = \mathfrak{upp}(n) \coloneqq \{ u \in \mathfrak{gl}(n); \ell(u) = 0 \}.$$

Proposition 5.8. The right-invariant metric g_G on GL(n) is descending with respect to the principal bundle structure (21). The corresponding metric on $Sym(n)^+$ is g_B in (22).

Proof. By Proposition 4.3 we need to show that

$$g_{G,I}(\mathrm{ad}_{\xi}(u),v) + g_{G,I}(u,\mathrm{ad}_{\xi}(v)) = 0, \quad \forall u,v \in \mathfrak{upp}(n), \xi \in \mathfrak{so}(n).$$

We have

$$\mathsf{g}_{G,I}(\mathsf{ad}_{\xi}(u),v) = \mathsf{tr}\left(([\xi,u]+[\xi,u]^{\top})(v+v^{\top})\right) = \mathsf{tr}\left(([\xi,u+u^{\top}])(v+v^{\top})\right).$$

By the cyclic property of the trace

$$\operatorname{tr}\left(([\xi, u+u^{\top}])(v+v^{\top})\right) = -\operatorname{tr}\left((u+u^{\top})([\xi, v+v^{\top}])\right)$$
$$= -\operatorname{tr}\left((u+u^{\top})([\xi, v]+[\xi, v]^{\top}])\right)$$
$$= -\operatorname{g}_{G,I}(u, \operatorname{ad}_{\xi}(v)).$$

Therefore, the metric is descending. If $u \in \mathfrak{upp}(n)$, then $T_I \pi_I \cdot u = u + u^{\top}$, so

$$\mathsf{g}_{G,I}(u,v) = \frac{1}{4} \operatorname{tr} \left((u+u^{\top})(v+v^{\top}) \right) = \mathsf{g}_{B,I}(T_I \pi_I \cdot u, T_I \pi_I \cdot v).$$

 \square

Since g_B is right-invariant, g_G descends to g_B . This proves the result.

The horizontal distribution \mathcal{H} is given by $\mathcal{H}_A = \mathfrak{upp}(n)A$. Since $\mathfrak{upp}(n)$ is a Lie algebra, i.e., closed under the matrix commutator, the horizontal distribution is integrable. Its integral manifold through the identity is the Lie group $\operatorname{Upp}(n)$ of upper triangular $n \times n$ matrices with strictly positive diagonal entries. Notice that $\operatorname{Upp}(n)$ forms the polar cone (15).

Let $A \in GL(n)$. If there exists a unique minimal geodesic $\overline{\zeta} : [0,1] \to Sym(n)^+$ from *I* to $\pi_I(A)$, then, by Proposition 5.3, we obtain a factorisation A = QR, with $Q \in SO(n)$ and $R \in Upp(n)$. Since the metric (23) is smooth, it follows from standard results in Riemannian geometry that there exists a neighbourhood $\mathcal{O} \subset Sym(n)^+$ of *I* such that any element in \mathcal{O} is connected to *I* by a unique minimal geodesic. Therefore, *A* has a unique *QR* factorisation if $\pi_I(A)$ is close enough to *I*.

Remark 5.9. The *QR* factorisation of any matrix *A* is well-known to exist. It is unique if *A* is invertible, which suggests unique minimal geodesics. Details of these questions are not investigated in this paper.

In summary, the factor R in the QR factorisation of A solves the problem of optimally (with respect to the cost function dist_G²) transporting the Euclidean inner product on \mathbb{R}^n to the inner product defined by $M = A^{\top}A$. In addition, the factor R is the transpose of the Cholesky factorisation of M. Indeed, if $L = R^{\top}$ then

$$M = \pi_I(A) = \pi_I(R) = R^{\top}R = LL^{\top}.$$

Usually, the *QR* factorisation is obtain by direct linear algebraic manipulations. A different approach is to solve the geodesic equation on $Sym(n)^+$, and lift the geodesic to a horizontal geodesic on GL(n). Although probably inefficient compared to existing algorithms (there are very fast algorithms based on Householder reflections), the geodesic approach may provide insight, for example in the case of sparse matrices.

Remark 5.10. The setting can be extended to $GL(n, \mathbb{C})$ by replacing SO(n) with U(n), and every transpose with the Hermitian conjugate.

Remark 5.11. Otto [34] studied gradient flows with respect to the Wasserstein metric in optimal mass transport ("Otto calculus", cf. [38]). Analogous gradient flows for the optimal transport problem in this section are related to the Toda flow, the "QR algorithm" [16], and Brockett's flow for continuous diagonalisation of matrices [6].
