# ENERGY DECAY RATES FOR SOLUTIONS OF THE WAVE EQUATION WITH LINEAR DAMPING IN EXTERIOR DOMAIN

#### Abstract

In this paper we study the behavior of the energy and the $L^{2}$ norm of solutions of the wave equation with localized linear damping in exterior domain. Let $u$ be a solution of the wave system with initial data $\left(u_{0}, u_{1}\right)$. We assume that the damper is positive at infinity then under the Geometric Control Condition of Bardos et al [3] (1992), we prove that: (1) The total energy $E_{u}(t) \leq C_{0}(1+t)^{-1} I_{0}$ and $\|u(t)\|_{L^{2}}^{2} \leq C_{0} I_{0}$ if $\left(u_{0}, u_{1}\right)$ belong to $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$, where $$
I_{0}=\left\|u_{0}\right\|_{H^{1}}^{2}+\left\|u_{1}\right\|_{L^{2}}^{2} .
$$ (2) The total energy $E_{u}(t) \leq C_{2}(1+t)^{-2} I_{1}$ and $\|u(t)\|_{L^{2}}^{2} \leq C_{2}(1+t)^{-1} I_{1}$, if the initial data $\left(u_{0}, u_{1}\right)$ belong to $\bar{H}_{0}^{1}(\Omega) \times L^{2}(\Omega)$ and verifies $\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}<+\infty$, where $$
I_{1}=\left\|u_{0}\right\|_{H^{1}}^{2}+\left\|u_{1}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2}
$$


## 1. Introduction and Statement of the result

Let $O$ be a compact domain of $\mathbb{R}^{d}(d \geq 2)$ with $C^{\infty}$ boundary $\Gamma=\partial \Omega$ and $\Omega=\mathbb{R}^{d} \backslash O$. Consider the following wave equation with localized linear damping

\begin{cases}\partial_{t}^{2} u-\Delta u+a(x) \partial_{t} u=0 & \text { in } \mathbb{R}_{+} \times \Omega,  \tag{1.1}\\ u=0 & \text { on } \mathbb{R}_{+} \times \Gamma, \\ u(0, x)=u_{0} \quad \text { and } \quad \partial_{t} u(0, x)=u_{1} . & \end{cases}
$$

Here $\Delta$ denotes the Laplace operator in the space variables. $a(x)$ is a nonnegative function in $L^{\infty}(\Omega)$.

Let

$$
A=\left(\begin{array}{cc}
0 & I \\
\Delta & -a
\end{array}\right),
$$

and $H=H_{D}(\Omega) \times L^{2}(\Omega)$, the completion of $\left(C_{0}^{\infty}(\Omega)\right)^{2}$ with respect to the norme

\left\|\left(\varphi_{0}, \varphi_{1}\right)\right\|_{H}^{2}=\frac{1}{2} \int_{\Omega}\left|\nabla \varphi_{0}\right|^{2}+\left|\varphi_{1}\right|^{2} d x
$$

then the domain of $A$

$$
D(A)=\left\{\left(u_{0}, u_{1}\right) \in H, A\binom{u_{0}}{u_{1}} \in H\right\} .
$$

[^0]Let $n \in \mathbb{N}$ and $\left(u_{0}, u_{1}\right) \in D\left(A^{n}\right)$. Linear semigroup theory applied to (1.1), provides existence of a unique solution $u$ in the class

$$
\left(u, \partial_{t} u\right) \in C^{k}\left(\mathbb{R}_{+}, D\left(A^{n-k}\right)\right), \text { with } k \leq n
$$

Moreover, if $\left(u_{0}, u_{1}\right)$ is in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$, then the system (1.1), admits a unique solution $u$ in the class

$$
u \in C^{0}\left(\mathbb{R}_{+}, H_{0}^{1}(\Omega)\right) \cap C^{1}\left(\mathbb{R}_{+}, L^{2}(\Omega)\right)
$$

With (2.2) we associate the energy functional given by

$$
E_{u}(t)=\frac{1}{2} \int_{\Omega}\left(|\nabla u(t, x)|^{2}+\left|\partial_{t} u(t, x)\right|^{2}\right) d x .
$$

The energy functional satisfies the following identity

$$
\begin{equation*}
E_{u}(T)+\int_{0}^{T} \int_{\Omega} a(x)\left|\partial_{t} u\right|^{2} d x d t=E_{u}(0) \tag{1.2}
\end{equation*}
$$

for every $T \geq 0$.
Zuazua [16, Nakao 14, Dehman et al 7] and Aloui et al [1 have considered the problem for the Klein-Gordon type wave equations with localized dissipations. For the Klein-Gordon equations the energy functional it self contains the $L^{2}$ norm and boundedness of $L^{2}$ norm of solution is trivial. Thus under a geometric condition we can show that the energy decays exponentially while for the system (1.1) the energy decay rate is weaker and more delicate.

In the case when $a(x) \geq \epsilon_{0}>0$ in all of $\Omega$ we know that

$$

E_{u}(t) \leq C_{0}(1+t)^{-1} I_{0} \text { and }\|u(t)\|_{L^{2}}^{2} \leq C_{0} I_{0}, \text { for all } t \geq 0, \tag{1.3}
\end{equation*}
$$

for weak solution $u$ to the system (1.1) with initial data in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$.
Nakao in [13] obtained the same estimates in (1.3) for a damper $a$ which is positive near some part of the boundary (Lions's condition) and near infinity.

On the other hand, Dan-Shibata [5] studied the local energy decay estimates for the compactly supported weak solutions of (1.1) with $a(x)=1$

\int_{\Omega \cap B_{R}}\left(|\nabla u(t, x)|^{2}+\left|\partial_{t} u(t, x)\right|^{2}\right) d x \leq C(1+t)^{-d} \tag{1.4}
\end{equation*}
$$

where $B_{R}=\left\{x \in \mathbb{R}^{d},|x|<R\right\}$.
Furthermore Ikehata and Matsuyama in [10] obtained a more precise decay estimate for the energy of solutions of the problem (1.1) with $a(x)=1$ and for weighted initial data

$$
\begin{equation*}
E_{u}(t) \leq C_{2}(1+t)^{-2} I_{1} \text { and }\|u(t)\|_{L^{2}}^{2} \leq C_{2}(1+t)^{-1} I_{1} \text { for all } t \geq 0 . \tag{1.5}
\end{equation*}
$$

Especially this estimate seems sharp for $d=2$ as compared with that of [5].
Ikehata in 9 derived a fast decay rate like (1.5) for solutions of the system (1.1) with weighted initial data and assuming that $a(x) \geq \epsilon_{0}>0$ at infinity and $O=\mathbb{R}^{d} \backslash \Omega$ is star shaped with respect to the origin.

For another type of total energy decay property we refer the reader to [8, 11, 15, 2] and reference therein.

Before introducing our results we shall state several assumptions:
Hyp A: There exists $L>0$ such that

a(x)>\epsilon_{0}>0 \text { for }|x| \geq L .
$$

Definition 1. $(\omega, T)$ geometrically controls $\Omega$, i.e. every generalized geodesic travelling with speed 1 and issued at $t=0$, enters the set $\omega$ in a time $t<T$.

This condition is called Geometric Control Condition (see e.g.[3] ). We shall relate the open subset $\omega$ with the damper $a$ by

\omega=\left\{x \in \Omega ; a(x)>\epsilon_{0}>0\right\} .
$$

We note that according to [3 and [4] the Geometric Control Condition of Bardos et al is a necessary and sufficient condition for the stabilization of the wave equation in bounded domain.

The goal of this paper is to prove that under the geometric control condition of Bardos et al [3] and for a damper $a$ positive near infinity, the estimates in (1.3) hold for all solutions of the system (1.1) with initial data in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$ and to show that the estimates in (1.5) hold for all solutions of the system (1.1) with weighted initial data. Moreover we show that for every $p \in \mathbb{N}^{*}$ there exists a initial data in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$ such that the solution $v$ of (1.1) verifies

E_{v}(t) \leq C(1+t)^{-p} \text { and }\|v(t)\|_{L^{2}}^{2} \leq C(1+t)^{-p+1}, \text { for all } t \geq 0
$$

and for some $C>0$ depending on the initial data.
Theorem 1. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Then there exists $C_{0}>0$ such that the following estimates

$$
E_{u}(t) \leq C_{0}(1+t)^{-1} I_{0} \text { and }\|u(t)\|_{L^{2}}^{2} \leq C_{0} I_{0}, \text { for all } t \geq 0
$$

hold for every solution $u$ of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$, where

$$
I_{0}=\left\|u_{0}\right\|_{H^{1}}^{2}+\left\|u_{1}\right\|_{L^{2}}^{2}
$$

As a corollary of theorem 1 we have:
Proposition 1. Let $n \in \mathbb{N}^{*}$. We assume that Hyp A holds and $(\omega, T)$ geometrically controls $\Omega$. Let $\left(u_{0}, u_{1}\right)$ in $D\left(A^{n}\right)$, such that $u_{0} \in L^{2}(\Omega)$. Then the solution $u$ of (1.1) satisfies

\begin{aligned}
E_{\partial_{t}^{n} u}(t) & \leq C_{n}(1+t)^{-n-1} I_{0, n} \text { for all } t \geq 0, \\
\left\|\partial_{t}^{n} u(t)\right\|_{L^{2}}^{2} & \leq C_{n-1}(1+t)^{-n} I_{0, n-1} \text { for all } t \geq 0,
\end{aligned}
$$

and

$$
\left\|\Delta \partial_{t}^{n-1} u(t)\right\|_{L^{2}}^{2} \leq C_{n}(1+t)^{-n} I_{0, n} \text { for all } t \geq 0
$$

where $C_{p}$ is a positive constant independent of the initial data and

$$
I_{1, p}=\sum_{i=0}^{p}\left\|A^{i}\left(u_{0}, u_{1}\right)\right\|_{H}^{2}+\left\|u_{0}\right\|_{L^{2}}^{2}, \text { for } p \in \mathbb{N}
$$

In the sequel, we use

$$
d(x)= \begin{cases}|x| & d \geq 3 \\ |x| \ln (B|x|) & d=2\end{cases}
$$

with $B \inf _{x \in \Omega}|x| \geq 2$.

Theorem 2. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Then there exists $C_{2}>0$ such that the following estimates

E_{u}(t) \leq C_{2}(1+t)^{-2} I_{1} \text { and }\|u(t)\|_{L^{2}}^{2} \leq C_{2}(1+t)^{-1} I_{1} \text { for all } t \geq 0,
$$

hold for every solution $u$ of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$ which satisfies

$$
\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}<+\infty,
$$

where

$$
I_{1}=\left\|u_{0}\right\|_{H^{1}}^{2}+\left\|u_{1}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2} .
$$

As a corollary we have:
Proposition 2. Let $n \in \mathbb{N}^{*}$. We assume that Hyp A holds and $(\omega, T)$ geometrically controls $\Omega$. Let $\left(u_{0}, u_{1}\right)$ in $D\left(A^{n}\right)$, such that $u_{0} \in L^{2}(\Omega)$ and

\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}<+\infty
$$

Then the solution $u$ of (1.1) satisfies

$$
\begin{gathered}
E_{\partial_{t}^{n} u}(t) \leq C_{n}(1+t)^{-n-2} I_{1, n}, \text { for all } t \geq 0 \\
\left\|\partial_{t}^{n} u(t)\right\|_{L^{2}}^{2} \leq C_{n-1}(1+t)^{-n-1} I_{1, n-1}, \text { for all } t \geq 0
\end{gathered}
$$

and

$$
\left\|\Delta \partial_{t}^{n-1} u(t)\right\|_{L^{2}}^{2} \leq C_{n+1}(1+t)^{-n-1} I_{1, n}, \text { for all } t \geq 0
$$

where $C_{p}$ is a positive constant independent of the initial data and

$$
I_{1, p}=\sum_{i=0}^{p}\left\|A^{i}\left(u_{0}, u_{1}\right)\right\|_{H}^{2}+\left\|u_{0}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2}, \text { for } p \in \mathbb{N} .
$$

## 2. Proof of Theorem 1

In order to prove theorem 1 we need some preliminary results.
Proposition 3. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Let $M=\Omega \cap B_{2 L}$. Setting

$$
\omega_{1}=\omega \cap B_{2 L}=\left\{x \in \Omega \cap B_{2 L} ; a(x)>\epsilon_{0}>0\right\}
$$

Then $\left(\omega_{1}, T\right)$ geometrically controls $M$. Therefore there exists a positive constant $C_{T}^{1}$, such that the following estimate

E_{w}(t) \leq C_{T}^{1}\left(\int_{t}^{t+T} \int_{M} a\left|\partial_{t} w\right|^{2}+|f(s, x)|^{2} d x d s\right) \tag{2.1}
\end{equation*}
$$

holds for every $t \geq 0$, for every solution $w$ of

$$
\begin{cases}\partial_{t}^{2} w-\Delta w+a(x) \partial_{t} w=f(t, x) & \mathbb{R}_{+} \times M  \tag{2.2}\\ w=0 & \mathbb{R}_{+} \times \partial M \\ \left(w(0), \partial_{t} w(0)\right)=\left(w_{0}, w_{1}\right) & \end{cases}
$$

with initial data in the energy space $H_{0}^{1}(M) \times L^{2}(M)$, and for every $f$ in $L_{\text {loc }}^{2}\left(\mathbb{R}_{+}, L^{2}(M)\right)$.

Proof. We remind that

$$
a(x)>\epsilon_{0}>0 \text { for }|x| \geq L .
$$

Let

$$
\omega_{1}=\left\{x \in \Omega \cap B_{2 L} ; a(x)>\epsilon_{0}>0\right\} .
$$

To prove that $\left(\omega_{1}, T\right)$ geometrically controls $M$, we have only to show that every geodesic starting from $B_{L}$ enters the set $\omega_{1}$ in a time $t<T$. Let $\gamma$ a geodesic starting from $B_{L}$, then we have the following two cases

- $\gamma$ stays in $B_{L}$ for every $t \in\left[0, T\left[\right.\right.$. Since $\left(\omega=\left\{x \in \Omega ; a(x)>\epsilon_{0}>0\right\}, T\right)$ geometrically controls $\Omega$, we infer that $\gamma$ enters the set $\left\{x \in \Omega \cap B_{L} ; a(x)>\epsilon_{0}>0\right\} \subset \omega_{1}$.
- $\gamma$ leaves the ball $B_{L}$ for some $t \in\left[0, T\left[\right.\right.$. Therefore $\gamma$ enters the set $\left\{x \in \Omega \cap B_{2 L} ;|x| \geq L\right\}$, since

$$
a(x)>\epsilon_{0}>0 \text { for }|x| \geq L
$$

we deduce that $\gamma$ enters the set $\omega_{1}$.
Therefore using [6, proposition 3], we obtain (2.1).
Proposition 4. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Let $\delta>0$ and $\chi \in C_{0}^{\infty}\left(\mathbb{R}^{d}\right)$. There exists $C_{T, \delta, \chi}>0$, such that the following inequality

\int_{t}^{t+T} \int_{\Omega} \chi^{2}(x)\left(|\nabla u|^{2}+\left|\partial_{t} u\right|^{2}\right) d x d s \leq C_{T, \delta, \chi}\left(\int_{t}^{t+T} \int_{\Omega} a(x)\left|\partial_{t} u\right|^{2} d x d s\right)+\delta E_{u}(t) \tag{2.3}
\end{equation*}
$$

holds for every $t \geq 0$ and for all $u$ solution of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H$.
Proof. To prove this result we argue by contradiction: If (2.3) was false, there would exist a sequence of numbers $\left(t_{n}\right)$ and a sequence of solutions $\left(u_{n}\right)$ such that

\int_{t_{n}}^{t_{n}+T} \int_{\Omega} \chi^{2}(x)\left(\left|\nabla u_{n}\right|^{2}+\left|\partial_{t} u_{n}\right|^{2}\right) d x d s \geq n\left(\int_{t_{n}}^{t_{n}+T} \int_{\Omega} a(x)\left|\partial_{t} u_{n}\right|^{2} d x d t\right)+\delta E_{u_{n}}\left(t_{n}\right) . \tag{2.4}
\end{equation*}
$$

Setting

$$
\lambda_{n}^{2}=\int_{t_{n}}^{t_{n}+T} \int_{\Omega} \chi^{2}(x)\left(\left|\nabla u_{n}\right|^{2}+\left|\partial_{t} u_{n}\right|^{2}\right) d x d s \text { and } v_{n}=\frac{u_{n}\left(t_{n}+\cdot\right)}{\lambda_{n}} .
$$

It is clear that (2.4), gives

\begin{equation*}
\int_{0}^{T} \int_{\Omega} a(x)\left|\partial_{t} v_{n}\right|^{2} d x d t \underset{n \rightarrow+\infty}{\longrightarrow} 0 \text { and } E_{v_{n}}(0) \leq \frac{1}{\delta} \tag{2.5}
\end{equation*}
$$

Let $Z_{n}$ be the solution of the following system

\begin{cases}\partial_{t}^{2} Z_{n}-\Delta Z_{n}=0 & \mathbb{R}_{+} \times \Omega \\ Z_{n}=0 & \mathbb{R}_{+} \times \Gamma \\ \left(Z_{n}(0), \partial_{t} Z_{n}(0)\right)=\frac{1}{\lambda_{n}}\left(u_{n}\left(t_{n}\right), \partial_{t} u_{n}\left(t_{n}\right)\right) & \end{cases}
$$

The hyperbolic energy inequality gives

\sup _{[0, T]} E_{v_{n}-Z_{n}}^{1 / 2}(s) \leq 2\left\|a(x) \partial_{t} v_{n}\right\|_{L^{1}\left([0, T], L^{2}(\Omega)\right)}
$$

Now using (2.5), we infer that

\sup _{[0, T]} E_{v_{n}-Z_{n}}(s) \underset{n \rightarrow+\infty}{\longrightarrow} 0 \tag{2.6}
\end{equation*}
$$

On the other hand,

$$
\frac{1}{2} \int_{0}^{T} \int_{\omega}\left|\partial_{t} Z_{n}\right|^{2} d x d t \leq \underset{[0, T]}{2 T \sup } E_{v_{n}-Z_{n}}(s)+\int_{0}^{T} \int_{\omega}\left|\partial_{t} v_{n}\right|^{2} d x d t
$$

Since $a(x) \geq \epsilon_{0}>0$ on $\omega$, from (2.5), we deduce that

\int_{0}^{T} \int_{\omega}\left|\partial_{t} v_{n}\right|^{2} d x d t \underset{n \rightarrow+\infty}{\longrightarrow} 0
$$

(2.6) combined with the result above, gives

\int_{0}^{T} \int_{\omega}\left|\partial_{t} Z_{n}\right|^{2} d x d t \underset{n \rightarrow+\infty}{\longrightarrow} 0 \tag{2.7}
\end{equation*}

It is clear that

$$
\sup _{[0, T]} E_{Z_{n}}(t)=E_{Z_{n}}(0)=E_{v_{n}}(0) \leq \frac{1}{\delta} .
$$

Therefore, along a subsequence, $\left(Z_{n}\right)$ is convergent to a function

$$
L^{2} \in C\left([0, T] ; H_{D}(\Omega)\right) \text { and } \partial_{t} Z \in L^{2}\left([0, T] ; L^{2}(\Omega)\right),
$$

with respect to the weak topology. Since $Z$ satisfies

$$
\begin{cases}\partial_{t}^{2} Z-\Delta Z=0 & \text { in }[0, T] \times \Omega \\ Z=0 & \text { on }[0, T] \times \Gamma \\ \left(Z_{0}, Z_{1}\right) \in H_{D}(\Omega) \times L^{2}(\Omega) \\ \partial_{t} Z(t, x)=0 & \text { on }[0, T] \times \omega\end{cases}
$$

Therefore we have

$$
Z \in C\left([0, T] ; H_{D}(\Omega)\right) \text { and } \partial_{t} Z \in C\left([0, T] ; L^{2}(\Omega)\right),
$$

We remind that $\left\{x \in \mathbb{R}^{d},|x| \geq L\right\} \subset \omega$. By a classical result of unique continuation, we obtain that $\partial_{t} Z \equiv 0$ on $[0, T] \times \Omega$. this mean that $Z(t, x)=Z(x)$ is independent of $t$. Therefore, we have

$$
\Delta Z=0 \text { and } Z \in H_{D}(\Omega),
$$

we conclude from this that $Z \equiv 0$ on $[0, T] \times \Omega$ (cf. [12, theorem 2.2 p 145$])$.
The sequence $\left(Z_{n}\right)$ is bounded in $H_{l o c}^{1}((0, T) \times \Omega)$, so eventually after extracting a subsequence we can associate to the sequence $\left(Z_{n}\right)$ a microlocal defect measure $\mu$. This measure satisfies these properties: The support of $\mu$ is contained in the characteristic set of the wave operator and it propagates along the geodesics of $\Omega$.

Now using (2.7), we deduce that

$$
\mu=0, \text { on }(0, T) \times \omega .
$$

Since $(\omega, T)$ geometrically controls $\Omega$ and $\mu$ propagates along geodesic flow, therefore we obtain

$$
\mu=0, \text { on }(0, T) \times \Omega .
$$

Let $R>0$ such that the support of $\chi$ is contained in $B_{R}$ and $\varphi \in C_{0}^{\infty}(0, T)$ such that

\int_{0}^{T} \varphi(s) d s \geq \epsilon>0
$$

Using the finite speed propagation property, we obtain

$$
\int_{0}^{T} \varphi(s) \int_{\Omega \cap B_{R+T}}\left|\nabla Z_{n}(s)\right|^{2}+\left|\partial_{t} Z_{n}(s)\right|^{2} d x d s \geq \epsilon \int_{\Omega \cap B_{R}}\left|\nabla Z_{n}(t)\right|^{2}+\left|\partial_{t} Z_{n}(t)\right|^{2} d x,
$$

for all $t \in[0, T]$. Now passing to the limit and using the fact that

$$
\mu=0, \text { on }(0, T) \times \Omega,
$$

we deduce that

$$
\int_{\Omega \cap B_{R}}\left|\nabla Z_{n}(t)\right|^{2}+\left|\partial_{t} Z_{n}(t)\right|^{2} d x \underset{n \rightarrow+\infty}{\longrightarrow} 0, \text { for all } t \in[0, T] .
$$

Using the result above and (2.6) we deduce that

$$
\int_{\Omega \cap B_{R}}\left|\nabla v_{n}(t)\right|^{2}+\left|\partial_{t} v_{n}(t)\right|^{2} d x \underset{n \rightarrow+\infty}{\longrightarrow} 0, \text { for all } t \in[0, T] .
$$

So we conclude that

$$

## 3. Proof of Theorem 2

This section is devoted to the proof of theorem 2 and proposition 2, we begin by giving some preliminary results.
Proposition 5. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Let $\delta>0$ and $\chi \in C_{0}^{\infty}\left(\mathbb{R}^{d}\right)$. There exists $C_{T, \delta, \chi}>0$, such that the following inequality

holds for every $t \geq 0$ and for all $u$ solution of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H_{0}^{1} \times L^{2}$.
Proof. To prove this result we argue by contradiction: If (3.1) was false, there would exist a sequence of numbers $\left(t_{n}\right)$ and a sequence of solutions $\left(u_{n}\right)$ such that

We may assume that $t_{n} \xrightarrow[n \rightarrow+\infty]{\longrightarrow}+\infty$ (if the sequence $t_{n}$ is bounded we can argue as in the proof of proposition (4). Setting

moreover

\leq & C \frac{\left(1+t_{n}\right)^{-1}}{\delta}
\end{aligned}
$$

and

\int_{0}^{T} \int_{\Omega}\left|\frac{1}{\lambda_{n}}\left(1+t_{n}+t\right)^{-\frac{1}{2}} \partial_{t} u_{n}\left(t_{n}+t\right)\right|^{2} d x d t & \leq \frac{\left(1+t_{n}\right)^{-1}}{\lambda_{n}^{2}} \int_{0}^{T} \int_{\Omega}\left|\partial_{t} u_{n}\left(t_{n}+t\right)\right|^{2} d x d t \\
& \leq \frac{\left(1+t_{n}\right)^{-1}}{\lambda_{n}^{2}} 2 T E_{u_{n}}\left(t_{n}\right) \\
& \leq \frac{2 T\left(1+t_{n}\right)^{-2}}{\delta}
\end{aligned}

We conclude that

& +\frac{2}{\lambda_{n}^{2}} \int_{t_{n}}^{t_{n}+T} \int_{\Omega} a(x)(1+s)\left|\partial_{t} u_{n}\right|^{2} d x d s \\
\leq & \frac{\|a\|_{\infty}\left(1+t_{n}\right)^{-1}}{\delta}+\frac{2}{\lambda_{n}^{2}} \int_{t_{n}}^{t_{n}+T} \int_{\Omega} a(x)(1+s)\left|\partial_{t} u_{n}\right|^{2} d x d s
\end{aligned}

Now using (3.3), we deduce that

Let $Z_{n}$ be the solution of the following system

The hyperbolic energy inequality gives

To complete the proof we have only to argue as in the proof of the proposition 4
As a corollary we have
Corollary 2. We assume that Hyp $A$ holds and $(\omega, T)$ geometrically controls $\Omega$. Let $\delta, R>0$. There exists $C_{T, \delta, R}>0$, such that the following inequality

+\delta\left((1+t) E_{u}(t)+\int_{t}^{t+T} \int_{\Omega}|u|^{2} d x d s\right)
\end{align*}

holds for every $t \geq 0$ and for all $u$ solution of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H$.
In the sequel we need the following result
Lemma 2. Let $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ such that $0 \leq \psi \leq 1$ and

Setting $w=\psi u$ and $v=(1-\psi) u$ where $u$ is a solution of (1.1) with initial data in $H_{0}^{1}(\Omega) \times$ $L^{2}(\Omega)$. Let

X(t)=\int_{\Omega} v(t) \partial_{t} v(t) d x+\frac{1}{2} \int_{\Omega} a(x)|v(t)|^{2} d x+k E_{u}(t)
$$

where $k$ is a positive constant. We have

Proof. We may assume that $u$ is smooth. According to (2.11)

3.1. Proof of Theorem 2. In the sequel $C, C_{T}$ and $C_{T, \delta}$ denote a generic positive constants and any changes from one derivation to the next will not be explicitly outlined.

Let $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ such that $0 \leq \psi \leq 1$ and

Let $w_{1}=(1+t)^{\frac{1}{2}} w$. Then $w_{1}$ is a solution of

with $M=\Omega \cap B_{2 L}$ and

holds for every $t \geq 0$. We have (cf, [6, proposition 2])

Using the estimate above, (3.8) and (3.9), we get

for some $C_{L}>0$. Using (3.6), we infer that

& \leq C_{T, \delta}\left(\int_{t}^{t+T} \int_{\Omega} a(1+s)\left|\partial_{t} u\right|^{2} d x d s\right)+C_{T} \delta\left(\int_{t}^{t+T} \int_{\Omega}|u|^{2} d x d s+(1+t) E_{u}(t)\right),
\end{aligned}

\leq & C_{T, \delta}\left(\int_{t}^{t+T} \int_{\Omega} a(1+s)\left|\partial_{t} u\right|^{2} d x d s\right)+C_{T} \delta\left(\int_{t}^{t+T} \int_{\Omega}|u|^{2} d x d s+\int_{t}^{t+T}(1+s) E_{u}(s) d s\right) .
\end{aligned}
$$

Now (3.7) and the two estimates above gives

$$
\begin{aligned}
& (1+t+T) X(t+T)-(1+t) X(t)+\left(1-3 C_{T} \delta\right) \int_{t}^{t+T}(1+s) E_{u}(s) d s \\
& +\left(k-\frac{2}{\epsilon_{0}}-3 C_{T, \delta}\right) \int_{t}^{t+T} \int_{\Omega} a(1+s)\left|\partial_{t} u\right|^{2} d x d s \\
& \leq \int_{t}^{t+T} X(s) d s+C_{T} \delta \int_{t}^{t+T} \int_{\Omega}|u|^{2} d x d s
\end{aligned}
$$

We have

$$
\begin{align*}
X(t) & \leq \frac{3}{2}\|a\|_{\infty} \int_{\Omega}|v(t)|^{2} d x+\left(k+\frac{2}{\epsilon_{0}}\right) E_{u}(t) \text { and }  \tag{3.14}\\
X(t) & \geq \frac{\epsilon_{0}}{4} \int_{\Omega}|v(t)|^{2} d x+\left(k-\frac{8}{\epsilon_{0}}\right) E_{u}(t) \tag{3.15}
\end{align*}
$$

We choose $\delta$ and $k$ such that

$$
\begin{aligned}
1-3 C_{T} \delta & =\frac{1}{2} \\
k-\frac{2}{\epsilon_{0}}-3 C_{T, \delta} & \geq \epsilon>0 \text { and } k-\frac{8}{\epsilon_{0}} \geq \epsilon
\end{aligned}
$$

Thus we get

$$
\begin{align*}
& (1+t+T) X(t+T)-(1+t) X(t)+\frac{1}{2} \int_{t}^{t+T}(1+s) E_{u}(s) d s \\
& +\epsilon \int_{t}^{t+T} \int_{\Omega} a(1+s)\left|\partial_{t} u\right|^{2} d x d s  \tag{3.16}\\
& \leq \int_{t}^{t+T} X(s) d s+\frac{1}{6} \int_{t}^{t+T} \int_{\Omega}|u|^{2} d x d s .
\end{align*}
$$

As in the proof of theorem 1, from the estimate above, we deduce that

$$
\begin{align*}
& \sup _{\mathbb{R}_{+}}((1+t) X(t))+\frac{1}{2} \int_{0}^{+\infty}(1+s) E_{u}(s) d s  \tag{3.17}\\
& \leq C\left(X(0)+\int_{0}^{+\infty} X(s) d s+\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s\right)
\end{align*}
$$

Using the fact that $1-\psi \equiv 1$ for $|x| \geq 2 L$, we obtain

$$
\sup _{\mathbb{R}_{+}}(1+t) \int_{\{|x| \geq 2 L\}}|u(t)|^{2} d x \leq C\left(X(0)+\int_{0}^{+\infty} X(s) d s+\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s\right) .
$$

On the other hand, using (2.17), we obtain

$$
\begin{aligned}
(1+t) \int_{\Omega \cap B_{2 L}}|u(t)|^{2} d x & \leq C_{L}(1+t) \int_{\Omega}|\nabla u(t)|^{2} d x \\
& \leq C_{L}(1+t) E_{u}(t) \\
& \leq C I_{0} .
\end{aligned}
$$

Combining the estimates above we deduce that

$$
\begin{equation*}
\sup _{\mathbb{R}_{+}}(1+t) \int_{\Omega}|u(t)|^{2} d x \leq C\left(X(0)+\int_{0}^{+\infty} X(s) d s+\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s+I_{0}\right) . \tag{3.18}
\end{equation*}
$$

Now we need the following result due to Ikehata [9, lemma 2.5]
Lemma 3. Let $u$ be a solution of (1.1) with initial data $\left(u_{0}, u_{1}\right)$ in $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$ which satisfies

$$
\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}<+\infty
$$

where

$$
d(x)= \begin{cases}|x| & d \geq 3 \\ |x| \ln (B|x|) & d=2\end{cases}
$$

with $B \inf _{x \in \Omega}|x| \geq 2$. Then there exists $C>0$, such that

$$
\begin{equation*}
\|u(t)\|_{L^{2}}^{2}+\int_{0}^{t} \int_{\Omega} a|u(s, x)|^{2} d x d s \leq C\left(\left\|u_{0}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2}\right) \tag{3.19}
\end{equation*}
$$

for all $t \geq 0$.
We have

$$
\begin{aligned}
\int_{0}^{t} \int_{\Omega}|u|^{2} d x d s & \leq \int_{0}^{t} \int_{\Omega \cap B_{L}}|u|^{2} d x d s+\int_{0}^{t} \int_{\{|x| \geq L\}}|u|^{2} d x d s \\
& \leq C_{L} \int_{0}^{t} \int_{\Omega \cap B_{L}}|\nabla u|^{2} d x d s+\frac{1}{\epsilon_{0}} \int_{0}^{t} \int_{\Omega} a|u(s, x)|^{2} d x d s \\
& \leq C_{L} \int_{0}^{t} E_{u}(s) d s+\frac{1}{\epsilon_{0}} \int_{0}^{t} \int_{\Omega} a|u(s, x)|^{2} d x d s
\end{aligned}
$$

Now using (3.19) and (2.16), we get

$$
\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s \leq C I_{1}
$$

with

$$
I_{1}=\left\|u_{0}\right\|_{H^{1}}^{2}+\left\|u_{1}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2}
$$

On the other hand, using (3.14) and the fact that

$$
\int_{0}^{+\infty} E_{u}(s) d s \leq C I_{0}
$$

we obtain

$$
\begin{aligned}
\int_{0}^{+\infty} X(s) d s & \leq C\left(\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s+\int_{0}^{+\infty} E_{u}(s) d s\right) \\
& \leq C I_{1}
\end{aligned}
$$

Finally it is clear that,

$$
X(0) \leq C I_{1}
$$

Therefore from (3.18)

$$
\begin{aligned}
\sup _{\mathbb{R}_{+}}(1+t) \int_{\Omega}|u(t)|^{2} d x & \leq C\left(X(0)+\int_{0}^{+\infty} X(s) d s+\int_{0}^{+\infty} \int_{\Omega}|u|^{2} d x d s+I_{0}\right) \\
& \leq C I_{1}
\end{aligned}
$$

and (3.17), gives

$$
\int_{0}^{+\infty}(1+s) E_{u}(s) d s \leq C I_{1}
$$

The energy decay estimate follows from the fact that

$$
\begin{aligned}
(1+t)^{2} E_{u}(t) & \leq E_{u}(0)+2 \int_{0}^{+\infty}(1+s) E_{u}(s) d s \\
& \leq C I_{1}, \text { for all } t \geq 0
\end{aligned}
$$

This finishes the proof of theorem 2 and now we give the proof of proposition 2 .
3.2. Proof of proposition 2. Let $n \in \mathbb{N}^{*}$ and $u$ the solution of (1.1) with initial data in $D\left(A^{n}\right)$ such that $u_{0} \in L^{2}(\Omega)$ and

$$
\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}<+\infty
$$

Let $v=\partial_{t} u$. Using these estimates

$$
\int_{0}^{+\infty}(1+s) E_{u}(s) d s \leq C I_{1} \text { and } \int_{0}^{+\infty}(1+s) E_{v}(s) d s \leq C I_{0,1}
$$

and proceeding as in the proof of proposition 1, we show that

$$
\int_{0}^{+\infty}(1+s)^{2} E_{v}(s) d s \leq C_{1} I_{1,1}
$$

We set $u_{n}=\partial_{t}^{n} u$, for $n \geq 1$. Using induction argument and arguing as in the proof of proposition 1, we prove that

$$
\int_{0}^{+\infty}(1+s)^{n+1} E_{u_{n}}(s) d s \leq C_{n} I_{1, n}
$$

with

$$
I_{1, n}=\sum_{i=0}^{n}\left\|A^{i}\left(u_{0}, u_{1}\right)\right\|_{H}^{2}+\left\|u_{0}\right\|_{L^{2}}^{2}+\left\|d(\cdot)\left(u_{1}+a u_{0}\right)\right\|_{L^{2}}^{2}
$$

## M. DAOULATLI

The energy decay estimate follows from the fact that

$$
\begin{aligned}
(1+t)^{n+2} E_{u_{n}}(t) & \leq E_{u_{n}}(0)+(n+2) \int_{0}^{t}(1+s)^{n+1} E_{u_{n}}(s) d s \\
& \leq C_{n} I_{1, n}, \text { for all } t \geq 0 .
\end{aligned}
$$

Now using the estimate above, we infer that,

$$
\begin{aligned}
(1+t)^{n+1}\left\|\partial_{t}^{n} u(t)\right\|_{L^{2}}^{2} & \leq 2(1+t)^{n+1} E_{u_{n-1}}(t) \\
& \leq C_{n-1} I_{1, n-1} \text { for all } t \geq 0
\end{aligned}
$$

We have $\partial_{t}^{n-1} u$ is a solution of the following system

$$
\begin{cases}\partial_{t}^{n+1} u-\Delta \partial_{t}^{n-1} u+a(x) \partial_{t}^{n} u=0 & \text { in } \mathbb{R}_{+} \times \Omega  \tag{3.20}\\ \partial_{t}^{n-1} u=0 & \text { on } \mathbb{R}_{+} \times \Gamma \\ \left(\partial_{t}^{n-1} u(0, x), \partial_{t}^{n} u(0, x)\right) \in D(A) & \end{cases}
$$

therefore

$$
\left(\partial_{t}^{n-1} u, \partial_{t}^{n} u\right) \in C^{1}\left(\mathbb{R}_{+}, H\right)
$$

Using Eq (3.20), we infer that

$$
\begin{aligned}
(1+t)^{n+1}\left\|\Delta \partial_{t}^{n-1} u(t)\right\|_{L^{2}}^{2} & \leq C(1+t)^{n+1}\left(E_{u_{n}}(t)+E_{u_{n-1}}(t)\right) \\
& \leq C I_{1, n}
\end{aligned}
$$
