# DECAY RATE AND RADIAL SYMMETRY OF THE EXPONENTIAL ELLIPTIC EQUATION

#### Abstract

Let $n \geq 3, \alpha, \beta \in \mathbb{R}$, and let $v$ be a solution $\Delta v+\alpha e^{v}+\beta x \cdot \nabla e^{v}=0$ in $\mathbb{R}^{n}$, which satisfies the conditions $\lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \rho^{1-n}\left(\int_{B_{\rho}} e^{v} d x\right) d \rho \in(0, \infty)$ and $|x|^{2} e^{v(x)} \leq A_{1}$ in $\mathbb{R}^{n}$. We prove that $\frac{v(x)}{\log |x|} \rightarrow-2$ as $|x| \rightarrow \infty$ and $\alpha>2 \beta$. As a consequence under a mild condition on $v$ we prove that the solution is radially symmetric about the origin.


## 1. Introduction

In this paper we will study various properties of the solution $v$ of the nonlinear elliptic equation

$$
\begin{equation*}
\Delta v+\alpha e^{v}+\beta x \cdot \nabla e^{v}=0 \quad \text { in } \mathbb{R}^{n} \tag{1.1}
\end{equation*}
$$

for any $n \geq 3$ where $\alpha, \beta \in \mathbb{R}$, are some constants. Let $v=\log u$. Then $u$ satisfies

$$
\begin{equation*}
\Delta \log u+\alpha u+\beta x \cdot \nabla u=0, \quad u>0, \quad \text { in } \mathbb{R}^{n} . \tag{1.2}
\end{equation*}
$$

As observed by S.Y. Hsu Hs3, the radial symmetric solution of (1.2) is the singular limit of the radial symmetric solutions of the nonlinear elliptic equation,

$$
\begin{equation*}
\Delta\left(u^{m} / m\right)+\alpha u+\beta x \cdot \nabla u=0, \quad u>0, \quad \text { in } \mathbb{R}^{n}, \tag{1.3}
\end{equation*}
$$

as $m \searrow 0$. On the other hand as observed by P. Daskalopoulos and N. Sesum DS, K.M. Hui and S.H. Kim HK1, HK2, (1.2) also arises in the study of the extinction behaviour and global behaviour of the solutions of the logarithmic diffusion equation,

$$
\begin{equation*}
u_{t}=\Delta \log u, \quad u>0, \quad \text { in } \mathbb{R}^{n} . \tag{1.4}
\end{equation*}
$$

(1.2) also arises in the study of self-similar solutions of (1.4) (DS, HK1, HK2, [1], V2]). Hence in order to understand the behaviour of the solutions of (1.3) and (1.4) it is important to understand the properties of solutions of (1.1).

In Hs2] S.Y. Hsu proved that there exists a radially symmetric solution of (1.1) ( or equivalently (1.2)) if and only if either $\alpha \geq 0$ or $\beta>0$. She also proved that when $n \geq 3$ and $\alpha>\max (2 \beta, 0)$, then any radially symmetric solution $v$ of (1.1) satisfies

\lim _{|x| \rightarrow \infty}|x|^{2} e^{v(x)}=\frac{2(n-2)}{\alpha-2 \beta} . \tag{1.5}
\end{equation*}
$$

By (1.5) and a direct computation the radially symmetric solution $v$ of (1.1) satisfies

\begin{equation*}
\lim _{|x| \rightarrow \infty} \frac{v(x)}{\log |x|}=-2, \tag{1.6}
\end{equation*}
$$

A_{0}:=\lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{|x|<\rho} e^{v} d x\right) d \rho \in(0, \infty) \tag{1.7}
\end{equation*}
$$

\]

and

$$
\begin{equation*}
|x|^{2} e^{v(x)} \leq A_{1} \quad \forall x \in \mathbb{R}^{n} \tag{1.8}
\end{equation*}
$$

for some constant $A_{1}>0$. A natural question is if $v$ is a solution of (1.1) which satisfies (1.7) and (1.8) for some constant $A_{1}>0$, will $v$ satisfy (1.6) and is $v$ radially symmetric about the origin? We answer the first question in the affirmative in this paper. For the second question we prove that under some conditions on the solution $v$ of (1.1), $v$ is radially symmetric about the origin.

For any solution $v$ of (1.1) we define the rotation operator $\Phi_{i j}$ by

\Phi_{i j}(x)=x_{i} v_{x_{j}}(x)-x_{j} v_{x_{i}}(x), \quad \forall x=\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}, i \neq j, i, j=1, \cdots, n
$$

Note that if we write $x_{1}=\rho \cos \theta$ and $x_{2}=\rho \sin \theta$ where $\rho=\sqrt{x_{1}^{2}+x_{2}^{2}}$, then $\Phi_{12}(x)=\frac{\partial v}{\partial \theta}(x)$. We are now ready to state the main results of this paper.

Theorem 1.1. Let $n \geq 3$ and $\alpha, \beta \in \mathbb{R}$. Suppose $v$ is a solution of (1.1) which satisfies (1.7) and (1.8) for some constant $A_{1}>0$. Then $v$ satisfies (1.6) and $\alpha>2 \beta$.

Corollary 1.2. Let $n \geq 3$. Suppose $\alpha \leq 2 \beta$. Then (1.1) does not have any solution that satisfies both (1.7) and (1.8) for some constant $A_{1}>0$.

Theorem 1.3. Let $n \geq 3$ and $2 \beta<\alpha<n \beta$. Suppose $v$ is a solution of (1.1) which satisfies (1.7), (1.8),

$$
\begin{equation*}
\|x \cdot \nabla v\|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \leq C<\infty \tag{1.9}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{|x| \rightarrow \infty}|x|^{n-2}\left|\Phi_{i j}(x)\right|=0, \quad \forall i \neq j, i, j=1, \cdots, n . \tag{1.10}
\end{equation*}
$$

Then there exists a constant $R_{0}>0$ such that if $v$ is radially symmetric in $B_{R_{0}}$, then $v$ is radially symmetric in $\mathbb{R}^{n}$.

Note that although there are many research done on the radial symmetry of elliptic equations without first order term by B. Gidas, W.M. Ni, and L. Nirenberg [GNN, L. Caffaralli, B. Gidas and J. Spruck [CGS], W. Chen and C. Li [CL, S.D. Taliaferro [T] and others, very little is known about the radial symmetry of elliptic equations with non-zero first order term. The reason is that one cannot use the moving plane technique to prove the radial symmetry of the solution for elliptic equations with non-zero first order term. The recent paper KM by E. Kamalinejad and A. Moradifam is one of the few papers that studies the radial symmetry of elliptic equations with non-zero first order term. Hence our result on radial symmetry is new.

The plan of the paper is as follows. In section two we will prove Theorem 1.1 and Corollary 1.2. In section three we will prove Theorem 1.3, For any $r>0, x_{0} \in \mathbb{R}^{n}$, let $B_{r}\left(x_{0}\right)=\left\{x \in \mathbb{R}^{n}\right.$ : $\left.\left|x-x_{0}\right|<r\right\}$ and $B_{r}=B_{r}(0)$. Let $S^{n-1}=\left\{x \in \mathbb{R}^{n}:|x|=1\right\}$. We will let $n \geq 3, \alpha, \beta \in \mathbb{R}$, and let $v$ be a solution of (1.1) which satisfies both (1.7) and (1.8) for some constant $A_{1}>0$ for the rest of the paper. We will also let $A_{0}$ be given by (1.7) for the rest of the paper.

## 2. Decay rate of the solution of (1.1)

In this section we will use a modification of the technique of [Hs1 to prove the decay rate (1.6) for $v$. We first start with a lemma.

Lemma 2.1. For any $x_{0} \in \mathbb{R}^{n}$, we have

\lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho=A_{0} \tag{2.1}
\end{equation*}
$$

Proof. Let $x_{0} \in \mathbb{R}^{n}$ and $\rho>\left|x_{0}\right|$. Since $B_{\rho-\left|x_{0}\right|} \subset B_{\rho}\left(x_{0}\right)$, for any $R>R_{0}>\left|x_{0}\right|+1$,

& \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho \\
& \quad \geq \frac{1}{\log R} \int_{R_{0}}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho-\left|x_{0}\right|}} e^{v} d x\right) d \rho \\
& \geq \frac{1}{\log R}\left(\frac{R_{0}-\left|x_{0}\right|}{R_{0}}\right)^{n-1} \int_{R_{0}-\left|x_{0}\right|}^{R-\left|x_{0}\right|} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}} e^{v} d x\right) d \rho \\
& =-\frac{1}{\log R}\left(\frac{R_{0}-\left|x_{0}\right|}{R_{0}}\right)^{n-1} \int_{1}^{R_{0}-\left|x_{0}\right|} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}} e^{v} d x\right) d \rho \\
& \quad+\frac{\log \left(R-\left|x_{0}\right|\right)}{\log R}\left(\frac{R_{0}-\left|x_{0}\right|}{R_{0}}\right)^{n-1}\left[\frac{1}{\log \left(R-\left|x_{0}\right|\right)} \int_{1}^{R-\left|x_{0}\right|} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}} e^{v} d x\right) d \rho\right] .
\end{aligned}
$$

Letting $R \rightarrow \infty$,

$$
\begin{align*}
& \liminf _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho \geq\left(\frac{R_{0}-\left|x_{0}\right|}{R_{0}}\right)^{n-1} A_{0} \\
& \quad \Rightarrow \liminf _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho \geq A_{0} \quad \text { as } R_{0} \rightarrow \infty \tag{2.2}
\end{align*}
$$

Similarly,

$$
\begin{equation*}
\limsup _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho \leq A_{0} \tag{2.3}
\end{equation*}
$$

By (2.2) and (2.3), we get (2.1) and the lemma follows.
Lemma 2.2. For any $x_{0} \in \mathbb{R}^{n}$, we have

$$
\begin{equation*}
\lim _{\rho \rightarrow \infty} \rho^{2} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma=(n-2) A_{0} \tag{2.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{\rho \rightarrow \infty}\left[\frac{1}{\log \rho} \int_{|\sigma|=1} v\left(x_{0}+\rho \sigma\right) d \sigma\right]=-(\alpha-2 \beta) A_{0} \tag{2.5}
\end{equation*}
$$

Proof. Let $x_{0} \in \mathbb{R}^{n}$ and $\rho>0$. We first observe that (1.1) can be rewritten as

\begin{equation*}
\Delta v+(\alpha-n \beta) e^{v}+\beta \operatorname{div}\left(x e^{v}\right)=0 \quad \text { in } \mathbb{R}^{n} \tag{2.6}
\end{equation*}
$$

Integrating (2.6) over $B_{\rho}\left(x_{0}\right)$,

$$
\begin{align*}
0=\rho^{n-1} & \int_{|\sigma|=1} \frac{\partial v}{\partial \rho}\left(x_{0}+\rho \sigma\right) d \sigma+(\alpha-n \beta) \int_{B_{\rho}\left(x_{0}\right)} e^{v} d x+\beta \rho^{n} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma \\
& +\beta \rho^{n-1} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)}\left(x_{0} \cdot \sigma\right) d \sigma . \tag{2.7}
\end{align*}
$$

Let $R>R_{0} \geq 1$. Dividing (2.7) by $\rho^{n-1}$ and integrating over $\rho \in(1, R)$,

$$
\begin{array}{rl}
\int_{|\sigma|=1} & v\left(x_{0}+R \sigma\right) d \sigma-\int_{|\sigma|=1} v\left(x_{0}+\sigma\right) d \sigma \\
= & -(\alpha-n \beta) \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}\left(x_{0}\right)} e^{v} d x\right) d \rho-\beta \int_{1}^{R} \rho\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho  \tag{2.8}\\
& \quad-\beta \int_{1}^{R}\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)}\left(x_{0} \cdot \sigma\right) d \sigma\right) d \rho
\end{array}
$$

Let $\left\{\rho_{i}\right\}_{i=1}^{\infty}$ be a sequence such that $\rho_{i}>2\left|x_{0}\right|+1$ for all $i \in \mathbb{Z}^{+}$and $\rho_{i} \rightarrow \infty$ as $i \rightarrow \infty$. Then by (1.8) there exists a constant $C_{1}>0$ such that

$$
\rho_{i}^{2} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho_{i} \sigma\right)} d \sigma \leq C_{1} \quad \forall i \in \mathbb{Z}^{+}
$$

Hence the sequence $\left\{\rho_{i}\right\}_{i=1}^{\infty}$ has a subsequence which we may assume without loss of generality to be the sequence itself such that

\rho_{i}^{2} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho_{i} \sigma\right)} d \sigma
$$

converges to some non-negative number as $i \rightarrow \infty$. On the other hand by (2.1), there exists a constant $R_{1}>1$ such that

$$
\begin{equation*}
\Rightarrow \quad \int_{B_{\rho}\left(x_{0}\right)} e^{v} d x \geq \frac{(n-2)}{2} A_{0} \log \rho \rightarrow \infty \quad \text { as } \rho \rightarrow \infty \tag{2.9}
\end{equation*}
$$

Then by (1.7), (2.1), (2.9), and the l'Hospital rule,

$$
\begin{aligned}
A_{0} & =\lim _{\rho \rightarrow \infty} \frac{\frac{1}{\rho_{i}^{n-1}} \int_{B_{\rho_{i}}\left(x_{0}\right)} e^{v} d x}{\frac{1}{\rho_{i}}}=\lim _{i \rightarrow \infty} \frac{1}{\rho_{i}^{n-2}} \int_{B_{\rho_{i}}\left(x_{0}\right)} e^{v} d x \\
& =\lim _{i \rightarrow \infty} \frac{\rho_{i}^{n-1} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho_{i} \sigma\right)} d \sigma}{(n-2) \rho_{i}^{n-3}}=\frac{1}{(n-2)} \lim _{i \rightarrow \infty} \rho_{i}^{2} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho_{i} \sigma\right)} d \sigma
\end{aligned}
$$

Since the sequence $\left\{\rho_{i}\right\}_{i=1}^{\infty}$ is arbitrary, (2.4) follows. Then by (2.4) for any $0<\varepsilon<1$ there exists a constant $R_{0}>1$ such that

\left|\rho^{2} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma-(n-2) A_{0}\right|<(n-2) A_{0} \varepsilon \quad \forall \rho \geq R_{0} \tag{2.10}
\end{equation*}
$$

By (2.10),

$$
\begin{align*}
& \int_{1}^{R_{0}} \rho\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho+(1-\varepsilon)(n-2) A_{0} \log \left(R / R_{0}\right) \\
& \quad \leq \int_{1}^{R} \rho\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho  \tag{2.11}\\
& \quad \leq \int_{1}^{R_{0}} \rho\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho+(1+\varepsilon)(n-2) A_{0} \log \left(R / R_{0}\right) \quad \forall R>R_{0}
\end{align*}
$$

and

$$
\begin{align*}
& \left|\int_{1}^{R} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)}\left(x_{0} \cdot \sigma\right) d \sigma d \rho\right|  \tag{2.12}\\
& \quad \leq\left|x_{0}\right| \int_{1}^{R_{0}}\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho+2(n-2) A_{0}\left|x_{0}\right|\left(\frac{1}{R_{0}}-\frac{1}{R}\right)
\end{align*}
$$

for any $R>R_{0}$. Dividing (2.11) and (2.12) by $\log R$ and letting first $R \rightarrow \infty$ and then $\varepsilon \rightarrow 0$, we get

\begin{equation*}
\lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \rho\left(\int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)} d \sigma\right) d \rho=(n-2) A_{0} \tag{2.13}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \int_{|\sigma|=1} e^{v\left(x_{0}+\rho \sigma\right)}\left(x_{0} \cdot \sigma d \sigma d \rho=0 .\right. \tag{2.14}
\end{equation*}
$$

Dividing (2.8) by $\log R$ and letting $R \rightarrow \infty$, by (1.7), (2.13) and (2.14), we get (2.5) and the lemma follows.

We now let

$$
\left\{\begin{align*}
w_{1}(x) & =\frac{1}{n(2-n) \omega_{n}} \int_{\mathbb{R}^{n}}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) e^{v(y)} d y \quad \forall x \in \mathbb{R}^{n}  \tag{2.15}\\
w_{2, R}(x) & =\frac{1}{n(2-n) \omega_{n}} \int_{|y| \leq R}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) \operatorname{div}\left(e^{v(y)} y\right) d y \quad \forall x \in B_{R}, R>0
\end{align*}\right.
$$

where $\omega_{n}$ is the volume of the unit ball in $\mathbb{R}^{n}$. Then $w_{1}$ and $w_{2, R}$ are well-defined in $\mathbb{R}^{n}$ and $B_{R}$ respectively with $w_{1} \in C\left(\mathbb{R}^{n}\right)$ and $w_{2, R} \in C\left(B_{R}\right)$. Moreover

$$
\left\{\begin{align*}
\triangle w_{1} & =e^{v} & & \text { in } \mathbb{R}^{n}  \tag{2.16}\\
\triangle w_{2, R} & =\operatorname{div}\left(e^{v(y)} y\right) & & \text { in } B_{R} \quad \forall R>0 .
\end{align*}\right.
$$

Lemma 2.3. As $R \rightarrow \infty$, $w_{2, R}$ will converge uniformly on every compact subset of $\mathbb{R}^{n}$ to

\begin{align*}
w_{2}(x) & =\frac{1}{n(n-2) \omega_{n}} \int_{\mathbb{R}^{n}} e^{v(y)} \nabla_{y}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) \cdot y d y  \tag{2.17}\\
& =\frac{1}{n \omega_{n}} \int_{\mathbb{R}^{n}}\left(\frac{(x-y) \cdot y}{|x-y|^{n}}+\frac{1}{|y|^{n-2}}\right) e^{v(y)} d y .
\end{align*}
$$

Proof. Let $R_{0}>1, R>2 R_{0}$ and $|x| \leq R_{0}$. Now

w_{2, R}(x)= & \frac{1}{n(2-n) \omega_{n}} \int_{|y|=R}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) e^{v(y)} y \cdot \nu(y) d \sigma_{R}(y) \\
& \quad+\frac{1}{n(n-2) \omega_{n}} \int_{|y|<R} e^{v(y)} \nabla_{y}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) \cdot y d y  \tag{2.18}\\
= & I_{1, R}(x)+I_{2, R}(x)
\end{align*}
$$

where $\nu(y)=\frac{y}{|y|}$. Since there exists a constant $C_{1}>0$ such that

\begin{align*}
\left|\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right| & =\left|\int_{0}^{1} \frac{\partial}{\partial \theta}\left(\frac{1}{|\theta x-y|^{n-2}}\right) d \theta\right|=(n-2)\left|\int_{0}^{1} \frac{(\theta x-y) \cdot x}{|\theta x-y|^{n}} d \theta\right| \\
& \leq C_{1} \frac{|x|}{|y|^{n-1}} \quad \forall|y| \geq 2|x| \tag{2.19}
\end{align*}
$$

by (2.10) there exists a constant $C_{2}>0$ such that

\begin{equation*}
\sup _{|x|<R_{0}}\left|I_{1, R}(x)\right| \leq \frac{C_{2} R_{0}}{R} \rightarrow 0 \quad \text { as } R \rightarrow \infty . \tag{2.20}
\end{equation*}
$$

By the Taylor expansion (P. 231 of [GNN),

$$
\frac{1}{|x-y|^{n}}=\frac{1}{|y|^{n}}\left(1+\frac{n}{|y|^{2}} \sum_{j=1}^{n} x_{j} y_{j}+O\left(\frac{1}{|y|^{2}}\right)\right) \quad \forall|y| \geq 2|x|, x=\left(x_{1} \cdots, x_{n}\right), y=\left(y_{1}, \cdots, y_{n}\right)
$$

Hence there exists a constant $C_{3}>0$ such that

\begin{align*}
& \left|\nabla_{y}\left(\frac{1}{|x-y|^{n-2}}-\frac{1}{|y|^{n-2}}\right) \cdot y\right| \\
& \quad=(n-2)\left|\frac{(x-y) \cdot y}{|x-y|^{n}}+\frac{1}{|y|^{n-2}}\right| \\

& \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}} e^{v} d y\right) d \rho \geq \frac{C_{1} R^{2-b}}{\log R}-\frac{C_{2}}{\log R} \quad \forall R>R_{2} \\
\Rightarrow & \lim _{R \rightarrow \infty} \frac{1}{\log R} \int_{1}^{R} \frac{1}{\rho^{n-1}}\left(\int_{B_{\rho}} e^{v} d y\right) d \rho=\infty \quad \text { as } R \rightarrow \infty
\end{aligned}
$$

which again contradicts (1.7). Hence $L=2$ and the theorem follows.
Corollary 2.8. If $v$ is a solution of (1.1) which satisfies (1.7) and (1.8), then

$$
\alpha>2 \beta \quad \text { and } \quad A_{0}=\frac{2 n \omega_{n}}{\alpha-2 \beta} .
$$

## 3. Radial symmetry of the solution

In this section we will prove that under some condition on the solution $v$ of (1.1), $v$ is radially symmetric about the origin. We first start with a proposition.

Proposition 3.1. Let $n \geq 3, \alpha>2 \beta, a_{0} \in \mathbb{R}$, and let $v$ be the unique radially symmetric solution of (1.1) with $v(0)=a_{0}$ constructed in [Hs2]. Then (1.5) holds and

$$
\lim _{r \rightarrow \infty} r v^{\prime}(r)=-2
$$

Proof. We first observe that (1.5) is proved in Hs2]. We next observe that by putting $x_{0}=0$ in (2.7) and simplifying,

$$
r v^{\prime}(r)=\frac{n \beta-\alpha}{r^{n-2}} \int_{0}^{r} \rho^{n-1} e^{v(\rho)} d \rho-\beta r^{2} e^{v(r)}
$$

Hence by (1.5),

$$
\begin{aligned}
\lim _{r \rightarrow \infty} r v^{\prime}(r) & =\lim _{r \rightarrow \infty} \frac{n \beta-\alpha}{r^{n-2}} \int_{0}^{r} \rho^{n-1} e^{v(\rho)} d \rho-\beta \lim _{r \rightarrow \infty} r^{2} e^{v(r)} \\
& =(n \beta-\alpha) \lim _{r \rightarrow \infty} \frac{r^{n-1} e^{v(r)}}{(n-2) r^{n-3}}-\beta \lim _{r \rightarrow \infty} r^{2} e^{v(r)} \\
& =\left[\frac{n \beta-\alpha}{n-2}-\beta\right] \lim _{r \rightarrow \infty} r^{2} e^{v(r)} \\
& =-2 .
\end{aligned}
$$

Proposition 3.2. Let $n \geq 3, \alpha>2 \beta$, and let $v$ be a solution of (1.1) which satisfies (1.7), (1.8) and (1.9). Then

$$
x \cdot \nabla v \rightarrow-2 \quad \text { uniformly as }|x| \rightarrow \infty .
$$

Proof. Let

$$
V(x)=x \cdot \nabla v(x) .
$$

By (1.1) and a direct computation $V$ satisfies

$$
\begin{equation*}
\Delta V=F(x) \quad \text { in } \mathbb{R}^{n} \tag{3.1}
\end{equation*}
$$

where

$$
\begin{equation*}
F(x) \equiv-\left(2 \alpha+(\alpha+2 \beta) V+\beta V^{2}\right) e^{v}-\beta(x \cdot \nabla V) e^{v} \tag{3.2}
\end{equation*}
$$

Let $0<\mu<1$ and $x \in \mathbb{R}^{n}$ be such that $|x|>1$. For any $y \in B_{\frac{|x|}{2}}(x)$, let

$$
d_{y}=\operatorname{dist}\left(y, \partial B_{\frac{|x|}{2}}(x)\right) \quad \text { and } \quad R=\frac{1}{3} d_{y}
$$

Then by Green's representation formula,

$$
\begin{equation*}
V(z)=H(z)+N(z) \quad \forall z \in B_{2 \mu R}(y) \tag{3.3}
\end{equation*}
$$

for some harmonic function $H$ in $B_{2 \mu R}(y)$ where

$$
\begin{equation*}
N(z)=\frac{1}{n(2-n) \omega_{n}} \int_{B_{2 \mu R}(y)}|z-w|^{2-n} F(w) d w \tag{3.4}
\end{equation*}
$$

is the Newtonian potential of $F$ in $B_{2 \mu R}(y)$. Since $d_{z} \geq d_{y} / 3=R$ for any $z \in B_{2 \mu R}(y)$, by (3.3), (3.4), and Theorem 2.1 and Lemma 4.1 of [GT],

$$
\begin{aligned}
d_{y}|\nabla N(y)| & =\frac{d_{y}}{n(n-2) \omega_{n}}\left|\int_{B_{2 \mu R}(y)} \nabla_{y}\left(|y-w|^{2-n}\right) F(w) d w\right| \\
& \leq C_{1} \mu d_{y}^{2} \sup _{B_{2 \mu R}(y)}|F| \\
& \leq C_{1} \mu\left\|d_{z}^{2} F(z)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}
\end{aligned}
$$

and

$$
\begin{aligned}
d_{y}|\nabla H(y)| & \leq \frac{C_{2} d_{y}}{\mu R} \sup _{B_{2 \mu R}(y)}|H| \leq \frac{3 C_{2}}{\mu}\left(\sup _{B_{2 \mu R}(y)}|V|+\mu^{2} R^{2} \sup _{B_{2 \mu R}(y)}|F|\right) \\
& \leq \frac{3 C_{2}}{\mu}\left(\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}+\mu^{2}\left\|d_{z}^{2} F(z)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}\right)
\end{aligned}
$$

for some constants $C_{1}>0, C_{2}>0$. Hence

$$
\begin{equation*}
\left\|d_{y} \nabla V(y)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)} \leq \frac{C_{3}}{\mu}\left(\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}+\mu^{2}\left\|d_{z}^{2} F(z)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}\right) \tag{3.5}
\end{equation*}
$$

for some constant $C_{3}>0$. Since $d_{z} \leq|x| / 2 \leq|z|$ for any $z \in B_{|x| / 2}(x)$,

$$
\begin{equation*}
d_{z}^{2} e^{v(z)} \leq A_{1} \quad \forall z \in B_{|x| / 2}(x) \tag{3.6}
\end{equation*}
$$

Then by (1.8), (3.2) and (3.6),

$$
\begin{equation*}
\left|d_{z}^{2} F(z)\right| \leq C_{4}\left(1+\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}+\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}^{2}+\left\|d_{w} \nabla V(w)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}\right) \tag{3.7}
\end{equation*}
$$

for some constant $C_{4}>0$ and any $z \in B_{|x| / 2}(x)$. Hence by (3.5) and (3.7),

$$
\begin{align*}
& \left\|d_{y} \nabla V(y)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)} \\
& \quad \leq \frac{C_{5}}{\mu}\left(1+\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}+\|V\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)}^{2}\right)+\mu^{2}\left\|d_{y} \nabla V(y)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)} \tag{3.8}
\end{align*}
$$

for some constant $C_{5}>0$. We now choose $\mu=1 /\left(2 C_{5}\right)$. Then by (3.8),

$$
\frac{|x|}{4}\|\nabla V\|_{L^{\infty}\left(B_{|x| / 4}(x)\right)} \leq\left\|d_{y} \nabla V(y)\right\|_{L^{\infty}\left(B_{|x| / 2}(x)\right)} \leq 2 C_{5}\left(1+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}^{2}\right)
$$

Hence

$$
\begin{equation*}
\|\nabla V\|_{L^{\infty}\left(B_{\frac{|x|}{4}}(x)\right)} \leq \frac{C_{6}}{|x|}\left(1+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}^{2}\right) \tag{3.9}
\end{equation*}
$$

where $C_{6}=8 C_{5}$. Let $r>1$. Taking supremum over all $|x| \geq r$ in (3.9), we get

$$
\begin{equation*}
\|\nabla V\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash B_{r}\right)} \leq \frac{C_{6}}{r}\left(1+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}+\|V\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}^{2}\right) . \tag{3.10}
\end{equation*}
$$

We next choose $\varepsilon_{0}>0$ such that for any $\sigma, \sigma^{\prime} \in S^{n-1}$, the line segment $l_{\sigma, \sigma^{\prime}}$ joining $\sigma$ and $\sigma^{\prime}$ is outside $B_{\frac{1}{2}}$, i.e., $|\xi| \geq \frac{1}{2}$ for all $\xi \in l_{\sigma, \sigma^{\prime}}$. Then by (3.10), $\forall x=r \sigma, x^{\prime}=r \sigma^{\prime},\left|\sigma-\sigma^{\prime}\right|<\epsilon_{0}$,

$$
\begin{aligned}
\left|x \cdot \nabla v(x)-x^{\prime} \cdot \nabla v\left(x^{\prime}\right)\right| & =\left|V(x)-V\left(x^{\prime}\right)\right| \\
& =\left|\int_{0}^{1} \frac{\partial}{\partial t} V\left(t x+(1-t) x^{\prime}\right) d t\right| \\
& \leq\left|x-x^{\prime}\right| \cdot \sup _{0 \leq t \leq 1}\left|\nabla V\left(t x+(1-t) x^{\prime}\right)\right| \\
& \leq\left|\sigma-\sigma^{\prime}\right| \cdot \sup _{0 \leq t \leq 1} \frac{C}{t \sigma+(1-t) \sigma^{\prime}} \\
& \leq C\left|\sigma-\sigma^{\prime}\right|
\end{aligned}
$$

for some constant $C>0$. Hence the family $\left\{r v_{r}(r \sigma)\right\}_{r>1}$ is equi-Hölder continuous on $S^{n-1}$. Let $\left\{r_{i}\right\}_{i=1}^{\infty}$ be a sequence of positive numbers such that $r_{i} \rightarrow \infty$ as $i \rightarrow \infty$. Then $\left\{r_{i}\right\}_{i=1}^{\infty}$ has a subsequence which we may assume without loss of generality to be the sequence itself that converges uniformly on $S^{n-1}$ as $i \rightarrow \infty$. Then by the l'Hospital rule and Theorem 1.1,

$$
\lim _{i \rightarrow \infty} r_{i} v_{r_{i}}\left(r_{i} \sigma\right)=\lim _{i \rightarrow \infty} \frac{v\left(r_{i} \sigma\right)}{\log r_{i}}=-2 \quad \text { uniformly on } S^{n-1} \text { as } i \rightarrow \infty
$$

Since the sequnece $\left\{r_{i}\right\}_{i=1}^{\infty}$ is arbitrary, $r v_{r}(r \sigma) \rightarrow-2$ uniformly on $S^{n-1}$ as $r \rightarrow \infty$ and the proposition follows.

We will now prove Theorem 1.3.
Proof of Theorem 1.3. Since any rotation in $\mathbb{R}^{n}$ can be decomposed into a finite number of rotations in 2-dimensional planes, it suffices to prove that

$$
\Phi_{12} \equiv 0 \quad \text { in } \mathbb{R}^{n}
$$

By direct computation $\Phi_{12}$ satisfies

$$
\triangle q+\alpha e^{v} q+\beta(x \cdot \nabla v) e^{v} q+\beta(x \cdot \nabla q) e^{v}=0
$$

Let $w(x)=\Phi_{12}(x) / g(x)$ where $g(x)=|x|^{2-n}$. Then $w$ satisfies

$$
\Delta w+\left(\frac{2 \nabla g}{g}+\beta e^{v} x\right) \cdot \nabla w+\left(\alpha+\beta(x \cdot \nabla v)+\frac{\beta(x \cdot \nabla g)}{g}\right) e^{v} w=0 \quad \text { in } \mathbb{R}^{n} .
$$

If $\beta \leq 0$, then $\alpha<n \beta \leq 2 \beta$. Then by Corollary 1.2 (1.1) has no solution and contradiction arises. Hence $\beta>0$. We now choose $\varepsilon>0$ such that $\alpha-n \beta+\epsilon \beta<0$. By Proposition 3.2 there exists a constant $R_{0}>0$ such that

$$
x \cdot \nabla v<-2+\varepsilon \quad \forall|x| \geq R_{0} .
$$

Then

$$
\alpha+\beta(x \cdot \nabla v)+\frac{\beta(x \cdot \nabla g)}{g} \leq \alpha-n \beta+\varepsilon \beta<0 \quad \forall|x| \geq R_{0}
$$

Suppose $v$ is radially symmetric in $B_{R_{0}}$. Then $\Phi_{12} \equiv 0$ in $\overline{B_{R_{0}}}$. Hence

$$
w \equiv 0 \quad \text { in } \overline{B_{R_{0}}} .
$$

We next observe that by (1.10),

$$
|w| \leq|x|^{n-2}\left|\Phi_{12}(x)\right| \rightarrow 0 \quad \text { as }|x| \rightarrow \infty .
$$

Then by the maximum principle for $w$ in $R^{n} \backslash \overline{B_{R_{0}}}$,

$$
w \equiv 0 \quad \text { in } \mathbb{R}^{n} \backslash \overline{B_{R_{0}}}
$$

Hence

$$
\Phi_{12} \equiv 0 \quad \text { in } \mathbb{R}^{n}
$$

Thus $v$ is radially symmetric in $\mathbb{R}^{n}$.
