# On the metric dimension and fractional metric dimension for hierarchical product of graphs

#### Abstract

A set of vertices $W$ resolves a graph $G$ if every vertex of $G$ is uniquely determined by its vector of distances to the vertices in $W$. The metric dimension for $G$, denoted by $\operatorname{dim}(G)$, is the minimum cardinality of a resolving set of $G$. In order to study the metric dimension for the hierarchical product $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$ of two rooted graphs $G_{2}^{u_{2}}$ and $G_{1}^{u_{1}}$, we first introduce a new parameter, the rooted metric dimension $\operatorname{rdim}\left(G_{1}^{u_{1}}\right)$ for a rooted graph $G_{1}^{u_{1}}$. If $G_{1}$ is not a path with an end-vertex $u_{1}$, we show that $\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right)$, where $\left|V\left(G_{2}\right)\right|$ is the order of $G_{2}$. If $G_{1}$ is a path with an end-vertex $u_{1}$, we obtain some tight inequalities for $\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)$. Finally, we show that similar results hold for the fractional metric dimension.

## 1 Introduction

All graphs considered in this paper are nontrivial and connected. For a graph $G$, we often denote by $V(G)$ and $E(G)$ the vertex set and the edge set of $G$, respectively. For any two vertices $u$ and $v$ of $G$, denote by $d_{G}(u, v)$ the distance between $u$ and $v$ in $G$, and write $R_{G}\{u, v\}=\left\{w \mid w \in V(G), d_{G}(u, w) \neq d_{G}(v, w)\right\}$. If the graph $G$ is clear from the context, the notations $d_{G}(u, v)$ and $R_{G}\{u, v\}$ will be written $d(u, v)$ and $R\{u, v\}$, respectively. A subset $W$ of $V(G)$ is a resolving set of $G$ if $W \cap R\{u, v\} \neq \emptyset$ for any two distinct vertices $u$ and $v$. A metric basis of $G$ is a resolving set of $G$ with minimum cardinality. The cardinality of a metric basis of $G$ is the metric dimension for $G$, denoted by $\operatorname{dim}(G)$.

Metric dimension was introduced independently by Harary and Melter [15], and by Slater [24]. As a graph parameter it has numerous applications, among them are computer science and robotics [18], network discovery and verification [5], strategies

[^0]for the Mastermind game [8] and combinatorial optimization [23]. Metric dimension has been heavily studied, see [3] for a number of references on this topic.

The problem of finding the metric dimension for a graph was formulated as an integer programming problem independently by Chartrand et al. 7], and by Currie and Oellermann [10]. In graph theory, fractionalization of integer-valued graph theoretic concepts is an interesting area of research (see [22]). Currie and Oellermann [10] and Fehr et al. [11] defined fractional metric dimension as the optimal solution of the linear relaxation of the integer programming problem. Arumugam and Mathew [1 initiated the study of the fractional metric dimension for graphs. For more information, see [2, 12, 13].

Let $g: V(G) \longrightarrow[0,1]$ be a real value function. For $W \subseteq V(G)$, denote $g(W)=$ $\sum_{v \in W} g(v)$. The weight of $g$ is defined by $|g|=g(V(G))$. We call $g$ a resolving function of $G$ if $g(R\{u, v\}) \geq 1$ for any two distinct vertices $u$ and $v$. The minimum weight of a resolving function of $G$ is called the fractional metric dimension for $G$, denoted by $\operatorname{dim}_{f}(G)$.

It was noted in [14, p. 204] and [18] that determining the metric dimension for a graph is an NP-complete problem. So it is desirable to reduce the computation for the metric dimension for product graphs to the computation for some parameters of the factor graphs; see [6] for cartesian products, [16] for lexicographic products, and [25] for corona products. Recently, the fractional metric dimension for the above three products was studied in [2, 12, 13].

In order to model some real-life complex networks, Barrière et al. 44 introduced the hierarchical product of graphs and showed that it is associative. A rooted graph $G^{u}$ is the graph $G$ in which one vertex $u$, called root vertex, is labeled in a special way to distinguish it from other vertices. Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. The hierarchical product $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$ is the rooted graph with the vertex set $\left\{x_{2} x_{1} \mid\right.$ $\left.x_{i} \in V\left(G_{i}\right), i=1,2\right\}$, having the root vertex $u_{2} u_{1}$, where $x_{2} x_{1}$ is adjacent to $y_{2} y_{1}$ whenever $x_{2}=y_{2}$ and $\left\{x_{1}, y_{1}\right\} \in E\left(G_{1}\right)$, or $x_{1}=y_{1}=u_{1}$ and $\left\{x_{2}, y_{2}\right\} \in E\left(G_{2}\right)$. See [17, 19, 20, 21] for more information.

In this paper, we study the (fractional) metric dimension for the hierarchical product $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$ of rooted graphs $G_{2}^{u_{2}}$ and $G_{1}^{u_{1}}$. In Section 2, we introduce a new parameter, the rooted metric dimension $\operatorname{rdim}\left(G^{u}\right)$ for a rooted graph $G^{u}$. If $G_{1}$ is not a path with an end-vertex $u_{1}$, we show that $\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right|$. $\operatorname{rdim}\left(G_{1}^{u_{1}}\right)$. If $G_{1}$ is a path with an end-vertex $u_{1}$, we obtain some tight inequalities for $\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)$. In Section 3, we show that similar results hold for the fractional metric dimension.

## 2 Metric dimension

In order to study the metric dimension for the hierarchical product of graphs, we first introduce the rooted metric dimension for a rooted graph.

A rooted resolving set of a rooted graph $G^{u}$ is a subset $W$ of $V(G)$ such that $W \cup\{u\}$ is a resolving set of $G$. A rooted metric basis of $G^{u}$ is a rooted resolving set of $G^{u}$ with the minimum cardinality. The cardinality of a rooted metric basis of $G^{u}$ is called rooted metric dimension for $G^{u}$, denoted by $\operatorname{rdim}\left(G^{u}\right)$. The following
observation is obvious.
Observation 2.1 If there exists a metric basis of $G$ containing $u$, then $\operatorname{rdim}\left(G^{u}\right)=$ $\operatorname{dim}(G)-1$. If any metric basis of $G$ does not contain $u$, then $\operatorname{rdim}\left(G^{u}\right)=\operatorname{dim}(G)$.

For graphs $H_{1}$ and $H_{2}$ we use $H_{1} \cup H_{2}$ to denote the disjoint union of $H_{1}$ and $H_{2}$ and $H_{1}+H_{2}$ to denote the graph obtained from the disjoint union of $H_{1}$ and $H_{2}$ by joining every vertex of $H_{1}$ with every vertex of $H_{2}$.

Observation 2.2 Let $G$ be a graph of order $n$. Then $1 \leq \operatorname{dim}(G) \leq n-1$. Moreover,
(i) $\operatorname{dim}(G)=1$ if and only if $G$ is the path $P_{n}$ of length $n$.
(ii) $\operatorname{dim}(G)=n-1$ if and only if $G$ is the complete graph $K_{n}$ on $n$ vertices.

Proposition 2.3 [7, Theorem 4] Let $G$ be a graph of order $n \geq 4$. Then $\operatorname{dim}(G)=$ $n-2$ if and only if $G=K_{s, t}(\underline{s, t} \geq 1), G=K_{s}+\overline{K_{t}}(s \geq 1, t \geq 2)$, or $G=$ $K_{s}+\left(K_{1} \cup K_{t}\right)(s, t \geq 1)$, where $\overline{K_{t}}$ is a null graph and $K_{s, t}$ is a complete bipartite graph.

Proposition 2.4 Let $G^{u}$ be a rooted graph of order $n$. Then $0 \leq \operatorname{rdim}\left(G^{u}\right) \leq n-2$. Moreover,
(i) $\operatorname{rdim}\left(G^{u}\right)=0$ if and only if $G=P_{n}$ and $u$ is one of its end-vertices.
(ii) $\operatorname{rdim}\left(G^{u}\right)=n-2$ if and only if $G=K_{n}$, or $G=K_{1, n-1}$ and $u$ is the centre.

Proof. If $G$ is a complete graph, by Observation 2.2 (ii) we have $\operatorname{dim}(G)=n-1$. Observation 2.1 implies that $\operatorname{rdim}\left(G^{u}\right)=n-2$. If $G$ is not a complete graph, then $1 \leq \operatorname{dim}(G) \leq n-2$, which implies that $0 \leq \operatorname{rdim}\left(G^{u}\right) \leq n-2$ by Observation 2.1.
(i) Since $\operatorname{rdim}\left(G^{u}\right)=0$ if and only if $\{u\}$ is a metric basis of $G$, by Observation2.2 (i), (i) holds.
(ii) Suppose $\operatorname{rdim}\left(G^{u}\right)=n-2$. Then $\operatorname{dim}(G)=n-1$ or $n-2$. If $\operatorname{dim}(G)=n-1$, then $G=K_{n}$. Now we consider $\operatorname{dim}(G)=n-2$. If $n=3$, then $\operatorname{dim}(G)=1$, which implies that $G=K_{1,2}$ and $u$ is the centre. Now suppose $n \geq 4$. Then $G$ is one of graphs listed in Proposition [2.3. If $s, t \geq 2$ or $G=K_{s}+\left(K_{1} \cup K_{t}\right)$, then there exists a metric basis containing $u$, which implies that $\operatorname{rdim}\left(G^{u}\right)=n-3$, a contradiction. Hence $G=K_{1, n-1}$. Since any metric basis of $K_{1, n-1}$ does not contain the centre, the vertex $u$ is the centre of $K_{1, n-1}$. The converse is routine.

Next, we study the metric dimension for the hierarchical product of graphs.
Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. For any two vertices $x_{2} x_{1}$ and $y_{2} y_{1}$ of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$, observe that

$$
d\left(x_{2} x_{1}, y_{2} y_{1}\right)= \begin{cases}d_{G_{1}}\left(x_{1}, y_{1}\right), & \text { if } x_{2}=y_{2},  \tag{1}\\ d_{G_{2}}\left(x_{2}, y_{2}\right)+d_{G_{1}}\left(x_{1}, u_{1}\right)+d_{G_{1}}\left(y_{1}, u_{1}\right), & \text { if } x_{2} \neq y_{2}\end{cases}
$$

Lemma 2.5 Let $x_{2} x_{1}$ and $y_{2} y_{1}$ be two distinct vertices of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$.
(i) If $x_{2}=y_{2}$, then
$R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}= \begin{cases}\left\{x_{2} z \mid z \in R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right\}, & \text { if } u_{1} \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}, \\ V\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \backslash\left\{x_{2} z \mid z \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right\}, & \text { if } u_{1} \in R_{G_{1}}\left\{x_{1}, y_{1}\right\} .\end{cases}$
(ii) If $x_{2} \neq y_{2}$, then $\left\{x_{2} z, y_{2} z\right\} \cap R\left\{x_{2} x_{1}, y_{2} y_{1}\right\} \neq \emptyset$ for any $z \in V\left(G_{1}\right)$.

Proof. (i) If $u_{1} \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, then $d_{G_{1}}\left(x_{1}, u_{1}\right)=d_{G_{1}}\left(y_{1}, u_{1}\right)$. By (11), the inequality $d\left(x_{2} x_{1}, z_{2} z_{1}\right) \neq d\left(y_{2} y_{1}, z_{2} z_{1}\right)$ holds if and only if $z_{2}=x_{2}$ and $d_{G_{1}}\left(x_{1}, z_{1}\right) \neq$ $d_{G_{1}}\left(y_{1}, z_{1}\right)$. It follows that $R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}=\left\{x_{2} z \mid z \in R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right\}$. If $u_{1} \in$ $R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, then $d_{G_{1}}\left(x_{1}, u_{1}\right) \neq d_{G_{1}}\left(y_{1}, u_{1}\right)$. By (1), the equality $d\left(x_{2} x_{1}, z_{2} z_{1}\right)=$ $d\left(y_{2} y_{1}, z_{2} z_{1}\right)$ holds if and only if $z_{2}=x_{2}$ and $d_{G_{1}}\left(x_{1}, z_{1}\right)=d_{G_{1}}\left(y_{1}, z_{1}\right)$. It follows that $R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}=V\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \backslash\left\{x_{2} z \mid z \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right\}$.
(ii) Suppose $x_{2} z \notin R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}$. Then $d\left(x_{2} x_{1}, x_{2} z\right)=d\left(y_{2} y_{1}, x_{2} z\right)$. By (11),

$$
d_{G_{1}}\left(x_{1}, z\right)=d_{G_{2}}\left(y_{2}, x_{2}\right)+d_{G_{1}}\left(y_{1}, u_{1}\right)+d_{G_{1}}\left(z, u_{1}\right) \geq d_{G_{2}}\left(x_{2}, y_{2}\right)+d_{G_{1}}\left(y_{1}, z\right),
$$

which implies that

$$
d_{G_{2}}\left(x_{2}, y_{2}\right)+d_{G_{1}}\left(x_{1}, u_{1}\right)+d_{G_{1}}\left(z, u_{1}\right) \geq 2 d_{G_{2}}\left(x_{2}, y_{2}\right)+d_{G_{1}}\left(y_{1}, z\right)>d\left(y_{2} y_{1}, y_{2} z\right) .
$$

Hence, $y_{2} z \in R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}$, as desired.
Lemma 2.6 Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. Then

$$
\operatorname{rdim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \geq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right)
$$

Proof. Let $\bar{W}$ be a rooted metric basis of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$. For $v \in V\left(G_{2}\right)$, write $\bar{W}_{v}=$ $\{z \mid v z \in \bar{W}\}$. For any two distinct vertices $x, y$ of $G_{1}$, there exists a vertex $w z$ in $\bar{W} \cup\left\{u_{2} u_{1}\right\}$ such that $d(v x, w z) \neq d(v y, w z)$. If $w=v$, by (11) we get $d_{G_{1}}(x, z) \neq$ $d_{G_{1}}(y, z)$, which implies that $z \in\left(\bar{W}_{v} \cup\left\{u_{1}\right\}\right) \cap R_{G_{1}}\{x, y\}$. If $w \neq v$, by (1) we have $d_{G_{1}}\left(x, u_{1}\right) \neq d_{G_{1}}\left(y, u_{1}\right)$, which implies that $u_{1} \in R_{G_{1}}\{x, y\}$. Therefore, we have $\left(\bar{W}_{v} \cup\left\{u_{1}\right\}\right) \cap R_{G_{1}}\{x, y\} \neq \emptyset$, which implies that $\bar{W}_{v}$ is a rooted resolving set of $G_{1}^{u_{1}}$. Hence

$$
\operatorname{rdim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=|\bar{W}|=\sum_{v \in V\left(G_{2}\right)}\left|\bar{W}_{v}\right| \geq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right)
$$

as desired.

Theorem 2.7 Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. If $G_{1}$ is not a path with an end-vertex $u_{1}$, then

$$
\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right)
$$

Proof. By Lemma 2.6, we only need to prove that

$$
\begin{equation*}
\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \leq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right) \tag{2}
\end{equation*}
$$

Let $W$ be a rooted metric basis of $G_{1}^{u_{1}}$. Then $W \neq \emptyset$. Write $\bar{W}=\{v w \mid v \in$ $\left.V\left(G_{2}\right), w \in W\right\}$. Note that $|\bar{W}|=\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}\left(G_{1}^{u_{1}}\right)$. In order to prove (2), we only need to show that $\bar{W}$ is a resolving set of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$. It suffices to show that, for any two distinct vertices $x_{2} x_{1}$ and $y_{2} y_{1}$ of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$,

$$
\begin{equation*}
\bar{W} \cap R\left\{x_{2} x_{1}, y_{2} y_{1}\right\} \neq \emptyset . \tag{3}
\end{equation*}
$$

If $x_{2}=y_{2}$ and $u_{1} \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, then $W \cap R_{G_{1}}\left\{x_{1}, y_{1}\right\} \neq \emptyset$, by Lemma 2.5 (i) we obtain (3). If $x_{2}=y_{2}$ and $u_{1} \in R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, by (1) we have $v w \in \bar{W} \cap R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}$ for any $v \neq x_{2}$ and any $w \in W$, which implies that (3) holds. If $x_{2} \neq y_{2}$, then (3) holds by Lemma 2.5 (ii). We accomplish our proof.

Combining Observation 2.1 and Theorem [2.7, we have the following result.
Corollary 2.8 Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs.
(i) If there exists a metric basis of $G_{1}$ containing $u_{1}$ and $G_{1}$ is not a path, then

$$
\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right|\left(\operatorname{dim}\left(G_{1}\right)-1\right)
$$

(ii) If any metric basis of $G_{1}$ does not contain $u_{1}$, then

$$
\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right| \operatorname{dim}\left(G_{1}\right)
$$

The binomial tree $T_{n}$ is the hierarchical product of $n$ copies of the complete graph on two vertices, which is a useful data structure in the context of algorithm analysis and designs [9]. It was proved that the metric dimension for a tree can be expressed in terms of its parameters in [7, [15, [24].

Corollary 2.9 Let $n \geq 2$. Then $\operatorname{dim}\left(T_{n}\right)=2^{n-2}$.
Proof. Note that $\operatorname{dim}\left(T_{2}\right)=1$. Now suppose $n \geq 3$. Since $T_{n}=\left(K_{2}^{0} \sqcap \cdots \sqcap K_{2}^{0}\right) \sqcap$ ( $K_{2}^{0} \sqcap K_{2}^{0}$ ) and $\operatorname{rdim}\left(K_{2}^{0} \sqcap K_{2}^{0}\right)=1$, the desired result follows by Theorem 2.7.

We always assume that 0 is one end-vertex of $P_{n}$. In the remaining of this section, we shall prove some tight inequalities for $\operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right)$.

Proposition 2.10 Let $G^{u}$ be a rooted graph with diameter d. Then

$$
\begin{align*}
\operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right) & \leq \operatorname{dim}\left(G^{u} \sqcap P_{n+1}^{0}\right) \text { for } 1 \leq n \leq d-1,  \tag{4}\\
\operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right) & =\operatorname{dim}\left(G^{u} \sqcap P_{n+1}^{0}\right) \text { for } n \geq d . \tag{5}
\end{align*}
$$

Proof. If $G=K_{2}$, then $G^{u} \sqcap P_{n}^{0}$ is the path, which implies that (5) holds. Now we only consider $|V(G)| \geq 3$. Suppose that $\bar{W}_{n}$ is a metric basis of $G^{u} \sqcap P_{n}^{0}$. Let $P_{n}=\left(z_{0}=0, z_{1}, \ldots, z_{n-1}\right)$. Define $\pi_{n}: V\left(G^{u} \sqcap P_{n+1}^{0}\right) \longrightarrow V\left(G^{u} \sqcap P_{n}^{0}\right)$ by

$$
\pi_{n}\left(v z_{i}\right)= \begin{cases}v z_{n-1}, & \text { if } i=n, \\ v z_{i}, & \text { if } i \leq n-1 .\end{cases}
$$

Then $\pi_{n}\left(\bar{W}_{n+1}\right)$ is a resolving set of $G^{u} \sqcap P_{n}^{0}$, which implies that $\operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right) \leq$ $\operatorname{dim}\left(G^{u} \sqcap P_{n+1}^{0}\right)$ for any positive integer $n$. So (4) holds.

In order to prove (5), we only need to show that $\bar{W}_{n}$ is a resolving set of $G^{u} \sqcap P_{n+1}^{0}$ for $n \geq d$. Pick any two distinct vertices $v_{1} z_{i}$ and $v_{2} z_{j}$ of $G^{u} \sqcap P_{n+1}^{0}$. It suffices to prove that

$$
\begin{equation*}
\bar{W}_{n} \cap R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{i}, v_{2} z_{j}\right\} \neq \emptyset . \tag{6}
\end{equation*}
$$

We claim that there exist two distinct vertices $w_{1}$ and $w_{2}$ of $G$ such that $\bar{W}_{n} \cap$ $\left\{w_{s} z_{k} \mid 0 \leq k \leq n-1\right\} \neq \emptyset$ for $s \in\{1,2\}$. Suppose for the contradiction that there
exists a vertex $w \in V(G)$ such that $\bar{W}_{n} \subseteq\left\{w z_{k} \mid 0 \leq k \leq n-1\right\}$. If the degree of $w$ in $G$ is one, then there exists a path $(w, x, y)$ in $G$. For any $w z_{k} \in \bar{W}_{n}$, we have $d\left(x z_{1}, w z_{k}\right)=k+2=d\left(y z_{0}, w z_{k}\right)$, contrary to the fact that $\bar{W}_{n}$ is a metric basis of $G^{u} \sqcap P_{n}^{0}$. If the degree of $w$ in $G$ is at least two, pick two distinct neighbors $x$ and $y$ of $w$ in $G$. Then $d\left(x z_{0}, w z_{k}\right)=k+1=d\left(y z_{0}, w z_{k}\right)$ for any $w z_{k} \in \bar{W}_{n}$, a contradiction. Hence our claim is valid.

Now we prove (6). Without loss of generality, we may assume that $0 \leq i \leq j \leq n$. If $j \leq n-1$, then $R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{i}, v_{2} z_{j}\right\} \supseteq R_{G^{u} \cap P_{n}^{0}}\left\{v_{1} z_{i}, v_{2} z_{j}\right\}$; and so (6) holds. Now suppose $j=n$.

Case 1. $v_{1}=v_{2}$. By the claim, the set $\left\{w_{1} z_{k} \mid 0 \leq k \leq n-1\right\}$ or $\left\{w_{2} z_{k} \mid 0 \leq\right.$ $k \leq n-1\}$ is a subset of $R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{i}, v_{1} z_{n}\right\}$. So (6) holds.

Case 2. $v_{1} \neq v_{2}$.
Case 2.1. $i=0$. By the claim, we can choose $w_{s} z_{k} \in \bar{W}_{n}$ with $w_{s} \neq v_{2}$. Then
$d\left(v_{1} z_{0}, w_{s} z_{k}\right)=d_{G}\left(v_{1}, w_{s}\right)+k \leq d+k \leq n+k<d_{G}\left(v_{2}, w_{s}\right)+n+k=d\left(v_{2} z_{n}, w_{s} z_{k}\right)$,
which implies that $w_{s} z_{k} \in R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{0}, v_{2} z_{n}\right\}$. So (6) holds.
Case 2.2. $i \geq 1$. Note that

$$
R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{i}, v_{2} z_{n}\right\}=R_{G^{u} \sqcap P_{n+1}^{0}}\left\{v_{1} z_{i-1}, v_{2} z_{n-1}\right\} \supseteq R_{G^{u} \sqcap P_{n}^{0}}\left\{v_{1} z_{i-1}, v_{2} z_{n-1}\right\} .
$$

Then (6) holds.

Proposition 2.11 For any rooted graph $G^{u}$, we have

$$
\begin{equation*}
\operatorname{dim}(G) \leq \operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right) \leq|V(G)|-1 \tag{7}
\end{equation*}
$$

Proof. Let $z$ be the other end-vertex of $P_{n}$. Fix a vertex $v_{0} \in V(G)$ and write $\bar{S}=\left\{v z \mid v \in V(G) \backslash\left\{v_{0}\right\}\right\}$. Since $\{z\}$ is a resolving set of $P_{n}$, the set $\bar{S}$ resolves $G \sqcap P_{n}$ by (11). Hence $\operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right) \leq|\bar{S}|=|V(G)|-1$. Since $G^{u}$ is isomorphic to $G^{u} \sqcap P_{1}^{0}$, Proposition 2.10 implies that $\operatorname{dim}(G) \leq \operatorname{dim}\left(G^{u} \sqcap P_{n}^{0}\right)$.

For $m \geq 2$, we have $\operatorname{dim}\left(K_{m}^{u} \sqcap P_{n}^{0}\right)=m-1$. This shows that the inequalities (4) and (77) are tight.

Example 2.12 For $m, n \geq 2$, we have $\operatorname{dim}\left(P_{m}^{u} \sqcap P_{n}^{0}\right)=2$.
Proof. Write $P_{k}=\left(z_{0}=0, z_{1}, \ldots, z_{k-1}\right)$. Then $\left\{z_{0} z_{n-1}, z_{m-1} z_{n-1}\right\}$ is a resolving set of $P_{m}^{u} \sqcap P_{n}^{0}$.

Example 2.13 Let $C_{m}$ be the cycle with length $m$. Then $\operatorname{dim}\left(C_{m}^{u} \sqcap P_{n}^{0}\right)=2$.
Proof. Let $P_{n}=\left(z_{0}=0, z_{1}, \ldots, z_{n-1}\right)$ and $C_{m}=\left(c_{0}, c_{1}, \ldots, c_{m-1}, c_{0}\right)$. Then $\left\{c_{0} z_{n-1}, c_{1} z_{n-1}\right\}$ is a resolving set of $C_{m}^{u} \sqcap P_{n}^{0}$.

## 3 Fractional metric dimension

In order to study the fractional metric dimension for the hierarchical product of graphs, we first introduce the fractional rooted metric dimension for a rooted graph.

Similar to the fractionalization of metric dimension, we give a fractional version of the rooted metric dimension for a rooted graph. Let $G^{u}$ be a rooted graph of order $n$. Write

$$
\mathcal{P}^{u}=\{\{v, w\} \mid v, w \in V(G), v \neq w, d(v, u)=d(w, u)\} .
$$

Suppose $\mathcal{P}^{u} \neq \emptyset$. Write $V(G) \backslash\{u\}=\left\{v_{1}, \ldots, v_{n-1}\right\}$ and $\mathcal{P}^{u}=\left\{\alpha_{1}, \ldots, \alpha_{m}\right\}$. Let $A^{u}$ be the $m \times(n-1)$ matrix with

$$
\left(A^{u}\right)_{i j}= \begin{cases}1, & \text { if } v_{j} \text { resolves } \alpha_{i}, \\ 0, & \text { otherwise }\end{cases}
$$

The integer programming formulation of the rooted metric dimension for $G^{u}$ is given by

$$
\text { Minimize } f\left(x_{1}, \ldots, x_{n-1}\right)=x_{1}+\cdots+x_{n-1}
$$

Subject to $A^{u} \mathbf{x} \geq \mathbf{1}$
where $\mathbf{x}=\left(x_{1}, \ldots, x_{n-1}\right)^{\mathrm{T}}, x_{i} \in\{0,1\}$ and $\mathbf{1}$ is the $m \times 1$ column vector all of whose entries are 1 . The optimal solution of the linear programming relaxation of the above integer programming problem, where we replace $x_{i} \in\{0,1\}$ by $x_{i} \in[0,1]$, gives the fractional rooted metric dimension for $G^{u}$, which we denote by $\operatorname{rdim}_{f}\left(G^{u}\right)$.

Let $G^{u}$ be a rooted graph which is not a path with an end-vertex $u$. A rooted resolving function of a rooted graph $G^{u}$ is a real value function $g: V(G) \longrightarrow[0,1]$ such that $g(R\{v, w\}) \geq 1$ for each $\{v, w\} \in \mathcal{P}^{u}$. The fractional rooted metric dimension for $G^{u}$ is the minimum weight of a rooted resolving function of $G^{u}$.

Proposition 3.1 Let $G^{u}$ be a rooted graph which is not a path with an end-vertex $u$. Then
(i) $\operatorname{rdim}_{f}\left(G^{u}\right) \leq \operatorname{rdim}\left(G^{u}\right)$.
(ii) $\operatorname{rdim}_{f}\left(G^{u}\right) \leq \frac{|V(G)|-1}{2}$.
(iii) $\operatorname{dim}_{f}(G)-1 \leq \operatorname{rdim}_{f}\left(G^{u}\right) \leq \operatorname{dim}_{f}(G)$.

Proof. (i) Let $W$ be a rooted metric basis of $G^{u}$. Define $g: V(G) \longrightarrow[0,1]$ by

$$
g(v)= \begin{cases}1, & \text { if } v \in W, \\ 0, & \text { if } v \notin W .\end{cases}
$$

For any $\{x, y\} \in \mathcal{P}^{u}$, there exists a vertex $v \in W$ such that $d(x, v) \neq d(y, v)$. Then $g(R\{x, y\}) \geq g(v)=1$, which implies that $g$ is a rooted resolving function of $G^{u}$. Hence $\operatorname{rdim}_{f}\left(G^{u}\right) \leq|g|=|W|=\operatorname{rdim}\left(G^{u}\right)$.
(ii) The function $g: V(G) \longrightarrow[0,1]$ defined by

$$
g(v)= \begin{cases}0, & \text { if } v=u \\ \frac{1}{2}, & \text { if } v \neq u\end{cases}
$$

is a rooted resolving function of $G^{u}$. Hence $\operatorname{rdim}_{f}\left(G^{u}\right) \leq \frac{|V(G)|-1}{2}$.
(iii) It is clear that $\operatorname{rim}_{f}\left(G^{u}\right) \leq \operatorname{dim}_{f}(G)$. Let $g$ be a rooted resolving function of $G^{u}$. Then the function $h: V(G) \longrightarrow[0,1]$ defined by

$$
h(v)= \begin{cases}1, & \text { if } v=u \\ g(v), & \text { if } v \neq u\end{cases}
$$

is a resolving function of $G$. Hence $\operatorname{dim}_{f}(G) \leq \operatorname{rdim}_{f}\left(G^{u}\right)+1$, as desired.
If $u$ is not an end-vertex of the path $P_{n}$, then $\operatorname{rdim}_{f}\left(P_{n}^{u}\right)=\operatorname{rdim}\left(P_{n}^{u}\right)=\operatorname{dim}_{f}\left(P_{n}\right)=$ 1, which implies that the upper bounds in Proposition 3.1(i) and (iii) are tight. The fact that $\operatorname{rdim}_{f}\left(K_{n}^{u}\right)=\frac{n-1}{2}$ shows that the inequality in Proposition 3.1(ii) is tight.

Next, we study the fractional metric dimension for the hierarchical product of graphs.

For two rooted graphs $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$, write

$$
\begin{gathered}
\mathcal{P}^{u_{1}}=\left\{\{x, y\} \subseteq V\left(G_{1}\right) \mid x \neq y, d_{G_{1}}\left(x, u_{1}\right)=d_{G_{1}}\left(y, u_{1}\right)\right\}, \\
\overline{\mathcal{P}}^{u_{2} u_{1}}=\left\{\left\{x_{2} x_{1}, y_{2} y_{1}\right\} \subseteq V\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \mid x_{2} x_{1} \neq y_{2} y_{1}, d\left(x_{2} x_{1}, u_{2} u_{1}\right)=d\left(y_{2} y_{1}, u_{2} u_{1}\right)\right\} .
\end{gathered}
$$

Lemma 3.2 Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. If $G_{1}$ is not a path with an end-vertex $u_{1}$, then

$$
\operatorname{rdim}_{f}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \geq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)
$$

Proof. Suppose that $\bar{g}$ is a rooted resolving function of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$ with weight $\operatorname{rdim}_{f}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)$. For each $z \in V\left(G_{2}\right)$, define

$$
\bar{g}_{z}: V\left(G_{1}\right) \longrightarrow[0,1], \quad x \longmapsto \bar{g}(z x)
$$

Write $\overline{\mathcal{P}}^{u_{1}}=\left\{\{z x, z y\} \mid z \in V\left(G_{2}\right),\{x, y\} \in \mathcal{P}^{u_{1}}\right\}$. By (11), we have $\overline{\mathcal{P}}^{u_{1}} \subseteq \overline{\mathcal{P}}^{u_{2} u_{1}}$. Hence $\bar{g}_{z}\left(R_{G_{1}}\{x, y\}\right) \geq 1$ for any $\{x, y\} \in \mathcal{P}^{u_{1}}$, which implies that $\left|\bar{g}_{z}\right| \geq \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)$. Consequently,

$$
\operatorname{rdim}_{f}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=|\bar{g}|=\sum_{z \in V\left(G_{2}\right)}\left|\bar{g}_{z}\right| \geq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)
$$

as desired.

Theorem 3.3 Let $G_{1}^{u_{1}}$ and $G_{2}^{u_{2}}$ be two rooted graphs. If $G_{1}$ is not a path with an end-vertex $u_{1}$, then

$$
\operatorname{dim}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right)=\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)
$$

Proof. Combining Proposition 3.1] and Lemma 3.2, we only need to prove that

$$
\begin{equation*}
\operatorname{dim}_{f}\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \leq\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right) \tag{8}
\end{equation*}
$$

By Proposition 2.4 we have $\mathcal{P}^{u_{1}} \neq \emptyset$. Let $g$ be a rooted resolving function of $G_{1}$ with weight $\operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)$. Define

$$
\bar{g}: V\left(G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}\right) \longrightarrow[0,1], \quad x_{2} x_{1} \longmapsto g\left(x_{1}\right) .
$$

We shall show that, for any two distinct vertices $x_{2} x_{1}$ and $y_{2} y_{1}$ of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$,

$$
\begin{equation*}
\bar{g}\left(R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right) \geq 1 . \tag{9}
\end{equation*}
$$

Case 1. $x_{2}=y_{2}$. If $u_{1} \notin R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, by Lemma [2.5 we get $R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}=$ $\left\{x_{2} z \mid z \in R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right\}$, which implies that $\bar{g}\left(R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right)=g\left(R_{G_{1}}\left\{x_{1}, y_{1}\right\}\right)$. Since $\left\{x_{1}, y_{1}\right\} \in \mathcal{P}^{u_{1}}$, we obtain (9). If $u_{1} \in R_{G_{1}}\left\{x_{1}, y_{1}\right\}$, by Lemma [2.5 we have $R\left\{x_{2} x_{1}, y_{2} y_{1}\right\} \supseteq\left\{v z \mid z \in V\left(G_{1}\right)\right\}$ for any $v \in V\left(G_{2}\right) \backslash\left\{x_{2}\right\}$, which implies that $\bar{g}\left(R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right) \geq|g|$, so (9) holds.

Case 2. $x_{2} \neq y_{2}$. Write $W=\left\{z \mid x_{2} z \in R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right\}$ and $S=\left\{z \mid y_{2} z \in\right.$ $\left.R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right\}$. By Lemma 2.5 we have $W \cup S=V\left(G_{1}\right)$. Then

$$
\bar{g}\left(R\left\{x_{2} x_{1}, y_{2} y_{1}\right\}\right) \geq \sum_{z \in W} \bar{g}\left(x_{2} z\right)+\sum_{z \in S}=g(W)+g(S) \bar{g}\left(y_{2} z\right) \geq|g|,
$$

which implies that (9) holds.
Therefore, $\bar{g}$ is a resolving function of $G_{2}^{u_{2}} \sqcap G_{1}^{u_{1}}$, which implies that $\operatorname{dim}_{f}\left(G_{2}^{u_{2}} \sqcap\right.$ $\left.G_{1}^{u_{1}}\right) \leq|\bar{g}|$. Since $|\bar{g}|=\left|V\left(G_{2}\right)\right| \cdot \operatorname{rdim}_{f}\left(G_{1}^{u_{1}}\right)$, we obtain (8). Our proof is accomplished.

Corollary 3.4 Let $n \geq 2$. Then $\operatorname{dim}_{f}\left(T_{n}\right)=2^{n-2}$.
Proof. It is immediate from Theorem 3.3,
By Corollaries 2.9 and 3.4, the binomial tree $T_{n}$ is a graph whose metric dimension is equal to its fractional metric dimension.

Finally, we shall prove some tight inequalities for $\operatorname{dim}_{f}\left(G^{u} \sqcap P_{n}^{0}\right)$.
Proposition 3.5 For any rooted graph $G^{u}$, we have

$$
\operatorname{dim}_{f}(G) \leq \operatorname{dim}_{f}\left(G^{u} \sqcap P_{n}^{0}\right) \leq \operatorname{dim}_{f}\left(G^{u} \sqcap P_{n+1}^{0}\right) \leq \frac{|V(G)|}{2}
$$

Proof. Write $P_{n}=\left(z_{0}=0, z_{1}, \ldots, z_{n-1}\right)$. For a resolving function $\bar{g}_{n+1}$ of $G^{u} \sqcap$ $P_{n+1}^{0}$, we define $\bar{g}_{n+1}^{\prime}: V\left(G^{u} \sqcap P_{n}^{0}\right) \longrightarrow[0,1]$ by

$$
\bar{g}_{n+1}^{\prime}\left(x_{2} x_{1}\right)= \begin{cases}\bar{g}_{n+1}\left(x_{2} z_{n-1}\right)+\bar{g}_{n+1}\left(x_{2} z_{n}\right), & \text { if } x_{1}=z_{n-1}, \\ \bar{g}_{n+1}\left(x_{2} x_{1}\right), & \text { if } x_{1} \neq z_{n-1} .\end{cases}
$$

Then $\bar{g}_{n+1}^{\prime}$ is a resolving function of $G^{u} \sqcap P_{n}^{0}$. Since $\left|\bar{g}_{n+1}^{\prime}\right|=\left|\bar{g}_{n+1}\right|$, we have

$$
\operatorname{dim}_{f}(G)=\operatorname{dim}_{f}\left(G^{u} \sqcap P_{1}^{0}\right) \leq \operatorname{dim}_{f}\left(G^{u} \sqcap P_{n}^{0}\right) \leq \operatorname{dim}_{f}\left(G^{u} \sqcap P_{n+1}^{0}\right)
$$

Define $\bar{h}: V\left(G^{u} \sqcap P_{n+1}^{0}\right) \longrightarrow[0,1]$ by

$$
\bar{h}\left(x_{2} x_{1}\right)= \begin{cases}\frac{1}{2}, & \text { if } x_{1}=z_{n}, \\ 0, & \text { if } x_{1} \neq z_{n} .\end{cases}
$$

Then $\bar{h}$ is a resolving function of $G^{u} \sqcap P_{n+1}^{0}$ with weight $\frac{|V(G)|}{2}$. Hence $\operatorname{dim}_{f}\left(G^{u} \sqcap\right.$ $\left.P_{n+1}^{0}\right) \leq \frac{|V(G)|}{2}$.

For $m \geq 2$, we have $\operatorname{dim}_{f}\left(K_{m}^{u} \sqcap P_{n}^{0}\right)=\frac{m}{2}$. This shows that all the inequalities in Proposition 3.5 are tight.
