# A REMARK ON GLOBAL REGULARITY OF 2D GENERALIZED MAGNETOHYDRODYNAMIC EQUATIONS

ABSTRACT. In this paper we study the global regularity of the following 2D (two-dimensional) generalized magnetohydrodynamic equations

$$\begin{cases} u_t + u \cdot \nabla u &= -\nabla p + b \cdot \nabla b - \nu (-\triangle)^{\alpha} u \\ b_t + u \cdot \nabla b &= b \cdot \nabla u - \kappa (-\triangle)^{\beta} b \end{cases}$$

and get global regular solutions when  $0 \le \alpha < 1/2$ ,  $\beta \ge 1$ ,  $3\alpha + 2\beta > 3$ , which improves the results in [5]. In particular, we obtain the global regularity of the 2D generalized MHD when  $\alpha = 0$  and  $\beta > \frac{3}{2}$ .

**Keywords:** Generalized Magnetohydrodynamic equations, Global regularity

#### 1. Introduction

Consider the Cauchy problem of the 2D (two-dimensional) generalized magnetohydrodynamic equations:

$$\begin{cases}
 u_t + u \cdot \nabla u = -\nabla p + b \cdot \nabla b - \nu (-\Delta)^{\alpha} u, \\
 b_t + u \cdot \nabla b = b \cdot \nabla u - \kappa (-\Delta)^{\beta} b, \\
 \nabla \cdot u = \nabla \cdot b = 0, \\
 u(x,0) = u_0(x), \quad b(x,0) = b_0(x)
\end{cases} \tag{1}$$

for  $x \in \mathbb{R}^2$  and t > 0, where u = u(x,t) is the velocity field, b = b(x,t) is the magnetic field, p = p(x,t) is the pressure, and  $u_0(x)$ ,  $b_0(x)$  with  $\operatorname{div} u_0(x) = \operatorname{div} b_0(x) = 0$  are the initial velocity and magnetic field, respectively. Here  $\nu, \kappa, \alpha, \beta \geq 0$  are nonnegative constants and  $(-\Delta)^{1/2}$  is defined through the Fourier transform by

$$((-\triangle)^{1/2}f)^{\wedge}(\xi) = |\xi| \,\widehat{f}(\xi),$$

where  $\wedge$  denotes the Fourier transform. Later, we will use the inverse Fourier transform  $\vee$ . As usual, we write  $(-\triangle)^{1/2}$  as  $\Lambda$ . To simplify the presentation, we will assume  $\nu = \kappa = 1$  when  $\alpha > 0$  and  $\nu = 0$ ,  $\kappa = 1$  when  $\alpha = 0$ .

There have been extensive studies on the global regularity of solutions to (1) (see e.g. [6][7][5] and references therein). It follows from [7] that the problem (1) has a unique global regular solution if

$$\alpha \geqslant 1, \quad \beta > 0, \quad \alpha + \beta \geqslant 2.$$

Recently, Tran, Yu and Zhai [5] proved that if

$$\alpha \geqslant 1/2, \ \beta \geqslant 1$$
 or  $0 \leqslant \alpha < 1/2, \ 2\alpha + \beta > 2$  or  $\alpha \geqslant 2, \ \beta = 0$ 

then the solution is global regular.

In this paper, we will prove the global regularity to (1) when  $0 \le \alpha < 1/2$ ,  $\beta \ge 1$ ,  $3\alpha + 2\beta > 3$ . Denote the vorticity by  $\omega = -\partial_2 u_1 + \partial_1 u_2$  and the current by  $j = -\partial_2 b_1 + \partial_1 b_2$ . We will prove that  $\omega, j \in L^2(0, T; L^{\infty})$  and hence obtain the global regularity of the solution due to BKM type criterion (see [1]). To this end, based on the estimates of  $\omega, j$  in  $L^{\infty}(0, T; L^2)$  in [5], we will prove a new estimate on  $\Lambda^r j$  for some r > 0 in this paper (see Lemma 2). Our result improves ones in [5] and in particular, if  $\alpha = 0$ ,  $\beta > \frac{3}{2}$ , the problem (1) has a global regular solution.

Our main result is stated as

**Theorem 1.** Suppose that  $(u_0, b_0) \in H^k$  with  $k > \max\{2, \alpha + \beta\}$ . If

$$0 \leqslant \alpha < 1/2, \ \beta \geqslant 1, \ 3\alpha + 2\beta > 3,$$

then the Cauchy problem has a unique global regular solution.

**Remark 1.** When  $\alpha + \beta > 2$ , k > 2, the global regularity has been proved in [5].

**Remark 2.** For the 2D MHD equations, it remains open to prove the global regularity when  $\alpha = 0$ ,  $\beta = 1$  or  $\beta = 0$ ,  $\alpha = 1$ .

### 2. A Priori estimates

In this section, we will give a priori estimates for  $\omega$  and j. For convenience, we use the same notation as in [5]. Let  $\omega$  and j denote the vorticity and the current respectively, where  $\omega = \nabla^{\perp} \cdot u = -\partial_2 u_1 + \partial_1 u_2$  and  $j = \nabla^{\perp} \cdot b = -\partial_2 b_1 + \partial_1 b_2$ . Applying  $\nabla^{\perp}$  to the equations (1), we obtain the following equations for  $\omega$  and j:

$$\omega_t + u \cdot \nabla \omega = b \cdot \nabla j - \Lambda^{2\alpha} \omega, \tag{2}$$

$$j_t + u \cdot \nabla j = b \cdot \nabla \omega + T(\nabla u, \nabla b) - \Lambda^{2\beta} j, \tag{3}$$

where

$$T(\nabla u, \nabla b) = 2\partial_1 b_1 (\partial_1 u_2 + \partial_2 u_1) + 2\partial_2 u_2 (\partial_1 b_2 + \partial_2 b_1).$$

The  $L^{\infty}(0,T;L^2(\mathbb{R}^2))$  estimates for  $\omega,j$  are obtained in [5], which is

**Lemma 1.** ([5]) Suppose that  $\alpha \ge 0$   $\beta \ge 1$ . Let  $u_0, b_0 \in H^1$ . For any T > 0, we have

$$\|\omega\|_{L^{2}}^{2}(t) + \|j\|_{L^{2}}^{2}(t) + \int_{0}^{t} \left( \|\Lambda^{\alpha}\omega\|_{L^{2}}^{2} + \|\Lambda^{\beta}j\|_{L^{2}}^{2} \right) d\tau \leqslant C(T).$$
 (4)

The following is a key lemma of this paper which will be used later.

**Lemma 2.** Suppose that  $0 \le \alpha < \frac{1}{2}, \beta \ge 1, r = \alpha + \beta - 1 > 0$  and  $k \ge \alpha + \beta$ . Let  $u_0, b_0 \in H^k$ . Then for any T > 0, we have

$$\|\Lambda^{r} j\|_{L^{2}}^{2}(t) + \int_{0}^{t} \|\Lambda^{\beta+r} j\|_{L^{2}}^{2} d\tau \leqslant C(u_{0}, b_{0}, T).$$

$$(5)$$

*Proof.* Applying  $\Lambda^r$  on both sides of the equation (3), we obtain

$$(\Lambda^r j)_t + \Lambda^r (u \cdot \nabla j) = \Lambda^r (b \cdot \nabla \omega) + \Lambda^r (T (\nabla u, \nabla b)) - \Lambda^{2\beta + r} j.$$
 (6)

Multiplying (6) by  $\Lambda^r j$  and integrating with respect to x in  $\mathbb{R}^2$ , we obtain

$$\frac{1}{2} \frac{\mathrm{d}}{\mathrm{d}t} \|\Lambda^{r} j\|_{L^{2}}^{2} + \|\Lambda^{\beta+r} j\|_{L^{2}}^{2} = -\int_{\mathbb{R}^{2}} \Lambda^{r} (u \cdot \nabla j) \Lambda^{r} j \mathrm{d}x + \int_{\mathbb{R}^{2}} \Lambda^{r} (b \cdot \nabla \omega) \Lambda^{r} j \mathrm{d}x 
+ \int_{\mathbb{R}^{2}} \Lambda^{r} T (\nabla u, \nabla b) \Lambda^{r} j \mathrm{d}x 
\equiv I_{1} + I_{2} + I_{3}.$$
(7)

 $I_1$  is estimated as follows:

$$\begin{split} |I_{1}| &= \left| \int_{\mathbb{R}^{2}} \Lambda^{r} \left( u \cdot \nabla j \right) \Lambda^{r} j \mathrm{d}x \right| \\ &= \left| \int_{\mathbb{R}^{2}} \Lambda^{-1} \nabla \cdot \Lambda^{\alpha} \left( uj \right) \Lambda^{\beta+r} j \mathrm{d}x \right| \\ &\leqslant \left\| \Lambda^{-1} \nabla \cdot \Lambda^{\alpha} \left( uj \right) \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left\| \Lambda^{\alpha} (uj) \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &= C \left\| \int_{\mathbb{R}^{2}} \left| \xi \right|^{\alpha} \hat{u} (\xi - \eta) \hat{j} (\eta) \mathrm{d}\eta \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left( \left\| \int_{\mathbb{R}^{2}} \left| \xi - \eta \right|^{\alpha} \left| \hat{u} (\xi - \eta) \right| \left| \hat{j} (\eta) \right| \mathrm{d}\eta \right\|_{L^{2}} + \left\| \int_{\mathbb{R}^{2}} \left| \hat{u} (\xi - \eta) \right| \left| \eta \right|^{\alpha} \left| \hat{j} (\eta) \right| \mathrm{d}\eta \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &= C \left( \left\| \Lambda^{\alpha} \left( \left| \hat{u} \right|^{\vee} \right) \right| \hat{j} \right|^{\vee} \right\|_{L^{2}} + \left\| \Lambda^{\alpha} \left( \left| \hat{j} \right|^{\vee} \right) \left| \hat{u} \right|^{\vee} \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left( \left\| \Lambda^{\alpha} \left( \left| \hat{u} \right|^{\vee} \right) \right\|_{L^{2}} \left\| j \right\|_{L^{2}}^{2+\alpha} \left\| j \right\|_{L^{2}}^{1-\frac{1}{2\beta}} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{1}{2\beta}} + \left\| u \right\|_{L^{2}}^{\frac{1}{2}} \left\| j \right\|_{L^{2}}^{2+\alpha-1} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{1+2\alpha}{2\beta}} \\ &\leqslant C \epsilon \left\| \Lambda^{\beta+r} j \right\|_{L^{2}}^{2} + C(\epsilon) \left\| u \right\|_{L^{2}}^{1-2\alpha} \left\| \omega \right\|_{L^{2}}^{1+2\alpha} \left\| j \right\|_{L^{2}}^{2-\frac{1}{\beta}} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{1}{\beta}} \\ &+ C(\epsilon) \left\| u \right\|_{L^{2}} \left\| u \right\|_{L^{2}}^{2\beta-2\alpha-1} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{1+2\alpha} , \end{split}$$

where we have used the following Gagliardo-Nirenberg inequalities

$$\begin{split} \left\| \Lambda^{\alpha} \left( | \hat{u} |^{\vee} \right) \right\|_{L^{4}} & \leq C \left\| | \hat{u} |^{\vee} \right\|_{L^{2}}^{\frac{1}{2} - \alpha} \left\| \nabla \left( | \hat{u} |^{\vee} \right) \right\|_{L^{2}}^{\frac{1}{2} + \alpha} \leq C \left\| u \right\|_{L^{2}}^{\frac{1}{2} - \alpha} \left\| \nabla u \right\|_{L^{2}}^{\frac{1}{2} + \alpha}, \\ \left\| | \hat{u} |^{\vee} \right\|_{L^{4}} & \leq C \left\| | \hat{u} |^{\vee} \right\|_{L^{2}}^{\frac{1}{2}} \left\| \nabla \left( | \hat{u} |^{\vee} \right) \right\|_{L^{2}}^{\frac{1}{2}} \leq C \left\| u \right\|_{L^{2}}^{\frac{1}{2}} \left\| \nabla u \right\|_{L^{2}}^{\frac{1}{2}}; \\ \left\| \left| \hat{j} \right|^{\vee} \right\|_{L^{4}} & \leq C \left\| \left| \hat{j} \right|^{\vee} \right\|_{L^{2}}^{1 - \frac{1}{2\beta}} \left\| \Lambda^{\beta} \left( \left| \hat{j} \right|^{\vee} \right) \right\|_{L^{2}}^{\frac{1}{2\beta}} \leq C \left\| j \right\|_{L^{2}}^{1 - \frac{1}{2\beta}} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{1}{2\beta}}, \\ \left\| \Lambda^{\alpha} \left( \left| \hat{j} \right|^{\vee} \right) \right\|_{L^{4}} & \leq C \left\| \left| \hat{j} \right|^{\vee} \right\|_{L^{2}}^{\frac{2\beta - 2\alpha - 1}{2\beta}} \left\| \Lambda^{\beta} \left( \left| \hat{j} \right|^{\vee} \right) \right\|_{L^{2}}^{\frac{1 + 2\alpha}{2\beta}} \leq C \left\| j \right\|_{L^{2}}^{\frac{2\beta - 2\alpha - 1}{2\beta}} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{1 + 2\alpha}{2\beta}}. \end{split}$$

Similarly, we can deal with  $I_2$  as follows.

$$\begin{split} |I_{2}| &= \left| \int_{\mathbb{R}^{2}} \Lambda^{r} \left( b \cdot \nabla \omega \right) \Lambda^{r} j \mathrm{d}x \right| \\ &= \left| \int_{\mathbb{R}^{2}} \Lambda^{-1} \nabla \cdot \Lambda^{\alpha} \left( b\omega \right) \Lambda^{\beta+r} j \mathrm{d}x \right| \\ &\leqslant \left\| \Lambda^{-1} \nabla \cdot \Lambda^{\alpha} \left( b\omega \right) \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left\| \Lambda^{\alpha} (b\omega) \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &= C \left\| \int_{\mathbb{R}^{2}} \left| \xi \right|^{\alpha} \hat{b} (\xi - \eta) \hat{\omega} (\eta) \mathrm{d}\eta \right\|_{L^{2}} \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left( \left\| \int_{\mathbb{R}^{2}} \left| \xi - \eta \right|^{\alpha} \left| \hat{b} (\xi - \eta) \right| \left| \hat{\omega} (\eta) \right| \mathrm{d}\eta \right\|_{L^{2}} + \left\| \int_{\mathbb{R}^{2}} \left| \hat{b} (\xi - \eta) \right| \left| \eta \right|^{\alpha} \left| \hat{\omega} (\eta) \right| \mathrm{d}\eta \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &= C \left( \left\| \Lambda^{\alpha} \left( \left| \hat{b} \right|^{\vee} \right) \left| \hat{\omega} \right|^{\vee} \right\|_{L^{2}} + \left\| \Lambda^{\alpha} \left( \left| \hat{\omega} \right|^{\vee} \right) \left| \hat{b} \right|^{\vee} \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left( \left\| \Lambda^{\alpha} \left( \left| \hat{b} \right|^{\vee} \right) \right\|_{L^{\infty}} \left\| \omega \right\|_{L^{2}} + \left\| \hat{b} \right|^{\vee} \right\|_{L^{\infty}} \left\| \Lambda^{\alpha} \omega \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \left( \left\| b \right\|_{L^{2}}^{\frac{\beta-\alpha}{1+\beta}} \left\| \Lambda^{\beta+1} b \right\|_{L^{2}}^{\frac{1+\alpha}{1+\beta}} \left\| \omega \right\|_{L^{2}} + \left\| b \right\|_{L^{2}}^{\frac{1+r}{1+\beta}} \left\| \Lambda^{\alpha} \omega \right\|_{L^{2}} \right) \left\| \Lambda^{\beta+r} j \right\|_{L^{2}} \\ &\leqslant C \epsilon \left\| \Lambda^{\beta+r} j \right\|_{L^{2}}^{2} + C(\epsilon) \left( \left\| b \right\|_{L^{2}}^{\frac{2(\beta-\alpha)}{1+\beta}} \left\| \Lambda^{\beta} j \right\|_{L^{2}}^{\frac{2(1+\alpha)}{1+\beta}} \left\| \omega \right\|_{L^{2}}^{2} + \left\| b \right\|_{L^{2}}^{\frac{2r}{1+r}} \left\| \Lambda^{r} j \right\|_{L^{2}}^{\frac{2r}{1+r}} \left\| \Lambda^{\alpha} \omega \right\|_{L^{2}}^{2} \right), \end{split}$$

where we have used the following Gagliardo-Nirenberg inequalities

$$\begin{split} \left\| \Lambda^{\alpha} \left( \left| \hat{b} \right|^{\vee} \right) \right\|_{L^{\infty}} & \leqslant \quad C \left\| \left| \hat{b} \right|^{\vee} \right\|_{L^{2}}^{\frac{\beta - \alpha}{1 + \beta}} \left\| \Lambda^{\beta + 1} \left( \left| \hat{b} \right|^{\vee} \right) \right\|_{L^{2}}^{\frac{1 + \alpha}{1 + \beta}} \leqslant C \left\| b \right\|_{L^{2}}^{\frac{\beta - \alpha}{1 + \beta}} \left\| \Lambda^{\beta + 1} b \right\|_{L^{2}}^{\frac{1 + \alpha}{1 + \beta}}, \\ \left\| \left| \hat{b} \right|^{\vee} \right\|_{L^{\infty}} & \leqslant \quad C \left\| \left| \hat{b} \right|^{\vee} \right\|_{L^{2}}^{\frac{r}{1 + r}} \left\| \Lambda^{1 + r} \left( \left| \hat{b} \right|^{\vee} \right) \right\|_{L^{2}}^{\frac{1}{1 + r}} \leqslant C \left\| b \right\|_{L^{2}}^{\frac{r}{1 + r}} \left\| \Lambda^{1 + r} b \right\|_{L^{2}}^{\frac{1}{1 + r}}. \end{split}$$

Now, we give estimate of  $I_3$ .

$$|I_{3}| = \left| \int_{\mathbb{R}^{2}} \Lambda^{r} T(\nabla u, \nabla b) \Lambda^{r} j dx \right|$$

$$= \left| \int_{\mathbb{R}^{2}} T(\nabla u, \nabla b) \Lambda^{2r} j dx \right|$$

$$\leq C \|\nabla u\|_{L^{2}} \|\nabla b\|_{L^{\infty}} \|\Lambda^{2r} j\|_{L^{2}}$$

$$\leq C \|\nabla u\|_{L^{2}} \|\nabla b\|_{L^{2}}^{\frac{\beta+r-1}{\beta+r}} \|\Lambda^{\beta+r+1} b\|_{L^{2}}^{\frac{1}{\beta+r}} \|j\|_{L^{2}}^{\frac{\beta-r}{\beta+r}} \|\Lambda^{\beta+r} j\|_{L^{2}}^{\frac{2r}{\beta+r}}$$

$$\leq C \|\nabla u\|_{L^{2}} \|j\|_{L^{2}}^{\frac{2\beta-1}{\beta+r}} \|\Lambda^{\beta+r} j\|_{L^{2}}^{\frac{2r+1}{\beta+r}}$$

$$\leq C \epsilon \|\Lambda^{\beta+r} j\|_{L^{2}}^{2} + C(\epsilon) \|j\|_{L^{2}}^{2} \|\omega\|_{L^{2}}^{\frac{2(\beta+r)}{2\beta-1}},$$

where we have used the following Gagliardo-Nirenberg inequalities

$$\begin{split} \|\nabla b\|_{L^{\infty}} & \; \leqslant \; \; C \, \|\nabla b\|_{L^{2}}^{\frac{\beta+r-1}{\beta+r}} \, \|\Lambda^{\beta+r+1}b\|_{L^{2}}^{\frac{1}{\beta+r}} \, , \\ \|\Lambda^{2r}j\|_{L^{2}} & \; \leqslant \; \; C \, \|j\|_{L^{2}}^{\frac{\beta-r}{\beta+r}} \, \|\Lambda^{\beta+r}j\|_{L^{\frac{2r}{\beta+r}}}^{\frac{2r}{\beta+r}} \, , \end{split}$$

Substituting estimates of  $I_1 - I_3$  into (7), we obtain

$$\begin{split} \frac{1}{2} \frac{\mathrm{d}}{\mathrm{d}t} \left\| \Lambda^r j \right\|_{L^2}^2 + \left\| \Lambda^{\beta + r} j \right\|_{L^2}^2 & \leqslant \quad C\epsilon \left\| \Lambda^{\beta + r} j \right\|_{L^2}^2 + C(\epsilon) \left\| u \right\|_{L^2}^{1 - 2\alpha} \left\| \omega \right\|_{L^2}^{1 + 2\alpha} \left\| j \right\|_{L^2}^{2 - \frac{1}{\beta}} \left\| \Lambda^{\beta} j \right\|_{L^2}^{\frac{1}{\beta}} \\ & \quad + C(\epsilon) \left\| u \right\|_{L^2} \left\| \omega \right\|_{L^2} \left\| j \right\|_{L^2}^{\frac{2\beta - 2\alpha - 1}{\beta}} \left\| \Lambda^{\beta} j \right\|_{L^2}^{\frac{1 + 2\alpha}{\beta}} \\ & \quad + C(\epsilon) \left( \left\| b \right\|_{L^2}^{\frac{2(\beta - \alpha)}{1 + \beta}} \left\| \Lambda^{\beta} j \right\|_{L^2}^{\frac{2(1 + \alpha)}{\beta}} \left\| \omega \right\|_{L^2}^2 + \left\| b \right\|_{L^2}^{\frac{2r}{1 + r}} \left\| \Lambda^r j \right\|_{L^2}^{\frac{2}{1 + r}} \left\| \Lambda^{\alpha} \omega \right\|_{L^2}^2 \right) \\ & \quad + C(\epsilon) \left\| j \right\|_{L^2}^2 \left\| \omega \right\|_{L^2}^{\frac{2(\beta + r)}{2\beta - 1}}. \end{split}$$

Choosing  $\epsilon = \frac{1}{2C}$ , we get

$$\frac{\mathrm{d}}{\mathrm{d}t} \|\Lambda^{r} j\|_{L^{2}}^{2} + \|\Lambda^{\beta+r} j\|_{L^{2}}^{2} \leqslant C(\epsilon) \|u\|_{L^{2}}^{1-2\alpha} \|\omega\|_{L^{2}}^{1+2\alpha} \|j\|_{L^{2}}^{2-\frac{1}{\beta}} \|\Lambda^{\beta} j\|_{L^{2}}^{\frac{1}{\beta}} \\
+ C(\epsilon) \|u\|_{L^{2}} \|\omega\|_{L^{2}} \|j\|_{L^{2}}^{\frac{2\beta-2\alpha-1}{\beta}} \|\Lambda^{\beta} j\|_{L^{2}}^{\frac{1+2\alpha}{\beta}} \\
+ C(\epsilon) \left( \|b\|_{L^{2}}^{\frac{2(\beta-\alpha)}{\beta}} \|\Lambda^{\beta} j\|_{L^{2}}^{\frac{2(1+\alpha)}{1+\beta}} \|\omega\|_{L^{2}}^{2} + \|b\|_{L^{2}}^{\frac{2r}{1+r}} \|\Lambda^{r} j\|_{L^{2}}^{\frac{2}{1+r}} \|\Lambda^{\alpha} \omega\|_{L^{2}}^{2} \right) \\
+ C(\epsilon) \|j\|_{L^{2}}^{2} \|\omega\|_{L^{2}}^{\frac{2(\beta+r)}{2\beta-1}}.$$
(8)

By assumptions of the lemma, we have  $0 \leqslant \alpha < \frac{1}{2}, \ \beta \geqslant 1, \ r = \alpha + \beta - 1 > 0$ , and hence  $\frac{1}{\beta} \leqslant 1, \frac{1+2\alpha}{\beta} \leqslant 2, \frac{2(1+\alpha)}{1+\beta} \leqslant 2, \frac{2}{1+r} \leqslant 2$ . Thus, due to Lemma 1, we have

$$\|\Lambda^{\beta}j\|_{L^{2}}^{\frac{1}{\beta}}, \|\Lambda^{\beta}j\|_{L^{2}}^{\frac{1+2\alpha}{\beta}}, \|\Lambda^{\beta}j\|_{L^{2}}^{\frac{2(1+\alpha)}{1+\beta}}, \|\Lambda^{\alpha}\omega\|_{L^{2}}^{2} \in L^{1}(0,T).$$

Using the Gronwall's inequality in (8), we obtain

$$\|\Lambda^r j\|_{L^2}^2(t) + \int_0^t \|\Lambda^{\beta+r} j\|_{L^2}^2 d\tau \leqslant C(u_0, b_0, T).$$

The proof of the lemma is complete.

#### 3. Proof of Theorem 1

In this section, we prove Theorem 1. We will prove that  $\omega, j \in L^1(0,T;L^\infty(\mathbb{R}^2))$  and Theorem 1 is then followed from the BKM-type criterion. Two cases will be considered respectively:  $0 < \alpha < 1/2, \beta \ge 1, 3\alpha + 2\beta > 3$  and  $\alpha = 0, \beta > \frac{3}{2}$ .

**case I:** 
$$0 < \alpha < 1/2, \beta \ge 1, 3\alpha + 2\beta > 3$$

We will first give  $L^{\infty}(0,T;H^1)$  estimates for  $\omega,j$ . Differentiating with respective to  $x_i(i=1,2)$  on both sides of (2) and (3) respectively, we get

$$(\partial_i \omega)_t + u \cdot \nabla (\partial_i \omega) = -(\partial_i u) \cdot \nabla \omega + (\partial_i b) \cdot \nabla j + b \cdot \nabla (\partial_i j) - \Lambda^{2\alpha} (\partial_i \omega), \tag{9}$$

$$(\partial_{i}j)_{t} + u \cdot \nabla (\partial_{i}j) = -(\partial_{i}u) \cdot \nabla j + (\partial_{i}b) \cdot \nabla \omega + b \cdot \nabla (\partial_{i}\omega) + \partial_{i} (T(\nabla u, \nabla b)) - \Lambda^{2\beta} (\partial_{i}j). \quad (10)$$

Multiplying  $\partial_i \omega$  and  $\partial_i j$  on both sides of (9) and (10) respectively, integrating with respect to x in  $\mathbb{R}^2$  and summing up i=1,2, we obtain

$$\frac{1}{2} \frac{\mathrm{d}}{\mathrm{d}t} \left( \|\nabla \omega\|_{L^{2}}^{2} + \|\nabla j\|_{L^{2}}^{2} \right) = -\sum_{i=1}^{2} \int_{\mathbb{R}^{2}} \left[ (\partial_{i}u) \cdot \nabla \omega \right] \partial_{i}\omega \mathrm{d}x + \sum_{i=1}^{2} \int_{\mathbb{R}^{2}} \left[ (\partial_{i}b) \cdot \nabla j \right] \partial_{i}\omega \mathrm{d}x 
- \sum_{i=1}^{2} \int_{\mathbb{R}^{2}} \left[ (\partial_{i}u) \cdot \nabla j \right] \partial_{i}j \mathrm{d}x + \sum_{i=1}^{2} \int_{\mathbb{R}^{2}} \left[ (\partial_{i}b) \cdot \nabla \omega \right] \partial_{i}j \mathrm{d}x 
+ \sum_{i=1}^{2} \int_{\mathbb{R}^{2}} \left[ \partial_{i} \left( T \left( \nabla u, \nabla b \right) \right) \right] \partial_{i}j \mathrm{d}x 
- \|\Lambda^{\alpha}\nabla \omega\|_{L^{2}}^{2} - \|\Lambda^{\beta}\nabla j\|_{L^{2}}^{2} 
\leqslant C \left( A_{1} + A_{2} + A_{3} + A_{4} + A_{5} \right) - \|\Lambda^{\alpha}\nabla \omega\|_{L^{2}}^{2} - \|\Lambda^{\beta}\nabla j\|_{L^{2}}^{2}, (11)$$

where we have used  $\nabla \cdot u = \nabla \cdot b = 0$ , and we denote

$$A_{1} = \int_{\mathbb{R}^{2}} |\nabla u| |\nabla \omega|^{2} dx,$$

$$A_{2} = \int_{\mathbb{R}^{2}} |\nabla b| |\nabla j| |\nabla \omega| dx,$$

$$A_{3} = \int_{\mathbb{R}^{2}} |\nabla u| |\nabla j|^{2} dx,$$

$$A_{4} = \int_{\mathbb{R}^{2}} |\nabla b| |\nabla \omega| |\nabla j| dx,$$

$$A_{5} = \int_{\mathbb{R}^{2}} \left[ |\nabla^{2} u| |\nabla b| + |\nabla u| |\nabla^{2} b| \right] |\nabla j| dx.$$

 $A_2 - A_5$  can be estimated in a straight way (see also [5]), which are

$$\begin{split} A_{2} &= A_{4} & \leqslant \quad C\left(\varepsilon\right) \left\| j \right\|_{L^{2}}^{2} + \left\| \nabla j \right\|_{L^{2}}^{2} \left\| \nabla \omega \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda \nabla j \right\|_{L^{2}}^{2} \\ & \leqslant \quad C\left(\varepsilon\right) \left\| j \right\|_{L^{2}}^{2} + \left\| \nabla j \right\|_{L^{2}}^{2} \left\| \nabla \omega \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda^{\beta} \nabla j \right\|_{L^{2}}^{2} , \\ A_{3} & \leqslant \quad C\left(\varepsilon\right) \left\| \omega \right\|_{L^{2}}^{2} \left\| \nabla j \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda \nabla j \right\|_{L^{2}}^{2} \\ & \leqslant \quad C\left(\varepsilon\right) \left\| j \right\|_{L^{2}}^{2} + C\left(\varepsilon\right) \left\| \omega \right\|_{L^{2}}^{2} \left\| \nabla j \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda^{\beta} \nabla j \right\|_{L^{2}}^{2} , \\ A_{5} & \leqslant \quad C\left(\varepsilon\right) \left\| j \right\|_{L^{2}}^{2} + C\left(\varepsilon\right) \left\| \omega \right\|_{L^{2}}^{2} \left\| \nabla j \right\|_{L^{2}}^{2} + \left\| \nabla j \right\|_{L^{2}}^{2} \left\| \nabla \omega \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda^{\beta} \nabla j \right\|_{L^{2}}^{2} \\ & \leqslant \quad C\left(\varepsilon\right) \left\| j \right\|_{L^{2}}^{2} + C\left(\varepsilon\right) \left\| \omega \right\|_{L^{2}}^{2} \left\| \nabla j \right\|_{L^{2}}^{2} + \left\| \nabla j \right\|_{L^{2}}^{2} \left\| \nabla \omega \right\|_{L^{2}}^{2} + C\varepsilon \left\| \Lambda^{\beta} \nabla j \right\|_{L^{2}}^{2} . \end{split}$$

Now we deal with  $A_1$ .

$$A_{1} = \int_{\mathbb{R}^{2}} \left|\omega\right| \left|\nabla\omega\right|^{2} dx \leqslant \left\|\omega\right\|_{L^{p}} \left\|\nabla\omega\right\|_{L^{q}}^{2}$$

$$\leqslant C \left\|\omega\right\|_{L^{p}} \left\|\nabla\omega\right\|_{L^{2}}^{2-\frac{2}{p\alpha}} \left\|\Lambda^{\alpha}\nabla\omega\right\|_{L^{2}}^{\frac{2}{p\alpha}}$$

$$\leqslant C\epsilon \left\|\Lambda^{\alpha}\nabla\omega\right\|_{L^{2}}^{2} + C(\epsilon) \left\|\omega\right\|_{L^{p}}^{\frac{p\alpha}{p\alpha-1}} \left\|\nabla\omega\right\|_{L^{2}}^{2},$$

where we have used the following Gagliardo-Nirenberg inequality:

$$\|\nabla \omega\|_{L^q} \leqslant C \|\nabla \omega\|_{L^2}^{1 - \frac{1}{p\alpha}} \|\Lambda^{\alpha} \nabla \omega\|_{L^2}^{\frac{1}{p\alpha}}.$$

Here

$$\frac{1}{\alpha}$$

and p is to be determined later.

To estimate  $\|\omega\|_{L^p}$ , we multiply on the both sides of (2) by  $p|\omega|^{p-2}\omega$  and integrate with respect to x in  $\mathbb{R}^2$  to obtain

$$\frac{1}{p}\frac{\mathrm{d}}{\mathrm{d}t} \|\omega\|_{L^{p}}^{p} + \int_{\mathbb{R}^{2}} (\Lambda^{\alpha}\omega) |\omega|^{p-2} \omega \mathrm{d}x \leqslant \int_{\mathbb{R}^{2}} |b| |\nabla j| |\omega|^{p-1} \mathrm{d}x,$$

where we have used  $\nabla \cdot u = 0$ . Thanks to the following inequality (see [4][2][8][3])

$$\int_{\mathbb{R}^2} (\Lambda^{\alpha} \omega) |\omega|^{p-2} \, \omega \mathrm{d}x \geqslant 0,$$

we get

$$\frac{\mathrm{d}}{\mathrm{d}t} \|\omega\|_{L^p} \leqslant \|b \cdot \nabla j\|_{L^p} \leqslant \|b\|_{L^\infty} \|\nabla j\|_{L^p}. \tag{12}$$

It follows from Lemma 2 that

$$j \in L^2\left(0, T; H^{\beta+r}\right).$$

Consequently, we have

$$b\in L^2(0,T;L^\infty) \ \text{ and } \ \nabla j\in L^2(0,T;L^p)\left(\text{for some } p>\frac{1}{\alpha}\right).$$

In fact, if  $\beta + r \geqslant 2$ , i.e.  $\alpha + 2\beta \geqslant 3$ , we can choose  $\frac{1}{\alpha} , such that$ 

$$\nabla j \in L^2(0,T;L^p);$$

if  $\beta + r < 2$ , i.e.  $\alpha + 2\beta < 3$ , we have  $\frac{2}{2 - (\beta + r)} = \frac{2}{3 - (2\beta + \alpha)} > \frac{1}{\alpha}$ , so we can choose  $\frac{1}{\alpha} , such that$ 

$$\nabla j \in L^2(0,T;L^p),$$

where we have used the assumption  $3\alpha + 2\beta > 3$  in the theorem. Integrating on t in (0, t) on both sides of (12) yields

$$\|\omega\|_{L^{p}} \leq \|\omega_{0}\|_{L^{p}} + \int_{0}^{t} \|b\|_{L^{\infty}} \|\nabla j\|_{L^{p}} d\tau \leq \|\omega_{0}\|_{L^{p}} + \|b\|_{L^{2}(0,T;L^{\infty})} \|\nabla j\|_{L^{2}(0,T;L^{p})} \leq C(\omega_{0},T),$$
(13)

which implies that  $\|\omega\|_{L^p} \in L^{\infty}(0,T)$ .

Putting the estimates of  $(A_1 - A_5)$  into (11), we have

$$\frac{1}{2} \frac{\mathrm{d}}{\mathrm{d}t} \left( \|\nabla \omega\|_{L^{2}}^{2} + \|\nabla j\|_{L^{2}}^{2} \right) \leqslant C\left(\varepsilon\right) \left( \|\omega\|_{L^{2}}^{2} + \|\nabla j\|_{L^{2}}^{2} + \|\omega\|_{L^{p}}^{\frac{p\alpha}{p\alpha-1}} \right) \left( \|\nabla j\|_{L^{2}}^{2} + \|\nabla \omega\|_{L^{2}}^{2} \right) 
+ C\left(\varepsilon\right) \|j\|_{L^{2}}^{2} + C\epsilon \|\Lambda^{\alpha}\nabla\omega\|_{L^{2}}^{2} + C\varepsilon \|\Lambda^{\beta}\nabla j\|_{L^{2}}^{2} 
- \|\Lambda^{\alpha}\nabla\omega\|_{L^{2}}^{2} - \|\Lambda^{\beta}\nabla j\|_{L^{2}}^{2}.$$
(14)

Combining this with (13) and lemma 1, taking  $\epsilon$  so that  $C\epsilon = \frac{1}{2}$ , and utilizing the Gronwall's inequality, we get

$$\|\nabla \omega\|_{L^{2}}^{2} + \|\nabla j\|_{L^{2}}^{2} + \int_{0}^{t} \|\Lambda^{\alpha} \nabla \omega\|_{L^{2}}^{2} + \|\Lambda^{\beta} \nabla j\|_{L^{2}}^{2} dt \leq C(T)$$

which implies that

$$\nabla \omega, \nabla j \in L^{\infty}\left(0, T; L^{2}\right), \nabla \omega \in L^{2}\left(0, T; H^{\alpha}\right), \nabla j \in L^{2}\left(0, T; H^{\beta}\right).$$

Thus, by the Sobolev imbedding, we have  $\omega, j \in L^2(0,T;L^\infty)$ . Applying the BKM type criterion for global regularity (see [1]), we get the proof of Theorem 1.

Case II: 
$$\alpha = 0, \beta > \frac{3}{2}$$

In this case, since  $\alpha=0, \beta>\frac{3}{2}$ , we have  $r=\alpha+\beta-1>\frac{1}{2}$  and  $\beta+r>2$ . It follows from Lemma 2 that  $\nabla j\in L^2(0,T;L^\infty)$ . Since

$$\omega_t + u \cdot \nabla \omega = b \cdot \nabla j,$$

we can prove that  $\omega \in L^{\infty}(0,T;L^{\infty})$  by using the particle trajectory method. By taking advantage of the BKM type criterion for global regularity (see [1]), we finish the proof of Theorem 1.
