# Stable determination of an inclusion in an elastic body by boundary measurements＊

#### Abstract

We consider the inverse problem of identifying an unknown inclu－ sion contained in an elastic body by the Dirichlet－to－Neumann map． The body is made by linearly elastic，homogeneous and isotropic ma－ terial．The Lamé moduli of the inclusion are constant and different from those of the surrounding material．Under mild a－priori regular－ ity assumptions on the unknown defect，we establish a logarithmic stability estimate．Main tools are propagation of smallness arguments based on three－spheres inequality for solutions to the Lamé system and a refined asymptotic analysis of the fundamental solution of the Lamé system in presence of an inclusion which shows surprising features．


## 1 Introduction

This paper deals with the inverse problem of determining an elastic inclusion $D$ contained in an elastic body $\Omega$ by measuring displacements and tractions

[^0]at the boundary $\partial \Omega$. More precisely, let $\Omega$ be a bounded domain in $\mathbb{R}^{3}$ and let $D$ be an open set contained in $\Omega$. Assume that both the body $\Omega$ and the inclusion $D$ are made by different homogeneous, isotropic, elastic materials, with Lamé moduli $\mu, \lambda$ and $\mu^{I}, \lambda^{I}$, respectively, satisfying the strong convexity conditions $\mu>0,2 \mu+3 \lambda>0, \mu^{I}>0,2 \mu^{I}+3 \lambda^{I}>0$. For a given $g \in H^{\frac{1}{2}}(\partial \Omega)$, consider the weak solution $u \in H^{1}(\Omega)$ to the Dirichlet problem

where $\mathbb{C}, \mathbb{C}^{I}$ are the elastic tensors of the body and of the inclusion, respectively, and $\chi_{D}$ is the characteristic function of $D$. We denote by $\Lambda_{D}: H^{\frac{1}{2}} \rightarrow$ $H^{-\frac{1}{2}}$ the Dirichlet-to-Neumann map associated to the problem (1.1)-(1.2), that is the operator which maps the Dirichlet data $\left.u\right|_{\partial \Omega}$ onto the corresponding Neumann data $\left(\left(\mathbb{C}+\left(\mathbb{C}^{I}-\mathbb{C}\right) \chi_{D}\right) \nabla u\right) \nu$, taken in the weak sense (see (3.3), (3.4) below), where $\nu$ is the outer unit normal to $\partial \Omega$. The inverse problem we are considering here is to determine $D$ when $\Lambda_{D}$ is given.

This problem is one of the fundamental issues of inverse problems in linear elasticity. In fact, the physical problem described by equations (1.1)(1.2) corresponds to a class of diagnostic problems very common in practical applications, in which the inclusion is constituted by a faulty or damaged portion of the elastic body and only the exterior boundary of the experimental sample is accessible to measurements. The hypothesis of piecewise constant coefficients is also realistic and describes practical situations in which there is a jump of the elastic coefficients at the interface of the inclusion. However, despite the simplicity of its formulation and the relevant implications in practical applications, few general results on this inverse problem are known.

The inverse problem of determining an elastic inclusion could be framed as a special case of determination of the Lamé moduli from the Dirichlet-toNeumann map. In this case, however, most of the results currently available concern only regular elastic coefficients. In [N-U1], Nakamura and Uhlmann established that in two dimensions the Lamé moduli are uniquely determined by the Dirichlet-to-Neumann map, assuming that they are smooth (e.g., $\left.C^{\infty}(\bar{\Omega})\right)$ and sufficiently close to a pair of positive constants. For the three-dimensional case, the uniqueness for both Lamé moduli was proved in [N-U2], [E-R], [N-U3], provided that they are smooth and that the shear modulus is close to a positive constant. Some of the above uniqueness results have been proved in the case of partial Cauchy data, see [I-U-Y] for more details. Concerning results for less regular coefficients, quite recently, the uniqueness and Lipschitz stability in the case of discontinuous piecewise
constant Lamé tensors, with unknown constants, but with a known decomposition of the domain, has been achieved in [B-F-V].

An alternative approach is the one based on identification of an unknown boundary, namely the interface $\partial D$ of the inclusion, by measurements taken on $\partial \Omega$. The extreme cases of a cavity or of a rigid inclusion in an isotropic elastic body were considered in (M-R1] and in (M-R2], respectively. For this class of inverse problems, under mild regularity assumptions on the unknown interface, Morassi and Rosset established a stability estimate of log-log type from a single pair of Cauchy data. For the elastic inclusion even the uniqueness question from a finite number of boundary measurements, not to mention stability, remains a largely open issue.

In connection with the problems discussed above, we wish to mention the reconstruction issue that has drawn a lot of attention in recent years.

Ikehata developed in [Ik1] the so-called probe method for reconstructing inclusions in elastic bodies by means of singular or fundamental solutions. A key ingredient of the method is a Runge type approximation theorem, which is useful to guarantee the existence of an approximating sequence to the singular solution. The basic idea of this method comes from Isakov's fundamental paper [Is1], in which the uniqueness of the determination of an inclusion in an electrical conductor from the Dirichlet-to-Neumann map was proved. See also a corresponding result of uniqueness for elastic inclusions [Ik-N-T]. Unfortunately, Runge type approximation theorems are typically based on nonconstructive arguments and, therefore, they are not suitable for stability estimates. Still along this line of research, interesting results for the reconstruction of an unknown inclusion in two dimensions were obtained by Ikehata in [Ik2].

Uhlmann and Wang proposed in [U-W] a method for constructing complex geometrical optics (CGO) solutions with general phases for various systems with Laplacian principal part, which include the inhomogeneous Lamé system in the plane. In particular, in [U-W-W], the authors provided a reconstruction algorithm to the inverse problem of determining $D$ from $\Lambda_{D}$. The idea is to probe the medium with CGO solutions having polynomialtype phase functions. The method works for bounded or unbounded planar regions, made by inhomogeneous Lamé material, and does not need a Runge type theorem. Using the CGO solutions, the authors develop an algorithm to reconstruct the exact shape of a large class of inclusions, including starshaped domains. Numerical implementation of the method gave encouraging results. Extension to three dimensions, however, does not seem to be easy as this method heavily relies on the use of conformal mappings.

In this paper we prove, under suitable mild a-priori assumptions on the regularity and on the topology of $D$, a continuous dependence of $D$ from $\Lambda_{D}$
with a modulus of continuity of logarithmic type. Our proof is inspired by the paper by Alessandrini and Di Cristo [A-DiC], in which a logarithmic stability estimate for the corresponding problem in impedance tomography, which involves a single scalar elliptic equation with piecewise constant coefficient, was obtained. In this direction, we would like also to mention the recent papers by Di Cristo and Vessella [DiC-V1], DiC-V2], for analogous results for the stable determination of a time varying inclusion within a thermal conductor. The aforementioned papers are based on quantitative estimates of unique continuation and on accurate study of the asymptotic behavior of fundamental solutions when the singularity gets close to the unknown interface.

The approach we follow here goes along the same line of reasoning but there are several steps which present new difficulties and in which we have been forced to introduce novel arguments. Let us outline the main steps of the proof and the new challenges that we have encountered.

Consider two possible inclusions $D_{1}, D_{2}$ and their corresponding Dirichlet-to-Neumann maps $\Lambda_{D_{1}}, \Lambda_{D_{2}}$. The main steps are the following.
i) We introduce the fundamental solutions $\Gamma^{D_{1}}, \Gamma^{D_{2}}$ for the Lamé system (1.1) in the full space when $D=D_{1}, D_{2}$ respectively.
ii) We show that $\left(\Gamma^{D_{1}}-\Gamma^{D_{2}}\right)(y, w)$ can be dominated linearly by $\Lambda_{D_{1}}-\Lambda_{D_{2}}$ when $y, w$ are outside of $\Omega$ (see (6.5), 7.1)).
iii) We propagate the smallness of $\left(\Gamma^{D_{1}}-\Gamma^{D_{2}}\right)(y, w)$ as $y, w$ are moved inside of $\Omega$ in the connected component $\mathcal{G}$ of $\mathbb{R}^{3} \backslash\left(\overline{D_{1} \cup D_{2}}\right)$ which contains $\mathbb{R}^{3} \backslash \bar{\Omega}$.
iv) We examine the asymptotics of $\left(\Gamma^{D_{1}}-\Gamma^{D_{2}}\right)(y, w)$ as $y, w$ approach to a point $P$ of $\partial D_{1} \backslash \overline{D_{2}}\left(\right.$ or $\partial D_{2} \backslash \overline{D_{1}}$ ).
v) We evaluate the distance between $D_{1}$ and $D_{2}$ by matching the smallness estimates of Step iii) with the blowup asymptotics of Step iv).

Let us now illustrate with some more details the character of such steps.
Step i) is based on a-priori regularity estimates of solutions of the Lamé system with piecewise constant Lamé moduli. For this purpose we appeal to the theory of existence developed by Hofmann and Kim [H-K] and to the apriori bounds due to Li and Nirenberg [L-N]. Details can be found in Section 5.

Step ii) is based on a version of the so-called Alessandrini's identity, Lemma 6.1.

Step iii) contains a complication of geometrical/topological character due to the fact that quantitative estimates of unique continuation can be obtained only in sets which are not only topologically connected, but also whose connectedness is expressed in tight quantitative terms. Namely, pairs of points need to be connected by chains of balls of controlled size and number, in
such a way that the iteration of the three-spheres-inequality gives rise to controlled constants and moduli of continuity in the estimates of propagation of smallness.

Note that $D$ is contained in $\Omega$ with no constraint on the distance between $\bar{D}$ and $\partial \Omega$, actually we may even admit that $\partial D \cap \partial \Omega \neq \emptyset$.

Indeed, in previous studies, it was assumed $\operatorname{dist}(\bar{D}, \partial \Omega) \geq$ const $>0$, here we show that this requirement is unnecessary since for our purposes the $\mathrm{D}-\mathrm{N}$ map is estimated only for solutions to (1.1) defined on a domain $\widetilde{\Omega}$ strictly larger than $\Omega$. See Section 7, Step 1 .

Step iv) is the one in which the difference between the scalar conductivity equation and the vector Lamé system becomes more evident and (in our view) presents the most challenging and interesting features.

In fact, in the scalar case it was possible to pick $y=w$ and prove that $\left(\Gamma^{D_{1}}-\Gamma^{D_{2}}\right)(y, y)$ blows up as $y$ tends nontangentially to $P \in \partial D_{1} \backslash \overline{D_{2}}$, and to evaluate quantitatively the blowup rate. In the present case the situation is more complicated for a number of reasons. First of all the fundamental solutions are matrix valued (not scalar) functions and, therefore, it is crucial to understand which of the entries of $\Gamma^{D_{1}}-\Gamma^{D_{2}}$ has the desired blowup behavior. Second, we are assuming that either $\mu^{I} \neq \mu$ or $\lambda^{I} \neq \lambda$ with no order condition between such parameters. Hence, we cannot expect, in general, that the difference matrix $\Gamma^{D_{1}}-\Gamma^{D_{2}}$ may satisfy any positivity condition. For these reasons we have chosen to examine each diagonal entry of $\Gamma^{D_{1}}-\Gamma^{D_{2}}$ separately. Similarly to the scalar case, we can show that, as $y, w$ tend to $P \in \partial D_{1} \backslash \overline{D_{2}},\left(\Gamma^{D_{1}}-\Gamma^{D_{2}}\right)(y, w)$ has, in a suitable reference frame, the same asymptotic behavior of $\left(\Gamma^{+}-\Gamma\right)(y, w)$. Here $\Gamma$ is the standard Kelvin fundamental solution with Lamé moduli $\mu, \lambda$ and $\Gamma^{+}$is the fundamental solution $\Gamma^{D}$ when $D$ is replaced by the upper half plane $\left\{x_{3}>0\right\}$.

We can take advantage of the fact that $\Gamma^{+}$is explicitly known, in fact its expression, although complicated, was calculated by Rongved [R] in 1955. With the aid of Rongved's formulas we have been able to estimate the blowup rate of $\left(\Gamma^{+}-\Gamma\right)_{i i}(y, w), i=1,2,3$, as $y, w \rightarrow 0$ vertically along the line $\left\{x_{1}=x_{2}=0\right\}$ for suitable choices of $y, w$. A notable fact is that we are obliged to pick very specific choices of $y, w, w \neq y$ (see Proposition 9.3). In fact we have found explicit examples of moduli $(\lambda, \mu) \neq\left(\lambda^{I}, \mu^{I}\right)$ for which $\left(\Gamma^{+}-\Gamma\right)_{i i}(y, y)=0$. We emphasize that such a precise analysis has been possible on the grounds of the explicit (algebraic) character of $\Gamma^{+}$(see Section 10.

The organization of the paper is as follows. In Section 2 we introduce some notation and the a-priori information needed for our stability result. The main result of stability, Theorem 3.1, is stated in Section 3. Section 4 is devoted to some technical details of topological-metric character related
to the evaluation of the distance between the inclusions and to estimates of propagation of smallness. The main properties of the fundamental solution of the Lamé system with discontinuous coefficients are presented in Section 5. In Section 6 we state two auxiliary estimates, Theorem 6.4 and Theorem 6.5, and in their basis we prove the main Theorem 3.1 . Theorem 6.4 is proven in the following Section 7. Section 8 contains evaluations of the asymptotic behaviour of the fundamental solution $\Gamma^{D}$, in preparation of the proof of Theorem 6.5, which is completed in Section 9. Section 10 is devoted to the analysis of Rongved's fundamental solution $\Gamma^{+}$. We also investigate the peculiar behaviour of $\Gamma^{+}-\Gamma$ (which shows remarkable differences with the scalar case of the conductivity equations) by exploring explicit examples of material parameters $\mu, \lambda$ and $\mu^{I}, \lambda^{I}$. Finally, Section 11 contains the proof of our main topological-metric lemma, Lemma 4.2.

## 2 Notation and a-priori information

### 2.1 Notation and definitions

Let us denote by $\mathbb{R}_{+}^{3}=\left\{x \in \mathbb{R}^{3} \mid x_{3}>0\right\}$ and $\mathbb{R}_{-}^{3}=\left\{x \in \mathbb{R}^{3} \mid x_{3}<0\right\}$. Given $x \in \mathbb{R}^{3}$, we shall denote $x=\left(x^{\prime}, x_{3}\right)$, where $x^{\prime}=\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}, x_{3} \in \mathbb{R}$. Given $x \in \mathbb{R}^{3}, r>0$, we shall use the following notation for balls and cylinders.

Definition 2.1. ( $C^{k, \alpha}$ regularity) Let $E$ be a domain in $\mathbb{R}^{3}$. Given $k, \alpha$, $k \in \mathbb{N}, 0<\alpha \leq 1$, we say that $E$ is of class $C^{k, \alpha}$ with constants $\rho_{0}, M_{0}>0$, if, for any $P \in \partial E$, there exists a rigid transformation of coordinates under which we have $P=0$ and

When $k=0, \alpha=1$, we also say that $E$ is of Lipschitz class with constants $\rho_{0}, M_{0}$.

Remark 2.2. We use the convention to normalize all norms in such a way that their terms are dimensionally homogeneous and coincide with the standard definition when the dimensional parameter equals one. For instance, the norm appearing above is meant as follows

We denote by $\mathbb{M}^{m \times n}$ the space of $m \times n$ real valued matrices and by $\mathcal{L}(X, Y)$ the space of bounded linear operators between Banach spaces $X$ and $Y$. When $m=n$, we shall also denote $\mathbb{M}^{n}=\mathbb{M}^{n \times n}$.

For every pair of real $n$-vectors $a$ and $b$, we denote by $a \otimes b$ the $n \times n$ matrix with entries

where $C_{i j k l}, A_{i j}$ and $B_{i j}$ are the entries of $\mathbb{C}, A$ and $B$ respectively.
Given two bounded closed sets $A, B \subset \mathbb{R}^{3}$, let us recall that the Hausdorff distance $d_{H}(A, B)$ is defined as

### 2.2 A-priori information

Throughout the paper, we use the following a-priori assumptions.
i) Domain

iii) Material

The body $\Omega$ is assumed to be made of linearly elastic, isotropic and homogeneous material, with elastic tensor $\mathbb{C}$ of components

where $\delta_{i j}$ is the Kronecker's delta. The constant Lamé moduli $\lambda, \mu$ satisfy the strong convexity conditions

where $\alpha_{0}>0, \gamma_{0}>0$ are given constants. We shall also assume upper bounds on the Lamé moduli

where also $\bar{\mu}>0, \bar{\lambda} \in \mathbb{R}$ are known quantities. In some points of our analysis, we will express the constitutive equation (2.12) in terms of $\mu$ and of Poisson's ratio $\nu$, instead of the Lamé moduli $\mu, \lambda$. Recalling that

where $\nu_{0}, \nu_{1}$ only depend on $\alpha_{0}, \gamma_{0}, \bar{\mu}, \bar{\lambda}$. Let us notice that (2.12) trivially implies that

We recall that the first equality in (2.17) is usually named as the major symmetry of the tensor $\mathbb{C}$, whereas the second equality is called the minor symmetry.

Also we note that (2.13) is equivalent to

Similarly, the inclusion $D$ is made of isotropic homogeneous material having elasticity tensor $\mathbb{C}^{I}$, with constant Lamé moduli $\lambda^{I}, \mu^{I}$ satisfying the conditions (2.13), (2.14) and such that

\left(\lambda-\lambda^{I}\right)^{2}+\left(\mu-\mu^{I}\right)^{2} \geq \eta_{0}^{2}>0 \tag{2.19}
\end{equation*}
$$

for a given constant $\eta_{0}>0$.
In what follows we shall refer to the constants $M_{0}, \alpha, M_{1}, \alpha_{0}, \gamma_{0}, \bar{\mu}, \bar{\lambda}$, $\eta_{0}$ as to the a-priori data.

Observe that, in view of (2.15) and of the a-priori bounds on the Lamé moduli, from (2.19) it also follows

where $C$ only depends on $\alpha_{0}, \gamma_{0}, \bar{\mu}, \bar{\lambda}$.
Finally, note that the jump condition (2.19) does not imply any kind of monotonicity relation between $\mathbb{C}$ and $\mathbb{C}^{I}$.

## 3 Formulation of the inverse problem and stability result

For any $f \in H^{1 / 2}(\partial \Omega)$, let $u \in H^{1}(\Omega)$ be the weak solution to the Dirichlet problem

\operatorname{div}\left(\left(\mathbb{C}+\left(\mathbb{C}^{I}-\mathbb{C}\right) \chi_{D}\right) \nabla u\right)=0, & \text { in } \Omega,  \tag{3.1}\\
u=f, & \text { on } \partial \Omega
\end{array}\right.
$$

where $\chi_{D}$ is the characteristic function of $D$.
Let us recall that the so-called Dirichlet-to-Neumann map

for every $v \in H^{1}(\Omega)$.
In what follows it will be convenient to write, with a slight, but customary, abuse of notation,

$$

The inverse problem we are interested in consists in recovering the inclusion $D$ from the knowledge of the map $\Lambda_{D}$ and, more precisely, we want to prove a stability estimate. Our main result is the following.

Theorem 3.1. Let $\Omega \subset \mathbb{R}^{3}$ satisfy $(2.8)-(2.9)$ and let $D_{1}, D_{2}$ be two inclusions contained in $\Omega$ satisfying (2.10)-2.11). Let $\mathbb{C}$ and $\mathbb{C}^{I}$ be the constant elastic tensors of the material of $\Omega$ and of the inclusions $D_{i}, i=1,2$, respectively, where $\mathbb{C}$ and $\mathbb{C}^{I}$ satisfy (2.12)-(2.14) and (2.19). If, for some $\epsilon$, $0<\epsilon<1$,

then

d_{H}\left(\partial D_{1}, \partial D_{2}\right) \leq \rho_{0} \omega(\epsilon), \tag{3.6}
\end{equation*}
$$

where $\omega$ is an increasing function on $[0,+\infty)$ satisfying

\omega(t) \leq C|\log t|^{-\eta}, \text { for every } 0<t<1, \tag{3.7}
\end{equation*}
$$

where $C>0$ and $\eta, 0<\eta \leq 1$, are constants only depending on the a-priori data.

Remark 3.2. In the case when $D_{1}, D_{2}$ are at a prescribed positive distance from $\partial \Omega$, it is also possible to obtain a result analogous to the above Theorem when the Dirichlet-to-Neumann maps $\Lambda_{D_{1}}, \Lambda_{D_{2}}$ are replaced with local maps. For instance, fixing $Q \in \partial \Omega$ and given $\rho_{1}>0$, denoting $\Sigma=\partial \Omega \cap B_{\rho_{1}}(Q)$, we introduce

as the restriction of $\Lambda_{D_{i}}$ to $H_{c o}^{1 / 2}(\Sigma)$. Thus, replacing the assumption (3.5) with

we obtain (3.6)-(3.7) with constants only depending on the a-priori data and on $\rho_{1}$. Such a result is a nearly straightforward adaptation of the theory developed in $A-K$.

The proof of Theorem 3.1 will be given in Section 6. In the following two sections, we introduce some auxiliary results, concerning the topologicalmetric aspects of the problem and the main properties of the fundamental solution of the Lamé system with discontinuous coefficients.

## 4 Metric lemmas

Let $\mathcal{G}$ be the connected component of $\mathbb{R}^{3} \backslash\left(\overline{D_{1} \cup D_{2}}\right)$ which contains $\mathbb{R}^{3} \backslash \bar{\Omega}$ and let us denote

As we shall see later, one of the key ingredients of the stability proof consists in propagating the smallness from the boundary $\partial \Omega$ inside $\Omega$. Since the value $d_{H}\left(\partial D_{1}, \partial D_{2}\right)$ may be attained at some point not belonging to $\overline{\mathcal{G}}$ and, therefore, not reachable from the exterior, it is necessary to introduce a modified distance following the ideas developed in A-DiC]. Precisely, let us introduce the modified distance between $D_{1}$ and $D_{2}$

We remark here that $d_{\mu}$ is not a metric and, in general, it does not dominate the Hausdorff distance. However, under our a priori assumptions on the inclusion, the following lemma holds true.

Lemma 4.1 (Proposition 3.3 in A-DiC). Under the assumptions of Theorem 3.1, there exists a constant $c_{0} \geq 1$ only depending on $M_{0}$ and $\alpha$ such that

It is easy to verify that

& \max _{x \in \partial D_{2} \cap \partial \Omega_{D}} \operatorname{dist}\left(x, D_{1}\right)=\max _{x \in \partial D_{2} \cap \partial \Omega_{D}} \operatorname{dist}\left(x, \partial D_{1}\right),
\end{aligned}
$$

so that $d_{\mu}\left(D_{1}, D_{2}\right) \leq d_{H}\left(\partial D_{1}, \partial D_{2}\right)$, and therefore, in view of Lemma 4.1, these two quantities are comparable.

Another obstacle comes out from the fact that the propagation of smallness arguments are based on an iterated application of the three-spheres inequality for solutions to the Lamé system over chains of balls contained in $\mathcal{G}$ and, in this step, it is crucial to control from below the radii of these balls. In order to circumvent the case in which points of $\partial \Omega_{D}$ are not reachable by such chains of balls, we found it convenient to adapt to our case ideas first presented in $\mathrm{A}-\mathrm{S}$ ] in dealing with crack detection in electrical conductors, which we summarize in the lemma below. We note, incidentally, that this issue was somewhat underestimated in $\mathrm{A}-\mathrm{DiC}$. The procedure developed here enables to fill the possible gaps in the proofs in A-DiC (and also in [DiC], DiC-V1], DiC-V2]).

Let us premise some notation. Given $O=(0,0,0), v$ a unit vector, $h>0$ and $\vartheta \in\left(0, \frac{\pi}{2}\right)$, we denote

the closed truncated cone with vertex at $O$, axis along the direction $v$, height $h$ and aperture $2 \vartheta$. Given $R, d, 0<R<d$ and $Q=-d e_{3}$, let us consider the cone $C\left(O,-e_{3}, \frac{d^{2}-R^{2}}{d}, \arcsin \frac{R}{d}\right)$. We note that the lateral boundary of this cone is tangent to the sphere $\partial B_{R}(Q)$ along the circumference of its base.

From now on, for simplicity, we assume that

and we write $d_{\mu}=d_{\mu}\left(D_{1}, D_{2}\right)$.
Let us define

We shall make use of paths connecting points in order that appropriate tubular neighbourhoods of such paths still remain within $\mathbb{R}^{3} \backslash \Omega_{D}$.

Let us pick a point $P \in \partial D_{1} \cap \partial \Omega_{D}$, let $\nu$ be the outer unit normal to $\partial D_{1}$ at $P$ and let $d>0$ be such that the segment $[(P+d \nu), P]$ is contained in $\mathbb{R}^{3} \backslash \Omega_{D}$. Given $P_{0} \in \mathbb{R}^{3} \backslash \Omega_{D}$, let $\gamma$ be a path in $\mathbb{R}^{3} \backslash \Omega_{D}$ joining $P_{0}$ to $P+d \nu$. We consider the following neighbourhood of $\gamma \cup[(P+d \nu), P] \backslash\{P\}$ formed by a tubular neighbourhood of $\gamma$ attached to a cone with vertex at $P$ and axis along $\nu$

V(\gamma)=\bigcup_{S \in \gamma} B_{R}(S) \cup C\left(P, \nu, \frac{d^{2}-R^{2}}{d}, \arcsin \frac{R}{d}\right) . \tag{4.7}

Note that two significant parameters are associated to such a set, the radius $R$ of the tubular neighbourhood of $\gamma, \cup_{S \in \gamma} B_{R}(S)$, and the half-aperture $\arcsin \frac{R}{d}$ of the cone $C\left(P, \nu, \frac{d^{2}-R^{2}}{d}\right.$, $\left.\arcsin \frac{R}{d}\right)$. In other terms, $V(\gamma)$ depends on $\gamma$ and also on the parameters $R$ and $d$. At each of the following steps, such two parameters shall be appropriately chosen and shall be accurately specified. For the sake of simplicity we convene to maintain the notation $V(\gamma)$ also when different values of $R, d$ are introduced.

Also we warn the reader that it will be convenient at various stages to use a reference frame such that $P=O=(0,0,0)$ and $\nu=-e_{3}$.

Lemma 4.2. Under the above notation, there exist positive constants $\bar{d}, c_{1}$, where $\frac{\bar{d}}{\rho_{0}}$ only depends on $M_{0}$ and $\alpha$, and $c_{1}$ only depends on $M_{0}, \alpha, M_{1}$, and there exists a point $P \in \partial D_{1}$ satisfying

and such that, giving any point $P_{0} \in S_{2 \rho_{0}}$, there exists a path $\gamma \subset\left(\overline{\Omega^{\rho_{0}}} \cup\right.$ $\left.S_{2 \rho_{0}}\right) \backslash \overline{\Omega_{D}}$ joining $P_{0}$ to $P+\bar{d} \nu$, where $\nu$ is the unit outer normal to $D_{1}$ at $P$, such that, choosing a coordinate system with origin $O$ at $P$ and axis $e_{3}=-\nu$, the set $V(\gamma)$ introduced in (4.7) satisfies

provided $R=\frac{\bar{d}}{\sqrt{1+L_{0}^{2}}}$, where $L_{0}, 0<L_{0} \leq M_{0}$, is a constant only depending on $M_{0}$ and $\alpha$.

The proof of Lemma 4.2 is given in Section 11 .

## 5 Fundamental solution of the Lamé system with discontinuous coefficients

In this Section, $D$ is a domain of class $C^{1, \alpha}$ with constants $\rho_{0}, M_{0}, 0<\alpha<1$, and $\mathbb{C}, \mathbb{C}^{I}$ satisfy 2.12 - 2.14 .

Given $y \in \mathbb{R}^{3}$ and a concentrated force $l \delta(\cdot-y)$ applied at $y, l \in \mathbb{R}^{3}$, $|l|=1$, let us consider the normalized fundamental solution $u^{D} \in L_{l o c}^{1}\left(\mathbb{R}^{3}, \mathbb{R}^{3}\right)$ defined by

\operatorname{div}_{x}\left(\left(\mathbb{C}+\left(\mathbb{C}^{I}-\mathbb{C}\right) \chi_{D}\right) \nabla_{x} u^{D}(x, y ; l)\right)=-l \delta(x-y), \quad \text { in } \mathbb{R}^{3} \backslash\{y\}  \tag{5.1}\\
\lim _{|x| \rightarrow \infty} u^{D}(x, y ; l)=0
\end{array}\right.
$$

where $\delta(\cdot-y)$ is the Dirac distribution supported at $y$, that is

\int_{\mathbb{R}^{3}}\left(\mathbb{C}+\left(\mathbb{C}^{I}-\mathbb{C}\right) \chi_{D}\right) \nabla_{x} u^{D}(x, y ; l) \cdot \nabla_{x} \varphi(x)=l \cdot \varphi(y), \quad \text { for every } \varphi \in C_{c}^{\infty}\left(\mathbb{R}^{3}, \mathbb{R}^{3}\right) . \tag{5.2}
\end{equation*}
$$

It is well-known that

u^{D}(x, y ; l)=\Gamma^{D}(x, y) l, \tag{5.3}
\end{equation*}
$$

where $\Gamma^{D}=\Gamma^{D}(\cdot, y) \in L_{\text {loc }}^{1}\left(\mathbb{R}^{3}, \mathcal{L}\left(\mathbb{R}^{3}, \mathbb{R}^{3}\right)\right)$ is the normalized fundamental matrix for the operator $\operatorname{div}_{x}\left(\left(\mathbb{C}+\left(\mathbb{C}^{I}-\mathbb{C}\right) \chi_{D}\right) \nabla_{x}(\cdot)\right)$. The existence of $\Gamma^{D}$ is ensured by the following Proposition.

Proposition 5.1. Under the above assumptions, there exists a unique fundamental matrix $\Gamma^{D}(\cdot, y) \in C^{0}\left(\mathbb{R}^{3} \backslash\{y\}\right)$. Moreover, we have

\Gamma^{D}(x, y)=\left(\Gamma^{D}(y, x)\right)^{T}, \quad \text { for every } x \in \mathbb{R}^{3}, x \neq y  \tag{5.4}\\
\left|\Gamma^{D}(x, y)\right| \leq C|x-y|^{-1}, \quad \text { for every } x \in \mathbb{R}^{3}, x \neq y  \tag{5.5}\\
\left|\nabla_{x} \Gamma^{D}(x, y)\right| \leq C|x-y|^{-2}, \quad \text { for every } x \in \mathbb{R}^{3}, x \neq y \tag{5.6}
\end{gather*}
$$

where the constant $C>0$ only depends on $M_{0}, \alpha, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.
Let us premise the following Lemma due to Li and Nirenberg [L-N].
Lemma 5.2. Under the above hypotheses, let $u \in H^{1}\left(Q_{r, r M_{0}}\right)$ be a solution to

Then, $u \in C^{0}\left(Q_{r, r M_{0}}\right)$ and, for every $x \in Q_{r, r M_{0}}$ such that $Q_{2 \rho, 2 \rho M_{0}}(x) \subset$ $Q_{r, r M_{0}}$, we have

& \leq \frac{C}{\rho^{1+\frac{3}{2}}}\left(\int_{Q_{2 \rho, 2 \rho M_{0}}(x)}|u|^{2}\right)^{\frac{1}{2}} \tag{5.8}
\end{align*}
$$

where $|\cdot|_{\beta}$ denotes the usual Hölder seminorm, $\beta=\frac{\alpha}{2(1+\alpha)}$ and $C>0$ only depends on $M_{0}, \alpha, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.
Proof of Proposition 5.1. In view of the results presented in [H-K], in order to ensure the existence of $\Gamma^{D}$ and properties (5.4), (5.5), it is sufficient to prove that there exist constants $\mu_{0} \in(0,1], C>0$ such that, for every $R>0$ and $\bar{x} \in \mathbb{R}^{3}$, all weak solutions $u \in H^{1}\left(B_{2 R}(\bar{x})\right)$ of the equation

satisfy

|u|_{\mu_{0}, B_{R}(\bar{x})} \leq \frac{C}{R^{\mu_{0}}}\left(\frac{1}{\left|B_{2 R}(\bar{x})\right|} \int_{B_{2 R}(\bar{x})}|u|^{2}\right)^{\frac{1}{2}} \tag{5.10}
\end{equation*}
$$

see Lemma 2.3 in $\mathrm{H}-\mathrm{K}$. In fact, we shall derive (5.10) with $\mu_{0}=1$.
By Lemma 5.2, $u \in W^{1, \infty}\left(B_{R}(\bar{x})\right)$ and consequently it is Lipschitz continuous. By the results in [L-N], we have

where $C>0$ only depends on $\alpha, M_{0}, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$. By (5.11), we finally obtain the desired estimate

It remains to prove estimate (5.6). By applying (5.11) to $\Gamma^{D}(\cdot, y)$ in $B_{s}(x)$, where $s=\frac{|x-y|}{4}$, we have

where $C>0$ only depends on $\alpha, M_{0}, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.

## 6 Proof of the main theorem

We begin with the following identity, the prototype of which can be attributed to Alessandrini [A] in connection with the inverse conductivity problem.

Lemma 6.1. Under the assumptions of Theorem 3.1, let $u_{i} \in H^{1}(\Omega), i=$ 1,2 , be solutions to (3.1) with $D=D_{i}$ respectively. Then the following identity holds

&=<\left(\Lambda_{D_{1}}-\Lambda_{D_{2}}\right) u_{2}, u_{1}> \tag{6.1}
\end{align*}
$$

Proof. Straightforward consequence of $(\sqrt{3.4})$ and of the symmetry properties of $\mathbb{C}, \mathbb{C}^{I}$.

Let us choose $y, w \in \mathbb{R}^{3}, y \neq w$, and $l, m \in \mathbb{R}^{3}$ such that $|l|=|m|=1$. We define the functions

f(y, w ; l, m)=S_{D_{1}}(y, w ; l, m)-S_{D_{2}}(y, w ; l, m) . \tag{6.4}
\end{gather*}

The following Lemma takes its inspiration from a result due to Beretta, Francini and Vessella B-F-V, Proposition 3.2].

=-\Gamma_{2}(y, w) m \cdot l
\end{array}

By using the major symmetry of $\mathbb{C}_{2}$ and subtracting,

=\Gamma_{2}(y, w) m \cdot l-\Gamma_{1}(w, y) l \cdot m .

where $\delta, 0<\delta<1, \vartheta^{*}, 0<\vartheta^{*} \leq 1$, only depend on $\alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu} ; \gamma>0$ only depends on $M_{0}, \alpha, M_{1}, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.

Theorem 6.5 (Lower bound on the function $f$ ). Under the notation of Lemma 4.2, let

## 7 Proof of Theorem 6.4

The proof is divided into four steps.
Step 1. For any $y, w \in S_{2 \rho_{0}}$ and for any $l, m \in \mathbb{R}^{3},|l|=|m|=1$, we have

& \leq C\left(\int_{\partial \Omega}|x-y|^{-2}+\rho_{0}^{2}|x-y|^{-4}\right)^{\frac{1}{2}}
\end{aligned}
\end{aligned}

Noticing that, for any $x \in \partial \Omega,|x-y| \geq \rho_{0}$, and estimating $|\partial \Omega|$ as

and $\gamma_{0}, \bar{\lambda}, \bar{\mu} ; \chi, 0<\chi<1$, only depends on $M_{0}, \alpha ; d_{*}, 0<d_{*}<\bar{d}$, only depends on $M_{0}, \alpha, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$, where $\bar{d}$ has been introduced in Lemma 4.2: $\beta, 0<\beta<1, C>0$ only depend on $M_{0}, \alpha, M_{1}, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.

Proof of Step 2. Let us fix $\bar{y}, \bar{w} \in S_{2 \rho_{0}}$.
By Lemma 4.2, there exists a path $\gamma \subset\left(\overline{\Omega^{\rho_{0}}} \cup S_{2 \rho_{0}}\right) \backslash \overline{\Omega_{D}}$ joining $\bar{w}$ to $Q=P-\bar{d} e_{3}$, such that

where $C>0$ and $\delta, 0<\delta<1$, only depend on $\alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}, \frac{r_{2}}{r_{3}}, \frac{r_{1}}{r_{3}}$.
Let us choose $r_{1}=\frac{\vartheta^{*} \bar{d}}{4}, r_{2}=3 r_{1}, r_{3}=4 r_{1}$. Let $x_{1}=\bar{w}$ and let us define $\left\{x_{i}\right\}, i=1, \ldots, s$, as follows: $x_{1}=\bar{w}, x_{i+1}=\gamma\left(t_{i}\right)$, where $t_{i}=$ $\max \left\{t\left|\left|\gamma(t)-x_{i}\right|=r_{1}\right\}\right.$ if $\left|x_{i}-Q\right|>2 r_{1}$; otherwise, let $i=s$ and stop the process. By construction, the balls $B_{r_{1}}\left(x_{i}\right)$ are pairwise disjoint, $\left|x_{i+1}-x_{i}\right|=$ $2 r_{1}$ for $i=1, \ldots, s-1,\left|x_{s}-Q\right| \leq 2 r_{1}$. Hence, we have

where the constant $C>0$ depends only on $M_{0}, \alpha, M_{1}, \alpha_{0}, \underline{\gamma}_{0}, \bar{\lambda}, \bar{\mu}$, and the constant $\beta, 0<\beta<1$, only depends on $M_{0}, \alpha, M_{1}, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.

Let us denote

In order to approach $w_{h}$, we construct a sequence of balls contained in the cone $C\left(P,-e_{3}, \frac{\bar{d}^{2}-R^{2}}{\bar{d}}, \arcsin \frac{R}{\bar{d}}\right)$, with $R=\frac{\bar{d}}{\sqrt{1+L_{0}^{2}}}$, as follows. Let us define, for $k \geq 2$,

B_{\rho_{k+1}}\left(w_{k+1}\right) \subset B_{3 \rho_{k}}\left(w_{k}\right) . \tag{7.25}

Denoting

At this stage, in order to estimate $f\left(y_{h}, w_{h} ; l, m\right)$ when $y_{h}, w_{h}$ are defined by (6.12), 6.13), we shall propagate the smallness with respect to the first variable, by iterating the three spheres inequality over suitable chains of balls. As in Step i), we need a preliminary rough estimate of $f\left(y, w_{h} ; l, m\right)$ for any $y \in \mathbb{R}^{3} \backslash \Omega_{D}$. However, since such an estimate degenerates when $y$ approaches $\Omega_{D}$, we have to restrict our analysis to points $y$ sufficiently far from $\Omega_{D}$. Precisely, we consider the set $\widehat{V}(\gamma)$ obtained reducing the width of the set $V(\gamma)$ appearing in 7.10 by replacing in its definition $R=\frac{\bar{d}}{\sqrt{1+L_{0}^{2}}}$ with $\widehat{R}=\frac{\bar{d}}{2 \sqrt{1+L_{0}^{2}}}$. Let us denote $\widehat{\vartheta}_{0}=\arcsin \frac{\widehat{R}}{\bar{d}}=\frac{1}{2 \sqrt{1+L_{0}^{2}}}$.

In Step 4, we shall apply the three-spheres inequality on a chain of balls contained in $\widehat{V}(\gamma)$ and centered at points belonging either to the arc $\gamma$ or to the segment joining $Q$ to $y_{h}=P-h e_{3}$. By a straightforward computation, the distance from $\Omega_{D}$ of the points of all these balls is, at least,

$i=1,2$. Let $R=\operatorname{diam}(\Omega)+\rho_{0} \leq C \rho_{0}$, with $C>0$ only depending on $M_{0}$, $\alpha, M_{1}$. Then, $\Omega \subset B_{R}(y)$ and $\Omega \subset B_{R}\left(w_{h}\right)$. Since $|x-y| \geq \sin \widehat{\vartheta}_{0} h$ for every $x \in \Omega_{D}$, we have

Let $\widetilde{y} \in S_{2 \rho_{0}}$ such that $\operatorname{dist}(\widetilde{y}, \partial \Omega)=\frac{3}{2} \rho_{0}$, so that $B_{\frac{\rho_{0}}{2}}(\widetilde{y}) \subset S_{2 \rho_{0}}$ and, by (7.8) of Step 2,

By Lemma 4.2, there exists a path $\gamma \subset\left(\overline{\Omega^{\rho_{0}}} \cup S_{2 \rho_{0}}\right) \backslash \bar{\Omega}_{D}$ joining $\widetilde{y}$ to $Q=$ $P-\bar{d} e_{3}$, such that $V(\gamma) \subset \mathbb{R}^{3} \backslash \Omega_{D}$, where $V(\gamma)$ is defined by (7.10).

By Lemma 6.3, the vector-valued function $\tilde{f}=\left(\widetilde{f}_{1}, \widetilde{f}_{2}, \tilde{f}_{3}\right)$, where $f_{k}(\cdot, m)=$ $f\left(\cdot, w_{h} ; e_{k}, m\right), k=1,2,3$, satisfies the Lamé system (7.11), with constant coefficients $\lambda, \mu$. Then, we can repeat the propagation of smallness arguments of Step 2 with the following modifications

By repeating the arguments of Step 2, in view of the estimates (7.34) and (7.39), the analogous of (7.14) becomes

Finally, by adapting the geometrical construction seen above to the chain of balls joining $Q$ to $y_{h}$ inside $\widehat{V}(\gamma)$, recalling (7.33) and noticing that the new values of $\chi$ and $d_{*}$ are bigger than the previous ones, we have

By linearity of $\tilde{f}(y, w ; l, m)$ with respect to the third argument, the bound (7.44) holds also for $f\left(y_{h}, w_{h} ; l, m\right)$, for every $l, m \in \mathbb{R}^{3},|l|=|m|=1$.

Introducing

## 8 Asymptotics of $\Gamma^{D}$

Given a bounded domain $D$ with boundary $\partial D$ of class $C^{1, \alpha}$, with constants $\rho_{0}, M_{0}, 0<\alpha \leq 1$, let $O \in \partial D$ and $\nu=\nu(O)$ the outer unit normal to $D$ at $O$.

Let us choose a coordinate system with origin $O$ and axis $e_{3}=-\nu$, and let $\Gamma^{+}(x, y)=\Gamma^{\mathbb{R}_{+}^{3}}(x, y)$ the normalized fundamental matrix associated to $D=\mathbb{R}_{+}^{3}$. We recall that its explicit expression was found by Rongved $\left.\mathbb{R}\right]$. See also Section 10 where Rongved's formulas shall be used in more detail.

Recalling the notation $u^{D}(x, y)=\Gamma^{D}(x, y) l($ see 5.3$)$ and defining similarly $u^{+}(x, y)=\Gamma^{+}(x, y) l$, for any $l \in \mathbb{R}^{3},|l|=1$, let us prove an asymptotic approximation of $u^{D}$ in terms of $u^{+}$.
Theorem 8.1. Let $y=(0,0,-h), 0<h<\frac{\rho_{0} M_{0}}{8 \sqrt{1+M_{0}^{2}}}$. Under the above assumptions and notation, we have

\end{gather*}

where $C>0$ only depends on $M_{0}, \alpha, \alpha_{0}, \gamma_{0}, \bar{\lambda}, \bar{\mu}$.

I_{2} & =\int_{\partial Q_{\frac{\rho}{2},}, \frac{\mu_{0}}{2}} \Gamma^{+}(\xi, z) m \cdot\left\{\left[\widetilde{\mathbb{C}}(\xi)\left(\nabla_{\xi} \widetilde{u}^{D}(\xi, \eta)(\widetilde{J}(\xi)-I d)\right)\right] \frac{\widetilde{J}^{T}(\xi)}{\operatorname{det} \widetilde{J}(\xi)}\right\} \nu_{\xi} d \sigma_{\xi}, \tag{8.22}

$I_{3}=-\int_{\partial Q_{\frac{\rho}{2}, \frac{\rho M_{0}}{2}}}\left[\widetilde{R}(\xi, \eta) \cdot\left(\widetilde{\mathbb{C}}(\xi) \nabla_{\xi}\left(\Gamma^{+}(\xi, z) m\right)\right) \nu_{\xi}-\Gamma^{+}(\xi, z) m \cdot\left(\widetilde{\mathbb{C}}(\xi) \nabla_{\xi} \widetilde{R}(\xi, \eta)\right) \nu_{\xi}\right] d \sigma_{\xi}$,
$I_{4}=\int_{Q_{\frac{\rho}{2}}, \frac{\rho M_{0}}{2}} \nabla_{\xi}\left(\Gamma^{+}(\xi, z) m\right) \cdot\left\{\left[\widetilde{\mathbb{C}}(\xi) \nabla_{\xi} \widetilde{u}^{D}(\xi, \eta)\right]\left(I d-\frac{\widetilde{J}^{T}(\xi)}{\operatorname{det} \widetilde{J}(\xi)}\right)\right\} d \xi$,

& I_{4 b}^{\prime \prime}=\int_{Q \cap\{|\xi| \geq 4|\eta-z|\}} \nabla_{\xi}\left(\Gamma^{+}(\xi, z) m\right) \cdot\left\{\left[\widetilde{\mathbb{C}}(\xi) \nabla_{\xi} \widetilde{u}^{D}(\xi, \eta)\right]\left(I d-\frac{\widetilde{J}^{T}(\xi)}{\operatorname{det} \widetilde{J}(\xi)}\right)\right\} d \xi . \tag{8.38}

Q_{\frac{\rho}{8}, \frac{\rho M_{0}}{8}} \cap D \subset \Phi^{-1}\left(Q_{\frac{\rho}{4}, \frac{\rho M_{0}}{+}}^{4}\right),  \tag{8.55}\\
Q_{\frac{\rho}{8}}, \frac{\rho M_{0}}{8} \backslash \bar{D} \subset \Phi^{-1}\left(Q_{\frac{\rho}{4}}^{-}, \frac{\rho M_{0}}{4}\right) . \tag{8.56}

Let $\widetilde{x}=\left(x^{\prime}, \varphi\left(x^{\prime}\right)\right) \in \partial D$ and $\bar{x}=\Phi(\widetilde{x})=\left(x^{\prime}, 0\right)$. By using the $C^{1}$ regularity of $u^{+}$separately in $\overline{\mathbb{R}^{3+}}$ and in $\overline{\mathbb{R}^{3-}}$, we have

where $w^{+} \in S^{+}=[\Phi(x), \bar{x}], w^{-} \in S^{-}=[\bar{x}, x]$. Let $\widetilde{w}^{+}=\Phi^{-1}\left(w^{+}\right)$. Since $w^{+} \in[\bar{x}, \Phi(x)]$, by (8.50) we have that $\widetilde{w}^{+} \in\left[\Phi^{-1}(\bar{x}), \Phi^{-1}(\Phi(x))\right]=[\widetilde{x}, x]$. Noticing that $\left|w^{-}-y\right|=$ $\left|\Phi\left(\widetilde{w}^{-}\right)-\Phi(y)\right| \geq C\left|\widetilde{w}^{-}-y\right|$, in both cases, by (5.6), we have

This choice ensures that estimates (8.1), (8.2) hold for $D=D_{1}$ in $B_{\rho}(O) \cap D_{1}$ and $B_{\rho}^{+}(O) \cap D_{1}$, respectively. For simplicity, in the following we shall denote $B_{\rho}=B_{\rho}(O), B_{\rho}^{+}=B_{\rho}^{+}(O)$.

Remark 9.4. We note that for the present purposes it would suffice to prove that (9.19) holds true for at least one $i=1,2,3$. We believe that such a result, slightly stronger than necessary, may be instructive because we shall show by examples (Section 10) that there may be values of $\lambda_{w}$ for which $\left(\Gamma^{+}\left(y_{0}, w_{0}\right)-\Gamma\left(y_{0}, w_{0}\right)\right) e_{i} \cdot e_{i}$ may indeed equal zero.

On the other hand, taking advantage of the explicit character of $\Gamma^{+}$, we shall prove that $\left(\Gamma^{+}\left(y_{0}, w_{0}\right)-\Gamma\left(y_{0}, w_{0}\right)\right) e_{i} \cdot e_{i}$ may vanish only for finitely many values of $\lambda_{w}$.

Finally, let us note that we restrict the choice of $\lambda_{w}$ to three specific values just for the sake of definiteness and also with the purpose of having (9.19) in a constructive form.

## 10 Rongved's fundamental solution and proof of Proposition 9.3

In this section, in order to prove Proposition 9.3, we investigate whether there exist directions $l, m$ for which there exists $w_{0}=(0,0,-c), 0<c<1$, such that

Consider the two halfspaces $R^{3+}=\{(x, y, z) \mid z>0\}, R^{3-}=\{(x, y, z) \mid z<0\}$ made by homogeneous Lamé materials with moduli $(\mu, \nu),\left(\mu^{I}, \nu^{I}\right)$, respectively. The two half-spaces are glued together on the interface $z=0$, that is the traction and the displacement both are continuous across the interface $z=0$. The problem of determining the displacement field

Furthermore we observe that, being the space of real second degree polynomials a 3 -dimensional linear space, for any three distinct values $t_{1}, t_{2}$, $t_{3} \in \mathbb{R}$ we have

In conclusion, picking any three distinct values $c_{1}, c_{2}, c_{3} \in\left[\frac{2}{3}, \frac{4}{5}\right]$ (for the sake of concreteness we may choose $c_{1}=\frac{2}{3}, c_{2}=\frac{3}{4}, c_{3}=\frac{4}{5}$ ), we obtain that there exists $i \in\{1,2,3\}$ such that $w_{0}=\left(0,0,-c_{i}\right)$ satisfies

An inspection of the polynomial $\mathcal{P}$ analogous to the one performed above leads again to the conclusion that, picking $c_{1}=\frac{2}{3}, c_{2}=\frac{3}{4}, c_{3}=\frac{4}{5}$, there exists $i \in\{1,2,3\}$ such that $w_{0}=\left(0,0,-c_{i}\right)$ satisfies

Hence only diagonal terms of $\Gamma^{+}-\Gamma$ appear to be relevant.

### 10.1 Examples

Let us conclude the present section with a remark emphasizing an interesting difference with respect to the electrostatic case. For the analogous inverse problem in electrostatics, which involves the Laplace operator, from the explicit expression of $\Gamma^{+}$given, for instance, by (3.11) in [A-DiC], it easy to see that

for any choice of different constant values of the conductivity within the inclusion $D$ and in $\Omega \backslash D$. On the contrary, an analogous result does not hold in the isotropic elastic case. Since for current materials, the Poisson coefficient takes positive value, let us restrict our analysis to the cases in which $0<\nu<\frac{1}{2}$ and $0<\nu^{I}<\frac{1}{2}$.

In case $m=l=e_{3}$, taking the limit in 10.27) as $w_{0}$ tends to $y_{0}$, that is choosing $t=2$, one finds

& +16 \mu \mu^{I} \nu^{2}+56 \mu \mu^{I} \nu \nu^{I}+16\left(\mu^{I}\right)^{2} \nu^{2}+48 \mu^{2} \nu+28 \mu^{2} \nu^{I}-28 \mu \mu^{I} \nu- \\
&  \tag{10.45}\\
& \quad-20 \mu \mu^{I} \nu^{I}-28\left(\mu^{I}\right)^{2} \nu-21 \mu^{2}+10 \mu \mu^{I}+11\left(\mu^{I}\right)^{2} .

The polynomial $Q$ is homogeneous of degree 2 in $\mu$ and $\mu^{I}$, and of degree 1 in $\nu^{I}$. Setting $s=\frac{\mu}{\mu^{I}}$ and dividing by $\left(\mu^{I}\right)^{2}$, we obtain

& +48 \nu s^{2}+28 \nu^{I} s^{2}+16 \nu^{2}-28 \nu s-20 \nu^{I} s-21 s^{2}-28 \nu+10 s+11 . \tag{10.47}

Solving $Q_{2}=0$ with respect to $\nu^{I}$, we have

From (10.48) it is possible to determine triples of values $\left(\nu, \nu^{I}, s\right)$ satisfying (10.48) and such that $0<\nu<\frac{1}{2}, 0<\nu^{I}<\frac{1}{2}, 0<s \neq 1$, for instance

$\left(\frac{1}{8}, \frac{17}{36}, \frac{6}{5}\right),\left(\frac{1}{4}, \frac{661}{1628}, \frac{11}{10}\right),\left(\frac{3}{8}, \frac{17}{36}, \frac{11}{10}\right)$. Therefore there exist infinitely many pairs of materials $\{\mu, \nu\},\left\{\mu^{I}, \nu^{I}\right\}$ such that $\left(\Gamma_{33}^{+}-\Gamma_{33}\right)\left(y_{0}, y_{0}\right)=0$.

Figure 1 shows the intersection of the surface $Q_{2}=0$ with the set $\left\{\left(\nu, \nu^{I}, s\right) \left\lvert\, 0<\nu<\frac{1}{2}\right., 0<\nu^{I}<\frac{1}{2}, 0<s<2\right\}$. It is evident from this graph that for each couple $\left(\nu, \nu^{I}\right)$ of Poisson coefficients such that $0<\nu<$ $\frac{1}{2}, 0<\nu^{I}<\frac{1}{2}$, there exists a positive value of $s$ such that $Q_{2}\left(\nu, \nu^{I}, s\right)=0$.

Moreover, substituting $s=1$ in the expression of $Q_{2}$, one finds

$$

Q_{2}\left(\nu, \nu^{I}, 1\right)=8(\nu-1)\left(\nu-\nu^{I}\right), \tag{10.49}
\end{equation*}

which has no zero when $\nu \neq \nu^{I}$. This implies that for each couple $\left(\nu, \nu^{I}\right)$ of Poisson coefficients such that $0<\nu<\frac{1}{2}, 0<\nu^{I}<\frac{1}{2}, \nu \neq \nu^{I}$, there exists $\bar{s}$, $0<\bar{s} \neq 1$ such that $Q_{2}\left(\nu, \nu^{I}, \bar{s}\right)=0$, that is $Q_{2}\left(\nu, \nu^{I}, \bar{s} \mu^{I}, \mu^{I}\right)=0$ for any $\mu^{I}>0$. Moreover, from (10.49) it follows that if $\mu=\mu^{I}$, then for any choice of the Poisson coefficients, such that $\nu \neq \nu^{I}$, then $Q_{2} \neq 0$ and therefore $\left(\Gamma_{33}^{+}-\Gamma_{33}\right)\left(y_{0}, y_{0}\right) \neq 0$.

Next, putting $\nu^{I}=\nu$ in the expression of $Q_{2}$, one finds

that is the intersection of the surface $Q_{2}=0$ with the plane $\nu=\nu^{I}$, when represented in the plane ( $\nu^{I}, s$ ), splits in the line $s=1$ and in an algebraic curve of degree 3. Figure 2, which contains the graph of this curve and of the line $s=1$, shows that in our set of interest, $0<\nu<\frac{1}{2}$, the only solution is

$s=1$, that is if the Poisson coefficients coincide, but $\mu \neq \mu^{I}$ (that is $s \neq 1$ ), then $\left(\Gamma_{33}^{+}-\Gamma_{33}\right)\left(y_{0}, y_{0}\right) \neq 0$.

In case $m=l=e_{2}$ and taking the limit in the complete expression of (10.37) as $w_{0}$ tends to $y_{0}$, that is choosing $t=2$, one finds

Therefore there exist infinitely many pairs of materials $\{\mu, \nu\},\left\{\mu^{I}, \nu^{I}\right\}$ such that $\left(\Gamma_{22}^{+}-\right.$ $\left.\Gamma_{22}\right)\left(y_{0}, y_{0}\right)=0$.

Figure 3 shows the intersection of the surface $Q_{2}=0$ with the set $\left\{\left(\nu, \nu^{I}, s\right) \left\lvert\, 0<\nu<\frac{1}{2}\right., 0<\nu^{I}<\frac{1}{2}, 0<s<2\right\}$. It is evident from this graph that for each couple $\left(\nu, \nu^{I}\right)$ of Poisson coefficients such that $0<\nu<$ $\frac{1}{2}, 0<\nu^{I}<\frac{1}{2}$, there exists a positive value of $s$ such that $Q_{2}\left(\nu, \nu^{I}, s\right)=0$.

Moreover, substituting $s=1$ in the expression of $Q_{2}$, one finds

$$
\begin{equation*}
Q_{2}\left(\nu, \nu^{I}, 1\right)=16(\nu-1)\left(\nu-\nu^{I}\right), \tag{10.58}
\end{equation*}
$$

which has no zero when $\nu \neq \nu^{I}$. This implies that for each couple $\left(\nu, \nu^{I}\right)$ of Poisson coefficients such that $0<\nu<\frac{1}{2}, 0<\nu^{I}<\frac{1}{2}, \nu \neq \nu^{I}$, there exists $\bar{s}$, $0<\bar{s} \neq 1$ such that $Q_{2}\left(\nu, \nu^{I}, \bar{s}\right)=0$, that is $Q_{2}\left(\nu, \nu^{I}, \bar{s} \mu^{I}, \mu^{I}\right)=0$ for any $\mu^{I}>0$. Moreover, from (10.58) it follows that if $\mu=\mu^{I}$, then for any choice of the Poisson coefficients, such that $\nu \neq \nu^{I}$, then $Q_{2} \neq 0$ and therefore $\left(\Gamma_{22}^{+}-\Gamma_{22}\right)\left(y_{0}, y_{0}\right) \neq 0$.

Next, putting $\nu^{I}=\nu$ in the expression of $Q_{2}$, one finds

$$
\begin{align*}
& Q_{2}(\nu, \nu, s)=(s-1) \cdot\left[32 \nu^{3} s^{2}+96 \nu^{3} s-72 \nu^{2} s^{2}-\right. \\
& \left.\quad-232 \nu^{2} s+64 \nu s^{2}-32 \nu^{2}+192 \nu s-21 s^{2}+48 \nu-56 s-19\right] \tag{10.59}
\end{align*}
$$

that is the intersection of the surface $Q_{2}=0$ with the plane $\nu=\nu^{I}$, when represented in the plane $(\nu, s)$, splits in the line $s=1$ and in an algebraic curve of degree 5. Figure 4, which contains the graph of this curve and of the line $s=1$, shows that in our set of interest, $0<\nu<\frac{1}{2}$, the only solution is $s=1$, that is if the Poisson coefficients coincide, but $\mu \neq \mu^{I}$ (that is $s \neq 1$ ), then $\left(\Gamma_{22}^{+}-\Gamma_{22}\right)\left(y_{0}, y_{0}\right) \neq 0$.

Analogous considerations hold, for symmetry evidence, when studying $\left(\Gamma_{11}^{+}-\Gamma_{11}\right)\left(y_{0}, y_{0}\right)$.

## 11 Metric lemmas, proofs

In order to prove Lemma 4.2, we shall use the following results.

Lemma 11.1. [Lemma 5.5 in $[A-R-R o-V e]]$ Let $U$ be a Lipschitz domain in $\mathbb{R}^{3}$ with constants $\rho_{0}, M_{0}$. There exists $h_{0}, 0<h_{0}<1$, only depending on $M_{0}$, such that

$$
\begin{equation*}
U_{h \rho_{0}} \text { is connected for every } h, 0<h \leq h_{0} \text {. } \tag{11.1}
\end{equation*}
$$

Theorem 11.2. [Theorem 3.6 in $[A-B-$ Ro-Ve $]]$ There exist positive constants $d_{0}, r_{0}, L_{0}, L_{0} \leq M_{0}$, with $\frac{d_{0}}{\rho_{0}}, \frac{r_{0}}{\rho_{0}}$ only depending on $M_{0}$ and $L_{0}$ only depending on $\alpha$ and $M_{0}$, such that if

$$
\begin{equation*}
d_{H}\left(\partial D_{1}, \partial D_{2}\right) \leq d_{0}, \tag{11.2}
\end{equation*}
$$

then $\partial \Omega_{D}$ is Lipschitz with constants $r_{0}$ and $L_{0}$. Moreover, for every $P \in$ $\partial \Omega_{D} \cap \partial D_{1}$, up to a rigid transformation of coordinates which maps $P$ into the origin and $e_{3}=-\nu$, where $\nu$ is the outer unit normal to $D_{1}$ at $P$, we have

$$
\begin{gather*}
D_{i} \cap B_{r_{0}}(P)=\left\{x \in B_{r_{0}}(0) \mid x_{3}>\varphi_{i}\left(x^{\prime}\right)\right\}, \quad i=1,2,  \tag{11.3}\\
\varphi_{1}(0)=0, \quad \nabla \varphi_{1}(0)=0,  \tag{11.4}\\
\left\|\varphi_{i}\right\|_{C^{0,1}\left(B_{r_{0}}^{\prime}(0)\right)} \leq L_{0} r_{0}, \quad i=1,2 . \tag{11.5}
\end{gather*}
$$

An analogous representation holds for every $P \in \partial \Omega_{D} \cap \partial D_{2}$.
Proof of Lemma 4.2. Let

$$
\begin{equation*}
d_{1}=\frac{d_{0}}{c_{0}} \tag{11.6}
\end{equation*}
$$

where $c_{0}$ is the constant introduced in Lemma 4.1, and let

$$
\begin{equation*}
d_{2}=\min \left\{d_{1}, h_{0} \rho_{0}\right\} \tag{11.7}
\end{equation*}
$$

where $h_{0}, 0<h_{0}<1$, only depending on $M_{0}$, has been introduced in Lemma 11.1. We shall distinguish two cases.

Case i) Let $d_{\mu} \leq d_{1}$.
Then, by Lemma 4.1 we have $d_{H}\left(\partial D_{1}, \partial D_{2}\right) \leq d_{0}$. Therefore, by Theorem 11.2. $\partial \Omega_{D}$ is Lipschitz with constants $r_{0}, L_{0}$, where $\frac{r_{0}}{\rho_{0}}$ only depends on $M_{0}$, and $L_{0}$ only depends on $M_{0}$ and $\alpha$. We may apply Lemma 11.1 to $\mathbb{R}^{3} \backslash \Omega_{D}$ obtaining that there exists $\widetilde{h}_{0}, 0<\widetilde{h}_{0}<1$, only depending on $\alpha$ and $M_{0}$, such that $\left(\mathbb{R}^{3} \backslash \Omega_{D}\right)_{h r_{0}}$ is connected for every $h \leq \widetilde{h}_{0}$.

Let $P \in \partial D_{1} \cap \partial \Omega_{D}$ be such that

$$
\begin{equation*}
d_{\mu}\left(D_{1}, D_{2}\right)=\operatorname{dist}\left(P, D_{2}\right) \tag{11.8}
\end{equation*}
$$

Under the coordinate system introduced in Theorem 11.2, let us consider the point $Q=P-\frac{\widetilde{h}_{0} r_{0}}{2} e_{3}$. We have that

$$
\begin{equation*}
\operatorname{dist}\left(Q, \Omega_{D}\right) \geq \frac{\widetilde{h}_{0} r_{0}}{2 \sqrt{1+L_{0}^{2}}} \tag{11.9}
\end{equation*}
$$

Let us denote $h_{1}=\frac{\widetilde{h}_{0}}{2 \sqrt{1+L_{0}^{2}}}$. Since $h_{1}<\widetilde{h}_{0}$, the set $\overline{\left(\mathbb{R}^{3} \backslash \Omega_{D}\right)_{h_{1} r_{0}}}$ is connected and contains $Q$. Therefore, there exists a path $\gamma \subset \overline{\left(\mathbb{R}^{3} \backslash \Omega_{D}\right)_{h_{1} r_{0}}}$ joining any point $P_{0} \in S_{2 \rho_{0}}$ with $Q$. Therefore, in the above coordinate system, the set $V(\gamma)$ satisfies

$$
\begin{equation*}
V(\gamma) \subset \mathbb{R}^{3} \backslash \Omega_{D} \tag{11.10}
\end{equation*}
$$

provided

$$
\begin{equation*}
d=\frac{\widetilde{h}_{0} r_{0}}{2}, \quad R=\frac{d}{\sqrt{1+L_{0}^{2}}} \tag{11.11}
\end{equation*}
$$

Case ii) Let $d_{\mu} \geq d_{1}$.
Then, trivially, $d_{\mu} \geq d_{2}$. Let $\widetilde{P} \in \partial D_{1} \cap \partial \Omega_{D}$ be such that

$$
\begin{equation*}
d_{\mu}\left(D_{1}, D_{2}\right)=\operatorname{dist}\left(\widetilde{P}, D_{2}\right) . \tag{11.12}
\end{equation*}
$$

Since $d_{2} \leq h_{0} \rho_{0}$, by Lemma 11.1, $\left(\mathbb{R}^{3} \backslash D_{2}\right)_{d_{2}}$ is connected. Therefore, given any point $P_{0} \in S_{2 \rho_{0}}$, there exists a path $\gamma, \gamma:[0,1] \rightarrow\left(\mathbb{R}^{3} \backslash D_{2}\right)_{d_{2}}$ such that $\gamma(0) \in S_{2 \rho_{0}}$ and $\gamma(1)=\widetilde{P}$. Let $\bar{t}=\inf _{t \in[0,1]}\left\{t \left\lvert\, \operatorname{dist}\left(\gamma(t), \partial D_{1}\right)>\frac{d_{2}}{2}\right.\right\}$. By definition, $\operatorname{dist}\left(\gamma(\bar{t}), \partial D_{1}\right)=\frac{d_{2}}{2}$, so that there exists $P \in \partial D_{1}$ satisfying $|P-\gamma(\bar{t})|=\frac{d_{2}}{2}$. We have that

$$
\begin{equation*}
\operatorname{dist}\left(P, D_{2}\right) \geq \operatorname{dist}\left(\gamma(\bar{t}), D_{2}\right)-|\gamma(\bar{t})-P| \geq d_{2}-\frac{d_{2}}{2}=\frac{d_{2}}{2} . \tag{11.13}
\end{equation*}
$$

Let $\bar{\gamma}=\left.\gamma\right|_{[0, t]}$ and let us choose a cartesian coordinate system with origin $O$ at $P$, and $e_{3}=-\nu$, where $\nu$ is the outer unit normal to $D_{1}$ at $P$. We have that

$$
\begin{equation*}
V(\bar{\gamma}) \subset \mathbb{R}^{3} \backslash \Omega_{D} \tag{11.14}
\end{equation*}
$$

assuming

$$
\begin{equation*}
d=\frac{d_{2}}{2}, \quad R=\frac{d}{\sqrt{1+M_{0}^{2}}} . \tag{11.15}
\end{equation*}
$$

Let

$$
\begin{equation*}
\bar{d}=\min \left\{\frac{\widetilde{h}_{0} r_{0}}{2}, \frac{d_{0}}{2 c_{0}}, \frac{h_{0} \rho_{0}}{2}\right\}, \tag{11.16}
\end{equation*}
$$

and let us notice that $\frac{\bar{d}}{\rho_{0}}$ only depends on $M_{0}, \alpha$. Observing that $L_{0} \leq M_{0}$, formula (4.9) follows with $\bar{d}$ given in 11.16). Since there exists a positive constant $C$ only depending on $M_{0}, M_{1}$ such that $\operatorname{diam}(\Omega) \leq C \rho_{0}$, we have that

$$
\begin{equation*}
d_{\mu} \leq\left(\frac{\operatorname{diam}(\Omega)}{\frac{d_{2}}{2}}\right) \frac{d_{2}}{2} \leq \widetilde{c}_{1} \frac{d_{2}}{2} \tag{11.17}
\end{equation*}
$$

with $\widetilde{c}_{1}$ only depending on $M_{0}, \alpha$ and $M_{1}$. Letting $c_{1}=\min \left\{1, \frac{1}{\widetilde{c}_{1}}\right\}$, inequality (4.8) follows.
