The Cauchy problem for \mathcal{D} -modules on Ran spaces.

Abstract

We will adopt an elementary approach to \mathscr{D} -modules on Ran spaces in terms of two-limits; the aim here is to define the category of coherent \mathscr{D} -modules, characteristic varieties and non-characteristic maps. An application will be the proof of the Cauchy-Kowaleski-Kashiwara theorem in this setting.

1 Introduction

The pioneering work [BD04] on the geometric foundations of Quantum Field Theory and Conformal Field Theory stressed the importance played by so-called Ran spaces. For example chiral, Lie* and factorization algebras can be considered as geometric objects living on such spaces (see [BD04]). The most appropriate approach to the theory of \mathscr{D} -modules on Ran spaces (as presented in [FG11]) requires many sophisticated tools from Lurie's work on $(\infty, 1)$ -categories. The main goal of this paper is to explore some definitions and properties of \mathscr{D} -modules on Ran spaces employing the classical theory of prestacks and two limits ([SGA4]). This simplified approach makes the theory accessible and sheds light on some definitions: the notions of characteristic varieties and of coherent \mathscr{D} -modules are really natural in this language. In paragraph §2 we recall some basics on the classical theory of \mathscr{D} -modules and microlocal geometry; in §3 we recall some definitions relative to prestacks, two-limits, etc.; in paragraph §4 we introduce the theory of modules on Ran manifolds by the use of §3; as an application we prove the Cauchy-Kowaleski-Kashiwara theorem for Ran manifolds.

2 Preliminaries

Sheaves

We shall mainly follow the notations of [KS90] for sheaves, that of [KS06] for categories and that of [Ka03] for \mathscr{D} -modules.

Let X be a real manifold and let \mathbf{k} be a field. One denotes by \mathbf{k}_X the constant sheaf on X with stalk \mathbf{k} and by $\operatorname{Mod}(\mathbf{k}_X)$ the abelian category of sheaves of \mathbf{k} -modules on X. We denote by $\operatorname{D}^{\mathrm{b}}(\mathbf{k}_X)$ the bounded derived category of $\operatorname{Mod}(\mathbf{k}_X)$. One simply calls an object of this category, "a sheaf".

We shall use the classical six operations on sheaves, the internal hom $\mathscr{H}om$, the tensor product \otimes , the direct image f_* , the proper direct image $f_!$, the inverse image f^{-1} and the derived functors $R\mathscr{H}om$, $\overset{L}{\otimes}$, Rf_* , $Rf_!$, f^{-1} , as well as the extraordinary inverse image $f^!$, right adjoint to $Rf_!$.

We also use the notation \boxtimes for the external product: if X and Y are two manifolds and where q_1 and q_2 denote the first and second projection on $X \times Y$, we set for $F \in \operatorname{Mod}(\mathbf{k}_X)$ and $G \in \operatorname{Mod}(\mathbf{k}_Y)$, one sets $F \boxtimes G := q_1^{-1}F \otimes q_2^{-1}G$.

Microlocal geometry

For a real or complex manifold X, we denote by $\tau \colon TX \to X$ its tangent vector bundle and by $\pi \colon T^*X \to X$ its cotangent vector bundle. If $E \to X$ is a vector bundle, we identify X with the zero-section.

Let $f: X \to Y$ be a morphism of real or complex manifolds. To f are associated the tangent morphisms

$$(2.1) TX \xrightarrow{f'} X \times_Y TY \xrightarrow{f_\tau} TY$$

$$\downarrow^\tau \qquad \qquad \downarrow^\tau \qquad \downarrow^\tau$$

$$X = X \xrightarrow{f} Y.$$

By duality, we deduce the diagram:

$$(2.2) T^*X \xrightarrow{f_d} X \times_Y T^*Y \xrightarrow{f_{\pi}} T^*Y$$

$$\downarrow^{\pi} \qquad \qquad \downarrow^{\pi} \qquad \qquad \downarrow^{\pi}$$

$$X = X \xrightarrow{f} Y$$

One sets

$$T_X^*Y := \ker f_d = f_d^{-1}(T_X^*X).$$

Definition 2.1. Let $\Lambda \subset T^*Y$ be a closed \mathbb{R}^+ -conic subset. One says that f is non-characteristic for Λ , or else, Λ is non-characteristic for f, if

$$f_{\pi}^{-1}(\Lambda) \cap T_X^*Y \subset X \times_Y T_Y^*Y.$$

O-modules

Now assume that (X, \mathcal{O}_X) is a complex manifold of complex dimension d_X . We denote by $\operatorname{Mod}(\mathcal{O}_X)$ the abelian category of sheaves of \mathcal{O}_X -modules and by $\operatorname{\mathscr{H}\!\mathit{om}}_{\mathcal{O}_X}$ and $\otimes_{\mathcal{O}_X}$ the internal hom and tensor product in this category. The sheaf of rings \mathcal{O}_X is Noetherian and we denote by $\operatorname{Mod}_{\operatorname{coh}}(\mathcal{O}_X)$ the thick abelian subcategory of $\operatorname{Mod}(\mathcal{O}_X)$ consisting of coherent sheaves.

We denote by $D^b(\mathscr{O}_X)$ the bounded derived category of $\operatorname{Mod}(\mathscr{O}_X)$ and by $D^b_{\operatorname{coh}}(\mathscr{O}_X)$ the full triangulated subcategory consisting of objects with coherent cohomology.

Let $f: X \to Y$ be a morphism of complex manifolds. We keep the notation f_* and $f_!$ for the two direct image functors for \mathscr{O} -modules and we denote by f^* the inverse image functor for \mathscr{O} -modules:

$$f^*\mathscr{G} := \mathscr{O}_X \otimes_{f^{-1}\mathscr{O}_Y} f^{-1}\mathscr{G}.$$

Hence we have the pair of adjoint functors (f^*, f_*)

$$\operatorname{Mod}(\mathscr{O}_X) \xrightarrow{f_*} \operatorname{Mod}(\mathscr{O}_Y)$$

It follows that f_* is left exact and f^* is right exact. We denote by Lf^* the left derived functor of f^* .

Given two manifolds X and Y, we denote by $\underline{\boxtimes}$ the external product for \mathscr{O} -modules. Hence,

$$\mathscr{F}\underline{\boxtimes}\mathscr{G}:=\mathscr{O}_{X\times Y}\otimes_{\mathscr{O}_{X}\boxtimes\mathscr{O}_{Y}}(\mathscr{F}\boxtimes\mathscr{G}).$$

\mathscr{D} -modules

We denote by \mathscr{D}_X the sheaf of rings of holomorphic differential operators, the subalgebra of $\mathscr{E}nd(\mathscr{O}_X)$ generated by \mathscr{O}_X and Θ_X , the sheaf of holomorphic vector fields.

Unless otherwise specified, a \mathscr{D}_X -module is a left- \mathscr{D}_X -module. Hence a right \mathscr{D}_X -module is a $(\mathscr{D}_X^{\text{op}})$ -module. We denote by $\text{Mod}(\mathscr{D}_X)$ the abelian category of \mathscr{D}_X -modules and by $D^{\text{b}}(\mathscr{D}_X)$ its bounded derived category.

Recall the operations

$$\begin{split} \mathscr{H}\!\mathit{om}_{\,\mathscr{O}_X} : & \operatorname{Mod}(\mathscr{D}_X)^{\operatorname{op}} \times \operatorname{Mod}(\mathscr{D}_X) \to \operatorname{Mod}(\mathscr{D}_X), \\ \mathscr{H}\!\mathit{om}_{\,\mathscr{O}_X} : & \operatorname{Mod}(\mathscr{D}_X^{\operatorname{op}})^{\operatorname{op}} \times \operatorname{Mod}(\mathscr{D}_X^{\operatorname{op}}) \to \operatorname{Mod}(\mathscr{D}_X), \\ \otimes_{\mathscr{O}_X} : & \operatorname{Mod}(\mathscr{D}_X) \times \operatorname{Mod}(\mathscr{D}_X) \to \operatorname{Mod}(\mathscr{D}_X), \\ \otimes_{\mathscr{O}_X} : & \operatorname{Mod}(\mathscr{D}_X^{\operatorname{op}}) \times \operatorname{Mod}(\mathscr{D}_X) \to \operatorname{Mod}(\mathscr{D}_X^{\operatorname{op}}). \end{split}$$

We denote by $\underline{\boxtimes}$ the external product for \mathscr{D} -modules:

$$\mathscr{M}\underline{\boxtimes}\mathscr{N}:=\mathscr{D}_{X\times Y}\otimes_{\mathscr{D}_{X}\boxtimes\mathscr{D}_{Y}}(\mathscr{M}\boxtimes\mathscr{N}).$$

For a morphism $f: X \to Y$ of complex manifolds, we denote as usual by $\mathscr{D}_{X \to Y}$ the transfert bimodule, a $(\mathscr{D}_X, f^{-1}\mathscr{D}_Y)$ -bimodule

$$\mathscr{D}_{X \to Y} := \mathscr{O}_X \otimes_{f^{-1}\mathscr{O}_Y} f^{-1}\mathscr{D}_Y.$$

One should be aware that the left \mathscr{D}_X structure of $\mathscr{D}_{X\to Y}$ is not the one induced by that of \mathscr{O}_X . We then have the inverse and direct image functors

$$f^{D}: \mathrm{D^{b}}(\mathscr{D}_{Y}) \to \mathrm{D^{b}}(\mathscr{D}_{X}), \quad f^{D}\mathscr{N} = \mathscr{D}_{X \to Y} \overset{\mathrm{L}}{\otimes}_{f^{-1}\mathscr{D}_{Y}} f^{-1}\mathscr{N},$$
$$f_{D}: \mathrm{D^{b}}(\mathscr{D}_{X}^{\mathrm{op}}) \to \mathrm{D^{b}}(\mathscr{D}_{Y}^{\mathrm{op}}), \quad f_{D}(\mathscr{M}) = \mathrm{R}f_{*}(\mathscr{M} \overset{\mathrm{L}}{\otimes}_{\mathscr{D}_{Y}} \mathscr{D}_{X \to Y}).$$

We denote by $\operatorname{Mod}_{\operatorname{coh}}(\mathscr{D}_X)$ the thick abelian subcategory of $\operatorname{Mod}(\mathscr{D}_X)$ consisting of coherent \mathscr{D}_X -modules and by $\operatorname{D}^{\operatorname{b}}_{\operatorname{coh}}(\mathscr{D}_X)$ the full triangulated subcategory consisting of objects with coherent cohomology.

For $\mathscr{M} \in \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}}(\mathscr{D}_X)$, we denote by $\mathrm{char}(\mathscr{M})$ its characteristic variety, a closed \mathbb{C}^{\times} -conic complex analytic subvariety of T^*X .

The Cauchy-Kowaleski-Kashiwara theorem

Definition 2.2. Let $f: X \to Y$ be a morphisms of manifolds and \mathscr{N} be a coherent \mathscr{D}_Y -module. One says that f is non-characteristic for \mathscr{N} if f is non-characteristic for $\operatorname{char}(\mathscr{N})$.

Proposition 2.3. ([Ka70]) Let \mathcal{N} be a coherent \mathcal{D}_Y -module. Suppose that $f: X \to Y$ is non-characteristic for \mathcal{N} . Then

- (a) $H^k(f^D \mathcal{N}) = 0$ for $k \neq 0$,
- (b) $H^0(f^D \mathcal{N})$ is a coherent \mathcal{D}_X -module,
- (c) $\operatorname{char}(f^D \mathcal{N}) = f_d f_{\pi}^{-1} \operatorname{char} \mathcal{N}$.

For \mathcal{N}_1 and \mathcal{N}_2 in $D^b(\mathcal{D}_Y)$ we have a natural morphism

$$f^{-1}R\mathcal{H}om_{\mathscr{D}_{X}}(\mathscr{N}_{1},\mathscr{N}_{2}) \to R\mathcal{H}om_{\mathscr{D}_{X}}(f^{D}\mathscr{N}_{1},f^{D}\mathscr{N}_{2}).$$

Note that $f^D \mathcal{O}_X \simeq \mathcal{O}_Y$.

The following theorem is known as the Cauchy-Kovalesky-Kashiwara theorem:

Theorem 2.4. ([Ka70]) Let $f: X \to Y$ be a morphism of complex manifolds and \mathcal{N} be a coherent \mathcal{D}_Y -module. If f is non-characteristic for \mathcal{N} , then

$$(2.3) f^{-1}R\mathcal{H}om_{\mathscr{D}_{Y}}(\mathscr{N},\mathscr{O}_{Y}) \to R\mathcal{H}om_{\mathscr{D}_{X}}(f^{D}\mathscr{N},\mathscr{O}_{X})$$

is an isomorphism.

3 Grothendieck stacks

References for this section are made to [SGA4] (see also [KS06] for an exposition). The results of this section are well-known to the specialists. We will work in a given universe \mathcal{U} , a category means a \mathcal{U} -category and a set means a small set. Here **Cat** denotes the big 2-category of all \mathcal{U} -categories.

Prestack

Let \mathfrak{S} be a 2-projective system of categories indexed by a small category \mathfrak{I} , that is, a functor $\mathfrak{S}: \mathfrak{I}^{\mathrm{op}} \to \mathbf{Cat}$. For short, we consider \mathfrak{I} as a presite and call \mathfrak{S} a prestack on \mathfrak{I} . Hence

- (a) for each $i \in \mathcal{I}$, $\mathfrak{S}(i)$ is a category;
- (b) for each morphism $s: i_1 \to i_2$ in \mathfrak{I} , $\mathfrak{S}(s)$ is a functor $\mathfrak{S}(i_2) \to \mathfrak{S}(i_1)$, called the restriction functor (for convenience, we shall write in the sequel ρ_s instead of $\mathfrak{S}(s)$);

(c) for $s: i_1 \to i_2$ and $t: i_2 \to i_3$, we have an isomorphism of functor $c_{s,t}: \rho_s \circ \rho_t \xrightarrow{\sim} \rho_{t \circ s}$, making the diagram below commutative for each $u: i_3 \to i_4$:

$$\begin{array}{c|c}
\rho_s \circ \rho_t \circ \rho_u \xrightarrow{c_{t,u}} \rho_s \circ \rho_{u \circ t} \\
c_{s,t} \downarrow & \downarrow c_{s,u \circ t} \\
\rho_{t \circ s} \circ \rho_u \xrightarrow{c_{t \circ s,u}} \rho_{u \circ t \circ s}.
\end{array}$$

(d) finally $\rho_{\mathrm{id}_i} = \mathrm{id}_{\mathfrak{S}(i)}$ and $c_{\mathrm{id}_i,\mathrm{id}_i} = \mathrm{id}_{\mathrm{id}_{\mathfrak{S}(i)}}$ for any $i \in \mathcal{I}$.

Functor of prestacks

Let \mathfrak{S}_{ν} ($\nu = 1, 2$) be prestacks on \mathfrak{I} with the restrictions ρ_s^{ν} and the composition isomorphisms $c_{s,t}^{\nu}$.

Recall that a functor of prestacks $\Phi \colon \mathfrak{S}_1 \to \mathfrak{S}_2$ on $\mathfrak I$ is the data of:

- (a) for any $i \in \mathcal{I}$, a functor $\Phi(i) \colon \mathfrak{S}_1(i) \to \mathfrak{S}_2(i)$;
- (b) for any morphism $s: i_1 \to i_2$, an isomorphism Φ_s of functors from $\mathfrak{S}_1(i_2)$ to $\mathfrak{S}_2(i_1)$

$$\Phi_s \colon \Phi(i_1) \circ \rho_s^1 \xrightarrow{\sim} \rho_s^2 \circ \Phi(i_2);$$

these data satisfying: for any sequence of morphisms $i_1 \xrightarrow{s} i_2 \xrightarrow{t} i_3$ the following diagram commutes

$$\begin{split} &\Phi(i_1)\circ\rho_s^1\circ\rho_t^1 \xrightarrow{\quad \Phi_s\quad } \rho_s^2\circ\Phi(i_2)\circ\rho_t^1 \xrightarrow{\quad \Phi_t\quad } \rho_s^2\circ\rho_t^2\circ\Phi(i_3)\\ &(3.1) \ \, \Big|c_{s,t}^1 \\ &\Phi(i_1)\circ\rho_{t\circ s}^1 \xrightarrow{\quad \Phi_{t\circ s}\quad } \rho_{t\circ s}^2\circ\Phi(i_3). \end{split}$$

Morphism of functors of prestacks

We will need the following definition

Definition 3.1. Let $\Phi_{\nu} \colon \mathfrak{S}_1 \to \mathfrak{S}_2$ ($\nu = 1, 2$) be two functors of prestacks on \mathfrak{I} . A morphism of functors of prestacks $\theta \colon \Phi_1 \to \Phi_2$ is the data for any $i \in \mathfrak{I}$ of a morphism of functors $\theta(i) \colon \Phi_1(i) \to \Phi_2(i)$ such that for any morphism $s \colon i_1 \to i_2$ in \mathfrak{I} , the following diagram commutes

$$(3.2) \qquad \Phi_{1}(i_{1}) \circ \rho_{s}^{1} \xrightarrow{\theta(i_{1})} \Phi_{2}(i_{1}) \circ \rho_{s}^{1}$$

$$\downarrow^{\Phi_{s}^{1}} \qquad \downarrow^{\Phi_{s}^{2}}$$

$$\rho_{s}^{2} \circ \Phi_{1}(i_{2}) \xrightarrow{\theta(i_{2})} \rho_{s}^{2} \circ \Phi_{2}(i_{2}).$$

2-projective limits

For a prestack \mathfrak{S} on \mathfrak{I} , one defines the category $\mathfrak{S}(\mathfrak{I})$ as the 2-projective limit of the functor $\mathfrak{S} \colon \mathfrak{I}^{\mathrm{op}} \to \mathbf{Cat}$:

$$\mathfrak{S}(\mathfrak{I}) = 2 \varprojlim_{i,s} \mathfrak{S}(i).$$

More explicitly $\mathfrak{S}(\mathfrak{I})$ is given as follows.

Definition 3.2. (a) An object F of $\mathfrak{S}(\mathfrak{I})$ is a family $\{(F_i, \varphi_s)\}_{i,s}$ $(i \in \mathfrak{I}, s \in \mathfrak{I})$ $Mor(\mathfrak{I})$ where

- (i) for any $i \in \mathcal{I}$, F_i is an object of $\mathfrak{S}(i)$,
- (ii) for any morphism $s: i_1 \to i_2$ in $\mathcal{I}, \varphi_s: \rho_s F_{i_2} \xrightarrow{\sim} F_{i_1}$ is an isomorphism such that
 - for all $i \in \mathcal{I}$, $\varphi_{\mathrm{id}_i} = \mathrm{id}_{F_i}$,
 - for any sequence $i_1 \stackrel{s}{\to} i_2 \stackrel{t}{\to} i_3$ of morphisms in \mathcal{I} , the following diagram commutes

$$\begin{array}{cccc}
\rho_{s}\rho_{t}F_{i_{3}} & \xrightarrow{\rho_{s}(\varphi_{t})} & \rho_{s}F_{i_{2}} \\
c_{s,t} \downarrow & & & \varphi_{s} \downarrow \wr \\
\rho_{tos}F_{i_{3}} & \xrightarrow{\varphi_{tos}} & F_{i_{1}}.
\end{array}$$

(b) A morphism $f: \{(F_i, \varphi_s)\}_{i,s} \to \{(F'_i, \varphi'_s)\}_{i,s}$ in $\mathfrak{S}(\mathfrak{I})$ is a family of morphisms $\{f_i\colon F_i\to F_i'\}_{i\in\mathcal{I}}$ such that for any $s\colon i_1\to i_2$, the diagram below commutes:

$$(3.4) \qquad \rho_{s}(F_{i_{2}}) \xrightarrow{\rho_{s}(f_{i_{2}})} \rho_{s}(F'_{i_{2}}) \\ \varphi_{s} \downarrow \wr \qquad \qquad \downarrow \varphi'_{s} \\ F_{i_{1}} \xrightarrow{f_{i_{1}}} F'_{i_{1}}.$$

Remark 3.3. Denote by $Mor(\mathfrak{I})$ the category whose objects are the morphisms of \mathcal{I} , a morphism $(s: i \to j) \to (s': i' \to j')$ being visualized by the commutative diagram

$$\begin{array}{ccc}
i & \xrightarrow{s} j \\
t \downarrow & \uparrow t' \\
i' & \xrightarrow{s'} j'.
\end{array}$$

For two objects $F = \{(F_i, \varphi_s)\}_{i,s}$ and $F' = \{(F'_i, \varphi'_s)\}_{i,s}$ in $\mathfrak{S}(\mathfrak{I})$, consider the functor $\Psi \colon \operatorname{Mor}(\mathfrak{I})^{\operatorname{op}} \to \mathbf{Set}$ defined as follows. For $(s \colon i \to j) \in \operatorname{Mor}(\mathfrak{I})$, set

$$\Psi(s) = \operatorname{Hom}_{\mathfrak{S}(i)}(F_i, \rho_s F'_j).$$

For $(s': i' \to j') \in \text{Mor}(\mathfrak{I})$ and for a morphism $(t, t'): s \to s'$ in $\text{Mor}(\mathfrak{I})$, define $\Psi(s') \to \Psi(s)$ as the composition

$$\begin{array}{ccc} \operatorname{Hom}_{\mathfrak{S}(i')}(F_{i'}, \rho_{s'}F'_{j'}) & \to & \operatorname{Hom}_{\mathfrak{S}(i')}(\rho_{t}F_{i'}, \rho_{t}\rho_{s'}F'_{j'}) \\ & \to & \operatorname{Hom}_{\mathfrak{S}(i)}(F_{i}, \rho_{s}F'_{j}) \end{array}$$

where the last map is associated with the morphisms $F_i \to \rho_t F_{i'}$ and $\rho_t \rho_{s'} F'_{i'} \to \rho_t F_{i'}$ $\rho_t \rho_{s'} \rho_{t'} F'_j \simeq \rho_s F'_j).$ Then

$$\operatorname{Hom}_{\mathfrak{S}(\mathfrak{I})}(F,F') \simeq \underset{s \in \operatorname{Mor}(\mathfrak{I})^{\operatorname{op}}}{\varprojlim} \Psi(s).$$

Proposition 3.4. Let \mathfrak{S} be a prestack on \mathfrak{I} . Assume that, for each object $i \in \mathfrak{I}$, the category $\mathfrak{S}(i)$ admits inductive (resp. projective) limits indexed by a small category A and that, for each morphism $s: i \to j$ in \mathfrak{I} , the restriction functor ρ_s commutes with such limits. Then the category $\mathfrak{S}(\mathfrak{I})$ admits inductive (resp. projective) limits indexed by A and the restriction functors $\rho_i \colon \mathfrak{S}(\mathfrak{I}) \to \mathfrak{S}(i)$ commute with such limits.

Some Lemmas

Lemma 3.5. Every functor of prestacks $\Psi \colon \mathfrak{S}_1 \to \mathfrak{S}_2$ on \mathfrak{I} induces a functor $\Psi_{\infty} \colon \mathfrak{S}_1(\mathfrak{I}) \to \mathfrak{S}_2(\mathfrak{I})$ on the corresponding two-limit categories.

Proof. To each object $\{(F_i, \varphi_s)\}_{i,s} \in \mathfrak{S}_1(\mathfrak{I})$, Ψ associates $\{(\Psi(i)F_i, \tilde{\varphi}_s)\}_{i,s} \in \mathfrak{S}_2(\mathfrak{I})$, with $\tilde{\varphi}_s$ defined as the composition $\rho_s^2\Psi(j)F_j \xrightarrow{\sim} \Psi(i)\rho_s^1F_j \xrightarrow{\sim} \Psi(i)F_i$ where the first isomorphism is the inverse of Ψ_s and the second is $\Psi(i)(\varphi_s)$. Notice that for any sequence $i_1 \xrightarrow{s} i_2 \xrightarrow{t} i_3$ of morphisms in \mathfrak{I} , the following diagram commutes

$$(3.5) \qquad \rho_s^2 \rho_t^2 \Psi(i_3) F_{i_3} \xrightarrow{\rho_s^2(\tilde{\varphi}_t)} \rho_s^2 \Psi(i_2) F_{i_2}$$

$$c_{s,t}^2 \downarrow \downarrow \qquad \qquad \tilde{\varphi}_s \downarrow \downarrow \downarrow$$

$$\rho_{tos}^2 \Psi(i_3) F_{i_3} \xrightarrow{\tilde{\varphi}_{tos}} \Psi(i_1) F_{i_1};$$

in fact it is enough to apply $\Psi(i_1)$ to the corresponding diagram in def (3.2) and then use property (3.1) of the morphism Ψ .

Finally Ψ_{∞} associates to each morphism $f: \{(F_i, \varphi_s)\}_{i,s} \to \{(F'_i, \varphi'_s)\}_{i,s}, \Psi_{\infty} f = \{\Psi(i)f_i\}: \mathfrak{S}_1(\mathfrak{I}) \to \mathfrak{S}_2(\mathfrak{I})$ with

$$(3.6) \qquad \rho_{s}(\Psi(i_{2})F_{i_{2}}) \xrightarrow{\rho_{s}\Psi(i_{2})(f_{i_{2}})} \rho_{s}(\Psi(i_{2})F'_{i_{2}}) \xrightarrow{\varphi_{s}} \psi_{s} \psi_{s$$

(it is enough to apply the functor $\Psi(i_1)$ to the diagram (3.4))

The next lemma is obvious

Lemma 3.6. Let $\Psi_1 \colon \mathfrak{S}_1 \to \mathfrak{S}_2$ and $\Psi_2 \colon \mathfrak{S}_2 \to \mathfrak{S}_3$ be two morphisms of prestacks on \mathfrak{I} . There exists an isomorphism of functors $\Psi_1 \otimes \Phi_2 \otimes \longrightarrow (\Psi_1 \circ \Phi_2)_{\infty} \colon \mathfrak{S}_1(\mathfrak{I}) \to \mathfrak{S}_3(\mathfrak{I})$.

Define

(3.7)
$$\pi \colon \mathfrak{S}(\mathfrak{I}) \to \prod_{i \in \mathfrak{I}} \mathfrak{S}(i)$$

as the functor that associates to each $\{(F_i, \varphi_s)\}_{i,s}$, the collection $\{F_i\}_i$ and acts on each morphism $\{f_i\}_{i\in I}$ forgetting the property (3.4).

Lemma 3.7. The functor π is conservative.

Proof. Consider $\{f_i\}_{i\in I}$ a morphism in $\mathfrak{S}(\mathfrak{I})$ between $\{F_i, \varphi_s\}_{i,s}$ and $\{F'_i, \varphi'_s\}_{i,s}$. Assume $\{f_i\}_{i\in I}$ is an isomorphism in $\prod_{i\in \mathfrak{I}}\mathfrak{S}(i)$. For each f_i denote by g_i the corresponding inverse morphism. Consider the diagram

$$(3.8) \qquad \rho_{s}(F'_{i_{2}}) \xrightarrow{\rho_{s}(g_{i_{2}})} \rho_{s}(F_{i_{2}}) \xrightarrow{\rho_{s}(f_{i_{2}})} \rho_{s}(F'_{i_{2}}) \xrightarrow{\rho_{s}(f_{i_{2}})} \rho_{s}(F'_{i_{2}}) \xrightarrow{\varphi'_{s} \downarrow \ell} \varphi_{s} \qquad \varphi'_{s} \downarrow \ell \xrightarrow{\varphi'_{s} \downarrow \ell} F'_{i_{1}};$$

the right square is commutative by hypothesis and the large rectangle is trivially commutative. Then the equality $f_{i_1} \circ \varphi_s \circ \rho_s(g_{i_2}) = f_{i_1} \circ g_{i_1} \circ \varphi_s'$ implies $\varphi_s \circ \rho_s(g_{i_2}) = g_{i_1} \circ \varphi_s'$ since each f_{i_1} is an isomorphism.

Lemma 3.8. Let $\Psi_{\nu} \colon \mathfrak{S}_1 \to \mathfrak{S}_2 \ (\nu = 1, 2)$ be two functors of prestacks on \mathfrak{I} , and $\theta \colon \Psi_1 \to \Psi_2$ a morphisms of functors.

- (a) θ defines a morphism of functors $\theta_{\infty} \colon \Psi_{1 \infty} \to \Psi_{2 \infty}$,
- (b) if θ is an isomorphism, then θ_{∞} is an isomorphism as well.

Proof. Obvious.

Grothendieck prestacks

Recall that a **k**-abelian prestack \mathfrak{S} on a presite \mathfrak{I} is a prestack such that $\mathfrak{S}(i)$ is a **k**-abelian category for each $i \in \mathfrak{I}$ and the restriction functors ρ_s are exact. For a site \mathfrak{I} , a **k**-abelian stack is a **k**-abelian prestack which is a stack. If there is no risk of confusion, we shall not mention the field **k**.

Definition 3.9. (see [GS06])

- (i) A Grothendieck prestack \mathfrak{S} over \mathbf{k} on a presite \mathfrak{I} is a \mathbf{k} -abelian prestack such that the abelian category $\mathfrak{S}(i)$ is a Grothendieck category for each object $i \in \mathfrak{I}$ and the restriction functor ρ_s commutes with small inductive limits for each morphism $s: i \to j$. (Recall that ρ_s is exact.)
- (ii) For a site \mathfrak{I} , a Grothendieck stack is a Grothendieck prestack which is a stack.

The next result is a deep results of [SGA4] (see Exposé I, Theorem 9.22).

Theorem 3.10. Let \mathfrak{S} be a Grothendieck prestack on \mathfrak{I} . Then $\mathfrak{S}(\mathfrak{I})$ is a Grothendieck category.

If \mathscr{C} is an abelian category, we denote as usual by $D^{b}(\mathscr{C})$ (resp. $D^{+}(\mathscr{C})$) its bounded (resp. bounded from below) derived category. Hence, for each $i \in \mathcal{I}$, the functor $\rho_{i} \colon \mathfrak{S}(\mathcal{I}) \to \mathfrak{S}(i)$ extends as a functor $\tilde{\rho_{i}} \colon D^{+}(\mathfrak{S}^{*}(\mathcal{I})) \to D^{+}(\mathfrak{S}^{*}(i))$ and one checks easily that these functors define a functor

(3.9)
$$\tilde{\rho} \colon \mathrm{D}^+(\mathfrak{S}(\mathfrak{I})) \to 2 \varprojlim_{i,s} \mathrm{D}^+(\mathfrak{S}(i)).$$

The $2 \varprojlim$ of triangulated categories is no more triangulated in general; the functor $\tilde{\rho}$ is neither full nor faithful. However it would be interesting to check if this functor is conservative.

4 Ran manifolds

We shall specialize the general theory of 2-limits presented in the previous section. Let J be a small category.

- **Definition 4.1.** (a) A real (resp. complex) Ran-manifold indexed by \mathcal{I} is a projective system $X = \{X_i\}_{i \in \mathcal{I}}$ of real (resp. complex) manifolds indexed by \mathcal{I} such that for every morphism $s \in \operatorname{Hom}_{\mathcal{I}}(j,i)$ the corresponding morphism $\Delta_s : X_i \to X_j$ is a closed embedding.
- (b) Let $X = \{X_i\}_{i \in \mathcal{I}}$ and $Y = \{Y_i\}_{i \in \mathcal{I}}$ be two Ran-manifolds. A morphism $f \colon X \to Y$ is defined as a collection of morphisms $\{f_i\}_{i \in \mathcal{I}}$ such that all the diagrams below commute

$$\begin{array}{c|c}
X_i & \xrightarrow{f_i} & Y_i \\
& & \downarrow \\
\Delta_s & & \downarrow \\
X_j & \xrightarrow{f_j} & Y_j
\end{array}$$

For each morphism $s: j \to i$, with the corresponding embedding $\Delta_s: X_i \hookrightarrow X_j$, we consider the following diagram

We denote by $T_s^* X_j$ the kernel of Δ_{sd} , that is, $\Delta_{sd}^{-1} T_{X_i}^* X_i$.

Definition 4.2. (a) We define T^*X as the collection of all the diagrams (4.2).


(b) A family $\{\Lambda_i\}_{i\in\mathbb{I}}$ of closed \mathbb{R}^+ -conic subsets $\Lambda_i\subset T^*X_i$ satisfying

$$(4.3) \Lambda_i \subset \Delta_{sd}(\Delta_{s\pi}^{-1}(\Lambda_j))$$

for all $s: j \to i$ is said to be a closed \mathbb{R}^+ -conic subset $\Lambda \subset T^*X$.

(c) A closed \mathbb{R}^+ -conic subset Λ of T^*X is said to be transversal to the identity, if for each $s \colon j \to i$, the map Δ_s is non-characteristic with respect to Λ_j , that is, $\Delta_{sd}^{-1} T_{X_i}^* X_i \cap \Delta_{s\pi}^{-1} \Lambda_j \subset X_i \times_{X_j} T_{X_j}^* X_j$.

Consider a morphism $f: X \to Y$ of Ran-manifolds. It gives rise to the commutative diagrams associated to $s: j \to i$:



Notice that in Diagram 4.4, we have defined the maps

$$\Delta_{f_s,d} \colon X_i \times_{Y_i} T^*Y_j \to T^*X_i, \quad \Delta_{f_s,\pi} \colon X_i \times_{Y_i} T^*Y_j \to T^*Y_j.$$

where $f_s \colon X_i \to Y_j$ is given by the sequence of morphisms of manifolds $X_i \xrightarrow{f_i} Y_i \xrightarrow{\Delta_s^{(Y)}} Y_j$.

Definition 4.3. Let us fix a closed \mathbb{R}^+ -conic subset $\Lambda \subset T^*Y$.

We say that Λ is transversal to f if for each $s\colon j\to i$, the map $f_s\colon X_i\to Y_j$ is non-characteristic with respect to Λ_j , that is $\Delta_{f_sd}^{-1}(T_{X_i}^*X_i)\cap\Delta_{f_s\pi}^{-1}(\Lambda_j)\subset X_i\times_{Y_j}T_{Y_j}^*Y_j$.

Note that to be transversal is stronger than to be non characteristic. When $f: X \to Y = X$ is the identity, we recover the notion of Definition 4.2 (c).

Notation 4.4. We will denote by $\Delta_s^{(Y)}$, $\Delta_s^{(X)}$, $\forall s \in \text{Hom}(\mathcal{I})$, the closed embeddings of Y and X respectively. However when it is clear from the context we will omit the superscript.

Lemma 4.5. Let Λ be a closed \mathbb{R}^+ -conic subset of T^*Y ; moreover assume Λ is transversal to f. Then for every $s: j \to i$

- (a) $\Delta_s^{(Y)}$ is non-characteristic for Λ_j in a neighborhood of $f_i(X_i)$;
- (b) $\Delta_s^{(X)}$ is non-characteristic for $f_{jd}f_{j\pi}^{-1}(\Lambda_j)$.

Proof. (a) By hypothesis the morphism f_s is non-characteristic for Λ_j . The result follows from Lemma 4.10 pag.65 in [Ka03] applied to the following commutative diagram:

$$(4.5) T^*X_i \stackrel{f_{id}}{\longleftarrow} X_i \times_{Y_i} TY_i \stackrel{\varphi}{\longleftarrow} X_i \times_{Y_j} T^*Y_j$$

$$\downarrow^{f_{i\pi}} \qquad \qquad \downarrow^{\psi}$$

$$T^*Y_i \stackrel{\Delta_{sd}}{\longleftarrow} Y_i \times_{Y_j} T^*Y_j$$

$$\downarrow^{\Delta_{s\pi}}$$

$$T^*Y_i.$$

(b) Same argument applied to $f_s = f_j \circ \Delta_s^{(X)}$.

5 Sheaves on Ran-manifolds

Let X be a Ran-manifold and \mathcal{I} a small category. Consider $D^{b}(\mathbf{k}_{X_{i}})$ the bounded derived category of $Mod(\mathbf{k}_{X_{i}})$. Define the functor $\mathfrak{S}: \mathcal{I}^{op} \to \mathbf{Cat}$ as follows:

- (a) to any $i \in \mathcal{I}$ set $D^{b}(\mathbf{k}_{X_{i}})$;
- (b) for any morphism $s \colon i_1 \to i_2$ set $\rho_s \colon \mathrm{D^b}(\mathbf{k}_{X_{i_1}}) \to \mathrm{D^b}(\mathbf{k}_{X_{i_2}})$, with $\rho_s := \Delta_s^{-1}$;
- (c) for $s: i_1 \to i_2, t: i_2 \to i_3$ the isomorphism of functors $c_{s,t}$ is $\Delta_t^{-1} \circ \Delta_s^{-1} \simeq \Delta_{t \circ s}^{-1}$.

Definition 5.1. We set

$$D^{b}(\mathbf{k}_{X}) := 2 \varprojlim_{i,s} (D^{b}(\mathbf{k}_{X_{i}}), \Delta_{s}^{-1}).$$

Hence, an object $D^{b}(\mathbf{k}_{X})$ is the data of $\{(F_{i}, \varphi_{s})\}_{i,s}$ $(i \in \mathcal{I}, s \in \text{Mor}(\mathcal{I}))$ with $F_{i} \in D^{b}(\mathbf{k}_{X_{i}})$ and $\varphi_{s} \colon \Delta_{s}^{-1}F_{j} \xrightarrow{\sim} F_{i}$ satisfying the compatibility conditions in def 3.2.

Inverse images

Let $f: X \to Y$ be a morphism of Ran manifolds.

Definition 5.2. The inverse image functor f^{-1} : $D^{b}(\mathbf{k}_{Y}) \to D^{b}(\mathbf{k}_{X})$ is defined as follows. Given $G \in D^{b}(\mathbf{k}_{Y})$, $G = \{(G_{i}, \psi_{s})\}_{i,s}$ with $i \in \mathcal{I}, s \in \operatorname{Hom}_{\mathcal{I}}(j,i)$, we set $f^{-1}G = \{(F_{i}, \varphi_{s})\}_{i,s}$ where $F_{i} = f_{i}^{-1}G_{i}$ and $\varphi_{s} \colon \Delta_{s}^{-1}F_{j} \simeq F_{i}$ is given by the isomorphisms

$$\Delta_s^{-1} F_j = \Delta_s^{-1} f_i^{-1} G_j \simeq f_i^{-1} \Delta_s^{-1} G_j \simeq f_i^{-1} G_i = F_i.$$

6 2-modules on complex Ran-manifolds

The ∞ -category of \mathscr{D} -modules on Ran spaces has been introduced and studied in [FG11]. We propose here a more elementary approach.

First we shall adapt Definition 5.1 in the \mathscr{D} -modules setting. Let X be a Ranmanifold and \mathcal{I} a small category. Define the functor $\mathfrak{S}: \mathcal{I}^{op} \to \mathbf{Cat}$ by

- (a) to $i \in \mathcal{I}$, $\mathfrak{S}(i) = D^{b}(\mathcal{D}_{X_{i}})$;
- (b) for any morphism $s: i_1 \to i_2$, $\rho_s: \mathrm{D^b_{coh}}(\mathscr{D}_{X_{i_1}}) \to \mathrm{D^b_{coh}}(\mathscr{D}_{X_{i_2}})$ is the functor Δ^D_s ;
- (c) for $s: i_1 \to i_2$, $t: i_2 \to i_3$, the isomorphism of functors $c_{s,t}$ is the obvious one $\Delta_t^D \circ \Delta_s^D \simeq \Delta_{tos}^D$.

Definition 6.1. We set

$$\mathrm{D^b}(\mathscr{D}_X) = 2 \varprojlim_{i,\,s} (\mathrm{D^b}(\mathscr{D}_{X_i}), \Delta^D_s).$$

Definition 6.2. Denote by $D^{b}_{\operatorname{coh} \operatorname{nc}}(\mathscr{D}_{X_{j}})$ the full triangulated subcategory of $D^{b}_{\operatorname{coh}}(\mathscr{D}_{X_{j}})$ whose objects \mathscr{M}_{j} are such that for every $s \in \operatorname{Hom}_{\mathfrak{I}}(j,i)$ the corresponding morphism $\Delta_{s} \colon X_{i} \to X_{j}$ is non-characteristic with respect to \mathscr{M}_{j} .

Definition 6.3. We set

$$D_{\operatorname{coh} \operatorname{nc}}^{\operatorname{b}}(\mathscr{D}_X) = 2 \varprojlim_{i,s} (D_{\operatorname{coh} \operatorname{nc}}^{\operatorname{b}}(\mathscr{D}_{X_i}), \Delta_s^D).$$

Let X and Y be two complex Ran-manifolds and $f: X \to Y$. We shall mimic the previous definitions

Definition 6.4. Denote with $D^{b}_{coh\ f-nc}(\mathscr{D}_{Y_{j}})$ the full triangulated subcategory of $D^{b}_{coh}(\mathscr{D}_{Y_{j}})$ whose objects \mathscr{N}_{j} are such that for every $s \in \operatorname{Hom}_{\mathfrak{I}}(j,i)$ the corresponding morphism $f_{s} = f_{j} \circ \Delta_{s}^{(X)} : X_{i} \to Y_{j}$ is non-characteristic with respect to \mathscr{N}_{j} .

Definition 6.5. We set $D^b_{coh\ f-nc}(\mathscr{D}_Y)$ as the 2-limit category

$$2 \varprojlim_{i,s} (\mathcal{D}^{\mathrm{b}}_{\mathrm{coh}\ f-\mathrm{nc}}(\mathscr{D}_{Y_i}), \Delta^D_s).$$

Of course the two definitions coincide in the case f = id.

Example 6.6. Let X be a complex Ran-manifold . Since $\Delta_s^D \mathscr{O}_{X_j} \simeq \mathscr{O}_{X_i}$, the family $\{\mathscr{O}_{X_i}\}_i$ defines an object in $\mathrm{D}^\mathrm{b}_{\mathrm{coh}}(\mathscr{D}_X)$.

Lemma 6.7. Any object $\mathcal{N} \in \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}\ f-\mathrm{nc}}(\mathcal{D}_Y)$ belongs to the subcategory of $\mathrm{D}^{\mathrm{b}}_{\mathrm{coh}}(\mathcal{D}_Y)$ consisting of objects s.t. for every $s \colon j \to i$, Δ_s is non-characteristic for \mathcal{N}_j in a neighborhood of $f_i(X_i)$.

Proof. It is a consequence of Lemma 4.5.

The inverse image functor f^D

Let $f: X \to Y$ be a morphism of Ran-manifolds. We will need the following result (which holds in view of Lemma 4.5).

Lemma 6.8. For all $s: j \to i$ the corresponding map $\Delta_s: X_i \to X_j$ is non characteristic for the corresponding $f_j^D \mathcal{N}_j$.

Proposition 6.9. The map f induces a functor $f^D: \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}\ f-\mathrm{nc}}(\mathscr{D}_Y) \to \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}\ \mathrm{nc}}(\mathscr{D}_X)$

Proof. We set $f^D := \{f_i^D\}_{i \in \mathbb{J}}$. This inverse image functor is well-defined due to Lemma 6.8. In view of Lemma 3.5 it is enough to prove that $\{f_i^D\}_{i \in \mathbb{J}}$ is a functor of prestack. In particular this means that each functor f_i^D commutes with the restriction morphisms. By Definition 4.1 of morphism of Ran manifolds we have $\Delta_s \circ f_i = f_j \circ \Delta_s$ and applying the inverse image functor we obtain the desired property $f_i^D \circ \Delta_s^D \simeq \Delta_s^D \circ f_j^D$.

The functor $\mathcal{R}\mathscr{H}om_{\mathscr{D}_{Y}}(-,\mathscr{O}_{Y})$

Lemma 6.10. The functor $\mathcal{R}\mathscr{H}om_{\mathscr{D}_{Y}}(-,\mathscr{O}_{Y}) := {\mathcal{R}\mathscr{H}om_{\mathscr{D}_{Y^{i}}}(-,\mathscr{O}_{Y^{i}})}_{i \in I}$,

$$R\mathcal{H}om_{\mathscr{D}_{Y}}(-,\mathscr{O}_{Y}) \colon D^{b}_{coh}(\mathscr{D}_{Y}) \to D^{b}_{coh}(\mathbf{k}_{X})$$

is well defined.

Proof. Consider an object $\{\mathcal{N}_i, \varphi_s\}_{i,s} \in \mathcal{D}^b_{\operatorname{coh}}(\mathcal{D}_Y)$; by the CKK theorem (Theorem 2.4), there is the isomorphism $\Delta_s^{-1} R \mathscr{H}om_{\mathscr{D}_{Y_i}}(\mathcal{N}_i, \mathscr{O}_{Y_i}) \simeq R \mathscr{H}om_{\mathscr{D}_{Y_j}}(\Delta_s^D \mathscr{N}_i, \mathscr{O}_{Y_j})$. By the composition of the last isomorphism with $\varphi_s : \Delta_s^D \mathscr{N}_i \xrightarrow{\sim} \mathscr{N}_j$ we obtain the isomorphism $\Delta_s^{-1} R \mathscr{H}om_{\mathscr{D}_{Y_i}}(\mathscr{N}_i, \mathscr{O}_{Y_i}) \xrightarrow{\sim} R \mathscr{H}om_{\mathscr{D}_{Y_j}}(\mathscr{N}_j, \mathscr{O}_{Y_j})$. Lemma 3.5 completes the proof.

The Cauchy-Kowaleski-Kashiwara theorem for Ran spaces

Theorem 6.11. There is an isomorphism of functors of prestacks

$$\theta_{\infty}: f^{-1} \circ \mathbf{R}\mathscr{H}om_{\mathscr{D}_{\mathbf{Y}}}(-,\mathscr{O}_{\mathbf{Y}}) \xrightarrow{\sim} \mathbf{R}\mathscr{H}om_{\mathscr{D}_{\mathbf{Y}}}(-,\mathscr{O}_{\mathbf{Y}}) \circ f^{D} \ .$$

In other words for any $\mathcal{N} \in \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}\ f-\mathrm{nc}}(\mathcal{D}_Y)$ we have the isomorphism

$$f^{-1}\mathbf{R}\mathscr{H}om_{\mathscr{D}_{\mathbf{Y}}}(\mathscr{N},\mathscr{O}_{\mathbf{Y}}) \xrightarrow{\ \sim \ } \mathbf{R}\mathscr{H}om_{\mathscr{D}_{\mathbf{X}}}(f^{D}\mathscr{N},\mathscr{O}_{\mathbf{X}})$$

functorial in $\mathcal{N} \in \mathrm{D}^{\mathrm{b}}_{\mathrm{coh}} _{f-\mathrm{nc}}(\mathcal{D}_Y)$.

The theorem is visualized by the following quasi commutative diagram:

(6.1)
$$D^{b}_{\operatorname{coh} f-\operatorname{nc}}(\mathscr{D}_{Y}) \xrightarrow{f^{D}} D^{b}_{\operatorname{coh} \operatorname{nc}}(\mathscr{D}_{X})$$

$$\mathbb{R}\mathscr{H}om_{\mathscr{D}_{Y}}(-,\mathscr{O}_{Y}) \downarrow \qquad \qquad \downarrow \mathbb{R}\mathscr{H}om_{\mathscr{D}_{X}}(-,\mathscr{O}_{X})$$

$$D^{b}(\mathbf{k}_{Y}) \xrightarrow{f^{-1}} D^{b}(\mathbf{k}_{X}).$$

Proof. In view of Lemmas 3.6, 3.6, 3.8, it is enough to observe that each morphism

$$\theta_i: f_i^{-1} \circ \mathcal{R}\mathscr{H}om_{\mathscr{D}_{Y_i}}(-,\mathscr{O}_{Y_i}) \xrightarrow{\sim} \mathcal{R}\mathscr{H}om_{\mathscr{D}_{Y_i}}(-,\mathscr{O}_{Y_i}) \circ f_i^D$$

is an isomorphism due to Theorem 2.4.

Example 6.12. Let \mathcal{I} be the category of finite non-empty sets and surjective maps. Let X be a complex manifold. The Ran space $Ran\ X$ in [BD04] is defined as follows: to $I \in \mathcal{I}$ one associates the product manifold X^I and to a surjection $s \colon J \to I$ is associated the diagonal embedding

$$\delta_s \colon X^I \hookrightarrow X^J$$

which maps $\{x_i\}_{i\in I} \in X^I$ to $\{x_j\}_{j\in J} \in X^J$ with $x_j = x_i$ if s(j) = i.

Appendix

There are two other natural categories, $\mathfrak{S}^+(\mathfrak{I})$ and $\mathfrak{S}^-(\mathfrak{I})$.

Definition 6.13. (a) An object F of $\mathfrak{S}^+(\mathfrak{I})$ (resp. $\mathfrak{S}^-(\mathfrak{I})$) is a family $\{(F_i, \phi_s)\}_{i,s}$ $(i \in \mathfrak{I}, s \in \operatorname{Mor}(\mathfrak{I}))$ where

- (i) for any $i \in \mathcal{I}$, F_i is an object of $\mathfrak{S}(i)$,
- (ii) for any morphism $s: i_1 \to i_2$ in $\mathfrak{I}, \phi_s: F_{i_1} \to \rho_s(F_{i_2})$ (resp. $\phi_s: \rho_s(F_{i_2}) \to F_{i_1}$) is a morphism such that
 - for all $i \in \mathcal{I}$, $\phi_{\mathrm{id}_i} = \mathrm{id}_{F_i}$,
 - for any sequence $i_1 \xrightarrow{s} i_2 \xrightarrow{t} i_3$ of morphisms in \mathcal{I} , the following diagram commutes

$$\rho_{s}\rho_{t}(F_{i_{3}}) \xleftarrow{\rho_{s}(\phi_{t})} \rho_{s}(F_{i_{2}})$$

$$c_{s,t} \mid \lambda \qquad \qquad \uparrow \phi_{s}$$

$$\rho_{tos}(F_{i_{3}}) \xleftarrow{\phi_{tos}} F_{i_{1}}$$

(resp. the following diagram commutes

$$\begin{array}{ccc}
\rho_{s}\rho_{t}(F_{i_{3}}) & \xrightarrow{\rho_{s}(\phi_{t})} & \rho_{s}(F_{i_{2}}) \\
c_{s,t} \mid & \downarrow \phi_{s} \\
\rho_{tos}(F_{i_{3}}) & \xrightarrow{\phi_{tos}} & F_{i_{1}}.)
\end{array}$$

(b) A morphism $f: \{(F_i, \phi_s)\}_{i,s} \to \{(F'_i, \phi'_s)\}_{i,s}$ in $\mathfrak{S}^+(\mathfrak{I})$ (resp. $\mathfrak{S}^-(\mathfrak{I})$) is a family of morphisms $f_i: F_i \to F'_i$ such that for any $s: i_1 \to i_2$, the diagram below commutes:

(6.5)
$$\rho_{s}(F_{i_{2}}) \xrightarrow{\rho_{s}(f_{i_{2}})} \rho_{s}(F'_{i_{2}})$$

$$\downarrow^{\phi_{s}} \qquad \uparrow^{\phi'_{s}}$$

$$F_{i_{1}} \xrightarrow{f_{i_{1}}} F'_{i_{1}}.$$

(resp. the diagram below commutes:

$$(6.6) \qquad \rho_{s}(F_{i_{2}}) \xrightarrow{\rho_{s}(f_{i_{2}})} \rho_{s}(F'_{i_{2}})$$

$$\downarrow^{\phi_{s}} \qquad \downarrow^{\phi'_{s}}$$

$$F_{i_{1}} \xrightarrow{f_{i_{1}}} F'_{i_{1}}.)$$

(c) We consider $\mathfrak{S}(\mathfrak{I})$ as the full subcategory of $\mathfrak{S}^+(\mathfrak{I})$ or $\mathfrak{S}^-(\mathfrak{I})$ consisting of objects $\{(F_i,\phi_s)\}_{i\in \mathfrak{I},s\in \mathrm{Mor}(\mathfrak{I})}$ such that for all $s\in \mathrm{Mor}(\mathfrak{I})$, the morphisms ϕ_s are isomorphisms and we denote by $\iota_{\mathfrak{I}}^+\colon \mathfrak{S}(\mathfrak{I})\to \mathfrak{S}^+(\mathfrak{I})$ and $\iota_{\mathfrak{I}}^-\colon \mathfrak{S}(\mathfrak{I})\to \mathfrak{S}^-(\mathfrak{I})$ the natural faithful functors.
