

REGULARIZING PROPERTIES OF THE TWISTED KÄHLER-RICCI FLOW

ABSTRACT. Let X be a compact Kähler manifold. We show that the Kähler-Ricci flow (as well as its twisted versions) can be run from an arbitrary positive closed current with zero Lelong numbers and immediately smoothes it.

INTRODUCTION

Let X be a compact Kähler manifold of complex dimension n and $\alpha_0 \in H^{1,1}(X, \mathbb{R})$ a Kähler class. The purpose of this note is to show that the Kähler-Ricci flow

$$\frac{\partial \omega_t}{\partial t} = -Ric(\omega_t)$$

can be run from an initial data $T_0 \in \alpha_0$ which is an arbitrary positive closed current with zero Lelong numbers, i.e. there is a family of Kähler forms $(\omega_t)_{t>0}$ solutions of the above equation, such that $\omega_t \rightarrow T_0$ as $t \rightarrow 0^+$.

We shall actually consider slightly more general twisted Kähler-Ricci flows

$$\frac{\partial \omega_t}{\partial t} = -Ric(\omega_t) + \eta,$$

where η is a fixed closed $(1,1)$ -form. The case when $\eta = [D]$ is the current of integration along an hypersurface has become quite important recently in connection with the Kähler-Einstein problem on Fano manifolds (see e.g. [Don11, Ber12, CDS12, Tian12]), however we will restrict here to the case of a smooth form η .

It is standard [Cao85, Tsu88, TZha06] that when T_0 is a Kähler form, such a flow admits a unique solution on a maximal interval of time $[0, T_{max}[$, where

$$T_{max} := \sup \{t \geq 0 \mid tK_X + t\{\eta\} + \alpha_0 \text{ is nef}\}.$$

Our main result is the following:

Theorem A. *Let $T_0 \in \alpha_0$ be a positive current with zero Lelong numbers. There exists a unique maximal family $(\omega_t)_{0 < t < T_{max}}$ of Kähler forms such that*

$$\frac{\partial \omega_t}{\partial t} = -Ric(\omega_t) + \eta,$$

and ω_t weakly converges towards T_0 , as $t \searrow 0^+$.

We shall prove this result by working at the level of potentials and establishing smoothing properties of more general parabolic complex Monge-Ampère flows (see Theorem 1.1). We give precise information on the weak continuity at time zero, depending on the properties of the initial potential (convergence in energy or in capacity).

Smoothing properties of the Kähler-Ricci flow have been known and used for a long time (see e.g. [BM87, Tian97, PSSW08]). Attempts to run the Kähler-Ricci flow from a degenerate initial data have motivated several recent works [CD07, CT08, CTZ11, ST09, SzTo11]. The best results so far were obtained in [ST09], where the authors succeeded in running the Kähler-Ricci flow from an initial current T_0 with continuous potentials.

Starting from an initial data T_0 having positive Lelong numbers at some points is an interesting issue and we shall discuss it on our way to proving the main result as well as in section 6, where we show that the normalized Kähler-Ricci flow eventually smoothes out any arbitrary positive closed current on a manifold with non-positive first Chern class (see Theorem 6.2). This is however not necessarily the case on a Fano manifold (see Example 6.4), although the smoothing property

could be useful in analyzing the long-term behavior of the normalized Kähler-Ricci flow on Fano manifolds (see Theorem 6.5 and Remark 6.7).

We push our analysis further in section 7 and show that one can start the twisted Kähler-Ricci flow from a positive current representing a nef class (Theorem 7.1), and then treat the case of mildly singular varieties. This is a particularly important situation for applications, in connection with the Minimal Model Program. Our main result extends to this context as follows:

Theorem B. *Let X be a projective complex variety with log terminal singularities. Let T_0 be a positive $(1,1)$ -current with zero Lelong numbers representing a Kähler class $\alpha_0 \in H^{1,1}(X, \mathbb{R})$. Then there exists a continuous family $(\omega_t)_{t \in [0, T_{\max}[}$ of positive $(1,1)$ -currents such that*

- (i) $[\omega_t] = \alpha_0 - t c_1(X)$ in $H^{1,1}(X, \mathbb{R})$;
- (ii) $\omega_t \rightarrow T_0$ as $t \rightarrow 0$;
- (iii) $(\omega_t)_{t \in (0, +\infty)}$ restricts to a smooth path of Kähler forms on X_{reg} satisfying

$$\frac{\partial \omega_t}{\partial t} = -\text{Ric}(\omega_t).$$

1. STRATEGY OF THE PROOF

1.1. Reduction to a scalar Monge-Ampère flow. Fix ω a reference Kähler form in the initial Kähler class α_0 . Thus $T_0 = \omega + dd^c \varphi_0$ for some ω -plurisubharmonic function φ_0 , by the $\partial\bar{\partial}$ -lemma. We use here and in the sequel the standard normalization

$$d = \partial + \bar{\partial}, \quad d^c = \frac{1}{2i\pi}(\partial - \bar{\partial}), \quad \text{so that } dd^c = \frac{i}{\pi}\partial\bar{\partial}.$$

Set

$$\theta_t := \omega + t\eta - t\text{Ric}(\omega)$$

and consider the parabolic scalar flow

$$\frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi_t)^n}{\omega^n} \right]$$

with $\varphi_{t|t=0} = \varphi_0$. Let ω_t denote the Kähler form $\omega_t := \theta_t + dd^c \varphi_t$ and observe that

$$\frac{\partial \omega_t}{\partial t} = \eta - \text{Ric}(\omega) + dd^c \dot{\varphi}_t = -\text{Ric}(\omega_t) + \eta,$$

since $dd^c \log(\omega_t^n / \omega^n) = -\text{Ric}(\omega_t) + \text{Ric}(\omega)$.

Conversely, one easily shows that if ω_t evolves along the twisted Kähler-Ricci flow, then $\omega_t = \theta_t + dd^c \varphi_t$ where φ_t satisfies the above scalar parabolic flow, up to a time dependent additive constant. We shall normalize the latter to be zero.

1.2. Approximation process. Fix $\varphi_0 \in PSH(X, \omega)$ an arbitrary ω -psh function. We are going to approximate φ_0 by a decreasing sequence $\varphi_{0,j}$ of smooth strictly ω -psh functions $\varphi_{0,j} \in PSH(X, \omega) \cap \mathcal{C}^\infty(X)$. This is always possible thanks to a regularizing result of Demailly [Dem92].

We consider the corresponding solution $\varphi_{t,j} \in PSH(X, \theta_t) \cap \mathcal{C}^\infty(X)$ to the above scalar parabolic flow. By the discussion above, these flows are well defined on $[0, T_{max}] \times X$.

Our goal is then to establish various a priori estimates which will allow us to pass to the limit as $j \rightarrow +\infty$. For example, when φ_0 is *bounded* we are going to prove that for each $\varepsilon > 0$ and $0 < T < T_{max}$ fixed,

- (1) $(x, t, j) \mapsto \varphi_{t,j}(x)$ is uniformly bounded on $X \times [0, T] \times \mathbb{N}$;
- (2) $(x, t, j) \mapsto \dot{\varphi}_{t,j}(x)$ is uniformly bounded on $X \times [\varepsilon, T] \times \mathbb{N}$;
- (3) $(x, t, j) \mapsto \Delta \varphi_{t,j}(x)$ is uniformly bounded on $X \times [\varepsilon, T] \times \mathbb{N}$;

Here Δ denotes the Laplace operator with respect to a fixed metric, e.g. ω .

Thanks to the complex parabolic Evans-Krylov theory and Schauder estimates (see [ShW11] for a recent account in the Kähler-Ricci flow context), these bounds allow to show that $\varphi_{t,j} \rightarrow \varphi_t$ in $\mathcal{C}^\infty(X \times]0, T])$, as $j \rightarrow +\infty$. We'll then check that $\varphi_t \rightarrow \varphi_0$ as $t \rightarrow 0^+$. This is obvious (by global continuity) if φ_0 is *continuous*, slightly more involved when φ_0 is less regular:

- when φ_0 is bounded, we show that φ_t converges to φ_0 in capacity as $t \rightarrow 0$;
- when φ_0 has finite energy, we show that the approximants $\varphi_{t,j}$ have uniformly bounded energies, hence are relatively compact in the finite energy class $\mathcal{E}^1(X, 2\omega)$. The $\varphi_{t,j}$'s then form a compact family in $\mathcal{C}^\infty(X \times]0, T])$ and converge in energy towards φ_0 as $t \rightarrow 0$ and $j \rightarrow +\infty$;
- for arbitrarily singular initial potential $\varphi_0 \in L^1(X)$ we use the convexity property of the mean value $t \mapsto V^{-1} \int_X \varphi_{t,j} d\mu$ to control $\sup_X \varphi_{t,j}$ from below and show continuity in the L^1 -topology at time zero.

1.3. Notations. In the sequel we set $\chi = \eta - \text{Ric}(\omega)$ so that

$$\theta_t = \omega + t\chi.$$

To simplify notations we always assume that for $0 < t \leq T < T_{max}$, one has

$$\frac{\omega}{2} \leq \theta_t \leq 2\omega.$$

Thus $\varphi_t \in PSH(X, 2\omega)$ for all t . We also set

$$V := \text{vol}_\omega(X) = \int_X \omega^n = \alpha_0^n.$$

We let $(CMAF)$ denote the scalar parabolic flow

$$(CMAF) \quad \frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi_t)^n}{\mu} \right]$$

where $\mu = e^h \omega^n$ is a smooth positive measure and $h \in \mathcal{C}^\infty(X, \mathbb{R})$ is normalized so that

$$V = \int_X e^h \omega^n.$$

The next four sections are devoted to proving the following:

Theorem 1.1. *Let φ_0 be an ω -psh function with zero Lelong numbers. There exists a unique maximal family of smooth strictly θ_t -psh functions (φ_t) such that*

$$\frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi_t)^n}{\mu} \right]$$

in $]0, T_{\max}[\times X$, with $\varphi_t \rightarrow \varphi_0$ in $L^1(X)$, as $t \searrow 0^+$. Moreover

- φ_t converges in energy towards φ_0 if $\varphi_0 \in \mathcal{E}^1(X, \omega)$ has finite energy;
- φ_t is uniformly bounded and converges to φ_0 in capacity if $\varphi_0 \in L^\infty(X)$.

Since the weak convergence of positive currents is equivalent to the L^1 -convergence of (normalized) potentials, this result clearly contains our Main Theorem as a particular case.

The uniqueness property has to be understood in the following weak sense: if ψ_t is another solution of the parabolic scalar flow which converges in L^1 to the same initial data φ_0 , then ψ_t lies below φ_t , i.e. φ_t is the envelope of such solutions (see [Top10, GT11] for the related notion of unique "maximally stretched" solution).

When the Monge-Ampère measure $MA(\varphi_0)$ is absolutely continuous with respect to Lebesgue measure, with density $f_0 \in L^p$, $p > 1$ and continuous initial potential φ_0 , it has been shown in [ST09] that there is no other solution ψ_t (this follows easily in this case from the maximum principle).

We discuss in section 6 how one can try and run the (normalized or twisted) Kähler-Ricci flow from a positive current having positive Lelong numbers.

2. BOUNDS ON φ_t

In this section we assume that φ_t satisfies (CMAF) with an initial data φ_0 , which is a smooth strictly ω -psh function.

2.1. Maximum principle. The following maximum principle is a basic tool to establish upper and lower bounds in the sequel.

Proposition 2.1. *Let Ω_t be a smooth family of Kähler metrics on X , and denote by Δ_t the Laplacian with respect to Ω_t . Assume that $H \in C^\infty(X \times [0, T])$ satisfies*

$$\left(\frac{\partial}{\partial t} - \Delta_t \right) H \leq 0 \quad \text{or} \quad \dot{H}_t \leq \log \left[\frac{(\Omega_t + dd^c H_t)^n}{\Omega_t^n} \right],$$

Then $\sup_X H_t \leq \sup_X H_0$ for all $t \in [0, T]$.

If we replace $\leq$ with $\geq$ then $\inf_X H_t \geq \inf_X H_0$.

We include a proof for the reader's convenience.

Proof. Replacing H with $H - \varepsilon t$ with $\varepsilon > 0$, we may assume in each case that the inequality is strict. By compactness H achieves its supremum at some point $(x_0, t_0) \in X \times [0, T]$, and the strict differential inequality implies that t_0 is necessarily 0, since otherwise we would have $\frac{\partial}{\partial t} H \geq 0$ and $dd^c H \leq 0$ at (x_0, t_0) . $\square$

Corollary 2.2. *Let u_t (resp. v_t) be a subsolution (resp. a supersolution) of (CMAF), i.e. $u_0 \leq \varphi_0 \leq v_0$ with*

$$u_t \leq \log \left[\frac{(\theta_t + dd^c u_t)^n}{\mu} \right] \quad \text{while} \quad v_t \geq \log \left[\frac{(\theta_t + dd^c v_t)^n}{\mu} \right].$$

Then $u_t \leq v_t$. Thus if φ_t, ψ_t are solutions of (CMAF) with initial data φ_0, ψ_0 ,

$$\inf_X (\varphi_0 - \psi_0) \leq \varphi_t - \psi_t \leq \sup_X (\varphi_0 - \psi_0).$$

In particular if $\varphi_0 \leq \psi_0$, then $\varphi_t \leq \psi_t$ for all t .

Proof. Apply Proposition 2.1 by setting $\Omega_t = \theta_t + dd^c v_t$ and $H = u_t - v_t$. $\square$

2.2. Bounding φ_t from above.

Lemma 2.3. *The function $t \mapsto \sup_X \varphi_t$ is quasi-decreasing, more precisely*

$$\varphi_t \leq \sup_X \varphi_0 + [n \log 2 - \inf_X h]t.$$

Proof. Observe that $\psi_t := \sup_X \varphi_0 + [n \log 2 - \inf_X h]t$ is a super-solution, i.e.

$$\dot{\psi}_t \geq \log \left[\frac{(\theta_t + dd^c \psi_t)^n}{\mu} \right]$$

with $\psi_0 \geq \varphi_0$ and apply Corollary 2.2 to conclude. $\square$

Remark 2.4. It might be useful to notice for other applications that one can get an upper-bound which is independent of $\inf_X h$. Indeed let ψ_0 denote the solution of the elliptic problem

$$(2\omega + dd^c \psi_0)^n = 2^n \mu,$$

normalized by $\sup_X (\varphi_0 - \psi_0) = 0$. Observe that φ_t is then a subsolution of the corresponding parabolic problem

$$\dot{\varphi}_t = \log \left[\frac{(2\omega + dd^c \varphi_t)^n}{\mu} \right], \quad \varphi_t|_{t=0} = \varphi_0,$$

whose solution is $\psi_t = \psi_0 + nt \log 2$. The comparison principle thus yields

$$\varphi_t \leq \psi_t = \psi_0 + nt \log 2.$$

An alternative observation which will reveal also useful is the following:

Lemma 2.5. *The mean value $I(t) = \frac{1}{V} \int_X \varphi_t d\mu$ is quasi-decreasing, namely*

$$t \mapsto I(t) - t \log(2^n) \text{ is non-increasing.}$$

The function I is moreover convex when $\chi \geq 0$.

Proof. It follows from the concavity of the logarithm that

$$I'(t) = \int_X \log \left[\frac{(\theta_t + dd^c \varphi_t)^n}{\mu} \right] \frac{d\mu}{V} \leq \log \int_X \frac{(\theta_t + dd^c \varphi_t)^n}{V} \leq n \log 2,$$

since we impose $\theta_t \leq 2\omega$.

For the second assertion, observe that

$$\ddot{\varphi}_t = \Delta_{\omega_t} \dot{\varphi}_t + \text{tr}_{\omega_t}(\chi) \geq \Delta_{\omega_t} \dot{\varphi}_t$$

when $\chi \geq 0$, hence

$$V I''(t) = \int_X \ddot{\varphi}_t d\mu \geq \int_X \Delta_{\omega_t} \dot{\varphi}_t e^{-\dot{\varphi}_t} \omega_t^n = n \int_X e^{-\dot{\varphi}_t} d\dot{\varphi}_t \wedge d^c \dot{\varphi}_t \wedge \omega_t^{n-1} \geq 0.$$

□

Recall [GZ05, Proposition 1.7] that since μ is a smooth measure, there exists $C_\mu > 0$ such that

$$\sup_X \varphi - C_\mu \leq \frac{1}{V} \int_X \varphi d\mu \leq \sup_X \varphi$$

for all 2ω -psh functions φ .

2.3. Various bounds from below.

2.3.1. Bounded initial data. Recall (Corollary 2.2) that φ_t dominates any sub-solution. An easy computation yields the following:

Lemma 2.6. *Fix $0 < T < T_{max}^2$. There exists $C = \sup_X h + C_n > 0$ such that $\psi_t = (1 - \sqrt{t})(\varphi_0 - \inf_X \varphi_0 + 1) - Ct + \inf_X \varphi_0 - 1$ is a subsolution, hence*

$$(1 - \sqrt{t})(\varphi_0 - \inf_X \varphi_0 + 1) - Ct + \inf_X \varphi_0 - 1 \leq \varphi_t,$$

for all $(t, x) \in [0, T] \times X$. In particular $\varphi_t \geq \inf_X \varphi_0 - C'$.

Such bound from below is useful to establish the "continuity" of the flow at time zero, starting from a bounded but non-continuous initial data.

Proof. Observe first that ψ_t is θ_t -plurisubharmonic, with

$$\theta_t + dd^c \psi_t = (1 - \sqrt{t})(\omega + dd^c \varphi_0) + \sqrt{t} \theta_{\sqrt{t}} \geq \frac{\sqrt{t}}{2} \omega.$$

We infer

$$\frac{n}{2} \log t - n \log 2 - \sup_X h \leq \log \left[\frac{(\theta_t + dd^c \psi_t)^n}{\mu} \right]$$

while $\dot{\psi}_t = -\frac{1}{2\sqrt{t}}(\varphi_0 - \inf_X \varphi_0 + 1) - C \leq -\frac{1}{2\sqrt{t}} - C$.

Since ψ_t and φ_0 coincide at time zero, the conclusion follows by adjusting the value of C so that for all $t > 0$,

$$-\frac{1}{2\sqrt{t}} - C < \frac{n}{2} \log t - n \log 2 - \sup_X h.$$

□

2.3.2. *Finite energy condition.* Set

$$E(\varphi_t) := \frac{1}{(n+1)V} \sum_{j=0}^n \int_X \varphi_t (\theta_t + dd^c \varphi_t)^j \wedge \theta_t^{n-j}.$$

When $\chi \equiv 0$, i.e. $\theta_t \equiv \omega$, this is the Aubin-Yau energy functional which plays a crucial role in studying the Kähler-Einstein equation (see [Tian, BEGZ10] for recent developments). In particular

$$E(\varphi_0) = \frac{1}{(n+1)V} \sum_{j=0}^n \int_X \varphi_0 (\omega + dd^c \varphi_0)^j \wedge \omega^{n-j}.$$

Definition 2.7. We let $\mathcal{E}^1(X, \omega)$ denote the "finite energy class", i.e. the set of ω -plurisubharmonic functions φ_0 such that $E(\varphi_0) > -\infty$.

A basic observation is the following monotonicity property:

Lemma 2.8. *Fix $0 < T < T_{max}$. There exists $C \geq 0$ such that*

$$t \mapsto E(\varphi_t) + Ct \text{ is increasing on } [0, T],$$

with $C = 0$ if $\chi = 0$. In particular

$$\frac{E(\varphi_0) - Ct}{2^n} \leq \frac{E(\varphi_0) - Ct}{\{\theta_t\}^n / V} \leq \sup_X \varphi_t.$$

Proof. We let the reader check that

$$V \frac{dE(\varphi_t)}{dt} = \int \dot{\varphi}_t \omega_t^n + \frac{1}{(n+1)} \sum_{j=0}^n \int \varphi_t \chi \wedge [j\theta_t + (n-j)\omega_t] \wedge (\omega_t)^{j-1} \wedge \theta_t^{n-j-1}.$$

The first term is almost non-negative as follows from the concavity of the logarithm. Namely

$$\int \log \left(\frac{\omega_t^n}{\mu} \right) \frac{\omega_t^n}{V_t} \geq -\log(V/V_t) \geq -n \log 2,$$

where $V_t := \int_X \omega_t^n \geq V/2^n$ by our assumption $\theta_t \geq \omega/2$. Note that this first term is non-negative when $\chi = 0$, since $V_t = V$ in this case.

The second one (which is zero if $\chi = 0$) is bounded below by $-C$ when $\chi \leq 0$, as can be checked by writing $\chi \varphi_t \geq \chi \sup_X \varphi_t$ and estimating the remaining cup-products.

If χ is not negative, we can nevertheless find $A > 0$ such that $\chi - A\theta_t \leq 0$ for all $0 \leq t \leq T$. Observing that

$$\int \varphi_t (\theta_t + dd^c \varphi_t)^j \wedge \theta_t^{n-j} \leq \int \varphi_t (\theta_t + dd^c \varphi_t)^{j-1} \wedge \theta_t^{n-j+1}$$

we end up with a differential inequality

$$\frac{dE(\varphi_t)}{dt} \geq -C_1 + C_2 E(\varphi_t),$$

for some constants $C_1, C_2 \geq 0$. It follows that $t \mapsto E(\varphi_t) + Ct$ is increasing on $[0, T]$ for an appropriate choice of $C = C_T$. $\square$

2.3.3. *The general case.* Recall that the integrability exponent of φ_0 at point $x \in X$ is

$$c(\varphi_0, x) := \sup\{c > 0 \mid e^{-2c\varphi_0} \in L^1(V_x)\},$$

where V_x denotes an arbitrarily small neighborhood of x . We let

$$c(\varphi_0) := \sup\{c(\varphi_0, x) \mid x \in X\}$$

denote the uniform integrability index of φ_0 . It follows from Skoda's integrability theorem that

$$\frac{1}{\nu(\varphi_0, x)} \leq c(\varphi_0, x) \leq \frac{n}{\nu(\varphi_0, x)},$$

where $\nu(\varphi_0, x)$ denotes the Lelong number of φ_0 at x . Thus $c(\varphi_0) = +\infty$ if and only if φ_0 has zero lelong number at all points.

Fix $0 < \beta < c(\varphi_0)$ and $0 < \alpha$ such that

$$\chi + (2\beta - \alpha)\omega \geq 0.$$

The measure $e^{-2\beta\varphi_0}\mu$ is absolutely continuous with density in L^p , for some $p > 1$. It follows from Kolodziej's uniform estimate [Kol98] that there exists a unique continuous ω -psh function u such that

$$\alpha^n(\omega + dd^c u)^n = e^{\alpha u - 2\beta\varphi_0}\mu.$$

Lemma 2.9. *For $0 < t < \min(T_{max}, 1/2\beta)$ and for all $x \in X$,*

$$(1 - 2\beta t)\varphi_0(x) + \alpha t u(x) + n(t \log t - t) \leq \varphi_t(x).$$

Proof. Set $\psi_t := (1 - 2\beta t)\varphi_0 + \alpha t u + n(t \log t - t)$. It follows from our choice of α, β that ψ_t is θ_t -psh since

$$\theta_t + dd^c \psi_t = (1 - 2\beta t)\omega_{\varphi_0} + \alpha t \omega_u + t[\chi + (2\beta - \alpha)\omega] \geq 0.$$

Moreover ψ_t is a subsolution of (CMAF),

$$(\theta_t + dd^c \psi_t)^n \geq \alpha^n t^n \omega_u^n = e^{\psi_t} \mu,$$

as the reader will easily check. Since $\psi_0 = \varphi_0$, the conclusion follows from the maximum principle. $\square$

Note for later use that this lower bound shows in particular that the integrability exponent (resp. the Lelong number) of φ_t at point x increases (resp. decreases) linearly in time.

3. BOUNDS ON $\dot{\varphi}_t$

In this section again we assume that φ_t satisfies (CMAF) with an initial data φ_0 , which is a smooth strictly ω -psh function.

3.1. Bounding $\dot{\varphi}_t$ from above. The following elementary estimate is, together with Kolodziej's a priori bound, a key to establish the smoothing property of complex Monge-Ampère flows:

Proposition 3.1. *There exists $C = C(\sup_X \varphi_0, -\inf_X h) > 0$ such that for all $t > 0$ and $x \in X$,*

$$\dot{\varphi}_t(x) \leq \frac{-\varphi_0(x) + C}{t} + C$$

Proof. Consider $H(t, x) := t\dot{\varphi}_t(x) - (\varphi_t - \varphi_0)(x) - nt$. Observe that

$$\frac{\partial H}{\partial t} = t\ddot{\varphi}_t - n = t\Delta_{\omega_t}\dot{\varphi}_t + t\operatorname{tr}_{\omega_t}\chi - n$$

while

$$\Delta_{\omega_t}H = t\Delta_{\omega_t}\dot{\varphi}_t - \Delta_{\omega_t}(\varphi_t - \varphi_0) = t\Delta_{\omega_t}\dot{\varphi}_t - [n - \operatorname{tr}_{\omega_t}(T_0) - t\operatorname{tr}_{\omega_t}(\chi)]$$

therefore

$$\left(\frac{\partial}{\partial t} - \Delta_{\omega_t}\right)H = -\operatorname{tr}_{\omega_t}(T_0) \leq 0.$$

It thus follows from Proposition 2.1 that H attains its maximum on $(t = 0)$. Now $H(0, x) \equiv 0$ hence Lemma 2.3 yields the conclusion. $\square$

Note that similar bounds involving $\inf_X \varphi_0$ were previously obtained by Song-Tian [ST09]. When $\dot{\varphi}_0$ is bounded from above, one can also show that $\dot{\varphi}_t$ is uniformly bounded from above (see Szekelyhidi-Tosatti [SzTo11] or Proposition 3.5). However all these estimates require the initial data φ_0 to be bounded, an hypothesis which we want to avoid here.

3.2. Bounding the oscillation of φ_t . Observe that φ_t is a family of θ_t -psh functions such that

$$(\theta_t + dd^c \varphi_t)^n = F_t \omega^n,$$

where for each fixed $t > 0$, the densities

$$F_t = \exp(\dot{\varphi}_t + h) \leq \exp\left(\frac{-\varphi_0(x) + C}{t} + C'\right)$$

are uniformly in $L^2(\omega^n)$ if φ_0 has zero Lelong number at all points (by Skoda's integrability theorem [Sko72]). It follows therefore from the uniform version of Kolodziej's estimates (see [Kol98, EGZ08]) that the oscillation of φ_t is uniformly bounded:

Theorem 3.2. *Assume φ_0 has zero Lelong number at all points $x \in X$. For each $t > 0$, there exists $M(t) > 0$ independent of $\inf_X \varphi_0$ such that*

$$\operatorname{Osc}_X(\varphi_t) \leq M(t).$$

When φ_0 has some positive Lelong number and $T_{\max}$ is large enough¹, then the Lelong numbers of φ_0/t become so small (when t is large) that f_t is uniformly in $L^{1+\varepsilon}(\omega^n)$ for $t \geq t_\varepsilon$ and the same conclusion thus applies.

¹e.g. when $\{\eta\} - c_1(X) = \{\chi\}$ is nef so that $T_{\max} = +\infty$.

3.3. Bounding $\dot{\varphi}_t$ from below. The following estimate is due to Song-Tian [ST09, Lemma 3.2]:

Proposition 3.3. *Fix $0 < T < T_{max}$ and assume φ_0 is bounded. Then for all $(x, t) \in X \times]0, T]$,*

$$\dot{\varphi}_t(x) \geq n \log t - A \text{Osc}_X \varphi_0 - C,$$

where $A > 1/(T_{max} - T)$ and $C = C(A) > 0$.

We include a proof for the reader's convenience.

Proof. Consider $G(t, x) = \dot{\varphi}_t(x) + A\varphi_t(x) - H(t)$, where $H : \mathbb{R}_+^+ \rightarrow \mathbb{R}$ is a smooth function to be specified hereafter. We let the reader check that

$$\left(\frac{\partial}{\partial t} - \Delta_t \right) (G) = A\dot{\varphi}_t + \text{tr}_{\omega_t}(A\theta_t + \chi) - H'(t) - An.$$

Now $A\theta_t + \chi = A\theta_s \geq A\omega/2$ with $s = t + 1/A < T_{max}$ since we assume A is so large that $1/A < T_{max} - T$ hence

$$\text{tr}_{\omega_t}(A\theta_t + \chi) \geq A \text{tr}_{\omega_t}(\omega)/2 \geq \frac{f_t^{-1/n}}{C},$$

where $\log f_t := \dot{\varphi}_t$ and we have used the inequality

$$\text{tr}_{\omega_t}(\omega) \geq n \left(\frac{\omega_t^n}{\omega^n} \right)^{-1/n} \geq f_t^{-1/n} e^{-\sup_X h/n}.$$

Observe finally that $\varepsilon x > \log x - C_\varepsilon$ for all $x > 0$ to conclude that

$$\left(\frac{\partial}{\partial t} - \Delta_t \right) (G) > \frac{f_t^{-1/n}}{C_1} - H'(t) - C_2.$$

The first condition we impose on H is that $H(0) = -\infty$. This insures that the function G attains its minimum on $[0, T] \times X$ at a point (x_0, t_0) with $t_0 > 0$. At this point we therefore have a control on the density f_t , namely

$$C_1[C_2 + H'(t_0)] \geq f_{t_0}^{-1/n}(x_0)$$

which yields

$$G(t_0, x_0) \geq A\varphi_{t_0}(x_0) - C_3 - \{n \log[C_2 + H'(t_0)] + H(t_0)\}$$

It follows from Lemmata 2.3 and 2.6 that $\varphi_{t_0}(x_0) \geq \inf_X \varphi_0 - C'$ and $\varphi_t(x) \leq \sup_X \varphi_0 + C''$, thus

$$\dot{\varphi}_t \geq H(t) - A \text{Osc}_X \varphi_0 - C_4 - \{n \log[C_2 + H'(t_0)] + H(t_0)\}$$

The second condition we now would like to impose on H is that

$$H + n \log [C_2 + H'] \leq C'''$$

is uniformly bounded from above on $]0, T]$. We let the reader check that the "best" function satisfying both conditions and not going too fast to $-\infty$ as t goes to zero is $H(t) = n \log t$. For such a choice we obtain the desired inequality. $\square$

Observe that if we start the complex Monge-Ampère flow (CMAF) from the initial data φ_s , $s \geq 0$, we obtain (by uniqueness of the solution) φ_{t+s} . Thus

$$\dot{\varphi}_{t+s}(x) \geq n \log t - A \text{Osc}_X \varphi_s - C.$$

From Theorem 3.2 we infer the following important consequence:

Corollary 3.4. *Assume φ_0 has zero Lelong number at all points and fix $T < T_{\max}$. Then there exists $\kappa :]0, T] \rightarrow \mathbb{R}^+$ a decreasing function such that for all $0 < t \leq T$ and $x \in X$,*

$$\dot{\varphi}_t(x) \geq -\kappa(t).$$

When φ_0 has positive Lelong number at some points, the conclusion merely applies when $t_\varepsilon \leq t \leq T$.

3.4. Further bounds on the densities. Here we consider the case when the initial data φ_0 is such that its Monge-Ampère measure $(\omega + dd^c \varphi_0)^n = f_0 e^h \omega^n$ is absolutely continuous with respect to Lebesgue measure.

An abstract measure theoretic argument shows that f_0 actually belongs to an Orlicz class: there exists a convex increasing function $w : \mathbb{R}^+ \rightarrow \mathbb{R}^+$ such that $w(t)/t \rightarrow +\infty$ as $t \rightarrow +\infty$ and

$$\int_X w \circ f_0 d\mu < +\infty.$$

Proposition 3.5. *Assume that $\chi \leq 0$. Then the map $t \mapsto \int_X w \circ f_t d\mu$ is decreasing along the complex Monge-Ampère flow, where $f_t := (\theta_t + dd^c \varphi_t)^n / \mu$.*

In particular if $f_0 \in L^\infty(X)$ is bounded from above, then so is f_t , with

$$\dot{\varphi}_t = \log f_t \leq \log \sup_X f_0.$$

Proof. Set $I(t) := \int_X w \circ f_t d\mu$. Using that $\dot{\varphi}_t = \log f_t$, we observe that $\log f_t$ satisfies the following Heat-type equation,

$$\frac{\partial f_t}{\partial t} = \Delta_{\omega_t} f_t - \frac{|\nabla_{\omega_t} f_t|^2}{f_t} + f_t \text{tr}_{\omega_t}(\chi).$$

Assuming $\chi \leq 0$ we infer

$$I'(t) \leq n \int_X \frac{w' \circ f_t}{f_t} dd^c f_t \wedge \omega_t^{n-1} - n \int_X \frac{w' \circ f_t}{f_t^2} df_t \wedge d^c f_t \wedge \omega_t^{n-1}.$$

Integrating by parts yields

$$\begin{aligned} \int_X \frac{w' \circ f_t}{f_t} dd^c f_t \wedge \omega_t^{n-1} &= - \int d \left(\frac{w' \circ f_t}{f_t} \right) \wedge d^c f_t \wedge \omega_t^{n-1} \\ &= - \int_X \frac{w'' \circ f_t}{f_t} df_t \wedge d^c f_t \wedge \omega_t^{n-1} + \int_X \frac{w' \circ f_t}{f_t^2} df_t \wedge d^c f_t \wedge \omega_t^{n-1}, \end{aligned}$$

therefore

$$I'(t) \leq -n \int_X \frac{w'' \circ f_t}{f_t} df_t \wedge d^c f_t \wedge \omega_t^{n-1} \leq 0.$$

as claimed.

Assume now that $f_0 \in L^\infty(X)$. In particular $f_0 \in L^p(X)$ for all $p > 1$ and we've just seen that $\|f_t\|_{L^p} \leq \|f_0\|_{L^p}$. Letting $p \rightarrow +\infty$ yields the desired control. $\square$

This computation is a generalization of an observation due to Chen-Tian-Zhang [CTZ11, Lemma 2.4], who consider the case when $f_0 \in L^p$ for some $p > 1$. In this case φ_0 is continuous, as follows from Kolodziej's estimate [Kol98].

For stronger lower bounds, we note the following immediate consequence of the minimum principle (Proposition 2.1):

Proposition 3.6. *Assume $\chi \geq 0$. If $f_0 > 0$ is uniformly bounded away from zero, then so is f_t for all $t > 0$ with*

$$\dot{\varphi}_t = \log f_t \geq \log \inf_X f_0.$$

Even though it requires a strong condition on the initial data, such a lower bound could be useful in some cases (see e.g. [SzTo11]).

4. HIGHER ORDER ESTIMATES

We assume here again that φ_t satisfies (CMAF) with an initial data φ_0 , which is a smooth strictly ω -psh function.

4.1. Preliminary results. We shall need two standard auxiliary results (see [Yau78, Siu87] for a proof):

Lemma 4.1. *Let α, β be positive $(1, 1)$ -forms. Then*

$$n \left(\frac{\alpha^n}{\beta^n} \right)^{\frac{1}{n}} \leq \text{Tr}_\beta(\alpha) \leq n \left(\frac{\alpha^n}{\beta^n} \right) \cdot (\text{Tr}_\alpha(\beta))^{n-1}.$$

Applying these inequalities to $\alpha = \omega_t := \theta_t + dd^c \varphi_t$ and $\beta = \omega$, we obtain:

Corollary 4.2. *For all $0 < t \leq T < T_{\max}$, there exists $C(t) > 0$ which only depends on $\|\dot{\varphi}_t\|_{L^\infty}, \|h\|_{L^\infty}$ such that*

$$\frac{1}{C(t)} \leq \text{Tr}_\omega(\omega_t) \leq C(t) [\text{Tr}_{\omega_t}(\omega)]^{n-1}.$$

Lemma 4.3. *Let ω, ω' be arbitrary Kähler forms. Let $-B \in \mathbb{R}$ be a lower bound on the holomorphic bisectional curvature of (X, ω) . Then*

$$\Delta_{\omega'} \log \text{Tr}_\omega(\omega') \geq -\frac{\text{Tr}_\omega(\text{Ric}(\omega'))}{\text{Tr}_\omega(\omega')} - B \text{Tr}_{\omega'}(\omega).$$

4.2. Bounding $\Delta \varphi_t$ from above.

Lemma 4.4. *Fix $0 < T < T_{\max}$. Then for all $x \in X$ and $s, t > 0$ such that $s + t \leq T$,*

$$0 \leq t \log \text{Tr}_\omega(\omega_{t+s}) \leq A \text{Osc}_X(\varphi_s) + C + [C - n \log s + A \text{Osc}_X(\varphi_s)]t$$

for some uniform constants $A, C > 0$.

Applying this inequality for $t/2$ and $s = t/2$, we obtain:

Corollary 4.5. *Fix $0 < T < T_{\max}$. Then for all $(t, x) \in [0, T] \times X$*

$$0 \leq t \log \text{Tr}_\omega(\omega_t) \leq 2A \text{Osc}_X(\varphi_{t/2}) + C'.$$

Proof. Set $\alpha := t \log u - A\varphi_{t+s}$, where $u := Tr_\omega(\omega_{t+s})$ and $A > 0$ will be specified later. The desired inequality will follow if we can bound α from above. Set $\Delta_t = \Delta_{\omega_{t+s}}$ and observe that

$$\left(\frac{\partial}{\partial t} - \Delta_t\right)(\alpha) = \log u + \frac{t}{u} \frac{\partial u}{\partial t} - A\dot{\varphi}_{t+s} - t\Delta_t \log u + A\Delta_t \varphi_{t+s}.$$

The last term yields $A\Delta_t \varphi_{t+s} = An - ATr_{\omega_{t+s}}(\theta_{t+s}) \leq An - \frac{A}{2}Tr_{\omega_{t+s}}(\omega)$. The last but one is estimated thanks to Lemma 4.3,

$$-t\Delta_t \log u \leq BtTr_{\omega_{t+s}}(\omega) + t \frac{Tr_\omega(Ric(\omega_{t+s}))}{Tr_\omega(\omega_{t+s})}.$$

Since

$$\frac{t}{u} \frac{\partial u}{\partial t} = \frac{t}{u} \Delta_t(\log \omega_{t+s}^n / \omega^n) = \frac{t}{u} \{-Tr_\omega(Ric \omega_{t+s}) + Tr_\omega(\chi + Ric \omega - dd^c h)\},$$

we infer

$$-t\Delta_t \log u + \frac{t}{u} \frac{\partial u}{\partial t} \leq (B + C_1)tTr_{\omega_{t+s}}(\omega) + C_2,$$

using that $Tr_\omega(\chi + Ric \omega - dd^c h)$ is uniformly bounded below and the elementary inequality $n \leq Tr_{\omega_{t+s}}(\omega)Tr_\omega(\omega_{t+s})$.

It follows now from Lemma 4.1 and the inequality $(n-1)\log x < x + C_n$ that

$$\log u \leq \dot{\varphi}_{t+s} + C_3 + Tr_{\omega_{t+s}}(\omega)$$

Altogether this yields

$$\left(\frac{\partial}{\partial t} - \Delta_t\right)(\alpha) \leq C_4 - (A-1)\dot{\varphi}_{t+s} + [(B + C_1)t + 1 - A/2]Tr_{\omega_{t+s}}(\omega).$$

We choose $A > 0$ so large that $(B + C_1)t + 1 - A/2 < 0$. The desired inequality now follows from the maximum principle and Lemma 2.3, together with Proposition 3.3. $\square$

4.3. Evans-Krylov and Schauder. Using the complex parabolic Evans-Krylov theory together with Schauder's estimates (see [BG13, Theorem 3.1.4]), it follows from previous results that the following higher order a priori estimates hold:

Theorem 4.6. *Fix $0 < T < T_{max}$. If φ_0 has zero Lelong number at all points $x \in X$ then for each $\varepsilon > 0$ and $k \in \mathbb{N}$, there exists $C_k(\varepsilon) > 0$ such that*

$$\|\varphi_t\|_{C^k(X \times [\varepsilon, T])} \leq C_k(\varepsilon).$$

If φ_0 has positive Lelong number at some points, the same results hold but only on some time interval $[t_\varepsilon, T]$.

We will analyze more precisely the value of t_ε in section 6.

5. PROOF OF THE MAIN THEOREM

We are now ready to prove Theorem 1.1.

5.1. Defining the flow. Let φ_0 be an ω -psh function. Using [Dem92] (or [BK07]), we approximate φ_0 by a decreasing sequence $\varphi_{0,j}$ of smooth ω -psh functions. We let $\varphi_{t,j}$ denote the smooth family of θ_t -psh functions, solution of the parabolic flow

$$(CMAF) \quad \frac{\partial \varphi_{t,j}}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi_{t,j})^n}{\omega^n} \right]$$

with initial value $\varphi_{0,j}$, which is well defined on $[0, T_{max}[\times X$.

It follows from Corollary 2.2 that for (t, x) fixed, $j \mapsto \varphi_{t,j}(x)$ is non-increasing. We can thus set

$$\varphi_t(x) := \lim_{j \rightarrow +\infty} \searrow \varphi_{t,j}(x).$$

It follows from Lemma 2.9 that the functions $t \mapsto \sup_X \varphi_{t,j}$ are uniformly bounded, thus φ_t is not identically $-\infty$ hence it is a well defined θ_t -psh function.

It moreover follows from Theorem 4.6 that for all $t > 0$, φ_t is smooth and satisfies

$$\frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi_t)^n}{\omega^n} \right]$$

when φ_0 has zero Lelong number at all points.

Note that (φ_t) is relatively compact in L^1 as $t \rightarrow 0^+$. We show in the next section that $\varphi_t \rightarrow \varphi_0$ as $t \searrow 0^+$, where the stronger the regularity assumption on φ_0 , the stronger the convergence.

5.2. Continuity at zero. Let $\psi = \lim \varphi_{t_k}$ be a cluster value of (φ_t) , as $t \rightarrow 0^+$. It is a standard property of quasi-plurisubharmonic functions that for all $x \in X$,

$$\psi(x) \leq \limsup \varphi_{t_k}(x),$$

with equality almost everywhere. We claim that

$$\psi \leq \varphi_0.$$

It follows indeed from Corollary 2.2 that $\varphi_{t,j}$ decreases to φ_t , hence for all $j \in \mathbb{N}$,

$$\psi(x) \leq \limsup \varphi_{t_k}(x) \leq \limsup \varphi_{t_k,j}(x) = \varphi_{0,j}(x)$$

since $\varphi_{t,j}$ is continuous at $t = 0$. The conclusion follows by letting $j \rightarrow +\infty$.

We now analyze various settings in which we establish the reverse inequality.

5.2.1. Convergence in capacity. When the initial data φ_0 is continuous, it follows from Corollary 2.2 that $\varphi_t \in C^0([0, T_{max}[\times X)$, hence φ_t uniformly converges towards φ_0 as $t \rightarrow 0$.

We can not expect uniform convergence when φ_0 is merely bounded; it follows however from Lemma 2.6 that $\psi \geq \varphi_0$. Thus

$$\varphi_t \rightarrow \varphi_0$$

in this case and the convergence moreover holds in capacity: this roughly says that the convergence is uniform outside sets of arbitrarily small capacity. It is the strongest convergence one can expect in this bounded context (see [GZ05]).

Remark 5.1. Observe that for all $x \in X$,

$$(\varphi_t - \varphi_0)(x) = \int_0^t \dot{\varphi}_s(x) ds = \int_0^t \log f_s(x) ds,$$

where $f_s = (\theta_s + dd^c \varphi_s)^n / \mu$. We have shown earlier that, when φ_0 is bounded,

$$f_s \geq s^n / C \quad \text{while} \quad \log f_s \leq C/s,$$

for some appropriate constant $C > 0$. Although the upper bound is much weaker, it is not far from being optimal if the initial data is bounded but not continuous: indeed if we could uniformly bound from above $\log f_s(x)$ by $h(s)$ with h integrable at zero, it would follow that φ_t uniformly converges towards φ_0 as $t \rightarrow 0$, hence φ_0 would have to be continuous.

5.2.2. Convergence in energy. We consider here the case when φ_0 has finite energy,

$$E(\varphi_0) := \frac{1}{(n+1)V} \sum_{j=0}^n \int_X \varphi_0 (\omega + dd^c \varphi_0)^j \wedge \omega^{n-j} > -\infty.$$

We refer the interested reader to [GZ07, BEGZ10] for various information on the finite energy class $\mathcal{E}^1(X, \omega)$ of those ω -psh functions with finite energy.

Proposition 5.2. *Assume $\varphi_0 \in \mathcal{E}^1(X, \omega)$. As t decreases to zero, the functions φ_t converge to φ_0 in energy (hence in particular in $L^1(X)$).*

Proof. It follows from Lemma 2.8 that the functions φ_t stay in a compact subset of $\mathcal{E}^1(X, \omega)$. Let $\psi \leq \varphi_0$ be a cluster point as $t \rightarrow 0$.

Recall from [BEGZ10] that the energy $E(\cdot)$ is upper semi-continuous (for the weak L^1 -topology), it follows therefore from Lemma 2.8 that

$$E(\varphi_0) \leq \lim_{t_j \rightarrow 0} E(\varphi_{t_j}) \leq E(\psi) \leq E(\varphi_0),$$

where the latter inequality follows from the fact that $\varphi \mapsto E(\varphi)$ is monotone increasing. We infer $E(\psi) = E(\varphi_0)$, whence $\varphi_0 = \psi$, as desired.

This not only shows that $\varphi_t \rightarrow \varphi_0$ in the L^1 -sense as $t \rightarrow 0$, but also that it does so in energy, in the sense of [BBGZ13, BBEGZ11]. $\square$

Let us stress an important feature of the convergence in energy: it guarantees the continuity of the complex Monge-Ampère measures

$$(\theta_t + dd^c \varphi_t)^n \xrightarrow{t \rightarrow 0} (\omega + dd^c \varphi_0)^n,$$

whereas these operators are usually discontinuous for the weaker L^1 -convergence of potentials, which we now consider.

5.2.3. L^1 -convergence. We finally treat the general case of an arbitrary initial data $\varphi_0 \in L^1$. Recall from Lemma 2.9 that

$$(1 - \beta t)\varphi_0 + \alpha t u + n(t \log t - t) \leq \varphi_t$$

where u is a continuous ω -psh function, thus

$$\varphi_0 \leq \liminf_{t \rightarrow 0} \varphi_t.$$

Since $\psi \leq \varphi_0$, we infer $\psi \equiv \varphi_0$, as desired.

5.3. Uniqueness. Let $(\varphi_t)_{t>0}$ be the solution to (CMAF) constructed above by approximation, and assume $(\psi_t)_{t>0}$ is another family of smooth θ_t -psh functions which satisfy, on $]0, T_{max}[\times X$,

$$\frac{\partial \psi_t}{\partial t} = \log \left[\frac{(\theta_t + dd^c \psi_t)^n}{\mu} \right],$$

with $\psi_t \rightarrow \varphi_0$ as $t \searrow 0^+$.

We claim that $\psi_t(x) \leq \varphi_t(x)$ for all t, x . Let $\varphi_{0,j}$ be a family of smooth ω -psh functions decreasing to φ_0 . By construction the θ_t -psh functions $\varphi_{t,j}$ are smooth on $[0, T_{max}[\times X$ and decrease pointwise to φ_t . It thus suffices to show that $\psi_t \leq \varphi_{t,j}$, for all fixed $j \in \mathbb{N}$.

Fix $\varepsilon > 0$. It follows from the maximum principle that the smooth function $\psi_t - \varphi_{t,j}$ attains its maximum on $[\varepsilon, T] \times X$ at a point $(\varepsilon, x_\varepsilon)$, thus

$$\psi_t(x) - \varphi_{t,j}(x) \leq \sup_X (\psi_\varepsilon - \varphi_{\varepsilon,j}).$$

Since $(\varepsilon, x) \mapsto \varphi_{\varepsilon,j}(x)$ is continuous, it follows from Hartogs lemma that

$$\sup_X (\psi_\varepsilon - \varphi_{\varepsilon,j}) \xrightarrow{\varepsilon \rightarrow 0} \sup_X (\varphi_0 - \varphi_{0,j}) \leq 0.$$

Thus $\psi_t(x) \leq \varphi_{t,j}(x)$ for all (t, x, j) and the conclusion follows.

The uniqueness property we have just established is called "maximally stretched" by P.Topping in complex dimension $n = 1$ (see [Top10, GT11]).

6. CURRENTS WITH POSITIVE LELONG NUMBERS

6.1. Long time existence. As we have noted on several occasions, our construction of the (twisted) Kähler-Ricci flow also yields interesting information in case the initial current T_0 has positive Lelong numbers.

Recall that the (global) integrability index of $T_0 = \omega + dd^c \varphi_0$ is

$$c(T_0) := \sup\{c > 0 \mid \int_X e^{-2c\varphi_0} \omega^n < +\infty\}.$$

The definition clearly does not depend on the choice of potential.

When T_0 has positive Lelong numbers, it follows from Skoda's integrability theorem [Sko72] that $c(T_0)$ is positive and finite. The "openness conjecture" of Demailly-Kollar [DK01] asserts that $e^{-2c(T_0)\varphi_0} \notin L^1$. It has been solved very recently by Berndtsson [Bern13] (the two dimensional case was previously settled in [FJ05]). When the cohomology class of ω is rational and $T_0 = [D]$ is the current of integration along a (rational) effective divisor, the exponent $c(T_0) = lct(D)$ is the log-canonical threshold of D , an important algebraic invariant.

If $T_{max} > 1/c(T_0)$ it follows from Proposition 3.1 that we have good control on the time derivative $\dot{\varphi}_t$ for $1/2c(T_0) < t < T_{max}$, namely

$$\|e^{\dot{\varphi}_t}\|_{L^{1+\varepsilon}} \leq C_\varepsilon$$

for all $\varepsilon > 0$ and $(1 + \varepsilon)/2c(T_0) \leq t \leq T_\varepsilon < T_{max}$. The following result therefore follows from Kolodziej's estimates and our previous analysis:

Theorem 6.1. *Let $T_0 \in \alpha_0$ be a positive current such that $1/2c(T_0) < T_{max}$. There exists a unique maximal family $(\omega_t)_{0 < t < T_{max}}$ of positive currents, whose potentials are the decreasing limits of parabolic flows approximating the potential of T_0 ; ω_t weakly converges towards T_0 , as $t \searrow 0^+$.*

When $t > 1/2c(T_0)$ these are smooth Kähler forms such that

$$\frac{\partial \omega_t}{\partial t} = -\text{Ric}(\omega_t) + \eta.$$

This basically means that the singularities of T_0 are slowly attenuated (by Lemma 2.9 the Lelong numbers of φ_t are linearly decreasing) so that ω_t eventually becomes a smooth Kähler form. This should be compared with Demailly's use of Kiselman's technique of attenuation of singularities: when regularizing a positive current in [Dem92], the presence of positive Lelong numbers is an obstruction to the approximation with small loss of positivity.

When $c_1(X) - \{\eta\} \leq 0$ so that $T_{max} = +\infty$, we therefore obtain the following generalization of Cao's celebrated result:

Theorem 6.2. [Cao85, ST12] *If $c_1(X) - \{\eta\} \leq 0$, the twisted Kähler-Ricci flow continuously deforms any positive closed $(1, 1)$ -current to a canonical metric.*

On the other hand there might be no smoothing at all when $T_{max} < 1/2c(T_0)$. We analyze more precisely this problem in the next section.

6.2. The normalized Kähler-Ricci flow on Fano manifolds. In this section we have a closer look at the smoothing properties of the normalized Kähler-Ricci flow on a Fano manifold, i.e. a manifold with positive first Chern class $c_1(X)$.

We assume here $\alpha_0 = c_1(X)$ and the Ricci-flow is normalized so as to have constant volume,

$$\frac{\partial \omega_t}{\partial t} = -\text{Ric}(\omega_t) + \omega_t.$$

One classically passes from the (unnormalized) Kähler-Ricci flow to the normalized one by rescaling in space and time: if Ω_s solves the Kähler-Ricci flow, then

$$\omega_t = e^t \Omega_{1-e^{-t}}$$

solves the normalized Kähler-Ricci flow. At the level of potentials we obtain

$$(NCMAF) \quad \frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\omega + dd^c \varphi_t)^n}{e^h \omega^n} \right] + \varphi_t,$$

where ω is a fixed Kähler form in $c_1(X) = \alpha_0$, $\omega_t = \omega + dd^c \varphi_t$ and

$$\text{Ric}(\omega) = \omega + dd^c h.$$

Our analysis thus applies here again, showing that we can run this flow from an arbitray positive current $T_0 = \omega + dd^c \varphi_0$ with zero Lelong numbers. The flow exists here for all times $t > 0$, i.e. the "normalized" T_{max} is $+\infty$.

We can adapt the proof of Proposition 3.1 and obtain here:

Proposition 6.3. *For all $x \in X$ and $t > 0$,*

$$\dot{\varphi}_t(x) \leq \frac{-\varphi_0(x) + e^t \sup_X \varphi_0 + nt}{1 - e^{-t}}$$

Proof. Consider $H(t, x) = (1 - e^{-t})\dot{\varphi}_t - (\varphi_t - \varphi_0) - nt$ and show that

$$\left(\frac{\partial}{\partial t} - \Delta_t\right) H = -\text{tr}_{\omega_t}(T_0) \leq 0.$$

The upper bound on φ_t can be obtained by applying the maximum principle to the function $e^{-t}\varphi_t(x)$. $\square$

Although the flow exists for all times $t > 0$, the attenuation of singularities is limited, as $1 - e^{-t} \nearrow 1$ as $t \nearrow +\infty$ (in contrast to $t \nearrow +\infty$ in Proposition 3.1). One can indeed not always expect smoothing properties in this case as the following simple example shows:

Example 6.4. Let $X = \mathbb{CP}^n$ equipped with a Kähler-Einstein Fubini-Study metric $\omega = (n+1)\omega_{FS} \in c_1(\mathbb{CP}^n)$, whose potential is written in some homogeneous coordinates as

$$\rho = \frac{(n+1)}{2} \log \sum_{i=0}^n |z_i|^2.$$

We can rescale these coordinates and still obtain a Kähler-Einstein metric (image of the initial one by a holomorphic automorphism), for example

$$\varphi^j = \frac{(n+1)}{2} \log \left[|z_0|^2/j + \sum_{i=1}^n |z_i|^2 \right] - (n+1) \log \|z\|$$

is such that $\omega^j := \omega + dd^c \varphi^j$ is Kähler-Einstein. Observe that

$$\varphi_0 = (n+1) \log \|(z_1, \dots, z_n)\| - (n+1) \log \|z\| = \lim_{j \rightarrow +\infty} \searrow \varphi^j$$

is such that $c(\varphi_0) = n/(n+1)$.

Since the ω^j are fixed points of the normalized Kähler-Ricci flow, our approximation process yields in this case a stationary family $\varphi_t \equiv \varphi_0$, hence there is no regularization at all here! A similar construction can be made on any Kähler-Einstein Fano manifold admitting non trivial holomorphic vector fields.

On the other hand we have the following positive result, which allows to extend Perelman's celebrated convergence result:

Theorem 6.5. *Let X be a Fano manifold. Let $T_0 \in c_1(X)$ be a positive current with integrability index $c(T_0) > 1$. Then the normalized Kähler-Ricci flow can be run from T_0 and yields a family of positive currents ω_t which are smooth Kähler forms for $t \geq 1$.*

If D_0 is a smooth anticanonical divisor, then one can also run the normalized Kähler-Ricci flow with initial data $T_0 = [D_0]$.

In particular if X admits a Kähler-Einstein, then the normalized Kähler-Ricci flow continuously deforms any such T_0 to a Kähler-Einstein metric.

A similar result can be obtained for the twisted Kähler-Ricci flow, using the recent work of Collins-Szekelyhidi [CSz12].

Proof. Assume first that $T_0 = \omega + dd^c \varphi_0$ with $c(\varphi_0) > 1$. Let u be a continuous ω -psh function such that

$$(\omega + dd^c u)^n = e^{2u-2\varphi_0} \omega^n.$$

That such a function exists follows from our assumption on the integrability index, together with Kolodziej's uniform estimate [Kol98]. Observe that

$$u_t = e^{-t} \varphi_0 + (1 - e^{-t})u - Ct + n(t \log t - t)$$

is a family of ω -psh functions which satisfy

$$(\omega + dd^c u_t)^n \geq (1 - e^{-t})^n (\omega + dd^c u)^n \geq \frac{\min(t^n, 1)}{2^n} e^{2u-2\varphi_0} \omega^n,$$

while

$$e^{\dot{u}_t - u_t + h} \omega^n = t^n e^{(2u-2\varphi_0)e^{-t} - u + h - C} \leq (\omega + dd^c u_t)^n$$

on $X \times [0, T]$, if $C \gg 1$ is large enough.

It follows from the maximum principle and Proposition 6.3 that $\varphi_t \geq u_t$ and

$$e^{\dot{\varphi}_t - \varphi_t} \leq \exp \left(- \left[e^{-t} + \frac{1}{1 - e^{-t}} \right] \varphi_0 + C' \right) \in L^p,$$

for some $p > 1$ as soon as $t > -\ln \left(\frac{3-\sqrt{5}}{2} \right)$.

We now consider the case when $T_0 = \omega + dd^c \varphi_0 = [D_0]$ is the current of integration along a smooth anticanonical divisor. Note that $\varphi_0 = \log |s_0|_h$, where s_0 is a holomorphic section of $-K_X$ such that $D_0 = (s_0 = 0)$ and h is a smooth hermitian metric with positive curvature form $\Theta_h = \omega$. In this case $c(T_0) = 1$ but the Poincaré type metric

$$\mu := e^{-2\varphi_0} \frac{\omega^n}{(\log |s_0|_h^2)^2} = \frac{\omega^n}{|s_0|_h^2 (\log |s_0|_h^2)^2}$$

has finite mass if D_0 is smooth or not too singular (this is precisely what we need here). It follows from the work of Tian-Yau (see [Auv11] for more recent information on this topic) that one can solve the complex Monge-Ampère equation

$$(\omega + dd^c v)^n = c \mu,$$

where u is ω -psh on X , smooth in $X \setminus D$, with mild singularities along D (modelled on the potential $-\log(-\log |s_0|_h^2)$). In particular v has zero Lelong number at all points of X . This latter mild information can also be obtained as a particular case of the results developed in [GZ07]. Observe that $u = v + C$ is then a solution of the complex Monge-Ampère equation

$$(\omega + dd^c u)^n = e^{2u-2\varphi_0} \omega^n,$$

for some appropriate choice of the normalizing constant $C \in \mathbb{R}$. We can from there proceed as in the case when $c(T_0) > 1$.

The asymptotic behavior of ω_t as $t \rightarrow +\infty$, is the same as that of the normalized Kähler-Ricci flow with smooth initial value ω_1 , as follows from the semi-group property. It thus follows from a celebrated result of Perelman (see [TZ07]) that when $t \rightarrow +\infty$, ω_t converges to a Kähler-Einstein metric if there is one. $\square$

Remark 6.6. Note that one can similarly continuously deform any positive current $T_0 = \omega + dd^c \varphi_0$ with $c(\varphi_0) = 1$, as long as $e^{-2\varphi_0}/[1 + |\varphi_0|^N] \in L^1$. While it is now known that $e^{-2\varphi_0}$ is not integrable at this critical exponent [Bern13], it is tempting to make the *closedness conjecture* that one can always reach integrability at the critical exponent by adding by a polynomial factor.

Remark 6.7. Here follows a heuristic argument showing how the smoothing property of the Kähler-Ricci flow should help in analyzing the long term behavior of the normalized Kähler-Ricci flow on Fano varieties.

Assume for simplicity that X is a Fano manifold with no holomorphic vector field and pick $\omega \in c_1(X)$ a Kähler form. Its Ricci curvature form decomposes as

$$\text{Ric}(\omega) = \omega + dd^c h,$$

where we normalize the function h (the Ricci deviation) so that $\int_X e^h \omega^n = 1$.

Any other Kähler form in $c_1(X)$ writes $\omega_\varphi = \omega + dd^c \varphi$, for some smooth ω -psh function φ . It follows from the work of Tian [Tian97] that X admits a (unique) Kähler-Einstein ω_{KE} if and only if the functional

$$\mathcal{F} : \omega_\varphi \mapsto E(\varphi) + \log \int_X e^{-\varphi+h} \omega^n$$

is *proper* (it is then actually even *coercive* as was shown by Phong-Song-Sturm-Weinkove in [PSSW08]). Moreover ω_{KE} is then the unique maximizer of $\mathcal{F}$. Here E denotes the functional introduced earlier, namely

$$E(\varphi) = \frac{1}{(n+1)V} \sum_{j=0}^n \int_X \varphi \omega_\varphi^j \wedge \omega^{n-j}.$$

We now consider the normalized Kähler-Ricci flow $(\omega_t)_{t>0}$ starting from $\omega_0 = \omega$ and the goal is to propose a scheme for the proof of Perelman's result that $\omega_t \rightarrow \omega_{KE}$ as $t \rightarrow +\infty$, assuming $\mathcal{F}$ is proper:

- (1) observe that $\mathcal{F}$ is non decreasing along the normalized Kähler-Ricci flow and even increasing unless we have reached ω_{KE} (entropy argument);
- (2) The properness assumption implies that the ω_t 's stay in a compact subset of the finite energy class $\mathcal{E}^1(c_1(X))$;
- (3) the functional $\mathcal{F}$ is constant on the set $\mathcal{C}$ of cluster values which consists of finite energy currents;
- (4) one can run the normalized Kähler-Ricci flow starting from any $T_0 \in \mathcal{C}$, since $\mathcal{F}$ is constant on $\mathcal{C}$, it follows from (1) that $\mathcal{C} = \{\omega_{KE}\}$.

All these arguments however need delicate justifications, we refer the interested reader to [BBEGZ11] for more details.

6.3. The 2D-Ricci flow. The smoothing properties of the Ricci flow in (real) dimension two has been intensively studied in the past twenty years, in connection with equations of porous medium type, notably the logarithmic (fast) diffusion equation. There is no existence nor uniqueness of solutions in general, if the initial measure has atoms (see [Vaz06]).

If $X = \mathbb{CP}^1$ is the Riemann sphere and ω a Fubini-Study metric, we can write $\omega_t = dd^c\psi_t$ in a chart $\mathbb{C} \subset \mathbb{CP}^1$, with

$$\frac{\partial\psi_t}{\partial t} = \log \Delta_\omega \psi_t \quad \text{in } \mathbb{C} = \mathbb{R}^2.$$

Setting $f_t = \Delta_\omega \psi_t$, this transforms into

$$\frac{\partial f_t}{\partial t} = \Delta_\omega \log f_t \quad \text{in } \mathbb{C} \times]0, T]$$

with initial data a positive Radon measure $T_0 = dd^c\psi_0 \geq 0$. We refer the interested reader to [GT11, R12, Top10, Top12] for recent works in this direction. It seems that our results go beyond what was previously known in this two-dimensional setting.

7. THE KÄHLER-RICCI FLOW ON LT VARIETIES

In this final section we briefly explain how to generalize our previous results in two different directions. We first show that one can even run the twisted Kähler-Ricci flow from a current representing a class that is merely nef. We then extend our previous analysis to the case of mildly singular varieties.

7.1. Starting from a nef class. Our purpose here is to show that the twisted Kähler-Ricci flow can also be used to smooth out a positive current with zero Lelong numbers belonging to a nef class, as long as the corresponding deformation at the level of cohomology immediately enters the Kähler cone.

Theorem 7.1. *Assume that α_0 is nef while $\{\eta\} - c_1(X)$ is a Kähler class. Let $T_0 \in \alpha_0$ be a positive current with zero Lelong numbers. There exists a unique maximal family $(\omega_t)_{0 < t < T_{max}}$ of Kähler forms such that*

$$\frac{\partial \omega_t}{\partial t} = -Ric(\omega_t) + \eta,$$

and ω_t weakly converges towards T_0 , as $t \searrow 0^+$.

The proof follows exactly the same lines as that of our previous results, so we only emphasize the main differences.

Proof. The problem can again be rewritten at the level of potentials. Fix θ a smooth differential closed form representing α_0 (note that θ is not necessarily semi-positive) and let $\varphi_0 \in PSH(X, \theta)$ be a θ -psh potential for T_0 , i.e. $T_0 = \theta + dd^c\varphi_0$. Fix $\omega \in \{\eta\} - c_1(X)$ a Kähler form and write $\omega_t = \theta + t\omega + dd^c\varphi_t$ so that

$$\frac{\partial \omega_t}{\partial t} = -Ric(\omega_t) + \eta,$$

is equivalent to

$$\frac{\partial \varphi_t}{\partial t} = \log \left[\frac{(\theta + t\omega + dd^c\varphi_t)^n}{e^h \omega^n} \right]$$

for some smooth real valued function h .

We already now how to solve the corresponding problem when α_0 is a Kähler class, so it is natural to approximate by replacing α_0 with $\alpha_0 + \varepsilon\{\omega\}$, $\varepsilon > 0$. We

let $\varphi_{t,\varepsilon}$ denote the solution of the corresponding scalar parabolic flow, with fixed initial data φ_0 (which is a $(\theta + \varepsilon\omega)$ -psh function with zero Lelong numbers).

Our first observation is that $\varepsilon \mapsto \varphi_{t,\varepsilon}$ is non-increasing. This follows from the maximum principle, since for $0 < \varepsilon < \varepsilon'$, the function $x \mapsto \varphi_{\varepsilon,t}(x)$ is both $(\theta + (\varepsilon + t)\omega)$ -psh and $(\theta + (\varepsilon' + t)\omega)$ -psh, and satisfies

$$(\theta + (\varepsilon + t)\omega + dd^c \varphi_{\varepsilon,t})^n = e^{\dot{\varphi}_{\varepsilon,t} + h} \omega^n \leq (\theta + (\varepsilon' + t)\omega + dd^c \varphi_{\varepsilon,t})^n,$$

thus $\varphi_{\varepsilon,t}$ is a subsolution of the parabolic Cauchy problem solved by $\varphi_{\varepsilon',t}$.

We can thus consider

$$\varphi_t := \lim_{\varepsilon \rightarrow 0^+} \searrow \varphi_{\varepsilon,t}$$

and we now need to show that φ_t is bounded from below (so as to guarantee in particular that $\varphi_t \neq -\infty$). We can assume without loss of generality that $\theta + \omega$ is a Kähler form (up to rescaling ω). Let u be a continuous $(\theta + \omega)$ -psh function such that

$$(\theta + \omega + dd^c u)^n = e^{u - \varphi_0} e^h \omega^n,$$

and consider $u_t = (1-t)\varphi_0 + tu + n(t \log t - t)$. The latter is a family of $(\theta + t\omega)$ -psh functions such that

$$(\theta + t\omega + dd^c u_t)^n \geq t^n (\theta + \omega + dd^c u)^n = e^{\dot{u}_t + h} \omega^n$$

with $u_0 = \varphi_0$. It therefore follows from the maximum principle that $\varphi_t \geq u_t$ which yields the desired lower bound.

We now briefly indicate how to deal with the key upper bound on $\dot{\varphi}_t$. For $\delta > 0$ we fix ω_δ a Kähler form representing the Kähler class $\alpha_0 + \delta\{\eta\} - \delta c_1(X)$ and let h_δ be a smooth function such that

$$\theta + \delta\omega = \omega_\delta + dd^c h_\delta.$$

Observe now that the parabolic equation can be rewritten, for $t \geq \delta$, as

$$(\omega_\delta + (t - \delta)\omega + dd^c(\varphi_t + h_\delta))^n = F_t \omega_\delta^n$$

where the densities

$$F_t = e^{\dot{\varphi}_t + h} \frac{\omega^n}{(\omega_\delta + (t - \delta)\omega)^n}$$

are uniformly in L^2 , since (as we have shown earlier)

$$\dot{\varphi}_t \leq -\frac{\varphi_0(x) + C}{t} + C.$$

It therefore follows from Kolodziej's estimate [Kol98] that $\varphi_t + h_\delta$ is uniformly bounded for $t \geq \delta$, hence so is φ_t .

The remaining estimates are identical to the ones previously established when α_0 is Kähler as the reader is invited to check. $\square$

Remark 7.2. Recall [BEGZ10] that a nef class does not necessarily contain a positive current with zero Lelong numbers. One can however slowly attenuate the logarithmic singularities along the lines of the results from section 6.

7.2. Deforming along big and semi-positive classes.

7.2.1. Continuous initial data. Recall that a $(1,1)$ -class $\alpha \in H^{1,1}(X, \mathbb{R})$ is *big* iff it can be represented by a *Kähler current*, i.e. a closed $(1,1)$ -current T such that $T \geq c\omega$ for some $c > 0$.

Lemma 7.3. *if θ is a closed real $(1,1)$ -form on X whose cohomology class in $H^{1,1}(X, \mathbb{R})$ is big then there exists a θ -psh function $\psi_\theta \leq 0$ such that:*

- (i) ψ_θ is of class C^∞ on a Zariski open set $\Omega \subset X$,
- (ii) $\psi_\theta \rightarrow -\infty$ near $\partial\Omega$,
- (iii) $\omega_\Omega := (\theta + dd^c\psi_\theta)|_\Omega$ is the restriction to Ω of a Kähler form on a compactification $\tilde{X}$ of Ω dominating X .

This follows from Demailly's regularization theorem [Dem92]. Condition (iii) means that there exists a compact Kähler manifold $(\tilde{X}, \omega_{\tilde{X}})$ and a modification $\pi : \tilde{X} \rightarrow X$ s.t. π is an isomorphism over Ω and $\pi^*\omega_\Omega = \omega_{\tilde{X}}$ on $\pi^{-1}(\Omega)$.

By the Noetherian property of closed analytic subsets, the set of all Zariski open subsets Ω so obtained admits a largest element, called the *ample locus* of θ and denoted by $\text{Amp}(\theta)$ (see [Bou04, Theorem 3.17]). Note that $\text{Amp}(\theta)$ only depends on the cohomology class of θ .

Our starting point is the following result proved in [BG13], which is a mild generalization of the technical heart of [ST09]:

Theorem 7.4. *Let X be a compact Kähler manifold, $T \in (0, +\infty)$, and let $(\theta_t)_{t \in [0, T]}$ be a smooth path of closed semipositive $(1,1)$ -forms such that $\theta_t \geq \theta$ for a fixed semipositive $(1,1)$ -form θ with big cohomology class. Consider*

$$\mu = e^{\psi^+ - \psi^-} \omega_X^n$$

a positive measure on X , where

- $\psi^\pm$ are quasi-psh functions on X ;
- $e^{-\psi^-} \in L^p$ for some $p > 1$;
- $\psi^\pm$ are smooth on a given Zariski open subset $U \subset \text{Amp}(\theta)$.

For each continuous θ_0 -psh function $\varphi_0 \in C^0(X) \cap \text{PSH}(X, \theta_0)$, there exists a unique bounded continuous function $\varphi \in C_b^0(U \times [0, T])$ with $\varphi|_{U \times \{0\}} = \varphi_0$ and such that on $U \times (0, T)$ φ is smooth and satisfies

$$\frac{\partial \varphi}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi)^n}{\mu} \right]. \quad (7.1)$$

Furthermore, φ is in fact smooth up to time T , i.e. $\varphi \in C^\infty(U \times (0, T])$.

Our goal is now to allow more singular θ -plurisubharmonic initial data φ_0 . For simplicity we only discuss the case of initial data with zero Lelong numbers and we only deal with initial cohomology classes that are both big and semi-positive.

7.2.2. General case. We are going to prove the following

Theorem 7.5. *Let X be a compact Kähler manifold, $T \in (0, +\infty)$, and let $(\theta_t)_{t \in [0, T]}$ be an affine path of closed semipositive $(1,1)$ -forms such that $\theta_t \geq \theta$ for a fixed semipositive $(1,1)$ -form θ with big cohomology class. Consider*

$$\mu = e^{\psi^+ - \psi^-} \omega^n$$

a positive measure on X , where

- $\psi^\pm$ are quasi-psh functions on X ;
- $e^{-\psi^-} \in L^p$ for some $p > 1$;
- $\psi^\pm$ are smooth on a given Zariski open subset $U \subset \text{Amp}(\theta)$.

For each θ_0 -psh function $\varphi_0 \in \text{PSH}(X, \theta_0)$ with zero Lelong numbers, there exists a unique maximally stretched function $\varphi \in C^\infty(U \times (0, T))$ such that

- for all $t \in [0, T]$, $\varphi_t := \varphi(t, \cdot)$ extends as a θ_t -psh function on X ;
- $\|\varphi_t - \varphi_0\|_{L^1} \rightarrow 0$ as $t \rightarrow 0$;
- $\frac{\partial \varphi}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi)^n}{\mu} \right]$ on $U \times (0, T)$.

Proof. It follows from [EGZ11] that one can find a sequence of continuous θ_0 -psh functions $\varphi_{0,j}$ decreasing towards φ_0 . Let $\varphi_{t,j}$ denote the corresponding approximating solutions provided by Theorem 7.4. It follows again from the maximum principle that $j \mapsto \varphi_{t,j}$ is non increasing, hence we consider

$$\varphi_t := \lim_{j \rightarrow +\infty} \searrow \varphi_{t,j}.$$

The goal is thus to establish a priori estimates. For simplicity we assume $U = \Omega = \text{Amp}(\theta)$ (the general case necessitates minor adjustments, see for example [BG13, Lemma 3.3.2]). We work on the approximants $\varphi_{t,j}$, but we suppress the subscript j in the sequel.

We first find an appropriate subsolution. This will guarantee that φ_t is not identically $-\infty$, hence is a well defined θ_t -psh function. The proof is completely similar to the Kähler case: let u denote a θ -psh function with minimal singularities such that

$$(\theta + dd^c u)^n = e^{u - \varphi_0} \mu = e^{u - \varphi_0 + \psi^+ - \psi^-} \omega^n \quad \text{in } U$$

(the existence of u follows from [BEGZ10]) and consider

$$u_t := (1 - t)\varphi_0 + tu + n(t \log t - t).$$

Using that $t \mapsto \theta_t = \theta_0 + t\chi$ is affine and $\theta_t \geq \theta$, we observe that

$$\theta_t + dd^c u_t = (1 - t)(\theta_0 + dd^c \varphi_0) + t(\theta_1 + dd^c u) \geq t\theta_u \geq 0,$$

thus u_t is θ_t -psh and the reader can check that u_t is a subsolution to the parabolic equation with initial data $u_0 = \varphi_0$, hence

$$\varphi_t \geq (1 - t)\varphi_0 + tu + n(t \log t - t),$$

as desired.

We now establish the key upper-bound on $\dot{\varphi}_t$ in the context of big cohomology classes. Fix $\varepsilon > 0$ and consider

$$H(t, x) = t\dot{\varphi}_t - [\varphi_t - (1 - \varepsilon)\varphi_0 - \varepsilon\psi_\theta] - nt,$$

where ψ_θ is a θ -psh function provided by Lemma 7.3. Since $\dot{\theta}_t = \chi$, a straightforward computation yields, setting $\omega_t = \theta_t + dd^c \varphi_t$ and $\Delta_t := \Delta_{\omega_t}$,

$$\begin{aligned} \left(\frac{\partial}{\partial t} - \Delta_t \right) H &= t \text{tr}_{\omega_t}(\chi) + \Delta_t(\varphi_t - (1 - \varepsilon)\varphi_0 - \varepsilon\psi_\theta) - n \\ &= -\text{tr}_{\omega_t}((1 - \varepsilon)T_0 + \varepsilon(\theta + dd^c \psi_\theta)) \leq 0, \end{aligned}$$

where these estimates are performed in $U = \Omega$. Since $\psi_\theta \rightarrow -\infty$ on $\partial\Omega$, It follows that H attains its maximum in $(t = 0) \cap \Omega$. Now $H(0, \cdot) \equiv 0$ hence letting $\varepsilon \rightarrow 0$, we obtain

$$\dot{\varphi}_t(x) \leq \frac{-\varphi_0(x) + C}{t} + n.$$

From there on, one can proceed as in the proof of [BG13, Theorem 3.3.4] to conclude. $\square$

7.3. Smoothing properties on mildly singular varieties.

7.3.1. Log terminal singularities. We assume in this section that X is a $\mathbb{Q}$ -Gorenstein space, i.e. it has normal singularities and its canonical bundle K_X exists as a $\mathbb{Q}$ -line bundle ($\exists r \in \mathbb{N}$ and a line bundle L on X s.t. $L|_{X_{\text{reg}}} = rK_{X_{\text{reg}}}$).

Choose a *log resolution* of X , i.e. a projective bimeromorphic morphism $\pi : X' \rightarrow X$ which is an isomorphism over X_{reg} and whose exceptional divisor $E = \sum_i E_i$ has simple normal crossings. There is a unique collection of rational numbers a_i (the *discrepancies* of X w.r.t the chosen log resolution) s.t.

$$K_{X'} \sim_{\mathbb{Q}} \pi^* K_X + \sum_i a_i E_i,$$

where $\sim_{\mathbb{Q}}$ denotes $\mathbb{Q}$ -linear equivalence.

Definition 7.6. We say that X has *log terminal singularities* iff $\forall i, a_i > -1$.

This definition is independent of the choice of a log resolution. Quotient singularities are log terminal, and conversely every two-dimensional log terminal singularity is a quotient singularity. Note however that ordinary double points are log-terminal but not quotient singularities in dimension $n \geq 3$.

Choose a local generator σ of the line bundle rK_X for some $r \in \mathbb{N}^*$. Restricting to X_{reg} , we define a smooth positive volume form by setting

$$\mu_\sigma := \left(i^{rn^2} \sigma \wedge \bar{\sigma} \right)^{1/r}. \quad (7.2)$$

Such measures are called *adapted measures* in [EGZ09], where the following analytic interpretation of the discrepancies is observed:

Lemma 7.7. *Let z_i be a local equation of E_i , defined on a neighborhood $U \subset X'$ of a given point of E . Then we have*

$$(\pi^* \mu_\sigma)_{U \setminus E} = \prod_i |z_i|^{2a_i} dV$$

for some smooth volume form dV on U .

The proof is a direct consequence of the change of variable formula. Thus a $\mathbb{Q}$ -Gorenstein variety X has log terminal singularities iff every adapted measure μ_σ has locally finite mass near each singular point of X .

The construction of adapted measures can be globalized as follows: let ϕ be a smooth metric on the $\mathbb{Q}$ -line bundle K_X . Then

$$\mu_\phi := \left(\frac{i^{rn^2} \sigma \wedge \bar{\sigma}}{|\sigma|_{r\phi}} \right)^{1/r} \quad (7.3)$$

becomes independent of the choice of a local generator σ of rK_X , and hence defines a smooth positive volume form on X_{reg} , which has locally finite mass near points of X_{sing} iff X is log terminal.

7.3.2. The Kähler-Ricci flow on lt varieties. Starting from a compact Kähler manifold (X_0, ω_0) , it is tempting to run the Kähler-Ricci flow until $T_{\max}$ and expect that (X, ω_t) converges, as $t \rightarrow T_{\max}$ towards some mildly singular model X equipped with a limiting current T_0 which is not too singular as well, and then try and run again the Kähler-Ricci flow from (X, T_0) .

When X is projective, there are some evidence that this may be feasible, provided both by algebraic geometry (notably [BCHM10]) and by recent progresses in Kähler-Ricci flow techniques (see the survey [SW13]).

The main application of our previous technical Theorem 7.5 is the following extension of a result of Song-Tian [ST09], which shows that one can indeed run the Kähler-Ricci flow on a log-terminal variety, starting from an arbitrary positive closed current with zero Lelong numbers:

Theorem 7.8. *Let X be a projective complex variety with log terminal singularities. Let T_0 be a positive $(1, 1)$ -current with zero Lelong numbers representing a Kähler class $\alpha_0 \in H^{1,1}(X, \mathbb{R})$. Then there exists a continuous family $(\omega_t)_{t \in [0, T_{\max}[}$ of positive $(1, 1)$ -currents such that*

- (i) $[\omega_t] = \alpha_0 - tc_1(X)$ in $H^{1,1}(X, \mathbb{R})$;
- (ii) $\omega_t \rightarrow T_0$ as $t \rightarrow 0$;
- (iii) $(\omega_t)_{t \in (0, +\infty)}$ restricts to a smooth path of Kähler forms on X_{reg} satisfying

$$\frac{\partial \omega_t}{\partial t} = -\text{Ric}(\omega_t).$$

Proof. Let $\pi : X' \rightarrow X$ be a log resolution of X . Since $\alpha'_0 = \pi^* \alpha_0$ is the pull-back of a Kähler class, it is big and semi-positive. We fix θ_0 a smooth closed semi-positive $(1, 1)$ -form representing it. Fix $0 < T < T_{\max}$ and let θ_T be a smooth closed semi-positive $(1, 1)$ -form representing $\pi^*(\alpha_0 - Tc_1(X))$. Set

$$\chi := \frac{\theta_T - \theta_0}{T} \quad \text{and} \quad \theta_t := \theta_0 + t\chi.$$

This yields an affine path of big and semi-positive forms. Note that both θ_0 and θ_T can be chosen as the pull-back by π of a Kähler form on X , hence we can moreover assume that there is a fixed big and semi-positive form θ such that $\theta_0, \theta_T \geq \theta$ hence $\theta_t \geq \theta$ for all $t \in [0, T]$.

Since χ is a representative of $\pi^*c_1(K_X)$, we can find a smooth metric ϕ of K_X whose curvature form is $\pi_*\chi$. We let μ_ϕ denote the corresponding adapted measure and set

$$\mu := \pi^* \mu_\phi = e^{\psi^+ - \psi^-} \omega_{X'}^n,$$

where $\omega_{X'}$ denotes a Kähler form on X' and $\psi^\pm$ are quasi-psh functions which satisfy the hypotheses of Theorem 7.5, as the reader will check using Lemma 7.7 (the Zariski open set U coincides here with $\pi^{-1}(X_{\text{reg}})$). We set

$$\pi^* \omega_t = \theta_t + dd^c \varphi_t$$

and observe that

$$\frac{\partial \omega_t}{\partial t} = -\text{Ric}(\omega_t) \iff \frac{\partial \varphi}{\partial t} = \log \left[\frac{(\theta_t + dd^c \varphi)^n}{\mu} \right]$$

if the potentials φ_t are conveniently normalized. The result therefore follows from Theorem 7.5. $\square$
