FK-DLR properties of a quantum multi-type bose-gas with a repulsive interaction

Abstract

The paper extends earlier results from [19], [20] about infinite-volume quantum bosonic states (FK-DLR states) to the case of multi-type particles with non-negative interactions. (An example is a quantum Widom–Rowlinson model.) Following the strategy from [19], [20], we establish that, for the values of fugacity $z \in (0, 1)$ and inverse temperature $\beta > 0$, finite-volume Gibbs states form a compact family in the thermodynamic limit. Next, in dimension two we show that any limit-point state (an FK-DLR state in the terminology adopted in [19], [20]) is translation-invariant.

1 Limit-point Gibbs states and reduced density matrices

The present paper is a continuation of earlier works [19], [20]. As in [19], [20], we attempt at establishing a working definition of an infinite-volume quantum bosonic Gibbs state and justify it by checking natural properties such as shift-invariance in dimension two. In addition, the paper lays a foundation for future research into phase transitions in quantum Widom–Rowlinson (WR) models

with several types of particles (following a recent progress in classical WR models; see [11, 12]). Cf. the earlier work [4]. The class of states under consideration is formed by the so-called FK-DLR states (a more general concept is an FK-DLR functional): these states satisfy a quantum analog of the DLR equation (after Dobrushin–Lanford–Ruelle). Throughout the paper, we refer to [19] and [20] by adding the Roman numerals I and II, respectively: Theorem 1.2.I, formula (4.1.II), etc.

The difference between the present work and [19], [20] is in assumptions upon the interaction potential, which implies different conditions on the thermodynamic variables z (the fugacity) and β (the inverse temperature). Besides, in this paper we consider systems with several particle types $i \in \{1, \ldots, q\}$. We suppose that the (two-body) interaction potentials V_{ij} between types i, j are non-negative (i.e., generate a repulsion of particles); they may also include hard cores. The non-negativity assumption allows us to work in the open domain $z_1, \ldots, z_q \in (0, 1), \beta > 0$: in the border of this domain (where $z_j = 1$ for some j) one may expect a Bose–Einstein condensation (which occurs for $V_{ij} \equiv 0$). However, even for z_j less than (but close to) 1 one can't exclude (at least at a rigorous level) a non-uniqueness of an infinite-volume Gibbs state as it has been defined in [19], [20] and in the current paper. In the quantum bosonic WR model with $z_1 = \ldots = z_q = z$ we expect a first-order phase transition for $z \in (1 - \eta, 1)$ (cf. [4]).

Remark Historically, the assumption $V \ge 0$ was used, elegantly and to a great effect, by Ginibre in [5] and became popular in quantum Statistical Mechanics (cf. the references [2], [18], to name a few). Admittedly, this assumption was termed in [5] "a severe physical limitation", and it was declared that the "next task is to get rid of it". To a certain extent, it was achieved in [6]. Indeed, it can be noted that in [6] and [7] (where a number of different conditions upon the potential were introduced and intermittently used) the assumption of non-negativity was not present. However (and perhaps, consequently), the conditions upon z and β guaranteeing the key result of [6], [7] (convergence to a unique infinite-volume limit and cluster expansion of the quantum Gibbs state) became notably less transparent than in [5].

The present paper follows the approach adopted in [19], [20]; this allows us to use pre-requisites and technical tools from the above references. However, we attempted at making this paper, to a degree, self-sufficient, as far as the statements of the main theorems are concerned. In Sections 1.1, 1.2 and 1.3 we introduce the models, state the main results and discuss the principal tool of the work: the Feynman–Kac (FK) representation. In Sections 2.1, 2.2 and 2.3 we prove the existence of an infinite-volume FK-DLR state). Finally, in Section 3 we focus on the 2D case and check that any FK-DLR functional is shift-invariant.

1.1 The local Hamiltonian

A model of a quantum Bose-gas in \mathbb{R}^d with q types of particles is determined by a family of local Hamiltonians. Given a vector $\underline{n} = (n(1), \ldots, n(q))$ with non-negative integer entries n(j). Consider a system with n(j) particles of type $j \in \{1, \ldots, q\}$ in a finite 'box' (a *d*-dimensional cube)

The Hamiltonian, $H_{\underline{n},\Lambda}$, is a self-adjoint operator acting on functions $\phi_{\underline{n}} \in \mathcal{H}_{\underline{n}}(\Lambda) := \underset{1 \leq j \leq q}{\otimes} L_{2}^{\text{sym}}(\Lambda^{n(j)})$:

Here function ϕ_n is symmetric under permutations of variables $x_{j,l}$ within each group $\underline{x}(j)$. The symbol $|x_{j,l} - x_{j',l'}|$ stands for the Euclidean distance between points $x_{j,l}, x_{j',l'} \in \mathbb{R}^d$. (Sometimes we use an alternative notation x(j,l), x(j',l').)

Operator $\Delta_{j,l}$ in (1.1.1) acts as a Laplacian in the variable $x_{i,l}$. Further, $V_{j,j'}: r \in [0, +\infty) \mapsto V_{j,j'}(r) \in [0, +\infty]$ is assumed to be a C^2 -function at each point where $V_{j,j'} < +\infty$ and with a compact support. Function $V_{j,j'}$ describes a two-body interaction potential between type j and type j' particles, depending upon the distance between the particles involved. The value

is called the interaction radius (or the interaction range). We also assume that $V_{j,j'}(r)$ may take the value $+\infty$ (e.g., when $0 \le r \le D(j,j')$, with $D(j,j') = D(j',j) \in [0,+\infty)$ representing the diameter of a hard-core repulsion between particles of types j and j').¹ Next, we suppose, for definiteness, that

Remark As was said above, the assumption that $V_{j,j'} \ge 0$ means that the interaction potential generates repulsion between particles. Such a condition was repeatedly used in the works on quantum systems of Statistical Mechanics; see, e.g., [5], [18], [2]. It covers the case of a free gas (where $V_{j,j'} \equiv 0$). Removing the non-negativity assumption (without introducing a hard-core of a positive diameter) represents some challenges and remains an open question. On the other hand, the finite range assumption is used in this paper for simplifying some technicalities and can be relaxed to a controlled decay of $V_{j,j'}(r)$ for large r; this will be the subject of a forthcoming research.

¹⁾In the case $V_{j,j'} = +\infty$ the operator $H_{\underline{n},\Lambda}$ acts on functions $\phi_{\underline{n}}$ vanishing whenever $V_{J,j'}(|x_{j,l} - x_{j',l'}|) = +\infty$ (Dirichlet's boundary conditions).

Operator $H_{\underline{n},\Lambda}$ is determined by a boundary condition on $\partial \Lambda^{\underline{n}}$. Here $\Lambda^{\underline{n}} = \underset{1 \leq j \leq q}{\times} \Lambda^{n(j)}$ and

$$\partial \Lambda^{\underline{n}} = \left\{ \underline{x}^{\underline{n}} = \left(\underline{x}(1), \dots, \underline{x}(q) \right) \in \Lambda^{\underline{n}} : \\ \max\left[\left| x_{jl} \right|_{\underline{m}} : 1 \le j \le q, \ 1 \le l \le n(j) \right] = L \right\}.$$

Here $| |_{\mathbf{m}}$ stands for the maximum norm in \mathbb{R}^d . More precisely, we initially consider $H_{\underline{n},\Lambda}$ as a symmetric operator given by the RHS of Eqn (1.1.1) on the set of C²-functions $\phi = \phi_{\underline{n}}$ vanishing in a neighborhood of $\partial \Lambda^{\underline{n}}$, i.e., have the support within the interior of $\Lambda^{\underline{n}}$. It is a self-adjoint extension of this symmetric operator (denoted by the same symbol $H_{\underline{n},\Lambda}$) which requires boundary conditions. Throughout the paper we consider Dirichlet's boundary condition:

Nevertheless, the methods of this paper allow us to consider a broad class of conditions, viz., elastic boundary conditions (where a linear combination of the value of ϕ at the boundary and the value of its normal derivative vanishes); periodic boundary conditions can also included. Considering various boundary conditions endeavors towards including possible phase transitions; this question can be left for forthcoming works.

Under the above assumptions, $H_{\underline{n},\Lambda}$ is a self-adjoint operator, bounded from below and with a pure point spectrum. Moreover, $\forall \beta \in (0, +\infty)$, the operator $G_{\beta,\underline{n},\Lambda} = \exp \left[-\beta H_{\underline{n},\Lambda}\right]$ (the Gibbs operator in $\mathcal{H}_{\underline{n}}(\Lambda)$ at the inverse temperature β) is a positive-definite operator in $\mathcal{H}_{\underline{n}}(\Lambda)$, of the trace class. The trace

represents the <u>*n*</u>-particle partition function in Λ .

As in [19], [20], we work with the grand canonical Gibbs ensemble. Namely, we consider, \forall vector $\underline{z} = (z_1, \ldots, z_q) \in (0, 1)^q$, the direct sum

This determines a positive-definite trace-class operator $G_{\underline{z},\beta,\Lambda}$ in the bosonic Fock space

The quantity

yields the grand canonical partition function in Λ at fugacity \underline{z} and the inverse temperature β . Further, the operator

$$R_{\underline{z},\beta,\Lambda} = \frac{1}{\Xi_{\underline{z},\beta}(\Lambda)} G_{\underline{z},\beta,\Lambda}$$

is called the (grand-canonical) density matrix (DM) in Λ ; this is a positivedefinite operator in $\mathcal{H}(\Lambda)$ of trace 1. Operator $R_{\underline{z},\beta,\Lambda}$ determines the Gibbs state (GS), i.e., a linear positive normalized functional $\varphi_{\underline{z},\beta,\Lambda}$ on the C^{*}-algebra $\mathfrak{B}(\Lambda)$ of bounded operators in $\mathcal{H}(\Lambda)$:

$$\varphi_{\underline{z},\beta,\Lambda}(A) = \operatorname{tr}_{\mathcal{H}(\Lambda)}(AR_{\underline{z},\beta,\Lambda}), \ A \in \mathfrak{B}(\Lambda).$$

Remark The assumption that $0 < z_j < 1$ means that we avoid a (possible) 'critical' regime. Viz., it is the values $z_j \nearrow 1$ that generates a Bose-condensation in the free gas $(V_{j,j'} \equiv 0)$ in dimension $d \ge 3$. Cf. [3] and the references therein.

As in [19], [20], the object of interest in this paper is the reduced DM (briefly, RDM), in cube $\Lambda_0 \subset \Lambda$ centered at a point $c_0 = (c_0^1, \ldots, c_0^d)$:

As in the aforementioned papers, the term RDM is used here for the operator $R_{z,\beta,\Lambda}^{\Lambda_0}$ defined via partial trace²⁾

it is based on the tensor-product representation $\mathcal{H}(\Lambda) = \mathcal{H}(\Lambda_0) \otimes \mathcal{H}(\Lambda \setminus \Lambda_0)$. Operator $R^{\Lambda_0}_{\underline{z},\beta,\Lambda}$ acts in $\mathcal{H}(\Lambda_0)$, is positive-definite and has trace 1. Furthermore, the partial trace operation generates an important compatibility property for RDMs. Suppose cubes $\Lambda_1 \subset \Lambda_0 \subset \Lambda$, then

Throughout this paper, we use the upper indices Λ_0 and Λ_1 to indicate the corresponding 'volumes' have been not affected by the partial trace.

To shorten the notation, the indices/arguments \underline{z} and β will be omitted whenever it does not produce a confusion. A straightforward modification of the above concepts emerges by including an external potential field induced by an external classical multi-type configuration (CC) $\mathbf{x}(\Lambda^{(R)})$. Such a configuration is represented by a collection $(\mathbf{x}(\Lambda^{(R)}, 1), \ldots, \mathbf{x}(\Lambda^{(R)}, q))$ of finite subset in an 'external' annulus encircling cube Λ :

Viz., the Hamiltonian $H_{\underline{n},\Lambda|\mathbf{x}(\Lambda^{(R)})}$ is given by

and has all properties that have been listed above for $H_{\underline{n},\Lambda}$. This enables us to introduce the Gibbs operators $G_{\underline{n},\Lambda|\mathbf{x}(\Lambda^{(R)})}$ and $G_{\Lambda|\mathbf{x}(\Lambda^{(R)})}$, the partition functions

 $\Xi_{\underline{n}}(\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})}))$ and $\Xi(\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})}))$, the DM $R_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$, the GS $\varphi_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ and the RDMs $R_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}^{\Lambda_0}$ where $\Lambda_0 \subset \Lambda$. Viz.,

The previous definitions (1.1.1)–(1.1.15) correspond to the case of an empty exterior CC $\mathbf{x}(\Lambda^{(R)}) = \emptyset$.

As in [19], [20], the Fock spaces $\mathcal{H}(\Lambda)$ and $\mathcal{H}(\Lambda_0)$ (see (1.1.9)) will be represented as $L_2(\mathcal{C}(\Lambda))$ and $L_2(\mathcal{C}(\Lambda_0))$, respectively. Here and below, $\mathcal{C}(\Lambda)$ denotes the space formed by collections $\overline{\mathbf{x}} = {\mathbf{x}_1, \ldots, \mathbf{x}_q}$ of finite (unordered) subsets $\mathbf{x}(j) \subset \Lambda$ (including the empty set) with the Lebesgue–Poisson measure

$$d\overline{\mathbf{x}} = \prod_{1 \le j \le q} \frac{1}{(\sharp \mathbf{x}(j))!} \prod_{x \in \mathbf{x}(j)} dx, \quad \left(\text{with} \int_{\mathcal{C}(\Lambda)} d\overline{\mathbf{x}} = \exp\left[q\ell(\Lambda)\right]$$
where ℓ is the Lebesgue measure on \mathbb{R}^d . (1.1.19)

Here and later on, the symbol \sharp is used for the cardinality of a given set. In accordance with this notation, we write that $\mathbf{x}(\Lambda^{(\mathbf{R})}) \in \mathcal{C}(\Lambda^{(\mathbf{R})})$. Points $\overline{\mathbf{x}}, \overline{\mathbf{x}}', \mathbf{x}(\Lambda^{(\mathbf{R})})$ (and $\overline{\mathbf{y}}$ later on) are called, as before, classical multi-type configurations (CCs). We also introduce the subset $\mathcal{C}(\Lambda, \underline{n})$ formed by CCs $\overline{\mathbf{x}} \in \mathcal{C}(\Lambda)$ with $\sharp \mathbf{x}(j) = n(j)$. Next, the external CCs $\mathbf{x}(\Lambda^{(\mathbf{R})})$ have to be controlled, up to a degree, as $\Lambda \to \mathbb{R}^d$; see below. The methods developed in this paper allow us to introduce several methods of such control. Throughout the paper we will refer to the following condition upon a family $\{\mathbf{x}(\Lambda^{(\mathbf{R})})\}$: for given $(z_1, ..., z_q) \in (0, 1)^q$ and $\beta > 0$, \forall constant $\mathbf{c} \in (0, +\infty)$, the quantity

This assumption will be used without stressing it every time again. However, we do not consider it as a final one; in our opinion, it can be weakened.

1.2 The thermodynamic limit and the shift-invariance property in two dimensions

The thermodynamic limit is the key concept of rigorous Statistical Mechanics; in the context of this work it is $\lim_{\Lambda \nearrow \mathbb{R}^d}$, the family of standard cubes ordered by inclusion. In the literature, the quantities and objects identified as limiting

points in the course of this limit are often referred to as infinite-volume oness (e.g., an infinite-volume RDM or GS). Traditionally, the existence and uniqueness of such a limiting object is treated as absence of a phase transition. On the other hand, a multitude of such objects (viz., depending on the boundary conditions for the Hamiltonian or the choice of external CCs) is considered as a manifestation of a phase transition.

However, since late 1960s there is known an elegant alternative where infinitevolume objects are identified in terms that do not explicitly invoke the thermodynamic limit. For classical systems, this is the DLR equations and for so-called quantum spin systems – the KMS boundary condition. The latter is not applicable to the class of quantum systems under consideration, since the Hamiltonians $H_{n,\Lambda}$ and $H_{n,\Lambda|\mathbf{x}(\Lambda^{(R)})}$ are not bounded.

In this paper we propose a construction generalising the classical DLR equation (see Section 2.3). A justification of this construction is given in Section 3 where we establish the shift-invariance property for the emerging objects (the RDMs and GSs) in dimension two (i.e., for d = 2). The first result claimed in this work is

Theorem 1.1. Given $\beta \in (0, +\infty)$ and $\underline{z} \in (0, 1)^q$, \forall cube Λ_0 (see Eqn (1.1.13)), the family of RDMs $\left\{R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(R)})}, \Lambda \nearrow \mathbb{R}^d\right\}$ is compact in the tracenorm operator topology in $\mathcal{H}(\Lambda_0)$, for any choices of CCs $\mathbf{x}(\Lambda^{(R)}) \in \mathcal{C}(\Lambda^{(R)})$ satisfying (1.1.20). Any limit-point operator R^{Λ_0} for $\left\{R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(R)})}\right\}$ is a positivedefinite operator in $\mathcal{H}(\Lambda_0)$ of trace 1. Furthermore, let $\Lambda_1 \subset \Lambda_0$ be a pair of cubes and R^{Λ_1} , R^{Λ_0} be a pair of limit-point RDMs such that

$$R^{\Lambda_1} = \lim_{k \to +\infty} R^{\Lambda_1}_{\Lambda(k)|\mathbf{x}(\Lambda(k))^{(\mathbb{R})}} \text{ and } R^{\Lambda_0} = \lim_{k \to +\infty} R^{\Lambda_0}_{\Lambda(k)|\mathbf{x}(\Lambda(k))^{(\mathbb{R})}}$$
(1.2.1)

for a sequence of cubes $\Lambda(l) = [-L(l), L(l)]^{\times d}$ where $l = 1, 2, ..., L(l) \nearrow \infty$ and external CCs $\mathbf{x}(\Lambda(l)^{(\mathbb{R})}) \in \mathcal{C}(\Lambda(l)^{(\mathbb{R})})$. Then R^{Λ_1} and R^{Λ_0} satisfy the compatibility property

$$R^{\Lambda_1} = \operatorname{tr}_{\mathcal{H}(\Lambda_0 \setminus \Lambda_1)} R^{\Lambda_0}. \qquad \Box \tag{1.2.2}$$

A direct consequence of Theorem 1.1 yields the construction of a limit-point infinite-volume Gibbs state φ . For this purpose, it is enough to consider a countable family of cubes $\Lambda_0(l_0) = [-L_0 l_0, L_0 l_0]^{\times d}$ centered at the origin, of side-length $2L_0 l_0$, where $L_0 \in (0, \infty)$ is fixed and $l_0 = 1, 2, \ldots$. By virtue of a diagonal process, we can ensure that, given a family of external CCs $\mathbf{x}(\Lambda^{(\mathbf{R})})$, one can excerpt a sequence $\Lambda(l) \nearrow \mathbb{R}^d$ such that (a) \forall natural $l_0 \exists$ the trace-norm limit

$$R^{\Lambda_0(l_0)} = \lim_{l \to +\infty} R^{\Lambda_0(l_0)}_{\Lambda(l)|\mathbf{x}(\Lambda(l)^{(\mathbb{R})})}.$$
(1.2.3)

and (b) for the limiting operators $R^{\Lambda_0(l_0)}$ relation (1.2.1) is satisfied, with $\Lambda_1 = \Lambda_0(l_1)$ and $\Lambda_0 = \Lambda_0(l_0)$ whenever $l_1 < l_0$. This allows us to define an infinite-volume Gibbs state φ by setting

$$\varphi(A) = \lim_{l \to \infty} \varphi_{\Lambda(l)}(A) = \operatorname{tr}_{\mathcal{H}(\Lambda_0(l_0))} \left(A R^{\Lambda_0(l_0)} \right), \quad A \in \mathfrak{B}(\Lambda_0(l_0)).$$
(1.2.4)

More exactly, φ is a state of the quasilocal C*-algebra $\mathfrak{B}(\mathbb{R}^d)$ defined as the norm-closure of the inductive limit $\mathfrak{B}^0(\mathbb{R}^d)$:

$$\mathfrak{B} = \left(\mathfrak{B}^0(\mathbb{R}^d)\right)^-, \quad \mathfrak{B}^0(\mathbb{R}^d) = \operatorname{ind}_{\Lambda \nearrow \mathbb{R}^d} \mathfrak{B}(\Lambda). \tag{1.2.5}$$

What is more, ϕ is defined by a family of finite-volume RDMs R^{Λ_0} acting in $\mathcal{H}(\Lambda_0)$, with $\Lambda_0 \subset \mathbb{R}^d$ being an arbitrary cube of the form (1.1.13), and obeying the compatibility property (1.2.2).

As we mentioned earlier, in two dimensions we prove the property of shiftinvariance of the limit-point Gibbs states φ . Note that \forall cube Λ_0 as in (1.1.13) and vector $s = (\mathbf{s}^1, \ldots, \mathbf{s}^d) \in \mathbb{R}^d$, the Fock spaces $\mathcal{H}(\Lambda_0)$ and $\mathcal{H}(\mathbf{S}(s)\Lambda_0)$ can be related via mutually inverse shift isomorphisms:

$$\mathbb{U}^{\Lambda_0}(s): \ \mathcal{H}(\Lambda_0) \to \mathcal{H}(\mathbb{S}(s)\Lambda_0) \quad \text{and} \quad \mathbb{U}^{\mathbb{S}(s)\Lambda_0}(-s): \ \mathcal{H}(\mathbb{S}(s)\Lambda_0) \to \mathcal{H}(\Lambda_0).$$

Here $\mathbf{S}(\mathbf{s})$ denotes the shift isometry $\mathbb{R}^d \to \mathbb{R}^d$:

$$\mathbf{S}(s): \ y \mapsto y + s, \ y \in \mathbb{R}^d, \tag{1.2.6}$$

while $S(s)\Lambda_0$ stands for the image of Λ_0 :

$$\mathbf{S}(s)\Lambda_{0} = \begin{bmatrix} -L_{0} + \mathbf{c}_{0}^{1} + \mathbf{s}^{1}, \mathbf{s}^{1} + \mathbf{c}_{0}^{1} + L^{0} \end{bmatrix} \\ \times \cdots \times \begin{bmatrix} -L_{0} + \mathbf{c}_{0}^{d} + \mathbf{s}^{d}, \mathbf{s}^{d} + \mathbf{c}_{0}^{d} + L^{0} \end{bmatrix}.$$
(1.2.7)

The isomorphisms $U^{\Lambda_0}(s)$ and $U^{S(s)\Lambda_0}(-s)$ are defined as follows:

$$\begin{pmatrix} \mathsf{U}^{\Lambda_0}(s)\phi_{\underline{n}} \end{pmatrix} (\underline{x}^{\underline{n}}) = \phi_{\underline{n}} \left(\mathsf{S}(-s)\underline{x}^{\underline{n}} \right), \quad \underline{x}^{\underline{n}} \in \in \mathsf{S}\Lambda^{\underline{n}}_{0}, \quad \phi_{\underline{n}} \in \mathcal{H}_{\underline{n}}(\Lambda_{0}), \\ \left(\mathsf{U}^{\mathsf{S}(s)\Lambda_{0}}(-s)\phi_{\underline{n}} \right) (\underline{x}^{\underline{n}}) = \phi_{\underline{n}}(\mathsf{S}(s)\underline{x}^{\underline{n}}), \quad \underline{x}^{\underline{n}} \in \Lambda^{\underline{n}}_{0}, \quad \phi_{\underline{n}} \in \mathcal{H}_{\underline{n}}(\Lambda_{0}),$$
(1.2.8)

with $\underline{n} = (n(1), \dots n(q)), \ n(j) = 0, 1, \dots$

Theorem 1.2. Let d = 2 and $\beta \in (0, +\infty)$, $\underline{z} \in (0, 1)^q$. Then any limit-point infinite-volume Gibbs state φ is shift-invariant: $\forall s = (\mathbf{s}^1, \mathbf{s}^2) \in \mathbb{R}^2$

$$\varphi(A) = \varphi(\mathbf{S}(s)A), \ A \in \mathfrak{B}(\mathbb{R}^2).$$
(1.2.9)

Here S(s)A stands for the shift of the argument A: if $A \in \mathfrak{B}(\Lambda_0)$ where Λ_0 is a square $[-L_0 + c_1, c_1 + L_0] \times [-L_0 + c_2, c_2 + L_0]$ then

$$\mathbf{S}(s)A = \mathbf{U}^{\mathbf{S}(s)\Lambda_0}(-s)A\mathbf{U}^{\Lambda_0}(s) \in \mathfrak{B}(\mathbf{S}(s)\Lambda_0).$$

In terms of the RDMs R^{Λ_0} :

$$R^{\mathbf{S}(s)\Lambda_0} = \mathbf{U}^{\Lambda_0}(s)R^{\Lambda_0}\,\mathbf{U}^{\mathbf{S}(s)\Lambda_0}(-s). \qquad \Box \qquad (1.2.10)$$

1.3 The FK-representation for the RDMs

Let us return to a general value of dimension d. We will assume that $\beta \in (0, +\infty)$ and $z \in (0, 1)^q$. According to the featured realization of the Fock space $\mathcal{H}(\Lambda)$ as $L_2(\mathcal{C}(\Lambda))$ (see (1.1.19)), its elements are identified as functions ϕ_{Λ} : $\mathbf{x}(\Lambda) \in \mathcal{C}(\Lambda) \mapsto \phi_{\Lambda}(\mathbf{x}(\Lambda)) \in \mathbb{C}$, with

$$\int_{\mathcal{C}(\Lambda)} |\phi_{\Lambda}(\mathbf{x}(\Lambda))|^2 \, \mathrm{d}\mathbf{x}(\Lambda) < \infty.$$
(1.3.1)

The space $\mathcal{H}(\Lambda_0)$ is represented in a similar manner: here we will use a shorthand notation $\overline{\mathbf{x}}_0$ and $\overline{\mathbf{y}}_0$ instead of $\mathbf{x}(\Lambda_0), \mathbf{y}(\Lambda_0) \in \mathcal{C}(\Lambda_0)$. (When it is convenient, $\overline{\mathbf{x}}_0$ and $\overline{\mathbf{y}}_0$ are understood as ordered arrays and identified with $\underline{x}^{\underline{n}}$ and $\underline{y}^{\underline{n}}$, points from $\Lambda_{\underline{0}}^{\underline{n}}$.)

The first step in the proof of Theorems 1.1 is to reduce its assertions to statements about the integral kernels $F^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ and F^{Λ_0} which define the RDMs $R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ and their infinite-volume counterpart R^{Λ_0} ; we call these kernels RDMKs for short. Indeed, $R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ and R^{Λ_0} are integral operators:

$$\begin{pmatrix} R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(R)})}\phi_{\Lambda} \end{pmatrix} (\overline{\mathbf{x}}_0) = \int_{\mathcal{C}(\Lambda)} F^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(R)})}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)\phi_{\Lambda}(\overline{\mathbf{y}}_0) \mathrm{d}\overline{\mathbf{y}}_0 \begin{pmatrix} R^{\Lambda_0}\phi_{\Lambda} \end{pmatrix} (\overline{\mathbf{x}}_0) = \int_{\mathcal{C}(\Lambda)} F^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)\phi_{\Lambda}(\overline{\mathbf{y}}_0) \mathrm{d}\overline{\mathbf{y}}_0.$$
 (1.3.2)

The RDMKs $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ and $F^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ are investigated through an FK representation. Properties of these kernels are listed in Theorem 1.3 where we adopt a setting from Theorem 1.1. We refer in Theorem 1.3 to the Hilbert–Schmidt (HS) metric generated by the norm $\|\rho\|_{\mathrm{HS}}$ where

$$\|\rho\|_{\mathrm{HS}}^{2} = \int_{\mathcal{C}(\Lambda_{0}) \times \mathcal{C}(\Lambda_{0})} |\rho(\overline{\mathbf{x}}_{0}, \overline{\mathbf{y}}_{0})|^{2} \,\mathrm{d}\overline{\mathbf{x}}_{0} \,\mathrm{d}\overline{\mathbf{y}}_{0}.$$
(1.3.3)

Here $(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0) \mapsto \rho(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ is an integral kernel (in general, complex) representing an HS operator in $\mathcal{H}(\Lambda_0)$. (Equivalently, $\rho \in \mathcal{H}(\Lambda_0) \otimes \mathcal{H}(\Lambda_0)$.)

Theorem 1.3. Any pair of cubes $\Lambda_0 \subset \Lambda$ and a family of CCs $\mathbf{x}(\Lambda^{(\mathbb{R})}) \in \mathcal{C}(\Lambda^{(\mathbb{R})})$ obeying (1.1.20), the family of RDMKs $F_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ is compact in the HS metric. Any limit-point function

$$(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0) \in \mathcal{C}(\Lambda_0) \times \mathcal{C}(\Lambda_0) \mapsto F^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$$
(1.3.4)

determines a positive-definite operator R^{Λ_0} in $\mathcal{H}(\Lambda_0)$ of trace 1 (a limit-point RDM). Furthermore, let $\Lambda_1 \subset \Lambda_0$ be a pair of cubes and F^{Λ_1} , F^{Λ_0} a pair of limit-point RDMKs such that

$$F^{\Lambda_0} = \lim_{k \to +\infty} F^{\Lambda_0}_{\Lambda(l)|\mathbf{x}(\Lambda(l)^c)}$$
(1.3.5)

in $C^0(\mathcal{C}(\Lambda_0) \times \mathcal{C}(\Lambda_0))$ for a sequence of cubes $\Lambda(l) \nearrow \mathbb{R}^d$ and external CCs $\overline{\mathbf{x}}(\Lambda(l)^{(\mathbb{R})})$. Then the corresponding limit-point RDMs R^{Λ_1} and R^{Λ_0} obey (1.2.2). \Box

Theorem 1.1 is deduced from Theorem 1.3 with the help of Theorem 1.4 below. The latter is a slight generalisation of Lemma 1.5 from [8] (going back to Lemma 1 in [17]).

Theorem 1.4. Let $\rho_m(\mathbf{x}, \mathbf{y})$, $\mathbf{x}, \mathbf{y} \in M$, be a sequence of kernels defining positive-definite operators R_m of trace class and with trace 1 in a Hilbert space $L_2(\mathbb{M}, \nu)$ where $\nu(\mathbb{M}) < \infty$. Suppose that as $m \to \infty$, $\rho_m(\mathbf{x}, \mathbf{y})$ converge to a limit kernel $\rho(\mathbf{x}, \mathbf{y})$ in the Hilbert–Schmidt (HS) norm:

$$\|\rho_m - \rho\|_{\mathrm{HS}}^2 = \int_{\mathbb{M} \times \mathbb{M}} \left[\rho_m(\mathbf{x}, \mathbf{y}) - \rho(\mathbf{x}, \mathbf{y})\right]^2 \nu(\mathrm{d}\mathbf{x}) \nu(\mathrm{d}\mathbf{y}) \to 0, \qquad (1.3.6)$$

and $\rho(\mathbf{x}, \mathbf{y})$ defines a positive-definite trace-class operator R of trace 1. Then

$$\lim_{m \to \infty} \|R_m - R\|_{\rm tr} = 0 \tag{1.3.7}$$

where $||A||_{\mathrm{tr}} = \mathrm{tr} (AA^*)^{1/2}$. \Box

The proof Theorem 1.4 repeats that of the aforementioned lemmas, and for shortness we do not reproduce it here.

Therefore we focus from now on upon the proof of Theorems 1.2 and 1.3. In fact, we will establish similar facts for more general objects – FK-DLR functionals. As in [19], we use the terms a (multi-type) path configuration (PC) and a (multi-type) loop configuration (LC). The concept of FK-DLR functionals is based in our context on a series of definitions from Sects 2.I and 4.I related to PCs and LCs. We will not repeat here Definitions 2.1.1.I–2.1.4.I but give the list of the relevant notation used below. As to Definitions 2.1.1.I, 2.1.2.I, the corresponding objects are grouped into pairs: items with the symbol \mathcal{W} represent path spaces whereas items with the symbol \mathbb{P} represent path measures:

$$\begin{split} \text{(i)} \ \overline{\mathcal{W}}^{k\beta}(x,y) \leftrightarrow \mathrm{d}\overline{\mathbb{P}}_{x,y}^{k\beta}(\overline{\omega}) \,. \\ \text{(ii)} \ \overline{\mathcal{W}}^*(x,y) &= \bigcup_{k\geq 1} \overline{\mathcal{W}}^{k\beta}(x,y) \leftrightarrow \mathrm{d}\overline{\mathbb{P}}_{x,y}^*(\overline{\omega}^*) \,. \\ \text{(iii)} \ \mathcal{W}^*(x) &= \overline{\mathcal{W}}^*(x,x) \leftrightarrow \mathrm{d}\mathbb{P}_x^*(\omega^*) = \mathrm{d}\overline{\mathbb{P}}_{x,x}^*(\omega^*) \,. \\ \text{(iv)} \ \overline{\mathcal{W}}^*(\underline{x}(j), \underline{y}(j)) &= \underset{1\leq i\leq n(j)}{\times} \overline{\mathcal{W}}^*(x_{j,i}, y_{j,i}) \\ \Leftrightarrow \ \overline{\mathbb{P}}_{\underline{x}(j), \underline{y}(j)}^*(\overline{\Omega}^*(j)) &= \underset{1\leq i\leq n(j)}{\times} \overline{\mathbb{P}}_{x_{j,i}, y_{j,i}}^*(\overline{\omega}_{j,i}^*) \text{ where } \overline{\Omega}^*(j) = (\overline{\omega}_{j,1}^*, \dots, \overline{\omega}_{j,n(j)}^*) \,. \\ \text{(v)} \ \underline{\mathcal{W}}^*(\underline{x}(j), \underline{y}(j)) &= \underset{\pi_{n(j)} \in \mathfrak{S}_{n(j)}}{\longrightarrow} \overline{\mathbb{W}}^*(\underline{x}(j), \pi_{n(j)}\underline{y}(j)) \\ \Leftrightarrow \ \mathrm{d}\underline{\mathbb{P}}_{\underline{x}(j), \underline{y}(j)}^*(\overline{\Upsilon}^*(j)) &= \underset{\pi_{n(j)} \in \mathfrak{S}_{n(j)}}{\sum} \mathrm{d}\overline{\mathbb{P}}_{\underline{x}(j), \pi_{n(j)}\underline{y}(j)}(\overline{\Omega}^*(j)) \,. \text{ Here } \mathfrak{S}_{n(j)} \text{ is the permutation group on } n(j) \text{ elements, and } \pi_{n(j)}\underline{y}(j) = (y_{j,\pi_{n(j)}(1)}, \dots, y_{j,\pi_{n(j)}(n(j))}) \,. \\ \text{Symbol } \overline{\Upsilon}^*(j) \text{ covers all type } j \text{ PCs } \overline{\Omega}^*(j) \in \overline{\mathcal{W}}^*(\underline{x}(j), \pi_{n(j)}\underline{y}(j)) \text{ where } \underline{x}(j), \\ \underline{y}(j) \text{ are fixed and } \pi_{n(j)} \in \mathfrak{S}_{n(j)} \text{ varies.} \\ (\text{vi)} \ \underline{\mathcal{W}}^*(\underline{x}^{\underline{n}}, \underline{y}^{\underline{n}}) = \underset{1\leq j\leq q}{\times} \underline{\mathcal{W}}^*(\underline{x}(j), \underline{y}(j)) \\ \leftrightarrow \ \mathrm{d}\underline{\mathbb{P}}_{\underline{x}^{\underline{n}}, \underline{y}^{\underline{n}}}(\overline{\Upsilon}^*) = \underset{1\leq j\leq q}{\times} \mathrm{d}\underline{\mathbb{P}}_{\underline{x}(j), \underline{y}(j)}^*(\overline{\Upsilon}^*(j)) \,. \end{split}$$

(vii)
$$\mathcal{W}^*(\mathbf{x}(j)) = \underset{x \in \mathbf{x}(j)}{\times} \mathcal{W}^*(x) \leftrightarrow d\mathbb{P}^*_{\mathbf{x}(j)}(\mathbf{\Omega}^*(j)) = \underset{x \in \mathbf{x}(j)}{\times} d\mathbb{P}^*_x(\omega_x^*)$$
 where $\mathbf{\Omega}^*(j) = \{\omega_x^*, x \in \mathbf{x}(j)\}.$

(viii) $\mathcal{W}^*(\overline{\mathbf{x}}) = \underset{1 \leq j \leq q}{\times} \mathcal{W}^*(\mathbf{x}(j)) \leftrightarrow \mathrm{d}\mathbb{P}^*_{\overline{\mathbf{x}}}(\mathbf{\Omega}^*) = \underset{1 \leq j \leq q}{\times} \mathrm{d}\mathbb{P}^*_{\mathbf{x}(j)}(\mathbf{\Omega}^*(j))$ where $\mathbf{\Omega}^* = (\mathbf{\Omega}^*(1), ..., \mathbf{\Omega}^*(q)).$

(ix) $\mathcal{W}^*(\Lambda) = \bigcup_{\overline{\mathbf{x}} \in \mathcal{C}(\Lambda)} \mathcal{W}^*(\overline{\mathbf{x}}) \leftrightarrow \mathrm{d}\overline{\mathbf{x}} \times \mathbb{P}^*_{\overline{\mathbf{x}}}(\mathrm{d}\Omega^*_{\Lambda}) =: \mathrm{d}\Omega^*_{\Lambda}$. Here $\mathcal{W}^*(\Lambda)$ is the

space of (finite) multi-type LCs Ω^*_{Λ} with the initial/end points in Λ (however, the loops constituting Ω^*_{Λ} do not need to stay in Λ).

(x) $\mathcal{W}^*(\mathbb{R}^d)$: the set of countable multi-type LCs $\Omega^* = \Omega^*_{\mathbb{R}^d}$ such that their initial/end point CCs $\overline{\mathbf{x}} = (\mathbf{x}(1), \dots, \mathbf{x}(q))$ have no accumulation points in \mathbb{R}^d . A similar meaning is assigned to the notation $\mathcal{W}^*(\Lambda^{\complement})$ and $\Omega^*_{\Lambda^{\complement}}$.

To recapitulate, we list once again most of frequently used symbols below:

- $\overline{\Omega}^*(j) = (\overline{\omega}^*(j, 1), \dots, \overline{\omega}^*(j, n(j)))$ a type j PC (ordered), with fixed initial/end points,

As in [19], we also use the term a t-section (of a path/loop, and of a PC/LC) and employ the notation

Furthermore, we need a host of (integral) energy functionals $h(\ \cdot\)$ and $h(\ \cdot\ |\ \cdot\),$ viz.,

where $\overline{\mathbf{\Upsilon}}_{0}^{*} \in \underline{\mathcal{W}}^{*}(\overline{\mathbf{x}}_{0}, \overline{\mathbf{y}}_{0})$ and $\mathbf{\Omega}_{0}^{*} = \mathbf{\Omega}_{\Lambda_{0}}^{*} \in \mathcal{W}^{*}(\Lambda_{0})$, see (1.3.8), (1.3.9). Cf. Eqns (2.1.1.I)–(2.1.14.I). We also use the (standard) representation of the partition function $\Xi[\Lambda|\mathbf{x}(\Lambda^{(R)})]$ (see Eqn (2.2.1.I)) and RDMK $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_{0}}(\overline{\mathbf{x}}_{0}, \overline{\mathbf{y}}_{0})$ (see Eqns (2.2.2.I)–(2.2.5.I)). Next, Lemma 2.2.1.I, Definition 2.4.I, Lemma 2.2.I and Definitions 2.5.I–2.7.I introduce the concepts of the infinite-volume FK-DLR functionals, states and measures.

We employ the same notation \mathfrak{F} (for infinite-volume FK-DLR functionals), \mathfrak{F}_+ (for infinite-volume FK-DLR states) and \mathfrak{K} (for infinite-volume FK-DLR probability measures) as in [19]. Recall, $\mu \in \mathfrak{K}$ is a probability measure (PM) on $(\mathcal{W}(\mathbb{R}^d), \mathfrak{M}(\mathbb{R}^d))$. Here $\mathfrak{M}(\mathbb{R}^d)$ is the sigma-algebra generated by cylinder events. In a probabilistic terminology, μ is a random marked point process with marks from $\mathcal{W}^*(0)$, the space of loops starting and ending up at the origin. Formally, $\mathfrak{M}(\mathbb{R}^d)$ is the smallest sigma-algebra contained the 'local' sigma-algebras $\mathfrak{M}(\Lambda) \forall$ cube Λ . Cf. Sect. 3.I.

For any PM $\mu \in \mathfrak{K}$, the Ruelle bound (see Eqns (2.3.18.I)–(2.3.20.I)) holds true, with $\overline{\rho} = z$. Finally, the statements of Theorems 2.1.I and 2.2.I are carried through.

To summarize the FK-DLR representation: \forall functional $\varphi \in \mathfrak{F}$, the RDMK of an RDM R^{Λ_0} in Λ_0 has the form: $\forall \Lambda \supseteq \Lambda_0$ and $\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0 \in \mathcal{C}(\Lambda)$ with $\sharp \mathbf{x}_0(j) = \sharp \mathbf{y}_0(j)$,

Here μ is an FK-DLR measure (i.e., $\mu \in \mathfrak{K}$). The rest of the paper is organized as follows. In Section 2 we analyse compactness properties and prove Theorem 1.3. Section 3 gives a brief sketch of the proof of Theorem 1.2.

2 The compactness argument: proof of Theorem 1.3

2.1 Uniform boundedness and HS convergence

Let us fix a cube Λ_0 of side length $2L_0$ centered at $c = (\mathbf{c}^1, \ldots, \mathbf{c}^d)$: cf. Eqn (1.1.13). The first step in the proof is to verify that, as $\Lambda_0 \subset \Lambda$ and cube $\Lambda \nearrow \mathbb{R}^d$, the RDMK $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ (see (1.3.2)) form a compact family in $C^0(\mathcal{C}(\Lambda_0, \underline{n}) \times \mathcal{C}(\Lambda_0, \underline{n})) \forall$ given \underline{n} . (We want to stress that we work with pairs $(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ with $\sharp \mathbf{x}_0(j) = \sharp \mathbf{y}_0(j)$; otherwise $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0) = 0$.) Clearly, the Cartesian product $\mathcal{C}(\Lambda_0, \underline{n}) \times \mathcal{C}(\Lambda_0, \underline{n})$ (the range of variable $(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ with given $\sharp \mathbf{x}_0(j) = \sharp \mathbf{y}_0(j) = n(j)$) is compact. As in [8], [9], [10], it is convenient to employ the Ascoli–Arzela theorem, i.e., verify that, for a given \underline{n} , the functions $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0) \upharpoonright_{\mathcal{C}(\Lambda_0, \underline{n})} \times \mathcal{C}(\Lambda_0, \underline{n})$ are uniformly bounded and equi-continuous.

Checking uniform boundedness for a fixed \underline{n} proceeds as follows. $\forall (\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0) \in \mathcal{C}(\Lambda_0, \underline{n}) \times \mathcal{C}(\Lambda_0, \underline{n})$, the RDMK $F^{\Lambda_0}_{\Lambda | \mathbf{x}(\Lambda^{(\mathbb{R})})}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ satisfies, $\forall \Lambda \subseteq \Lambda' \supseteq \Lambda_0$,

To this end, we estimate first the integral in $d\mathbf{y}_0$, $\int_{\mathcal{C}(\Lambda_0,n)} d\overline{\mathbf{y}}_0 \Big[Q^{\Lambda_0}(\overline{\mathbf{x}}_0,\overline{\mathbf{y}}_0) \Big]^2$, for $\sharp \mathbf{x}_0(j) = \sharp \mathbf{y}_0(j) = n(j)$, does not exceed

The next step in the proof of (2.1.5) is to decompose the permutation $\pi_{n(j)}$ into the product of cycles: $\pi_{n(j)} = \gamma_1 \cdots \gamma_s$, a cycle γ_i having length n_i where $n_1 + \ldots + n_s = n(j)$ and starting at digit t_i (say). Next, we take into account such a decomposition, and for each cycle γ_i merge the paths $x_0(t_i) \to x_0(\gamma_i t_i)$, $x_0(\gamma_i t_i) \to x_0(\gamma_i^2 t_i), \ldots, x_0(\gamma_i^{n_i-1} t_i) \to x_0(t_i)$ into a loop with the identical initial and endpoint $x_0(t_i)$ lying within Λ_0 . In addition, each among the above paths contains precisely one intermediate time point of the form βm , where m is a positive integer such that the path at this point lies in Λ_0 . It is not hard to see that for the emerging loop $\overline{\omega}^*$, of the time-length βM (say), the total number of time-points βm such that m is a positive integer, $1 \leq m < M$ and $\overline{\omega}^*(\beta m) \in \Lambda_0$ is always odd. So,

where $v(\Lambda_0)$ stands for the Euclidean volume of cube Λ_0 .

A similar argument remains valid for the limiting RDMK $F^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$, beginning with the representation

Let us outline the argument of compactness in the HS norm. After checking that the family of the RDMKs $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$ satisfies, for given \underline{n} and Λ_0 , the assumptions of the Ascoli–Arzela theorem, we guaranty compactness in $C^0(\mathcal{C}(\Lambda_0, \underline{n}) \times \mathcal{C}(\Lambda_0, \underline{n}))$. Hence, $\forall \Lambda_0$ and \underline{n} , we can extract a sequence $\{\Lambda(s), \mathbf{x}((\Lambda(s))^{(\mathbb{R})}\}$ along which we have a convergence

Next, by using the Lebesgue dominated convergence theorem, we get from (2.1.5) and (2.1.10) that along our sequence,

Then Theorem 1.4 implies that the RDMs $R^{\Lambda_0}_{\Lambda|\mathbf{x}(\Lambda^{(\mathbf{R})})}$ converge to R^{Λ_0} in the trace norm. Finally, by inspecting a countable family of cubes Λ_0 , we get convergence for all given Λ_0 , i.e., the compactness of states.

2.2 Equicontinuity

To verify the equi-continuity property of RDMKs $F_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$, we have to check uniform bounds upon the gradients

Here x = x(j, l) is one of the points in $\underline{x}_0(j)$ and $y = y(j, \pi l)$ one of the points in $\underline{y}_0(j)$, $1 \leq l \leq n(j)$, $1 \leq j \leq q$. Both cases are treated in a similar fashion; for definiteness, we consider gradients $\nabla_y F^{\Lambda_0}_{\Lambda | \mathbf{x}(\Lambda^{(\mathsf{R})})}(\overline{\mathbf{x}}_0, \overline{\mathbf{y}}_0)$.

It can be seen from representation (2.1.2), (2.1.8) that there are two contributions into the gradient. The first contribution comes from varying the functional exp $\left[-h\left(\overline{\Upsilon}_{0}^{*} \vee \Omega_{\Lambda \setminus \Lambda_{0}}^{*} | \mathbf{x}(\Lambda^{(R)})\right)\right]$. The second one emerges from varying the measure $\overline{\mathbb{P}}_{\overline{\mathbf{x}}_{0},\overline{\mathbf{y}}_{0}}^{*}$. (We are interested only in variations related to a chosen point y.) Symbolically,

+ \left(\nabla_{y} \int_{\mathcal{W}^{*}(\mathbf{x}_{0}, \mathbf{y}_{0})} d\underline{\mathbb{P}}_{\mathbf{x}_{0}, \mathbf{y}_{0}}^{*}(\overline{\mathbf{\Upsilon}}_{0}^{*}) \right) \exp \left[-h\left(\overline{\mathbf{\Upsilon}}_{0}^{*}\right| \mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \lor \mathbf{x}(\Lambda^{R}) \right) \right] \Big\} \\
\times \prod_{1 \leq j \leq q} z_{j}^{K(\overline{\mathbf{T}}_{0}^{*}(j))} \frac{z_{j}^{K(\Omega_{\Lambda\setminus\Lambda_{0}}(j))}}{L(\Omega_{\Lambda\setminus\Lambda_{0}}(j))} \chi^{\Lambda_{0}}(\overline{\mathbf{\Upsilon}}_{0}^{*}) \alpha_{\Lambda}(\overline{\mathbf{\Upsilon}}_{0}^{*} \lor \mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}). \quad (2.2.1)$$

Let us analyze the parts involving the gradient. As before, write $\overline{\mathbf{x}}_0 = (\underline{x}_0(1), \dots, \underline{x}_0(q)), \ \overline{\mathbf{y}}_0 = (\underline{y}_0(1), \dots, \underline{y}_0(q)) \text{ and } \ \overline{\mathbf{\Upsilon}}_0^* = (\overline{\mathbf{\Upsilon}}_0^*(1), \dots, \overline{\mathbf{\Upsilon}}_0^*(q)).$ Here

(The indicators χ^{Λ_0} and α_{Λ} do not contribute and are omitted.) Here $\overline{\mathbf{Z}}_0^*$ is a collection of straight paths: $\overline{\mathbf{Z}}_{0}^{*} = (\overline{\mathbf{Z}}^{*}(1), \dots, \overline{\mathbf{Z}}^{*}(q)), \text{ with } \overline{\mathbf{Z}}^{*}(j) = (\zeta_{j,1}^{*}, \dots, \zeta_{j,n(j)}^{*})$ where each $\zeta_{j,l}^*$ is a linear function

(The fact that potentials $V_{j,j'}$ may take the value $+\infty$ does not play a role in this bound.)

(Here $k(\omega^*)$ stands for the time-multiplicity of ω^* .) The contribution of this sum into (2.2.1) is bounded from above in norm by

By using the Campbell theorem, the Ruelle bound and the fact that $h\left(\overline{\Upsilon}_{0}^{*}+\overline{\mathbf{Z}}_{0}^{*}\mid\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}\vee\mathbf{x}(\Lambda^{\mathtt{R}})\right)\geq0$ and omitting unused indicators, the quantity (2.2.6) does not exceed

Observe, that the expression (2.2.7) does not depend upon $\Lambda \supset \Lambda_0$. In turn, (2.2.7) is less than or equal to

lies within distance $\le \mathbb{R}$ from $\overline{\omega}^*_{j,l}(\mathbf{t} + m\beta)$, for some $\mathbf{t} \in [0,\beta] \Big) \Big].$

Next, by moving the starting/end points of both paths, ω^* and $\overline{\omega}_{j,l}^*$, we obtain that (2.2.8) does not exceed

To assess the RHS in (2.2.9), we use the requirement that the path $\overline{\omega}_{j,l}^*$ and the loop ω^* must come close to each other on the time interval $[0, \beta]$. A necessary condition for this is that – when $\operatorname{dist}_{\operatorname{Eu}}(x, \Lambda_0) > \mathbb{R}$ – at least one of them must travel at least a half of the distance $\operatorname{dist}_{\operatorname{Eu}}(x, \Lambda_0) - \mathbb{R}$ over the time interval $[0, \beta]$. For a point $x \in \mathbb{R}^d$ with a large value of $\operatorname{dist}_{\operatorname{Eu}}(x, \Lambda_0)$ it generates a sum of two small probabilities: one coming from $\mathbb{P}_{x,x}^{\beta k}$, the other from $\overline{\mathbb{P}}_{x(j,l),y(j,\pi l)}^{\beta k(j,l)}$. (Recall that $y(j, \pi l) = y$, the varying point from $\overline{\mathbf{y}}_0$.)

Proof of Lemma 2.1. The starting point is the Skorohod formula for the Brownian bridge on the time interval $[0, \beta]$ in one dimension: given a > 0 and $x, y \in \mathbb{R}$ with |x - y| < a,

Next, consider the contribution of the integral $\int du \mathbf{1}(|\mathbf{x} - \mathbf{u}| < a)$. When $a > \mathbf{u} - \mathbf{x} > 0$, we can write

A similar bound holds when u < x. Integrating in du yields a finite value, with the factor $e^{-a^2/(2\beta)}$ in front.

Let us now focus on the forth sum, $\sum_{\substack{1 \le m < k(j,l) \\ j' \ne j}} \sum_{\substack{1 \le j' \le q \\ j' \ne j}} \sum_{\overline{x} \in \mathbf{x}(\Lambda^{(\mathtt{R})}, j')}$, in the RHS

of (2.2.4). This sum contributes into (2.2.1) a quantity whose norm is

$$\times \int_{\mathcal{W}^{*}(\Lambda)} d\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}) \chi^{\Lambda_{0}}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}) \mathbf{1} \Big(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \in \mathcal{W}^{*}(\Lambda\setminus\Lambda_{0}) \Big)$$

$$\times \prod_{1 \leq i' \leq q} \frac{z_{i'}^{K(\Omega_{\Lambda\setminus\Lambda_{0}}^{*})}}{L(\Omega_{\Lambda\setminus\Lambda_{0}}^{*})} \alpha_{\Lambda} \Big(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \Big) \exp \Big[-h \Big(\overline{\mathbf{\Upsilon}}_{0}^{*} \mid \mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \lor \mathbf{x}(\Lambda^{R}) \Big) \Big]$$

$$\times \int_{0}^{\beta} d\mathbf{t} \sum_{\substack{1 \leq m < k(l,j) \\ \overline{x} \in \mathbf{x}(\Lambda^{(R)})}} \mathbf{1} \Big(|\overline{\omega}_{j,l}^{*}(\mathbf{t} + m\beta) - \overline{x}| < \mathbf{R} \Big). \tag{2.2.15}$$

The middle integral in (2.2.15) is

Indeed, $\mu_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ is a probability distribution, the values $z_{i'} \in (0, 1)$, functionals $K(\Omega^*_{\Lambda \setminus \Lambda_0}(i')), L(\Omega^*_{\Lambda \setminus \Lambda_0}(i')) \geq 1$ and $h\left(\overline{\mathbf{T}}^*_0 \mid \mathbf{\Omega}^*_{\Lambda \setminus \Lambda_0} \lor \mathbf{x}(\Lambda^{\mathbb{R}})\right) \geq 0$, and the rest are indicators. Therefore, (2.2.15) does not exceed

To bound (2.2.16) from above, we use the following argument. The sum $\sum_{\substack{1 \leq m < k(j,l) \\ \overline{x} \in \mathbf{x}(\Lambda^{(\mathbb{R})})}}$ is not zero only if the path $\overline{\omega}_{j,l}^*$ reaches the 'internal' annulus

where $\operatorname{dist}_{\operatorname{Eu}}(0, \Lambda_0)$ is the distance between Λ_0 and the origin. Going back to the external annulus $\Lambda^{(\mathbb{R})} = \Lambda_L^{(\mathbb{R})}$ (see (1.1.16)), the quantity (2.2.16) is

$$\leq \beta \overline{V}^{(1)} \sharp \mathbf{x}(\Lambda^{(\mathbf{R})}) \prod_{1 \leq i \leq q} n(i)! \left(1 \vee \sum_{k \geq 1} \frac{z_i^k}{(\sqrt{2\pi\beta k})^d} \right)^{n(i)} \\ \times \sum_{k \geq 1} \frac{z_j^k k}{(2\pi\beta k)^{d/2}} \exp\left[-\frac{\left(L - \mathbf{R} - L_0 - \operatorname{dist}_{\operatorname{Eu}}(0, \Lambda_0)\right)^2}{2\beta k} \right]$$

which in turn does not exceed

$$\beta \overline{V}^{(1)} \prod_{1 \le i \le q} n(i)! (1 + \Theta_0(z_i))^{n(i)} B(\mathbf{c}) := A_4(\underline{n}, \Lambda_0).$$
(2.2.17)

Here the quantity B(c) has been introduced in Eqn (1.1.20), and the argument c is specified as

$$c = (R + L_0 + dist_{Eu}(0, \Lambda_0))^2.$$
 (2.2.18)

We see that the norm of the gradient vector represented by (2.2.1) is upperbounded by

$$\overline{V}^{(1)}\Big[A_1(\underline{n},\Lambda_0) + A_2(\underline{n},\Lambda_0) + A_3(\underline{n},\Lambda_0) + A_4(\underline{n},\Lambda_0)\Big]$$

which yields the equi-continuity property required. Hence, the family of RDMKs $\left\{F_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}^{\Lambda_0}\right\}$ is compact in space $C^0(\mathcal{C}(\Lambda_0,\underline{n}) \times \mathcal{C}(\Lambda_0,\underline{n}))$. This closes the argument that the set of Gibbs states $\varphi_{\Lambda|\mathbf{x}(\Lambda^{(\mathbb{R})})}$ is compact.

2.3 Weak compactness of FK-DLR measures

A version of the above argument is applicable for proving that, for any given cube Λ_0 , the probability measures (PMs) $\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}$ on $\mathcal{W}^*(\Lambda_0)$ form a compact family as $\Lambda \nearrow \mathbb{R}^d$. According to the Prokhorov theorem, it is enough to verify that the family $\left\{\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}\right\}$ is tight.

The proof of tightness proceeds along steps (a)–(d); see below.

(a) Let $\epsilon > 0$ be given. Then we can find $k^0 = k^0(\epsilon, \Lambda_0)$ such that the value

$$\mu_{\Lambda|\mathbf{x}(\Lambda^{(\mathsf{R})})}^{\Lambda_0} \left(\mathbf{\Omega}_0^* = (\Omega_0^*(1), \dots, \Omega_0^*(q)) \in \mathcal{C}(\Lambda_0) : \max\left[K(\Omega_0^*(j)) : 1 \le j \le q \right] \ge k^0 \right)$$
(2.3.1)

can be made as small as desired. In fact,

$$\begin{split} &\mu_{\Lambda|\mathbf{x}(\Lambda^{(\mathsf{R})})}^{\Lambda_{0}}\left(\mathbf{\Omega}_{0}^{*}: \max\left[K(\Omega_{0}^{*}(j)): 1 \leq j \leq q\right] \geq k^{0}\right) \\ &= \int_{\mathcal{W}^{*}(\Lambda)} \mathrm{d}\mu_{\Lambda|\mathbf{x}(\Lambda^{(\mathsf{R})})}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*})\mathbf{1}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \in \mathcal{W}^{*}(\Lambda\setminus\Lambda_{0})) \\ &\times \int_{\mathcal{W}^{*}(\Lambda_{0})} \mathrm{d}\mathbf{\Omega}_{0}^{*} \prod_{1 \leq j \leq q} \frac{z_{j}^{K(\Omega_{0}^{*}(j))}}{L(\Omega_{0}^{*}(j))} \mathbf{1}(\max\left[K(\Omega_{0}^{*}(j)): 1 \leq j \leq q\right] \geq k^{0}) \end{split}$$

$$\times \chi^{\Lambda_{0}}(\boldsymbol{\Omega}_{0}^{*} \vee \boldsymbol{\Omega}_{\Lambda \setminus \Lambda_{0}}^{*}) \alpha_{\Lambda}(\boldsymbol{\Omega}_{0}^{*} \vee \boldsymbol{\Omega}_{\Lambda \setminus \Lambda_{0}}^{*}) \exp\left[-h(\boldsymbol{\Omega}_{0}^{*} \mid \boldsymbol{\Omega}_{\Lambda \setminus \Lambda_{0}}^{*} \vee \mathbf{x}(\Lambda^{(\mathbb{R})}))\right]$$

$$\leq \int_{\mathcal{W}^{*}(\Lambda_{0})} \mathrm{d}\boldsymbol{\Omega}_{0}^{*} \prod_{1 \leq j \leq q} \frac{z_{j}^{K(\Omega_{0}^{*}(j))}}{L(\Omega_{0}^{*}(j))} \mathbf{1}(\max\left[K(\Omega_{0}^{*}(j)) : 1 \leq j \leq q\right] \geq k^{0})$$

$$= \prod_{1 \leq j \leq q} \exp\left[v(\Lambda_{0})\left(1 + \Theta_{0}(z_{j})\right)\right]$$

$$\times \sum \sum \sum \frac{v(\Lambda_{0})^{n}}{L(\Omega_{0}^{*})^{n}} \prod \sum \frac{z_{i}^{k(l)}}{L(\Omega_{0}^{*})^{n}} \mathbf{1}\left(\sum k(l) \geq k^{0}\right)$$

$$(2.3.2)$$

$$\times \sum_{1 \le i \le q} \sum_{n \ge 0} \frac{\upsilon(\Lambda_0)^n}{n!} \prod_{1 \le l \le n} \sum_{k(l) \ge 1} \frac{z_i^{h(l)}}{k(l)(2\pi\beta k(l))^{d/2}} \mathbf{1} \left(\sum_{1 \le l \le n} k(l) \ge k^0 \right).$$

Like before, $v(\Lambda_0)$ stands here for the Euclidean volume of Λ_0 . For the definition

of Θ_0 (and Θ_{-1} below), see (2.2.5). The sum $\sum_{n\geq 0}$ in the RHS of (2.3.2) is divided into two: $\sum_1 := \sum_{n>\sqrt{k^0}}$ and $\sum_2 := \sum_{n\leq \sqrt{k^0}}$. The contribution of the former to the last line in (2.3.2) is

$$\leq \sum_{1 \leq i \leq q} \sum_{n > \sqrt{k^0}} \frac{\upsilon(\Lambda_0)^n}{n!} \Theta_{-1}(z_i)^n \tag{2.3.3}$$

which can be made arbitrarily small for large k^0 . Next, in the latter at least one k(l) must satisfy $k(l) \ge k^0/n \ge \sqrt{k^0}$. So, the contribution from \sum_2 to the last line in (2.3.2) does not exceed

$$\sum_{1 \le i \le q} \left(\sum_{k \ge \sqrt{k^0}} \frac{z_i^k}{k(2\pi\beta k)^{d/2}} \right) \sum_{n \le \sqrt{k^0}} n \frac{\upsilon(\Lambda_0)^n}{n!} \Theta_{-1}(z_i)^{n-1}$$
(2.3.4)

which again is small for large k^0 .

(b) The second step is the remark that the Radon-Nikodym derivative is bounded uniformly in Λ and $\mathbf{x}(\Lambda^{(\mathbf{R})})$ (since $z \in (0, 1)$):

$$\frac{\mathrm{d}\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_{0}}(\mathbf{\Omega}_{0}^{*})}{\mathrm{d}\mathbf{\Omega}_{0}^{*}} = \int_{\mathcal{W}^{*}(\Lambda)} \mathrm{d}\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}) \mathbf{1}(\mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*} \in \mathcal{W}^{*}(\Lambda\setminus\Lambda_{0}))$$

$$\times \chi^{\Lambda_{0}}(\mathbf{\Omega}_{0}^{*} \vee \mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}) \prod_{1 \leq j \leq q} \frac{z_{j}^{K(\Omega_{0}^{*}(j))}}{L(\Omega_{0}^{*}(j))} \alpha_{\Lambda}(\mathbf{\Omega}_{0}^{*} \vee \mathbf{\Omega}_{\Lambda\setminus\Lambda_{0}}^{*}) \leq 1.$$
(2.3.5)

(c) By virtue of property (b), it suffices to prove that, for given $\delta > 0$ and positive integer k^0 , there exists a compact set $\mathcal{J} \subset \mathcal{C}(\Lambda_0)$ such that

$$\mathcal{J} \subset \mathcal{K}(k^0) := \left\{ \mathbf{\Omega}_0^* : \max \left[K(\Omega_0^*(j)) \right] \le k^0 \right\} \text{ and } \int_{\mathcal{C}(\Lambda_0) \setminus \mathcal{J}} \mathrm{d}\mathbf{\Omega}_0^* < \delta.$$
(2.3.6)

As before, this is achieved with the help of the Ascoli–Arzela theorem, connecting compactness with uniform boundedness and equi-continuity. First, we guarantee the uniform boundedness by claiming that $\forall \delta$ and k_0 there exists an $\ell^0 \in (0, \infty)$ such that

$$\int_{\mathcal{K}(k^0)} \mathrm{d}\mathbf{\Omega}_0^* \, \mathbf{1}\bigg(\max_{\omega^* \in \mathbf{\Omega}_0^*} \sup \, \left[|\omega^*(\mathsf{t}) - \omega^*(0)| : 0 \le \mathsf{t} \le \beta k(\omega^*) \right] \ge \ell^0 \bigg) \le \frac{\delta}{2}.$$
(2.3.7)

This claim holds because on the set $\mathcal{K}(k^0)$ the number of loops ω^* constituting the LC Ω_0^* and their time-multiplicities $k(\omega^*)$ do not exceed k^0 .

(d) Finally, we need to verify the equi-continuity property. But this fact holds true since the reference measure $d\Omega_0^*$ on the set $\mathcal{K}(k^0)$ is supported by LCs Ω_0^* such that all loops $\omega^* \in \Omega^*$ have a (global) continuity modulus not exceeding $\sqrt{2k^0\beta\epsilon \ln(1/\epsilon)}$.

This completes the proof of compactness for PMs $\mu_{\Lambda|\mathbf{x}(\Lambda^{(R)})}^{\Lambda_0}$.

As a result, the family of limit-point PMs { μ^{Λ_0} : $\Lambda_0 \subset \mathbb{R}^d$ } has the compatibility property and therefore satisfies the assumptions of the Kolmogorov theorem. This implies that there exists a unique PM μ on ($\mathcal{W}^*(\mathbb{R}^d), \mathfrak{W}(\mathbb{R}^d)$) such that the restriction of μ on the sigma-algebra $\mathfrak{W}(\Lambda_0)$ coincides with μ^{Λ_0} .

The fact that μ is an FK-DLR PM follows from the above construction. Hence, each limit-point state φ falls in class $\mathfrak{F}_+(z,\beta)$. This completes the proof of Theorem 1.2.

Remark. In the course of the proof of compactness of measures $\mu_{\Lambda|\mathbf{x}(\Lambda R)}^{\Lambda_0}$ we did not use the condition (1.1.20).

3 The shift-invariance of an FK-DLR PM in a plane

In this section we establish the following theorem (cf. Theorem 1.2.II).

Theorem 3.1. In dimension two (d = 2), any FK-DLR PM $\mu \in \mathfrak{K}$ is translation invariant: $\forall s = (\mathfrak{s}^1, \mathfrak{s}^2) \in \mathbb{R}^2$, square $\Lambda_0 = [-L_0, L_0]^{\times 2}$ and event $\mathcal{D} \in \mathcal{W}^*(\mathbb{R}^2)$ localised in Λ_0 (i.e., belonging to a sigma-algebra $\mathfrak{W}(\Lambda_0)$; cf Definition 2.4.**I**), we have that

$$\mu(\mathbf{S}(s)\mathcal{D}) = \mu(\mathcal{D}).$$

Here $S(s)\mathcal{D}$ stands for the shifted event localised in the shifted square $S(s)\Lambda_0 = [-L_0 + s^1, s^1 + L_0] \times [-L_0 + s^2, s^2 + L_0].$

Our Theorem 1.2 is a direct corollary of Theorem 3.1. As in [20], the principal step in the proof of Theorem 3.1 is

Theorem 3.2. Let μ be an FK-DLR PM, Λ_0 be a square $[-L_0, L_0]^{\times 2}$ and an event $\mathcal{D} \subset \mathcal{W}^*(\mathbb{R}^2)$ be given, localized in $\Lambda_0: \mathcal{D} \in \mathfrak{W}(\Lambda_0)$. Then

$$\mu(\mathbf{S}(s)\mathcal{D}) + \mu(\mathbf{S}(-s)\mathcal{D}) - 2\mu(\mathcal{D}) \ge 0. \qquad \Box \tag{3.1}$$

Cf. Theorem 2.1.II. The proof of Theorem 3.2 is basically a repetition of that of Theorem 2.1.II (its main ideas go back to [13]–[15], particularly [14]). Consequently, we will omit various technical details referring the reader to the

above publications. Let $L > L_0$ be given, and set $\Lambda = [-L, L] \times [-L, L]$. The main ingredient of the proof is a family of maps $T_L^{\pm} = T_{L,L_0}^{\pm}(s) : \mathcal{W}^*(\mathbb{R}^2)$ $\rightarrow \mathcal{W}^*(\mathbb{R}^2), s = (\mathbf{s}^1, \mathbf{s}^2)$, featuring properties (i)–(vi) listed in Sect. 2.II. The formal definition of maps T_L^{\pm} follows Sect 3.II and is given in terms of t-sections of LCs $(\Omega^*_{\Lambda} \vee \Omega^*_{\Lambda^c})$. As in [20], Theorem 3.2 can be deduced from Theorem 3.3:

Theorem 3.3. For any $\delta > 0$ there exists $L_0^* = L_0^*(\delta) > 0$ such that for $L \geq L_0^*$ there exists a subset $\mathcal{G}_L \subset \mathcal{W}^*(\mathbb{R}^2)$ such that $\mathcal{G}_L \in \mathfrak{M}$ and the following properties are satisfied:

(A)

$$\begin{aligned}
\mu(\mathcal{G}_{L}) &= \int_{\mathcal{W}^{*}(\mathbb{R}^{2})} \mu(\mathrm{d}\Omega_{\Lambda^{\complement}}^{*}) \mathbf{1} \left(\Omega_{\Lambda^{\complement}}^{*} \in \mathcal{W}^{*}(\Lambda^{\complement})\right) \\
\times &\int_{\mathcal{W}^{*}(\Lambda)} \mathrm{d}\Omega_{\Lambda}^{*} \mathbf{1} \left(\Omega_{\Lambda}^{*} \lor \Omega_{\Lambda^{\complement}}^{*} \in \mathcal{G}_{L}\right) \\
\times &\frac{z^{K}(\Omega_{\Lambda}^{*})}{L(\Omega_{\Lambda}^{*})} \exp\left[-h(\Omega_{\Lambda}^{*}|\Omega_{\Lambda^{\complement}}^{*})\right] \geq 1 - \delta.
\end{aligned}$$
(3.2)

(B) The probabilities $\mu(\mathbf{S}(\pm s)(\mathcal{D} \cap \mathcal{G}_L))$ are represented in the form

$$\mu(\mathbf{S}(\pm s)(\mathcal{D} \cap \mathcal{G}_L)) = \int_{\mathcal{W}_{\mathbf{r}}^*(\mathbb{R}^2)} \mu(\mathrm{d}\mathbf{\Omega}_{\Lambda^{\complement}}^*) \mathbf{1} \left(\mathbf{\Omega}_{\Lambda^{\complement}}^* \in \mathcal{W}_{\mathbf{r}}\left(\Lambda^{\complement}\right)\right) \\ \times \int_{\mathcal{W}_{\mathbf{r}}^*(\Lambda)} \mathrm{d}\mathbf{\Omega}_{\Lambda}^* \mathbf{1} \left(\mathbf{\Omega}_{\Lambda}^* \vee \mathbf{\Omega}_{\Lambda^{\complement}}^* \in \mathcal{G}_L \cap \mathcal{D}\right) \frac{z^{K(\mathbf{\Omega}_{\Lambda}^*)}}{L(\mathbf{\Omega}_{\Lambda}^*)} \\ \times J_L^{\pm}(\mathbf{\Omega}_{\Lambda}^* \vee \mathbf{\Omega}_{\Lambda^{\complement}}^*) \exp\left[-h(\mathbf{T}_L^{\pm}(s)\mathbf{\Omega}_{\Lambda}^*|\mathbf{\Omega}_{\Lambda^{\complement}}^*)\right]$$
(3.3)

where functions $J_L^{\pm} = J_{L,s}^{\pm}$ give the Jacobians of maps $\mathsf{T}_L^{\pm}(s)$. (C) Furthermore, the following properties hold true: $\forall \ \Omega_{\Lambda}^* \in \mathcal{W}^*(\Lambda), \ \Omega_{\Lambda}^* \in \mathcal{W}^*(\Lambda)$ $\mathcal{W}^*(\Lambda^{\complement})$ with $\Omega^*_{\Lambda} \vee \Omega^*_{\Lambda^{\complement}} \in \mathcal{G}_L$,

$$\left[J_{L}^{+}(\boldsymbol{\Omega}_{\Lambda}^{*} \vee \boldsymbol{\Omega}_{\Lambda^{\complement}}^{*})J_{L}^{-}(\boldsymbol{\Omega}_{\Lambda}^{*} \vee \boldsymbol{\Omega}_{\Lambda^{\complement}}^{*})\right]^{1/2} \ge 1 - \delta;$$
(3.4a)

and

$$h(\mathsf{T}_{L}^{+}(s)\mathbf{\Omega}^{*}_{\Lambda}|\mathbf{\Omega}^{*}_{\Lambda^{\complement}}) + h(\mathsf{T}_{L}^{-}(s)\mathbf{\Omega}^{*}_{\Lambda}|\mathbf{\Omega}^{*}_{\Lambda^{\complement}}) - 2h(\mathbf{\Omega}^{*}_{\Lambda}|\mathbf{\Omega}^{*}_{\Lambda^{\complement}}) \le \delta.$$
(3.4b)

Remark. As in [20], the dimension 2 is crucial for properties (3.4a,b). Theorem 3.3 is the only place where condition $\overline{V}^{(2)} < +\infty$ is used. Cf. (1.1.4).

Theorem 3.2 is deduced from Theorem 3.3 in a standard fashion (see Eqns (2.10.II) - (2.12.II)).

The proof of Theorem 3.2 goes in parallel with that of Theorem 2.2.II; a particular role is played by a specific form of the Jacobians $J_L^{\pm}(\Omega^*_{\Lambda} \vee \Omega^*_{\Lambda^{\mathsf{G}}})$; cf. Eqn (3.23.II). Here we mark the places where the proof of Theorem 2.2.II (see Sects 3.II–5.II) has to be modified, because of the assumption of non-negativity for the potentials $V_{j,j'}$ and the condition that fugacities $z_j \in (0,1), 1 \leq j \leq q$. (a) Every time we use the Ruelle bound (cf. Eqns (3.27.II), (4.12.II), (4.21.II)), we should employ z_j instead of $\overline{\rho}$ (defined in Eqn (1.1.4.II). (b) The quantity r appearing in Eqns (3.13.II), (4.4.II), (4.5.II), (4.8.II), (4.9.1.II), (4.9.2.II), (4.10.II) (4.13.II), (4.14.II), (4.17.II), (4.19.1.II), (4.19.2.II). (4.20.1.II) (4.20.2.II), (4.21.II), (5.8.II) and (5.9.II) should be set to be 0.
