Ultradiscrete sine-Gordon Equation over Symmetrized Max-Plus Algebra, and Noncommutative Discrete and Ultradiscrete sine-Gordon Equations

Abstract. Ultradiscretization with negative values is a long-standing problem and several attempts have been made to solve it. Among others, we focus on the symmetrized max-plus algebra, with which we ultradiscretize the discrete sine-Gordon equation. Another ultradiscretization of the discrete sine-Gordon equation has already been proposed by previous studies, but the equation and the solutions obtained here are considered to directly correspond to the discrete counterpart. We also propose a noncommutative discrete analogue of the sine-Gordon equation, reveal its relations to other integrable systems including the noncommutative discrete KP equation, and construct multisoliton solutions by a repeated application of Darboux transformations. Moreover, we derive a noncommutative ultradiscrete analogue of the sine-Gordon equation and its 1-soliton and 2-soliton solutions, using the symmetrized max-plus algebra. As a result, we have a complete set of commutative and noncommutative versions of continuous, discrete, and ultradiscrete sine-Gordon equations.

Key words: ultradiscrete sine-Gordon equation; symmetrized max-plus algebra; noncommutative discrete sine-Gordon equation; noncommutative ultradiscrete sine-Gordon equation

1 Introduction

1.1 Ultradiscretization and its problem

Ultradiscrete integrable systems are integrable systems where independent variables take values in \mathbb{Z} , and dependent variables in the max-plus algebra $\mathbb{R}_{\max} = \mathbb{R} \cup \{-\infty\}$. Among them is the famous box-ball system [21], represented by the equation

$$U_n^{t+1} = \min \left[1 - U_n^t, \sum_{k=-\infty}^{n-1} U_k^t - \sum_{k=-\infty}^{n-1} U_k^{t+1} \right].$$

Defining $S_n^t = \sum_{k=n}^{\infty} \sum_{l=-\infty}^{t} U_k^l$, we obtain

$$S_{n+1}^{t+1} + S_n^{t-1} = \max \left[S_{n+1}^{t-1} + S_n^{t+1} - 1, S_n^t + S_{n+1}^t \right], \tag{1.1}$$

which is ultradiscretization of the discrete KdV equation

$$(1+\delta)\sigma_{n+1}^{t+1}\sigma_n^{t-1} = \delta\sigma_{n+1}^{t-1}\sigma_n^{t+1} + \sigma_n^t\sigma_{n+1}^t. \tag{1.2}$$

Ultradiscretization [22] is a systematic procedure to obtain ultradiscrete systems from discrete systems. The fundamental formula of the procedure is

$$\lim_{\epsilon \to +0} \epsilon \log \left(e^{A/\epsilon} + e^{B/\epsilon} \right) = \max[A, B], \qquad \lim_{\epsilon \to +0} \epsilon \log \left(e^{A/s} \cdot e^{B/s} \right) = A + B.$$

This may be understood as a transformation of addition into max operation and of multiplication into addition. Setting $\delta = e^{-1/\epsilon}$ in (1.2) and applying ultradiscretization, we obtain (1.1).

The problem is, however, that ultradiscretization cannot be applied to subtraction, which is of course necessary in many discrete integrable systems. The reason is as follows. If one wants to define an ultradiscrete version of subtraction, it is natural to solve the linear equation

$$\max[x, a] = b$$

for $x \in \mathbb{R}_{\text{max}}$. This has no solution when a > b, and therefore subtraction cannot be defined in general.

Several attempts [8, 11, 15, 18, 19, 23] have been made to solve this problem. We focus on the symmetrized max-plus algebra [1, 2], denoted by $u\mathbb{R}$ in this paper. This algebra is an extension of \mathbb{R}_{max} and looks natural in the sense it traces the construction of \mathbb{Z} from \mathbb{N}^2 . Linear algebra over $u\mathbb{R}$ is also possible, and ultradiscretization with $u\mathbb{R}$ is presented in [4]. These theories of $u\mathbb{R}$ are mainly developed in the field of discrete event systems and seems little known to the field of integrable systems.

1.2 Contents of the paper

The discrete sine-Gordon equation [3, 7]

$$\begin{split} &(1-\delta)\tau_l^m\tau_{l+1}^{m+1} = \tau_{l+1}^m\tau_l^{m+1} - \delta\sigma_{l+1}^m\sigma_l^{m+1},\\ &(1-\delta)\sigma_l^m\sigma_{l+1}^{m+1} = \sigma_{l+1}^m\sigma_l^{m+1} - \delta\tau_{l+1}^m\tau_l^{m+1} \end{split}$$

has not been ultradiscretized until recent years because soliton solutions include subtraction or even complex numbers. The first attempt is made by Isojima et al. [9, 10] where a τ -only trilinear equation is exploited to exclude subtraction. Here we propose another method to ultradiscretize the sine-Gordon equation which utilizes u \mathbb{R} . The equation and the solutions are ultradiscretized keeping subtraction and complex numbers in a highly direct fashion.

Noncommutative integrable systems have been drawing more interest in the last two decades. It is difficult to point out the first appearance of such systems, but the noncommutative KdV equation is already mentioned in [13]. The first discrete noncommutative integrable system is probably the noncommutative discrete KP equation [12, 17]. Along this line, we propose a noncommutative discrete analogue of the sine-Gordon equation, explore relations to other integrable systems, and construct multisoliton solutions by the Darboux transformation. Moreover, we also propose a noncommutative ultradiscrete analogue of the sine-Gordon equation and explicitly derive 1-soliton and 2-soliton solutions by ultradiscretization with $u\mathbb{R}$. As a result, we have a complete set of commutative and noncommutative versions of continuous, discrete, and ultradiscrete sine-Gordon equations.

The rest of the paper is organized as follows. In Section 2.1, the discrete sine-Gordon equation and 1-soliton and 2-soliton solutions are reviewed. Special solutions such as the traveling-wave and kink-antikink solutions are presented probably for the first time. In Section 2.2, an ultradiscrete analogue of the sine-Gordon equation is proposed and the solutions are obtained. Because of ultradiscretization with $u\mathbb{R}$, correspondence between the discrete and ultradiscrete systems are direct, which is also supported by figures.

In Section 3.1, a noncommutative discrete analogue of the sine-Gordon equation is proposed. A relation to other integrable systems including the noncommutative discrete KP equation is

explained, and multisoliton solutions are constructed by a repeated application of Darboux transformations. In Section 3.2, a noncommutative ultradiscrete analogue of the sine-Gordon equation is proposed and 1-soliton and 2-soliton solutions are derived. Also figures of solutions for both equations are displayed.

In Section 4, concluding remarks and discussions are presented.

2 Discrete and ultradiscrete sine-Gordon equations

In this section, we first review the discrete sine-Gordon equation [3, 7] and several results around it. Explicit calculation of the traveling-wave, kink-antikink, kink-kink, and breather solutions are probably presented for the first time.

Then, we propose an ultradiscrete analogue of the sine-Gordon equation. The solutions are obtained in two ways: by calculations completely inside $u\mathbb{R}$, and by ultradiscretization with $u\mathbb{R}$. The correspondence between the discrete and ultradiscrete systems is quite clear. Similarity of profiles of solutions is also visually confirmed by figures. Our formulation is different from Isojima et al. [9].

2.1 Discrete sine-Gordon equation

We review the three representations of the discrete sine-Gordon equation, their connection to the sine-Gordon equation, and some solutions for the sine-Gordon equation.

For any function f = f(l, m) over \mathbb{Z}^2 , define shift operations by

$$f_l = f_l(l, m) = f(l+1, m),$$
 $f_m = f_m(l, m) = f(l, m+1).$

Inverse operations are denoted by

$$f_{\bar{l}} = f(l-1, m), \qquad f_{\overline{m}} = f(l, m-1).$$

Let $\tau = \tau(l, m)$, $\sigma = \sigma(l, m)$ be functions $\mathbb{Z}^2 \to \mathbb{C}$. Date et al. [3] gave the discrete sine-Gordon equation (dsG) in the following form

$$(1 - \delta)\tau \tau_{lm} = \tau_l \tau_m - \delta \sigma_l \sigma_m, \tag{2.1a}$$

$$(1 - \delta)\sigma\sigma_{lm} = \sigma_l\sigma_m - \delta\tau_l\tau_m, \tag{2.1b}$$

where $\delta \in \mathbb{C}^{\times}$ is a parameter with a small absolute value. The vacuum solution

$$\tau = \sigma = 1$$

is the simplest solution, other than the null solution $\tau = \sigma = 0$. Calculating the cross product of the both sides of (2.1a), (2.1b), we have

$$\tau \tau_{lm}(\sigma_l \sigma_m - \delta \tau_l \tau_m) = \sigma \sigma_{lm}(\tau_l \tau_m - \delta \sigma_l \sigma_m) \iff \frac{\tau_{lm} \sigma_m}{\sigma_{lm} \tau_m} - \frac{\tau_l \sigma}{\sigma_l \tau} + \delta \left(\frac{\sigma_m \sigma}{\tau_m \tau} - \frac{\tau_{lm} \tau_l}{\sigma_{lm} \sigma_l}\right) = 0$$

and thus

$$\frac{w_{lm}}{w_m} - \frac{w_l}{w} + \delta \left(\frac{1}{w_m w} - w_{lm} w_l \right) = 0, \tag{2.2}$$

where w is defined by

$$w = \frac{\tau}{\sigma}$$
.

If we introduce u defined by

$$u = \frac{2}{i} \log w,$$

we have

$$e^{i(u_{lm}-u_m)/2} - e^{i(u_l-u)/2} + \delta(e^{i(-u_m-u)/2} - e^{i(u_{lm}+u_l)/2}) = 0$$

$$\iff \sin\left(\frac{u_{lm} - u_l - u_m + u}{4}\right) = \delta\sin\left(\frac{u_{lm} + u_l + u_m + u}{4}\right). \tag{2.3}$$

Each of (2.2) and (2.3) is also called the discrete sine-Gordon equation, where (2.3) is the original form discovered by Hirota [7].

Remark 2.1. By the non-autonomous transformation $w' = w^{(-1)^m}$, (2.2) becomes

$$\frac{w_m'}{w_{lm}'} - \frac{w_l'}{w'} + \delta\left(\frac{w_m'}{w'} - \frac{w_l'}{w_{lm}'}\right) = 0 \iff \frac{w_m' - \delta w_l'}{w_{lm}'} = \frac{w_l' - \delta w_m'}{w'}.$$

This is known as a discrete analogue of the modified KdV equation [16], and its ultradiscretization is also known [20].

Assume u is also a function u(x,y) of continuum variables $x,y \in \mathbb{R}$ and has an expansion

$$u(x+r,y+s) = u + (ru_x + su_y) + \frac{1}{2} (r^2 u_{xx} + 2rsu_{xy} + s^2 u_{yy}) + \cdots,$$

where $u_x = \partial u/\partial x$, etc. Connect l, m to x, y via the Miwa transformation

$$u(x, y; l, m) = u(x + la, y + mb)$$

where $a, b \in \mathbb{R}^{\times}$ are parameters. Then we have

$$u_{lm} - u_l - u_m + u = abu_{xy} + \text{(higher-order terms of } a, b\text{)}.$$

Setting $\delta = ab$ and taking the limit $a, b \to 0$ of (2.3) successively, we obtain

$$\lim_{a,b\to 0} \frac{1}{ab} \sin\left(\frac{u_{lm} - u_l - u_m + u}{4}\right) = \lim_{a,b\to 0} \frac{1}{ab} \sin\left(\frac{abu_{xy} + \cdots}{4}\right) = \frac{1}{4}u_{xy},$$

$$\lim_{a,b\to 0} \sin\left(\frac{u_{lm} + u_l + u_m + u}{4}\right) = \sin u,$$

and thus the (continuous) sine-Gordon equation

$$u_{xy} = 4\sin u$$
.

This is known to have following special types of solutions (see, for example, [6]): the traveling-wave solution

$$u = 4\arctan\exp\left(\pm\frac{x - vy}{\sqrt{1 - v^2}}\right),\tag{2.4}$$

the kink-antikink solution

$$u = 4 \arctan\left(\frac{\sinh\frac{vy}{\sqrt{1-v^2}}}{v\cosh\frac{x}{\sqrt{1-v^2}}}\right),\tag{2.5}$$

the kink-kink solution

$$u = 4 \arctan\left(\frac{v \sinh\frac{x}{\sqrt{1-v^2}}}{\cosh\frac{vy}{\sqrt{1-v^2}}}\right),\tag{2.6}$$

and the breather solution

$$u = 4 \arctan\left(\frac{\sqrt{1-\omega^2}}{\omega} \frac{\sin \omega y}{\cosh \sqrt{1-\omega^2} x}\right),\tag{2.7}$$

where v, ω are constants.

2.1.1 1-soliton and 2-soliton solutions

Isojima et al. [9] have given the following conditions for τ and σ to be a 1-soliton or 2-soliton solution. As a 1-soliton solution, assume

$$\tau = 1 + f, \qquad \sigma = 1 - f, \qquad f = cp^l q^m \tag{2.8}$$

where $c, p, q \in \mathbb{C}^{\times}$ are constants. By substitution, the dispersion relation

$$(1 - \delta)(1 + pq) = (1 + \delta)(p + q) \iff q = \frac{(1 + \delta)p - (1 - \delta)}{(1 - \delta)p - (1 + \delta)}$$
(2.9)

is found to be a necessary and sufficient condition. As a 2-soliton solution, assume

$$\tau = 1 + f_1 + f_2 + \alpha f_1 f_2, \qquad \sigma = 1 - f_1 - f_2 + \alpha f_1 f_2, \qquad f_j = c_j p_j^l q_j^m,$$

where $\alpha \in \mathbb{C}^{\times}$ is a constant. This time, the pair of the dispersion relation

$$(1 - \delta)(1 + p_j q_j) = (1 + \delta)(p_j + q_j) \iff q_j = \frac{(1 + \delta)p_j - (1 - \delta)}{(1 - \delta)p_j - (1 + \delta)}$$

and the relation

$$\alpha = -\frac{p_1 - p_2}{1 - p_1 p_2} \frac{q_1 - q_2}{1 - q_1 q_2} = \left(\frac{p_1 - p_2}{1 - p_1 p_2}\right)^2 \tag{2.10}$$

is a necessary and sufficient condition.




Figure 2.1. 1-soliton solution (left) and 2-soliton solution (right) for dsG.

Fig. 2.1 shows the 1-soliton solution with

$$\delta = 0.04, \qquad c = -1, \qquad p = 2,$$

and the 2-soliton solution with

$$\delta = 0.04,$$
 $c_1 = c_2 = -2.125,$ $p_1 = q_2 = 2,$

in the light-cone coordinates

$$(n,t) = \left(\frac{l+m}{2}, \frac{l-m}{2}\right) \iff (l,m) = (n+t, n-t). \tag{2.11}$$




Figure 2.2. Traveling-wave solution for dsG.

2.1.2 Traveling-wave solution

In Sections 2.1.2–2.1.4, we give solutions for (2.1a) and (2.1b) which correspond to the continuous counterparts (2.4)–(2.7). These do not seem to be previously presented in the literature, including Hirota [7] and Isojima et al. [9].

Replacing c by ic in the 1-soliton solution, we obtain

$$w = \frac{1 + ic(pq)^n (pq^{-1})^t}{1 - ic(pq)^n (pq^{-1})^t}, \qquad u = 4\arctan\left(c(pq)^n (pq^{-1})^t\right)$$
(2.12)

in the light-cone coordinates. This corresponds to the traveling-wave solution (2.4) for the sine-Gordon equation (if we restrict $\delta, c, p \in \mathbb{R}^{\times}$). Fig. 2.2 shows the solution with

$$\delta = 0.04, \qquad c = 1, \qquad p = 2.$$

2.1.3 Kink-antikink and kink-kink solutions

Set $p_1 = q_2$ in the 2-soliton solution. Then

$$p_1 = \frac{(1+\delta)p_2 - (1-\delta)}{(1-\delta)p_2 - (1+\delta)} \iff p_2 = \frac{(1+\delta)p_1 - (1-\delta)}{(1-\delta)p_1 - (1+\delta)}$$
(2.13)




Figure 2.3. Kink-antikink solution for dsG.

and thus $p_2 = q_1$. Rewriting in the light-cone coordinates, we have

$$\tau = 1 + c_1 p_1^{n+t} p_2^{n-t} + c_2 p_2^{n+t} p_1^{n-t} + \alpha c_1 c_2 (p_1 p_2)^{2n}$$

$$= (p_1 p_2)^n \left(\alpha c_1 c_2 (p_1 p_2)^n + (p_1 p_2)^{-n} + c_1 \left(p_1 p_2^{-1} \right)^t + c_2 \left(p_1 p_2^{-1} \right)^{-t} \right),$$

$$\sigma = (p_1 p_2)^n \left(\alpha c_1 c_2 (p_1 p_2)^n + (p_1 p_2)^{-n} - c_1 \left(p_1 p_2^{-1} \right)^t - c_2 \left(p_1 p_2^{-1} \right)^{-t} \right).$$

We set

$$\beta = \pm \frac{p_1 - p_2}{1 - p_1 p_2}, \qquad c_1 = -c_2 = i\beta^{-1}$$

and define

$$\operatorname{ch}(p,l) = \frac{p^l + p^{-l}}{2}, \qquad \operatorname{sh}(p,l) = \frac{p^l - p^{-l}}{2}.$$

Then

$$w = \frac{\beta \operatorname{ch}(p_1 p_2, n) + i \operatorname{sh}(p_1 p_2^{-1}, t)}{\beta \operatorname{ch}(p_1 p_2, n) - i \operatorname{sh}(p_1 p_2^{-1}, t)}, \qquad u = 4 \arctan\left(\frac{\operatorname{sh}(p_1 p_2^{-1}, t)}{\beta \operatorname{ch}(p_1 p_2, n)}\right).$$
(2.14)

This corresponds to the kink-antikink solution (2.5). Fig. 2.3 shows the solution with

$$\delta = 0.04,$$
 $c_1 = -c_2 = 2.125i,$ $p_1 = 2.$

Similarly, setting $p_1q_2 = 1$ gives

$$p_1^{-1} = \frac{(1+\delta)p_2 - (1-\delta)}{(1-\delta)p_2 - (1+\delta)} \iff p_2^{-1} = \frac{(1+\delta)p_1 - (1-\delta)}{(1-\delta)p_1 - (1+\delta)}$$

and thus $p_2q_1=1$. We have

$$\tau = \beta^{-1}(p_1p_2)^t \left(\beta(p_1p_2)^t + \beta(p_1p_2)^{-t} + i \left(p_1p_2^{-1} \right)^n - i \left(p_1p_2^{-1} \right)^{-n} \right),$$

$$\sigma = \beta^{-1}(p_1p_2)^t \left(\beta(p_1p_2)^t + \beta(p_1p_2)^{-t} - i^{-1} \left(p_1p_2^{-1} \right)^n + i \left(p_1p_2^{-1} \right)^{-n} \right)$$




Figure 2.4. Kink-kink solution for dsG.

for the same β , c_1 , c_2 defined above and

$$w = \frac{\beta \operatorname{ch}(p_1 p_2, t) + i \operatorname{sh}(p_1 p_2^{-1}, n)}{\beta \operatorname{ch}(p_1 p_2, t) - i \operatorname{sh}(p_1 p_2^{-1}, n)}, \qquad u = 4 \arctan\left(\frac{\operatorname{sh}(p_1 p_2^{-1}, n)}{\beta \operatorname{ch}(p_1 p_2, t)}\right). \tag{2.15}$$

This corresponds to the kink-kink solution (2.6). Fig. 2.4 shows the solution with

$$\delta = 0.04,$$
 $c_1 = -c_2 = -0.470588i,$ $p_1 = 2.$

2.1.4 Breather solution

Consider the kink-antikink solution where p_1 and p_2 are complex numbers satisfying

$$p_1 p_2 \in \mathbb{R}_{>0}, \qquad \left| p_1 p_2^{-1} \right| = 1.$$

Such p_1 , p_2 are complex conjugates of each other. If we write $p_1 = g + hi$, $p_2 = g - hi$ and substitute these into (2.13), we find g, h must satisfy

$$(1 - \delta) (1 + g^2 + h^2) = 2(1 + \delta)g \iff (1 - \delta)g^2 - 2(1 + \delta)g + (1 - \delta) (1 + h^2) = 0.$$

As a quadratic equation of g, the condition for the existence of real roots is given by

$$(1+\delta)^2 - (1-\delta)^2 (1+h^2) \ge 0 \iff h^2 \le \left(\frac{1+\delta}{1-\delta}\right)^2 - 1.$$

Such a real number h does exist if $\delta \geq 0$, and g is given by

$$g = \frac{1+\delta}{1-\delta} \pm \sqrt{\left(\frac{1+\delta}{1-\delta}\right)^2 - (1+h^2)}.$$

Rewriting $p_1 = re^{i\theta}$, $p_2 = re^{-i\theta}$, we obtain $\beta = i\gamma$ where γ is defined by

$$\gamma = \pm \frac{2r\sin\theta}{1 - r^2},$$




Figure 2.5. Breather solution for dsG.

and sh $(p_1p_2^{-1}, t) = i \sin 2t\theta$. Thus,

$$w = \frac{\gamma \operatorname{ch}(r^2, n) + i \sin 2t\theta}{\gamma \operatorname{ch}(r^2, n) - i \sin 2t\theta}, \qquad u = 4 \arctan \left(\frac{\sin 2t\theta}{\gamma \operatorname{ch}(r^2, n)}\right).$$

This corresponds to the breather solution (2.7). Fig. 2.5 shows the solution with

$$\delta = 0.04,$$
 $c_1 = -c_2 = 0.75,$ $p_1 = 0.75 + 0.25i.$

2.2 Ultradiscrete sine-Gordon equation

2.2.1 Ultradiscrete sine-Gordon equation

In order to ultradiscretize the discrete sine-Gordon equation (2.1a), (2.1b), we must deal with negative numbers since either or both of τ and σ include subtractions. We adopt ultradiscretization with the symmetrized max-plus algebra u \mathbb{R} . For details, see Appendix A and references cited there.

We perform ultradiscretization of dsG through the parametrization

$$\delta = \mu_D e^{\widetilde{D}s}, \qquad \widetilde{D} < 0. \tag{2.16}$$

This can be regarded as an other aspect of continuum limit since $\delta \to 0$ as $s \to \infty$. Assuming $\delta \xrightarrow{\mathrm{ud}} D$, $\tau \xrightarrow{\mathrm{ud}} T$, $\sigma \xrightarrow{\mathrm{ud}} S$, we obtain

$$TT_{lm} \nabla T_l T_m \ominus DS_l S_m,$$
 (2.17a)

$$SS_{lm} \nabla S_l S_m \ominus DT_l T_m.$$
 (2.17b)

We call the pair (2.17a), (2.17b) the ultradiscrete sine-Gordon equation (udsG). The vacuum solution T = S = 0 is the simplest solution, other than the null solution $T = S = -\infty$. We can also ultradiscretize (2.2) to obtain

$$W_{lm}W_m^{-1} \ominus W_lW^{-1} \oplus D\left(W_m^{-1}W^{-1} \ominus W_{lm}W_l\right) \nabla -\infty$$

$$(2.18)$$

where $w \xrightarrow{\mathrm{ud}} W \nabla TS^{-1}$. We also call (2.18) the ultradiscrete sine-Gordon equation. The ultradiscretization of (2.3) is unclear.

2.2.2 Deterministic time evolution and class of solutions

It seems sensible to restrict ourselves to the class of signed solutions, that is, $T, S, W \in \mathbb{C}^{\vee}$ for any $(l, m) \in \mathbb{Z}^2$ since it permits basic properties like weak substitution. The null and vacuum solutions are signed solutions.

The problem is that udsG no longer admits time evolution, at least deterministic one, in general, since the balance relation is not equality. For example, if we have

$$f(t+1) \nabla (\text{expression including } f(t)) = 3^{\bullet},$$

we cannot determine f(t+1) from f(t), since this relation is satisfied whenever $|f(t+1)|_{\oplus} \leq 3$. Strictly speaking, udsG is not an equation.

But in some cases, it actually becomes an equation, or furthermore, a deterministically evolutionary form. Multiplying T^{-1} to (2.17a) and S^{-1} to (2.17b), we have

$$T^{-1}TT_{lm} \nabla T^{-1} (T_l T_m \ominus DS_l S_m), \qquad S^{-1}SS_{lm} \nabla S^{-1} (S_l S_m \ominus DT_l T_m).$$

If $T^{-1}T = S^{-1}S = 0$ and the right hand sides are signed, we obtain

$$T_{lm} = T^{-1} \left(T_l T_m \ominus D S_l S_m \right), \tag{2.19a}$$

$$S_{lm} = S^{-1} \left(S_l S_m \ominus D T_l T_m \right) \tag{2.19b}$$

by reduction of balances (see Appendix A). We call (2.19a), (2.19b) the deterministically evolutionary form of udsG. If we replace D by $\ominus D$ and restrict ranges of D, T, S to \mathbb{R} for example, the assumptions are satisfied, and we obtain the completely ordinary-looking ultradiscrete equation:

$$T_{lm} = \max(T_l + T_m, D + S_l + S_m) - T, \tag{2.20a}$$

$$S_{lm} = \max(S_l + S_m, D + T_l + T_m) - S. \tag{2.20b}$$

Deterministic time evolution is also possible in other settings, which are presented in the following sections.

It might be natural to think we should consider (2.19a), (2.19b), or even (2.20a), (2.20b) only. However, it seems that the former cannot capture the traveling-wave, kink-antikink, and kink-kink solutions. And the latter does not even seem to contain soliton solutions. Therefore, we consider (2.17a), (2.17b) primarily.




Figure 2.6. Positive (\mathbb{R}) evolution of udsG.

We show one example of positive (\mathbb{R}) time evolution by (2.20a), (2.20b) in Fig. 2.6. Initial values are set as

$$T(l, -10) = l,$$
 $S(-10, m) = m,$ $-10 \le l, m \le 10$

with D=-1. The sign (in the sense of \pm) of the solution alternates with time.

2.2.3 1-soliton solution

Consider a signed solution T, S satisfying

$$T \nabla 0 \oplus F, \qquad S \nabla 0 \ominus F, \qquad F = CP^l Q^m,$$
 (2.21)

where $C \in \mathbb{uC}^{\vee}$ and $P, Q \in \mathbb{uR}^{\otimes}$. Weakly substituting these into (2.17a), (2.17b), we have

$$0 \oplus PQF^2 \oplus (0 \oplus PQ)F \nabla 0 \oplus PQF^2 \oplus (P \oplus Q)F, \tag{2.22a}$$

$$0 \oplus PQF^2 \ominus (0 \oplus PQ)F \nabla 0 \oplus PQF^2 \ominus (P \oplus Q)F, \tag{2.22b}$$

where $0 \oplus D = 0 \ominus D = 0$ is used. The dispersion relation

$$0 \oplus PQ \nabla P \oplus Q \tag{2.23}$$

is a sufficient condition for (2.22a), (2.22b) to hold, since we can construct them by adding and multiplying same numbers to the both sides of (2.23). Rewriting (2.23), we have

$$(P \ominus 0)Q \nabla (P \ominus 0)$$

and thus P = 0 or Q = 0. Obviously, (2.21) and (2.23) can be obtained by ultradiscretizing (2.8) and (2.9), respectively, through

$$c = \mu_C e^{\widetilde{C}s} \xrightarrow{\mathrm{ud}} C, \qquad p = \mu_P e^{\widetilde{P}s} \xrightarrow{\mathrm{ud}} P, \qquad q \xrightarrow{\mathrm{ud}} Q$$

or

$$c = \mu_C e^{\widetilde{C}s} \xrightarrow{\mathrm{ud}} C, \qquad p \xrightarrow{\mathrm{ud}} P, \qquad q = \mu_Q e^{\widetilde{Q}s} \xrightarrow{\mathrm{ud}} Q.$$

The solution is, however, not completely determined yet, because the balance relation is not equality as stated before. So we try to utilize reduction of balances. If $C \in \mathbb{Z}$ is an odd number and $P,Q \in \mathbb{Z}$ are even numbers, then F is always odd and $0 \oplus F$, $0 \ominus F$ can never be balanced since 0 is even. By reduction of balances, we obtain

$$T = 0 \oplus F$$
, $S = 0 \ominus F$,

and W is also immediately determined since S^{-1} is signed. This solution admits deterministic time evolution since

$$|T_l T_m|_{\oplus} > |DS_l S_m|_{\oplus}, \qquad |S_l S_m|_{\oplus} > |DT_l T_m|_{\oplus}$$

and thus

$$T^{-1}(T_l T_m \ominus DS_l S_m) = T^{-1} T_l T_m \in \mathbb{UR}^{\otimes},$$

$$S^{-1}(S_l S_m \ominus DT_l T_m) = S^{-1} S_l S_m \in \mathbb{UR}^{\otimes}.$$




Figure 2.7. Signs (left) and absolute values (right) of 1-soliton solution for udsG.

Fig. 2.7 shows the solution with

$$D=-1, \qquad C=\ominus 1, \qquad P=2$$

in the light-cone coordinates (2.11). It is somehow difficult to depict ultradiscrete numbers in figures; here signs and absolute values are displayed separately, and signs are mapped from $\oplus 0$, 0^{\bullet} , $\oplus 0$ to -1, 0, 1, respectively (balanced elements do not appear in the figure, though). Observe that the form of the 1-soliton solution w for dsG is preserved in the signs. Absolute values are always 0, corresponding to the fact that w asymptotically behaves as ± 1 .




Figure 2.8. Traveling-wave solution for udsG.

2.2.4 Traveling-wave solution

If we replace C by CI and redefine $F = CP^lQ^m$ ($C \in u\mathbb{R}^{\otimes}$), we obtain

$$T = 0 \oplus FI$$
, $S = 0 \ominus FI$

and

$$W \nabla \frac{\left(0 \ominus F^2\right) \oplus FI}{0 \oplus F^2}.$$

We choose odd C and even P, Q so that $0 \oplus F^2$ is always signed and reduction of balances can be applied. This solution no longer admits deterministic time evolution, but is apparently ultradiscretization of the traveling-wave solution (2.12) for dsG. Fig. 2.8 shows the solution with

$$D = -1,$$
 $C = 1,$ $P = 2.$

The uRe and uIm parts are displayed separately. The profile of the traveling-wave solution for dsG is preserved well.

2.2.5 2-soliton solution

Assume

$$T \nabla 0 \oplus F_1 \oplus F_2 \oplus AF_1F_2, \qquad S \nabla 0 \ominus F_1 \ominus F_2 \oplus AF_1F_2,$$
 (2.24)




Figure 2.9. 2-soliton solution for udsG.

where $A \in \mathbb{uR}^{\otimes}$ and $F_j = C_j P_j^l Q_j^m$. We also assume

$$P_1 \neq P_2, \qquad Q_1 \neq Q_2.$$

By substitution, we find the pair of the dispersion relation

$$0 \oplus P_j Q_j \nabla P_j \oplus Q_j$$

and the relation

$$A(0 \ominus P_1 P_2)(0 \ominus Q_1 Q_2) \oplus (P_1 \ominus P_2)(Q_1 \ominus Q_2) \nabla -\infty \tag{2.25}$$

is a sufficient condition for (2.24) to become a solution. Obviously, (2.25) is ultradiscretization of (2.10). When $P_1 = P_2 = 0$ or $Q_1 = Q_2 = 0$, any A satisfies (2.25). When $P_1 = Q_2 = 0$, we have

$$A(0 \ominus P_2)(0 \ominus Q_1) \oplus (0 \ominus P_2)(Q_1 \ominus 0) \nabla -\infty \implies A = 0.$$

The case $P_2 = Q_1 = 0$ is similar.

We can choose $A, C_j, P_j, Q_j \in \mathbb{Z}$ such that $0 \oplus AF_1F_2$ is always positive, even and $F_1 \oplus F_2$ is negative, odd. Then the solution is determined as

$$T = 0 \oplus F_1 \oplus F_2 \oplus AF_1F_2, \qquad S = 0 \ominus F_1 \ominus F_2 \oplus AF_1F_2.$$

This admits deterministic time evolution, of course. Fig. 2.9 shows the solution with

$$D = -1,$$
 $C_1 = C_2 = \ominus 1,$ $P_1 = Q_2 = 4.$

2.2.6 Kink-antikink and kink-kink solutions

If we replace C_1 by C_1I , C_2 by $\ominus C_2I$, and redefine $F_j = C_jP_j^lQ_j^m$ ($C_j \in u\mathbb{R}^{\otimes}$) in the 2-soliton solution, we obtain

$$T \nabla 0 \oplus AF_1F_2 \oplus (F_1 \ominus F_2) I$$
, $S \nabla 0 \oplus AF_1F_2 \ominus (F_1 \ominus F_2) I$

and

$$W \nabla \frac{\left((0 \oplus AF_1F_2)^2 \ominus (F_1 \ominus F_2)^2\right) \oplus (0 \oplus AF_1F_2)(F_1 \ominus F_2)I}{(0 \oplus AF_1F_2)^2 \oplus (F_1 \ominus F_2)^2}.$$

We choose $C_j, P_j, Q_j \in u\mathbb{Z}$ such that

$$|F_1|_{\oplus} \equiv 1, \qquad |F_2|_{\oplus} \equiv 3 \pmod{4}$$




Figure 2.10. Kink-antikink solution for udsG.

or

$$|F_1|_{\oplus} \equiv 3, \qquad |F_2|_{\oplus} \equiv 1 \pmod{4}.$$

Then $F_1 \ominus F_2$ and $(0 \oplus AF_1F_2)^2 \ominus (F_1 \ominus F_2)^2$ are always signed and the balance relations become equalities.

If we set $P_1 = Q_2$, $P_2 = Q_1$, we have the kink-antikink solution. Similarly, setting $P_1 = Q_2^{-1}$, $P_2 = Q_1^{-1}$ gives the kink-kink solution. These solutions does not admit deterministic time evolution, but are ultradiscretization of (2.14), (2.15). The ultradiscretization of the breather solution is unclear.

Fig. 2.10 shows the kink-antikink solution with

$$D = -1,$$




Figure 2.11. Kink-kink solution for udsG.

 $C_1 = 1,$ $C_2 = -1,$ $P_1 = Q_2 = 4,$

and Fig. 2.11 shows the kink-kink solution with

$$D = -1,$$
 $C_1 = \ominus 1,$ $C_2 = \ominus (-1),$ $P_1 = Q_2^{-1} = 4.$

Observe that in the uIm part, two waves approach to each other for t < 0, collide at t = 0, and move away from each other for t > 0. In the kink-antikink solution, the two waves have the same sign and bump up by collision. In the kink-kink solution, the two have opposite signs and reflect by collision.

3 Noncommutative discrete and ultradiscrete sine-Gordon equations

In this section, we propose a noncommutative discrete analogue of the sine-Gordon equation as a compatibility condition of a certain linear system. This equation reduces to the commutative version once the underlying algebra turns out to be commutative and one simple reduction condition is applied. A reduction from the noncommutative discrete KP equation [12, 17] also gives the equation, and continuum limit of the equation gives the noncommutative (continuous) sine-Gordon equation, which is already known in a different context [14]. We define the Darboux

transformation, which constructs new solutions from old ones, and obtain Casoratian-type solutions by repeating it. Explicitly setting the starting solutions for repetition, we derive so-called multisoliton solutions.

Along the construction of Casoratian-type solutions, quasideterminants [5] are used, which is a noncommutative extension of determinants. The theory needs some space for explanation, but it is not essential to the main story. Therefore, we only briefly explain the definition and some properties of them in Appendix B. For details, see [5].

We finally propose a noncommutative ultradiscrete analogue of the sine-Gordon equation. Noncommutative ultradiscrete setting is probably one of the hardest environments for integrable systems to exist, but we manage to obtain 1-soliton and 2-soliton solutions by ultradiscretization.

Notations are slightly changed in this section because of the complexity of expressions we are going to manipulate. Shifts are always indicated after a comma like $f_{,l}$. This is to distinguish indices and shifts. In addition, shift operators T_l , T_m are also used:

$$T_l f = f_{,l} = f(l+1,m), \qquad T_m f = f_{,m} = f(l,m+1).$$

Do not confuse these with the ultradiscretized τ function of the previous section; in the non-commutative setting, τ functions do not seem to exist. We also use superscripts for elements of matrices. For example,

$$w = (w^{\iota\kappa}) = \begin{pmatrix} w^{11} & \cdots & w^{1N} \\ \vdots & \ddots & \vdots \\ w^{N1} & \cdots & w^{NN} \end{pmatrix}.$$

3.1 Noncommutative discrete sine-Gordon equation

3.1.1 Linear system

Let w = w(l, m), v = v(l, m) be functions $\mathbb{Z}^2 \to \operatorname{Mat}(N, \mathbb{C})$ and

$$B_l = \begin{pmatrix} w_{,l}w^{-1} & -a\lambda \\ -a\lambda & v_{,l}v^{-1} \end{pmatrix}, \qquad B_m = \begin{pmatrix} 1 & -b\lambda^{-1}w_{,m}v^{-1} \\ -b\lambda^{-1}v_{,m}w^{-1} & 1 \end{pmatrix},$$

where $a, b, \lambda \in \mathbb{C}^{\times}$ are parameters. Consider the linear system

$$T_l\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_l\begin{pmatrix} \phi \\ \psi \end{pmatrix}, \qquad T_m\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_m\begin{pmatrix} \phi \\ \psi \end{pmatrix}$$
 (3.1)

for $\phi, \psi: \mathbb{Z}^2 \to \operatorname{Mat}(N, \mathbb{C})$. Denoting entrywise shift operations by $T_m B_l = B_{l,m}$ etc., we have

$$T_{m}T_{l}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_{l,m}T_{m}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_{l,m}B_{m}\begin{pmatrix} \phi \\ \psi \end{pmatrix},$$
$$T_{l}T_{m}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_{m,l}T_{l}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = B_{m,l}B_{l}\begin{pmatrix} \phi \\ \psi \end{pmatrix}.$$

These must coincide, so we require the compatibility condition

$$B_{l,m}B_m = B_{m,l}B_l$$
.

This is equivalent to

$$w_{,lm}w_{,m}^{-1} - w_{,l}w^{-1} + ab\left(v_{,m}w^{-1} - w_{,lm}v_{,l}^{-1}\right) = 0,$$
(3.2a)

$$v_{,lm}v_{,m}^{-1} - v_{,l}v^{-1} + ab\left(w_{,m}v^{-1} - v_{,lm}w_{,l}^{-1}\right) = 0.$$
(3.2b)

We call the pair (3.2a) and (3.2b) the noncommutative discrete sine-Gordon equation (ncdsG).

Proposition 3.1. When N=1, the reduction condition

$$wv = 1 (3.3)$$

gives the (commutative) discrete sine-Gordon equation [3, 7]

$$\frac{w_{,lm}}{w_{,m}} - \frac{w_{,l}}{w} + ab\left(\frac{1}{w_{,m}w} - w_{,lm}w_{,l}\right) = 0.$$
(3.4)

Proof. Under (3.3), (3.2a) is apparently equivalent to (3.4). Since

(l.h.s. of (3.2a))
$$\times \left(w_{,m}w - \frac{1}{w_{,lm}w_{,l}} \right) = w_{,lm}w + \frac{1}{w_{,lm}w} - w_{,l}w_{,m} - \frac{1}{w_{,lm}w_{,m}}$$

= (l.h.s. of (3.2b)) $\times \left(\frac{1}{w_{,m}w} - w_{,lm}w_{,l} \right)$,

(3.2b) is also equivalent to (3.4).

For any w_0 satisfying

$$abw_{0,\overline{l}m}=\frac{w_{0,l\overline{m}}}{ab},$$

(3.2a) and (3.2b) are solved by $(w, v) = (w_0, abw_{0,\bar{l}m})$, which is not an interesting solution. We consider other types of solutions in the rest of this section.

3.1.2 Reduction from the noncommutative discrete KP equation

Let $w_i = w_i(n_1, n_2, n_3)$ (i = 1, 2, 3) be functions $\mathbb{Z}^3 \to \operatorname{Mat}(N, \mathbb{C})$. The noncommutative discrete KP equation [12, 17] is the set of equations

$$w_{i,j}(c_i - c_j)w_i^{-1} + w_{j,k}(c_j - c_k)w_j^{-1} + w_{k,i}(c_k - c_i)w_k^{-1} = 0$$
(3.5)

for any combination of $i, j, k \in \{1, 2, 3\}$. Here i, j, k can take same values, and shifts are denoted like

$$w_{1,2} = w_1(n_1, n_2 + 1, n_3).$$

 $c_i \in \mathbb{C}^{\times}$ are parameters taking mutually different values.

We replace (n_1, n_2, n_3) by new coordinates $(n'_1, n'_2, n'_3) = (n_1 - n_3, n_2, n_3)$. Shifts are also in new coordinates, and double-shifts are to be used:

$$w_{1,2} = w_1(n'_1, n'_2 + 1, n'_3), \qquad w_{2,13} = w_2(n'_1 + 1, n'_2, n'_3 + 1),$$
 etc.

Then, setting

$$\delta = \frac{c_1 - c_3}{c_1 - c_2},$$

we can rewrite (3.5) as

$$w_{1,2}w_1^{-1} + (\delta - 1)w_{2,13}w_2^{-1} - \delta w_{3,1}w_3^{-1} = 0,$$

$$w_{1,2}w_1^{-1} = w_{2,1}w_2^{-1}, \qquad w_{2,13}w_2^{-1} = w_{3,2}w_3^{-1}, \qquad w_{3,1}w_3^{-1} = w_{1,13}w_1^{-1}.$$

By imposing the reduction condition

$$w_i(n'_1+2, n'_2, n'_3) = w_i(n'_1, n'_2, n'_3)$$

and defining $v_i = w_{i,1}$, we obtain

$$w_{1,2}w_1^{-1} + (\delta - 1)v_{2,3}w_2^{-1} - \delta v_3 w_3^{-1} = 0, (3.6a)$$

$$v_{1,2}v_1^{-1} + (\delta - 1)w_{2,3}v_2^{-1} - \delta w_3 v_3^{-1} = 0, (3.6b)$$

$$w_{1,2}w_1^{-1} = v_2w_2^{-1},$$
 (3.6c)

$$v_{2,3}w_2^{-1} = w_{3,2}w_3^{-1}, (3.6d)$$

$$v_3 w_2^{-1} = v_{1,3} w_1^{-1},$$
 (3.6e)

$$v_{1,2}v_1^{-1} = w_2v_2^{-1}, (3.6f)$$

$$w_{2,3}v_2^{-1} = v_{3,2}v_3^{-1}, (3.6g)$$

$$w_3 v_3^{-1} = w_{1,3} v_1^{-1}.$$
 (3.6h)

Proposition 3.2. For any w_1 , v_1 satisfying (3.6a)–(3.6h),

$$(w, v) = (w_1, v_1)$$
 $(l = n'_2, m = n'_3)$

solves (3.2a) and (3.2b) with $ab = \delta$.

Proof. Let us rewrite (3.6a) using only w_1 , v_1 . From (3.6e) we immediately have

$$w_{1,2}w_1^{-1} + (\delta - 1)v_{2,3}w_2^{-1} - \delta v_{1,3}w_1^{-1} = 0, (3.7)$$

and thus try to rewrite the second term.

(3.6d) implies

$$(\delta - 1)v_{2,3}w_2^{-1} = (\delta - 1)w_{3,2}w_3^{-1} = w_{3,2}v_{3,2}^{-1} \cdot (\delta - 1)v_{3,2}v_3^{-1} \cdot v_3w_3^{-1}.$$

$$(3.8)$$

Then, (3.6h) implies

$$w_{3,2}v_{3,2}^{-1} = w_{1,23}v_{1,2}^{-1}, v_3w_3^{-1} = v_1w_{1,3}^{-1},$$
 (3.9)

and (3.6g) implies

$$(\delta - 1)v_{3,2}v_3^{-1} = (\delta - 1)w_{2,3}v_2^{-1}.$$

By (3.6b) and (3.6h), this equation becomes

$$(\delta - 1)w_{2,3}v_2^{-1} = \delta w_3 v_3^{-1} - v_{1,2}v_1^{-1} = \delta w_{1,3}v_1^{-1} - v_{1,2}v_1^{-1}.$$
(3.10)

Combining (3.8)–(3.10), we obtain

$$(\delta-1)v_{2,3}w_2^{-1} = w_{1,23}v_{1,2}^{-1} \cdot \left(\delta w_{1,3}v_1^{-1} - v_{1,2}v_1^{-1}\right) \cdot v_1w_{1,3}^{-1} = \delta w_{1,23}v_{1,2}^{-1} - w_{1,23}w_{1,3}^{-1}.$$

Finally, (3.7) becomes

$$w_{1,2}w_1^{-1} - w_{1,23}w_{1,3}^{-1} + \delta(w_{1,23}v_{1,2}^{-1} - v_{1,3}w_1^{-1}) = 0. (3.11a)$$

In the same way, (3.6b) becomes

$$v_{1,2}v_1^{-1} - v_{1,23}v_{1,3}^{-1} + \delta(v_{1,23}w_{1,2}^{-1} - w_{1,3}v_1^{-1}) = 0.$$
(3.11b)

If we set

$$(w, v) = (w_1, v_1), \qquad (l, m) = (n'_2, n'_3), \qquad ab = \delta$$

we have

$$w_{1,2} = w_{.l}, w_{1,23} = w_{.lm}, \text{etc.}$$

Therefore, (3.11a) and (3.11b) become (3.2a) and (3.2b).

Remark 3.3. The solution constructed here seems to be only a part of the whole solutions of (3.2a) and (3.2b), since it satisfies extra conditions

$$w_{1,2}w_1^{-1} \cdot v_{1,2}v_1^{-1} = 1, \qquad v_{1,3}w_1^{-1} \cdot w_{1,3}v_1^{-1} = 1.$$

3.1.3 Continuum limit

Assume w is also a function w(x,t) of continuum variables $x,t\in\mathbb{R}$ and has an expansion

$$w(x+r,t+s) = w + (rw_x + sw_t) + \frac{1}{2} (r^2 w_{xx} + 2rsw_{xt} + s^2 w_{tt}) + \cdots,$$

where $w_x = \partial w/\partial x$, etc. Connect l, m to x, t via the Miwa transformation

$$w(x,t;l,m) = w(x+la,t+mb).$$

Assume similarly for v = v(x, t; l, m). Then we have

$$w_{,l} = w + aw_x + \frac{a^2}{2}w_{xx} + \cdots,$$

$$w_{,lm} = w + (aw_x + bw_t) + \frac{1}{2} \left(a^2 w_{xx} + 2abw_{xt} + b^2 w_{tt} \right) + \cdots,$$

$$w_{,m}^{-1} = w^{-1} - bw^{-1} w_t w^{-1} - \frac{b^2}{2} \left(w^{-1} w_{tt} w^{-1} - 2w^{-1} w_t w^{-1} w_t w^{-1} \right) + \cdots,$$

$$v_{,l} = \cdots,$$

and from (3.2a), (3.2b)

$$0 = w_{,lm}w_{,m}^{-1} - w_{,l}w^{-1} + ab(v_{,m}w^{-1} - w_{,lm}v_{,l}^{-1})$$

$$= ab(w_{xt}w^{-1} - w_{x}w^{-1}w_{t}w^{-1} + vw^{-1} - wv^{-1}) + (\text{higher-order terms}),$$

$$0 = ab(v_{xt}v^{-1} - v_{x}v^{-1}v_{t}v^{-1} + wv^{-1} - vw^{-1}) + (\text{higher-order terms}).$$

Taking the limit $a, b \to 0$ successively, we obtain

$$w_{xt}w^{-1} - w_xw^{-1}w_tw^{-1} + vw^{-1} - wv^{-1} = 0,$$

$$v_{xt}v^{-1} - v_xv^{-1}v_tv^{-1} + wv^{-1} - vw^{-1} = 0.$$

Since $-w^{-1}w_tw^{-1}=(w^{-1})_t$, these are transformed into

$$(w_x w^{-1})_t = w v^{-1} - v w^{-1}, (3.12a)$$

$$(w_x w^{-1} + v_x v^{-1})_t = 0. (3.12b)$$

We call the pair (3.12a) and (3.12b) the noncommutative sine-Gordon equation. A quite similar equation with the same name has been derived in a different context [14, (3.10)].

Proposition 3.4. When N = 1, the reduction condition

$$wv = 1 (3.13)$$

gives the (commutative) sine-Gordon equation

$$u_{xt} = 4\sin u,\tag{3.14}$$

where u is defined by

$$u = \frac{2}{i} \log w.$$

Proof. Under (3.13), (3.12b) clearly holds. And (3.14) is immediate from (3.12a) since

$$u_{xt} = \frac{2}{i} \frac{w_{xt}w - w_x w_t}{w^2}, \qquad \sin u = \frac{w^2 - w^{-2}}{2i}.$$

3.1.4 Darboux transformation

When (w, v) is a solution for (3.2a) and (3.2b), the column vector $(\phi \psi)$ satisfying the linear system (3.1) is called the eigenfunction of (w, v) for eigenvalue λ .

Let ${}^t(\phi_{\lambda} \psi_{\lambda})$, ${}^t(\phi_{\mu} \psi_{\mu})$ be eigenfunctions of (w, v) for eigenvalues λ , μ , respectively. Define the Darboux transformation of (w, v) and ${}^t(\phi_{\lambda} \psi_{\lambda})$ by ${}^t(\phi_{\mu} \psi_{\mu})$ as

$$\widetilde{w} = \psi_{\mu} \phi_{\mu}^{-1} w, \qquad \widetilde{v} = \phi_{\mu} \psi_{\mu}^{-1} v, \qquad \begin{pmatrix} \widetilde{\phi}_{\lambda} \\ \widetilde{\psi}_{\lambda} \end{pmatrix} = K \begin{pmatrix} \phi_{\lambda} \\ \psi_{\lambda} \end{pmatrix}$$

where

$$K = \begin{pmatrix} -\mu \psi_\mu \phi_\mu^{-1} & \lambda \\ \lambda & -\mu \phi_\mu \psi_\mu^{-1} \end{pmatrix}.$$

Theorem 3.5. $(\widetilde{w}, \widetilde{v})$ is a solution to (3.2a) and (3.2b), and $(\widetilde{\phi}_{\lambda}, \widetilde{\psi}_{\lambda})$ is an eigenfunction of $(\widetilde{w}, \widetilde{v})$ for eigenvalue λ .

Proof. From the linear system (3.1), we can write

$$\begin{split} w_{,l}w^{-1} &= (\phi_{\mu,l} + a\mu\psi_{\mu})\phi_{\mu}^{-1}, & v_{,l}v^{-1} &= (\psi_{\mu,l} + a\mu\phi_{\mu})\psi_{\mu}^{-1}, \\ w_{,m}v^{-1} &= b^{-1}\mu(\phi_{\mu} - \phi_{\mu,m})\psi_{\mu}^{-1}, & v_{,m}w^{-1} &= b^{-1}\mu(\psi_{\mu} - \psi_{\mu,m})\phi_{\mu}^{-1}. \end{split}$$

Then we have

$$\begin{split} \widetilde{w}_{,l}\widetilde{w}^{-1} &= \psi_{\mu,l} \big(\psi_{\mu}^{-1} + a\mu \phi_{\mu,l}^{-1} \big) = v_{,l}v^{-1} + a\mu \big(\psi_{\mu,l} \phi_{\mu,l}^{-1} - \phi_{\mu} \psi_{\mu}^{-1} \big), \\ \widetilde{v}_{,l}\widetilde{v}^{-1} &= \phi_{\mu,l} \big(\phi_{\mu}^{-1} + a\mu \psi_{\mu,l} \big) = w_{,l}w^{-1} + a\mu \big(\phi_{\mu,l} \psi_{\mu,l}^{-1} - \psi_{\mu} \phi_{\mu}^{-1} \big), \\ \widetilde{w}_{,m}\widetilde{v}^{-1} &= b^{-1}\mu \psi_{\mu,m} \big(\phi_{\mu,m}^{-1} - \phi_{\mu}^{-1} \big) = v_{m}w^{-1} + b^{-1}\mu \big(\psi_{\mu,m} \phi_{\mu,m}^{-1} - \psi_{\mu} \phi_{\mu}^{-1} \big), \\ \widetilde{v}_{,m}\widetilde{w}^{-1} &= b^{-1}\mu \phi_{\mu,m} \big(\psi_{\mu,m}^{-1} - \psi_{\mu}^{-1} \big) = w_{,m}v^{-1} + b^{-1}\mu \big(\phi_{\mu,m} \psi_{\mu,m}^{-1} - \phi_{\mu} \psi_{\mu} \big), \end{split}$$

which imply

$$(\widetilde{w}_{,l}\widetilde{w}^{-1})_{,m} - \widetilde{w}_{,l}\widetilde{w}^{-1} + ab(\widetilde{v}_{,m}\widetilde{w}^{-1} - (\widetilde{w}_{,m}\widetilde{v}^{-1})_{,l}) = 0,$$

$$(\widetilde{v}_{,l}\widetilde{v}^{-1})_{,m} - \widetilde{v}_{,l}\widetilde{v}^{-1} + ab(\widetilde{w}_{,m}\widetilde{v}^{-1} - (\widetilde{v}_{,m}\widetilde{w}^{-1})_{,l}) = 0.$$

Define \widetilde{B}_l , \widetilde{B}_m by

$$\widetilde{B}_{l} = \begin{pmatrix} \widetilde{w}_{,l}\widetilde{w}^{-1} & -a\lambda \\ -a\lambda & \widetilde{v}_{,l}\widetilde{v}^{-1} \end{pmatrix}, \qquad \widetilde{B}_{m} = \begin{pmatrix} 1 & -b\lambda^{-1}\widetilde{w}_{,m}\widetilde{v}^{-1} \\ -b\lambda^{-1}\widetilde{v}_{,m}\widetilde{w}^{-1} & 1 \end{pmatrix}.$$

Then we have

$$K_{l}B_{l} = \widetilde{B}_{l}K, \qquad K_{m}B_{m} = \widetilde{B}_{m}K$$

and thus

$$T_{l}\left(K\begin{pmatrix}\phi\\\psi\end{pmatrix}\right) = K_{,l}B_{l}\begin{pmatrix}\phi\\\psi\end{pmatrix} = \widetilde{B}_{l}\left(K\begin{pmatrix}\phi\\\psi\end{pmatrix}\right),$$

$$T_{m}\left(K\begin{pmatrix}\phi\\\psi\end{pmatrix}\right) = K_{,m}B_{m}\begin{pmatrix}\phi\\\psi\end{pmatrix} = \widetilde{B}_{m}\left(K\begin{pmatrix}\phi\\\psi\end{pmatrix}\right).$$

3.1.5 Multisoliton solutions

The simplest solution for (3.2a) and (3.2b) is the vacuum solution (w, v) = (1, 1). The linear system (3.1) of the vacuum solution is

$$T_{l}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = \begin{pmatrix} 1 & -a\lambda \\ -a\lambda & 1 \end{pmatrix} \begin{pmatrix} \phi \\ \psi \end{pmatrix}, \qquad T_{m}\begin{pmatrix} \phi \\ \psi \end{pmatrix} = \begin{pmatrix} 1 & -b\lambda^{-1} \\ -b\lambda^{-1} & 1 \end{pmatrix} \begin{pmatrix} \phi \\ \psi \end{pmatrix},$$

which has two basic solutions

$$\begin{pmatrix} \phi \\ \psi \end{pmatrix} = \begin{pmatrix} (1-a\lambda)^l \left(1-b\lambda^{-1}\right)^m \\ (1-a\lambda)^l \left(1-b\lambda^{-1}\right)^m \end{pmatrix}, \begin{pmatrix} (1+a\lambda)^l \left(1+b\lambda^{-1}\right)^m \\ -(1+a\lambda)^l \left(1+b\lambda^{-1}\right)^m \end{pmatrix}.$$

Let λ_k (k = 1, 2, ...) be mutually different eigenvalues and define

$$\phi_k = (1 - a\lambda_k)^l (1 - b\lambda_k^{-1})^m + (1 + a\lambda_k)^l (1 + b\lambda_k^{-1})^m c_k,$$

$$\psi_k = (1 - a\lambda_k)^l (1 - b\lambda_k^{-1})^m - (1 + a\lambda_k)^l (1 + b\lambda_k^{-1})^m c_k,$$




Figure 3.1. 1-soliton solution for ncdsG.

where $c_k \in \operatorname{Mat}(N,\mathbb{C})$ are parameters introducing noncommutativity. ${}^t(\phi_k \ \psi_k)$ is of course an eigenfunction of the vacuum solution for eigenvalue λ_k . Repeating the Darboux transformation by ${}^t(\phi_k \ \psi_k)$, we can construct multisoliton solutions.

A 1-soliton solution is given by

$$w = \psi_1 \phi_1^{-1} = (1 - f_1)(1 + f_1)^{-1}, \tag{3.15a}$$

$$v = \phi_1 \psi_1^{-1} = (1 + f_1)(1 - f_1)^{-1}, \tag{3.15b}$$

where f_k is defined by

$$f_k = \left(\frac{1 + a\lambda_k}{1 - a\lambda_k}\right)^l \left(\frac{1 + b\lambda_k^{-1}}{1 - b\lambda_k^{-1}}\right)^m c_k.$$

As a concrete example, Fig. 3.1 shows the behavior of

$$w = \begin{pmatrix} w^{11} & w^{12} \\ w^{21} & w^{22} \end{pmatrix} \qquad (N = 2)$$

with

$$a = b = 0.2,$$
 $c_1 = \begin{pmatrix} 2 & -4 \\ 1 & -1.5 \end{pmatrix},$ $\lambda_1 = \frac{5}{3}$

in the light-cone coordinates (2.11).

A 2-soliton solution is given by

$$w = (\lambda_2 \phi_2 - \lambda_1 \phi_1 \psi_1^{-1} \psi_2) (\lambda_2 \psi_2 - \lambda_1 \psi_1 \phi_1^{-1} \phi_2)^{-1} \psi_1 \phi_1^{-1}$$

$$= (\lambda_2 \phi_2 \psi_2^{-1} - \lambda_1 \phi_1 \psi_1^{-1}) (\lambda_2 \phi_1 \psi_1^{-1} - \lambda_1 \phi_2 \psi_2^{-1})^{-1}$$

$$= (\lambda_2 (1 + f_2)(1 - f_2)^{-1} - \lambda_1 (1 + f_1)(1 - f_1)^{-1})$$

$$\times (\lambda_2 (1 + f_1)(1 - f_1)^{-1} - \lambda_1 (1 + f_2)(1 - f_2)^{-1})^{-1},$$

$$v = (\lambda_2 (1 - f_2)(1 + f_2)^{-1} - \lambda_1 (1 - f_1)(1 + f_1)^{-1})$$
(3.16a)




Figure 3.2. 2-soliton solution for ncdsG.

$$\times \left(\lambda_2(1-f_1)(1+f_1)^{-1} - \lambda_1(1-f_2)(1+f_2)^{-1}\right)^{-1}.$$
 (3.16b)

Fig. 3.2 shows the solution with

$$a = b = 0.2,$$
 $c_1 = \begin{pmatrix} 2.5 & -0.8 \\ 2 & 1.8 \end{pmatrix},$ $c_2 = \begin{pmatrix} 1.5 & 1.2 \\ -1 & 0.5 \end{pmatrix},$ $\lambda_1 = \lambda_2^{-1} = \frac{5}{3}.$

3.1.6 Casoratian-type solutions

Let (w, v) be a solution for (3.2a) and (3.2b), ${}^t(\phi_k \psi_k)$ be eigenfunctions of (w, v) for eigenvalues λ_k (k = 1, 2, ...), where λ_k are mutually different. Define repetition of the Darboux transformation by

$$w^{(n)} = \psi_n^{(n)} (\phi_n^{(n)})^{-1} w^{(n-1)},$$

$$v^{(n)} = \phi_n^{(n)} (\psi_n^{(n)})^{-1} v^{(n-1)},$$

$$\phi_k^{(n+1)} = \lambda_k \psi_k^{(n)} - \lambda_n \psi_n^{(n)} (\phi_n^{(n)})^{-1} \phi_k^{(n)},$$

$$\psi_k^{(n+1)} = \lambda_k \phi_k^{(n)} - \lambda_n \phi_n^{(n)} (\psi_n^{(n)})^{-1} \psi_k^{(n)},$$

and

$$w^{(0)} = w,$$
 $v^{(0)} = v,$ $\phi_k^{(1)} = \phi_k,$ $\psi_k^{(1)} = \psi_k.$

For notational convenience, we introduce reduced shift operator T defined by

$$Tf(\phi_1, \psi_1, \phi_2, \psi_2, \ldots) = f(\lambda_1 \psi_1, \lambda_1 \phi_1, \lambda_2 \psi_2, \lambda_2 \phi_2, \ldots),$$

where $f(x_1, x_2,...)$ is any rational function of noncommutative variables x_j . For example, we have

$$T\phi_k = \lambda_k \psi_k, \qquad T\psi_k = \lambda_k \phi_k, \qquad T^2 \phi_k = \lambda_k^2 \phi_k.$$

Lemma 3.6.

$$T\phi_k^{(n+1)} = \lambda_k \psi_k^{(n+1)}, \qquad T\psi_k^{(n+1)} = \lambda_k \phi_k^{(n+1)}.$$

Proof. We prove by induction. Obviously, $\phi_k^{(n+1)}$, $\psi_k^{(n+1)}$ are rational functions of ϕ_j , ψ_j . Assume $T\phi_k^{(n)} = \lambda_k \psi_k^{(n)}$, $T\psi_k^{(n)} = \lambda_k \phi_k^{(n)}$ for certain n. Then,

$$T\phi_k^{(n+1)} = \lambda_k \left(\lambda_k \phi_k^{(n)}\right) - \lambda_n \left(\lambda_n \phi_n^{(n)}\right) \left(\lambda_n \psi_n^{(n)}\right)^{-1} \lambda_k \psi_k^{(n)} = \lambda_k \psi_k^{(n+1)}.$$

Similarly,
$$T\psi_k^{(n+1)} = \lambda_k \phi_k^{(n+1)}$$
.

Theorem 3.7.

$$w^{(n)} = \prod_{j=1}^{n} \left(-\lambda_{j}^{-1} \right) \cdot \begin{vmatrix} \phi_{1} & \phi_{2} & \cdots & \phi_{n} & 1 \\ T\phi_{1} & T\phi_{2} & \cdots & T\phi_{n} & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_{1} & T^{n-1}\phi_{2} & \cdots & T^{n-1}\phi_{n} & 0 \\ T^{n}\phi_{1} & T^{n}\phi_{2} & \cdots & T^{n}\phi_{n} & 0 \end{vmatrix} w, \tag{3.17a}$$

$$v^{(n)} = \prod_{j=1}^{n} \left(-\lambda_j^{-1} \right) \cdot \begin{vmatrix} \psi_1 & \psi_2 & \cdots & \psi_n & 1 \\ T\psi_1 & T\psi_2 & \cdots & T\psi_n & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\psi_1 & T^{n-1}\psi_2 & \cdots & T^{n-1}\psi_n & 0 \\ T^n\psi_1 & T^n\psi_2 & \cdots & T^n\psi_n & 0 \end{vmatrix} v, \tag{3.17b}$$

eigenem 3.7.
$$w^{(n)} = \prod_{j=1}^{n} (-\lambda_{j}^{-1}) \cdot \begin{vmatrix} \phi_{1} & \phi_{2} & \cdots & \phi_{n} & 1 \\ T\phi_{1} & T\phi_{2} & \cdots & T\phi_{n} & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_{1} & T^{n-1}\phi_{2} & \cdots & T^{n-1}\phi_{n} & 0 \\ T^{n}\phi_{1} & T^{n}\phi_{2} & \cdots & T^{n}\phi_{n} & 0 \end{vmatrix}$$

$$\psi_{k}^{(n+1)} = \begin{vmatrix} \psi_{1} & \psi_{2} & \cdots & \psi_{n} & \psi_{k} \\ T\psi_{1} & T\psi_{2} & \cdots & T\psi_{n} & T\psi_{k} \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\psi_{1} & T^{n}\psi_{2} & \cdots & T^{n-1}\psi_{n} & T^{n-1}\psi_{k} \\ T\psi_{1} & T\psi_{2} & \cdots & T^{n-1}\psi_{n} & T^{n-1}\psi_{k} \\ T^{n}\psi_{1} & T^{n}\psi_{2} & \cdots & T^{n}\psi_{n} & T^{n}\psi_{k} \end{vmatrix} .$$

$$(3.17a)$$

$$\psi_k^{(n+1)} = \begin{vmatrix} \psi_1 & \psi_2 & \cdots & \psi_n & \psi_k \\ T\psi_1 & T\psi_2 & \cdots & T\psi_n & T\psi_k \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\psi_1 & T^{n-1}\psi_2 & \cdots & T^{n-1}\psi_n & T^{n-1}\psi_k \\ T^n\psi_1 & T^n\psi_2 & \cdots & T^n\psi_n & \boxed{T^n\psi_k} \end{vmatrix}.$$
(3.17d)

Here, quasideterminants [5] are used (see Appendix B). When n = 0, (3.17a) and (3.17b) read $w^{(0)} = 1 \cdot | \boxed{1} | w, \qquad v^{(0)} = 1 \cdot | \boxed{1} | v,$

respectively.

Before proceeding to the proof, we prepare the following lemma.

Lemma 3.8. Let $C = (c_{ij}), C' = (c'_{ij})$ be $n \times n$ matrices where $c_{ij}, c'_{ij} \in \operatorname{Mat}(N, \mathbb{C})$. Assume $c_{ij} = c'_{ij}$ for $1 \le i \le n$, $1 \le j \le n-1$. Then,

$$|C|_{p_1 n}^{-1}|C'|_{p_1 n} = |C|_{p_2 n}^{-1}|C'|_{p_2 n}. (3.18)$$

Proof. By the column homological relation (Proposition B.3), we have

$$|C^{p_2n}|_{p_1j}^{-1}|C|_{p_1n} = -|C^{p_1n}|_{p_2j}|C|_{p_2n}, (3.19a)$$

$$|C'^{p_2n}|_{p_1j}^{-1}|C'|_{p_1n} = -|C'^{p_1n}|_{p_2j}|C'|_{p_2n}.$$
(3.19b)

By the assumption, we have $C^{p_2n} = C'^{p_2n}$, $C^{p_1n} = C'^{p_1n}$. Therefore, we obtain (3.18) by multiplying the inverse of (3.19a) to (3.19b) from the left.

Proof of Theorem 3.7. We prove by induction. The case n = 0 is trivial.

Assume $w^{(n-1)}, v^{(n-1)}, \phi_k^{(n)}, \psi_k^{(n)}$ have the above expressions for certain n > 0. Then,

$$w^{(n)} = \lambda_n^{-1} \left(T \phi_n^{(n)} \right) \left(\phi_n^{(n)} \right)^{-1} w^{(n-1)}$$

$$= -\prod_{j=1}^n \left(-\lambda_j^{-1} \right) \cdot \begin{vmatrix} T \phi_1 & \cdots & T \phi_n \\ \vdots & \ddots & \vdots \\ T^n \phi_1 & \cdots & T^n \phi_n \end{vmatrix} \begin{vmatrix} \phi_1 & \cdots & \phi_n \\ \vdots & \ddots & \vdots \\ T^{n-1} \phi_1 & \cdots & T^{n-1} \phi_n \end{vmatrix}^{-1}$$

$$\times \begin{vmatrix} \phi_1 & \cdots & \phi_{n-1} & 1 \\ T \phi_1 & \cdots & T \phi_{n-1} & 0 \\ \vdots & \ddots & \vdots & \vdots \\ T^{n-1} \phi_1 & \cdots & T^{n-1} \phi_{n-1} & 0 \end{vmatrix} w.$$

By Lemma 3.8, we obtain

$$\begin{vmatrix} \phi_{1} & \cdots & \phi_{n} \\ \vdots & \ddots & \vdots \\ T^{n-1}\phi_{1} & \cdots & T^{n-1}\phi_{n} \end{vmatrix}^{-1} \begin{vmatrix} \phi_{1} & \cdots & \phi_{n-1} & 1 \\ T\phi_{1} & \cdots & T\phi_{n-1} & 0 \\ \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_{1} & \cdots & T^{n-1}\phi_{n-1} & 0 \end{vmatrix}$$

$$= \begin{vmatrix} \phi_{1} & \cdots & \phi_{n} \\ \vdots & \ddots & \vdots \\ T^{n-1}\phi_{1} & \cdots & T^{n-1}\phi_{n} \end{vmatrix}^{-1} \begin{vmatrix} \phi_{1} & \cdots & \phi_{n-1} & 1 \\ T\phi_{1} & \cdots & T\phi_{n-1} & 0 \\ \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_{1} & \cdots & T^{n-1}\phi_{n-1} & 0 \end{vmatrix}.$$

We define an $(n-1) \times (n-1)$ matrix A_0 by

$$A_0 = \begin{pmatrix} T\phi_1 & \cdots & T\phi_{n-1} \\ \vdots & \ddots & \vdots \\ T^{n-1}\phi_1 & \cdots & T^{n-1}\phi_{n-1} \end{pmatrix}.$$

With A_0 , the above quasideterminants are rewritten as

and also, we have a trivial identity

$$0 = \begin{vmatrix} A_0 & & 0 \\ & A_0 & & \vdots \\ & & 0 \\ T^n \phi_1 & \cdots & T^n \phi_{n-1} & \boxed{0} \end{vmatrix}.$$

By the invariance under row and column permutations (Proposition B.2) and Sylvester's identity (Proposition B.4), we can combine these four quasideterminants into one to obtain

$$w^{(n)} = \prod_{j=1}^{n} \left(-\lambda_j^{-1} \right) \cdot \begin{vmatrix} \phi_1 & \cdots & \phi_{n-1} & \phi_n & 1 \\ & & & T\phi_n & 0 \\ & A_0 & & \vdots & \vdots \\ & & & T^{n-1}\phi_n & 0 \\ & & & & T^n\phi_{n-1} & T^n\phi_n & 0 \end{vmatrix} w.$$

Similarly for $v^{(n)}$.

For $\phi_k^{(n+1)}$, we have

$$\begin{split} \phi_k^{(n+1)} &= T\phi_k^{(n)} - \left(T\phi_n^{(n)}\right) \left(\phi_n^{(n)}\right)^{-1}\phi_k^{(n)} \\ &= \begin{vmatrix} T\phi_1 & \cdots & T\phi_{n-1} & T\phi_k \\ \vdots & \ddots & \vdots & \vdots \\ T^n\phi_1 & \cdots & T^n\phi_{n-1} & T^n\phi_k \end{vmatrix} - \begin{vmatrix} T\phi_1 & \cdots & T\phi_{n-1} & T\phi_n \\ \vdots & \ddots & \vdots & \vdots \\ T^n\phi_1 & \cdots & T^n\phi_{n-1} & T^n\phi_n \end{vmatrix}^{-1} \\ &\times \begin{vmatrix} \phi_1 & \cdots & \phi_{n-1} & \phi_n \\ T\phi_1 & \cdots & T\phi_{n-1} & T\phi_n \\ \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_1 & \cdots & T^{n-1}\phi_{n-1} & T^{n-1}\phi_n \end{vmatrix} \\ &\times \begin{vmatrix} \phi_1 & \cdots & \phi_{n-1} & \phi_k \\ T\phi_1 & \cdots & T\phi_{n-1} & T\phi_k \\ \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_1 & \cdots & T^{n-1}\phi_{n-1} & T^{n-1}\phi_k \end{vmatrix} \\ &\times \begin{vmatrix} \vdots & \ddots & \vdots & \vdots \\ T^{n-1}\phi_1 & \cdots & T^{n-1}\phi_{n-1} & T^{n-1}\phi_k \end{vmatrix} \end{split}$$

With the same technique for $w^{(n)}$, we obtain

$$\phi_k^{(n+1)} = \begin{vmatrix} \phi_1 & \cdots & \phi_n & \phi_k \\ \vdots & \ddots & \vdots & \vdots \\ T^n \phi_1 & \cdots & T^n \phi_n & \boxed{T^n \phi_k} \end{vmatrix}.$$

Similarly for $\psi_k^{(n+1)}$.

3.2 Noncommutative ultradiscrete sine-Gordon equation

3.2.1 Ultradiscretization

We perform ultradiscretization of ncdsG by the parametrization

$$a = \mu_A e^{\widetilde{A}s}, \qquad b = \mu_B e^{\widetilde{A}s}, \qquad \widetilde{A}, \widetilde{B} < 0.$$

Assuming

$$a \xrightarrow{\operatorname{ud}} A$$
, $b \xrightarrow{\operatorname{ud}} B$, $w \xrightarrow{\operatorname{ud}} W$, $v \xrightarrow{\operatorname{ud}} V$,

we obtain

$$W_{,lm}W_{,m}^{-1} \ominus W_{,l}W^{-1} \oplus AB(V_{,m}W^{-1} \ominus W_{,lm}V_{,l}^{-1}) \nabla -\infty, \tag{3.20a}$$

$$V_{,lm}V_{,m}^{-1} \ominus V_{,l}V^{-1} \oplus AB(W_{,m}V^{-1} \ominus V_{,lm}W_{,l}^{-1}) \nabla -\infty.$$

$$(3.20b)$$

We call the pair (3.20a) and (3.20b) the noncommutative ultradiscrete sine-Gordon equation (ncudsG). Because $\mathrm{uMat}(N,\mathrm{u}\mathbb{C})$ can be realized by $\mathrm{uMat}(2N,\mathrm{u}\mathbb{R})$, we use $\mathrm{uMat}(N,\mathrm{u}\mathbb{R})$ as the underlying algebra for simplicity.

3.2.2 1-soliton solution

In order to ultradiscretize solutions for ncdsG, we introduce

$$p_j = \frac{1 + a\lambda_j}{1 - a\lambda_j}, \qquad q_j = \frac{1 + b\lambda_j^{-1}}{1 - b\lambda_j^{-1}}.$$
 (3.21)

These solve the dispersion relation

$$(1 - ab)(1 + p_i q_i) = (1 + ab)(p_i + q_i), \tag{3.22}$$

and any solution of (3.22) is parametrized by λ_j through (3.21) unless ab = 1. As in the commutative case, (3.22) is ultradiscretized to

$$0 \oplus P_i Q_i \nabla P_i \oplus Q_i, \tag{3.23}$$

where $p_j \xrightarrow{\text{ud}} P_j$, $q_j \xrightarrow{\text{ud}} Q_j$.

We can directly discretize the 1-soliton solution (3.15a), (3.15b) to obtain

$$w \xrightarrow{\mathrm{ud}} W \nabla (0 \oplus F_1)(0 \oplus F_1)^{-1}, \qquad v \xrightarrow{\mathrm{ud}} V \nabla (0 \oplus F_1)(0 \oplus F_1)^{-1},$$

where

Define

$$F_j = P_i^l Q_i^m C_j, \qquad c_j \xrightarrow{\mathrm{ud}} C_j \in \mathrm{uMat}(N, \mathrm{u}\mathbb{R}).$$

This relation is valid, but inadequate to determine W, V in many cases. For simplicity, we assume N=2 hereafter. If we write $W=\left(W^{\iota\kappa}\right)$, $F_j=\left(F_j^{\iota\kappa}\right)$, the (1,2)-th element of $(0\ominus F_1)(0\oplus F_1)^{-1}$ is given by

$$\frac{\ominus F_1^{12}\left(\left(0\ominus F_1^{11}\right)\oplus \left(0\oplus F_1^{11}\right)\right)}{\det(0\oplus F_1)} = \frac{\ominus F_1^{12}\left(0\oplus \left(F_1^{11}\right)^{\bullet}\right)}{\det(0\oplus F_1)},$$

and $|F_1^{11}|_{\oplus}$ exceeds 0 for large $\pm l$ or $\pm m$. Then this element is balanced and W^{12} cannot be determined. Therefore, we need more precise expressions to ultradiscretize.

 $g_i = (1 + f_i)(1 - f_i)^{-1}, \qquad h_i = (1 - f_i)(1 + f_i)^{-1}.$

Of course, $w = h_1$, $v = g_1$ is a 1-soliton solution for ncdsG. Writing $f_j = (f_j^{\iota\kappa})$, we have

$$g_{j} = \begin{pmatrix} \frac{\left(1 + f_{j}^{11}\right)\left(1 - f_{j}^{22}\right) + f_{j}^{12}f_{j}^{21}}{\det(1 - f_{j})} & \frac{2f_{j}^{12}}{\det(1 - f_{j})} \\ \frac{2f_{j}^{21}}{\det(1 - f_{j})} & \frac{\left(1 + f_{j}^{22}\right)\left(1 - f_{j}^{11}\right) + f_{j}^{21}f_{j}^{12}}{\det(1 - f_{j})} \end{pmatrix},$$

$$h_{j} = \begin{pmatrix} \frac{\left(1 - f_{j}^{11}\right)\left(1 + f_{j}^{22}\right) + f_{j}^{12}f_{j}^{21}}{\det(1 + f_{j})} & \frac{-2f_{j}^{12}}{\det(1 + f_{j})} \\ \frac{-2f_{j}^{21}}{\det(1 + f_{j})} & \frac{\left(1 - f_{j}^{22}\right)\left(1 + f_{j}^{11}\right) + f_{j}^{21}f_{j}^{12}}{\det(1 + f_{j})} \end{pmatrix}.$$

By ultradiscretization, we obtain

$$g_{j} \xrightarrow{\operatorname{ud}} G_{j} \nabla \begin{pmatrix} \frac{\left(0 \oplus F_{j}^{11}\right)\left(0 \ominus F_{j}^{22}\right) \oplus F_{j}^{12}F_{j}^{21}}{\det(0 \ominus F_{j})} & \frac{F_{j}^{12}}{\det(0 \ominus F_{j})} \\ \frac{F_{j}^{21}}{\det(0 \ominus F_{j})} & \frac{\left(0 \oplus F_{j}^{22}\right)\left(0 \ominus F_{j}^{11}\right) \oplus F_{j}^{21}F_{j}^{12}}{\det(0 \ominus F_{j})} \end{pmatrix}, (3.24a)$$

$$h_{j} \xrightarrow{\operatorname{ud}} H_{j} \nabla \begin{pmatrix} \frac{\left(0 \ominus F_{j}^{11}\right)\left(0 \oplus F_{j}^{22}\right) \oplus F_{j}^{12}F_{j}^{21}}{\det(0 \oplus F_{j})} & \frac{\ominus F_{j}^{12}}{\det(0 \oplus F_{j})} \\ \frac{\ominus F_{j}^{21}}{\det(0 \oplus F_{j})} & \frac{\left(0 \ominus F_{j}^{22}\right)\left(0 \oplus F_{j}^{11}\right) \oplus F_{j}^{21}F_{j}^{12}}{\det(0 \oplus F_{j})} \end{pmatrix}. (3.24b)$$




Figure 3.3. 1-soliton solution for neudsG.

We can choose $C_j, P_j, Q_j \in u\mathbb{Z}$ such that $(0 \oplus F_j^{11})(0 \ominus F_j^{22})$ is always even and $F_j^{12}F_j^{21}$ odd. Then all the elements on the r.h.s. of (3.24a), (3.24b) are signed and G_j , H_j are completely determined. Fig. 3.3 shows $W = H_1$ with

$$A = B = -1,$$
 $C_1 = \begin{pmatrix} \ominus(-7) & -8 \\ \ominus(-5) & \ominus 7 \end{pmatrix},$ $P_1 = 2,$ $Q_1 = 0.$

3.2.3 2-soliton solution

Ultradiscretization of (3.16a), (3.16b) gives

$$W \nabla (L_2G_2 \ominus L_1G_1) (L_2G_1 \ominus L_1G_2)^{-1}, V \nabla (L_2H_2 \ominus L_1H_1) (L_2H_1 \ominus L_1H_2)^{-1},$$

where

$$\lambda_j \xrightarrow{\mathrm{ud}} L_j$$
.

In order to determine the value of L_j , we examine the relation

$$\lambda_j = \frac{p_j - 1}{a(p_j + 1)} = \frac{b(q_j + 1)}{q_j - 1}.$$

By the dispersion relation (3.23), we have $P_j = 0$ or $Q_j = 0$. When $Q_j = 0$, q_j behaves like a constant with regard to the ultradiscretization parameter s and p_j cannot behave like one. Therefore, we have

$$L_{j} = \frac{P_{j} \ominus 0}{A(P_{j} \oplus 0)} = \begin{cases} A^{-1}, & |P_{j}|_{\oplus} > 0, \\ \ominus A^{-1}, & |P_{j}|_{\oplus} < 0. \end{cases}$$

Similarly, when $P_j = 0$, we have

$$L_{j} = \frac{B(Q_{j} \oplus 0)}{Q_{j} \ominus 0} = \begin{cases} B, & |Q_{j}|_{\oplus} > 0, \\ \ominus B, & |Q_{j}|_{\oplus} < 0. \end{cases}$$

If we choose $P_2=Q_1=0$, we have $|L_1|_{\oplus}>|L_2|_{\oplus}$ and thus

$$W \nabla G_1 G_2^{-1}, \qquad V \nabla H_1 H_2^{-1}.$$




Figure 3.4. 2-soliton solution for neudsG.

Similarly, if $P_1 = Q_2 = 0$,

$$W \nabla G_2 G_1^{-1}, \qquad V \nabla H_2 H_1^{-1}.$$

Fig. 3.4 shows behavior of $W = G_1 G_2^{-1}$ with parameters A = B = -1,

$$C_1 = \begin{pmatrix} \ominus 2 & \ominus (-13) \\ \ominus 11 & 15 \end{pmatrix}, \qquad C_2 = \begin{pmatrix} -3 & \ominus (-15) \\ \ominus (-7) & \ominus (-13) \end{pmatrix}, \qquad P_1 = Q_2 = 4.$$

These are chosen so that every elements involved are signed.

4 Conclusion and discussion

We have proposed an ultradiscrete analogue of the sine-Gordon equation and constructed signed 1-soliton and 2-soliton solutions utilizing uR. The traveling-wave, kink-antikink, and kink-kink

solutions, which contain ultradiscrete complex numbers, do exist and their correspondence to those for the discrete sine-Gordon equation is quite clear. When the range of solutions are restricted to $u\mathbb{R}$, even deterministic time evolution is possible.

As stated in Section 1, another ultradiscretization of the sine-Gordon equation has been given by Isojima et al. [9, 10]. There, only τ is ultradiscretized, no complex solutions are dealt with, and time evolution is not possible. Our formulation looks better in these respects. Also, ultradiscretization via the parametrization (2.16) can be considered as another aspect of continuum limit, but ultradiscretization in [9] cannot since they choose a parametrization such that $\delta \to \pm 1$.

We have also proposed a noncommutative discrete analogue of the sine-Gordon equation and revealed its relation to other integrable systems including the noncommutative discrete KP equation. Also, multisoliton solutions are constructed by a repeated application of Darboux transformations. And finally, a noncommutative ultradiscrete analogue of the sine-Gordon equation and its signed 1-soliton and 2-soliton solutions are derived by ultradiscretization with $u\mathbb{R}$.

A Symmetrized max-plus algebra and ultradiscretization

We make extensive use of the symmetrized max-plus algebra $u\mathbb{R}$ in the main part of the paper. Therefore we describe basic definitions and properties of $u\mathbb{R}$ here. For details, see Baccelli et al. [2].

A.1 Symmetrized max-plus algebra

A.1.1 Pair of the max-plus algebra

Let $\mathbb{R}_{max} = \mathbb{R} \cup \{-\infty\}$. \mathbb{R}_{max} has the obvious total order. Define \oplus and \otimes by

$$x \oplus y = \max(x, y), \qquad x \otimes y = x + y$$

for $x, y \in \mathbb{R}_{\text{max}}$. With these operations, \mathbb{R}_{max} becomes a commutative dioid called the max-plus algebra. The null element is $-\infty$ and the unit element is 0. We extend \oplus and \otimes over $\mathbb{R}^2_{\text{max}}$ by

$$(x_1, x_2) \oplus (y_1, y_2) = (x_1 \oplus y_1, x_2 \oplus y_2),$$

 $(x_1, x_2) \otimes (y_1, y_2) = (x_1 y_1 \oplus x_2 y_2, x_1 y_2 \oplus x_2 y_1).$

Then \mathbb{R}^2_{\max} is a commutative dioid with null element $(-\infty, -\infty)$ and unit element $(0, -\infty)$. \mathbb{R}_{\max} is embedded into \mathbb{R}^2_{\max} by $x \longmapsto (x, -\infty)$.

Define minus sign \ominus by

$$\ominus(x_1, x_2) = (x_2, x_1)$$

for $x=(x_1,x_2)\in\mathbb{R}^2_{\max}$. We write $x\ominus y$ for $x\oplus(\ominus y)$, which is regarded as subtraction. Define absolute value $|\cdot|_{\oplus}:\mathbb{R}^2_{\max}\to\mathbb{R}_{\max}$ by

$$|(x_1,x_2)|_{\oplus}=x_1\oplus x_2.$$

Define balance operator • by

$$(x_1, x_2)^{\bullet} = (x_1, x_2) \ominus (x_1, x_2) = (x_1 \oplus x_2, x_1 \oplus x_2).$$

A.1.2 Symmetrized max-plus algebra

It is natural to consider the balance relation ∇ defined by

$$(x_1, x_2) \nabla (y_1, y_2) \iff x_1 \oplus y_2 = x_2 \oplus y_1.$$

 ∇ is reflexive and symmetric, but *not* transitive. Therefore, we introduce another relation \mathcal{R} defined by

$$(x_1, x_2) \mathcal{R} (y_1, y_2) \iff \begin{cases} (x_1, x_2) \nabla (y_1, y_2), & \text{when } x_1 \neq x_2 \text{ and } y_1 \neq y_2, \\ (x_1, x_2) = (y_1, y_2), & \text{otherwise.} \end{cases}$$

 \mathcal{R} is an equivalence relation compatible with the operations \oplus , \otimes , \ominus , $|\cdot|_{\oplus}$, \bullet , and the relation ∇ . Thus, we can define the quotient structure

$$u\mathbb{R} = \mathbb{R}^2_{max}/\mathcal{R}$$
.

This is called the symmetrized max-plus algebra [1, 2]. Usually this is denoted by \mathbb{S} , but we use $u\mathbb{R}$ to imply it is somehow a whole set of *ultradiscrete real numbers*. We will also introduce $u\mathbb{Z}$, $u\mathbb{C}$ later.

Proposition A.1. We have three kinds of equivalence classes:

$$\overline{(x, -\infty)} = \{(x, t) : t \in \mathbb{R}_{\max} \text{ and } x > t\},$$
$$\overline{(-\infty, x)} = \{(t, x) : t \in \mathbb{R}_{\max} \text{ and } t < x\},$$
$$\overline{(x, x)} = \{(x, x)\}.$$

 \mathbb{R}_{\max} is embedded into \mathbb{R} by $x \longmapsto \overline{(x, -\infty)}$. Define

$$\ominus \mathbb{R}_{\max} = \big\{ \overline{(-\infty,x)} : x \in \mathbb{R}_{\max} \big\}, \qquad \mathbb{R}^{\bullet}_{\max} = \big\{ \overline{(x,x)} : x \in \mathbb{R}_{\max} \big\}.$$

Then $u\mathbb{R}$ has a decomposition

$$u\mathbb{R} = \mathbb{R}_{max} \cup \ominus \mathbb{R}_{max} \cup \mathbb{R}_{max}^{\bullet}$$

and $\overline{(-\infty, -\infty)}$ is the only element which belongs to any two of the three sets. Thus, we simply write x for $\overline{(x, -\infty)}$, $\ominus x$ for $\overline{(-\infty, x)}$, and x^{\bullet} for $\overline{(x, x)}$.

Define sign function $\operatorname{sgn} x$ by

$$\operatorname{sgn} x = \begin{cases} 0, & x \in \mathbb{R}, \\ 0^{\bullet}, & x \in \mathbb{R}_{\max}^{\bullet}, \\ \ominus 0, & x \in \ominus \mathbb{R}. \end{cases}$$

 $x \in \mathbb{UR}$ is said to be positive if $\operatorname{sgn} x = 0$, negative if $\operatorname{sgn} x = 0$, and balanced if $\operatorname{sgn} x = 0^{\bullet}$. Define $\mathbb{UR}^{\vee} = \mathbb{R}_{\max} \cup \oplus \mathbb{R}_{\max}$. $x \in \mathbb{UR}$ is said to be signed if $x \in \mathbb{UR}^{\vee}$.

Proposition A.2. Let $u\mathbb{R}^{\otimes}$ denote the whole set of invertible elements in $u\mathbb{R}$. Then,

$$u\mathbb{R}^{\otimes} = u\mathbb{R}^{\vee} \setminus \{-\infty\} = u\mathbb{R} \setminus \mathbb{R}_{\max}^{\bullet}.$$

Define $u\mathbb{Z}, u\mathbb{Z}^{\vee} \subset u\mathbb{R}$ by

$$u\mathbb{Z} = \{-\infty\} \cup \mathbb{Z} \cup \ominus \mathbb{Z} \cup \mathbb{Z}^{\bullet}, \qquad u\mathbb{Z}^{\vee} = u\mathbb{Z} \cap u\mathbb{R}^{\vee}$$

with obvious notations. $u\mathbb{Z}$ is a subdioid of $u\mathbb{R}$ and can be regarded as a whole set of *ultradiscrete* integers. $x \in u\mathbb{Z}$ is said to be even if $|x|_{\oplus}$ is even, odd if $|x|_{\oplus}$ is odd. We do not define whether $-\infty$ is even or odd. We have of course

$$u\mathbb{Z}^{\otimes}=u\mathbb{Z}^{\vee}\setminus\{-\infty\}.$$

A.1.3 Properties of balance relation

We make much use of ∇ , rather than \mathcal{R} , since members of $\mathbb{R}_{max}^{\bullet}$ can be regarded as a kind of null elements by virtue of the following proposition.

Proposition A.3. For any $x \in u\mathbb{R}$,

$$x \nabla - \infty \iff x \in \mathbb{R}_{\max}^{\bullet}$$
.

Proposition A.4. For any $x \in u\mathbb{R}$ and $t \in \mathbb{R}_{max}$,

$$x \nabla t^{\bullet} \text{ and } x \notin \mathbb{R}_{\max}^{\bullet} \iff |x|_{\oplus} \leq t.$$

Proposition A.5. For any $x, y \in u\mathbb{R}$, we have

$$x \nabla y \iff x \ominus y \nabla -\infty.$$

Proposition A.6. For any $x, y, z, w \in u\mathbb{R}$, we have

$$x \; \nabla \; y \; \, and \; z \; \nabla \; w \; \implies \; x \oplus z \; \nabla \; y \oplus w,$$

$$x \nabla y \implies xz \nabla yz.$$

Proposition A.7 (weak substitution).

$$x \nabla y$$
, $cy \nabla z$, and $y \in u\mathbb{R}^{\vee} \implies cx \nabla z$.

Corollary A.8 (weak transitivity).

$$x \nabla y, y \nabla z, \text{ and } y \in u\mathbb{R}^{\vee} \implies x \nabla z.$$

Proposition A.9 (reduction of balances).

$$x \nabla u \text{ and } x, u \in u\mathbb{R}^{\vee} \implies x = u.$$

A.1.4 Matrices and determinants

Let $uMat(N, u\mathbb{R})$ denote the whole set of $N \times N$ matrices over $u\mathbb{R}$. Define addition \oplus by

$$(a_{ij}) \oplus (b_{ij}) = (a_{ij} \oplus b_{ij})$$

and multiplication \otimes by

$$(a_{ij}) \otimes (b_{ij}) = (c_{ij}), \qquad c_{ij} = \bigoplus_{k} a_{ik} \otimes b_{kj}$$

for any $(a_{ij}), (b_{ij}) \in \mathrm{uMat}(N, \mathrm{u}\mathbb{R})$. Then $\mathrm{uMat}(N, \mathrm{u}\mathbb{R})$ becomes a dioid, noncommutative when $N > 1. \ominus, \bullet$, and ∇ are of course defined by

$$\ominus(a_{ij}) = (\ominus a_{ij}), \qquad (a_{ij})^{\bullet} = (a_{ij}^{\bullet}),$$

$$(a_{ij}) \nabla (b_{ij}) \iff a_{ij} \nabla b_{ij} \text{ for any } i, j$$

respectively. $(a_{ij}) \in \mathrm{uMat}(N, \mathrm{u}\mathbb{R})$ is said to be signed if all the elements are signed. The whole set of signed elements in $\mathrm{uMat}(N, \mathrm{u}\mathbb{R})$ is denoted by $\mathrm{uMat}(N, \mathrm{u}\mathbb{R})^{\vee}$. $\mathrm{u}\mathbb{R}$ is embedded into $\mathrm{uMat}(N, \mathrm{u}\mathbb{R})$ by

$$x \longmapsto \begin{pmatrix} x & -\infty & \cdots & -\infty \\ -\infty & x & \ddots & \vdots \\ \vdots & \ddots & \ddots & -\infty \\ -\infty & \cdots & -\infty & x \end{pmatrix}.$$

For any permutation $\sigma \in S_N$, define $sgn(\sigma)$ by

$$\operatorname{sgn}(\sigma) = \begin{cases} 0, & \text{when } \sigma \text{ is even,} \\ \ominus 0, & \text{when } \sigma \text{ is odd.} \end{cases}$$

And define the determinant of a matrix $A = (a_{ij}) \in \mathrm{uMat}(N, \mathrm{u}\mathbb{R})$ by

$$\det A = \bigoplus_{\sigma} \operatorname{sgn}(\sigma) \bigotimes_{i} a_{i\sigma(i)}.$$

 $\det A$ is also denoted by |A| or $|a_{ij}|$.

Proposition A.10.

$$|^t A| = |A|$$

where ${}^{t}A$ denotes transposition of A.

Proposition A.11.

$$|v_1 \cdots \lambda v_j \oplus u \cdots v_N| = \lambda |v_1 \cdots v_j \cdots v_N| \oplus |v_1 \cdots u \cdots v_N|$$

where $v_j = {}^{t}(a_{1j}, \dots, a_{Nj})$ and $u = {}^{t}(u_1, \dots, u_N)$.

Proposition A.12. For any permutation $\sigma \in S_N$,

$$|a_{i\sigma(j)}| = \operatorname{sgn}(\sigma)|a_{ij}|.$$

Corollary A.13. If $v_j = v_k$ for some $j \neq k$, then

$$|v_1 \cdots v_N| \nabla -\infty.$$

Let $cof_{ij}(A)$ denote the cofactor of a_{ij} in |A|, which by definition satisfies

$$|A| = \bigoplus_{i} a_{ij} \otimes \operatorname{cof}_{ij}(A)$$

for any j. Define the adjacent matrix of A by

$$\operatorname{adj} A = (b_{ij}), \qquad b_{ij} = \operatorname{cof}_{ji}(A).$$

Theorem A.14.

$$A \otimes \operatorname{adj} A \nabla |A|$$
, $\operatorname{adj} A \otimes A \nabla |A|$.

If
$$|A| \in \mathbb{R}^{\otimes}$$
, define A^{-1} by

$$A^{-1} = |A|^{-1} \operatorname{adj} A.$$

This is not a multiplicative inverse in general, but plays a similar role with regard to ∇ . Therefore we use the notation A^{-1} .

A.1.5 Ultradiscrete complex numbers

It is well known that we can construct complex numbers by 2×2 real matrices, using

$$i = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$$

as the imaginary unit. Here we try to construct ultradiscrete complex numbers in a similar way. Let $\mathrm{uMat}(N,\mathrm{u}\mathbb{R})$ denote the algebra of $N\times N$ matrices whose elements are in $\mathrm{u}\mathbb{R}$. Define $I\in\mathrm{uMat}(2,\mathrm{u}\mathbb{R})$ by

$$I = \begin{pmatrix} -\infty & \ominus 0 \\ 0 & -\infty \end{pmatrix}.$$

We have

$$I^2 = \begin{pmatrix} -\infty & \ominus 0 \\ 0 & -\infty \end{pmatrix} \begin{pmatrix} -\infty & \ominus 0 \\ 0 & -\infty \end{pmatrix} = \begin{pmatrix} \ominus 0 & -\infty \\ -\infty & \ominus 0 \end{pmatrix} = \ominus 0.$$

Define $u\mathbb{C} \subset uMat(2, u\mathbb{R})$ by

$$\mathbf{u}\mathbb{C} = \{ x \oplus yI \mid x, y \in \mathbf{u}\mathbb{R} \}.$$

Proposition A.15. $u\mathbb{C}$ is a commutative subdivid of $uMat(2, u\mathbb{R})$.

Proof. Obviously u \mathbb{C} includes $-\infty$ and 0. For any $a \oplus bI$, $c \oplus dI \in u\mathbb{C}$, we have

$$(a \oplus bI) \oplus (c \oplus dI) = (a \oplus c) \oplus (b \oplus d)I \in \mathbb{U}C,$$

$$(a \oplus bI) \otimes (c \oplus dI) = (ac \ominus bd) \oplus (ad \oplus bc)I \in \mathbb{U}C.$$

And u \mathbb{C} is commutative because I^0 and I^1 are commutative.

When $z \in u\mathbb{C}$ is expressed as z = x + yI where $x, y \in u\mathbb{R}$, we write

$$uRe z = x, uIm = y.$$

The whole set of signed elements of $u\mathbb{C}$ is denoted by $u\mathbb{C}^{\vee}$.

If $det(x \oplus yI) = x^2 \oplus y^2 \in u\mathbb{R}^{\otimes}$, we have

$$(x\oplus yI)^{-1}=\frac{x\ominus yI}{x^2\oplus y^2}$$

and

$$(x \oplus yI)(x \oplus yI)^{-1} = 0 \oplus \frac{(xy)^{\bullet}}{x^2 \oplus y^2} I \nabla 0.$$

A.2 Ultradiscretization with negative numbers

Ultradiscretization with negative numbers is presented in De Schutter et al. [4]. Here we reformulate it in a similar, but more convenient form for our purpose.

Let f(s) and g(s) be real functions. We say f(s) is asymptotically equivalent to g(s) if there exists a real number s_0 such that $g(s) \neq 0$ for any $s > s_0$ and

$$\lim_{s \to \infty} \frac{f(s)}{g(s)} = 1.$$

We also say f(s) is asymptotically equivalent to 0 if there exists a real number s_1 such that f(s) = 0 for any $s > s_1$. Asymptotic equivalence is an equivalence relation and denoted by $f(s) \sim g(s)$.

We are interested in asymptotic equivalence to exponential functions. If

$$f(s) \sim \mu_F e^{\widetilde{F}s}, \qquad \mu_F \in \mathbb{R}^{\times}, \qquad \widetilde{F} \in \mathbb{R},$$

we write

$$f(s) \xrightarrow{\mathrm{ud}} F, \qquad F = S(\mu_F) \otimes \widetilde{F} \in \mathrm{u}\mathbb{R}^\vee,$$

where

$$S(\mu) = \begin{cases} 0, & \mu > 0, \\ \ominus 0, & \mu < 0. \end{cases}$$

We regard $0 \sim \mu e^{(-\infty)s}$ for some $\mu \in \mathbb{R}^{\times}$ and $0 \xrightarrow{\text{ud}} -\infty$ as a convention.

It is very important here to notice that μ_F is not restricted to positive numbers, unlike the usual ultradiscretization procedure.

Proposition A.16 (ultradiscretization of addition). Let $f(s), g_1(s), \ldots, g_n(s)$ be real functions satisfying

$$f(s) = \sum_{k=1}^{n} g_k(s)$$

and

$$f(s) \xrightarrow{\mathrm{ud}} F, \qquad g_k(s) \xrightarrow{\mathrm{ud}} G_k.$$

Then,

$$F \nabla \bigoplus_{k=1}^{n} G_k$$
.

Remark A.17. $f(s) \xrightarrow{\mathrm{ud}} F$ and $g(s) \xrightarrow{\mathrm{ud}} G$ do not imply $f(s) + g(s) \xrightarrow{\mathrm{ud}} F \oplus G$ because f(s) + g(s) might be no longer asymptotically equivalent to exponential functions. But if f(s), g(s) can be expressed by power series in $\delta = \mu_D e^{\widetilde{D}s}$ where $\widetilde{D} < 0$, this is not a problem because f(s) + g(s) can also be expressed by a power series in δ .

Proposition A.18 (ultradiscretization of multiplication). Let f(s), g(s), h(s) be real functions satisfying

$$f(s) = g(s)h(s)$$

and

$$g(s) \xrightarrow{\mathrm{ud}} G, \qquad h(s) \xrightarrow{\mathrm{ud}} H.$$

Then,

$$f(s) \xrightarrow{\mathrm{ud}} F = G \otimes H.$$

Corollary A.19 (ultradiscretization of polynomials). Let real functions f(s), $g_{kl}(s)$ satisfy

$$f(s) = \sum_{k=1}^{n} \prod_{l=1}^{m_k} g_{kl}(s)$$

and

$$f(s) \xrightarrow{\mathrm{ud}} F, \qquad g_{kl}(s) \xrightarrow{\mathrm{ud}} G_{kl}.$$

Then,

$$F \nabla \bigoplus_{k=1}^{n} \bigotimes_{l=1}^{m_k} G_{kl}.$$

A.3 Ultradiscretization of matrices and complex numbers

We also reformulate ultradiscretization of matrices in [4]. Extension to complex numbers is straightforward.

Consider a matrix-valued function $f(s) = (f_{ij}(s)) : \mathbb{R} \to \operatorname{Mat}(N, \mathbb{R})$. If

$$f_{ij}(s) \xrightarrow{\mathrm{ud}} F_{ij},$$

we write

$$f(s) \xrightarrow{\mathrm{ud}} F = (F_{ij}) \in \mathrm{uMat}(N, \mathrm{u}\mathbb{R}).$$

This is a componentwise property; there is no exponential functions of matrices.

Proposition A.20. Let matrix-valued functions f(s), $g_{kl}(s)$ satisfy

$$f(s) = \sum_{k=1}^{n} \prod_{l=1}^{m_k} g_{kl}(s)$$

and

$$f(s) \xrightarrow{\mathrm{ud}} F, \qquad g_{kl}(s) \xrightarrow{\mathrm{ud}} G_{kl}.$$

Then,

$$F \nabla \bigoplus_{k=1}^{n} \bigotimes_{l=1}^{m_k} G_{kl}.$$

Considering 2×2 -matrix construction of complex numbers, we have

$$i = \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix} \xrightarrow{\text{ud}} I = \begin{pmatrix} -\infty & \ominus 0 \\ 0 & -\infty \end{pmatrix}.$$

Let f(s) = u(s) + v(s)i where u(s), v(s) are real functions. If

$$u(s) \xrightarrow{\mathrm{ud}} U, \qquad v(s) \xrightarrow{\mathrm{ud}} V,$$

we have of course

$$f(s) \xrightarrow{\mathrm{ud}} F = U \oplus VI \in \mathrm{u}\mathbb{C}.$$

Proposition A.21. Let complex-valued functions f(s), $g_{kl}(s)$ satisfy

$$f(s) = \sum_{k=1}^{n} \prod_{l=1}^{m_k} g_{kl}(s)$$

and

$$f(s) \xrightarrow{\mathrm{ud}} F, \qquad g_{kl}(s) \xrightarrow{\mathrm{ud}} G_{kl}.$$

Then.

$$F \nabla \bigoplus_{k=1}^{n} \bigotimes_{l=1}^{m_k} G_{kl}.$$

B Quasideterminants

Quasideterminants [5] are noncommutative extension of determinants, or, more precisely, determinants divided by cofactors. Here we describe the definition and some properties required for Theorem 3.7. See [5] for more detail.

Let R be a ring and Mat(N, R) be the whole set of $N \times N$ matrices over R. R is not commutative in general. For any $(a_{ij}), (b_{ij}) \in Mat(N, R)$, define addition by

$$(a_{ij}) + (b_{ij}) = (a_{ij} + b_{ij})$$

and multiplication by

$$(a_{ij})(b_{ij}) = (c_{ij}), c_{ij} = \sum_{k=1}^{N} a_{ik} b_{kj}.$$

Ordering of multiplication is important here.

For any $A = (a_{ij}) \in \operatorname{Mat}(N, R)$, define the (p, q)-th quasideterminant $|A|_{pq}$ by

$$|A|_{pq} = a_{pq} - r_p^q (A^{pq})^{-1} c_q^p,$$

where r_p^q is the p-th row of A without the q-th element, c_q^p is the q-th column of A without the p-th element, and A^{pq} is A without the p-th row and the q-th column. $|A|_{pq}$ is also written as

$$|A|_{pq} = \begin{vmatrix} a_{11} & \cdots & a_{1N} \\ \vdots & \boxed{a_{pq}} & \vdots \\ a_{N1} & \cdots & a_{NN} \end{vmatrix}.$$

For example, we have

$$\begin{vmatrix} a_{11} & a_{12} \\ a_{21} & a_{22} \end{vmatrix} = a_{11} - a_{12}a_{22}^{-1}a_{21}, \qquad \begin{vmatrix} a_{11} & a_{12} \\ a_{21} & a_{22} \end{vmatrix} = a_{12} - a_{11}a_{21}^{-1}a_{22}$$

and

$$\begin{vmatrix} a_{11} & a_{12} & a_{13} \\ a_{21} & a_{22} & a_{23} \\ a_{31} & a_{32} & a_{33} \end{vmatrix} = a_{11} - \begin{pmatrix} a_{12} & a_{13} \end{pmatrix} \begin{pmatrix} a_{22} & a_{23} \\ a_{32} & a_{33} \end{pmatrix}^{-1} \begin{pmatrix} a_{21} \\ a_{31} \end{pmatrix}$$

$$= a_{11} - a_{12} \begin{pmatrix} a_{22} - a_{23}a_{33}^{-1}a_{32} \end{pmatrix}^{-1} a_{21} - a_{13} \begin{pmatrix} a_{23} - a_{22}a_{32}^{-1}a_{33} \end{pmatrix}^{-1} a_{21}$$

$$- a_{12} \begin{pmatrix} a_{32} - a_{33}a_{23}^{-1}a_{22} \end{pmatrix}^{-1} a_{31} - a_{13} \begin{pmatrix} a_{33} - a_{32}a_{22}^{-1}a_{23} \end{pmatrix}^{-1} a_{31}.$$

Proposition B.1. If we write $A^{-1} = (b_{ij})$, we have

$$b_{ij} = |A|_{ii}^{-1}$$
.

Proposition B.2. Quasideterminants are invariant under row and column permutations. (If the row or column contains the box, it is moved together.)

Proposition B.3 (homological relations). For $p_1 \neq p_2$, $q_1 \neq q_2$, $i \neq p$, $j \neq q$, we have the row homological relation

$$|A|_{pq_1} |A^{pq_2}|_{iq_1}^{-1} + |A|_{pq_2} |A^{pq_1}|_{iq_2}^{-1} = 0$$

and the column homological relation

$$|A^{p_2q}|_{p_1j}^{-1}|A|_{p_1q} + |A^{p_1q}|_{p_2j}^{-1}|A|_{p_2q} = 0.$$

Proposition B.4 (Sylvester's identity). For any $A = (a_{ij}) \in \text{Mat}(N, R)$, define $(N-k) \times (N-k)$ matrix A_0 by

$$A_0 = (a_{ij}), \qquad k+1 \le i, j \le N$$

and $k \times k$ matrix C by

$$C = (c_{ij}),$$
 $c_{ij} = \begin{vmatrix} a_{ij} & a_{i(k+1)} & \cdots & a_{iN} \\ a_{(k+1)j} & & & \\ \vdots & & A_0 & \\ a_{Nj} & & & \end{vmatrix}.$

Then

$$|A|_{pq} = |C|_{pq}.$$
