STABILITY OF BOSE-EINSTEIN CONDENSATES IN A \mathcal{PT} SYMMETRIC DOUBLE- δ POTENTIAL CLOSE TO BRANCH POINTS

ABSTRACT. A Bose-Einstein condensate trapped in a double-well potential, where atoms are incoupled to one side and extracted from the other, can in the mean-field limit be described by the nonlinear Gross-Pitaevskii equation (GPE) with a \mathcal{PT} symmetric external potential. If the strength of the in- and outcoupling is increased two \mathcal{PT} broken states bifurcate from the \mathcal{PT} symmetric ground state. At this bifurcation point a stability change of the ground state is expected. However, it is observed that this stability change does not occur exactly at the bifurcation but at a slightly different strength of the in-/outcoupling effect. We investigate a Bose-Einstein condensate in a \mathcal{PT} symmetric double- δ potential and calculate the stationary states. The ground state's stability is analysed by means of the Bogoliubov-de Gennes equations and it is shown that the difference in the strength of the in-/outcoupling between the bifurcation and the stability change can be completely explained by the norm-dependency of the nonlinear term in the Gross-Pitaevskii equation.

KEYWORDS: Bose-Einstein condensates, \mathcal{PT} symmetry, stability, Bogoliubov-de Gennes equations.

1. INTRODUCTION

29 In quantum mechanics non-Hermitian Hamiltonians 30 with imaginary potentials have become an impor-31 tant tool to describe systems with loss or gain effects 32 [1]. Non-Hermitian \mathcal{PT} symmetric Hamiltonians, i.e. 33 Hamiltonians commuting with the combined action of the parity $(\mathcal{P}: x \to -x, p \to -p)$ and time reversal 34 35 $(\mathcal{T}: x \to x, p \to -p, i \to -i)$ operators, possess the 36 interesting property that, in spite of the gain and 37 loss, they can exhibit stationary states with real eigen-38 values [2]. When the strength of the gain and loss 39 contributions is increased typically pairs of these real 40 eigenvalues pass through an exceptional point, i.e. a 41 branch point at which both the eigenvalues and the 42 wave functions are identical, and become complex and 43 complex conjugate.

44 A promising candidate for the realisation of a \mathcal{PT} 45 symmetric quantum system are Bose-Einstein conden-46 sates. At sufficiently low temperatures and densities 47 they can in the mean-field limit be described by the 48 nonlinear Gross-Pitaevskii equation [3, 4]. If a conden-49 sate is trapped in a double-well potential it is possible 50 to add atoms to one side of the double well and re-51 move atoms from the other. This leads to a gain or 52 loss to the condensate's probability amplitude. If the 53 strength of both contributions is equal, the process 54 can effectively be described by a complex external 55 potential $V(-x) = V^*(x)$ rendering the Hamiltonian 56 \mathcal{PT} symmetric [5]. The experimental realisation of 57 an open quantum system with \mathcal{PT} symmetry will be 58 an important step since the experimental verification 59 has only been achieved in optics so far [6, 7]. 60

The nonlinearity $\propto |\psi(\boldsymbol{x},t)|^2$ of the Gross-Pitaevskii equation introduces new interesting properties [8–17] such as \mathcal{PT} broken states which appear for gain/loss contributions lower than those at which the corresponding \mathcal{PT} symmetric states vanish. In optics the same effect can be observed for wave guides with a Kerr nonlinearity. They are described by an equation being mathematically equivalent to the Gross-Pitaevskii equation. It has been shown that the additional features appearing in the presence of the nonlinearity might be exploited to create uni-directional structures [18] or solitons [19–24]. Since \mathcal{PT} symmetry in optics is extensively studied [5, 18–28] and has been experimentally realised [6, 7] these approaches seem to be very promising.

From the mathematical point of view a new type 103 of bifurcation appearing in the nonlinear \mathcal{PT} sym-104 metric Gross-Pitaevskii equation is of special interest 105 [8–17]. As in linear quantum systems two \mathcal{PT} sym-106 metric stationary states merge in an exceptional point 107 108 if the strength of a parameter describing the gain and loss processes is increased. However, in contrast to 109 its linear counterpart the Gross-Pitaevskii equation 110 possesses no \mathcal{PT} broken states emerging at this excep-111 tional point. They already appear for lower strengths 112 of the gain/loss parameter and bifurcate from one of 113 the \mathcal{PT} symmetric states in a pitchfork bifurcation. 114 The new bifurcation point has been identified to be 115 a third-order exceptional point [10]. For attractive 116 117 nonlinearities one finds that the \mathcal{PT} broken solutions bifurcate from the ground state. In this scenario the 118 119 \mathcal{PT} symmetric ground state is the only state which 120

exists on both sides of the bifurcation and always
possesses a real energy eigenvalue. The pitchfork bifurcation is expected to entail a change of its stability.
However, it is observed that this stability change does
not occur exactly at the bifurcation but at a slightly
different value of the gain/loss parameter.

The discrepancy between the points of bifurcation 8 9 and stability change seems to be surprising and does 10 not appear in all similar systems. The mean-field limit 11 of a two mode approximation with a Bose-Hubbard 12 Hamiltonian [14–17] does not show this effect. The 13 model has, however, two crucial differences to the 14 treatment of Bose-Einstein condensates with the full 15 Gross-Pitaevskii equation in Ref. [11]. The latter 16 system contains a harmonic trap in which infinitely 17 many stationary states can be found, whereas the 18 nonlinear two-mode system exhibits only four states. 19 viz. the two \mathcal{PT} symmetric and the two \mathcal{PT} broken 20 states mentioned above. Furthermore the nonlinearity 21 derived in [14, 15] is slightly different from that of 22 the Gross-Pitaevskii equation. It has the form \propto 23 $|\psi|^2/||\psi||^2$, and hence does not depend on the norm of 24 25 the wave function. Thus, there might be two reasons for the appearance of the discrepancy. It could have 26 27 its origin in the existence of higher modes influencing 28 the ground state's stability or in the norm-dependency 29 of the Gross-Pitaevskii nonlinearity. 30

It is the purpose of this article to clarify this ques-31 tion. To do so we study a Bose-Einstein condensate in 32 33 an idealised double- δ trap [8–10], a system of which al-34 ready its linear counterpart helped to understand basic 35 properties of \mathcal{PT} symmetric structures [29–33]. This 36 system is described by the Gross-Pitaevskii equation, 37 i.e. the contact interaction has the norm-dependent 38 form $\propto |\psi(\boldsymbol{x},t)|^2$. However, it exhibits only four sta-39 tionary states of which two are \mathcal{PT} symmetric and 40 two are \mathcal{PT} broken as in the two-mode model [14– 41 17]. Additionally, in a numerical study the structure 42 of the nonlinearity can easily be changed such that 43 the system's mathematical properties can be brought 44 in agreement with the mean-field limit of the Bose-45 Hubbard dimer. 46

47 The article is organised as follows. We will intro-48 duce and solve the Gross-Pitaevskii equation of a 49 Bose-Einstein condensate in a double- δ trap for an 50 attractive atom-atom interaction in Section 2. Some 51 properties of the stationary solutions which are im-52 portant for the following discussions are recapitulated. 53 Then we will investigate the ground state's stability 54 in the vicinity of the bifurcation in Section 3. The 55 Bogoliubov-de Gennes equations are solved for both 56 57 types of the nonlinearity, and the origin of the discrepancy between the bifurcation and the stability change 58 59 is discussed. Conclusions are drawn in Section 4. 60

2. Bose-Einstein condensates in the \mathcal{PT} symmetric double- δ trap

We assume the condensate to be trapped in an idealised trap of two delta functions, i.e. the potential has the shape [8]

$$V(x) = -(1 - i\gamma) \,\delta(x - b) - (1 + i\gamma) \,\delta(x + b) \,, (1)$$

where the units are chosen such that the real part due to the action of the δ functions has the value -1. It describes two symmetric infinitely thin potential wells at positions $\pm b$. In the left well we describe an outflux of atoms by a negative imaginary contribution $-i\gamma$, and on the right side an influx of particles is described by a positive imaginary part $+i\gamma$ of the same strength. This leads to the time-independent Gross-Pitaevskii equation in dimensionless form [8],

$$\left[-\frac{\mathrm{d}^{2}}{\mathrm{d}x^{2}}-(1-\mathrm{i}\gamma)\,\delta\left(x-b\right)-(1+\mathrm{i}\gamma)\,\delta\left(x+b\right)\right]$$

$$+g|\psi(x)|^{2}\bigg]\psi(x) = -\kappa^{2}\psi(x) \quad (2)$$

with the energy eigenvalue or chemical potential $\mu = -\kappa^2$. The parameter g is determined by the s-wave scattering length, which effectively describes the van der Waals interaction for low temperatures and densities. Physically it can be tuned via Feshbach resonances. Throughout this article we assume g to be negative, i.e. the atom-atom interaction is attractive.

Solutions to the Gross-Pitaevskii equation are found 93 94 with a numerical exact integration. The wave function is integrated outward from x = 0 in positive 95 96 and negative direction. To do so the initial values 97 $\psi(0), \psi'(0)$, and κ have to be chosen. The arbitrary 98 global phase is exploited such that $\psi(0)$ is chosen to be 99 real. Together with $\psi'(0) \in \mathbb{C}$ and $\kappa \in \mathbb{C}$ we have five 100 parameters which have to be set such that physically 101 relevant wave functions are obtained. These have to 102 be square-integrable and normalised in the nonlinear 103 system. The five conditions $\psi(\infty) \to 0$, $\psi(-\infty) \to 0$, 104 and $||\psi|| = 1$ ensure that these conditions are fulfilled, and, together with the five initial parameters, define a 105 106 five-dimensional root search problem, which is solved 107 numerically.




Figure 1: Real (a) and imaginary (b) parts of the 22 stationary solutions found for the Gross-Pitaevskii 23 equation (2) for the case g = -1 (red solid lines), 24 which is compared with its linear counterpart q =25 0 (green dashed lines) and the weaker interaction 26 q = -0.5 (blue dotted lines). In the nonlinear case 27 we observe two complex conjugate states bifurcating 28 from the ground state in a pitchfork bifurcation. For 29 g = -1 this occurs at $\gamma_{\kappa} \approx 0.3071$. 30

108 Figure 1 shows a typical example for all station-109 ary states found in the case q = -1 (red solid lines). 110 Two states with purely real eigenvalues vanish for 111 increasing γ in an exceptional point. Since κ is plotted and $\mu = -\kappa^2$ is the energy eigenvalue, the upper 112 line corresponds to the ground state. Two complex 113 114 and complex conjugate eigenvalues bifurcate from this ground state in a pitchfork bifurcation at a critical 115 value $\gamma_{\kappa} \approx 0.3071$. The same plots for g = -0.5 (blue 116 117 dotted lines) and g = 0 (green dashed lines) demonstrate how the pitchfork bifurcation is introduced by 118 119 the nonlinearity.

This eigenvalue structure is very generic for \mathcal{PT} 32 symmetric systems with a quadratic term in the Hamil-33 tonian. It is found for Bose-Einstein condensates in a 34 true spatially extended double well in one and three 35 dimensions [11, 12] which contain the nonlinearity 36 $\propto |\psi|^2$ as well as for the mean-field limit of the Bose-37 Hubbard dimer [14–17] with a term $\propto |\psi|^2/||\psi|^2$. The 38 difference in the norm-dependency of the nonlinearity 39 between both systems does not lead to different eigen-40 values, which has already been mentioned [17]. The 41 difference appears, however, for the dynamics, where 42 the norm plays a crucial role in the presence of gain 43 and loss [13]. 44

3. Stability analysis of the 46 GROUND STATE 47

48 The linear stability is analysed with the Bogoliubov-de 49 Gennes equations. They are derived under the assump-50 tion that a stationary state $\psi_0(x,t)$ is perturbed by a 51 small fluctuation $\theta(x, t)$, i.e. 52

58 With this ansatz and a linearisation in the small quan-59 tities u and v one obtains from the Gross-Pitaevskii 60

equation the coupled system of the Bogoliubov-de Gennes differential equations,

$$\frac{d^2}{dx^2}u(x) = \left[-(1+i\gamma)\,\delta\,(x+b) - (1-i\gamma)\,\delta\,(x-b) + \kappa^2 - \omega + 2g|\psi_0(x)|^2\right]u(x) + g\psi_0(x)^2v(x) ,$$
(4a)

$$\frac{\mathrm{d}^2}{\mathrm{d}x^2}v(x) = \left[-(1-\mathrm{i}\gamma)\,\delta\,(x+b) - (1+\mathrm{i}\gamma)\,\delta\,(x-b) + (\kappa^2)^* + \omega + 2g|\psi_0(x)|^2\right]v(x) + g\psi_0^*(x)^2u(x) \,.$$

In Equation (3b) it can be seen that ω decides on the temporal evolution of the fluctuation. Real values of ω describe stable oscillations, whereas imaginary parts lead to a growth or decay of the fluctuation's amplitude. Thus, ω measures the stability of the stationary solution ψ_0 against small fluctuations.

Numerically the Bogoliubov-de Gennes equations are solved with the same method as the stationary states, i.e. the wave functions u and v are integrated outward from x = 0. It can easily be seen that the Bogoliubov-de Gennes equations (4) are invariant under the transformation $u(x) \rightarrow u(x)e^{i\chi}$, $v(x) \to v(x) e^{i\chi}$ with a real phase χ . Similarly to the procedure for the integration of the stationary states this symmetry can be exploited. The remaining initial values with which the integration has to be started are $u(0) \in \mathbb{C}$, $\operatorname{Re}(v(0))$, $u'(0) \in \mathbb{C}$, $v'(0) \in \mathbb{C}$, $\omega \in \mathbb{C}$. In a nine-dimensional root search they have to be chosen such that the conditions $u(\pm \infty) \to 0, v(\pm \infty) \to 0$, and

$$\int_{-\infty}^{\infty} |u(x) + v^*(x)|^2 \, \mathrm{d}x = 1$$

are fulfilled [11].

Two further symmetries can be exploited to reduce the number of independent stability eigenvalues which have to be calculated. The replacement $(u, v, \omega) \rightarrow (v^*, u^*, -\omega^*)$ leaves the ansatz (3b) invariant. Thus, if ω is a stability eigenvalue also $-\omega^*$ is a valid solution. Furthermore for every eigenvalue ω there is also one solution with the eigenvalue ω^* if the stationary state ψ_0 is \mathcal{PT} symmetric. This can be verified by applying the \mathcal{PT} operator to the Bogoliubov-de Gennes equations (4). Due to these two symmetries it is sufficient to search for stability 107 eigenvalues with $\operatorname{Re}(\omega) > 0$ and $\operatorname{Im}(\omega) > 0$.

3.1. Stability in the vicinity of the BIFURCATION




Figure 2: Real (red solid line) and imaginary (green 15 dashed line) part of the stability eigenvalue ω for the 16 stationary ground state in the case g = -1. The 17 stability change occurs at $\gamma_{\omega} \approx 0.3138$. To illustrate 18 the pitchfork bifurcation the real parts of κ of all 19 stationary states are also shown (blue dotted lines). 20 The value $\gamma_{\kappa} \approx 0.307$ is marked by the black dashed-21 dotted line. Obviously there is a discrepancy between 22 both values. 23

112 The relevant question which has to be answered by our 113 calculation is whether or not the discrepancy between 114 the γ values of the pitchfork bifurcation and the stability change appears for the double- δ potential. Thus 115 116 we calculated the stability eigenvalue with $\operatorname{Re}(\omega) > 0$, 117 $\operatorname{Im}(\omega) > 0$ for a range of γ around the bifurcation, which is shown in Figure 2 for q = -1. For increasing 118 119 γ the eigenvalue ω switches from real to imaginary 120

²⁵ at $\gamma_{\omega} \approx 0.3138$ marking the stability change. The ²⁶ pitchfork bifurcation is visible in the real parts of κ ²⁷ of all stationary states of the system. It is marked ²⁸ by the black dashed-dotted line. Obviously there is a ²⁹ discrepancy between γ_{κ} and γ_{ω} . The difference

$$\Delta \gamma = \gamma_{\kappa} - \gamma_{\omega} \tag{5}$$

is $\Delta \gamma \approx -0.0067$.

34 The system does not possess any further stationary states besides those shown in Figure 1. Three of 35 these four states are participating in the pitchfork 36 bifurcation. Only the excited \mathcal{PT} symmetric solution 37 would be able to influence the dynamics of the ground 38 state at a value $\gamma \neq \gamma_{\omega}$. However, it stays real for all 39 parameters γ shown in Figure 2 and cannot cause any 40 qualitative different behaviour of the ground state's 41 dynamics. Thus, an influence of further states can be 42 ruled out to be the reason for the discrepancy in the 43 double-well system of Refs. [11, 12]. 44

The remaining difference between the Gross-45 Pitaevskii equation (2) and the two mode system 46 of Refs. [14–17] is the norm-dependency of the non-47 linearity. Indeed, an influence of the norm is already 48 present if the study done in Figure 2 is repeated for dif-49 ferent values of the nonlinearity parameter q. Figure 50 3 shows $\Delta \gamma$ as a function of q. A strong dependency 51 is visible. Even the sign changes. For $g \lesssim 0.4$ the 52 ground state becomes unstable at $\gamma_{\omega} < \gamma_{\kappa}$. For $g \to 0$ 53 the discrepancy vanishes as expected. 54

3.2. NORM-INDEPENDENT VARIANT OF THE GROSS-PITAEVSKII EQUATION

equation (2) can be given with a small modification. The replacement

$$g|\psi|^2 \to \frac{g|\psi|^2}{\int |\psi|^2 dx} \tag{6}$$

makes the Gross-Pitaevskii equation (2) normindependent. Note that this is exactly the form of the mean-field limit of Refs. [14–17]. Since the stationary states are normalised to 1 they are not influenced by the replacement. However, it influences the dynamics and also the linear stability. The Bogoliubov-de Gennes equations have to be adapted. Assuming again a small perturbation of the form (3a) and (3b) a linearisation in u and v leads us to

 $\frac{\mathrm{d}^2}{\mathrm{d}x^2}v(x) = \left[-(1-\mathrm{i}\gamma)\,\delta\,(x+b) - (1+\mathrm{i}\gamma)\,\delta\,(x-b) + (\kappa^2)^* + \omega + 2a|\psi_0(x)|^2\right]v(x) + a\psi_*^*(x)^2u(x)$

with the integral

For a numerical solution of the modified Bogoliubovde Gennes equations the value of S is included in the root search. i.e. for the integration of the Equations (7a) and (7c) a value for S is guessed and subsequently compared with the result of Equation (7c). Since S is in general a complex value this increases the dimension of the root search to 11.

An example for a typical result is shown in Figure 114 4. The discrepancy between the γ values at which the 115 pitchfork bifurcation and the stability change occur 116 vanishes. Both values agree as it is expected for a 117 pitchfork bifurcation. This is true for all values of g. 118 Thus, we conclude that the discrepancy appearing in 119 120



Figure 2 for the Gross-Pitaevskii equation is solely a result of the norm-dependent nonlinearity $\propto |\psi|^2$ in the Hamiltonian and is not a consequence of the interaction with higher excited states.

²⁵ **3.3.** DISCUSSION

19

26 The reason why the stability change does not occur 27 exactly at the bifurcation can also be understood in-28 tuitively. Figure 1 indicates that the value γ_{κ} of the 29 pitchfork bifurcation is not equal for all values of g. 30 For g = 0 there is no pitchfork bifurcation. The two 31 real eigenvalues κ vanish in a tangent bifurcation and 32 two complex eigenvalues emerge. Only for nonvanish-33 ing q the pitchfork bifurcation exists and moves to 34 smaller values of γ for increasing |g|. 35

If now the norm of a wave function changes, this 36 can also be understood as a variation of q, i.e. a wave 37 function with a norm $N = ||\psi||^2$ has the same effect as 38 a wave function with the norm 1 and a modified value 39 $\tilde{g} = Ng$. The values γ_{κ} of the pitchfork bifurcation is 40 obviously different for g and \tilde{g} . With this relation in 41 mind it is not surprising that a fluctuation changing 42 the norm of the wave function may cause a qualitative 43 change of the condensate's stability properties in the 44 vicinity of γ_{κ} . 45

46 47 **4.** CONCLUSIONS

48 We investigated the origin of the discrepancy between 49 the value of the gain/loss parameters, at which the 50 ground state of a Bose-Einstein condensate in a double-51 well trap passes through a pitchfork bifurcation and 52 at which its stability changes. In a naive expecta-53 tion these γ values should be identical. However, it 54 is found that this is not exactly fulfilled. Since this 55 discrepancy does not occur for a similar system, viz. 56 the mean-field limit of a Bose-Hubbard dimer [14–17], 57 we investigated the differences between the equations 58 describing both systems. It was found that the norm-59 dependency of the nonlinearity in the Hamiltonian 60

 $\propto |\psi|^2$ is unambiguously the origin of the discrepancy. It can be completely removed with the replacement $|\psi|^2 \rightarrow |\psi|^2/||\psi||^2$. An intuitive explanation can be given. Fluctuations which change the norm of a stationary state are able to shift the position γ_{κ} of the bifurcation.

Since the dynamical properties of the wave functions are crucial for an experimental observability of a \mathcal{PT} symmetric Bose-Einstein condensate it is important to know about all processes introducing possible instabilities. As has been shown in this article the stability relations are nontrivial close to branch points in condensate setups with gain and loss. The Gross-Pitaevskii has a norm-dependent nonlinearity, and therefore it should be clarified in future work, which type of fluctuation influences the wave function's norm such that additional instabilities appear. In particular, it would be interesting to see, how the amplitude of a fluctuation is related to the size of the difference $\Delta \gamma$. Also a deeper understanding, how this effect influences realistic setups generating the \mathcal{PT} symmetric external potential [34], would be of high value.
