# 1D area law with ground-state degeneracy

#### Abstract

An area law is proved for 1D spin systems with ground-state degeneracy. In particular, consider a chain of $d$-dimensional spins governed by a Hamiltonian with nearest-neighbor interaction. Suppose the ground states are $n$-fold (exactly) degenerate with $n=O(1)$, and are separated from excited states by an energy gap $\epsilon$. Then for any given cut there exists a ground state such that the entanglement entropy across the cut is upper bounded by $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right)$.


## 1 Introduction

It is conjectured that the entanglement of a region scales as its boundary (area law) in the ground state of a gapped quantum system. Hastings rigorously proves the area law in 1D (one-dimensional) spin systems by giving the upper bound $\exp (O((\log d) / \epsilon))$ on entanglement entropy [2], where $d$ is the dimension of each local spin and $\epsilon$ is the energy gap. The bound is recently improved to $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon^{3 / 2}\right)^{1]}$ [1, where $\tilde{O}(x)=O(x$ polylog$(x))$ hides a polylogarithmic factor.

The aforementioned proofs of the 1D area law assume a unique (nondegenerate) ground state. This paper proves an area law for 1D spin systems with ground-state degeneracy. Suppose the ground states are $n$-fold (exactly) degenerate with $n=O(1)$. Then for any given cut there exists a ground state such that the entanglement entropy across the cut is upper bounded by $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right)$, which even slightly improves the best known result (see above) for nondegenerate systems $(n=1)$.

One major technical contribution of this paper is a stronger version (Theorem (1) of the robustness theorem (Theorem 6.1 in [1), and then the improved bound follows. All complications due to degeneracy need to be taken care of. To simplify the presentation, assume $n=2$ (generalization to $n=O(1)$ is straightforward).

## 2 Approximate ground-state projector

This section generalizes the notion of approximate ground-state projector (AGSP) to nearly degenerate systems. Let $H$ be the Hamiltonian of a 1D spin system. Let $0 \leq \epsilon_{0} \leq \epsilon_{1} \leq \epsilon_{2}$ be the energies of the ground state $\left|\psi_{0}\right\rangle$, the first excited state $\left|\psi_{1}\right\rangle$, and the second excited state of $H$, respectively. Suppose $H$ is nearly 2 -fold degenerate in the sense that $\epsilon_{0} \approx \epsilon_{1}$, and define $\epsilon=\epsilon_{2}-\epsilon_{0}$ to be the energy gap. Let $G$ be the 2 -dimensional space spanned by $\left|\psi_{0,1}\right\rangle$. Fix a cut, and $R(|\psi\rangle)$ denotes the Schmidt rank of a state $|\psi\rangle$ across the cut.

[^0]A linear operator $K$ is a $(\delta, \Delta, D)$-AGSP if (i) for any normalized state $|\psi\rangle \in G$,

(ii) for any normalized state $|\psi\rangle \perp G$,

\end{equation*}

(iii) for any state $|\psi\rangle$,

\end{equation*}

Lemma 1. Let

\begin{equation*}
\mu_{\psi}^{2}=\left|\left\langle\psi_{0} \mid \psi\right\rangle\right|^{2}+\left|\left\langle\psi_{1} \mid \psi\right\rangle\right|^{2} . \tag{4}
\end{equation*}
$$

A $(\delta, \Delta, D)$-AGSP with $D \Delta \leq 1 / 10$ implies the existence of a normalized product state $|\psi\rangle$ across the cut such that

\mu_{\psi}^{2} \geq(9 / 10-\delta) / D \tag{5}
\end{equation*}
$$

Proof. The proof is similar to that of Lemma 2.2 in [1]. Let $K$ be such an AGSP and $|\psi\rangle$ be the optimal normalized product state in the sense that $\left|\mu_{\psi}\right| \geq\left|\mu_{\psi^{\prime \prime}}\right|$ for any normalized product state $\left|\psi^{\prime \prime}\right\rangle$. The optimal state $|\psi\rangle$ exists as the set of all normalized product states is compact. The states $|\psi\rangle$ and $|\phi\rangle=K|\psi\rangle$ can be decomposed as

|\psi\rangle=\mu_{\psi}\left|\psi^{\prime}\right\rangle+\sqrt{1-\mu_{\psi}^{2}}\left|\psi^{\perp}\right\rangle,|\phi\rangle=\mu^{\prime}\left|\phi^{\prime}\right\rangle+\mu^{\perp}\left|\phi^{\perp}\right\rangle, \tag{6}
\end{equation*}
$$

where $\left|\psi^{\prime}\right\rangle,\left|\phi^{\prime}\right\rangle \in G,\left|\psi^{\perp}\right\rangle,\left|\phi^{\perp}\right\rangle \in G^{\perp}$ are normalized states. The definition of $K$ implies

(1-\delta) \mu_{\psi}^{2} \leq\left|\mu^{\prime}\right|^{2} \leq \mu_{\psi}^{2},\left|\mu^{\perp}\right|^{2} \leq \Delta, \quad R(|\phi\rangle) \leq D \tag{7}

Let $|\Phi\rangle=|\phi\rangle / \|| | \phi\rangle \|$. Its Schmidt decomposition is given by $|\Phi\rangle=\sum_{i=1}^{D} \lambda_{i}\left|L_{i}\right\rangle\left|R_{i}\right\rangle$ with $\sum_{i} \lambda_{i}^{2}=1$. Then the Cauchy-Schwarz inequality implies

\left.\left.\left|\mu^{\prime}\right| / \|| | \phi\right\rangle \|=\left|\left\langle\phi^{\prime} \mid \Phi\right\rangle\right| \leq \sum_{i=1}^{D} \lambda_{i}\left|\left\langle\phi^{\prime} \mid L_{i}\right\rangle\right| R_{i}\right\rangle \mid \leq \sqrt{\left.\sum_{i=1}^{D}\left\langle\phi^{\prime} \mid L_{i}\right\rangle\left|R_{i}\right\rangle\right|^{2}} . \tag{8}
\end{equation*}

There exists an index $i$ such that

& \left.\mu_{\psi}^{2} \geq \mu_{\left|L_{i}\right\rangle\left|R_{i}\right\rangle}^{2} \geq\left|\left\langle\phi^{\prime} \mid L_{i}\right\rangle\right| R_{i}\right\rangle\left.\right|^{2} \geq\left|\mu^{\prime}\right|^{2} D^{-1} \||\phi\rangle \|^{-2}=\left|\mu^{\prime}\right|^{2} D^{-1}\left(\left|\mu^{\prime}\right|^{2}+\left|\mu^{\perp}\right|^{2}\right)^{-1} \\
& \geq(1-\delta) \mu_{\psi}^{2} D^{-1}\left(\mu_{\psi}^{2}+\Delta\right)^{-1} \Rightarrow 1 \geq(1-\delta) D^{-1}\left(\mu_{\psi}^{2}+\Delta\right)^{-1} \geq(1-\delta)\left(D \mu_{\psi}^{2}+1 / 10\right)^{-1} \\
& \Rightarrow \mu_{\psi}^{2} \geq(9 / 10-\delta) / D \tag{9}
\end{align*}

Let $u$ be an upper bound on $\|H\|$ (the maximum eigenvalue of $H$ ).
Lemma 2. There exists a polynomial $C_{\ell}$ of degree $\ell$ such that (i) $C_{\ell}\left(\epsilon_{0}\right)=1$; (ii) $1-\delta \leq C_{\ell}\left(\epsilon_{1}\right)^{2} \leq$ 1, where

\delta=4 \ell^{2}\left(\epsilon_{1}-\epsilon_{0}\right) /\left(u-\epsilon_{2}\right) . \tag{10}

(iii) $\left|C_{\ell}(x)\right|^{2} \leq \Delta$ for $\epsilon_{2} \leq x \leq u$, where

\Delta=4 \exp (-4 \ell \sqrt{\epsilon / u}) \tag{11}
\end{equation*}
$$

Proof. The Chebyshev polynomial $T_{\ell}(x)$ is defined as

$$

T_{\ell}(\cos \theta)=\cos (\ell \theta) . \tag{12}
\end{equation*}
$$

Clearly $\left|T_{\ell}(x)\right| \leq 1$ for $|x| \leq 1$. For $x \geq 1$, the definition reduces to $T_{\ell}(x)=\cosh (\ell t)$, where $t=\operatorname{arccosh} x \geq 0$. Then,

T_{\ell}(x) \geq \exp (\ell t) / 2 \geq \exp (2 \ell \tanh (t / 2)) / 2 \geq \exp (2 \ell \sqrt{(x-1) /(x+1)}) / 2 . \tag{13}
\end{equation*}

Moreover,

T_{\ell}^{\prime}(x) / T_{\ell}(x)=\ell \tanh (\ell t)(\mathrm{d} t / \mathrm{d} x)=\ell \tanh (\ell t) / \sinh t \leq \ell(\ell t) / t=\ell^{2} . \tag{14}

Define

C_{\ell}(x)=T_{\ell}(f(x)) / T_{\ell}\left(f\left(\epsilon_{0}\right)\right), \tag{15}
\end{equation*}
$$

where $f(x)=\left(u+\epsilon_{2}-2 x\right) /\left(u-\epsilon_{2}\right)$. Clearly $\left|C_{\ell}(x)\right| \leq 1 / T_{\ell}\left(f\left(\epsilon_{0}\right)\right)$ for $\epsilon_{2} \leq x \leq u$, and

\begin{equation*}
T_{\ell}\left(f\left(\epsilon_{0}\right)\right) \geq \exp \left(2 \ell \sqrt{\left(f\left(\epsilon_{0}\right)-1\right) /\left(f\left(\epsilon_{0}\right)+1\right)}\right) / 2=\exp \left(2 \ell \sqrt{\epsilon /\left(u-\epsilon_{0}\right)}\right) / 2 \geq \exp (2 \ell \sqrt{\epsilon / u}) / 2 \tag{16}
\end{equation*}
$$

Furthermore, there exists $\epsilon_{0} \leq \xi \leq \epsilon_{1}$ such that

& C_{\ell}\left(\epsilon_{1}\right)=C_{\ell}\left(\epsilon_{0}\right)-\left(\epsilon_{1}-\epsilon_{0}\right) C_{\ell}^{\prime}(\xi) \geq 1-\left(\epsilon_{1}-\epsilon_{0}\right) C_{\ell}^{\prime}(\xi) / C_{\ell}(\xi) \geq 1-2 \ell^{2}\left(\epsilon_{1}-\epsilon_{0}\right) /\left(u-\epsilon_{2}\right) \\
& \Rightarrow C_{\ell}\left(\epsilon_{1}\right)^{2} \geq 1-4 \ell^{2}\left(\epsilon_{1}-\epsilon_{0}\right) /\left(u-\epsilon_{2}\right), \tag{17}
\end{align*}
$$

as $C_{\ell}(x)$ is a decreasing function of $x$ for $x<\epsilon_{2}$.
Lemma 3. For any normalized state $|\psi\rangle$ satisfying $\langle\psi| H|\psi\rangle \leq \epsilon_{0}+b$, there exists a normalized state $|\phi\rangle \in G$ such that

\begin{equation*}
\||\psi\rangle-|\phi\rangle \|^{2} \leq 2 b / \epsilon \tag{18}
\end{equation*}
$$

Proof. The proof is similar to that of the Markov lemma (Lemma 6.4 in [1). The state $|\psi\rangle$ can be decomposed as

$$
\begin{equation*}
|\psi\rangle=a|\phi\rangle+\sqrt{1-a^{2}}\left|\phi^{\perp}\right\rangle, \tag{19}
\end{equation*}
$$

where $|\phi\rangle \in G,\left|\phi^{\perp}\right\rangle \perp G$ are normalized states, and $a \geq 0$. Then,

\begin{align*}
& \epsilon_{0}+\left(1-a^{2}\right) \epsilon=a^{2} \epsilon_{0}+\left(1-a^{2}\right) \epsilon_{2} \leq\langle\psi| H|\psi\rangle \leq \epsilon_{0}+b \Rightarrow 1-a^{2} \leq b / \epsilon \\
& \Rightarrow \||\psi\rangle-|\phi\rangle \|^{2}=2-2 a \leq 2\left(1-a^{2}\right) \leq 2 b / \epsilon . \tag{20}
\end{align*}
$$

## 3 Perturbation theory

Suppose the original Hamiltonian is $H^{\prime}=\sum_{i=1}^{n} H_{i}^{\prime}$, where $0 \leq H_{i}^{\prime} \leq 1$ acts on the spins $i$ and $i+1$. Define a new Hamiltonian

H=H_{L}+H_{1}+H_{2}+\cdots+H_{s}+H_{R} \tag{21}
\end{equation*}
$$

as (i)

$$
\begin{equation*}
H_{L}=\sum_{i=1}^{m} H_{i}^{\prime}-c, H_{R}=\sum_{i=m+s+1}^{n} H_{i}^{\prime}-c^{\prime}, \tag{22}
\end{equation*}
$$

where $c, c^{\prime}$ are the ground state energies of $\sum_{i=1}^{m} H_{i}^{\prime}, \sum_{i=m+s+1}^{n} H_{i}^{\prime}$, respectively; (ii) $H_{i}=H_{m+i}^{\prime}$ for $i=1, s$; (iii)

\begin{equation*}
H_{i}=H_{m+i}^{\prime}-c^{\prime \prime} /(s-2) \tag{23}
\end{equation*}
$$

for $2 \leq i \leq s-1$, where $c^{\prime \prime}$ is the ground state energy of $\sum_{i=2}^{s-1} H_{i}^{\prime}$.
Clearly, (a) $H_{L, R} \geq 0$, and the ground state energies of $H_{L, R}$ are 0 ; (b) $0 \leq H_{i} \leq 1$ for $i=1, s$; (c) $0 \leq \sum_{i=2}^{s-1} H_{i} \leq s-2$, and the ground state energy of $\sum_{i=2}^{s-1} H_{i}$ is 0 ; (c) the ground states (2-fold exactly degenerate) and the energy gaps of $H$ and $H^{\prime}$ are the same as $H-H^{\prime}$ is a multiple of identity.

Let $\epsilon_{0}=\epsilon_{1} \leq \epsilon_{2} \leq \cdots$ be the lowest eigenenergies of $H$, and define $\epsilon=\epsilon_{2}-\epsilon_{0}$ to be the energy gap of $H$. Let $G$ be the 2-dimensional ground state space of $H$. Let $P_{t}^{L, R}$ be the projection onto the space spanned by the eigenstates of $H_{L, R}$ with energies at most $t$. Define

H_{\bar{L}, R}^{\leq t}=P_{t}^{L, R} H_{L, R} P_{t}^{L, R}+t\left(1-P_{t}^{L, R}\right) \tag{24}
\end{equation*}
$$

Let $\epsilon_{0}^{\prime} \leq \epsilon_{1}^{\prime} \leq \epsilon_{2}^{\prime} \leq \cdots$ be the lowest eigenenergies of

H^{(t)}=H_{\bar{L}}^{\leq t}+H_{1}+H_{2}+\cdots+H_{s}+H_{\bar{R}}^{\leq t}, \tag{25}
\end{equation*}
$$

and define $\epsilon^{\prime}=\epsilon_{2}^{\prime}-\epsilon_{0}^{\prime}$ to be the energy gap of $H^{(t)}$. Let $\left|\phi_{0}^{(t)}\right\rangle,\left|\phi_{1}^{(t)}\right\rangle,\left|\phi_{2}^{(t)}\right\rangle$ be the ground state, the first excited state, and the second excited state of $H^{(t)}$. Clearly $H^{(t)} \leq H$ and $H^{(t)} \leq 2 t+s$.
Lemma 4.

$$
\begin{equation*}
\epsilon_{0}^{\prime} \leq \epsilon_{0} \leq 2, \quad \epsilon_{2}^{\prime} \leq \epsilon_{2} \leq 20 \tag{26}
\end{equation*}
$$

Proof. Let $\left|\psi_{L}\right\rangle,\left|\psi_{M}\right\rangle,\left|\psi_{R}\right\rangle,\left|\phi_{R}\right\rangle$ be the ground states of $H_{L}, \sum_{i=2}^{s-1} H_{i}, H_{R}, \sum_{i=4}^{s} H_{i}+H_{R}$, respectively. Let $|\Psi\rangle \in G$ be a ground state of $H$, and

\left|\psi_{L M R}\right\rangle=\left|\psi_{L}\right\rangle\left|\psi_{M}\right\rangle\left|\psi_{R}\right\rangle,\left|\psi_{L R}^{0,1,2}\right\rangle=\left|\psi_{L}\right\rangle\left|\phi_{M}^{0,1,2}\right\rangle\left|\phi_{R}\right\rangle \tag{27}
\end{equation*}
$$

where

\begin{equation*}
\left|\phi_{M}^{0}\right\rangle=|00\rangle,\left|\phi_{M}^{1}\right\rangle=|01\rangle,\left|\phi_{M}^{2}\right\rangle=|10\rangle \tag{28}
\end{equation*}
$$

are pairwise orthogonal states of the spins $m+2$ and $m+3$. Then,

& \epsilon_{0} \leq\left\langle\psi_{L M R}\right| H\left|\psi_{L M R}\right\rangle \\
& =\left\langle\psi_{L}\right| H_{L}\left|\psi_{L}\right\rangle+\left\langle\psi_{M}\right| \sum_{i=2}^{s-1} H_{i}\left|\psi_{M}\right\rangle+\left\langle\psi_{R}\right| H_{R}\left|\psi_{R}\right\rangle+\left\langle\psi_{L M R}\right| A\left|\psi_{L M R}\right\rangle \leq\|A\| \leq 2 \\
& \left\langle\psi_{L R}^{0,1,2}\right| H\left|\psi_{L R}^{0,1,2}\right\rangle=\left\langle\psi_{L}\right| H_{L}\left|\psi_{L}\right\rangle+\left\langle\psi_{L R}^{0,1,2}\right| H_{1}+H_{2}+H_{3}\left|\psi_{L R}^{0,1,2}\right\rangle+\left\langle\phi_{R}\right| \sum_{i=4}^{s} H_{i}+H_{R}\left|\phi_{R}\right\rangle \\
& \leq\langle\Psi| H_{L}|\Psi\rangle+\langle\Psi| H_{1}+H_{2}+H_{3}|\Psi\rangle+3+\langle\Psi| \sum_{i=4}^{s} H_{i}+H_{R}|\Psi\rangle \leq\langle\Psi| H|\Psi\rangle+3=\epsilon_{0}+3( \tag{29}
\end{align*}
$$

Lemma 3 implies that $\left|\psi_{L R}^{0,1,2}\right\rangle$ are close to the 2-dimensional space $G$ (this is impossible because they are pairwise orthogonal) unless $\epsilon_{2} \leq 20$.

Let

A=H_{1}+H_{s} . \tag{30}
\end{equation*}

Clearly the operators $H_{L, R}, H-A, H^{(t)}-A$ have a common complete set of eigenstates. Let $P_{t}$ be the projection onto the space spanned by the eigenstates of $H-A$ with energies at most $t$. Then,

H_{L, R} P_{t}=H_{L, R}^{\leq t} P_{t} \Rightarrow H^{(t)} P_{t}=H P_{t} . \tag{31}
\end{equation*}

Let $\left|\phi^{(r)}\right\rangle$ be an eigenstate of $H^{(r)}$ with energy $\epsilon^{(r)}$.

## Lemma 5.

\left.\|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \|^{2} \leq\left|\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) A P_{t}\right| \phi^{(r)}\right\rangle \mid /\left(\min \{r, t\}-\epsilon^{(r)}\right) . \tag{32}
\end{equation*}
$$

Proof.

\begin{align*}
& \epsilon^{(r)}=\left\langle\phi^{(r)}\right| H^{(r)}\left|\phi^{(r)}\right\rangle=\left\langle\phi^{(r)}\right| P_{t} H^{(r)}\left|\phi^{(r)}\right\rangle+\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) H^{(r)}\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \\
& +\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) H^{(r)} P_{t}\left|\phi^{(r)}\right\rangle \geq \epsilon^{(r)}\left\langle\phi^{(r)}\right| P_{t}\left|\phi^{(r)}\right\rangle+\left\langle\phi^{(r)}\right|\left(1-P_{t}\right)\left(H^{(r)}-A\right)\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \\
& +\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) A P_{t}\left|\phi^{(r)}\right\rangle+\left\langle\phi^{(r)}\right|\left(1-P_{t}\right)\left(H^{(r)}-A\right) P_{t}\left|\phi^{(r)}\right\rangle \\
& \geq \epsilon^{(r)} \| P_{t}\left|\phi^{(r)}\right\rangle\left\|^{2}+\min \{r, t\}\right\|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \|^{2}+\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) A P_{t}\left|\phi^{(r)}\right\rangle \\
& \left.\geq \epsilon^{(r)}\left(1-\|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \|^{2}\right)+\min \{r, t\} \|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \|^{2}-\left|\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) A P_{t}\right| \phi^{(r)}\right\rangle \mid . \tag{33}
\end{align*}

The proof is completed by rearrangement.
Let $r, t>100$ and $\epsilon^{(r)}<30$.

## Lemma 6.

$$

\|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \| \leq 2^{-\Omega(t)} \tag{34}
\end{equation*}
$$

Proof. The proof is similar to that of the truncation lemma (Lemma 6.7 in [1). In particular, it is an induction on $t$ by keeping $r$ fixed. Following the notations of [1], I just point out the difference (the remainder of the two proofs is identical). Lemma 5 implies

\left.\|\left(1-P_{t}\right)\left|\phi^{(r)}\right\rangle \|^{2} \leq\left|\left\langle\phi^{(r)}\right|\left(1-P_{t}\right) A P_{t}\right| \phi^{(r)}\right\rangle \mid /\left(\min \{r, t\}-\epsilon^{(r)}\right), \tag{35}
\end{equation*}
$$

where $t=s+n_{0} d$. Clearly the denominator on the right-hand side is larger than 50 .
Let

\left|\phi^{(t), t}\right\rangle=P_{t}\left|\phi^{(t)}\right\rangle / \| P_{t}\left|\phi^{(t)}\right\rangle \| . \tag{36}
\end{equation*}

## Lemma 7.

\left\langle\phi^{(t), t}\right| H\left|\phi^{(t), t}\right\rangle \leq \epsilon^{(t)}+2^{-\Omega(t)} . \tag{37}
\end{equation*}
$$

Proof.

$$
\begin{align*}
& \epsilon^{(t)}=\left\langle\phi^{(t)}\right| H^{(t)}\left|\phi^{(t)}\right\rangle \geq\left\langle\phi^{(t)}\right| P_{t} H^{(t)} P_{t}\left|\phi^{(t)}\right\rangle+\left\langle\phi^{(t)}\right| P_{t} H^{(t)}\left(1-P_{t}\right)\left|\phi^{(t)}\right\rangle \\
& +\left\langle\phi^{(t)}\right|\left(1-P_{t}\right) H^{(t)} P_{t}\left|\phi^{(t)}\right\rangle=\left\langle\phi^{(t)}\right| P_{t} H P_{t}\left|\phi^{(t)}\right\rangle+\left\langle\phi^{(t)}\right| P_{t} A\left(1-P_{t}\right)\left|\phi^{(t)}\right\rangle \\
& +\left\langle\phi^{(t)}\right|\left(1-P_{t}\right) A P_{t}\left|\phi^{(t)}\right\rangle \geq\left\langle\phi^{(t)}\right| P_{t} H P_{t}\left|\phi^{(t)}\right\rangle-2 \| A P_{t}\left|\phi^{(t)}\right\rangle\|\cdot\|\left(1-P_{t}\right)\left|\phi^{(t)}\right\rangle \| \\
& \geq\left\langle\phi^{(t)}\right| P_{t} H P_{t}\left|\phi^{(t)}\right\rangle-2^{-\Omega(t)} \Rightarrow\left\langle\phi^{(t), t}\right| H\left|\phi^{(t), t}\right\rangle \leq\left(\epsilon^{(t)}+2^{-\Omega(t)}\right) / \| P_{t}\left|\phi^{(t)}\right\rangle \|^{2} \\
& =\left(\epsilon^{(t)}+2^{-\Omega(t)}\right) /\left(1-2^{-\Omega(t)}\right)=\epsilon^{(t)}+2^{-\Omega(t)} . \tag{38}
\end{align*}
$$

Theorem 1. Let $t \geq c \log (1 / \epsilon)$ for sufficiently large $c=O(1)$. (a)

$$
\begin{equation*}
\left|\epsilon_{0,1}^{\prime}-\epsilon_{0}\right| \leq 2^{-\Omega(t)} ; \tag{39}
\end{equation*}
$$

(b) there exist $\left|\psi_{0,1}^{0}\right\rangle \in G$ such that

$$
\begin{equation*}
\|\left|\psi_{0,1}^{0}\right\rangle-\left|\phi_{0,1}^{(t)}\right\rangle \|^{2} \leq 2^{-\Omega(t)} ; \tag{40}
\end{equation*}
$$

(c) $\epsilon^{\prime} \geq \epsilon / 10$.

Proof. Lemma 7 implies

$$
\begin{align*}
& \epsilon_{0,1}^{\prime} \leq \epsilon_{0} \leq\left\langle\phi_{0,1}^{(t), t}\right| H\left|\phi_{0,1}^{(t), t}\right\rangle \leq \epsilon_{0,1}^{\prime}+2^{-\Omega(t)}  \tag{41}\\
& \left\langle\phi_{2}^{(t), t}\right| H\left|\phi_{2}^{(t), t}\right\rangle \leq \epsilon_{2}^{\prime}+2^{-\Omega(t)}=\epsilon_{0}^{\prime}+\epsilon^{\prime}+2^{-\Omega(t)} \leq \epsilon_{0}+\epsilon^{\prime}+2^{-\Omega(t)} . \tag{42}
\end{align*}
$$

(a) follows from (41). Lemma 3 implies the existence of $\left|\psi_{0,1,2}^{0}\right\rangle \in G$ such that

$$
\begin{equation*}
\|\left|\phi_{0,1}^{(t), t}\right\rangle-\left|\psi_{0,1}^{0}\right\rangle\left\|^{2} \leq 2^{-\Omega(t)} / \epsilon=2^{-\Omega(t)-\log (1 / \epsilon)},\right\|\left|\phi_{2}^{(t), t}\right\rangle-\left|\psi_{2}^{0}\right\rangle \|^{2} \leq \epsilon^{\prime} / \epsilon+2^{-\Omega(t)} / \epsilon . \tag{43}
\end{equation*}
$$

Lemma 6 implies

$$
\begin{equation*}
\|\left|\phi_{0,1}^{(t)}\right\rangle-\left|\phi_{0,1}^{(t), t}\right\rangle \|^{2} \leq 2^{-\Omega(t)} . \tag{44}
\end{equation*}
$$

(b) follows from (43), (44) as $t \geq c \log (1 / \epsilon)$. Moreover, as $\left|\phi_{0,1,2}^{(t)}\right\rangle$ are pairwise orthogonal, $\left|\psi_{0,1,2}^{0}\right\rangle$ are approximately pairwise orthogonal (this is impossible because they are in the 2-dimensional space $G$ ) unless $\epsilon^{\prime} \geq \epsilon / 10$.

## 4 Area law

Lemma 8 ([1]). Let $K=C_{\ell}(H)$, where $C_{\ell}$ is an arbitrary polynomial of degree $\ell$. For any state $|\psi\rangle$,

$$
\begin{equation*}
R(K|\psi\rangle) \leq(d \ell)^{O(\max \{\ell / s, \sqrt{\ell}\})} R(|\psi\rangle) . \tag{45}
\end{equation*}
$$

To construct an AGSP for $H^{\left(t_{0}\right)}$, let $\ell=s^{2}$ and $u=2 t_{0}+s$. Lemmas 218 imply

$$
\begin{equation*}
D \Delta \leq 4(d s)^{O(s)} \exp \left(-4 s^{2} \sqrt{\epsilon / u}\right) \leq 4(d s)^{O(s)} \exp \left(-4 s^{2} \sqrt{\epsilon /\left(2 t_{0}+s\right)}\right) . \tag{46}
\end{equation*}
$$

A little algebra shows that the condition $D \Delta<1 / 100$ for $t_{0}=O(\log (1 / \epsilon))$ can be satisfied with $s=\tilde{O}\left(\left(\log ^{2} d\right) / \epsilon\right)$ so that $\log D=\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right)$. Let $t_{0}=O(\log (1 / \epsilon)+\log \log d)$ so that

$$
\begin{equation*}
\delta \leq O\left(\ell^{2} 2^{-\Omega\left(t_{0}\right)} /\left(2 t_{0}+s\right)\right) \leq \tilde{O}\left(2^{-\Omega\left(t_{0}\right)} \log ^{6} d / \epsilon^{3}\right)<1 / 10 . \tag{47}
\end{equation*}
$$

Let $t_{i}=i c+t_{0}$ with $c=O(1)$ so that $\Omega\left(t_{i}\right) \geq i+4$ for the $\Omega$ in Theorem 1 .
Lemma 9. There exists a convergent sequence of states $\left|\psi_{0}\right\rangle,\left|\psi_{1}\right\rangle, \ldots$ satisfying: (i)

$$
\begin{equation*}
\left|\left\langle\phi_{0}^{\left(t_{i}\right)} \mid \psi_{i}\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{i}\right)} \mid \psi_{i}\right\rangle\right|^{2} \geq 1-2^{-i-4} ; \tag{48}
\end{equation*}
$$

(ii) Letting $\ell_{j}=O\left(\sqrt{\left(t_{j}+s\right) / \epsilon}\right)$,

$$
\begin{equation*}
\log R\left(\left|\psi_{0}\right\rangle\right)=\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right), \quad \log R\left(\left|\psi_{i}\right\rangle\right)=\log R\left(\left|\psi_{0}\right\rangle\right)+\sum_{j=1}^{i} \tilde{O}\left(\ell_{j} \log d\right) ; \tag{49}
\end{equation*}
$$

(iii) Letting $\left|\psi_{\infty}\right\rangle=\lim _{i \rightarrow+\infty}\left|\psi_{i}\right\rangle \in G$,

$$
\begin{equation*}
\left|\left\langle\psi_{i} \mid \psi_{\infty}\right\rangle\right| \geq 1-O\left(2^{-i}\right) \tag{50}
\end{equation*}
$$

Proof. Theorem $\square$ implies the existence of $\left|\psi_{0,1}^{\left(t_{i}\right)}\right\rangle \in G$ such that

$$
\begin{equation*}
\|\left|\psi_{0,1}^{\left(t_{i}\right)}\right\rangle-\left|\phi_{0,1}^{\left(t_{i}\right)}\right\rangle \|^{2} \leq 2^{-(i+4)} \tag{51}
\end{equation*}
$$

for all $i$. The AGSP $K=C_{\ell}\left(H^{\left(t_{0}\right)}\right)$ constructed above implies the existence of a normalized product state $|\psi\rangle$ such that

$$
\begin{equation*}
\left|\left\langle\phi_{0}^{\left(t_{0}\right)} \mid \psi\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{0}\right)} \mid \psi\right\rangle\right|^{2} \geq(9 / 10-\delta) / D \tag{52}
\end{equation*}
$$

The condition $D \Delta<1 / 100$ implies that $\left|\psi_{0}\right\rangle=K|\psi\rangle / \| K|\psi\rangle \|$ satisfies

$$
\begin{equation*}
\left|\left\langle\phi_{0}^{\left(t_{0}\right)} \mid \psi_{0}\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{0}\right)} \mid \psi_{0}\right\rangle\right|^{2} \geq 15 / 16, \quad \log R\left(\left|\psi_{0}\right\rangle\right)=\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right) \tag{53}
\end{equation*}
$$

Then $\left|\psi_{i}\right\rangle$ and (i) can be defined and proved by induction. (51) is a quantitative statement that the space spanned by $\left|\phi_{0,1}^{\left(t_{i}\right)}\right\rangle$ is close to $G$. It implies that the spaces spanned by $\left|\phi_{0,1}^{\left(t_{i}\right)}\right\rangle$ and spanned by $\left|\phi_{0,1}^{\left(t_{i-1}\right)}\right\rangle$ are also close. Thus the induction hypothesis implies

$$
\begin{equation*}
\left|\left\langle\phi_{0}^{\left(t_{i-1}\right)} \mid \psi_{i-1}\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{i-1}\right)} \mid \psi_{i-1}\right\rangle\right|^{2} \geq 1-2^{-i-3} \Rightarrow\left|\left\langle\phi_{0}^{\left(t_{i}\right)} \mid \psi_{i-1}\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{i}\right)} \mid \psi_{i-1}\right\rangle\right|^{2} \geq 1-2^{-i} . \tag{54}
\end{equation*}
$$

Let $\ell_{i}=O\left(\sqrt{\left(t_{i}+s\right) / \epsilon}\right)$. Lemmas 2/8 imply the existence of a $(\delta, 1 / 100, D)$-AGSP $K$ for $H^{\left(t_{i}\right)}$ with $\log D=\tilde{O}\left(\ell_{i} \log d\right)$ and

$$
\begin{equation*}
\delta \leq O\left(\ell^{2} 2^{-\Omega\left(t_{i}\right)} /\left(t_{i}+s\right)\right)=O\left(2^{-\Omega\left(t_{0}\right)} / \epsilon\right) 2^{-i} \leq 2^{-i} / 10 . \tag{55}
\end{equation*}
$$

Let $\left|\psi_{i}\right\rangle=K\left|\psi_{i-1}\right\rangle / \| K\left|\psi_{i-1}\right\rangle \|$. Clearly,

$$
\begin{equation*}
\left|\left\langle\phi_{0}^{\left(t_{i}\right)} \mid \psi_{i}\right\rangle\right|^{2}+\left|\left\langle\phi_{1}^{\left(t_{i}\right)} \mid \psi_{i}\right\rangle\right|^{2} \geq 1-2^{-i-4} \tag{56}
\end{equation*}
$$

and (ii) follows. (54) and $\delta=O\left(2^{-i}\right)$ imply

$$
\begin{equation*}
\|\left|\psi_{i}\right\rangle-\left|\psi_{i-1}\right\rangle \|^{2}=O\left(2^{-i}\right) \tag{57}
\end{equation*}
$$

Thus the sequence $\left|\psi_{0}\right\rangle,\left|\psi_{1}\right\rangle, \ldots$ is convergent, and

$$
\begin{equation*}
\left|\left\langle\psi_{i} \mid \psi_{\infty}\right\rangle\right| \geq 1-\|\left|\psi_{i}\right\rangle-\left|\psi_{\infty}\right\rangle \|^{2} / 2 \geq 1-O\left(2^{-i}\right) \tag{58}
\end{equation*}
$$

Theorem 2. For any given cut there exists a ground state such that the entanglement entropy across the cut is upper bounded by $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right)$.
Proof. Let $\lambda_{i}$ be the Schmidt coefficients of $\left|\psi_{\infty}\right\rangle$ across the cut. Then

$$
\begin{equation*}
1-p_{i}=\sum_{i=1}^{R\left(\left|\psi_{i}\right\rangle\right)} \lambda_{i}^{2} \geq\left|\left\langle\psi_{i} \mid \psi_{\infty}\right\rangle\right|^{2} \geq 1-O\left(2^{-i}\right) \tag{59}
\end{equation*}
$$

The entanglement entropy of $\left|\psi_{\infty}\right\rangle$ is upper bounded by

$$
\begin{align*}
& \sum_{i} p_{i} \log \left(R\left(\left|\psi_{i}\right\rangle\right)-R\left(\left|\psi_{i-1}\right\rangle\right)\right)-\sum_{i} p_{i} \log p_{i} \leq \sum_{i} p_{i} \log R\left(\left|\psi_{i}\right\rangle\right)+O(1) \\
& =\sum_{i} p_{i} \sum_{j=1}^{i} \tilde{O}\left(\ell_{j} \log d\right)+\sum_{i} p_{i} \log R\left(\left|\psi_{0}\right\rangle\right)=\sum_{i} p_{i} \sum_{j=1}^{i} \tilde{O}\left(\sqrt{\left(t_{j}+s\right) / \epsilon} \log d\right) \\
& +O\left(\log R\left(\left|\psi_{0}\right\rangle\right)\right)=\tilde{O}\left(\sqrt{\left(t_{0}+s\right) / \epsilon} \log d\right)+O\left(\log R\left(\left|\psi_{0}\right\rangle\right)\right)=\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right) \tag{60}
\end{align*}
$$

## Appendix: Details on footnote 1

For nondegenerate systems $(n=1)$, the upper bound claimed in [1] on entanglement entropy is $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon\right)$. In my opinion, the proof in [1] of this claim is incomplete. In particular, in Lemma $6.3 t_{0}$ should be at least $O\left(\epsilon_{0} / \epsilon^{2}+1 / \epsilon\right)$ in order that the robustness theorem (Theorem 6.1) applies to $H^{\left(t_{0}\right)}$ (the robustness theorem does not guarantee that $H^{\left(t_{0}\right)}$ is gapped for $\left.t_{0}=O(1)\right)$. Then $s=\tilde{O}\left(\left(\log ^{2} d\right) / \epsilon\right)\left(\right.$ and $\left.\ell=s^{2}\right)$ does not give an AGSP for $H^{\left(t_{0}\right)}$ with $D \Delta \leq 1 / 2$, but $s=$ $\tilde{O}\left(\left(\log ^{2} d\right) / \epsilon^{3 / 2}\right)$ does. A straightforward calculation shows that the upper bound $\tilde{O}\left(\left(\log ^{3} d\right) / \epsilon^{3 / 2}\right)$ follows from the proof in [1].

However, I have shown that the claim in [1] is correct (Theorem 2 also holds for $n=1$ ). This is because Theorem (as a stronger version of the robustness theorem) only requires $t \geq c \log (1 / \epsilon)$ for $c=O(1)$.
