# SPLITTING METAPLECTIC COVER GROUPS 

CHUN-HUI WANG


#### Abstract

If $\left(G_{1}, G_{2}\right)$ is a dual reductive pair of type I in $\operatorname{Sp}(W)$, it is known that the degree 8 metaplectic cover of $\operatorname{Sp}(W)$ splits over $G_{1} G_{2}$, with one obvious exception. In this paper we replace $G_{1} G_{2}$ by a larger subgroup obtained via similitude groups, and show that the degree 8 metaplectic cover splits, with the same obvious exception.


## 1. Statement of the results

Let $F$ be a non-archimedean local field of residue characteristic different from 2, and let $D$ be a division algebra over $F$ with an involution $\tau$ such that $F$ consists of all $\tau$-fixed points of $D$. We define $(W,\langle\rangle$,$) as a symplectic space over F$ of dimension $2 n$ with a tensor product decomposition

W=W_{1} \otimes_{D} W_{2}, \quad\langle,\rangle=\operatorname{Trd}_{D / F}\left(\langle,\rangle_{1} \otimes \tau\left(\langle,\rangle_{2}\right)\right)
$$

where $\left(W_{1},\langle,\rangle_{1}\right)$ is a right $\epsilon_{1}$-hermitian space over $D$ and $\left(W_{2},\langle,\rangle_{2}\right)$ is a left $\epsilon_{2}$-hermitian space over $D$ with $\epsilon_{1} \epsilon_{2}=-1$. We let $\mathrm{U}\left(W_{i}\right)$ be the group of isometries of $\left(W_{i},\langle,\rangle_{i}\right)$, and $\mathrm{GU}\left(W_{i}\right)$ the group of similitudes of $\left(W_{i},\langle,\rangle_{i}\right)$. In [10, p.15], it was shown that except the case $\epsilon_{1}=1, \epsilon_{2}=-1$, and $W_{2}=$ the quaternion algebra over $F$, the pair $\left(\mathrm{U}\left(W_{1}\right), \mathrm{U}\left(W_{2}\right)\right)$ is the so-called irreducible dual reductive pair of type I in the sense of Howe.

Denote by $\mu_{8}$ the cyclic group of the roots of unity in $\mathbb{C}$ of order 8 . To a non-trivial element [ $c_{R a o}$ ] of order 2 in the measurable cohomology group $\mathrm{H}^{2}\left(\mathrm{Sp}(W), \mu_{8}\right)$ is associated a central extension

$$
0 \longrightarrow \mu_{8} \longrightarrow \overline{\mathrm{Sp}(W)} \longrightarrow \mathrm{Sp}(W) \longrightarrow 1
$$

of $\operatorname{Sp}(W)$ by $\mu_{8}$. Let $\overline{\mathrm{U}\left(W_{i}\right)}$ be the degree 8 metaplectic cover of $\mathrm{U}\left(W_{i}\right)$ induced by $\overline{\mathrm{Sp}(W)}$. Then the following result about the above irreducible dual reductive pair was drawn from [10. Chapitre 3, p. 51 ](written by Vignéras).

Theorem 1.1. The exact sequence $0 \longrightarrow \mu_{8} \rightarrow \overline{U\left(W_{1}\right)} \longrightarrow U\left(W_{1}\right) \longrightarrow 1$ splits, except for $W_{1}$ being symplectic and $W_{2}$ being orthogonal of odd dimension.

We remark that Kudla discussed the explicit splitting group extensions of dual reductive pairs in [7]. His results play a significant role in the study of the classical theta correspondences. In this paper we shall generalize the above result to a larger subgroup of $\operatorname{Sp}(W)$. We define

$$
\Gamma:=\left\{\left(g_{1}, g_{2}\right) \mid g_{1} \in \mathrm{GU}\left(W_{1}\right), g_{2} \in \mathrm{GU}\left(W_{2}\right) \text { such that } \lambda_{1}\left(g_{1}\right) \lambda_{2}\left(g_{2}\right)=1\right\}
$$

where $\lambda_{1}, \lambda_{2}$ are the similitude characters from $\mathrm{GU}\left(W_{1}\right), \mathrm{GU}\left(W_{2}\right)$ to $F^{\times}$respectively. Accordingly there exists a canonical $\operatorname{map} \iota: \Gamma \longrightarrow \operatorname{Sp}(W)$. Now let $\bar{\Gamma}$ be the degree 8 metaplectic cover of $\Gamma$ induced by $\overline{\mathrm{Sp}(W)}$. By using [10]'s approach we derive the following coherent result analogy of Theorem 1.1 ,

Theorem A. The exact sequence $1 \longrightarrow \mu_{8} \longrightarrow \bar{\Gamma} \longrightarrow \iota(\Gamma) \longrightarrow 0$ splits, except when the irreducible dual reductive pair is a symplectic-orthogonal type and the orthogonal vector space over $F$ is of odd dimension.

Remark. The major regular part of this result is known to the specialist. However here we deal it more systematically and use much cohomology theory.

(1) When $D=F, W_{1}$ is a symplectic vector space over $F$, and $W_{2}$ is an orthogonal vector space over $F$ of even dimension, the result is compared with Robert's result [17, Proposition 3.3.].
(2) When $D=$ the quaternion algebra over $F$, and $W_{1}$ is a Hermitian vector space over $D$ of even dimension, and $W_{2}$ is a skew-Hermitian vector space over D, the result is due to Gan, see [3, Sections 2- 3].

The explicit behavior of the cohomology class [ $c_{R a o}$ ] in $\mathrm{H}^{2}\left(\mathrm{Sp}(W), \mu_{8}\right)$ has been investigated by Rao [16], and by Perrin [14] (see also the comprehensive note [8] written by Kudla). To control the restriction of [ $c_{R a o}$ ] to $\Gamma$, we use a long exact sequence of cohomology groups obtained by inflation-restriction from the exact sequence of groups $1 \longrightarrow \mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right) \longrightarrow \Gamma \longrightarrow$ $\Gamma /\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right) \longrightarrow 1$. That exact sequence of cohomology is stated in section 2.4 and section 3 deduces a criterion for the splitting of $\bar{\Gamma}$. The criterion involves several conditions, which are verified in the next sections 4 to 9 The verification requires us to use results about the commutator subgroups of unitary groups over $D$. So in section 2 we recall the classification of the skew hermitian spaces over a $p$-adic division algebra $\mathbb{H}\left(c f .\left[19, ~[21)\right.\right.$ and the fine structure of the norm one subgroup of $\mathbb{M}^{\times}$ (cf. [18]).

## 2. Notation and preliminaries

2.1. Notation and conventions. We fix the following notations and assumptions for the whole paper:

- $F$ : a non-archimedean local field of residue characteristic different from 2;
- $E$ : a quadratic field extension of $F$;
- $\mathbb{H}$ : the unique quaternion algebra over $F$, up to isometry;
- Nrd, Trd: the reduced norm, resp. trace of $\mathbb{H}$;
- $\mathbb{H}^{0}$ : the subspace of elements of pure quaternion of $\mathbb{H}$;
- $\mathfrak{D}$ : the ring of integers of $\mathbb{H}$ consisting of the elements $\mathbb{d} \in \mathbb{H}$ such that $|\operatorname{Nrd}(\mathbb{d})|_{F} \leq 1$;
- $\mathfrak{P}$ : the maximal ideal of $\mathfrak{D}$;
- $\mathrm{U}_{\mathbb{H}}=\left\{\left.\mathbb{d} \in \mathbb{H}| | \operatorname{Nrd}(\mathbb{d})\right|_{F}=1\right\} ;$
- $\mathbb{S L}_{1}(\mathbb{H})=\left\{\mathbb{d} \in \mathbb{H}^{\times} \mid \operatorname{Nrd}(\mathbb{d})=1\right\} ;$
- $k_{\mathbb{H}}$ : the residue field of $\mathbb{H}$;
- $\mathbb{C}_{-1}$ : an element of $\mathbb{H}^{\times}$with reduced norm -1 ;
- $\{1, \xi, \omega, \xi \omega\}$ is a fixed standard basis of $\mathbb{H}$ such that $\xi \omega=-\omega \xi$, and $F(\xi) / F$ is an unramified extension of degree 2;
- The ring of integers of a local field $K$ will be denoted by $\mathfrak{D}_{K}$, its unique maximal ideal by $\mathfrak{p}_{K}$, its residue field by $k_{K}$, its group of units by $U_{K}$;
- $\mathbb{S L}_{1}(K)=\left\{d \in K^{\times} \mid \mathrm{N}_{K / F}(d)=1\right\}$, for a finite field extension $K / F$;
- ( $D, \tau$ ): a division algebra over $F$ with an involution $\tau$ such that $F$ consists of all $\tau$-fixed points of $D$; it has one of the following forms: (1) $D=F, \tau=\mathrm{Id}$; (2) $D=E$, $\tau=$ the canonical conjugation; (3) $D=\mathbb{H}, \tau=$ the canonical involution;
- $(H,\langle\rangle):$, a right (resp. left) $\epsilon$-hermitian hyperbolic plane over $D$, defined as $\left\langle\left(d_{1}, d_{1}^{\prime}\right),\left(d_{2}, d_{2}^{\prime}\right)\right\rangle=\tau\left(d_{1}\right) d_{2}^{\prime}+\varepsilon \tau\left(d_{1}^{\prime}\right) d_{2}$, $\left(\right.$ resp. $\left.\left\langle\left(d_{1}, d_{1}^{\prime}\right),\left(d_{2}, d_{2}^{\prime}\right)\right\rangle=d_{1} \tau\left(d_{2}^{\prime}\right)+\varepsilon d_{1}^{\prime} \tau\left(d_{2}\right)\right)$, for $d_{1}, d_{2}, d_{1}^{\prime}, d_{2}^{\prime} \in D$;
- ( $\mathbb{H}[\mathfrak{i}],\langle\rangle$,$) : a right (resp. left) skew hermitian vector space over \mathbb{H}$ of dimension 1 , defined as $\left\langle d_{1}, d_{1}^{\prime}\right\rangle=\tau\left(d_{1}\right)$ id $d_{1}^{\prime}$ (resp. $\left.\left\langle d_{1}, d_{1}^{\prime}\right\rangle=d_{1} \dot{\mathbb{L}} \tau\left(d_{1}^{\prime}\right)\right)$, for $d_{1}, d_{1}^{\prime} \in \mathbb{H}$, where $0 \neq \dot{\mathrm{i}} \in \mathbb{H}^{0}$;
- $(W,\langle\rangle),,\left(W_{i},\langle,\rangle_{i}\right), \epsilon_{i}, \mathrm{U}\left(W_{i}\right), \Gamma$, and $\overline{\mathrm{U}}\left(W_{i}\right), \bar{\Gamma}, \mu_{8}$, etc.: introduced above;
- Without confusion, sometimes we write a matrix in its block form, and write for instance $\mathrm{GL}_{3}\left(M_{2}(F)\right)$ for $\mathrm{GL}_{6}(F)$.
2.2. Preliminaries on unitary groups. In this subsection, we reviewed some results of unitary groups and their commutator subgroups which are indispensable. Our main references are the books written by Scharlau [20] and Hahn-O'Meara [4]. We also do benefit from the articles [18], [21]. Let us first rephrase one result from [10, p.7] concerning about the classification of anisotropic $\epsilon$-hermitian spaces over $D$.

Theorem 2.1. Up to isometry,

- an anisotropic quadratic vector space over $F$ has one of the following forms:
(i) $F[a]$, for $a \in F^{\times}$modulo $\left(F^{\times}\right)^{2}$, with the canonical form $x \longmapsto a x^{2}, x \in F$;
(ii) $F_{1}[a]$, for any quadratic field extension $F_{1}$ of $F, a \in F^{\times}$modulo $\mathrm{N}_{F_{1} / F}\left(F_{1}^{\times}\right)$with the form $x \longmapsto a \mathrm{~N}_{F_{1} / F}(x), x \in F_{1}$;
(iii) $\mathbb{H}^{0}[a]$, for $a \in F^{\times}$modulo $\left(F^{\times}\right)^{2}$, with the form $x \longmapsto \tau(\mathbb{x}) a \mathbb{X}, \mathbb{x} \in \mathbb{H}^{0}$;
(iv) $\mathbb{H}$, with the form $\mathbb{x} \longmapsto \operatorname{Nrd}(\mathbb{x}), \mathbb{x} \in \mathbb{H}$.
- an anisotropic hermitian vector space over $E$ has one of the following forms:
(i) $E[a]$, for $a \in F^{\times}$modulo $\mathrm{N}_{E / F}\left(E^{\times}\right)$, with the form $(x, y) \longmapsto a \tau(x) y, x, y \in E$;
(ii) $\mathbb{H}$, with the form $(\mathbb{x}, \mathbb{y}) \longmapsto \operatorname{Tr}_{\mathbb{H} / E}(\tau(\mathbb{x}) \mathbb{y}), \mathbb{x}, \mathbb{y} \in \mathbb{H}$
- an anisotropic right hermitian vector space over $\mathbb{H}$ has the following form: $\mathbb{H}$, with the form $(\mathbb{x}, \mathbb{y}) \longmapsto \tau(\mathbb{x}) \mathbb{y}, \mathbb{x}, \mathbb{y} \in \mathbb{H}$.

Suppose ( $V,\langle$,$\rangle ) is an anisotropic hermitian space over E$. By Hilbert's Theorem 90, we can take an element $\mu$ of $E^{\times}$such that $\bar{\mu} / \mu=-1$. Multiplication of $\langle$,$\rangle by \mu$ will give a skew hermitian form $\mu\langle$,$\rangle on V$, so in analogy with Theorem 2.1] we have

Proposition 2.2. Up to isometry,

- an anisotropic skew hermitian space over $E$ has one of the following forms:
(i) $E[a]$, for $a \in F^{\times}$modulo $\mathrm{N}_{E / F}\left(E^{\times}\right)$, with the form $(x, y) \longmapsto a \mu \tau(x) y, x, y \in E$,
(ii) $\mathbb{H}$, with the form being given as $(\mathbb{x}, \mathbb{y}) \longmapsto \mu \operatorname{Tr}_{\mathbb{H} / E}(\tau(\mathbb{x}) \mathbb{y}), \mathbb{x}, \mathbb{y} \in \mathbb{H}$;
- an anisotropic right skew hermitian space over $\mathbb{H}$ has one of the following forms:
(i) $\mathbb{H}[\dot{1}]$, for $\dot{\mathrm{i}}=\xi, \omega, \xi \oplus$,
(ii) $\mathbb{H}[\mathfrak{i}] \oplus \mathbb{H}[\mathfrak{j}]$, for $(\mathfrak{i}, \mathfrak{j})=\left(\xi, \mathbb{E}_{-1} \omega\right),\left(\xi, \mathbb{E}_{-1} \xi \omega\right)$ or $\left(\omega, \mathbb{C}_{-1} \xi \Phi\right)$,
(iii) $\mathbb{H}[\xi] \oplus \mathbb{H}[\omega] \oplus \mathbb{H}\left[\mathbb{C}_{-1} \xi \Phi\right]$,
where $\mathbb{e}_{-1}$ is an element of $F(\xi)$ with norm -1 .
Proof. The second assertion is due essentially to Tsukamoto (see [21, Theorem 3]).
2.2.1. The hyperbolic unitary groups. Suppose that $\left(V=H \oplus V_{1},\langle\rangle,\right)$ is a right $\epsilon$-hermitian space over $D$ of dimension $n$ composed by a hyperbolic plane $H$ and a subspace $V_{1}$. For two vectors $u, v$ in $V$ with $\langle u, u\rangle=0=\langle u, v\rangle$, and any $d$ in the coset $\frac{1}{2}\langle v, v\rangle+\mathscr{S}_{D}$ of $D / \mathscr{S}_{D}$, where $\mathscr{S}_{D}=\{s-\epsilon \tau(s) \mid s \in D\}$, we define the so-called Eichler transformation related to $u, v, d$ as follows (cf. [4] p. 214]): $e_{u, v, d}(x)=x+\epsilon u\langle v, x\rangle-(\nu+\epsilon u d)\langle u, x\rangle$. Let $E U_{V}(D) \subseteq U(V)$ be the group generated by all above Eichler transformations of $V$.
Theorem $2.3(4] \mathrm{pp} .333-335]) .\left[\mathrm{EU}_{V}(D), \mathrm{EU}_{V}(D)\right]=\mathrm{EU}_{V}(D)$, and $\mathrm{U}(V)=\mathrm{U}(H) \cdot \mathrm{EU}_{V}(D)$.
As a consequence we obtain:
Lemma 2.4. There is a surjective map $\mathrm{U}(H) /[\mathrm{U}(H), \mathrm{U}(H)] \longrightarrow \mathrm{U}(V) /[\mathrm{U}(V), \mathrm{U}(V)]$.
Lemma 2.5. Let $\mathfrak{A}=\left\{\left.\left(\begin{array}{cc}a & 0 \\ 0 & \bar{a}^{-1}\end{array}\right) \right\rvert\, a \in D^{\times}, \bar{a}=\tau(a)\right\} \simeq D^{\times}$. Despite of the case $D=F, \epsilon=1$, we have:
(1) $\mathrm{U}(H)=\mathfrak{A} \cdot \mathrm{EU}_{H}(D)$,
(2) The image of $\frac{\mathfrak{R}}{[\mathfrak{2}, 2]}$ or $\frac{D^{\times}}{\left[D^{\times}, D^{\times}\right]}$in $\frac{\mathrm{U}(H)}{[\mathrm{U}(H), \mathrm{U}(H)]}$ is full.

Proof. The first statement follows from [20, p. 263], and the second one is a consequence of Lemma 2.4]
The main purpose of this section is to achieve the similar results as Lemma 2.4 for each $\epsilon$-hermitian space $V$ over $D$. Before attempting to investigate the problem, let us cite the following results from Carl Riehm's paper [18] involving some subgroups of $\mathbb{M}^{\times}$.
Lemma 2.6. (1) $\left[\mathbb{H}^{\times}, \mathbb{H}^{\times}\right]=\mathbb{S} \mathbb{L}_{1}(\mathbb{H})$.
(2) $\left[\mathbb{S L}_{1}(\mathbb{H}), \mathbb{S L}_{1}(\mathbb{H})\right]=\mathbb{S} \mathbb{L}_{1}(\mathbb{H}) \cap(1+\mathfrak{P})$.
(3) $\mathbb{S L}_{1}(\mathbb{H}) /\left[\mathbb{S L}_{1}(\mathbb{H}), \mathbb{S L}_{1}(\mathbb{H})\right]$ is isomorphic with the subgroup $\mathbb{S L}_{1}\left(k_{\sharp}\right)$ consisting of elements of $k_{\sharp}$ with norm 1 in $k_{F}$.

Proof. See also [15, p.648].
Remark 2.7. Suppose now that $\mathbb{H}$ is merely a division algebra over its centre $F$ of dimension $d^{2}$. Then the above results also hold.

[^1]Proof. See [18, Section 5 and Theorem 7(iii)(2)] for the details.
Now let $\{1, \dot{i}, \dot{j}, \mathbb{k}\}$ be a standard base of $\mathbb{H}$ such that $\dot{i} \cdot \dot{j}=-\dot{j} \cdot \dot{\mathbb{i}}=\mathbb{k}$, and $\dot{\mathrm{i}}^{2}=-\alpha, \dot{\mathfrak{j}}^{2}=-\beta$. Set $F_{1}=F(\dot{i})$, and $F_{2}=F(\mathfrak{j})$.
Lemma 2.8. Let $(V=\mathbb{H}[\dot{1}],\langle\rangle$,$) be a right skew hermitian space over \mathbb{H}$ of dimension 1. Then $\mathrm{U}(V)=\mathbb{S L}_{1}\left(F_{1}\right)$ and $\mathrm{GU}(V)=$ $\left\langle F_{1}^{\times}, \mathfrak{j}\right\rangle=F_{1}^{\times} \cup F_{1}^{\times} \mathfrak{j}$.
Proof. An element $\alpha_{0}+\alpha_{1} \dot{\mathfrak{j}}$ with $\alpha_{0}, \alpha_{1} \in F_{1}$ lies in $U(V)$ if and only if $\left(\overline{\alpha_{0}}-\alpha_{1} \dot{\mathfrak{j}}\right) \dot{\mathrm{i}}\left(\alpha_{0}+\alpha_{1} \dot{\mathfrak{j}}\right)=\dot{\mathrm{i}}$; this means $\alpha_{1}=0$ and $\mathrm{N}_{F_{1} / F}\left(\alpha_{0}\right)=1$, or $\alpha_{0}=0$ and $\mathrm{N}_{F_{1} / F}\left(\alpha_{1}\right) \dot{\mathfrak{j}}^{2}=1$. But the second case contradicts to $\dot{j}^{2} \notin \mathrm{~N}_{F_{1} / F}\left(F_{1}^{\times}\right)$, so $\mathrm{U}(V)=\mathbb{S L}_{1}\left(F_{1}\right)$. Similarly, if $g=\alpha_{0}+\alpha_{1, j} \in G U(V)$, then $\left(\overline{\alpha_{0}}-\alpha_{1, j}\right) \dot{\mathrm{i}}\left(\alpha_{0}+\alpha_{1, j}\right)=\lambda(g)$ i for some suitable $\lambda(g) \in F^{\times}$. By calculation, we see that $\alpha_{0}=0$ or $\alpha_{1}=0$, so the last result follows.

The following result is immediate:
Lemma 2.9. Let $(V=\mathbb{H},\langle\rangle=,\operatorname{Trd})$ be a right hermitian space over $\mathbb{H}$ of dimension 1 . Then $U(V)=\mathbb{S}_{1}(\mathbb{H})$ and $G U(V)=\mathbb{H}^{\times}$.
2.2.2. The anisotropic unitary group $I$. Let $(V,\langle\rangle$,$) be an anisotropic hermitian space over E$.

Lemma 2.10. If $\operatorname{dim}_{E}(V)=1$, then $\mathrm{U}(V,\langle\rangle)=,\mathbb{S}_{1}(E)$, and $\mathrm{GU}(V,\langle\rangle)=,E^{\times}$.
Proof. Obviously.
Now let us begin to discuss the case when $\operatorname{dim}_{E}(V)=2$. By Theorem 2.1] we assume $E=F(\mathrm{i})$, with $\dot{\mathrm{i}}^{2}=-\alpha \in F^{\times}$. By [20, p.358], we can choose an element $\mathfrak{j}$ in $\mathbb{H}$, such that $i \mathfrak{j}=-\mathfrak{j} \dot{i}=\mathbb{k}, \dot{j}^{2}=-\beta \in F^{\times}$, and $\{1, \dot{i}, \mathfrak{j}, \mathbb{k}\}$ forms a standard basis of $\mathbb{H}$. Then there is a decomposition of $E$-vector space: $\mathbb{H}=E \oplus \dot{j} E$. Let $\operatorname{Tr}_{\mathbb{H} / E}$ denote the canonical projection from $\mathbb{H}$ to $E$ defined by $\operatorname{Tr}_{H / E}\left(e_{1}+j e_{2}\right)=e_{1}$, for $e_{1}, e_{2} \in E$. Now, we can define an $E$-hermitian form $\langle$,$\rangle on \mathbb{H}$ as follows:

$$
\left\langle e_{1}+\mathfrak{j} e_{2}, e_{1}^{\prime}+\mathfrak{j} e_{2}^{\prime}\right\rangle=\operatorname{Tr}_{\mathbb{H} / E}\left(\overline{\left(e_{1}+\mathfrak{j} e_{2}\right)}\left(e_{1}^{\prime}+\mathfrak{j} e_{2}^{\prime}\right)\right)=\overline{e_{1}} e_{1}^{\prime}+\overline{e_{2}} \bar{j} j \dot{j} e_{2}^{\prime}=\overline{e_{1}} e_{1}^{\prime}+\beta \overline{e_{2}} e_{2}^{\prime}
$$

If given $a, a^{\prime} \in E$, we then have $\left\langle\left(e_{1}+\mathfrak{j} e_{2}\right) a,\left(e_{1}^{\prime}+\mathfrak{j} e_{2}^{\prime}\right) a^{\prime}\right\rangle=\bar{a} \overline{e_{1}} e_{1}^{\prime} a^{\prime}+\beta \bar{a} \overline{e_{2}} e_{2}^{\prime} a^{\prime}=\bar{a}\left\langle e_{1}+\dot{j} e_{2}, e_{1}^{\prime}+\mathfrak{j} e_{2}^{\prime}\right\rangle a^{\prime}$. Moreover, if $\left\langle e_{1}+\right.$ $\left.\dot{j} e_{2}, e_{1}+j e_{2}\right\rangle=\operatorname{Nrd}\left(e_{1}\right)+\beta \operatorname{Nrd}\left(e_{2}\right)=0$, then $\operatorname{Nrd}\left(e_{1}\right)=\operatorname{Nrd}\left(e_{2}\right)=0$, namely $e_{1}=e_{2}=0$. So $(\mathbb{H},\langle\rangle$,$) is the unique anisotropic$ space over $E$ of dimension 2 , up to isometry. Under the basis $\{1, \mathfrak{j}\}$ of $\mathbb{H}$, we identify $U(V,\langle\rangle$,$) with the unitary matrix group$ $\mathrm{U}_{V}(D)$ consisting of elements $G=\left(\begin{array}{ll}\alpha_{11} & \alpha_{12} \\ \alpha_{21} & \alpha_{22}\end{array}\right) \in \mathrm{GL}_{2}(E)$ such that

Moreover, $\mathrm{U}(V,\langle\rangle)=,\left\{H \cdot A \mid H \in \mathbb{S}_{1}(\mathbb{H}), A \in \mathfrak{l}\right\}$.

Proof. The first part of (2) follows from the above equations (2.2). By definition, an element $\alpha_{1}+\mathfrak{j} \alpha_{2} \in \mathbb{S L}_{1}$ ( $\mathbb{H}$ ) belongs to $\mathrm{U}(V,\langle\rangle$,$) , and sends 1$ to $\alpha_{1}+\mathfrak{j} \alpha_{2}$, and $\mathfrak{j}$ to $-\beta \overline{\alpha_{2}}+\mathfrak{j} \overline{\alpha_{1}}$, which gives the result (1). Moreover, $G=\left(\begin{array}{ll}\alpha_{11} & \alpha_{12} \\ \alpha_{21} & \alpha_{22}\end{array}\right) \in \mathrm{U}(V,\langle\rangle$,$) can be$ written in the following forms:

So the other part of (2) follows.

Proof. We prove the result along with the cases given in Proposition 2.2. First of all,

In case $\dot{\mathrm{i}}=\xi, \dot{\mathrm{j}}=\omega$ or $\xi \emptyset$, the commutator of two elements $G_{1}=\left(\begin{array}{cc}\alpha_{1} & -\beta \bar{\alpha}_{2} \\ u_{1} \alpha_{2} & u_{1} \bar{\alpha}_{1}\end{array}\right), G_{2}=\left(\begin{array}{cc}\alpha_{1}^{\prime} & -\beta \overline{\alpha^{\prime}} \\ u_{1}^{\prime} \alpha_{2}^{\prime} & u_{1}^{\prime}{\overline{\alpha^{\prime}}}_{1}\end{array}\right) \in \mathrm{U}(V,\langle\rangle$,$) , modulo \mathfrak{P}$, is presented by

which means $\left[G_{1}, G_{2}\right] \equiv 1 \bmod \mathfrak{P}$ in $\mathbb{S}_{1}(\mathbb{H})$. In case $\dot{\mathfrak{i}}=\omega$ or $\xi \emptyset, \dot{\mathfrak{j}}=\xi$, an element $G=\left(\begin{array}{cc}1 & 0 \\ 0 & u_{1}\end{array}\right) \in \mathfrak{l}$ has the form $\left(\begin{array}{cc}1 & 0 \\ 0 & \pm 1\end{array}\right)$ $\bmod \mathfrak{P}$; hence the derived subgroup of $U(V,\langle\rangle$,$) degenerates to that of \mathbb{S L}_{1}(\mathbb{H})$.

Remark 2.13. By Proposition[2.2] arguing for the unitary groups of anisotropic skew hermitian spaces over E eventually reduces to the above cases.
2.2.3. The anisotropic unitary groups II. Let $(V=\mathbb{H}[i] \oplus \mathbb{H}[j] \oplus \mathbb{H}[\mathbb{\square}],\langle\rangle$,$) be a right anisotropic skew hermitian space over \mathbb{H}$ of dimension 3 subject to the conditions that (1) $\{1, \dot{i}, \mathfrak{j}, \mathbb{k}=\dot{i} \mathfrak{j}=-\mathfrak{j} \hat{i}\}$ is a standard basis of $\mathbb{H}$; (2) $\dot{\mathbb{i}}^{2}=-\alpha, \dot{\mathfrak{j}}^{2}=-\beta, \mathbb{1}^{2}=-\mathbb{k}^{2}=\alpha \beta$ 回 (3) $\mathbb{1}=\dot{1} b_{0}+\dot{j} c_{0}+\mathbb{k} d_{0}$ for $b_{0}, c_{0}, d_{0} \in F$, so $b_{0}^{2} \alpha+c_{0}^{2} \beta+d_{0}^{2} \alpha \beta=-\alpha \beta$. The purpose of this sub-section is to review the concrete description of the group $\mathrm{U}(V,\langle\rangle$,$) by Satake [19], and derive some consequences.$

Let us begin with recalling two results in classical groups. Let $M$ be a vector space over $F$ of dimension 4 with basis $\left\{x_{1}, \cdots, x_{4}\right\}$.

Theorem 2.14 ([2] Chapitre IV, §8]). There is an exact sequence

where $\mathrm{GO}^{+}\left(\bigwedge^{2} M, Q\right)=\left\{g \in \mathrm{GO}\left(\bigwedge^{2} M, Q\right) \mid \operatorname{det}(g)=\lambda(g)^{3}\right\}$, and $\lambda: \mathrm{GO}\left(\Lambda^{2} M, Q\right) \longrightarrow F^{\times}$is the similitude character.
Remark 2.15. If we choose $x_{i j}=x_{i} \wedge x_{j}$ for $1 \leq i<j \leq 4$, to be the basis of $\wedge^{2} M$, then $\left(Q\left(x_{i j}, x_{k l}\right)\right)=$ $\operatorname{diag}\left(\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right),\left(\begin{array}{cc}0 & -1 \\ -1 & 0\end{array}\right),\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right)\right)$. Through the mapping $\kappa$, the action of $g=\left(a_{i j}\right) \in \mathrm{GL}_{4}(F) \simeq \mathrm{GL}(M)$ on $x_{k} \wedge x_{l}$ is given by $g \cdot\left(x_{k} \wedge x_{l}\right)=\sum_{1 \leq i, j \leq 4} a_{i k} a_{j l} x_{i} \wedge x_{j}$. Following [19], we denote $g^{(2)}$ to be the matrix in $\mathrm{GL}_{6}(F)$ such that $g$. $\left(x_{12}, x_{34} ; x_{13}, x_{24} ; x_{14}, x_{23}\right)=\left(x_{12}, x_{34} ; x_{13}, x_{24} ; x_{14}, x_{23}\right) g^{(2)}$.

Set $F_{1}=F(\dot{\text { i }}), K=F_{1}(\sqrt{-\beta})$, and $\operatorname{Gal}\left(F_{1} / F\right)=\langle\sigma\rangle, \operatorname{Gal}(K / F)=\langle\sigma, \tau\rangle$. For the above right skew hermitian space $V$ over $\mathbb{H}$, we let $\mathbf{U}_{V}$ (resp. $\mathbf{S} \mathbf{U}_{V}$ ) be the associated unitary (resp. the special unitary) group scheme.

Lemma 2.16. $\mathrm{U}(V,\langle\rangle$,$) is isomorphic to \mathbf{S U}_{V}(F)$.
Proof. See [10] p. 21] or [3. Section 2.2].
By turning to $V_{F_{1}}=V \otimes_{F} F_{1}$, indeed we obtain a right skew hermitian space over the splitting algebra $\mathrm{M}_{2}\left(F_{1}\right)$ with the skew hermitian form $\langle,\rangle_{V_{F_{1}}}$ induced by the scalar extension. Moreover according to [19, Section 1], the unitary group $\mathrm{U}\left(V_{F_{1}},\langle,\rangle_{V_{F_{1}}}\right)$ is isomorphic to an orthogonal group $\mathrm{O}\left(W,(,)_{W}\right)$, where $W=F^{2} \times F^{2} \times F^{2}$, and the form is given

[^2]by $\left(\left(w_{1}, w_{2}, w_{3}\right),\left(w_{1}^{\prime}, w_{2}^{\prime}, w_{3}^{\prime}\right)\right)_{W}=w_{1}^{t} Q_{1} w_{1}^{\prime}+w_{2}^{t} Q_{2} w_{2}^{\prime}+w_{3}^{t} Q_{3} w_{3}^{\prime}$, for $w_{i}, w_{i}^{\prime} \in F^{2}, Q_{1}=\left(\begin{array}{cc}0 & -\dot{1} \\ -\dot{\mathbb{i}} & 0\end{array}\right), Q_{2}=\left(\begin{array}{ll}1 & 0 \\ 0 & \beta\end{array}\right), Q_{3}=$ $\left(\begin{array}{cc}c_{0}-d_{0} \dot{\mathrm{i}} & -b_{0} \dot{\mathrm{i}} \\ -b_{0} \dot{\mathrm{i}} & \beta\left(c_{0}+d_{0} \dot{\mathrm{i}}\right.\end{array}\right)$. By [19] p. 405], we let $P_{1}=\left(\begin{array}{cc}1 & 0 \\ 0 & 2 \dot{\mathrm{i}}\end{array}\right), P_{2}=\left(\begin{array}{cc}1 & \sqrt{-\beta} \\ 1 & -\sqrt{-\beta}\end{array}\right), P_{3}=\left(\begin{array}{cc}-c_{0}+d_{0} \dot{\mathrm{i}} & \left(b_{0}+\sqrt{-\beta}\right) \dot{\mathrm{i}} \\ 1 & \frac{\left(-b_{0}+\sqrt{-\beta}\right)}{c_{0}-d_{0} \dot{\mathrm{i}}}\end{array}\right)$, and $P=$ $\operatorname{diag}\left(P_{1}, P_{2}, P_{3}\right)$. Let $I=\binom{\left(\begin{array}{cc}-\frac{b_{0}+\sqrt{-\beta}}{2} & 0 \\ 0 & \frac{\sqrt{-\beta}}{2 \dot{\mathrm{I}}}\end{array}\right)}{\left(\begin{array}{cc}1 & 0 \\ 0 & \frac{\dot{\mathrm{i}}\left(b_{0}+\sqrt{-\beta}\right)}{\sqrt{-\beta}}\end{array}\right)} \in \mathrm{GL}_{4}(K), J=\left(\begin{array}{ll}\left(\begin{array}{lll}0 & -c_{0}+d_{0} \dot{\mathrm{I}} \\ 1 & 0\end{array}\right) & \\ & \\ & \left(\begin{array}{cc}0 & -1 \\ c_{0}-d_{0} \dot{\mathrm{I}} & 0\end{array}\right)\end{array}\right) \in \mathrm{GL}_{4}(K)$.
Lemma 2.17 ([19, Section 3]). There is an exact sequence $1 \rightarrow F_{1}^{\times} \rightarrow C^{+}\left(W,(,)_{W}\right) \xrightarrow{\kappa} \mathrm{SO}\left(W,(,)_{W}\right) \rightarrow 1$, where $C^{+}\left(W,(,)_{W}\right)=$ $\left\{(t, g) \mid g \in \mathrm{GL}_{4}(K), t \in F_{1}^{\times}\right.$such that $t^{2} \operatorname{det}(g)=1$ and $\left.J^{-1} g J=g^{\tau}\right\}$. The mapping $\kappa$ is defined by $(t, g) \longmapsto t P^{-1} g^{(2)} P$, where $g^{(2)}$ is given in Remark[2.15]

Accord to [19] p.404], $\mathrm{U}(V,\langle\rangle$,$) is isomorphic to the \operatorname{Gal}\left(F_{1} / F\right)$-invariant part of $\mathrm{SO}\left(W,(,)_{W}\right)$.
Proposition $2.18([19, ~ p .407])$. There exists an exact sequence $1 \longrightarrow F^{\times} \longrightarrow C^{+}(V,\langle\rangle,) \xrightarrow{\kappa} \mathbf{S U}_{V}(F) \longrightarrow 1$, where $C^{+}(V,\langle\rangle)=$, $\left\{(t, g) \mid g \in \mathrm{GL}_{4}(K), t \in F^{\times}\right.$such that $\left.t^{2} \operatorname{det}(g)=1, J^{-1} g J=g^{\tau}, I^{-1} g I=g^{\sigma}\right\}$.

Let $\mathbb{D}_{4}=\{0\} \cup\left\{g \in \mathrm{GL}_{4}(K) \mid J^{-1} g J=g^{\tau}, I^{-1} g I=g^{\sigma}\right\}$. Then it was shown by Satake in [19, p.407] that $\mathbb{D}_{4}$ is a division algebra over $F$ of degree 4 , and $\mathbb{D}_{4}=\widetilde{K}+\mathrm{a}_{1} \widetilde{K}+\mathrm{a}_{2} \widetilde{K}+\mathrm{a}_{3} \widetilde{K}$ for $\widetilde{K}=\left\{\widetilde{\alpha}=\operatorname{diag}\left(\alpha, \alpha^{\tau}, \alpha^{\sigma}, \alpha^{\sigma \tau}\right) \mid \alpha \in K\right\}$ and $\mathrm{a}_{1}=\left(\begin{array}{cc}X_{11} & 0 \\ 0 & X_{22}\end{array}\right) \in \mathrm{GL}_{4}(K)$, $\mathrm{a}_{2}=\left(\begin{array}{cc}0 & Y_{12} \\ Y_{21} & 0\end{array}\right) \in \mathrm{GL}_{4}(K), \mathrm{a}_{3}=\left(\begin{array}{cc}0 & Z_{12} \\ Z_{21} & 0\end{array}\right) \in \mathrm{GL}_{4}(K)$ with $X_{11}=\left(\begin{array}{cc}0 & -\left(c_{0}+d_{0} \dot{\mathrm{i}}\right) \\ 1 & 0\end{array}\right), X_{22}=\left(\begin{array}{cc}0 & -\frac{\sqrt{-\beta}\left(c_{0}+d_{0} \dot{\mathrm{i}}\right)}{\dot{\mathrm{i}}\left(b_{0}+\sqrt{-\beta}\right)} \\ \frac{\dot{\mathrm{i}}}{\sqrt{-\beta}}\left(b_{0}+\sqrt{-\beta}\right) & 0\end{array}\right)$, $Y_{21}=\left(\begin{array}{cc}1 & 0 \\ 0 & c_{0}-d_{0} \dot{\mathrm{I}}\end{array}\right), Y_{12}=\left(\begin{array}{cc}-\frac{b_{0}+\sqrt{-\beta}}{2} & 0 \\ 0 & -\frac{b_{0}-\sqrt{-\beta}}{2\left(c_{0}-d_{0} \dot{\mathrm{i}}\right)}\end{array}\right), Z_{12}=\left(\begin{array}{cc}0 & \frac{\sqrt{-\beta}}{2 \dot{\mathrm{i}}} \\ \frac{\sqrt{-\beta}}{2 \dot{\mathrm{i}}} & 0\end{array}\right), Z_{21}=\left(\begin{array}{cc}0 & -1 \\ 1 & 0\end{array}\right)$ in $\mathrm{GL}_{2}(K)$. For simplicity, we will identity $\widetilde{K}$ with $K$ henceforth.

Now let $\left(V_{1}=\mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}],\langle,\rangle_{V_{1}}\right)$ be a subspace of $(V,\langle\rangle$,$) . We denote D_{F(\mathrm{i})}=K+\mathrm{a}_{1} K$ to be the quaternion algebra over $F(\mathrm{i})$ endowed with the reduced norm $\operatorname{Nrd}\left(k_{1}+\mathrm{a}_{1} k_{2}\right)=k_{1}^{1+\tau}+\left(c_{0}-d_{0} \dot{\mathrm{I}}\right) k_{2}^{1+\tau}$ for $k_{1}, k_{2} \in K$.

Proposition 2.19 ([19, p. 409]). There exists an exact sequence $1 \rightarrow F^{\times} \longrightarrow C^{+}\left(V_{1},\langle,\rangle_{V_{1}}\right) \xrightarrow{\kappa_{1}} \mathrm{U}\left(V_{1},\langle,\rangle_{V_{1}}\right) \longrightarrow 1$, where $C^{+}\left(V_{1},\langle,\rangle_{V_{1}}\right)=\left\{(t, g) \in C^{+}(V,\langle\rangle) \mid, t \in F^{\times}, g \in D_{F(\mathrm{i})}\right.$ and $\left.\operatorname{Nrd}(g) t=1\right\}$.
2.3. In the rest of this subsection, we assume that $\mathrm{j}^{2}$ is a uniformizer of $F$.

Lemma 2.20. Under the conditions at the beginning of Section 2.2 .3 the quotient group $F^{\times} /\left(F^{\times}\right)^{2}$ is represented by the set $\{1,-\alpha, \beta,-\alpha \beta\}$. 周
Proof. By the second part of Proposition [2.2, and [9] p. 155, Proposition 2.9], $-1 \in \mathrm{~N}_{F(\mathrm{i}) / F}\left(F(\mathrm{i})^{\times}\right)$, or $-1 \in \mathrm{~N}_{F(\mathbb{k}) / F}\left(F(\mathbb{k})^{\times}\right)$. In the first case, $-\alpha=-1 \cdot \alpha \in \mathrm{~N}_{F_{1} / F}\left(F_{1}^{\times}\right)$. So $F^{\times}=\left\langle\mathrm{N}_{F_{1} / F}\left(F_{1}^{\times}\right),-\alpha \beta\right\rangle$, and $F^{\times}=\mathrm{N}_{F_{1} / F}\left(F_{1}\right)^{\times} \sqcup\left(-\alpha \beta \mathrm{N}_{F_{1} / F}\left(F_{1}\right)^{\times}\right)=\left(F^{\times}\right)^{2} \sqcup(-$ $\left.\alpha\left(F^{\times}\right)^{2}\right) \sqcup\left(-\alpha \beta\left(F^{\times}\right)^{2}\right) \sqcup\left(\beta\left(F^{\times}\right)^{2}\right)$. The proof of the second case is similar.

Lemma 2.21. Let $\Upsilon=\left\{(1,1),\left(-\alpha, \dot{\mathrm{i}}^{-1}\right),\left(\beta, \sqrt{-\beta}^{-1}\right),\left(-\alpha \beta, \mathrm{i}^{-1} \sqrt{-\beta}^{-1}\right)\right\}$, and let $\Xi$ be a coset representatives of $\mathbb{S L}_{1}\left(\mathbb{D}_{4}\right) /\left[\mathbb{S \mathbb { L }}_{1}\left(\mathbb{D}_{4}\right), \mathbb{S L}_{1}\left(\mathbb{D}_{4}\right)\right]$. Then the canonical mapping induced by the exact sequence in Proposition 2.18 from $T=\{\omega \varsigma \mid$ $\omega \in \Xi, \varsigma \in \Upsilon\}$ to $\mathrm{U}(V,\langle\rangle) /,[\mathrm{U}(V,\langle\rangle),, \mathrm{U}(V,\langle\rangle)$,$] is surjective.$

The field extension K$ of $F$ contains $F(\mathrm{i})$ and $F(\sqrt{-\beta})$, so that $\mathrm{N}_{K / F}\left(K^{\times}\right) \supseteq\left(\mathrm{N}_{F(\mathrm{i}) / F}\left(F(\mathrm{i})^{\times}\right)\right)^{2} \cup\left(\mathrm{~N}_{F(\sqrt{-\beta}) / F}\left(F(\sqrt{-\beta})^{\times}\right)\right)^{2} \supseteq\left(F^{\times}\right)^{2}$; thus every element $g \in C^{+}(V,\langle\rangle$,$) can be written in the$ form $g=\left(t_{1}, k_{1} g_{1}\right)$ for $k_{1} \in K^{\times}, t \in F^{\times}$with $\mathrm{N}_{K / F}\left(k_{1}\right) t_{1}^{2}=1$, and $g_{1} \in \mathbb{S L}_{1}\left(\mathbb{D}_{4}\right)$. This in turn shows that $\mathbb{S}_{1}\left(\mathbb{D}_{4}\right)$ is a normal subgroup of $C^{+}(V,\langle\rangle$,$) , and C^{+}(V,\langle\rangle)=,\mathbb{S} \mathbb{L}_{1}\left(\mathbb{D}_{4}\right) N$. As a consequence, one obtains

\left[C^{+}(V,\langle,\rangle), C^{+}(V,\langle,\rangle)\right] \simeq\left[\mathbb{S L}_{1}\left(\mathbb{D}_{4}\right) N, \mathbb{S \mathbb { L }}_{1}\left(\mathbb{D}_{4}\right)\right]=\left[\mathbb{S \mathbb { L }}_{1}\left(\mathbb{D}_{4}\right), \mathbb{S \mathbb { L }}_{1}\left(\mathbb{D}_{4}\right)\right] \cdot\left[N, \mathbb{S \mathbb { L }}_{1}\left(\mathbb{D}_{4}\right)\right]
$$

and

$$
C^{+}(V,\langle,\rangle) /\left(\left[C^{+}(V,\langle,\rangle), C^{+}(V,\langle,\rangle)\right] F^{\times}\right) \simeq \mathbb{S}_{1}\left(\mathbb{D}_{4}\right) N /\left(\left[\mathbb{S}_{1}\left(\mathbb{D}_{4}\right), \mathbb{S}_{1}\left(\mathbb{D}_{4}\right)\right] F^{\times}\left[N, \mathbb{S}_{1}\left(\mathbb{D}_{4}\right)\right]\right)
$$

By observation, the group $N /\left(\mathbb{S L}_{1}(K) F^{\times}\right)$is represented by the set $\Upsilon$; this ensures the result.
Lemma 2.22. Let $\Xi_{1}$ be a coset representatives of $\mathbb{S L}_{1}\left(\mathbb{D}_{F(\mathrm{i})}\right) /\left[\mathbb{S L}_{1}\left(\mathbb{D}_{F(\mathrm{i})}\right), \mathbb{S L}_{1}\left(\mathbb{D}_{F(\mathrm{i})}\right)\right]$. Then the canonical mapping from $T_{1}=$ $\left\{\omega \varsigma \mid \omega \in \Xi_{1}, \varsigma=(1,1),\left(-\alpha, \dot{\mathrm{i}}^{-1}\right),\left(\beta, \sqrt{-\beta}^{-1}\right),\left(-\alpha \beta, \dot{\mathrm{i}}^{-1} \sqrt{-\beta^{-1}}\right)\right\}$ to $\mathrm{U}\left(V_{1},\langle,\rangle_{1}\right) /\left[\mathrm{U}\left(V_{1},\langle,\rangle_{1}\right), \mathrm{U}\left(V_{1},\langle,\rangle_{1}\right)\right]$ is surjective.
Proof. The proof is similar to that of Lemma 2.21 .
2.4. Moore cohomology. For the sake of completeness we recall some aspects of spectral sequence of topological group extensions developed by Moore in [11] and [12]. Our purpose is to extend the classical five inflation-restriction exact sequence to six terms in such case, so that one can use it freely in next sections.
2.4.1. Moore cohomology. Let $G$ be a locally profinite group, and let $A$ be a finite abelian group on which $G$ acts trivially. Let $\mathrm{H}^{*}(G, A)$ be the cohomology groups as defined in [1] by Moore. Now let $K$ be a normal closed subgroup of $G$. To filter $\mathrm{H}^{*}(G, A)$ with $G \supseteq K \supseteq 0$, Moore introduced the following standard filtering $\left\{L_{j}\right\}$ on the complex $C^{*}(G, A)$ :
(1) $L_{j}=\sum_{n=0}^{\infty} L_{j} \cap C^{n}(G, A)$.
(2) $L_{j} \cap C^{n}(G, A)=0$, if $j>n$, and $L_{j} \cap C^{n}(G, A)=0$, if $j<0$.
(3) For $0 \leq j \leq n, L_{j} \cap C^{n}(G, A)$ is the group of all elements $f \in C^{n}(G, A)$ such that $f\left(s_{1}, \cdots, s_{n}\right)$ depends on $s_{1}, \cdots, s_{n-j}$, and the cosets $s_{n-j+1} K, \cdots, s_{n} K$.
It is clear that $\delta\left(L_{j}\right) \subseteq L_{j}$. Let $Z_{r}^{j}$ denote the preimage of $L_{j+r}$ in $L_{j}$ and $E_{r}^{j}=Z_{r}^{j} /\left(Z_{r-1}^{j+1}+\delta\left(Z_{r-1}^{j+1-r}\right)\right)$. The group $E_{r}^{j, i}$ is just the image of $Z_{r}^{j} \cap C^{i+j}(G, A)$ in $E_{r}^{j}$. By definition, one has $E_{1}^{j, i} \simeq \mathrm{H}^{i+j}\left(L_{j} / L_{j+1}\right)$. To use the spectral sequence like [6], let $C^{j}\left(G / K, C^{i}(K, A)\right)$ be the group of " normalized " $j$-cochains $f^{\prime}$ 's on $G / K$ with values in $C^{i}(K, A)$ subject to the condition that $f\left(\overline{s_{1}}, \cdots, \overline{s_{j}}\right)\left[t_{1}, \cdots, t_{i}\right]$ defines a Borel function from $(G / K)^{j} \times(K)^{i}$ to $A$. On $C^{j}\left(G / K, C^{*}(K, A)\right)$, one introduces the natural coboundary operators $\delta_{K}^{*}$, and obtains the $i$-th cohomology group $\mathrm{H}^{i}\left(C^{j}\left(G / K, C^{*}(K, A)\right)\right.$. In 11 p.48, Lemma 1.1], it is shown that $E_{1}^{j, i}$ is isomorphic to $\mathrm{H}^{i}\left(C^{j}\left(G / K, C^{*}(K, A)\right)\right)$. Notice that a Borel homomorphism of local compact groups is also continuous, so we have $\mathrm{H}^{1}(K, A) \simeq \operatorname{Hom}(K, A)$, and $\mathrm{H}^{1}(K, A)$ becomes a topological group when equipped with a canonical Borel structure. Along with [6] but taking the Borel structure into account, Moore proved the following results:
Theorem 2.23 ([11, p. 49 and p.52, Theorem 1.1]). (1) $E_{1}^{j, 0} \simeq C^{j}(G / K, A), E_{1}^{0, i} \simeq \mathrm{H}^{i}(K, A)$.
(2) $E_{1}^{j, 1} \simeq C^{j}\left(G / K, \mathrm{H}^{1}(K, A)\right)$, and $E_{2}^{j, 1} \simeq \mathrm{H}^{j}\left(G / K, \mathrm{H}^{1}(K, A)\right)$.

According to [11 pp. 52-53], the composed map $\mathrm{H}^{j}(G / K, A) \simeq E_{2}^{j, 0} \longrightarrow E_{\infty}^{j, 0} \hookrightarrow \mathrm{H}^{j}(G, A)$ is the inflation from $G / K$ to $G$, $j=1,2$ and the composed map $\mathrm{H}^{i}(G, A) \rightarrow E_{\infty}^{0, i} \hookrightarrow E_{2}^{0, i} \simeq H^{i}(K, A)$ is the restriction from $G$ to $H$. By [6] p.130, Remark] we have the following inflation-restriction sequence

\begin{equation*}
0 \longrightarrow \mathrm{H}^{1}(G / K, A) \xrightarrow{\text { inf }_{1}} \mathrm{H}^{1}(G, A) \xrightarrow{\text { res }_{1}} \mathrm{H}^{1}(K, A)^{G} \xrightarrow{d_{2}} \mathrm{H}^{2}(G / K, A) \xrightarrow{\text { inf }} \mathrm{H}^{2}(G, A) . \tag{2.3}
\end{equation*}
$$

For later use, let us extend the above long exact sequence to six terms. Now let $\mathrm{H}^{2}(G, A)_{1}$ denote the kernel of the restriction from $\mathrm{H}^{2}(G, A)$ to $\mathrm{H}^{2}(K, A)$, which is isomorphic to $\mathrm{H}^{2}\left(L_{1}\right)$. Recall that the coimage of $d_{2}$ is $E_{\infty}^{2,0}$, which is isomorphic with
$\mathrm{H}^{2}\left(L_{2}\right)$. Note that $\mathrm{H}^{2}\left(L_{1}\right) / \mathrm{H}^{2}\left(L_{2}\right)$ is isomorphic with $E_{\infty}^{1,1}$. Now $\delta: E_{2}^{1,1} \longrightarrow E_{2}^{3,-1}$ is null, so there is an embedding $E_{\infty}^{1,1} \hookrightarrow$ $E_{2}^{1,1} \simeq \mathrm{H}^{1}\left(G / K, \mathrm{H}^{1}(K, A)\right)$. Hence we conclude that the following exact sequence of six terms holds:

0 \longrightarrow \mathrm{H}^{1}(G / K, A) \xrightarrow{\text { inf }_{1}} \mathrm{H}^{1}(G, A) \xrightarrow{r e s_{1}} \mathrm{H}^{1}(K, A)^{G} \xrightarrow{d_{2}} \mathrm{H}^{2}(G / K, A) \xrightarrow{\text { inf }} \mathrm{H}^{2}(G, A)_{1} \xrightarrow{p} \mathrm{H}^{1}\left(G / K, \mathrm{H}^{1}(K, A)\right) . \tag{2.4}
\end{equation*}
$$

Remark that the above sequence coming from spectral sequence is functorial over the pair ( $G, K$ ).
2.4.2. Explicit expression. For convenience, let us describe explicitly the map $p$ in terms of cocycles by following 6. Let $[c] \in \mathrm{H}^{2}(G, A)_{1}$ such that the restriction of the cocycle $c$ to $K \times K$ is trivial. By definition, we have

\begin{equation*}
c\left(s_{2}, s_{3}\right)-c\left(s_{1} s_{2}, s_{3}\right)+c\left(s_{1}, s_{2} s_{3}\right)-c\left(s_{1}, s_{2}\right)=0, \quad s_{1}, s_{2}, s_{3} \in G \tag{2.5}
\end{equation*}
$$

We choose a set of representatives $\Omega=\left\{s^{*} \in G\right\}$ for $G / K$ such that the restriction of the morphism $G \longrightarrow G / K$ to $\Omega$ is a Borel isomorphism, and $1_{G} \in \Omega$. For $s=s^{*} t, t \in K$, define $h(s)=c\left(s^{*}, t\right)$. Note that

$$
\begin{equation*}
\delta_{1} h\left(s, t^{\prime}\right)=h\left(t^{\prime}\right)-h\left(s t^{\prime}\right)+h(s)=-c\left(s^{*}, t t^{\prime}\right)+c\left(s^{*}, t\right), \quad t^{\prime} \in K \tag{2.6}
\end{equation*}
$$

Consider $c^{*}\left(s, s_{1}\right)=c\left(s, s_{1}\right)+\delta_{1} h\left(s, s_{1}\right)$, for $s=s^{*} t, s_{1} \in G$. Then $c^{*}\left(s, t^{\prime}\right)=\left(c+\delta_{1} h\right)\left(s, t^{\prime}\right)$ is zero by (2.5) and (2.6). As $\delta_{2} c^{*}=$ $\delta_{2}\left(c+\delta_{1} h\right)=0$, we obtain $c^{*}\left(s^{*}, t\right)-c^{*}\left(s_{1} s^{*}, t\right)+c^{*}\left(s_{1}, s^{*} t\right)-c^{*}\left(s_{1}, s^{*}\right)=0$. Hence $c^{*}\left(s_{1}, s\right)=c^{*}\left(s_{1}, s^{*} t\right)=c^{*}\left(s_{1}, s^{*}\right)$, meaning that $c^{*}\left(s_{1}, s\right)$ depends only on $s_{1}$ and the coset $s K$. By replacing $c$ with $c^{*}$, the map $p$ is just given by $p\left(\left[c^{*}\right]\right): s K \longmapsto(t \longrightarrow$ $c^{*}(t, s)$ ), for $t \in K, s \in G$.

## 3. The criterion

We keep the notations of Section2. Throughout this section, we will let $\Lambda_{\Gamma}=\left\{\lambda_{1}\left(g_{1}\right)=\lambda_{2}\left(g_{2}\right)^{-1} \mid\left(g_{1}, g_{2}\right) \in \Gamma\right\}$. Then there exists a short exact sequence $0 \longrightarrow \mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right) \longrightarrow \Gamma \xrightarrow{\lambda} \Lambda_{\Gamma} \longrightarrow 1$, where $\lambda$ sends $\left(g_{1}, g_{2}\right)$ to $\lambda_{1}\left(g_{1}\right)$. Applying the given map $\iota$ in Section we obtain $0 \longrightarrow \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right) \longrightarrow \iota(\Gamma) \longrightarrow \iota(\Gamma) / \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right) \longrightarrow 1$. By an abuse of notation, we write $\iota\left(\Lambda_{\Gamma}\right)$ for $\iota(\Gamma) / \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$ in the following. By Hochschild-Serre spectral sequence $(c f$. Section 2.4, there exists the following long exact sequence:

& 0 \longrightarrow \operatorname{Hom}\left(\iota\left(\Lambda_{\Gamma}\right), \mu_{8}\right) \operatorname{Hom}\left(\iota(\Gamma), \mu_{8}\right) \longrightarrow \operatorname{Hom}\left(\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right), \mu_{8}\right)^{i(\Gamma)} \longrightarrow \mathrm{H}^{2}\left(\iota\left(\Lambda_{\Gamma}\right), \mu_{8}\right) \\
& \longrightarrow \mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right)_{1} \longrightarrow \mathrm{H}^{1}\left(\iota\left(\Lambda_{\Gamma}\right), \mathrm{H}^{1}\left(\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right), \mu_{8}\right)\right)
\end{aligned}
$$

Now let $\left[c_{R a o}\right] \in \mathrm{H}^{2}\left(\operatorname{Sp}(W), \mu_{8}\right)$ be the unique nontrivial class of order 2 and $[c]$ its restriction to $\iota(\Gamma)$. By Theorem 1.1 the restriction of $[c]$ to $\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$ is trivial apart from the exceptional case mentioned there.

Lemma 3.1. Assume that $\Gamma_{1}$ is a closed subgroup of $\Gamma$ satisfying the following four conditions:
$(\mathbb{C} 1) \lambda: \Gamma_{1} \longrightarrow \Lambda_{\Gamma}$ is surjective;
(C2) $\operatorname{Hom}\left(\iota\left(\Gamma_{1}\right), \mu_{8}\right) \longrightarrow \operatorname{Hom}\left(\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)_{0}, \mu_{8}\right)^{\iota\left(\Gamma_{1}\right)}$ is surjective, where $\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)_{0}=\iota\left(\Gamma_{1}\right) \cap \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$; S
(C3) Under the restriction map Res : $\mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right) \longrightarrow \mathrm{H}^{2}\left(\iota\left(\Gamma_{1}\right), \mu_{8}\right)$ the image of $[c]$ is trivial;
(C4) For each $v=1,2$, there exists a set $\Omega_{v}$ of representatives for $\iota\left(\mathrm{U}\left(W_{v}\right)\right) /\left[\iota\left(\mathrm{U}\left(W_{v}\right)\right), \iota\left(\mathrm{U}\left(W_{v}\right)\right)\right]$ such that the set $\left[\Omega_{v}\right]^{l\left(\Gamma_{1}\right)}$ belongs to the parabolic subgroup $P\left(Y_{v}\right)$ for some Lagrangian vector space $Y_{v}$ of $W$.
Then the exact sequence $1 \longrightarrow \mu_{8} \longrightarrow \bar{\Gamma} \longrightarrow \iota(\Gamma) \longrightarrow 1$ splits over $\iota(\Gamma)$.
Proof. $\iota(\Gamma)$ is identified with $\iota\left(\Gamma_{1}\right) \cdot \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$, so $\iota\left(\Gamma_{1}\right) / \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)_{0} \simeq \iota\left(\Lambda_{\Gamma}\right)$. Applying the six-term exact sequence (2.4) to the following commutative diagram

[^4]yields a diagram of long exact sequences:

It is possible to divide the horizontal arrow $p$ into $p_{1}$, $p_{2}$, where $p_{v}: \mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right)_{1} \longrightarrow \mathrm{H}^{1}\left(\iota\left(\Lambda_{\Gamma}\right), \mathrm{H}^{1}\left(\iota\left(\mathrm{U}\left(W_{v}\right)\right), \mu_{8}\right)\right)$. For each $v=1,2$, we let $c_{v}$ be a 2-cocycle constructed in [10 p. 55, Théorème], associated to $Y_{v}$ and $\psi$, which is a Borel function from $\operatorname{Sp}(W) \times \operatorname{Sp}(W)$ to $\mu_{8}$. Under the restriction from $\mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right)$ to $\mathrm{H}^{2}\left(\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)\right.$, $\left.\mu_{8}\right)$, the image of [ $c_{v}$ ] is trivial, meaning that $\left[c_{v}\right]$ lies in $\mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right)_{1}$. So there is a Borel function $f$ from $\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$ to $\mu_{8}$ such that $c_{v}\left(t_{1}, t_{2}\right)=f_{v}\left(t_{1} t_{2}\right) f_{v}\left(t_{1}\right)^{-1} f_{v}\left(t_{2}\right)^{-1}$, for $t_{1}, t_{2} \in \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$. Note that when $t_{0} \in \Omega_{v} \subseteq P\left(Y_{v}\right), t \in \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$, we even have $f_{v}\left(t_{0} t\right)=f_{v}\left(t_{0}\right) f_{v}(t)=f_{v}\left(t t_{0}\right)$. According to [11] p.42, Definition 1.2], we can choose a set of representatives $\Delta=\left\{s^{*} \in \iota\left(\Gamma_{1}\right)\right\}$ for $\iota(\Gamma) / \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$ subject to the conditions that the restriction of $\iota(\Gamma) \longrightarrow \iota(\Gamma) / \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$ to $\Delta$ is a Borel isomorphism, and $\Delta$ contains the identity element of $\iota(\Gamma)$ or $\iota\left(\Gamma_{1}\right)$. Now let $f_{v}$ extend to a Borel function of $\iota(\Gamma)$ by taking the trivial value outside $\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$. We replace $c_{v}$ with $c_{v}^{\prime}=c_{v} \cdot \delta_{1} f_{v}$, i.e. $c_{v}^{\prime}\left(s_{1}, s_{2}\right)=c_{v}\left(s_{1}, s_{2}\right) f_{v}\left(s_{1}\right) f_{v}\left(s_{2}\right) f_{v}\left(s_{1} s_{2}\right)^{-1}$ for $s_{1}, s_{2} \in \iota(\Gamma)$. It is immediate that $c_{v}^{\prime}\left(t, t^{\prime}\right)=1$ for $t, t^{\prime} \in \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$. Following Section 2.4.2 we define a Borel function $h$ of $\iota(\Gamma)$ as $h(s)=c_{v}^{\prime}\left(s^{*}, t\right)$, for $s=s^{*} t \in \iota(\Gamma)$ with $s^{*} \in \Delta, t \in \iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right)$, and consider the cocycle $c_{v}^{*}=c_{v}^{\prime} \cdot \delta_{1} h$; then the map $p_{v}$ is just given by $p_{v}\left(\left[c_{v}\right]\right): s^{*} \longmapsto\left(t \longrightarrow c_{v}^{*}\left(t, s^{*}\right)\right)$, for $t \in \iota\left(\mathrm{U}\left(W_{v}\right)\right), s^{*} \in \Delta$. Notice that $p_{v}\left(\left[c_{v}\right]\right)\left(s^{*}\right)$ belongs to $\operatorname{Hom}\left(\iota\left(\mathrm{U}\left(W_{v}\right)\right), \mu_{8}\right)$, so it depends only on the values at those $t_{0} \in \Omega_{v}$. Now $c_{v}^{*}\left(t_{0}, s^{*}\right)=c_{v}^{\prime}\left(t_{0}, s^{*}\right)\left[\delta_{1} h\left(t_{0}, s^{*}\right)\right]=$ $c_{v}^{\prime}\left(t_{0}, s^{*}\right) c_{v}^{\prime}\left(s^{*},\left(s^{*}\right)^{-1} t_{0} s^{*}\right)^{-1}=f_{v}\left(t_{0}\right) f_{v}^{s^{*}}\left(t_{0}\right)^{-1}$, a coboundary with respect to $\mathrm{H}^{1}\left(\iota(\Gamma), \operatorname{Hom}\left(\iota\left(\mathrm{U}\left(W_{v}\right)\right), \mu_{8}\right)\right)$. Hence under the map $p_{v}$, the image of $\left[c_{v}\right]$ is trivial, and $\left[c_{1}\right]=\left[c_{2}\right]=\alpha([d])$ for some $[d] \in \mathrm{H}^{2}\left(\iota\left(\Lambda_{\Gamma}\right), \mu_{8}\right)$. By assumption, $l\left(\left[c_{v}\right]\right)=0=\alpha_{1}([d])$; as $\alpha_{1}$ is injective, we get $[d]=0$, and then $\left[c_{v}\right]=0$, so the result follows.

Remark 3.2. Keep the above notations. The result also holds if we replace the above $(\mathbb{C} 3)$ and $(\mathbb{C} 4)$ by the following condition:
$\left(\mathbb{C} 3 \frac{1}{2}\right)$ For each $v=1,2$, there exists a set $\Omega_{v}$ of representatives for $\iota\left(\mathrm{U}\left(W_{v}\right)\right) /\left[\iota\left(\mathrm{U}\left(W_{v}\right)\right), \iota\left(\mathrm{U}\left(W_{v}\right)\right)\right]$ such that the set $\left[\Omega_{1}\right]^{l\left(\Gamma_{1}\right)}$ belongs to $P\left(Y_{1}\right)$ for some Lagrangian vector space $Y_{1}$ of $W$, and the restriction of $[c]$ to the new group generated by $\iota\left(\Gamma_{1}\right)$ and $\iota\left(\Omega_{2}\right)$ is trivial.
Proof. Under the above condition, it can also be shown that $p([c])$ is trivial in $\mathrm{H}^{1}\left(\iota\left(\Lambda_{\Gamma}\right), \mathrm{H}^{1}\left(\iota\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right)\right), \mu_{8}\right)\right)$, and the remaining proof is the same as above.

In the following Sections $4-9$ we shall prove Theorem A. Our main tool is the above lemma 3.1, and it reduces to find certain suitable subgroup $\Gamma_{1}$ of $\Gamma$ satisfying the desired conditions $(\mathbb{C} 1)-(\mathbb{C} 4)$, or the variant ones. In the rest of this paper, we shall frequently come back to these conditions without further illustration.

## 4. The proof of the main theorem-Part I.

In this section, we follow the notations of Section 3 and prove Theorem A (cf. Section in one major type of cases, where either $W_{1}$ or $W_{2}$ is a hyperbolic space over $D$.
Proposition 4.1. When $W_{1}$ or $W_{2}$ is a hyperbolic space over $D$, Theorem A holds.
Proof. Without loss of generality, we assume that $W_{2} \simeq n_{2} H$ for a hyperbolic plane $H$ over $D$. Let $H=X \oplus X^{*}$ be a complete polarisation, so that we can define two sections $s^{ \pm}: F^{\times} \longrightarrow \mathrm{GU}\left(W_{2}\right) ; a \longmapsto \underbrace{t_{a}^{ \pm} \times \cdots \times t_{a}^{ \pm}}_{n_{2}}$ for $t_{a}^{ \pm}=\left(\begin{array}{cc} \pm 1 & 0 \\ 0 & \pm a\end{array}\right) \in$ $\mathrm{GU}(H)$. Consider the subgroup $\Gamma_{1}=\left\{\left(g_{1}, g_{2}\right) \in \mathrm{GU}\left(W_{1}\right) \times s^{ \pm}\left(F^{\times}\right) \mid \lambda_{1}\left(g_{1}\right)=\lambda_{2}\left(g_{2}\right)^{-1}\right\}$ of $\Gamma$. We identify $\Lambda_{\Gamma}=\Lambda_{\Gamma_{1}}$, and fairly have $\Gamma_{1} \cap\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=\{(1,1),(-1,-1)\}$. It is known that $\Gamma_{1}$ belongs to a parabolic subgroup $P\left(W_{1} \otimes X^{*}\right)$ of $\mathrm{Sp}(W,\langle\rangle$,$) , provided the condition (C3). By Lemmas 2.4, 2.5 P\left(W_{1} \otimes X^{*}\right)$ contains a complete set of representatives for $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) /\left[\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right]$, and also $\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right), \Gamma_{1}$, so the condition ( $\left.\mathbb{C} 4\right)$ holds. By Lemma 3.1 the result follows.
${ }^{{ }^{\text {I }} \text { Here, we assume that }} W_{2}$ is not an orthogonal space over $F$.

Corollary 4.2. If $W_{1}$ is a symplectic vector space over $F$ and $W_{2}$ is an orthogonal vector space over $F$ of even dimension, then the central extension $\bar{\Gamma}$ splits over $\Gamma$.

## 5. The proof of the main theorem-Part II.

In this section we shall prove Theorem A in another type of cases.
Proposition 5.1. Let $D=E$ be a quadratic field extension of $F$. If both $W_{1}, W_{2}$ are anisotropic vector spaces over $E$, then Theorem A holds.

Proof. Cases I \& II: $\operatorname{dim}_{E}\left(W_{1}\right)=1$ or $\operatorname{dim}_{E}\left(W_{2}\right)=1$. By almost symmetry, we only deal with the first case. Assume $W_{1}=E(f)$, for $f=1$ or $f \in F^{\times} \backslash \mathrm{N}_{E / F}\left(E^{\times}\right)$. We now define an $F$-bilinear mapping $\theta$ from $W \simeq E(f) \otimes_{E} W_{2}$ to $W_{2}$ as $\theta: W=E(f) \otimes_{E} W_{2} \longrightarrow$ $W_{2} ; e \otimes w_{2} \longmapsto e w_{2}$, which further induces an isometry of symplectic spaces over $F$, when $W_{2}$ on the right-hand side is endowed with the symplectic form $\langle,\rangle_{2, F}=\operatorname{Tr}_{E / F}\left(f \overline{\langle,\rangle_{2}}\right)$. Then the composite map $\iota: \Gamma \hookrightarrow \operatorname{Sp}(W,\langle\rangle,) \simeq \operatorname{Sp}\left(W_{2},\langle,\rangle_{2, F}\right)$, induced by the above $\theta$, implies that $\iota(\Gamma)=\iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)$. By Theorem $1.1 \bar{\Gamma}$ splits over $\Gamma$.
Case III: $\operatorname{dim}_{E}\left(W_{1}\right)=\operatorname{dim}_{E}\left(W_{2}\right)=2$. By Theorem 2.1. we assume that $W_{1} \simeq \mathbb{H}$ and $W_{2} \simeq \mathbb{H}$. Suppose now $E=F(\mathrm{i})$ for some $\dot{\mathrm{i}} \in \mathbb{H}^{0}$, with $\dot{\mathrm{i}}^{2}=-\alpha \in F^{\times}$. By [20 p. 358], we choose an element $\dot{j} \in \mathbb{H}$, such that $\{1, \dot{\mathrm{i}}, \dot{j}, \mathbb{k}=\dot{\mathrm{i}} \dot{\mathfrak{j}}\}$ forms a standard basis of $\mathbb{H}$, with $\dot{\mathrm{i}}^{2}=-\alpha$ and $\dot{\mathfrak{j}}^{2}=-\beta$. Let $\operatorname{Tr}_{\mathbb{H} / E}$ denote the canonical projection from $\mathbb{H}$ to $E$ defined by $\operatorname{Tr}_{H / E}\left(e_{1}+\mathfrak{j} e_{2}\right)=e_{1}$, for $e_{i} \in E$. Then the $E$-vector space $\mathbb{H}=E \oplus \dot{j} E$, equipped with the form defined as $\left\langle e_{1}+\dot{j} e_{2}, e_{1}^{\prime}+\dot{j} e_{2}^{\prime}\right\rangle_{1}=\operatorname{Tr}_{H / E}\left(\overline{\left(e_{1}+\dot{j} e_{2}\right)}\left(e_{1}^{\prime}+\dot{j} e_{2}^{\prime}\right)\right)=\overline{e_{1}} e_{1}^{\prime}+\beta \overline{e_{2}} e_{2}^{\prime}$, for $e_{i}, e_{i}^{\prime} \in \mathbb{H}$, will turn into a hermitian space over $E$. On the other hand we assume that the form $\langle,\rangle_{2}$ on $\mathbb{H}=E \oplus E j$ is just given by $-\dot{\mathbb{i}} \overline{\langle,\rangle_{1}}$, i.e., if $e_{1}+e_{2} \mathfrak{j}, e_{1}^{\prime}+e_{2}^{\prime} \dot{\mathfrak{j}} \in \mathbb{H}$, we then have $\left\langle e_{1}+e_{2} \mathfrak{j}, e_{1}^{\prime}+e_{2}^{\prime} \mathfrak{j}\right\rangle_{2}=-\dot{\mathrm{i}}\left(e_{1} \overline{e_{1}^{\prime}}+\beta e_{2} \overline{e_{2}^{\prime}}\right)=\operatorname{Tr}_{\mathbb{H} / E}\left(-\dot{\mathrm{i}}\left(e_{1}+e_{2} \dot{\mathfrak{j}}\right)\left(\overline{e_{1}^{\prime}}+\overline{e_{2}^{\prime} \dot{\mathfrak{j}}}\right)\right)$, for $e_{1}, e_{1}^{\prime}, e_{2}, e_{2}^{\prime} \in E$. The skew hermitian form $\langle,\rangle_{W, E}$ on $W=\mathbb{H} \otimes_{E} \mathbb{H}$ is now defined as $\left\langle w_{1} \otimes w_{2}, w_{1}^{\prime} \otimes w_{2}^{\prime}\right\rangle_{W, E}=\left\langle w_{1}, w_{1}^{\prime}\right\rangle \overline{\left\langle w_{2}, w_{2}^{\prime}\right\rangle_{2}}=$ $\dot{\mathrm{i}}\left(\overline{a_{1}} \overline{b_{1}} a_{1}^{\prime} b_{1}^{\prime}+\beta \overline{a_{1}} \overline{b_{2}} a_{1}^{\prime} b_{2}^{\prime}\right)+\dot{\mathrm{i}} \beta\left(\overline{a_{2}} \overline{b_{1}} a_{2}^{\prime} b_{1}^{\prime}+\beta \overline{a_{2}} \overline{b_{2}} a_{2}^{\prime} b_{2}^{\prime}\right)$, for $w_{1}=a_{1}+\dot{j} a_{2}, w_{1}^{\prime}=a_{1}^{\prime}+\dot{j} a_{2}^{\prime} \in \mathbb{H} ; w_{2}=b_{1}+b_{2} \dot{\mathfrak{j}}, w_{2}^{\prime}=b_{1}^{\prime}+b_{2}^{\prime} \dot{\mathfrak{j}} \in \mathbb{H}$. As is easy to verify that if $\mathbb{H} \oplus \mathbb{H}$ is endowed with the skew hermitian form $\langle,\rangle_{H \oplus \Perp}, E=\overline{\langle,\rangle_{2}}+\beta \overline{\langle,\rangle_{2}}$, then the $E$-linear map $\theta=\theta_{1} \oplus \theta_{2}: W=\mathbb{H} \otimes_{E} \mathbb{H} \simeq(E \oplus \dot{j} E) \otimes_{E} \mathbb{H} \longrightarrow \mathbb{H} \oplus \mathbb{H} ;\left[\left(a_{1}+\dot{\mathfrak{j}} a_{2}\right) \otimes\left(b_{1}+b_{2} \dot{\mathfrak{j}}\right)\right] \longmapsto\left(a_{1} b_{1}+a_{1} b_{2} \dot{\mathfrak{j}}, a_{2} b_{1}+a_{2} b_{2} \dot{\mathfrak{j}}\right)$, defines an isometry from $\left(\mathbb{H} \otimes_{E} \mathbb{W},\langle,\rangle_{W, E}\right)$ to $\left(\mathbb{H} \oplus \mathbb{W},\langle,\rangle_{\mathbb{} \oplus \uplus, E}\right)$. By definition, we can embed $E^{\times}$into $G U\left(W_{1}\right)$ resp. $G U\left(W_{2}\right)$ defined as $e \cdot\left(e_{1}+\mathfrak{j} e_{2}\right):=$ $e_{1} e+\dot{j} e_{2} e$ resp. $e \cdot\left(e_{1}+e_{2} \dot{\mathfrak{j}}\right):=e e_{1}+e e_{2 \mathrm{j}}$, for $e \in E^{\times}$; both multipliers of $e$ are the same $\mathrm{N}_{E / F}(e)$. We choose an element $\mathbb{E}_{-1} \in \mathbb{M}^{\times}$, with reduced norm -1 . Now let $\mathbb{E}_{-1} \mathfrak{j}$ act on $W_{1}$ as $\left[\mathbb{C}_{-1, \mathfrak{j}}, e_{1}+\mathfrak{j} e_{2}\right]:=\mathbb{C}_{-1} \mathfrak{j} \cdot\left(e_{1}+\mathfrak{j} e_{2}\right)$, and on $W_{2}$ as $\left[\mathbb{C}_{-1} \mathfrak{j}, e_{1}+e_{2} \mathfrak{j}\right]:=\left(e_{1}+e_{2 \mathfrak{j}}\right) \cdot \mathbb{e}_{-1} \mathfrak{j}$ with multipliers both being $\operatorname{Nrd}\left(\mathbb{E}_{-1} \mathfrak{j}\right)=-\beta$.
(A) If $\dot{\mathbb{i}}=\xi$, $\mathbb{E}_{-1} \in E^{\times}$, we define a subgroup $\Gamma_{1}$ of $\Gamma$ as generated by $\left(\dot{j}, \dot{j}^{-1}\right),\left(e, e^{-1}\right)$, for all $e \in E^{\times}$. Then $\lambda\left(\Gamma_{1}\right)=$ $\left\langle\mathrm{N}_{E / F}\left(E^{\times}\right), \beta\right\rangle=F^{\times}$, and $\iota\left(\Gamma_{1}\right) \cap \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=1$. Indeed by definition, we have $\mathfrak{j} \cdot(a+\mathfrak{j} b)=-\beta b+\mathfrak{j} a$ and $(a+b \dot{\mathfrak{j}}) \cdot \dot{\mathfrak{j}}^{-1}=b-\frac{a}{\beta} \mathfrak{j}$, so through the above $\theta$ the element $\left(\mathfrak{j}, \dot{\mathfrak{j}}^{-1}\right)$ acts on $\mathbb{H} \oplus \mathbb{H}$ as $\left(\dot{\mathfrak{j}}, \dot{\mathfrak{j}}^{-1}\right) \cdot\left(a_{1}+b_{1} \mathfrak{j}, a_{2}+b_{2}, \dot{\mathfrak{j}}\right)=\left(-\beta b_{2}+a_{2} \dot{\mathfrak{j}}, b_{1}-\right.$ $\left.\frac{a_{1}}{\beta} \mathfrak{j}\right)$. Hence the image of $\Gamma_{1}$ or $\Gamma$ in $\operatorname{Sp}(W,\langle\rangle$,$) sits in U\left(W,\langle,\rangle_{W, E}\right)$. By Theorem 1.1 the result holds in this case.
(B) If $\dot{i}=\omega$ or $\xi \emptyset$, and $\mathfrak{j}=\xi$, we set $F_{2}=F(\xi)$. In this case, $\mathbb{e}_{-1}=a_{-1}+\mathfrak{j} b_{-1} \in F(\dot{j})^{\times}$, for some $a_{-1}, b_{-1} \in F^{\times}$. We define a subgroup $\Gamma_{1}$ of $\Gamma$ as generated by $\left(\mathbb{E}_{-1} \mathfrak{j},\left(\mathbb{E}_{-1} \mathfrak{j}\right)^{-1}\right),\left(e, e^{-1}\right)$, for all $e \in E^{\times}$. Then $\lambda\left(\Gamma_{1}\right)=\left\langle\mathrm{N}_{E / F}\left(E^{\times}\right),-\beta\right\rangle=F^{\times}$, and $\iota\left(\Gamma_{1}\right) \cap$ $\iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=1$. By definition, $\mathbb{e}_{-1} \mathfrak{j} \cdot(a+\mathfrak{j} b)=-\mathbb{e}_{-1} b+\mathbb{e}_{-1} \mathfrak{j} a$, and $(a+b \mathfrak{j}) \cdot\left(\mathbb{e}_{-1} \mathfrak{j}\right)^{-1}=(a+b \mathfrak{j}) \cdot \frac{\mathfrak{j}}{\beta} \overline{\mathbb{E}_{-1}}=$ $-b \overline{\mathbb{E}_{-1}}+\frac{a \overline{\mathbb{X}_{-1}}}{\beta} \mathfrak{j}$, so through the above $\theta$, the element $\left(\mathbb{C}_{-1} \mathfrak{j},\left(\mathbb{C}_{-1} \mathfrak{j}\right)^{-1}\right)$ acts on $\mathbb{H} \oplus \mathbb{H}$ as

$$
\left(\mathbb{E}_{-1} \dot{\mathfrak{j}},\left(\mathbb{E}_{-1, \dot{\mathfrak{j}}}\right)^{-1}\right) \bullet\left[a_{1}+b_{1} \dot{\mathfrak{j}}, a_{2}+b_{2} \dot{\mathfrak{j}}\right]=\left[\left(b_{1} b_{-1}+b_{2} a_{-1}\right) \beta-\left(a_{1} b_{-1}+a_{2} a_{-1}\right) \dot{\mathfrak{j}},\left(-b_{1} a_{-1}+\beta b_{2} b_{-1}\right)+\left(\frac{a_{1} a_{-1}}{\beta}-a_{2} b_{-1}\right) \mathfrak{j}\right] \bullet \overline{\mathbb{E}_{-1}} .
$$

By observation, the image of $\Gamma_{1}$ in $\operatorname{Sp}(W,\langle\rangle$,$) belongs to \mathrm{U}\left(W,\langle,\rangle_{W, E}\right)$. By Theorem 1.1 the result holds in this case. This completes the proof.

In Sections 6-8, in view of the results of Satake( Section 2.2.3) we shall prove Theorem A in some quaternionic cases.

## 6. The proof of the main theorem-Part III.

In this section we shall follow the notations introduced at beginning of Section 3 Let $\left(W_{1}=\mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}],\langle,\rangle_{1}\right)$ be a right anisotropic shew hermitian space over $\mathbb{H}$ of dimension 2 such that (1) $\{1, \dot{\mathrm{i}}, \dot{\mathrm{j}}, k=\dot{\mathrm{i}} \mathrm{j}=-\mathrm{j} \dot{\mathrm{i}}\}$ is a standard basis of $\mathbb{H} ;(2) \dot{\mathrm{i}}^{2}=-\alpha$, $\dot{\mathfrak{j}}^{2}=-\beta, \mathbb{1}^{2}=-\mathbb{k}^{2}=\alpha \beta$; (3) $\mathbb{I}=b_{0} \dot{\mathbb{I}}+c_{0} \dot{\mathfrak{j}}+d_{0} \mathbb{k}$ for some $b_{0}, c_{0}, d_{0} \in F$ satisfying $b_{0}^{2} \alpha+c_{0}^{2} \beta+d_{0}^{2} \alpha \beta=-\alpha \beta$. Let $\left(W_{2}=\mathbb{H},\langle,\rangle_{2}\right)$ be
a left hermitian space over $\mathbb{H}$ of one dimension with the hermitian form defined by $\left\langle\mathbb{d}, \mathbb{d}^{\prime}\right\rangle_{2}=\mathbb{d} \overline{\mathbb{d}^{\prime}}$, for vectors $\mathbb{d}, \mathbb{d}^{\prime} \in \mathbb{H}$. Let $(W,\langle\rangle)=,\left(W_{1} \otimes_{\boldsymbol{H}} W_{2}, \operatorname{Trd}\left(\langle,\rangle_{1} \otimes \overline{\langle,\rangle_{2}}\right)\right)$ be as in Section 3

Let $\{1, \zeta, \omega, \zeta \oplus\}$ be the fixed standard basis of $\mathbb{H}$ given in Section 2.1] If $W_{1}$ is endowed with the $F$-symplectic form $\langle,\rangle_{1, F}=$ $\operatorname{Trd}\left(\langle,\rangle_{1}\right)$, then one can check that the canonical mapping $\theta: W=W_{1} \otimes_{H} W_{2} \simeq(\mathbb{H}[j] \oplus H[1]) \longrightarrow W_{1}=\mathbb{H}[j] \oplus \mathbb{H}[1] ; w_{1} \otimes \mathbb{d} \longmapsto w_{1} \mathbb{d}$, defines an $F$-isometry from $(W,\langle\rangle$,$) to \left(W_{1},\langle,\rangle_{1, F}\right)$. An element $g \in U\left(W_{2},\langle,\rangle_{2}\right)$ now acts on $W_{1}$ on the right-hand side by multiplication. In the following, we shall prove the result closely along the different cases described in Proposition [2.2,
6.1. Cases $I \& I I$. We assume $(\mathbb{i}, \mathfrak{j}, \mathbb{I})=\left(\omega, \xi, \mathbb{C}_{-1} \xi \varnothing\right)$ or $\left(\xi \oplus, \xi, \mathbb{X}_{-1} \varpi\right)$, in which cases we may and do assume $c_{0}=0$. Assume that $\mathbb{@}_{-1}$ is the Teichmüller representative of an element of $k_{F(\mathrm{j})}$ in $\mathfrak{D}_{F(\mathrm{j})}$ with order $2(q+1)$. It then follows that $\operatorname{Nrd}\left(\mathbb{e}_{-1}\right)=-1$. For simplicity, we choose certain $b_{0}, d_{0}$ at the beginning such that $\left(\mathbb{e}_{-1}\right)^{-1}=d_{0}+\frac{b_{0}}{\beta} \mathfrak{j}$, and $\mathbb{I}=\left(\mathbb{e}_{-1}\right)^{-1} \mathbb{k}$. Let us fix a symplectic basis $\mathscr{A}_{2}=\left\{e_{1}=-\frac{1}{2 \beta}, e_{2}=\frac{\dot{i}}{2 \alpha \beta} ; e_{1}^{*}=\mathfrak{j}, e_{2}^{*}=\mathbb{k}\right\}$ of the subspace $\left(\mathbb{H}[\mathrm{j}],\langle,\rangle_{1, F}\right)$ and a symplectic basis $\mathscr{A}_{3}=\left\{f_{1}=\frac{1}{2}, f_{2}=-\frac{j}{2 \beta} ; f_{1}^{*}=\frac{\mathbb{1}}{\alpha \beta}, f_{2}^{*}=\frac{j \mathbb{I}}{\alpha \beta}\right\}$ of the subspace $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. Let $U_{1}=\operatorname{Span}\left\{e_{1}, e_{1}^{*}\right\}, U_{2}=\operatorname{Span}\left\{e_{2}, e_{2}^{*}\right\}$ be the symplectic vector subspaces of $\left.(\mathbb{H}[j]),\langle,\rangle_{1, F}\right)$ with the symplectic basis $\mathscr{A}_{2}^{(1)}=\left\{e_{1}, e_{1}^{*}\right\}, \mathscr{A}_{2}^{(2)}=\left\{e_{2}, e_{2}^{*}\right\}$ respectively.

In those cases, $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) \simeq \mathbb{S L}_{1}(\mathbb{H})$. By Lemma [2.6] $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) /\left[\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right]$ is a cyclic group of order $(q+1)$ generated by $\mathscr{E}_{-1}^{2}=\left(d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\right)-\frac{2 b_{0} d_{0}}{\beta} \mathfrak{j}$ in $\mathbb{S} \mathbb{L}_{1}(F(\mathfrak{j}))$. Under the above basis $\mathscr{A}_{2}^{(1)}, \mathscr{A}_{2}^{(2)}$, and $\mathscr{A}_{3}, \mathbb{E}_{-1}^{2}$ acts on $U_{1}, U_{2}$ and $\mathbb{H}[1]$ by means of the matrices $G_{1}^{(1)}=\left[\begin{array}{cc}d_{0}^{2}-\frac{b_{0}^{2}}{\beta} & -4 \beta b_{0} d_{0} \\ \frac{b_{0} d_{0}}{\beta^{2}} & d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\end{array}\right], G_{1}^{(2)}=\left[\begin{array}{cc}d_{0}^{2}-\frac{b_{0}^{2}}{\beta} & 4 \alpha \beta b_{0} d_{0} \\ -\frac{b_{0} d_{0}}{\alpha \beta^{2}} & d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\end{array}\right]$, and $G_{2}=$ $\left(\begin{array}{cc}{\left[\begin{array}{cc}d_{0}^{2}-\frac{b_{0}^{2}}{\beta} & -\frac{2 b_{0} d_{0}}{\beta} \\ 2 b_{0} d_{0} & d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\end{array}\right]} & 0 \\ 0 & {\left[\begin{array}{cc}d_{0}^{2}-\frac{b_{0}^{2}}{\beta} & -2 b_{0} d_{0} \\ \frac{2 b_{0} d_{0}}{\beta} & d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\end{array}\right]}\end{array}\right)$ respectively.

On the other hand, according to Lemma 2.22 $\mathbb{S L} L_{1}\left(D_{F(\mathrm{i})}\right) /\left[\mathbb{S L}_{1}\left(D_{F(\mathrm{i})}\right), \mathbb{S L}_{1}\left(D_{F(\mathrm{i})}\right)\right]$ together with $T_{1}=$ $\left\{(1,1),\left(-\alpha, \mathrm{i}^{-1}\right),\left(\beta, \sqrt{-\beta^{-1}}\right),\left(-\alpha \beta, \mathrm{i}^{-1} \sqrt{-\beta^{-1}}\right)\right\}$ have full image in $\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) /\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right]$. Now let us first describe the action of $\left\{(1,1),\left(-\alpha, \mathrm{i}^{-1}\right),\left(\beta, \sqrt{-\beta^{-1}}\right),\left(-\alpha \beta, \mathrm{i}^{-1} \sqrt{-\beta^{-1}}\right)\right\}$ on $W_{1}$ by following the procedure of Section [2.2.3 The element $\dot{\mathrm{i}}^{-1}$ (resp. $\quad \sqrt{-\beta^{-1}}$ ) corresponds to $h_{1}=\operatorname{diag}\left(\mathrm{i}^{-1}, \mathrm{i}^{-1},-\dot{\mathrm{i}}^{-1},-\mathrm{i}^{-1}\right)$ (resp.

Therefore the elements $\left(-\alpha, \mathrm{i}^{-1}\right)$ and $\left(\beta, \sqrt{-\beta^{-1}}\right)$ act on $W_{1} \otimes_{F} F_{1}$ as well as $W_{1} \otimes_{F} K$ via the matrices $-\alpha P^{-1} h_{1}^{(2)} P=$ $\operatorname{diag}(I,-I,-I)$ and $\beta P^{-1} h_{2}^{(2)} P=\operatorname{diag}(I,-I, I)$ of $\mathrm{GL}_{3}\left(M_{2}(F)\right)$ respectively. Observe that the images of $\left(-\alpha, \mathrm{i}^{-1}\right)$ and $\left(\beta, \sqrt{-\beta}^{-1}\right)$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belong to the center of $\operatorname{Sp}\left(\mathbb{H}[j],\langle,\rangle_{1, F}\right) \times \operatorname{Sp}\left(\mathbb{H}\left[\mathbb{[ 1 ]},\langle,\rangle_{1, F}\right)\right.$. Next, by Lemma [2.6] $\mathbb{S L}_{1}\left(D_{F(\mathrm{i})}\right) /\left[\mathbb{S L}_{1}\left(D_{F(\mathrm{i})}\right), \mathbb{S L}_{1}\left(D_{F(\mathrm{i})}\right)\right]$ is a cyclic group of order $(q+1)$ generated by $g_{0}=\left(d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\right)-\frac{2 b_{0} d_{0}}{\beta} \sqrt{-\beta}$ in $\mathbb{S L}_{1}(F(\sqrt{-\beta}))$. Let $s_{0}=\left(d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\right)$, and $t_{0}=-\frac{2 b_{0} d_{0}}{\beta}$. Then $g_{0}=s_{0}+t_{0} \sqrt{-\beta}$ corresponds to $h=\operatorname{diag}\left(s_{0}+t_{0} \sqrt{-\beta}, s_{0}-t_{0} \sqrt{-\beta}, s_{0}+t_{0} \sqrt{-\beta}, s_{0}-\right.$ $t_{0} \sqrt{-\beta}$ ) in $\mathbb{D}_{4}$. By Remark[2.15) $h^{(2)}=\operatorname{diag}(1, A, 1) \in \mathrm{GL}_{3}\left(M_{2}(K)\right.$ ) for $A=\left(\begin{array}{cc}\left(s_{0}+t_{0} \sqrt{-\beta}\right)^{2} & 0 \\ 0 & \left(s_{0}-t_{0} \sqrt{-\beta}\right)^{2}\end{array}\right) \in \mathrm{GL}_{2}(K)$; it acts on $W_{1} \otimes_{F} F_{1}$ as well as $W_{1} \otimes_{F} K$ via the matrix $P^{-1} h^{(2)} P=\operatorname{diag}(1, B, 1)$ (lemma.2.17), for

In this way we understand $g_{0}$ well as an element of $\mathbf{S} \mathbf{U}_{V}(F)$, where $V=\mathbb{H}[i] \oplus W_{1}$ is given at the beginning of Section 2.2.3 As shown in Section 2.2.3, there is a canonical one-to-one mapping from $\mathbf{U}\left(W_{1},\langle,\rangle_{1}\right)$ to $\mathbf{S} \mathbf{U}_{V}(F)$. By following the procedure described by Satake in [19], $g_{0}$ acts on $W_{1}=\mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}]$ as an element $\left(s_{0}^{2}-t_{0}^{2} \beta+2 s_{0} t_{0} \mathfrak{j}, 1\right)$ in $\mathbb{U}(\mathbb{H}[\mathfrak{j}]) \times \mathbb{U}(\mathbb{H}[\mathbb{1}])$. Under the above bases $\mathscr{A}_{2}^{(1)}, \mathscr{A}_{2}^{(2)}$, and $\mathscr{A}_{3}$, such element acts on $U_{1}, U_{2}$, and $\mathbb{H}[\mathbb{1}]$ via the matrices $H_{1}^{(1)}=\left[\begin{array}{cc}s_{0}^{2}-t_{0}^{2} \beta & 4 \beta^{2} s_{0} t_{0} \\ -\frac{s_{0} t_{0}}{\beta} & s_{0}^{2}-t_{0}^{2} \beta\end{array}\right]$, $H_{1}^{(2)}=$ $\left[\begin{array}{cc}s_{0}^{2}-t_{0}^{2} \beta & 4 \alpha \beta^{2} s_{0} t_{0} \\ -\frac{s_{0} t_{0}}{\alpha \beta} & s_{0}^{2}-t_{0}^{2} \beta\end{array}\right]$, and $H_{2}=\left(\begin{array}{cc}{\left[\begin{array}{cc}1 & 0 \\ 0 & 1\end{array}\right]} & 0 \\ 0 & {\left[\begin{array}{ll}1 & 0 \\ 0 & 1\end{array}\right]}\end{array}\right)$ respectively.

Notations being as above, we can let $\Omega_{1}=\left\langle g_{0}\right\rangle \times T_{1}$, and $\Omega_{2}=\left\langle\mathbb{e}_{-1}^{2}\right\rangle$. Note that for any two elements $g_{1} \in \operatorname{GU}\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right)$, $g_{2} \in \operatorname{GU}\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$ with the same similitude factor, the ordered pair ( $g_{1}, g_{2}$ ) can be viewed as an element in $G U\left(W_{1},\langle,\rangle_{1}\right)$. Now let us define a subgroup $\Gamma_{1}$ of $\Gamma$ as generated by $\left(\mathbb{E}_{-1} \dot{\mathfrak{j}}, \mathfrak{j} ;\left(\mathbb{E}_{-1, \mathfrak{j}}\right)^{-1}\right)$, $\left(\mathbb{E}_{-1} \mathbb{1}, \mathbb{1} ; \mathbb{1}^{-1}\right)$, and $\left(a, a ; a^{-1}\right)$ for all $a \in F^{\times}$.

Lemma 6.1. (i) $\Lambda_{\Gamma_{1}}=F^{\times}=\Lambda_{\Gamma}$;
(ii) $\Gamma_{1} \cap\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=\{(1,1),(-1,-1)\}$;
(iii) $\iota\left(\Omega_{i}\right)^{\iota\left(\Gamma_{1}\right)}=\iota\left(\Omega_{i}\right)$, for $i=1,2$.

Proof. Parts (i)(ii) are straightforward. For (iii), when $i=1$, $\left[\mathbb{C}_{-1} \mathfrak{j}, \mathfrak{j}\right]\left(s_{0}^{2}-t_{0}^{2} \beta+2 s_{0} t_{0} \mathfrak{j}\right)\left[\mathbb{C}_{-1}^{-1} \dot{\mathfrak{j}}^{-1}, \mathfrak{j}^{-1}\right]=s_{0}^{2}-t_{0}^{2} \beta+2 s_{0} t_{0} \dot{\mathfrak{j}}$. Note that $\mathbb{C}_{-1} \mathbb{I}=\mathbb{k}$, so $[\mathbb{k}, \mathbb{1}]\left(s_{0}^{2}-t_{0}^{2} \beta+2 s_{0} t_{0} \mathfrak{j}\right)\left[\mathbb{k}^{-1}, \mathbb{1}^{-1}\right]=s_{0}^{2}-t_{0}^{2} \beta-2 s_{0} t_{0} \mathfrak{j}=\mathbb{C}_{-1}^{-4} \in \Omega_{1}$. The result for $i=1$ is similar.

Under the bases $\mathscr{A}_{2}^{(1)}, \mathscr{A}_{2}^{(2)}, \mathscr{A}_{3},\left(\mathbb{E}-1 \mathfrak{j}, \mathfrak{j} ;(\mathbb{E}-1 \mathfrak{j})^{-1}\right)$ acts on $U_{1}, U_{2}, \mathbb{H}[\mathbb{1}]$ via the matrices $A_{1}^{(1)}=\left[\begin{array}{ll}1 & 0 \\ 0 & 1\end{array}\right], A_{1}^{(2)}=$ $\left.\left[\begin{array}{cc}d_{0}^{2}-\frac{b_{0}^{2}}{\beta} & -4 \alpha \beta b_{0} d_{0} \\ \frac{b_{0} d_{0}}{\alpha \beta^{2}} & d_{0}^{2}-\frac{b_{0}^{2}}{\beta}\end{array}\right], A_{2}=\left(\begin{array}{cc}{\left[\begin{array}{cc}d_{0} & \frac{b_{0}}{\beta} \\ -b_{0} & d_{0}\end{array}\right]} & \\ & \\ & \\ \hline-d_{0} & -b_{0} \\ \frac{b_{0}}{\beta} & -d_{0}\end{array}\right]\right)$ respectively.
Under the bases $\mathscr{A}_{2}^{(1)}, \mathscr{A}_{2}^{(2)}, \mathscr{A}_{3},\left(\mathbb{Q}_{-1} \mathbb{1}, \mathbb{1} ; \mathbb{1}^{-1}\right)$ acts on $U_{1}, U_{2}$, $\mathbb{H}[\mathbb{1}]$ via the matrices $B_{1}^{(1)}=\left[\begin{array}{cc}-d_{0} & -2 \beta b_{0} \\ -\frac{b_{0}}{2 \beta^{2}} & d_{0}\end{array}\right], B_{1}^{(2)}=$ $\left[\begin{array}{cc}d_{0} & -2 \alpha \beta b_{0} \\ -\frac{b_{0}}{2 \alpha \beta^{2}} & -d_{0}\end{array}\right], B_{2}=\left(\begin{array}{cc}{\left[\begin{array}{cc}1 & 0 \\ 0 & -1\end{array}\right]} & \\ & {\left[\begin{array}{cc}1 & 0 \\ 0 & -1\end{array}\right]}\end{array}\right)$ respectively.
Remark 6.2. (1) $H_{1}^{(1)}=\left\{G_{1}^{(1)}\right\}^{2}$, and $H_{1}^{(2)}=\left\{G_{1}^{(2)}\right\}^{-2}$;
(2) $B_{1}^{(1)} G_{1}^{(1)}=\left\{G_{1}^{(1)}\right\}^{-1} B_{1}^{(1)}$;
(3) $G_{1}^{(2)} A_{1}^{(2)}=I$ and $B_{1}^{(2)} A_{1}^{(2)}=\left\{A_{1}^{(2)}\right\}^{-1} B_{1}^{(2)}$, where I is the identity matrix;
(4) $\left\{B_{1}^{(i)}\right\}^{2}=-I$, for $i=1,2$.

Proof. (1) Notice that $s_{0}^{2}-t_{0}^{2} \beta+2 s_{0} t_{0} \dot{\mathfrak{j}}=\mathbb{C}_{-1}^{4}$. The matrices $G^{(1)}, G^{(2)}$ correspond to the element $\mathbb{C}_{-1}^{4}$ acting on $\mathbb{H}[\mathfrak{j}]$ on the right-hand side, and $H_{1}^{(1)} H_{1}^{(2)}$ correspond to the element $\mathbb{E}_{-1}^{2}$ acting on $\mathbb{H}[j]$ on the left-hand side, so the result follows from $\overline{\mathbb{E}}-1^{4}=\left(\mathbb{e}_{-1}\right)^{-4}$. Other parts (2)—(4) are straightforward.

Let $\mathscr{S}_{i}$ be the subgroup of $\operatorname{SL}\left(U_{i},\langle,\rangle_{1, F}\right)$ generated by $G_{1}^{(i)}, H_{1}^{(i)}, A_{1}^{(i)}$, and $\mathscr{T}_{i}=\mathscr{S}_{i} \cdot\left\langle B_{1}^{(i)}\right\rangle$, for $i=1,2$ respectively. By Remark 6.2 $\mathscr{S}_{i}=\left\langle G_{1}^{(i)}\right\rangle \simeq \mathbb{Z}_{q+1}$, and $\left\langle B_{1}^{(i)}\right\rangle \simeq \mathbb{Z}_{4}$. Let us fix a non-trivial character $\psi$ of $F$.

Remark 6.3. Let $C_{1}^{(1)}=\left[\begin{array}{cc}-d_{0} & 2 \beta b_{0} \\ \frac{b_{0}}{2 \beta^{2}} & d_{0}\end{array}\right]$, and $C_{1}^{(2)}=\left[\begin{array}{cc}d_{0} & 2 \alpha \beta b_{0} \\ \frac{b_{0}}{2 \alpha \beta^{2}} & -d_{0}\end{array}\right]$. Then

(2) $B_{1}^{(i)} \notin \mathscr{S}_{i}, C_{1}^{(i)} \notin \mathscr{S}_{i}$;
(3) $\left\{C_{1}^{(i)}\right\}^{2}=-I$, for $i=1,2$.

Proof. Parts (1) and (3) are straightforward. For (2), by observation, every element $g \in \mathscr{S}_{i}$ has the form $\left[\begin{array}{cc}t & * \\ * & t\end{array}\right]$, for some $t \in F$. However the diagonal parts of $B_{1}^{(i)}, C_{1}^{(i)}$ are $\operatorname{diag}\left(d_{0},-d_{0}\right)$ or $\operatorname{diag}\left(-d_{0}, d_{0}\right)$ with $d_{0} \neq 0$.

Then $C_{1}^{(1)}=$ $u(-x) h(-t) u(x)$. Set $Y_{1}^{*}=\operatorname{Span}\left\{e_{1}^{*}\right\}$. Let $c_{Y_{1}^{*}, \psi}$ the Leray $\operatorname{cocycle}\left(c f\right.$. [8] p.13]) associated to the Lagrangian subspace $Y_{1}^{*}$ and $\psi$. Then using the formulas in [8 pp.18-21], we can calculate the Leray cocycle

According to Theorem 1.1 the restriction of $\left[c_{Y_{1}^{*}, \psi}\right]$ to $\mathscr{S}_{1}$ is trivial, so there exists a Borel function $f(t)$ from $\mathscr{S}_{1}$ to $\mu_{8}$ such that $c_{Y_{1}^{*}, \psi}\left(t_{1}, t_{2}\right)=f\left(t_{1} t_{2}\right) f\left(t_{1}\right)^{-1} f\left(t_{2}\right)^{-1}$, for $t_{1}, t_{2} \in \mathscr{S}_{1} \|$ Now view $f(t)$ as a function from $\mathscr{T}_{1}$ to $\mu_{8}$, and define a new 2-cocycle $\bar{c}_{Y^{*}, \psi}=c_{Y^{*}, \psi} \cdot \delta_{1}(f)$. Then $\bar{c}_{Y^{*}, \psi}\left(\left[G_{1}^{(1)}\right]^{k},\left[G_{1}^{(1)}\right]^{l}\right)=\bar{c}_{Y^{*}, \psi}\left( \pm B_{1}^{(1)}, \pm B_{1}^{(1)}\right)=1$, for any integers $k, l$. Moreover,

Let us define a new function $h$ from $\mathscr{T}_{1}$ to $\mu_{8}$ as $h(a)=\bar{c}_{Y^{*}, \psi}\left(\left(B_{1}^{(1)}\right)^{k},\left(G_{1}^{(1)}\right)^{l}\right)$, for $a=\left(B_{1}^{(1)}\right)^{k}\left(G_{1}^{(1)}\right)^{l} \in \mathscr{T}_{1}$. Then replace the 2-cocycle $\bar{c}_{Y^{*}, \psi}$ by $c_{Y^{*}, \psi}^{*}=\bar{c}_{Y^{*}, \psi} \cdot \delta_{1}(h)$. Next let us apply the criterion(Lemma 3.1) to the triple $\left(\mathscr{S}_{1},\left\langle B_{1}^{(1)}\right\rangle, \mathscr{T}_{1}\right)$ instead of $\left(\mathrm{U}\left(W_{1}\right) \times \mathrm{U}\left(W_{2}\right), \Gamma_{1}, \Gamma\right)$. Go back to the proof of Lemma 3.1 and it suffices to show that the image $p\left(\left[c_{Y^{*}, \psi}^{*}\right]\right)$ is trivial, where $p: \mathrm{H}^{2}\left(\mathscr{T}_{1}, \mu_{8}\right)_{1} \longrightarrow \mathrm{H}^{1}\left(\left\langle B_{1}^{(1)}\right\rangle, \mathrm{H}^{1}\left(\mathscr{S}_{1}, \mu_{8}\right)\right)$. Since $\left\{B_{1}^{(1)}\right\}^{2}=-I$, and $\mathscr{S}_{1}$ is a finite cyclic group, it suffices to verify that $p\left(\left[c_{Y^{*}, \psi}^{*}\right]\right)\left(G_{1}^{(1)}, \pm B_{1}^{(1)}\right)=1$. Note that $p\left(\left[c_{Y^{*}, \psi}^{*}\right]\right)\left(G_{1}^{(1)}, \pm B_{1}^{(1)}\right)=\bar{c}_{Y^{*}, \psi}\left(G_{1}^{(1)}, \pm B_{1}^{(1)}\right) h\left(G_{1}^{(1)}\right) h\left( \pm B_{1}^{(1)}\right)\left[h\left( \pm G_{1}^{(1)} B_{1}^{(1)}\right)\right]^{-1}=$ $\bar{c}_{Y^{*}, \psi}\left(G_{1}^{(1)}, \pm B_{1}^{(1)}\right) \bar{c}_{Y^{*}, \psi}\left( \pm B_{1}^{(1)},\left[G_{1}^{(1)}\right]^{-1}\right)^{-1}=1$ by 6.1], 2.5 and Remark6.3 The case $i=2$ is similar.

According to [5] pp. 245-246], there exists the following morphism on cover groups:

$$

Let $Y_{3}=\operatorname{Span}\left\{f_{1}^{*}, f_{2}^{*}\right\}$ be a Lagrangian subspace of $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. Then the above elements $G_{2}, H_{2}, A_{2}, B_{2}$ all belong to the parabolic subgroup $P\left(Y_{3}\right)$ of $\operatorname{Sp}\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. By Lemma3.1]and Remark 3.2 we obtain:

Proposition 6.5. In the above two cases I and II, Theorem A holds.
6.2. Case III. In this subsection, we follow the notions of Section 2 Let $(\dot{i}, \mathfrak{j}, \mathbb{1})=\left(\xi, \oplus_{,}, \mathbb{e}_{-1} \xi \emptyset\right)$, and for simplicity we assume the beginning $b_{0}=0$. Let us fix a symplectic basis $\mathscr{B}_{2}=\left\{-\frac{1}{2 \beta}, \frac{\dot{i}}{2 \alpha \beta} ; \mathfrak{j}, \mathbb{k}\right\}$ of $\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right)$ and $\mathscr{B}_{3}=\left\{\frac{1}{2},-\frac{\dot{1}}{2 \alpha} ; \frac{\mathbb{1}}{\alpha \beta}, \frac{\dot{i l}}{\alpha \beta}\right\}$ of $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. It is known that $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) /\left[\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right] \simeq \mathbb{S} \mathbb{L}_{1}(\mathbb{H}) /\left[\mathbb{S L}_{1}(\mathbb{H}), \mathbb{S}_{1}(\mathbb{H})\right]$, which is a cyclic group of order $(q+1)$; we choose a generator with inverse image $x_{0}+y_{0} \dot{i}$ in $\mathbb{S}_{1}(F(i))$. Such element acts on $\mathbb{H}[\mathfrak{j}]$ resp. $\mathbb{H}[\mathbb{1}]$, with respect to the basis $\mathscr{B}_{2}$ resp. $\mathscr{B}_{3}$, via the matrices $L_{2}=\left(\begin{array}{cccc}x_{0} & y_{0} & 0 & 0 \\ -y_{0} \alpha & x_{0} & 0 & 0 \\ 0 & 0 & x_{0} & y_{0} \alpha \\ 0 & 0 & -y_{0} & x_{0}\end{array}\right)$ resp. $L_{3}=L_{2}$. Now let $Y_{v}=$ $\{x+y \dot{\mathrm{i}} \mid x, y \in F\}$ be a Lagrangian subspace of $\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right)$ as well as $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$, and $Y=Y_{v} \oplus Y_{v}$ a Lagrangian subspace of $\left(W_{1},\langle,\rangle_{1, F}\right)$. So $L_{2}$ or $L_{3}$ belongs to the parabolic subgroup $P(Y)$ of $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$. If we let $\Omega_{2}=\mathbb{S} \mathbb{L}_{1}(F(\dot{i}))$, with full image in $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) /\left[\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right]$, then the image of $\Omega_{2}$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belongs to $P(Y)$.

[^5]Now let us turn to the group $U\left(W_{1},\langle,\rangle_{1}\right)$. Similarly as Cases $I \& I I$, the images of $\left(-\alpha, \dot{\mathrm{i}}^{-1}\right)$ and $\left(\beta, \sqrt{-\beta^{-1}}\right)$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belong to the center of $\operatorname{Sp}\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right) \times \operatorname{Sp}\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. By Remark[2.7 $\mathbb{S L}_{1}\left(D_{F(\mathfrak{i})}\right) /\left[\mathbb{S L}_{1}\left(D_{F(\mathfrak{i})}\right), \mathbb{S L}_{1}\left(D_{F(\mathfrak{i})}\right)\right]$, is isomorphic with a cyclic group of order $\left(q^{2}+1\right)$. Let us chose a generator of that group with inverse image $\alpha_{1}+a_{1} \alpha_{2}$ in $\mathbb{S}_{1}\left(D_{F(\mathfrak{i})}\right)$ so that $\alpha_{1}^{2}+\left(c_{0}-d_{0} \dot{\mathrm{i}}\right) \alpha_{2}^{2}=1$. Then it acts on $W_{1} \otimes_{F} F_{1}$ via the matrix $g=\left(\begin{array}{ccc}\alpha_{1} & \left(-c_{0}+d_{0} \dot{\mathrm{I}}\right) \alpha_{2} & \\ \alpha_{2} & \alpha_{1} & \\ & & \alpha_{1}^{\sigma} \\ & & -\frac{\left(c_{0}+d_{0} \dot{\mathrm{i}}\right)}{\dot{\mathrm{i}}} \alpha_{2}^{\sigma} \\ & & \alpha_{1}^{\sigma}\end{array}\right) \in \mathbb{D}_{4}$. By calculation (cf. Remark 2.15), we know that

& & \dot{\mathrm{i}} \mathrm{~N}_{F(\mathrm{i} \dot{\mathrm{i}} / F}\left(\alpha_{2}\right) & \mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{1}\right) & \alpha_{2} \alpha_{1}^{\sigma} & \dot{\mathrm{i}} \alpha_{1} \alpha_{2}^{\sigma} \\
& & \dot{\mathrm{i}} \alpha_{1} \alpha_{2}^{\sigma} & \left(-c_{0}+d_{0} \dot{\mathrm{i}}\right) \alpha_{2} \alpha_{1}^{\sigma} & \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{1}\right) & \dot{\mathrm{i}}\left(-c_{0}+d_{0} \dot{\mathrm{i}}\right) \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{2}\right) \\
& & \alpha_{2} \alpha_{1}^{\sigma} & -\frac{c_{0}+d_{0} \dot{\mathrm{i}}}{\dot{\mathrm{i}}} \alpha_{1} \alpha_{2}^{\sigma} & -\frac{c_{0}+d_{0}}{\dot{\mathrm{i}}} \mathrm{~N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{2}\right) & \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{1}\right)

It can be directly checked that $P^{-1} g^{(2)} P=\left(\begin{array}{ccc}1 & 0 & 0 \\ 0 & X_{22} & X_{23} \\ 0 & X_{32} & X_{33}\end{array}\right) \in \quad \operatorname{GL}_{3}\left(M_{2}(F)\right)$ for $\quad X_{22} \quad=$ $\left(\begin{array}{cc}\mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{1}\right)+\dot{\mathrm{i}} \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{2}\right) & 0 \\ 0 & \mathrm{~N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{1}\right)-\dot{\mathrm{i}} \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{2}\right)\end{array}\right), \quad X_{23} \quad=\left(\begin{array}{cc}\left(-c_{0}+d_{0} \dot{\mathrm{i}}\right) \alpha_{2} \alpha_{1}^{\sigma}+\alpha_{1} \alpha_{2}^{\sigma} \dot{\mathrm{I}} & 0 \\ 0 & -\alpha_{2} \alpha_{1}^{\sigma} \dot{\mathrm{i}}-\left(c_{0}+d_{0} \dot{\mathrm{i}}\right) \alpha_{1} \alpha_{2}^{\sigma}\end{array}\right)$, $X_{32}=\left(\begin{array}{cc}\alpha_{2} \alpha_{1}^{\sigma}-\frac{\left(c_{0}+d_{0} \dot{\mathrm{i}}\right) \alpha_{1} \alpha_{2}^{\sigma}}{\dot{\mathrm{i}}} & 0 \\ 0 & \alpha_{1} \alpha_{2}^{\sigma}+\frac{\left(c_{0}-d_{0} \dot{\mathrm{i}}\right) \alpha_{2} \alpha_{1}^{\sigma}}{\dot{\mathrm{i}}}\end{array}\right), \quad X_{33}=\left(\begin{array}{cc}\mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{1}\right)+\dot{\mathrm{i}} \mathrm{N}_{F(\dot{\mathrm{i}}) / F}\left(\alpha_{2}\right) & 0 \\ 0 & \mathrm{~N}_{F(\mathrm{i}) / F}\left(\alpha_{1}\right)-\dot{\mathrm{i}} \mathrm{N}_{F(\mathrm{i} \mathrm{i}) / F}\left(\alpha_{2}\right)\end{array}\right)$. Hence the matrix $\left(\begin{array}{ll}X_{22} & X_{23} \\ X_{32} & X_{33}\end{array}\right)$ corresponds to $\left(\begin{array}{cc}\mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{1}\right)+\dot{\mathrm{i}} \mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{2}\right) & \left(-c_{0}+d_{0} \dot{\mathrm{i}}\right) \alpha_{2} \alpha_{1}^{\sigma}+\alpha_{1} \alpha_{2}^{\sigma} \dot{\mathrm{i}} \\ \alpha_{2} \alpha_{1}^{\sigma}-\frac{\left(c_{0}+d_{0} \dot{\mathrm{i}} \alpha_{1} \alpha_{2}^{\sigma}\right.}{\dot{\mathrm{i}}} & \mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{1}\right)+\dot{\mathrm{i}} \mathrm{N}_{F(\mathrm{i}) / F}\left(\alpha_{2}\right)\end{array}\right) \in \mathrm{SL}_{2}(\mathbb{H})$. Taking the set $\Xi_{1}=\mathbb{S}_{1}\left(F(\mathrm{i})\left(\mathrm{a}_{1}\right)\right)$ as defined in Lemma 2.22 we then have

Lemma 6.6. Recall the set $T_{1}$ in Lemma [2.22, Let $\Omega_{1}$ be the image of $T_{1}$ in $\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)$. Then:
(1) The composite map $\pm \iota\left(\Omega_{1}\right) \hookrightarrow \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right) \rightarrow \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right)\right) / \iota\left(\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right)\right]\right)$ is onto.
(2) The image of $\Omega_{1}$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belongs to certain $P(Y)$.

Proof. The first statement is immediate. Recall that $Y_{v}=\{x+y \dot{\mathbb{1}} \mid x, y \in F\}$ is a Lagrangian subspace of $\left(\mathbb{H}(\mathfrak{j}),\langle,\rangle_{1, F}\right)$ as well as $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. From the above discussion, we know that the Lagrangian subspace $Y=Y_{v} \oplus Y_{v}$ of $\left(W_{1},\langle,\rangle_{1, F}\right)$ is $\left(\alpha_{1}+a_{1} \alpha_{2}\right)$-stable for $\alpha_{1}+\mathrm{a}_{1} \alpha_{2} \in \mathbb{S}_{1}\left(F(\dot{\mathrm{i}})\left(\mathrm{a}_{1}\right)\right)$, which is the required result.

We assume $\left(\mathbb{E}_{-1}\right)^{-1}=d_{0}-\frac{c_{0}}{\alpha} \dot{\mathrm{i}}$, and $\mathbb{1}=\left(\mathbb{E}_{-1}\right)^{-1} \mathbb{k}$. Now we let $\Gamma_{1}$ be a subgroup of $\Gamma$ generated by the following elements: (i)

Lemma 6.7. (1) The condition ( $\mathbb{C} 4)$ of Section 3 holds in this case.
(2) Under the restriction $\mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right) \longrightarrow \mathrm{H}^{2}\left(\iota\left(\Gamma_{1}\right), \mu_{8}\right)$, the image of $[c]$ is trivial.

Proof. Let $Y=\left\{\left[\left(x_{1}+y_{1} \dot{\mathrm{i}}\right),\left(x_{2}+y_{2} \dot{\mathrm{i}}\right)\right] \mid x_{i}, y_{i} \in F\right\}$ be a Lagrangian subspace of $\left(W_{1},\langle,\rangle_{1, F}\right)$. Then $\iota\left(\Gamma_{1}\right), \iota\left(\Omega_{1}\right), \iota\left(\Omega_{2}\right)$ all belong to $P(Y)$.

Finally we achieve the main result of this subsection:
Proposition 6.8. In Case III, Theorem A holds.

## 7. The proof of the main theorem-Part IV.

Let $\left.\left(W_{1}=\mathbb{H}[i]\right] \oplus \mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}],\langle,\rangle_{1}\right)$ be a right anisotropic shew hermitian space over $\mathbb{H}$ of dimension 3 given at the beginning of Section 6 Let $\left(W_{2}=\mathbb{H},\langle,\rangle_{2}\right)$ be a left hermitian space over $\mathbb{H}$ of dimension 1 . Let $\{1, \xi, \omega, \xi \oplus\}$ be the fixed standard basis of
$\mathbb{H}$ as given in Section 2.1. By Proposition 2.2, we assume that $(\mathfrak{i}, \mathfrak{j}, \mathbb{1})=\left(\xi, \varrho_{,} \mathbb{e}_{-1} \xi \oplus\right)$, and $b_{0}=0$. Let $\mathbb{E}_{-1}$ be the Teichmüller representative of an element of $k_{F(\mathbf{i})}$ in $\mathfrak{D}_{F(\mathrm{i})}$ with order $2(q+1)$.

As before we endow $W_{1}$ with the $F$-symplectic form $\langle,\rangle_{1, F}=\operatorname{Trd}\left(\langle,\rangle_{1}\right)$ so that the canonical mapping $\theta: W=W_{1} \otimes_{\text {H }} W_{2} \simeq$ $(\mathbb{H}[\dot{i}] \oplus \mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}]) \otimes_{\mathbb{H}} \mathbb{H} \longrightarrow \mathbb{H}[\mathfrak{i}] \oplus \mathbb{H}[\mathfrak{j}] \oplus \mathbb{H}[\mathbb{1}] ; w_{1} \otimes \mathbb{d} \longmapsto w_{1} \mathbb{d}$, defines an isometry between $(W,\langle\rangle$,$) and \left(W_{1},\langle,\rangle_{1, F}\right)$. We fix a basis $\mathscr{B}_{1}=\left\{-\frac{1}{2 \alpha}, \frac{\dot{j}}{2 \alpha \beta} ; \dot{\mathbb{1}},-\mathbb{k}\right\}$ of $\left(\mathbb{H}[\dot{i}],\langle,\rangle_{1, F}\right)$, resp. $\mathscr{B}_{2}=\left\{-\frac{1}{2 \beta}, \frac{\dot{i}}{2 \alpha \beta} ; \mathfrak{j}, \mathbb{k}\right\}$ of $\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right)$, resp. $\mathscr{B}_{3}=\left\{\frac{1}{2},-\frac{\dot{1}}{2 \alpha} ; \frac{\mathbb{1}}{\alpha \beta}, \frac{\dot{i} \mathbb{l}}{\alpha \beta}\right\}$ of $\left(\mathbb{H}[\mathbb{\square}],\langle,\rangle_{1, F}\right)$. In this case $U\left(W_{2},\langle,\rangle_{2}\right) \simeq \mathbb{S}_{1}(\mathbb{H})$. According to the discussion in Section 6.2, the image of $\Omega_{2}=\left\langle\mathbb{E}_{-1}^{2}\right\rangle$ in $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right) /\left[\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right]$ is full.

Next let us consider $\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)$. By Lemma 2.21 the group $\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) /\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right]$ is generated by the images of $\mathbb{S L}_{1}\left(\mathbb{D}_{4}\right) /\left[\mathbb{S L}_{1}\left(\mathbb{D}_{4}\right), \mathbb{S}_{1}\left(\mathbb{D}_{4}\right)\right]$ and $\left\{(1,1),\left(-\alpha, \dot{\mathrm{i}}^{-1}\right),\left(-\beta, \sqrt{-\beta^{-1}}\right),\left(\alpha \beta, \dot{\mathrm{i}}^{-1} \sqrt{-\beta^{-1}}\right)\right\}$. According to the proof of Case III in Section6.2, the images of $\left(-\alpha, \dot{\mathrm{i}}^{-1}\right),\left(-\beta, \sqrt{-\beta}^{-1}\right)$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belong to the center of $\operatorname{Sp}\left(\mathbb{H}[\dot{i}],\langle,\rangle_{1, F}\right) \times \operatorname{Sp}\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right) \times$ $\operatorname{Sp}\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. On the other hand, $\mathbb{S L}_{1}\left(\mathbb{D}_{4}\right) /\left[\mathbb{S}_{1}\left(\mathbb{D}_{4}\right), \mathbb{S L}_{1}\left(\mathbb{D}_{4}\right)\right]$ is isomorphic with $\mathbb{S} \mathbb{L}_{1}\left(\mathbb{D}_{F(i)}\right) /\left[\mathbb{S}_{1}\left(\mathbb{D}_{F(i)}\right), \mathbb{S L}_{1}\left(\mathbb{D}_{F(i)}\right)\right]$; taking the set $\Xi_{1}$ as defined in Lemma 2.22 we then have:

Lemma 7.1. Recall the set $T$ in Lemma 2.21 , Let $\Omega_{1}$ be the image of $T$ in $U\left(W_{1},\langle,\rangle_{1, F}\right)$. Then:
(1) The composite map $\pm \iota\left(\Omega_{1}\right) \hookrightarrow \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right) \rightarrow \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right)\right) / \iota\left(\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1, F}\right)\right]\right)$ is onto.
(2) The image of $\Omega_{1}$ in $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$ belongs to $P(Y)$, for certain Lagrangian subspace of $\left(W_{1},\langle,\rangle_{1, F}\right)$.

Proof. We only sketch the proof of the second statement. Let us follow the notations in Section 2.2.3, By the arguments of Section 6.2. an element $\alpha_{1}+\mathrm{a}_{1} \alpha_{2} \in \mathbb{S L}_{1}\left(F(\dot{\mathrm{i}})\left(\mathrm{a}_{1}\right)\right)$ acts on $W_{1}$ via the matrix with the form $\left(\begin{array}{ccc}1 & 0 & 0 \\ 0 & X_{22} & X_{23} \\ 0 & X_{32} & X_{33}\end{array}\right) \in \mathrm{GL}_{3}\left(M_{2}(F)\right)$, where $\left(\begin{array}{ll}X_{22} & X_{23} \\ X_{32} & X_{33}\end{array}\right)$ is given in Lemma6.6 then the result is clear.

Similarly as before, we assume $\left(\mathbb{E}_{-1}\right)^{-1}=d_{0}-\frac{c_{0}}{\alpha} \dot{1}$, and $\mathbb{1}=\left(\mathbb{E}_{-1}\right)^{-1} \mathbb{k}$. Let $\Gamma_{1}$ be a subgroup of $\Gamma$ generated by $\left(\mathbb{C}_{-1} \dot{1}, \dot{\mathbb{i}}, \dot{\mathbb{1}} ; \dot{\mathbb{i}}^{-1}\left(\mathbb{C}_{-1}\right)^{-1}\right),\left(\mathbb{C}_{-1} \mathbb{1}, \mathbb{E}_{-1} \mathbb{1}, \mathbb{1} ; \mathbb{1}^{-1}\right)$, and $\left(a, a, a ; a^{-1}\right)$ for all $a \in F^{\times}$.

Lemma 7.2. (1) $\Lambda_{\Gamma_{1}}=F^{\times}=\Lambda_{\Gamma}$.
(2) $\iota\left(\Gamma_{1}\right) \cap \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=1$.

Proof. Straightforward.
Let $\mathscr{T}_{2}$ be the subgroup of $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$, generated by $\iota\left(\Gamma_{1}\right)$ and $\iota\left(\Omega_{2}\right)$.
Lemma 7.3. The restriction of $[c]$ to $\mathscr{T}_{2}$ is trivial.
Proof. By definition, $\mathscr{T}_{2}$ is a subgroup of $\operatorname{Sp}\left(\mathbb{H}[i],\langle,\rangle_{1, F}\right) \times \operatorname{Sp}\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right) \times \operatorname{Sp}\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$; we denote its image in the first group by $\mathscr{T}_{2}^{(1)}$, the second one by $\mathscr{T}_{2}^{(2)}$, and the third one by $\mathscr{T}_{2}^{(3)}$. By what we have proved in Lemma 6.4, $\mathscr{T}_{2}^{(1)}$ splits. We now let $Y_{*}=\{x+y \dot{\mathbb{1}} \mid x, y \in F\}$ be a Lagrangian subspace of $\left(\mathbb{H}[\mathfrak{j}],\langle,\rangle_{1, F}\right)$ as well as $\left(\mathbb{H}[\mathbb{1}],\langle,\rangle_{1, F}\right)$. Then $\mathscr{T}_{2}^{(2)}, \mathscr{T}_{2}^{(3)}$ both belong to $P\left(Y_{*}\right)$ so the lemma is proved.

By Lemma3.1 Remark3.2 we obtain

## Proposition 7.4. Under the conditions of the beginning, Theorem A holds.

## 8. The proof of the main theorem-Part V.

Let $(H,\langle\rangle$,$) be a right skew hermitian hyperbolic plane over \mathbb{H}$ defined as in Section [2.2. Let $\left(W_{1}=\mathbb{H}[i] \oplus H,\langle,\rangle_{1}\right)$ be a right skew hermitian hyperbolic space over $\mathbb{H}$ of dimension 3. Let $\left(W_{2}=\mathbb{H},\langle,\rangle_{2}\right)$ be a left hermitian space over $\mathbb{H}$ of dimension 1 . Let $\{1, \dot{1}, \dot{j}, \dot{1} \dot{j}=\mathbb{k}=-\dot{j} \dot{j}\}$ be a standard basis of $\mathbb{H}$. We endow $W_{1}$ with the $F$-symplectic form $\langle,\rangle_{1, F}=\operatorname{Trd}\left(\langle,\rangle_{1}\right)$. Then it can be checked that the canonical mapping $\theta: W=W_{1} \otimes_{\mathbb{H}} W_{2} \longrightarrow W_{1}=\mathbb{H}[\mathfrak{i}] \oplus H ; w_{1} \otimes \mathbb{d} \longmapsto w_{1} \mathbb{d}$, defines an isometry between
$(W,\langle\rangle$,$) and \left(\mathbb{H}[\dot{i}] \oplus H,\langle,\rangle_{1, F}\right)$. Let us fix a complete polarisation $H=X \oplus X^{*}$ of $H$. By Lemmas 2.4 2.5, there is a surjective composite map

$$
\mathfrak{h}: \frac{\mathbb{H}^{\times}}{\left[\mathbb{H}^{\times}, \mathbb{H}^{\times}\right]} \rightarrow \frac{\mathrm{U}\left(H,\langle,\rangle_{1}\right)}{\left[\mathrm{U}\left(H,\langle,\rangle_{1}\right), \mathrm{U}\left(H,\langle,\rangle_{1}\right)\right]} \rightarrow \frac{\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)}{\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right]}
$$

Corollary 8.1. Let $\Omega_{1}=\mathbb{H}^{\times}$, and $Y=Y_{1} \oplus X^{*}$, for an arbitrary Lagrangian subspace $Y_{1}$ of $\left(\mathbb{H}[\mathrm{i}],\langle,\rangle_{1, F}\right)$. Then the image of $\Omega_{1}$ in $\frac{\mathrm{U}\left(W_{1},(,\rangle_{1}\right)}{\left[\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right), \mathrm{U}\left(W_{1},\langle,\rangle_{1}\right)\right]}$ is full and $\iota\left(\Omega_{1}\right) \subseteq P(Y)$.

For the group $\mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)$, we can let $\Omega_{2}=\mathbb{S L}_{1}(F(\xi))$. Then it is clear that the image of $\Omega_{2}$ in $\frac{U\left(W_{2},,\langle \rangle_{2}\right)}{\left[\mathrm{U}\left(W_{2},\langle,\rangle\right), \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right]}$ is full. Following the comprehensive discussion in Section7 we define a subgroup $\Gamma_{1}$ of $\Gamma$ as follows:
(I) If $\dot{i}=\xi$ and $\mathbb{E}_{-1} \in F(\dot{i})$, then let $\Gamma_{1}$ be generated by $\left(\mathbb{E}_{-1} \dot{\mathbb{i}}, \operatorname{diag}\left(\mathbb{E}_{-1} \dot{\mathbb{1}}, \mathbb{E}_{-1} \dot{\mathrm{i}}\right) ; \dot{\mathrm{i}}^{-1} \mathbb{P}_{-1}^{-1}\right)$, $\left(\dot{\mathfrak{j}}, \operatorname{diag}\left(\mathbb{E}_{-1} \dot{\mathfrak{j}}, \mathbb{E}_{-1} \dot{\mathfrak{j}}\right) ; \dot{\mathfrak{j}}^{-1} \mathbb{E}_{-1}\right)$, ( $a, \operatorname{diag}(a, a) ; a^{-1}$ ) for all $a \in F^{\times}$;
 ( $\left.a, \operatorname{diag}(a, a) ; a^{-1}\right)$ for all $a \in F^{\times}$.

Lemma 8.2. (1) $\Lambda_{\Gamma_{1}}=F^{\times}=\Lambda_{\Gamma}$;
(2) $\Gamma_{1} \cap\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=\{(-1,-1),(1,1)\}$;
(3) $\iota\left(\Omega_{i}\right)^{\iota\left(\Gamma_{1}\right)}=\iota\left(\Omega_{i}\right)$, for $i=1,2$.

## Proof. Straightforward.

In case (I), we let $\mathscr{T}_{2}$ be the subgroup of $\operatorname{Sp}\left(W_{1},\langle,\rangle_{1, F}\right)$, generated by $\iota\left(\Gamma_{1}\right)$ and $\iota\left(\Omega_{2}\right)$. Analogous to Lemma 7.3 it can be also shown that the restriction of $[c]$ to $\mathscr{T}_{2}$ is trivial. In case (II), we let $Z_{1}=\left\{x_{1}+y_{1, \dot{j}} \mid x_{1}, y_{1} \in F\right\}$ be a Lagrangian subspace of $\left(\mathbb{H}[\mathrm{i}],\langle,\rangle_{1, F}\right)$. Then $\iota\left(\Gamma_{1}\right), \iota\left(\Omega_{2}\right) \subseteq P\left(Z_{1} \oplus X^{*}\right)$. Finally by Lemma3.1 Remark3.2 we obtain
Proposition 8.3. Under conditions at the beginning of this section, Theorem A holds.

## 9. The proof of the main theorem-Part VI.

In this section we finish proving Theorem A in the general case. The whole process has already been done in Section 8 To avoid duplicating work, we only give a sketch of the necessary steps. We will use the notations introduced in Section 1 Now let $W_{v}=W_{v}^{0} \oplus H_{v}$ be a Witt's decomposition with $W_{v}^{0}$ being its anisotropic subspace, and $H_{v} \simeq m_{v} H$ being its hyperbolic subspace, as $v$ runs through $1,2$.
Remark 9.1. (1) If $W_{1}^{0}=0$, or $W_{2}^{0}=0$, we deduce the result from Section 4 ,
(2) If $m_{1}=0=m_{2}$, the result has been verified in Sections 5, 6,7 ,
(3) The case $D=F,\left\{\epsilon_{1}, \epsilon_{2}\right\}=\{ \pm 1\}$ has been completely discussed in Corollary 4.2. In what follows we shall exclude this case automatically.
Suppose now $W_{1}^{0} \neq 0, W_{2}^{0} \neq 0$, and we assume that either $m_{1}$ or $m_{2}$ is nonzero. In this situation there is a morphism $i: \operatorname{Sp}\left(W_{1}^{0} \otimes_{D} W_{2}^{0}\right) \times \operatorname{Sp}\left(W_{1}^{0} \otimes_{D} H_{2}\right) \times \operatorname{Sp}\left(H_{1} \otimes_{D} W_{2}^{0}\right) \times \operatorname{Sp}\left(H_{1} \otimes_{D} H_{2}\right) \longrightarrow \underline{\operatorname{Sp}\left(W_{1} \otimes_{D} W_{2}\right)}$, which induces a morphism on cover groups by [5] pp. 245-246], that is, $\bar{i}: \overline{\operatorname{Sp}\left(W_{1}^{0} \otimes_{D} W_{2}^{0}\right)} \times \overline{\operatorname{Sp}\left(W_{1}^{0} \otimes_{D} H_{2}\right)} \times \overline{\operatorname{Sp}\left(H_{1} \otimes_{D} W_{2}^{0}\right)} \times \overline{\operatorname{Sp}\left(H_{1} \otimes_{D} H_{2}\right)} \longrightarrow \overline{\operatorname{Sp}\left(W_{1} \otimes_{D} W_{2}\right)}$. For these subspaces $W_{1}^{0} \otimes_{D} W_{2}^{0}, W_{1}^{0} \otimes_{D} H_{2}, H_{1} \otimes_{D} W_{2}^{0}, H_{1} \otimes_{D} H_{2}$ of $W_{1} \otimes_{D} W_{2}$, we have already defined the suitable pairs

$$
\left(\Gamma^{(0,0)}, \Gamma_{1}^{(0,0)}\right),\left(\Gamma^{\left(H_{1}, 0\right)}, \Gamma_{1}^{\left(H_{1}, 0\right)}\right),\left(\Gamma^{\left(0, H_{2}\right)}, \Gamma_{1}^{\left(0, H_{2}\right)}\right),\left(\Gamma^{\left(H_{1}, H_{2}\right)}, \Gamma_{1}^{\left(H_{1}, H_{2}\right)}\right)
$$

of the subgroups of $\left(\mathrm{GU}\left(W_{1}^{0},\langle,\rangle_{1}\right) \times \mathrm{GU}\left(W_{2}^{0},\langle,\rangle_{2}\right)\right), \cdots,\left(\mathrm{GU}\left(H_{1},\langle,\rangle_{1}\right) \times \mathrm{GU}\left(H_{1},\langle,\rangle_{2}\right)\right)$ respectively in Sections 4, 5, 6 7, 8 By Proposition4.1 we can let $\Gamma_{1}$ be a subgroup of $\Gamma$ consisting of the elements $\left[\left(g_{1}^{(0)}, g_{1}^{\left(H_{1}\right)}\right),\left(g_{2}^{(0)}, g_{2}^{\left(H_{2}\right)}\right)\right]$ such that (1) $\left(g_{1}^{(0)}, g_{2}^{(0)}\right) \in$ $\Gamma_{1}^{(0,0)}$, (2) $\left(g_{1}^{(0)}, g_{2}^{\left(H_{2}\right)}\right) \in \Gamma_{1}^{\left(0, H_{2}\right)}$, (3) $\left(g_{1}^{\left(H_{1}\right)}, g_{2}^{(0)}\right) \in \Gamma_{1}^{\left(H_{1}, 0\right)}$, and consequently (4) $\left(g_{1}^{\left(H_{1}\right)}, g_{2}^{\left(H_{2}\right)}\right) \in \Gamma_{1}^{\left(H_{1}, H_{2}\right)}$. As a consequence we obtain:
Lemma 9.2. (1) $\Lambda_{\Gamma}=\Lambda_{\Gamma_{1}}$.
(2) $\iota\left(\Gamma_{1}\right) \cap \iota\left(\mathrm{U}\left(W_{1},\langle,\rangle_{1}\right) \times \mathrm{U}\left(W_{2},\langle,\rangle_{2}\right)\right)=1$.

Lemma 9.3. Under the restriction $\mathrm{H}^{2}\left(\iota(\Gamma), \mu_{8}\right) \longrightarrow \mathrm{H}^{2}\left(\iota\left(\Gamma_{1}\right), \mu_{8}\right)$, the image of $[c]$ is trivial.
9.1. Suppose now $m_{1} m_{2} \neq 0$. By Lemmas 2.4 2.5 for each $v=1,2$, there exists a surjective composite map

$$
\frac{D^{\times}}{\left[D^{\times}, D^{\times}\right]} \rightarrow \frac{\mathrm{U}\left(H,\langle,\rangle_{v}\right)}{\left[\mathrm{U}\left(H,\langle,\rangle_{v}\right), \mathrm{U}\left(H,\langle,\rangle_{v}\right)\right]} \rightarrow \frac{\mathrm{U}\left(W_{v},\langle,\rangle_{v}\right)}{\left[\mathrm{U}\left(W_{v},\langle,\rangle_{v}\right), \mathrm{U}\left(W_{v},\langle,\rangle_{v}\right)\right]} .
$$

Namely we choose $\Omega_{v}=D^{\times}$. Let $Y_{v}=Y_{v}^{(0)} \oplus Y_{v}^{\left(H_{v}\right)}$ be a Lagrangian subspace of $\left(W_{1} \otimes W_{2},\langle,\rangle_{1} \otimes \tau\left(\langle,\rangle_{2}\right)\right)$ consisting of an arbitrary Lagrangian subspace $Y_{v}^{(0)}$ of $W_{1}^{0} \otimes_{D} W_{2}^{0}$, and $Y_{v}^{\left(H_{v}\right)}$ as defined in Proposition4.1 in each case. By Proposition 4.1 we obtain

Lemma 9.4. (1) $l\left(\Omega_{v}\right) \subseteq P\left(Y_{v}\right)$.
(2) $l\left(\Omega_{v}\right)^{\iota\left(\Gamma_{1}\right)} \subseteq P\left(Y_{v}\right)$.

By Lemma3.1 Theorem A holds in this case.
9.2. Without loss of generality, suppose now $m_{1} \neq 0$ and $m_{2}=0$. In this case, we let $\Omega_{1}=D^{\times}$, and $Y_{1}$ be the Lagrangian subspace of $W_{1} \otimes W_{2}$ as defined before. Nevertheless, $W_{2}=W_{2}^{0}$ is an anisotropic $\epsilon$-hermitian space over $D$. We follow the discussion in Sections 4, 5, 6, 7, 8 , and define the distinct set $\Omega_{2}$ in each case. With the benefit, we obtain the same result as Lemma 8.2. We can define a new subgroup $\mathscr{T}_{2}$ of $\operatorname{Sp}\left(W_{1} \otimes W_{2}\right)$ as generated by $\iota\left(\Gamma_{1}\right)$ and $\iota\left(\Omega_{2}\right)$. Then similarly as Section 8 , it can be shown that either $t\left(\Omega_{2}\right)^{\iota\left(\Gamma_{1}\right)} \subseteq P(Y)$ for certain Lagrangian subspace of $\left(W_{1} \otimes W_{2},\langle,\rangle_{1} \otimes \tau\left(\langle,\rangle_{2}\right)\right)$, or the restriction of $[c]$ to $\mathscr{T}_{2}$ is trivial. Without a doubt, Theorem A holds in this case.
